His Majesty said the youth was the future of the region, and addressing all matters that concerned them meant that they would be guaranteed of leaving the organisation in safe hands. His Majesty also said, while the region had reasons to pride itself for the progress it had made so far, there was still room for improvement, All that was needed. His Majesty said was mobilisation of resources because without such implementation the SADC programmes would be stalled.

Adding, in the past SADC had had difficulty implementing the programmes agreed upon, due to budgetary constraints, hence the need to vigorously mobilise funds for the development of the region. The king also said there was a need to capacitate the SADC Secretariat so that it could effectively push the regional agenda.

# 60 million people affected by El Nino worldwide

THE UN Special Envoy said the drought effects of El Nino have badly affected more than 60 million around the world, impacting lives and reversing hard-won development gains.

She said the droughts effects had also threatened peoples' human security and endangering achievement of the Sustainable Development Goals.

In the SADC region, she said 40 million people were affected and of these people, 23 million needed urgent humanitarian assistance.

She said the Southern Africa drought had caused a regional shortfall of 9.3 million tons of cereal production and hundreds of thousands of livestock deaths. Six SADC member states, Botswana, Lesotho, Malawi, Namibia, Swaziland and Zimbabwe have already declared national drought emergencies. South Africa has reportedly declared it in eight of its nine provinces, while Mozambique declared a 90-day institutional red alert for its central and southern regions.

Close to 600 000 children may die of malnutrition in SADC AN estimated 579 000 children in the SADC region are at risk of dying from malnutrition.

The United Nations Special Envoy Mary Robinson said the worst was still to come with regards to the drought effects.

She called for special attention to the already vulnerable groups among those worst affected by El Nino, which comes in the form of drought and devastating floods in other areas.

The UN special envoy said she had spoken to some of the SADC Heads of State about the eminent calamity.

"Although the El Nino climate event has officially concluded, food insecurity is not expected to peak until well into 2017 and it is a painful economic, social and human legacy that could ripple through generations if we do not take all necessary measures to prevent further suffering. Nowhere will this suffering be felt

more than among the estimated 579 000 children in Southern Africa facing the most severe form of malnutrition, for these children this is literally a matter of life or death," she said.

She also called for special attention for the already vulnerable groups among those worst affected by El Nino including women, children, people with disabilities, people living with HIV and AIDS and the rural

She said it was important to bear in mind the injustice of climate change impacts, which she said affected most severely, countries and communities least responsible for the problem.


"These most vulnerable groups must be the focus of our combined efforts to respond to this emergency, and to change our approach to future climate threats."

In her role as a Special Envoy, Robinson has so far visited El Nino affected communities in Ethopia, Hunduras and Swaziland. Her counterpart, Special Envoy Ambassador Macharia Kamau, has also visited

Papua New Guinea and Timor-Leste. As part of the special envoy work to call attention to the threats posed by El Nino-linked drought and climate impacts, they would also be reporting to the United Nations General Assembly in September, advocating to raise more resources for short-term and long-term relief and resiliencebuilding measures across the globe so that countries could avoid becoming entangled in a cycle of shocks and partial recovery.

During the special envoy's visit into the country, she engaged with drought affected communities in the Lubombo region.

She reported that she was able to meet with a group of elderly women at Dvokodvweni.





**THE 36th Ordinary Southern** Africa Development Community (SADC) Summit of Heads of State officially closed on a high note, having achieved a great deal in the past two days.

SADC Executive Secretary Dr

Stergomena Lawrence Tax presented a communiqué that proved that the summit was surely prosperous.

### Summit

The Summit took place under the theme "Resource Mobilisation for Investment in Sustainable Energy Infrastructure for an Inclusive SADC Industrialisation and for Prosperity of the Region".

### AREAS OF CONCERN THE SADC HEADS OF STATE DISCUSSED

- Summit elected His Majesty, King Mswati III as Chairperson and H.E Jacob Gedleyihlekisa Zuma, President of the Republic of South Africa as Deputy Chairperson of SADC
- Summit also elected His Excellency Dr. John Pombe Magufuli President of the Republic of Tanzania and H.E. Jose Eduardo Dos Santos, President of the Republic of Angola as Chairperson and Deputy Chairperson of the SADC Organ on Politics, Defence and Security Cooperation, respectively.
- Summit was also attended by H.E Dr Stergomena Lawrence Tax, SADC Executive Secretary, H.E Dr Nkosazana Dlamini- Zuma, Chairperson of the Africa Union, H.E. Dr Carlos Lopes, Executive Secretary of UNECA. H.E. Sindiso Ngwenya, Secretary General of COMESA, H.E Ambassador Zachary Muburi-Muita, Executive Secretary of ICGLR and H.E Ms Paulina M. Elago, Executive Secretary of SACU.
- His Majesty, King Mswati III of the Kingdom of Swaziland, Incoming Chairperson and host of the 36th Summit welcomed of SADC Heads of States and Government and other delegates to the Kingdom of Swaziland. His Majesty King Mswati III paid tribute to the Outgoing Chairperson of SADC, H.E. Lieutant General Dr. Seretse Khama Ian Khama of the Republic of Botswana for having provided exemplary and foresighted leadership to the Region during his tenure, and for significant progress made.
- Summit commended the people and government of the United Republic of Tanzania and Republic and Seychelles for holding peaceful and credible elections in their respective countries and congratulated Their Excellencies, Dr John Pombe Magufuli and Mr. James Michel, for emerging victorious in the Presidential elections.
- Summit commended the Outgoing Chairperson, H.E President Lt. General. Dr. Seretse Khama Ian Khama for convening the High Level Ministerial Workshops of Food Security and Poverty and Poverty Eradication, Water and Energy and Illegal Trade in Wildlife, which were timely and addressed critical challenges.
- Summit commended His Majesty, King Mswati III and the government of the Kingdom of Swaziland for dedicating a SADC University of Transformation which will grant 300 scholarships, representing 20 for each of the SADC Member States.
- Summit received a report of the

- Outgoing Chairperson of the SADC Organ on Politics, Defence and Security Cooperation, H.E Filipe Jacinto Nyusi, President of the Republic of Mozambique, and commended him for the outstanding leadership of the Chairperson of the
- The Summit applauded the SADC Region for the unity around the candidature of Hon. Dr. Pelomoni Verson-Moitoi, Minister of Foreign Affairs and International Cooperation of the Republic of Botswana as SADC candidate for the African Commission position. And undertook to continue supporting the candidature to the next round of elections set for January 2017, in Addis Ababa.
- Summit noted the adoption of the UN Council Resolution 2277 (2016) which extended the mandate of the United Nations Stabilization Mission in the DRC (MONUSCO) including its Intervention Brigade to 31 March 2017 and commended the DRC government and MONUSCO for signing the Technical Arrangement on 28 January 2016, thereby paving the way for the effective resumption of joint operations between MONUSCO Forces and the FARDC.
- Summit noted the initiative of the facilitation of the facilitation of the National Inclusive Dialogue spearhead by the African Union Special Envoy H.E Eden Kodjo and urged the Government and all political stakeholders to participate in the National Dialogue and agree on the calendar for elections and stakeholders to create a conducive environment and to participate in the national dialogues.
- Summit commended the massacre perpetuated by negative force in the Eastern DRC, particularly the ADF that has grown into a terrorist group posing danger not only to the DRC but to the whole Region, thus requiring concerted, collective and robust response.
- Summit commend the Government of the DRC, the African Union facilitation, all Congolese Stakeholder and the Facilitation Support Group for the effective launching of an inclusive dialogue that is expected to adopt a roadmap towards peaceful elections in accordance with SADC and International standards.
- Summit noted the progress of the SADC decisions; and the Roadmap on the constitutional, security sector, parliamentary and judiciary reforms as presented by the Government of the Kingdom of Lesotho, and mandated the Organ on Politics, Defence and Security Cooperation to assess the report and the

- roadmap and present a report to Summit.
- Summit noted progress made with the convening of the Security Sector Workshops and adopted the recommendation of the
- Summit encouraged the Kingdom of Lesotho to continue implementing SADC decisions, and all stakeholders to participate in the reform processes.
- Summit reiterated the urgent need for the return from exile of the opposition leaders that will pave the ways for an inclusive participation in the on-going reforms and commended H.E. Cyril Ramaphosa, Deputy President of the Republic of South Africa for his stewardship in facilitating the process in the Kingdom of Lesotho.
- Summit commended the Republic of South Africa for hosting AMANI AFRICA II Field Training Exercise (AAFTXII)in October/ November 2015 and member states that contributed graciously and participated on this important exercise.
- Summit noted progress on Madagascar on the political arena and economic recovery, and underscored the importance of regional support to the mobilization of resources in the country's efforts to revive the economy.
- Summit noted that the Republic of Zambia held a peaceful general elections and urged for the speedy resolution of the pending legal issues currently under consideration by the Constitution Court.
- Summit commended H.E. Dr Carlos Lopes, CEO foe UNECA for his excellent presentation on the 36the Theme of the Summit. Summit adopted the theme and directed the Secretariat to expedite the finalization of the SADC Resource Mobilization Framework underpinned by innovative, predictable and sustainable financing modalities.
- Summit received the Report of the Ministerial Task Force on Regional Economic Integration, and noted appreciation the progress made in the implementation of the Industrialization Strategy, emphasizing the need to prioritize and act collective in the implementation in high impact infrastructure projects with potential to catalyse industrialization. While noting progress made in the preparing the Costed Industrialisation Action Plan, and urged Member States to finalise consultations and facilitate its approval

- in March 2017.
- Summit urged Member States that have not signed and ratified SADC Protocols to do so as soon as practically possible.
- Summit approved the Agreement on the Operationalisation of the SADC Regional Fund, and urged Member States to urgently ratify the Agreement in order to facilitate mobilisation of resources to finance key regional projects and programmes, giving further impetus to preparation of infrastructure and industrialisation.
- Summit noted progress made with regard to the implementation of the Regional Infrastructure Development Master Plan, and urged Member States to scales up implementation of priority infrastructure projects.
- Summit noted with satisfaction, the progress with the commissioning of power generation projects yielding 1700 Mega Watts during the year under review, as well as the planned commissioning of power generation projects whose net output amounts to about 4 000 Mega Watts, which will go a long way in alleviating power shortfalls in the region.
- Summit noted the overall deterioration of the Regional food security situation following the 2015/16 agricultural season occasioned by the extreme El Mino drought phenomenon, which left 39.6 million vulnerable people requiring both food and other humanitarian assistance. Summit appealed to the Regional and International Community for continued support to the effected population, in particular to close the gap of E35 billion (US\$2.5 billion).
- Summit noted the presentation by Mrs Mary Robinson, the United Nations Secretary roznide General Special Convoy on El Nino on the severe impact of the current situation drought affecting the region, and appreciated supported rendered by the United Nations.
- Summit commended the then Chairperson of SADC, the President of the republic of Botswana, H.E. Lt General Dr Seretse Khama Ian Khama, for declaring a Regional Drought Disaster and launching the SADC Regional Humanitarian Appeal in Gaborone, Botswana on 26th July 2016.
- The Summit also commended the Secretariat for timely preparation of the disaster declaration and humanitarian Appeal.
- Summit received a report on the

- implementation of the Maseru Declaration on HIV and AIDS, and noted a decline in rates of infections across the region and an increase in the coverage of the Prevention of Mother to Child Transmission (PMTCT) programme with coverage for the SADC region at 90 percentage in 2015. Summit also appreciated the substantial reduction in the incidence of tuberculosis and malaria, including malaria-
- Summit noted the progress made with empowerment of women through appointment to key decision making positions. Summit commended Member States that achieved high representation of women in both political and decision making positions and urged Member States to strive towards reaching the gender parity target at all levels.



# **COUNCILLOR NGANONO** BACK AT WORK

**RECENTLY** suspended Mbabane Ward One Councillor Nganono Manyatsi, is back at work with effect from Tuesday.

He was seen representing Ward One, which is the place in which he was elected back in 2012. Manyatsi fully participated in a councillors' meeting, where he also spoke about the concerns of Ward One residents.

This was during the time when Municipal Council of Mbabane CEO Gideon Mhlongo spoke about the fact that the Council wanted to put up recreational facilities in some other wards that had no such.

Biggest

"I would like Ward One to be considered in such developments because there are no recreational facilities there. Ward One is one of the biggest in the city.

It starts from Manzana, right up to Zone Six. It would be a great achievement for the ward to have such," Manyatsi submitted.

His submission was accepted by Mbabane Mayor Benito Jones and CEO Mhlongo. However, Jones noted that some recreational parks

were destroyed in the city because there were no consultations before such projects were implemented.

He made an example of a certain ward in the city where facilities were stolen from the park. He said to avoid such, it was advisable to ask residents from the concerned ward if they wanted the recreational facili-

Suspended

Manyatsi was suspended in March by the Council. During a meeting held at Mahwalala on Sunday, Manyatsi himself confirmed that he would be back at work on Tuesday during the end-of-month meeting that usually takes place at the municipal Council offices.

"I will start working on Tuesday at the municipal Council after I had been suspended for about four months," Manyatsi said after the meeting.

This was after one resident had raised the issue of Manyatsi's suspension during the meeting. Andreas Mavuso complained about the super slow justice system in the country. He even suspected that there were corrupt tendencies within the system, hence its snail pace.

"I have seen Manyatsi moving in

and out of the courts trying to challenge his suspension but up to this date, nothing had come out of this," Mavuso said.

He said Manyatsi moved an application at the High Court under a certificate of urgency and this was just after being suspended back in March.

Mavuso said what was disappointing was that Manyatsi was back at work not because of the mercy of the law. He said they did not know why the judgment was not issued by the High Court on the matter.

# No deadline extension on old coins - Central Bank

THE Central Bank of Swaziland (CBS) says there will be no more extension to the deadline on old coins that ceased to exist as of yesterday.

This was said by CBS Head of Strategy and Communications Zithulele Gina. He said yesterday's deadline was already an extension as the initial deadline was July 31

Educate

He added that they had also done their best to educate the nation about the issue of old coins through roadshows and advertisements both in print and electronic media.

"We do understand what they are going through, however, we cannot extend the deadline any longer as we have done that already, but our doors are welcome for an exchange of the newer coins in Mbabane," Gina

He added that they were also working on extending their contract with Swazi Post which ended yesterday, to cater for the people far from Mbabane.

"We had an agreement with Swazi Post which has also ended, but we are hoping to negotiate a contract extension with them since post offices are found even in the outskirts of the country," Gina explained.

The issue of scrapping the old coins has been going on since the beginning of the year and the bank has had a number of roadshows in the country to promote the new ones as well as make the public aware of the new setting.

Confusion

However, it seems the confusion is rife now that the deadline has come as the public claims they are being given the old coins as change from shops and public transport, yet are disallowed from buying or paying fees using the same.

The old and new coins being used simultaneously was also said to be very confusing to the public as there were many versions; hence the bank resorted to ruling out the old coins instead.

# Mbabane councillors want litterers arrested

PEOPLE who continue littering in the capital city might find themselves in for a shock as they could be arrested.

The move to arrest people who litter in the capital city was suggested by Mbabane councillors during their end-of-the-month meeting at the Council offices on Tuesday. They said this after praising the Council's decision to clean the city ahead of the recently-concluded SADC Summit. The councillors, however, stated that the city could not afford to be kept clean only if there was an important event to be held in the country. They said the city was generally dirty and such was not good

for the country. Ward Eight Councillor Thulani Mkhonto, was of the view that security companies should be used to arrest people who littered the town.

"In Pigg's Peak, For Him Security Services is used to arrest people who litter the town.

'I think we should also use the security company to do the same here because there is a law that prohibits people from littering," Mkhonta said. Ward 10 Councillor Sabelo Magagula, however, was of the view that some kind of education needed to be done to the people living in the residential areas of the

"I think in our areas, we need to raise some awareness about the advantages of keeping the environment clean. We need to rope in the media to assist us in raising the awareness. I was once helped by the media when we had such an exercise before," Magagula said.

Municipal Council of Mbabane CEO Gideon Mhlongo said security officers had the power to arrest people who littered the city. He said even health inspectors of the Council had such powers, adding that it was painful to see a plot belonging to a person full of litter and such was condemned in the strongest possible

Sigwane said they were currently closely monitoring the levels of water at the available sources which have

"We have two main sources of water which supply the town. Even though we have not yet received a formal report from the Swaziland Water Services Corporation, we acknowledge the decrease of water levels in our sources," said Sigwane.

Meanwhile, surrounding areas such as Mhlumeni, Sitsatsaweni and Ka-Langa are reportedly facing a serious shortage of water. This situation is at the verge of getting out of control as rain remains scarce.

# EL NINO BRINGS WORSE TIMES – UN ENVOY

THE devastating effects brought by El Nino are still to continue unabated if the necessary precautions are not taken urgently.

This was said by United Nations Special Envoy on El Niño and Climate, Mary Robinson, during her visit to Swaziland to discuss and assess the devastating effects of the recent El Niño climate event in Southern Africa, sharing lessons learned at all levels of the humanitarian response.

Robinson visited Swaziland from 29-31 August, meeting with El Niñoaffected communities, development and humanitarian partners, local government officials, UN agencies and SADC Heads of State.

On August 29, she travelled to Dvokodvweni to meet with El Niñoaffected children and families to understand and assess the situation, including the immediate and longer-term actions needed at all levels.

She also attended the SADC Summit on 30 August, delivering remarks on

the regional and global implications of El Niño, calling for changes to the ways that governments and communities prepare themselves for drought and other environmental threats.

"Even in my short time in Swaziland I have witnessed the terrible impacts of relentless drought on children, families and communities," Robinson said. The envoy met with a group of elderly women who explained how the drought had killed their livestock and made water completely unavailable in their households.

They told the envoy that they had seen drought before but they knew that this time, something was different. When Robinson asked the group what they feared most in the future, they told her they feared everything.

The drought had caused them to fear for their families, their livelihoods, the future of their community, the prospects for their children and grandchildren.

Because of climate change, Robinson said Swaziland and other SADC countries should now expect that future weather events like El Niño and La Niña will be more frequent and severe than ever before. This 'new normal'

demanded a different way to reduce and reverse the effects of climate change. It also demanded a different way in preparing for, and responding to these climate-linked threats.

El Niño has badly affected more than 60 million people around the world, impacting lives and livelihoods, reversing hard-won development gains.

It has also threatened people's human security and endangered the achievements of the Sustainable Development Goals. Two-thirds of all affected people (an estimated 40 million) live in Southern Africa, including some 23 million people, who urgently need humanitarian assistance.

The Southern Africa drought has caused a regional shortfall of 9.3 million tons of cereal production and hundreds of thousands of livestock deaths.

Six SADC Member States (Botswana, Lesotho, Malawi, Namibia, Swaziland and Zimbabwe) have already declared national drought emergencies. South Africa has declared drought emergencies in eight of its nine provinces, while Mozambique declared a 90-day institutional red alert for its central and southern regions.

# Vulnerable groups need urgent attention

UNITED Nations Special Envoy on El Niño and Climate Mary Robinson calls for urgent help for vulnerable groups to combat drought in SADC.

Robinson also called for special attention to the already-vulnerable groups among those worst affected by El Niño – including women, children, people with disabilities, people living with HIV and AIDS and the rural poor.

**Impact** 

She said it was important to bear in mind the impact of the injustice of climate change, which affected, most severely, countries and communities least responsible for the problem.

"These most vulnerable groups must be the focus of our combined efforts to respond to this emergency, and to change our approach to future climate threats," she said.

The envoy said this during her visit to Swaziland to discuss and assess the devastating effects of the recent El Niño climate event in Southern Africa, sharing lessons learned at all levels of the humanitarian

esponse.

Robinson visited Swaziland from 29-31 August, meeting with El Niño-affected communities, development and humanitarian partners, local government officials, UN agencies and SADC Heads of State.

In her role as special envoy,
Mary Robinson has so far visited El Niño-affected communities in Ethiopia, Honduras and
Swaziland. Her counterpart
Special Envoy, Ambassador
Macharia Kamau, has also visited Papua New Guinea and
Timor-Leste.

### **Posed**

As part of the special envoys' work to call for attention to the threats posed by El Niño-linked drought and climate impacts, they will also be reporting to the United Nations General Assembly in September, advocating to raise more resources for short-term and long-term relief and resilience-building measures across the globe so that countries can avoid becoming entangled in a cycle of shocks and partial recovery.

# Conductor beats up sick passenger

KOMBI passengers watched in dismay as its conductor assaulted a sickly man over and over after he threw up inside the minibus.

The kombi, which was from Luve to Manzini, is said to have earlier been taken for a thorough wash, something that angered the conductor.

According to eyewitnesses, the visibly sick man, was sleeping through the whole journey but only woke before they reached Manzini and asked that a window should be open.

"I then asked him to swap seats with me since I was seated by the window and soon after exchanging seats the man opened the window

wider and threw up. But since the kombi was in motion, it got plastered in the other windows too," one of the eyewitnesses said.

The conductor was livid and attacked the sick man. Seeing what was happening, the driver promptly stopped the kombi and tried to stop the enraged conductor.

**Sickness** 

The victim confirmed this, stating he was on his way to get medical attention at one of the hospital in Manzini, where his sickness is said to have got worse before he reached the doctors.

"I could feel that I was about to throw up, so I asked for a window to be opened as I was feeling hot and dizzy, luckily the lady seated next to me swapped seats with me, but before long I threw up," he confirmed.

It is said shortly after that the conductor jumped onto the sickly man with fists, demanding he should wash the kombi.

"He told me that he had washed the kombi that morning and I had dirtied it, barely two hours after the first load of the day.

I did not understand why he then decided to reduce me to a punching bag in front of everyone because I was embarrassed enough already," he explained.

He went on to add that even though he was going to clean his mess up he was not expecting such treatment.

"I was willing to clean my mess, even with my clothes if it called for, yet he belittled me by hitting me especially because he is young enough to be my youngest son," he added

# LECTURER FIRED VIA SMS SUES E230 000

Stories by Linda Jele Industrial Court

A lecturer who was allegedly dismissed via a text message at **Metropolitan International** College, wants over E230 000 compensation.

Godwin Hungwe from Tshaneni in the Lubombo region, has instituted legal proceedings against Arhast Investments, trading as Metropolitan International College Swaziland Campus, seeking an order to be compensated for unfair dismissal.

He alleged that he was employed as an educator on April 12, 2014 on a three-year contract expiring on December 31, 2016.

However, the college unilaterally varied his contract's terms of employment before expiry and gave him a new one-year contract without lawful cause

He claimed that after his employment, he was given two copies of a contract to sign and return both of them to the employer. As a result, he did not have a copy

He was earning E8 300 per month. He had remained in continuous employment with the college until November 29, 2015 when his services were unfairly terminated.

"The applicant alleges that on October 30, 2014, he was handed an application form to re-apply for employment for the year 2015, despite the fact that he had signed a three-year fixed contract in April 2014 ending in December 2016.

The applicant alleges that pursuant to signing the re-application form, he was notified that the process was merely procedure and had no effect on his initial three years fixed term contract and this coincided with the advertisement of the applicant's edu-

Then in January 2015, he was handed a new one year fixed term contract and instructed to sign and return all copies to the employer.

Sign

He was reluctant to sign because the new contract varied his initial employment agreement with the employer which had also not run its course.

He further alleged that the new agreement introduced less favourable terms than those offered under the initial three-year contract.

The applicant alleges that he eventually signed the one-year contract on the strength of the respondent's (college) assurances that it did not revoke his initial contract of employment," read papers filed by Hungwe's law firm, Gigi Reid Attorneys.

He claimed that the college, on August 11, 2015 advertised his post as vacant in the local media and on October 5, 2015, he was given yet another re-application form to fill up. Again, he was told this was mere procedure he had undergone in 2014.

"To Hungwe's dismay, on October

15, 2015, interviews were held at the college's premises for all the posts, including that of the applicant."

"The applicant alleges that on November 29, 2015, he received a message through his mobile short message service (SMS) to the effect that his services were no longer required in 2016 at the school, which message terminated the contract of employment between the parties which was intended to endure until December 31, 2016," it was stated.

It was alleged the college's Principal, one Ivo, informed Hungwe to vacate the institution's house before he could be given his end of year salary.

Hungwe said his attorneys wrote to the college, claiming compensation for unfair termination of his services, but they were told Hungwe was not owed anything and rejected his claim.

Hungwe then lodged a complaint before the Conciliation, Mediation and Arbitration Commission (CAMC), which then issued a certificate of unresolved dispute. He is claiming payment of E232 351. The mater is pending before court and the college is yet to file its papers in the matter.

# Bus war: Phumzakhele loses to Emavulane

**HIGH Court Judge Nkululeko** Hlophe has dismissed Phumzakhele Bus Service's application to charge the Road **Transportation Board with** contempt of court in its battle over routes with Emavulane Transport.

The two public transport operators have been involved in a dispute over the schedules of their buses servicing Mbabane, Pigg's Peak and Matsamo.

Phumzakhele Bus Service had instituted legal proceedings before the High Court seeking an order to charge the RTB with contempt of court.

It had been argued that the board had failed to comply with a court order to address the clashing travelling schedules between the two buses as directed by the court about five years ago.

Phumzakhele Bus Service had argued that it had been granted a permit prior to that of Emavulane Bus Service. They complained that the time intervals between the two buses was too short and it gave Emavulane unfair advantage because it left about 15 minutes earlier than the former.

In 2009, Judge Qinisile Mabuza issued an order reverting the matter to the board to address the issue. Phumzakhele argued that the board failed to address the issue as directed by the court.

However, the board, represent-

ed by the attorney general's office, disputed that the court order was not complied with. It submitted before court that the representatives of Phumzakhele Bus Service were invited on two occasions to appear before the board, but failed and the matter was dismissed due to their

Judge Hlophe ruled that the board had complied with the court order and correctly dealt with the matter in the absence of Phumzakhele Bus Service who had been invited but failed to attend.

"A dismissal of the matter on the absence of the Applicant as a party for the second time running cannot realistically amount to a failure to hear the matter and cannot therefore found contempt of court.

Given that civil contempt turns on whether there was a wilful or wreck less disregard of the court order, there cannot be liability for contempt of court in circumstances like the present, where the first Respondent believed it was entitled to dismiss the matter serving before it because of nonattendance or non-prosecution of it by the interested party even if it were shown to have been erroneous in its belief," Judge Hlophe said.

Each party was ordered to pay its own costs.

# Asian businessman ordered to pay ex-worker E20 000

A Siteki-based businessman from one of the Asian countries, is alleged to have slapped and fired his employee for complaining that he sold defective cellphones to the

Mazhar Iqbalnoon, Managing Director of Mandi Investments, is alleged to have slapped Thandazile Mthethwa three times across the face and dismissed her from her job on January 5, 2016.

The bone of contention was that Mthethwa had confronted Igbalnoon on the escalation of complaints from the shop's customers that they had been sold defective goods.

She had been employed as a sales

Mthethwa said on the day she was fired, a customer went to the shop in the company of police officers and complained that she had been sold a defective phone. After that Mthethwa confronted her boss, but she received more than she had bargained for.

It was stated that the former employee's sin was to speak out about the scourge of complaints from customers. The commissioner said the retaliation from the company managing director was uncalled for and extreme. He

said Mthethwa neither committed any form of misconduct nor was she disobedient, but merely raised a concern which the employer could have easily ignored or reprimanded her for if she was out of line.

"She could not, therefore, be dismissed for raising a glaring thorny issue which had the potential of running down the business if not dealt with accordingly," the commissioner said.

He said the issue of dismissal must be preceded by a fair hearing as provided for in the code of good practice for termination of employment. Mandi Investments was ordered to pay Mthethwa E20 693.06 through the CMAC

The application to enforce compliance of the order was heard by the Industrial Court and an order in favour of Mthethwa was issued with costs.

# AGGRIEVED MA STABS COP IN TOW

## THIEVING CONGREGANTS PASTOR CUTS TIES WITH

**PASTOR Sikelela Lukhele** who previously stood as surety for two young men who were arrested and charged with house breaking and theft, has changed his mind and withdrew the offer.

Lukhele had taken the stand as a spiritual father of the accused persons who are members of his church after they allegedly stole from another denomination.

Mduduzi Mncina (27) of Malindza and Nkosinathi Dlamini (23) of Magubheleni allegedly wrongfully and unlawfully broken and entered into a house belonging to

# Ka-Shoba case postponed again

THE case of 18 men from Ka-Shoba who were arrested early last year has been postponed again following the death of one of the accused persons.

They were arrested and charged with malicious damage to property and contravening the Swazi Administration Act.

On the first count, the accused persons were said to have acted in furtherance of a common purpose and did wrongfully, unlawfully and intentionally damage a concrete fence valued at E11 510, belonging to Bheki Dlamini.

## Accused

On the second count, the accused persons are alleged to have acted jointly and obstructed or interfered with the lawful exercise of the chief by disputing allocation of land to Dlamini by the traditional authorities.

They were further charged with a similar offence, in that they wrongfully and unlawfully conspire or attempt to undermine the lawful power and authority of the chief by failing to regard Fanyana Motsa as their indvuna.

# Matter

The matter was back in court on Tuesday for commencement of trial.

However, the court was informed that the first accused person, Sibusiso Langa

Ndzimandze, has recently passed away. Ndzimandze was also a police officer.

He was discovered dead in a house on August 24, after returning from a local sports ground. Ndzimandze was reportedly on suspension when he mysteriously died.

After the presentation of Ndzimandze's death certificate, the court then postponed the matter to September 7.

Meanwhile, the accused persons are out on E500 bail each.



# Station Layout





# HHOHHO REGION CAUTIONED ON MALARIA

**THE National Malaria Control** Programme (NMCP) has cautioned residents of Hhohho to apply preventative measures to curb malaria.

Hhohho is not 'immune' to malaria due to climate change and the topography of the land.

NMCP Surveillance Officer Talisile Malambe said Hhohho was giour 10 percent of all cases from also at risk of malaria, particularly the areas around Ndzingeni, mining Mayiwane, Mhlangatane and Madlangemphisi. To curb malaria, these areas must be sensitised on the preventative methods.

### Unfortunately

"Unfortunately due to extenuating factors like the warming up of the day leas dropped and we continue to ask world's climate areas within the region of Hhohho which now have conditions suited to the breeding of one. The preventative measures are mosquitoes, some of these areas are in adjivided into two groups. Individuals closer to Mhlume and Lomahasha THO vare encouraged to buy and use: being major malaria hotspots. Areas noing around Madlangemphisi and Mayiwane require special attention," she said.

'Malambe said over the previous years, Hhohho region came second in the number of malaria cases reported and was followed by these

- regions in previous years: 70 percent of all cases are from
- the Lubombo region Six percent of all cases from Shiselweni region
- 14 percent of all cases from Hhohho region
- Manzini.

However, the number of malaria cases has infact gone down over the years, due to the fact that people are aware of the disease and its dangers.

- Wearing long sleeves
- Using window screens The second group of prevention

methods which are the most important and provided by the ministry of health to the affected communities include:

- The provision of insecticide treated nets for individuals to sleep under every night
- Allowing of households to be sprayed with insecticides
- Taking prevention tablets when travelling, particularly to warmer climate areas like the Lowveld.

### **Symptoms**

A nurse at the Pigg's Peak Government Hospital stated that malaria was very dangerous and upon onset of its signs and symptoms, people should rush to the nearest health facility within 24 hours.

Now health facilities could quickly test for malaria within 20 minutes using a rapid test tool. New and effective drugs have been introduced as the country was heading towards eliminating malaria.

The signs and symptoms of malaria are headache, fever, dizziness, sweating, tiredness, vomiting and diarrhoea and in some severe cases, patients could fall in to a coma.

# SD receptive to Muslims than other countries

MUSLIMS feel at home in the Northern Hhohho as the number of Swazi members shows a positive increase.

This is according to Imran Mohammed, a Muslim of Senegalese decent who has lived in Swaziland since 2001 and spoke on behalf of the Muslims at the Matsamo Mosque.

Mohammed stated that the area of Northern Hhohho had two mosques; a smaller one in Matsamo and a bigger one closer to Nsangwini.

"We are growing in numbers and that is very positive for us. Last year during Ramadan period, which is celebrated every year, we were about 10 based at the Matsamo mosque. This year about 20 are worshipping at the mosque and this is good. We have four young Swazi men who have converted to Islam," he said.

Mohammed stated that the positive growth was due to Islam's acceptance of all religions and Swazis' hospitality towards foreign religions.





It is usually established by national legislation and yes, it does not happen overnight.


### Dependent

Government is trying to address the issue brought about by health financing of the nation while, however, it is still premature to talk about the project," Director of Health Services Dr Vusi Magagula was quoted as saying.

Meanwhile, the Swaziland Democratic Nurses' Union (SWADNU) was elated on such development, with the Secretary General Sibusiso Lushaba saying they were happy about the strides made towards health inclusion of everybody as they were of the view that health matters had to take priority in the country.

"The issue of people having access to quality health care regardless of financial capability is what we are calling for as a union and have been consulted for our views." he said. Having a tool like NHI at play in any country was not an easy thing, it takes years. And if taxpayers are happy with where their hard earned cash was invested in, they simply give it a nod.

## Consulted

But for us, we have many bitter taxpayers for obvious reasons and these are the very same people that must be consulted for the NHI. I doubt if they will be ok with it. The NHI should be considered by government but...it will be hard to convince the already overtaxed taxpayers to put more of their hard earned cash to the health fund.

As to-date many people are living lavishly and have not been prosecuted yet they 'stole' from government, corruption is raping the cooperation sense from taxpayers. NHI is good, but the basics!!!

# Information remains key resource in HIV, AIDS response

THAT the fight against HIV and AIDS is not over yet, cannot be over emphasised.

In fact, the journey to end AIDS as a public health threat in the country has just begun in earnest.

With over 4 000 people succumbing to AIDS-induced death annually and over 11 000 becoming newly infected, the war against AIDS is not over by any means. In short, the journey is not over for the over 200 000 people of Swaziland who are living with HIV (PLHIV) or the close to 900 000 that are HIV negative.

Ending AIDS requires that we strengthen the delivery of antiretroviral therapy services, deal with enacted stigma and discrimination against people who live with or are affected by HIV while at the same time coerce those that do not have HIV to adopt "appropriate' behaviour to reduce their HIV risks. If the journey to end AIDS is to be meaningful, there is therefore need for a deliberate effort to reach-out to the masses with target-specific information that will address their specific concerns and unique needs.

With this in mind, the National Emergency Response Council on HIV and AIDS (NERCHA) through the National HIV and AIDS Information and Training Centre (Info Centre) is once again, taking part in the annual Swaziland International Trade Fair (SITF) that began on August 26, and runs until Monday, where it is exhibiting and disseminating HIV and AIDS information. The 2016 SITF theme is 'Development Unusual: SITF paves way for SADCs industrialisation and infrastructure development for regional prosperity.'

The SITF brings together over 20 000 local, regional and international people and presents an opportunity for an organised presence of the HIV response aimed at coercing business and the general public, to scale up their participation in the agenda to end AIDS by investing in the HIV response and promoting access and uptake of HIV and AIDS services, including prevention, HIV testing and counselling, and treatment.

# **Exciting period in global HIV** response

The SITF has come at an exciting period when the world is building momentum towards reaching the Sustainable Development Goals (SDG) of a



sustainable, equitable and healthy future for all by 2030. The outstanding progress made in the pursuit of the Millennium Development Goals (MDGs), in particular Goal 6 (to halt and begin to reverse the spread of HIV) has fuelled the urgent effort to complete the unfinished business of the MDGs, as well as pursue the Fast-Track approach that is critical to establishing the necessary momentum to reach the SDG target to end the AIDS epidemic as a public threat by 2030 - though, guided by the vision of His Majesty King Mswati III, the country is committed to Ending AIDS eight years earlier in 2022.

NERCHA continues to provide visionary leadership in the country's HIV response by rolling out programmes that advance global strategies, by translating those ideals into local targets through the Extended National Strategic Framework (eNSF), the UmgubudlaFast-Track Programme Towards an AIDS-Free Swaziland, and itemised in the National Operation Plan (NOP).

**Prestigious** 

On the first day of the ongoing 36th Ordinary Summit of Southern African Development Community (SADC) Heads of State and Government held at the prestigious Mandvulo Grand Hall at Lozitha, His Majesty King Mswati III assumed the position of SADC Chairperson. Multisectoral Response congratulates His Majesty and the Government of the Kingdom of Eswatini, and believes that the chairmanship, provides an xcellent opportunity to show case to our regional partners, the country's experience in responding to HIV and AIDS. Through the SADC HIV fund, the country is leading the mainstreaming of HIV and AIDS in the public sector project in six SADC member states (Botswana, Lesotho, Malawi, Namibia, Swaziland, and Zimbabwe) and further participates in many health related programmes including the cross

border initiative within 15countries.

# His Majesty's unprecedented call

At a time when HIV and AIDS was slowly being relegated to the bottom of the heap of priorities, His Majesty's Vision 2022 brought it back to the pinnacle of public discourse. His Majesty did this through a wideranging address in his 2015 Speech from the Throne where he unprecedentedly and categorically stated that the first world Swaziland that every Swazi needs to work towards attaining by 2022, is one that is AIDS-free.

Without question, His Majesty's call is on point. We cannot speak first world status while still battling a large AIDS-related disease burden - a burden which will dig deep into the country's vault of resources now and in the future. Also, the old adage, "Our health is our wealth" rings true even today. For, it is only when we are healthy and in a good space that we can be productive and generate wealth.

Health is a critical component of the country's balance sheet. Ending the AIDS epidemic requires a shared responsibility that demands increases in both domestic and international investment. Investment needs for preventing new infections from occurring through condom promotion, prevention of mother-to-child transmission, preexposure prophylaxis, voluntary medical male circumcision, a contribution towards outreach services for key populations and using treatment as prevention require an increase in the HIV response budget. This and many more, need to be brought to the fore, for all to appreciate and identify a role to play - individually and collectively; nationally and regionally.

# HIV response at 2016 SITF

NERCHA is not a new comer to the SITF, as it has been participating since 2007, when the Info Centre was established.

With key HIV and AIDS response related activities having already taken place in the year (The HIV Prevention Indaba for Young People in Swaziland; The United Nations High-Level Meeting on HIV; and the National HIV and AIDS Conference; and the International AIDS Conference), and the SADC Head of States Meeting happening alongside the Umhlanga (Reed Dance) and the SITF, the aim for this year's HIV response showcase is to disseminate information on innovative programmes and strategies to accelerate towards vision 2022, from which our regional partners can learn.

For a start, the 2016 NER-CHA Info Centre stall provides a hub for HIV and AIDS information and link to services. Copies of key national documents like the 'Umgubudla': Swaziland HIV Investment Case: the Extended National Strategic Framework (eNSF); and the HIV prevention policy are distributed to both public and private organisations, as well as the regional partners. Researchers can also get copies of the Conference Abstracts Booklet.

Engagement with public

The NERCHA Info Centre stall allows for engagement with the visiting public, including children. With His Majesty also directing that "Akubete lotfola i-HIV -meaning that no one should get newly infected with HIV", various ways are used to gather ideas and advice on what can be done to really end AIDS by 2022. Facebook pages, Ziyakhipha and HIV Info Centre Swaziland are also used to gather the thoughts and suggestions of those not able to make it to the SITF.

There are also short-films shown, especially the 'Shuga' series that proved ever-popular during the recent "Taking HIV and AIDS information to institutions of higher learning" programme.

The stall also offers referral mechanisms for the public to take up HIV services including HIV testing, treatment and support. Everyone is invited to learn more about HIV, its drivers and to become a partner in Ending AIDS in Swaziland, the SADC region and globally.

In the absence of a cure for HIV, information remains the key weapon in the response to HIV and AIDS. If you have not yet been to the 2016 SITF, let us meet at Hall 1 at the Mavuso Trade Centre.

# Widows; society's black sheep

THERE is probably no segment of society more affected by the sins of neglect than widows, and this applies not only in the country but the region, continent and many parts of the world.

Widows must contend with economic abuse and extreme exploitation while also bearing the brunt of stigmatisation as a result of cultural stigma attached to widowhood.

Rarely do they get mention in the multitudes of reports pertaining to poverty alleviation while laws catering specifically for their benefit are conspicuously missing from the legislative realms of many countries.

They are an absent lot and will only come out as a result of extreme necessity, leaving the sanctuary of their dwellings to join mainstream society as part of the daily grind that is life.

Shut out of national initiatives and accorded wretched status, some have to rely on the crumbs that fall from the tables of the as vet-to-be-widowed, since death has this knack of knocking on any door, uninvited.

### Auspicious

They are considered ill-omens and even excluded in the most auspicious of events as if they were the lepers of olden times. Some are accused of witchery and blamed for the demise of their husbands, who are suddenly posthumously honoured to have been upright individuals.

This is despite their sometimes immoral and amorous ways, well documented by the brood of 'out of the marital bed' whelps they may have spawned all over the village and elsewhere.

At times, they find themselves with no shelter having been disinherited of their homes by greedy in-laws and their children drop out of school after jackals in sheepskin cheat them off their late husbands' estates.

They are treated like outcasts just for their unfortunate turn of events and while this signals the urgent need for society to revisit its stance towards widowhood and start treating them humanely - societies seem reluctant to accord them their rights as citizens of their respective countries.

Despite the advent of the HIV and AIDS pandemic, which has cut a swathe of death and destruction amongst nations, many families still regard the hapless widows as harbingers of death and conveniently forget the late person's forays into illicit dens and unbridled virility.

They are punished and denied

everything they may have ever worked for; pots and teaspoons, blankets, sacks and even access to the granary, for which they may have worked hard tilling the fields so it could be filled.

This is the price widows must pay for widowhood and the law in many instances will hardly look their direction, especially if they have no means of engaging attorneys.

Interestingly, the direct opposite obtains if it is the man who gets widowed. He receives all the support from the family and even encouraged to wed another woman the soonest to continue the propagation of the family name, mostly at the expense of the children of the demised woman.

# Attention

They will most likely be relegated to the back-burner while lavish attention is accorded the newly-arrived wife and her children. Widows mostly do not feature in the multitudes of reports on women's poverty, development, health and human rights compiled in the quest for national development.

In developing countries like ours, accessing statistics about their exact numbers, ages and other social and economic aspects of their lives is like traversing a difficult maze.

This is despite that they comprise a substantial portion of the female populace now that the Grim Reaper was also harvesting married men of a relatively young age. In developed western countries, widowhood is largely experienced by elderly women since those countries do not have adverse practices like child marriages and polygamy, while their

life expectancy indexes are much higher than developing nations.

Widowhood also affects women in child rearing age in developing countries and this exacerbates their plight, unlike in the developed world where social systems have effective catch nets that ably take care of the manageable numbers of orphans.

But most importantly, widows in societies like ours are affected by patriarchal, customary and religious laws while also having to confront discrimination in inheritance rights.

### **Disputes**

They suffer abuse and exploitation veiled in the guise of property and land disputes. Few cases proceed successfully through the justice system and mostly, perpetrators go unpunished.

They further suffer from loss of status and marginalisation, neglect from social policy researchers, human rights activists, women movements and even governments.

Such status obviously require urgent attention at all levels and is further legitimised by the fact that in most instances widows far outnumber widowers, mostly as the result of the age disparity between partners in these parts of the globe.

Marginalisation from mainstream society results in their eventual pauperisation and until all taboos attached to widowhood are eliminated, there is no way they can be freed from the clutches of poverty and suffering they currently reel under.

In many African cultures, widows cannot remarry as part of the custom that death does not end a marriage. A widow is expected to fulfill her obligations towards

her deceased husband's family until her own death. This effectively denies her any economic opportunities or leeway to seek alternative support or companionship.

The patriarchal nature of societies and domination posed by oppressive traditional practices and customary codes takes precedence even over constitutional guarantees of equality that modern laws and human rights offer, and this negatively impact on women and widows.

## **Treaties**

Also, legislative reform in compliance with international treaties such as the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) has largely failed to take precedence over customary law, much to their detriment.

Courts could then assist widows by basing judgments on international conventions like CEDAW, especially when it comes to land ownership and property rights.

Like everybody else, widows must be encouraged and empowered to develop so they cannot be seen as just recipients of alms and

They need to be seen as women who can effectively contribute to society and this can be made possible by the removal of all impediments in their growth path, customary or otherwise.

But ultimately, the pauperisation of widows is broadly a result of the violence against women, which is a manifestation of historically unequal power relations between men and women. This has over the years led to domination and discrimination and the prevention of full advancement for women.

# PSPF, SNPF COMMIT E400M

**THE Public Service Pensions** Fund (PSPF) and Swaziland **National Provident Fund** (SNPF) have committed E400 million towards the Lower Maguduza Hydro Power Scheme (LMHPS)

PSPF committed E300 million while SNPF pledged E100 million, which is required by the project company in the form of equity finance and external debt finance.

This is contained in the company's licence application document which is open for public inspection for a period of 30 days before approval.

The projected total costs of the project is E667 829 000.

Other equity members included, OMLACSA via the IDEAS Managed Fund, Swazi Hydro (Pty) Ltd, the project company LMHPS, and lender Nedbank.

According to the company's application, the project involves the design, construction and commission of the hydro plant.

Project

"12MW Lower Maguduza Hydro Power Scheme (LMHPS) hydro project (the Bid Case) or 24MW Lower Maguduza Hydro Power Scheme (LMHPS) hydro project (the Alternative Bid Case)," said the document.

It states that the commencement of electricity generation by the LMHPS would occur in late 2018, while the expected commercial operations date of the project is projected to be July 4,

"The operation of LMHPS is hence strongly influenced by Swaziland Electricity Company (SEC) operations at the existing Ezulwini, Edwaleni, and Maguduza Hydro-Power Stations, and thus is likely that the LMHPS will also produce power in the five hours of RSA peak demand (weekdays from 07h00-10h00 and from 18h00-20h00) and will also target the production of power in the winter months, benefiting from the releases at Lake Luphohlo."

Electricity

The project is expected to stimulate SEC's internally generated electricity which according to the company's 2014/15 annual report slumped from 25 percent to 19 percent.

This, according to the report pushed imports up from E621 million to E757 million as imports increased from 860GWh to 978GWh.

"These figures expose the long held concern of an SEC that is a price taker due to its over reliance on imported power," said the report.

In 2015, according to the report, the power utility's revenues increased from E1.3 billion from the previous year to E1.4 billion after a price squeeze created by the National Energy Regulator of South Africa (NERSA) tariff increase approval for Eskom.

LMHPS seeks a Power Purchase Agreement (PPA) for 25 years where after the LMHPS would be handed over to SEC under its own generation licence.



National Agricultural Marketing Board (NAMBoard) Chief **Executive Officer Siphephiso** Dlamini said those who have sufficient water, or used their water efficiently through new systems and had an integrated market have managed to reap benefits, especially in cabbages, tomatoes and beetroot.

Speaking at the Swaziland International Trade Fair (SITF) business seminars hosted by the Swaziland Investment Promotion Authority (SIPA) he said the drought has also presented opportunities for farmers.

However, he said farmers must be prepared by employing certain strategies.

They should get into discussions with financial institutions on agriculture funding for more efficient irrigation such as the drip method.

"They should also seek funding for undercover cultivation, exploring smaller units to meet farmer needs," he said.

Dlamini said farmers should work on clearing land off alien invasive plant species before the rains come to increase available water for irrigation.

"Farmers should stick to strict irrigation schedules to improve

efficiency in the planting-market cycle. They should also choose crops, and crop timing carefully to reduce prolonged harvest cycles conduct practical information sourcing regimes to improve

outlook and relevance," he said. During his presentation, Dlamini further discussed the key indicators for the future of the industry.

"Going forward it is imperative

to note for farmers that climate change is here to stay, and therefore erratic weather conditions will continue. Unprepared farmers will suffer as water shortages continue," he said.

Dlamini said the predicted floods should be taken full advantage of at household, community, and national levels to harvest water.

"Although I must stress waterways, springs and small rivers will continue to lose water to alien invasive species, therefore it is imperative to deal with that situation. Government and development partners are enhancing available water through water harvesting," he said.

It is inevitable that commodity prices would continue to be volatile and furthermore quality would continue to be important but tricky.

Agriculture is defined as the mainstay of the Swaziland economy; its contribution has declined significantly in recent years to 8.6 percent.

The sector contributes through supporting livelihoods of the approximately 70 percent of the population and it employs nine percent of the country's labour force.

Dlamini said the sector's performance was expected to improve owing to the ongoing initiatives to increase land area under irrigation and commercialisation.

# SWAZISPA HOSPITALITY REVENUES INCREASES BY 19%

AN increase in corporate and national sales business has driven Swazispa Holdings Limited hospitality revenues up by 19 percent.

According to the recently released financial results for the year ended June 30, 2016, the company's corporate and national sales figures increased by 32 percent and 66 percent respectively.

However, the report said this was partly offset by a decline of 11 percent in international business and 16 percent in local campaigned business.

Swazispa operates as an investment holding company, which owns the Royal Swazi Sun, Lugogo Sun, Ezulwini Sun, and various other property assets.

It is also amongst the few companies listed on the Swaziland Stock Exchange (SSX) with a market capitalisation of close to E42 million.

"The hospitality side of the business achieved satisfactory results, whilst the gaming side of the business continued to experience difficult trading conditions," reads the report as part.

The report further says although the casino industry in general experienced a slowdown in business, tables business reflected a growth of 10 percent mainly as a result of direct marketing, "however, the slots business followed the Southern African trend of poor growth due to pressure on disposable income."



Other positive growth achieved by the company were in food and beverage revenues which were attributed to the increase in room bookings, compounded by various outside catering functions held during the reporting financial period.

"The room occupancy increased by 4.8 percent points whilst the room rate was up 12 percent on the prior year."

The increase in room bookings and meals served consequently increased inline with inflation by eight percent.

On the other hand the statement reported that indirect costs were 13 percent up on last year resulting from increased utility costs of 29 percent and rates and taxes at 66 percent.

"This resulted in an EBITDA (company's earnings before interest, taxes, depreciation, and amortisation) of E12.2 million, an increase of 47 percent on the prior year," said the statement.

It states that headline earnings per share of 59.9 cents (2015:18.7 cents) were achieved.

The company reported that it incurred a capital expenditure of E6.5 million which resulted from a number of activities including the refurbishment of the Royal Swazi lounge, heat pump replacements, electricity generator, slot machines, computer equipment, and motor vehicles.

By the end of the reporting year, the company said it had bank borrowings of E20.4 million which was E4.5 million up compared to the previous year.

"Given the high level of borrowing and the difficult trading conditions the directors are reviewing the company's funding requirements on an ongoing basis," said the statement.

Looking forward, the company projects trading to remain challenging, especially on the casino side of business, with an overall marginal revenue growth in the year ahead.

"The company will continue to focus on gaming promotions, improved customer offerings and cost control. It is expected that the company will generate positive operating cash flows in the year ahead."

The company has declared no dividend as yet.

# SD imports E8.5m bottled water from SA

SWAZILAND imported and average of E8.5 million worth of bottled water from South Africa per month in 2015.

Bulembu Ministries Enterprise Manager Kurt Puttkammer said the country has the capacity of producing most of these locally and therefore increasing economic growth which would also create employment opportunities which will ultimately lead to increasing the gross domestic produce of the country.

"As we all know Swaziland imports the majority of its goods from neighbouring countries especially the Republic of South Africa (RSA).

This serves as major competition for anyone who wants to start producing locally at a competitive price," he said.

Puttkammer, in his presentation, proposed trade restrictions to help curb this problem.

"Swaziland should consider imposing import restrictions or taxes on products that can successfully be produced locally. A success story of this is the honey industry, after import restrictions were enforced Swaziland producers were able to service the local market increasing job opportunities and gross domestic product," he said.

Cautioned

The enterprise manager however cautioned that this can only be done if local producers can supply consistently at a high quality to retailers.

This view on trade policy was further echoed by the Swaziland Investment Promotion Authority Chief Executive Officer, Phumelele Dlamini, who said the issue of trade policy was a very important one, "I was hoping an official from the Ministry of Commerce, Industry and Trade would be here to provide clarification on this."

Dlamini said trade policy was influenced by the Southern Africa Customs Union (SACU) and one wonders if there is room for the trade policy in the region to safe guard infant industries in the country.

These sentiments were shared by people who were in attendance of the question and answer section.

One attendee said the issue of trade policy is a pertinent one and needs to be addressed by the government so that small business in Swaziland can thrive.

"The playing ground is unequal such that it is difficult to compete with products that are imported from South Africa as they are competitive."

# Lack of specialised equipment suppliers affects producers

THERE are not enough suppliers or agents of specialised equipment in Swaziland which adversely affects producers of goods in the country.

Speaking at the Swaziland
International Trade Fair (SIPA)
business seminar presentations
held yesterday Bulembu
Ministries Enterprise Manager
Kurt Puttkammer said entrepreneurs were forced to import
equipment and then struggle with
after sales service due to the lack
of technical expertise in the country.

"This causes inefficient production lines that can lead to closure," he said.

The manager proposed that Swaziland should encourage equipment manufacturers to set up shops in the country.

He said the country was ideally located to service several countries like Mozambique and Botswana and should become the

preferred distribution hub into Africa for said equipment and service.

Another challenge the manager noted was that of the lack of material manufacturers in the country.

"There are not enough suppliers

of materials such as packaging and value adding ingredients in Swaziland. Entrepreneurs are forced to import said products at a premium and increased transport cost. This causes higher input costs making local produc-

ers less competitive on the retailer shelves," he said.

He suggested that Swaziland should encourage and assist local entrepreneurs to get training and start up businesses that can address this need.

Meanwhile, during his presenta-

tion Puttkammer highlighted the relationship that should exist between producers and suppliers.

"Communication between the producer and the retailer is the most critical element in working towards a successful business relationship. Laying out clear

expectations from both sides and honouring each other in the agreement will lead to good business practices.

The producer is usually the initiator of the relationship between producer and retailer. The onus falls on the producer to understand his business

needs to start a successful production entity. The retailer is usually established in selling the proposed product and has to communicate their needs to the producer to ensure that the supply relationship starts correctly," he said.

Puttkammer said there were

certain factors which were key for the producer before they begin to seek a relationship with the retailer as this would increase the likelihood of getting that contract to supply goods for the retailer to sell at their shop.

"Producers should ensure they conduct sustainability research which involves the volumes need to be sold to maintain sustainability. This is important because if you fail then retailers will lose confidence in buying local," he said.

The manager further said producers should conduct adequate market research and ask questions to get the volumes requirements by the retailer.

"If you push the wrong product then you create dead shelf space and the retailer will lose trust in buying local. Another fact is that of production research which touches on issues of what input materials and resources are required to produce the product. Consistency is needed to build trust," he emphasised.

# Institutional investors urged to participate in stock exchanges


**QUANTUM United Consulting Engineers Projects Business Consultant, Bahabwa** Rushalika, says participation of institutional investors in stock exchanges should strongly be encouraged.

He said institutional investors such as pension funds, life insurers and mutual funds that operates in retirement savings system, should be at the forefront when it comes to the promotion of effective market practices and financial novelty in modern financial

"They are a source of long-term capital with investment portfolios built around the two main asset classes (bonds and equities) and an investment horizon tied to the often long-term nature of their liabilities. Institutional investors also reduce reliance on the banking system, acting as shock absorbers at times of financial distress," he said.

Rushalika said the growth of these institutions has also contributed to the development of capital markets, providing financing to companies and governments and helping to develop mechanisms for corporate control and risk management.

He said, however, beside their important role, there were con-

cerns relating to institutional investors.

"Such concerns include the fact that investment holding periods are declining and that allocation to less liquid, long-term assets such as infrastructure and venture capital are generally very low and considered less important by allocations to hedge funds and other high frequency traders.

Generally, institutional investors can act as a countervailing force to commercial and investment banks as well as other market intermediaries, forcing them to be more competitive and efficient. NSE stands to gain from high involvement of institutional investors on the stock

exchange," he said.

Collectively, pension funds in Swaziland have over E24 billion assets under management.

Recently the largest single individual investor in Swaziland the Public Service Pensions Fund (PSPF) said it has over E2 billion to invest in the country and agriculture could be a viable sector to invest in.

### Revealed

This was revealed by a senior manager of the fund during the Swaziland National Agriculture Investment Plan (SNAIP) investment plan high level meeting held at the Royal Swazi Sun Convention Centre, Ezulwini. "Out of the E6 billion in

investable funds that we have to invest in Swaziland, about E2 billion is yet to be invested and initiatives such as the SNAIP could provide an avenue for us to invest in. However, the projects need to be feasible so we can fund them," he said.

An institutional investor that has made significant investments in the Swaziland Stock Exchange (SSX) is private equity outfit private equity firm Greystone Partners, which has raised over E75 million on the exchange.

Financial Services Regulatory Authority (FSRA) recently announced that it intends to enforce a clause that will compel collective investment schemes to invest 50 percent of their assets under management in Swazi economy. FSRA Chief Executive Officer Sandile Dlamini said the Securities Act of 2010 stipulated that collective investment schemes should be investing 50 percent of their assets under management in the local economy which would include investments in the Swaziland capital market such as the SSX.

Currently collective investment schemes like unit trusts, hedge funds and private equity firms manage over E5 billion in assets.

These investment schemes ordinarily invest in the capital markets in both Swaziland and South

# '*Dvuladvula'* for public sector pensioners

PENSIONERS will be receiving their own increment from the Public Service Pensions Fund (PSPF) at their next pay day as the fund has increased their payments by seven percent.

"We are pleased to inform all pensioners that the ministry of public service, in consultation with the board of trustees, has approved a pension increase of seven percent for pensioners with effect from April 1, 2016," reads a statement sent by the Pensions Fund.

This would imply that the pensioner's payment would be backdated till April

The increase comes at a time when the Swazi economy was facing some inflationary pressure.

Currently Swaziland's inflation rate is at 7.4 percent and therefore, the increment of seven percent for pensioners is in line with the current price level rate.

### Payments

According to the PSPF annual report, the fund disbursed payments to active members totalling over 38 000.

"Of these members, 38 percent were dependants which included dependant beneficiaries including children and spouses of members who also receive a pension from the fund.25 percent were retirees, whilst 25 percent were suspended pensions," reads the report in part.

Suspended pensioners are those beneficiaries whose pension has been withheld because proof of life has not been veri-

# Gordhan probe will undo efforts to avoid downgrade - CEOs

JOHANNESBURG - The CEOs Initiative said it believes the Hawks probe into Finance Minister Pravin Gordhan will undo the work done to ensure economic growth and avoid a credit downgrade.

While the CEOs said they are encouraged by President Jacob Zuma's recent announcement of support for Finance Minister Pravin Gordhan, they also made a plea to the president to prioritise the country's economic growth in the "best interest" of the nation.

Following reports on the Hawks' probe into Gordhan, the CEO Initiative released a statement on Tuesday condemning the damage caused to the work done in the past eight months by business, labour and government to ensure economic growth and avoid a credit ratings downgrade.

"A continuation of political uncertainty would be disastrous for the future of our economy, especially given its fragile state at the moment," the statement read. "We are thus very disturbed and concerned by recent developments that undermine the work under way."

The CEOs believe that political uncertainty arising from the probe will increase the likelihood of a credit ratings downgrade in December. Most recently, the rand has taken a dip. # CAMPAIGN TO KILL TRUST IN ESKOM - NGUBANE

CAPE TOWN - There is a campaign to "kill trust in Eskom," Chairperson Ben Ngubane told Parliament yes-

Referring to claims of state capture regarding Eskom's contract with Gupta-owned Tegeta, Ngubane said the only state capture occurred when the National Party came to power in 1948.

He told the Portfolio Committee on Public Enterprise that Eskom is still dealing with prepayment contracts with five coal mining companies the NP government put in place 40 years ago.

"Those shareholders sitting in London have benefited on the sweat of our miners because of state capture," he said. "Let us be clear what we are talking about." He said Eskom does not want to renew these contracts, as that would enable it to draw up new contracts with black industrialists, small businesses and rural businesses to transform the mining industry.

This comes as Eskom handed over a document to Treasury on Tuesday evening, after the ministry said Eskom failed to cooperate with the process of reviewing the power utility's coal contracts.

"To date, not only has Eskom failed to honour its undertaking to submit comments to

Treasury's report, but it chose to ignore correspondence and put (up) all forms of hindrances,"> 11 National Treasury said in a statement on Monday.

The review relates to Eskom's coal contracts with Gupta-owned Tegeta, a company that has been

accused of state capture due to the Guptas' close links to President Jacob Zuma.

Ngubane said Eskom had given all the information National Treasury wanted. "Then they gave us a 172-page document and stipulated it be approved by the board," he said. "Our next meeting is on September 21."

CEO Brian Molefe said Eskom was simply trying to comply with Treasury's instructions to ensure the report was approved by the

With a clear gibe at Finance Minister Pravin Gordhan, who failed to meet the Hawks to receive a warning letter last week, Molefe said: "If Treasury had come to do a warning state-

# Trump's surprise trip before immigration speech

EVERETT - In a surprise move, Donald Trump was to travel to Mexico yesterday to meet with President Enrique Pena Nieto, just hours before the Republican delivers a highly anticipated speech on immigration.

Trump took to Twitter on Tuesday night to say he looks "very much forward" to meeting with the Mexican leader. Pena Nieto's office confirmed the meeting with its own tweet, saying the two men would meet privately. The unexpected trip comes as Trump seeks to clarify his stand on illegal immigration, a contentious issue that has been a centerpiece of his Republican presidential campaign. Trump has long called for deporting people currently living in the US illegally and building a wall along the country's border with Mexico. But in meetings recently with Hispanic supporters, Trump has suggested he could be open to changing the hardline approach he outlined during the GOP primaries. AFP

# Singapore urges tests for pregnant women with Zika signs

SINGAPORE - Singapore urged all pregnant women showing symptoms of fever or rashes to have themselves tested for the Zika virus yesterday after the number of cases in the city-state soared to 82.

Environment agency workers stepped up efforts to eradicate mosquitoes that spread the disease, expanding a fumigation campaign centred on the "ground zero" of the outbreak, the eastern suburb of Aljunied.

As infections climbed, they blasted a district of warehouses and industrial buildings to destroy breeding sites that fuelled the outbreak, which began at a construction site housing foreign workers.

Zika, which has been detected in 58 countries including hardest-hit Brazil, causes only mild symptoms for most people, such as fever and a rash.

But in pregnant women, it can cause microcephaly, a deformation in which babies are born with abnormally small brains and heads.

The health ministry said "all pregnant women in Singapore with symptoms of Zika — fever, rash and other symptoms such as red eyes or joint pain" should be tested for infection.

Pregnant women with male partners who have tested positive were also told to visit their doctors, *AFP* 

# Obama cuts sentences of 111 inmates

WASHINGTON –
President Barack Obama
on Tuesday commuted the
sentences of 111 drug
offenders and other
inmates, setting a record
for such White House
moves in a single month.

The latest grants came on top of 214 early releases Obama agreed to earlier this month, for a total of 325 in August.

Obama, whose second term ends in January, has trimmed 673 prison sentences since coming to office in 2009 more than the previous 10 presidents combined.

The president is thus making good on his call for sec-

ond chances in the US penal system.

Prisoners benefiting from these shortened sentences are supposed to no longer present a threat. Most were lowlevel drug dealers who were facing heavy sentences due to a penal system critics say imposes excessive sentences for such crimes.

About a third had been handed sentences of life in prison.

The move is part of Obama's effort to push ahead with criminal justice reform.

The United States currently has among the world's highest incarceration rates and puts a disproportionate num-

ber of black and Hispanic Americans behind bars.

One often cited reason are mandatory sentencing laws for the use of crack that are tougher than those for cocaine.

# PRESIDENTIAL VOTE DELAYED IN ESTONIA

TALLINN – Estonia's divided parliament failed on Tuesday to elect a successor to two-term liberal President Toomas Hendrik Ilves, delaying the choice until September 24.

The head of state plays a largely ceremonial role in the Baltic NATO country of 1.3 million people and is elected by parliament or Electoral College rather than direct public vote.

They will now face the vote of the 347-strong Electoral College on September 24, made up of parliamentarians as well as local representatives

where they will need just a simple majority to win.

"Everything is still open and up for grabs," Andres Kasekamp, a professor of political science at Tartu University told AFP on Tuesday.

Former prime minister and EU commissioner Siim Kallas and the opposition Centre Party candidate Mailis Reps both failed to secure the required two-thirds majority in the 101-seat parliament following two rounds of voting.

Kallas, a liberal and cofounder of the governing Reform party, scored 42 votes while the left-leaning Reps took 26.

It is unclear whether Reform Prime Minister Taavi Roivas will keep his promise to nominate popular Foreign Minister Marina Kaljurand to run in the Electoral College round.

Presidents can remain in office for up to two consecutive five-year terms.

Although his standing as a Reform Party founding father gives him strong backing among the group's old guard, Kallas is still haunted by a murky party funding scandal dating back to the late 1990s.

# State crucial to peace - ex-spy chief

JERUSALEM - The former head of Israel's Mossad spy agency on Tuesday said the establishment of an independent Palestinian state is crucial to region-wide peace in the Middle East, joining the ranks of retired security men to urge the government to seek a two-state solution. The comments by Tamir Pardo were his first foray into political issues since stepping down as Mossad chief early this year. With peace efforts with the Palestinians stalled for more than two years, Prime Minister Benjamin Netanyahu has instead sought to cultivate alliances across the Arab world. In addition to the decades-old peace treaties with Egypt and Jordan, Netanyahu frequently boasts of what he calls strong behind-the-scenes contacts with moderate Sunni countries, presumably Saudi Arabia and smaller Gulf

# Vowing to 'transform' France, Macron quits

PARIS - France's Emmanuel Macron vowed after stepping down as economy minister on Tuesday to "transform" an ailing country, but stopped short of declaring a presidential run. The 38-year-old said he had "seen at first hand the limits of our political system" and that quitting the government of President Francois Hollande would enable him "to be free" to push forward his own agenda. With elections eight months away, the former investment banker said: "I am determined to do everything so that our values, our ideas, our actions can transform France as soon as next year". AFP

# Refugee jailed six years for setting fire

STOCKHOLM - A Swedish court on Tuesday jailed a Syrian national for six years after he admitted to setting fire to the asylum seekers' hostel he had been staying in. Although it caused no injuries, the July 7 fire caused extensive damage to the centre in Surahammer, in the southeast of Sweden. Obada Albaradan, 28, arrived in the country in August 2015 and was treated for depression and epilepsy. He said he had started the blaze by setting fire to the curtains in his bedroom. Under police questioning Albaradan complained of serious mental health problems, of not being listened to by the authorities, not getting on well and being insulted by other asylum-seekers. AP

# Chinese 'killer' becomes temple abbot

BEIJING - A suspected murderer on the run for 16 years in China found refuge in Buddhist temples, eventually rising to become an abbot, state media said yesterday. Zhang Liwei was detained by police earlier this month on suspicion of stabbing three people to death with accomplices in 2000, the Beijing News reported. After the killings in his home province of Heilongjiang, deep in northeastern China, Zhang fled nearly 2 000 kilometres (more than 1 000 miles) south to Anhui, changing his name and finding work as a temple cook and ticket-seller, it said.

CARACAS – Venezuelan President Nicolas Maduro vowed Tuesday to jail opposition leaders if they incite violence at upcoming protests to pressure authorities to allow a referendum on removing him from power. Maduro, whose opponents blame him for a devastating economic crisis, accused opposition leaders of plotting a "terrorist coup" against him ahead of today's nationwide protests. "We must defeat the coup d'etat without impunity. Whoever gets involved in a coup plot, or calls for violence, is going to jail, sir". AFP

# Man gets 15 years for attempted rape, attempted murder

JOHANNESBURG – A 32-year-old man was sentenced to 15 years in prison for attempted rape and attempted murder in the Mdantsane Magistrate's Court, Eastern Cape police said on Tuesday.

# ANC Western Cape 'ill discipline' criticised after conflicting Fransman statements

CAPE TOWN – A "caretaker" to the Western Cape ANC, appointed earlier in the year by the national executive committee (NEC), on Tuesday spoke out about confusion created by two conflicting statements from the party.

Dipuo Letsatsi-Duba said she had been made aware of a statement issued by the provincial secretary on Monday night, and a subsequent one by the former convenor of the ANC's provincial executive committee (PEC) sub-committee on media and communications.

She was assured that the statement issued in the name of secretary Faiez Jacobs was "factually correct and reflected accurately" the decisions of the PEC meeting on Sunday. Jacobs's statement said the ANC wanted disciplinary procedures against its Western Cape chairperson Marius Fransman to be expedited, and that he be suspended pending the outcome.

"The caretakers should recommend to the NEC that Comrade Marius be suspended until the conclusion of the disciplinary processes," the statement read.

Fransman had to step aside after he was accused of sexually harassing 21-year-old Louisa Wynand. They were on their way to the party's January 8 celebrations in Rustenburg at the time.

Fransman has denied the allegations. There have been suggestions that he was set up, which Wynand has denied.





# Nine top officials sacked after Dubai ruler holds impromptu desk inspection at 7:30am and finds lots of empty seats.

DUBAI - Dubai's ruler has ordered a shake-up of the city state's management, including the retirement of nine senior officials, a day after he conducted a surprise spot check of government offices at 7.30am and found a significant number of employees absent.

On Sunday, his government posted a video on Instagram of him making an unannounced visit to the Land Department and Department of Economic Development office and finding it empty, an exercise which a Dubai media official said was intended to "send a message". Sheikh Mohammed bin Rashid al-

Maktoum casually wandered around the deserted office with empty seats, picking up an employee's book and flicking through it.

The visit should not have caught so many people out as Sheikh Mohammed is known for his earlymorning inspections "to ensure government services are up to Dubai's globally admired standards."

In Dubai, public sector workers usually work from 7.30am to 2.30pm, while in the private sector usual business hours are from 8am to 1pm, resuming after the temperatures have begun to cool from 4pm.

In the video posted online, the

leader then goes on to inspect Dubai's airport - thankfully finding immigration officers were in place.

### Finances

Governments around the Gulf are trying to make their bureaucracies more efficient as low oil prices pressure state finances, and the move by Sheikh Mohammed is one of the most dramatic efforts in that direction so far.

He ordered the retirement on Monday of nine members of Dubai Municipality's executive management, including directors and assistant director-generals in departments such as legal affairs and planning, the United Arab Emirates' state news agency WAM reported.

Some of those sacked include Abdul Qader Al Jasmi, Director of Legal Affairs, Deputy Director General Eisa Al Maidoor and assistant Director General for corporate support Mohammad Abdul Karim Julfar.



# Opposition vows to discard Islamists

RABAT - The main opposition party PAM has vowed to "liberate" Morocco from the scandal-tainted ruling PJD Islamist party as the country gears up for campaigning ahead of a crucial October election. The liberal PJD - Justice and Development Party - has led a coalition governing the North African kingdom since late 2011 but faces growing opposition from its rival, the Authenticity and Modernity Party. It is expected to have to fight for its survival on October 7, particularly after a spate of scandals. AFP

### Rwanda-Burundi border withers

BURUNDI - "Before, at this time of year, we imported beans from Burundi but now they say they don't want to sell their crops to 'the enemy'," said Evariste Ndikumana, a trader on the Rwandan side of the border. Worsening relations between Burundi and Rwanda mean the once-bustling border town of Akanyaru is suffering, hitting the economies of both countries. Always awkward neighbours, Rwanda and Burundi have fallen out since a domestic political crisis enveloped Burundi in April last year, while spiteful policy-making in Bujumbura has made a bad situation worse. In Akanyaru, bored traders and mobile phone scratchcard vendors kill time on a low wall beneath a shady awning. AFP

# GDP contracts by 2.06% in Q2

LAGOS - Nigeria's gross domestic product (GDP) contracted by 2.06 percent in the second quarter, the statistics office said yesterday, sending Africa's biggest economy into a recession after a decline in the first quarter. The Nigerian Bureau of Statistics (NBS) said the non-oil sector declined due to a weaker currency while lower oil prices dragged the oil sector down. Output shrank by 0.36 percent in the first quarter. Nigeria is in the midst of an economic crisis triggered by a slump in crude prices, its mainstay, which has hammered public finances and the naira and caused chronic dollar shortages. Crude sales accounts for around 70 percent of government revenues.

I'll be meeting with developers and entrepreneurs, and learning about the startup ecosystem in Nigeria. # REBELS CLAIM ATTACK ON STATE-OWNED PIPELINE

WARRI - Nigerian rebels claimed a Tuesday attack on a state-owned oil pipeline and accused the military of "endlessly harassing" the country's south as they vowed to intensify their campaign of sabotage.

The newly formed Niger Delta Greenland Justice Mandate (NDGJM) group said in a statement that they attacked a Nigerian Petroleum Development Company line in the southern oil-producing Delta State in the early hours of Tuesday.

The NDGJM brought down the Ogor-Oteri major delivery line," said the militants. "Good job

A Nigerian state security official confirmed the attack to AFP, saying: "I can't give you much detail on the incident as investigations into the incident are still ongoing."

The NDGJM militants said that they do not recognise the ceasefire declared this month by the Niger

Delta Avengers, a rival armed group in the region, or its ongoing negotiations with the Nigerian gov-

The group also criticised the Nigerian military for its operations in the Delta's restive swamplands.

"The NDGJM will no longer sit quietly watching the endless harassment of our peoples in various parts of the region by the Nigerian military," said the group.

"It shall from now on be an eye for an eye, for every military atrocity carried out in the creeks... the Nigerian armed forces will have the NDGJM to contend with."

Last week the Nigerian military launched "Operation Crocodile Smile" in the oil-hub of Warri claiming to have killed five militants and arrested 23 others in a weekend raid. An amnesty programme introduced in 2009 brought peace to the Niger Delta after years of attacks crippled crude output. Yet when Nigerian President Muhammadu Buhari indicated that he would wind down the costly programme in an effort to trim government spending violence once again erupted in the

Groups including the Niger Delta Avengers and the NDGJM are demanding a greater share of oil revenues and political autonomy. Their attacks have hampered oil exports and damaged Nigeria's fragile economy. AFP

# 816 African migrants held in 2 months

KHARTOUM - At least 800 African migrants and a group of smugglers were arrested near Sudan's border with Libya while trying to reach Europe between June and August, security officers told reporters Tuesday.

Between June 27 and August 16, security forces arrested 816 African migrants attempting to enter Libya, senior army and police officers said.

They included 347 Eritreans,

130 Ethiopians and 90 Sudanese. Ten smugglers were also arrested on August 16 after clashing with security forces near the bor-

"An officer and two soldiers were killed in the firefight," army General Aseer Hussein Bashir told a press conference at the defence ministry in Khartoum.

"These people will face legal charges, after which they will be deported," police General Awad Dahia said of the migrants who were detained. AFP

# TUNISIA'S NEW UNITY **GOVT TAKES OFFICE**

**TUNIS - A new Tunisian unity** government took office on Monday in the birthplace of the Arab Spring, with Prime Minister Youssef Chahed, the country's youngest-ever leader, facing major economic and security challenges.

Chahed, who turns 41 next month, becomes the former French colony's seventh prime minister in less than six years, following a 2011 revolution that ousted strongman Zine El Abidine Ben Ali.

His new cabinet of 26 ministers and 14 ministers of state includes women, young and independent ministers, three members of the

Islamist Ennahda party and two former members of the powerful UGTT union.

The interior and defence ministers were kept on, in a show of faith for having restored calm after a string of spectacular jihadist attacks last year.

### Handed

It formally took office at a ceremony in Carthage just outside Tunis during which outgoing premier Habib Essid, 67, handed over power.

"I hope this government will last," Essid said. "The worst thing for this country is the government changing ever year or year and a half." AFP

# Egypt parliament adopts disputed law on churches

CAIRO - The Egyptian parliament on Tuesday adopted a law on regulating the construction of churches, despite opposition by some members of the Christian community which complains of discrimination.

Egypt's Copts, the Middle East's largest Christian minority, have long struggled to obtain official permission to build

places of worship.

They find it especially difficult to erect churches south of Cairo, where even the rumour of Christians building one can spark mob violence.

"The parliament adopted the bill presented by the government for the construction and restoration of churches by a two-thirds majority," the parliament's website reported. AFP



# CHELSEA MOVE FOR LUIZ EDGING CLOSER

LONDON - Chelsea's move for David Luiz is edging closer and is set to be sealed before the end of the transfer window.

Antonio Conte's side had a £30million bid rejected but were expected to go back with another offer before the window closed last night.

Luiz left Chelsea for Paris Saint-Germain in 2014 for £50million and the Blues will need to edge up their bid to £32million to seal the return of their former defender.

They also enquired about Luiz's PSG team-mate Marquinos.



# Venus scrambles into second round

NEW YORK - Venus Williams battled into the second round of the US Open on Tuesday, grabbing a slice of Grand Slam history along the way with her 72nd main draw appearance in a major.

On the same day that younger sister Serena was due to launch her bid for a record seventh US Open title - and a record-setting 23rd Grand Slam crown - the elder Williams broke the Open Era mark she had shared with Amy Frazier for most Grand Slams contested.

The 36-year-old Venus, enjoying something of a resurgence in a 2016 season that includes a WTA title in Taiwan, survived 63 unforced errors in a 6-2, 5-7, 6-4 victory over 22-year-old Ukrainian Kateryna Kozlova, who has risen more than 80 spots in the world rankings since February to her current number 93.

"The errors told the story today," said Williams, whose aggressive game also produced 46 winners. "I'm going to try to change that for the sec-

ond round."

The match closed out the afternoon action on the Arthur Ashe stadium court, setting the stage for a block-buster night that included Serena's first-round clash with Russian veteran Ekaterina Makarova and second-seeded Andy Murray taking on Czech Lukas Rosol.

Serena's Wimbledon triumph in July saw her equal Steffi Graf's Open Era record of 22 major titles.

She has won four of five encounters with Makarova, including two US Open matches against the Russian

left-hander.

Murray is bidding to become the fourth man in the Open Era to reach all four major finals in a calendar

Since capturing his second Wimbledon title Murray has gone on to defend his Olympic gold in Rio.

Murray has downplayed any grudge match aspect to his clash with Rosol, who provoked an angry outburst from the Briton when they met in the quarter-finals at Munich last year.

In other early matches, third-seeded Swiss Stan Wawrinka, a two-time semi-finalist, reached the second round with a 7-6 (7/4), 6-4, 6-4 win over Spain's Fernando Verdasco.

"I'm really happy," Wawrinka said after evening his career record against Verdasco at three wins apiece.

"Fernando is a tough player to play. He can be really aggressive. He doesn't give you so much rhythm, so it's not easy."

Kei Nishikori, who became Asia's first men's Grand Slam finalist in New York in 2014, when he fell to Marin Cilic in the final, also advanced, downing German Benjamin Becker 6-1, 6-1, 3-6, 6-3.

"It was a great feeling of course," said Nishikori, whose breakthrough run in 2014 was followed by an abrupt first-round exit last year.

"I have great memories here and I always love coming back to New York."




