

PUBLIC ORDER BILL SAYS NO TO POLITICAL PARTIES

THE portfolio committee of the prime minister's office says the Public Order Bill, 2016, does not legitimise political parties and it has no intention of allowing political parties to exist.

The committee, led by appointed MP Thuli Dladla, responding to concerns from stakeholders, said even the national constitution did not provide for political parties.

The portfolio committee's report said the constitution, instead of providing for political parties only made reference to political associations or organisations.

The concern raised to the PM's portfolio committee was in a form of a question relating to the definition of 'gathering' provided for in the Bill. The concern was whether the Bill would not provide a leeway of allowing political parties or was this law legitimising political parties.

The Public Order Bill, currently being piloted in parliament, is reportedly aimed at balancing the core societal interest of the public order on one hand, and freedom of assembly The committee, led by appointed MP Thuli Dladla, responding to concerns from stakeholders, said even the national constitution did not provide for political parties

SPECIFICALLY, THE BILL SEEKS TO PROMOTE AND PROTECT PUBLIC ORDER, PUBLIC HEALTH, PUBLIC SAFETY AND PUBLIC MORALS

- Give effect to the fundamental rights of freedom or peaceful assembly, and freedom of expression as embodied in the constitution of the Kingdom of Swaziland;
- Provide for notification and consultation in respect of public gatherings:
- Provide for regulation and where necessary, prohibition of public gatherings and public events;

■ Delimit and regulate the powers of

and expression, on the other.

MP Dladla's committee reported that government believed the best possible balance between those competing interests had been achieved.

Dladla said a law of this nature was always not easy to come up with in view of the fact that it must ensure in its content and spirit that while granting others their rights, it should also ensure reasonable limitation to the exercise of those rights in order to protect the rights of others.

PM says Public Order Act of 1963 violated constitution

PRIME Minister Sibusiso
Dlamini says the Public Order
Act of 1963, has been found to be
inconsistent with the country's
constitution because it infringed
on the rights to freedom of
assembly, expression and associ-

Making his preamble to the portfolio committee that sought public submissions of the amendment of the Act, the prime minister said the supervisory structures of the International Labour Organisation (ILO) had also drawn to the country's attention that the existing Act was not compliant with ILO Conventions, particularly Conversion 87 and 8 which related to the right to freedom of association and the right to organise and conduct collective bargaining. The prime minister reported that, subsequently, an ILO consultant was duly commissioned to review the country's legislation that impacted on ILO Convention 87 on the Freedom of Association and Protection of the Right to Organise.

In his report of 2011, the consultant recommended that: "the Public Order Act should be replaced by a new legislation that clearly delineates a clear procedure for apply for the holding of public gatherings. This legislation should be consistent with the relevant constitutional provisions, protecting rights such as freedom of association, and should clearly delineate the functions of local authorities, the courts and the police."

Following that recommendation by the ILO consultant, government



through the portfolio committee, has been meeting various stake-holders trying to come up with a piece of legislation that would conform to the requirements of the ILO conventions.

It is hoped that this would help the country to gain its lost AGOA controlled market in the United States of America.

Some legislators said the drafters of the Bill, however, have made it so difficult for organisations seeking to stage protest marches such that they would be forced to do so outside the country.

Both in the House of Assembly and Senate, they noted that it was near impossible to obtain a compliance certificate.

A compliance certificate would be issued by a local authority to a group of people in excess of 15 or organisations who had, within seven days given notice to the authority that they want to have a gathering. The certificate would be issued after the applicant has satisfied all the required conditions and after every stakeholder or interested party has agreed on the sought gathering.

Sections of Bill unconstitutional - CANGO

The Coordinating Assembly of Non-Governmental Organisations (CANGO) says there can be no question of prohibiting public gatherings as this contravenes the country's constitution.

The organisation said such an act amounted to a contravention of Section 25 of the country's Constitution and could not hold to be 'reasonably justifiable in a democratic society'.

The organisation, making its submissions to the prime minister's portfolio committee on the Public Order Bill, said the section purporting: "To give effect to fundamental rights or freedom of peaceful assembly and freedom of expression embodied in the Constitution of the Kingdom of Swaziland:" in the Memorandum of Objectives and Reasons in the Bill should be deleted.

CANGO argued that the Constitution itself was sufficient for the effect of these rights and there was no need for any legisla-



tion to be enacted for this purpose, and more so because the constitution was the supreme law of the land.

CANGO further argued that it was wrong for government to make the Public Order Bill, 2016: "To provide for the regulation and prohibition of public gatherings and public events". Their argument is that the Urban Government Act has sufficient provisions to regulate notification and consultations and, should there be a need, the said Act may be amended accordingly. On

the part whereby the Bill purportedly seeks: "To delimit and regulate the powers of the police during gatherings", CANGO argued that such and other regulations pertaining to police conduct fell within the Police Act. They noted though that this object was necessary, particularly in view of that the police had over the years allegedly used undue and unnecessary force to disrupt, disperse and stop public gatherings. To give effect to that, CANGO recommended an amendment of the bad existing law and policies and not coming up with the Public Order Bill, 2016.

The organisation also decried that a section of the Bill granted the minister, in this case Prime Minister Sibusiso Dlamini, wide powers in formulating the Code of Good Practice without consultations.

The organisation said the Code should be formulated through a process of consultation and consensus with various stakeholders including the public.

CHIEFS CAN OBJECT GATHERINGS IN THEIR CHIEFDOMS

THE prime minister's portfolio committee says chiefs can object the holding of public gatherings within their chiefdoms.

The portfolio committee made the statement in response to a concern by stakeholders during the consultations conducted on the Bill.

On a question relating to the Bill providing for a local authority but not explicitly mentioning chiefs, several chiefs in Senate raised concern, questioning why their role was not stated in the Bill yet they regarded themselves as local authorities.

The chiefs, however, did not want to be mentioned under the general term, 'local authority'

but wanted to be clearly mentioned in the law as chiefs.

Omitted

The committee stated that chiefs were deliberately omitted to protect them by not including them in the notification process to obtain the compliance certificate by people or organisations seeking to stage gatherings or protests marches.

The responsibility was given to regional administrators although chiefs retained the right to object to the public gatherings within their chiefdoms.

The portfolio committee's report stated that the police national commissioner should make it his priority to protect the chiefs in this regard.

Govt now sponsors Gwamile VOCTIM

GWAMILE VOCTIM has now been listed as one of the institutions that will be fully sponsored by the government.

The acronym VOCTIM stands for Vocational Training Institute Matsapha.

The vocational training institute will join the likes of the University of Swaziland (UNISWA), Swaziland College of Technology (SCOT), Limkokwing University of Creative Technology (LUCT), Southern Africa Nazarene University (SANU), Swaziland Christian University (SCU), William Pitcher Teacher Training College, Ngwane Teacher Training College, and Good Shepherd Nursing College.

This was disclosed on Monday by Minister for Labour and Social Security Winnie Magagula during the labour programme that usually airs on Mondays on the Swaziland **Broadcasting and Information** Services (SBIS).

The scholarship programme is under the ministry of labour and social security, under the department of national employment services. Magagula said government roped in Gwamile VOCTIM because it wanted to make sure that it improved production on vocational training.

"The aim of the government now, going forward, is to produce graduates who will be job creators, not job seekers," Magagula said. Magagula did state that there were other institutions like Limkokwing that did the same thing as Gwamile. She said roping in Gwamile was meant to add on what the other institutions were doing.

Magagula said the addition of the college was in line with what government wanted to achieve in terms of development.

She said the health and education sectors took a bigger portion of the budget of the nation.

"Right now, government wants to prioritise health and education, followed by agriculture.

The minister said it was actually in the plans of government to help all Swazi students.

However, for now, the government prioritised health and education. She said government wanted to ensure that the nation was educated and healthy so that it could be able to produce food through agriculture.

Then the social sciences would then make sure that people would be able to manage the products that would be produced by the people who would be educated and healthy.

Magagula said the scholarship selection board was now at the stage whereby the selection of the students was done. The only thing that was left for them was to send the list of the students back to the institutions mentioned above.

These are the students that would be funded by the government in the form of scholarships.

No stationary for UNISWA students

HARDLY a week after commencing their academic year, University of Swaziland (UNISWA) students cannot buy books.

UNISWA students usually get all their books and stationery from the book shop in order to be able to go on with their lessons.

The government, through the ministry of labour and social security, usually pays for the books and stationery expenses for government sponsored

UNISWA Students Representative Council (SRC) President Brian Sangweni confirmed the sad state of affairs currently faced by the students.

"It is true that students cannot get books and stationery at the bookshop," Sangweni said.

He said this made the situation diffi-

cult for the students, more especially because they accessed almost all their learning tools at the bookshop.

Sangweni stated that they tried to engage the university on this issue. They did this in an effort to find a long lasting solution to the problem so that the learning processes could be easy for the students in the university.

When asked why they engaged the university instead of the ministry of labour and social security, Sangweni said they did so because there was an arrangement in place between the university and the ministry.

He said the university would fork out money to the bookshop as payment for the books and stationery costs for the students. Sangweni said the ministry would then pay the money to the university. Sangweni said the university promised them that the issue would be solved by tomorrow.

Government sponsors 11 000 students

GOVERNMENT, through the ministry of labour and social security, sponsors 11 000 students. This was disclosed on Monday by

Minister for Labour and Social Security Winnie Magagula. She said this during the labour programme that is broadcast on Mondays on the Swaziland Broadcasting and Information Services (SBIS).

Magagula said this in reference to some situations whereby students take time to receive their allowances. This usually happens almost every year. Magagula admitted that the year. were there. She stated that such would happen because the communication of information to the students would be poor,

"In any given institution, we usually make use of the structures that are in place to transmit information among all the people in those institutions. When students have problems, they should inform Deans of Student Affairs," Magagula said.

She said this was done because the ministry was communicating with the institutions on matters pertaining to the welfare of the students. She said at any given time, they had over 11 000 students. Usually, the minister said, they had cases of about 3 000 students.

"These are the students who are usually experiencing the delays in getting their allowances. It is unfortunate that to people, it is thought that all the students are affected. Right

CTA compound goes up in flames

THE Mbabane city was on Monday covered in smoke as the compound of the Central Transport Administration (CTA) went up in flames.

The situation was so serious that more than three motor vehicles were almost burnt by the raging fire.

The cars were rescued by fire fighters who were called to the scene to put out the turbulent fire.

It is worth noting though that one of the three cars, a Ford Bantam, was rescued by members of the public, who pushed it away from the scene where it was in danger of being burnt.

Supreme

Confusion reigned supreme after the fire fighters arrived at the scene. As they were putting out fire behind the garage, other parts of the compound would be up in flames, with no fire fighter in sight to put out the fire.

This happened three times, as three vehicles almost got burnt. These included the abovementioned Ford Bantam, a Toyota Hilux belonging to government, and another black sedan.

The cars could not be removed because their owners were nowhere in sight during the incident. The Toyota Hilux belonging to government could not be moved because its keys seemed to have been misplaced. This forced the fire fighters to reinforce their

resources at the scene as more fire engines were eventually seen at the scene. At first, there was only one truck, but after sometime, they were about four. At this time, people were heard shouting on top of their voices, calling upon the fire fighters to put out the

fire that had a potential of burning the cars and some tanks that are restoring fuel within

Some cars had to be driven out of the compound to prevent the fire, which was fast approaching the parking area of the CTA.

Fire Services arrive late at scene

SWAZILAND National Fire Services personnel were blamed for arriving late at the scene of the incident on Monday.


Some people even blamed the fire fighters for taking about an hour to arrive at the scene. The fire fighters came under heavy criticism for arriving after such a long time at the scene According to some CTA employees interviewed during the incident, they said it took the fire fighters more than an hour to come to the scene. "The fire could have been controlled if they had responded early," an employee said.

He said they had to risk their lives and remove some of the cars from the scene. even stating how dangerous it was since some of the cars had already caught some fire underneath.

"The fire started from that mountain on the other side of the river. We called the firefighting personnel to help but they came after an hour while they are right in town. How do you expect them to help those in distant places?, one member of the public was heard commenting.

Another person, believed to be working at the CTA said the fire personnel were called, but they said they had no trucks at the moment. He said the fire engines had gone to attend similar incidents in some places. As a result they brought a smaller fire engine which failed to rescue the situation as the fire was huge. Royal Swaziland Police were applauded by some employees of the CTA for responding timely to the scene to control traffic along the CTA street.

Cop stabber arrested, slapped with 3 counts

THE man who was reported to have stabbed an on-duty police officer has since been arrested and slapped with three counts.

Sebenele Maziya appeared before Senior Magistrate Donald Mavuso, where he was represented by Kush Vilakati Attorneys.

On the first count, the accused was charged with assault with intent to cause grievous bodily harm.

He is said to have wrongfully and unlawfully assaulted Constable Lihle Shabangu by stabbing him with a knife on the left shoulder.

The incident is said to have happened last Tuesday near the Siteki Police Station.

Sebenele Maziya appeared before Senior Magistrate Donald Mavuso where he was represented by Kush Vilakati Attorneys.

On the second count, the accused was charged with obstructing the course of justice, in that he wrongfully and unlawfully obstructed the officer from his duty, by insulting him and further accusing him of not being capable to investigate criminal activities properly.

The officer who was in the company of his colleagues is said to have been on his way to investigate a case of a house breaking, when he was confronted by the accused person.

This incident is said to have caused the officer to abandon his duty and go seek medical attention after he was stabbed by the accused.

On the third count, the accused is charged with contravening section 43(1) of the Criminal Pprocedure and Evidence Act 7 of

1938.

He is said to have resisted arrest by the same officer, whom he eventually stabbed. During his appearance before the court, he was not asked to plead to the charges.

He successfully applied for bail which was fixed at E1 000,

Meanwhile, information gathered was that the accused person had numerous grievances against the police.

He is said to have been at loggerheads with the same officer for a long time, as he accused him of frustrating every case which he would report to the police.

One particular case was that of a six-yearold boy who was reported to have been accidentally shot by his grandfather while in the forest for hunting.

The boy was a son to the accused person in the stabbing case.

Maziya had accused the police of failing to conduct proper investigations on the events

which led to the said accidental shooting.
Maziya also accused the stabbed officer of causing a break-up between him and his

girlfriend earlier in the year.

The eventual stabbing incident is said to have therefore been a result of the numerous grudges which the accused had against the police and the particular officer.

Arrested boarding master also a pastor

THE suspended boarding master of Mpaka High School, who was arrested for allegedly having illicit bedroom games with a pupil, is also said to be a pastor.

Mabuya Mark Dlamini was arrested in 2014 and charged with rape.

According to the charge sheet, the accused person is alleged to have wrongfully, unlawfully and intentionally had sexual intercourse with a pupil of the school, while employed as a boarding master.

The crime is said to have been committed at the school's boarding facility.

The matter was back in court for trial on Monday.

During the trial, the complainant narrated how the accused person known as a respected man of God, would at times preach to them.

She stated that on this fateful day, he had promised to come and pray for her after she was left alone at the boarding facility, which was a few metres away from the boarding master's house.

Attacked

She said the accused gave her a cellphone so that she could call him during the night, in case she was attacked by anything, in which case, he could come to check on her. The complainant said, however, she had a nightmare which terrified her such that she called the boarding master to come and pray for her while it was already after midnight.

She said however, the accused started fondling her after arriving at the room in which she was sleeping.

The accused is said to have further proceeded and committed the said offence without the consent of the complainant.

The complainant said the accused then asked her not to tell anyone about the incident, promising to provide her with whatever she would ask for.

The complainant said however, she reported the incident to her aunt the following day. She was subsequently taken for a medical check-up after the matter was reported to the police. Of note is that the accused person also mentioned on several occasions before the court that he was a respected preacher.

Apparently, he has pleaded not guilty to the charge. The matter was then postponed to November 9, for continuation of trial.





'Doors Are Open' saga: Swazi pastors now wanted out of SA

FOLLOWING the recent reports of controversial Pastor Mandla Mhlanga, who is famously known in the country as 'Doors are Open', offering to pray for people's successes and other social problems at a fee of E250 up to a maximum of E5 000, some Swazi pastors based in South Africa are now facing rejection from their congregations.

A pastor who wanted to remain anonymous said since the reports was published by South African Publication ILANGA newspaper last week, his congregation has lost faith in him and was questioning his authenticity.

He said his congregants were now accusing him of being after their hard earned money and saying he was not concerned about salvation just like his countryman Mhlanga.

Salvage

"Trying to salvage the situation, I together with other pastors went to try and calm things in his church in Nondabuya in Jozini, but we were met with insults and threats by the community.

The community members said they did not want anymore Swazi pastors in their community, saying we are corrupt, hungry, poverty

stricken and using the gospel of Jesus to defraud them of their monies.

This did not sit well with us since some of us are committed men of God, committed to the gospel and to have someone tainting our name in that manner is not good," he said.

The pastor said the angry community said Swazi pastors must come and collect Pastor 'Doors are open' from South Africa so he can do his shenanigans in Swaziland, not in South Africa.

He further said they had learnt that a handful of congregants had already left the church save for a few. He, however, said some of his congregants defended Mhlanga

relentlessly saying everything that was published by the ILANGA Times was not true while others were baying for his blood.

He said what surprised them was that the congregants that defended Mhlanga were young women in the

He further revealed that amongst the young women who were fighting for Mhlanga's innocence was one young woman who is said to be betrothed to Mhlanga.

Engaged

"They got engaged last year and Mhlanga was set to pay the bride price but nothing has happened ever since," he said.

The sources further revealed that

when the rumours about Mhlanga's shenanigans started, the community set his church 'a tent' alight trying to get rid of him in the area but he did not budge.

Mhlanga stands accused of making money from unsuspecting church members and members of the public by offering to pray for their successes and other social problems at a fee of E250, up to a maximum of E5 000.

Alleged

It is alleged by the South African newspaper that Mhlanga also sells a lucky juice costing E50, which he tells his congregation to drink and further use to bath so that they can have good luck in whatever they do.

Mhlanga is also alleged to be selling branded T-shirts with his name on them at a fee of R250, the Tshirts according to the reports are said to bring luck on whoever wears them. Among the series of allegations brought against the pastor is that when he goes to different places where he offers prayer services where he charges E5 000.

POLICE RECRUITS TO PASS OUT SOON - COMMISSIONER

POLICE recruits are expected to pass out either this month or next month.

The recruits are those who were admitted to the police college last vear. It had initially been reported that the recruits were to spend a period of two years while undergoing vigorous training exercise at Police College in Matsapha.

However, National Commissioner of Police Isaac Magagula assured them that they would pass out this year. He said this during a press conference at the police headquarters, where he was thanking Imbali from the Royal Swaziland Police (RSP) for

showing a good behaviour during the recently-ended Umhlanga cere-

Many of the maidens who took part at the ceremony are still undergoing training at the police college.

"It has come to our attention that many of you are now asking yourselves if you will be able to pass out this year. Some are said to be very anxious as they look forward to pass out and be deployed to your working stations. I must say that you will pass out this year, probably this month or next month, depending on the month the authorities will approve," Magagula said.

However, this is contrary to the previous intake which took two full years at the college before they passed out. Initially, the police had said it would now take two full

...this means the new recruits will only train for less than a year at the college, unlike the previous group which trained for two full years.

years for recruits to pass out at the college as they had changed the syllabus.

His pronouncement was met with excitement from the maidens as they clapped hands with passion, while shouting in jubilation, saying "Thank you, Sir!" They did this to show that they were happy and relieved to hear such good news.

However, Magagula warned the girls that they would have to make sure that they took care of themselves because failure to do so would result in them being dismissed.

She told the maidens that rowdy

behaviour from them would mean they were selfish and ill-disciplined because they would have prevented other Swazis who could not get admission into the police service. "This means you prevented many other Swazis who wanted to work diligently for the country and that would be very painful to them," he

The national commissioner said it was painful for him to dismiss police officers for bad behaviour. He wished that the recruits would all pass out to maintain the number of police they wanted from the start. "You came here wanting to

cooperate with the Royal Swaziland Police (RSP) in safeguarding civilian life and property. We expect you to do just that. If you are to cooperate with us by committing crimes, you will have to leave us in peace," he said.

Police looking after Imbali on behalf of chiefs'

THE Royal Swaziland Police (RSP) cooperates with princes and chiefs, who are in charge of chiefdoms across the country.

National Commissioner of Police Isaac Magagula said this during a press conference at the police headquarters in Mbabane.

The commissioner had called the press conference to thank Imbali from the RSP for showing good behaviour during the recently-ended Umhlanga ceremony.

Magagula said they did not dispute the fact that the people working in the police service were from various chiefdoms in the country.

"As the police service, we find it our responsibility to take care of you because you spend most of your time with us.

If we do not take care of you, we would be failing in our duty as the police service. By so doing, we cooperate with the princes and chiefs who are in charge of your chiefdoms," Magagula said.

The national commissioner said the Imbali would then be taken care of by the chiefs when they were in their respective chiefdoms.

Magagula said the idea behind the formation of the culture wing within the police service was to understand the way in which Swazis were doing things.

This would enable them, as a police service organisation, to serve the Swazis with a better understanding of their way of life.

"This is a way of communicating with the nation, so that there

can be a better understanding between our organisation and the society it serves. This is what happens even if you want to penetrate a certain group of people participating in a war. You have to know their language, if you want to penetrate them to find how they operate," he said.

Magagula's statement comes after there were submissions made during the people's parliament, commonly known as Sibaya last month, where some speakers expressed their concern over the fact that regiments from the security forces were taking part in national cultural ceremonies as regiments from their work places, thus gaining unfair advantage.

Go

The speakers felt that the regiments from the security forces should go to their respective chiefdoms and participate there during such ceremonies.

They said this would enable the regiments to depart from their chiefdoms, where they come from and not from their workplaces.

earlier had been broken into. This incident allegedly unfolded itself out at around 10pm.

After noticing something sinister in one of his kombis, Mamba said he knew something was wrong thus he went to check the other kombis. Indeed his fears were confirmed as five of the kombis had been broken into and the robber was found in one of the kombis allegedly continuing with his wicked deed.

Evidence

While leading evidence as the first witness in the case before Mbabane Magistrate Sifiso Vilakati, Mamba said getting the robber out of his kombi proved a tall order as he not only locked all the doors but also allegedly 'sjambokked' the businessman together with his driver, Sikhombisa Dlamini.

They were later joined by the security guard providing security at the car wash but that did not help as it is said Themba Dlamini, the suspect robber, was violent and did not show any signs of backing down.

"Sikhombisa told me there was someone in a grey Quantum and after proper inspection we noted that he gained entry through the windows.

But getting himself out of the Quantum did not come easy as he took a sjambok inside the kombi and whipped us each time we tried opening the quantum.

Jumped

This went on for minutes and we had to call the police. We finally managed to open the door but he jumped out and ran away," Mamba alleged in court.

Mamba went on to say the suspect robber also produced a knife and used it as he tried to escape from them but they managed to overpower him and waited for the police to arrest him.

"In all the five kombis, he stripped off the dashboards and tried to take out the radios but he could not. I believe we found him while he was busy trying to

steal the car radios and our arrival disturbed him. When we talked to the security guard, he told us that the suspect might have arrived a few minutes earlier as he did not notice anything sinister while patrolling," the businessman said.

The suspect robber, pleaded guilty to breaking into the five kombis and further damaging each dashboard which is said to be worth E2 600. The businessman confirmed that each of the damaged dashboards set him back by E2 600.

Fateful

Another kombi owner, Richard Simelane from PTS, confirmed the incident while leading evidence in court as he said his kombi was parked at the car wash too, and on this fateful night he received a call from Dlamini alerting him that their kombis had been broken into.

The accused person was charged with 10 counts of breaking into the five kombis and further damaging property while inside the five kombis. He was remanded back to custody until Friday while his trial will proceed on October 18.

NCOBILE Mkhabela (21) was allegedly infuriated when her half-brother organised a 'side chick' for her boyfriend.

Tenants, residing at the Masango homestead situated at Msunduza, allegedly had a tough time getting their sleep on the night of August 26 when Mkhabela discovered that her boyfriend was with a woman in her brother's house in the same compound.

Apparently, Mkhabela and her boyfriend, Mzwakhe were in the process of working on their relationship after going through a rough patch, the complainant

Mkhabela said on the day of her assault, the man of her dreams had apologised and told her he

wanted to fix things. However, things went from bad to worse on the night as it is said, Mihla Masango organised a female friend for his brother-in-law, something that got Mkhabela seething with fury.

While appearing at the Mbabane National Court before President Chief Lembelele, Masango pleaded guilty to the offence of common assault laid against him by his half-sister. He stated that he did hit her twice with claps on her face but refuted kicking her until she fell down.

"She came at night while drunk and demanded to see her boyfriend, I told her to come back in the morning as I hate being woken up while asleep.

All I knew was that the two had

separated and that is why Mzwakhe was with a woman in one of the rooms in the house," Masango said during mitigation. He added that her half-sister did not show any respect to him and the tenants residing at the homestead as she allegedly made a lot of noise while shouting and insulting him.

"I beat her out of anger as she told me I was homeless and had nothing as the house belongs to my grandmother. I never kicked her but tried to reason with her to stop making noise and she tried hitting me with a beer bottle," he added. However, Mkhabela insisted with her allegations and Masango was sentenced to pay a fine of E400 or face imprisonment for six months.







Striking Plantation workers vow to continue with protest

THE striking workers of **Swaziland Plantations Limited** are declining in numbers as only 300 are still protesting after their clash with the police.

The protest action started off with 460 workers.

"We will continue with the strike and the police will have to arrest us all," a worker said.

The workers delivered firm and defiant messages that they would continue to engage in the strike. The protest action has been going on for over 24 days now.

Swaziland Agriculture & Plantations Workers Union (SAPAWU) Chairperson Sibusiso Masuku said only 300 workers had remained in the strike. He was addressing the 300 remaining striking plantation workers who congre-

gated at the Plantation sports ground instead of their usual meeting area at the gate of the plantation in fear of a repeat of Wednesday's

attack by police.

Masuku is still nursing a head injury that he suffered at the hands of police on Wednesday.

Masuku whilst addressing his fellow striking Plantation Forest Company employees said, "what happened last week Wednesday

was unfair to us, we held our strike in its usual place outside the Plantation, unfortunately police were called to disperse us. We will not stop our strike because it is a legal one, we may have dwindled in number but we will continue, the police will have to arrest all of us."

Addressing

Also addressing the remaining striking Plantation workers was shop steward of the Swaziland Agriculture and Plantations Workers Union (SAPAWU) Victor Shongwe who said the remaining plantation workers should be careful and try not to wear their customary red t-shirts until a designated time.

Shongwe said the workers should wait until they were given the go ahead from the secretary general of the Swaziland Agriculture and Plantations Workers Union (SAPAWU) Manqoba Dlamini to continue the strike action.

At that point they would congregate at the Plantation Forest Company entrance where they have been demonstrating for the past 24

Police fire teargas at protesting Plantation workers

PLANTATION workers have complained that though they had embarked on a legal strike, police fired at them with teargas.

About six plantation workers were arrested after a policeman that had come to man the strike was injured. The police officers dressed in full gear, fired teargas canisters at about 200 unarmed striking plantation company workers resulting in two female workers being injured and rushed to the Pigg's Peak government hospital for treatment.

The incident happened last week Wednesday afternoon outside the Plantation Forest Company. The riot police were joined by a helicopter that was being used to douse the flames that resulted after Plantation workers allegedly started lighting fires in the neighbouring forests.

Swaziland Agriculture and Plantations Workers Union (SAPAWU) Chairman Sibusiso Masuku said the violent police came out of nowhere and started firing teargas canisters at the unarmed, unsuspecting Plantation workers who were striking for the seventeenth day.

"It was an unprovoked attack by the police who ambushed us, two of our female colleagues are injured and have been admitted at the Pigg's Peak hospital, one was injured in the leg by a tear-

Shongwe said after the plantation workers had disbanded, the police then started chasing them out of their houses which are behind the plantation sports ground with teargas canisters.

"After we ran away from the police and their guns, they started invading our quarters, firing teargas inside our houses, it was terrible. We had to run away from them, but why did they follow us because we were unarmed?" Shongwe said.

According to Acting Police Information and Communications Officer Assistant Superintendant Phindile Vilakati, she said a male policeman was injured in the head with a rock as the plantation workers became violent.

"Police were called to disperse the plantation workers who were becoming violent. Unfortunately, a male officer was injured in the head as a result, we are waiting for more information on his condition," Vilakati said

Pigg's Peak Town Council to add park to cemetery, upgrade road

THE Pigg's Peak Town Council wants to construct a car park and upgrade the gravel road leading to the town's cemetery.


Town Clerk Mzwandile Ndzinisa said the town council had a budget in place to rehabilitate the gravel road leading to the cemetery. He added that the construction of the new car park would also commence as soon as possible.

The small town of Pigg's Peak has a formal cemetery located adjacent to the Pigg's Peak landfill site past the Gobolondlo Hall three kilometres away from the Pigg's Peak correctional facility.

"People have complained that the cemetery has no parking, ablution facilities or a proper entrance.

We intend giving the town a facelift, we are currently planning for a proper car park for the cemetery and we will also upgrade the road leading to the cemetery," the town clerk said. Ndzinisa stated that the current wall fence at the cemetery was in good condition and there was no need for the council to have a new one.

"The town council does not need to add a new wall fence to the cemetery, the current wall fence serves its purpose of keeping livestock out of the cemetery we have had no complaints from residents about the wall fence. If we do add a new wall fence it will be purely for cosmetic reasons," he said. The rehabilitation of the road to the cemetery would begin soon.

SUGAR ASSOCIATION FEELS BRUNT OF EL NINO

KWASA Farmers Association has abandoned over 20 hectares of sugarcane fields, due to the prevailing drought and financial difficulties.

In the past few months, the farm has been reported to be in a financial crisis and has been turned into grazing land for animal owners in that area.

Some of the people were cutting the cane for consumption purposes.

According to some of the people who were found grazing their cattle in the area, the association members have abandoned the fields and thus will not harvest this financial year.

"People travel as far as from Madlangemphisi and

In July, the Association retrenched over 20 workers in a space of two months.

Luve to fetch cane here," a resident Sifiso Tsabedze said. He said due to the prevalent drought in that area, the fields have been abandoned with the sugarcane and people come with trucks and cars to fetch the cane. "Some even sell the sugar cane along the road for motorist and other passerby." According to the Chairman of the association Ellen Masuku, SwaziBank stopped funding them as the bank claimed they were in arrears.

She said they were left with no option but to wait, and then residents decided to force their animals in.

In July, the Association retrenched over 20 workers in a space of two months.

The shareholders of the troubled Kwasa Farmers Association tried to have a special meeting with SwaziBank board members to discuss their financial woes, however it is reported that the Bank with a heart did not come to their rescue. It was also alleged that the six shareholders were also at loggerheads over the matter as they blame each other for misusing funds.

Also a water pump was left hanging at the Mbuluzi River since the association has not paid electricity.

Family members hacked, assaulted by 'sick' sibling

A family in Mdzangwini has been left shattered after a family member turned against them. hacking them with a spade, further using a knobkerrie to assault them.

Thabo Makhubu (22) has been charged for allegedly assaulting, with intent to cause grievous bodily harm, two of his family members.

Assaulted

Makhubu, who is currently taking medication at National Psychiatric Referral Hospital since February, was said to have intentionally assaulted his sister, Nelisiwe Gamedze by hitting her with a knobkerrie three times on her head with intent to cause her grievous bodily harm. This incident allegedly occured on May 6 in Fonteyn.

The other count was that on the following day, being May 7, Makhubu allegedly continued with his terrifying reign of terror as he wrongfully, unlawfully and intentionally assaulted his aunt, Lindiwe Shongwe, by hacking her several times on the head and hands with a spade.

After being arrested for committing these crimes, Makhubu appeared in court, where the correctional services were ordered to refer the offender for assessment at the psychiatric centre.

The examination report proved that he was a regular patient at the hospital and was responding well to medication, as he appeared to be sound.

Reported

When Makhubu appearing before Magistrate Sifiso Vilakati last week, he told the court that he was struggling to raise the E500 bail, hence he was still in custody.

His trial could not proceed as the complainant was reported not to have been ready to face the accused person in court.

"I am worried about the

accused person as justice must be served and the court will not be able to do so if the complainants do not show up to court saying they are not ready.

The accused person was of the idea that the trial will proceed," Vilakati said, while postponing the matter.

When Vilakati asked the prosecutor, if the complainant had recovered from injuries, he was told that she had been released from hospital and was recovering well.

Remanded

Makhubu was remanded back to custody, with Vilakati urging the accused person to make means for the E500 bail.

Speaking to a family member about the accused person, it was mentioned that he normally does this.

"We are shattered and angered with what he has done.

He was admitted at the psychiatric centre and we thought he was recovering," the family member said.





KE AIDS CURES GUE THE DESPERATE



LIKE a skin rash that comes back or a pest that returns, medical charlatans continue to promote 'cures' for AIDS.

Of course, these hucksters are more than willing to share their medical miracles with one and all - provided of course that they receive payment.

AIDS LIFELINE again calls on our nations' authorities to consider this: The vultures who prey on the final hopes of desperate people should face prosecution for fraud. It is simply too easy for anyone, particularly it seems for individuals arriving from foreign lands and with unverifiable claims to be experts in traditions medicines, to

testimonials from persons who say

they feel better after drinking the they feel better after drinking the stuff and claim they have cured

No scientific evidence is ever presented. In fact, modern medicine is attacked for not producing an AIDS cure yet.

People living with HIV and AIDS can indeed have good days and bad days in terms of their health, and like anyone can feel a physical boost from drinking a vitamin-laced beverage or a Red Bull. This does not mean they are

cured of HIV.

Sadly, truly desperate people are the ones who turn to such tonics. This is not medicine but faith healing in which the faith of a person does the healing. Positive attitude is not enough to stop a virus, unfortunately.

Effectiveness

safety. There is no conspiracy to keep AIDS cures away from patients, but there is a conspiracy to use fake AIDS cures as a way to rob ill people of money they truly need to finance legitimate health care and proper nutrition.

One of the key problems that result from fakery is that false AIDS cures take people's lives. Those patients who purchase these 'cures' do so out of faith and ignorance, and thus become heavily invested in their success. Indeed, many of the people who take these fake medicines become so psychologically enslaved to the belief in their effectiveness that they begin to feel better.

Every illness waxes and wanes like the cycles of the moon. Even with a normal flu there are times when the patient feels better, before again feeling worse. Those moments when the symptoms of flu are relaxed do not represent an end to the illness.

Similarly, the stages of HIV are not continuous, but occur in a halting manner. The first onslaught of HIV produces worrisome and painful symptoms in the patient. These pass, however, to the relief of the sufferer. However, this does not mean the patient is free of HIV.

Dislodged

Once in a person's system, the virus cannot be dislodged although it can be contained through the use of anti-retroviral drugs (ARVs) taken as part of

antiretroviral therapy (ART). Some people who invest in fake AIDS medicines take the concoctions at a time when their HIV symptoms are declining. They feel better, although this state of relief has nothing to do with an end to HIV. It certainly has nothing to do with the medical quackery they have subjected themselves to. Nevertheless, it is from these same people from whom we hear glowing testimonies about the effectiveness of a nonconventional

AIDS 'cure.' The patients proclaim they have been cured, and the seller of the concoctions readily use these testimonies are proof that they have achieved what the world's medical sciences have thus far failed to accomplished. They say they have conquered HIV and ended AIDS. They must share this miracle with one and all, provided that one and all come up with sufficient cash to pay for the

As for the person who makes the claim that what they are paying for cures them, sadly they are doubly troubled. Firstly, their symptoms return, only worse because they have not been undergoing legitimate HIV therapy. Where ARVs would have helped them if consumed in a timely manner, this was not done and the course of the disease would have advanced in the person. This advance might possibly be fatal.

Unconventional

The true test for any testimony that declares success for an unconventional medicine is whether the patient's 'cure' can be scientifically validated. For HIV it is simple. The person need only take a blood test to determine the amount of HIV virus in his or her body.

People who take fake medicines will not turn to science for two reasons. The first is they have lost faith in science because after 30 years there is no AIDS cure. Secondly, they feel loyal to their fake medicine, because the effectiveness of that medicine is a matter of faith to them. It would seem a betrayal to them to then ask science to validate what they believe to be true.

Unfortunately for them, the only betrayal that has occurred has been against their personal health and the safety and security of their loved ones.





It's hard to get rid of the governor of a central bank

With the continued harassment of South Africa's **Finance Minister Pravin** Gordhan, it has become patently clear that no institution will be spared in the wave of state capture that is sweeping through the country.

The finance ministry has been at the centre of this wave for nearly a year. The latest move against Gordhan comes against a backdrop of efforts to wrestle control of this particular portfolio. The most spectacular was President Jacob Zuma's decision in December 2015 to fire, then Finance Minister, Nhlanhla Nene and replace him with someone more agreeable to his plans.

That plan backfired. President Zuma had no option but to reappoint Gordhan, the previous Minister of Finance. But Gordhan is now back in the firing line after refusing to give ground to Zuma on some crucial issues. Rumours persist that the finance minister is about to be fired or charged - possibly even arrested - by the elite police unit, the Hawks.

Is the governor of the SA reserve bank next? This consideration comes on the back of political attacks directed at the country's central bank by senior members of the governing African National Congress (ANC) aligned with Zuma.

The Deputy Secretary General of the ANC Jessie Duarte has raised questions about the central bank's role. She is suggesting that the bank serves partisan interests because it has private shareholders.

It has also emerged that Mosebenzi Zwane, the Minister of Mineral Resources, tabled a working paper to the Cabinet recommending that the power to issue banking licences should be taken away from the SA Reserve Bank and given to the minister of finance.

But can the governor be removed as easily as a minister of finance? My reading of the SA reserve bank Act is that the answer is no. The current legislation makes no provision for the President to dismiss the central bank governor.

Holding central bankers to account

Central banks' governors need security of tenure once appointed. Security of tenure allows them the opportunity to conduct monetary policy in the interests of the whole country without fear of dismissal.

Imagine a scenario in which a central bank governor was dismissed every time he or she took a monetary policy decision that the government disliked - for example by raising interest rates. This would render the job unworkable.

Because of this, the appointment of central bank governors has been designed to ensure that they can get on with their mandate without political interfer-

The governor of the SA reserve bank is appointed by the president of the Republic after consultation with the minister of finance and the Board of the South African reserve bank. Appointments are for an initial five years. Once the first term is served, the president can reappoint the governor for an unlimited number of further terms, each for a maximum period of five years.

So much for the appointment.

What about getting rid of a governor?

The SA reserve bank Act lists conduct that will render the governor unsuitable to complete any term of appointment. Other than on these grounds, no provision is made for the dismissal of the governor.

So how would a governor would be removed if he or she was considered to be unsuitable for office? This is open to some debate, but it seems that there might be at least two possibilities:

• The government (including Parliament) or any other party can take legal action to have the governor declared unfit to hold office. The governor and his deputies serve as directors of the central bank. As such they are bound by rules which demand that they remain fit and proper to serve. The act sets out in some detail what fit and proper entails. It includes avoiding conflicts of interest between personal interests and the interests of the central bank and not working for a bank. If the incumbent falls short of any of these requirements, there is recourse to taking legal action against them.

• Parliament can amend the South African Reserve Bank Act to give the president power to dismiss the governor.

My understanding is therefore that the president cannot simply remove the governor of the SA remove the governor of the SA influence the value of a currency reserve bank. It would require - by intervening in the market is at a minimum - legal action or a second state of the same at a minimum - legal action or a futile. China is an exception to parliamentary process

Central banks with shareholders

Duarte's main point of contention is that South Africa's central bank has private shareholders, which means that it cannot act independently. This is not true.

South Africa isn't the only country with a central bank owned by private shareholders. While most central banks in the world are publicly owned, there are a handful that aren't. These include Belgium, Greece, Japan, Switzerland and Turkey. In the case of the US and Italy, only shareholding by commercial banks is allowed.

In none of these instances is there evidence that private ownership affects the institutions' independence. In fact, it can be argued that a private ownership structure adds to the transparency and accountability of central banks. For example, the SA reserve bank publishes a comprehensive annual report for distribution to shareholders. In addition it has to hold an annual ordinary general meeting of shareholders at which the governor responds to questions about the business of the central bank and the conduct of monetary policy.

The link that Duarte tries to make between the central bank's shareholding and its approach to exchange rate policy simply does not exist. The SA reserve bank made this point clearly in a statement it issued shortly after Duarte's salvo. This points out that shareholders play no role in the formulation and implementation of monetary policy

On its approach to exchange rate policy, South Africa's central bank takes a stance similar to most central banks in the world: namely, that any attempt to this rule. It has a controlled economy and has substantial foreign currency reserves with which to support the yuan in the open market. The SA reserve bank serves the best interests of all South Africans. The governer's security of tenure supports the efforts of the central bank to contain inflation. At the same time a structure of private shareholders in the central bank helps to improve monetary policy transparency.

IUTUALIV DAIRY PROJECT TO REDUCE IMPORTATION BY 30%

OLD Mutual Swaziland is currently producing over 8000 litres of milk a day in its E90 million Joint Venture (JV) dairy project.

Old Mutual has partnered with the Swaziland National Provident Fund (SNPF) and the Public Service Pensions Fund (PSPF) on the project.

Old Mutual and its strategic partners are on course to fully invest about E90 million towards production of dairy products, through a project expected to create 80 jobs on direct production and more through the value chain.

Old Mutual Chief Executive Officer Muzi Bell said the project was expected to produce at least 60 percent of locally consumed dairy products per annum, which would bring down the country's dairy imports by 30 percent.

Bell was speaking during a Southern African Development Community (SADC) Council of Ministers lunch hosted by the company in Marquee at Lozitha on August 27 during the recently concluded SADC Summit.

Through a video presentation, the company showcased country

projects for Swaziland, Malawi, Zimbabwe and Namibia.

According to Bell the country was importing about 90 percent of its dairy consumption before the project started.

He said the project was unique in many ways, "firstly, it has the most technically advanced milking system in Africa, second in the Southern hemisphere, bought from Germany, secondly, it produces almost all the cattle feed itself and thirdly, it now can sustain itself in terms of water

through a newly constructed dam that could supply water for up to two years in cases of shortages or drought."

He said at full scale, 3 500 cattle would be kept at the farm, phased in over a three-year period, with future plans to produce various dairy products in-house within a year, thus making Swazi Milk a competitive dairy supplier.

"All this will be done while keeping in mind that we have to protect and improve local dairy farmers," he said.

Bell said they would also employ specialised experts in agriculture and establish an internship programme with the University of Swaziland and train students on large scale dairy farming.

He said the dairy project would be rolled out in two phases.

The investment of the completed first phase was worth of E38 million, which catered for various purposes that included preparing the farms, irrigation systems, construction of the milking plant, staff housing and a dam.

Bell said the second phase which was on a larger piece of land would also be converted with fixed dairy farm improvements to the tune of E47million.

He said the milking cattle were supplied separately through a joint venture with the farm operator, Swazi Milk.

"Construction of this project started October 2015, and is now fully operational with over 700 genetically superior cattle. Most of them are imported, but from them we already have locally

"These new locally born cattle and many more expected will be next in-line for milking, meaning less needs to import in future. As we speak we produce just over 8000 litres of milk a day."

Swaziland Stock Exchange (SSX) Manager Joyce Dlamini said the automation would see the exchange moving from a manual system to joining other modern markets.



She further thanked the Financial Services Regulatory Authority (FSRA) Chief Executive Officer, Sandile Dlamini for his guidance and standing by her ever since she joined the SSX last year July, especially in this automation project, the FSRA Board Chairman Stephen Simelane and the entire Board of the FSRA.

Dlamini said in today's rapidly changing and expanding financial markets, which include money and capital markets, Escrow Systems' leading

FSRA CEO Sandile Dlamini said this was a flagship project in the capital market development process of Swaziland, "as the exchange is a national asset, we hope that more companies, both big and SMEs, will now look up to the exchange to raise the needed capital to spur their business start-ups, developments and expansions."

"I am also confident that the SSX will now operate a fair, efficient and transparent platform and as its regulator, Escrow System will supply us with a surveillance system which will enable us to monitor, real-time, every activity happening on the market to curb insider trading and other market misconduct to protect investors," he added.

Dlamini emphasised that information dissemination would also improve as the SSX would be connected to Market Data Vendors, like Reuters and Bloomberg. BOTSWANA TAGS SWAZI COMPANIES IN COAL VALUE CHAIN

SWAZI investors have been afforded an opportunity to partner with Botswana-based companies in the coal value chain.

Botswana Trade Project Manager Julius Dipopego said, in Bostwana there were numerous sectors which would benefit from increasing value chain linkages. "Botswana has a confirmed 212 billion tonnes of unexploited coal. Currently only one mine, called Morupule, produces around 3 million tonnes per annum. The demand of coalfor-energy has increased significantly nationally, regionally and internationally therefore beneficiation in this industry would be a good investment for any investor," he said.

He was speaking during the recently concluded Swaziland International Trade Fair (SITF) business seminars.

Dipopego said the coal could be used to generate electricity for exports to other Southern African Development Community (SADC) member countries.

"The coal could to produce liquid fuels from coal, using the Fischer Tropsch and MTG processes as well as also the production of gas from coal for power generation which would also be possible," he said. Dipopego said given the immense benefits to gain from developing coal beneficiation, Swazi investors in this sector would enjoy sustainable profits.

"Another sector that has growth opportunities for Swazi investors to benefit from is that of leather.

Botswana has a national herd size of of 2.5-3.3 million cattle annually which yields 200 000-300 000 hides annually.

These hides could be used to manufacture leather products as there is a demand for such products," he said.

The Common Market for Eastern and Southern Africa (COMESA) under the COME-SA-Leather and Leather products Institute Swaziland Leather Chain Strategy 2016-2025 report said the leather industry is a multibillion emalangeni industry.

"Swaziland is missing out on over E938 million per year from exports of finished leather products, due to the absence of a proper leather value chain.

This could significantly contribute to the Kingdom of Swaziland earning potential," reads the report as part.

The report said, while the livestock base of the country is small in comparison to other neighboring countries, the quality and size of the hides and skins were superior, "the hides and skins are estimated to be earning an average of E16 per kilogram."

SWAZI business owners have encouraged government to implement the Common Market for Eastern and Southern Africa (COMESA) Yellow Card Scheme.

Ministry of Commerce
Industry and Trade Deputy
Director of Trade, Lungile
Dlamini, said the yellow card
was essentially a regional third
party motor vehicle insurance
scheme that provides third party
legal liability cover and compensation for medical expenses
resulting from road traffic accidents, caused by visiting

"Besides offering third party liability protection to the insured or the driver, whilst in a foreign country, the COMESA yellow card scheme also offers emergency medical cover to the driver and passengers of a foreign motor vehicle involved in the traffic accident.

The third party liability cover is limited to the statute provisions for the road traffic third party liability award limits of that country being visited and in which the incident has happened from," she explained.

She said Swaziland was not part of the scheme yet, and

therefore this could be considered a barrier to trade, as it means people have to buy insurance every time they enter another country within the regional bloc.

The COMESA Yellow Card Scheme is currently operational in twelve COMESA member Countries and one non-COMESA member country. The countries in which the COMESA Yellow Card is recognised, as a valid insurance cover, are; Burundi, Democratic Republic of Congo, Djibouti, Eritrea, Ethiopia, Kenya, Malawi, Rwanda, Sudan, Tanzania, Uganda, Zambia and Zimbabwe. "It is also widely used by

"It is also widely used by non-COMESA motorists, particularly from SADC countries visiting or transiting through the COMESA member countries," she said.

Business owners, attending the business seminars expressed their wish for Swaziland to join the scheme.

"We do business in Mozambique and it is very cumbersome to have to buy insurance so that we can travel to that country," said one businessman who was only identified as Simelane.


CLINTON AMPED UP FOR FINAL CAMPAIGN

CLEVELAND - Hillary Clinton launched the home stretch of her US presidential bid Monday aiming to solidify her various advantages over rival Donald Trump, with both candidates converging on working-class Ohio for separate Labour Day events.

The Democratic nominee maintains an edge over Republican flag bearer Trump in national polls, has dramatically more expansive ground operations in several swing states, and trounced Trump in fundraising in August.

But Trump's unconventional White House bid, including his campaign's apparent imperviousness to criticism about his harsh rhetoric, assures a tight contest for the next 64 days until the election.

Clinton debuted her new campaign plane, with the slogan "Stronger Together" emblazoned in big blue letters on the side, that will carry her through to the

November 8 election, and it hosted guests whom she has been reluctant to travel with until now: reporters.

Criticism

Under extensive criticism from her rival and journalists for not holding a full press conference in more than eight months, Clinton

welcomed reporters on her plane and briefly entertained questions before taking off from New York.

"I am so happy to have all of you with me. I've been just waiting for this moment," said Clinton, perhaps in gentle jest, to three dozen media members in the back of her plane. AFP

Italian navy recovers six dead migrants

ITALY - The Italian navy announced Monday it had recovered the bodies of six migrants in search and rescue operations which saved nearly 500 people.

Two patrol boats "recovered nearly 500 people during six rescue operations, including one involving an inflatable boat which was only just about floating, and from which some migrants had fallen into the sea," it said in a statement.

"Six bodies were recovered so far. Search and rescue operations for survivors are continuing," added the navy, which has deployed significant resources off the Libyan coast.

A huge wave of migrants arrived in Italy at the end of August, when some 14,000 people were rescued in the space of five days. According to UN High Commissioner for Refugees (UNHCR) figures 117,590 migrants arrived in Italy between the start of 2015 and September 1, around the same level as last year. AFP

The device, packed in the fuel tank of the parked motorcycle, struck as pupils and teachers filed into the school in Tak Bai district of Narathiwat province for the start of the day." Two people killed were including a kindergarten girl and one adult - who may be her father," a policeman in Tak Bai told AFP, requesting anonymity.

No to independence push - China

HONG KONG - In a statement late on Monday, China said that it would not tolerate any talk of independence "inside or outside" the legislature. We firmly oppose any activity relating to Hong Kong independence in any form, inside or outside the Legislative Council, and firmly support the Hong Kong government to impose punishment in accordance with the law," state news agency Xinhua cited a spokesperson of the Hong Kong and Macau Affairs Office of the State Council — China's cabinet — as saying. It said some candidates had used the election as a platform to "openly promote" independence, adding that that went against China's constitution, as well as Hong Kong's own mini-constitution, known as the Basic Law.

Annan booed on peace mission

SITTWE - Hundreds of Buddhist hardliners booed former United Nations (UN) Chief Kofi Annan as he arrived in Myanmar's troubled Rakhine state yesterday to probe religious conflict that has displaced tens of thousands of Muslim Rohingya. Annan has been asked by the leader of Myanmar's new government, Aung San Suu Kyi, to find ways to heal wounds in the bitterly divided and poor western state. Rakhine, which borders Bangladesh, has been scarred since 2012 by bouts of communal violence between ethnic Rakhine Buddhists and a minority Muslim population.

Erdogan proposes 'no fly zone'

ISTANBUL - Turkish President Recep Tayyip Erdogan said on Monday he proposed setting up a no-fly zone in northern Syria to the US and Russia, after Ankarabacked fighters pushed the Islamic State group from the border area." We are working for this region to be declared no-fly zone," Erdogan said at the G20 meeting in China, referring to the land extending from Jarabulus to Azaz in northern Syria seized from ISIS jihadists. "This is my proposal to Mr Putin and Mr Obama," he said.

Sri Lanka certified malaria free

COLOMBO - The World Health Organization has certified Sri Lanka as a malaria-free nation, in what it called a "truly remarkable" achievement. WHO regional director Poonam Khetrapal Singh said in a statement on Monday that Sri Lanka was among the most malaria-affected countries in the mid-20th century. WHO said Sri Lanka began an anti-malaria campaign that successfully targeted the mosquito-borne parasite that causes the disease, not just mosquitoes. Health education and effective surveillance also helped the campaign. It said no locally transmitted cases of malaria have been recorded in the country for 31/2 years.

Muslim moms in headscarves barred from entering nursery school

MARSEILLE - Two Muslim mothers wearing headscarves were accosted and prevented from entering a nursery school on the French island of Corsica on Monday by two other parents, officials said.

The incident happened as parents were dropping off their children at the start of the school day in Bonifacio, on the island's southern

tip.

The two women, wearing traditional headscarves, "were stopped by two men, two brothers, who thought it wasn't right that their children are not allowed to wear emblems of their religion at school and yet these women could enter with their veils," said local prosecutor Eric Bouillard, confirming a report in the Corse-Matin newspa-

Bonifacio mayor Jean-Charles Orsucci said his education official "had intervened to allow normal entry to the school".

Police and a schools inspector were also sent to the scene "and the situation calmed down. There was no violence, no threats, and therefore no laws broken," said Bouillard.

Symbols
While religious symbols are banned for pupils and teachers in French schools, there is no such constraint on parents. The incident is the latest example of intercommunal tensions in France. A burkini ban by local authorities in a string of resorts in southern France divided opinion and ended up in the courts. AFP

"While the immediate cause was my strong comments to certain press questions that elicited concern and distress we also regret it came across as a personal attack on the US president," a statement released by Duterte said.

The US and Philippine leaders were due to meet late yesterday in the Lao capital of Vientiane at a gathering organised by the Association of Southeast Asian

But Obama pulled out of holding a bilateral meeting after Duterte launched a tirade against him ahead of the visit during a Monday press conference.

Tongued

The acid-tongued former prosecutor on Monday warned he would not be lectured by Obama over concerns about a brutal war on crime that has claimed more than 2 400 lives in the Philippines.

You must be respectful. Do not just throw away questions and statements. Son of a whore, I will curse you in that forum," Duterte told reporters when asked about

his message for Obama.

Duterte's statement yesterday in Laos struck a much more conciliatory tone, saying both sides would hold face-to-face talks "at a later date".

"Our primary intention to chart an independent foreign policy while promoting closer ties with all nations especially the US with which we have a long standing partnership," the statement said.

"We look forward to ironing out differences arising out of national priority perceptions and working in mutually responsible ways for both countries," it added.

A white and a black police officer arrive on the scene. The white officer objects to her comments and warns her to stop.

"The calibre of blacks in this town vary from the calibre of

blacks in Durban. They're opinionated, they're arrogant, and they're just plain and simple useless. I am happy for a white person to assist me, or a coloured person, or an Indian person. I do not want a black person to assist me," she shouts. "Let me tell you something. This is the type of police force we have got. We got a low calibre people working. If I see a black person, I will drive them over. If I have a gun, I will shoot everyone," she tells the officer before driving off.

And we don't leave our ideals and values behind when we take those trips."

Even the American Defense Intelligence Agency weighed in, linking to a NYTimes article about the incident and tweeting "Classy as always China" to its 83,000 followers before it was deleted.





BUFFON GESTURE HAILED BY FRENCH PRESIDENT

ROME - French president
Francois Hollande has sent a message of gratitude to the charismatic
captain of Italy's football team,
who hushed fans booing the visitors' national anthem ahead of
their friendly match last Thursday.

The Italian prime minister Matteo
Renzi revealed the matter in his
weekly letter to the nation on
Monday, saying Hollande had spoken to him on the sidelines of the current G20 meeting in China.

"At today's (Monday) meeting Francois Hollande thanked me for Gigi Buffon's gesture of goodwill in silencing the whistling during 'La Marseillaise' and instead galvanising fans at the Bari stadium to applaud," Renzi wrote.

"Sportspeople can make a big impact in transmitting educative messages: the team captain Buffon proved this. I believe the whole of Italy can be proud of him," Renzi added. Ahead of the friendly international between the two nations at the



Saint Nicolas stadium in Bari the opening bars of the French national anthem were booed.

But the veteran goalkeeper Buffon, who commands great respect in Italy for his powerful leadership of the national team, began instead to applaud 'La Marseillaise' and was very quickly followed by the rest of the Italy team before the gesture also swept through the tribunes.

France went on to win the match 3-1.

CSA working on finding new T20 sponsor

CAPE TOWN - Cricket South Africa (CSA) remain hopeful that they will secure a new sponsor for this season's domestic T20 competition.

This comes after the tournament's previous sponsor, RAM Hand-to-Hand Couriers, and CSA could not agree new terms for a renewed deal in 2016.

RAM had been the title sponsor of the tournament since 2013, but Executive Director (Legal & Commercial) Alan Da Costa told Sport24 back in January that the company was considering its future dealings with the competition due to the match fixing scandal that erupted at the beginning of the year.

"We are hopeful that CSA is taking every measure to comprehensively investigate the allegations and enforce a 'Zero Tolerance' approach," Da Costa said at the time.

"However no one ever wants their brand associated with any dishonest activities and we are seriously considering the outcome of the matter before renewing our sponsorship."

The scandal first saw Gulam Bodi banned for 20 years before further bans were handed out to Thami Tsolekile (12 years), Jean Symes (7 years), Pumelela Matshikwe (10 years) and Ethy Mbhalati (10 years).

Just how much of a role the whole mess played in the negotiations between RAM and CSA is unclear, but CSA's commercial leg is working tirelessly to secure a new sponsor before the tournament begins.

An official from CSA told Sport24 that the organisation was doing all it could and that there was sufficient time to find a replacement sponsor.

The competition begins on November 12.

Should nothing materialise before then, it would not be the first time that a domestic competition has taken place without a title sponsor.

Before the introduction of Momentum in 2012, the One Day Cup endured a sponsor-less season in 2011/12 following MTN's partnership with the tournament.

But the T20 competition is considered the most lucrative commercially for South African domestic cricket, and securing a sponsor will surely be a matter of urgency considering the possible expansion of the tournament.

CSA has announced its intentions to carry out a "re-positioning" of the tournament, with a possible extension to eight teams and a move towards a more global product the vision for 2017/18. sport24

Terry sparks memories of Ferguson

MANCHESTER - It's the picture that only serves to remind Manchester United fans what might have been.

A young John Terry, floppy haired and bright eyed, sits beside Sir Alex Ferguson during the Scot's ultimately unsuccessful attempt to lure the future England captain to Old Trafford.

It's 1994-95. United are trying to defend the double and Ferguson - then just plain 'Alex' from Glasgow - is already looking to build his next generation of Red Devils stars.

At the age of 14, Terry - then a holding midfielder - had already been identified as a possible option.

Ferguson invited the Barkingborn boy with a United-supporting father up to Manchester to train during the schools holidays as he tried to convince him to sign.

Ultimately he was unsuccessful, Terry chose Chelsea and the rest - four Premier League titles, five FA Cups, three League Cups, the Champions League and 78 England caps - is history.

But that fortnight in the north west stuck with Terry, who was

evidently impressed by the personal touch applied by Ferguson.

Speaking in an interview with The Observer in 2006, he remembered the whole episode vividly.

"I was Man United growing up," he said. "You know what it's like when you're a boy, you want to support the team that's winning everything. And my dad and granddad were Man United fans.

"But my first day at Chelsea I knew that was the club I wanted to be at. I just loved it. But Man United also approached me.

"I met Alex Ferguson - great to meet. During the school holidays I would go up to Manchester and train with their boys for two weeks, play a few games and come home.

"But one thing that was really special about Man United was that Alex Ferguson took time out and invited me to one of their games and to have lunch with their players.

"So there we are - me, my mum and dad, my brother. He made me feel so special, autographs, my photo done with the Premiership trophy. *Daily Mail*

Djokovic, Murray close in on US Open final duel

NEW YORK - Andy Murray will contests his sixth US Open quarter-final today looking to maintain his stranglehold over Kei Nishikori and take a step closer to a dream title showdown with Novak Djokovic.

Murray won the first of his three career majors at the US Open in 2012 and will be the favourite to make a fourth semifinal at the season's last Grand Slam.

The world number two has a 7-1 record against Nishikori whose only win over the Briton came at the World Tour Finals in 2014. This year, Murray came out on top in five sets to help steer Britain past Japan in the Davis Cup before cantering to a straight sets win in the Olympics semi-finals

All in all, Murray is on a 26-1 run since losing the French Open final to Djokovic in June, collecting the Queen's Club,

Wimbledon and Olympic titles on the way.

But he won't under-estimate the threat posed by Nishikori, who made the final in New York in 2014 having knocked out Djokovic in the semi-finals.

"He played some good stuff at the Olympics and won the bronze," said Murray who reached the quarter-final with a brutal dismissal of Grigor Dimitrov where he lost just five games.

"I played a really good match against Kei in Rio and I'll need to do that again if I want to beat him because he's one of the best players in the world, plays extremely well on hard court."

Djokovic was targeting a 10th successive semi-final appearance yesterday when he faced long-time rival Jo-Wilfried Tsonga, one of three Frenchmen in the last-eight.



JOHANNESBURG - Mike Mangena believes that Kaizer Chiefs forward Bernard Parker's best years are behind him, and suggested that he should hang



I WANT TO MAKE EVERY PLAYER BETTER - BOUCHER

JOHANNESBURG - "I want to make every player in the Titans squad 10% better. If I didn't think I could take every player forward, I would not have accepted the job as Titans coach," said Mark Boucher.

Boucher, successor of Rob Walter as the man at the helm of the Titans, said he learned from a number of coaches who all had their own philosophy on how to make South Africa a world-class unit. He played in 147 Tests and 291 One Day Internationals under the tutelage of Bob Woolmer, Graham Ford, Eric Simons, Ray Jennings, Mickey Arthur and Gary Kirsten.

Yet, he also learned from humble beginnings in East London while Pieter Strydom was the captain and Richard Pybus the coach. He said those players at Border were not necessarily individually the best, but as a unit they punched above their weight and played as a family who wanted to achieve silver-ware for one another. They constantly challenged for titles and pushed big teams to the brink because of their work-ethic and cohesion.

Boucher said he thrived under the coaching regime of Jennings, but was similarly at ease when Kirsten was at the helm. Those were different extremes, but he enjoyed both experiences.

"I enjoyed Ray. He hit base with me," Boucher said.

"During my playing days, I was quite feisty, but the freak accident (Boucher lost the lens, iris and pupil of his left eye after a bail hit his eye in a warm-up game prior to the test series in the United Kingdom in 2012) changed my personality quite a bit.

"It opened up my eyes," he said.
"In my dealings with Paddy Upton and Gary, I learned that each player is different. Not every player is comfortable with an up-front (confrontational) approach.

"You need to manage each player differently."

Micro-management of players in order to get the best out of them is

important because some players might thrive if they are get the hairdryer treatment, but others would rather need encouragement and a pat on the back, rather than a kick.

Boucher also learned from different captains.

Graeme Smith was a tough task master who led from the front with enormous pride and determination and demanded high standards from his players. The former South African wicketkeeper-batsman, who claimed 998 dismissals during his legendary career, said it is important to create an environment in which each player can thrive.

'Ronaldo could join Barca'

MADRID - There are a few double agents, who switched between bitter rivals FC Barcelona and Real Madrid, and one of them has now insisted Cristiano Ronaldo could join the Catalan giants.

Luis Figo became one of the most controversial players in the game when he famously left the Camp Nou for €60 million (R979 million) to join Real in 2000. The Portuguese joined Barcelona's bitter rivals for a then record fee after Los Blancos activated his buyout clause and Barcelona's hands were tied.

The 2001 FIFA World Player of the Year admits he was expecting Barcelona to improve his contract in order to prevent the move, but it didn't happen.

"The first reason was the recognition from the president

of Real Madrid," he told Portuguese publication Record.

"So things were getting more serious and I received the offer, I reported it (to Barcelona) and thought I wanted to improve the contract."

Figo was then asked whether his countryman Ronaldo could follow a similar path and responded it's possible if Barcelona would pay his €1.5 billion (R24.5 billion) buyout clause.

"We are in a free market. If there is a termination clause (in Ronaldo's contract), anything can happen," he added.

The law in Spain requests for every La Liga player to have a buyout clause and while Ronaldo's is reportedly set at €1.5 billion, Lionel Messi's release clause is worth €250 million (R4.1 billion).

McIlroy ends title drought

NORTON - Rory McIlroy shot a superb six-underpar 65 to end his 16-month PGA Tour title drought with victory in the Deutsche Bank Championship in Norton, Massachusetts, on Monday.

The Northern Ireland star laid the foundations for a two-stroke victory over England's Paul Casey with a bewitching front nine performance, sinking five birdies to be five under at the turn.

Two more birdies and a bogey on the back nine at TPC Boston sealed a deserved win for the 27-year-old, whose last win on the PGA Tour came at the Wells Fargo Championship in May 2015.

The win earned McIlroy another \$1.53 million and will see him move up to third in the next set of world rankings. It also catapulted him from 38th to fourth place in the standings for the lucrative FedExCup post-season series. The win completed a remarkable turnaround for McIlroy, who had got off to a disastrous start in his opening round on Friday to be four over par after his first three holes.

"It's amazing in this game how things can change so quickly," McIlroy said.

"From three holes in - four over par - there were a lot of things going through my mind, and one of them was not winning this tournament," he added. © *AFP*

And, experienced private investigator Brad Nathanson, who's currently handling the case, believes Meyiwa's killing was related to match-fixing and not robbery, as initially suggest-

"I don't believe that man died as a result of home invasion or a robbery, housebreaking or whatever it is they want you to believe," Nathanson told Sunday Independent.

"I think this has something (to do) with match-fixing.

"That is my belief. Who (would) rob that man anyway? He was a national hero and for me what comes

to my mind is match-fixing, and it's the first thing that comes to my mind.

"I don't know what level this investigation was taken to. But, as an investigator of 36 years experience, I am very, very surprised no arrest has been made.

"It's unbelievable for me. I can't imagine what Meyiwa's family might be going through knowing this man has died and he had such an amazing career and life ahead of him."

Meyiwa's killers are yet to be arrested, but Nathanson is confident of concluding the case, saying all it requires is money and time.

"You can quote me on this one, any case can be solved. All it requires are two things.

"One is money and another is time," he concluded.



Ramadhan himself confessed, warming up to the job saying he has what it takes to handle the hot seat. He is also a fan favourite and the victory-starved supporters showered him support, carrying placards saying "Ramadhan the tactician, we believe in you."

It will also be cost effective, as the government of Malawi has put its foot down not to engage an expatriate coach, as Ramadhan works with conditions suited for local. Getting a monthly salary of about US\$30,000 is still a better deal than the five times less what he used to earn at Malawi flagship league champions Nyasa Bullets.

Ramadhan took charge of the team against Swaziland on Sunday at Kamuzu Stadium after the dismissal of Mtawali as head coach. Malawi scrapped a 1-0 deserved win through a Gerald Phiri 8th minute free kick, which ensured the Flames their first win in nine Africa Cup of Nations qualifying

"I would like to thank the govern-

ment of Malawi, Football Association for offering me this chance," he said.

He also commended the supporters for turning out in large numbers to watch the formality match, regardless of the outcome it would not have had any impact on the teams chance to qualify.

His undertone also showed that he underrated his predecessor Mtawali who was his boss.

The Burundian said he was delighted to see that the same players, used in the campaign had delivered on his future, the former Bullets coach who is fluent in Malawi's national local language said it was not for him to decide.

Guinea-Bissau will be the only newcomer at next year's finals, whilst Senegal was the only team to have won all six matches. Other countries who qualified include Burkina Faso, Cameroon and Senegal.

Mabila has served in successive PLS executives. He has been widely regarded as a far stronger candidate with better credentials for the position.


Sought for comment, Mabila thanked the PLS for putting it's trust in him.

Sought for comment, SFCA Secretary Aaron 'Katalala' Mavimbela denied

that Baxter was going to offer free services to local coaches.

"I cannot agree with Baxter saying he was going to come here for free as his local representative told us to pay E11 200 for his expenses. Unfortunately, we couldn't raise that amount on time since we are still working on our membership registration process. It was impossible for us to raise the money from nowhere," he said.

When asked about Baxter's statement that he would not honour invitation of the current executive, Mavimbela said they were open to seek other international experts when necessary.

"We are not puzzled by his statement because we can go for other international coaches from other countries. If we want to organise other seminars, we can always engage our members for recommendations," he said.

A source close to matter also revealed that two local business people had pledged to assists the association and cater for some costs of the seminar.

"There were two individuals (names deliberately withheld), who offered to cater for Baxter's accommodation costs but the issue was not handled well by the negotiating parties," the source said.

Baxter won the two ABSA Premierships with Kaizer Chiefs and recently won the 2016 Nedbank Cup with his current side SuperSport United.
