ASIANS SHOCKER; MPS BUST THEM

FINALLY, the cat is out of the bag. Investigations on the influx of illegal immigrants into the country are pointing at the heart of the ministry of home affairs, where a senior officer is raking in millions of emalangeni in this illegal but rather lucrative business.

Members of a parliamentary select committee tasked to investigate the influx of the illegal immigrants were shocked to the marrow to find out that a web of corrupt, multi-sectoral officers have cunningly established a neat networking system of trafficking hundreds of people of Asian origin into the country. The senior home affairs officer is a ring-leader in the massive human trafficking scheme involving some members of the Royal Swaziland Police, entry-point officials and a host of other players, each of whom have a critical role to play as

members of the human trafficking syndicate. For each person trafficked, the ring-leader is said to be getting no less than E10 000.

Those being trafficked are mostly from Bangladesh, India and Pakistani and a few nationals within Africa, mainly Nigerians.

bers of the House of Assembly at one of the country's entry points, King Mswati III International Airport, was conducted last week.

It revealed shocking figures that in every flight landing in the country from OR International Airport in Johannesburg, on average, nine Asians are always on board. Four flights land at the airport daily.

Corrupt Senior Home Affairs Officer nets E360 000 a day

CONSERVATIVE estimates based on the activities taking place at King Mswati III International Airport alone show that the corrupt officer makes on average E360 000 per day for trafficking 36 illegal immigrants.

From the nine immigrants alone in each flight, the corrupt senior. officer who is reportedly charging E10 000 per person makes a hefty E90 000 per flight.

In the four flights per day that brings on average 36 illegal immigrants, the officer makes E10.8 million a month.

In 30 days, the E360 000 translates to E10.8 million. Figures at the airport show that four flights

land into the country every day with an average nine people of Asian descent per flight and that multiplied by four equals to 36 immigrants per day.

This means per annum the officer receives a whopping E129.6 million if he enjoyed an uninterrupted flow of the immigrants.

Biggest

This is probably the biggest human trafficking syndicate in Southern Africa.

The agents who transport the immigrants from the airport to their respective destinations are reportedly paid E3 000.

Two Swazi men were seen lying low at the airport to avoid the roving eyes of the legislators.

Home Affairs shifts goal posts

FOLLOWING a parliamentary resolution to suspend the issuance of memos granting foreigners entry into the country by the ministry of home affairs, the ministry has since shifted the goal posts and created a new entry sys-

The parliamentary select committee said they found that the ministry has since introduced what they call a visitors pass and a dependence pass.

Minister Princess Tsandzile and Principal Secretary Anthony Masilela are political and administrative leaders of the ministry respectively, making them equally responsible for implementing the House resolu-

The newly introduced system of dependence pass enables foreigners staying in the country as company directors to import their own, of any age group, even a 75 year-old retiree, as a dependent.

When calling for the suspension of the memos issued by the ministry pending the investigation, parliament was trying to reduce the influx of the illegal immigrants until a permanent solution to the national problem has been found. The ministry, however, continued to issue the memos in a different name.

Documents

Those willing to contribute in the fight against illegal immigrants said they found it difficult because they arrived with documents allowing them to enter the country as visitors only to disappear into thin air once they were inside the coun-

"You wonder why a person would travel all the way from Pakistan to visit a place for only ten days where he knows no body does not even know where to sleep," said one offi-

Also noticeable was that most of the immigrants were using new passports, an indication that for most the trip to Swaziland was the first international travel for them.

Asians in verbal showdown with probe team MPs

PARLIAMENTARIANS last week had a verbal showdown with immigrants where they came face to face with them at the King Mswati III International Airport.

The select committee led by Zombodze Emuva MP Titus Thwala went to the airport to see for themselves the allegations that were made by Lobamba Lomdzala MP Marwick Khumalo when he moved the motion calling for the selection

of the ten-member committee to look into the influx of the illegal immigrants.

Indeed Khumalo's allegations were confirmed when a flight operated by South African Airlink landed at 13:40 with Bangladeshi and Pakistan nationals whose visit into the country was highly question-

First to appear from the arrivals terminal was a man of mixed colour who seemed to be without issues.

He was followed shortly by Health Minister Sibongile Ndlela and a few African natives.

A few minutes later, a flood of people of Asian descent emerged pulling their luggage

Committee

They were met by curious MPs Thwala, Jan Sithole, Frans Dlamini, Johane Shongwe, Patrick Motsa and the committee clerk Celumusa Khoza.

With the assistance of officers man-

ning the airport, the MPs intercepted the suspects and enquired about their destinations.

Soon the MPs were outnumbered by the immigrants who were joined by those who had come to pick them up.

An Indian man who was rushing to grab the immigrants was stopped dead on his tracks by the MPs who asked him to produce his particulars.

The Asian man checked all his pockets and produced a Swazi National Identity card that was marked non-Swazi, which forced the officials to demand proof that he Was resident in the coul The man got irritated and with a raised voice told the MPs his papers Were not with him.

While quarrelling with the MPs, both his hands gesturing, Shakeel Ahmeb who had come to fetch his 'cousins' rushed to his fellow Asian to warn him against 'talking nonsense.'

Ahmeb said he stayed at Magevini and wondered what was going on at the airport because: "we collect our people every day here without any hassle."

Limkokwing University suspends 12 students

LIMKOKWING University of Creative Technology (LUCT) has suspended 12 students for allegedly disrupting classes.

The university sought and obtained a High Court order restraining the 12 students who were eventually suspended by the

University. The 12 students' suspension is pending disciplinary proceedings in accordance with relevant LUCT procedures.

This is contained in a press statement that was released by the University's Vice Chancellor Professor Cedric Bell.

"During the course of last week the University encountered attempts by a minority of students to disrupt

the running of the University.

This involved serious misconduct on campus including disruption of classes, damage to property including interference with health and safety equipment, intimidation of fellow students and some cases of stone throwing including at police officers," stated Bell.

Bell states that the majority of LUCT students wanted to continue with their studies as they were on campus studying as usual and were not involved in the disruptions.

Concern

He said the safety of both the students and the staff was the primary and overriding concern to the management of the University, hence the need to attain a court order against the 12 students and subsequently their suspension.

Bell further said the University is committed at all times to listen to legitimate concernas of both staff and students.

"It is satisfied that the matter, the minority group of students have brought to the attention of the campus management has been properly and responsibly addressed" he said.

Complaints Last week a group of Limkokwing students delivered a petition in Parliament which had complaints that LUCT's lecturers are not qualified to teach at the institution because they have similar qualifications that are pursued at the institu-

'Limkokwing lecturers incompetent'

LIMKOKWING lecturers are allegedly not qualified to lecture at the institution because they have similar qualifications that are persued at the university.

This was said by students of Limkokwing University of Creative Technology (LUCT) in a petition they delivered in Parliament.

The petition was addressed to Speaker of the House of Assembly Themba Msibi. It was received by Assistant Clerk-at-Table Mathokoza Dlamini. The students were led by their Student Representative Council (SRC) under the chairmanship of Baphatse Dladla.

The students also complained that they were allowed by LUCT to go to class without adequate infrastructure and adequate materials.

These included computer labs for

Information Technology (IT) modules and standard kitchens for Hotel Management students.

"It is in this institution where students share a kitchen with an external business (Eclipse Catering) for their Food Preparation practicals," read part of the petition. The institution was also blamed in the petition for allowing students to go to class without adequate learning materials like chairs and desks. According to the students, previous SRCs have had endless meetings with the institution about the provision of all materials and equipment that students needed to

further their studies. "It is worth noting that each Swazi child pays a total of E58 000 as their tuition fee. The government adds an additional E33 700 as accommodation and meal allowance and E9 000 as a book allowance.

This means that the Government of Swaziland pays a total of E101 200 for the three years," the petition read in part.

The students stated that as a future generation of this country, they decided that they could not let their future go down the

drain. They voiced out that they did not want to be taught by lecturers who were not qualified and they wanted the institution to be improved and be favourable for learning purposes. They urged the speaker of the House of Assembly to give the matter urgent attention. The petition had a picture of a group of students being taught outside a lecture room.

COP SHOOTS SOLDIER IN **PUBLIC OVER YELLOW BONE**

A Manzini-based member of the police criminal investigation department gunned down a soldier in broad day light near the notorious Liqhaga Flats last Friday.

The incident occurred in full view of members of the public as an enraged Constable Dludlu brutally shot Singinzini Army Barracks-based Private David 'LP' Dlamini.

However, when the second bullet miraculously missed the soldier's head by inches, Dludlu kicked the now bleeding profusely Dludlu as he lay on the ground helplessly, further hurting him on the left eye.

Constable Dludlu who is said to have been plainly clothed, attempted to murder Dlamini in full view of his friends, who also watched in shock.

Assistant Chief PICO Phindile Vilakati confirmed the brutal shooting of Dlamini by a police officer.

Soon after the spine chilling public display of violence, Constable Dludlu went to the Manzini police station to hand himself to his fellow colleagues.

Dlamini was then rushed to Raleigh Fitkin Memorial Hospital and on

Saturday he could walk unsupported, surrounded by his friends and family members.

According to Vilakati, Dludlu is believed to have used his personal firearm to commit the offence.

"We are still conducting our own investigations despite Dludlu surrendering himself to the police," she said.

Those close to the matter said the bone of contention between these two members of the disciplined forces revolved around a two-timing employee of FNB Swaziland known as 'Tholie' who is allegedly dating the police officer and a friend of the soldier. The implicated friend in the love triangle refused to comment on the matter.

Close sources said the police officer was driving Tholie's car. The other boyfriend in the company of the shot soldier were looking for Tholie who claimed to be in a salon.

"Just when the boyfriend and the soldier was negotiating for a parking space, some few parking spaces away they saw Tholie's parked car. The soldier, popularly known as LP, was allegedly the first to disembark from the car and went straight to Tholie's car.

"Manyatsi was supposed to contact the Municipal Council of Mbabane about the meeting so that they would then instruct me to inform Zone Six residents about the meeting. No one informed me about the meeting. I

Mkhonta went on to say Manyatsi tired to disturb the meeting by grabbing the microphone from the person who was announcing the meeting in the area. "However, the people attended the meeting in their numbers. They were not intimidated by what was happening. About 70 people were in attendance," she said.

She said they were talking about electricity schemes in the area.





Jobs Galore: Catholic Church's E47m sugar cane project

SATURDAY was a historic day for Siphofaneni community as the Roman Catholic Church officially launched a E47 million sugar cane planting project which promises to employ about 90 percent of area's the employed people.

This project which has already made a difference in the lives of the neighbouring communities by creating employment opportunities was officially launched by Bishop Jose Luis Ponce De Leon at St Philips on Saturday.

Speaking during the event the Bishop said as a mission they declared their interest in growing sugar cane to Ubombo Sugar

Limited (USL) in 2010, but they were advised land alone was not enough as they needed to get a water permit and also do a soil survey.

Leon said they did not succeed the

first time hence they had to try

He said after discussions with the USL, it was agreed a farm would be developed through a concessional lease to USL.

About E47 million was spent to develop the farm and plant sugar cane

The net area of the farm was 427 hectares with more than five pivots and semisolid sprinkler irrigation.

Father Jose said since its inception, during the project development, community members were engaged by contractors who were doing land preparation and irrigation system installation, planting and fencing.

"During the cane growing season, at peak season, 50 people were employed in the farm and 90 percent are from local communities. Two small businesses have been engaged to harvest and haul sugar cane. About 90 cane cutters are employed to harvest sugar cane," he said. With the country facing a serious drought problem, the project was not spared.

The Bishop said before the project

Commenced, there was a serious Water crisis, particularly amongst the inhabitants of the mission.

Magician's murder case

LATE MAGICIAN'S FAMILY CAN'T FIND CLOSURE

EXACTLY three months since Mbabane magician Mduduzi Gama died, his family wants closure on his demise, as nobody has explained to them as to how and why he died.

The late magician died allegedly at the hands of the police and they (police) supposedly dropped him on the roadside at Mvakwelitje.

Gama who hailed from Mbabane Zone 2 is said to have been last seen by eye witnesses being dropped by a police van with two police officers inside (male and female) at around 05:00 hours on that fateful cold day (June 1), only to die from severe wounds on his head two hours later.

"We cannot move on with our lives if we still do not know who did that to our brother, he is a loved one to

us and we want answers," his brother Sicelo said, adding that this incident had also divided the family.

He noted that there was more anger between the members who wanted answers and those that want the magician to be left to rest in peace.

"My family members have gone quiet about this matter, no one seems to want to get the answers, and it is making me more angry, especially when I wake up and find that it was only in my dreams that my older brother was alive, it hurts to not know what happened to him," Sicelo added.

The late magician's brother said police had also been untrustworthy as regards this matter, as they never came back to them after promising to do so.

"The Royal Swaziland Police Services promised to get back to us, yet it has been three months now. There is no clear explana-

THE Royal Swaziland Police (RSP) Services says it is still investigating the case of the late Mbabane Magician Mduduzi Gama.

Acting Chief Police Information and Communications Officer Phindile Vilakati said, "we still have not found the culprits on this case and we are working around the clock to find them and bring them to justice.

We can also add the fact that the eye witness saw a police van, does not mean the police are responsible, it is still an allegation."

tion as to what killed one of our own, we need closure and we need to mourn our brother well, we have not yet received the post mortem results either," Gama added.

Meanwhile, Acting Chief Police Information and Communications Officer Phindile Vilakati said the post mortem results were only for the court.

"The results are the evidence collected for the court, should this matter be taken there, we do not give them to the families and we can not interprete them either, as it is written in medical form," she said.

She added that even in court, only the doctor who conducted the post mortem would detail the findings and not the police. "We only collect evidence and forward it to the relevant people, even if it is against us as police, which is rare," Vilakati added.

Man cons woman E22 000 for property, has sentence reduced

A man charged with conning a woman a sum of E22 000 has had his prison sentence reduced after his five-year sentence was suspended for three years.

Siboniso Manyatsi must have been a happy man when his attorney, Simo Simelane, successfully submitted that his sentence must be suspended as the accused person has learnt his lesson

The fact that Manyatsi has also paid the full amount of E22 000 back to Xolile Nxumalo also worked to his favour as the court said it considered that too when passing sentence.

Manyatsi had been initially sentenced to five years in a correctional facility or a fine of E5 000. It is said on, 2010, Manyatsi enticed Nxumalo into buying an incomplete house at Timbutini yet he knew it did not belong to him. He ordered Nxumalo to deposit a sum of E22 000 so as to be the new owner of the house.

However, according to his attorney, Manyatsi received an attractive offer from another willing buyer and he was tempted to accept it even though he had already taken Nxamulo's money. Manyatsi's lawyer informed the court that his client used a third party to pay back the money and he had successfully managed to put the complainant back to the position she was on before defrauding her.

"The item on sale was once seen by the complainant, he was willing to sell her the house but a better offer emerged. He never planned on defrauding the complainant. A meeting has also been arranged your worship between the complainant and the accused, in a quest to bring closure into this matter," Simelane made his submissions in court.

He said Manyatsi was more than willing to smoke the peace pipe with Nxumalo while adding that the court should also avoid slapping him with a harsh sentence as what was more important was that the complainant should get her money back while the accused was rehabilited rather than punished.

The attorney also asked the court to consider that Manyatsi had three minors and also that he just started a trucking business, something that usually comes with huge debts.

"Suspending his sentence is also very much effective as this will always keep him on his toes, he will know that once he commits an offence the suspended sentence would catch up with him," Simelane said.

Principal Magistrate Fikile Nhlabatsi agreed with Simelane's submissions while adding that the court would give Manyatsi the benefit of a doubt that he has learnt his lesson.

Nurses offside -Ministry of Health

MINISTRY Health Principal Secretary Dr Simon Zwane says the country's nurses are offside by saying they will not support the roll out of the early access to ART programme.

The PS said it was wrong for nurses not to support the programme.

He said if the nurses had a concern, they must engage with the relevant structures and discuss the issue.

Zwane said he would like to believe that the nurses were not opposing the programme because they were against it, but maybe according to his opinion it might be because they were not properly engaged.

Zwane said even when the ART programme was introduced in the past, there were issues but they engaged with each other and sorted them out.

Indian nationals fined E2 000 for illegal stay

AS the investigations into the influx of Asian nationals continue, four Indian nationals have been fined E2 000 for being in the country illegally.

This follows a raid by the Mbabane police whereby they uncovered the Indian nationals in places such as Msunduza, Extension 3 and Parkview Heights.

According to the charge

According to the charge sheet, the four were arrested last Wednesday after it was discovered that they remained in the country even though their entry permits had expired.

Bhaiyat Yusuf (41), Faruk Ahmed (34), Waseem Muhammad (28) and Kudiya Hasan (35), were represented by Lawyer Sabelo 'Chicken' Dlamini, who told the court that his clients instructed him that they were remorseful about their illicit conduct.

They all pleaded guilty while appearing before Principal Magistrate Fikile Nhlabatsi at the Mbabane Magistrate's Court.

They were convicted and found guilty of the offence of contravening Section 14 (2) (c) of the Immigration Acts

17/1982.

During mitigation, whereby Dlamini represented each of them, the court was told that the first offenders used the legal entry points when coming into the country as they possessed legitimate travelling documents.

However, their crime was deciding to remain in the country when it was apparent that their entry permits had expired. "I request the court to be lenient when passing sentence as by pleading guilty it shows that they know they have done something wrong and they did not waste the court's time. They intructed me that they will fix the issue of entry permits as soon as they leave the court," Dlamini said.

Nhlabatsi slapped each one of them with a fine of E500 or five months of imprisonment. On another note, the court has sentenced yet another shoplifter to pay a fine of E500 or face the prospect of spending five months in jail after he was found to have stolen a roll-on deodorant valued at E8.99 at Shoprite supermarket. Gcina Mhlanga pleaded guilty to the offence of shoplifting and further apologised to the boss of the suermarket. "I apologise for my actions, I will never steal again, I mainly want to apologise to the owner of Shoprite for my actions. I also plead with the court to be lenient with me when passing sentence," Mhlanga said.

COUNTRY'S UNEMPLOYMENT RATE SADDENING - FSE&CC

FEDERATION of the Swaziland Employers and Chamber of Commerce (FSE&CC) Chief Executive Officer Bonisiwe Ntando has decried the high level of youth unemployment in the country.

She said it was saddening that Swaziland faced a major youth employment challenge, as evidenced by one of the highest youth unemployment rates in SADC and widespread youth idleness.

Ntando was speaking during the third graduation ceremony of Gwamile Voctim held at the institution's premises last Friday.

She challenged the graduates to develop an entrepreneurial mindset and start exploring opportunities of utilising their acquired skills for the establishment of businesses.

The CEO said the development of youth entrepreneurs and of entrepreneurship could help stimulate the country's economic growth, and help reduce the unemployment gap currently faced by youth in the country.

Ntando said as the voice of business, they were also concerned for many years, women had not been associated with, or considered for jobs in male-dominated industries, resulting in the country having highly occupationally segregated workforces in some sectors.

"It is assumed, for example, women are most suited to do work involving caring and nurturing, and so, women's work is found in areas like health care and education; not in roles that are operational, technical or in the trades," Ntando stated.

She said this stereotyping was reinforced in all aspects of everyone's lives as a society.

She said this included at home, where parents often adopted stereo-typical roles themselves, from anything as simple as who does the ironing or takes out the trash, to who works full time and who is the primary care giver. She said the problem started at home as it was also rare to see women and girls encouraged to consider careers in mining, construction or utilities.

Ntando said as a business commu-


FSE&CC Bonisiwe Ntando called for more women to join the building and plumbing department.

She said as the business community, they encouraged VOCTIM to correct the misconception that the entity was male-dominated by providing cases and content for their websites and promotional materials that would inspire, and attract women to enroll for programmes such as engineering, plumbing and bricklaying. An important employment challenge was to tackle occupational segregation of traditionally accepted 'male' and 'female' jobs and to break the barriers in opening

Ntando said women were only slowly penetrating the professions traditionally dominated by men.

"Young women, particularly in developing countries, are often unable to take advantage of training opportunities due to barriers to entry, discrimination in selection and gender stereotyping. This needs to change," Ntando said.

She added that such under-representation of women continues to undermine gender equality, industry performance and the country's economy. Ntando said women's economic participation was a gamechanger with the potential to transform entire economies and societies.

Mpolonjeni resident arrested for DD, while found on driver's seat

A man has pleaded for the court's mercy after he was found on the driver's seat while intoxicated.

This offence landed Themba Maseko of Mpolonjeni to a fine of E1 800 after he was found to have contravened section 91 (1) as read with section 122 (2) of the Road Traffic Act of 2007.

Maseko was slapped with two counts, with the second one being found to have wrongfully and unlawfully drove his Toyota Corolla and parked it on the roadway of Mpolonjeni Public Road.

While representing himself before Principal Magistrate Fikile Nhlabatsi, Maseko pleaded guilty to both counts.

Nhlabatsi then asked Maseko if he could confirm a breathalyser was



conducted on him. Maseko said the result of the test showed there was 0.84 mg per litre of alcohol in his body.

"I ask the court to be lenient with me as the police found me seated on the driver's seat. I was not driving the car," Maseko said.

Nhlabatsi convicted and found

him guilty as per his own pleas. For count one, he was sentenced to a fine of E1 800 in default of payment 18 months imprisonment. While for the second count he was sentenced to pay a fine of E800 or spend six months in jail. Nhlabatsi said sentences would run concurrently.

MKHOMBE NABBED FOR DD

ABOUT three of the five offenders who appeared before the court to answer for drink-driving charges claimed they were nabbed while rushing close relatives to hospital.

They said had it not been for emergency calls to rush their close relatives to hospital, they would not have committed the offences they faced.

Ronnie Mkhombe (52) of Thembelihle, who was arrested at Msunduza, was amongst those that appeared before Fikile Nhlabatsi and claimed to be rushing a relative to the hospital when nabbed.

"I ask the court to be lenient as I am a first offender. I received a call that a certain cousin of mine was sick and I had to attend to that," Mkhombe mitigated.

This comes after Mkhombe was slapped with two charges said to have committed while under the influence of alcohol at Msunduza. It is alleged, while driving his Mitsubishi LDV, Mkhombe wrongfully and unlawfully parked it on the roadway thus contravened the Road Traffic Act.

However, the first offender pleaded not guilty to the count of wrongful parking, thus he was only sentenced to a fine of E2 000 or two years in a correctional facility. He was acquitted and dis-

charged for the other offence.

Another offender, Daniel Jookim (42) of Corpation also claimed he was from taking his child to hospital when he was arrested for drink-driving at Corporation. Jookim was nabbed on Saturday with his results from the breathalyser reading 0.77mg/l.

Convicted

He pleaded guilty to the offence and was convicted and found guilty as per his own plea.

"I apologise to the court. My child was sick. I will not commit such an offence ever again," he

Principal Magistrate Fikile Nhlabatsi sentenced this lawbreaker to a fine of E1 700 or the prospect of spending 17 months in jail.

Accused, Mxolisi Shabangu was also slapped with two traffic counts of driving while under the influence of alcohol and also wrongfully parking his car.

While mitigating, Shabangu said he was taking his child to hospital when he got arrested.

He pleaded guilty to both counts and he was sentenced to pay a fine of E1 000 for driving a motor vehicle while high. He was further slapped with a fine of E800 for parking his car in an unlawful manner. The sentences ran concurrently.

MY DRIVER WAS DRUNK TOO

IT was a case of being unlucky for one, Lunga Mndzebele (29) of Mbangweni after the driver he had organised also got drunk, leaving him with no option but to

drive himself.

Mndzebele was arrested in the early hours of Sunday morning at Sidwashini whereby it was discovered his breathalyser results stood at a whopping 0.93mg/l.

He was fined E2 000 or face two years in a correctional facility.

HIGHER EDUCATION COUNCIL TIGHTENS ITS GRIP

THE Swaziland Higher **Education Council (SHEC) has** sharpened its teeth against institutions that are non-compliant to the country's higher education regulations.

SHEC Chairperson Makhosazane Madolo said since cabinet had passed the higher education council regulations, the council was ready to crack the whip on non-complaint institu-

Madolo said she was not expecting any institution to be found on the wrong side of the regulations since when the council was drafting the regulations, they regularly held consultation meetings with stakeholders on how the regulations should be shaped for the betterment of the quality of the education system in the country.

"The regulations basically are to ensure that the learning institu-



tions provide quality education. Education is advancing all the time and ours is to make sure that our institutions meet the advanced standards," she said during a stakeholders meeting held at the Royal Villas on Thursday, where the regulations were launched.

On that note, SHEC Executive Secretary Mboni Dlamini said the programmes that the institutions provided in their entities, should

be in line with the higher education regulation.

"All stakeholders must be in possession of the regulations as they will guide them on what is expected of them. Education and skills are under transformation and all the institutions must provide competitive skills," he said.

Dlamini said the council conducted a two-year study and the findings drove them to make the regulations for the higher educa-

"The study found there was a fragmented provision of the postsecondary education meaning the system lacked internal relevance. The lack of a regulatory body system of training providers meant there was a mushrooming of unregulated providers which created a doubtful quality of higher education. The study also found that training provisions were isolated from the market needs with available programmes being outdated," he said.

Dlamini said the study also discovered there was lack of lifelong learning and no coherent qualification system. He said SHEC then intervened and drafted regulations of higher education quality assurance. "The council also saw a need for the development and implementation of a coherent qualification. There was a need to protect student and their investment, to enhance excellence across providers and to encourage investment and innovation," he said.

MEDIOCRE LECTURERS IN FOR A SHOCK

LECTURERS found to be holding mediocre and fraudulent qualifications to what they are teaching in the institutions will fry.

SHEC Executive Secretary Mboni Dlamini said the council would conduct certificates verification so as to ensure the lectures qualify for the courses they were teaching.

"You cannot be a degree holder and be teaching a degree qualification.

A lecturer teaching a degree qualification needs to possess a much higher qual-

For all those lectures who studied out of the country the council will investigate the authenticity of their qualifications from institutions where they obtained their qualifications from.

Once the authenticity is verified the council will then evaluate foreign qualifications to the local standard to determine if its' quality allows its bearer to lecture those particular programmes.

Heads are going to roll," he said. He added the council wanted to ensure the education quality that was produced in the country was at its best hence the overhaul the whole higher education system. "The council will also conduct surprise quality control audits in all institutions," he said.

PLAY-ACTING ACCREDITATION IN ADVERTS WILL GET YOU PROSECUTED

EDUCATION institutions that bear false information about their accreditation status when advertising their programmes will be prosecuted.

SHEC Executive Secretary Mboni Dlamini said some institutions had a tendency of advertising their institutions claiming they were fully accredited and fully regis-

tered when it's not the case. "The law will take its cause on all those institutions. They will have to tell us which office accredited and fully registered them. Institutions must not misrepresent facts at the expense of others education," he said. Dlamini said non-compliant institutions would have their operating authorities revoked. "We will engage the institution before the license is eventually revoked," he said. SHEC Chairperson Makhosazane Madolo further advised the institutions to organise themselves so it may be easy for the council to communicate with them. "For ease of communication between us we need you to be organised," she said.

E5 000 to establish a university

SHEC Executive Secretary Mboni Dlamini says establishing a university will cost providers E5 000. Dlamini said the establishment fees would secure a provisional authority which has a stipulated time frame and if requirements are met the institution will be fully

registered at another E5 000. He said once an institution was fully registered it would be accredited at another cost of E5 000, "Colleges will also undergo the same process but their fees are slightly lower at E2 000 for all the three processes, while vocational institutions will

be expected to pay E1 000 for each of the processes," he said. "New programmes should be registered with SHEC for approval. Programmes evaluation and accreditation will be charged at 0.72 percent of the total nuition fees for annual programmes," he said.



Hawane Dam now stands at 1%

HAWANE Dam now stands at one percent carrying capacity after the rains that were received over the past weekend which saw Mbabane recording 28.1mm of rainfall.

Swaziland Water Services Corporation (SWSC) Corporate Affairs Manager Nomahlubi Matiwane confirmed that the dam now stands at a capacity of only one percent.

"The past weekend's rains saw the dam rising from nothing to one percent," she said. Matiwane further highlighted that even though the dam rose from zero to one percent,

they were still not using it. "We are not using the dam, instead we are using tributary streams which are better due to the rains received over the past days," she

She also mentioned that the tributaries were also starting to disappear.

Matiwane said the rains experienced over the weekend did not do much to the levels of the dam.

Meanwhile, the Swaziland National Meteorological Services Department said there were rainfall drizzles expected before the week ends in some parts of the country.

Impact The impact of the El Niño induced drought continue to be felt across the country even though sporadic rains are currently enabling the maintenance of a four-day water-rationing system in Mbabane.

The Swaziland Meteorological Services' current seasonal rainfall forecast had indicated a slight trend towards normal to below normal rainfall for October, 2016 to March, 2017 in parts of Shiselweni and Lubombo, which are already the areas most impacted by the drought. MET's forecast also indicated that the whole country might receive normal to below normal rains in the period from January to March 2017.

INKHOSIKATI LAMATSEBULA TALKS ABOUT CORPORAL PUNISHMENT

ABOUT 758 million adults across the world cannot read or write a simple sentence.

United Nations Educational, Scientific and Cultural Organisation (UNESCO) Secretary General Hazel Zungu said two thirds of these are women.

Zungu was speaking at the Timphisini constituency last Thursday as Sebenta National Institute and UNESCO celebrated the 50th anniversary of World Literacy Day.

Zungu stated that since the inception of the International Literacy Day by UNESCO in 1966, the number of young adults without literacy skills had decreased by 25 percent and 43 countries worldwide including Swaziland had shown major improvements in gender parity and equality.

The event was graced by her Royal Highness Inkhosikati LaMatsebula as well as Hhohho Regional Administrator Prince Tshekedi as well as the Minister of Education and Training Dr. Phineas Magagula along with Timphisini Member of Parliament Sikhumbuzo Ndlovu who participated in a three kilometre walk that marked the beginning of the event.

Guest speaker at the event, Inkhosikati LaMatsebula stated that teachers should discipline children in order for the country to have a bright future. She said this was because even a young King Sobhuza II was also disciplined by his teachers that was why he was such a successful King.

She said the lack of corporal punishment in schools nowadays could be compared to giving children free education, but no knowledge as the children lacked discipline therefore


successful.

TAIWAN FUND BUILDS E1m KITCHEN AT MBANGWENI

A charity organisation with its origins in Taiwan has helped in the construction of a state-of-the-art soup kitchen at Mbangweni, a project that has cost close to E1 million.

The Taiwan Fund for Children and Families (TFCF) was approached by the Shiselweni Home Based Care (SHBC), to assist with funds to construct the beautiful neighbourhood care point (NCP) kitchen which is a different design from the common NCPs that exist in other communities around the country.

SHBC is a Shiselweni based ministry founded by Dr Arnau van Wyngaard who is a pastor of the Shiselweni Reformed Church.

Dr van Wyngaard has been hailed in a number of communities in the region for his efforts in improving lives of the destitute and orphans as well as the sick.

His ministry is fully involved in assisting communities in a number of ways and now wherever he goes, many refer to him as 'Hope of The Needy'.

Dr van Wyngaard was showered with accolades by almost all the speakers during the official opening on Friday, an event that was graced by authorities from Mbangweni chiefdom as well as representatives from Shiselweni II Inkhundla.

TFCF Director Cash Kuo who was accompanied by some of the organisation's employees also attended and delivered a speech. The organisation was the main sponsor of the project as it splashed out a sum of E788 503 and this donation was made towards the end of 2015.

In her remarks, Kuo thanked SHBC as well as the Mbangweni chiefdom

for the dedication they showed from the first day the project started up to the last day it was completed.

The TFCF Director said it was after meeting the parties that were involved in the planning of the project of this nature that they (TFCF) saw it proper that it should be funded.

The zeal and vigour shown by Dr van Wyngaard in changing lives of those less privileged touched TFCF hence they did not hesitate to assist in a project of such magnitude.

"The desire of TFCF for Mbangweni is to see the standard of life improving

and this project its part of this desire. You will have at least a decent structure for cooking, access to clean water, a better storage for things like food. This facility we are handing over today has a pre-school, playground and is well fenced. In addition, there is a garden and toilets of the required health standard," said Kuo.

Kuo also thanked all the caregivers saying they were a dedicated team and kind. She noted the love the caregivers have for the children on daily basis and said it showed their humanity and true 'ubuntu'.

SHBC takes care of close to 1 000 children

MEANWHILE, Dr van Wyngaard disclosed that SHBC has a total of 11 NCPs it caters for and a total of almost 1 000 children fed in these NCPs.

Others include those at Edwaleni, Matsanjeni, Hlushwana and now SHBC has also stretched its assistance to Big Bend which is in the Lubombo region.

Explaining about the work of Shiselweni Home Based Care (SHBC), Dr van Wyngaard said what they were doing was encouraged in the scriptures. He said SHBC was a God sent organisation built on a Christian oriented foundation.

"God is using us to do his good work.

In fact we are His partners as he can't come from heaven to do what needs to be done here on earth. Through us, He is able to do what needed to be done, that is assisting the needy in these communities," said Dr van Wyngaard.

Speaking on behalf of the caregivers, Monica Hlophe said they were pleased as women to see progress and it was pleasing to see a project of this magnitude completed. She said what was also interesting was that it was a project fully supported by the authorities of the area.

"We are encouraged that the soup kitchen is right at the umphakatsi's door step and that they (elders) allocated this piece of land to have such a project built is another indication that the authorities of Mbangweni are caring about destitute people of the area," said Hlophe.

The NCP at Mbangweni caters for 124 children who will get a meal daily.

Soldier arrested for killing royal game tried to bribe rangers

licence or permit while at
Milwane is said to have tried to

bribe game rangers so as to avoid losing his job.

John Zakhele Dlamini (51) was arrested for hunting and killing an *Inyala* and *Inhlangu* while at Mlilwane Game Reserve.

Dlamini who is based at Ngabezweni Army Barracks was arrested together with David Zakhele Ntjingile (54).

The two first appeared before

Magistrate Xolile Nxumalo who released them on bail of E2 000 each.

During their court appearance last Thursday it was revealed that Dlamini who was found at the Game Reserve was driving his vehicle during the time of committing the offence.

It is alleged Dlamini left his vehicle outside the game reserve and proceeded with four other men to hunt. It is said when the two were caught, they produced a letter which belonged to a Ginindza man that gave only Ginindza the permission to hunt at the nature reserve. The witness in court said even the letter that the soldier produced was not his and it did not give the owner permission to hunt for any other animals except for wild pigs. Shiba told the court that after the two were caught, the soldier is said to have tried to bribe the

game rangers so that they could not take him to the police because he feared that by so doing he was going to lose his job.

Shiba told the court that he made it clear to Dlamini that the animals they have killed were of great value as they were Royal Game and therefore he could not forgive the soldier for committing such an offence. When asked how much the cost of the killed animals was, Shiba stated that the total value was E3 600.

The ACC was called in. They interviewed the minister and in the middle of that exercise. Dlamini's mouth was ordered shut, so was his political movement.

He was only free to do shopping. Never mind that such came at a huge cost to taxpayers. The same way Magobetane Mamba was set against the public by being paid yet he was sitting at home.

We all knew his condition was unfortunately not improving. He was finally rested last Friday too. In an attempt to clear his name, Dlamini alluded to insinuations that whosoever was peddling this E1.4 million story was wasting his/her

Suppose

Like the late Jack Selebi, Dlamini declared that his hands (both of them) were clean. So, all hell broke loose, I suppose.

They, too, led the chorus of feeling undermined by ministers' failure to attend parliament work and I expect them to rise above arrogance.

Whilst Gamedze rarely attracted the attention of the media in his debates, Nxumalo is known to be the loud one. Loudness in politics is what matters.

He was not to be brought down by that incident as he was elected a councillor in Manzini and was subsequently elected mayor. He ran the city.

Claims

I will deliberately not touch the E11 million question that arose in the middle of his reign. He claims him and his team were cleared but residents are not happy such that they want the matter re-opened. They want proper closure so to speak.

Despite that set-back, Nxumalo raced to parliament until last Friday when he reached the pinnacle of Swazi politics. I hope he will add value. Or better still, he could do like some ministers I know, keep quiet and just enjoy the meal.

The ministers I am talking about are those that subscribe to the African axiom that 'you don't talk in between your meal'.

During the same press conference where the appointments of Gamedze and Nxumalo were announced, something puzzled me. The PM did not impress me. He spoke out of turn. I think I now appreciate him more when quiet. He makes a lot of sense to me when in that state. A polite way of saying he has reached the end.

At the press conference he said the mess taking place at SIPA had not reached his office. What more does

the PM needs to know that SIPA is in a mess than what he reads in newspapers?

I have always known this PM to be very particular about what he reads and if need be he is very quick to set the record straight. It made me suspect that the PM is condoning what the CEO Phumelele Dlamini is doing to both the staff and the country's image to investors. Here I am talking about a woman who was sent on special leave by the board but declined. It's called insubordination in industrial terms.

South Africa is known for its extreme income inequality, which is one of the highest in the world.

Ten percent of the population earn around 55 - 60 percent of all income, compared to only 20 - 35 percent in the advanced economies.


But while the top income share is high in its own right, it pales in comparison to those for wealth; such as real estate, pension funds and shares of listed companies. New tax and survey data suggest that 10 percent of the South African population owns at least 90 - 95 percent of all assets. This share is much higher than in the advanced economies, where the richest 10 percent own "only" around 50 -75 percent of all assets.

Why does wealth matter? First, the level and distribution of wealth in a country are important indicators of its citizens' longterm welfare. Whereas income and consumption tell us something about a household's current living standards, information on wealth is important in assessing whether the household can sustain these living standards during spells of unemployment or throughout retirement.

But wealth is also of particular concern for long-term inequality. This is because wealth can generate its own income (such as interest, dividends, rents, and capital gains), and can be passed on between generations.

Over time, small differences in assets can therefore grow larger and larger. As Thomas Piketty argues in his influential book on wealth and inequality (Capital in the 21st Century), this tendency has been one of the biggest drivers of growing inequality in both advanced and developing countries.

SANEEDS TO FIX ITS DANGEROUSLY WIDE WEALTH GAP



A growing number of studies have suggested that high inequality can have unfavourable political and economic consequences, which is why South African policymakers are increasingly concerned about it. Currently, most initiatives focus on inequality of income and consumption, since these variables are closely linked to poverty and exclusion.

But based on my own research I argue that narrowing the wealth gap also deserves close attention.

WHY WEALTH IS **DIFFICULT TO MEASURE**

We know South Africa's wealth distribution is highly unequal. It is, however, very hard to measure precisely how unequal it is. This is because our usual tools are well suited to measuring income and consumption, but not very good at measuring wealth.

The most widely used data on living standards come from household surveys. Their main limitation when it comes to measuring wealth is participation is voluntary and richer households tend to be less likely than others to participate.

Because of these limitations, researchers have started to use data from tax records. Since tax filings are mandatory, tax data do not run the risk of under-representing individuals at the top of the distribution.

LAST week the Cape Peninsula University of Technology (CPUT) announced their fees increase for next year. Read about it here: CPUT Fees Increases

Their plan is an eight percent fees increase for the 10 percent "rich" students. The "rich" students are those whose families earn R600 000 per year and more. All of this in reaction to Fees Must Fall, now in its second

The 10 percent "rich" students will contribute R26 million to the CPUT budget. They are about 3 000 students. That leaves CPUT R94 million short next year. 90 percent Of students will get a 0 percent fees increase. For the second year in a row.

If Fees Must Fall was about fees increases, then, as Tabitha Bailey said about Unisa, the students have achieved their goal. No fees increase for 90 percent of students must be a huge victory... IF you were aiming at

achieving no fees increases. However, I think that Fees Must Fall is about free education. And a zero percent fees increase does not mean that you are studying for free.

WHAT HAPPENS NEXT?

Maybe the "rich" students and their parents are happy to pay more than the other students. But I suspect, not.

It is easy to be for or against a political or social idea. A "Like" on Facebook takes very little effort. But the real test is when it starts costing you money, or risk the future of your own child. So, we shall see if those parents and those students are willing to pay more.

CONSE-QUENCES I PREDICTED...

"Rich" students will find loopholes and become poor overnight.

Students will learn about the transportability of academic credits (hint: you can't just move to a different university).

A lack of funds will mean Universities have to "cut their cloak according to their cloth". First the "rich" students, and

eventually all students looking for quality education, will abandon the traditional universities and go private.

MOVING BETWEEN UNIVERSITIES

The "rich" students and their parents will start looking around for alternatives. Since they have to pay more, they will try and find better education for their money. And they will find more and more accredited and recognised private higher education institutions happy to take on their

The problem is a student who has finished one or two years at one institution, will not automatically be able to continue their studies at a different institution. These students are about to discover their academic credits are not very transportable. If you finished two years of a degree at CPUT, you cannot simply walk into the third year of that degree at a different university.

This lack of transportability of academic credits will keep most of these students captive in the institutions where they have started their studies.

NET GOVERNMENT BALANCES SLUMP BY 66.7%

NET Government balances with the banking sector over the year, have decelerated by 66.7 percent to reach E1.2 billion.

Month-on-Month government balances with the banking sector shrank by 41.4 percent.

The Central Bank of Swaziland (CBS) money and banking statistics August/September 2016 report said the contraction largely emanated from a combined effect of a decrease in government deposits held by the banking industry and an increase in claims on government over the review month.

"As a result, government deposits held by the banking industry contracted by 0.9 percent whilst claims on government grew by 32.4 percent over the review month," reads the

report in part.

The CBS further reported the country's gross official reserves stood at E7.5 billion at the end of September 2016, depicting a contraction of 5.3 percent when compared with August 2016.

"The decline in the reserves was mainly on account of payment of government's external obligations over the month of September 2016. At this level the reserves represented an import cover of 3.6 months, lower than the 3.8 months observed at the end of August 2016," reads the report in part.

The CBS said the value of the reserves in Special Drawing Rights (SDRs), closed at SDR386. 3 million reflecting a month-on-month growth of 0.3 percent. "When compared over the same period last year, the reserves decreased by seven percent in Emalangeni terms and by 6.2 percent in SDRs terms," the

CBS said

The report said Swaziland reserves represented an import cover of 3.6 months of goods and services, lower than the 3.8 months cover recorded in August 2016.

Meanwhile, the CBS reported the liquidity position of the banking industry stood at E3.6 billion at the end of August 2016, depicting an expansion of 12.8 percent compared with the previous month.

This development was attributed to the growth in commercial banks' balances with the Central Bank and investment in government securities over the month under review.

"Over the month of August 2016, the banks' liquidity ratio rose to 27 percent from 25.8 per cent in July 2016. Compared on an annual basis, commercial banks' domestic liquid assets expanded by 52.5 per cent," said the report.

The CBS reported credit advanced to the private sector reached E12.3 billion at the end of August 2016 from E12.4 billion in July 2016, reflecting a month-on-month decline of 0.6 percent. On the other hand. credit advanced to businesses closed at E5.6 billion over the month under review, down from the E5.7 billion registered at the end of July 2016, representing a decline of two percent.

"Credit advanced to other sectors contracted by 0.9 percent to settle at E940.8 million at the end of August 2016, down from the E949.7 million recorded in July 2016.'

Credit advanced to households and Non-profit institutions serving households improved by 0.9 percent over the month of August 2016 to settle at E5.8 billion from E5.7 billion recorded in the previous month.

LACK OF STRATEGY COULD MINIMISE PPPS RETURNS

PUBLIC Private Partnerships (PPPs) should always be a long term investment to yield maximum benefits.

Recently, government has appealed to the private sector to form PPPs for the benefit of the country's economy.

QualConsul QS Managing Director Professor Raymond Nkado, said the main purpose for PPPs was the diversification of skills that it brings about.

"PPPs should have a long term duration, typically 20 years or 40 years not the two to five years that occurs in most African partnerships," he said. Nkado was speaking during the second annual Asakhane Construction Indzaba hosted by the Construction Industry Council (CIC) held last week at Esibayeni Lodge, Matsapha.

Adding, he said within any PPP there were three main components and it was important that the relationship is managed properly.

"There is the private sector, the public sector and other stakeholders which include the public, the last group is often ignored in the partnership yet they play an integral part of the relationship," he said.

Nkado said another issue that often results in minimal returns of a PPP was that of lack of strategy.

"Any PPP should have a strategic plan which is written down for all the parties to understand and use as a reference point," he said.

When considering a PPP, Nkando said the parties should consider the benchmark that would be able to determine the success of the venture.

"With any PPP, the issue of value of money is always thought of.

Pointless

It is pointless conducting a venture that will then be of little value for the economy as a whole," he said.

He said what must be remembered was that these were public funds, so the issue of value for money has to come into play.

"Value for money does not mean the venture is a profit maximising endeavor, but the social benefits should also be considered," he said.

MTN SWAZILAND SEEMS SAFER FROM THE GROUP'S DOWNGRADE

THE MTN Groups-downgrade of its long term debt to junk status by international rating agency Standard & Poor's (S&P) is unlikely to have an effect on MTN Swaziland.

According to a South African publication, Business Report, the company officially informed the market last week that S&P had lowered the group's long-term corporate credit rating to BB+ from BBB- and its South African national scale rating to zaA+ from zaAA, with a stable outlook.

The ratings agency maintained a cap of two notches above the blended sovereign rating of Nigeria and South Africa, which is currently BB-.

"The sovereign downgrade reflects increased risk for MTN Group, as MTN Nigeria is a significant contributor to the group," the company reportedly said. However, University of Swaziland (UNISWA) lecturer and financial analyst Kennedy Hlatini said if there would be any effects for MTN Swaziland, there would be minimal.

Downgrade

The recent downgrade of MTN group resulted from a negative sentiment within their two most important subsidiaries, Nigeria and South Africa which between them contribute over 60 percent of total revenues.

"Of cause MTN Swaziland's own credit will be affected, but to a very limited extent since MTN International owns about 30 percent and considering the size of the Swazi market, it may be safe to say that the levels of implicit support should MTN Swaziland face a financial crunch are not great and hence the downgrade should not result in a very significant rise in the cost of debt for Swazi MTN," he said. Hlatini said the different subsidiaries would normally borrow from their domestic markets in order to avoid the

volatility of currencies and as such they would rely on their own credit ratings.

"In the event that MTN
Swaziland has or intends to borrow from the parent company, the parent will lend in line with its own assessment of the riskiness of the cash-flows of the subsidiary and will most likely rely on the same ratings by the international rating agencies, although in practice most parent companies would provide guarantees depending of course on the importance of the subsidiary and the corresponding implicit support," he said.

MTN Swaziland Corporate
Affairs Manager, Mandla
Luphondvo when contacted
referred the issue to the group's
director of communication.

"I cannot comment on this issue as this is a group matter and there are people within the group's structure who are best placed to comment," he said.

Meanwhile, the corporate finance academia said rating agencies' methodologies were all based on a 'bottom-up' approach that first determines a stand-alone credit rating for the subsidiary.

Relationship

"They then factor in the relationship with the parent. Then, a judgment is made based on a number of factors as to what extent the parent would provide the support in the event of financial stress. In general, these factors reflect the importance of the subsidiary to the parent and the nature of the linkages between them," he said. He said once the overall significance of the factors has been assessed, the number of notches by which the stand-alone rating should be improved or reduced was then determined. "This of cause suggest that most subsidiaries receive their own rating which is based on their own country, industry and specific fundamentals which is then adjusted with the perceived importance of the particular subsidiary to the parent company," he said.

NMC resumes selling split beans

THE National Maize Corporation (NMC) is re-exploring the concept of trading in split, red, spleckled sugar beans locally.

These are beans that have been split in half, either during harvesting or pre-cleaning and grading process and can no longer be graded as Grade 1 beans.


However, NMC Marketing and Communications Officer Nokwanda Dlamini-Masuku said since their Officer Nokwanda nutritional value, quality of flavour and hygiene don't get compromised, these beans could be sold in the market at highly discounted prices.

"These beans are very attractive and favourable to the end consumer, because they are lower priced, therefore, affordable to most.

They cook in much less time, hence save on energy and time; and yet they remain as delicious as the full red, speckled sugar beans," he said.

She said this was not for the first time that NMC has traded in split beans.

"NMC introduced split beans into the market in 2015 and they were



received with great enthusiasm by the public," she said.

However, she said it was a pilot project that was halted due to short supply.

She said the organisation has since been flooded with orders for the beans and thus has re-introduced them back into the market to gauge interest, with a view to possibly adopt the product as a full NMC pre-packed product. She said the corporation would continually seek ways to contribute to food security.

She said the organisation understands that other than being able to produce enough maize to sustain itself, the country and its citizens also need to be able to access good quality food at affordable prices, hence this venture.

"All quality processes are always followed by the NMC, when handling her food products.

Therefore, the split beans, like all our grains, will be tested and quality assured for human consumption, thus, the public need not be concerned about the quality of split beans.

They do indeed remain the

same quality and flavour and are high in nutritional value as is the full red, speckled sugar bean, thus this is truly a potentially good buy," said the marketing and communications officer.

NMC also trades in white maize; red speckled sugar beans and parboiled long-grain Thai rice which Masuku said they were fast becoming household names in the country.

Govt bonds better investment to beat inflation

INDIVIDUAL Investors looking to beat Swaziland's high inflation rate could do well by investing in government bonds.

A financial analyst from a leading financial services firm said subject to the individual investors risk appetite, investment horizon time period and fixed income, government debt instruments present an opportunity for investors to obtain returns that are higher than inflation.

"It is widely accepted that in the investment industry government bonds can be considered the closest investment that is said to be risk free as it is unlikely that a government will default on its financial market obligation," he said.

"In terms of investment objectives, investors have many and varied objectives. Parents, for instance, may want to set money aside for their children's education without it being eroded by inflation. Bonds can be able to achieve this objective," he further stated.

The analyst made an example of a parent who has a seven year old

child and buys a fixed term 10 year government bond at 10.75 percent.

"The parent would get annual interest payments of the money they invested for ten years and at the end of that period they would receive their initial investment. At this time the child is likely around 17 and is looking to get into tertiary education this investment would go a long way in paying for their tuition," he said.

Government recently announced that it would be floating its SG027 bond which has a coupon rate of 10.75 percent; currently inflation is at eight percent per annum was

projected to decline by some economists.

Interestingly
Swaziland's inflation, according to inflation tables obtained from the Central Bank of Swaziland (CBS) has not exceeded 10.75 percent since 2010.

"Investors should be aware however that they cannot buy more bonds with their interest payments to benefit from interest payments.

However what they can do is to invest their interest proceeds in Treasury Bills or alternatively in

unit trusts and this will help them achieve some

semblance of compound interest," the analyst said.

SA needs to get it right this time

SOUTH Africa has its sights set on the 2019 general elections, which many people believe stand to herald a new era another beginning.

That might and might not be true. But before then, we have a number of key milestones to reach and some hurdles to overcome and get out of the way. How we deal with the latter over the next two to three years will contribute to bringing the picture that will emerge in 2019 into sharper relief.

The most crucial of these is the country's looming credit rate assessment by the big three credit ratings agencies - Standard & Poor's, Moody's and Fitch - on whether South Africa has met all the minimum conditions to avoid being downgraded into junk credit status.

Having succeeded in pushing off a feared downgrade earlier this year, Finance Minister Pravin Gordhan has again gathered another Team South Africa, comprising representatives from government and big business for another roadshow and charm offensive in the UK and US.

Their mission has become all too predictable: to convince both investors and creditors despite appearances, the country is in the hands of good, disciplined leaders who are committed to operating within good, sound, and predictable governance principles.

They also have to convince them that the much-publicised phenom-

enon of state capture exists only in the minds of people who do not have the country's interests at heart, and National Treasury is not under threat of being handed over on a platter to a bunch of faceless people who want to plunder it for nefarious pre-armageddon interests.

For the sake of us all, we wish them much success.

The next milestone - seeing there has not been a change of leader-ship at the top of the ruling party despite seminal court judgments, a dismal electoral performance, and increasingly strident public calls

for change - will be the ANC's elective conference in 2017.

Calls for this conference to be brought forward seem to be losing momentum. What we see, instead, is a growing drive to weaken the belief of many inside and outside the ANC that it is always traditional for the deputy president to succeed the president.

This revision seems to be gaining impressive traction, despite it being the same call that was made repeatedly by one Julius Malema, at the time an influential player within the ruling party, when he led a coalition of the wounded

who insisted on the then deputy succeeding the then president.

Strangely, history seems to be repeating itself. The same Dr Nkosazana Dlamini-Zuma who was touted as the most qualified potential successor to former president Thabo Mbeki is now being promoted as the most qualified and preferred candidate to succeed the current president, ahead of his deputy Cyril Ramaphosa.

Strange

In his strange silence on leadership issues and his own ambitions, Ramaphosa is increasingly becoming like the man who occupied his position before the last general elections, Kgalema Motlanthe. He doesn't seem to have learned anything from his experience. This silence is also, apparently, tradition; but an aspect of it that all seem to agree has to be respected.

Accordingly, no one pronounces his or her presidential ambitions in public unless they want to have a ton of bricks falling on their heads. So Ramaphosa will continue to stand by, hoping for the best, while his formerly admired personal brand gets eroded inch by inch.

There was much hope when he was roped in because many thought he was the kind of level-headed leader needed to help bring a semblance of order in the house by balancing developmental needs with market requirements.

SA sheds 67 000 jobs in second quarter - Stats SA

JOHANNESBURG – South Africa's formal economy shed 67,000 jobs in the second quarter of this year.

That's according to the latest Quarterly Employment Statistics, released by Stats SA on Friday. The biggest quarter-on-quarter decline was in the social and personal services sector which shed about 48,000 jobs.

The manufacturing and transport sectors lost 7,000 jobs each. Mining and manufacturing have been under sustained pressure this year.

Year-on-year mining lost 32,000 jobs. Meanwhile, the construction industry posted an increase of 1,000 jobs compared to the previous quarter. But it's not all bad news – Stats SA says remuneration increased very slightly. Gross earnings have risen by R32-million. *eNCA*

Property mogul pays R125m for car number plate

DUBAI - Indian businessman Balwinder Sahani paid 33 million dirhams (R125m, S9m) for a Dubai license plate for one of his Rolls Royces.

Sahani, who owns an international real estate management company, also purchased another plate for One million dirhams. Shock fine for top SA insurer in NZ

CAPE TOWN - One of South Africa's biggest insurance companies is in hot water in New Zealand, after pleading guilty in that country to more than a dozen major misconduct charges - including debiting consumers' bank accounts without their permission.

Managers at Youi, sister company of South Africa's OUTsurance, admitted to 15 transgressions.

It was also announced this week that, as a result, Youi had been fined the maximum possible penalty of \$100 000 (R993 000). According to the OUTsurance website, Youi, which stands for You Insured, is a short-term insurer which "follows the same customerorientated approach that has made OUTsurance successful in South Africa". The Youi website said it complied with the South African Insurance Association.

But this week the Board of the Insurance Council of New Zealand announced Youi had pleaded guilty to 15 charges, and warned any further misconduct on its part would result in the termination of its council membership.

Willem Roos, Chief Executive of OUTsurance Holdings, Youi's parent company, told Weekend Argus they were dealing with the matter.

He said a few unrelated incidents of misconduct had been picked up in South Africa. "We have identified isolated instances of

unacceptable sales practices in South Africa."
"OUTsurance has also engaged our regulator, the Financial Services Board, on the matter to ensure they are fully informed," Roos said. Fin24

LAGARDE SAYS EGYPT HAS MORE TO DO TO SEAL \$12 BILLION LOAN

CAIRO - Egypt has "almost completed" the actions required for the International Monetary Fund's board to review its \$12 billion loan accord, but some measures related to the exchange rate and subsidies are still pending, Managing Director Christine Lagarde said on Saturday.

The most populous Arab country

is relying on the deal to restore investor confidence and ease a dollar shortage that hampered the economy and led to the emergence of a black market for foreign exchange. Masood Ahmed, the IMF Middle East Chief, told reporters on Friday the board may be able to review the agreement by early November.

"There are several prior actions

which need to be completed before the board can actually meet," Lagarde said at a press briefing in Washington.

Knowledge

"To my knowledge, these prior actions are almost completed — not quite — in relation to both exchange rate and in relation to subsidies, there is still a little bit of implementation to be had before

the board can meet."

The comments will likely add to speculation that Egyptian policy makers will cut subsidies and devalue the pound before the IMF board meets and not after securing the first installment of the loan.

The pound has plunged to record lows in recent days on the black market on speculation a devaluation was imminent. Bloomberg

Mauritania opposition slams idea of third term for president

NOUAKCHOTT — Mauritania's opposition denounced the government on Saturday after it said that lifting the two-term limit on the president would be part of ongoing talks about constitutional changes, a move they say would favour the incumbent leader.

The question of the presidential mandate is indeed on the agenda" of the national dialogue launched on September 29, said government spokesman Mohamed Lemine Ould Cheikh, and in the comments released late Friday. "There is no limit on subjects to bring up" in the talks, which have been extended to October 13, he added. The opposition parties which are boycotting the talks say that such a move could see President Mohamed Ould Abdel Aziz run for a third term,. "(It is) a coup d'etat against the constitution" which could have "very serious consequences for the country," the opposition coalition said in a statement. The opposition groups participating in the talks in the West African nation threatened to withdraw from the dialogue over the issue. "These positions, coming from a top official of the state, are considered a provocation for the political forces engaged in the dialogue and threaten the continuing of the conference," said the spokesman for the National Democratic Alliance (ANP e by President Joseph Kabila. that critics say is airned at extending his stay in power into a third term. HARARE - Zimbabwean opposition, the People's Democratic Party led by Tendai Biti, has urged the African Union (AU) and the Southern African Development Community (SADC) to force President Robert Mugabe to cease power, a report said yesterday.

According to New Zimbabwe, the former finance minister's party handed a ten point petition to all member countries of the two blocs. The petition was addressed to the heads of state, the SADC troika on politics, defence and security, as well as to the AU executive council, AU judicial and human rights institutions and AU peace and Security Council. Egypt admonishes US embassy over Cairo security warning

CAIRO - Egypt has criticised an "incomprehensible" US warning to citizens to avoid theatres and malls in Cairo over the weekend because of unspecified security concerns, saying it could damage the country's economy.

The alert issued by the US embassy in Cairo on Friday was cited in a Canadian travel warning, with the British Foreign Office later putting out a message that copied the US warning. Embassy officials declined to comment, and

an Egyptian interior ministry official said he was unaware of any specific threat. "The US Embassy strongly advises US citizens to avoid large gatherings and public spaces such as concert halls, movie theatres, museums, shopping malls, and sports venues in Cairo through Sunday, October 9, (yesterday) due to potential security concerns," it said on its website. Egyptian foreign ministry spokesman Ahmed Abu Zeid said he "was disturbed" by the warning. "When contacted to clarify the reasons for issuing the security message, the US

embassy denied the presence of any particular reasons or security threats that triggered the alert," he said in a statement overnight

ment overnight.

He added that the embassy said it was a routine warning over long weekends. The embassy was closed yesterday, a workday in Egypt, for Columbus Day.

"The Foreign Ministry deplored, during the call (with the US embassy), these unnecessary alerts that can have negative impacts, particularly on the economic front," he said.

BRITS - Public Protector Thuli Madonsela on Saturday appealed to the Bapo Ba Mogale community in Bapong, Brits to stop fighting among themselves as she gave them a progress report on her investigation into the alleged looting of a tribal bank account.

"Just all calm down, there is no reason to fight... as long as we do not know who did what, there will always be suspicions," she told community members.

Her appeal came after a community member, Kgomotso Morare showed her his head wounds which he sustained from a panga two weeks ago. He was apparently attacked by a group of people accusing him of holding an illegal meeting.

Another resident, Dinah Sello, appealed to Madonsela to speed up the investigation and release a final report

into the affairs of the community so that the fighting between opposing groups could stop.

You left us empty by not releasing the final report. We do not want to wait for six months to get the report, please release the report so that fighting could stop," said Sello.

Madonsela said she would release an exit report by October 14, before she leaves office.

The final report was expected to be released in December or January to give forensic investigator Godfrey Rangongo and quantity surveyor Andre Moolman a chance to verify the information collected.

The community approached the public protector in 2012 to investigate allegations of systematic looting of the collective resources of the community, including funds held in the so-called "D account" - an account into which

mining companies pay royalties to communities on whose ancestral land they mine.

Madonsela was also asked to look into whether all of the royalty payments due to them from mining company, Lonmin, and other businesses mining on the community's land were paid. She was also asked to probe the alleged abuse of resources relating to the construction of Kgosi Bob Mogale's palace. On her last visit in July, Madonsela told the community that they had R721,000 in the account when the auditor-general audited it in 1994. Over a period of 20 years, the funds in the account grew to more than R617-million, which was made up of R392m in deposits and R224m in interest earned. By the end of 2014, the balance in the account had dropped to just over R495,000.

SABC drops attorneys who cleared Hlaudi

JOHANNESBURG - The SABC has parted ways with Mchunu Attorneys, the law firm that cleared former chief operating officer Hlaudi Motsoeneng of any wrongdoing despite the findings of Public Protector Thuli Madonsela in her 2014 report, called When Governance and Ethics Fail.

The law firm came to the fore when it was appointed by the SABC to consider and investigate the veracity of the findings and recommendations by the Public

In February 2014, Madonsela released the report on Motsoeneng - when he was acting chief operating officer - and found his salary had increased from R1.5 million to R2.4 million in one year, and purged senior staff and misrepresented his qualifications.

Madonsela recommended that a new chief operating officer be appointed within

But five months later, Communications Minister Faith Muthambi announced the permanent appointment of Motsoeneng in that position.

Muthambi said Motsoeneng was cleared of all wrongdoing by a legal firm before the decision was made.

It later emerged the legal firm was Mchunu Attorneys.

Then chairperson of the SABC board, Ellen Tshabalala, said:

"The SABC is satisfied that Mr Motsoeneng did not defraud it or mislead it. The public protector's findings of dishonesty and fraud are at variance with objective facts."



A HOME FIT FOR A PRINCE!

Fans descend on late singer's famed Paisley Park as his secretive studio complex opens to the public as a museum

MUSIC fans around the world and Minnesota residents have long wondered about Paisley Park, the late pop icon Prince's mysterious studio complex to which few have had full

Last Thursday, the mystery came to an end for some fans who snared tour tickets and descended on the Minneapolis suburb of Chanhassen to see inside the late Purple Rain star's 55 000-square-foot (5 100-square-meter)

The unveiling was decidedly muted. Organisers required ticket holders to meet at an offsite location and be bused into the complex in groups.

Fans described the tour as an emotional experience, especially when they were confronted by Prince's ashes in a Paisley Park replica urn.

Diane Fluin told CNN: "It was reverent. Everyone was very quiet and there was a lot of tears and hugging."

Sonja Fagan, a 37-year-old from Dublin, arrived with a bouquet of roses, saying Paisley Park was now a place of

"His legacy is going to live on, and that's what he would have wanted," she said. Fan Rhonda Watson traveled 1 000 miles (1 600 kilometers) from Tennessee to tour the complex.

"It is very unique and very distinctive, and it's a very creative space, just like the musician,' she said. 'I am very grateful that I am one of the people that got to experience that today.'


Another visitor, Erin Goetdel, told CNN: "As soon as I got in, I felt really honoured to be in a space that he had created to bring people into his world and his thoughts and his vision."

Prince died on April 21 from an accidental overdose of painkillers, at the age of 57.

The complex opens one week before a memorial tribute concert in St. Paul, which is adjacent to Minneapolis.

The public opening of the studio complex is a milestone for music lovers and historians. It was the pop legend's 'playground,' said Mobeen Azhar, author of the book Prince: Stories from the Purple Underground.

Paisley Park is where he would play, experiment and most importantly cre-

"That spirit of creativity is just so strong. For that reason, as far as I'm concerned, Paisley Park is holy ground." The complex opened in 1987, and was a fully functional recording studio used by a number of artists during its peak in the 1990s, including the Stone Temple Pilots, REM and Madonna.

Prince also arranged impromptu free shows and parties there for small groups of fans.

Shabazz, a professor of cultural geography at the University of Arizona, said he attended one such show in

which Prince took the stage at 12.30am before an audience of about 50 people.

The star performed for three hours playing every instrument and stepping

into the crowd to direct the band from the floor.

'You didn't have to have a ticket. You just walked in. You stood at the stage five feet from him" Shabazz said. Daily Mail



Belgium missed 13 chances to attackers

BRUSSELS - Belgian police missed 13 opportunities to unmask the participants of the deadly Paris November attacks before the events, according to an internal report leaked to a newspaper on Saturday. The police report in the De Tijd daily shows that as early as February 2015, the force was in possession of phone records linking known terrorist suspects to Salah Abdeslam, allegedly the sole surviving member of the jihadist team that attacked Paris in November 2015. The information however was not handled, due to lack of investigators, De Tijd cites the report as saying. Of the 13 missed chances for Belgian police to catch some of the Paris attackers, six were due to staffing shortages, the secret report said. AFP

Several wounded in shooting

JERUSALEM - An Arab assailant shot and wounded several people in Jerusalem yesterday and was then killed by Israeli police, a police spokeswoman said. At least two of the wounded - a police officer and a female pedestrian - were in critical condition. Army Radio said about eight people were hurt. The incident, near Israeli national police headquarters, began when shots were fired from a car at people waiting at a tram stop, the spokeswoman said. The assailant then drove off, chased by motorcycle police, and shot and wounded a woman motorist." Reuters

Police officers killed, one injured

LOS ANGELES-

Two US police officers were fatally shot and one injured on Saturday while responding to a domestic disturbance call in Palm Springs,

California, police said. The shooting occurred after two officers went to a home after receiving a report from a female caller that her adult son was causing a disturbance, police chief Bryan Reyes told journalists." The male refused to open the door and threatened to shoot the officers through the closed doors," Reyes said. Approximately 10 minutes after they first responded, the two officers called for emergency reinforcement. AFP

Over 80 mourners killed, hundreds wounded

SANA'A – Rebels in control of Yemen's capital accused the Saudi-led coalition fighting them of killing dozens of people on Saturday and wounding hundreds more in air strikes on a funeral in Sana'a. The strikes came as Saudi Arabia, which has overseen the bombing of Houthi rebels in Yemen since March last year, is under increasing international scrutiny over alleged civilian deaths in its air raids. Officials at the rebel-controlled health ministry in Sana'a said at least 450 people were killed or wounded in the air strikes, although there was no immediate independent confirmation of the figure. *Reuters*

Unicef calls for end to 'dire' situation

Beirut - Unicef's representative in Syria is calling for an immediate end to the violence that has beset the northern city of Aleppo, saying UN agencies are on "standby" to deliver needed assistance. Hanaa Singer of the UN's children agency said on Saturday conditions in besieged Aleppo were "terribly dire," with hospitals hit, doctors overwhelmed and over 100 children killed in bombings since September 10. Singer returned from the government-held part of Aleppo where she was visiting thousands of displaced Syrians.



REPUBLICANS REELING AFTER TRUMP'S VULGAR COMMENTS

NEW YORK - In a videotaped midnight apology, Donald Trump declared "I was wrong and I apologise" after being caught on tape making shockingly vulgar and sexually charged comments.

Yet he also defiantly dismissed the revelations as "nothing more than a distraction" from a decade ago and signaled he would close his presidential campaign by arguing rival Hillary Clinton has committed greater sins against women.

"I've said some foolish things,"
Trump said in a video posted on
his Facebook page early Saturday.
"But there's a big difference
between the words and actions of
other people. Bill Clinton has actually abused women and Hillary has
bullied, attacked, shamed and

intimidated his victims."

Trump's 90-second statement capped a jarring day that threatened to sink the billionaire businessman's White House campaign, sending Republicans into a panic with just over a month until Election Day and on the cusp of yesterday's crucial presidential debate.

Outraged

One by one, outraged GOP law-makers condemned Trump's comments in a 2005 video obtained and released last Friday by The Washington Post and NBC News. In the video, Trump is heard describing attempts to have sex with a married woman. He also brags about women letting him kiss and grab them because he is famous.

"When you're a star they let you do it. You can do anything,"
Trump says in the previously unaired comments. He adds seconds later: "Grab them by the p——.

You can do anything."
House Speaker Paul Ryan said he was "sickened" by Trump's remarks and angrily revoked an invitation for the real estate mogul to appear at a GOP event in Wisconsin on Saturday. But like most of the many lawmakers who slammed Trump's words as reprehensible, Ryan did not pull his endorsement of his party's nominee. *Reuters*

The potential ending of an alliance comes as a reaction to the international outrage of the slaughter of drug addicts and criminals at the hands of vigilantes and police in the Philippines. The Filipino president, dubbed 'The Punisher', has been heavily lambasted for his ruthless crackdown on drugs with the Philippines' death toll reaching more than 3 700 in less than three months, according to Al Jazeera. Duterte ordered the drug crackdown as an election promise fuelling widespread bloodshed - equating to 36 Filipinos dying every day in his first 100 days in office. Daily Mail

MOSCOW - The text message from Aleppo flashed up on my phone as I was curled up on the sofa watching animated film The Good Dinosaur with my wife and 14-month-old daughter. It came from a much-loved Syrian friend, a surgeon like me.

Written in haste, it read starkly: 'Massacres in Aleppo today... 168 cases arrived at the hospital. All of them civilians and mostly children.' The scene of family contentment at my home in South-West London instantly dissolved. For the next 48 hours I dispensed advice, directed an operation and issued general instructions via instant messaging service WhatsApp to medics 2,500 miles

away as they fought to save the lives of children pulverised by ball-bearings from cluster bombs dropped from the skies above the most benighted city on Earth.

Those injured had been lined up in an orderly queue at the time, waiting for bread to feed their starving families. As it transpired, 50 children were taken to hospital M10, the codename used by local doctors to disguise its location.


DUK REFUSES TO APOLOGISE AFTER ELBOWING NEYMAR

BRAZIL - Bolivia defender Yasmani Duk is refusing to apologise after elbowing Neymar and demands that the Barcelona forward stops his 'Charlie Big B***** behaviour'.

Duk has been in the headlines after catching Neymar full in the face during his country's World Cup Qualifier against Brazil on Thursday - a blow which caused a gash on his eyebrow to bleed heavily.

Totti open to a career in coaching

ITALY - Roma legend Francesco Totti admits he would be open to becoming a coach when he retires, although the 40-year-old acknowledges he would have to change his temperament beforehand.

Totti's playing contract with the Giallorossi is due to expire at the end of the season and he may then retire from professional football. The forward has yet to make a final decision on his future but is eager to prolong his stay at the Stadio Olimpico by potentially joining the club's backroom staff, and he would take the necessary steps to prepare for the role.

Speaking to Corriere dello Sport, Totti said: 'I do not know what the future holds, but I know it will be something enjoyable.

"Part of me would like to start coaching. But I am not thinking about it too much yet, because I know it might not be easy to handle a group of players with my character.

"But I see all my former teammates starting a career as a

JAPAN - Lewis Hamilton admitted he 'made a mistake' after his slow start handed Nico Rosberg victory at the Japanese Grand Prix.

Starting from second on the grid, Hamilton crawled off the line, getting swallowed up by several cars to lie eighth at the end of the first lap.

On arriving at his grid slot before the race, Hamilton appeared concerned by a damp patch on the tarmac, the result of overnight rain at Suzuka. But the Briton insisted that had no adverse effect.

"The damp patch had nothing to do with it," said Hamilton. "I made a mistake.

"I just got some wheel-spin, I need to see what the engineers say."

Hamilton fought his way back to claim third place and said: "I did the best I could from where I was in the race. I'm happy with clawing it back

"It was a different level to Wayne, of course, but Paul Merson transformed Portsmouth for me. He arrived back in 2002, the lads loved him and he was a good player given a fresh test of his character. "There are certain players who thrive off that and Wayne might



just need a new challenge," he added.
"He would be a great signing for a couple of seasons and could have a major impact on a Premier League club. "He could tip the balance for a top-four

team if United were to let him go. I'd take Wayne at Arsenal or Chelsea and he has to play as a No.9 or 10, midfield isn't for him yet."



ANDY MURRAY DOWNS NOVAK DIMITROV TO WIN CHINA OPEN

BEIJING - Andy Murray claimed the title at the China Open in Beijing yesterday, taking a step toward unseating world No 1 Novak Djokovic.

He romped to victory in straight sets on a chilly night in the Chinese capital, having not dropped a set in the tournament.

Murray's 6-4, 7-6 (7/2) win over unseeded Grigor Dimitrov is his fifth title of the year and 40th of his career,


The Scot's victory moves him 1 000 points closer to long-reigning world No 1 Djokovic, with the chance of taking the top spot by year-end and capping off a career-best season.

Murray broke Dimitrov's serve in the opening game of the match, putting the 15th-ranked Bulgarian on the defensive as he made 21 unforced errors in the opening set.

In the second, both held their serve through the first four games until Murray broke Dimitrov at 3-2.

It looked like the Scot would serve for the championship but Dimitrov – who beat Rafael Nadal en route to the final – won the next 11 points, breaking Murray to love.

Pushed to a tiebreak, the three-time Grand Slam champion immediately seized back control, storming through



the decider to claim his first title in the Chinese capital. Dimitrov had received a free pass through the semifinals after Canadian Milos Raonic pulled out with an ankle injury, but was left overwhelmed by the Scot.

"I just didn't feel I had another gear," Dimitrov told reporters after the match. "Andy's fighting pretty much every single point.

You know you're not going to get anything for free." With his 40th win, Murray is the 16th player in the open era to win at least 40 titles and the fourth active player to accomplish the feat, joining Djokovic, Nadal and Roger Federer.

When the new leaderboards are released Monday it will be the first time since computerised rankings were introduced that a British man (Andy Murray) and woman are ranked in the top 10 at the same time.

Konta claimed two top 10 scalps en route to the final, sixth-ranked Karoline Pliskova and number eight Madison Keys, but she was kept on the defensive oyesterday. The Briton, usually a solid baseliner, repeatedly pushed to the net as she tried to shift the match momentum in her favour, but it was a risky strategy that cost her 29 unforced errors.

AFRICA - Ivory Coast beat Mali 3-1 to go top of Group C after Gabon and Morocco had earlier drawn 0-0.

DR Congo thrashed Libya in Group A, winning 4-0 in Kinshasa.

In Group D, Senegal beat Cape Verde 2-0 after Burkina Faso and South Africa had drawn 1-1. The reigning African champions, Ivory Coast, took on Mali in Group C in Bouake with a largely new generation of players in the post Toure-brothers era. The hosts were put under pressure after just 18 minutes when Sambou Yatabare scored to give Mali a 1-0 lead. It took eight minutes for Ivory Coast to level the match, with Aston Villa forward Jonathan Kodjia scoring an equaliser. Five minutes later, the Ivorians went 2-1 up after Mali's Salif Coulibaly struck into his own net.

Ivory Coast took a commanding 3-1 lead in the 34th minute when Gervinho (pictured), one of the few existing members of Ivory Coast's so-called "golden generation" volleyed in to put his side top of Group C, above Gabon and Morocco who drew 0-0 in Franceville earlier.

Gabon, hosts of the 2017 Africa Cup of Nations, were left frustrated by Morocco at home. They looked to their Borussia Dortmund talisman, Pierre-Emerick Aubameyang, to conjure up a winner and he came closest to scoring in the 68th minute, only to see his header cleared off the line by Moroccan goalkeeper, Munir. 




