

SHOCKER: USED CONDOM IN SUGAR AT SWAZILAND MILLING


n a shocking incident, a used condom and a piece of toilet paper were found in a 25kg bag of sugar packed at Swaziland Milling (PTY) Ltd and shipped to a yoghurt manufacturing company, Clover in South Africa.

On the strength of a polygraph examination otherwise referred to as a lie detector test at least three employees have since been sacked by the company in connection with the shocking incident. After the polygraph was administered on the three employees and they were found to have failed the tests they were immediately charged with grossly dishonest practices and intentional damage to company property and image. Subsequent to a ... disciplinary hearing they were all found guilty and immediately dismissed from working for the company they had on average worked for in over 10 years. They were all dismissed on the strength of deceit that was according to the company sensed by the polygraph test.

According to minutes of the disciplinary hearings, the gory discovery of the bag of sugar containing the used condom and toilet paper was made in South Africa just before the sugar could be used and Clover SA raised an alarm by alerting Swaziland Milling about the discovery through an email. The employees that are directly connected with the packing of the sugar were quickly hauled into a meeting by the Swaziland Milling management, told about the email and called upon to come forward with information pertaining the incident. After none of the employees came forward with the required information they were then informed that a polygraph test would be administered to them if no information was forthcoming.

Indeed an expert from South Africa

was brought into the country to conduct the polygraph on a total of 11 of the company's employees that are employed in the pre-packing division and were working closely to the sugar packed on the date of the incident – March 21, 2016 when the sugar was packed, loaded and transported to South Africa. They were made to sign consent forms before the procedure was entered into. A total of 10 questions were asked to each of the 11 employees with five of them relevant to the incident.

Amongst the questions asked were: Are you going to lie to the questions in this test; before the condom was found in the sugar were you aware of any plans to contaminate the sugar: did you put the condom in the sugar; do you know of an outside party who arranged for the sugar to be contaminated; and do you know for sure the name of the person who put the condom into the sugar?

Three of the employees failed the

test and were swiftly suspended and subjected to a disciplinary hearing by the company. As per the outcome of the disciplinary hearing the employees were therefore dismissed and they all further lost their appeal cases. This was after they all challenged the reason behind the use of the polygraph while also arguing that there was absolutely no evidence as to their involvement in the condom and toilet paper being found in the sugar.

The employees confirmed that they were now in the process of taking the matter to the Conciliation, Mediation and Arbitration Commission (CMAC) for redress as they feel they were irregularly dismissed. Meanwhile, Swaziland Milling Managing Director (MD) Leon Jacobs said the former employees were well within their right to take the matter to CMAC just like the company was also within its rights to take the necessary steps to

They can't rely on lie detector test alone – Labour Expert

labour expert has highlighted that it defeats proper labour practices for a company to rely only on a polygraph test in getting to the bottom of a case they have against their employees.

Reached to give a view on whether Swaziland Milling was right to use the lie detector results to make a case against the sacked employees the labour expert said it was not procedural to use the lie detector alone in winding up the case as there are many factors involved in the polygraph process.

"For one, the employee may be under a lot of pressure as to falter when asked questions.

They could be scared of the machine for instance as they could be using it for the first time. On the other hand, while they might consent to being subjected to the test, but such can still be under duress due to fear of being victimised if they do not consent. All in all there should be enough evidence to nail any employee for wrong-doing and not just results from a polygraph test," said the expert.

The labour expert further advised the aggrieved former employees to exercise their rights by taking the matter to CMAC for further redress.

Jacobs stated vehemently clear that the polygraph was accepted globally and that it had been tried and tested for many. He said he found nothing wrong with using the polygraph on his employees as even in their recognition agreement it was included that such a tool could be used on the employees. He further

argued that the results of the three employees were outstanding from the rest that were also tested and he found nothing wrong with using the polygraph results in winding up the case.

"The polygraph has been used all over the world for many years before and has been submitted in courts as evidence. It is also widely used in the industry. An expert from South Africa was brought in to authenticate the entire process and there was absolutely nothing wrong with it," said Jacobs.

discipline the three. He said his company was not one that treated its employees unfairly as they made sure that all proper procedure was followed in whatever situation.

"There was absolutely nothing wrong with the procedure we followed as we took all the lawful steps to punish the offenders.

If they feel otherwise they are well within their rights to take all the necessary steps in seeking redress on the matter," he said.

Terror alert SA: Don't panic, say cops

Police have urged the Swazi nation to remain calm in the aftermath of reports of likely terror attacks of mainly United States and British citizens in South Africa.

Chief Police Information and Communications Officer Superintendent Khulani Mamba said they were following developments closely in that country adding that the intelligence department was monitoring information and if needs arise communication would be flowing. He emphasised that so far there was no need to fear anything.

In the meantime South Africa's

Presidency issued a statement on the terror alert for South Africa after the International Relations Department on Thursday morning said the United States which issued the warning - handled the matter badly.

Warning

The US has stood by its decision to issue the warning. The South African Presidency says the two countries continue to enjoy cordial relations and will discuss the matter as part of on-going cooperation on security. Over the past few days the United States, Britain and Australia have issued travel advisories, urging their citizens to avoid tourist hot spots in South Africa.

The US says it has information pointing to a possible terror attack, in either Johannesburg or Cape Town. International Relations has issued this statement in response,

saying it's unhappy with the manner in which the information was handled. It's describing the information as dubious, saying it was provided by a walk-in source.

It's also accusing some countries of trying to manipulate and control South Africa's counter-terrorism efforts. The statement follows reports that a discredited East African businessman was the source of the alert, but the State Security Department will not confirm this.

The US Embassy in Pretoria is sticking to its original line.

US Embassy Spokesperson, Cynthia Harvey said," There is no change in status of the Security Message issued on June 4, 2016. It was based on specific, credible, and non-counterable threat information. We have been, and continue to be, pleased and impresse with the high level of professionalism and transparent cooperation with the government of South Africa throughout this period." In February, ANC Secretary General Gwede Mantashe accused the US of trying to destabilise South Africa, NGO's such as the Media Review Network and Cage have also spoken out against the warnings, saying they are an attempt to increase security and surveillance around Muslim communities in South Africa.

ANOINTED SALIVA, HOLY SPERM PROPHET HERE

n a rather 'holy' scandalous occurrence, a foreign nomadic Lprophet is alleged to be involved in adulterous relationships with Swazi women, and has further been accused of fleecing unsuspecting members of the public.

The prophet who has been in and out of countries is alleged to have been deported from Botswana after being accused of fleeing the poor, and found to have about USD 4 million in his bank account after being investigated by the Botswana home affairs ministry before moving to Swaziland.

Investigations carried out by this newspaper revealed that the prophet also allegedly fled Lusaka in Zambia after he was accused of having sexual relations with the female church community.

According to well placed sources, the prophet, Peter Bollaward of the Gory of the Later Rain Ministry, allegedly seduces women with his 'anointed saliva and holy semen' a thing that has resulted in some women who attend the recently established local church having sour relationships with their spouses.

The sources confided to this publication that once the prophet plants his hands on the women they allegedly throw themselves on him, resulting in

It has also been gathered that the prophet, whose church was once called the Glory of Lazania, was also discovered to be involved in the same shenanigans while in Botswana as he has love relationships with other women outside marriage.

This is the same prophet, who together with his bodyguards, assaulted a journalist while on duty as he was taking pictures of him after making a court appearance at the Mbabane Magistrate's Court for immigration charges.

This week our news team visited the church which is situated at the heart of the industrial hub in what is supposed to be a factory shell.

From what this publication gathered, the majority of the congregants comprised mostly women although a few males were also spotted.

Arriving in his sleek black Audi A4 for the evening services at about 5:15pm, the prophet who was in the company of three of his aides, waited until congregants started arriving just before 6pm.

While the other three men alighted from the vehicle, the prophet remained in the car up until the factory shell swallowed most of the congregants and by this time it was around 6:15pm, with more and more women arriving in rather expensive

News of the alleged adulterous prophet seem to be known amongst some people within the industrial area who normally clock in for night

When called for comment on his mobile phone, the man on the other line, however, said he was not the prophet advising this reporter that he might have called the wrong number.

Speaking in plain Pidgin, the man insisted he was not actually the prophet and asked where this reporter got his number from.

Thuli clings on Hospice's car

Thuli Msane, wants to Swaziland Hospice at Home, cling to the organisation's motor vehicle despite that she was fired about five months ago.

The organisation won an interim order directing a deputy sheriff to dispossess the motor vehicle from Msane.

Allocated

She is alleged to have left with a Chevrolet Captiva SUV she had been allocated by the organisation to use as she carried out her duties as its head honcho. Msane was fired on February 10, 2016 after being found guilty by a disciplinary tribunal. The organisation has alleged that it demanded return of the motor vehicle but Msane neglected to do so.

It has now instituted legal proceedings seeking an order directing her to return the motor vehicle forthwith. The organisation has further sought an order directing the police to assist a deputy sheriff in dispossessing Msane of the motor vehicle.

Msane has filed a notice showing intention to oppose the application.

The Swaziland Hospice at Home is represented by LM Simelane and Associates in the matter.

The Acting Directo,r Mefika Zwane, in an affidavit, claimed the non-governmental organisation was the registered owner of the Chevrolet Captiva SUV registered MSD 082 AM.

He claimed the motor vehicle had been officially given to Msane in 2010 while she was director of the organisation.

"The motor vehicle was assigned to the respondent (Msane) to enable her carry out her duties as the director of the organisation," Zwane said.

Terminated

He said when Msane's services were terminated, by letter dated February 10, 2016, she was also notified to hand back the motor vehicle together with other assets of the organisation that were in her possession. She had been given six days to have handed over the motor vehicle, from the date of service of the letter terminating her services.

"It is my submission that up to date the respondent has not delivered the motor vehicle to the

applicant.

I submit that the respondent has no legal authority to withhold the motor vehicle. The respondent is not the owner of the motor vehicle. Further she is no longer an employee of the appli-

I further submit that Msane is also not challenging the decision to terminate her services," her stated.

He further alleged Swaziland Hospice at Home had not been served with a notice of appeal by Msane challenging the decision

The organisation had been rocked by financial irregularities and a number of issues bordering on maladministration. The matter was postponed to June 24, 2016.

Prophet investigated

ollowing serious concerns from members of civil society about the alleged prophet's shenanigans, active investigations have been launched against him.

Although this publication is aware of the department investigating him, this will not be published for now as investigations are ongoing. It has been reliably gathered that the prophet was found to be in possession of a Swaziland National Identity in which he uses the surname Vilakati, a thing that has raised serious concerns. It has been reliably gathered that the Nigerian Prophet, Peter Bollaward, who was operating as the Glory of the Latter Rain Ministries in Broadhurst,

was detained in Botswana before

The same pastor was also arrested and charged with the same offence last year in August. He was found guilty and fined E500.

Chief Police Information and Communications Officer Superintendent, Khulani Mamba, confirmed the prophet's arrest this year. "He is a prohibited immigrant as he does not have proper authorisation for him to stay in the country," Mamba said. The prophet, who was arrested and charged for being in the country illegally, and his bodyguard assaulted a Times of Swaziland reporter when he took pictures of him at the Magistrate's Court early this year. The reporter, Sibusiso Shange, saw the pastor around the court premises and took a picture of him.

'Home affairs should intervene'

he Swaziland Conference of Churches (SCC) has said this is a serious issue that needs to be addressed by the ministry of home affairs. According to Bishop Steven Masilela of the Conference, although he does not know prophet in question, he has heard of the allegations and advised that such cases should be dealt with by home



LET'S STOP ASIANS TAKING OUR BUSINESSES — SENATOR

Princess Phumelele, a Senator, has called for the country to tackle the Asian problem where mainly Indians, Pakistanis and Bangladeshis have taken over small and medium businesses in both rural and urban Swaziland.

The princess is calling for a national indaba well beyond parliament to establish the immediate interventions not only to stem but also reverse the situation she says is a threat to nationhood in that it impacts negatively on the economy.

She supports her view with as much as basic observations that Swazi owned shops are closing down en-masse while the Asians are taking them over with impunity because of many loopholes in the governance system. Her other immediate concern is that of the Asians hiring mainly girls whom they further allegedly sexually abuse while giving them slave wages because they have no other available decent employment avenues.

"The girls in these shops are the ones that talk about their plight at the hands of the employer. Let us talk more about

this in parliament because the Swazil economy is not developing any further because of such malady."

The princess further notes that it is common knowledge that the Asian business owners do not bank their revenue but instead take it out of the country illegally.

She says previously shops and other small businesses in Swaziland were owned by people of very diverse nationalities such as Afrikaners, Britons, Portuguese, native Africans, Greeks, Italians but suddenly the Asians have swept their carpet from under the feet. She notes that the rural areas are now flooded by applications for grocery businesses with the land being slowly taken by the Asians

and in the process displacing Swazis.

"The native Swazi businesspersons are now renting out their premises to the Asians because these offer attractive rentals but in the long run with devastating effects in that the Swazi ends up being marginalised and permanently taken out of business including the transport business sector.


"Others argue that the Asians bring better stocked shops, are better organised compared to Swazis but this finally weighs heavily on the economy because they drain from it without investing in it in real terms."

The Asians now find their way into chiefs by acquiring land and citizenships through *kukhonta*, a system that is grossly being abused because there is no one called to account, she says.

"When we ask about this we are told there is a loophole in the constitution that allows foreigners to acquire land in the name of investment. There are also problems at home affairs where permits are being sold with individuals pocketing the money for themselves and letting loose the controls. There is a loud cry out there and Swazis say we are doing nothing in Parliament."

Home affairs denies selling of permits

66 We do not have a shop where we sell permits to aliens only that they come to apply for them and may be they at times bring false papers."

Principal Secretary in the Ministry of Home Affairs, Anthony Masilela, says there are several types of permits the main being the Temporary Residents Permit (TRP), there is also the study permit, the permits for company directors depending on the need of each applicant and these carry alongside them different fees also depending on duration of stay.

He adds that if, for instance they are issued with a 24-months permit, they then return three months before expiration for renewal and are often granted. While admitting that some may submit false papers at application, that remains illegal and not for them at home affairs to approve or condone.

He further explains that they conduct impromptu inspections where they arrest those who are holders of non altogether.

"Home affairs does not grant those leave to stay in the country illegally, they are arrested." He says even those who claim to have opened other businesses in a different address they are advised to declare and obtain the necessary papers operate or to stay at a particular area. Masilela acknowledges

that the law has been lax in that illegal immigrants instead of being deported are often fined and return to stay in the country illegally. He notes that it is relatively very expensive to deport illegal aliens especially



because the state must not foot only the bill of the deported person but also for the one to accompany them to their countries.

Cops catch illegal aliens, courts make them pay fines

Police have said they conduct raids regularly but because of some problems regarding deportations the courts simply fine them as little as E500 for being found illegally in the country and are released back into the country only to be caught in another raid, and so goes the process.

Chief Police Information and Communications Officer, Superintendent Khulani Mamba, says the most recent raids caught 13 illegal aliens around Lobamba and Ezulwini who were found with no work permits and others had overstayed, subsequently all were freed by the courts due especially to another more cumbersome problem which he could not indulge himself in, that of deportation.

Deportation

It is said it becomes more expensive for government to deport illegal aliens because over and above keeping them in prison pending deportation government must finance their passage back to their countries and these are from Asia, very far away.

Sources within the justice ministry department say government therefore remains contented with just making the culprits pay the fines.

Lukhele, clarifying the difference between smuggling and trafficking says people smuggling is on the rise confirming that her office has handled cases involving Asians.

She says as a matter of fact most cases of trafficking involve foreigners in that Swazis are generally trafficked outside the country. She explains that trafficking entails debt bondage in that those smuggled are then billed and unable to free themselves until they render services to settle the debt.

"We come across cases of smuggling that are reported as human trafficking but on interrogation it turns out they are not trafficked because they are often intercepted before reaching their destination where they were to be exploited. We find them in the process of transportation or at smuggling level hence most Asians fall under the smuggling bracket, the statistics issued by Immigration are also not specific to our definitions," she adds.

'TERROR THREAT COULDN'T BE **COMING FROM BUSINESS'**

ommerce Minister Gideon Dlamini says his ministry is only at the end of the process of regulating the acquisition of all necessary documentation that vet the credibility of foreigners doing business in Swaziland.

He adds that as the case of the security situation in neighbouring South Africa as first alerted by the United States government to its citizens of threats of terror attack, this cannot be solely blamed to be coming from the commercial sector.

He says in order for them to accept applications and issue permits they check all that has already been provided at earlier stages of the process such as identity papers (IDs), citizenship, work permits and so on, processes that involve other stages such as the ministry of home affairs, the chiefs and the King's Office which oversee the issuance of the King's Consent on Swazi Nation Land through Swazi Commercial Amadoda. "Most of the processes are not initiated by us, the applicants come to us already with papers having been vetted elsewhere. Ita kitsi vele seyinonile. At Commerce we promote investment and trade and we don't regulate. I can't call people from outside to come and invest in

the country and then later issue threats against them. It is not within our mandate to check whether they bank their money here or take it out through trunk boxes across the borders, that is not ours, ours is promotion of business. In the event the regulations are bent it won't be even Commerce to effect an arrest or make due diligence."

On a parallel note Dlamini believes if Swaziland could make capital easily accessible to small and medium businesses then the threat of foreigners taking over business would dissipate and subsequently disappear forever. He says currently it is very difficult for Swazis to obtain funding for business making an exam-



Scheme Guarantee with the Central Bank of Swaziland which he says is very minimal yet it has the potential, if increased, to break the cycle of foreigners eating away from local business opportunities. "Our people have ideas on where to invest and are knowledgeable and with the availability of finance and removal of similar barriers coupled with the provision of mentorship then all other things will fall in place. Even the so called

threat of Asians taking over urban business will fall away. Poverty would be eliminated in a single year with farmers getting finances to drill boreholes thus bringing the countryside back to life, life could never be the same again."

OF SMUGGLED ASIANS IN SD **'STOCKPILES'**

nvestigations have revealed syndicates with branches in Swaziland are involved in the smuggling of Asians into the country and beyond.

Most of them are housed in business premises where they masquerade as operators or relatives of the licence operators within the premises while they are used as cheap or slave labour to pay for their passage into the country. It is only after fully paying for meals and passage including forged travel documents that they start working for start-up capital to open their own businesses especially in the rural areas.

Having stayed in Swaziland for a relatively lengthy period during the repayment time, they acquire basics in the siSwati language and English to be able to mingle freely with the populace, hence the recent upsurge in the numbers in rural areas and high density peri-urban centres. Some have been able to marry Swazi girls in order to take advantage of the kukhonta system of acquiring land and citizenship status. In Manzini a known baron at Liqhaga building ran a successful smuggling den of the Asians. It was alleged that on arrival they submitted all their documents to the baron and were sourced out to work for other Asians until they paid back their passage fee, feeding, housing, clothing and other related costs.

One such person to make the revelations was the late Baghdad Khan who became one of the first Asian migrants to undergo kubutseka and become a member of the regiments in order to seek protection as he was now a threat after he threatened to expose the syndicates.



Senior officials from 11 Southern African Development Community countries dealing with criminal justice also comprising immigration authorities, the police, prosecutors and ministers of justice early last month noted that despite the existing regulations of legal migration systems, people in the SADC region move continuously for a range of reasons - to seek employment, to escape poverty, to reunite with their families, and to flee internal conflict.

However, the difficulty in accessing legal channels for migration often forces individuals to rely on the services of smugglers to reach their destination. Migrant smuggling generates large profits for the criminals involved as it is a low-risk and highprofit crime. The participants of the workshop voiced particular concern over the increased trend of unaccompanied minors smuggled into the region and the exposure of women and children to sexual abuse during smuggling. Reports delivered during the workshop also showed that Southern Africa serves as a transit and a destination for people on the move from other regions in Africa, as well as Asia.

While South Africa was identified as the main destination in the region for smuggled migrants, the participants agreed that due to the scope and implications of irregular migration, no single country could address the crime on its own. Smuggling of migrants is a

security challenge in the Region because it undermines the states' ability to protect national borders and puts the lives and safety of migrants at risk, while generating enor-

mous profits for criminals, in turn fueling corruption and organised crime.

"In the absence of a specific law on smuggling of migrants, it is difficult to apprehend smugglers.

We only have immigration laws which are quite lenient and deal only with illegal entry, illegal stay, and illegal exit from the country. We end up only apprehending the smuggled migrants, and not the criminal networks behind the smuggling," highlighted a participant of the workshop.

The Regional Workshop, the first one of this kind, was organised by the SADC Secretariat and the UN Office on Drugs and Crime in order to discuss regional trends and patterns of smuggling of migrants and to share ideas for a possible regional response to this challenge.


It was delivered within the Regional Programme for Southern Africa, supported by the UNODC Global Programme against the Smuggling of Migrants and the European Union-UNODC Global Action to Prevent and Address Trafficking in Persons and the Smuggling of Migrants - a project UNODC is working on in partnership with the International Organisation for Migration (IOM) and the United Nations Children's Fund (UNICEF).

Siteki Pakistani bashing reveals rot

asim Ranjhi, one of the accused persons in the bashing of a fellow national is fighting battles about how law abiding he is.

In his case against the King he says "I humbly submit that I am a law abiding citizen and I have never been questioned and or charged with any offence since my arrival in the country.'

However he does not explain how he was able to reside in the country illegally for four years. He also claims in court papers that he is a shareholder in a pharmacy business together with his BASHED: The victim brother and this pharmacy is in Siteki. However this is not reflect-



ed as he claims in his temporary residence permit.

Information

According to his acknowledgement of renewal for permit class F, the following information was received: Surname: Waseem; Forenames: Akram, Ranjha; Nationality: Pakistani; Swazi Region: Manzini Region and this information was filed on November 21, 2011 but the renewal was submitted on May 24, 2016 long after he had been arrested and appeared in court on May 12, 2016.

Similarly in the case of Ehsan Ahmed he claims to have been employed by Ranjha but there is no attachment in terms of his residents permit papers, if he has any, that he is indeed an

employee of Ranjha in his wholesale business.

In his bail application papers he alludes that "it is inconceivable that I can skip bail and settle in another country because I am in the process of acquiring Swazi citizenship having arrived in the country in around June 2012."

He has not attached proof of

this claim but also it is common knowledge that citizenship is applied for before one leaves his country of origin and not after residing in the other country for four years.

Claims

Furthermore he claims that "I have renounced my

Pakistan citizenship as I am desirous of acquiring full Swazi citizenship and I am now fully settled and firmly rooted in the Kingdom of Swaziland. But renunciation of citizenship is done after approval of citizenship not through the process of acquisition.

He further adds another startling revelation "I humbly submit that I am not currently in possession of my travel document obtained in Pakistan as same was confiscated by Swaziland Immigration Department during my application for Swazi citizenship.' Now procedurally Immigration does not confiscate alien's passports because they belong to their countries of origin.

INTRODUCTION

The Stockholm Convention on Persistent Organic Pollutants (POPs) is an international law. Swaziland acceded to the Convention on 13 January 2006 and is now bound by this international instrument (treaty). Parties to this Convention are required to eliminate or restrict the production, use and trade of POPs

1. ABOUT THE CONVENTION

The Stockholm Convention on Persistent Organic Pollutants (POPs) is a global treaty to protect human health and the environment from chemicals that:

- 1. remain intact in the environment for long periods,
- 2. become widely distributed geographically
- 3. accumulate in the fatty tissue of humans and wildlife.

There are also Unintentional POPs (uPOPs) released from the open burning or incomplete combustion of material. They are mainly unintentionally produced by-products that are formed during certain combustion and chemical industry processes

3. WHAT ARE THE HEALTH IMPACTS ASSOSCIATED TO **EXPOSURE TO POPS AND UPOPS**

Exposure to Persistent Organic Pollutants (POPs) can lead to serious health effects including:

- cancers,
- birth defects,
- dysfunctional immune
- reproductive systems especially in woman
- greater susceptibility to disease
- Diminished intelligence.

2. SOURCES OF uPOPs in SWAZILAND

The level of activity of open burning fires in the country is relatively large and biomass burning is likely the main source for dioxins and Furans (uPOPs).

Open burning covers a wide range of different uncontrolled waste combustion practices, including



He added that Swaziland and the continent at large looked up to the European continent, especially countries like France, for assistance as they aspired to become a strong force to reckon economically.





El Nino lessons

GOVT LAYS BARE PLAN

nce bitten, twice shy. This adage holds true for government who has planned ahead of the next season following the El Nino induced drought that swept across the entire region and particularly the country in the past season resulting in the deaths of approximately 65 000 cattle.

In reaction to the situation that left many Swazis shell-shocked with the livestock deaths especially in the most affected areas in the Lubombo and Shiselweni regions, government has made a provision for any possible drought season in the future by making available hay that will be sold at affordable prices to cattle farmers. Minister of Agriculture Moses Vilakati yesterday revealed government's plans to support livestock farmers that will require hay bales in case the drought situation arises again. He said the hay bales will be sold to the farmers at a subsidised price of E300 per 250kg round hay bale.

"As we are all aware the previous season has not been a good one for agricultural production and most of our farmers made tremendous losses. This year we have been informed that El-Nino effects are over.

We therefore believe that we will be having a normal rain pattern. In this regard, His Majesty's Government has deemed it fit to assist farmers with production inputs to help them recover from the effects of the drought. We will recall that the country lost approximately 65 000 cattle as a result of the drought and we do not want to see a recurrence of the same situation," he

The minister pointed out that the hay bales will be produced locally and from neighbouring countries and sold to farmers at the subsidised price. He said the hay will be stored at the Cotton Ginnery in Big Bend and that payments and collection will also be done at the same place.

Government's aim is, for starters, to attain 130 000 metric tons of maize for the country to be food secured. Minister of Agriculture Moses Vilakati yesterday highlighted that the input subsidy that government has provided over the past two seasons will continue even for the 2016/17 cropping season. He hoped that adequate rainfall would be received this time around for production to take place resulting in improved yields.

He said this year it has been decided that their scope in terms of subsidised crops is increased instead of limiting such to maize, but to include other crops that can have a meaningful contribution to national food

"Farmers can also pay at the Cotton Board offices in Manzini and collect their hay from Big Bend. We will also facilitate where possible in bringing hay closer for those who have paid for it," he added.

The minister announced more good news for cattle farmers as he said government would continue to assist cattle farmers in severe dry areas by providing water with tankers for the cattle. He explained that this would be a stopgap measure while the drilling of boreholes in areas where ground water is a potential source is being explored as a sustainable option.

Meanwhile, while the recent rains witnessed around the country were not likely to reverse the irreparable damage to crop production and livestock mortality already experienced in the country over the last year, there is hope after all.

This follows recent reports that the worst of this year's historic El Niño may be behind us. Scientists with the

security.

"In addition to the tractor hire subsidy, government will provide compound NPK fertiliser, LAN topdressing and seeds for maize, sorghum and beans.

The quantities to be subsidised will be for one hectare per farmer. Since this is not a full subsidy, participating farmers will be expected to contribute as follows: Maize – E2 000 per hectare for six bags NPK 37, four bags LAN and 25kg seeds; Sorghum – E2 000 for six bags NPK 37, four bags LAN and 6kg seeds; Beans – E2 500 for six bags NPK 37 and 60kg seeds," he specified.

The minister further requested farmers to start planning for the upcoming season and make early payments to avoid delays in receiving their inputs so that they catch up with the first rains that usually provide sufficient moisture for planting.

United Nations World Meteorological Organization are now saying that the weather phenomenon has "passed its peak", but that does not mean the weather havoc is over. The drought caused by the El Nino has had a negative impact on the livelihoods of so many people in the country and region, now and into the foreseeable future resulting to the Prime Minister Sibusiso Barnabas Dlamini declaring the country's current drought situation a national emergency. He said almost the entire Swazi nation was affected by the present drought, though to varying degrees and that government would need a total budget of E1.4 billion over the next five years to mitigate the situa-

The 2015/16 El Nino has been linked to below average rainfall in southern Africa, while last year's Indian monsoon was well below average. This climate phenomenon which has helped push global temperatures to record levels and caused extreme weather, floods

Minister announces increase in price of cotton

inister of Agriculture Moses Vilakati has announced an increase in the price of top grade cotton from E5.85 to E6 per kilogram in the coming planting season.

The increase translates to a 2.5% price increase. The minister said the increase has come into effect despite the unfavourable conditions in the world markets. He said the price of cotton is a key driver in the motivation of growers to commit to cotton production. He said they are optimistic that the new price will motivate cot-

ton farmers to continue producing the crop for income generation and economic growth.

"Cotton remains a major cash crop for farmers in the dry mid-dle-veld and low-veld of Swaziland. The industry struggled during the previous season and cotton production has gradually decreased in the last two seasons due to drought. We recognise the effort put in by cotton farmers who have ensured a continued existence of the cotton industry and produced under challenging conditions in an effort to sustain their livelihood," he remarked.

and droughts, is one of the most powerful ever, experts have revealed.

El Niño is the result of interaction between the ocean and atmosphere in an area of the Pacific that occurs irregularly between every two and seven years, affecting the climate and increasing global temperatures.

While figures provide evidence

that the recent El Nino is one of the strongest on record, similar to events in 1997-98 and 1982-83, it is too early to tell if it is the strongest ever recorded. Last year was the hottest year on record globally, with temperatures pushed 0.76C above average by man-made climate change and the strong El Nino, and scientists wam this year is likely to follow suit.

River sand, plaster sand theft on the rise

he extraction and sale of soil from Swazi Nation Land (SNL), especially on mountains is on the rise with some people being taken to taski by local traditional authorities.

So serious is the Issue that some have gone to the extent of selling the gravel soil at lucrative prices to members of the public, companies and municipalities.

According to some traditional authorities, the trend has been fast becoming despite that environmentalists have been warning against same.

with the gravel soil trafficked to various places leaving a large donga that is now posing danger to local residents. School children using the mountain as a route to and from schools between Sicelwini and Logoba are at danger according to the

concerned residents as massive dongas have turned into dams which during rainy days become full to the brim. " we have had a case of a child who fell down the donga injuring herself on the leg while we found a group of school children swimming inside the stagnant water in the now dongas turned ponds at the summit of the mountain," said Mandla Dlamini a local resident who normally grazes cattle at the summit of the mountain. Information gathered by the Observer on Saturday is to the effect that some members of th Inner Council were part of the extraction of the soil at the summit of the mountain a thing that was later stopped after the matter was reported to the elders.

Already there are cases of illegal sales of soil (gravel) which are currently dealt with by some traditional authorities within the country as such matters have even been reported to the Environmental Authority.

According to a recent statement issued by the Environmental Authority, environmental crime will now be prioritised with all those found to have committed such crimes, brought to book.

The statement mentioned that such cases which include the illegal extraction of soil, illegal cutting of trees and others will now be taken seriously as the laws will bite dipper.

Land Management Board (LMB) Chairman Clement Dlamini has condemned such acts which are on the rise.

Dlamini said his office is all out to deal with such issues as they are currently in an exercise to root out all illegal sale of SNL and such cases of extraction and sale of soil.

Manzini student employee goes on foreign trip, workers outraged

n employee of the Municipal Council of Manzini currently on two-year study leave has returned to take a company vehicle and travel on an all expenses paid trip to arrange for inter-municipal games to be held in Mahikeng while there is a sporting committee in place mandated for such preparations. As a result, this has parked indignation among the members of the sporting committee who met on a Friday two weeks ago after discovering the employee who is also a football player of a prominent Mbabane club was given the task otherwise reserved for the committee as per customary arrangements each year. It is said he had been part of the committee but was replaced when he had to go for a course outside the country only to return during this vacation to take a Council vehicle without even their knowledge and going to Mahikeng posing as representing the committee. He was in the company of a female employee who is also instrumental in arranging for ladies' games.

This scandal has promoted workers to make an agenda item during the ongoing performance management and development system (PMDS) whereby some employees favoured


by Council are rewarded outside work performance as per the intent and purpose of PMDS.

This development has also revived wounds among employees of Council after a botched trip to Durban on an experience exchange expedition whereby those who attended had no one to receive them at eThekwini municipality because they were not expected.

As a result only a handful of the chosen favoured team that went to Durban benefitted and the rest whose turn was to come finally never came. At this money spending spree each employee pocketed E2 000 for free spending and now the rest of those who missed out want their turn or a at least the money

"On the issue of the trip to Mahikeng we wish to state that the officer in question is still an employee of Council.

He undertook the trip on the full mandate of Council. Management has the prerogative to select befitting employees for trips undertaken on behalf of Council. As such, we see nothing wrong with the employee having taken the trip. In fact, we wonder what qualifies this matter as one of public interest because this is a purely operational matter which involves employees of Council who were tasked with carrying-out a legitimate responsibility with full mandate from Council," says Mathokoza Thwala, the Public Relations Officer.



orkers are also outraged at an employee who joined Council as an intern but is now working on the turnaround strategy.

This matter took centrestage during the workers' briefing session held at Zakhele Community Hall on Tuesday during the lunch hour.

It was said the intern remained when the others returned to their learning institutions but later given a short-

term contract before being elevated to take head on the turnaround strategy.

The workers are now questioning the procurement procedures followed when the intern was elevated because this job was not advertised as per procurement procedures for government jobs.

More disturbing is that he is alleged to be enjoying lucrative pay packages to the level of head of department.

hwala, on the other hand, denies the intern has been elevated to head of department, saying he is only a facilitator.

"First of all we wish to mention that when the turnaround exercise was officially launched during an all-staff meeting held in April 2016, it was clearly stated that it would be carried out using available internal resources.

As a result, an in-house steering committee was established and it is the one carrying out the exercise in full consultation with internal stakeholders such as the workers' union and staff association.

We wish to clarify it is NOT true that the officer you are referring to has been elevated

to the position of head of department. The Municipal Council of Manzini is a professional organisation that respects the principles of corporate governance; and there is no way elevations of that magnitude can happen overnight.

The true position is the role of the officer you are referring is more of a facilitator and performs duties for the steering committee that is leading the implementation of the turnaround strategy.

We also wish to state that it is not true that consultations are not happening relating to the turnaround exercise. A number of consultations with the workers' union and staff association have been held already; and more are still to happen."

Swazi, SA army officers linked to illegal border crossings

n the latest illegal cross border reports, the Swazi army and their of South African counterparts have been linked to illegal border crossing.

It has been reported that the South African borders are porous, but exactly how and where it is done, is unknown to many.

In a time when passport control is tightening worldwide, the borders of South Africa and Swaziland are actually most porous.

According to a report published by Two Oceans Vibe, from South Africa into Swaziland there are several illegal crossing spots along this strip of fence that lines the road between Pongola and Piet Retief. Swaziland is on the other side of the fence, but it is not just Swazis who use it, as many Mozambicans and other nationalities like this route because it is considered less risky.

It has been gathered that most of the illegal immigrants allegedly stop at some crossings, guarded by soldiers, two South Africans and

two Swazis where more taxis drop off people from the South African side, who want to cross illegally into Swaziland.

The illegal immigrants are reported to always look terrified, with each of them casting a sharp look along the stretch of road before alighting from the taxis, obviously looking to see if there are no approaching police cars. The taxis would thereafter leave immediately after dropping off their passengers.

Large "Once a large group has assembled, about 95 people in all, they approach the soldiers. The Swazi soldiers are humble young men in their early twenties.

One of them twists a bit to adjust the firearm on his back, while he asks everybody to produce their identity documents and children's certificates for those travelling with children. There are indeed 28 children travelling with adults in the group. Both soldiers check through the documents quickly and hand

them back to their owners," the report states.

With those illegally crossing having identity documents, it becomes cheaper as they pay less while most Mozambican nationals who do not have IDs, their exit or entrance becomes more expensive as they

After every document has been checked, the report states, the group anxiously waits for orders from the soldiers and when the directive finally does come, a white container is pointed by the soldiers where each of the illegal immigrants must go past with R10, R20 and R50 notes and lots of coins scattered at the bottom of the container.

"It is, however, exceptional for the children as they do not pay, each individual in the group goes past the container, dropping off whatever they can afford.

There is no stipulated figure. Some admit they evaded this informal 'container tax' by pretending to throw something in. Everyone is let through into Swaziland regardless," the report further states.

Meanwhile from Swaziland to South Africa on the other side, a group of about 25 people were allegedly found looking to cross into the Republic.

They dealt with the two South African soldiers who searched their bags and requested to see their identity documents. Again there are a few people who did not bring their IDs and they were requested to step aside.

Everyone is let through, except the people without IDs. They all contribute whatever they can afford, as they cross over to Pongola and the soldiers are alleged to get goodies in return if those illegally crossing do have money at that time.

According to the report, one South African soldier was reported as confessing that, this is a good deal, and travellers pay far more at other illegal border crossings. "For us it's become more of a routine

that our counterparts from other countries also observe," the soldier was quoted as saying. It is clear the soldiers from both sides of the border work together. Many of the people who make the illegal crossing are regulars. Perhaps they have children in the neighbouring country, or perhaps they are elderly and cross to receive welfare and health services. None of them possess passports.

Many South African and Swazi children attend school in either country and they use these crossings. Likewise many children from other countries cross illegally to get to their schools in South Africa. The soldiers know what damage denying people the pass would do to such youngsters' future.

All the soldiers can do is search for drugs and weapons. Without these, one is guaranteed a safe, and simple pass.

Immediate comment from the army public relations officer could not obtained as he was reported out of office by his secretary, however, a soldier who preferred to remain anonymous confided to this newspaper that such indeed happens along the countries border lines


FRAMEWORK FOR JUDGES PAY, NOTHING FOR MAGISTRAT

The justice ministry has denied that judges salaries were increased, saying they remained as they have been in the past year but instead there is a "framework created through negotiations between teams representing the judiciary and the executive, aimed at creating uniformity and certainty in the terms and conditions of service for the honourable judges."

This is in reference to a newspaper article citing a notice announcing salary pay raise for judges, a notice that says nothing about the magistrates. However, the magistrates claim an exercise was concluded to review their salaries and allowances but the results have not been gazetted as the matter is said to be still with cabinet.

Already there are reports that only the magistrates are lagging behind in the review of their remuneration while their counterparts at the directorate of public prosecutions are already on comfortable

"An internal exercise was done and concluded with recommendations made to cabinet. We made

our submissions but are still expecting the necessary outcomes," said a principal magistrate when asked on whether they had also been given pay raises.

He added that the process was somehow interrupted by the coming of the independent consultant who tabled his report on salary review for the entire civil service. "So far there is nothing, we are

waiting for what is being cooked for us." This put paid to speculation that this could have an effect on the performance of magistrates as they work with colleagues who are handsomely rewarded for nearly equal efforts on daily basis.

Acting Principal Secretary in the Ministry of Justice Vusie Dlamini, said "the framework was a result of a review in the judges' terms and conditions of service brought about by the lack of uniformity and certainty for the honourable judges which had caused disharmony within the judiciary for a long time."

Prescription of Salaries and Allowances of judicial officers Notice 2016 effective from last week prescribes that the Judicial Officer means chief justice, Supreme Court judge, High Court judge, Industrial Court of Appeal judge, Industrial Court judge and any other judge of any court established in terms of the law.

The current framework was allegedly published by Minister of Finance Martin Dlamini and is cited as claiming that it revokes Notice No.177 of 2013, on which salaries of judges were based. In October 2013 then Chief

Justice Michael Ramodibedi, together with judges of the High and Industrial Courts were awarded over 30 per cent in salary increments. That was contained in a gazette dated October 11, 2013 whereby the CJ was to receive E584 473, an increase from E370 000 he was getting per year; an increment of 36.6 per cent and a monthly salary of E48 706 before allowances. The Legal Notice 177 of 2013 was issued by the minister of finance but signed by the then principal secretary Khabonina Mabuza.

In 2014 the ministry of finance stopped the allowances of the judges who presided over cases during the recently ended May session of the Supreme Court.

The affected Judges were Chief Justice Michael Ramodibedi, resident Judge Bheki Maphalala, Justices Seth Twum from Ghana, Ahmed Ebrahim from Zimbabwe, Benjamin Odoki from Uganda and Stanley Moore from Guyana.

Ramodibedi filed claims for the judges before the session commences and he claimed it was standard practice in most countries. This was contested within the min-

ANGRY 'HOLY WATER' PASTOR RAZES PARTNER'S CHURCH

• Pastor had allegedly entered into partnership to run church at Mbikwakhe, conflict arises over leadership of church as holy water pastor decides to demolish church structure

• Church members left in the open as hired TLB grader brings down structure

e had partnered with a local pastor to run a church as he offered 'holy water' and anointed oil to the congregants after both pastors signed a 'holy deal' that was blessed by the congregants.

However, in a rather shocking move, the 'holy water' pastor did the unthinkable when he, after a misunderstanding over the leadership of the church with the founding pastor at Mbikwakhe, came all fires blazing and drought down the church structure in broad daylight.

The incident that has shocked Mbikwakhe community happened after the two engaged in a heated argument over the leadership of the church, since both wanted to be at the forefront despite that they had agreed to partner.

According to sources close to the matter, the holy water pastor whose name is known to this newspaper, but cannot be published for now since no formal charges have been pressed against him by his former partner, the two had all along been getting well.

In fact, the sources said the holy water pastor approached Pastor Matse of the Mbikwakhe church, making a proposal that they both partner and run the church as he had a financial muscle and to crown it all, came along with the holy water and anointed oil, which would during church services, be given to congregants.

Upon reaching the agreement, the sources said all had been going well between the two as they ran the church together, resulting in the holy water pastor eventually erecting a church structure as Matse, the founding pastor, had all along been using a tent for his church's services.

Although the structure had not yet been completed but had been roofed, the church services were eventually held under that structure up until the fateful day on Sunday when the holy water pastor pounced.

"For some strange reasons, the two had misunderstandings that emanated from nothing but the leadership of the church.

Apparently the new partner felt he was the one to lead the church while the founding pastor held a different view, hence the heated arguments over same," said our sources.

Without suspecting anything out of the ordinary, it was on Sunday when the holy water pastor pounced, leaving congregants

and Mbikwakhe community in shock. He showed up leading a TLB grader to the church premises that are adjacent to a homestead nearby.

Making his intentions known, the pastor is said to have instructed the grader to waste no time, but bring down the church structure which was within an hour razed to the ground.

Some of the church members who reside nearby, reportedly rushed to the scene but could do nothing, save to watch helplessly as the church building was brought down. Nothing but the concrete floor and pulpit were last.

Since the founding pastor was not around when the incident happened, he is said to have been called through his cellphone before he rushed to the scene only to find that the church structure was no more.

Visited by our news team this week, debris of the old structure were found at the scene with some brethren just having finished setting up a tent in preparation for church services which they hold both during the week and on Sundays.

The corrugated iron sheets and other building material that was used in the construction

Swaziland Conference of Churches (SCC) Bishop Steven Masilela, expressed shock on the 'holy brawl' that has resulted in one of the two destroying the church structure.

Masilela said they condemned such an act as it sets a bad precedence, sending the wrong message about the church.

Problems

He said real church leaders do not do such as all whenever problems arise, they always seek God's intervention not violence.

"We are shocked at this to say the least and advise that in the event there are differences between church leaders, such should be sorted out amicably with the parties involved engaging in dialogue and ask God's intervention, not this," Masilela said.

He said their office remained open for those church leaders who might have problems and need assistance, as such cases send the wrong message about the church.

his development-oriented agreement is the first of its kind with an African region pursuing regional economic integration.

The European Union and six countries of the Southern African Development Community (SADC) yesterday signed an Economic Partnership Agreement (EPA), the first of its kind between the EU and an African region pursuing the objective of economic integration. The signature took place in Kasane, Botswana.

The agreement was signed by Commissioner for Trade Cecilia Malmström, on behalf of the EU. In a comment, Commissioner Malmström said: "Trade is a tool to spur economic growth and sustainable development. It's also an important factor for integrating regions and forming stronger bonds between countries.

"With the Economic Partnership Agreement we are signing today, we want to base our trade relations with our partners in the Southern African region on commonly agreed, stable rules.

"Trade has helped lift millions of people from poverty throughout the

years. Thanks to agreements like this one, we are preparing the ground for that process to contin-

Commissioner for International Cooperation and Development, Neven Mimica, added: "Fully utilising the economic potential of the private sector and further strengthening the trade is critical for the new global development agenda of the Sustainable Development Goals. Today's agreement can help us to tap this potential."

The Economic Partnership Agreement (EPA) with Botswana, Lesotho, Mozambique, Namibia, South Africa and Swaziland - the so-called "SADC EPA group" - is a development-oriented free trade agreement.

This is the first such agreement to be signed between the EU and an African region pursuing the objective of economic integration.

Other regional agreements could also soon be signed with West Africa and the East African Community. At the signature ceremony in Botswana, Commissioner Malmström held a speech on the benefits of the agreement.

The EPA takes account of the dif-

ferent levels of development of each partner.

It guarantees Botswana, Lesotho, Mozambique, Namibia, and Swaziland duty-free, quota-free access to the European market. South Africa will also benefit from enhanced market access, going beyond the existing bilateral arrangement.

Flexibility

Furthermore, the agreement increases the flexibility of Southern African producers to put together products components from various countries, without the risk of losing their free access to the EU market. It also provides for a number of protective measures, for instance, for nascent, fragile industries or for food security reasons.

The Southern African markets will open gradually and partially to EU exports, in an asymmetric way. In the process of diversifying their economies and broadening production, imports of certain goods are important for Southern African countries - certain industrial parts, seeds and machinery, for instance. The import duties on many of these so-called intermediary goods will be significantly reduced, making

the products more easily accessible to Southern African entrepreneurs.

For the South African market specifically, particular advantage has been granted to EU producers of traditional quality products with a worldwide reputation - for example, wines and food products - that will now get the exclusive right to use their traditional names, or 'geographical indications', in South Africa.

Correspondingly, several South African geographical indications will, from now on, be protected on the EU market, such as different types of South African wine such as Stellenbosch and Paarl, along with Rooibos tea and other prod-

By signing the agreement, all participants commit themselves to act towards sustainable development, including by upholding social and environmental standards.

The EPA also establishes a consultation procedure for environmental or labour issues and defines a comprehensive list of areas in which the partners will cooperate to foster sustainable development. Civil society will have a special role in monitoring the impact of the agreement.

In addition, a detailed chapter on development cooperation identifies trade-related areas that could benefit from EU financial support.

The EPA creates joint institutions to support dialogue, smooth handling of all trade issues, and monitoring of the impact of the trade deal. The EU will work with its SADC partners to ensure smooth implementation of the agreement, together with regional and national development cooperation bodies.

The EU Council of Ministers took the decision to authorise the signature of the Economic Partnership Agreement on June 1.

Following the signature, the agreement will now be submitted for approval to the European Parliament, and for ratification in the 28 EU Member States according to national ratification procedures and in the Southern African countries.

BACKGROUND

Trade and Economic Partnership Agreements are an essential pillar of the ACP-EU Cotonou Agreement. The SADC EPA Group consists of six out of 15 members of the Southern African Development Community (Botswana, Lesotho, Mozambique, Namibia, Swaziland and South Africa). Angola has observer status and may join the agreement in the future.

The EU is the largest trading partner of the SADC EPA group. In 2015, the EU imported goods worth almost €32 billion from the region, mostly minerals and metals. The EU exported goods of the nearly same value, mostly engineering, automotive and chemical products.

The success of Ecotricity which supplies energy to more than 100 000 customers - has made Mr Vince considerable wealth, and he now lives in a £3million 18th century Georgian fort and drives a custom made electric supercar. He remarried in 2006.

Non-stop illegal diamond mining at Dvokolwako

Desperate residents continue to sneak into the minefield, collect and surf sand for precious stones

Deployed army personnel chase off diamond looters who always run for dear life

espite the presence of the Umbutfo Swaziland Defense Force (USDF) personnel who were deployed to secure one of the country's precious natural resources, diamond, desperate members of the public continue to loot diamonds at Dvokolwako.

The Observer on Saturday has reliably learnt that people still want to lay their hands on the precious stones at the defunct mine which was shut down, about a decade ago in the Hhohho region, as they are eager to make quick cash owing to the scourge of unemployment.

Dvokolwako residents and those from surrounding areas are said to be the most popular as they sneak into the minefield especially at night where they collect and later surf the sand around the mine in search of the stones that are said to be in the market and in demand by Asian nationals in neighbouring South Africa and Mozambique.

It was established that a syndicate of Asian nationals based in South

Africa are actually promoting the continued attempts by local residents to loot the diamond at the mine by providing a ready market, as they want nothing but the precious stones in return for quick cash.

Decade

The mine was shut down about a decade ago with South African Business mogul Roux Shabangu reported to have been ready to take over the mine.

With the area and mapping of the mine known to them, some locals are said to be using simple methods to extract the precious stones which are believed to be later smuggled to neighbouring South Africa.

These foreign national are said to want nothing more but diamonds and pay cash as no questions are asked, it has been reliably gathered.


The country attained a certificate

from the Kimberly Process Certification Scheme, which allowed Swaziland to trade in diamonds some time in 2011.

After its shut down, interested business people including South African business magnate Roux Shabangu had indicated that they want to take over the mine and hopes from locals have all along been baked that job opportunities would be open once operations at the mine resume.

However there has been no positive reports as regards the reopening of the mine which is one of the country's major natural resource with two other prominent mines, the Mpaka Coal and Ngwenya Iron Ore mines also having been shut down.

According to well placed sources, with the knowledge that the precious stone's value can change peo-

ple's lives, the looting at the defunct mine is far from over as people will continue to loot.

"The fact that they continue to search for the diamonds, despite the presence of the army, is proof enough that the looting is far from over," the sources said.

This week the Observer on Saturday visited the Dvokolwako mine on a fact finding mission and found on site was a lone plain clothed soldier who confirmed that they have a tough time chasing away people who try to steal precious stones.

He said the illegal miners normally sneaked in with all sorts of containers in the dead of the night, as they first identify the areas the soldiers are patrolling at and once they know the other perimeters are un guarded, they sneak in and steal the stones. "Diamond looters here continue to sneak in search of the precious stones, but we usually detect and chase them away, and knowing that the area is guarded by the army they run for dear life, although some normally scan the area in order to detect where we are positioned, taking the opportunity to sneak in at the areas we are not at," he said.

Owing to the ratio of the soldiers to the mine, the illegal miners take advantage as about three of the army officers cannot position themselves at all corners of the minefield.

In most cases when the looters are caught, they are punished and released, leaving behind the containers they had brought, while others are chased off while attempting to sneak into the minefield.

However it has been gathered that the presence of the Geology Department at the defunct mine does not mean that it will be reopened.

In an interview with some locals, they said they have been taking note that officers from the department are frequenting the area with the piece of land having been already cleared and is now being fenced.

Fencing poles have already been erected around the piece of land and efforts to get information on what would be done on the land were unsuccessful as the Geology officials referred further queries to the Ministry whose Principal Secretary could not be reached by the time this report was complied.

that the mining sector will improve with an investor that would be mining diamonds which are based at Dvokolwako mine.

As reported by our sister paper the Swazi Observer daily recently, Commissioner of Mines Samuel Ntshalintshali had said there were about six prospective applicants interested into diamond mining at Dvokolwako adding that a team would look into the applications and decide on the ultimate investor, stating that most of the applicants were from South Africa.


The eventual investor to be granted mining rights must be able to extract the diamond, contribute to the surrounding community and also invest in processing the mineral locally.

Ntshalintshali could not divulge as to how much capital the investor must have but said they were looking for someone who would meet all the requirements and had capacity to undertake the mining job. He said for the Dvokolwako mine, they were talking of at least 15 years production life.

There are diamonds in Swaziland and government has indicated that the diamond industry must be vibrant in the near future.

Worth noting is that the country has completed certain processes for the

diamond industry. The country last year finalised the procurement process for the Kimberly Process Certificates which translates to the fact that Swaziland is legalised to operate in diamonds.

Dvokolwako mine has been operational up until 1997 but could not proceed as the investor had to do underground mining, in 2008, there

was another applicant and was given a licence and in 2012, that interested investor was supposed to forward capital but could not thus government decided to revoke the licence.

From 2012 to 2014, they worked on deregistering that potential investor who failed to abide by the requirements, with the licence already available.

GMO: ANOTHER HEATED DEBATE OVER GLYPHOSATE

...as EU refuses to back a limited extension of the pesticide glyphosate's use, threatening withdrawal of Monsanto's Roundup and other weedkillers from shelves if no decision is reached by the end of the month.

Thile Swazi legislators were taken on a study tour of the benefits of genetic engineering to farmers in nearby South Africa last month with a view to influence amendments in the current legislation regulation biotechnology, a debate is heating up about the suitability of the technology worldwide following European Union's position on temporary licence extension for chemical used in weedkiller, to study concerns over cancer risks. The motion in the EU Parliament this week failed to get sufficient majority in

On the Swazi front, however, while there are environmental concerns, cotton farmers look more into the benefits of importing the technology because already the country is importing from food and other agricultural products that have used the same biotechnology in other countries but is not using the technology itself.

Daniel Khumalo of the Swaziland Cotton Board argues that traditionally Swazis do not look into their problems adequately but rush to

tackle how other people are shaping up into embracing or rejecting new and upcoming technology as is the case with Europe's position on pesticide glyphosate.

Technology

He says the law does not compel Swazis to accept Roundup but allows for means to regulate and take informed decisions on the technology as to what comes in or not come into the country. "We must be able to control anything coming into the country than simply blocking outrightly any technology on the market out there. We want the law to guide us and create forums on how to handle the technology, that is where the law is taking us. IN the EU they are able to control or vote because they have the relevant laws to guide them."

He adds that Swaziland has a somewhat hostile biotechnology law that does not allow the technology to come in altogether but there is the risk of the same technology being smuggled into the country and once that happens it would be virtually impossible to control its use.

He cited the Lukhetseni outside Siphofaneni BT cotton test project which was allowed with specific provisions for the ministry of agriculture to see how far the biotechnology could be rolled out further. He says the ministry was given limited permission simply because of the hostile Biosafety Act of Swaziland.

However, Khumalo observes that in other countries this technology improved cotton production immensely.

Spray

He says it comes with a gene that controls pests and subsequently cuts costs with huge margins and makes the farming undertaking of even small farmers more viable than ever.

He notes that conventional cotton takes six months in the field and weeding is done four or five times at E50 per hectare per person per day which translates to E500 a week and in a month this could total E2 000. At this cost the farmer is already counting losses but the technology means the farmer no longer has to weed manually, which translates to reduced costs of spraying and subsequently eliminating the burden of weeding. He says the environment will also be happy because of reduced chemicals resulting from reduced spraying of

chemicals to kill pests. The chemical to eliminate the weed is E90 per hectare instead of the E500 and, therefore, the farmer makes huge savings.

As for spraying it the plant requires eight to 10 times for the conventional seed but with the technology it is reduced to only twice but he admits there are some problems in the region in that it favours other diseases because of the temperatures. "Even if the cotton is grown conventionally it depends on how much effort a farmer puts in to prevent diseases.

Money

This gene has come with all the protection measures. Once the plant bears fruit the harvest is definite because it does not depend on how much effort I put to keep away pests, which requires spraying and spraying means killing the environment by putting in more chemicals." Conventional cotton has a gross margin of E1 200 while BT cotton grosses E10 000 per hectare.

He admits this is not a magical cotton, saying farmers are aware there are concerns in other countries where it has been introduced such as Roundup no longer kills just the target weed but other plants; there is also the concern around Superweed; concerns the chemical could be targeting certain pests but what about other insects such as bees.

"Everything has its own risks, the law is to manage the risk in order to make the country precautionary in dealing with biotechnology while at the same time reaping benefits of the technology, that is why we need to enact an enabling law."

EU nations have refused to back a limited extension of the pesticide glyphosate's use, threatening withdrawal of Monsanto's Roundup and other weedkillers from shelves if no decision is reached by the end of the month. Contradictory findings on the carcinogenic risks of the chemical have thrust it into the centre of a dispute among EU and US politicians, regulators and researchers.

The EU executive, after failing to win support in two meetings earlier this year for a proposal to renew the licence for glyphosate for up to 15 years, had offered a limited 12 to 18 month extension to allow time for further scientific study. It hopes a study by the European Union's Agency for Chemical Products (ECHA) will allay health concerns. Despite the compromise, the proposal failed to win the qualified majority - the support of member states representing at least 65% of the EU's population - needed for adoption, an EU official said. Seven member states abstained from Monday's vote, 20 backed the proposal and one voted against, a German environment ministry spokeswoman said. The controversy overhangs German chemicals group Bayer's \$62bn offer in May to buy US seeds company Monsanto. Germany was among those which abstained from Monday's vote and has in the past opposed Monsanto's genetically modified seeds.

Monsanto case

Regulatory authorities and other third parties have conducted extensive analysis demonstrating that MON810 is safe to humans, animals, non-target organisms and beneficial insects. However, in several European countries, politicians - using scientific arguments rejected by the EU's own Food Safety Authority (EFSA) have taken decisions to illegally ban the planting MON810 com hybrids despite a robust safety assessment and a long history of safe cultivation and consumption.

As consumers ourselves, the safety of the foods we serve to our friends and families is important to everyone who works at Monsanto. Consequently, the safety of the products we sell to farmers is our top priority, and we confidently stand behind the safety and healthfulness of each of our GM seed products.

the service was Ludzeludze Member of Parliament Bambumuzi Sithole, as well as members of the police executive.

The theme of the service was "Love your neighbour as you love yourself" which was extracted from the Book of Leviticus 19:18. This theme was chosen after observing that society is plagued by criminal activities and social problems which show that love amongst people is lacking much against the teachings of the Bible.

The national commissioner expressed gratitude towards Bakhandleki Church for the allow-

ing the police service to praise and worship with the congregation.

He stated that the Police Sunday Services were an extension of the various outreach programmes through which the police service forges partnerships aimed at waging an effective war against crime. He alluded that the police cannot achieve much in their quest to bring crime and all its social maladies under control without the assistance and support of various sectors in society.

Magagula further commended Bakhandleki Church in Zion for having a programme that supports the destitute in society.

persons of high integrity. These should be individuals committed enough to put the interests of the country and that of the nation before theirs.

Salary

This is why they are called public servants because their job entails serving the interests of the public and the superiors who availed to them the employment opportunity.

This means earning a salary should be least in the priorities of the employees and those seeking employment in a discipline service.

Whilst the duty of Correctional respect and honesty. Officers is to ensure public safety by facilitating the rehabilitation of convicted offenders as well as overseeing awaiting trial inmates in correctional centres, it is imperative to note that officers cannot have the ability to perform their duties successfully if theylack the essential attributes that make up an ideal correctional officer.

This means such officers should be faithful and allow their conduct to be guided by a clear conscience during the performance of their duties. Remember the adage 'who guards the guard'. This means those willing to achieve success in this career should be willing to allow a paradigm shift in their mindsets. This will facilitate their smooth transition from the civilian culture to embody the principles of the discipline service. When they have done so, it will not be difficult to understand that theirs is a 24/7 kind of job, that abiding to lawful orders from superiors and complaining later is part of the package of their calling.

They will have no trouble understanding that their conduct should always be above reproach and that inmates look up to them for their transformation into law abiding citizens.

Correctional Officers also have a duty to facilitate offenders' reintegration to society as well as enabling hypher between offenders and victims of crime.

A close analysis of this job reveals that to become an ideal correctional officer is not as a result of some cosmic accident without purpose or value. It is indeed a high calling!

o sooner had the unresolved matter of the paralysed University of Swaziland student began to die than the police returned to hog headlines, this time over the unexplained death of a magician last seen with them.

This also comes at a time when the national commissioner had been recovering from a grilling by the Public Accounts Committee over mishandling of cash received by the police at the outstations. The national commissioner was all out to defend his charges where they committed what he considered to be minor misdemeanours regarding processing and safekeeping of the cash, and now the coroner's report on the death of the magician has identified multiple injuries on the cadaver. This, however, does not, at this level, point to anyone in particular as being responsible for those injuries.

There are still a number of unanswered questions as to how the police could not crack this mystery even where there are reports of eyewitnesses who last saw the deceased with the police who had ordered him to alight from their vehicle. Neither the officers nor the vehicle concerned is known to the police authorities, leaving huge gaps that need to be explained. Many a time the police have complained about shortages of transport thus making it even easier for fleet managers to account for the movement of the few vehicles and their whereabouts at any one particular in time of the day.

If our police service can still not account for the vehicle that was spotted at the scene on the day then how much more would it be difficult for police in Mainland China, India or Nigeria, the world's largest populations, to account for their fleet? Now this will call for the tracking device of all police and their vehicles in the country over and above the systems used by the desk or assigned officers.

An account by a street vendor and some workers on the twilight rush hour is to the extent that they witnessed the deceased lying on the ground while the officers on site were said to have been telling him to walk home. There are also claims that he had been part of a fun filled patronage at a popular drinking spot in the capital but still this does not give the public the answers on how he finally died.

Even if the police found him staggering on the way home they should have found criminality in that and on seeing he was injured would have taken him to hospital other than what we heard that he could have been assaulted elsewhere by heaven-knows and later dumped by the police where he finally died.

Officers are expected to stay away from home for long periods of time on national duty and this has necessitated the state to provide them not just with comfortable working tools but also with decent accommodation in order for them to deliver. We

have seen the state providing them with decent accommodation through the institutional housing programme and also with decent pay compared to the rest of the nondisciplined arms of the civil service such as nurses, teachers and fire-fighters.

Demanding

Teachers as we speak are now demanding equal housing allowances instead of them having to share mud huts in far flung rural areas of Swaziland, away from home. Similarly nurses have complained about the discrepancy in working and living conditions for the same pay but in the event they have been found wanting in delivery at the workplace they have been taken to task.

Now this gives credence to the police boss' crack of the whip among his charges in recent times with requests for the law to allow him to deal with them more effectively internally first and foremost, before they are thrown into the abyss of the criminal justice system.

The commissioner, who is the controlling officer of the police service, has been on the receiving end when his officers are ever caught on the wrong end of law enforcement. But this time he must explain to this small yet powerful nation how the police service will ever crack such cases as those

involving cyber crime, data manipulation, the Riverstone Mall heist, the smuggling of Asians into Swaziland, tenderpreneuring, if they cannot crack the case of a simple death on the roadside where there are witnesses who did the watching in the presence of two police officers, a male and a female.

Expose

How are we going to believe the police that evidence submitted to the Director of Public Prosecutions is worth its salt, or part of it has been sifted in order to frustrate prosecution efforts that may expose shortcomings within the service? How are we going to absolve the police service from suspicions that it is only those with bad blood within the service that find their way into the frying pan?

What if there are officers that suffer double jeopardy in that after being suspects in malpractice they are either given the boot without due diligence simply because they have crossed paths with superiors or are denied the opportunity to prove themselves otherwise, how are we to believe that this does not happen?

Inquests or probes or investigations are nothing but mere window dressings because we never get to hear what comes of them. At least we would be in the know of what became of the murdered Mozambican who was suspect in police custody Luciano Zavale or the findings of the investigations into the injury of the UNISWA student who has been left paralysed for life, just to mention two.

This might boil down to the port of entry, that is to what extent is the recruitment process transparent?

Many have joined the police service because of the stinging high unemployment rate out there and not because of the calling into the service of the state, people and property of the motherland. Some have been taken in because their parents are former police officers and not that they have what it takes to be a police officer, others for shaking what their mama gave 'em', a majority are in there for kicking the ball or for being connected to some high places, some may have used the financial muscle, what product do you expect to come out of this concoction, no amount of training or drilling can turn a baboon from its facial caves and dongas because it will cease being a baboon.

Now when we see the blue uniform we see blood splashes of the dead magician, we look further into the hands of the police service we also see his blood because we have nowhere else to look.

Dealing with Diabetes

t's another Saturday good readers, for the next three Saturdays we will be focusing on Diabetes Insipidus, which is not commonly known.

Diabetes insipidus is an uncommon disorder characterized by intense thirst, despite the drinking of fluids (polydipsia), and the excretion of large amounts of urine (polyuria). In most cases, it's the result of your body not properly producing, storing or releasing a key hormone, but diabetes insipidus can also occur when your kidneys are unable to respond properly to that hormone. Rarely, diabetes insipidus can occur during pregnancy (gestational diabetes insipidus).

You may assume diabetes insipidus and diabetes mellitus - the more common form of diabetes involving blood sugar - are related. Although the disorders share a name and have some common signs, diabetes mellitus (type 1 and type 2) and diabetes insipidus are unrelated.

Treatments are available to relieve your thirst and normalize your urine output.

Symptoms

The most common signs and symptoms of diabetes insipidus are:

- Extreme thirst
- · Excretion of an excessive amount of diluted urine

Depending on the severity of the condition, urine output can range from 2 quarts (about 2 liters) a day if you have mild diabetes insipidus to 21 quarts (about 20 liters) a day if the condition is severe and if you're drinking a lot of fluids. In comparison, the average urine output for a healthy adult varies, in the range of 1.6 to 2.6 quarts (about 1.5 to 2.5 liters) a day.

Other signs may include needing to get up at night to urinate (nocturia) and bed-wet-

Infants and young children who have diabetes insipidus may have the following signs and symptoms:

- Unexplained fussiness or inconsolable crying
- Unusually wet diapers
- · Fever, vomiting or diarrhea
- Dry skin with cool extremities
- Delayed growth
- Weight loss

When to see a doctor


See your doctor immediately if you notice the two most common signs of diabetes insipidus: excessive urination and extreme thirst. taken in because their taken

Causes Diabetes insipidus occurs when your body can't regulate how it handles fluids! !skes! Normally, your kidneys remove excess mi body fluids from your bloodstream! This fluid waste is temporarily stored in your bladder as urine; before you urinate! When your fluid regulation system is working properly, your kidneys make less urine when your body water is decreased, such as through perspiration, to conserve fluid.

The volume and composition of your body fluids remain balanced through a combination of oral intake and excretion by the kidneys. The rate of fluid intake is largely governed by thirst, although your habits can

increase your intake far above the amount necessary. The rate of fluid excreted by your kidneys is greatly influenced by the production of anti-diuretic hormone (ADH), also called vasopressin.

Your body makes ADH in the hypothalamus and stores the hormone in your pituitary gland, a small gland located in the base of your brain. ADH is released into your bloodstream when your body starts to become dehydrated. ADH then concentrates the urine by triggering the kidney tubules to release water back into your bloodstream rather than excreting as much water into your urine.

The way in which your system is disrupted determines which form of diabetes insipidus

 Central diabetes insipidus. The cause of central diabetes insipidus in adults is usually damage to the pituitary gland or hypothalamus, most commonly due to surgery, a tumor, an illness (such as meningitis), inflammation or a head injury. For children, the cause is often an inherited genetic disorder Income cases the cause is unknown This damage disrupts the normal production, storage and release of ADH. de Nephrogenic diabetes insipidus.

Nephrogenic diabetes insipidus occurs when there's a defect in the kidney tubules the structures in your kidneys that cause

water to be excreted or reabsorbed. This defect makes your kidneys unable to properly respond to ADH.

The defect may be due to an inherited (genetic) disorder or a chronic kidney disorder. Certain drugs, such as lithium and demeclocycline (a tetracycline antibiotic), also can cause nephrogenic diabetes

insipidus.

 Gestational diabetes insipidus. Gestational diabetes insipidus occurs only during pregnancy and when an enzyme made by the placenta — the system of blood vessels and other tissue that allows the exchange of nutrients and waste products between a mother and her baby destroys ADH in the mother.

 Primary polydipsia. This condition also known as dipsogenic diabetes insipidus or psychogenic polydipsia - can cause excretion of large volumes of dilute urine. Rather than a problem with ADH production or damage, the underlying cause is intake of excessive fluids. Prolonged excessive water intake by itself can damage the kidneys and suppress ADH, making your body unable to concentrate urine. Primary polydipsia can be the result of abnormal thirst caused by damage to the thirst-regulating mechanism, situated in the hypothalamus. Primary polydipsia can also be caused by mental illness.

In some cases of diabetes insipidus, doctors never determine

Nephrogenic diabetes insipidus that's present at or shortly after birth usually has a genetic cause that permanently alters the kidneys' ability to concentrate the urine. Nephrogenic diabetes insipidus usually affects males, though women can pass the gene on to their children.

Complications

Dehydration

Except for primary polydipsia, which causes you to retain too much water, diabetes insipidus can cause your body to

retain too little water to function properly, and you can become dehydrated.

Dehydration can cause:

- Dry mouth
- Muscle weakness
- Low blood pressure (hypotension)
- Elevated blood sodium (hypernatremia)
- Sunken appearance to your eyes
- Fever
- Headache
- Rapid heart rate
- •Weight loss

Electrolyte imbalance

Diabetes insipidus can also cause an electrolyte imbalance.

Electrolytes are minerals in your blood such as sodium and potassium - that maintain the balance of fluids in your body. Electrolyte imbalance can cause symptoms, such as:

- Fatigue or lethargy
- Irritability
- Nausea
- Loss of appetite
- Muscle pains



ADVICE TO KEEN SPINNERS





5 Toughest Single Mom Struggles

single parents probably read the title of this article and think, "Ha! They've narrowed it down to five?" And in fairness, we realise that the challenges of caring for kids alone are innumerable.

But there are some hardships that are unique to the individual, and others that are heard time and time again from our single-mom friends. So this list is an overview of those common single mom struggles, along with some encouragements and suggestions to help you deal with them.

1. Financial strain. The most common life events that lead to single parenthood—death, divorce, etc.—upset more than just your marital status. They upset your financial balance, and leave one adult shouldering a load that is typically carried by two. Even if you're a single adoptive parent and chose the challenge of doing it alone, it's still tough. Single moms often hang in limbo waiting for child support that never arrives or paying attorneys to pursue what should be paid. There always seems to be a little less in the checking account than what your kids need.

And remember: what your children need most—your love—you do have in abundance. Lavish them with that, and lay down the guilt of not being able to give them every material thing they desire.



2. Social isolation. Single moms tell us that they sometimes feel trapped underneath a mountain of responsibility that never allows them to invest in friendships, much less find another companion for life. Working single moms say the guilt of leaving your kids in the evening to do something just for yourself is crushing. Add to that the cost of hiring a sitter and getting out of the house for adult interaction seems almost impossible.

3. Decision pressure. Parenting is hard.
There are lots of gray areas and the game changes daily as your children grow. For married parents, there's at least another adult to

talk things out with, and to share the burden of making tough decisions. Single parents bear the weight of all of those tough calls-where to go to school, which friends are okay, or when a child is mature enough for a new privilege or responsibility-alone. The emotional burden can wear a mom down in a hurry. 4. Guilt. Is there any end to the guilt a single parent feels? If you know that your decisions (some of which you may regret) contributed to your current family status, it's especially present. There's guilt about the financial things you can't provide, guilt about the time you spend away from them, guilt about the things you just can't do because of your situation. Regardless of how your children became the kids of a single parent, you worry daily about

5. Fatigue. Let's face it: you're doing alone what was designed to be a two-person job. The fact that you often feel physically, emotionally, and spiritually worn out is not just your imagination. aving children is what most women want; from when we are children, girls usually play with dolls calling them their babies the feeling of being a mother comes naturally to all females.

Pregnancy can be a joyous journey or the worst nine months of your life, especially because most women suffer from morning sickness during the first three months of pregnancy (first trimester). Eating healthy food will benefit your baby; including your baby being born with a healthy birth weight, improved brain development, and a lower risk of certain birth defects, you will also be paving the way towards a safer, more comfortable pregnancy. In fact, women who eat well while they are expecting can minimize a host of pregnancy symptoms including morning sickness and mood swings. They are more likely to deliver on time and have a speedier recovery after birth.

Importance of eating healthy during pregnancy

You do not need to go on a special diet when pregnant but it is important to eat a variety of different foods everyday to get the right balance of nutrients that you and your baby needs. It is best to get vitamins and minerals from foods you eat, but when you are pregnant you need to take some supplements as well, to make sure you get everything.

Maternal nutrition during pregnancy also appears to have a "foetal programming" effect, that is, the foetus learns nutritional habits, which will influence it for the rest of its life, before it is even born. A foetus will also adapt its metabolism and other body systems to cope with different states of nutrition. For example, an under-nourished foetus, which does not receive enough macronutrients or energy, responds by reducing glucose and insulin production, which ultimately slows the rate of foetal growth and increases the risk of low birth weight. It may also alter the metabolism permanently and leave an individual predisposed to metabolic conditions such as diabetes. The foetus also adapts to under-nutrition by redirecting blood flow and therefore the supply of nutrients to protect the brain, at the expense of fully developing other organs including the kidneys, muscles and endocrine system which is the system that regulates the body's hormone production.


Food safety

Most foods are safe for pregnant women and their babies. But you will need to use caution or avoid eating certain foods. Clean, handle, cook, and chill food properly to prevent foodborne illness, including listeria and toxoplasmosis.

The following guides should be followed:

- Wash hands with soap after touching soil or raw meat.
- Keep raw meats, poultry, and seafood from touching other foods or surfaces.
- Cook meat completely.
- Wash produce before eating especially

fresh fruits and vegetables.

Wash cooking utensils with hot, soapy
water

Do not eat:

- Refrigerated smoked seafood like whitefish, salmon, and mackerel
- Hot dogs or deli meats unless steaming hot
- Refrigerated meat spreads
- Unpasteurized milk or juices
- Store-made salads, such as chicken, egg, or tuna salad
- Unpasteurized soft cheeses, such as unpasteurized feta.
- Shark, swordfish, king mackerel, or tile fish (also called golden or white snapper); these fish have high levels of mercury.
- Herbs and plants used as medicines without your doctor's approval. The safety of herbal and plant therapies is not always known. Some herbs and plants might be harmful during pregnancy, such as bitter melon and unripe papaya.

Do not forget fluids

All of your body's systems need water. When you are pregnant, your body needs even more water to stay hydrated and support the life inside you. Water also helps prevent constipation, hemorrhoids, excessive swelling, and urinary tract or bladder infections. Not getting enough water can lead to premature or early labor. A good way to tell if your fluid intake is okay is if your urine is pale yellow or colorless and you rarely feel thirsty. Thirst is a sign that your body is on its way to dehydration. Do

Alcohol

not wait until you feel thirsty to drink.

There is no known safe amount of alcohol a woman can drink while pregnant. When you are pregnant and you drink beer, wine, hard liquor, or other alcoholic beverages, alcohol gets into your blood. The alcohol in your blood gets into your baby's body through the umbilical cord. Alcohol can slow down the baby's growth, affect the

Caffeine

baby's brain, and cause birth defects.

Moderate amounts of caffeine appear to be safe during pregnancy. Moderate means less than 200 mg of caffeine per day, which is the amount in about 340 g of coffee. Most caffeinated teas and soft drinks have much less caffeine. Some studies have shown a link between higher amounts of caffeine and miscarriage and preterm birth. But there is no solid proof that caffeine causes these problems. The effects of too much caffeine are unclear. Ask your doctor whether drinking a limited amount of caffeine is okay for you.

Cravings

Many women have strong desires for specific foods during pregnancy. The desire for "pickles and ice cream" and other cravings might be caused by changes in nutritional needs during pregnancy. The fetus needs nourishment. And a woman's body absorbs and processes nutrients differently while pregnant. These changes help ensure normal development of the baby and fill the demands of breastfeeding once the baby is born.

Some women crave nonfood items such as clay, ice, laundry starch, or cornstarch. A desire to eat nonfood items is called pica (PYE-KUH). Eating nonfood items can be harmful to your pregnancy. Talk to your doctor if you have these urges.

Keeping fit

Fitness goes hand in hand with eating right to maintain your physical health and well-being during pregnancy. Pregnant or

not, physical fitness helps keep the heart, bones, and mind healthy. Healthy pregnant women should get at least 2 hours and 30 minutes of moderate-intensity aerobic activity a week. It's best to spread your workouts throughout the week. If you regularly engage in vigorous-intensity aerobic activity or high amounts of activity, you can keep up your activity level as long as your health does not change and you talk to your doctor about your activity level throughout your pregnancy.

Healthy recipes for pregnant women Peanut-Butter-Chocolate-Chip Energy Bars suitable to go snack. Makes 20 bars Ingredients:

1/2 tsp. vegetable oil

1 cup quick-cooking rolled oats

1 cup dry-roasted peanuts

1/2 cup peanut butter

1/2 cup sunflower seeds 20 Medjool dates, pitted

2 eggs

1 tsp. kosher salt 1 tsp. vanilla

1/2 cup chocolate chips

Directions
1. Preheat the oven to 350°F. Lightly grease a 9-inch-square baking pan with vegetable oil and line the bottom with

parchment paper.

2. Put the oats, peanuts, peanut butter, sunflower seeds and dates in a food processor and pulse until finely chopped.

3. In a bowl, whisk the eggs together with the salt and vanilla. Add the mixture to the food processor and pulse until it becomes a coarse, chunky paste. Fold in the chocolate chips with a wooden spoon. Transfer the mixture to the prepared baking pan and spread evenly, gently pressing down to flatten. Bake for 35 minutes, or until firm and golden.


Express



on heat approximately every six months from this time. The heat season lasts about 21 days. During this time she may be restless and try to escape from your property. The odour of a bitch on heat is very strong, and will attract males over a long distance.

 The male dog does not have a season; he will always be receptive to females on heat.

A male dog that scents a female on heat will make every attempt to escape from your property and reach the object of his desire. During his wanderings he may become lost, run over, come into contact with other dogs with contagious diseases. He will almost certainly fight with other males and may be seriously injured. He is no use as a guard

dog if he is focused on his own reproductive

 The sterilisation operation is a safe surgical procedure which is carried out under general anaesthetic. There are no harmful after-effects whatsoever.

 There is no reason why a female should have one litter before being spayed. On the other hand, there is every reason to save puppies from a lifetime of neglect, starvation and euthanasia.

 If you feel for your male dog, then neuter him and save him a lifetime of frustration. He will experience absolutely no effect from the procedure.

 Have you smelt cat pee or heard mating cats caterwauling? Reason enough to sterilise them.

 Children do not need to see a litter being born to enrich their lives. Rather take them to a shelter and explain why it is not fair to breed more kittens and puppies.

 Sterilising is the only way to slow the tidal wave of strays that carry contagious diseases which can ravage populations of beloved pets and working animals and bring killer diseases like rabies into your home. Strays overturn litter bins and cause traffic

 Strays tend to form packs which are aggressive and dangerous. They injure and kill other dogs and humans. The presence of rabies is in large part due to owners who fail to sterilise their pets.

 Sterilise all pets - male and female, dogs and cats - by six months old, a maximum of five months for cats which can go into season at five months. Do not delay by even a

ometimes there is confusion between the terms "cardiac arrest" and "heart attack." A heart attack, or myocardial infarction, is damage to the heart muscle that occurs due to reduced blood flow to the heart muscle, depriving the heart muscle of the oxygen it needs to function properly.

Cardiac arrest means that the heart stops beating and death is imminent. A heart attack, if severe, can lead to cardiac arrest, and this is what occurs when a heart attack is fatal. However, other conditions, such as serious arrhythmias or shock, can also cause cardiac arrest.

What are symptoms of a heart attack? Knowing the early warning signs of a heart attack is critical for prompt recognition and treatment. Many heart attacks start slowly, unlike the dramatic portrayal often seen in the movies. A person experiencing a heart attack may not even be sure of what is happening. Heart attack symptoms vary among individuals, and even a person who has had a previous heart attack may have different symptoms in a subsequent heart attack. Although chest pain or pressure is the most common symptom of a heart attack, heart attack victims may experience a diversity of symptoms. The following list describes the symptoms of a heart attack in more detail.

What are the symptoms of a heart attack?

1. Chest discomfort

Chest pain is the hallmark symptom of a heart attack, although it can take many different forms. In other cases, chest pain may not occur at all. The characteristic chest pain of a heart attack has been described as a sense of pressure, squeezing, fullness, or pain that starts in the center of the chest. The pain or discomfort typically lasts more than a few minutes, or it may go away and then return. It can spread down the arms, to the back, or to the head and neck. Both women and men report chest pain as a primary symptom of heart attack, but women more often than men are likely to have some of the other symptoms, such as nausea, jaw pain, or shortness of breath, that are described below.

2. Jaw pain, toothache, headache

The pain of a heart attack can spread down both arms, to the jaw or head, or to the back. Some people report tooth pain or headaches as a symptom of a heart attack. It is possible to have these types of pain without chest pain during a heart attack.


3. Shortness of breath

Feeling short of breath or like you are gasping for air is a common symptom of a heart attack. Shortness or breath, or difficulty breathing, is medically known as dyspnea. Shortness of breath may occur before or during the chest pain of a heart attack, and in some cases, it may be associated with other heart attack symptoms without any chest pain

4. Nausea

Nausea or feeling sick on your stomach is a less common but possible symptom of heart attack. Sometimes belching or burping can accompany the nausea, and some patients have described a feeling like indigestion associated with a heart attack. Women are more Focus on heart-failure...

likely than men to report these less typical symptoms of heart attack, and some patients have described feeling as though they are developing the flu.

5. Vomiting

The nausea that accompanies a heat attack can become so severe that vomiting occurs.

6. General epigastric

Sometimes the pain of heart attack is described as stomach pain, or pain in the middle of the upper abdomen. The pain usually feels more like discomfort of heaviness rather than sharp, stabbing pain, and the pain tends to persist more than a few minutes. This can occur with or without pain in the true chest

7. Sweating

Sweating, or perspiration, can accompany a heart attack. Some people have described feeling like they are breaking out in a cold sweat.

8. Heartburn

As mentioned above, some people experiencing a heart attack can have belching and burping and describe a feeling of indigestion. Likewise, the pain and pressure of a heart attack may occur in the epigastric or upper middle abdominal area, similar to the pain of heartburn.

9. Arm pain

The chest pain of a heart attack can spread, or radiate, down one or both arms and to the shoulders. This often happens, and the pain may even extend to the wrist and fingers. This is most common on the left side of the body but it can also occur on the right side.

10. Upper back pain

The upper back is another common location for the spread of pain from a heart attack. Most commonly, back pain that stems from a heart attack is described as occurring between the shoulder blades.

11. General malaise

A feeling of being generally unwell or like you are coming down with an illness can accompany a heart attack. This can be described as fatigue or even light-headedness, with or without fainting. Some people will experience severe anxiety or panic during the heart attack. This has been described as feeling a sense of doom, as one experiences with a panic attack.

12. No symptoms

Approximately one quarter of all heart attacks are silent, without chest pain or new symptoms and silent heart attacks are especially common among patients with diabetes mellitus.

Even though the symptoms of a heart attack at times can be vague and mild, it is important to remember that heart attacks producing no symptoms or only mild symptoms can be just as serious and life-threatening as heart attacks that cause severe chest pain. Too often patients attribute heart attack symptoms to "anxiety," "indigestion," "fatigue," or "stress," and consequently delay seeking prompt medical attention. One cannot overemphasise the importance of seeking prompt medical attention in the presence of symptoms that suggest a heart attack.

Early diagnosis and treatment saves lives, and delays in reaching medical assistance can be fatal. A delay in treatment can lead to permanently reduced function of the heart due to more extensive damage to the heart muscle. Death also may occur as a result of the sudden onset of arrhythmia such as ventricular fibrillation.

frica being a large continent is working hard to establish a more consolidated agenda for African development.

Through various trade blocs like COME-SA, SADC, and EAC the efforts are getting rewarded. This challenge is working for the good of every African state, unlike the old way of thinking that South Africa was the hub of all African economy. The tripartite will establish interdependence and sharing of long lasting solutions towards the economic development. The union of the east and southern African communities can be seen as a delayed opportunity for African regional integration.

Despite this need to create an urgent bridge of demand and supply, of man's greatest challenge has now become that of space and distance, long distances for that matter, causing the cost of production to be on the high side, hence the standard of living low and the high cost of living.

The ideology of having more consolidated trade zones in Africa cannot be challenged by any reason of thinking otherwise, however the most advantageous side of such initiatives are too many to mention. Of which some include the following:

Increased market access and market centers

It is evident in some countries like Zambia and Tanzania, trade expansion has become the headache of the civil engineers. Every day the markets are growing and creating much access to the outside world like China

and Japan. In terms of FTA, One of the main benefits of the tripartite FTA is that a much larger market, with a single economic space, than any one of the three regional economic communities and as such will be more attractive to investment and large scale production.

According to the research done by Shayanowako (2011). The three RECs (COMESA, EAC and SADC) have a combined population of over 500 million people, and a combined gross domestic product (GDP) of USD 624 billion. The 26 countries in the three RECs constitute half of the African Union (AU)'s membership and their combined population constitutes 57% of the AU's total population.

The tripartite FTA will therefore create an enlarged market for producers and traders in the partner countries to the FTA. Due to the principles of variable geometry and asym-

metry, not all COMESA and SADC member states are in the COMESA and SADC FTAs. For instance countries such as Angola, DRC and Malawi are not yet participating in the SADC FTA although they are Member States of SADC. Similarly countries such as DRC, Eritrea and Ethiopia, though Members of COMESA, are not yet participating fully in the COMESA FTA. The situation is similar within the EAC.

Due to these variations in the levels of trade liberalization within each of the three RECs some countries in the tripartite region currently only access part of the COMESA, SADC and EAC markets at MFN rates, which are not preferential as they apply to trade with all WTO members.

The establishment of the Tripartite FTA is set to eliminate tariff and non-tariff barriers and other restrictions of commerce thus

enhancing partner countries' market access to the expanded market of the Tripartite FTA. If successfully implemented, all partner countries to the Tripartite FTA will then be able to trade freely with more than half of the African continent.

This spider network of trade within Africa, establishes not a mass market for African countries to do business amongst themselves, but rather making Africa a new Europe, a land of not developing states as it has ever been called, instead this time it will called a block of developed states. it is commonly said that many strings can bind an elephant, so must be the case of Africa. The resources that can dominate the global market we have in abundance, but the challenge is that the prices for these items on the global market are always determined by the minority who in this case tends to be the buyers.

They buy from the land of plenty in its most raw state only to process it and sale it back to Africa for consumption, this time around not on a friendly price, but a cut throat.

If the tripartite was well established among African states, then it would be like building a mansion of a house with self contained bedrooms. Africa being one of the largest continents would attract high levels of utility among the member states, hence creating high circulation levels of goods and services within the circles of the continent and one day, like it has been a dream for most patriotic Africans, Africa would be a place of development like any other continent such as Asia and Europe.

MURDERER COUNCILLORS STILL GET R35K A MONTH

URBAN - Two ANC eThekwini councillors continue to draw R35 000 monthly salaries from beleaguered ratepayers despite being in prison for murder.

To add insult to injury, Mduduzi Ngcobo and Velile Lutsheku have not performed their duties since February last year, when they were arrested for the September 2014 murder of community activist Thulisile Ndlovu in her Thokoza home near Pinetown.

The city has paid the two almost R1 million in salaries since their arrests. However the bill could be much higher as The Mercury also understands that they were assigned bodyguards after their arrests. This could not be independently verified by the council at the time of publication.

Ngcobo is a KwaNdengezi ward councillor. Lutsheku is a proportional representation councillor. They were charged and convicted together with triggerman Mlungisi Ndlovu of murder in May.

Judge Johan Ploos van Amstel sentenced the three in the Durban High Court to life imprisonment for the premeditated murder and denied them leave to appeal.

Thulisile was a branch chairperson of shack dwellers' movement 'Abahlali baseMjondolo.'

This week council Speaker Logie Naidoo dropped a bombshell when he refused to dismiss the two, despite the convictions.

They are serving their sentences at Westville Prison after their bids to apply for leave to appeal against their convictions and sentences were dismissed on the day they were sentenced.

This was confirmed by provincial National Prosecutions Authority spokeswoman Natasha Kara on Thursday.

DA provincial and eThekwini caucus leader Zwakelele Mncwango this week demanded to know why the minutes of the city's town planning committee still reflected Lutsheku as being its c

reflected Lutsheku as being its chairperson. He said he failed "to understand how someone can be convicted and jailed and still reflect as a chairperson of a committee. There's something wrong there".

Naidoo offered to "educate" Mncwango on council processes.

"According to the Municipal Structures Act, until a person exhausts the appeals processes, council cannot (act). So in all fairness, no matter how strong we feel about this matter, we are guided by legislation. (That is) until that process is finalised. As I understand it, they have applied for leave to appeal. My hands are tied," Naidoo said, adding that the convicted killers were still city councillors

Mncwango protested, asking what the ANC was doing about the convictions. He was dismissed with laughter by some ANC councillors, before

Naidoo offered Mncwango directions to the party's offices.

According to the Municipal Structures Act, councillors can vacate their office for several reasons including if they are "no longer qualified to be a councillor".

Shepstone and Wylie, said the employer could take steps, in accordance with a process governed by labour law regulations, to terminate employment if a person was con-

Maeso said another factor was whether the councillors were "suitable to hold their office" given their convictions. *News24*

Oscar's uncle to tell all in TV exclusive

RETORIA - While the world's eyes will once again be on the high court in Pretoria next week, with Oscar Pistorius being sentenced for murder, his uncle Arnold Pistorius said on Thursday night that he (Arnold) will break his silence after the case had been concluded, by speaking to an international television channel.

It will be a tough and uncertain week for Oscar, as jail definitely looms following his conviction for murdering his girlfriend Reeva Steenkamp. The only question is for how long will he be going in.

His legal team will have to fight a battle to convince Judge Thokozile Masipa not to send him to jail for 15 years, as the law requires.

On Thursday night, his uncle issued a statement in which he said the family had rejected countless offers for interviews over the past three years, often offering great amounts of money.

"We have been deeply respectful of the legal process and mindful not to contribute to the media frenzy that has characterised this case. Despite the many, many requests for interviews with Oscar from across the globe - often coupled with huge financial inducements - we have been absolutely consistent in our position that there will be no interview, or media engagement, for Oscar's financial benefit."

Arnold said despite Oscar's "crippling" legal fees, this remains their position. "Not knowing what the future holds for Oscar after this week, I decided it was necessary to take up one media offer that would provide our family with a voice to address some of the misconceptions that have remained unchallenged. "Having considered the various offers and options available, I decided to engage with Mark Williams-Thomas. I felt his platform on ITV was the most appropriate place to do this - because of its style and format. Williams-Thomas is a Peabody awardwinning investigative journalist, and has followed the case closely from the outset. News24

Striking SA firefighters sent packing

ALGARY – A team of South African firefighters dispatched to Canada to fight a massive wildfire in the oil sands region is heading home after a pay dispute, South African officials said.

The 301 firefighters arrived in northern Alberta less than two weeks ago to help quell the blaze near Fort McMurray, which forced the evacuation of 90 000 people, destroyed part of the city and shuttered more than a million barrels per day of oil sands production. Working on Fire, a South African government-funded organisation that trains firefighters, said a senior management team was on its way to Alberta assist with their demobilisation and return home.

At issue is how much pay the firefighters should receive for their work in Canada.

During their deployment.

Canadian authorities agreed to cover accommodation and meals, while each fire fighter would also receive a daily stipend of C\$15 (R175) for discretionary purchases, according to Working on Fire. In addition, after their return home, each firefighter would receive an "out of country daily allowance" to the rand value equivalent of C\$35 (R408) a day. They were also to receive the regular wage they earn at home. However, local media reports about salary increases for personnel deployed to Canada caused confusion among the firefighters, prompting them to strike, Work on Fire said in a statement. "We wish to categorically state that the quoted amount of \$21 per hour is incorrect and was never agreed to with anyone," Working on Fire said, referring to the media reports. eNCA

Eskom promises to plug youth into nuclear future

APE TOWN - Eskom has initiated a major training programme for nuclear operators, saying it will train 100 artisans as operators at its Koeberg plant to meet South Africa's requirements in the future.

The programme, launched by

Public Enterprises Minister Lynne Brown in Cape Town, is a strong vote of confidence by the government and Eskom for an expanded nuclear energy sector in the future.

The Koeberg-Eskom programme is the latest in several initiatives to gear up for the country's proposed nuclear build, which government has said will involve the construction of 9600MW of new capacity. Others include training programmes with Russia, France, China and South Korea, where South African students are being empowered in a variety of skills. Citize

Nigerian women face risk of abuse

KAMPALA - New assessments of the protection risks faced by the affected people living in Nigeria's restive northeastern Borno state have concluded that women face a high risk of abuse in displacement sites, the United Nations humanitarian wing has reported. According to a humanitarian bulletin on Nigeria issued by the UN Office for the Coordination of Humanitarian Affairs (OCHA), displacement and conflict have destroyed traditional hierarchies and resulted in a large number of female-headed households across the north-east of Borno state. US embassy in Gambia closed

GAMBIA - The US embassy in Banjul was closed for all but essential services after Gambian authorities removed its police protection. It was not immediately clear why President Yahya Jammeh's government had taken this step, but Washington has criticised its rights record. A State Department official in Washington told AFP the United States had "registered concern" with Gambia over the withdrawal of the officers. "We will continue to closely monitor and assess the situation as events unfold," he said. News24

KIAMBU - Residents of Kiambu County, Kenya, took to the streets to protest against the conduct of a selfproclaimed prophet who had been demanding sexual

favours from his female followers. Zachariah Baricho, alias Nabii Wanyonyi, allegedly

claimed that he had been directed by the spirit to sleep with the women at least seven times. Those who failed to give in to his demands would be branded as witches.

According to Citizen Digital, the father of 12 had also been soliciting money, foodstuffs and livestock from area residents, leading to family break-ups. News24

Algerian troops kill four militants

ALGIERS - The Algerian army has killed four suspected jihadists in an ambush south of the capital, Algiers, the defence ministry said. A ministry statement said soldiers swooped on militants in the mountai ous Medea region, 80km from Algiers, adding that firearms and ammunition were seized. Last year, the army killed or arrested 157 "terrorists" - the term Algeria's authorities use for Islamist militants - according to ministry figures.

Nigeria to recruit teachers

ABUJA - The federal government has created an internet portal named npower.gov.ng. through which job seekers can apply for jobs. A statement issued in Abuja Wednesday by the Senior Special Assistant to the Vice President on Media and Publicity, Laolu Akande, said the presidency would start taking applications online for positions in the 500 000 direct teacher jobs scheme. eNCA

MUGABE LABELS WAR VETERANS 'DISSIDENTS'

ARARE – Zimbabwe's 92-year-old President Robert Mugabe has labelled liberation war fighters as "dissidents" and threatened to deal with them the same way he did during the "Gukurahundi" – the anti-dissident armed response.

Shona for "the early rain which washes away the chaff before the spring rains," the Gukurahundi massacres saw an estimated 20 000 Ndebeles killed by the Zimbabwe army's notorious Fifth Brigade in the 1980s.

Addressing a ZANU-PF central committee meeting at the party headquarters in Harare on Thursday, Mugabe said the Zimbabwe National Liberation War Veterans Association (ZNL-WVA) was formed to cater for the welfare of the former freedom fighters and not to champion the political struggle in the country.

Mugabe said the war veterans had no mandate to decide who should succeed him or who should not

The nonagenarian said ZANU-PF should lead the war veterans

and not vice-versa.

"It is not proper for anyone to use this welfare body as a platform that is used to attack the top leadership or seeking to direct party processes in a certain direction preferred by some individuals within that body; to do so will once again, amount to going the way of the dissidents," Mugabe declared.

The 92-year-old leader said war veterans should speak through party structures. He warned he would deal with those that failed to toe the party line.

"The association was never formed to be the bully of the party nor the entity to make the choices of who should lead and who should not, never ever, except within the people, within the party," said Mugabe.

"The dissidents tried it, they were war veterans, and you know what happened ... lots of trouble, lots of fighting, lots of suffering caused to our people."

Muagbe, who has been in power for 36 years, said the unity accord signed between him and the late Vice President Joshua Nkomo was not only for ordinary people, but also for the war veterans, adding they should work in harmony with the party structures. "It was to bring an end to the war that the dissidents had decided to wage. Do we see another rise of dissident activity? Well the leadership will say no. No to the war veterans' association ... it is not your function," said Mugabe, who has made it public that he intends to stand for re-election in 2018.

"It is not your business to talk of who shall succeed the president. And worse still; and I am stunned, to threaten that unless what you do, your wish is fulfilled there shall be bloodshed." News24

Libya unity govt forces enter ISIS bastion

RIPOLI - Fighting raged for control of the Islamic State group's Libya stronghold of Sirte after unity government forces battled their way into the centre of the city.

The United States confirmed the advance on Sirte, the hometown of ousted dictator Muammar Gaddhafi that has also been in the sights of forces of a rival authority in eastern Libya.

The loss of Sirte would amount to a huge setback for ISIS, which is also faced with battlefield reverses in Syria and Iraq.

"The armed forces entered Sirte. They are currently in the centre, where clashes continue with Daesh," said Mohamad Ghassri, spokesperson for the forces of the UN-backed Government of National Accord (GNA).

"The operation will not last much longer. I think we'll be able to announce the liberation of Sirte in another two or three days," he said.

Brett McGurk, US President Barack Obama's special envoy to the international coalition fighting ISIS, confirmed the advance.

DR Congo opposition demands Kabila quit by year's end

R CONGO - Opposition parties in the Democratic Republic of Congo early yesterday said they had forged an alliance and demanded that President Joseph Kabila quit when his term expires in December.

After a two-day closed-doors meeting in Belgium, the groups issued a statement saying they had set up a joint organisation called 'Rassemblement,' or 'Rally' in English.

Its goal "is to realise the struggle of the Congolese people for change and a state of law," they said.

They also issued a warning to Kabila, in power since 2001 and who is widely believed to want a third term, in contravention of the constitution which allows only two

If Kabila stays in power beyond December 19, when his second term elapses, this would be deemed "a constitutional coup d'etat," they sāid.

A so-called committee of wise men headed by veteran opposition figure Etienne Tshisekedi will be set up to coordinate decisions

Tshisekedi, 83, an opposition leader since the rule of strongman Mobutu Sese Seko, came second to Kabila in a fraud-tainted 2011 election.

AN KI-MOON SLAMS S

Secretary General Ban Ki-moon on Thursday rebuked Saudi Arabia and its allies for resorting to "undue pressure" to remove the Saudiled coalition fighting in Yemen from a blacklist of child rights violators.

In his first public remarks about the uproar, Ban said he decided to take the coalition off the list after Saudi Arabia along with other Arab and Muslim countries threatened to cut off funding to UN humanitarian programmes.

"It is unacceptable for memberstates to exert undue pressure," Ban told reporters at UN headquarters.

"Scrutiny is a natural and necessary part of the United Nations."

The United Nations had blacklisted the coalition after concluding in a report released a week ago that it was responsible for 60% of the 785 children killed in Yemen last year.

But in a humiliating climbdown for the United Nations, Ban announced on Monday that the coalition would be scratched from the list pending a joint review with the Saudi-led alliance. The UN chief has been under fire from rights groups who charged that he had caved in to Saudi pressure and damaged the credibility of the United Nations.

"This was one of the most painful and difficult decisions I have had to make," Ban said.

Confirming reports of a threatened cut-off of funding, Ban said he "had to consider the very real prospect that millions of other children would suffer grievously if, as was suggested to me, countries would de-fund many UN programmes".

Saudi Ambassador Abdullah al-Mouallimi denied that his government had put pressure on the United Nations to reverse its decision by threatening to cut off millions of dollars in funding.

"We did not use threats or intimidation and did not talk about funding," said Mouallimi.

A Security Council diplomat earlier said the Saudis had "whipped up a lot of supporters" to pressure Ban to make the changes and threatened in particular to withdraw funding from the Palestinian relief agency UNRWA."I stand by the report," Ban said, warning that "the content will not change".

The UN chief appealed to member-states to defend the reporting mechanisms such as the children in armed conflict annual blacklist. The blacklist was established by a decision of the Security Council in 1999, but the council has been silent on the dispute over the coalition's listing.

South Australian police have collected a piece of wreckage slightly larger than a shoebox after a man searching for driftwood on Kangaroo Island, 100km from Adelaide, came across the debris.

'Waste turned to stone'

UNITED KINGDOM - Scientists think they have found a smart way to constrain carbon dioxide emissions - just turn them to stone. The researchers report an experiment in Iceland where they have pumped CO2 and water underground into volcanic rock. Reactions with the minerals in the deep basalts convert the carbon dioxide to a stable, immobile chalky solid. Even more encouraging, the team writes in Science magazine, is the speed at which this process occurs: on the order of months. iol

Drunk England fans chant 'ISIS, where are you?'

RANCE - French police fired teargas on Thursday in Marseille after violent clashes broke out between English fans and local football hooligans.

Clashes erupted shortly after midnight in the French city's Old Port area where hundreds of travelling supporters had spent Thursday drinking.

Local French youths are thought to have attacked England supporters who had gathered en masse outside the Queen Victoria pub, and O'Malley's, an Irish bar next door, ahead of the Three Lions first group game of Euro 2016 against Russia today.

The ultras posted messages on social media saying: 'Welcome to Marseille, England fans.

A group of England fans chanted: 'ISIS, where are you?"

Marseille is a port city with a strong Islamic community and Muslims make up around a third of the population.

Two England fans have been arrested, one for assaulting a barman and the other for violent disorder.

On Thursday night there was conflicting reports of what sparked the clashes in the southern French city.

"They were baiting us, and then attacked," said one fan from Leeds, who asked to be named only as Simon.

"None of the England fans were doing anything wrong - a few of us had a bit much to drink, but that was all.

"Suddenly a French gang appeared and started attacking us, and throwing stuff. We had to defend ourselves, and then the police showed up." Others spoke of their fear as they were targeted by youths brandishing makeshift weapons, and shouting 'Get the English'. Chris Lord, another England fan from London, said: "This was a really nasty attack. The gang knew exactly where we were, and clearly wanted to hurt us." Daily Mail

England face Russia test in opener

PARIS-England and Russia are the big beasts of Group B and, though each would love a winning start when they meet today, the fear of losing could well become all-pervading and lead to a cagey encounter.

With games against Wales and Slovakia to come, and the potential for three teams to qualify with two guaranteed, a point at the Velodrome might look a very useful result in a couple of weeks.

England, on the back of winning all 10 qualifiers, not to mention a rare victory in Germany in a friendly, start favourites and will expect to make the running in front of a 60 000 crowd that will be predominantly behind them.

However, despite that great run of form, England are anything but a settled side as Roy Hodgson struggles with the question of how to shoe-horn his form players into an established system.

Strikers

Strikers Jamie Vardy, fresh from leading Leicester City to the most unlikely Premier League title, and Harry Kane, the Premier League's top scorer, seemingly demand selection.

But Hodgson is adamant Wayne Rooney, the captain and most experienced squad member, should get a starting berth, leaving the coach experimenting with his attacking options right up to the last minute.

At least he is picking from strength in that regard as his, and England's more pressing concern is in central defence where any combination of Gary Cahill, Chris Smalling and John Stones has looked vulnerable and remains England's Achilles heel. England have not lost in 90 or 120 minutes in 22 Euro matches in finals and qualifiers, going back to a 3-2 defeat by Croatia in November 2007.

The impressive statistics are skewed, however, as they lost on penalties to Italy in the 2012 quarter-finals and failed to qualify in 2008. Russia reached the semi-finals that year with a side full of passion and pace but they were disappointing in 2012 and in the 2014 World Cup and the current crop are not a group to have fans on the edge of their seats.

Risks

They are, however, a well-organised and technically adept squad and coach Leonid Slutsky has quickly developed a strong team spirit since taking over from Fabio Capello last August. He has, however, been forced to change his plans somewhat after injuries ruled midfielders Alan Dzagoev and, after last week's 1-1 draw with Serbia, Igor Denisov out of the tournament. With that to deal with and winnable games on the horizon. Russia are unlikely to take too many risks on Saturday, leaving it up to England to decide whether to open up in all-out pursuit of victory or indulge in 90 minutes of cautious chess. Daily Mail

"He feels good in Barcelona, he's loved over there, and he's playing for the best team in the world,' Ribeiro said. 'It's no small feat to impose yourself at such an enormous club.

Divided loyalties as Swiss face Albania

Paris - Switzerland may get a taste of their own medicine today when they meet an Albania side featuring several players who benefited from the highly-acclaimed Swiss youth set-up.

Wales may need 'Plan B' vs Slovakia

RANCE - Wales must find a way of avoiding over dependence on Gareth Bale if they are to make progress at their first major international tournament for 58 years, starting with Saturday's opening Group B match against Slovakia.

Not since John Charles, a world-class performer at centre-half and centre-forward in Serie A six decades ago, have they relied so much on one player.

Yet those who believe Wales are totally reliant on their totem can point to how they have fared without him in subsequent friendlies, of which he has played only half an hour in total.

They lost three and drew the other one at home to Northern

A LEGEND IS HONOURED - MUHAMMAD ALI



SO QUICK, SO PRETTY, SO UNIQUE, THE BEST

ASHINGTON - In 1978, DC comics put Superman into the ring with Muhammad Ali.

There was only ever going to be one winner. Superheroes, superhumans were Ali's sole contemporaries by then.

He beats Superman to a standstill, stops the fight himself to spare any more pain. Superman collapses at his feet. In the time between concept and publication Ali had lost the heavyweight championship of the world to Leon Spinks.

It did not matter. Like the mighty Superman, his legend, his myth, and for Ali his place in history, was long assured. Ali would later beat Spinks in the rematch to win his crown a third time, a feat that remains unequalled. In doing so, he became the athlete against whom all others would be measured. That title, at least, remains undisputed, even in death.

In the small hours of Saturday morning, the Louisville Lip trembled a final time, emitting a last breath. Parkinson's syndrome had long denied Ali the words that once tumbled out, by turn playful, witty, threatening, inspiring. Yet not even decades of shuffling, diminished living had tainted him in the public imagination. He was still 'The Greatest', he was still King of the World, the mantra he repeated in the ring after beating Sonny Liston in 1964.

Mismatch

The fight was considered such a mismatch that the boxing writer for The New York Times was asked to map out a route from the Miami arena to the local hospital, to better pursue the ambulance that would transport the challenger when it was over. Instead, Cassius Clay - as he was until the next day - came with a



style that transformed his sport.

So much is said of Ali the man, that the fighter is almost steered to the periphery. Yet to watch him against Liston that day was to see boxing altered as if by enchantment. Sugar Ray Robinson held his hands low and moved around the ring with a hoofer's grace but in the heavy-weight division Ali's speed and technique remain unsurpassed. 'Ali was the first 15 stone man to get up on his toes and dance around the ring,' said Barry McGuigan, but there was more to it than that.

Reflexes

His reading of a punch, the way he could move just far enough out of range, his lightning reflexes in retali-

ation, this was a new world. "He could run like a gazelle," recalled his trainer, Angelo Dundee, and in a world of sluggers his athleticism stood out.

Ali broke the rules. He had little time for working an opponent's upper torso - kill the body and the head will die, has long been a fight maxim - and retreated in straight lines, always alert to the danger. His awareness in the ring was second to none, as was his speed. Liston was a big man, and a big

hitter, but film of their meetings shows some of his blows missing by as much as two feet. Ali chooses not to parry his punches but simply avoid them, moving his body back or to the side, sometimes without even gloves for protection.

His epic fights came later, but the greatest years were early in his career, when Ali redefined the possibilities of the heavyweight division, when he didn't have to take punches and counter to win.

Rope-a-dope was a strategy designed to compensate for what had been lost in his enforced withdrawal from boxing: the sharpness in his legs; the flexibility of his frame. Before it, he could simply circle a helpless opponent, staying out of range, coming inside only to deliver the next cobra-like jab. Some found his style raw, almost untrained. In its way, it

was. Ali was
writing his

for the
fight game.
He wasn't
a novice,

was an originator.

The ban from boxing for refusing the draft to Vietnam stole his sporting youth and deprived him of what may have been his peak years: early 1967 to late 1970. Between the age of 25 and 29, Ali fought four times. When he returned - slower, but no less brave or bold - it was to a succession of brutal confrontations that many still believe represent the pinnacle of boxing, and perhaps of the sport itself. Joe Frazier, Ken Norton, George Foreman: fights known by their tag lines - the 'Rumble in the Jungle, the Thrilla in Manila' that bucked the modern trend by living up to the hype.

In Britain, tickets were sold for live showings in cinemas in the small hours, or for repeat viewings at friendlier times the next day. I was taken to one at Gants Hill Odeon, the images authentically exotic, the atmosphere electric. These were the days when it seemed Ali could fight Superman - or, as DC Comics also had it, Hun'ya, champion of an alien galaxy, run by the maniac leader Rat'lar - and win by TKO. Just his presence on a late-night talkshow was an

event. As a child of the
Seventies, staying up to
watch Match of the Day
was a rare treat; to see
Ali on Parkinson afterwards equally so.

Revisited, some of Ali's utterings in those conversations jar with modern sensibilities.



"Matsenjwa is in good shape and he is currently in Germany where he is expected to compete in various competitions.

Matsenjwa will leave for Brazil along with Phumlile Ndzinisa who holds the national record in 400m in the country. The Manzini Athletics Club (MAC) athlete ran 53.14 seconds during the Africa Games in Congo, Brazzaville, finishing fifth.

Ndzinisa is also Swaziland's national record holder in the 400m (53.95 seconds) attained at the London 2012 Olympic Games.

The 21-year-old also holds the 200m national record of 24.00 seconds, set at the Western Australia Athletics Club, where she was on scholarship courtesy of Australian Corporation ASCOT Capital.


