



SCHOOL FEES DILEMMA AS BANKS' STAFF TO STRIKE FOR THREE DAYS

WORKERS in the financial services sector are planning a January mass protest to force their employers to heed their salary increase demands.

The mass protest by the financial institutions is expected to take place on January 17-19.

This effectively means banks will be closed or would operate on skeletal basis. The protest has been coincided with the busy period where parents are paying school fees.

The protest action will entail marches in the city of Mbabane and submission of a petition to the Minister of Finance Martin Dlamini on the third day of the strike action (January 19).

The Swaziland Union of Financial Institutions and Allied Workers Secretary General Jabu Shiba, said the union demanded that parliament amend the Public Enterprise Act 1989 and the Legal Notice No.62/2016 from the Central Bank of Swaziland.

Shiba was speaking at a press conference at SUFIAW offices yesterday.

Shiba advised parents or guardians to pay their school fees this month. She said next year January the financial institutions sector would be disturbed by the strike action they would embark on.

Shiba said the Public Enterprise Act should include the right to collective bargaining, as envisaged in the International Labour Organisation Convention 98 on Collective Bargaining and the right to organise, when negotiating with a parastatal governed by the Act nugatory.

"In view of Parliament having adjourned, we propose that the government gives us a guarantee it will table the Bill soon after the Appropriations Bill, with a certificate of urgency," Shiba stated.

Shiba said the union signed an agreement through the Industrial Court requesting the Minister of Labour and Social Security Winnie Magagula to act on the amendment of the Act, which the minister in question received but she has not responded to date.

To prepare for a better negotiating atmosphere for the 2017 season and onwards, and to persuade government to appreciate the seriousness with which they demand it deals with this matter, they decided to embark on a strike action to force government amend the Act.

THE financial services sector has also raised concerns about the removal of all charges on cash deposits in the banks from its customers.

SUFIAWU Secretary General Jabu Shiba said in their negotia-

tions with the banks for salary adjustments for the year 2016/2017, almost all the institutions cautioned about the implications of the above legal notice, to their bottom line and the effect this notice may have in the 2017/2018 salary adjustment negotiations.

"Proper consultation of all stakeholders prior to the issuance of the

legal notice would have ensured that the scope of the impact was delimited as factors from all these stakeholders that ought to have been considered would have been taken on board," she stated.

Shiba said this was because there were inherent costs associated with cash handling and the free banking for all was not workable.

"Effectively this means as workers in the financial sector. we will bear the full brunt of the effects of these developments by way of losing our jobs and working excessive hours, with the banks pointing out difficulties in carrying these costs without charging the customers," Shiba said.

She said the governor of the Central bank

ignored their letters and never even had the courtesy to acknowledge receipt of the letter.

FINCORP workers to get xmas pay

SUFIAWU will compensate FINCORP workers who are on strike who were threatened with no-work-no-pay.

Shiba said they should not worry much about their Christmas salaries as SUFIAWU would take care of that.

"We will not divulge how much

they will get but eventually they will get paid for Christmas and we will not back off from their course," she said.

Shiba said the strike would continue until management come into agreement with the demands of the workers. FINCORP strike action began on November 21.

E54million for pothole-riddled KaLanga-Big Bend road

THE government has allocated E54 million to improve the road from KaLanga to Big Bend in the Lubombo region.

The ministry reported in its second quarter performance report that the process of procuring a suitable contractor was ongoing.

The tender board has reportedly approved a recommendation and issued a tender sanction for contract award. The road is currently in a very bad state, full of potholes.

The ministry, however, reported that the process of preparing a Loan Bill for parliament approval was ongoing, after which the contractor will be engaged for construction. Parliament is the government wing responsible for approving government loan requests from other institutions.

The ministry further said the process of procuring a supervising consul-

tant was ongoing and technical proposals have been evaluated. Financial proposals, according to the ministry, shall be evaluated shortly and a recommendation for a service contract subsequently made to tender board.

The ministry reported that initially, it had been allocated a budget of E100 million but had to be cut to E54 million.

Should these budget cuts be persistent, the ministry said such would have negative impact on the scheduled monthly repayments to the contractor once they are on site.

Other challenges highlighted were the processes involved in finally approving the contractor.

'The Loan Bill cycle and parliamentary processes will delay implementation. Projections indicate that implementation will not happen in the current financial year, thus rendering the allocated funding unusable. Discussions are underway with Central Agencies on how best to move forward."

Judge Mlangeni puts foot down in hacking matter

HIGH Court Judge Titus Mlangeni has refused to grant another postponement to the Pakistani nationals accused of hacking their fellow countryman.

The four attempted murder suspects assaulted Siteki businessman Naeem Gul in April 2016, damaged his car and further stole his cash, it has been alleged.

However, the judge wondered if the advocate was setting dates for the court, but Nzima responded to the effect that the senior learned friend was merely suggesting dates which could be used. The judge said it was not enough justification because he had given the defence six weeks to instruct an advocate, therefore he would not accept another postponement.

He said there were many advocates in the country and in South Africa who could have been engaged if the chosen one was engaged.

However, Nzima said the suspects had a constitutional right to choose an advocate of their own and whom they trusted would represent them well in the criminal trial.

The judge said there was need to deal with the matter expediently because the complainant needed to be given time to go to his home country and get medical attention for the injuries he suffered when he was attacked by the four.

The judge ordered that the matter should be postponed to December 20

He said he hoped the advocate would have been done with the other engagements and be available or the suspects would have to instruct any other advocate they could get.

Philippines' Duterte says he personally killed people

MANILA - Philippine President Rodrigo Duterte has said he personally killed suspected criminals when he was mayor of a southern city to set an example for police.

Duterte made the comments in a speech late on Monday night to businessmen as he discussed his campaign to eradicate illegal drugs, which has seen police and

unknown assailants kill thousands of people since he became president on June 30. After speaking about police killing suspects during the current crime war, Duterte said he led similar efforts when he was mayor of Davao, the major southern city that he ruled for most of the previous 20 years. "In Davao I used to do it personally. Just to show to the guys

[police] that if I can do it why can't you Duterte said in his speech at the presi dential palace.

"And I'd go around in Davao with a motorcycle, with a big bike around, and I would just patrol the streets, looking for trouble also. I was really looking for a confrontation so I could kill.

The Incwala is an annual kingship ceremony that marks the first fruits of a new year.

It has been celebrated by the nation for centuries and it serves as a unifying factor for the Swazis, a Nguni tribe founded by the Dlamini Royal dynasty.

The ceremony is one of the truly indigenous African events that evoke the African spirit in the men as they dance to spiritual, traditional battle songs which were composed by their ancestors.

To the outside world, today the ceremony has become a huge tourist attraction.

THE FULL SEOUENCE OF THE **INCWALA IS AS FOLLOWS:**

DAY 1

DISPERSING OF REGIMENT (TINGAJA):

Unmarried male youths set off from Ngabezweni Royal Residence and march 50km to cut branches of the sacred shrub (lusekwane) under the light of the full moon, accompanied by the libutfo

DAY 2 **DELIVERING THE LUSEKWANE:** the boys place their lusekwane branches in the national cattle byre. The elders weave these branches in between poles of the "inhlambelo", the King's private sanctuary.

DAY 3 MORNING: Young boys cut branches of the black "Imbondvo" (red bush willow/combretum apiculatum) and these are

added to the "Inhlambelo." AFTERNOON: A bull charges out and the Lusekwane boys catch and overpower the beast and return it to the sanctuary.

DAY 4 MAIN DAY: All the key players perform in a spectacular pageant inside the cattle byre; the King and the regiment appear in full wardress and dance to a number of songs.

DO'S AND DON'TS OF THE INCWALA

- Females should wear skirts or sarongs
- Men should not wear hats or any head gear that is not traditional
- Shoes are worn at the ceremony but not on the dance arena
- Do take pictures at the ceremony but not of the Inhlambelo (King's private sanctuary)
- Please use restrooms
- Do sing, dance, encourage and uphold unity
- amongst Swazis ■ Do inform friends and tourists of prohibitions during Incwala.

Senior regimental members accompanied the boys regiment to Esikhaleniselusekwane in Nhlambeni, near Gundvwini, where they would cut the lusekwane.

The long journey to Nhlambeni becomes an interesting annual physical test for both the young and elderly warriors who participate as they travel from Ngabezweni to Nhlambeni, past Masundvwini, and back to Ludzidzini.

The commissioning of the Ingatja boys regiment confirmed the imminence of the main Incwala.

Dancing

The main day is on Saturday. The commissioning comes after 14 days of hard dancing of the Little Incwala. Both

the young and the old took the long trip to Nhlambeni enthusiastically, and marched in their regimental groups with the Emavulandlela (Boy Scouts) taking the lead and followed by Inkhanyeti then Inyatsi and Umgadlela forms the backline.

The regiment is dressed in their traditional regalia consisting mainly of the colourful (umdada) leop-

ard skirt on top of the bright regimental tidvwashi with the upper body fully covered by the sigeja, a well knitted oxtails that provides warmth and protects them from rain.

The senior regimental members are fully armed with shields and spears, signifying the war-like nature of the journey to cut the lusekwane shrub and bring it to the Royal Residence, the country's traditional headquarters at Ludzidzini.

The Lusekwane shrub is used to build the Ingwenyama's inhlambelo enclosure at the cattle byre where the Incwala main ceremony would be danced.

In terms of strict Swazi culture, boys who have had an encounter with married women are not eligible to cut the lusekwane.

CJ announces 2017 court sessions

CHIEF Justice Bheki Maphalala has announced dates for the country's court sessions for 2017.

In a notice issued yesterday, Justice Maphalala said the High Court's first session would commence on January 30 until May 5. The High Court session would run concurrently with that of the Industrial Court.

The Supreme Court session would commence on February 6 until May 31 for the first session.

The superior court's second session would run between July 1, 2017 and November 30.

The Industrial Court of Appeal, Justice Maphalala announced, would have two sessions with the first commencing on April 3 to 21, 2017. The second session would be held between September 25 and October 13.

Medical aid for teachers next June but...

MEMBERS of the Swaziland **National Association of Teachers** (SNAT) will finally get medical aid.

SNAT has embarked on a mission to find a reputable medical aid provider for medical services to its members.

Secretary General Zweli Mndzebele said the SNAT burial department was exploring all options to get a reputable and affordable medical aid provider in the country.

He said efforts to find a medical aid provider come after fruitless attempts to have government provide medical aid for teachers.

Seeing that government was not interested in aiding the whole teaching fratemity with medical aid, they have resorted to at least provide it for the SNAT members.

"SNAT has in the past approached the ministry of education, imploring them to provide medical aid for teachers.

"SNAT went as far identifying a medical aid provider, but after all that, government told us there was no money to finance the medical aid for teachers in the country," he said

Search

The secretary general said the search for a medical aid provider process was still at preliminary stages and there were still a lot of logistics to be considered.

He further said the process might take about six months to be finalised. "If everything goes well, we are looking at June to be the first month for the implementation of the medical aid," he said.

SNAT has already sent invitations for reputable medical aid providers to forward proposals for providing same to the association.








400 000 Mobile Money users

SWAZI MTN has 395 000 registered Mobile Money users.

However, out of that number, a total of 195 000 users are active. This was revealed by Small and Medium Enterprise (SME) wholesale and Distribution Manager at MTN Business Division Winile Vilakati.

Vilakati explained that once customers register under MTN business, they can have no limit to the amount of mobile money in their account and no limit to the amount of money they can transfer.

Vilakati stated that the move by MTN to incorporate a limitless system under their business model of mobile money, was to make it more convenient to small or medium business clients who might want to pay their employees with the mobile money system.

"Some business people might want to pay their customers with mobile money and we feel is a cost effective measure that will allow the consumer to be more flexible with the mobile money platform," she said. Vilakati was making her presentation at the Pigg's Peak Hotel yesterday morning during the MTN business seminar.

wazi, 5 SA men arrested in foiled robbery

A foiled business robbery ended in a high speed chase and a violent shootout between South African police and a Swazi national who was in the company of five South Africans.

The scene depicted what looked like a movie as a helicopter and other special forces combating crime in South Africa were involved in the violent speed chase, tracking down two vehicles full of criminals.

Information gathered is that a joint special intelligence driven operation comprising of Crime Intelligence Unit, the Provincial Tracking Team, the Provincial General Detectives, the Tzaneen Cluster First Responders, the Tactical Response Team and Air Wing received information about the planned robbery and they joined forces in order to intercept the group of criminals who were going to commit a business robbery in Tzaneen.

According to information from the South African Police Service, following the information, the teams of SAPS members tracked and spotted a Mercedes Benz sedan along the road outside Tzaneen and when they attempted to stop it, it sped off and the occupants started shooting at the police and a high speed chase ensued until the suspects lost control of their vehicle and it went off the road. It is said after the car veered off the road the six suspects, aged between 28 and 38, were arrested while being trapped inside their vehicle.

Reports stated that the gang of six was arrested on Tuesday and now faces a string of charges ranging from attempted murder to cellphone jamming.

It is said the suspects were caught near Tzaneen, an area under Limpompo Province, driving around in a flashy Mercedes Benz and an Audi vehicle. The Mercedes Benz vehicle was also allegedly stolen as it had its chassis number altered.

Information gathered is that the suspects carried with them high military grade weapons which they were going to use during the planned robbery.

The Provincial Commissioner Lieutenant General Nneke Ledwaba stated that preliminary investigations have revealed that the Audi vehicle was stolen in Ivory Park in the Gauteng Province. The South African police stated that the suspects were found to be from Sekororo, Lenyenye and Tickyline, outside Tzaneen,

Tembisa in Gauteng and one from Swaziland. The suspects are expected to appear before Tzaneen Magistrate's Court soon and police investigations are still continuing.

According to SAPS, the gang members are facing various charges including attempted murder, conspiracy to commit armed robbery, possession of cell phone jamming device, possession of stolen motor vehicles and possession of unlicensed firearms and ammunition.

High grade military weapons found at scene

THE Swazi national who was arrested in South Africa with his gang members is alleged to have been also found in possession of high grade military weapons.

These weapons included a military cellphone jamming device, two 9mm firearms, two magazines and one six channel radio, which is used by members of the police or army to communicate.

The suspects were also using two stolen vehicles a Mercedes Benz sedan, which had its chassis number altered and an Audi sedan vehicle. which was reported to be stolen in Ivory Park in the Gauteng Province.

109 arrested in Operation BASADI

THERE were 109 people arrested by the Royal Swaziland Police (RSP) officers during the Basadi Operation, which began last month.

According to Chief Police Information and Communications Officer Superintendent Khulani Mamba, the 109 were arrested for various offences at different areas of the country.

Mamba said there were 20 people arrested for assault with intent to cause grievous bodily harm while there were 19 arrested for common assault. "There were 18 people arrested for dagga while 27 were arrested for trading without a licence."

He said some were arrested for cases of abduction, violating the Girls and Women's Protection Act, attempted murder, crimen injura, illegal immigrants and others.

"RSP, through its Gender Network, has in commemoration of the 16 days of activism to end violence against women and children and in compliance with a resolution taken by the SARPCCO police chiefs to combat this scourge, conducted an operation with the code name BASADI."

He said Basadi Operation was an annual exercise purposely made to coincide with the 16 Days of Activism to show commitment on the gender based violence issues.

Thus the operation was conducted from November, 23-25 simultaneously by SARPCCO member states and in all the regions.

Mamba said its objective was to arrest wanted persons for the offences of violence against women

and children. "It was also imperative to widen the net by dealing with other sources that contribute to this evil. Hence dagga raids and roadblocks were also conducted."

According to Mamba, this proved to be a huge success as there were 109 arrests for various offences inter alia: rape, assault GBH, abduction, violating the Girls and Women Protection Act, assault common and attempted murder, to mention a few relating to this operation. "The Royal Swaziland Police Service is grateful for the cooperation received from the members of the public during this operation."



FAMILY IMPLICATES HUBBY IN WIFE'S DEATH, EXHUMES BODY

By Linda Jele High Court

A family of a dead woman has implicated her husband to be behind her demise.

This has resulted in the body of the late Dudu Mamba exhumed from the Ngwane Park Cemetery for the purposes of conducting an autopsy examination to determine the cause of death, it has been alleged. Manzini police, it has been alleged, have opened an inquiry file to determine the cause of Mamba's death.

Her corpse is currently kept at Dups Funeral Home and her family does not want her to be buried at her husband Sibonangaye Shongwe's home of Makholweni in the Manzini region.

Marriage

Her brother Owen Mamba has filed an application at the High Court seeking an order interdicting Shongwe from conducting the re-burial. He argues that Shongwe is not the lawful husband to his sister.

These are allegations contained in Owen's affidavit, merits of which are yet to be contested before court. Shongwe has denied that he is implicated in his wife's death and that he was not legally married to her.

Owen is represented by lawyer Sipho Gumedze from VZ Dlamini Attorneys in the matter.

He alleged his wife had been married to one Gideon Groening in Swazi customary law, and dowry was paid. He alleged the couple separated

due to Groening's violence and the latter died while they were still finalising the nullification of the marriage. He claimed Mamba then established herself a home at Sicelwini in Manzini, where she constructed flats for rental

Parental Home

He claimed she later moved in with her new lover Shongwe and he attempted to marry her in Swazi customary law, but it was refused because her first marriage had not been nullified.

"My sister became gravely ill in the beginning of 2016. On her sick bed, she had made known of her desire not to be buried at her parental home, but rather at her home, which she built for herself at Sicelwini. On the day my sister was to be buried, Shongwe (first respondent) intercepted the vigil wherein, he presented us with a court order interdicting us from continuing burying the deceased

Investigation

Her body was removed from the home and taken to a place unknown to us. We later learnt Shongwe had buried my sister at the Ngwane Park Cemetery and none of her family members knew of the burial," Owen said.

He claimed the police summoned him and other family members on October 11, 2016 whereupon they were informed of an investigation into the murder of his sister.

He claimed the police told the Mamba family that some people had confessed of having killed Mamba. 'The first respondent has been implicated in the murder allegation. We were informed the body of my late sister will be exhumed for the purposes of conducting a post-mortem," Owen said.

Judge

He alleged Mamba's body was exhumed and examined by a pathologist and the family is waiting for the results of the cause of death. He argued his sister could not be buried by the Shongwe family because she was not legally married to Shongwe. He also claimed his sister had never written a will and never had a child.

The matter was heard by High Court Judge Nkululeko Hlophe who postponed it to tomorrow for argu-

Hubby argues he has right to bury wife

SIBONANGAYE Shongwe has argued that he is the surviving lawful spouse of the late Dudu Mamba, therefore has the right to bury her in his homestead.

He presented a marriage certificate before court attached to his answering affidavit filed by lawyer Sipho Simelane from Zonke Magagula Attorneys. He argued he buried Dudu Mamba pursuant to his rights as her husband and on the strength of the court order that interdicted anyone from burying her aside from him. He further denied that he was implicated in her death. He also said the office of the director of public prosecutions has not served him with an application for the exhumation of his wife's body. He said in his knowledge his wife was still buried at Ngwane Park because no application was made before court for her body's exhumation. He said he exercised his rights to bury his wife when he approached the High Court and said the Mamba family decided to distance itself from burying her, therefore he could not be held accountable for their action. He labelled Owen Mamba's allegations that he was implicated in his wife's murder as scandalous because he has not been charged.

He said the Mamba family could not be allowed to bury a Shongwe wife. He also said the Mamba family could only challenge the High Court judgment that allowed him to bury his wife than file a fresh application for an interdict.

"It is rather unfortunate that the issue of my wife dying without children is being used to mock her marriage to me, however, it does not revoke the marriage between me and the deceased," Shongwe said.

4. If you think your PIN has been compromised, change it immediately

5. Do not respond to competition SMS's or MMS's

6. If you receive a phone call requesting personal information over the line, do not share those details, end the call.

7. If you use a Smartphone, install an upto-date anti-virus application to your cell phone. Most banks provide this free of charge to their customers.



MBABANE – GO to Taiwan and you will see how they manage the art of dealing garbage.

I was personally impressed on learning how they do it. I noticed every household does not put its garbage bag at the street corner; in fact, Taiwanese hold their garbage bags, stand by the roadside and throw their own garbage bags into the garbage-collecting trucks.

No wonder the country is so clean and honestly, when I say they know no garbage, I just mean that. It's just a breath of fresh air. I also like the fact that it has not always been like this. They had to come up with strategies to make the country what it is today in terms of cleanliness and dealing with garbage.

I was told there were a lot of garbage pickup spots around Taipei, Taiwan's capital that trucks visit five nights a week. You wake up in the morning, there is no garbage.

No one tells them its time but instead there are signals to the surrounding community that it's time to move out onto the street in preparation.

Then you see a big yellow truck appear, always followed by a smaller white cart. The yellow truck is for general trash and the white cart has a set of bins used to categorise recyclable materials. There's one for glass, paper, cardboard, cans and plastic.

Process

There's even a bin for raw food waste and one for cooked food waste. Recycling companies process the raw food waste into fertiliser for farmers, and the cooked food waste into food for farm animals.

Volunteers and officials stand on the back of the recycling truck ready to help people sort their recyclables correctly. One by one, everyone throws their small amount personal garbage into the correct truck, and return home to continue on with the day.

They just do a lot to make sure the country is always clean. Judging from what they do, they can never go wrong in as far as maintaining cleanliness is concerned.

In 1996 Taiwan Government made a 'Keep trash off the ground' Programme and this is why they throw their own garbage bags into the garbage-collecting trucks.

When they tell you how they started this, you are really shocked at how they have managed to turn things around after they were once dubbed as a 'garbage island'.

There were huge dumpsters and loose trash on the streets such that they were running out of space to put their waste.

It is clear Taiwan's previous biggest problem is now its biggest asset, due to the implemen-



tation of these advanced waste management practices.

The Taiwanese buy government designated bags to put their garbage in and throw it into garage collecting trucks and failure to do so, you receive a fine of 1 200 Taiwan dollars (approximate E522).

It means if a household or a shop generates more garbage they should pay more for their waste. The Taiwanese are made to distinguish different types of garbage, for metal can, plastic products they need to throw to recycle trucks instead of throwing into normal garbage collecting trucks.

Then in 1997, the Taiwan Environmental Protection Bureau introduced the 'Waste Management Law 'which made plans to recycle the waste and made subsidy to encourage industries to recycle used prod-

Thoughtful

Recycling is free and can be brought to the truck in any kind of bag and this is what encourages people to recycle more and produce less trash.

As a result, Taiwan's communities have learned to be very thoughtful and considerate with their consumptive practices. The Taiwanese government has successfully slashed the daily household waste accumulation from 1.14 kg to a mere


The people there pay for plastic bags in the shops so most of them always carry their own shopping bags when they do shopping. I think as Swazis we should also adopt the idea of carrying our bags when going to shop. It helps a great deal in as far as plastic and waste management is concerned.

Due to this successful garbage recycle plan, they successfully reduced 58 per cent of their general garbage in 2011.

You should also be aware, they are the first country to set up the recycle scheme and factories for four electronic products (TV, laundry machine, air conditioner and PC related prod-

In 2011 Taiwan had a 48.8 per cent recycle rate of these above four used products which is already over the EU 45 per cent recycle rate set up for the year of 2016.

Man stabs woman for looking at him

A woman almost lost her life after she was viciously stabbed with a beer bottle on the head by a man for merely looking at him in an 'unfriendly' manner.

This is one incident which has been viewed as one of the cases of gender based violence.

Sustaining

Mancoba Fakudze (34), who is a public transport driver, allegedly stabbed Rose Magongo just above her eye and on the arm, resulting to her sustaining serious wounds.

The incident occurred near a bar, which is situated within the town cen-

He was subsequently arrested and charged with assault with intent to cause grievous bodily harm.

When the charge sheet was read to him, he pleaded not guilty while conducting his own defence before Principal Magistrate Dumsani Magagula.

Unfriendly

When presenting her evidence, Magongo told the court that Fakudze accused her of looking at him in an unfriendly manner.

She admitted to have mistakenly bumped onto the accused after finding him standing at the entrance of the

bar. This then earned her the assault from Fakudze.

In his defence, Fakudze told the court that the complainant intentionally pushed him before hurling insults at

Misunderstanding

He said in the midst of their misunderstanding, he was attacked by a number of men who assaulted him with fists and open hands.

He claimed it was during this fight that the complainant got injured. Meanwhile, the complainant told the court that the accused was assaulted by a mob after he had already stabbed her. The matter was postponed to February 10, for continuation of trial.

Traffic cop loses control of vehicle, overturns

A female traffic police officer deployed at Siteki Police Station is currently recuperating at Good Shepherd Hospital after she lost control of her vehicle, overturning it once.

The accident happened in the early hours of Tuesday when the officer was on her way from home to her work place.

Witnesses said the officer, who is well known amongst motorists, failed to negotiate her way through a sharp corner situated near Mzilikazi, at an area known as KaJezi.

Her vehicle veered off the road and headed towards a nearby homestead, before overturning once and coming to a standstill.

She remained in the vehicle for some minutes as nobody came to her rescue. But she later managed to pull her-

self out and called for help from her colleagues. She was rushed to the hospital where she was admitted.

Chief Police Information and Communications Officer Superintendent Khulani Mamba confirmed the incident. Mamba said the officer was recovering in hospital after sustaining injuries on the head.

Meanwhile in another road accident, a police van was hit on the side by a run-away Isuzu van near Futheni. The accident happened on Monday morning.

During this accident, a police officer, who was on the passenger seat, sustained minor injuries on the body while the driver escaped unhurt.

The officer was treated at Good Shepherd Hospital and discharged on the same day.

Man bumps into fuel attendant, fined E500

A man has been fined E500 for bumping into a petrol attendant at a fuel service station.

Peter Dlamini, aged 42 from Buhleni, was arrested for bumping into fuel attendant, Patrick Zwane, who is aged 39.

He subsequently appeared before Pigg's Peak Magistrate Simangele Mbatha. Dlamini said his car locked its steering wheel when it switched off.

Automatically

"I did not intend to cause the accident, unfortunately the car I drive locks its steering wheel automatically when the engine stops running.

In this case, the engine failed because the car had ran out of fuel. So I was on my way to the service station and right before the petrol pumps my car switched off," he said.

Dlamini said there was nothing else he could do as the car bumped into the service station attendant.

"I then rushed the attendant to the Pigg's Peak Government Hospital and paid for his treatment. I also checked

up on him regularly and bought him food as I was trying to indicate how sorry I was for the accident in the first place," he said. Meanwhile, the magistrate sentenced Dlamini to five months in a correctional facility for causing the accident if he failed to pay the E500 fine.



Two nabbed with sports bags filled with 53kg dagga

TWO men were busted with sports bags filled with dagga weighing 53 kilograms at the Ngwenya Border Gate.

The two were busted with four others on separate occasions at the border gate.

The two; Teacher Dlamini (29) and Sikelela Dlamini (33) had the highest load and thus were ordered to appear before the High Court to make their bail application.

The two men appeared before Magistrate Sifiso Vilakati on Tuesday and were ordered to come back to court on January 10.

A desperate move by Sikelela to gain his freedom was in vain as he alleged the bags did not belong to him but the person he was found with.

"I was only accompanying him, I know nothing about the dagga," he said.

The two were remanded back into custody.

Meanwhile, three South Africans also appeared in court after being nabbed on Sunday with the illegal herb at the Ngwenya Border Gate.

Monku Kagiso (31) was nabbed with five blocks of dagga weigh-

ing 6.8kg. He said he was unemployed and was trying to raise morey feed his children. He was fined E 000 or two years in a correctional facility.

Nobony Zenzele (46) of Johannesburg told the court she was a dagga dealer after being found with 5.75kg bags of dagga.

She was also charged for contravening the Immigration Act after being found in the country without a valid licence or permit.

"I am sorry; I was going to sell the dagga. I would not like to see my children using this drug, I apologise," she said.

She was fined E2 000 or two years in jail for being found in possession.

She was further fined E500 or

She was further fined E500 or five months in jail for being in the country illegally.

Another dagga case was of Mfanaleni Nkosi from Oshoek, who was also nabbed with the illegal herb weighing 3.9kg and was fined E2 000 or two years in jail.

In addition, a man from Mankayane told the court his lack of education resulted in him not being unable to secure a job hence his decision to turn into dagga dealing.

Ndumiso Mvubelo (25) said he was only trying to earn a living. Vilakati sentenced him to pay a fine of E2 000 or two years in jail.

Farmers must pay for recovered cattle - Ministry

FARMERS who had their stolen cattle recovered from Mozambique and later kept at a quarantine must either pay the required fee or lose these to the ministry of agriculture, says the Department of Veterinary Services.

This is contrary to what the farmers were recently made to believe after they were informed they would be given the opportunity to negotiate for the release of their cattle with the director.

Apparently, the livestock owners, who are mainly from Mhlumeni and Siteki, lost 17 cattle to rustlers early last month.

The cattle were later recovered from Mozambique and were taken to a quarantine at Maphiveni for monitoring of the deadly foot and mouth disease.

The farmers were then informed they must pay at least E700 for the release of each cow.

Following numerous meetings with officials at the Siteki veteri-

nary office, the farmers were later informed that the director had promised to help them at no cost.

They were told that they would be meeting the director this week. However, when reached for clarity on the matter yesterday, the

director disputed the reports.

Instead, he highlighted that there was a standing Animal Act which stated that farmers would be required to pay a certain amount for having their livestock checked for diseases whenever it was transported into the country from another.

He said the Act had no exceptions on whether this would apply when the animals were being transported freely or have been stole. The director, who opted to be brein his explanation, said the affected Mhlumeni and Siteki farmers would therefore have to pay the required amount without any option.

This also comes after the fame ers reported they were informed that the ministry of agriculture would sell their cattle on auctical if they fail to pay for them.

Odede said through this project they hoped it would present an

opportunity to ensure that every child born in a hospital does not leave without a birth certificate.

She said such would prevent cases of human trafficking because every child would get out of hospital knowing his or her nationality. The country representative stated that she was aware with these success stories, comes massive challenges.

She said because of limited resources, many children and their parents get excluded.

Maphungwane man held for house breaking and theft

AS more cases of house breaking and theft are reported, a man of Maphungwane has been arrested and charged with house breaking and theft of property worth over E13 000.

Mduduzi Maziya appeared before Principal Magistrate Dumsani Magagula on Monday where he faced three charges. He is also charged with robbery, in that he wrongfully and unlawfully robbed Ndumiso Khoza of a cell-



phone valued at E1 200 and a bag which carried various items. The accused is said to have threatened his victims with a knife, saying he would stab them if they did not comply with his orders.

During his appearance in court, the crown applied that the accused be remanded in custody pending setting of a trial date.

The matter was subsequently postponed to next Monday.

Meanwhile, Dumisa Sibandze (34) also appeared before the same court

where he faced a charge of theft. He is accused of having stolen a Galaxy cellphone valued at E4 000. His case was also postponed to next Monday after he was granted bail of E500.

Worth noting is that police have been warning members of the public to be vigilant as criminals intensify their attack during the festive season. During recent crime prevention events, the public has also been warned against carrying large amounts of money or highly valued property in public.

NHLANGANO SATELLITE BUS RANK REHABILITATION COMPLETED

THE refurbishment of the satellite bus rank in Nhlangano has been completed and public transport operators have thanked the owners of the structure.

The satellite bus rank is part of the Nhlangano Mall, which is a privately owned property housing a number of businesses.

The refurbishment of the facility situated close to the Swaziland Building Society (SBS) happened over a couple of weeks and it was opened for use at the beginning of the week.

For a long time, the facility has been in a terrible state.

The new look satellite bus rank is used mostly by short distance public transport vehicles servicing routes like Nhlangano/Makhosini/Mashobeni as well as Nhlangano/Mahamba routes.

Sifiso Kunene, owner of Sanele Transport servicing Nhlangano/Mashobeni route, said they were pleased that now they would use an improved facility.

He said as public transport operators. they were encouraged with the good work done by the owner of the property. "The facility is now usable, unlike before where there were potholes all over which made us customers wonder as to who was supposed to maintain the place. We are happy that the facility has been rehabilitated," said Kunene. He said as there was a rank fee collected daily from each kombi. it would be a wise thing to use the money in maintaining the facility. Kunene said the town Council, which collected the fee, should put it to good use. He said with the satellite bus rank refurbished, it was necessary that town Council consider renovating the main bus rank, especially the stretch from KaMjuda Filling Station.

"Roads in Nhlangano have improved and the only task that also needs urgent attention is the stretch to the main bus rank from KaMjuda Filling Station. There are also unbearable potholes inside the facility and it's time they are fixed," said Kunene.

PROMOTE DOMESTIC TOURIS



40% MORE FARMERS WANT TO PLOUGH, PLANT

THE number of farmers who are eager to plant and plough has increased by 40 per cent.

Minister for Agriculture Moses Vilakati, asked for an update on where the country was in terms of attaining its objective of maize production, said he was optimistic Swaziland would achieve its objective. "The farmers have come out in great numbers to register for ploughing. Our target was to have 40 000 hours ploughed, but we now have 56 000 hours registered for the yea;" Vilakati said. The minister said this was a 40 per cent increase in the number of farmers who were eager to plough and plant this year.


Vilakati, who is also a Member of Parliament (MP) for Ntondozi Constituency, said such a turn out from the farmers was exciting and overwhelming.

He said the aim for them, as a ministry, was to cover all the 56 000 hours. "If all of the hours are used to plough and plant, we will get a minimum of two tons per hectare. This will make us self-sufficient in maize," he said,

If the enthusiasm shown by the farmers was to continue, the minister said the country would reap 112 000 metric tons of maize. The ministry of agriculture is aiming at making the country reap 110 000 metric tons of maize. That would be enough to make the country self-sufficient in this staple product.

The minister said for the country to be self-sufficient and export maize, 130 000 to 140 000 metric tons of maize would have to be reaped. That was the ultimate goal, according to the minister. He said the country would reach that goal next year, if things went according to plan.

This was mainly because most farmers were sceptical to go to the fields this year. The minister sounded very optimistic that the country would overcome hunger this year.

MULTISECTORAL RESPONSE (MR)

THE country's extended National Strategic Framework (eNSF) 2014 – 2018, clearly articulates that the HIV response's first priority "is to prevent new HIV infections, reduce mortality amongst people living with HIV (PLHIV)."

It goes on to set out nine priority programmes that have the potential to yield the desired national results.

The nine core programmes are designed around and implemented using the "combination strategy" model in which different programmes and interventions together contribute towards achieving results.

The successful implementation of these rest on the level of investment, that is, the degree of intensity, community involvement to create demand, shift in social norms, and human and technological capacity—including the availability of systems to deliver the needed services.

INADEQUATE TARGETING AND LACK OF INTENSITY OF HIV PREVENTION PRO-GRAMMES

The mid-term review of the initial NSF (2009-2014) showed that strategies did not adequately address critical behaviours, epidemic drivers, underlying factors that increase risk and vulnerability such as cultural and social norms, gender inequality, gender based violence, poverty, mobility, stigma and discrimination. Prevention programmes are typically provided in a generic manner.

With this in mind and in line with the extended NSF, the National Emergency Response Council on HIV and AIDS (NERCHA) though the National HIV and AIDS Information and Training Centre (Info Centre) having identified men as "left behind" yet critical players in the HIV response, engaged Siphila Nje Drama Society (SNDS) and worked together to conceptualise, develop and deliver a programme specific to men. One that would not only talk to men as individuals but one that could target them as members of communities and in the process help address the issue of weak community ownership and participation, including the participation of PLHIV.

The SNDS then developed a programme based on tradition and culture, and aptly named it "Enjobeni Majaha" - an idiomatic Swazi expression - whose main objective is to create demand and mobilise men for HIV services uptake. The concept follows the Kudliw' Inhloko Majaha concept that was also con-

ceived and popularised by SNDS, through funding from NERCHA in the early 2000s.

ENJOBENI MAJAHA WAC PILOT

The 2016 WAC had as its objective, the reinvigoration of the HIV prevention and treatment agenda towards the elimination of new infections and ending AIDS as a public health threat in Swaziland by 2022.

Through its "Hands Up for #HIV Prevention" theme, it presented an opportune time to pilot the *Enjobeni Majaha*. With the national World AIDS Day commemoration set to be hosted by the Manzini region, in the sub-region of Mankayane, the SNDS was therefore given the responsibility of delivering the programme in the 10 *imiphakatsi* under the Ingwempisi *Inkhundla* and an additional urban setting.

Its main objective was to galvanise men in these communities for action so those that were reached by the programme not only take up the HIV Testing and Counselling (HTC) services provided as part of the *Enjobeni* delivery, but also find time to participate in the 2016 WAD commemoration and take up other HIV and AIDS related services offered on the day.

The Enjobeni Majaha pilot programme targeted men above 30 years of age (identified as one of the "priority populations" as they, including those from age 24, indicate a higher prevalence rate of HIV infection, and are also the ones to account for the high HIV incidence among adolescent girls aged 15-19).

The programme ran from 15th November to the 1st of December 2016 and covered all 10 *imiphakatsi* under the Ingwemphisi *Inkhundla*, with an additional community of men from the Mankayane Town.

AMBUSH PARTICIPATORY THEATRE

As Siphila Nje Drama Society uses theatre drama to communicate across all themes, a stage drama carrying the important messages of the Enjobeni Majaha was conceived, developed, and delivered.

Messages covered by the drama include: the test and start initiative; linkages to health care; treatment as prevention (benefits of being on treatment); voluntary medical male circumcision and condom; the role of men in the prevention of mother-to-child transmission of HIV; post exposure prophylaxis; stigma and discrimination; as well as power relations and gender issues.

The drama was set as 'Ambush Participatory Theatre' and engaged the men as active participants who were asked to respond to some of the issues raised.

In the initial, a pre-test evaluation was conducted to assess the knowledge levels of the participants, something that helped the facilitators to note information gaps and or lack of information, which was then addressed during discussions, with a post-test evaluation conducted at the very end.

After the drama performance, facilitated discussions guided by set discussion questions which touched on all the issues contained in the drama, as well as questions, reflections and recommendations from the participants, ensued.

During this time, the facilitators constantly called out for the next man to get tested for HIV on-site. With support from the AIDS Healthcare Foundation (AHF) save for the communities of Ngcoseni and Mankayane town, all other visited communities were provided with HTC services.

Men found pleasure in being the next to be seen going for the test, resulting in almost 65 per cent attendants testing on the spot.

LESSONS LEARNT

Men's access to and use of sexual reproductive health (SRH) services is particularly important in settings with a generalised HIV epidemic like that in the country. Evidence has shown that men use such services far less than women do and offer many reasons for the state of affairs.

The Enjobeni Majaha pilot programme has however served to show that men and boys (many showed up and were not turned away) when engaged in their own

space and in an environment they are comfortable with, are willing and determined to change their attitudes and practices towards their health, especially as regards their sexual activity and sexual relationships.

There are a number of factors to be taken into consideration however, if the programme is to be upscaled and taken nationally, like the *Kudliwi Nhloko* concept that was evidently recognised as a best practice, adopted and widely implemented by other HIV and AIDS organisations in their bid to reach men with information on HIV and AIDS. These include:

■ In male consultations, the imphakatsi and other structural bodies should be viewed as partners for ownership purposes rather than including them as the target audience.

There is need to obtain buy-in from all community structures for them to take full ownership of the programme.

Cultural customised interventions such as *Enjobeni Majaha* are positively received by men, some even going to the extent of saying that when His Majesty the King (*Umlomo longacaliemanga*) has given the directive for an AIDS free Swaziland by 2022, they as men, have to rise up and play their part. Many of the men expressed their satisfaction at the programme and stated they relate better to issues that speak to them directly.

The greater involvement of PLHIV proved to be a motivation to men to understand the possibility of living a healthy life regardless of the results of an HIV test.

Health information on issues such as test and start and the many other prevention technologies including HIV self-testing. PrePex and PrEPs hould be customised and shared with men at a faster pace as men expressed they are always the last recipients of accurate information. Many appreciated the presence of CHAPS, who provided accurate answers to their questions on

medical male circumcision.

LEADERSHIP GREETINGS FOR POWERFUL GIRLS

WE live in societies where leadership is seen as an exclusive preserve for men. Women and girls are socialised to support men and assist them to flourish in their leadership roles.

Women have been made to believe they do not have it in them to lead. How many times have you heard that women do not have what it takes to become leaders? But what is it really that makes a leader?

If Warren Bennis' definition is anything to go by, then we can make the assumption that leaders are people who are able to express themselves fully. It does not take anything outside of oneself to become a leader. It requires integrated people who know who they are, what their strengths and weaknesses are, and how to fully deploy their strengths and compensate for their weaknesses.

Goals

They also know what they want, why they want it, and how to communicate what they want to others, in order to gain their cooperation and support. Finally, they know how to achieve their goals.

The key to full self-expression is understanding one's self and the world, and the key to understanding is learning-from one's own life and experience.

Young girls and women living in patriarchal societies are already set to not meet this benchmark because their everyday interactions and environments emphasise the need to deny who they are and assume identities defined by selfinterested agents of stagnation and oppression.

These agents, so powerful, then "confer" these identities on the women who struggle to identify with them as they are in conflict with who they are and so fail to become what they set out to be. If society is always quick to point out women are natural nurturers, why is it difficult to see that the very same nurturing trait is an ingredient for leadership-servant leader-

This is the kind of leadership that ship? will take us far as societies especially because we do not want people that will become leaders and just put that in their CVs; we need people who will make change and leave a legacy and for something as timeless as that, we need nurturers who have "Ubuntu".

Voice

Warren Bennis argues timeless leadership is always about character, and it is always about authenticity. To underscore this point, psychologist William James wrote, "I have often thought the best way to define a man's character is to seek out the particular mental or moral attitude in which, when it came upon him, he felt himself most deeply and intensively active and alive. At such moments, there is a voice inside which speaks and

says, "This is the real me." Young girls,

you are encouraged to discover and cultivate that authentic self, the part of you that is most everyday interactions and alive, the part that is most you. Now, as then, finding and nurturing that authentic self is the one interested agents of stagsure way of becoming a leader. But that is the

hardest part for most of us. Rightly think and do into a whole person so, because becoming a leader is not easy, just as becoming a doctor or a poet isn't easy, and those who claim otherwise are fooling themselves.

But learning to lead is a lot easier than most of us think it is, because each of us contains the capacity for leadership. In fact, almost every one of us can point to some leadership experience; at home, school, in the church or the community. So, what made us leaders in those instances?

The first thing that our girls need to have for them to become timeless leaders is integrity. This is a

difficult one because it calls for us to be discouraged, based on ignoring the hypocrisy and double-standards that are pervasive in our societies.

deeds match up." We struggle everyday with situations that demand decisions between what we want to do and what we ought to do. Integrity establishes the ground rules for resolving these tensions.

It determines who we are and how we will respond before the conflict even appears. It welds what we say,

so that permission is never grantsync. It binds our person together and fosters a spirit of contentment within us. It will not allow our lips to violate our hearts. When integrity is the referee, we become consistent- our beliefs are mirrored by our conduct. To earn trust, a leader must be authentic.

It appears that traditional definitions of leadership make leadership overrated in our time. In the past, the emphasis was on collecting data, establishing whether you were on the right track and then acting. It gave so much room for superstitions, outdated beliefs and oppressive measures. Today, young people understand that time is of essence.

They think on their feet, make rules as they go- even bending and breaking some of them. This new way of thinking is what is going to lead our young people to uncharted worlds. The leaders of today's digital age, whose world is never still or quite in focus, must depend on compasses, according to Weick. He explains, "Maps, by definition, can help only in known worldsworlds that have been charted before. Compasses are helpful when you are not sure where you are and can get only a general sense of direction."

If we are going to break the mold, we need young girls who have seen the gloomy picture of women in leadership, but still remain determined to navigate the path with only a compass in their heads (vision), but not knowing where it will lead- only believing in themselves. In addition to vision, selfconfidence and emotional intelligence will take our girls far.

As we welcome the festive season, the message (by Warren Bennis) to beautiful, fun-loving girls should take is this: No leader sets out to be a leader. People set out to live their lives, expressing themselves fully. When that expression is of value, they become leaders. So the point is not to become a leader. The point is to become yourself, to use yourself completely-all your skills, gifts, and energiesin order to make your vision manifest. You must withhold nothing. You must, in sum, become the person you started out to be, and to enjoy the process of becoming.

MANUFACTURING SECTOR CREDIT HIT FIVE-YEAR LOW

CREDIT extended to the manufacturing sector has reached a five year low as only E410 million was extended to the sector as at the end of the third quarter.

According to the Central Bank of Swaziland (CBS) September Quarterly Report, credit extended to the manufacturing sector was E410 million.

The CBS said December 2014 credit manufacturing reached its highest point in 10 years as it reached E1.2 billion; it follows that in just two years manufacturing credit has plummeted almost two thirds, or 66 per cent.

A year on year comparison with this latest figure reveals credit extended to the manufacturing sector has contracted by more than 50 per cent in just 12 months, from E899 million.

University of Swaziland (UNISWA) lecturer and economist Sanele Sibiya said this could be a sign the economy was not going into recovery just yet.

"The manufacturing sector is an important entity as it is labour intensive, which therefore creates a lot of jobs within any economy," he

said

Sibiya said with the current data, the sector was not going through an expansionary cycle.

"This, therefore, is indicative of an economic downturn," he said. Developed economies often track

the level of productivity of the manufacturing sector and it was often used as an indicator for the level of activity within the economy.

South Africa, United Kingdom (UK) and United States of America (USA) financial publication houses often quote the PMI Index, an instrument which measures the manufacturing sector and its productivity.

It was akin to the inflation consumer price index (CPI).

Asked what could be causing credit levels to spike to five year historical levels, Sibiya said there were quite a number of factors that could be considered.

"It is important firstly to note the rise of globalisation has introduced global value chains which have resulted in companies having a large international value chain," he said.

Asked to simplify what this means

that companies now streamline their operations not nationally but globally.

"For instance, the company could choose to have an internalised process for credit; in that the company will not go to a local bank for credit but

will be funded internally by channelling money around the organisation itself," he said.

Sibiya said local companies, that have a local foot print only, should be the ones seeking credit but they have certain problems themselves.

"One issue for local manufacturing companies is they are not equipped technically to obtain loans," he said.

Elaborating, Sibiya said banks typically required certain type of paper work like cash flows, business plans and the like. This requires expertise advice which the smaller manufacturing companies do not have and cannot afford

In conclusion, Sibiya opined that banks were willing to lend to manufacturing sector, however, there were certain structural impediments that prevented them and also the demand for the loans was mooted from the sector itself.

IMF team visits Swaziland

AN International Monetary Fund (IMF) team, led by Geremia Palomba, IMF Mission Chief for Swaziland, visited Mbabane during December 5-12, to review recent developments, and discuss with the authorities the economic outlook and policy challenges going forward.

According to a statement released by the IMF, discussions with the authorities focused on the economic impact of recent developments, in particular on fiscal accounts, and policy options going forward.

"Discussions set the stage for the upcoming 2016 Article IV consultation with Swaziland planned to take place in the first half of 2017," said IMF.

At the end of the visit, in the statement, Palomba noted that during 2016, the country was hit by a severe drought and a sharp decline of the Southern African Customs Union (SACU) revenue.

Drought

"The drought is projected to weigh heavily on 2016 growth and inflation. The decline in SACU revenue has put pressure on both external and fiscal accounts. An expansionary fiscal stance has amplified the negative impact of these economic shocks on the budget," he said.

The mission met with Prime Minister Sibusiso Dlamini, Minister of Finance Martin Dlamini, Minister of Economic Planning and Development Prince Hlangusemphi, Central Bank of Swaziland (CBS) Governor Majozi Sithole, other senior officials and private sector representatives.

"The mission thanks the authorities for their hospitality and the productive and open discussions," stated Palomba.

According to the IMF website, Article IV consultations are country surveillance which are an ongoing process that culminates in regular comprehensive consultations with individual member countries, with discussions in between as needed.

The consultations are known as 'Article IV consultations' because they are required by Article IV of the IMF's Articles of Agreement.

During an Article IV consultation, an IMF team of economists visits a country to assess economic and financial developments and discuss the country's economic and financial policies with government and central bank officials.

Inflation might increase, mount pressure on bank rate

THERE is a high possibility that the country's inflation rate might also increase after South Africa's inflation increased to 6.6 per cent.

According to South African publication, Business Report, Statistics South Africa reported that the Republic's inflation rate increased to 6.6 per cent in November, from 6.4 per cent in October. It noted that, on average, prices increased by 0.3 per cent between October 2016 and November 2016.

Following which, financial analyst and economist Thembinkosi Dube said it was highly possible that the country's inflation rate would also ascend following the recent developments in South Africa.

He said this was because the country imports most of its products from the Republic.

"The effect will be in two folds, first it's the squeeze on the inflation rate and secondly, the interest rate pressure depending on how the South African Reserve Bank (SARB) and the Central Bank of Swaziland (CBS) will consequently decide on the interest rate," he said.

To contain inflation, one of the measures available to central banks is to increase interest rates.

In a recent interview with Swaziland Building Society (SBS) Managing Director Timothy Nhleko, he said if the inflation rate in South Africa was high, it gets imported to the country, "so we get affected by those exogenous factors which we have no control of, so that is why you sometimes find that South Africa has a lower inflation rate while we have a higher inflation rate."

The country's inflation rate currently stands at 8.2 per cent, but the CBS has kept the bank rate at seven per cent.

In his latest Monetary Policy statement following the Monetary Policy Consultative Committee (MPCC) meeting held in November 24-25, CBS Governor Majozi Sithole said the outlook was marred by persistent effects of drought on food supply. Going forward, the bank projected inflation to average 7.8 per cent for 2016.

However, the governor did say the

However, the governor did say the tough economic conditions were expected to continue in the short term with growth depressed.

"However, the bank wishes to emphasise that monetary policy shall remain supportive of sustained long-term growth," he said.

SAVE AND NOT PAY THE BANK FOR 12 MONTH

YOU can decide not to pay the bank for 12 months while you save with Nedbank's Savings Account.

Mbabane Region Small and Medium Enterprise Area Manager Sindi Motsa said this was possible as the account was a no charge in nature.

The account was designed for groups or individuals who wish to save together, from a minimum of three people.

Speaking during a short event held by the bank with its customers and prospect customers of the account, Motsa said clients could deposit for free using all the instruments that banks use for collecting deposits, "it may be cash, cheques or electronic funds transfer, whatever way that the money can be deposited with in the account for free.'

The event was held as Sibane Hotel in Ezulwini on Tuesday.

Motsa said the account arrangement was quite different because, those who have transactional accounts were charged when depositing a cheque for the reason that the bank has to then process the transaction.

"Of course now the market is lucky, because for cash irrespective of the amount, you deposit for free. There is no service fee or cost of having the account or when transacting. Also there is no maintenance fee for this account," she said.

She said customers were allowed two free withdrawals per month, "which means in a year you may do 24 transactions or withdrawals without paying a cent as we only start charging you from a third and subsequent withdrawal."

Motsa said that was done to encourage the culture of saving.

"The other charge you may incur is when you give us an instruction like to issue a cheque or maybe an instruction to pay another bank from the account," she said.

With regards to interests, Motsa said it depended on the invested amount.

The amount of interest earned depends on the balance you maintain in the account, so in other words it's teared from anything from 1.4 per cent up to 3.75 per cent," she explained.

"Somebody can say somewhere else I can earn 10 per cent. Fact is we do have those accounts that will give even a better return. But, we have actually made this to be free, if we were to give you 10 per cent what we will then be getting? Through this product, we are trying to be in business with your support," she further stated.

Access

The account also offers holders immediate access. Motsa said this was because they were cognisant of the fact that clients don't want to be inconvenienced when they need their money back, "you just give us the instruction and we do as you wish." The minimum balance for the account is E1 000 and customers are not restricted on the number of deposits they can make.

"We do not dictate how clients should use the funds, after all it is their money and we say it is a saving mechanism for building up cash.

"We have observed that some other small businesses, when they do their startups, they put together money they build up until they can open a transactional or current account and then when they want to start their project, they use those funds taking advantage of the no fees and minimum fees," she said.

On another note, she said they had

observed that some clients have been saving for holidays.

"They start from the beginning of the year and decide how much each member could contribute. This has eliminated the need of treasurers who before had the burden to collect contributions from members.

"Some people have already taken out the funds as they were saving from the beginning of the year. Some are yet to be distributing because they have been saving for school fee requirements. There is also a concept of stokvels as well as other various uses for the product, we cannot exhaust the list," said Motsa

She encouraged account holders to avoid closing and reopening the account due to the complications accrued to such. Instead, she encouraged customers to leave the minimum balance after distribution, "as long as you leave your minimum balance you are covered, there is no further documentation we will require from you as

Adding, she said the minimum was only required at the initial stages, but she stressed there was a need to ensure that the account was active, which therefore, calls for it to be credited now and again.

She said the essence of coming up with the product was to respond to customer

MEANWHILE, Nedbank Head of Sales and Distribution Kevin Reid says the Club Savings Account is means of saving culture that all people have to subscribe to.

SEL SHARE PRICE SOARS 16 %

SWAZILAND Empowerment Limited (SEL) share price has soared on the Swaziland Stock Exchange (SSX) possibly on the back of news of a possible acquisition of more MTN Swaziland shares from current owners Swaziland Post and **Telecommunications Corporations**

Swaziland Empowerment Limited (SPTC). (SEL) share price increased by 16 per cent in the third quarter of 2016 during the time it was announced SPTC would be selling its stake in MTN

Swaziland. This increase in the share price was in spite of SEL recording a signifiyear ended March 31, 2016.

According to SEL's financial statements for the year ended March 31, the investment company's profits decreased to E64.1 million.

However, the reduction in profit does not tell the whole story as according to the audited results of SEL for the year ended March 31, total comprehensive income for the year under review was up 12 per cent to E82 million from E73.6 million.

The boost in the company's total comprehensive income was a result of a 704.7 per cent; eight fold increase in other comprehensive income when compared to the previous year.

"The company recorded E18.5 million in other comprehensive income

cant drop in profits for the financial for the year ended March 31, 2016, whilst other comprehensive income for the year ended March 31, 2015 was E2.3 million," reads the statement in part. At the time the financial results were issued, the share price was trading at 2 500 cents per share.

Currently the share price of SEL is at 3 050 cents per share.

Results

After the financial results were announced, SEL Board Chairperson Cleopas Dlamini at the company's Annual General Meeting (AGM) said the board had explored the different options available to the company should the shareholders decide to purchase the MTN shares.

Dlamini said the situation right now was that SPTC owned 41 per cent of

MTN Swaziland and were looking to sell given the unbundling of the com-

"SPTC has a legal obligation to offer 30 per cent of its shares to existing shareholders, pro rata. Whilst with he remaining 11 per cent SP free to find its own buyer.

"However, that is not to say as existing shareholders of MTN Swaziland we cannot lodge a complaint if we feel the person or company buying the 11 per cent is an entity we cannot work with," he said.

"The principal activity of the SEL during the year under review remained that of an investment holding com-

"The investments comprise a 19 per cent stake in Swazi MTN Limited. Swaziland Government Bond's SG016 and SG017, a bond in the Swaziland Development Finance Corporation (FINCORP) and a loan to FINCORP." the chairman said.

The chairman further revealed the company would be expecting at least E41 million in the next two months from its investments.

In light of all this information, the share price of the investment holding company has increased drastically in the last couple of months.

Yesterday a financial analyst from a leading investment management firms said share prices were mostly driven by the factors of demand and supply, amongst other things.

"If there is a growing demand for a certain share, then the price of the share is likely to raise," he said.

It follows that the prospects of SEL acquiring MTN shares has created some demand for the share thus initiating a rise in its price.

CHRISTIAN BANK REPACKAGE, IMPROVE PAYMENT TERMS

The bank would be known as SWSI (Sichwaga Wealth Solutions Investment)

FOLLOWING the positive response from brethren and Swazis interested in the formation of the Christian bank by Swaziland Conference of Churches (SCC), the organisation has decided to repackage and improve its payment terms.

SCC Chief Executive Officer Reverend Winston Shongwe said the positive feedback had compelled them to review the categories for one to purchase shares into the Christian bank as the interest out there was massive.

Their intention was to have an inclusive entity with flexible payment arrangements for citizens not to feel excluded.

The bank would be known as SWSI (Sichwaga Wealth Solutions Investment) and requires E160 million to be set up.

SCC has extended the deadline for recruitment or registering potential Founding Member Subscribers (FMS) from the end of this month.

The SCC's ambitious bid to establish a Christian bank, a first for the country, has the tagline 'SCC is making a turnaround, be part of it'.

Individuals and churches from across the three Christian bodies in the League of Swaziland Churches, Council of Swaziland Churches and SCC are welcome to join.

"This is a great project of the Christian community in this country," Rev. Shongwe

He listed the three categories of membership one can choose from as;

1. Founding Member Subscriber (FMS) - The joining fee for this category is E1 600, minimum investment being E15 000, thus giving the total of E16 600. The rate of return on this investment (ROI) per annum is 15 per cent with maximum number of members being 400. SCC said terms of payment were now up to 36 months. The waiting period is 60 months.

One can enjoy benefits for this membership for up to 25 years.

2. General Member Subscriber (GMS) – Here the joining fee is E1 100, minimum investment is E2 500, meaning the total to be forked out from any interested individual is E3 600.

The ROI here is 10.5 per cent per annum. Under this category, there is no maximum number of members or limit set, meaning as many interested citizens as desirable could join according to the (SCC) CEO. The terms of payment are also up to 36 months with the waiting period at 60 months. One can enjoy benefits of this membership for up to 10 years.

3. Kulula Member Subscriber (KMS)

- The joining fee is E350 for this category with the minimum investment being E250 whilst the maximum is E2 500. This means the total asked of one interested in joining here is E2 850. The ROI is 9.5 per cent per annum. The terms of payment are up to 18

Again, here there is no limit on the number of members who can join whilst the waiting period is 18 months. One can enjoy benefits of this membership for up to 10 years.

Behavioural change key to mitigate climate change effects

By Manqoba Makhubu

THE effects of climate change are here to stay and the only option humanity has is to adapt and mitigate.

To do this, the country needs to put in place policies to facilitate integrated water resources management that will assist in mitigating the impacts of the increasing global climate change.

The Ministry of Natural Resources and Energy, through the Department of Water Affairs has initiated a process to review the National Water Strategy and Action Plan 2003 and establish the National Water Policy and Strategy.

The initiative is supported by the United Nations Development Programme (UNDP).

The Policy will facilitate effective management of water resources for both urban and rural areas and different stakeholders are being engaged to make an input towards the development of the policy.

An inception meeting was held between various stakeholders such as government department, University of Swaziland (UNISWA), Royal Swaziland Sugar Corporation (RSSC) and others this week where the findings of the consultant's desk review were presented.

UNDP Deputy Resident Representative Lars Tushuizen noted behavioral change was critical to mitigate the effects of climate change.

He stated there was need for public education on the efficient use of water, as household users were one of the key stakeholders that cannot be overlooked.

"Climate change is real. We have all seen the different faces of how it manifests itself: we have experienced water rationing, 66 per cent of agricultural production dropped and many cat-

"This shows that climate change is real to everyone which is why

we had to consider developing the policy because climate change is here to stay.

"We need to adapt and mitigate and the policy is critical in getting our house in order," he

He said this adds to other important pillars such as governance, specific interventions and financial sustainability which are key to water resource management.

Ministry of Natural Resources and Energy Under Secretary, Dumisani Mngomezulu said the Water Act formed a basis for the establishment of the policy, which was important for the country.

Trevor Shongwe from the Department of Water Affairs said the issue of water cuts across a number of players which are coordinated at the ministry and neighbouring countries as water is a transboundary commodity.

Development

The water sector as expressed in the National Development Strategy (NDS) is about the development and implementation of strategies for poverty alleviation and drought mitigation, with the main objective of improving water availability for both socioeconomic and economic productivity.

Therefore, water is construed as an engine for development which ensures sustainable economic prosperity and is consequently expected to play a catalytic role in poverty endication in the country through various interventions.

The enactment of the National Water Policy and Strategy will guide government on how to develop and manage the diminishing and erratic water resource for sustainable and socio-eco nomic advancement of the people's livelihoods in this county Moreover, the policy will provide clear demarcation of the responsibilities of the various stakeholders and institutions involved in the integrated deter opment and management of was resources in the country.

Biomass: the energy answer for Swaziland

Johannesburg - Swaziland could become the first African country to become totally powered by renewable energy, writes Alexander Matthews.

It's early days, but the prospect of Swaziland becoming the first African country to become totally powered by renewable energy is looking increasingly bright.

Ushering in this green revolution is a 35MW biomass power plant to be developed by the kingdom's largest timber company, Montigny Investments, by

"Using the offcuts from our sawmilling and forestry harvesting processes to produce power allows Montigny to increase the value we extract out of each tree sustainably, which is our ultimate goal," Kelly Cure, the company's Head of Strategic Initiatives, says.

"We view the forests as an interconnected ecosystem full of opportunities, which is why we are involved in many markets outside of traditional forestry and sawmilling — including essential oils, resin tapping and honey harvest-

The plant will be built at Bhunya mill, located within Montigny's 76 000ha Usutu Forest Estate in western Swazilarid. The location is ideal: harvest areas where forest biomass can be gathered - are, on average, only 23km away, while sawmill waste is generated onsite. Initial projections are that the project will create several hundred jobs, with an estimated R275m flowing into the Swazi economy annually - through increased employment, investment and

Gambia's ruling party wants fresh election

DAKAR - Gambia's ruling party pressed for a fresh presidential election Tuesday as West African regional mediators intervened to try to resolve a mounting political crisis in the tiny country that voted its leader of 22 years from power less than two weeks ago.

A petition signed by the secretary general of President Yahya Jammeh's party on Tuesday demanded a new vote with a revalidated voter registry.


The document, which was also signed by a notary public and seen by The Associated Press, says the election was not conducted fairly or in good faith and therefore should be invalidated.

Jammeh initially acknowledged defeat, even calling the Dec. 1 election fair and conceding to President-elect Adama Barrow in a telephone call broadcast on state television. But he announced last week that he was rejecting the election results.

Among the irregularities cited in the petition brought against the Independent Electoral Commission and Gambia's attorney general were the different results reported the day after the election and again on December 5. It also questioned why some 360 000 registered voters did not make it to the polls.

The commission said the vote was transparent, fair and accurate. The results it gave on December 5 were updated totals, but the commission said the new counts did not change the outcome and that Barrow was still the winner.

MDC-T in election reforms climbdown

HARARE – The Movement for Democratic Change (MDC-T) led by former prime minister Morgan Tsvangirai has abandoned its "no reforms no elections agenda", declaring on Tuesday it would form a coalition with like minded parties and contest the 2018 elections.

Until now, the MDC-T had insisted it would not participate in any elections until the electoral playing field was made even. The largest opposition party has boycotted a number of by-elections – a move that saw President Robert Mugabe's Zanu PF regain a number of urban seats. Electoral reforms expected to be implemented by the Zimbabwe Electoral Commission (ZEC) together with the government have been moving at snail pace. This has raised doubts that the electoral playing field would be level by the time of the elections, which are due in the first quarter of 2018. Africa News Agency

EU SANCTIONS ARE 'ILLEGAL' - DRC

KINSHASA - DR Congo on Monday slammed as illegal a European Union decision to impose sanctions on seven of its top security officials for their role in deadly clashes with proteste

"[These sanctions] are illegal because they are a sort of imperial law that is at odds with international law. The DRC, a non-European country, condemns them and intends to take action against them," said government spokesperson Lambert Mende.

More than 50 people died in the September protests against the rule of President Joseph Kabila and European Union foreign ministers had warned in October they would act if Kabila showed no sign of leaving office when his term ends on December 19.

Ministers decided "to impose restrictive measures against the seven individuals who hold positions of authority in the chain of command over the Congolese security forces which have exercised a disproportionate use of force," a statement said.

The steps include travel bans and asset freezes.

The seven include two Kabila allies - Army Commander Major General Gabriel Amisi Kumba and former inspector of police General John Numbi - who have previously been sanctioned by the United States.


NGALA – Seen from above in a helicopter, the straight white walls of Ngala camp in north-east Nigeria carve a misshapen star out of the dry brown scrub.

There are 55 000 people living in tents and straw huts inside the geometric garrison, protected from Boko Haram jihadists by the military.

Though the city of Ngala is less than a kilometre away, these people can't go back to a normal life.

"Boko Haram is still here, the only thing we can do is wait for food," said Aishi, a 50-year-old woman with deep lines in her tired face.

Over the past year, Nigerian President Muhammadu Buhari's government has made repeated announcements that Boko Haram is close to being defeated and that thousands of people are returning home. "They are done for," said Buhari early this month. "The security situation in Nigeria had improved significantly." But many reclaimed

towns, like Ngala, are charred, looted ruins still vulnerable to Boko Haram attacks.

Nigeria discloses \$7.2bn of unrecorded debts

LAGOS - Nigeria's government has found unrecorded debts of 2.2 trillion naira (\$7.22 billion) left over from the previous administration, which turned up after an audit aimed at improving transparency, it said in a tweet. "2.2 trillion unrecorded debt owed contractors/private sector found on federal government books, inherited from previous administration," said the message posted on Twitter. The debts were owed to contractors, oil marketers, exporters and electricity distribution companies, Finance Minister Kemi Adeosun said on Sunday in a statement. Reuters





Germany deports rejected asylum seekers

BERLIN - Germany yesterday carried out its first group deportation of Afghans whose asylum applications were rejected, in line with an agreement with Kabul, the news magazine Der Spiegel said on Tuesday, citing government sources. More than a million migrants from the Middle East, Africa and elsewhere have arrived in Germany this year and last, prompting concerns about security and integration and boosting support for antiimmigrant groups such as the Alternative for Germany (AfD) party. In 2016, Afghans are the second biggest group of asylum seekers in Germany after Syrians, according to data from the Federal Office for Migration and Refugees (BAMF). Reuters

As Aleppo falls, Trump faces the test

WASHINGTON - Aleppo's fall to Syrian government forces is shaping up as the first major test of President-elect Donald Trump's desire to cooperate with Russia, whose military support has proven pivotal in Syria's civil war.

The death and destruction in the city is only renewing Democratic and Republican concern with Trump's possible new path. Though Trump has been vague about his plans to address this next phase in the nearly six-year-old conflict, he's suggested closer alignment between US and Russian goals could be in order. AP

US Osprey flights in Japan halted

TOKYO - The US Marines yesterday suspended their controversial Osprey flights in Japan as anger mounts over an accident that saw the aircraft apparently crash



land off the southern island of Okinawa. Five crew members aboard the MV-22 Osprey were injured late Tuesday when the tilt-rotor aircraft suffered a "mishap" and landed in shallow water, the Pentagon said. But that characterisation was belied by footage aired on Japanese public broadcaster NHK, which showed the main wings of the Osprey broken in half and the cockpit separated from half-submerged fuselage drifting ashore. *AFP*

Iraqi gains reveal Islamic State arms industry

QARAQOSH - Factories churning out tens of thousands of munitions and an entire street turned into a conveyor belt for car bombs: advances by Iraqi forces around Mosul have laid bare the scale of the Islamic State group's arms industry. In the more than two years since it seized control over swathes of the country, IS established a sprawling and highly organised system that experts say no other insurgent group has matched. The capability has seriously boosted the threat from the group as it battles ferociously to eling to territory in Iraq and Syria - and the fresh intelligence could now prove vital in countering its plots to carry out attacks on the West. Iraqi army deminer Hashim Ali picked his way carefully through the rubble as he explained how IS transformed Mart Shmony Street in Qaraqosh, some 16km south-east of Mosul, into a production line of death after seizing the town in 2014 and forcing the mainly Christian population to flee. eNCA

He added "we understand it will not be a simple task considering the extent of degradation of the Russian-American relationship. But we are prepared to do our bit."

Putin said, however, that a meeting between the two leaders was more likely after Trump's January inauguration.

Venezuela opposition pushes for president's trial


CARACAS - Venezuelan opposition lawmakers relaunched efforts to drive President Nicolas Maduro from power on Tuesday after negotiations to ease the country's political and economic crisis stalled.

Deputies in the National Assembly made a declaration ruling that the socialist president bore "political responsibility" for the crisis and urged state attorneys to investigate him with a view to prosecution.

The opposition MUD coalition has been divided over whether to pursue talks with Maduro's government.

Maduro has consistently blocked efforts by the legislature to challenge his power since the opposition took over the assembly in January.

He retains the support of the

military and key state institutions including the Supreme Court, which has frequently overruled the legislative assembly.

Maduro's allies in the assembly boycotted Tuesday's session, branding the motion a "coup d'etat."

Tuesday's move "is a blow from the legislature, but it does not mean the president will be deposed," Legal Expert Pedro Afonso Del Pino told AFP anticipating the lawmakers' declaration.

An economic crisis fuelled by falling prices for Venezuela's crucial oil exports has led to food shortages and riots over recent months.

The socialist president says the crisis is a US-backed conspiracy. The opposition blames his economic management.

"This is going to heat up the political process in Venezuela," said political scientist Carlos Romero of Tuesday's move.

"It is going to make the situation worse." *Reuters*

France votes to extend state of emergency

PARIS - France's Parliament voted early on Wednesday to extend a national state of emergency until July 15, after next year's e l e c t i o n s .

The security measures, in force since attacks in Paris that killed 130 people in November 2015, are now expected to be approved by the Senate on Thursday.

It is the fifth extension of the state of emergency, which gives police extended powers of search and arrest.

Passed

The overnight vote in the National Assembly passed by 288 to 32, with only Left Front law-makers, protesting ecologists and a handful of centre-right Republicans voting against.

The extension, which will give the country its longest uninterrupted state of emergency since the Algerian War in the 1960s, will span the two-round presidential election in April-May and June parliamentary polls

The government has cited a heightened risk of jihadist attacks coinciding with the polls. Ahead of the vote new Interior Minister Bruno Le Roux stressed France faced "an extremely high" risk of a terrorist attack. Since the last extension - shortly after the Bastille Day attack in July when a Tunisian jihadist rammed a truck through a crowd in Nice, killing 86 people.

NEW YORK – Donald Trump on Tuesday defended his nomination of ExxonMobil Chief Rex Tillerson as America's next secretary of state, dismissing concerns about the oilman's ties to Russia and saying US foreign policy needed a new direction.

The nomination, which capped weeks of debate about the right candidate, was the most keenly awaited in Trump's Cabinet as the world waits to see how the incoming Republican president intends to alter US foreign policy.

Trump has stoked alarm among Democrats and fellow Republicans ahead of his January 20 inauguration by calling for closer ties with Moscow, in contrast to

received wisdom in Washington that Russia remains a global security threat.

That sentiment – coupled with the fact that Trump is at loggerheads with some Republican senators over a CIA assessment that Russian hackers helped him win the election – may complicate Tillerson's confirmation hear-

Trump, who announced the nomination early on Tuesday, hailed Tillerson as a "great diplomat" and "one of the greatest and most skilled global business leaders of our time" at a campaign-style rally on Tuesday night in the traditionally Democratic-leaning state of Wisconsin that helped elect him. eNCA

Schweinsteiger is yet to feature since but Mourinho said: "I do [expect him to stay]. Unless again, the player knocks on our door with a future that he wants to grab with both hands.

"We have Premier League, Europa League, then in the League Cup we have a two-legged semi and hopefully one more match in the final.

"The FA Cup is a lot of matches, so our number of players is not so big, even Schweinsteiger is back to the group which was exactly the intention because he is one more option for us."

Oscar set for £60m move to China

LONDON - Brazilian international midfielder Oscar is to become the latest big name to move to China in a £60 million transfer (\$76m, 71.5m euros) from Chelsea to Shanghai SIPG, British media reported yesterday.

The 25-year-old - who would be the second Brazilian star from the Premier League leaders to leave for China in a year - had been a target of Shanghai Manager Andre Villas-Boas since the Portuguese managed Spurs in the 2012/13 season. However, Oscar opted to join Chelsea who had fired Villas-Boas during the 2011/2012 campaign - instead.

This time Villas-Boas has succeeded in persuading Oscar to join up with him, seeing off competition from rivals Jiangsu Suning, who bid for him in the close season, and Guangzhou Evergrande, managed by former Brazil handler Luiz Felipe Scolari. 



Swaziland rejects Ronaldo in Ballon d'Or voting

SOCCER - REAL Madrid forward Christiano Ronaldo walked away with the top prize for the fourth time in a glittering career, but not everyone thought he was the world's best in 2016, including local voters.

Some of those who didn't vote for the Portuguese international include former Sihlangu head coach Harries 'Madze' Bulunga.

The former Sihlangu coach is amongst three other people, who are eligible to vote for this very important football award including Sihlangu Captain Tony 'TT' Tsabedze

and former Swazi Observer Sports Editor now News Editor Kenneth Dlamini. Information gathered from Goal.com is that the country was amongst 11 nations that opted to Ieave Real Madrid's main man off their shortlist: Uruguay, Turkmenistan, Swaziland, Namibia, Romania, Libya, Iran, Central African Republic, Bolivia, Cape Verde and Andorra.

Ronaldo will now be hoping to convince them of his worth over the next 12 months, although there are further individual prizes on the horizon.

He has already claimed the Ballon d'Or and top spot in the Goal 50, and is expected to add FIFA's Best Player award to his ever-growing

collection in the New Year.

In total, the 31-year-old has netted 48 goals in just 52 appearances in the calendar year to date.

That return was enough to impress many of the Ballon d'Or voters, with Ronaldo receiving more than twice as many points as runner-up Lionel Messi.

The Barcelona talisman collected 316, while his rival polled 745, journalists from across the globe -173 in total - were asked to cast their vote for a deserving winner, and they overwhelmingly favoured Ronaldo.

They awarded five points to their first pick, three to second and one to the man positioned in third.
