Hours before the first trumpet sounded, the royal residence was already abuzz with regiments who came in droves to participate in the national cultural ceremony. e first trumpet that is sounded on the main day usually notifies the regiments to get ready, and is blown moments before the trumpet that signifies the start of the event inside the cattle byre. The first trumpet was blown at 2pm while the second one sounded at 2.30pm.

By then, regiments were fully clad in their traditional gear ready to join Their Majesties and members of the royal residence in dancing the Incwala, an important cultural ceremony for Swazis. Incwala is known to be a

### 'King's drought prophecy fulfilled'

Then throngs of regiments gathered at the Ludzidzini Royal Residence in January this year, His Majesty King Mswati III pronounced an end to the drought situation that ravaged the country resulting in the death of livestock and destruction of crops.

Ingatja has noted that His Majesty's prophecy last year was fulfilled as the situation went on to improve from then, and also noted that the situation was returning to normal this ploughing season. It was at the end of last year's Incwala where His Majesty said the drought situation changed as soon as the water party (bemanti) was commissioned to fetch water in the Indian Ocean in Mozambique towards the end of the year last year.

"When the water party was commissioned (kuphuma kwesigubhu), the heavens responded and we saw rain coming down and things changed.

From there onwards, we saw a difference as rain began to fall and the valleys became green. We have our irrigation system coming straight from God.

We do not need drip irrigation because God has always shown. He has powers to bring us rain. We use drip irrigation just for the sake of it, otherwise God is the one who provides us with irrigation water," the King was quoted saying.

Ingatja at this year's ceremony said this prophecy had been fulfilled to the fullest as they had since last year. "Incwala is known to be a mass gathering for Swazi citizens where we pray for the nation and anything that may be affecting.

Last year when we gathered we were highly affected by drought and the King proclaimed an end to the drought.

I would say Swazis prayer helped a lot," said a seasoned member of the

regiment identified as Phalamende. Umbutfo Phalamende was given the name when he underwent the initiation process during the construction of the parliament.

Other members who were asked on their views over this year's ceremony also shared the same sentiments. Umbutfo Tsandzemajaha from Kudzeni also said they took pride in participating in the ceremony which gathers Swazis for national prayer. ### Joy wants to retire

aving spent nearly three years as the Director of the Swaziland National Library Services (SNLS), Joy Maziya has tendered a request for early retirement.

The former Prime Minister Sibusiso Dlamini's wife, recently tendered her request to retire from the post she was appointed into a few months after her relationship with the premier was revealed.

Confirming these latest devel-Ministry opments, Information, Communications and Technology Principal Secretary Sikelala Dlamini said the request was being considered by relevant ministries. He further referred questions to his counterpart at the Ministry of Public Service PS Evart Madlopha stating how he was not aware of the current stage of the request.

When called, Madlopha confirmed that his ministry was in receipt of the former premier's wife's request for early retire-

He revealed that there were several processes which have to be completed before the request gets approved. "There are documents still being put together before the request can be approved," he said.

Employees at the Mbabane Library stated how they were also aware of their director's wish to retire as they were privy to the letter that is in the two above stated ministries' posses-

The request to retire early comes fast on the heels of her divorce from the premier which was finalised at the beginning of November. The PM initiatited divorce proceedings from Maziya less than two years after their wedding which took place in 2014. The two met while she worked at the Swaziland National Archives from whence their romance sparked.

The prolonged divorce proceedings saw the premier alleging how Maziya had violent tendencies and he further made certain demands towards their estate and Maziya at first resisting through her lawyers before the order was issued by the Chief Justice Bheki Maphalala.

Reports of their divorce surfaced in April, months after Maziya was noted to be conspicuously missing from the premier's side at several local and international events whereas they attended most ceremonies together during the peak of their marriage.



# THIS YEAR'S INCWALA IS DIFFERENT - DPM

The Deputy Prime Minister, Paul Dlamini has said this year's Incwala ceremony was different from previous ones.

He said it was different in the sense that there had been increase in numbers as far as regiments are concerned as seen from the beginning of the little Incwala building up to the main day that was yesterday

Dlamini said this when interviewed yesterday at Ludzidzini Royal Residence before the commencement of the day's activities where throngs of people both from in and out of the country had come to witness the ceremony dubbed as the kingdom's sacred prayer.

The DPM said such large numbers were impressive because one would have assumed that since the country was still recovering from the drought that lasted for the better part of last year people would not be able to participate in the ceremony.

"But, since the His Majesty King Mswati III prophesized that the dry spell was coming to an end during the conclusion of last year's Incwala, we are very much happy that we have seen changes taking place for the good and the spell is as good as gone," he said.

He went on to point at the rain pattern which he said was almost normal as per the expectation in farming on dry land where the focus is based on the frequency of the rain rather than how much it rains

Dlamini also appreciated God for bringing about the changes to save the nation and said if the country continues to work

as one more benefits would be reaped as evident in this particular subject.

He said, "It is important that the country sticks together in the fight over drought and we encourage the spirit of resilience displayed by the nation during such a bad period for the country."

In the quest to overcome the situation, he encouraged the public to continue using water responsibly and further encouraged

the spirit of diversification in farming and not just focus on one thing.

When asked on the period he has been attending the ceremony, he responded by stating that it's been over five decades since he started participating in the ceremony he refers to as an important ritual for the country.

This is because it is during this ceremony that the country can be able to pray and fight all enemies as a unit hence the need for more Swazis to take part in the sacred prayer.

He added that in order for the country to go forward, there was need for unity because in that way it would be easy to fight each and every challenge that may come.

Worth noting is that a year ago, the King pronounced an end to the drought situation that had wreaked havoc on the country resulting in the death of livestock and destruction of crops.

He was speaking during the end of the Incwala ceremony at a time when the country was heavily affected by the dry spell

In his own words, he was reported to have said, "When the water party was commissioned (kuphuma kwesigubhu), the heavens responded and we saw rain coming down and things changed. From there onwards we saw a difference as rain began to fall and the valleys became green. We have our irrigation system coming straight from God. We do not need drip irrigation because God has always shown that he has powers to bring us rain. We use drip irrigation just for the sake of it, otherwise God is the one who provides us with irrigation water."

They went on to state that such tradi-

The boys said it was further motivating for them to take part in the ceremony with the King as they pray for the nation and since they are getting these values from elders they were also keen on spreading them to the next generation.


In addition, they encouraged more boys to take part in the ceremony if not all cultural activities which they said were of great significance and they could not afford missing them.

# Police announce reshuffles, promotions

he National Commissioner of Police Isaac Magagula has announced a reshuffle affecting senior police officers.

The two affected officers were based in regional offices and the latest move has seen one transferred and promoted while other s have only been transferred. Of note is that the second officer was promoted in the last major reshuffle which happened a few months ago.

According to insiders, the changes, which came as a surprise, were announced on Thursday, and the promoted senior officer is Wendy Hleta who once served as the police mouthpiece.

Transferred

Wendy Hleta has been elevated to be the Regional Commissioner (Assistant Commissioner) and she was transferred to the Shiselweni region. Impeccable sources revealed that an internal message was communicated about the transfer of the officers as it was sent to all regional police headquarters as well as police stations in the country.

She was previously the Deputy Regional Commissioner in the

Lubombo region. In the Shiselweni region, Hleta is replacing newly promoted Regional Commissioner Musa Magic Zwane who is hardly two months in the region and was posted after his elevation announced few months back.

'Magic' as Zwane is popularly known will replace Joseph Ndlovu who is now based at the police headquarters in Mbabane.

Meanwhile, those who were taken aback by the sudden transfer of Zwane included the busi-

ness community had thought they were already getting used to him and the approach which they noticed from him that he was the kind of a person who was cooperative and seemingly already having good plans to work hand in hand with them.

Shiselweni Regional Administrator Themba Masuku was saddened to learn about the transfer of Zwane saying he had built a good working rapport with him and had fast adapted to the number of initiatives the region has. ### NOTICE ON THE INTERIM INCREASE OF MEALIE-MEAL IMPORTATION VOLUMES FOR HOUSEHOLD USE

- Pursuant to the passing of motion 13/2016 by Parliament, as well as Press Release by Ministry of Agriculture of 14th September 2016 on mealie meal importation, the Ministry announces the review of the limit of mealie meal to be imported by each household for consumption from 50kg to 100kg per month.
- This is a temporary relief to the drought stricken areas whilst continuing to explore better ways to address the situation. It came into effect from 05th December 2016 and will remain until 28th February 2017, where it will be reviewed again.
- Stakeholders shall continue to assess the situation within affected communities over this period to the end of February 2017, after which a decision will be communicated for the benefit of the public.
- 4. The Ministry remains sensitive to the drought situation and the effects it has on local communities hence it re-emphasizes its commitment to working with all stakeholders towards alleviating the plight of affected communities.
- 5. Meanwhile His Majesty's Government takes this opportunity to thank all millers who have continued supporting the communities with mealie meal at competitive prices during this period. We have further been informed that millers have committed themselves to continuously deliver mealie meal to all drought stricken areas at competitive prices during this period.
- We hope this interim measure will bring the desired relief to the affected communities around the country until the situation normalizes.

# EX-ACTING DIRECTOR ACCUSED OF TAKING CLIENT'S E16 000

he questionable dismissal of employees at Hospice at Home has opened a can of worms for the former acting Director, Mefika Zwane.

This has seen people coming out with various allegations of misconduct and misappropriation against him; but these have not been proven or substantiated.

The former director, although having held the fort on interim basis, was alleged to have taken a client's money amounting to E16 000 two years ago under the pretext he would be investing it in a business venture he had persuaded the client to get into with him. However, this was before he was given the responsibilities to be the acting director after Thuli Msane.

These allegations have been made by sources who spoke to this newspaper following the publication of reports that three employees had been fired from the organisation over the past months under questionable circumstances.

The sources wondered why these employees were being fired for unclear reasons when there was one employee who still had his job yet he had allegedly robbed a client, much against the institution's code of conduct.

When asked how the two met, it was said they met at the hospital in

2014 when the woman, whose name is known to this newspaper, was looking after her daughter and mother who had been admitted at the facility.

It is alleged the woman had just got back from school overseas and whilst looking after her mother and daughter, she told Zwane she had money she wanted to invest in order to build herself a home as she had reached maturity.

"Upon hearing that she had money, Zwane persuaded her to buy into a joint venture retailer business that would serve as an investment for her so she could be able to make more money to build her home," alleged the sources.

These allegations were further confirmed by the woman during a telephonic conversation where she explained that the then nurse pounced on her at a time when she was vulnerable and looking to make money quickly. She alleged that upon hearing his proposal, it sounded like it was legit hence she bought into it and put in money towards it. It was expected that the venture would be for supplying local motor spare shops with parts they would purchase from some supplier in South Africa.

"As we were in the process of finalising the deal, he took me to some shop where he showed me the parts

esponding to the allegations of allegedly taking a client's money amounting to E16 000 under false pretences, Zwane said their agreement had nothing to do with Hospice at Home.

"I am currently repaying back the money and can show you receipts to prove that but the agreement we made with the client has nothing to do with the organisation," he said, in a telephonic interview this past week.

that he said we would supply locally and they would make us quick money," alleged the woman.

The investment by the woman was allegedly made in instalments and these amounted to E16 000 which never brought back any returns despite Zwane allegedly making promises to that effect.

Amongst the many reasons he allegedly forwarded when it was time to bring forward the gains, he blamed the customers for not paying them on time.


He is alleged to have also brought receipts in efforts to justify the nonpayments which the woman claims were questionable.

Seeing as she was unable to get her money back, the aggrieved woman then roped in the services of a lawyer who was tasked with the responsibility to request Zwane to pay back the money.

It is alleged, "He did not cause any troubles when approached by the lawyers as he admitted he had done wrong and revealed he had used the money to settle certain debts that were troubling him."

Thereafter, an arrangement was made to pay back the money in instalments of E1 500 monthly and he has been doing so for the past few months. But he is alleged to have last paid around August and has not been forthcoming since then. "The debtor shall pay the total sum of E16 000 together with costs at six per cent in the following manner; the debtor shall pay instalments of E1 500 on or before the end of each month until the whole amount has been settled," reads part of the agreement in possession of this newspaper made by the two par-

When asked how much was left from the debt now, the woman alleged she is still owed around E12 000, which is yet to be paid back by the former acting director.



'Client should report matter to the police'

he Swaziland Democratic Nurses Union (SWADNU) Secretary General Sibusiso Lushaba, advised the complainant to do the right thing and report the matter to the police, if it did happen.

This was after he had been asked on the code of conduct of nurses in as far as addressing such cases was concerned which he labelled a criminal act that deserved to be reported.

"If such a transaction had been made between the nurse and patient, it would have been professional malpractice and a criminal act by the nurse but if it was between the nurse and a relative of the patient then it's only a criminal act that needs to be reported," said Lushaba,

The secretary general said the law was supposed to take its course and get into the details of the matter to find the alleged robber guilty or not guilty.

He was responding to allegations that have been made against Zwane, who is alleged to have swindled a patient's relative an amount of E16 000 under the pretext they were going into a business venture that never happened.

It is worth noting though that Zwane allegedly admitted his wrongdoings after the complainant sought the services of a lawyer and an arrangement to pay back the money was made.

### E73M MALKERNS CANAL NOW COMPLETE


he rehabilitation of the 45km Malkerns canal infrastructure has been completed after 18 months since the commencement of the project.

Worth 73million of Emalangeni, the project was funded by the European Union (EU) two years ago and was aimed at refurbishing the water canal that benefits mostly sugar farmers around Malkerns.

At the time of signing the agreement between the EU and the government, it was said the project would focus on replacing weakened flumes and gates, alterations to the canal intake and construction of metered farm off takes. Addressing the gathering during the signing, the Principal Secretary in the Ministry of Economic Planning and Development Bertram Stewart, reportedly said the signing ceremony marked the culmination of an extended process of preparation from 2008 when a detailed structural survey of the Malkerns main canal was undertaken. When some of the workers found working on the project at Mhlabubovu were interviewed, they said they were working on finalising the project that started two years ago.

"Tomorrow is our last day working and right now we are busy with the touch-ups before leaving the site as the project is complete," said the workers, when speaking on Wednesday in the past week.

Nonetheless, when a survey was done

on the canal, it was noted that there was a serious risk of collapse of the system which would have resulted in the loss of irrigated water and pose a serious threat to the livelihood of the Malkerns populace too.

The canal, also known as Mdlwayiza, has served its beneficiaries for over 60 years and the rehabilitation was meant to maintain and improve it to ensure it continues working properly.

With the refurbishment, this would make sure the canal continues to deliver and increase the capacity of the water for agricultural, domestic, industrial and commercial use. It was noted that the ongoing National Adaptation Strategy (NAS) for sugar in which the EU contributed over E1.8 billion (€120 million) would support the development of smallholder cane growers.

It was also anticipated that the project would also improve transport infrastructure and strengthening the provision of social services in the sugar belt and the technical assistance.

This was because the government, through the PS, said NAS resources were used for the development of the Malkerns project and would continue to be used for the supervision of the rehabilitation work on the canal.

On the other hand, the EU said it was committed to the promotion of agriculture, adding the improvement of water availability helps in sustaining food security and the development of economic growth.

He said the programmes the EU would engage in the future would be for the development of agricultural infrastructure in the country.

### EAST 3 ROUTE MOU BEING REVIEWED

s initial principals who launched the East 3 Route have since vacated office, uncertainty clouds the initiative which has been held for the past five years.

The initiative was conceptualised in 2011 when Swaziland, Mozambique and South Africa's Kwazulu Natal Province came together to establish a route which was meant to be a crossborder development that would ensure economic growth and job creation. The East3Route is an initiative which seeks to promote tourism as a collective at regional level.

When East 3 Route was launched in 2011, the country principals who were in office were former Minister of Tourism and Environmental Affairs Macford Sibandze who was later fired,

former Mozambique Minister of Tourism Fernando Sumbana, and former Kwazulu Natal Province MEC of the Economic Development and Tourism Michael Mabuyakhulu. The latter was also sacked from this position and later reportedly handed in his resignation from the South African parliament. Minister Sibandze on the other hand was succeeded by Minister Jabulani Mabuza who was also actively involved in the initiative, although he has since been moved to the Ministry of Commerce, Industry and Trade.

The Route was conceptualised taking into account the needs of each region and the opportunities for product development that would impact positively on, as well as leave a lasting legacy for the communities through which the expedition passed. Since its inception in 2011, delegates from the

three countries have been taking part in the initiative yearly without fail. The delegation however last travelled to the route last year and it has not taken place in 2016, as the year comes to an end.

Information gathered by this publication is that while most things were on track for this year's route, there were delays on the South African side following the evacuation of Mabuyakhulu in office. Well placed sources in the province revealed that it was expected that his successor Sihle Zikalala would sign off on this year's initiative to allow it to take place. The initiative is usually held in October, with delegates travelling through the three countries

When reached for comment, Swaziland Tourism Authority (STA) Chief Executive Officer Eric Maseko said they had been in communication with their South African counterparts early this year and they were informed that they were waiting for direction from the new MEC.

"That was the last communication we had where they were still waiting for directive," he said. However, this publication also learnt that during this period while they waited for the go ahead, there were arrangements that were being made for a meeting with the country principals to meet for a review of the Memorandum of Understanding (MoU) that was signed between the three countries.

East 3 Route managed to increase widespread coverage by local and international media in the three countries as South Africa's major media print, radio and television networks as well as international networks such as

French TV have participated in the expedition and provided coverage. This promoted tourism for South Africa (KZN), Swaziland, and Mozambique while there were also talks of Mpumalanga province joining the initiative. Participants took pride in knowing that Tourism and community projects along the route received significant exposure and preliminary stakeholder engagements with partners in the three countries and with product developers and owners along the route suggest that this will continue to grow. Meanwhile, the new Minister of the initiative Tourism and Environmental Affairs Christopher Gamedze said he was yet to follow up on the matter seeing as he is still settling in office. He was also out of the country last week. It is understood however that before Minister Mabuza left office he had also engaged the new KZN MEC on the initiative although discussions were never finalised.

### HIGH LIGHTNING INCIDENCES INCREASE DEMAND FOR FRIZZLE

ith the country experiencing increased lightning strikes which claim lives, a lowly chicken has found itself in high demand.

"When there is such a chicken in a homestead, lightning does not strike that home," Sebentile Mohale, a vendor who was found at her makeshift stall in Mbadlane, said.

She explained how a lot of people stopped at their stall whenever they saw the chicken and bought it outright without negotiating the price.

At E200 for a bird weighing less than two kilograms, she said the odd looking bird's demand increased with the weekly reports of deaths caused by lightning. "A home which has the frizzle is never affected by lightning. Lightning curves the homestead," she said. This belief seemed to be shared by several members of the community who revealed how the chicken with ruffled feathers was revered in most rural areas as people believed in its supernatural powers.

Expanding, Mohale revealed how the frizzle was said to also have special powers which assisted in absorbing demonic spirits.

"When there are evil spirits abound, the chicken is endowed with certain powers which are able to absorb those ...the chicken with odd feathers is revered and believed to be a lightning conductor

spirits and nothing happens to the family to which the curse was intended," she said. Several children, when asked about the frizzle, revealed how their families also bought the bird and celebrated its existence in the coop whenever one was born. "The problem with the newly hatched chicks looking like the frizzle, is that the ruffles could be caused by a virus which can kill them. However, if the chick has ruffled feathers and is lively, we then celebrate its existence," Mohale said. She explained how with the frizzle being a hard to find breed, they had to go to several households between Hhelehhele and as far as Lonhlupheko in order to purchase it for resale.

Supporting claims on its use in healing and protection, President of the Swaziland Traditional Healers Association Nhlavana Maseko however disputed that the chicken, on its own, could avert lightning strikes.

"Yes, the chicken is used for muti purposes which are intended to heal and protect," he said during a telephonic interview yesterday.

He said the muti was bestowed in the odd looking bird by an inyanga hence its supernatural powers.

He however said lightning could only

be averted after certain rituals were done to a home as the frizzle didn't have any powers to deter this force of nature. The traditional healer said even the way it was eaten indicated its peculiarity as there were certain things to observe when cooking and serving it. "You know that it is not served as it? is eaten from the pot it is cooked in," he informed. On the other hand, Jericho Church Leader Bishop Bhekibandla Vilakati said he was not aware of the chicken's supposed supernatural powers.

"All I know is how it is supposed to be eaten. I am not aware of its powers. Does it have any," he asked.

He added how he was only aware that the chicken was not supposed to be cut nor served as people were supposed to eat it without invitation. Echoing surprise to the chickens supposed powers, Ministry of Agriculture Director of Veterinary Dr Xolani Dlamini laughed off questions about its powers saying, "It is just a chicken. If you give it to me, I will put it in a pot, cook and eat it," he said further assuring that it was healthy and that it's feathers were genetically inclined to stand out.





Speaking at her party, she narrated how the industry was white and male dominated, and how they had to work extra hard in order for them prove their worth.

"It has not always been easy in the industry but we survive. At some point in my career things were so difficult that I did not want to hear anything about aviation and I almost

gave up. I have managed to stay though because aviation is my passion and I am more determined more than ever to make it," she said.

She celebrated her new achievements in the party that also served as a thanksgiving ceremony. Her family also spoke highly of Bediako and applauded her for her determination and hard work. Her mother, who was a bit skeptical in a previous interview about her daughter's chosen career, said at the event that her daughter had made her so proud.

"We are proud parents; never in my wildest dreams did I think I would be a mother to a pilot. I am very proud of her because she has worked hard." She further thanked her son in-law, Daniel, who she said had been a pillar of strength for her daughter

### Deaf community lament universities for sidelining them

ompleting high school as a member of the deaf community simply means that your academic life has come to an end, you cannot go any further than that."

These were the words of Mzamo Mamba from Siteki during an interview with the Sunday Observer when found participating during the Brothers Reach Out (BRO) Club's annual camp held at St. Marks High School.

He was reacting to the career fair that had been organised as part of the camp where different professionals and tertiary institutions had come to share their knowledge about their different fields of expertise.

Mamba said at times they found themselves stuck at home after the completion of studies at high school because they were not accommodated in most institutions and that meant the end of their education have hearing impairments.

In fact, he said there are only four members of the deaf community that have completed high school in Swaziland and its only one of these that managed to go to tertiary and in South Africa for that matter.

Mzamo said as much as they were keeping tabs on His Majesty's vision of having reached first world status by the year 2022, but in as far as their matters were concerned they were left behind and were not accepted in the society in Swaziland.

He further revealed of his wish to have sign language recognised as an official language in the country as the population of people with such a disability was increasing, with Mvuzo Mamba, a sign language interpreter adding that the country has over 20 000 people who have hearing impairments.

Adding, Mvuzo said they were concerned members of the deaf community were left behind in a number of issues, one of which was not being accepted in the society, as well as not being accommodated in local universities.

"We would like to request the country's institutions to make a special provision for us because at present there is no equality in terms of getting the

same treatment at university level with the rest of the students," said Majaha Maseko who's also a member of the community.

He said the least they could ask for was the provision of interpreters at these institutions to enable them to gel easily because a number of them were dropping out from as early as Form three and can't even get decent jobs.

Mfundo Dlamini said they would be happy to be given a fair opportunity at these institutions and thanked His Majesty King Mswati and the government for all he was doing for them.

"Much thanks goes to Non-governmental organisations (NGO's) for seeing the need to include us in such activities at this camp and we would

like for others to do likewise as well," he added.

Meanwhile, in response to the cries by the deaf community, Limkokwing Public Relations Officer, Lucky Mathonsi said they had plans in place to accommodate the community.

He was responding to sign language interpreter, Mvuzo Mamba who said Limkokwing, as a relatively new institution of innovation in the country they expected it to come with change in as far as the issue of the deaf community is concerned.

"As the university of innovation and transformation, we always look to explore all areas to make sure that we cover everyone in the society and we have actually looked at this issue before so we are working towards accommodating the deaf community at Limkokwing," said Mathonsi.

He said since the university strived

to instil a creative mindset in students as evident in a group that invented the Braille menu which will be useful for the community.

Of course, he said this cannot happen overnight but there was progress looking at the Braille concept as he encouraged students to accommodate the deaf community both within and outside the institution.

Mathonsi concurred with Mamba and said the number of people living with this disability was growing by the day hence the need to consider them in all plans made by the university.

He also said that another positive was the infrastructure they had at Limkokwing which was friendly to people living with disabilities as they had special walkways for the physically impared in the corridors and that on its own was something towards the right direction.

### RICE BRINGS SMILES TO MAPHUNGWANE FOL

his rice will help me take my antiretroviral tablets in comfort."

Bettina Matsenjwa said she was excited about receiving the needed food as she didn't know what she would eat with her children.

She was found waiting in line at Maphungwane where Caritas Swaziland was distributing food coordinated by the National Disaster Management Agency (NDMA) this past week.

She, together with 713 other people, got the rice which was recently donated to government by the Embassy of the Republic of China on Taiwan. Matsenjwa said she lived openly with her HIV status and wanted donors to know how the food would assist her.

"I really value this donation as I do others since they help when we have to take medication. It is hard taking medication on a stomach which is not well lined," she said, adding how she can't hide her status as this might help

her to get assistance.

She said the food came at the right time as they had greens aplenty with the recent rains and this would mitigate their shortage of starch as they failed to harvest any maize. On the other hand, a grateful Rose Matsebula said it was her third time receiving food aid. "We never used to get any

food in the area in times past but the drought has reduced us to beggars," she said. Echoing words of gratitude, Mangena Myeni, who was in the presence of her grandson Njabulo Ndwandwe, said she was excited because she would get to eat rice, which is her favourite carbohydrate. "I don't always get to eat it due to being impoverished

so now I will be like my neighbours and be able to eat rice whenever I want," she said.

Revealing how they had eaten green peas 'borrowed' from a neighbour the previous day, Anna Ndzabandzaba stated how her seven grandchildren would benefit.

"Most of my children died, leaving me with orphans to take care of and the only way we live is by asking neighbours to give us food in exchange for a favour later. Yesterday we ate tijujile (peas) alone which we asked from a neighbour and today we will have something to enhance the food," she said. Ndzabandzaba said she was praying that the rains replenish her fields as she feared going on without a harvest. "For the better part of the year, I have had to wholly rely on God and If I fail to harvest anything, I will be doomed," she said. yd bar

According to the NDMA Goordinator Victor Dube, the donation was sans beans as the need was great and they couldn't wait for beans while people were hungry. "As you can see, there are no beans to go with the rice because we have a shortage of beans which we had hoped would go with the rice and cooking oil," he said. Responding to the concern about the lack of beans, the elderly women, who were receiving the food, said they were not disappointed as there was plenty of greens (umbhidvo). "Our concern has been maize which we received a few weeks back. The rice has been a welcome extra," they said.

Decrying the level of need in the community, caregiver Thabitha Matsenjwa said their job was difficult as the need was enormous.

"There are many grannies who stay with grandchildren and they find themselves having to feed the many mouths despite having no source of income. It is very difficult as there are also children who stay on their own after being orphaned," she said, adding how the donation alleviated the need the community faced.

Carrying her bag of cooking oil, Malingose Tsakasile Maziya said she was grateful for the rice she had received. "This is for my grandchildren," she said, as she leaned heavily on the mop handle she used as her walking stick. Through eyes lightened by cataracts, she said she couldn't remember her age but she would feed the children who were her responsibility.

### Good news as mealie-meal importation increased

Christmas, a holiday celebrated in most parts of the country, locals will be pleased to know that the limit of mealie-meal importation per household has been increased.

This has been communicated to the public through a press release that has been put up in the local newspapers by the National Agricultural Marketing Board (NAMBoard) to

Press Release by the ministry of agriculture on September, 14, 2016 on mealie-meal importation, the ministry announces the review of the limit of mealie-meal to be imported by each household from consumption from 50kg to 100kg per month," reads the statement.

Although this should come as good news for the nation, but it was clearly stated that this was a temporary relief to drought stricken areas whilst continuing to explore improved ways to address the situation.

The increase came to effect as of

December 5, and will remain until "Pursuant to the passing of motion February 28, 2017 where it will be s people gear towards 13/2016 by parliament, as well as the reviewed again. This is not the first time the government has reviewed the limit as previously it was increased from 20kg to 50kg.

At the time of the review, the minister of agriculture said this change was meant to apply for the next three months with effect from September to December 2016, wherein the next review would be considered to fully assist and support the affected communities. He added this was an interim measure that would only be applicable to individuals representing households and requires them to apply for a permit from NAMBoard. These permits were said to be obtainable from strategic border posts.

Nonetheless, the current information by NAMBoard is to the extent that the relevant stakeholders shall continue to assess the situation within affected communities over this period to the end of February after which a decision will be communicated for the benefit of the public.

Also, the ministry remains sensitive to the drought situation and its effects it has on local communities hence it re-emphasises its commitment to working with all stakeholders towards alleviating the plight of affected communities.

The assertion further extends to all millers who are appreciated for their continued support of the communities with mealie-meal at compet-

itive prices during this period and millers have been said to be committed to continuously deliver mealiemeal to all drought stricken areas at competitive prices.

Of note, this subject has previously been criticised by the public because the limit was said to be very low and the people's parliament that took place a couple of months ago was used as the platform to express the dissatisfaction.

Moreover, the ministry of agriculture's production outlook 2016 held that maize yields were estimated to drop to 33 460 metric tonnes for the cropping season, resulting in a deficit of about 96 540 metric tonnes and this reflects a supply squeeze going forward until at least the next harvesting season.

### HOW STAN MOTSA MADE THE MINISTRY OF ICT TICK

...He played an instrumental role in setting up the ministry's first ever communications department where he developed a number of important policies and further contributed to the set-up of SCCOM

ooking at Former Acting Chief Executive Officer and Communications Director, Stan Motsa's achievements in the country's communications sector, one could be forgiven for concluding that he made the ministry of Information, communications and technology (ICT) tick.

This is because be boasts over three decades of experience in this industry, having served in three different managerial positions where he made valuable contribution that went on to benefit the rest of the country.

Motsa has been central in the establishment of a number of policies and projects within the ministry in his span of at-least five years as the communications director before he was seconded to position of acting CEO of the country's first ever electronic communications regulator, Swaziland Communications Commission (SCCOM), which was set-up with him as the anchorman.

Previously, he had been with the Swaziland Broadcasting Information Services known as SBIS where he spent 28 years firstly as a cadet engineer, later on as Swaziland's first transmission engineer before taking after Tass Makama as the Director.

Although he has spent most of his professional life at the SBIS where he made an impact but he further played an important role in the ministry which came into life in 2008.

He told the Sunday Observer during an interview with him at his home in Mhlabubovu this past week that he is one person who has on many occasions found himself having to come up with something out of nothing.

This is because after leaving SBIS, he was promoted to the position of Director of Communications and worked at the ministry of commerce at the time until

the ministry of ICT was introduced.

Motsa said at this period they had nothing to work on and he had to develop a number of communication policies that would be used by the new ministry, as well as draft a plan on how they would go about working in the

"We were transferred together with the legal advisor to the newly formed ministry of ICT and had the responsibility to develop the department of communications whose responsibility has been advising the government on communications issues and policies," he stated.

The National Information and Communications Infrastructure policy implementation plan is another responsibility he carried through and eventually saw it adopted by the government in November 2012.

He was further responsible for the development of important communications policies such as the regulatory frameworks that brought about the establishment of the Swaziland Communications Commission together with the Swaziland Electronic Communications Commission Act.

Amongst his responsibilities at the

ministry was also advising both the minister and PS on communications policy, licensing and regulatory issues in regard to broadcasting, the internet, the postal and telecommunications sector together with guidance on the need for national communications policies designed to support the economic and social wellbeing of the country. He also worked on the drafting of both the Swaziland Communications Bill and Swaziland Electronic Communications Bill which on instruction of the minister he presented to both cabinet and parliament to pass it into law. Both bills came into law in July, 2013.

Apart from his work at the ministry, he was also the first Chief Executive Officer of SCCOM, although on acting basis when it was formed in July 2013 subsequent to the passage of the law that allowed for its formation.

At SCCOM, he came up with the organizational structure and played a role in plans of how the commission will work and, "I believe I worked well even though I was never made permanent a situation that still stands even today, the commission has no substantive CEO."

### ... The bitter-sweet journey as SBIS Director

ontrary to the assumption by the normal person on the street that being a manager is all about the huge salary and benefits, such a task comes with lots of challenges amongst which is making unpopular decisions for the good of that particular organi-

And Stan Motsa is no stranger to such opposition as he found himself taking shots fired at him by both the Parliament and members of his staff at the Swaziland Broadcasting and Information Services (SBIS) where he served as the Director and this was for trying to introduce changes that were unpopular with the majority.

During the interview this past week, he revealed how he was called all sorts of names by members of the parliament as he singled out one instance where he was allegedly called a 'dictator' for doing his job.

His said only sin was trying to bring about changes at the national broadcaster where he had taken over from Tass Makama in September of 2001.

Amongst these changes was that he wanted the daily news to be presented in a different manner than it was at the time, but because the parliament arians opposed such innovation, he stated that even today those changes were never implemented and the news is still packaged in the same way it was over a decade ago.

One of the few changes he managed to implement was the introduction of the news programme 'Letishisako' which he said was exactly how he wanted to package the news but because that was not allowed the least he could do was come up with the programme instead. "People within the organisation were defiant to the changes I was trying to bring about and all that earned me was a brutal name calling by MPs who said all they wanted to say about me in the media and what surprised

me was that all these articles were one-sided there was never a time when journalists bothered to hear my side as I was butchered by all who cared to," recalls Motsa who held reigns for seven years at SBIS before leaving to be the Director of Communications at Ministry of Information, Communications and Technology (ICT) in 2008.

At first, he explained that he shared the plans to implement a number of changes at the station where he had been since 1980 when he came in as a Cadet Engineer, but the staff rejected these and he allowed them to do things in their own way until he decided to stomp the foot down and implement those changes as the manager. But, the employees ran to parliament and he was called to explain on the issues that could have been dealt with internally but ended up expanding and turned everything into chaos. Reports from parliament are said to have been to the extent that he was not qualified for the position and that he was also troublesome hence action needed to be taken against him despite that he was one of the most learned and experienced people at the SBIS, he shared.

Changes

"Life wasn't easy," he admitted during the interview at his home in Mhlabubovu and further revealed that his wife would call him every day and tell him how life was with all the negative reports about him as he left for Rhodes University in South Africa in the midst of the troubles. At the time, the broadcasting station was under House Assembly Speaker, Themba Msibi who was a minister and Motsa shared that all the changes he sought to implement were fully supported by Msibi but politics were playing a major role in the matter in that he wasn't just the only one he needed on his side, but so was the Principal Secretary, who however was not for the idea.

### ... How his fortunes changed

t the height of all the negative reports and troubles faced by the SBIS, Motsa left for the neighbouring South Africa to do his Post Graduate Diploma in Media Management and it was during his stay in the foreign country that he is fortunes changed.

This is thanks to one reporter from the country he met at the university with whom he had a discussion about the forthcomings at the national broadcaster.

Understood

He revealed that from their discussion and presentation of what he was trying to do at the station, this reporter understood where he was coming for and as a result he wrote an article for the Times of Swaziland.

It was through this article that how people viewed him and the changes he was trying to introduce for the good of the station.

Issue

"I explained to him about how the whole hullabaloo had started and how I ended up on every newspaper on the land being portrayed as the bad person without anyone bothering to hear my side of the whole issue," he explained.

After this article, Motsa stated his frustrations and relied on the he said they managed to change that the storm started to calm down and they did another one where he wrote about the changes and explained them in detail and it is at this point that things began to change for the better with one member of parliament going to the extent of coming to him to apologise about all they had said to him before.

He stated that this particular MP told him they were not aware of

media for information and admitted they had been at fault on how they handled the whole debacle.

Allegations

The MP is further said to have sympathised with Motsa and stated that it was unfortunate he had not been given the right to respond to all the allegations levelled against him in concern to the changes he wanted to implement at the sta-

### ...Role in digital migration

tan Motsa is one of the country's most experience, boasting of over three decades in the country's communication structures and one of the projects he has worked on from scratch is the migration of Television from analogue to digital.

During the interview, he shared that he literally worked on this project with nothing and had to assembly the different teams he needed to work with on the project and further drafted the policy and specifications of how this would be carried out.

This was after he had done a research on the internet where he saw how a similar project had been done in Ghana which he used to benchmark the one he was working on for the

"Thereafter, I made a plan of how we would roll-out the project and the timeframes and then I was seconded to be the acting Chief Executive Officer of the Swaziland Communications Commission (SCCOM)," he explained.

But, at the time he left, he claims all was in place and the project was ready to be rolled out, although it is yet to be with him having left for SCCOM in July 2013.

In fact, his CV states that he personally sought for expert assistance and obtained it in 2010 from the International Telecommunications Union (ITU) to establish a national roadmap for the migration of television from analogue to digital.

Whilst doing this, he participated in the Southern African Development Community (SADC) study teams to establish the most appropriate standard that could be used for digital migration, as well as personally led the development and launch in 2012 of the Swaziland Television Digital Migration Policy. Later in December of 2013, Motsa led the development and completion of the tender documents that included technical specifications for the pro-

Meanwhile, Digital Broadcasting Migration is a process in which broadcasting services offered on the traditional analogue technology are replaced with digital based networks over a specific period.

The transition or switch from analogue television to digital television is referred to as Digital Migration. On two occasions, the country has failed to execute the transformation with recent reports that the country was ready to make its third attempt on the process.

Part of the reasons for previous failures have been said to be only a few Swazis were ready for the transformation as many had not yet purchased the set-top boxes.

Initially, the set deadline by the International Telecommunications Union (ITU) was June,

This he said during the interview in the past week as he said after all the years he had been working there was no better time for him to take a break than now. However, he pointed out that maybe after the break he would consider taking up anything if an opportunity availed itself, said the man who worked in the communications industry for over three decades.

When asked how he managed with the transformation from his busy life to being laid back, he said he was doing just fine as he has recently taken up farming full-time, something which he never had time for before.

He said that he now had the time and energy to drive his tractor and plough his fields as means to keep himself healthy and busy. He is also working on supporting his daughter and artist known as 'Amanda

### On his training at the BBC

brief span at the British Broadcasting Corporation (BBC) where he was trained to be a fully-fledged engineer.

This at the time when he was an incoming engineer at the SBIS and he was sent to the United Kingdom to train with the BBC's incoming engineers where he was the only engineer from Swaziland and one of two from Africa. The BBC is a British public service broadcaster and headquartered at Broadcasting House in London. It is the world's oldest national broadcasting organisation and the largest broadcaster in the world by number of employees, with over 20,950 staff in total.

Whilst in the UK, he did Part I and II of the course on the engineering of transmitters where

he former director also shared about his he said he learnt with mostly Englishmen and a lot of the training was focused on transmitters; how to repair and maintain them, basically the basics, he shared.

When he came back to the country, Motsa became the first engineer in transmitters, whilst one Ambrose Dlamini became the second in Studio engineering.

"Although, I had done the engineering of transmitters at school but I only had the theory part hence the SBIS saw it fit that they send me to BBC where I was taken through the practical part of this kind of engineering," shared Motsa.

He has also been to the United States of America and Germany for a similar course in order to be a fully-fledge engineer.

### "I have learnt my lesson and would like to return to school"

t nineteen years of age, she knows

She has a 17-month-old son with a man who promised her the world but deserted her the minute she told him she was pregnant.

She knows the situation at home calls for her to find whatever job that might come her way, even if it means leaving home at 3am on a daily basis in order to plant sugar cane.

Precious Manana\* (not her real name) lives in Mambane, the hills located east of the country which rise above the Lusutfu

The scenic area which overlooks both Mozambique and South Africa is marred by the abject poverty of some of the people and the high incidence of teenage pregnancies which result in school drop

The young woman carried a hoe as she walked wearily along the dusty road carrying a backpack presumably with warm clothes as well as remnants of food.

"I am from the sugar cane fields in Big Bend," she said as she shielded her eyes from the scorching heat after curiosity about her demeanour sparked a conver-

According to the Swaziland Meteorological Services, maximum temperatures for Big Bend on Tuesday were at 34 degrees Celsius, yet she wore a long sleeve vest as well as leggings under her simple makeshift skirt and top.

"I have to work in order to help at home and provide for my son," she said when asked for reasons behind carrying a hoe from the fields at such a young age.

She explained how she was dressed in this manner in order to protect her skin from the sun as well as the thorny bushes through which they travel to and from

She said she usually left her home at 3am and walked with her brother through the thick bushes, down to the valley where lies Big Bend's sprawling sugar cane fields. She was found returning home after 3pm and she revealed how she earned E50 per day from her labour.

"It takes us over two hours of brisk walking to get there since we start planting at

I leave the house while it is still dark and some other co-workers join us along the way," she said explaining how she carried the hoe because there was a shortage at the farm she worked.

I carry the hoe so I don't have to haggle for the few as we are many and the work has to be done quickly in order for one to return home while there is still light," she said,

She stated how she needed the job because she was at her wit's end trying to find means to fend for herself.

"The situation at home is bad and right now I need clothes for my son and I," she

Elaborating, she said she was the third

born of nine children living with her mother after their father passed away a few years ago.

Only the eldest is employed working a menial job and living away from home whereas the second born is still trying to find a job.

"Both of them failed to complete school after flunking different grades

several times and I was the hope of the family seeing as I was quite determined to become a doctor on completing," she said as she looked at the handle of her hoe nostalgically.

She stated how her life changed last year when she fell in love with an older man.

"That was my mistake, falling for a man who was older than I am," she said angrily adding how that killed off all her dreams.

"I was planning to become a doctor and I now work in the fields."

She said the relationship lasted for six months before discovering she was preg-

"I know about condom usage and I tried to ask him to use a condom but after initially using it, he said it would be ok to not use it and we stopped," she said shyly.

After reporting she was pregnant, she said her boyfriend disappeared from her life and she had to leave school.

"I stopped attending school on my own accord after confirming I was pregnant as I didn't want to be embarrassed," she said of the discovery which shattered her dreams of leaving her home area to return as someone with a qualification to reck-



Describing the last 11 months as great for this young man would be an understatement. He grew from being the talented hard-working rapper to being a full blown artist who undoubtedly owns the local crown.

He performed at the Hipnotik main stage, dazzled in his own show, The Soiree - which is definitely history deeply in-scripted in our entertainment scenes history books, he brought the house down with a thrilling performance at House on Fire when headlining one of the Friday Night Live series shows, he won two awards at the controversial inaugural Swazi Hip Hop Awards, was featured on a CNN special for CNN Inside Africa – and the list goes on and on.

He has been taking major strides. He said something during this interview when quizzed on the long wait of the album.

This was his answer - "I was going to drop the album in 2016 but as I got busier with all my shows and the business side of my brand, I found myself in a position where I was going to succumb to the pressure and make my album under pressure so I decided to hold it off a little longer, mainly

because I already invested so much into 2016 and there was no need to force the drop just for the sake of dropping" Ladies and gentleman let me digress no further and present to you the sit-down with the king of the

ASPIRE - You have been doing a lot this year, but what can you specifically say has been your major highlight of the year 2016?

80 - It's hard for me to pinpoint a major highlight because for me the vear itself has been a major highlight. To me, this has been my most successful year as a performing artist and it's only been three years now. I got to do so many amazing things this year.

I was one of the headliners at the Hipnotik Festival and it was my second time on the stage. I saw one of my icons J Cole, performing Live in Johannesburg.

I was the first headliner for the first Hankey Bannister Royal Nights hosted by King Terry and we recorded a full house that day. I headlined at House on Fire for the Sibebe Friday Night Live series and did numbers on

the day. I hosted my first event as an artist called The Soiree which is an annual event and became the first ever artist to host a show rated number 1 MC on a list mulo compiled by MTV Base. I won two awards at the first ever Swaziland Hip Hop Awards. I featured on a CNN special for CNN - Inside Africa - which will hit the screens and internet early January. I have yet another event in partnership with The Scientists. So it truly has been a year of success and 2017 is poised to be a year of even more success because I am not taking my foot off the pedal.

ASPIRE - How would you describe your show - The Sorre?.

80 - The Soiree to me was a success. I always hear the same story of how this could have been better, that could have been better, but in the words on Sean Carter "People will try to tell you how to do it yet they never did". My dream came true.

I've always wanted to start my own event franchise because I believe in these tough economical times, we need more than just artists, we need artists who have an entrepreneurial culture about them. The Soiree is an annual event and 2016 was about planting the seeds of this idea and vision. Next year is about growth. It's about hosting a bigger and more loaded show than I did this year. This is an upscale dress up event and people came out to my show looking amazing and happy to be given the platform to come out and dress to the nines. So it's important for me to keep bringing the show and with the vision behind it, it will be the biggest dress up event in Swaziland come 2018/19. Next year, we host the second install-

ASPIRE - You've always made it clear that your dream has always been to

perform at the

stage, how's the

road to making that dream a reality so far? 80- I always say that the only thing left for me to do in Swaziland is perform on the Bushfire main stage. I got a step closer to realising that dream when I performed at the Sibebe Friday Night Live

Season 6 show that took place on the 25th

November this year. I had a full live band, aptly called The Juggernauts, and we hammered it. If popular opinion is anything at The Convention Centre. I was so to go by, then I should make it to the next phase and I have a feeling I'll probably go all the way because I believe if you really want something, the universal energies will adjust to make it happen for you and there's no doubt as to how much I want it.

ASPIRE - What do you think of the current standard of the industry - what are the positives we can take and where can we improve?.

80 - The industry is wobbly. We don't have a proper industry yet. We are all trying to build one but we don't have an industry. For instance, artists should receive some form of royalties from radio for playing their music, but instead we have our music played for free and receive nothing. Promoters drag their feet when it comes to paying artists, or merely putting down the deposit and we are told the same story about 'budget' yet they are able to pay internationals exorbitant fees. Data is all expensive and this stifles a lot of artists' growth because everything nowadays happens online.

That's the one place where the world can connect with you but it's hard to keep it going. The industry is still crawling and it will be a while before it gets on its feet and starts walking, less of all running.

ASPIRE - When are you dropping that LONG AWAITED album? Yes, that sizzling project With the 'Yaya' hit track!

80 - I was going to drop the album in 2016 but as I got busier with all my shows and the business side of my brand, I found myself in a position where I was going to succumb to the pressure and make my album under pressure so I decided to hold it off a little longer, mainly because I already invested so much into 2016 and there was no need to force the drop just for the sake of dropping. I wanted to get done with the year I've had and save my album drop for 2017. I'm not going to overhype the album. When it's ready, I'll just drop it. The strategy we have in place is to make it go viral and I plan on dropping it in South Africa since I want to explore a broader market. So with the album, I'm tuning it. But it won't be long. Simply because, I myself just can't wait to drop it.

ASPIRE - What are you looking forward to in the year 2017? And where should your fans hang out at this festive season to see you in action?

80 - The only thing I'm looking forward to in 2017 is blowing up. Simple and straight-forward!

My brand is at a point where, if I play my cards right, I'm taking off. So everything is meticulous and calculated. Even the delay of the album release, I didn't want to just to drop. I want to drop a project that I will watch change my life altogether. My fans can find me at the Grande Mansion Party on the 31st hosted by Tendaness.



His ability to fuse proficiency, edification as well as experience in his approach has somehow rendered him distinctive in presenting his

He has somehow managed to strike a balance in both matured and youthful entertainment by widening his music scope, thereby bridging the generation gap presented by age & preference in entertainment

The stage name "Karly-B" emanates from a high school nickname, which came to life at the debut of the clothing brand "Karl Kani" whose articulation sounds pretty close to the name Khulekani. The "B" springs from the first initial of his middle name, Baphelele.

His deejaying career came to life in 2007, while he served as a sound technician for shows organised by the then giants of the industry, Sandla Entertainment.

He drew his inspiration from the company's director and

"I started collecting music,


practising and getting better and better by the day.





### ARV treatment rollout in KZN prisons

URBAN - Inmates throughout KwaZulu-Natal prisons have been trained as caregivers to assist their HIV positive peers take part in a massive ARV roll-out programme. Speaking at the launch of the Central Chronic Medication Dispensing and Distribution (CCMDD) programme on Friday at Westville Prison, provincial health MEC Sibongiseni Dhlomo said the programme would ensure better coordinating and dispensing of chronic medications for HIV, diabetes, asthma, cancer and others.

"This programme is ideal because the inmates are confined so there is minimal risk of non-adherence," he said.

Dhlomo said 4 000 HIV positive inmates from the province's 41 correctional facilities would benefit from the programme, which would also assist with eradication of stigma associated with HIV because the ARVs would be packaged sim-

ilarly to other chronic medication. KZN's prisons have 7 741 known HIV positive offenders, with 3 855 already on treatment.

"The CCMDD programme will help enrol the remaining nearly 4 000 HIV-positive inmates on ART," said Dhlomo.

"Under the new programme, pharmacies at correctional facilities in Pietermaritzburg and Durban will coordinate the collation of prescriptions from various correctional facilities in the province and submit those prescriptions to the service provider," he said.

Dhlomo said the initiative would benefit the inmates and broader society. "The vast majority of people committed to prison eventually return to the wider society. Therefore any diseases contracted in prison, or any medical conditions made worse by conditions of confinement, become issues of public health for the wider community when people are released."

### 13 injured from wind swept marquee during Zuma's speech

EERUST – At least 13 people were injured when gale force winds blew over a marquee in Gopane near Zeerust where President Jacob Zuma was delivering a Reconciliation Day speech on Friday.

North West police spokesperson Brigadier Sabata Mokgwabone said: "The injured persons include two police officials, a local municipality mayor and a chief."

According to police, of the 13 injured, four were admitted to hospital while the rest were treated and discharged. The North West provincial government had earlier said no one was injured. A storm wreaked havoc, uprooting the marquee tent in which the Reconciliation Day celebration was held, forcing Zuma to stop his speech as security personnel moved in to whisk him to safety.

Strong winds accompanied by rain blew over the tent at around 1pm, just as Zuma was outlining government's intervention in Marikana following the killing of 44 people during a violent wildcat strike at Lonmin platinum mine operations in Marikana near Rustenburg in August 2012.

Thirty four mineworkers were killed by the police on August 16, 2012, while 10 people, including two policemen and two security guards, were killed a week before.

Zuma said among the actions being taken was the provision of housing by government and also the mining company in order to improve living conditions. "Importantly, the issue of compensation, particularly for loss of support for the deceased families, for unlawful arrest and detentions, is being attended to. The South African Police Service is ready to pay. "Government lawyers are working with the legal teams of the affected persons or families of the deceased to finalise the claims. We cannot bring those who died back. However, we can and must do our best to ensure that the lives of their children improve.'

He said other remedies included taking steps against all those, particularly within the police service, who were found to have committed criminality in the way they handled the situation at Marikana.

# Eskom praises convictions for electricity theft

South African power utility

OHANNESBURG - Eskom has hailed the conviction of four people this week as a major victory in its fight against electricity theft which costs the power provider billions each year in lost revenue.

Last Monday, the Palm Ridge Regional Court ruled in favour of Eskom, handing down a guilty verdict in the case of the four accused, including a mother and son duo – aged 56 and 23, respectively.

The four, who collectively faced over 36 000 charges related to electricity theft, were found guilty on 16 451 counts.

The two main suspects, Mafuthi Chiliza and her son Nqobile from De Deur, south of Gauteng, were arrested in December 2012 when they were found in possession of a stolen Credit Dispensing Unit (CDU), a machine belonging to Eskom that

prints out prepaid electricity vouchers. Also recov-

Also recovered from the Chiliza's premises was a hard drive belonging to

another stolen CDU machine, numerous customer lists, including electricity meter numbers, 996 illegal prepaid electricity vouchers of varying value as well as other equipment used for printing prepaid electricity vouchers.

The two other suspects, who were also found in possession of cus-

tomer lists, meter numbers and illegal prepaid vouchers, were linked to Mafuthi Chiliza, whom the court established was the ring leader of a syndicate that sold illegal prepaid electricity vouchers, through records found on their mobile phones.

Telephone records also linked Chiliza to Andile Mgadi, who was also arrested for the illegal possession of a CDU machine but was murdered during the trial.

The victory was described as a great coup by Richard De Nobrega, senior adviser for Eskom Security Investigations, who also testified at the trial.

"Eskom loses billions each year to electricity theft," said De Nobrega during his testimony. "But Eskom or the state is not the only victim of this crime. To recover the money that is lost by the power utility due to electricity theft, including illegal

connections, meter tampering and bypassing and the selling of illegal prepaid vouchers, Eskom is forced to increase the price of elec-

tricity, which ultimately affects legal electricity users in the form of increased tariffs." Following the guilty verdict, the state applied for an investigation into how the four accused benefited from their illegal activity, which could lead to the seizure of assets, including real estate and vehicles. *Timeslive*

Assisting

This money was supposed to be used to teach ordinary Joe to become a business person and run enterprises instead of seeking employment. Instead of assisting people get the necessary skills to start businesses; the opportunity opened itself for fraudsters who claimed to have conducted classes for people whereas they hadn't and they made away with part of E50 million which they felt they deserved after circumventing a system which was not watertight to start

The country lost billions in pledges by institutions which

eading the judgement of saw the project as one which would be viable and good to awaken a spirit of entrepreneurship the country so lacks. No institution could support an initiative which had so many holes, holes which saw money literally stolen from the pockets of the Swazi nation in so short

The fact that it took nine years for the case to come to conclusion, is another issue that should make the blood of any Swazi boil because in those nine years, essential witnesses died and the nation was denied the opportunity to hear their evidence.

In the nine years since the arrest of the people who were paid for doing nothing, the economic landscape of the country changed. Advantage

Other opportunists came about and took advantage of the nation's failure to harness its own resources and make money out of them. Look at how many businesses that could be run by ordinary Swazis are in the hands of for-

eign nationals.

I wish there was a way of having all the people paid from the E50million kitty to show where their impartation of skills has been of benefit for the economy instead of always importing. because to date, I have personally not seen or heard anybody state how they were able to start a viable business post the Job Creation exercise.

With the population of an estimated 40% of people who are unemployed, who knows what the hundreds of Swazi people who could have been empowered could have achieved?

The country was seriously robbed, not just of the E50 million; that is peanuts when looking at the potential the exercise could have had. Instead, we have over thousands of graduates sitting at home twiddling their thumbs while alternatively hopelessly looking for jobs which would not have been the case had people been called up and taught how to start businesses.

Selling

With Swazis being able to emulate what their neighbours are doing when it comes to businesses (think of vendors at a market, all selling the same vegetables), we would have thousands of people engaged in different enterprises because some would have copied from those who were supposed to have been taught.

Had this exercise been successful, the country would have more to look forward to when it comes to South African Customs Union (SACU) revenue because most businesses would be exporters

The Swaziland Revenue Authority (SRA) would probably have no cause to get into businesses and personally count stock in an attempt to get people pay

the correct amount of taxes as everybody who would have been empowered would have cause to pay the right amount of tax because they would have engaged in viable businesses.

The government wage bill would not be inflated in this manner simply because there would have been no need to employ so many people as many would have aspirations to work in the private sector. Think of all the people who are in the civil service simply because it is more comfortable and employment is assured.

### Confidence

The exercise was supposed to create businesses which should have brought back the confidence of the small businesses. In fact, the small businesses would have been medium enterprises by now had people curbed their greed.

One can never deny the fact that Swaziland needs to increase the number and size of small and medium enterprises and the Job Creation exercise was intended for just that.

To attract foreign direct investment is acute.

I have no opinion whatsoever about the three who were found guilty just as much as I have nothing against those who were acquitted save to say, this exercise made Swaziland poor and it is to blame for taking opportunities away from the nation.

# Regional Company of the Year Competition: board chairperson's perspective



ast week, I had the privilege to be a part of one of Junior Achievement's prestigious competitions in Africa which showcases the magnitude of entrepreneurial talent that lies within young people found in the African continent.

It was truly one of the most important gathering of the JA family which was a great platform for skills and information sharing on how the JA programmes can be enhanced and strategies of how to move forward from the accomplishment covered thus fair. I found myself wishing I could have made an effort to join this activity.

Nonetheless I believe there was no better time than now for me to be a part of this event. Representatives as far as the world wide office were present to witness this event such as the worldwide President and CEO Asheesh Advani who was instrumental in giving a worldwide perspective of the strategic direction of JA Programmes.

My first exposure was attending a meeting that was organised for board chairperson, country directors and other key staff members in the different countries. This particular meeting was intended to give insight on the current JA standard worldwide, discuss the direction at which this institution is being taken in the next five to 10 years' time. During this platform, the JA strategic plan was discussed from the worldwide office. The worldwide office monitors about six continents worldwide with about 163 countries.



This therefore means they present a strategy that has been born out of the monitoring activities conducted and identifying the needs for all member nations and coming up with one key strategy for all. It was revealed that there are four priority areas for JA that all member nations should work towards.

Supporting

The first priority area is defining and communicating the impact of all programmes based on the alumni. The second aspect is supporting human capital in order to accelerate growth. This therefore includes taking courses from the Harvard University that will capacitate country directors on different leadership skills. The third priority area discussed was the expansion of our funding base. This is where the worldwide office indicated that their newly formed target was to increase funding up to one billion per annum. Countries were challenged to set their own targets yearly that will see increase in revenue each year. The last key aspect discussed was the strengthening of network alignment. The worldwide office shared with the African region some of the strategies they had taken to ensure adherence to these four priority areas as a benchmark for the African countries.

Of course the gist of my trip to Zimbabwe was to attend the competition itself and see young people give presentations on their different products to eventually come up with the overall winner. What I discovered looking at the standard of the competition is that Swaziland is really outstanding, of course this fact being proven true by the fact that we have currently won the competitions for years now. We have, therefore, become a resource for the regional office where they can benchmark on how we prepare our young people for the regional

office. When the regional office CEO, Elizabeth Bintcliff was in the country, she was just amazed at the standard at which our local competition is placed. In terms of girls' empowerment, this was amazing but it also poses a challenge to the member countries to pay attention to the boy child as well.

**Opportunities** 

All our kids, irrespective of gender, deserve equal opportunities for development and empowerment. Swaziland, having won the competition several times, is becoming a point of discomfort for the other member nations. It is also becoming a challenge for them that perhaps they need to revisit their strategies in order to compete with Swaziland. Again for Swaziland it raises the bar each year we win that we should maintain these kinds of results.

One of the things that make us winners is the fact that we constantly evaluate our own performance and look at areas in which we can improve. We aim to represent the country in the worldwide competition that will resume in January 2018.

There are aspects in which we need to pay particular attention to. There is a growing need for participants to come up with products that will touch on the science and technology aspect. The world being a global village has adopted this concept hence our thinking should be tailored to that level as well. There are strategies we are putting in place for us to promote the science and technology aspect among learners. We are looking into infusing the Science, Technology, Engineering and Mathematics (STEM) concept into our programmes. The award winning JACO programme will now focus more on innovation and critical thinking that will encourage pupils to explore their innovative capabilities in Science, Technology, Engineering and Mathematics (STEM) based business models. The entire programme will not be limited to this model but pupils will be exposed and oriented on how this model can help address needs, shortfalls and opportunities within their communities, corporate organisations and industry. We are also exploring the possibilities of utilising the newly formed Royal Science and Technological Park on how the pupils' businesses can be further incubated in this park for further research until they reach the expected I international standards.

As I conclude, I would like to emphasis that as a nation we are developing the kind of generation that is sure to match the standards of the world and directly invest to the economic turnover of our country. from the year 2003, the Swaziland Government developed a series of ICT related policies designed to unlock the entrepreneurial potential of existing and prospective businesses in the country.

The policies contained requisite framework for the liberalisation of the ICT sector, through the eventual creation of a new regulatory regime which will promote the technological convergence of various sub-sectors through digitisation.

Swaziland's ICT sector began to be more focussed given the institutionalisation of the sector through the establishment of a fullyfledged ministry of information communication and technology towards the end of 2009.

In June 2010, the Government of Swaziland reconfirmed that the ICT sector is critical in supporting sustainable development in the

This 'pronouncement' and commitment by government was viewed by business as a milestone and was in line with the 2013 Business Agenda, which had been jointly developed by the private sector and government. It was a historic activity which was to revitalise the economy through a properly developed information and communications infrastructure and framework.

### DATA IS THE FUTURE OF BUSINESS

It is against this background that His Majesty King Mswati III, in His Speech from the Throne, in 2010, stated that, like most emerging countries, the kingdom faced a major challenge of improving its ICT sector in order to close the digital divide. "We need to intensify our efforts in this regard since ICT has proven to be a catalyst for success in our development objectives, bearing in mind its various aspects such as e-government, e-agriculture, e-commerce, e-education and e-health, to mention but a few."

In this age, doing business through electronic form, has provided a platform for most blooming and advancing economies; it has been a gamechanger in the business space; it has improved the lives of citizens, saving time and energy on the day to day activities and decision-making

The use of information technology in commerce saves costs, time, energy and paperwork.

In the advanced economies, ICT in governance has provideda platform to the people to do all government based activities sitting in the comfort of their homes and offices at the click of a button. All the works that required forming long queues can be done over the internet. Healthcare facilities can reach people living at every corner of the world as a doctor's consultation can be available through online communication. The use of information technology in daily life has made tedious tasks simpler and cheaper and improved lives of the ordinary person.

However, in Swaziland, it is an open secret that data charges are extremely high compared to some other countries within the SADC region. This has resulted in innovations like e-governance, e-education and e-health a nightmare in the kingdom. People from advanced economies coming to Swaziland are frustrated by the inefficiency and high costs of the internet in the coun-

Members of the Federation of Swaziland Employers and Chamber of Commerce, particularly in the banking sector, hotel industry and manufacturing industries who trade regionally and internationally, have registered complaints about the exorbitant costs when transmitting data through the Internet as part of their business.

The cost of installing an optical fibre line in Swaziland is more than 300 per cent higher compared 'to other countries in Sub-Saharan Africa; yet one of the selling points for industries such as hotelsis free

Internet access.

The high costs of the internet in the country have not only had a negative impact on businesses alone, but academic institutions as well, including primary and secondary schools. Hundreds of schools in the country have computer labs, but are without internet access as it in unaffordable. This is a sad reality as it has been observed that countries with reasonable internet access have high technological research innovations which begin at primary schools. Insufficient capacity to innovate has been noted as one of the most problematic factors for doing business in Swaziland. The country's quality of scientific research and government's procurement of advanced technological products is lacking as a result of the poor internet infrastructure in the kingdom. Globally, when the internet is accessible to all schools and communities, it expands their thinking aptitude.

The digital environment is already empowering learners and teachers as never before and it is the FSE&CC's view that Swaziland should not be left behind in ensuring that the internet is easily accessible and efficient in all the sectors of the economy of the kingdom.

For this to happen, competition

is paramount. One of the key reasons for the country to experience such higher data charges is mainly a result of lack in competition due to the monopolisation of the telecommunications industry. Efforts to liberalise the telecommunications sector will further be in vain should the Swaziland Infrastructure Corporation Bill of 2016 be approved by the country's legislatures.

The Bill establishes the Swaziland Infrastructure Corporation and confers on it the exclusive privilege of providing the national telecommunications backbone infrastructure.

Currently, businesses in the country are unable to tele-conference, for instance, as a result of the poor internet services which comes with exorbitant charges.

Businessmen in Swaziland would prefer taking a flight to South Africa for a business meeting which would have been easily facilitated through tele-conferencing.

The Voice of Business in Swaziland strongly believes that the country possesses the potential to develop the necessary skills sets to achieve a competitive advantage in the ICT sector. For example, its competency level in the English language gives rise to the country's competitive advantage in respect of 'Call Centres' and development of business websites. Such potential will, however, go down the drain for as long as monopolisation of the telecommunications sector continues.

## MIND THAT **ERROR**

( Marching into 2017" is the title of the second editorial of the Times of Swaziland SUNDAY, December 10, 2016. The editorial begins with an observation that could be rightly described as mixed: "While some people are still struggling to comprehend the atmosphere and spirit out there, many are already in a festive mood."

However, in the fourth paragraph, the editorial turns very sombre, as it waxes philosophical. Listen: "The downside is that as the merriment and excitement continues, some of us will not make it into the year 2017. This is the harsh reality we live in. Some will die because of their negligence and overexcitement while others, Lord forbid, will be involved in accidents. Still, others will die of natural courses; for death is, after all, part of life."

Nobody can contradict that observation or deny the sentiment expressed. But anybody with an eye for spotting errors can see something that is amiss in the fourth sentence. People do not die of natural "courses," but of natural "causes." This is an error of faulty diction in the realm of pseudo-homophone.

In the same edition of the newspaper was an opinion piece with the title, WHEN GOD CRE-ATED SD... I do not exaggerate when I say this was a reflective and scintillating commentary. A taste of the pudding, they say, is in the eating. The first and second paragraphs would sufficiently buttress that adage.

"When God created Swaziland, He eliminated most challenges that negatively affect other countries."

"The living example of this claim, is that Swaziland is a country that has so tribes and that is one nation, one culture, one King, one language, we also have a culture of loving education, a people who have in their DNA abundant and unreserved hospitality.'

The second paragraph of the article qualifies for what we, on this page, have come to know as STOME: Sentence with Two Or More Errors. In it are two elements that will raise the eyebrows of anybody with an eye for yanking errors, the first of which is the comma after the word, "claim." This punctuation mark creates the error of comma slice.

The comma is unnecessary because it splits the sentence by separating its subject from its predicate which begins with the verb, "is."

Interestingly, the second element is also a comma which does the exact opposite of the first one. It is the comma that comes after "one language." At this point in the construction, we have a complete sentence, so the punctuation needed is not a comma. Instead, what the con-

struction needs is a full stop or a semi colon. The comma creates the error of comma splice: We cannot use a comma to join two independent or main clauses.

However, if we must use a comma at this point in the construction, it must be followed by the co-ordinating conjunction, "and." But that would make the sentence rather clumsy. If, like I do, you have a problem with the word, "example," we may correct the sentence by revising it, thus: "A veritable evidence of this claim, is that Swaziland is a country that has no tribes and that is one nation, one culture, one King, one language. We also have a culture of loving education, a people who have in their DNA abundant and unreserved hospitality."

If I may digress from grammar in order to celebrate the first sentence of the article under our spotlight, let me note that you cannot appreciate what God has done for Swaziland until you become aware of the fact that a country in Africa that goes by the name Nigeria has more than 700 languages and dialects, corresponding, of course, with different tribes. Not to mention its many kings who assume sundry names across the country!

Let us make yet another note, this not about grammar, particularly, but about writing, generally. Can you guess how many words constitute the sentence that follows the one which we have just corrected? One hundred and eight words! That's right: 108 words! Maybe, someday we shall examine the grammar of this 108-word sentence to see whether the writer pulled it off, or not. No doubt, this is an overly long sentence, but an extremely long sentence could be error-free.

Although the following sentence is about three times shorter than the aforementioned, it is not error-free. It is the lead of the news story in The Star of December 14, 2016, with the headline.

"All eyes on SABC's Maguvhe." It reads, thus: "Controversial SABC executive Hlaudi Motsoeneng, who a court of law has found was not entitled to hold any position at the public broadcaster, was doing a sterling job, MPs heard yesterday."

Quickly, let us say that the pronoun, "who," which begins the parenthetical construction in the sentence, is supposed to be "whom." This is an error of improper case of pronoun. The proper case, in other words, is the objective, not the nominative. If you turn the construction around in the following way, you will quickly see why the pronoun should not be in the nominative case: "Who has a court of law found not entitled to hold any position at the public broadcaster?"

Talking about length of sentences and proneness to errors, here is an eight-word sentence: "It was long, ugly and plagued with scandals." It they were commissioned by His is the lead of a news story in the Saturday Star of December 10, 2016, with the headline, "Austrians' wordy response poll."

Short as it is, this sentence is not error-free, for its predicate has three elements, one of which is not equal to the first two. Whereas the first two elements in the construction, to wit, "long" and "ugly," are words, the third, "plagued with scandals," is a phrase.

The sentence therefore has an error of faulty parallelism, and it may be corrected this way: "It was long, ugly and scandalous.'

"The girl is said to have ran to her father, who is separated from her mother, and begged him to save her education by paying her school fees." This sentence is the third paragraph of the news story in the Swazi Observer of December 16, 2016, with the headline, "Mother diverts kid's exam fees for other use."

In error in that sentence is the verb phrase, "have ran." The error is that of incorrect tense. Instead of "ran," the verb should be "run": "The girl is said to have run to her father...

At the top left side of the Swazi Observer of December 15, 2016 was a photo news story with the headline, KING COMMISSIONS INGAT-JA. Its caption read: "FOR THE LOVE: Thousands of Ingatja heeded to the King's call and convened at Ngabezweni Royal Residence where Majesty to cut the lusekwane shrubs."

The verb, "heed," is transitive; therefore, it takes on a direct object. The error is caused by the infinitive, "to," which is unwarranted in the construction.

The confusion here might be connected with the verbal phrase, "pay heed to." But, here, the word, "heed," is actually a noun, not a verb.

Our last error for today - and for the year, 2016 - comes from the following sentence: "When you read about the litany of blunders we are given to making financially, as country, and how we continue to seemingly hold it together thereafter, one cannot help but feel like thanking our lucky stars for the continuous dogging of these disasters - disasters that we unwittingly create ourselves; perpetually." This is the opening sentence of a commentary in the Times of Swaziland December 15, 2016, titled, THIS NATION IS LUCKY TO AVERT DISASTER.

The error in that sentence is one of shift of pronoun. There is a shift from the pronoun, "you," at the beginning of the first clause of the sentence, to the pronoun, "one," in the second clause. Make the two pronouns match and the sentence is

am greatly disquieted by the fact that the value of our culture and traditions seems to diminish and no one seems to notice, in actual fact, it is not that no one seems to notice, we all just decide to live in ignorance, pretend not to be aware of our surroundings.

I would not say we are oblivious, the truth of the matter is we are so short sighted to the point we have manipulated ourselves into believing that what is not ours is ours and what is ours is not ours. *Impela sitayicelivutsiwe!* 

There are several things that have been brought to my attention, things that are considered to be minority by many yet ironically they are very significant in the life of a Swazi. By Swazi I do not mean someone who claims to be a Swazi just because he or she is very fluent on the Siswati language but I refer to the person who is deeply rooted in the Swazi culture and traditions. We Swazis value the presence of our ancestors and so we make sacrifices to them to keep a close relationship with them.

We believe that being lidloti is not an easy thing as not all members within a family can really attain that stage. It is part of tradition that whenever an animal sacrificed to the ancestors, the horns are kept *endlini kagogo*, usually by the entrance high up on the door. It is fundamental to note that these horns typify the alliance between the dead and the living.

Moreover, it enactment as a perpetual admonisher of the mandatory services to the ancestors. They are also conceived as having ability to protect the family from predicaments and any quandary. However, small horns like those of a goat can warn against evil spirits often times these are worn by *tangoma* and *tinyanga*.

Another important thing that I want to bring your attention dear reader is the importance of *tiphandla*.

**Tiphandla** are derived from the skin of a goat or bull. These animals are slaughtered for sacrifices.

The stirrup of skin are removed and given to the person who has made a sacrifice or on whose behalf has been made to wear. *Sphandla* (singular) which is worn on the wrist is believed to protect the person and also for him or her to be guided by the ancestors to whom the sacrifice has been made to.

It is reckoned to make a sacrifice in advance of a major task. It could be a war or weeding amongst others.

While in the gestation period, the mother to be goes under rituals and observe taboos that vary from clan to clan, for example, a woman pregnant with a Dlamini child is prohibited to eat mutton. Furthermore, when the time to deliver overture, the expectant mother is given *timbita* which are believed to subside or minify the labor pains and to ensure fast delivery.

It is very important that delivery takes place *endlini kagogo* where there is presence of the ancestors.

However, it is believed that when the delivery takes longer than expected, then the child

is the product of an adulterous relationship hence he is a foreigner in the family and the ancestors do not recognise him or her. Soon after the child has been born, the new mother is supposed to be in seclusion.

She keeps indoors and whenever she is obliged to go outside, she puts on a cow skin or something over her head. I just want to remind people that these things are still necessary for us to practice, we are who we are today because of them.

Our grandparents ensured they follow the

They also reflect the values of the company then and now, meaning the colours, no matter what the initial motivation may have been, reflect and

These are structures that were left by our grandparents for us to emulate. We read in newspapers of wrongs that are committed by pupils and seemingly no one seems to see the negative effects of our now famous positive discipline.

The funny part is positive discipline happens not only in schools but worse at family level. Imphela sitayicela ivutsiwe, indlela langikhulisa ngayo make yangenta ngaba ngumuntfu emphilweni, kani positive discipline ugcina esikolweni, luswati lwakha umntfwana weliSwati abe liSwati lelikhuliswe liSwati lamenta watsandza buSwati ngobe liSwati buSwati ngeluSwati emntfwaneni. Old and outdated as this method seems, it still stand the taste of time.

Bangamane bangibophe ngobe sebaba nemalungelo. Sitayicela ivutsiwe. Itolo besati kutsi umntfwana emalungelo ngobe lilungelo lemntfwana likumtali wakhe. Batali labakhetsela umntfwana lokutamsita abe lutfo kusasa.

In fact, there are already growing concerns that some of these characters claiming to be helping the needy masses are cashing out big time by abusing the very stories of people's plights. 

We implore NGOs, whose leadership is transparent and accountable with good corporate governance policies in place by being in their operations.

We are, however, alarmed to such terrible stories circulation all



over the world, attracting attention and sympathy from donors, yet little, if any of such support, trickles down to the vulnerable masses.

The state of people's poverty and vulnerability that is being flushed all over the world is sad and embarrassing, when these are used for enriching undeserving people. Sadly even though such stories generate big interest and support, especially those touching on the lives of destitute OVC, for instance, there is no one monitoring the utilisation of these resources once they fall in the hands of these heartless people.

While we promote freedom of association and assembly, we certainly cannot be seen condoning theft with ulterior motives and false pretences, honestly. Such inhuman actions that thrive on abusing the sad reality and vulnerability of our people are exposed to definitely cannot be tolerated. Such human rights violations cannot be ignored and left unattended. Who gives such characters mandate to do what they are doing on behalf of the marginalised and vulnerable people?

### JOY NDWANDWE'S ZONE LEADERSHIP

ncwala, the annual traditional prayer and ritual, is transdisciplinarity.

According to Nicolescu (Nabudere: 2011) transdisciplinarity implies, by its nature, the rejection of all dogma, all ideology and all closed systems of thought. *Incwala* rejects all religious dogma, ideology and most significantly the structural violence of all closed systems of thought. It is a prayer and ritual in terms of natural rights, does not need to validate by the structural violence of religion. It is a science in terms of natural rights, does not have to be validated by the structural violence of science.

It is a governance system in terms of natural rights, does not have to be validated by the structural violence of ideology and close systems thoughts. Incwala is social science in terms of natural rights, does not need validation from structural violence of all closed systems of thought. These thoughts emerged during my retreat which began from November 21 to December 4th ending at University of Venda. The theme at University of Venda was towards the science and technologies of humility in South Africa, funded by the Department of Science and Technology (RSA) through the National Research Foundation (RSA).

### Cosmologies and Knowledge Systems

Incwala, rooted in indigenous cosmologies embedded within knowledge systems. It honours what Prof Luutu explicates as the feminine deity of self-renewal and regeneration. This begins with the King's seclusion, enabling meditation towards achieving a self-renewal process at year end. Thus, similar to the self-renewal and regeneration process of the snake, allowing for regeneration, which requires seclusion.

The feminine deity of self-renewal and regeneration is evident in the monthly menstrual cycle, which also requires seclusion. Kings must experience self-renewal so they go into seclusion, as this provides this period of regeneration towards renewed leadership the following year.

This is humility, embedded within indigenous leadership, rooted in indigenous cosmologies and knowledge system. According to Prof Luutu, enabling the human decompose to occur, evident in terms of the seclusion period. When the water party pilgrimages to the ocean and veld to bring compost elements for renewal towards regeneration. Cosmologically this occurs according to the feminine deity, the moon, as the water party collects the sacred water from the ocean. This sacred water emanates from the ocean during the period of the mating of corrals, this is indigenous science. This science has experienced structural violence from religions, as *Incwala* is considered demonic and evil whilst in terms of natural rights rejects dogma.

The return of sacred water in calabash, known as *inkosazana*, rejects all ideology as this is cosmological, happens with no human spirit but cosmologically. Closed systems reject this notion presented by indigenous science as ludicrous, due to their structural violence.

Thus, intolerance of any ideology that is perceived as 'irrational' or 'demonic' or 'superstitious' or 'barbaric.' This is how structural violence embedded within religious institutions tried to advocate for *Incwala* to be stopped or banned. Reflecting how our education system encourages linear thinking, confide in dogma as dominant ideology within closed systems.

The negation of these indigenous cosmologies and knowledge systems, supported by the negative explanation of how lives are lost within the process of *Incwala*.

Am certain that the water and herb parties used to have casualties and deaths during these pilgrimages to the ocean and mountains. However, these pilgrimages have transcended as the general conditions have changes, so this linear thinking of *Incwala* reflects structural violence. Hence the contention now focuses on how the water and herb parties say 'mudlulise', let him/her pass, when

going to the ocean or moun-

This call 'mudlulise' respects and honours the calabashes carried to and from the ocean and mountain. Due to structural violence embedded within dogma, ideology and closed systems we negate this call. I do admit this culture too has become arrogant, the water and herb party have elements of arrogance. They demand money, during the ocean and mountain pilgrimage, also during the 'numike' during the collection of negativity engulfing the nation. To be liberated and burnt during the burning of the log ceremony.

Yet the regiments should be able to accept tokens from the nation. As this is symbolic rather than an Incwala tax, as presented at times. **Humility of Science and Technology** 

During my retreat I was immersed into why Incwala is transdisciplinarity, this is not to suggest that Incwala was the topic of discussion. When Prof Shiv speaks of cognitive justice, and how this must evoke the humility of science and technology. As Little Incwala had begun, I was mediating on Prof's message on the festival of humble knowledges. On how humble knowledges are playful, Little Incwala came to my mind, as it is playful whilst building confidence in dancing skills. I was mentored on how humility is confidence in the other, which requires patience as the story telling occurs on the other side.

Thus came the realisation on how Incwala has been facing structural violence from all dogma, ideology and closed systems.

As religious dogma, ideology, science and technology lacks humility, and lacks confidence and patience required to listen to the story telling of Incwala. Evidence of how religious dogma, ideology, and all closed systems lacks plurality, required by cognitive justice. As cognitive justice enables language dialects to express cosmologies, knowledge systems, myths and culture towards humility of science and technology. Science and technology lacks humility as it confines language into dichotomies, hence the western, Asian and African.

Yet humble knowledges use language as art and cultures, for truth to be truth it has to be true

in two languages, as Prof Shiv stated. This was taking me into the Little Incwala dancing that I was missing out on, as the languages of the songs are in both Siswati and Kuyeyeza, Ndwandwe dialect. Symbolising the feminine principle that is within the context of Incwala, embedded on how Incwala as it is preserved came with the feminine power of LaZidze of the Ndwandwe's.

The role of the feminine power continues irrespective of whether the Queen Mother is from the Ndwandwe's or not, but the plurality of language is the core. The femi-

nine power of the reigning Queen Mother requires that she be in seclusion during the *Incwala* process. Thus reflecting what Prof Luutu refers to as the complimentary principle embedded in the placenta. This placenta, requiring the Queen Mother to experience the humility of self-renewal and regeneration. This complementarity should not be misrepresented to be competitive principle, as they are humbled together during seclusion. In particular, as during the year the Queen Mother has been listening to the King and nation. Thus, taking into consideration how her Royal Residence is where all citizens come to 'kumbula ingubo' when they appeal for leniency

This year's retreat made me reflect deeply into the arrogance of culture, particularly when it incorporates into modernity and not integrate

Thus, suggesting how there comes a time when culture is not transdiscipliarity by becoming dogmatic and closed system, hence my academic and research is on indigenous cosmologies and knowledge systems. Evidently enabling me to be a transdisciplinarity scholar, as its culture questioning that is perpetually accompanied by responses that are accepted as temporary (Nabudere 2011). Finally, Incwala questions the king and queen mother through its processes, and it also questions the governance system of the kingdom. Evidently Incwala ceremony annually responses to the temporary questions each year. To appreciate this critical thinking requires the rejection of dogma, all ideology and closed systems thought, and immersion into indigenous cosmologies and knowledge systems.

# Loosening the apron strings of children with disabilities

eople usually do not like to give alms to non-disabled beggars on the streets. I've known people to complain, "But that person is not disabled! Why should I give him anything? He should work for money like everybody else.'

The norm is, beggars have to be disabled to get help. The gist of today's discussion is people with disabilities do not have to be beggars. They should be able to work like everybody else and should be accorded the right support.

Most parents dream of a brilliant future for their children.

They want their children to be active members of the community - make good friends, enjoy good wealth, work and earn a salary to enable them to live independently. However, when a child has intellectual disabilities, and

sometimes even physical disabilities, parents tend to expect far less of them. This is ironic because it is the same parents who also want their children to have equal opportunities out there in the world. But capacity building should rather begin at home, shouldn't it? Intellectual disability is a term used when a person has certain limitations in mental functioning and in skills such as communicating, taking care of him or herself, and social skills.

These limitations will cause a child to learn and develop more slowly than a typical child. They are likely to have trouble learning in school.

They will learn, but it will take them longer. There may be some things they cannot learn, but it is important to realise they will have things that they excel at, and these should be harnessed to make sure they can live off them. It is hard to have very high hopes for children that struggle with so many basic things, but we can never know how far they can go unless we loosen the apron strings a little bit. If you believe your child will always be helpless, it's hard for you to work towards changing the course of his life.

You will most likely convey the same negative perception to him. Parents need to have faith that despite their challenges, children with cognitive disabilities can live to transcend their diag-

During my conversation with Sonia Paiva on how her family assisted with the construction of the Enjabulweni Learning Centre, she raised what I thought were very important points regarding how to raise children with disabilities.

When her child was diagnosed with a learning disability, she and her husband worked hard to ensure he got a good education. Because the son is now a young man with his own sense of autonomy, his name will not be disclosed. Sonia

confessed that she was always fearful of letting him go anywhere by himself, much to his annoyance because he believed he was perfectly capable of taking care of himself. Even though she harboured certain fears, she did not stop trying to groom him for an independent life. He can drive, cook, go to work, and has even moved out of his parental home! Sonia encouraged parents to work with what they have, and not try to force children into what they hoped they would be. "If your son has a problem with his hand, let's see what he can do with his feet, if he has a problem with his legs, let's see what he can do with his arms," she said. Since moving out of home, Sonia has noticed that her son's independence and confidence have actually grown by leaps and bounds, forcing her to realise that by overprotecting him from the harsh world, she was actually impeding his progress.

"The problem I had was that I was too protective of my son, and there was a lot of damage I created, because a lot of people felt if I'd let go earlier and not protect him too much, then he would have progressed a lot better. If I were to turn the clock back, especially when I see the progress he has made when he's more liberated, I should have done it sooner. If I were to give advice to parents I'd say, if your son can walk, let him walk. Let him experience how it feels to fall and get hurt," she added.

So how do you help your son become independent? Experts say you need to pay particu-

lar attention to your child's interests. Does he like counting, cooking, fixing gadgets, cycling, gardening or does he like creating things? More attention should be paid to the child's strengths, rather than mope over the things he cannot do.

Many children with intellectual disabilities need help with adaptive skills, which are needed to live, work, and play in the community.

This is where it becomes important to send them to school where

they can be assisted by professionally trained teachers to relate appropriately with others, reading, writing, counting, and taking instruction. At home they can also be taught to take care of their personal needs such as cleaning after themselves, dressing, bathing and cook-

It's a process of trying to hone their skills and should start from an early age. It is a good idea for parents to have good relationships with the child's teachers and therapists in order to share tips on how best to help the child.

Children are always a handful during school holidays; it's a little more hectic when they have cognitive disabilities like autism and are accustomed to a set routine. Instead of getting frustrated with them, give them chores to do, take them shopping and assist them in counting change. These skills will definitely come in handy later in life.



ONDON - Dejan Lovren says he does not fear the physical threat of Romelu Lukaku as Liverpool prepare to take on Everton tomorrow.

The Belgium international striker has already netted nine times this Premier League campaign, almost half of the Toffees' tally.

Nevertheless, Lovren is relishing the chance to battle it out with the powerful attacker.

"Everton have some top players and Lukaku is one of them," the Reds' defender told the Liverpool Echo. "He has proved it over many years in the Premier League that he is one of the best strikers in the league."

The Croatian centre-back was withdrawn at half-time of

Liverpool's 2-2 draw with West Ham with cramp last Sunday but played the full 90 minutes of the 3-0 win at Middlesbrough in mid-week and is fit and raring to go for the Merseyside derby at Goodison Park.

"It will be a tough challenge but I am ready. We are all ready to fight," he said.

"Physically, I am fine. I had a small problem but it is gone now." Liverpool are unbeaten in their last 11 league matches against Everton, winning four and drawing seven, their longest unbeaten run against their city rivals in the league since an 11-game streak between March 1979 and March 1984.

# FIFA boss wants video refs at 2018 SWC

okohama - FIFA president Gianni Infantino hopes to see video referees used at the 2018 Soccer World Cup in Russia - if its teething problems have been fixed in time.

Colombia's Atletico Nacional slammed the new video assistant referee (VAR) technology being trialled at the Club World Cup in Japan after the first-ever penalty awarded under the system helped knock them out midweek. Real Madrid were also lukewarm after confusion around a Cristiano Ronaldo goal in another game, but Infantino promised FIFA would iron out the glitches.

"It's still premature to say when we will go live with this system," he told reporters yesterday. "But I hope at the next World Cup the test results will be positive enough to be able to implement it." Infantino praised the decision to award

Japan's Kashima Antlers a penalty against the South American champions.

"The referee didn't see the play and his non-decision could be corrected thanks to the video technology," he said on the eve of the final between Real and Kashima.

"The time it took (to award the spot kick) lasted too long, that's something we can work on. "But the right decision was taken and the penalty awarded, which was correct."

Chaos followed Ronaldo's late goal in a 2-0 victory over Club America a day later, when it appeared video technology could have ruled out the effort.

Ronaldo's celebrations were briefly cut short before the goal was confirmed. Infantino blamed the confusion on the video assistant pressing the intercom while consulting colleagues, confusing the match referee. *AFP*

Hamilton, 31, missed out on a fourth drivers' title this year to now-retired Mercedes teammate Nico Rosberg.


Palmer says Hamilton is in a "good place" for next season, but does not know how long he will stay at the top.

"It is what everyone else is aspiring to do, so to be in that position and call it quits is difficult to understand for a lot of other people. "I would love to be in that position, but I don't have a family and kids. I respect him,

because from that position it is a very brave call."

Palmer, who will drive alongside Nico Hulkenberg next year, believes Hamilton will have an 'advantage" over whoever Mercedes recruit to replace Rosberg.

"Anyone else is going to be coming in new to the team, and also pretty late without the preparation that most others have had," he said.

Palmer says it will be tough for Mercedes to replace the world champion because the "main contenders" are all under contract. But he added: "I don't doubt they will be fine. They still have Lewis Hamilton in the car and whoever they do get in the second car will be a very capable driver anyway.

"It is harder for them, and I'm sure they would much prefer Nico was staying on, but I think they have been so dominant the last few years they should be able to transfer that in to the next generation of cars and at least be race winning.'

mediary between the Premier League and Serie A, has claimed the 31-yearold could have been flogged to Napoli during the summer,


A move to an English rival was ruled out but the former FIFA agent insists Mourinho is keen to offload the ageing star and make room in his squad, with even a loan move mooted.

ONDON - Oscar's decision to leave Chelsea for the £400 000 wages on offer in China has been described as 'embarrassing' by Jamie Carragher.

The 25-year-old Brazilian will complete a £52m move to the Chinese Super League in the next fortnight, with reports suggesting the player will become football's best paid player by making the move.

But Carragher, writing in his Daily Mail column, lamented the Brazilian's decision to effectively put wealth before his career.

"It is a sad day for football when a player about to enter his prime moves for financial reasons and nothing else," Carragher wrote.

'The money is astronomical, but it's not as if he is on a pittance at Chelsea.

'This is not a move to further his career. He will talk about the league growing in China, the chance to work with Andre Villas-Boas and the excitement about a new adventure — but we all know those words will be nonsense.

"He has gone for the size of the contract. Nothing else. Players used to look for a pay day in their mid-thirties when their career was coming to an end. We all understood that.

"With the riches now on offer in China, I could understand a player's head getting turned when he reaches 30 – but 25?

"It is embarrassing that a player would give up his career and the chance to compete for the biggest prizes in the game just for money." **TEAMTALK** 

# 'Stones has potential to be Europe's best, but isn't ready yet'



ONDON - Roberto Martinez believes John Stones has what it takes to become one of the best centre-halves in Europe but says he still has a lot to learn.

The Belgium boss managed Stones for three years at Everton, during which time he saw him mature into the player Manchester City made England's most expen-

made England's most expensive defender when they paid £47.5 million for him in the summer.

"You're talking about one

of the best footballing centre-halves in European football, but that's potential," the 'Spaniard told BBC Radio 5 Live.

"We're very, very quick to judge people and not to understand that he's still a very young man, probably ahead of where he should be."

Stones has come under fire following

some below par defensive performances this season, the most recent example coming in his side's 4-2 defeat at Leicester last weekend, when he was culpable for at least one of the Foxes' goals.

"You're the last man and when you make a mistake in those areas

you are going to get punished. He's someone who needs to learn many aspects of his play," Martinez said.


