



JOURNALISM BACK AMONGST PRIORITY COURSES AT UNISWA

THE ministry of labour and social security has reviewed the priority programmes of study to be funded by government from 2016-2020, which has seen Journalism and Mass Communication bouncing back to be included amongst the priority courses.

The list of priority courses which were previously approved for 2012-2015 excluding journalism in the awarding of scholarships, in local institutions, was revoked after several consultations from different stakehold-

Minister of Labour and Social Security Winnie Magagula announced the latest developments during an interview with Swaziland Broadcasting and Information Service (SBIS) yesterday.

The newly prioritised areas include Journalism and Mass Communication (University of Swaziland), Early Childhood Care and Music (Ngwane Teachers College), Panel Beating and Spray Painting & Office Management and Technology (Swaziland College of Technology), Pharmacy (Good Shepherd College of Nursing), Diploma in Motor Vehicle Engineering, Building Construction, Plumbing, Mechanical and Manufacturing, Engineering, Electrical installation, Carpentry and Joinery, business finance and accounting (VOCTIM).

Minister Magagula said the review of the existing priority areas for the award of pre-service scholarships was mainly guided by the priority sectors identified by government through its various programmes, such as the Investor Road Map, government programme action, Speech from the Throne and Vision 2022.

She said the priority areas were then submitted to cabinet for consideration and approval.

"The review of the priority programme areas commenced in July 2015 and was facilitated by a working group comprising of the scholarship secretariat, localisation unit, statistics unit, Directorate of Vocational and Industrial Training chaired by the Director of National Employment Service. All stakeholders, including the private sector and parastatals, were requested to identify scarce skills. The stakeholders provided crucial lists that

"I am canvassing that journalists must go to school and get all the needed knowledge as I need them as a minister of labour and social security. I want to ensure that when they get their education, they are not exploited and to be rightfully

When I took over the office, I found the priority lists already there, so I could not tamper with it. But now that I'm in charge of the ministry I will ensure that I give journalists all the support they need," she said.

facilitated the review of the old list of priority area," she said.

She also mentioned that line ministries and parastatals also provided information on skill gaps in the labour market.

Shortage

"The localisation unit of the ministry provided data of work permits issued to expatriates from 2013-2015, in order to identify where there was shortage of skills.

The Speech from the Throne, Vision 2022 Investor Road Map programme of action 2013-2018 were utilised in order to align the stakeholders submission with government key areas for development.

Furthermore, a stakeholders' consultative workshop was held and the priority areas were reviewed and adopted," she added.

The minster disclosed on air (Swaziland Broadcasting and Information Service SiSwati channel) that those that are already studying the programmes could apply for the scholarships and if they met the criteria, they would be considered.

UNISWA's Dr Mthembu elated over govt decision

UNIVERSITY of Swaziland Journalism and Mass Communication Head of Department, Dr Maxwell Mthembu says the decision by government to reconsider sponsoring journalism courses at the university was a right step towards the country attaining first world status.

Dr Mthembu said the enrolment of journalism had dropped drastically over the years at the institution, as they currently have 24 students in the first year programme, two doing their second year, six in their third year while 10 are doing their final year. He

said with the good news announced by government, they hope the enrolment would significantly improve in the coming years. "We are elated with the decision as this was an oversight in the first place.

Development can never take place without the involvement of the media. We have heard how they were complaining how the standard of journalism had dropped and were pulling out their own funds to improve those journalists. We really appreciate the effort, this is the right step towards attaining first world status," he said.

HITMAN HIRED TO KILL PM, MPS

THERE was deafening silence and shock yesterday afternoon at the Mbabane Magistrate's Court when it was revealed that a businessman had hired a hit man to kill the Prime Minister Sibusiso Dlamini and several other MPs.

Details of the shocking plot to take the life of the PM and a couple of legislators will not be printed for now as per a humble request by Principal Magistrate Fikile Nhlabatsi.

Testify

It was in open court where a female complainant, who happens to be the wife of the businessman, took the stand to testify against the hitman who had been hired to kill her first then the PM.

Names of the people involved will not be published because Magistrate Nhlabatsi held the view Names of the people involved will not be published because Principal Magistrate Fikile Nhlabatsi held the view that it would jeopardise full-blown investigations that have been launched into the matter

that it would jeopardise investigations that have been launched into the matter.

The court heard that the businessman had paid the hitman E20 000 to kill his wife. The wife resides in one of the fastest growing settlements outside the capital city. It was revealed in court that after being paid, the hitman set out to strategise how he would kill the businessman's wife.

Arrangement

On March 3, 2016, the hitman allegedly went and broke into the businessman's wife house where he assessed the living arrangement.

He allegedly stole electronics and other expensive household goods. On her return the wife found the house upside down and reported this to the police the same night.

As a security measure she was offered a neighbour's child to live with her. Things were normal until April 7, 2016 when disaster struck

The businessman's wife told the court that when she returned home at night she found the hit man relaxed in the house waiting for

The neighbour's child was held hostage by the hitman. The hitman allegedly ordered both of them into the living room where he narrated his mission.

Claimed

The wife, however, told the court that she was familiar with the face of the hit man and knew him as a God fearing man. She claimed to have been taken aback by his mission.

"He told me that he had been hired by my husband to kill me. He further told me that I was not the only one to be killed because the PM and some MPs were next in line. I asked how much he had been paid to kill me.

"He said I must match the amount he had been given and he demanded E20 000," she said.

She said judging from the amount the hitman demanded it was clear that her husband had allegedly paid E20 000 for her killing.

The wife told the court that she then drove with the hit man to her son's shop, where they managed to get E18 000. From the shop the hit man instructed her to drive to a filling station where he wanted to count the money.

Before the hit man left, he told the woman that he was to flee the country because he had double crossed the businessman who had hired him to kill her by agreeing to take the E18 000.



He is said to have told the woman that he was considering dropping the idea of assasinating the PM and the MPs and flee to Zimbabwe where it would be difficult for the businessman to find him. The hit man allegedly instructed the woman not to say a word about the plot to kill the PM and the MPs. He then left

then left. The woman returned home and reported the matter to the police the following day. She said things went quiet for some time until she got a call from the police on April 12, 2016. When she got to the police station she was shown items that matched hers that were stolen on March 3, 2016.

She was later shown the man who had been arrested in connection with the theft and it was then that she realised it was the hit man.

However, the money was never recovered because he told the police it had been used. As the woman testified she was overcome by emotions and tears flowed. The matter was adjourned and will continue on Friday.

EBUTSINI ROYAL KRAAL CELEBRATES CULTURE DAY

HIS Majesty King Mswati III and Her Majesty Indlovukazi have continued to support Swazis based in chiefdoms in neighbouring South Africa.

Their Majesties have always commissioned regiments to participate in cultural activities in the respective Royal households in that country.

The Ebutsini Royal Kraal held a culture day where the King commissioned *Lutsango*, *Emajaha* and *Imbali*, *Sagila Semnikati* and *Ligcabho*

Lamhlekazi to be part of the delegation led by Umngani Lusendvo Fakudze, which attended the ceremony over the weekend.

The event started on Saturday and finished the following day.

Ebutsini Royal Kraal is led by Prince Deyani who was appointed by His Majesty King Mswati III. The area is situated in the Mpumalanga Province, near Badplaas.

It is one of the many royal kraals around the region with a Swazi population which normally hosts the annual ummeno ceremonies. They also partake in cultural events in the country includ-

ing the Reed Dance and Incwala among others.

Fakudze said Their Majesties attach great importance to culture and tradition, thus chiefs in South Africa were not left out but actively involved in such activities. He said by commissioning them to represent royalty in such an important ceremony was a sign of support to the chiefs based in the neighbouring country.

"We are here following an instruction of His Majesty, though The Indlovukazi commissioned us since the King is out of the country on official business. Her Majesty told us to convey a special message of encouragement to the chief, to say they must stick to culture and always remember that their home is in Swaziland and their king is His Majesty King Mswati III.

Her Majesty said we must commend the chiefs for always extending an invitation to the Royal family in Swaziland whenever they hosted such important ceremonies. This, she said, was a sign that they have not forgotten where they come from and where they are supposed to report," he said.

Fakudze also relayed a brief history of the area, saying the current leader of the area

Prince Deyani is a son to Prince Ngilandi, who is the son of Prince Magcuzu also known as Sgodvo.

Change

He said they are the descendants of Ndvungunye who was son to King Ngwane III who was a son to Dlamini III.

Prince Deyani on the other hand said they were grateful to His Majesty Mswati III and Her Majesty Indlovukazi for the support they always extended to the Ebutsini Royal Kraal. Prince Deyani, who says he was blessed by His Majesty to lead the people of Ebutsini, stated that His Majesty said the place is to be called Elutsini after noting that the name Ebutsini had a witchcraft connotation. He

always make it a point that they go to Swaziland to be part of all the cultural ceremonies including the Reed Dance, Incwala and other important national events such as the King's Birthday celebrations.


Attendence







SEPARATION OF POWERS THROWS GOVT IN DEEPER CRISIS

THE separation of powers in government has thrown Justice and Constitutional Affairs Minister Senator Edgar Hillary into deeper crisis with regard to accounting for funds allocated to the Judiciary.

Although this is a department within the justice ministry portfolio, Senator Hillary's predicament is that the Judicial arm of government is brandishing its independency status and pushing the line minister aside on administrative issues, in the process making it difficult for the minister to account for their actions in the Legislature.

Appearing before the Government Assurance Committee (GAC) yesterday, Senator Hillary had difficulty explaining certain actions or omissions of the Judiciary because although he is the line minister, he is not responsible for the administration of the department. The minister told members of the GAC that the

country's constitution made it clear that the Judiciary is responsible for its finances and administers itself. The minister told the GAC his role was to seek approval of their budget in parliament and it ended there. Members of the GAC, chaired by Kwaluseni MP Bukhosi

Dlamini, were left bewildered as to how they would hold the Judiciary accountable for the taxpayer's money they receive from the public purse. The minister was summoned by GAC to answer on why he did not meet certain recommendations of the House of Assembly, which included one that required him to bring a progress report in the next performance report on the issue of facilitation of the Law Reform, in order to align the old laws with the constitution.

The other recommendation was "That the ministry considers amending the Legal Practitioners Act 1964 to make the remedial powers more effective on unscrupulous lawyers.'

Lastly, parliament recommended: "That the minister should present the Administration of Estates Bill, within a period of six months to

Justice Ministry in a shambles

SENATOR Edgar Hillary has told the GAC that he inherited a ministry in shambles when he was appointed to head the justice and constitutional affairs ministry.

The ministry had serious shortages of legal draftsmen and the ministry's failure to retain retired Deputy Attorney General Sabelo Matsebula made the situation

The ministry is currently faced with a situation whereby various Bills need to be drafted and the workload proved to be too much for AG Majahenkhaba Dlamini.

The minister told the committee upon appointment into the ministerial position, that he had no choice but to inherit all the challenges the ministry faced. He said he was fully aware that government need-

Cabinet's approval and thereafter to Parliament within the above time limits." For the minister to provide satisfactory answers to the committee on these questions, he needs to be hands on and be in full control with regard to the operations of all the departments under his ministry.

ed legal draftsmen but there was very little he could do about it. He said Matsebula was the most qualified person but because his powers were limited, hence he could not do anything to retain him following his failed attempts to have him engaged on a contract basis.

Difficult

The minister said not every lawyer was a legal draftsman and to obtain such highly resourceful officers was very difficult.

He said the recently appointed Deputy Attorney General Sifiso Khumalo, was an ordinary lawyer who did not possess the legal draftsman skills. Attorney General Majahenkhaba Dlamini said overall, the country had less than 10 legal draftsmen, some of whom had been taken away by the private sector.

However, with these rather unclear demarcation lines around the separation of powers, the Swaziland government is apparently geared for a constitutional crisis whereby a collision of the two arms of government, the legislature and the Judiciary is eminent.

MINISTER VISITS WORSE PERFOMING SCHOOL

The minister was accompanied by the Principal Secretary, Pat Muir and Manzini Regional Education Officer (REO) Mlimi Mamba.


The minister, when addressing the teachers, said they must break the stigma that the school was infamous for.

"We are here to share ideas on how we can move forward. I request that the teachers work together, hand in hand. The rules and guidelines of the ministry should be abided to as they govern the work of the teachers in the country. Do not divert from these rules," he said.

DRILL AT WESBANK CAUSES PA

THERE was panic and confusion amongst Wesbank employees vesterday when the fire alarm went off just at the start of the working hours.

The sound of the fire alarm caused a near mayhem at Wesbank Swazi Plaza as employees left everything they were doing to the fire assembly point within the vicinity.

Fear and uncertainty was written all over their faces as they evacuated their different work stations, however, there was neither visible fire nor smoke coming from the building.

Situation

The fire personnel and their managers tried to calm the situation. They were relieved when Swaziland Fire **Emergency Services Station** Commander Luke Lushaba told them that it was only a fire drill.

"A fire drill is a method of practising how a building will be evacuated in the event a fire breaks out or other emergency. Usually, the building's fire alarm system is activated and the building is evacuated as if the emergency had occurred.

Evacuate

"Generally, the time it takes to evacuate is measured to ensure that it occurs within a reasonable length of

note of the role played by His Majesty and Her Majesty in taking a leading role in protecting wildlife


He said due to the support and commitment from His Majesty the country has been recognised by the international community for the successful conservation of rhinos, which the King spearheaded.

The DPM said wildlife in particular, played an important role in increasing the numbers of tourists coming to the country thus adding





I AM BANKRUPT, LIVING IN FEAR -HACKED PAKISTAN BUSINESSMAN

NAEEM Khan Gul, the businessman who was cruelly hacked with bushknives by fellow Pakistani men last month says his family now lives in fear following the release of his assailants from custody.

Gul was left with multiple gashing wounds all over his body after he was attacked by four men who were led by renowned businessman n Siteki, Akber Ali. Ali and his cocused; Zafar Iqbal, Ehsan Ahmed and Wasim Ranjhi were subsequently arrested and charged with attempted murder, theft, malicious damage to property and contravening the immigration act.

They were eventually released from custody last week after they had spent about a month behind bars. Following the turn of events, the victim has come out to say that the incident did not only leave him with physical wounds but has also left him bankrupt.

Gul said since the incident, he has not been able to go out and conduct his business as he used to in the past.

It is understood that Gul was admitted in a hospital for about two weeks after the incident which left

him with 20 stitches on the head. Although he is now out of hospi-

tal, Gul said doctors have informed him that he needs to undergo an intensive operation on his head, something which requires him to be transferred to a major hospital in South Africa.

Fluent

The Pakistani man who speaks fluent English in an Asian accent says that his stay in hospital has cost him a lot of money as he could not operate his shop at Mpolonjeni. He alleged that he was now struggling even to support his family due to the financial constraints he is faced with.

On another note, Gul said that the release of the accused persons from custody has also brought him and

his family a lot of fear. He alleged that he is now scared of even walking out of his house as he believes that his assailants will be back to attack him again. Gul alleges that his assailants are capable of launching another attack to finish him off.

Promise

"As far as I know my assailants, they can attack me again at any time to fulfill their promise to kill me," said Gul. He stated that currently, he is compelled to take his family with him whenever he visits the hospital for further examination and treatment. Meanwhile, Gul disclosed that he was currently working on his travel documents so that he could be taken to a hospital in South Africa before the end of this

MAN (23) FINED E8 000 FOR SEX WITH 15-YEAR-OLD

A man from Emvakwelitje has pleaded guilty and has been convicted for having unlawful, unprotected sex with a 15-yearold minor.

The man had allegedly been in a 'romantic relationship' with the minor since 2013, when she was 12-years-old and he was aged 20 then.

The mother of the minor was called in as witness for the prosecution and she said she discovered sexual relations between her daughter and the accused in 2013.

After the discovery, a meeting was called between the families of the accused and the minor.

It is said an agreement was reached that no charges would be brought against the accused on condition that the relationship between the accused and minor ended.

Minor

However, this year, the parents of the minor were informed by the principal of the school which she attended that she had not attended school for two days, and because she had not returned home the previous day her parents reported her missing.

A tip-off from a neighbour of the accused led police to the home of the accused.

The accused told the police that the minor had been in his house on the previous day and night but had left for school in the morning.

He told the parents of the minor that she did not return home the previous day because she was afraid that she was going to get home after curfew and get punished by her parents.

Further questioning however led the witness to reveal that the minor was infact at a nearby sawmill.

After police located the young girl at the mill she was taken to doctors for examination.

The subsequent medical report was given as evidence and it confirmed that the minor had recently had sexual intercourse and she had an active sex life.

The accused offered no argument and disputed nothing.

In his testimony he only asked that the court consider that he did not force himself on the minor, he said that she had consented

Magistrate Philisiwe Simelane however dismissed this.

"This is no defence as minors cannot lawfully consent to sexual activities of any sort," she said. The man was convicted and

found guilty as per his plea. Mitigation

The man chose to offer no mitigation. Magistrate Simelane informed the man that the court had a duty to pass a sentence that would not only deter him but other perpetrator as well.

"There are so many like you but these cases often do not get reported. You may not have been caught but you had become so comfortable that you kept this girl overnight and over the next day," the magistrate said. However the magistrate told the accused that she would be lenient for the sake of the accused's mother who had attended every court appearance that her son had made. The man was fined E8 000 and given a three year jail sentence, half of which was to be suspended for three years on condition that he does not repeat this act or any similar offences.

MOYENI HIGH PUPIL (16) COMMITS SUICIDE

WHILE pupils at Moyeni High school are still recovering from the shock of losing one of their colleagues last month, a 16-year-old Form Two pupil from the same school has committed suicide by hanging herself from a tree on Saturday morning.

Information gathered is that Zodwa Dlamini* (not her real name) hanged herself in front of other children who thought she was just playing.

Sources close to the matter said the deceased went to fetch firewood in the morning with her neighbour's children and she showed no signs nor

reported that something was bugging her. It is understood that her uncle who is a police officer left them home alone with two other children and she was the oldest. Information gathered is that the deceased told her peers that she would commit suicide and when they asked her why she told them that she would tell them when she comes back.

Response

Having heard that response the children thought the deceased was joking. It is said the children continued playing and realised later on that the deceased was hanging from a nearby tree. A young child is said to have raised an alarm and ran to a nearby homestead for help. It was alleged that the girl who is 16 years old has

been stating that ever since her parents passed away she has not been herself and that it was better to die because she doesn't see a reason to live anymore.

Altercation

It is said on the day of the incident the pupil had an altercation with a family member and she didn't take kindly to it.

When contacted about the incident Chief Police Information and Communications Officer Assistant Superintended Khulani Mamba stated that police were aware of the incident and they are investigating the matter. Mamba stated that it could not be ascertained why the child who is 16 years old decided to take her own life. ments or the first

MAN JUST DOESN'T WANT TO PAY MORE FOR MAINTENANCE

MBABANE Magistrate Sifiso Vilakati had to explain to a man appearing before him for failure to make monthly maintenance uons what the money was to be used for and why it is important that he make his contribution.

The applicant in the case requested a monthly contribution of E400 for the maintenance of one child whom she had parented along with the respondent. When asked to offer an amount which he might be able to contribute on a monthly basis, the respondent told the court that he could offer only E250 to which the applicant scoffed, telling Magistrate Vilakati that this amount could not provide for her child's needs. The respondent then told the court that he does not

understand why so much money was needed. The Magistrate instructed the applicant to tell the respondent what the money was to be used for. An elementary list of food, toiletries and clothes followed before Magistrate Vilakati told the man that all this was for his child's wellbeing.

Pay

The court then heard from the applicant that the respondent had told her (the applicant) that he had not impregnated her at the department of social welfare and therefore did not see reason to pay any money at the fore mentioned department.

An outraged Magistrate Vilakati ordered the man to contribute E400 monthly and informed him that he would have to pay this contribution at the department of social welfare whether he likes it

MAN FORCED TO USE NEW CAR AS SURETY

A man who had just bought a new car had his celebrations 'aborted prematurely' as police busted him for driving (his new vehicle under) the influence of alcohol.

Osborne Maziya was charged with two counts of violating the Road Traffic Act No. 6 of 2007.

On the first count, he was driving the car under the influence of alcohol. He committed the act on Saturday and was driving a Toyota motor vehicle which was registered ISD 539 AS.

He was caught at or near the headquarters of the Swaziland Electricity Company (SEC) in Mbabane.

On the second count, he was accused of driving a car that was unroadworthy.

It was unroadworthy in the sense that it had no number plates both in front and behind.

Maziya apologised for doing what he had done.

"I beg the court to be lenient with me in this case. My car had no number plates because I had just come from buying it and I was still going to put on those number plates. Another reason I plead with the court to forgive me is that I cooperated with the police officers

as they were carrying out their duties," Maziya said.

He also said he had taken only a sip of alcohol before driving the car. He said that was proven by the fact that a breathalyser was used several times on him to ascertain whether he had alcohol in his body or not.

Jail

He also told Mbabane Senior Magistrate Phathaphatha Mdluli that he was a bread winner at his home. He told Mdluli that he was willing to be let out of jail yesterday because he was due to appear today at Nhlangano Magistrate's Court for a case related to a piece of land he had bought in Nhlangano.

Another problem, according to Maziya, was that his company was going to be grounded if he was incarcerated yesterday. He said the office keys of his company were with him, so his staff members were going to suffer. He pleaded with the court to allow him to go out to find ways of organising the funds to pay for his sins. He said his business partner was out of the country.

"My business partner is not here and the cheques cannot be cashed when both of us did not sign the cheques. I plead with the court to allow me to find the money to pay the fine," he said.

Mdluli told him to pay a fine of E1 500 or spend 15 months behind bars. On the second count, he was to pay E500 fine or spend three months behind bars. Mdluli allowed him to use the car as surety as he was looking for money to pay his fines.

EX-DPM'S FAMILY CONFLICT CASE SHELVED

The family has made several trips to Ludzidzini in the company of KaGwegwe inner council and it was believed had this month's meeting materialised, a final verdict would have been issued by the Ludzidzini authorities.

Vusweni indvuna continues work despite RA's advise

VUSWENI Chiefdom Indvuna Reggie Lukhele says he will continue executing his duties despite that he is not recognised by the office of the Shiselweni Regional Administrator (RA).

Lukhele said he would continue executing his duties until he was otherwise instructed by the elders of the area, the he would stop.

"I am answerable only to those

who appointed me to this position, and these are 'bantfwabenkhosi' of Vusweni. Anyone who has a problem with me regarding this position should approach them," said Lukhele.

Lukhele said he was not interested in delving much into the matter as there were more important issues he wanted to tackle which included working on a development plan.

Action

He said he would make sure that Vusweni remained a respected chiefdom. "We have a plan of action which also includes having offices within the royal kraal, so as to have records and other information that we feel can be useful to people," said Lukhele.

Lukhele said residents in the area were aware of the programmes that would bring about development in the area. He said for some plans to succeed, it has been agreed that residents should make some contributions. He said there was a certain amount of money collected from homesteads towards some of the projects that would be carried out in the area.

Projects

"We are presently raising funds for some of these projects. Residents are cooperating and keen to see all our developmental plans materialize. There are to be sports facilities and we are targeting to have a soccer stadium build just close to the constituency (Maseyisini)," said Lukhele.

Lukhele said youth should be considered on anything done in the area and should be encouraged to participate in all activities at *umphakatsi* level.

Advised


The magistrate then advised fathers that maintenance was simple.

OVER 2 000 PEOPLE AFFECTED BY WATER SHORTAGE UNDER ZOMBODZE EMUVA

FOR some areas under Zombodze Emuva constituency water scarcity has been a problem for over 40 years or even more.

People from areas such as Edwaleni, Thunzini, Mahosha, Eqinisweni, Hhotela as well as Mpandeni draw water from wells and a few surrounding dams which also share water with livestock. Though the water is not as clean it remains the only reliable source.

Bucopho of Engwanyameni, which is chiefdom under the same constituency, Vusi Mkhwanazi said water scarcity in the area had delayed progress and development.


He said what was saddening was that other neighbouring constituencies had realized much better development and had access to clean water.

He said as the country wanted to attain first world status by 2022, they were hopeful that the situation under Zombodze Emuva, especially of water scarcity, would be sorted sooner.

Mkhwanazi said it was time donors or government came to the rescue of the communities and saw how they could be bailed out of this problem.

He said under his chiefdom they had a total of over 2 000 people, affected by water scarcity.

"I was born nearly 40 years ago

and in all these years, water has been a problem here. Only a few homesteads have boreholes but some families have to make other means so that they get water and the only alternatives are the river sources. At times these sources run dry and it is then, that residents have to walk long distances in search of water," said Mkhwanazi.

Mkhwanzi said surrounding schools were also affected by the water scarcity and this impacted badly on academic performances.

"At times you find long queues where residents line up for water to be drawn from a well or any of the existing water sources. It takes almost 30 minutes to fill up one 20 litre container of water.

Some spend the whole day queuing and others, at times, are forced to return home empty handed. Others then resort to camping next to the well and this places their lives in danger," said Mkhwanazi.

Mkhwanazi made a special appeal to anyone including donors or government to assist them address the water shortage.

"We have elderly people who have no one to assist them to get the water from those faraway places. It's only people with transport who are better off where there is clean water," said Mkhwanazi.

Engwanyameni homesteads need power (Inthere hos to be a way)

SOME homesteads at Engwanyameni chiefdom under Zombodze Emuva constituency are not powered by electricity as they cannot afford to raise money required for an electricity scheme.

"This area has few electricity scheme projects that have succeeded. Right now, we are busy working on a plan on how we can go about assisting some of these families as some have genuine excuses.

There has to be a way of assisting needy people in our society as it's not a good thing to neglect them when such services are brought into communities," Engwanyameni Bucopho Vusi Mkhwanazi said. Mkhwanazi said even the Swaziland Electricity Company (SEC) needs to be considerate when working on an electricity scheme in a rural community.

"It's time that there should be a special fund either from government which has to cater for all the services such as electricity supply for elderly and orphans or any of the people disadvantaged in one way or the other.

We have people with disabilities, they can't afford raising money and therefore this special fund can be used when there are projects that require one to pay," said Mkhwanazi.

He also lamented on the hike in electricity, adding that some homesteads preferred using candles or lamps. Meanwhile, Mkhwanazi said some projects were delayed by residents who could not afford to pay the contribution that each homestead must pay.

Luvelo Association caterer means serious business

MEMBERSHIP of Luvelo Association formed by Vusi Mkhwanazi who is bucopho of Engwanyameni under Zombodze Emuva has increased to 110 peo-

When the association was formed in 2013, it only had five members. The association was formed to assist in the community during social gatherings such as funerals, weddings or any other activity where a helping hand is needed. Mkhwanazi said the association has been growing, not only in terms of membership, but also its assets.

Costs

He said as an association the main focus was to assist during funerals where bereaved family received E500 to use, to meet some of the costs and expenses.

"The objectives when we formed Luvelo Association, we initially thought we were to concentrate on funerals, as we were touched each time how a family would love its beloved one, where others were unable meet all the expenses that come with such painful experience.

The E500 is raised through the E5 each member contributes each month," said Mkhwanazi.

Mkhwanazi said apart from the money that a family receives during a funeral, the association also assists with things like three legged pots, used to prepare meals for mourners.

Funerals

"We all know that funerals are now not different from other social gatherings, where people don't expect to be hungry. It is not something we encourage whereby funerals become parties. As Luvelo Association, we feel touched when a family does not have a pot to boil water: for tea or other things, hence we provide the pots," said Mkhwanazi.

Mkhwanazi said the association also rented out pots to anyone, even if it was not someone from the area in need of pots.

"We have people coming to hire what we have, in terms of assets. The size 25 three legged pots are now hired by residents for any other family event. It's just E5 per pot to hire it," said Mkhwanazi.

Mkhwanazi said the association would soon have a tent and furniture which would also be used during events in the area.

"We already have the idea of the tent we need and it's just a matter of having people fetch it from South Africa, as the money is already available. Our plan is to have a marquee in future," said Mkhwanazi. He said Luvelo Association's future is bright and soon it would spread its wings to the other chiefdoms, if not, all over the region. "It is also our plan to spread awereness throughout the Kingdom. It is in our plan that we have a catering company as part of our wing. We have big plans as an association and we have realised that there is demand for what we are doing and the demands seemed to be growing as we find ourselves unable to meet some of what people require, hence we now have to broaden the scope time we plan. We have to think out of the box in order for us, as an association, to be able to meet all the expectations from the people," said Mkhwanazi.

Widowers need urgent help

TWO men, including an elderly man who is in his late 80s are living a painful life as they do not have anyone to cater for their needs.

Nyambo Mtsetfwa and Steven Simelane are both widowers from Siyendle near Gege. Bucopho of the Mjikijelweni/Siyendle Chiefdom Mfaniseni Stan Vilakati said the two were living a miserable life and anything could happen to them if they don't get urgent help.

"Mtsetfwa who I believe is around 80 years old lost his wife many years ago. What he considers his house is not different from a pigsty. His shack is on the verge of collapsing and one just wonders how he has been coping, as he has been living in this poor condition for years now. Sicela tinini te-Nkhosi mane tisite ungakafi lomuntfu lomdzala," said Vilakati.

Vilakati who has served for many terms as bucopho in the area mentioned that the old man also needed food.

He said, what he was made to understand was Mtsetfwa had a son who was still alive but lived in South Africa. He said the old man has been living in abject poverty for many years.

"I understand his son is in SA and as to why he is not taking care of him, I do not know.

The old man is dying and as a community, I feel we should be doing something. He also needs food but the priority is accommodation. If we can have someone to at least build him a proper and decent house. My concern is the shack he is living in because during bad weather, the situation is bad. This is not different from torture," said Vilakati. He added another man who also needed attention was Steven Simelane, a widower who is in his late 50s. "Simelane also lost his wife and just like Mtsetfwa, his house is a shack and could bury him anytime. The worse thing with Simelane is that he now looks mentally challenged. We may not be experts in identifying the symptoms of a mentally challenged person, but Simelane's behavior has changed completely. He goes around picking bones and boils them as the only thing he could have as a meal. I think it all started when he lost his wife and then his children left him alone," said Vilakati.

Vilakati said the two needed urgent help and requested the public to come to their rescue.

"Yindzaleyo kuwo wonkhe wonkhe longasita," said Vilakati. Anyone willing to assist anyhow, Vilakati can be contacted on cellphone number 7632 6941.

SOME residents in drought-stricken areas around Matsanjeni will soon have access to clean water as an organisation known as 'Water Thirst' from overseas is currently installing boreholes in that part of the country.

Close to 600 homesteads from two areas will benefit from the project.

These areas include Mgamudze, which is situated at the Kwaluseni chiefdom and Gudla near Qomintaba.

Member of Parliament (MP) Sikiza Mhlungu said the organisation had come to the rescue of the two communities as they had experienced water scarcity.

He said as the drought worsened, residents had to travel long distances to fetch water.

Assess

"A Swazi, who is a coordinator of the programme, came to assess the situation and realised that it was dire.

We were advised to make a formal application and it did not take long as Water Thirst considered our request.

"The coordinator was instrumental in bringing the organisation here.

Work

"As we are speaking, we are hard at work drilling the borehole at Mgamudze," said MP Mhlungu.

The MP said it would take just a few days to complete the borehole, adding that it was expected that the community would start drinking and using the water anytime next week.

"Work had to be finished in a short space of time, we

are done at Mgamudze and we will proceed to Gudla at Oomintaba, where we are expected to finish drilling the borehole and its installation in a couple of days. In these two areas, close to 600 homesteads will have access to clean water, courtesy of Water Thirst," said the MP.

The MP said it was pleasing to have such organisations from overseas coming to the country to assist rural communities



Innovation means identifying new ways and means of providing service in order to better meet the needs of the people.

Innovation refers to a new idea, more effective device or process. Innovation can be viewed as the application of better solutions that meet new requirements, unarticulated needs or existing market needs. This is accomplished through more effective products, processes, services, technologies or ideas that are readily available to markets, governments and society. WHEN GRACE CHANGES THE RULES-PART 1

THEOLOGIANS have generally concluded that the man who lived the longest on the earth was a man called Methusela, who according to Genesis 5:27, lived a total of 969 years and then died.

However, I dare to differ as there is a man whom I believe lived longer than Methusela. The book says in Genesis 5:21 -24 Enoch lived for 65 years and he begat Methusela. Then he continued living for 300 years walking and communicating with God. After living for 365 years, Enoch disappeared because God took him away. Notice that he didn't die but God took him away. Meaning that wherever he is right now, he is still alive and that means that he has lived longer than anyone as his life continues even today.

However, we mark our yearly

calendar according to the years that Enoch spent on earth as he spent 365 years before being raptured. Those who are sophisticated as well as scientists say our calendar year is 365 and a quarter days. Therefore someone may ask where does the quarter come from? The quarter was added in Joshua 10 verse 12, when he prayed or rather by faith commanded the sun to stand still until they had killed all their enemies.

As we begin this subject, I feel it is imperative for us to understand the word Grace which in scripture is often times referred to as favour. Grace or favour is a kind act by God because of His LOVE, AFFECTION and REMEMBERENCE, which brings about preferential treatment. One day of favour is better than a thousand years of labour. He offers us forgiveness (Hebrews 8:12; Ephesians 1:7), reconciliation (Colossians 1:19-20), abundant life (John 10:10), eternal treasure (Luke 12:33), His Holy Spirit (Luke 11:13) and a place in heaven with Him some day (John 3:16-18) when we accept His offer and place our faith in His sacrifice.

Grace means God has chosen someone who didn't deserve to be chosen in the first place. God said that the days of man shall be 120 years, but Noah lived 950 years. The reason why Noah lived so much longer than what God had proclaimed, is a reflection of God's grace. Mercy says 'No' to those things that are meant to destroy you, but grace says 'Yes' to those meant to uplift you.

When you experience the grace of God, it's in times when you can't afford to get your hair done in the hair salon. Sometimes you need to undo your hairpieces, wash them and put them back on your head in a different style. People who look at you will compliment your hairstyle because it looks new, but in your heart you know it's nothing but grace. Grace changes rules, regulations and laws just to accommodate you. Favour can open doors for you that others didn't want to see you walk through. Grace turns curses into blessings.

The Bible teaches us about Noah who experienced the grace of God first hand. The sinfulness of mankind had angered God so much that He made a very difficult decision of having to destroy the very human race that He'd created in His own image. It's as if God wanted to start all over, meaning that He had opted for destroying the entire population of the earth and creating a new generation of mankind.

However, God could not destroy everybody because Noah found grace in the sight of the Lord. Though evil has encompassed the whole world, grace prevented God from destroying the innocent together with the guilty. Because Noah feared God and served Him in righteousness, was not the only one saved from the flood. The grace of God overflowed to the members of his family. In the next couple of weeks we will discover approximately 10 things that Noah experienced in his life because of the grace of God, which changed the rules for him.

Better maternal care in Africa can save women

EVERY year just over 500 000 women die from complications in pregnancy and childbirth across the world. Another 20 million experience severe complications.

But many of these complications are entirely avoidable – including obstructed and protracted labour and one of its sideeffects, obstetric fistula.

An obstetric fistula is a hole in the birth canal between the vagina and the rectum or between the vagina and the bladder that is largely caused by obstructed and prolonged labour. This can occur when the mother's pelvis is too small or the baby is too large.

In sub-Saharan Africa for every 100 000 deliveries there are about 124 women who suffer an obstetric fistula in a rural area.

Obstetric fistulas predominantly happen when women do not have access to quality emergency obstetric-care services. Antenatal care could help identify potential problems early but will not have an impact if there is no skilled surgeon to assist with the labour. Although skilled attendants are necessary, it is the emergency obstetric surgeon who is needed to successfully remove the foetus and save both the baby and mother's life.

A developing world problem

Obstetric fistulas are more com-



monly reported in developing countries, including South Africa. But it is predominantly localised to the "fistula belt" – an area spanning the northern half of sub-Saharan Africa from Mauritania to Eritrea, and the Middle East and Asia's developing countries.

About two million women suffer obstetric fistulas worldwide. But most are concentrated in the fistula belt, where more than 6,000 new cases are reported each year. For example, in Ethiopia it is estimated that 9,000 women develop a fistula each year, of which only 1,200 are treated. A fistula forms when, during prolonged labour contractions, the foetus constantly pushes against the mother's unyielding pelvic bones. The effect leads to the compression of the blood vessels, which decreases blood

flow to this area and deprives the tissue of nutrients.

As a result, it weakens the tissue and a hole forms. The baby is unlikely to survive – and if the mother survives and the fistula is not repaired, she is left with both psychological and physiological scarring.

In some cases, a woman may experience labour for up to a week. Globally, more than 75% of women with fistulas have endured labour that lasted three days or more.

For most women who live in the developed world, obstetric fistulas are uncommon and are usually promptly repaired. This is primarily due to emergency obstetric care that is readily available.

But women who survive the excruciating ordeal of obstructed

labour and develop an obstetric fistula in impoverished countries are often doomed to a life of absolute misery.

From a physiological perspective, they suffer from uncontrollable leaking of urine and faeces and are unlikely to bear more children. The psychological suffering stems from often being rejected by their husbands, shamed and socially segregated and ultimately divorced, demoralised and excluded from their family and religious activities. They also face a high risk of worsening poverty and malnutrition.

Obstructed labour is preventable

In principle, obstetric fistula can be avoided by:

 delaying the age of first pregnancies;

 removing harmful traditional practices such as child marriages and female genital mutilation;

 providing access to obstetric medical care with suitably trained surgeons.

In many instances, young girls do not have pelvises fully developed for childbirth. According to the World Health Organisation, more than 25% of the patients with fistula in Ethiopia and Nigeria, for example, became pregnant before the age of 15.

LESSONS FROM SA ON WHY GENDER MATTERS IN SOCIAL WELFARE POLICIES

THE question of gender equality, in social welfare policies, is a topic that remains under-'developed' in social welfare policy development in the Global South.

This is true even though it continued to receive attention in the North.

Gender equality features in various United Nations platforms of action, including the Millennium Development Goals. But these have been criticised for their narrow focus on health and education outcomes for women and girls while remaining silent on the unpaid care work of women in social and economic develop-

The 2015 Sustainable Development Goals do give greater weight to gender equality. But how countries will execute the goals, remains a key challenge. The paths of welfare, economic and gender-equality development seldom cross. This may be because scholars and practitioners come from different disciplines professions and theoretical perspectives.

This has resulted in the gendered nature of social welfare theories and policies remaining hidden, invisible and taken for granted.

This is particularly true in a development context. It is therefore timely to debate how we might think about a more gendersensitive and equitable welfare agenda in the South.

The South African case is useful as it is one of the few countries that has explicitly adopted the developmental approach to social welfare.

Two issues provide context of how successful, or not, this has been in practice. The first is gender and care in the country's welfare regime. The second is gender issues in social protection.

The invisible world of caregivers

South Africa's welfare policies were substantially reviewed at the end of apartheid. Nevertheless the overarching pol-

icy framework, set by the White Paper on Welfare, was criticised for not locating care - that is, the right to receive and give care, and to be supported by various actors, including the state, in meeting people's care needs - within a

social rights framework. There has been a shift in social policy thinking by feminists away from an emphasis only on gender discrimination towards the more equal distribution of care responsibilities in society, including greater public support for care services delivered by women in the home. Care services are viewed as a public good, a social investment in current and future social well-being.

Care work refers to physical care such as house work, cleaning, and feeding and bathing a

child or a sick older person. It is also about providing emotional care and social support.

Women bear the greatest personal cost of care. A woman with care responsibilities is often not able to be employed. She may experience social isolation, expend emotional resources and may forfeit opportunities for education, engagement in livelihood activities and wider social partici-

This situation is worsened by a lack of access to basic services such as water, sanitation, electricity and transport, and could increase the time and physical work of caring.

These factors can increase the cost of caregiving in time, physical energy consumed and hidden financial costs that caregivers and their families and households have to bear.

Moreover, this unpaid care work is not factored into the calculation of the gross domestic product (GDP). As such, it is taken for granted and remains invisible to policymakers and planners. Debbie Budlender, a prominent South African researcher, estimated unpaid care work in South Africa to range between 11% and 30% of the GDP. Women spent three times more time on unpaid care work than men. Similarly, gender norms undergird paid care work in the social service or caring professions. Social workers employed in non-profit organisations (NPOs) earn significantly lower salaries than those in the public sector. This is so, despite the fact that NPOs deliver the bulk of welfare facilities and services, and end up subsidising the government. Welfare services and development programmes 175 remain underfunded.

Nominal increases are budgeted for over the next three years and will not reduce the backlog at a time when the demand for services has increased due to a lack of jobs, high food prices and overall economic decline. Although the government's National Development Plan 2030 proposed a complementary role for NPOs in the delivery of welfare services, it says little about

how this is to be done and neither does it have anything to say about the gendered nature of welfare services.

Gender and social protection

South Africa is considered a leader for its expansive social protection (grants) programme in the Global South. Despite negative views about such grants, positive outcomes are achieved in reducing poverty and inequality, with particular benefits for women.

The design of the country's child support grant shifted away from the European and British welfare-state models - where public support was contingent on the loss of earnings of the male breadwinner and tacitly supported the marriage-based nuclear family.

The child support grant policy recognised that the primary caregiver of a child could be either a male or female, and be a biological relative of the child or not.

It took into account the large numbers of children who lived apart from their biological parents and anticipated the possibility of increasing care burdens on women and families due to the HIV/AIDS epidemic.

The child support grant represents some degree of public responsibility for child care in disadvantaged families, even though the monetary value of the grant is small.

Despite access to the grant being gender neutral, most beneficiaries are women. Our research at the Centre for Social Development in Africa shows that the grant increases women's financial and decision-making powers, which benefits both women and children.

Towards a fairer welfare dispensation

Care is crucial to social and economic development. But the gendered nature of welfare and care regimes is seldom interrogated. Unless countries in the South grapple with finding ways to redistribute care responsibilities in more equitable ways, women will continue to pay the

price of social reproduction in the home, the family, community and society at large.

The solutions are not easy, as families will continue to remain the main providers of care. Innovative solutions might be found in the provision of infrastructure support. This could be through the delivery of basic services to ease the burden of care such as water, electricity, sanitation, housing and transport costs.

The burden of care could also be eased through finding creative ways of expanding access to child-care services and supporting households to boost their income-earning capacity, such as support for livelihood strategies and combining cash transfers with other supportive family and household-level interventions.

A further trend points in the direction of rethinking cash transfers to be more gender transformative in design, implementation and in the monitoring and evaluation of outcomes. South Africa's child support grant achieves this to some extent, but there are limitations, such as the fact that few men take up the grant and, where they do, we do not know what the gender dynamics are. Research shows that money channelled via women is more likely to benefit child well-being.

We do not know whether the same outcomes apply when men are the beneficiaries. Much of the policy thinking is beginning to shift to understanding how a package of social and economic policies might work together to achieve more gender-equitable outcomes that could also move beyond income.

Simply put, for social protection to be transformative, it needs to be gender transformative, and move beyond fulfilling women's rights and working for onedimensional notions of equality. Transformative social protection policies might be able to move society further along the road towards genuine social justice for all members of society.

GOVT COMMITTED TO CAADP PRINCIPLES - PM

DESPITE failing to meet the 10 percent agriculture budget allocation stipulated by the Comprehensive Africa Agriculture Development Programme (CAADP), Prime Minister Sibusiso Dlamini says government is committed to the principles of the CAADP.

"Though a number of governments, including our own, struggle to meet that 10 percent budgetary allocation, I do however see serious commitment to meeting those targets," he said.

The prime minister was speaking during the official opening of the Southern Africa Confederation of Agricultural Unions (SACAU) annual policy conference and annual general meeting held at the Royal Swazi Convention Centre at Ezulwini yesterday.

In March 2010, Swaziland signed the CAADP, through which the country committed to the CAADP principles which included reducing poverty and hunger by half, pursuing a six percent average annual agriculture sector growth rate at national level, and allocating at least 10 percent of the national budget for the agricultural sector.

However, the Swazi government had failed for the past eight years to meet the required 10 percent budget allocation.

During the 2014/15 financial year, E541 million was allocated to the agriculture sector and during the 2015/16 financial year the

allocation decreased to E537 mil-

Minister of Finance Martin
Dlamini tabled a E20.6 billion
budget in the August house in
March 2016 and the ministry of
agriculture had a share of about
E843 million, an improvement of
only about E306 million to that
of the previous year which stood
at E537 million.

Dlamini further praised the role of SACAU in its efforts to lobby farmer organisations which were its members.

Aware

He said he was well aware of the significant advocacy role that SACAU, together with its affiliates, play at national, regional, and international levels.

"This annual policy not only provides an advocacy platform

for farmers to be heard, but also demonstrates the commitment of farmer organisations, by investing their own time and resources to support their governments in addressing the poverty and food insecurity challenges that affect our countries," he said.

The prime minister further urged farmers to look at commercial agriculture as a vehicle for poverty alleviation in the country.

Examine

"As you examine the potential strategies for enhancing your agricultural sectors please embrace the transformation in the agriculture sector that requires a shift from subsistence-oriented production towards more specialised and market-driven production; effectively shifting from subsistence to commercial farm-

ing" he said.

He said the importance of the agricultural sector was not only important in terms of food security, but also its contribution to the economy.

"Agriculture remains, for all of us here, of huge importance to feeding our respective peoples and is, in itself, an economic sector of considerable importance," he said. The premier concluded by welcoming the delegates of the conference who had come from different countries in the Southern Africa region to talk about issues affecting farmers.

"It is impressive that we have, here, no fewer than 120 delegates from 12 different countries and 17 farmer organisations in the Southern African region of our continent," he said.

Allow

"Further allow me to thank our own farmer organisation, the Swaziland National Agricultural Union (SNAU), for representing the interest of Swazi farmers so effectively, at both national level and regional level, and establishing the credibility and approval that has allowed this conference to be brought to the kingdom of Swaziland," he said.

He said he was looking forward to receiving a copy of the policy, since it would be a valuable guidance for policy decisions of the country.

"It is my privilege, on behalf of His Majesty's Government, to declare the 2016 annual policy conference and annual general meeting for SACAU officially open," he concluded.

Stefanutti Stocks Group profit at E392 million

REGARDLESS of a challenging trading environment, Stefanutti Stocks, the Group produced a reasonable performance this financial year.

In a statement, the Group Chief Executive Officer Willie Meyburgh said despite the challenging environment they were satisfied with the overall performance of the group.

"We are satisfied with the overall performance of the group. given the circumstances, and while the South African construction market remains challenging and competition for available work continues to escalate, we have managed to maintain the order book in most of our divisions," he said.

Responsible

The group's current order book is E12.7-billion with 38 percent of the total comprising work from outside of South Africa and this amounted to E4.8 billion.

In Swaziland, the group subsidiary is part of the Kiss Joint Venture responsible for the International Convention Centre and Five Star Hotel (ICCFSH). Tough

Meyburgh said in spite of the tough environment, the group is of the view that there is potential growth in certain sectors of the economy, providing opportunities for the roads and earthworks, building, oil and gas and electrical and instrumentation operations

He said in other sectors, the group remained well positioned to take advantage of the medium-

sized projects coming to the local marketplace. Though the contract revenue decreased by E900 million to E9.7 billion, primarily due to a reduction in revenue from the building business, the group's operating profit increased from E335 million in the previous year to E392 million in the current year.

However, after excluding the profit on sale of the investment property and fair value adjustment, operating profit increased by 10 percent to E370 million, with the corresponding margin improving from 3.2 percent to 3.8 percent.

Water scarcity could cost regions up to 6% of GDP

WATER scarcity, exacerbated by climate change, could cost some regions up to 6 percent of their gross domestic product (GDP), spur migration, and spark conflict, World Bank has reported.

However, the bank said the negative impact of climate change on water could be neutralised with better policy decisions.

"When governments respond to water shortages by boosting efficiency and allocating even 25 percent of water to more highly-valued uses, such as more efficient agricultural practices, losses decline dramatically and for some regions may even vanish," said the World Bank.

Drought

Swaziland is also one of the countries facing the far worst drought, compared to previous occurrences. Having lost over 44 200 cattle since January 2015, a projected shortage of about 35 000 metric tonnes of maize until the next ploughing season, and the projected E1 billion loss inthe sugar industry, it is beyond any doubt that the country's GDP would substantially decrease.

As the World Bank said, the economy now depends on government's policy decisions.

As a response, government has come up with a National Drought Mitigation and Adaptation Plan to deal with the immediate problems, as well as plan for medium to long term mitigation.

During his budget speech 2016/17, Minister of Finance Martin Dlamini said government has set aside E200 million for continued drought mitigation.

"The funds will be utilised on



food distribution, water distribution to affected areas, drilling boreholes, dredging Hawane Dam, harnessing water from Pholinjane and Mbabane River, prevention of cholera and acute malnutrition, provision of supplementary feed for livestock and the importation of power from Eskom to cater for power shortfall among other interventions," he said.

Engage

Dlamini said government would also engage with the donor community and the private sector to assist the country, as it strived to mitigate the drought.

The World Bank said stronger policies and reforms were needed to cope with deepening climate stresses.

"Policies and investments that can help lead countries to be more water secure and climate-resilient economies include, better planning for water resource allocation, adoption of incentives to increase water efficiency, and investment in infrastructure for more secure water supplies and availability," said the bank.

Beware of shopping spree after home loan approval

CAPE TOWN - Consumers should think twice before taking on any more debt after just having a home loan approved, cautions Shaun Rademeyer, CEO of mortgage originator BetterLife Home Loans.

He warns that the sense of relief and excitement once a home loan has been approved can easily lead to some unwise financial choices, especially among first-time buyers.

In his view, the safest course is for the homebuyer to change as little as possible between the time a loan is approved and the completion of the new home. Steady employment and spending habits will pay off

"For example, it is natural to want to move into your new

home with new curtains, furniture and appliances, but the latest smart-fridge might not be the best choice," says Rademeyer. "Our advice is that borrowers should in fact avoid taking on new credit of any kind at this stage, and especially put off buying anything like a new car or a luxury lounge suite." He explains that, buying a new home offplan, for instance, is a pretty common occurrence in today's property market, but it can mean a long wait between the time that the buyer's home loan application is approved and the time when the loan is formally granted and becomes active. This can pose a real risk for the unwary. During the waiting period, it's also better for borrowers to avoid

or delay changing jobs, in his view. "Career changes can also have an effect on a loan approval, even if they are not negative. You may be offered a better job or a position with bigger bonuses, but lenders are generally looking for stability in your earnings and employment, and will need to be notified if you decide to make a change while waiting for your new home to be completed," explains Rademeyer.

"A loan approval can come completely undone as a result of reckless spending or sudden changes that affect the homebuyer's financial profile, and this could lead to serious problems with the home builder and damage the buyer's credit record for many years."

Diesel faces 61-cent price rise. petrol to go up 39 cents a litre

JOHANNESBURG - The increase is driven by weak rand and stronger international oil prices, the AA

"Motorists have been fortunate in 2016 so far, with lower oil prices buffering the country from the weaker rand. However, oil has now strengthened while the rand continues to decline, with both contributing to the current under-recovery picture," the AA said.

The mid-month data shows



petrol set for an increase of around 39 cents a litre, with stronger oil accounting for around 23 cents of the rise, and the weaker rand contributing 16 cents. Diesel is faring worse, with a 61-cent rise on

the cards, while illuminating araffin is showing a 44 cents a litre increase, the association said. "With oil prices rising steadily, South African fuel users have lost their cushion against the rand's ongoing weakness.

"Our concern over the rand's short-term trajectory is growing; since the start of May, it has depreciated from around R14.20 to the US dollar to its current level of R15.80.

"If oil continues to firm, rand weakness is set to have a severe impact on fuel users," the AA concluded. - TMG Digital

China's blunt warning to America

"We're ready for repeat of Korean War or Vietnam if US military stirs up any conflict in South China Sea"

BEIJING - China has warned the United States not to 'stir up any conflict' in the South China Sea and said it was ready to replay the Korean War or Vietnam if provoked.

Liu Zhenmin, a vice minister in China's Ministry of Foreign Affairs said: 'The Chinese people do not want to have war, so we will be opposed to U.S. if it stirs up any conflict.

"Of course, if the Korean War or Vietnam War are replayed, then we will have to defend ourselves." China has adopted an increasingly aggressive posture in the South China Sea as it seeks to intimidate neighbours Vietnam and the Philippines over the Spratly Islands, which are believed to be at the center of an oilfield.

A tribunal at the Permanent Court of Arbitration in The Hague is expected to rule in the next couple of months on Beijing's claims to 1.4 million square miles of ocean, though China has already rejected those proceedings.

There has also been growing tension with the US and its allies Japan, Taiwan and the Philippines.

Earlier this week the Pentagon claimed two Chinese aircraft intercepted a U.S. EP-3 reconaissance plane near Hainan island in an

'unsafe' manner.

The Chinese denied this, saying their jets kept at 'a safe distance' and did not make any 'dangerous moves'

Zhemin said: "We rely heavily on the South China Sea for transportation of resources and energy and the South China Sea is an important trading group for us.

"We attach great importance to peace and stability in the South China Sea.' He warned the U.S. it 'cannot circle China by building military bases.'

Zhemin said: 'The Chinese people and the government feel like we haven't been treated fairly

because the U.S. is blaming China for rising tensions in the South China Sea.

"What matters is that the U.S. government has recognized that times have changed, and the U.S. can gain much more through cooperation than going to war."

China has the largest standing army in the world - more than two million soldiers - and it has been building up its naval and air capability in recent years.

It has also been building airstrips on disputed islands and atolls in the South China Sea to support its claim on the so-called 'nine-dash line' in the area. Daily Mail

6 dead in pair of nightclub shootings

VERACRUZ - A total of six men were killed early in shootings at two nightclubs in the Gulf coast state of Veracruz, authorities said. The state prosecutor's office said three gunmen opened fire from the deejay's booth at four men sitting at a table in the La Madame club, killing them all. About a dozen people were wounded in that attack in the Veracruz state capital of Xalapa.In the other incident, two men died in a gunfight with law enforcement officers at a club in the Veracruz city of Orizaba, prosecutors said. One of the dead was identified as organised crime figure Luis Alberto Carrera Rodriguez, alias 'El Negro,' or 'Blackie.' Reuters

MH370 kin 'gravely concerned' at impending end of search

SIDNEY - An international network of MH370 next-of-kin said yesterday it was "gravely concerned" that the search for the missing jet could end by August, calling instead for it to be extended and expanded.

The grouping, known as Voice370, appealed to countries involved in the expensive operation, aircraft manufacturer Boeing and the International Civil Aviation Organisation to commit resources to continue the search in the southern Indian Ocean.

"We are gravely concerned about the impending completion of the search in the current targeted area," the group said in a statement to AFP.

"It has always been, and still remains, in everyone's best interest that this plane is found."

Australian Transport Safety Bureau chief Martin Dolan, who is in charge of the search, said last week that deep-sea sonar scanning of a designated 120 000-sq-km (46 332-sq-mile) area was likely to finish by early

In comments to The Australian newspaper, he added there was no indication the search zone

would be enlarged.

The Malaysia Airlines Boeing 777 vanished on March 8, 2014 en route from Kuala Lumpur to Beijing, with 239 people including 152 from China -

The cause of the disappearance of Flight MH370 is still unknown and it remains one of the greatest mysteries in aviation history. Australia, Malaysia and China have said their joint search would likely be abandoned if nothing is found in the current designated zone.

Suspect

Many family members still suspect a cover-up in the mystery and have repeatedly called for the most expensive search operation in history to continue until something is found.

Authorities have said the cost of the search could be up to \$130 million. Five pieces of debris which have been identified as either definitely or probably from the jet have been discovered thousands of kilometres from the search zone - in South Africa, Mozambique, Mauritius and the Reunion island — likely swept there by currents. National Assembly tomorrow to answer several questions. There was a bomb scare in Parliament last Thursday when an unattended bag was spotted by security near the National Council of Provinces.

The suspicious bag led to the police cordoning off the area and calling in the explosives unit. After sniffer dogs and the police found that the bag posed no threat, as it contained clothes, the area was cleared. However, security remains tight around Parliament following the drama of last Tuesday.

ANC chief whip Jackson Mthembu said he welcomed tight measures to prevent any trouble in the House. He said last week it would be a pity if there was "any danger or threat to the lives of Zuma, Ramaphosa or ordinary MPs".

Ramaphosa will be in the Chamber to answer several questions, including on the findings of the public protector that the ANC had abused its position by distributing food parcels in the run-up to the 2009 elections. *Political Bureau*

Zuma to hear if corruption charges will be reinstated

JOHANNESBURG - The charges, relating to a multi-billion dollar arms deal, were dropped in 2009, clearing the way for Zuma to be elected president just weeks later.

The prosecutor justified dropping the charges by saying that tapped phone calls between officials in then-president Thabo Mbeki's administration showed political interference in the case.

But a court last month dismissed the decision to discontinue the charges as "irrational" and said it should be reviewed. Zuma has endured months of criticism and growing calls for him to step down after a series of corruption scandals amid falling economic growth and record unemployment. Pressure on the president would increase if some or all of the 783 charges — which relate to alleged corruption, racketeering, fraud and money

laundering — were reinstated.
"Zuma might remain in office
while any prosecution was going
on, which would undermine his
role as president," Shadrack Gutto,
professor for African Renaissance
Studies at the University of South
Africa (UNISA), told AFP. "Any
charges would add pressure for
him to step aside."

The ruling African National Congress (ANC) party faces tricky local elections in August, but Zuma retains widespread support within the party and has appointed many loyalists to key positions countrywide.

Last month, a commission that Zuma set up cleared all government officials — including himself — of corruption over the 1999 arms deal. He was accused of having accepted bribes from international arms manufacturers.

Standard Bank confirms being target of Japanese fraud syndicate

JOHANNESBUEG - Standard Bank confirmed yesterday it is the South African bank referred to in Japanese reports whose data leak resulted in ¥1.4-billion (R200 million) being stolen from about 1 400 automated teller machines (ATMs) on May 15.

Business Day reported that the bank said in a statement: "The South African banking operations

of Standard Bank Group have been the victim of a sophisticated, co-ordinated fraud incident.

"This involved the withdrawal of cash using a small number of fictitious cards

at various ATMs in Japan. The target of the fraud has been Standard Bank and there has been no financial loss for customers.

"Standard Bank has taken swift action to contain the matter and the gross loss to the bank is estimated at R300-million. This is prior to any potential recoveries that may serve to reduce the loss.

"The relevant authorities have been alerted. Investigations are at a sensitive stage and further information will be provided as appropriate," Standard Bank said.

Japanese newspaper Mainchichi reported on Sunday that Japanese police would work with South African authorities through the International Criminal Police Organisation (Interpol) to look into the major theft, including how credit card information was leaked, the sources said.

The theft at convenience store

ATMs took place on the morning of May 15 in Tokyo and 16 prefectures across the country, and police believe more than 100 people might have co-ordinated

in the unlawful withdrawal, Mainchichi reported.

In each of the approximately 14 000 transactions, the maximum amount of ¥100 000 was withdrawn from ATMs using the fake credit cards, according to the sources.

ATM transaction data suggested that information from 1 600 credit cards issued by a South African bank was used, the sources said.

Motsoeneng alleged that he went to Kunene for advice on his minibus, which had mechanical problems.

"He then told me he knew of a mechanic who could repair the car."

Motsoeneng said he handed the vehicle over to Kunene to take to the mechanic for repairs because of the trust he reposed in him.

NEW DELHI - Hundreds of villagers in India gathered together to mourn the death of an elephant that died after being electrocuted when it wandered into a community looking for something to eat.

People decorated the elephant's body with paints and plants as part of prayers as it was laid to rest and buried in a massive grave on Sunday at Chakrapani village in the Kamrup district of Assam, India.

Local reports claim the massive mammal was killed after coming into contact with one of the community's unauthorized electric wires erected and hidden by the villagers to keep away the wild elephants.

It is understood the Asiatic elephant had strayed near a storehouse where it had attempted to eat some paddy rice when it inadvertently touched the high voltage fence.

An official said that the scarcity of food and the illegal encroachment of forest areas nearby may have forced the wild beast to desperately seek out food in a populated area.

A woman was seen holding an earthen lamp as she offered prayers to the wild Asiatic male elephant lying dead in the village.

Forest officials took measurements of the carcass of the Asiatic elephant before it was buried as other villagers watched.

Nun dies after being shot in South Sudan

KHARTOUM - A Slovakian run working as a nurse in war-torn South Sudan has died after being shot earlier in the week. BUJUMBURA - An African Union human rights report called on Friday for an international police force and more military and rights observers to be sent to troubled Burundi. The AU rights investigators said it was "necessary that, apart from strengthening AU human rights monitors and military

observers, an international police mission is deployed." Last year the AU proposed a 5 000-strong

peacekeeping force but the pan-African

bloc buckled in the face of opposition from Bujumbura. Hundreds have been killed and a quarter of a million people have left Burundi since President Pierre Nkurunziza's controversial decision in April 2015 to run for a third term, . *IOL*.

SA to limit farm sizes

FREE STATE - South Africa's government is planning to impose limits on farm sizes to free up parcels of land to hand over to blacks, a minister said on Saturday, giving an insight into the workings of a divisive redistribution scheme. Gugile Nkwinti, the minister of rural development and land reform, told Reuters the government was planning to set a range of limits - from a 1 000-hectare (2,470-acre) 'small-scale' farm, up to the largest allowed, at 12 000 hectares. If you are a small-scale farm and have 1,400 HA, we will buy the 400, and leave you with your 1 000," the minister said. Reuters.

Police disperse protesters in Kenya

MOMBASA - Kenyan police in the port city of Mombasa fired teargas to disperse hundreds of protesters demonstrating against an electoral oversight body which opposition parties want scrapped, a Reuters witness said. Police in riot gear earlier patrolled the streets while businesses stayed closed for fear of looting, the witness said. About three hundred protesters demonstrated with placards reading "IEBC must go home now", a reference to the Independent Electoral and Boundaries Commission. Another banner read "Democracy on trial. Reuters.

Mugabe tape exposes Grace

HARARE - President Robert Mugabe believes his wife is strong-headed and he does not challenge most of her decisions for the sake of peace at home, a leaked audio recording of a family event has revealed.

The 41-minute long recording was allegedly made at First Lady Grace Mugabe's graduation party on October 14 2014 after she controversially acquired a PhD at the University of Zimbabwe.

The 92-year-old ruler also complained that Grace does not cook for him often enough and regularly changes staff that serve Zimbabwe's ruler since independence.

He said Grace was always busy at her Mazowe orphanage and was hardly at home to cook for him. Part of the recording went viral on social media last week before The Standard obtained the full recording. "She [Grace] is strong-headed," Mugabe is heard saying. "She is someone who if she says I want this, she will not back down and you will have to give in, in order to maintain peace in the family."

The recording was made at a time Grace was making her entry into politics where she has caused headaches for Mugabe. After a few months, the veteran ruler was forced to dump some of his long-time allies such as Joice Mujuru and Didymus Mutasa. This came after Grace organised rallies across the country demanding their ejection from the party and government.

Grace has also been identified as one of the people causing factionalism that is threatening to destroy Zanu PF.

Mugabe also justifies his controversial marriage to Grace in the recording, saying his mother pressured him to have children.

 "My mother wanted to see my child. She said to me, your wife is sick and I want to see your child.

I thought about it and concluded that it was good for my mother to see my child before she dies," he said.

"She saw Omar (Bona) and I think where ever she is, she is happy. That was the reason why I married Grace.

"Sally had been told by doctors that she would die in 10 years; she died as the doctors had rightly seen," Mugabe said. *The Standard*

ZANU-PF warns against corruption

HARARE - ZANU-PF has warned party members that it will not brook corrupt activities among its rank and file and has activated its provincial structures led by chairpersons to fight the scourge.

The crackdown follows a meeting President Mugabe held with provincial party chairpersons and other leaders at State House on Wednesday last week. Addressing a Mashonaland West provincial coordinating committee meeting in Chinhoyi at the weekend, Secretary for Administration Dr Ignatius Chombo said corruption would not be tolerated in the party. "At last week's meeting of (provincial) chairpersons with President Mugabe a. State House on Wednesday, the President talked about something that we think when said to us chairpersons, is a

"President Mugabe pressed on the issue of corruption saying in the provinces where chairpersons work they should seriously look at the issue of corruption as it has the potential of killing the party."

The meeting was held to allow chairpersons to present challenges they face in executing their duties. Dr Chombo, who is also Home Affairs Minister, said the President had also called on the party to adhere to proper disciplinary procedures in dealing with any member accused of wrongdoing. Dr Chombo said his office would soon write to all provinces restating party disciplinary procedures to avoid matters premised on lies and hatred of individuals, which help to weaken the party.

NIGERIAN GOVT MEET UNIONS OVER STRIKE

ABUJA - Labour ministry officials were to meet with representatives of the Nigeria Labour Congress and the Trade Union Congress to discuss the 67 percent hike imposed last week.

Both unions have called for an indefinite strike from Wednesday unless prices are slashed from 145 naira (\$0.73 0.64 euros) to 86.50 naira per litre.

Government offices, airports, sea ports and businesses, including banks, shops and markets, would be shut if talks failed, the unions warned, calling on people to stockpile food.

Any industrial action would exacerbate pressures in Africa's largest economy caused by the global slump in crude prices, which has drastically cut government revenue from oil exports.

Yesterday, Nigeria's National Bureau of Statistics said the inflation rate had risen for the sixth consecutive month to 13.7 percent in April, up from 12.8 percent in March.

Nigeria depends on oil sales for 70 percent of government revenue and the global plunge in oil prices has weakened the naira currency and made foreign exchange scarce.

To make matters worse, junior oil minister Emmanuel Kachikwu said domestic production had fallen from 2.2 million barrels per day because of renewed militant attacks on pipelines and facilities.

"We are basically producing about 1.4 million barrels (per day)," he told parliament in a presentation to explain the petrol price rises. *Citizen*.

Kenya discusses plan to close Somali camp with UN envoys

NAIROBI - Kenya's president showed 'room for discussion' over a decision to shut a refugee camp for Somalis but did not promise to reverse it, a delegation of U.N. Security Council diplomats opposed to any forced closure said after talks on Friday.

Kenya said last week it was drawing up a timetable to shut Dadaab refugee camp, home to about 350,000 Somalis, because of security concerns. The United Nations and Western donors have urged Kenya to rethink and not forcibly return the Somalis.

A delegation of U.N. Security Council diplomats, returning from a visit to Somalia, held talks with Kenyan President Uhuru Kenyatta on Dadaab and other issues, such as the African force battling militants in Somalia, which Kenya contributes to.

Egypt's U.N. ambassador, Abdellattif Aboulatta, said the delegation voiced concern about the Dadaab closure plan.

"The discussion was open. We did not receive any promise. But what we understood was that there was room for discussion about it," he said at a news conference, with Britain's envoy Matthew Rycroft, who was also among diplomats on the trip.



Nonhle involved in car accident

YOUNG gospel star Nonhle Mthethwa and her father Mabandla Mthethwa experienced yet another setback in the form of a car crash on Saturday night.

The Mthethwa family must be on their knees, praying and asking God for divine intervention, following three agonising experiences within a space of a year.

Late last year, they survived a nasty car accident, and then about two weeks ago, they were robbed of their goods and money amounting to about E2 500 while shopping in Nelspruit, South Africa.

Incident

They were involved in another accident over the weekend at Mbadlane during a night trip after the young star's performance in Siteki. This incident occurred at around 10:15pm, after another car bumped into their vehicle from behind. The occupants of the other car were allegedly drunk.

"We were from performing at revivals at Mpolonjeni and just when we joined the highway around Sikhuphe, a white Toyota corolla hit us from behind.

Disappeared

"What made things worse for us is that the occupants jumped out of the car and disappeared into the night after the crash and we were left with more questions than answers," Mthethwa said. Mthethwa, a renowned keyboard player and manager to gospel star Nonhle Mthethwa, said the car accident left the young sensation traumatised. Mthethwa said there were three occupants in their car.

Impact

"My daughter was asleep when the accident happened. The impact was so severe such that the car swerved off the road and we hit the car seats inside, this experience left my daughter traumatised. She was shaking as she could not understand what had just happened," Mthethwa said.

He added that the other car involved in the hit and run, was speeding.

"We had to wait for the police to arrive and explain what happened," he said.

Talking about the disturbing events constantly unfolding in their lives, Mthethwa asked the nation to pray with them as they go through this challenging phase.

Drinking

"We are now left with a cost that amounts to E4 000, to fix the car. We are glad that the long arm of the law got hold of the occupants and it was also discovered that the car was taken without the parent's consent before the drinking spree that ended in a tragedy. We are grateful to God that we are still alive and unhurt," he added.

It also transpired that the driver could not be of any assistance with the costs incurred from the accident, as he did not have money.



BARCELONA - A moment of divine intervention from Lionel Messi seven minutes into extratime helped Barcelona win a draining Spanish Cup final against Sevilla.

Both teams were down to 10 men in the last game of what has been a marathon season when Messi played the pass of the night – dropping the ball 25 yards behind the Sevilla defence and into the path of Jordi Alba who let it bounce once before sending it just inside Sergio Rico's far post.

It was 25 to minutes before midnight and somehow Barcelona – having played much of the game with 10 men after having Javier Mascherano sent off and losing Luis Suarez in tears in the second half to a hamstring tear won the Copa del Rey.

Supreme

There were many heroes. Andres Iniesta was supreme throughout, Gerard Pique had been immense after Mascherano's first-half sending off, and Neymar had come to life in the absence of Suarez and scored a second with almost the last kick of the game. But it was Messi who had the last word on another wonderful season.

There were players in Sevilla's ranks who deserved winners' medals too. Keeper Rico was one of those saving brilliantly at the end from Dani Alves' shot. They had nothing left to give when full-time was blown in the early hours of yesterday morning.

Both these teams came into the game having won important trophies but from the first-half displays it seemed that whereas Sevilla's Europa League win over Liverpool had topped the tank up for them, Barça were back running on empty.

NEW YORK - Sergio Garcia beat Brooks Koepka in a playoff to win the AT&T Byron Nelson despite twice finding the water in his final round.

It capped a poor day for Koepka, who completed his final round in 71, one over par, after three bogeys, including back-to-back dropped shots on the 14th and 15th which left the door open to his rivals as he fell to 15 under. Only Garcia was able to take advantage, however, as the 2004 winner, who was in the lead after the first round, battled his way to a 68 which included four bogeys and six birdies, forcing the play-off.

Patrice Evra signs new deal at Juventus

JUVENTUS - Patrice Evra is set to extend his contract with Juventus until 2018 after announcing that he has reached an agreement with the club - keeping him at the club until he is 37.

The former Manchester United left back has played a crucial role under Massimiliano Allegri since arriving on a free transfer in 2014, winning back-to-back Serie A and Coppa Italia titles.

The 35-year-old's consistent form has seen him retain his place as first-choice left-back for the majority of the campaign, despite the arrival last year of Alex Sandro from Porto for a reported €26million (£20 million)



'Yes, I gave my consent to the club, I'll stay for another two years,' he told La Gazzetta dello Sport after the Coppa Italia final win over AC Milan. Evra has made 35 appearances in all competitions this season, scoring twice, and has been part of a defence that only conceded 20 goals in 38 Serie A games last season. The left-back will be 37 when his extension expires, but his leadership and winning qualities are priceless for Juventus side. *Daily Mail*

Rory McIlroy wins Irish Open

LONDON - Rory McIlroy has targeted a summer of success after producing a stunning finish to win the Dubai Duty Free Irish Open for the first time at The K Club.

McIlroy was in danger of blowing a three-shot lead after 54 holes for the second time this season after Scotland's Russell Knox carded four birdies and an eagle in the first 15 holes of a dramatic final round interrupted twice by hailstorms and torrential rain.

However, the world No 3 then birdied the par-five 16th as Knox three-putted and, after lipping out for birdie on the 17th, fired a stunning approach from 252 yards to within three feet of the hole on the 18th for a closing eagle.

The resulting 69 meant McIlroy finished three shots clear of Knox and Wales' Bradley Dredge to claim the first prize of £515 000, which he will donate to his foundation which hosted the tournament for the second year.

"It means a lot for my summer," said McIlroy, who failed to convert a similar position in the WGC-Cadillac

Championship in March. "It's nice to get that first win of the year," he said

Turkey coach uses phone to complain about England goal

ISTANBUL - Turkey head coach Fatih Terim received a telling-off from the fourth official during his side's friendly with England after appearing to complain about a decision with the use of mobile phone footage.

The bizarre moment occurred during the first half of Sunday evening's game, just minutes after Harry Kane had opened the scoring from an offside position.

Images of the controversial incident quickly circulated on social media, and a member of Turkey's back-room staff appeared to spot the footage on

his phone from the bench.

He passed the mobile device to manager Terim alongside him in the technical area, who immediately leapt up to remonstrate with

the fourth official. Clearly disappointed with the decision to award Kane's opener, the Turkey boss handed the official the phone, who glanced at the screen before trying to confiscate the device. Quickly, the owner of the phone intervened and slipped it back into his pocket. Rules surrounding the use of mobile devices on the bench are a grey area, but this incident appears to be the first of its kind. *Daily Mail*

Murray admits 'embarrassment

PARIS - Andy Murray has responded to insinuations that his on-court behaviour was a major factor in his split with Amelie Mauresmo, and admitted he was sometimes 'embarrassed' by it.

As rain again ruled out any chance of early play at Roland Garros, Murray addressed the implied criticism of his former coach about his demeanour on court.

"It's true, emotions overtake me sometimes on court. I am emotional, I know

that," he admitted in a question and answer session with L'Equipe newspaper.

"Some people say it's positive when I don't show my emotions, when I control them completely.

"Others say the opposite. It's very difficult to place where the truth is. The thing that is most important, is to know whether the fact of being emotional makes me play the points afterwards badly, if that disrupts me.

"I have in the past played matches where I haven't opened my mouth. Shown

nothing. And they were matches that were horrible, lost, flat. You have to find the right balance," he said.

While Murray did not name Mauresmo, he pointed out that since they went their separate ways his focus is much improved, and it has seen him reach the final of the Madrid Open and win the Italian Open.

"In recent weeks I've done some good work on my attitude. I don't think staying completely silent is a good thing for me. I have a need to express myself on the

court. And that means expressing positive emotions, too." Referring to his habit of barking at his support box, something which led Mauresmo to exile herself to the stands at the Miami Open in March, he said: "Sometimes I am embarrassed.

"You have to try to understand that on the court a lot of things are happening to us. The way in which you react is not necessarily linked to what you really think, upon reflection.

MANCHESTER - Jose Mourinho has convinced Zlatan fbrahimovic to join him at Manchester United, according to stunning claims in Holland.

Respected Dutch newspaper De Telegraaf report that Ibrahimovic will join United this summer on a free transfer from Paris St-Germain.

It's said he will start his Old Trafford career as a player before moving into a role as coach under Mourinho.

United have yet to confirm Louis van Gaal's sacking, yet alone Mourinho's arrival to replace him. But De Telegraaf are close to

Ibrahimovic's agent Mino Raiola and the news isn't believed to be idle speculation.

The piece, which was published

this afternoon is headlined "Ibrahimovic to Manchester United".

In it the newspaper claim Zlatan "will be next season wearing the shirt of Manchester United".

The star striker has been linked with a move away from PSG all season with numerous clubs interested but United seem to have won the race according to the sensational report.

De Telegraaf also claim there are plans for Ibrahimovic to become an 'assistant coach' at Old Trafford after his playing career.

They add: "After his active career as a football player he wants to become a trainer. Manchester United is a few years working as assistant coach in the offing." DailyStar

United paid Jose Mourinho £4m to stay away from rivals

LONDON - Jose Mourinho was paid a staggering £4million by Manchester United not to take a job elsewhere while they decided the future of Louis van Gaal.

An agreement was reached midway through the season to give United the option of bringing him in if Van Gaal failed to meet their targets.

Sportsmail can also reveal that Mourinho refused to accept a 'behavioural clause' in his five-year, £75m deal despite concerns among the United hierarchy over his eccentric touchline behaviour.

The 53-year-old was fined £229,900 and received two stadium bans during his two spells at Chelsea and United

are desperate to avoid the negative publicity those incidents generated.

However, Mourinho refused to agree during negotiations in January, highlighting his strong bargaining position as United's season unravelled. Unlike Manchester City's precontract deal with Pep Guardiola, the unique arrangement with Mourinho was merely to ensure he would be available if required.

Had Van Gaal been deemed to have been a success, by whatever criteria United laid down, he would have stayed for the last year of his contract. The deal was first reported by Spanish newspaper El Pais in March.

Jose wants Giggs stay

LONDON - Jose Mourinho retains hope that Ryan Giggs will stay on at Manchester United but his future is shrouded in doubt.

The Portuguese is set to take over from Louis van Gaal this week and has No 2 Rui Faria and goalkeeping coach Silvino Louro primed to join

Mourinho still wants United assistant boss Giggs to stay on at Old Trafford, even though the 42-yearold wants to go it alone in management.

All the talk at Old Trafford yesterday morning among staff was that the Welshman had decided to leave the club.

A source said: "It's all over the place that Giggsy's gone too, which people are more upset about than Van Gaal."

There was no confirmation from United on Giggs's status.

The decision will be left to Giggs, who was the subject of Premier League interest this season.

He came out of Van Gaal's reign with credit among the squad, who were keen for the former winger to be handed a shot at the top job. But executive vice-chairman Ed Woodward opted for Mourinho.

Van Gaal still did not know whether he would be leaving the club on Sunday but was sacked yesterday, and attention will turn to Giggs once Mourinho's appointment is confirmed.

YAYA TO BECOME HIGHEST PAID PLAYER IN FOOTBALL HISTORY?



13 YEARS OF FOOTBALL BEAUTY FLUSHED

IN ONE IMPRACTICAL OCCURRENCE

THE SwaziBank Cup is known to be one of the best cup tournaments the country has ever launched, not necessarily based on figures but they strive to do extremely well and surpass other football competitions to better the tournament in each edition

The 'Bank with a heart' slogan is complementing their substantial deeds, which has facilitated their credibility over the years.

Never in the history of the tournament has there been any inconvenience in as far as administering the tournament is concerned, but all the wonderful work and effort put in for over a decade was flushed down the drain

in the recently ended 13th edition.

It is an obvious norm for a prize presentation to be held after a football tournament, especially of this prestige, where the deserving faction is formally awarded their respective prizes. SwaziBank has never failed to live up to that norm since its launch in 2003, but to many people's surprise, it was a different story this year.

Awardees were made to hand pick their prizes at the Premier League of Swaziland (PLS) offices, fuelling rumours that all is not well in the relations between the financial institution and the football governing body. We cannot run away from the fact that the

cancellation of the presentation has sent tongues wagging and we are all in the dark as to what really happened.

Silence

The bank's MD broke his silence on the matter, pinning the blame on budget considerations with limited time to mull over, but the sound of it is not convincing. It seems as though there is more into it than meets the eye and parties involved are choosing to shove the fluff under the carpet. There is rising speculation that the bank is on the verge of pulling out and ending 13 years of the annual tournament, but we won't dwell much on that because it remains a rumour.

(Could this be one of the signs, no I don't want to believe that). Personally, kungangivisa buhlungu.

It is such a shame to our local football to experience such ugly occurrences and it falters decades of hard work to put up a professional setup in the sport. The initiator of the tournament the late Stanley Matsebula, may his soul rest in peace, is probably looking down in disgrace while his architect is tumbling down.

Fingers are not pointing at anyone (yet they are actually pointing somewhere), but the occurrence is bringing a bad mark to the institution and football at large, ruining the reputation of both. A prize presentation is not only about the awards, but it presents an opportunity for stakeholders of the sponsor to mingle and network.

Evolution

They share ideas while also enhancing each other on relevant issues. Some of them plan prior to the event and get expensive outfits to put on and surely it doesn't go down well with them when such incidents occur. Our football is taken aback just when there were high hopes of evolution. It has been gathered that the money was due Thursday last week, but Simelane failed to live up to promises hence the car dealers turning hideous as they went to report the matter to the

Simelane is said to have sent his wife to the debtors to talk on his behalf after they threatened to repossess the car (a red bakkie) if he fails to pay the outstanding balance.

His wife allegedly pleaded with the car dealers to bear with them until the following day (Friday) and she gave them E1000 at the scene.

According to a reliable source close to the matter, the Highlanders boss' kept his promise and paid the amount the following day.

"He has paid the amount in hard cash through his wife. He paid a total of E5 000 and is still outstanding the remain-

"The car dealers and 'Rubber' are now on talking terms after Simelane kept his promise. It is after yesterday's article that one of the dealers allegedly revealed being related with Simelane (brother in law); therefore, it was not their intention to ridicule him in public. All they wanted was the issue to be resolved outside of the public eye," the reliable source said.

Admitted

"The car dealers admitted that the article was well relayed and they felt you journalists did a wonderful job, but it was pointless to do a follow-up since he has admitted to paying the outstanding amount. There is no story to write since all is settled, the article also ensured that he will always be on the right side of the law since he is a public figure," the reliable source added.

When the car dealer was contacted yesterday they declined to comment further. They pleaded with this reporter not to reveal their identity since the matter has been resolved.

"We do not want to discuss this issue in the public, Simelane has paid us E5000, there is still money pending and we have agreed on when he would settle the outstanding balance," said one of

Efforts to get comments from Simelane were futile as his mobile phone rang unanswered after several attempts were made to reach him.

MANCHESTER -Manchester United have sacked manager Louis van Gaal, Old Trafford according to sources close to Goal maga-

The Dutchman led United to their first FA Cup triumph since 2004 on Saturday, with a 2-1 win over Crystal Palace, though celebrations were quickly overshadowed by speculation regarding Jose Mourinho's imminent arrival. Van Gaal's

two-year reign at Old Trafford proved divisive, with several fans and former players bemused by the Dutchman's playing style having seen United score just 49 league goals this season.

And after Van Gaal arrived at the club's Carrington training ground for work yesterday he was relieved of his duties. The 64-year-old remained cordial throughout the rest of the morning but his backroom staff were seen clearing their desks after being sacked along with the man who brought them to the club in 2014. Executive vicechairman Ed Woodward was also seen on site alongside one of the club's lawyer.

Mourinho has been out of work since he was sacked by Chelsea in December, but is

poised to return at Old Trafford. Van Gaal's departure comes two years after his appointment,
