OUR LIVES MATTER

A journalist of this newspaper, who showed bravery amid a violent situation, was attacked by drunken revellers while going about her duties. Her sin was that she was at the wrong place—a place full drunk revellers who went berserk and destroyed property at the Mhlume Country Club.

This is a cause for concern. In fact, this is unacceptable; but more unacceptable is that a promoter put our journalists' lives at risk-and those of other innocent fun lovers who went to the club looking for entertainment. The culprit here is not those fans who went crazy; or those two men who attacked a female journalist and injured her, even when she had begged for them not to harm her but to delete

the pictures they were concerned with.

This promoter who organised this show, advertised an artist who would not pitch, and knowing fully well that he would not, should be locked behind bars—or made to pay for the damage caused to the club. He must be made to pay for putting the lives of hundreds of people in danger, because if he is not made to do so, he will do it again. Not only that, others too, will take chances and continue to lie to the gullible public that they have suchand-such artist coming for a show when they have not even paid for their services.

This also applies to the group that also let down desperate gospel music lovers on Saturday; the aborted Dr

Tumi show, who was supposed to perform at Esibayeni Lodge. The truth is that these promoters took the public for a ride. They have no right to be advertising events using musicians who have not been paid.

Questions

However, all this said, we need to ask the serious questions of both events. For starters, where were the police on Saturday when the crowd went about in the destructive manner at the Mhlume Club? How were the police not inside the hall, at a packed hall? Surely, they knew of this event, having been advertised? How is it that people were held hostage when there was no security on sight?

Where is the Swaziland National

Council of Arts and Culture when dubious promoters are going to risk our lives like this?

It is also shocking to read the comment attributed to the RSSC, who own the club, and who are seemingly refusing to take responsibility for this mayhem; the club has its own security, has a duty to protect its property and surely, has a duty to protect those who live around the club in case of any danger. How then did it not insist on its own security here? Is this because our lives do not matter? The club can't just fold its hands to promoters hosting events, it needs to insist on security, because this is still in their premises—their venue, their name, and therefore, it has to make sure everything is

considered.

For a company that puts safety and security measures in everything, it is mindboggling how they left this in the hands of one individual—and would not even ensure the police were there.

As for the police, well, they owe our journalist an apology—for she even called 999 when it was clear that there was no one to save the situation inside the Club.

Yet, the National Commissioner can warn the Swaziland National Union of Students about conduct long before they embark on their march. How did this escape his very good attention to

It is uncharacteristic of the police to expose us to such danger.

8 ARRESTED FOR HACKING, **SCALDING MAN WITH BOILING WAT**

EIGHT people from Mangozeni area have been arrested for allegedly hacking and assaulting a man with bush knives and all sorts of weaponry in a gang rival battle.

The assault which saw the complainant Sibusiso Ndlovu being admitted to RFM Hospital in a critical condition is alleged to have been a rather disturbing mob justice incident.

Witnesses alleged that Ndlovu was on of his friends. heavily assaulted with bush knives, It is alleged on this day Ndlovu was stones and sticks and also scalded with hot water on his back before being further paraded on the streets by the mob in front of his girlfriend at Mangozeni area.

The mob of about 15 men is said to have pounced on the victim while at a drinking spot known as KaFakudze in Malkerns. The bone of contention is that Ndlovu once assaulted one of the gang members in the company

spotted by one of the accused while visiting his girlfriend near the drinking spot. Information gathered is that suddenly the people who were drinking at the shebeen were immediately called to where Ndlovu was.

Witnessing

Upon reaching Ndlovu the mob is said to have started assaulting him with bush knives, kicks, fists, stones and sticks all over the body. Information



gathered is that the mob also used boiling water and poured it on Ndlovu's back.

Residents who were witnessing the scene are said to have called the police who quickly came to the scene. The police are said to have found Ndlovu surrounded by the mob lying unconscious in a pool of blood.

Eight people among the mob were

arrested, the accused Lucky Masimula (28), Mandla Maziya (30), Mncedisi Nkambule (28), Lungelo Ncongwane (24), Sandile Hlatjwako (22), Ndumiso Shabalala (25), Mayibongwe Shabangu (25) and Lungelo Zwane (28) appeared before Magistrate Lucia Lukhele at Matsapha Circuit Court yesterday.

They were charged with assault with intent to cause grievous bodily harm. The prosecutor Fakazi Mngomezulu applied that the accused be remanded back into police custody; he informed the court that bail is opposed since the complainant is in a critical condition at RFM Hospital.

The accused were informed to make bail application during their next court appearance which is next week Tuesday.

SwaziMed vs Medscheme:

JUDGE SETS ASIDE INTERIM ORDER

THE High Court of Swaziland delivered its judgment in the marathon case of Swazi Med and Medscheme wherein Swazi Med had approached court on an urgent basis seeking the removal of the Arbitrator and to set aside the interim order issued by the Arbitrator.

The High Court last Friday ruled in favour of SwaziMed following an application by SwaziMed to have Manzini removed as arbitrator in their ongoing arbitration process with Medscheme. They further wanted the court to set aside an order issued by Manzini, wherein Manzini granted an interim order in Medscheme's favour.

The interim order stated that pending the finalisation of the arbitration proceedings between SwaziMed and Medscheme, SwaziMed was interdicted and restrained from cancelling the management agreement between the two parties. According to SwaziMed the order was not interim but definite of the parties' rights and final in nature and as such could not be classified interim.

The order removing Manzini and rescinding his order was granted by Judge Mumsy Dlamini on Friday.

In her judgment Dlamini said Manzini's judgment to grant the interim order as per Medscheme's application was



erroneous in that SwaziMed had already replaced Medscheme's software with one Cana II and Medscheme was no longer dealing with SwaziMed's clients except for payments of 2016 outstanding bills.

"Had the Hon. Arbitrator considered the status quo as so ordered by him on March 21 he would have reached the conclusion that the balance of favour that the status quo pronounced by him on March 21 ought to have been maintained.

The effect of the interim order changed the status quo and therefore it was erroneous to so order," reads the judg-

The judge said the order by Manzini was reversing the current status quo something that could be costly considering that SwaziMed was now doing

most of its administration work. "It would be costly to reverse the status quo by calling upon Medscheme to take over the administration work of SwaziMed when SwaziMed has been doing so prior to April 3 (The day Manzini issued the interim order)," continues the judgment.

The second prayer by SwaziMed was that Manzini recused himself from the case.

Decision

SwaziMed argued that Manzini sits on the Competition Commission Board hence he would be biased towards them as the commission was currently investigating them and he was privy to some information that could inform his decision.

They further argued that when issuing the interim order Manzini showed

bias towards SwaziMed as he had made findings against SwaziMed which disposed of the central issue for determination for arbitration.

In her judgment Dlamini granted SwaziMed their second prayer as she ordered that Manzini recuse himself from the case. In delivering her judgment, Judge Dlamini stated that Hon. Arbitrator ought to have recused himself for failure to disclose that he was a member of the commission seized with a continuing investigation against Swazi Med.

Argued

SWAZI MED had argued at the hearing of the case that the complaint before the Competition Commission was still pending. In her findings, the judge held that "It was common cause that during the hearing of the application for recusal before Hon. Arbitrator that the Hon. Arbitrator was still a member of the Competition Commission. What was raised as an issue was whether the complaint against Swazi Med was still pending before the Competition Commission. Swazi Med asserted that NACES NEWSTREET

it was still pending and investigations against it were ongoing".

"From the above, it is clear that Hon. Arbitrator was of the view that Swazi Med having been investigated, the matter came before the commission where they as members of the board of the commission discharged Swazi Med. In so asserting the Arbitrator relied on a report by the Secretariat which was presented to the Board on 23 January 2015", said the judge.

The order also declined a counter application by Medscheme for an order turning the arbitrator's award into an order of court.

In her judgment, Judge Dlamini emphasizes that her judgment by no means suggests that the management agreement between the two parties has been terminated.

The parties will now have to find a new arbitrator in the matter where the major issue of dispute is the termination of the partnership by SwaziMed where Medscheme was the adminis-

The dispute between the two parties started when SwaziMed informed Medscheme of an intention to terminate their five year renewable contract which dates back to 1980 in a quest to save money.

In her final analysis the judge ordered the removal of Arbitrator Manzini in the arbitration proceedings and also set aside the interim order of April 3,

MPS COMPLAIN OF SBIS, STVA'S CENSORSHIP

THE state broadcasters should serve interests of Swazis because they belong to Swazis and they are funded by Swazis.

This was said by Members of Parliament (MPs) who are members of the portfolio committee of the ministry of information, communication and technology (ICT). The MPs even made an example of the verbal showdown that happened in Parliament on Monday in the House of Assembly. The showdown involved MPs, Prime Minister Dr. Sibusiso Dlamini, and Attorney General (AG) Sifiso Khumalo.

Nkwene MP Sikhumbuzo Dlamini wondered if the SBIS personnel knew if balanced reporting existed, which he said was written in the policies of the national radio station. What made the Nkwene MP complain was that SBIS only broadcast a statement that was made by the prime minister and Buthelezi was never given a forum to respond to the statement on the national radio, yet he was part of the Swazis that funded the radio station.

What was even worse, according to MP Sikhumbuzo, was that the Matsanjeni North legislator was verbally assaulted through the national radio because the statement was repeatedly aired and was aimed at hurting Buthelezi.

Horrible

Motshane MP Phesheya Hlathswayo said it was unfortunate that there was a horrible mandate at the radio station. That horrible mandate was the one that made the people less interested in accessing the state broadcasters.

He wondered how the directors of the broadcasters were going to make people pay for the Swaziland Television Authority (STVA) if it did not serve the needs of the people. People could not tolerate being fed government news every time. This contributed to people not wanting to pay for television licences.

Hlatshwayo urged the leadership of the national radio station to find ways of ensuring that people were not allowed to use the station to assassinate other people's characters. The radio content had become so boring such that people knew what would be broadcast there. The only news that dominated was on police, government, road updates, and weather update that would, in most cases, be the same throughout the day.

Hhukwini MP Saladin Magagula also stated that there was nothing like balanced reporting at SBIS. He also made an example of the Monday verbal showdown that happened in Parliament. The national radio did not broadcast the side of Buthelezi on the showdown. They only told the nation that the MP said 20 71 they were in good terms with the PM.

There is more rot at SBIS

MINISTER for Information, Communication and Technology (ICT) Dumisani Ndlangamandla should conduct intensive investigations at SBIS.

The MPs said there was a lot of rot at the national radio station, citing last week's four-hour blackout as being part of the rot currently taking place at the station. Nkwene MP Sikhumbuzo Dlamini accused SBIS Deputy Director Gcinangaye Tsabedze of doing as she pleased at the station.

"It is like she is the one running the show at the station, making SBIS Director Martin Dlamini to appear as someone who was doing nothing," he charged.

The MP further alleged that the situation is so serious that a senior engineer has been reduced to driving around the deputy director in a government vehicle registered GSD 006 BT. The blackout, the MP said, was caused by the fact that the engineer was busy chauffeuring Tsabedze, even in the thick of the night. What made matters worse, according to MP Sikhumbuzo, was that the car had already developed mechanical problems, without the knowledge of the officials at Central Transport Administration (CTA). The car was reported to be parked somewhere next to the High Court in Mbabane, where the engineer stayed.

The MP also wanted to know why ordinary people were allowed to go on external trips even before the Head of State. He said it was procedural that people who were the first to go were security professionals like the police and/or soldiers. But in this case, other professionals were made to go with the security professionals.

He did not understand what security measures were to be provided by those professionals. What was painful was that the said professionals would pocket around E30 000, which came at a high cost to taxpayers'. The MP wondered how financial resources could be hindrance to the operations of the stations. He was of the view that such could not be the case because money was wasted on external trips at the station.

...SEX IS STILL DONE AT SBIS

SEX is alleged to be done at SBIS, despite the call for MPs for such an act to stop happening.

This was said by Mbabane West MP Johane Shongwe, when telling ICT Minister Dumisani Ndlangamandla to investigate what was happening at the radio station. Shongwe said he was once approached by a certain woman at Mbabane city centre. She told him that her husband was still being 'chowed' at SBIS.

Lucky

"The woman told me that she was lucky to come across me because she wanted to talk to me. She told me that her husband was cheating with some woman at SBIS. It is shocking that we think the people at the station are working yet kudlalwa bhabhosa! bhabhosa! bhabhosa! (sex is being done)" the MP said, provoking laughter from the MPs and ICT officials, who were listening to him.

SPTC SLEEPS ON THE JOB

by Members of Parliament for sleeping on the job.

The legislators urged Minister Ndlangamandla to find out why the communications company was failing to serve people in their areas. Lugongolweni MP Joseph Souza said 40 people applied for landline telephone services in 2014. Nkwene MP Sikhumbuzo Dlamini also complained of SPTC's lack of service delivery. The company had installed poles at his constituency and nothing was done ever since.

WORKERS at Swazi Telecomms are accused Nkhaba MP Menzi Dlamini said the case was true in his constituency. Many people in his place had applied for the company's services, but the company failed to render the services. Hhukwini MP Saladin Magagula also complained because the services were not availed in his area.

GOVERNMENT HOUSES TO BE AUDITED

CIVIL servants who are benefitting from renting out government houses might be caught red handed.

This is supposed to happen from now until at least the end of this year. This was said by Minister for Public Service Owen Nxumalo. He was telling MPs who are members of the ministry's portfolio committee yesterday at the House of Assembly. This was during the debate of the first quarter performance report yesterday.

Nxumalo told the MPs that the issue of the abuse of government houses was a cause for concern in his ministry. He was responding to concerns of the MPs because of the houses, which they said were being abused on a daily basis. Some of the houses, according to the MPs, were now used for something they were not built for.

The minister stated that he was one person that did not like to disrespect Parliament resolutions. He urged the MPs to work with him as he embarked on an exercise to check if the government houses were still used for the right reasons. He promised the legislators that the ministry would soon start compiling the number of houses and the places where the houses were

Nxumalo promised that he would have a full report on this exercise during the debate of the second quarter performance report of the ministry. The MPs showed concern in the manner which the government houses were abused. Some civil servants were given the houses to stay in,

... Armed forces waste money

THE country's security forces are meaning they added to the increase of consuming a lot of the country's financial resources and contribute to increasing the wage bill of the gov-

Armed forces include Umbutfo Swaziland Defence Force (USDF), Royal Swaziland Police Service (RSPS), and His Majesty's Correctional Services (HMCS). MPs feel the forces are not making money for the country yet they recruit often. They wanted to know what the ministry of public service was doing to alleviate the situation. Manzini North Member of Parliament Jan Sithole said armed forces only rendered services to the country. This meant they only took money from the Swazis,

the wage bill. To make matters worse, the forces increased by hundreds almost every year, yet the country failed to create the same number of investments to make money into the purse of the The Manzini North lawmaker also

told Nxumalo that the armed forces also promoted their officers in their hundreds. This also contributed to the increase of the wage bill. He wanted to know what the ministry was doing to alleviate the situation. The issue of the wage bill was a thorny issue among the MPs. They urged the ministry to ensure that such a situation because it was bad for the country.

while they also got housing allowances. Issue

Mbabane West MP Johane Shongwe spoke aggressively on this issue. He accused the whole ministry of not attending to the problem concerning the government houses. "For how long are we going to talk about this issue to this ministry? What do we have to do to ensure that something is done about the houses?" Shongwe enquired.

The MP told the ministry that he was sending a strong and last warning to the ministry to stop acting lazily on the matter. "I am now going to check some of these houses if they are still used in a good manner. Once I do my own confirmations, I will then come back and table a report here in Parliament," he said.

Somntongo MP Sandile Nxumalo urged the minister to do as he promised and get a compiled report on the houses because some civil servants could not get accommodation yet there were undeserving people occupying the houses.

Some companies, according to Nxumalo, issued housing allowances to its workers, so that they workers could be able to get loans and build houses

. He suggested that even government could do that and rent out the houses to make money.

Speaking at the event acting Chief Executive Officer (CEO) Jeff Penberton said their shop was not an ordinary service centre but it was an experience centre a place where potential customers could get to experience Swazi Mobile services before buying them.

Developed

"Experience centres are common in developed countries, but it is the first of its kind in Swaziland.


We want people to get a feel of the services we are offering, so they make informed decisions," he said. "People will be allowed

to test the speed of our internet while in the centre," he said. Penberton added that this would not be the only service centre as they would have at least two others in areas yet to be announced.

"We are looking at having 24 shops around the country so, at least two more will also be experience centres and the rest will be normal service shops," he said. He said the objective was to bring their customers the best services and experiences possible.

The experience centre opens everyday from 9 am to 8 pm. "We open from 9 am and we close at 8pm every day, even on public holidays and weekends," he said.

15 000 already signed up

PEOPLE who are looking to become Swazi Mobile shareholders still have a shot as at least 15 000 Swazis have registered with the network since Friday.

At least 15 000 Swazi are now Swazi Mobile users since the company started selling its SIM cards on Friday.

According to company acting CEO Jeff Penberton the company has sold at least 15 000 SIM cards between Friday and Monday.

"From the stats received, about 15 000 people have registered with us and that's just between Friday and Monday," he said. He said the demand for their SIM

cards had been very high ever since they had gone live and the numbers seemed to be increasing with each day.

"On average we have about 5 000 registering with us on a daily basis and that is an impressive turn out," he said.

Stores

The Swazi Mobile SIM cards are sold at all malls in the country. "We have popup stores at malls in the country, until we open all our service centres that will open on different days that will be revealed in due course," he said. The SIM cards cost E50 and they come with a weekly bundle that encompasses E250 minutes on-

net bundle, 50 minutes off-net bundle, 50 SMS and 50MB data bundle.

A week ago the company revealed that the first 100 000 Swazis to buy SIM cards and be active on the network would automatically become shareholders.

Making the revelation company chairman Victor Gamedze said the first 100 000 Swazis who would buy SIM cards and stay active on the network by receiving 30 different calls, from 30 unique Swazi numbers and load E600 airtime, would be shareholders. "To be shareholders the 100 000 should have bought E600 airtime after three months and should have received 30 calls from 30 unique Swazi numbers from either networks," he said.

Users to register numbers on WhatsApp platform next month

SWAZI Mobile users will have to wait until end of September to register their numbers on WhatsApp.

According to Swazi Mobile acting CEO Jeff Penberton said Swazi Mobile users would have to wait until September 30 before they could register on the popular social media platform WhatsApp.

Penberton said they were still waiting on the GSMA trade body that represents the interests of mobile operators worldwide to inform all other networks of the new network that is Swazi Mobile.

"What you have to do as a network is register with GSMA and they then inform all other networks around the world that there is a new member called Swazi Mobile.

Now, that information has gone out, so these networks now have to update their databases that are currently not accepting Swazi Mobile, that process is ongoing and we expect it to be completed end of September," he said.

He explained that WhatsApp is based in San Francisco and the network used to send SMS to verify numbers when registering still didn't have Swazi Mobile in its database.

"WhatsApp is based in San Francisco, so the network they use to send SMS to verify your number when registering has not yet registered Swazi Mobile on its database hence when you register it says not recognised," he said.

He said people should be patient and wait for September 30 because there after they would be able to register for WhatsApp and all other social media platforms that needed one to register using their mobile numbers. "On September 30 the process

will be done, we will be recognized by all networks worldwide and only then will customers be able to register on WhatsApp,"

KING'S VISION BEING REALISED





MHLATANE High Principal Dr Mandla Dlamini has warned pupils against engaging in sexual activities while still in school.

Dlamini said the school was against pupils engaging is such activities at a tender age, thus they have been banned from any sexual activity.

He said this was a written rule in the school's prospectus and anyone who defied it would be expelled from the school forthwith.

He was addressing reports that a kombi conductor was disciplined by a Mhlatane High teacher for allegedly having an affair with a pupil from the school. He dismissed the reports as untrue, saying no such thing would happen at Mhlatane High.

"Those rumours are false, there has been no such thing at Mhlatane, as a journalist you are free to ask any of the over 80 adult staff members who work at the school about the matter.

I highly doubt that all of them would hide the truth from you and if you want to further investigate the matter I am inviting you to the school to ask any of the pupils.

We have not disciplined any bus conductor for having a relationship with a pupil. However, I have heard the rumour as another media house also asked me about the same story and I told them the same thing that I am telling you now," he said.

He said what happened was that in January this year the school reminded pupils in an assembly about the schools prospectus that prohibit them from engaging in sexual activities.

He said those who disobeyed this rule and other rules written in the school's prospectors would be expelled immediately. "I want to reiterate the point that Mhlatane High will expel any pupil involved in any sexual relationship," he said.

Police boss intimidating us – Students

SWAZILAND National Union of Students (SNUS) has accused National Commissioner of Police Isaac Magagula of applying intimidation tactics so that students may fear to take part in the 'Right to Education Campaign' organised by the students union.

This comes after the national commissioner stated that SNUS remains unknown in the domain of officialdom in the country.

Magagula went on to state that SNUS is all out to hold the country hostage through sowing fear by stirring up anarchy and lawlessness. The national commissioner is said to have cautioned that instigating violence was not the way to go and should never been a viable solution.

SNUS in response to the statement made by Magagula stated that violence has never been their principle. In a statement released by SNUS Communications Officer Tengetile Masuku, she stated that Magagula was attacking the students union for its Right to Education campaign.

"Fortunately, we could locate from the

statement that it is driven by nothing else but a shocking level of ignorance about general students affairs," Masuku stated, adding that the statement made was misleading the public and only meant to intimidate the students community.

Violence

Masuku said violence had never been their principle. She stated that while the NATCOM street questioned the relationship of SNUS with the government, presumably the ministry of education and that of labour and social security, Masuku pointed out that the organisation is for and by the students of Swaziland.

"Whosoever denies its existence is denying the existence of students in Swaziland and most unfortunately, to his or her own peril." Masuku stated that by talking about the issue on national radio, the NATCOM, as usual was taking advantage of the easily accessible national radio sta-

tion to mislead the public knowing very well that they stand no chance to respond in the same medium.

"This is the same platform where a year and a half ago, he announced a commission of inquiry for an attempted students massacre by the same institution he preside over and to date he has not cared to update the public on its progress but never cease to mislead it using it," Masuku stated.Masuku stated that as students they had expected the national commissioner to address the issue in a different manner in that if he saw anything wrong about students calling for the full recognition of their right to education to merely facilitate an explanation session on that and to further advise them as students from a security perspective on how best they can cooperate.

Stated

The student body stated that they were disappointed in that instead the NATCOM resorted to demonising and intimidating said as a students' union theywere affirming their call for students not to be deprived of their right to education because of their economic background.

"We will throw our entire weight and exhaust the last atom of our joule for the realisation of this right. The leadership of SNUS further calls for students to remain confident and not be intimidated by the NATCOM statements," Masuku said.

Masuku said the year 2017/2018, SNUS is engaging in a campaign that seeks to pressurise the government to ensure that no students who are admitted in institutions of higher learning are hindered to enrol because of their economic status.

Lawyer Leo successfully moves for release of two more convicts

CONVICTED of robbery by the Manzini Magistrate's Court, a convict who took His Majesty's Correctional Services to court for failure to implement the Prerogative of Mercy by the King is now a free man after his lawyer Leo Dlamini successfully moved an application at the High Court.

Mduduzi Skomu Dlamini had filed an urgent application seeking an order in terms of a writ of mandamus issued against the commissioner general compelling compliance with paragraph C of the Prerogative of Mercy by the King Notice of 2015 and that of 2016 in commuting the period of his imprisonment.

He is not the only to be released as yesterday Mafutseni based lawyer Leo Dlamini also successfully moved another similar application which saw the release of Thembinkosi Satiso Masina who was incarcerated at the Pigg's Peak Correctional facility.

Masina had also been pardoned by the King both in 2015 and 2016, but the commissioner had not been commuting the period of his imprisonment.

According to a court order issued by Judge Mumcy Dlamini, on Skomu's urgent application, the respondent (Commissioner General) is ordered to comply with paragraph (C) of the Prerogative of Mercy of the King of 2015 and 2016.

Prayer

On prayer two, the Court ordered the respondent to correct the time (period) of serving imprisonment by the applicant to be in line with the provisions of paragraph (C) of the Prerogative of Mercy of the King Notice 2016 and further that the applicant is declared to be entitled to the benefit stated in the Prerogative of Mercy as at the time of its promulgation he was already convicted.

Last week Dlamini also received a judgment in favour of former member of Parliament Charles Myeza who had also been granted such pardon but but had not been released following his five years imprisonment.

Dlamini yesterday confirmed that his clients have been released by the court and Skom's application was before Judge Dlamini while that of Masina was heard by Judge John Magagula.

Mduduzi Dlamini, who had been in custody since his arrest in 2014, wants the commissioner general to correct the time period of his serving sentence to the time line with the provisions of the King's pardon.

The convict in his founding affidavit stated that he was arrested by the Manzini Police in

connection with a robbery case on August 13, 2014 and was in custody before he was sentenced on May 29, 2016 as he had been detained at the Zakhele Remand Centre to date of sentence.

This was due to the fact that he had been denied bail on the charge he was facing and has been in custody till the date of instituting the present application.

He submitted that he was convicted and sentenced to five years in prison, which according to prison calculations amounts to 50 months without a fine option and total period of imprisonment which is 60 months. To date he states that he has spent a total of 31 months in custody and as per the pardon he received from His Majesty during the 2015/16 Correctional Services days, he stands to be released from prison.

Remission

"I verily believe that in terms of the Prison's Act as read with Section 78 and 275 of the Constitution of Swaziland of 2005, I am entitled to remission of four months per calendar year which is 40 months remission and 12 months reduction of sentence in terms of paragraph C of the prerogative of mercy by the King Notice 2015 and that of 2016," the convict stated in his affidavit.

He further stated that it is common cause that with the remission, his stay in prison is with effect from August 13 2015 (day of arrest) to December 12 2017 and further that it is common cause that on August 2015 he was already serving sentence at Bhalekane here he was awarded six months remission of his sentence by the King and that in terms of the prerogative of mercy he is entitled to 12 months remission for the both the 2015 and 2015 periods.

In his supplementary affidavit, the convict had submitted that a well established practice that gives effect to the provisions of the Prerogative of Mercy by the King in 2015 and that of 2016, same was applied to a similar matter involving similar convict's calculation of sentences by the Correctional Services in Sicelo and Phakamiso Dlamini at Nhlangano Correctional facili-

He further stated that latter convicts benefited from the 2015/16 prerogative of mercy and were standing along side him and further submitted that the same applied to some convicts who received same pardon from the King at the Big Bend Correctional facility which included about 10 convicts.


QUICK ROUND UP:

WHAT MANZINI COUNCIL HAS BEEN UP TO IN RECENT MONTHS

DEAR reader. You undoubtedly desire to know what your hard working Municipal Council of Manzini has been busy with in the recent past. The following are some of the services that have been delivered by the local authority in the last one or two months. Please read on...

42 BUSINESSES GRADED. DO THEY MEET HYGIENE STANDARDS?

A total of 42 business outlets were graded within the city of Manzini in the last two months or so. The purpose of the grading exercise was to ascertain whether or not they met the laid down hygiene standards and to assist them improve in that aspect. The grading certificate, which should be placed in a visible spot within the outlet, also helps the customer make a decision whether or not to carry on and buy from the shop. Dear customer. Next time you get into a shop, please look around for either an A, B, C, D, E or even F grading certificate. If the shop has displayed a grading certificate "A", it means it is between 80 and 100 per cent hygienic and it is safe to buy from. A "B" grading means the outlet is between 79 and 70 per cent hygienic. It is also safe to buy from but the owner needs to attend to a few things so to improve the health and hygiene standard. A "C" grading means the

hygiene standard is only average; between 69 and 60 per cent. In other words, it's not that safe. In fact, the Manzini News crew would not buy from such an outlet for health and safety purposes. If you lay your eyes on a "D" grade it means a red alert. The business outlet is in the range of 59 and 50 per cent in terms of hygiene condition. It is not safe to buy from that outlet. Grading "E" (49 to 40 per cent) and "F" (39 to 1 per cent) mean you must run and never look back. No matter how cheap the items on sale may be, if you consume them you run the

risk of a booking into the nearest hospital. Out of the 42 business outlets that were inspected and graded, 30 were restaurants, three were bakeries, seven butcheries and two were groceries and supermarkets.

Please note that Council does not only inspect and grade them but makes follow-ups in an effort to see to it that the outlets improve their state of hygiene. Those that fall under grades "E" and "F" are shut down in order to protect the consumer. The table below gives a summary of the grading results;

27 BUILDING PLANS SCRUTINIZED. 17 APPROVED, 10 DEFERRED

A total of 27 building applications were received last month. Seventeen (17) were residential, six were business related, one was industrial, another one was institutional and two related to building of boundary walls.

make it due to various reasons. The applicants were advised to revisit their building plans and attend to a number of issues. value of the proposed structure. Three were told that the proposed development/use is prohibited in the sited zone. Another was advised to submit a locality plan with street names. 35 STRAY CATFLE IMPOUNDED FROM URBAN AREA

YOU will recall, dear reader, that animals that are found roaming within the Manzini urban area are impounded in accordance with the Urban Government Regulations, 1969, as read with the Pound Act, 1969.

Indeed, in June Council sprang to action and impounded 35 cows that were found within the urban area. The figure indicates a slight decline when compared to 43 that were impounded in May 2017.

All 35 animals were released subsequent to payment of the requisite fees by owners. The fee is

E75 per cow, per day spent at the municipal pound plus trespass and driving fees. Livestock owners are urged to see to it that their animals do not trespass into the urban area lest they find themselves having to pay the hefty release fees.

Always remember that the urban area is no grazing zone under any circumstances. Keeping of livestock is prohibited in the urban area. Residents are urged to continue alerting Council whenever they come across stray animals. They are urged to make use of the Council Call Centre numbers (800 2004 or 2505 7000).

COUNCIL EMBARKS ON BILHARZIA SCREENING, 84 TREATED

COUNCIL, through its social welfare office as well as assistance from the ministry of health, embarked on a bilharzia screening exercise in Murray Camp, an informal settlement within the Manzini urban area.

Urine samples were taken for screening and the results were positive.

A total of 84 children in the informal settlement were treated for bilharzia.

MKHOSI TOWNSHIP DEVELOPMENT 82% COMPLETE

DEVELOPMENT of phase 1 of the multi-million worth of residential township just below Coates Valley in Manzini (to be known as Mkhosi Township) is now 82 per cent complete and pointers indicate that the project will be wound up at the end of this month.

The scope of works consists of construction of surfaced roads, road marking, water reticulation, sewerage reticulation, electrical reticulation and area lighting. On another note, Manzini News has learnt that the other projects that are taking place in the city are also coming up okay.

Eagle road rehabilitation (in

Coates Valley) is 90 per cent complete, D98 (road stretch from Zakhele Remand Centre via Old Zakhele and kaZakhali school and down to Sihlahleni and Mathayini near the Ngwane Park cemetery) rehabilitation is 37 per cent complete and indications are that the project will be completed much earlier than anticipated.

Upgrading of Zakhele gravel roads into bitumen status is also progressing well. Overall progress on site is at 35 per cenj. More intense works are currently happening on Goal street. The project covers Dlamini, Musi, Nkambule and Goal streets.

"Now I'm very confident that even during winds and storms the house will remain intact. I'm also excited about the toilet because I didn't have one before. I had only dug one but still used the forest for defecating. Now this one is clean and more sanitary, I just feel blessed with the new house and toilet," said Lomathemba.

She also revealed that if the house had not come she would have fixed the old one as much as they would have breakins losing a lot of food as the burglars would only steal food. Now with the new house a heavy burden has been lifted off her shoulders, she said.

"My warmest and humble gratitude goes to the donors. My children are half orphans and now have a proper home. We would have died if this help had not come. I'm so happy and forever thankful," said Lomathemba happily.





 Malpractice is an act, in examinations, that is illegal, improper, unprofessional and unethical which may give unfair advantage to candidates over others. Candidates should report instances of malpractice to ECOS.

The following are examples of malpractice. The list is not exhaustive

- misuse or forgery of examination material
- behaving in such a way as to undermine the integrity of the examination failure to abide by the conditions of supervision designed to maintain the security of the examinations disruptive behaviour in the examination room (including the use of offensive language)
- introduction of unauthorised material into the examination room (e.g. notes, study guides and personal organisers, own blank paper, calculators (when prohibited), personal stereos, mobile phones or other similar electronic devices)
- . obtaining, receiving, exchanging or passing on information which could be examination-related (or attempting to) by means of talking or written paper/notes
- impersonation; pretending to be someone else, arranging for another to take one's place in an
- the inclusion of inappropriate, offensive or obscene material in scripts or coursework
- · copying from another candidate
- · collusion; working collaboratively with other
- · plagiarism; the failure to acknowledge sources properly and/or the submission of another person's work as if it were the candidate's own
- · theft of another's work
- the deliberate destruction of another's work
- . the alteration of any results document, including
- · failure to abide by the instructions of an Invigilator
- failure to abide by the conditions of supervision designed to maintain the security of the examinations
- seeking or posting confidential information on the internet including social media during relevant series
- organised cheating carried out by Centre administrators, invigilators or teachers assisting candidates in the production of coursework, beyond that permitted by the regulations
- assisting or prompting candidates with the production of answers

Late arrival of candidates

Candidates must avail themselves to sit for the examination to sit for the examination before the prescribed starting times. However, Centres must warn candidates who arrive late that ECOS reserves the right not to accept that script.

Reasons which ECOS may consider acceptable for late arrival

- sudden illness
- · Transport difficulties beyond the candidate's

Non-acceptable reasons for late arrival reading timetable incorrectly oversleeping

Lost certificates and certifying statements

A candidate who has lost an ECOS certificate may apply for a certifying statement of results Centres may apply to ECOS for a certifying statement of results at any time.

ECOS will charge a fee for issuing certifying statements. All payments should be made to NEDBANK account number: 020000026458 To apply for a certifying statement the candidate must produce the following:

- A copy of their national identity card (PIN)
- 2. A letter from their school
- 3. A Police report in case of a lost certificate or one that was destroyed by fire
- Bank deposit slip as proof of payment of E315.00 for SGCSE and E105.00 for JC certificate.

Candidates with Special Educational Needs

ECOS recognises that although some candidates cope with the learning demands of a course and demonstrate attainment in the skills being assessed, they still face unnecessary barriers when it comes to the standard assessment. Some barriers may result from:

- · a permanent long-term impairment or learning difficulty
- · a temporary impairment, illness or indisposition the immediate circumstances of the assessment
- To cater for the special needs of these candidates there are access arrangements offered by ECOS.

Access Arrangements

- Access arrangements are pre-exam arrangements made on behalf of a candidate
- · with special educational needs, for example, the use of a scribe, modified papers or extra time. The purpose of access arrangements is to
- · remove any unnecessary barriers to the normal assessment, without compounding the standards being tested, so that the candidate
- can receive recognition for their attainment. For some subjects certain access arrangements are not available. A candidate may require a particular type of access arrangement in one
- type of assessment but not in another.

How to apply for access arrangements

The Centre making the entry must submit the application.

Each application must be accompanied by a medical certificate from a recognized medical practitioner.

ECOS will not accept any application from candidates or their parents/guardians.

OVER 66 000 BOGOGO BENEFIT FROM GRANTS

OVER 66 000 elderly people benefitted from grants that were disbursed to senior citizens in the 2016/2017 financial year.

This is contained in a preamble of Deputy Prime Minister (DPM) Paul Dlamini's report which he presentedin the House of Assembly last Thursday. This was during the debate of the first quarter performance report of the Deputy Prime Minister's Office (DPMO).

The report states that a total number of 66 480 elderly people benefitted from the payment in the last quarter of ,2016/2017. The payment of the elderly grants is divided into two forms. One of them is the manual payment by Swazi Post and the other is through electronic payments in various banks.

The number of those who are paid manually is higher than that of those electronically paid. The ones paid manually receive their grant every after three months while those paid electronically are given their grants every

A total of 51 547 are being paid manually while 14 933 are paid through the electronic system. The number of

such people to be given the money is high in the country, as 1302 child mainsupposed to increase because it appears that some have not been given because they have not been in a position to receive the money.

Some of the elderly could not receive the money because they could be bedridden, while some could be out of the country. The elderly people are one group of people which the DPMO has a mandate to support. It is also mandated to support people living with disabilities, ex-servicemen (Umsizi), children, and those affected by disaster.

The office of the DPM has also disbursed E3 425 100 to a total of 6 918 OVC beneficiaries. This is done under the OVC Social Safety Net Pilot Cash Transfer Project.

Welfare

This exercise is still done under four constituencies. It is done to see if the hard cash will be able to help the children to meet their needs in a better way.

The department of social welfare has attended to 201 cases of counselling and 132 cases of abuse. Furthermore, 425 ex-servicemen beneficiaries were reached by the DPMO and were given various kinds of assistance. About 54 494 OVC were given bursaries for their education at secondary and high schools.

Child maintenance cases seem to be tenance cases have been reported to the department. The social welfare department resolved 729 cases, while 279 cases were referred to the courts for further deliberation.

Children who are 30 in number have been reported to be in conflict with the law, committing serious offences ranging from robbery, rape, housebreaking and theft.

PASSENGER LOSES E1.1M SUIT AGAINST PHINDUVUKE

By Phesheya Kunene High Court

A passenger in Phinduvuke Bus Service has lost his case wherein he was suing the bus owner a sum of E1.1 million after an injury he claimed was caused by the bus.

Judge Nkululeko Hlophe dismissed the case of Sifiso Mabuza, plaintiff, as he said it was an unfortunate and sad incident. The incident occured on September 2009, at an area known as Ematfuntini, in Lomahasha.

The passenger claimed a bus conductor of Phinduvuke, defendant, threw a bottle under a bus from which Mabuza had just alighted and was trampled on by same, causing a stump from the crushed part to spring up and hit Mabuza in the eye causing him a serious injury.

Defendant "Whether plaintiff is entitled to damages arising from the injuries sustained from the defendant, whether defendant's employee was negligent, that is whether damage reasonably foreseeable and reasonably preventable, court finds damage neither reasonably foreseeable nor reasonably preventable, plaintiff's claim dismissed with costs," the judge said.

He said the bottle thrown away had been lying idle on the floor of the bus before the bus conductor threw or put it under the bus.

The conductor was rushing to offload the plaintiff's luggage from the side-boot of the bus where it had been kept when Mabuza boarded from Manzini to Lomahasha.

The evidence reveals that as the bus took off with the conductor running to board it, the bus trampled on the bottle in question with its rear wheels or wheel.

Injuring

The bottle hit the plaintiff who was tending to his luggage, on the right hand side eye and seriously injuring him in the process," he added.

According to evidence, Mabuza made means to get to Good Sheperd Hospital in Siteki for treatment where he was treated.

'Contending to have suffered serious injuries and by extension damages, the plaintiff instituted the current proceedings where he prayed for the following reliefs against the defendant based on alleged negligence; payment of a total sum of E1 138 000, interest thereon at nine

per cent per annum a tempore morae and cost of suit," the judgment reads. Disability

Mabuza had claimed E200 000 for loss of business and E500 000 for disability due to the incident. The other expenses are as follows; medical expenses E2 000, estimated future medical expenses E150 000, transport costs E1 000, pain and suffering E20 000 and costs for truama stood at E85 000.

"Whatever else had been said in the defendant's plae as regards the claim against it, when the matter commenced and upon evidence having been led by the plaintiff, it became clear that this was more the type of matter that turns on a point of law as opposed to facts.

This is because the disputes as may have existed related to whether the bus conductor threw or put one bottle or several under the bus, including whether such bottles were actually thrown or simply put there, which are irrelevant to the determination of the real question," he added.

Negligent

He said the legal point that came to the fore was whether from the facts of the matter, it could be said that the defendant's employee in question was negligent.

The judge agreed with the defendant's counsel that in so far as it was not shown that the incident that brought about Mabuza's injury was going to bring about that specific injury in the manner done, the bus conductor's action cannot be said to have been negligent in so far as it was not reasonably foreseeable and that the bus owner reasonably failed to guard against it, which is to say legally, the defendant was not negligent and therefore not liable to Mabuza for the damage suffered.



Inmates can have sex once a month - Magistrate

SENIOR Pigg's Peak Magistrate Siphosini Dlamini stated inmates were now allowed to have conjugal visitations lasting up to five

Dlamini was speaking at the Pigg's Peak Magistrate's Court during the trial of Quantum driver Mbongiseni Mamba who was arrested for reckless driving as well as driving under the influence of alcohol. Mamba was arrested along the MR6 public road on Sunday morning.

He asked to be allowed to pay a fine and said if he spent time in a correctional facility he might lose his young wife. "I had taken 12 bottles of Savannah Black on Saturday evening. I then



went to sleep only to be woken up four hours later by my boss who told me to drive the Quantum that usually services the Pigg's Peak to Matsamo route to Timphisini. However, on the way I then saw a police roadblock. Unfortunately, in the heat of the moment I panicked and elected to make a Uturn, which attracted the police who

then arrested me after subjecting me to an embarrassing breathalyser test. If I am not allowed the option of paying a fine I could lose time with my wife," he said.

Senior Magistrate Dlamini told Mamba not to worry as his wife would be allowed to visit him and have sex for up to five hours at the correctional facility, only once a month.

"You should not worry about spending time with your wife; some correctional facilities allow conjugal visitations at least once a month.

I am sentencing you to 20 months in a correctional facility for drunk driving if you fail to pay the E2 000 fine and I am further sentencing you to four months in a correctional facility if you fail to pay the E800 for the reckless driving," said an amused Dlamini.

Man steals car keys from mom's bag, drives off before arrest

A 29-year-old man has been bag and taking her car. slapped with a E2 000 fine or 10 months imprisonment for drunk driving after he stole car keys from his mother's handbag and going on a drinking

Thabiso Ngwenya (29) was arrested on Saturday afternoon at a three-way stop close to the Northern entrance of Pigg's Peak town. Ngwenya was first asked by the police to produce his driver's licence which he did not have at the time of his arrest.

The police then subjected Ngwenya to a breathalyser test, which also confirmed that he had taken alcoholic bevarages.

Appearing at the Pigg's Peak Magistrate's Court on Monday, Ngwenya admitted to stealing the car keys in his mother's hand-

"I had been drinking a few hours before my arrest. I had taken three 750ml bottles of Hansa when i decided to go home to steal the car keys from my mother's handbag. I took the car and proceeded to Pigg's Peak from Mangwaneni to buy more alcohol. Unfortunately, I came across a police roadblock by the threeway stop," he said.

Senior Pigg's Peak Magistrate Siphosini Dlamini sentenced Ngwenya to 10 months in a correctional facility if he failed to pay a E2 000 fine for driving under the influence of alcohol.




"We, as the Ntfonjeni Inkhundla, would like to send our heart felt thanks to Micro Projects for helping our region kick-start the rural water project.

A lot of people do not know that so many homesteads in the four royal kraals around Ntfonjeni had no direct access to water, so people living in these areas had to walk to the various rivers to collect water.

Now if our calculations are accurate I see about 900 home-steads benefitting from this water project that originally

started way back in 2015 but could not get off the ground due to lack of funding. tion much closer to their homes. We have been told by our engineers that phase one will take up to five months starting in June 2017 and ending in October 2017," he said.

He said what made them proud was that the locals were the ones who came up with the dream of starting the project first.

Mthupha said Lavumisa being a border town it was important that its infrastructure should be up to the required standard. He said visitors coming through the border gate get the first impression about the Kingdom when coming through the border gate.

"Border gates remain the mirrors of the country and therefore it's a good thing to have even the road infrastructure being of world standard. The facility is not only to be opened to youth but even adults. These days we preach that we all should stay healthy and part of this is to do physical fitness exercise," said Mthupha.

"The issue of speed humps was long raised and this was after we noticed the way motorists were driving along this road. Speeding has been a major cause of accidents. There are lives which have been lost including those of school children.

Had the speed humps been erected

at the time we started raising this concern, some deaths would have been prevented. We have others who are now crippled as we speak.

Just this year, a sedan which was driven by a police officer plunged into a waiting room and this could have been avoided had the speed humps been there," said Sibandze.

Sibandze said as Hluti is considered a passage for those coming through Mahamba and Lavumisa border gates it was therefore a busy area.

"Some of the motorists are those coming from South Africa and use the two border gates. Some come through these border gates for visit

opening business opportunities. It is however sad to see some of them involved in accidents caused by reckless driving or speeding. The speed humps will hopefully save many lives," said Sibandze.

Sibandze said straying livestock was another concern giving them a headache.

"Livestock owners have to be dealt with as they don't take care of their animals which roam freely even during the night thus contributing to accidents. It's an issue which we have to do everything to see tackled," said Sibandze.



REFRESH WHAT YOU THINK...



DURING the past month as we enter the second half of the year we celebrated World Youth Skills Day.

This day is particularly relevant in the current climate as globally, young people are almost three times more likely to be unemployed and are continuously exposed to lower quality jobs, greater labour market inequalities as well as longer and more insecure school-to-work transitions.

This situation profoundly impacts women, as women are more likely to be underemployed and under-paid, and to undertake part-time jobs or work under temporary contracts.

Overall, more young people have greater educational opportunities than previously, but there are too many who are out of school, denied the quality education they deserve and are unable

Developing the skills of young people is fundamental to the growth and sustainability of our country and economy, it is also undeniably one of the most important decisions we can have as a nation. The youth are our future and they stand to inherit the consequences of our current decisions and actions.

How then, can we as a people actively neglect this population whose livelihood is impacted by every single policy, law or custom we enforce? On the streets we travel each day, the news we watch or read, we see an understandably frustrated population of young people.

This picture is however, incomplete, because with the right skills, our young people are exactly the force that we need in order to drive progress forward towards building more inclusive and vibrant societies.

The fact is, investing in skills development reduces poverty and better equips the young to find decent jobs.

Swaziland as a country is suffering under the strain of high poverty levels and we cannot ignore this glaring solution for not just our young but also our country as a whole, as it will trigger a process of empowerment and self-esteem that benefits everyone.

Globally, forty (40) per cent of young people are unemployed or ranked amongst "the working poor," this situation prompted the inclusion of youth skills in the prospective 2030 Agenda for Sustainable Development.

The agenda recognises the importance of tackling youth concerns, in particular unemployment and calls specifically for promoting youth employment and economic empowerment.

Each and every day, numerous numbers of our young people are placed in positions whereby they must risk their lives in the hopes of finding economic opportunities in distant places. This is why education and training are key determinants of success in the labour market, but unfortunately, existing systems are failing to

address the learning needs of many young people. Skills affect people's economic development in many ways but they are not only limited to economic impacts and playing a positive role in career prospects. Adults with low levels of foundational skills have a higher likelihood of reporting poor health and they also display levels of social anxiety as evidenced by less participation in community groups or meetings. Skills are also key in tackling inequality, therefore investing in human capital is the single most effective way of not just promoting growth but also its fair distribution. The simplest method of understanding the importance of investing in youth skills development is that investing in skills is far less costly, in the long run for our country, than paying the price of poorer health, lower incomes, unemployment and social exclusion - all of which are closely tied to lower skills.

DEFINING CUSTOMER SERVICE

WE have often heard complaints of "bad" customer service experiences as well as com-pliments on "good" customer service from our daily interactions with family, friends and acquaintances but what is customer service and why does it mat-

In its most basic definition, customer service has been defined by some as an organisations ability to supply their customers wants and needs.

However, for organisations who realize the importance of good customer relations some experts in the field give a more beneficial definition of customer service. That is, "customer service is a businesses ability to satisfy its customers." This is because only satisfied customers have the potential to become loyal customers

Excellent customer service is the ability of an organization to constantly and consistently exceed the customer's expectations."

Recently I visited an organisation to inquire on the procedures to renew a licence. I walked in to be assisted by a customer service officer whom i informed that I need to re-new my licence and would like to know what the procedure is as well as get all the forms I need to apply. The man asked what the expiry date on my licence was and I informed him that I do not have the exact date in memory and he informed me that he cannot give me an application form until I tell him the expiry date of my licence.

I expressed my frustration as I told him I am not in a position to drive backhome just to check a date and come back. He insisted on denying me information on reapplying until I asked if I may call to inform him of the expiry date as driving back to their offices would not be possible today. When I asked for his email so that he forwards me the requirements once I have confirmed the expiry

date on my

In contrary, I decided to call the landline with the hope of getting assistance from a more "reasonable" person who would not deny me basic information such as requirements and to my relief I was assisted by a lady over the phone who simply forwarded me all the re-quirements of applying licence, he told me that he prefers not for a licence without me giving her

expiry date of the licence.


She sent me the email with requirements as we were speaking and I was so grateful for her speed and efficiency. If my last interaction with the organisation was with the first customer service officer I met in person, I would probably not have had any positive customer experience to speak about as the man was not empathetic nor did he communicate in a manner that showed concern. Even if the rules really were as rigid as he tried to portray them to be, showing empathy and courtesy may have had a more positive impact in the customer interaction. Basically, the lady who assisted me over the phone exceeded my expectation as a customer and contrary to the walk in experience. I felt valued.

In a nutshell from my experience I would say, I received good customer service over the phone and I would not say the same about the first walk in encounter.

As the American author and marketing guru Seth Godin wrote, customer service means different things to different organisations, but things aren't going to end well for "the industrial titans who see customer service as a cost, not a profit centre."

Gary Vaynerchuk also echoes that sentiment in 'The Thank You Economy', a treatise on the "undeniable evidence that there is financial gain for any size company that is willing to open the lines of communication with its customers and market to them in a personal, caring way that makes them feel valued."

Intodays highly competitive environment, organisations cannot afford to ignore the impor-tance of good customer service. Superior customer service is the most reliable way to grow your business. The business world constantly changes. However, the need for customer service does not go away.

JOHANNESBURG - So the EFF has survived for four years and, unlike the other ANC split-offs, Cope and the UDM, it is still growing.

But my looking glass tells me that the EFF's best chance of being in government soon would be in alliance with the ANC.

The media seem to be more in love with the red berets than the voters.

Having said that, the party has an energy and Julius Malema is a leader that would ensure that it plays an influential role in our political and national life, at least until 2019.

The EFF's 6.3 per cent support in the 2014 general election was impressive, seeing that the party was just about-one-year-old then.

Voting patterns are different in national and local elections, but it was still significant that the EFF only increased its support by two per cent between the 2014 election and the 2016 local elections.

This was despite the massive media coverage the EFF had generated in that time.

During the EFF's fourth birthday

celebrations last week Malema and his leadership boasted that the party was growing very fast and was on its way to become a majority party.

If the pace of growth between 2014 and 2016 is sustained, the EFF would probably only get 10 per cent or so of the national vote in 2019.

In contrast, the DA's growth trajectory since 2009 could mean they could get to the 30 per cent mark in 2019, as things stand now.

But these are mere calculations. The reality could be very different.

Opinion surveys indicate that most EFF supporters are younger than thirty. Two-thirds of all South Africans are under 35 years old and this is clearly the best market for a political party to capture.

If one accepts that the millions of young, mostly poor and often unem-

ployed black people are the EFF's most natural primary constituency, the party could theoretically have the potential to grow into a major play-

er in years to come. The reality is that few really poor and marginalised people bother to register as voters, and if they have, to turn up at the polling booths. Their lives are just too desperate. This is also the case in other developing

The EFF hasn't gone out of its way to mobilise this group, organise them into branches and getting them to register as voters.

It seems to believe that radical talk, theatrics and symbolism are its best weapons to grow its support.

It has in fact now decided to grow its support, so far concentrated in Limpopo, Northwest and Gauteng,

to KwaZulu-Natal and last week they went to suck up to the Zulu king.

Its growth potential in this region doesn't look strong.

Malema and senior colleagues like Floyd Shivambu, Mbuyiseni Ndlozi and Dali Mpofu have matured a lot politically and are not as raw as in the early days, but their rhetoric and policy proposals are still rather crude and race-obsessed.

Sometimes they even create the impression that they're more focused on avenging white people than in growing and transforming the economy in the interest of the majority.

Malema's statement last week that all white South Africans, without exception, are white supremacists was a deeply racist thing to say because it suggests a genetic imperative to certain attitudes.

TWENTY YEARS ON, DIANA REMAINS THE ROYAL REBEL. LET HER SPEAK

TWENTY years after her death, visions of Diana are reappearing. These are not glimpses of a beatific saint. They are neither neat nor comfortable. Rather, they are full of indications that Diana was a difficult woman.

One of the most difficult things about her was that she voiced her unhappiness sometimes in public. There was the famous Panorama interview, but there were also private tapes made with her voice coach, Peter Settelen, which are the basis of a Channel 4 documentary Diana: In Her Own Words.

Does it matter what she said all those years ago? Apparently it does, because there are those who feel these tapes were a form of therapy and should not be in the public domain. Diana's friend Rosa Monckton expressed this view. Her brother, Earl Spencer, demanded that the programme be dropped as it would upset the princes. The princes themselves have said nothing, but have spoken movingly of what a great mother she was in the ITV documentary Diana, Our Mother: Her Life and Legacy. She was a naughty parent full of fun who wanted them to know life beyond the palace walls. Her ability to open up about private distress and relate to "civilians" is carried on through them. Harry's recent frank discus-

sion of mental health has been admirable. So, her good works con-

Yet when we get to hear Diana's actual words, everything becomes more complex. She wasn't simply a pretty young mother. She was trapped in two miserable institutions: one of marriage and one of the royal family in which she was visibly struggling.

She had only met Charles 13 times before they were engaged. She was both naive and manipulative even then, it seems. But also very funny. She talks, for example, of being "absolutely traumatised" by the infamous interview upon their engagement when she and Charles were asked if they were in love. He questioned the meaning of "in love"

and she recalls in the video replying that of course she was in love, adding "like the fat Sloane Ranger that I was".

As the marriage became more and more miserable after five years she went sobbing to the "top lady" asking for advice about what to do. According to her, the queen just said: "I don't know what you do." She also talks of an affair with a bodyguard.

Is this scraping the barrel? Is there anything new here? Is this lowestcommon-denominator TV, as it has been called? Or is it an important historical record? As so often with Diana it is all those things, but what is undeniable still is that Diana's "presence", her words, simple as they are, are disruptive of the royal

narrative and cannot just be ignored. She wanted to be seen and heard and that was troublesome. She wanted to voice how unfairly she had been treated by her husband and the entire "firm" - and that was seen by them as betrayal.

Her death made the family realise that they had to modernise - just enough - but also that they had to revert to bringing in marriage material that was not so explosive. Kate - photogenic, bland, almost mute - is a safe bet. Everyone loves the Queen more than ever due to her sphinx-like qualities. Camilla has been accepted, while Charles potters about on his permanent gap year. Few people discuss republicanism as a serious political movement any more. The royals have recalibrated just enough to secure the unthinking consent they need to carry on.

Then Diana's voice comes up again, demanding as she is. Demanding because she refused to accept her lot. When the bulimia no longer worked as a coping mechanism she became more vocal. She would speak her unhappiness. In doing so she revealed not only her own problems, but how alarming and cruel the protocols of the royal family remain.

Diana is still blamed, somehow, for the Dianafication - the open display of emotion - that unfolded after she died, and is said to have ruined our style of repressed, stiff-upperlip grieving. But her legacy remains precisely to do with this rebellious openness, her refusal to shut up, her demand to be loved and to have some kind of life. Why is there still a need to shut her voice down, to sanitise the image of this turbulent woman? Twenty years on, how much of a threat can her talking of her marital unhappiness really be? And who does it threaten? I say let her speak.

tural expert would disagree that the EFF's insistence that all land be expropriated without compensation would be catastrophic for the economy, stability and food security.

The party's simplistic, purist socialist policies have demonstrably failed in every society that had adopted them. It is not an exact science to measure the attitudes of voters, but my sense is that the EFF overestimates the power of radical rhetoric, crude race politics and theatre.

Some voters would join in on social media, but I think the ordinary South African voter is actually more pragmatic and focused on real solutions that would deliver a better and fairer society. Many citizens are entertained by the EFF's violent shenanigans in Parliament, but I don't believe these theatrics have much of an impact any longer. Refusing to be in Parliament when the president was present, for instance, was counter-productive.

"Give our land back" has become

a popular slogan, but this is more about symbolism and assertiveness than reality. Relatively few people have the ambition to leave the city for the tough life of working the land - and South Africa is two-thirds urbanised. Malema and Co targets Jacob Zuma all the time, but in reality there is little difference between the noises the Zuma faction and the ANC Youth League have been making recently and that of the EFF.

Talented

Malema is a clever, talented politician with ample charisma. He's not the kind of politician who would want to be in perpetual opposition. He wants power. The EFF has celebrated its fourth birthday, but it might not have a sixth birthday party, at least not as a stand-alone party.

After Zuma had gone, and the ANC further weakened because of irreconcilable factions, a coalition with or even merger with the EFF must be seen as likely right now-if Malema

is assured of a powerful position. But until then the EFF will continue to punch way above its weight.

Brand


"We will then open franchise outlets around the country where we are looking to work with people. They will run the outlets. We will brand them and stay with the franchisees for three months showing them how everything is done," he

INTERESTED eligible bidders will be required to present a bid security worth E15 million for the construction of secondary distribution systems to serve approximately 2 826 hectares of irrigation development within three off-take areas of the Matata Block.

A bid security refers to a deposit submitted with a bid to guarantee to the project owner that the bidder, if awarded the contract, will execute the contract within the specified period of time.

The contract falls under the Lower Usuthu Smallholder Irrigation Project II - (LUSIP II) championed by the Swaziland Water and Agricultural Development Enterprise (SWADE).

According to the tender invitation notice, the tender is international and bids are expected not later August 11 at 11:00.

Government applied for a loan from the European Investment Bank (EIB) towards the cost of the LUSIP II and intends to apply part of the proceeds of this loan to cover eligible payments under the contract. SWADE was appointed as the executing agency for the project.

"The contract for the construction of the secondary distribution systems and pump stations and roads for contract 1: 2 826 hectares

of the Matata Block (Off-takes 1, 2 and 3) will be procured under open procedures in accordance with EIB 'Guide to Procurement' 2011 edition, as amended where specific considerations within the EIB required a change for the project as set out in the bank's guide to procurement," said the notice.

The contract includes the construction of secondary distribution systems to serve approximately 2 826 hectares of irrigation development within three off-take areas of the Matata Block.

"Works in each off-take area shall consist of pipeline networks with associated booster pump stations, valves and ancillaries and the construction of haulage/service/access roads.

"The works will include pipeline

civils components, pipeline mechanicals and structural components (valves, chambers and ancillaries), pump station mechanical, electrical, control and instrumentation (C&I) and structural components and the construction of gravelled access/ service

roads running along certain of the secondary distribution pipelines to facilitate construction and later permanent access into the irrigation area," said the notice.

The contract is expected to be implemented from October 1 to July 31, 2019.

The notice said the criteria to be used in the tender evaluation include general eligibility, historical contract performance, financial capacity, project experience, personnel and equipment.

RAND WEAKENS AS SARB BATTLES MANDATE INSTRUCTION IN COURT

JOHANNESBURG - South Africa's Reserve Bank yesterday asked the court to reverse an instruction from the nation's anti-graft ombudsman to change its mandate, as it seeks to protect its independence.

The High Court in Pretoria, the capital, is due to hear the central bank's application to set aside Public Protector Busisiwe Mkhwebane's June 19 instruction that lawmakers must change the constitution to make it focus on the "socio-economic well-being of citizens" instead of inflation.

This roiled market, with the rand being the most volatile among major and emerging-market currencies this year, was condemned by the ruling party and parliament.

Concern

The independence of the central bank is cited by rating companies as a key strength, and any move to erode that could lead to further downgrades, particularly after President Jacob Zuma removed Pravin Gordhan as finance minister in March.

The move raised concern that National Treasury decisions would be become more political, and sparked cuts to junk status by S&P Global Ratings and Fitch Ratings Ltd. A court judgment will bring certainty and settle the matter for investors, said Azar Jammine, chief economist at Econometrix in Johannesburg.

"The decision won't create too much of a stir if it goes the way



of the Reserve Bank," Jammine said by phone.

Ratings

"The real issue comes if the decision is in favor of the Public Protector, which may cause a little bit of panic with fears from ratings agencies as well."

While Mkhwebane has said she

won't oppose the application, her instruction remains in place until it's reversed by a court.

'Far-Reaching Consequences

"Simply by not opposing the matter she is now accepting that she did not have the authority or jurisdiction to do what she did," Lawson Naidoo, the Executive Secretary of the Council for the Advancement of the South African Constitution, said by phone from Johannesburg.

"Given the far-reaching consequences of the original findings of the Public Protector, it is very prudent to have it set aside properly so that there can be no ambiguity about the matter."

Economy

The Reserve Bank's mandate is to target inflation at three per cent to six per cent. The Monetary Policy Committee cut the benchmark repurchase rate on July 20 for the first time in five years as its inflation outlook improved and it halved its economic growth forecast for 2017 to 0.5 percent.

Governor Lesetja Kganyago and his three deputies will be in Parliament, briefing lawmakers about the nation's economic outlook, the lender's mandate and Mkhwebane's report at the same time as the court application.

The timing of the Public Protector's report "points to growing political pressure for less independent monetary policy, a key pillar in our assessment of South Africa's gradually deteriorating institutional strength," Moody's Investors Service lead sovereign analyst for South Africa, Zuzana Brixiova, said in research report on Monday.

"It also sends another unclear signal about the policy direction."

The rand weakened 0.2 per cent to 13.2142 per dollar by 9:23 a.m. yesterday in Johannesburg.

JSE bullish as it breaches record highs

JOHANNESBURG - The JSE all share index, which reached a fresh record of 55,367 points on Monday before settling back to close at 55,207, looks likely to make further gains yesterday.

Chinese stocks continued their rally ahead of the JSE's opening yesterday morning, buoyed by the Caixin manufacturing purchasing managers' index (PMI) for July coming in at 51.1 points, far higher than the expected 50.4.

This helped Hong Kong's Hang Seng index gain 0.73 per cent, the Shanghai composite index gain 0.41per cent and the Shenzhen composite index 0.06 per cent.

Sydney's S&P/ASX 200 was 0.81per cent higher, with BHP Billiton gaining one per cent to A\$26.11. On the JSE on Monday BHP closed 2.88 per cent higher at R239.62.

Much as China had the NBS manufacturing PMI released on Monday and the Caixin manufacturing PMI released on Tuesday, SA has the ABSA-sponsored poll of factory managers released yesterday at 11am and a similar survey sponsored by Standard Bank released on Thursday.

The ABSA manufacturing PMI, done by Stellenbosch University's Bureau of Economic Research, is expected to show factory managers rebounded to the optimistic side of 50 points in July after falling to a pessimistic 46.7 points in June. Trading Economics found the economists' consensus is for 53.6 points for July.

The Standard Bank manufacturing PMI is expected to show a rebound to 50.6 points in July from 49 in June.

Another health check of SA's manufacturing will be provided when the National Association of Automobile Manufacturers of SA releases July's new vehicle sales figures. After plummeting to 34,956 in April, new vehicle sales recovered to 45,369 in June. Royal Bafokeng Platinum (RBPlat) said in a trading statement on July 13 it expected to report soon it fell into an interim headline loss per share for the six months to end-June of up to 20c from headline earnings per share (HEPS) of 77.8c. *Fin24*

Energy Minister suspends Central Energy Fund board

CAPE TOWN – Energy Minister Mmamoloko Kubayi has suspended the Central Energy Fund (CEF) board, including its acting chief executive, chief financial officer and company secre-

Fin24 was tipped off about the suspension by a source on Monday. CEF spokesperson Jacky Mashapu declined to comment, pointing journalists to their shareholder, Kubayi. Her spokesperson, Nomvula Khalo, told Fin24 yesterday that the minister is unable to respond to questions related to CEF as they are "internal matters".

A report in the Business Day confirmed the tip-off yesterday, explaining that the suspension occurred after the board was called to a meeting last Thursday regarding the controversial stock rotation issue. They were given until 17:00 on Monday to respond to questions regarding the issue, the paper reported.

Without naming their source, the newspaper said those suspended included board chairperson Luvo Makasi, acting CEO Mojalefa Moagi, chief financial officer Lufuno Makhuba and company secretary Abdul Haffejee.

Makasi, who was appointed by former Energy Minister Tina Joemat-Pettersson, was in the news for his apparent close relationship to Minister of Water Affairs and Sanitation Nomyula Mokonyane this year.

City Press reported in February that Mokonyane is "allowing her young male companion to call the shots in her department – so much so that he has gone so far as giving orders to her director-general".

Khalo told Fin24 that "any correspondence between the CEF and the minister as a shareholder is confidential and not for public consumption. Should there be a need for the minister to brief the public on any matter it shall be done.

"On matters related to the sale of the country's reserves; we are almost at the end of internal process and should be able to brief the nation by September 2017." *Fin24*

Former Prasa CFO must pay back R8.22m

CAPE TOWN - Former chief financial officer and consultant at the Passenger Rail Agency of SA (PRASA) Fenton Gastin must pay back R8.22m to the agency, the high court in Pretoria has ordered.

The court declared certain agreements of employment and consultancy between Gastin and former Prasa group CEO Lucky Montana unlawful, invalid, void from the start and of no force and effect.

PRASA applied to have a contract for professional services regarding finance and strategic advice concluded on September 30 2014 between Montana and Gastin declared unlawful and invalid. PRASA asked for Gastin to pay back R8.2m relating to certain contracts. The amount included about R3.4m as part of a "mutual separation" agreement between Montana and Gastin dated July 16 2013, and about R4.9m in payments made to Gastin in terms of a consultancy agreement of September 30 2014. In an affidavit to substantiate the application on behalf of PRASA, Sipho Sithole, group chief strategy officer of the rail agency, explained that Gastin is a former PRASA

employee. According to Sithole, the history of Gastin's employment at Prasa demonstrated that he and Montana maintained a relationship with the purpose of defrauding the rail agency.

Montana had appointed Gastin as group chief risk officer on a five-year contract from August 1 2010. In January 2012 Gastin was appointed acting group chief financial officer and subsequently group chief financial officer at R3m per year.

No board resolution to approve appointment "After a diligent search no board

resolution was found approving this appointment," said Sithole.

A clause in the contract stated PRASA would compensate Gastin a six-month payout if his employment of group chief risk officer was terminated.

Sithole states, however, that by becoming chief financial officer, Gastin's remunaration increased from R2m to R3m per year. "There was no legal basis for (PRASA) to compensate (Gastin) on the basis that his appointment as the group CFP had terminated his permanent employment," stated Sithole. In his view, the payment of the compensation was a "deliberate ploy" by Montana and Gastin to pay the latter monies not legally due to him.

Later in his affidavit, Sithole said "it is wholly inexplicable that an employee's contract of employment could be terminated on the basis that the trust relationship between the employer and employee had irrevocably broken down, only to have the same relationship restored on the very day of termination, moreover at an increased remuneration and for an indefinite period. *Fin24*

LIBYA'S UN-BACKED PM CALLS FOR VOTE ON CONSTITUTION

TRIPOLI - Libya's UN-backed Prime Minister Fayez al-Sarraj called on Monday for a referendum on a draft Constitution approved over the weekend following years of wrangling in the war-torn country.

Libya had no Constitution throughout the fourdecade dictatorship of Muammar Gaddafi, who was overthrown and killed in a NATO-backed 2011 uprising.

Libyans elected a 60-member panel in 2014 to draft one, although the vote was marred by the low turnout as public frustration mounted over the weak central government's failure to restore order in the wake of the uprising.

The panel finally voted through its draft Constitution on Saturday, paving the way for a national referendum to enshrine it into law.

The document defines the structure of power, the status of minorities, the role of Islamic law

in legislation and seeks to create institutions capable of restoring stability after years of violence.

The vote in the eastern city of Baida was disrupted by protesters, but the draft finally passed by 43 votes out of the 44 members present.

Sarraj on Monday "welcomed the vote by the Constituent Assembly on the draft Libyan Constitution", according to a statement on the unity government's Facebook page.

Expression

"Freedom of opinion and expression must be respected by all, along with the right of all the Libyans to choose their way of life without terror or threat," he said.

He called on political actors to "create a suitable climate" for holding a referendum on the Constitution.

If passed, the draft text would make Libya a republic with a president and two houses of Parliament. Tripoli would remain the capital, Islam would be the state religion and Islamic law a source of legislation.

Senegal ruling party claims election

DAKAR - The ruling coalition of Senegal's President Macky Sall won a widely expected landslide in a legislative election, his prime minister said on Monday, bolstering Sall's prospects for re-election in 2019. The Benno Bokk Yakaar (BBY) coalition swept all except three of the country's 45 electoral departments, said Prime Minister Mahammed Boun Abdallah Dionne, speaking to the public Senegalese press agency APS ahead of the official release of results. The ruling coalition 'emerged victorious' following the vote on Sunday, Dionne said, while the turnout was 54 per cent among Senegal's 6.2 million registered voters, an increase on voting in 2012. AFP

12 killed in Somalia Shabaab attack

KAMPALA - Uganda's military said on Monday it had lost 12 soldiers in an attack claimed by Shabaab militants in southern Somalia. The Al-Qaeda linked insurgents ambushed Ugandan troops that are part of an African Union force as they patrolled a supply route in the hotly-contested Lower Shebelle region, the military said in a statement. Witnesses told AFP the attack occurred in the village of Golweyn, some 120 kilometres from the capital Mogadishu.

been found tortured and killed, the electoral commission chairperson said on Monday, as concerns grew that the East African nation's vote again would face dangerous unrest. Wafula

Chebukati helped identify the body of Christopher Msando at the city morgue and said he had injuries to the neck and head. Mssando had been reported missing a few days ago.

'Witch killings': Women beaten, burned

DAR ES SALAAM - Five women accused of being witches and murdered by a mob last week were among some 80 people killed each month in Tanzania this year by vigilantes taking the law into their own hands, a report said. Thousands of elderly Tanzanian women have been strangled, knifed to death and burned alive over the last two decades after being denounced as witches. The report published by the Dar es Salaam-based rights group Legal and Human Rights Centre showed 479 deaths related to mob justice reported in Tanzania from January to June this year, including women accused of witchcraft

Ex-warlord, footballer Weah begins Liberia presidential campaigns

MONROVIA - Liberia's 20 presidential candidates, including a former warlord, footballer George Weah and a former fashion model, started campaigning Monday to succeed Africa's first female head of state in October's election.

Ellen Johnson Sirleaf is stepping down and there is no obvious frontrunner to lead the fragile west African state.

The Nobel Prize-winning Sirleaf was elected to run in 2005 following a long civil war which left deep scars on Liberia's economy and social fabric.

Elections for the presidency and House of Representatives take place on October 10, the first time since the end of the conflict in 2003 that the country will hold a vote

"When Africans in many townships explode in xenophobic violence against Pakistanis and other Africans from the continent, we condemn them. "Equally, the racism that African people suffer in the hands of many Indian businesses and families must be condemned and must come to an end.'

During the EFF's fourth-year birthday celebrations at Curries Fountain Stadium in Durban on Saturday, Malema said Indian people are "worse than Afrikaners".

"This is not an anti-Indian statement, it's the truth. Indians who own shops don't pay our people, but they give them food parcels," Malema told thousands of sup-

Following the statement, controversial Durban businessman and former advisor to President Jacob Zuma, Schabir Shaik, said Malema "is misinformed".

Shaik was released on medical parole in 2009 after being convicted on charges of fraud in 2005 and sentenced to 15 years in prison.

"This fool is misinformed and does not have any insight with regard to business ownership in KZN. Why does he not talk about Huletts and other big, white capital and business in the province," Shaik asked.

JOHANNESBURG - The economy featured high on the agenda of the ANC's National Executive Committee (NEC) Lekgotla at the week-

The party's Secretary General, Gwede Mantashe revealed some of the party's new plans during a media briefing at Luthuli House on Monday.

The ANC holds a lekgotla twice per year, to assess government's progress in implementing its policies.

Mantashe said there was a focus on jobs and education, with discussions around the unemployment rate which stands at a 14-year high of 27.7 per cent. The NEC also said the government needs to provide free higher education for the poor.

"The NEC further directed the NEC Lekgotla to engage ANC to come up with a concrete proposal on the imple-

mentation of free education for the working class and the poor, and moving the National Health Insurance from the phase of pilot to the implementation phase, harnessing science as a tool for economic development and growth, as well as strengthening the capacity of the state to deliver," Mantashe

wants government to convert student loans into grants, for students from poor homes in 2018.

"Fully subsidised grants should be provided for academically qualifying poor students. Poor students are defined as coming from families who earn a gross income of R150 000 (per annum). So if you are given financial assistance and you are in that category that would be a grant - R150 000 and below. It will be a grant."

Mantashe admitted the NEC is deeply concerned about the health of stateowned enterprises.

"Actually we have nagged government to attend to that issue urgently because it does not instill confidence in this very important tool for economic growth - the state-owned companies."

SA, DRC sign visa waiver for diplomats

Cape Town - South Africa and the Democratic Republic of the Congo have signed a visa waiver agreement for official and diplomatic passport holders.

LONDON - The Tesla Model 3 was already being hailed as the Ford Model T of the modern age, and now the first look at the electric car's interior shows just how revolutionary it is.

The dashboard lacks all the bells and whistles of every car to come before - it has no speedometer or gauges at all, and owners never need to use a key - instead relying on their phone.

In addition to the complete lack of a traditional dashboard, even hardware features like air vents are invisible.

All the typical features that help drivers navigate the roads have been replaced with a single 15-inch touch-screen display that sits in the centre of the dash.

The screen provides all necessary information - from speed to the car's battery life - on the single display, which can be controlled easily using two buttons on either side of the steering wheel or the touch pad.

Musk has even taken to Twitter to tell customers 'You just won't care' that there is no traditional dashboard.

Even airflow from the discreet vents is aimed by moving spots around on the display, where you can divide the airflow to send it past each ear.

'Model 3 uses two intersecting planes of air for vertical control and lateral fins hidden within the dashboard for horizontal control,' Musk tweeted.

this will take a while for drivers to adjust to. Other moving parts have been fixed as well, leading the makers to boast it is 'virtually maintenance-free'. The car doesn't have a key instead it syncs to your phone through a bluetooth connection and automatically unlocks as you approach the vehicle.

There are also two 'keycards' supplied, which can be given to valets or parking attendants. These use NFC similar to a travelcard to unlock the car and start it. Over time, they will have the option to pay for iPhone-style updates which will unlock new features and correct any glitches.

Even at its cheap price, the first test

drivers have reached a consensus that it still drives and feels like the initial luxury-priced models.

While this is a compact Tesla, it boasts 15 cubic feet and feels big and roomy, according to reviews.

Clever design made it happen - the dash is pulled ahead and pressed down, yet the touchscreen is apart from it and set close to your right hand for easy reach. The premium version, which costs US\$5 000 more, has better-grade materials, a wood-veneered dash, 12-way front seats, heated rear seats, side-by-side inductive phone chargers, 12-speaker sound and a panoramic glass ceiling.

10 slain in central Mexico state

MEXICO CITY - Ten people were slain in several locations in a central Mexico state, among them a police cliff in one city and four members of a family in an other town, authorities said. The federal Attorney General's Office said Police Chief J Santos Juarez Rocha of the city of Celaya and one of his bodyguards were found dead on Monday morning on the outskirts of the nearby city of Salamanca. The office said its Homicide Investigation Unit and Criminal Investigation Agency would be analysing evidence to try to determine responsibility for the double homicide.

EU free movement to end in 2019

LONDON - Prime Minister Theresa May's office says free movement to Britain from European Union countries will end when the UK leaves the bloc in March 2019, but it's uncertain what migration arrangements will look



like after that. Spokesperson James Slack said on Monday that "other elements of the post-Brexit immigration system will be brought forward in due course". May's government is divided over Brexit, and ministers have been sending mixed signals. AP

Probe into downed flight wraps up

MOSCOW - The Dutch-led Joint Investigation Team (JIT), which is conducting the probe into the Malaysian Boeing MH17 crash in the Donetsk region in 2014, was scheduled to finish its work yesterday. Malaysian Airlines Boeing 777 crashed in eastern Ukraine in July 2014 en route to Kuala Lumpur from Amsterdam. All 298 people on board were killed. In September 2016, the JIT, comprising Australia, Belgium, Malaysia, the Netherlands and Ukraine, announced that the airplane was allegedly downed by a missile launched from a Buk missile system, which was delivered from Russia and returned there after the incident.

Trump dictated son's statement

WASHINGTON - President Donald Trump personally dictated a misleading statement in which his son - Donald Trump Jr - said a meeting with a Russian lawyer during the 2016 election was focused on adoptions, The Washington Post reported. It later emerged that during that fateful June 2016 meeting, Trump's eldest son, his son-in-law Jared Kushner and then-campaign manager Paul Manafort met with a Russian government attorney who, an intermediary claimed, had incriminating information about Trump's rival Hillary Clinton. The subject line of the email from Trump Jr inviting Kushner and Manafort to the meeting read "Russia -Clinton - private and confidential.



TRUMP SWEARS IN NEW CHIEF OF STAFF

WASHINGTON - Anthony Scaramucci is out as White House Communications Director after just 11 days on the job, and just hours after President Donald Trump's new chief of staff, John Kelly, was sworn into office.

Hoping to turn the page on a tumultuous opening chapter to his presidency, Trump had insisted earlier on Monday that there was "no chaos" in his White House as he swore in the retired Marine general as second chief of staff.

Not long after, Scaramucci, who shocked many with his profane outburst last week against thenchief of staff Reince Priebus, was gone.

In the words of the White House announcement, he was leaving because he "felt it was best to give Chief of Staff John Kelly a clean slate and the ability to build his own team". The twosentence release concluded, "We wish him all the best".

Earlier, in an Oval Office ceremony, Trump predicted Kelly, who previously served as Homeland Security chief, would do a 'spectacular job'. And the president chose to highlight the rising stock market and positive jobs outlook rather than talk about how things might need to change in his White House under Kelly.

Trump last Friday ousted Priebus as chief of staff and turned to Kelly, who he hopes will bring military discipline to an administration weighed down by a stalled legislative agenda, infighting among West Wing aides and a stack of investigations.

The re-shuffling continued on Monday with word that Scaramucci, on the job from less than two weeks, will no longer serve in the White House's top communications post.

Unemployment

While Trump is looking for a reset, he pushed back against criticism of his administration with this tweet: "Highest Stock Market EVER, best economic numbers in years, unemployment lowest in 17 years, wages rising, border secure, SC: No WH chaos!"

In fact, economic growth averaged two per cent in the first half of this year, a pace Trump railed against as a candidate and promised to lift to three per cent. The stock market first hit a record under President Barack Obama and has kept growing. The unemployment rate, too, started to decline on Obama's watch. And wage gains have been weak.

Trump on Monday convened his first Cabinet meeting with Kelly at his side, telling his team it is "doing incredibly well" and "starting from a really good base". On how he would deal with rising tensions with North Korea, Trump said only: "It will be handled."

Mexican president denies calling Trump to praise border policy

MEXICO CITY - Mexican President Enrique Pena Nieto said on Monday he had not recently spoken to Donald Trump on the phone, after the US leader boasted his counterpart had called him to praise his border policy.

Trump made the comments as he presented his new chief of staff, former Homeland Security secretary John Kelly, who is tasked with restoring order to a White House beset by scandal, infighting and legislative defeats.

"At Homeland, what he has done has been nothing short of miraculous," Trump said of

"As you know, the border was a tremendous problem and they're close to 80 per cent stoppage. And even the president of Mexico called me they said their southern border, very few people are coming because they know they're not going to get through our border, which is the ulti-

mate compliment."

Pena Nieto's office rejected that account.

"President Enrique Pena Nieto has not recently communicated with President Donald Trump by phone," it said in a statement.

It said the two leaders had last discussed migration issues when they met on the sidelines of the G20 summit in Germany on July 7.

US targets Venezuelan President for sanctions

WASHINGTON - The US government slapped sanctions on Venezuelan President Nicolas Maduro on Monday, the Trump's administration's toughest move so far against his government in response to Sunday's election of a legislative superbody Washington denounced as a "sham" vote.

No oil-related measures were included in the announcement, but such measures remain under consideration, according to congressional sources and a person familiar with the White House's deliberations on the matter.

Under the sanctions, all of Maduro's assets subject to US jurisdiction were frozen and Americans are now barred opposition to the policies of

from doing business with him, the US Treasury Department's Office of Foreign Assets Control

"By sanctioning Maduro, the United States makes clear our his regime and our support for the people of Venezuela who seek to return their country to a full and prosperous democracy," Treasury Secretary Steven Mnuchin said in a state-

He said anyone who participates in the new legislative superbody could be exposed to future US sanctions for undermining democracy in Venezuela.

In Caracas on Monday, Maduro celebrated the election of the new legislative superbody, which is expected to give the ruling Socialist Party sweeping powers. He mocked US criticism that the vote on Sunday was an affront to democracy.

It is amazing that at a young age he has managed to put Swaziland on the map for film making.





MAYWEATHER, MCGREGOR CIRCUS PROVES THAT MONEY TALKS

LOSANGELES - First the good news from Las Vegas: Tickets for when the Mayweather-McGregor circus comes to town are still available at face value on the official website.

The bad news: Prices range from £1 596.49 for high up in the back row of the gods at the T-Mobile Arena to £6 155.95 for the inner ringside. The breaking news: Despite rumours of thousands of tickets remaining unsold there were approximately 800 left at the time of writing this, with more than 500 potential buyers queuing on line.

The worst news: Once those seats have gone prices on the black market-or secondary sale as it is more politely entitled in the US - are likely to escalate from their current scale of £2,500 up to, wait for it... f115 000. Which is why Conor McGregor's UFC boss Dana White was sounding off about exploitation when it was mistakenly reported that the Arena sold out within hours of the box office opening a

week ago. To put the sales into perspective, 800 tickets equates to four per cent of capacity. That means that despite the exorbitant pricing, 19 200 of the 20 000 places have gone already. So like it or not, spec-

ulation that there could be a financial shortfall in this hybrid fight between Money Mayweather the boxing legend and Notorious McGregor the mixed martial arts star, is currently unfounded. August

26 will see the shattering of the \$50million-plus record for gate revenue for a boxing match, set when Mayweather fought Manny Pacquiao two years ago.

Salihamidzic Bayern's new sporting director

MUNICH - Bayern Munich named former Bosnian international Hasan Salihamidzic as their new Sporting Director, filling a role that has gone vacant for over a year.

Salihamidzic has signed a three-year contract, taking over the post after Matthics Sammer quit last July due to ill health.

"He will be the responsible man for the next three years," said Chairman Karl-Heinz

President Uli Hoeness added that "there will be no contract negotiations without Hasan Salihamidzic at the table".

Bayern described Salihamidzic as someone they know best, as the Bosnian played more than 300 times for the club from 1998 to 2007 and helped them win the Champions League in 2001. He was named an ambassador of the club this year, and had accompanied the Bundesliga giants on a tour to


Salihamidzic was however not Bayern's first pick for the role.

Hoeness had initially hoped for Germany's World Cup-winning captain Philip Lahm to take the job, but talks failed.

Lahm in February caught teammates and club bosses by surprise when he not only announced he would retire in June but also said that he would spurn an offer to fill the vacant sporting director role at Bayern.

"That needs to be a positive pressure," said Genesio.

"We can't be over-motivated or allow that to create negative waves by saying we have to win or have to be in the final because it's in Lyon. "It's a great opportunity for us to play in a first European final, and on top of that it's at home.

"It needs to transcend the team and not create a pressure that inhibits us." However, Genesio said the main aim was to ensure the team would not be playing in

that competition the following season.

Barcelona block Neymar's bonus

BARCELONA - Barcelona have blocked payment of a \$31-million bonus for star attacker Neymar as speculation mounts that he will move to Paris Saint-Germain, a source at the club said yesterday.

The Brazilian football star, who is due to come back for training today morning, is at the centre of an apparent tug of war between the two European giants in what would be the most expensive transfer fee in football history. Speculation is mounting that the 25-year-old could quit Barcelona for PSG for a world-record 222 million euros. "These 26 million euros have been placed with a notary pending to see if the player continues," the source, who refused to be named, told

The renewal bonus was agreed on a year ago when Neymar extended his contract with Barcelona until 2021, and was due to be paid to the player after he completed a year. But the club has decided to put it on hold pending to see how the situation evolves. The contract Neymar signed also increased an early termination clause from 200 to 222 million euros, which PSG is reportedly willing to pay.

Neymar's future is the talk of Spanish football, and particularly Barcelona supporters. After a successful pre-season tour in the United States that saw Barcelona win against Juventus, Manchester United and Real Madrid, the footballer flew to China for a promotion trip.

But he studiously avoided commenting on the situation.

Today, Barcelona players resume training after their summer break, with a double session in the morning and in the afternoon. Neymar has been called to the training, the club source said, although Spanish sports media doubt he will show up.

GRIEZMANN 'THE FAVOURITE' TO REPLACE NEYMAR

LIVERPOOL - Antoine Griezmann has been identified as Barcelona's No 1 target to replace the PSGbound Neymar.

The Brazilian is edging closer towards a sensational £196m move this summer and the Spanish giants are now desperately lining up a new star for their front three.

According to Sport, Griezmann is 'the favourite' among the Nou Camp hierarchy to take the Brazilian's spot this coming season.

Earlier this summer the France international had been expected to join Manchester United. before Diego Simeone's side were hit with a transfer embargo. But reports in the Spanish press now claim Griezmann has become the preferred option

for Ernesto Valverde, and they will prioritise snaring the Atletico star.

Mundo Deportivo are reporting that Liverpool value Brazilian star Philippe Coutinho at €100m (£90m).

Barca saw a £72m bid for Coutinho rejected in July, with Jurgen Klopp reiterating on Monday that the 25-year-old is not for sale at any price.

When asked if the playmaker was available for sale, the German replied: "You formulate the question in a strange way. Where is the interpretation if you say he (Coutinho) is not available to be sold?

'The word "most" means there is nothing to interpret. It is nothing new from our point of view."

C WILL HELP UNLOCK POGBA'S TALENTS'


MANCHESTER - The signing of workhorse Nemanja Matic should allow Manchester United to make better use of gifted France midfielder Paul Pogba in the coming years, the club's former forward Brian McClair said.

United Manager Jose Mourinho acquired the tall Serbian enforcer from Premier League rivals and champions Chelsea for a reported fee ranging from 40 million to 50 million pounds on a three-year contract on Monday.

"United need someone who sits there behind Pogba, who played his best football when (current United captain) Michael Carrick also played last season," McClair told ESPNFC.

"Michael is coming to the end of a wonderful career, so United need someone who can do something similar but who will be more mobile in the coming years."

With Pogba a regular starter for United, Matic looks set to compete for a midfield slot with the



36-year old Carrick, Spaniard Ander Herrera and Belgian enforcer Marouane Fellaini.

"In the short term, I could see that someone like Matic would fit in," McClair said.

"In some games, Paul Pogba has been in the wrong place and it has stifled his abilities which United bought him for."

Matic, who turned 29 yesterday, won two Premier League titles in his second stint with Chelsea, having been offloaded to Portuguese giants Benfica in 2011 during his first spell with the club under

Mourinho. Pogba, who was shipped out from United to Juventus by Alex Ferguson in 2012 as a 19year old, returned to Old Trafford last year for a then world record fee of 89 million pounds and endured a patchy comeback.

With Matic boosting the array of ball-winners at United, the physical yet talented Frenchman should be allowed to play further upfield to make use of his greatest skills.

"Pogba's attributes are all about attacking," said McClair.

"He can find a pass, beat a player and has fantastic skills. He can score goals. For him to have the best opportunity of success at Old Trafford, Pogba needs to be playing in the final third of the pitch as much as possible."

Matic could make his competitive debut for last season's Europa League winners United against Champions League holders Real Madrid in the UEFA Super Cup showdown next Tuesday in Macedonia's capital Skopje.


Liverpool have sights set on title - Klopp

The crackdown, announced in May, is aimed at players who go unpunished during the match for actions that have a signifiby video. Diving for penalties cant bearing on it. The Football

Association will be able to charge them with "successful deception of a match official". Its implementation follows a year of feedback from players and officials and it is adapted from a similar regulation in force in Scotland.

While controversies there are settled by a compliance officer, in England a three-person panel consisting of an ex-player, an ex-manager and an ex-referee will sit in judgement. All three must agree there is a "clear and overwhelming case" for a charge to be brought. Reuters

Blues boss Antonio Conte had lamented the impatience of young players wanting to leave the club, but the 22-yearold Netherlands international disagrees.


"I understand what he said but I think we also know that Chelsea is a big club and for myself it was going to be difficult to come in and play straight away," Ake told reporters.



SA LONG JUMPER MANYONGA HAS HIGH HOPES FOR WORLD CHAMPS

ONDON - Having taken the siler medal at last year's Olympic lames, missing out on gold by ust one centimetre, South Africa's uvo Manyonga should be heading to this year's World hampionchips with high hopes of going one better.

However, due to an ankle injury sustained while winning at the IAAF Diamond League meeting in Stockholm in June, the 26-year-old hasn't been able to show any recent form.

Securing the world title, which at one point looked like a formality, is therefore no long a quite so certain, despite an African record and world-leading leap of 8.65m to his name alongside three other jumps beyond 8.60m in 2017.

It says a lot for the current crop of jumpers from South Africa that two of Manyonga's closest challengers hail from that same country.

Ruswahl Samaai leads the IAAF Diamond League standings after winning in Rabat in Manyonga's absence in July.

He also jumped 8.49m in finishing second at the South African Championships in April. Zarck Visser, the 2014 African champion, finished third that day and has since recorded an 8.22m leap.



Bermuda's Tyrone Smith lies third on this year's world list with an 8.34m jump, but that was back in May and the 32-year-old has been beyond eight metres on just one occasion since, meaning that it is likely to fall to the trio of jumpers from each of the USA and China to prevent a South African victory.

Jeff Henderson, the man who beat Manyonga to the Olympic title last year, has had a quiet season so far, but following an 8.28m jump at the US Championships in June, he took victory at the IAAF Diamond League meeting in London to complete his preparations in a satisfactory fashion. Jarrion Lawson, who was fourth in Rio, is, perhaps, the best placed

US jumper to challenge, winning the US title with a windy 8.49m and finishing second behind Samaai in Rabat with 8.33m, while world indoor champion Marquis Dendy has a successful championship experience on which to draw.

For China, Huang Changzhou, Wang Jianan and Shi Yuhao all have season's bests within five centimetres of each other, the best of which is Shi's 8.31m.

Yet it is Huang, with a bronze medal from last year's World Indoors, and Wang, who finished fifth in Rio and who secured bronze in Beijing two years ago, who have the championship pedigree.

Traditional 'Big Four' still rule - Thiem

LONDON - Austrian tennis player Dominic Thiem believes he and the 'next generation' are nowhere near the standard of the traditional 'Big Four' yet.

The 23-year-old world number seven says despite his victories over Rafael Nadal and Novak Djokovic this year, he and the other youngsters hoping for grand slam success have a long way to go before emulating the likes of Nadal, Djokovic, Britains Andy Murray and Wimbledon champion Roger Federer.

"We still have to win a lot of matches to deserve to be called the next big things in tennis," Thiem said, as quoted on Yahoo.
"It's nice to hear that but I think it's still a pretty long ways for both of us.

Thiem said further that the Big Four's recent decreased participation in tournaments will only help upcoming players like himself, Germany's Alexander Zverev and Nick Kyrgios of Australia to improve and close the gap.

"They are really special," he added. "It's very unusual you have four players like this in one generation. I think it's getting a little better for the other players.

"They are starting

to take a few tournaments. In the grand slams, you would have to beat two or three (of them) in a run. That's why other players haven't won the big titles."

The final grand slam of the year, the US Open, starts on August 28 and Thiem feels if he is playing well going into the event he could surprise the big guns.

His build up for the US Open begins with the Washington Open where he faces Finland's

Henri Laaksonen in Tuesday's first round. "It's important to find a strong game. It's the start of a very long journey," Thiem explained.

SERENA SERVES ACE FOR BLACK WOMEN'S EQUAL PAY

NEW YORK - Serena Williams served up a rallying cry for equal pay for black women on Monday, decrying that they would have to work on average eight months longer to earn the same as male counterparts in one year.

The record-breaking tennis star and world's highest paid female athlete - who has spoken candidly about sexism and racism - wrote a nearly 1 000-word essay in Fortune magazine to mark Black Women's Equal Pay Day.

For every dollar made by a man, black women make 63 cents in the United States. Black women earn 17 per cent less than white women, and black women with graduate degrees get paid less at every level, wrote Williams.

The 23-time Grand Slam singles champion quoted data showing that only 44 per cent of white men recognise the pay gap as an issue.

"I have been treated unfairly, I've been disrespected by my male colleagues and - in the most painful times - I've been the subject of racist remarks on and off the tennis court," wrote the 35-year-old.

"The cycles of poverty, discrimination, and sexism are much, much harder to break than the record for Grand Slam titles," she added, calling for legislation and

action to change the status quo.

Williams, who announced her engagement to Reddit co-founder Alexis Ohanian last December, is pregnant with her first child. She plans to return to competitive tennis next year.

"Black women: Be fearless. Speak out for equal pay. Every time you do, you're making it a little easier for a woman behind you," she said.

"Most of all, know that you're worth it. It can take a long time to realise that. It took



12 ARRESTED AFTER CELTIC BANNER CONTROVERSY

GLASCOW - Scottish police have arrested 12 men after illicit banners were displayed at the politicallycharged Champions League clash between Celtic and Linfield last month.

UEFA, European football's governing body, charged the Scottish champions over the illicit banners and blocked stairways during the qualifying round clash with Linfield at Parkhead on July 19.

Linfield fans are drawn from Northern Ireland's Protestant community, putting

them at odds with Celtic, who are historically seen as a Catholic side, and there were pitch invasions and missiles thrown during the first leg in

Celtic responded to the UEFA charge by imposing a two-game closure on the section of their stadium used by the ultras-style 'Green Brigade' fans who displayed the banner.

Police Scotland yesterday said 12 men, aged between 18 and 49, have now been arrested after a "proactive police investigation into banners and

material displayed".

They have all been released on an undertaking to appear at Glasgow Sheriff Court later this month.

Celtic's partial stadium closure, thought to have affected 900 season-ticket holders in the safe-standing section of the ground, will be lifted after the Scottish Premiership match against Hearts on Saturday.

However, the Glasgow club said "a number of fans within this area remain suspended" while investigations continue. *AFP*

It's seen him win six Serie A titles and lift the Champions League on two occasions, but while he will go down in the football history books as one of the most technically gifted players of his generation, he certainly will not be remembered as a player who put his body on the line to help his team.

New York City fans are finding that out at the moment, with the 38-year-old Italian coming under scrutiny for his lack of effort which some fans believe cost their side victory in their recent clash with Toronto.

The Chilean was due back at London Cobey on Sunday but was permitted anextra two days off due to illness.




He said it was their wish to have some of their youngsters plying their trade with red and white ensemble.



There was also no response to a message sent to him at the time of going to press.

The player will spearhead Swallows striking force as the team will take part in next year's Total CAF Champions League after convincingly clinching the 2016/17 MTN Premier League crown with an impressive 22 matches unbeaten run.
