LOVERS MOTION FAILING TO GO THROUGH IN PARLY

IT seems as if some spouses are still going to have their rights violated as efforts to enact a legislation protecting them is being stalled by both government and Parliament.

Members of Parliament (MPs) have been trying to move a motion that seeks to protect the rights of spouses in order for them to be able to inherit estates left by their lovers.

To make that happen, the motion wants to direct Minister for Justice and Constitutional Affairs Edgar Hillary to table a Bill that seeks to protect spouses to inherit the estates.

The efforts by Parliament seek to give effect to Section 34 of the Constitution. Section 34 says: "(1) A surviving spouse is entitled to a reasonable provision out of the estate of the other spouse whether the other spouse died having made a valid will or not and whether the spouses were married by civil or customary rites

(2) Parliament shall, as soon as practicable after the commencement of this Constitution, enact legislation regulating the property rights of spouses including common-law husband and wife."

The motion was to be moved last Wednesday by Kubuta MP Njabulo On Wednesday this week, the motion appeared again on the order paper. An order paper is a list of activities to be done by either MPs or Senators in Parliament. MP Mabuza also tried on Wednesday to move the motion. He was supposed to be seconded by MP Jan Sithole. It turned out to be unfortunate again for the Kubuta legislator because when he was motivating his motion, the House had to adjourn because MPs could not form a quorum

Mabuza.

He was supposed to be seconded by Manzini North MP Jan Sithole. However, it was felt that moving their motion would be improper because Hillary was not present in the House.

The MPs wanted to move the motion because they saw the presence of other Cabinet ministers. They were of the view that they would pass the message to Hillary so that he could action the motion.

On Monday this week, the motion was moved again but it could not see the light of day.

On Wednesday this week, the motion appeared again on the order paper. An order paper is a list of activities to be done by either MPs or Senators in Parliament. MP Mabuza also tried on Wednesday to move the motion. He was supposed to be seconded by MP Jan Sithole. It turned out to be unfor-


tunate again for the Kubuta legislator because when he was motivating his motion, the House had to adjourn because MPs could not form a quorum.

This time, Hillary was represented by Minister for Information, Communication and Technology Dumisani Ndlangamandla, who was ready to pass the motion to Hillary.

Speaker Themba Msibi tried to save the situation by ordering that the House should go for a five-minute break, hoping that by that time, the MPs would have come back to the House.

When Msibi came back to let the House resume its business, he found the situation worse than it had been before.

The MPs were less than 20 at that time yet they were more than 20, but less than 30, when he ordered the House to the five-minute break. The House cannot continue with any business if MPs are less than 30.



Motion aimed at protecting live-in-lovers

THE motion on the protection of the rights of spouses is aimed at protecting even live-in-lovers.

This was said by Kubuta MP Njabulo Mabuza on Wednesday, when he motivated the motion he had moved in the House. However, Mabuza could not finish because the House could not form a quorum.

When called yesterday by this newspaper, Mabuza mentioned that there was a huge outcry from members of the public because some spouses, particularly women, were subjected to degrading treatment when their spouses died.

Live-in-lovers are people who live together as spouses, yet they have no formal agreement that could pronounce them as romantic partners.

Mabuza said even such people had to be protected because they could live together, preparing that one day, they would formally agree to be life time

partners.

It would be unfortunate to encounter death when the live-in-lovers were still preparing to formalise their union.

Spouses, according to Mabuza, were expelled when they encountered unfortunate situations of having lost their partners.

"At the Master of the High Court, you find that some estate cases are pending because the spouse's in-laws do not want to give the estates to the spouse," Mabuza said.

The MP said the aim of Parliament was to force the government to give effect to the Constitution because Section 34 of the supreme law wanted that to be done.

The Constitution, in Subsection 2 of Section 34, compels Parliament to enact legislation that will protect the rights of spouse, as soon as practicable, after the commencement of the constitution. The Constitution received a Royal assent on July 26, 2005 and it started working on February 8, 2006.

However, up to this day, no legislation of that sort has been enacted by the legislature.

Mabuza said it was frustrating to note that on several occasions, the motion did not see the light of day whenever he moved it. Mabuza opined that maybe the problem would be the structure of the order paper. The business of the government had to take precedence in the House.

This means matters directly concerning the business of government are the first to be done in the House.

Matters concerning the people could then follow on the order paper. Mabuza even stated that the Speaker could not call MPs for a sitting if government did not have business to be done in the House on the day.

'Skhothane' ordered to pay E20 000 alcohol bill

THE Magistrate's Court has ordered the South African man who is believed to be part of the infamous 'Skhothane' crew to settle the E18 321 alcohol bill he failed to pay at the George Hotel.

Bongani Linda Mhlongo (26) of South Africa was arrested for defrauding the George Hotel after he failed to settle a bill of E18 321.

The accused is said to have arrived at the George Hotel and started buying drinks, food and cigarettes for everyone at the bar. The accused made his first court appearance before Magistrate Philisiwe Simelane.

During the course of the trial it was revealed that the accused deceived the hotel staff by booking a room using Grace Travel Agents. It is alleged that hotel staff received an email from the travelling agents saying they must give their client alcoholic beverages amounting to E2 000. It is alleged after that the travelling agent sent a proof of payment for E15 731.

However, later it was discovered that the payment the accused made through Nedbank was dishonoured and by that time the accused was long gone.

The taxi which he hired to ferry him to Ngwane Park was called and police were able to track him down and arrest him.

The court has since ordered the accused to pay the hotel his unsettled bill.

Mhlongo informed the court that he will pay the money with the help of his girlfriend who is working in South Africa.

The accused is expected to be back in court on August 7, for judgment on the mater.

Mhlatane High Secretary changes tune on invoices

MHLATANE High School Secretary changed her tune yesterday when she told the court she did sign invoices.

Queeneth Lukhele had previously denied this when asked by the defence.

However, CB Office Automations' attorney Bonginkhosi Magagula produced an invoice dated February 15, 2012, which was signed by Lukhele.

When he asked her about it Lukhele quickly told the court she did not recall such but confirmed that she did sign invoices.

This then led to Magagula asking the witness if she was lying before court as she was asked several times the previous days and she repeatedly told the court she never signed any invoices. She said she used to sign them a long time ago hence the result of forgetting about such.

This was during former Mhlatane High school principal Simeon Makhubu at the High Court.

The invoice in question was from CB Office Automations as Lukhele also confirmed that the company was working with the school on a number of business dealings.

Furthermore, Magagula said Lukhele did not sign the invoices brought to her by Comfort Hlophe because she did not want to do so, not that her superiors were the rightful people to deal with Hlophe.

"Yes my Lord, I did not want to sign the invoices mainly because I did not see the listed items. I did not bother to ask Hlophe because it was not for me to question him," she said.

Lukhele confirmed that the E150 000 which was loaned to the school to pay for the examination fees was paid in three stages in 2010. She said there was a bank cheque of E60 000, an amount of E50 000 and E40 000.

She said all these monies were cashed by her at the bank.

The defence also asked her to explain how CB Office Automations paid for the incentives it sponsored for the teachers who performed well. However, Lukhele said she was not aware.

Magagula mentioned that the auditor made an error when it tasked Lukhele that she must call the company and demand invoices as they were submitted in 2010 but were misplaced by the school.

SCHOOLS TO FINALLY GET FOOD TUESDAY

HEAD teachers around the country will next week Tuesday heave a sigh of relief as the ministry of education and training will be delivering schools' food rations.

Principal Secretary to the Ministry of Education and Training Pat Muir confirmed this. He, however, said not all schools would receive the food on Tuesday, but that the ministry would follow a schedule in its distribution list, which means some schools will get food later than Tuesday. "Food will definitely be available from Tuesday as the supplier will have the food by then. We have managed to sort out the problems that were surrounding the food crisis and finally food will be available for pupils. The ministry advises that schools that have their own mode of transport pick up their rations from Swaziland Milling," said the principal secretary. Muir said for now, the ministry would be distributing rice and beans to the schools and at a later stage it will be communicated with them on when and how to get the breakfast rations.

It is worth noting that since schools opened for the second term, government hasn't delivered food to any school in the country. The food crisis, worsened in the past weeks where in some schools teachers had to bring food for starving pupils from their homes. It is said teachers became compassionate when some children came

Senior ACC Investigator suspended over ex-minister Sibusiso's case

A senior Investigator at the Anti Corruption Commission (ACC) has been suspended for alleged misconduct.

He is alleged to have leaked confidential and sensitive information concerning former Justice and Constitutional Affairs Minister Sibusiso Shongwe on his corruption case.

Patrick Mooi Dlamini of Makholokholo has however filed an urgent application at the Industrial Court where he seeks an order declaring his suspension irregular and unlawful as he wants to go back to work. According to Dlamini in his founding affidavit, the court should under a Judicial Review of legality, set aside his suspension from work as it is inconsistent with Section 33 of the Constitution of the Kingdom.

Section 33 of the Constitution provides that "a person appearing before an administrative authority has a right to be heard and to be treated justly and fairly in accordance with the requirements imposed by law including the requirements of fundamental justice or fairness and has a right to apply to a court of law in respect of any decision taken against that person with which that person is aggrieved."

He stated in his application that he first held the position of investigator and was later promoted to the position of Senior Investigating Officer.

He submitted that June 29, 2017 while going about his duties in his office, the respondent (ACC) through

Chief ACC Officer Bheki Dlamini approached him and gave him a surprise letter of suspension from work.

Another Chief Officer Sipho Mtsetfwa also approached him and told him that he is being suspended for alleged misconduct and enquired about events leading to the arrest of the former minister Sibusiso Shongwe.

He further accused Dlamini of leaking confidential information as regards the corruption case against the former minister.

"I submit that the person I am alleged to have leaked the information to is Lillian Zwane also of the ACC," he stated.

He submitted in his papers that although he is on suspension with full pay, he however wants to go back to work since he has sensitive corruption cases currently investigating and that staying at home might jeopardise his investigations. He said people investigated for corruption related cases can dispose of evidence he was gathered as he was close to nailing them and that his continued suspension could blow the cases.

He argued in his application that the ACC can continue investigating him for the alleged misconduct while he continues with his duties since he is dealing with sensitive corruption cases.

Dlamini who is represented by lawyer Promise Msibi in the matter has cited the ACC Commissioner as the first respondent and the attorney general as the second respondent respectively and the matter was yesterday postponed by Industrial Court Judge Nkosinathi Nkonyane.

Government runs out of passports again

BARELY four months after restocking government has once run out of travel documents.

Four months ago there was a wave of relief in the country after the ministry of home affairs announced that the country had travel documents again after being without for about five months. The unavailability of travel documents which was dubbed a crisis by others was first reported in November last year and the ministry promised that they would have them before peak season in December but the travel harmened.

Travel documents only arrived

in the country in March this year. Information gathered by this publication is that the ministry has run out of travel documents once again and people who had applied for them beginning of June are being turned back when coming for collections.

People who had been turned

People who had been turned back when they had gone for collections said the officers keep giving unsatisfactory responses and that is when they realised that government had probably run out again.

Acting Principal Secretary in the Ministry Thandi Khumalo confirmed that they were currently not issuing out travel documents but said it wasn't due to a shortage but because they wanted the 30-page travel documents and issue out 60-page ones.

"The ministry has decided to increase the number of pages in the travel document after realising that the 30 pages were too little and people kept coming back for new ones. We are waiting for the 60 page travel documents to arrive not that we have run out," she said.

Khumalo said she couldn't say when the traveling documents would arrive in the country as this was being handled by the PS Anthony Masilela.

"I am not sure when they will arrive as the PS who is currently out of the country on business is the person with the right answers. He is the one working on the issue, he knows best," she said.

POLICE PROBE CHIEF DAMBUZA'S WIFE HARASSMENT

THE harassment of Chief Dambuza's wife is now reportedly being investigated by the police service top brass.

Inkhosikati LaMagagula, Chief Dambuza's wife, was subjected to unbelievable torture at the hands of KaPhunga Police. It is alleged Inkhosikati LaMagagula was found at a family business at Mpophotha Shopping Complex without a valid trading licence.

She was then bundled into the back of a police van and then driven for a long distance at a bumpy gravel road

before later being taken to the Hlatikulu Police Station, where she was made to pay an admission of guilt fine of E500.

It's still unclear as to why the chief's wife was subjected to such kind of torture and as to why she could not be taken to the KaPhunga Police Station as it was known to be the local police station servicing the area.

Reports are that the seriousness and sensitivity of the issue has resulted to those in the police service hierarchy, springing to action with the purpose of finding out what actually happened.

Sources have revealed that the issue is now being handled by the police top brass at a regional level including the office of the regional commissioner as well the station commanders.

Reports are that today there are plans to have a delegation of senior police officers including station commanders sent to Chief Dambuza with the purpose of apologising over the incident.

Apologising

"The plan is to have top brass such as station commanders from the Hlatikulu and KaPhunga police stations sent to meet the chief's family with the purpose of apologising. The meeting is planned to be held tomorrow (today) and this is going to depend whether the chief is going to have time for that," said a source.

Station commanders at the two police stations (Hlatikulu and KaPhunga) have been identified Superintendent Annah Mathunjwa and Assistant Superintendent Pat Kunene.

The two, said sources, will from part of the delegation to meet the chief's family. Others have said the issue at the KaPhunga Police Station come as no surprise to some of the officers as one of those implicated has for a long time been protected whenever there were accusations against him.

"There are some police officers who are keen to see what will happen to one of those who had a hand in the harassment of the chief's wife. Others feel at

least there should be something done to this individual. Transfer of this individual which is highly likely is not going to be a good thing but some want him suspended," said another source.

Confirmed

Deputy Police Information and Communications Officer Assistant Superintendent Phindile Vilakati only confirmed that the matter was now being handled by the office of the Regional Commissioner Wendy Hleta who had only learned about it after reading this newspaper.

"The RC is now handling the issue. I'm not aware that there is now a team to be sent to apologise. What I know is that the RC is handling the matter but how she is going to handle it is something we cannot unpack to the public," said Vilakati.

PM unveils 13-member Health Task Team

PRIME Minister Dr Barnabas Sibusiso Dlamini has announced a 13-member task team to review the capacity of the Swaziland Medical and Dental Council, the working environment of medical and allied specialists and the efficiency of the Phalala Fund.

The task team was announced yesterday at the Cabinet offices, where various Cabinet ministers and principal secretaries were in attendance.

These appointments come after the inter-ministerial consultations that the Prime Minister held with doctors held on June 26. Subsequent to the consultations, a 13-member interministerial task team has been approved by Cabinet. The PM said the task team will examine the legislative terms of reference defining the operation of the Swaziland Medical and Dental Council and assess its present capacity, staffing, resources and effectiveness. He said in making these assessments, the task team will need to examine the management structure of the medical and dental centres. "In this regard, consideration should be given to whether the tripartite system of management is still appropriate. We expect the task team to assess the

Motorists slam council over new parking fees

MOTORISTS have described the parking changes to be implemented by the Municipal Council of Mbabane impractical.

Motorists, who park along the busy Mbabane streets, have concurred with the Swaziland Consumer Association Chairman Bongani 'Bhanyaza' Mdluli that the changes by the council are unrealistic and impractical. This comes after the council through their Public Relations Officer Lucky Tsabedze announced that motorists would be Bongani charge as much as E60 if they were found parking longer than four

hours on short term parking areas. Tsabedze said parking areas around the Central Business District had been divided into two, that is, long term parking and short term parking.

Explaining, he said the long term parking was designed for long term parkers, people who worked in the CBD while the short term parking areas were designed for motorists who had come to run errands in town and would spend four hours or less.

He said the motorists who parked on the short term parking areas regardless of whether they worked in those streets would be charged up to

Motorists who work in the busy streets of Mbabane like Betfusile and Gwamile say the move by the council was impractical and have questioned the reasoning behind it.

The motorists said the move by the council was not feasible as it didn't make sense to them to park far from their places of work. People who work along Betfusile Street are expected to walk as far as 'Phezukwendlu' or in front of TEBA offices.

The motorists said the whole purpose of driving was for convenience but the move by the council was drawing them back to a space of inconvenience. "The whole purpose of driving is to never walk long distance, but now we are being coerced into walking. We want to step on the pavement and walk into our offices not this thing that they are forcing us to do," he said. Another who identified himself as Colani Shongwe said his offices are at Gwamile Street but the street was labelled under the short term parking areas. "What is it that they are trying to achieve? What informed this decision? he wondered. He said the changes were impractical and they would not happen. "We will not be bullied by the council, they must first explain to us what informed the decision," he said,







"The family has our deepest condolences during this most difficult time."



Businesswoman robbers face two more charges

THREE men who were arrested last week for allegedly robbing a businesswoman her pistol and live rounds of ammunition have since been slapped with two more charges including that of attempted murder.

The accused persons, namely; Zakhele Dlamini, Mancoba Ndzimandze and Bongumusa Mngometulu made their first appearance before court last Wednesday.

They are facing a charge of robbery in that they acted jointly robbing one Vivian Williams ofher 9mm pistol, 13 live

rounds of ammunition, a cellphone and cash amounting to E800.

The offence was said to have been committed early last month.

During their second appearance before Principal Magistrate Dumsani Magagula yesterday, the accused were informed of an amended charge sheet which now includes the new charges.

The charge sheet indicates that

the accused person face a charge of attempted murder, in that they wrongfully and unlawfully attempted to kill Williams by shooting her with a pistol with intent to kill

On the last count, the second accused person is charged with contravening Section (3) of the theft of motor vehicle Act 16 of 1991.

He is alleged to have wrongfully and unlawfully stolen a motor vehicle, a Toyota Corolla valued at E14 000, belonging to Jabulile Seya. The offence is said to have

> been committed January this at Mpolonjeni. Following the addition of the charge

of attempted murder, Prosecutor Zanele Mabila stated that the crown now opposes the bail application which was filed by the accused person during their first appearance last week.

The accused were advised to file their application at the High Court. Meanwhile, they were remanded into custody pending committal to the High Court.

SEC IN E1BN ELECTRIC **PURCHASE DEAL**

Currently, SEC is buying all of the electricity it supplies from Eskom, a company that supplies electricity in SA

IN an effort to reduce reliance on South Africa for electricity, SEC has now entered into a deal that will see it sourcing power in the country.

This was revealed yesterday by Minister of Finance Martin Dlamini in the House of Assembly on Wednesday.

He was presenting a preamble on the Swaziland Electricity Company (SEC) Guarantee (Lower Maguduza Hydro Power Scheme) Bill, 2017 before Members of Parliament (MPs).

SEC is a company tasked with the responsibility of supplying electricity in the country.

The parastatal is supposed to enter into the E1 billion deal with Middle Lusutfu Hydropower (Proprietary) Limited, which, according to Dlamini, will be working with Old Mutual Swaziland.

The deal is supposed to last for 25

Middle Lusutfu Hydropower (Proprietary) Limited will be given an authority to operate the Lower Maguduza Hydro-electric Power Plant, which is situated at Edwaleni in the Manzini region, to produce hydro-electricity.

The company will then sell the electricity to SEC, which will then sell it to the public. It is worth noting that the E1 billion will be paid in a space of 25

Dlamini told the House that the company is expected to produce electricity that is more than 20 megawatts. If things go well, the company could produce even more than the 20 megawatts. Dlamini said what was good about the project is that it could use renewable energy, which is encouraged by the international community because it is environmentally friendly.

Currently, SEC is buying all of the electricity it supplies from Eskom, a company that supplies electricity in South Africa. It buys about 300 megawatts of electricity from that company. The deal that SEC is about to enter into with Middle Lusutfu Hydropower (Proprietary) Limited will not make much of a difference. Dlamini said more electricity is still going to be bought from South

The ministry of finance is part of the deal because it has to provide a guarantee to the company to get the E1 billion over the said period, should SEC fail to pay the money. The minister was quick to assure the MPs that there were

very minimal chances of such a situation. He said SEC was buying electricity, without fail from Eskom. It will use that money to buy electricity from the Lower Maguduza Power Plant. According to Dlamini, was that part of the money that goes to Eskom will be used within the country.

After making the preamble, only two politicians made submissions on the

These included Siphofaneni MP Gundwane Gamedze and Minister for Natural Resources and Energy Jabulile Mashwama.

They all hailed the project as an initiative that could help the country in terms of electricity production.

The MPs then adjourned the debate and allowed the Bill to be discussed by the portfolio committee of the ministry of finance.



Prince wants to produce coffee for HMCS

PRINCE Jabulani Dlamini is interested in producing coffee for His Majesty's Correctional Services (HMCS).

Prince Jabulani is interested in working with HMCS in producing coffee, which he claims would help boost the country's income.

The institution could also have income to implement other projects aimed at developing it.

The project, according to the prince, is aimed at enriching both the correctional officers and prisoners with the knowledge of producing coffee. This



could be a great source of income to both the HMCS and the country. Dlamini said coffee could be very productive as witnessed during the coffee production tests with the correctional institution.

"Coffee can be very productive when grown in a proper way and method. In a recent sample that had been done in Matsapha Correctional Services, four bags were harvested in an area of 0.5 hectares.

This means eight bags can be produced in a hectare," he said. The prince said the coffee he was proposing was very important to the health of any human being because it cleaned kid-

...Also wants to produce cow fertiliser

THE prince now wants to introduce fertiliser made from crushed cow bones.

The fertiliser, according to the prince, is made by crushing used cow bones. The bones are crushed using a specialised machine up until they are powdery, and that is the first product.

The powdery product is crushed again in the second phase to an even finer fertiliser that becomes very handy if the soil has been over-used and has lost all its nutritious value and qualities.

Prince Jabulani said the fertiliser sought to improve a situation where-

by the soil is poor and can not produce good harvest yields. He said for this project, he was trained in Germany for two years. He said from this course, he was able to acquire a degree in making fertiliser.

The prince said this type of fertiliser does not come with side effects that affects harvest like the commonly used organic fertiliser. He said it would be a blessing for the Swazi nation to have access to such a product that can not harm crops, producing the harvest yield whilst, restoring soil to its natural nutritious state.

LOMDASHI FARMERS' WAR FAR FROM OVER AS JUDGE RETURNS 50/50 RULE

THE war between two haulage and harvesting groups assigned to harvest 670 hectares is far from over despite High Court Judge Sipho Nkosi having issued an order directing that the two contesting parties be in a 50/50 deal pending finalisation of the case.

This he said would save the farmers from a potential loss which might result from drying of the cane which is now ready for harvest.

The judge was quick to add that this was not the final decision as he needed time to go through the papers presented in court to ascertain the rightful contractor and to reach a final fair decision.

Nkosi stated that Wednesday's session was to find a way forward so that the association does not make losses due to the drying up of cane which is ready for harvest.

"All sugar cane that is required and ready for harvesting should be har-

vested equally on the 50/50 agreement with immediate effect. This order shall prevail until the matter has been finalized in court," he said.

He added that he was not going to make decisions without careful consideration but would take this matter seriously so that a fair judgment is



issued so that no party will waste money on appeal. He further warned parties to respect the court order as the failure to do so is a punishable offence. He stated that burning of sugar is unlawful and evil and should stop as it is detrimental to the economy.

The judgment did not go down well with the members of the association and the Jozana Logistics directors as they were contesting against Kwasabalimi's involvement in the harvesting and haulage of their sugar cane.

While the chairperson of the scheme is complaining that in the previous year the company performed poorly and is still owing the scheme 2 per cent of the total harvest as per their agreements on the other hand Jozana Logistics is accusing Kwasabalimi of not abiding with the 50/50 judgment in the previous year and also bulldozing a share in a tender that was won by the former. It is worth noted that Wednesdays' order has been accepted and found fair by

Kwasabalimi. The dispute saw Lomdashi scheme's sugarcane fields being reduced into ashes causing damage estimated at E2.5 million while some members were hacked and sustained serious injuries last month. This allegedly resulted from the feud between Mantjinga Investment trading as Jozana Logistics and Kwasabalimi.

The parties had engaged the courts where Jozana Logistics was contesting the sharing of the cane cutting and hauling tender with Kwasabalimi as they wanted them stop demanding a share in the tender. They said a previous court judgment had ruled in their favour as it indicated that Jozana was the rightful contractor not Kwasabalimi. They argued that the later judgement which allowed Kwasabalimi to have 50 per cent of their tender had elapsed.

However, Kwasabalimi has been accused of bulldozing 50 per cent of the tender. On Thursday June 28, the court had instructed the scheme to file its responding papers with a resolution concerning the two contractors.

MP Stezi files urgent appeal application against ruling on judicial separation

DESPITE getting a judicial separation from the Magistrate's Court, Dvokodvweni Member of Parliament (MP) Stezi Dlamini insists that he wants out of his marriage from his wife Patricia Mphumelelo Dlamini.

The MP otherwise referred to as Musa Goodman Dlamini of Malindza's application was heard by High Court Judge Cyril Maphanga where he argued that Magistrate Lucia Lukhele erred in law in issuing the ruling on judicial separation.

Legally judicial separation is when a married couple is prevented from staying under one roof at their matrimonial home with one using alternative accommodation far from their home while the marriage subsists. Dlamini submitted through his Lawyer Zonke Magagula that his marriage with his wife Patricia Mphumelelo Dlamini (nee Nxumalo) is already dead and that keeping her under the guise of judicial separation will not do any good.

Instead, Dlamini who has been cited as the applicant in the matter argued that the ruling by the magistrate was only meant to keep him paying for his wife's rentals as she is staying at a rented flat at Ngwane Park.

Making his submissions before Judge

Maphanga, Magagula said the magistrate erred in law in holding that Dlamini deserted their matrimonial home at Malindza and when she made the decision on the judicial separation.

The evidence that was brought before the magistrate according to Dlamini (applicant) was unreliable as his wife (respondent) did not tell the truth when she said he committed adultery with another woman.


Further, Magagula submitted that the evidence given by one Malungisa Dlamini who is a brother to his wife was totally unreliable as he told the Magistrate Court that his sister informed him that the applicant was having an adulterous affair with the woman who happens to be a relative to his wife. He said keeping the marriage was out of the question since they had already separated with his wife, at least for the past five years and that the judicial separation is not healthy for both parties. The respondent had argued that the applicant was abusive and that he feared for her life, an argument that was disputed by the applicant.

He submitted that Magistrate Lukhele should have dissolved the marriage as per the applicant's application as his wife was in an adulterous relationship with another man. Meanwhile, the respondent's representative Lawyer Nonhlanhla Ndlangamandla submitted that the magistrate issued a proper ruling in that the couple

had to sort out something between them which included amongst others property issues and that a final decree of divorce would not be proper at this stage.

She also submitted that the applicant was indeed involved in an adulterous affair with the said woman and that with the judicial separation, the couple might reconcile and rebuild the marriage, a submission that was objected to by Magagula as he stated that the marriage is dead and cannot be resurrected at all. After having heard both counsel, Judge Maphanga reserved judgment on the matter and implored both parties to reach a consensus in as far as the property issues are concerned before he hands down h i s

judgment on the matter.

Wife accused of committing adultery with family driver

MP Stezi Dlamini has claimed that his wife was having an adulterous affair with the family driver who is also their relative.

According to Dlamini (applicant) his wife used to travel to South Africa with the driver Bongani Dlamini

Her lawyer submitted that the applicant did all this all in the name of sleeping with his *inhlanti* as the respondent could not giving birth to a baby boy. Death threats cited during divorce application

PATRICIA Mphumelelo Dlamini alleged in papers during her counter application against the divorce, that her husband once threatened her.

She submitted that at one time, her husband told her to her face that either

of them would end-up in jail or at the mortuary if they continued staying together as husband and wife.

She stated that she was also subjected to assault by her husband while staying together at their matrimonial home at

Malindza.

However the applicant's Lawyer Zonke Magagula when making submissions yesterday, disputed the allegations made by the respondents to that effect.

He said there was not even a single day

when his client became abusive to his wife, but instead each time they had misunderstandings, he resorted to have the matter dealt with by the police or family elders (lusendvo).

Occured.

Magagula said at one time while at Gundvwini, when an altercation occurred, his client told his wife to go with him to the Manzini Police Station where he wanted the police to solve their problem, but his wife would not heed that advice.

Magagula disputed the allegations that there was a time when his clients threatened her by informing her that either of them will end up at the mortuary of jail and that there was no evidence of any assault against her.

"Robbers have stopped attacking residential houses or shops at night. I believe it is because of the active police presence everywhere," he said.


A teacher, Busin Majola said the collaboration of vigilante groups and the police had helped in reducing crime in the area.

GARBAGE IN GARBAGE OUT

THE more things change the more they stay the same, so they say. I was impressed this week when National Commissioner of Police Isaac Magagula read the Riot Act to new recruits at the Police College in Matsapha.

I really admired the commissioner for his high-energy kick-dust kind of address to the aspiring police officers. That was so typical of Magagula; so full of energy, vigour and passion. That's a true policeman.

Magagula told the recruits in no uncertain terms that he will not tolerate people who have joined the police service because of empty stomachs and to earn a salary, saying policing was all about being a calling.

He said officers who have joined the organisation to earn a salary were the main culprits in corrupting the entire police force.

They are the rotten potatoes, so to speak. Therefore, during his hair-dryer kind of address to the recruits the commissioner told them to shape up or ship out. I can understand the commissioner's passion. To an extent, I feel for him because I know very well how much he loves his job.

And I know very well how much he gets affected by seeing screaming headlines in the daily newspapers about corrupt officers.

The sad reality is that finding a police officer who has joined the police force as a calling these days would be similar to finding a virgin

at the maternity ward (as my dear friend would say). Chances are next to zero.

People are hungry outside Mr Commissioner. That's the plain truth unfortunately. Jobs in the security forces have not only proved as the best alternative these days but come with the kind of job security that you can hardly find anywhere.

But that's not the main thrust of the article today. The main concern is with regard to the recruitment process itself.

We know what happened in the army recently, so I won't bore readers by reciting what's probably the biggest recruitment scandal witnessed in the security forces in recent times.

Many a poor Swazi child is still licking their wounds in frustration and probably contemplating the worst after they had to be pulled out of the army training base at Mbuluzi because of a recruitment gaffe. Which is exactly where the real issues are with our security forces. So many people have suddenly become more desperate for jobs such that they are willing to pay anything just to get in the security forces.

So, Magagula can rant all he wants but the fact remains, the police jobs have become such an attraction for Swazis.

Gone are the days when jobs in the security forces were reserved for those who were last to raise a hand in class. Or when the same jobs were for people who grew up admiring being in the security forces.

In short, those who had a calling. It's the same all over. You cannot go to the Mbabane Government Hospital nowadays and expect to find nurses who had the calling of the Florence Nightingale nursing principles.

People are hungry and somehow have to find jobs to feed themselves. Which probably explains Prime Minister Dr Sibusiso Dlamini's concern with the way nurses treat patients at the hospi-

But that's a topic for another day. The reason I was citing that issue was to illustrate to the police chief that it may not entirely be his fault that the country is littered with so many corrupt police officers. Yes, he may be partly to blame

because of the system that allows such corrupt officers to get into the force in the first place. But we know what goes on in the recruitment processes and the cause of these problems. I believe if

screws could tighten at the recruitment point, then we

wouldn't be even discussing this issue. Of course, the dwindling economy of the country is also to blame for this problem, because people somehow find themselves having to go to the security forces.

And, as the commissioner rightly said, it is these people who go to the forces as an alternative that often cause the problems.

Somehow you cannot blame the crooked officers at the same time, because they are just being themselves. I mean we can't expect more from such people because afterall they become exactly what they are in society, nothing more nothing less. In short, garbage in garbage out. You cannot recruit a thug and

expect a priest to come out of that in the year's training at the Police College.

That is practically impossible.

If it's fake, it's not news

PRETORIA - Bra Joe Thloloe, director of the SA Press Council and legendary Editor, recently made the following remark that stuck with me at a panel discussion about so-called

fake news. "If it's fake, it's not news," Thloloe said and pleaded with the public and the media to stop using the phrase "fake news".

The term has become a magical, allencompassing phrase to describe a range of things: from patently false clickbait websites to legitimate news publications you don't agree with (think Donald Trump and Mzwanele Manyi).

I participated in a fascinating discussion about the issue at the National Arts Festival in Grahamstown this week and was again persuaded that "fake news"

should fall. The term simply doesn't help us grapple with the plethora of issues it tries to encapsulate.

The extremely helpful online resource First Draft News has distinguished between seven types of mis- and disinformation they believe are lumped together under the banner "fake news". I believe there are more than seven categories, but it's a useful starting point:

- 1. Satire or parody. "No intention to cause harm but has potential to fool." Think of a Zapiro cartoon, meme or the satirical American "news" website The Onion. The aim of these forms of media is to entertain and comment.
- 2. Misleading content: "Misleading use of information to frame an issue or individual." These publications or plat-

forms don't publish false news, but mislead their audience by portraying the facts in a skewed, biased manner. I would argue that the patently biased coverage of politics by the Gupta-owned ANN7, that clearly propagates President Jacob Zuma's faction in the ANC, falls under this category.

- 3. Imposter content: "When genuine sources are impersonated." This could be a comedian or publication that deceives its audience by pretending to be or speak on behalf of a real source. It's not harmful if clearly identified and understood by the audience.
- 4. Fabricated content: "News content is 100 per cent false, designed to deceive and do harm." This category was classically defined as "fake news" before

the water became muddied by Trump and other enemies of the truth. Several local websites like Mzansi Live or City Sun qualify under this category. They publish patently false stories, often referring to celebrities or politicians. Their content is distributed on social media networks like Facebook and Twitter by trusting readers and they make money by selling clicks to advertisers on Google.

- 5. False connection: "When headlines, visuals or captions don't support the content." This is a common complaint against legitimate sources of news, who are under increasing pressure to lure clicks by using sensational head-
- 6. False context: "When genuine content is shared with false contextual information." Publications with strong ideological biases often publish stories that suit their agendas, confirm their prejudices and serve as an echo chamber. A local example is Maroela Media,

a publication owned and operated by Afrikaner lobby group AfriForum which focuses mainly on (true) news articles about crimes committed against white victims, but largely fails to report on crime committed against black victims. The consequence is the existence of false perceptions that a genocide against white people is underway, particularly on farms.

7. Manipulated content: "When genuine information or imagery is manipulated to deceive." Examples could include the selective use of quotations by politicians to suit a pre-determined narrative or the manipulation of photos to aggravate or falsely portray an event or incident

Mis- or disinformation is of course nothing new. Apart from number four -fabricated news, which is intrinsically linked to the business model of digital media - the remainder of the "offences" are as old as the news. In another time, we called it "bad journalism". News24

WE the public are still to be educated on what is the ultimate benefit to the motorist or rate and taxpayer of ever -increasing costs of parking in the country's cities.

With the uncontrollable influx of substandard vehicles condemned in Asian markets but a can't-do-without luxury to the poorly paid majority of this country, Swaziland is becoming home to among the largest fleet of imported cars in southern Africa that compete for the limited services that the urban governments can hardly ever afford.

The only thing we hear, however, is the announcements of increased parking rates without the equivalent improvement in service delivery or in capital investment with a view to develop the economy. The proceeds from the street collections only seem to enrich harvesters of the parking moneys. We are still to be educated better on why the municipalities decided to privatise this service in the first place if at all it was essential to manage the traffic congestion problems they are currently failing to manage. Attack

This is no personal attack on the municipalities of Mbabane and Manzini but believe you me they still owe me the reasons why they opt to privatise or outsource services which by the nature of the establishment of urban governance they must be providing to the public at affordable rates.

If you may ask, first they privatised the abattoir services in both cities making urban meats unfit because they are most likely slaughtered in forests and smuggled into the shelves without undergoing the necessary inspections all because the cities closed down those services and the most ludicrous reason given was that the abattoirs were not profit making as though they were instituted to make profits in the first place.

Parking

Now back to parking management; these services are also in private hands and the companies enjoying the harvesting of profits much to their growth at the expense of improved urban ser-

If these moneys generated by the private companies were generated through efficient urban government management systems instead of enriching others, we would have been evaluating the capacity of our municipal service system in terms of delivery to the people and not in terms of giving business to friends and acquaintances through corrupt tendering processes.

This is not directed specifically to city parking management systems but to the rest of other service delivery assignments of urban governments.

When the garbage processing services were privatised we had thought it was a learning curve for the urban governments to one day take over the responsibility and make savings for

We are afraid that the municipalities, in the quest for profits, will privatise the sanitary services (toilets), another service that is always wanting with major sections of the cities already having given the responsibility to the private sector.

At the going rate we shall see municipality executives only sitting in office to swing in chairs, globetrotting, spending quality time in breakfast and dinner meetings, managers driving sleek cars throwing their weight about the

The cities now require even a new parking meter system that do away with parking meters altogether and put an end to informal car guards.

This was after it had been noticed that the system then used had a number of drawbacks and did not address the challenges associated with the proliferation of informal car guards.

The situation may also be comparable to the experience of driving or walking in Tokyo during the rush

But Swaziland is a very poor country with ample space that it has not made good economic use of in the past 50 years of independence. Instead it has opted to import metropolitan crises to itself by not closing in on the management of its cities.

REN RAISED BY SIN THERS DO NOT SUFFER

Children brought up by a single mother do not suffer compared to those from a traditional nuclear family, a study found.

Many women without partners now choose to start a family alone, with 4 675 females choosing to become pregnant by donor insemination in 2014.


Some experts have expressed concerns that children brought up by a single mother may not do as well because of a lack of a father figure.

But a new study has found that children brought up by a singlemother-by-choice do not suffer from poor well-being in comparison to those brought up by two parents.

CHILD'S **WELL-BEING DEPENDS ON BIRTH MONTH**

Your child's well-being at school could all depend on what month they are born, according to new research.

A study has found children who are the oldest in their class are less likely to struggle with poor mental health. Poor mental health refers to range of behaviours, including struggling with worry and fear and finding it difficult to make good relationships with schoolmates. Researchers believe the additional stress of keeping up with older peers could prove a 'tipping point' for children who start school as one of the youngest in their class. They added children who were born prematurely or have learning difficulties are a particularly high risk of falling behind their peers.

Absence of father did not impact well-being

RESEARCH assistant Mathilde Brewaeys, from the University of Amsterdam, said: 'Children in both family types are doing well in terms of their well-being.

"Single-mothers-by-choice and their children benefit from a good social support network, and this should be emphasised in the counselling of women who want to have and raise a child without a partner." She added that the wrong assumption that growing up without a father is not good for children is based on research into divorced families who have experienced conflict.

"However, it seems likely that any negative influence on child development depends more on a troubled parent-child relationship and not on the absence of a father,' she said.

'Single-mothers-by-choice knowingly make the decision to raise

their child alone, in contrast to stress between family types. unintended single mothers"

How was the study conduct-

The study compared 69 singlemothers-by-choice who had knowingly chosen to raise their child alone and 59 mothers from heterosexual two-parent families with a child between the ages of one-and-a-half and six.

Most women in the study were financially stable, had received a higher education and had meaningful partner relationships in the past. The parent-child relationships, mothers' social support network and children's well-being were compared with family types.

What did the study find?

The study found there were no significant differences in emotional involvement or parental But single-mothers-by-choice

were more likely to have a large support network made up of family, friends and neighbours.

And children of single mothers are no more likely to show signs of problem behaviour than their counterparts raised in traditional families, the study found.

The researchers said that this finding indicated that children from single-parent families aren't more likely to have poor wellbeing than their peers.

Children growing up with single-mothers-by-choice appeared to enjoy a similar parent-child relationship as those in heterosexual two-parent families.

The findings were presented at the 33rd Annual Meeting of the European Society of Human Reproduction and Embryology in Geneva.

STEPPING into the ring is the best way to shed the pounds, a new survey has revealed. Boxers can burn 800 calories over an hour in the ring - making the sport the most effective sport for weight loss, according to the research.

Squash was the second most effective sport for weight loss, allowing players to burn 748 calories an hour. In comparison, sex burns 200 calories an hour for a man but just 138 for a woman, the survey found. The results are from a new survey of healthy men and women, who recorded how many calories they burned while doing a range of physical activities.

Weak currency can boost job creation, manufacturing

A weak domestic currency is a tailwind for even the smallest export business because it makes goods and services more afford-

It was on this basis that Standard Bank Head- African Research Phumelele Mbiyo said he hopes the lilangeni/rand could remain weak long enough so that there could be a shift from thinking about the currency only from a consumer perspective to a production point of view.

From a production point of view, Mbiyo said a weak lilangeni/rand boosts the productive capacity and the competitive potential for local based manufacturers.

"So my hope is that all this negativity keeps the rand weak for us to think less about consuming foreign produced goods and more about producing more goods from our local markets," he said.

He was speaking during the Standard Bank Investor Services meeting held on Wednesday at the Royal Villas Hotel in Ezulwini.

Mbiyo said at the moment their view on the lilangeni/rand was not particularly concerning.

"When you look forward to the next year and a half, it doesn't seem likely that the rand will sell off significantly," he said.

Mbiyo said their view on the lilangeni/rand was that it will trade between E14 and E15 next year against the dollar.

Fundamental view

On a fundamental view, Mbiyo said it does seem that the local unit was undervalued.

"When you estimate the fair value of the rand on the basis of purchasing power parity, the rand should be stronger than what it is right now by 50 cents to E1. When you look at the real effective exchange rate of the lilangeni/rand for a while it was more than two standard deviations below the long term average, it was quite weak on a total basis. By looking just at those two matrixes, it was evident that the rand was much undervalued," he

However, he also acknowledged that there were significant risks to the lilangeni/rand.

These included in part, politics and mainly the local currency ratings of the Republic.

Just recently, the lilangeni/rand hit a seven-week low against the dollar on Wednesday, after the

All in all he said about \$17 billion was foreign currency investor holdings of local currency bonds

was also more likely to also sell down if South Africa were to be thrown out of various global indices.

"This threat is the biggest downside risk for the lilangeni/rand. Not whether foreign currency ratings is cut and South Africa is rated junk, it's the local

currency rating that matters most," he said.

Therefore, Mbiyo said the pressure on the local unit would come from the billions that might then leave the South African bond mar-

With regards to political risk, he said it matters.

"It matters so much in terms of providing direction on economic policy going forward. But what ultimately matters is whether or not South Africa gets downgraded such that it is thrown out of these indices," he said.

Even with that said, he said their core view was not particularly worrying.

"We are also pretty confident that the central bank is not going to continue to raise interest rates. We are also slightly more optimistic about the inflation outlook of South Africa than the central bank is. We think inflation will fall close to 4.5 per cent by the first quarter of next year and then perhaps gradually rise, but still remain between the 3-6 per cent target band over the course of 2018," he said.

Considering these factors, Mbiyo said the risks were shifting towards

Being within the same Common Monetary Area (CMA), the same could be said about the country.

"This outlook for South Africa is not inconsistent with developments in Swaziland. It will be justifiable in our view for monetary policy to be easing in Swaziland," he said.

Govt raises E134.5m under SG30 bond

GOVERNMENT has been able to raise E134.5 million from the auction of the SG030 bond.

The auction for the seven year bond was held on June 27.

According to the Central Bank of Swaziland (CBS) bond auction results announcement, the total amount on offer for the bond was E150 million.

The settlement date was set on June

30. The bond was issued by competitive multiple bid auction and was open to the public including individuals, corporate and institutional investors.

The CBS reported that the total allotted was E134.5 million, competitive bids received amounted to E196 million and competitive bids accepted amounted to E133 million.

Non-competitive bids received amounted to about E1.5 million.

The annual coupon rate was placed

at 10.25 per cent and the maturity date will be June 30, 2024.

"The purpose of the issuance is to develop the secondary market, establish a fair market price which will compensate both the borrower and investors for interest rate risks and to facilitate financial intermediation, whilst also meeting government budgetary requirements," said the CBS.

Just recently, government had also announced a launch of the inaugural E2 billion infrastructure bond programme which is expected to run between three and five years, wherein government will be tapping into the market at regular intervals when there is a need to finance infrastructure programmes.

The project sectors to be financed under the programme include Micro-Projects, the Technology Park, Roads Infrastructure and Nhlangano Water Supply.

Minister of Finance Martin Dlamini said the bonds under the E2bn infra-

structure programme would run concurrently with the normal issuance programme as both issuances play different roles towards the development of the economy.

"The plain vanilla bonds are meant to create the yield curve for the market and are used as a benchmark for pricing by potential borrowers when they source funds in the capital markets. This programme is mainly focused on the development of the financial markets," he said.

SIA SENDS STERN WARNING TO UNREGISTERED CAS

THE Swaziland Institute of Accountants (SIA) has issued a stern warning against unregistered chartered accountants.

"As a professional body we stand fully against any individual who practices in the profession without being registered. There are different bodies that subscribe under us as an accounting profession and as a regulating body we want to make it clear that these unregistered individuals will be fined," said SIA Executive Director Barnabas Mhlongo.

He said the International Federation of Accountants (IFAC) urges accoun-

tancy bodies worldwide to unite with various professions, the business community, governments, regulators, and other organisations to maintain professionalism.

"Both accountants and auditors perform their respective functions on these bases of international standards of practice which have clear guidelines in identifying, for instance, indicators of fraud and other irregularities, and reporting these to the highest levels of authority," he said.

Mhlongo said if auditors, chartered accountants, registered accountants were not registered they will be guilty of an offence and liable on conviction to a fine not exceeding five thousand Emalangeni (E5 000) or three

years imprisonment or both.

"We would like to further urge members of the public to bring to the attention of the SIA any person they suspect to be carrying on as an Auditor, CA(SD) or RA(SD) and are not registered with SIA.

"This will help us better fight corruption as a country and improve the standard of the profession. A strong, consistent, and persistent advocacy effort is, therefore, essential. Clear communication and engagement with stakeholders, such as the government, businesses, citizens, and students is a priority to secure buyin of these groups," he said.

NAMBOARD NAMES FRESH PRODUCE LEADING CROPS

FARMERS in the country have been advised on the products they can focus on when farming. National Agricultural Marketing Board (NAMBoard) Chief Executive Officer (CEO) Siphephiso Dlamini said in general the market and consumer demand determines the type and quantities of fresh produce or crops needed at any particular moment.

"However, most retail outlets (formal and informal) stock a great deal of the following vegetables: spinach, cabbage, lettuce, carrots, butternut, potatoes, onions, tomatoes, green peppers, and beetroot," he said.

"Caution should be observed as fresh produce is perishable; farmers must identify markets prior to planting or at the earliest stage of production to avoid losses due to prod-



uct maturity and available markets," he said.

He said the prolonged drought from the past year still affects the quantities of vegetables and crops produced by farmers. "The country was heavily hit by the drought as vegetable production is mostly practised by small-scale farmers who rely mostly on surface water from rivers, dams, and streams. During the drought season surface water bodies were close to zero per cent in large dams and dried up in most rivers and streams," he said.

As a result, he said the lack of water for irrigation halted vegetable production to a number of farmers in the country, thus reducing the overall availability of locally produced vegetables.

"It was noted that the severe impact of the El' Nino drought that lasted for approximately two years were more pronounced in the second year of the drought where produce declined by over 35 per cent of suitable commodity lines. Cabbages suffered the worst as volumes dropped significantly causing a surge in imports," he said.

However, Dlamini said there has been a positive turnaround due to recently experienced rainy weather conditions.

"Improvement in the amount of rainfall experienced within the last six months significantly improved the availability of water in most part of the country.

"This has led to positive growth in the production of fresh produce (vegetables and crops) from most of the fresh produce farmers in the country. Production yield data is yet to be collated for the 2017 harvest season and indicators show a relatively positive outcome in productions yield and availability of locally produced fresh produce," he said.

THE local stock market has been advised to avail information and enhance liquidity in order to improve market performance.

"Stock market operators and companies should make information available so that investors can evaluate the performance of companies appropriately. So disclosure of information is quite important," he said


On another note, he said it was also important to enhance liquidity in the market to make it easy for people to buy and sell and for market makers to effectively intermediate flows.

"The rate of unemployment among the youth in the country is more than 50 per cent of the labour force, putting every graduate youth at a higher risk of being out of employment for a considerable longer period of time," he said.

ESKOM GETS R20-BILLION LOAN FROM CHINESE BANK

JOHANNESBURG - Eskom today signed a \$1.5-billion (R20.2-billion loan agreement with the China Development Bank (CDB) at a signing ceremony held at Eskom's Johannesburg head office yesterday.

The facility will form part of the financing of the Medupi power plant.

Eskom's interim group CEO, Johnny Dladla, said the deal showed investor confidence in the utility and South Africa.

"The conclusion of this second loan agreement continues to demonstrate financial markets' confidence in Eskom and South Africa notwithstanding the challenging market conditions. We are confident that the

agreement will cement Eskom's relationship with the CDB.

"This loan will also aid us in ensuring that we complete the Medupi project and ensure the security of energy supply," he said in a statement.

Eskom's Chief Financial Officer, Anoj Singh, added that: "The loan fulfils our intent to diversify Eskom's funding sources; to date Eskom has secured 77 per cent of this fiscal year's funding requirement (including cash on hand). We remain resolute that we will fully execute the required funding for the year. We are confident that our liquidity levels and financial profile will continue to improve and stabilise."





ALARMING ACCELERATION IN BUSINESS DECLINE

CAPE TOWN - The Standard Bank Purchasing Managers' Index (PMI) on Wednesday showed private sector business activity in South Africa declined for the third successive month in June, with the rate of contraction accelerating the fastest since April last year.

The bank said its data showed the PMI slowed to 49 points last month, down from the 50.2 points in May, charging that this could be attributed to a reduction in the volume of incoming new business for the first time since October last year.

Contributions

It said new export orders declined for the eighth consecutive month.

Standard Bank forex strategist Shireen Darmalingam said it was worrying that four sub-components of the PMI recorded negative contributions last month which marked the sixth consecutive monthly decline in the index.

"The employment sub-component

reflected the largest decline in June, followed by output and new orders. Stocks of purchases also fell, although its subtraction from the overall index was more muted in June. We expect the index to remain pressured as the SA economy battles with low business confidence and slow economic activity as reflected in the recent recessionary quarter one GDP data," Darmalingam said.

Pressure

The PMI is a composite index calculated as a weighted average of five individual sub-components.

The bank said inflationary pressures in the private sector remained weak last month, despite strengthening slightly compared with May. Input and output prices rose at the fastest rates in four and five months respectively, albeit ones that were still among the weakest seen over the survey history.

On Monday, the ABSA manufacturing PMI also plunged to 46.7 points

last month from 51.4 points recorded in May, largely due to sluggish new order sales and lower business activity. ABSA's PMI business activity index eased to 45.4 points last month from the 52.3 points recorded in the previous month.

Steel and Engineering Industries Federation of South Africa (SEIFSA) senior economist Tafadzwa Chibanguza said the fundamentals of the South African economy remained too weak to support the manufacturing sector.

"At a deeper glance, this weakness is a function of a weak economy. This was also very evident in SEIFSA's first-quarter review of the metals and engineering sector, wherein those sub-industries with lower export-to-output ratios and more reliant on the domestic economy for orders performed the worst and, in fact, contracted in all instances," Chibanguza said.

ANC mulls nationalisation of Reserve Bank

JOHANNESBURG -The ANC is mulling over the idea of nationalising the SA Reserve Bank but says its independence should be guaranteed.

Addressing the media on the outcome of discussions in the economic transformation commission at the ANC's national policy conference, party head of economics transformation sub committee Enoch Godongwana said that private ownership of the SARB was an "anomaly".

However, he said that come what may, the independence of the Reserve Bank should be guaranteed.

Recommendations

"The independence of the Reserve Bank is sacrosanct and there is no intention in the recommendations (from the policy conference) to tamper with that. "It must remain independent." In the lead-up to the policy conference, there had been a strong push to nationalise the Reserve Bank and bring it completely under the control of the government.

But Godongwana explained that, while the Reserve Bank had over 650 shareholders, their influence over the bank's mandate and decision-making was "neither here nor there".

He said even if the bank were to be nationalised, South Africans would still not be able to interfere in its operational mandate.

The proposal will be taken to branches for further discussion before it is again tabled before the national conference in December for possible adoption as policy.

On calls for a state bank, Godongwana said: "Our intention is that by the time we get to the conference, we should have clarified (the formation of a state bank)."

The ANC's national policy conference came to an end on Wednesday.

Households net wealth is same as 2014

DURBAN - The Momentum/UNISA Household Wealth Index for the first quarter of 2017 has shown that households net wealth in South Africa increased marginally as compared with the fourth quarter of 2016, but it is still lower than a year

Momentum, in collaboration with UNISA, measures the wealth of South African households on a quarterly basis. The index showed the combined real net value of all the goods households own (including residential property) and the money they saved and invested increased marginally to R6.99 trillion in the first quarter of 2017, up from R6.96trln in the fourth quarter of 2016. This figure was 1.3 per cent lower than a year ago. The index showed the small quarterly increase occurred for lots of right and some "wrong" reasons, according to the report. "On a macro level the right reason is because the real value of households' assets increased to R8.37trln, up from R8.36trln in the fourth quarter of 2016, which is 0.4 per cent higher.

Retailers under pressure as consumers tighten their belts

JOHANNESBURG - As Stuttafords, the country's oldest luxury brand, prepares to close down next month, retailers are expected to come under pressure with South Africa's technical recession and rising unemployment.

The clothing sector is under severe pressure - as clothing is classified as "discretionary spend" from a consumer's budgetary perspective, meaning that when people are short of cash, they cut back in such areas, Stefan Salzer, a Partner and Managing Direc-

tor of Boston Consulting Group South Africa, said on Wednesday.

Salzer also said the entry of international players such as H&M, Zara, and Cotton On had put more pressure on local players Mr Price, Truworths, Foschini and Edcon.

Salzer believed that the retail industry as a whole was under pressure from the recession.

"Market pressures will remain high, international entrants will stay around - this is the 'new normal' for which the retailers need to plan. "This puts pressure on achievable sales prices - to survive in such an environment, retailers need to be aware of this and offer great value (quality for price) to customers," Salzer said.

He also said retailers had to reduce all extra costs from their operations to remain in a healthy profitability state.

Currency swings

Retailers needed to understand their customer segments in detail to design their product range into the right "sweetspot" between low prices and

high quality, he added.

"Given the fluctuation of the rand to the dollar and other currencies, they need to plan for currency swings when sourcing product from the Far East," he said. 36One Asset Management equity analyst Daniel Isaacs agreed, saying that companies needed to try to make sure strained consumers could still afford to, and want to purchase their merchandise.

"The affordability comes down to the price and credit available," Isaacs said. *Fin24*



Mining Charter III may be problematic

JOHANNESBURG - While the transformation imperatives in the government's Mining Charter III, which was gazetted last month, were laudable, its unintended consequences are problematic.

Stelio Zakkas, the manager at Monitor Deloitte, on Wednesday unpacked the six compliance areas of the charter during a discussion on the strategic implications of it. It was hosted by legal experts from Deloitte and Webber Wentzel and held in Sandton, Johannesburg, on Wednesday.

He told the 186 member audience comprising mining executives that ownership, one of the six elements which had attracted the most controversy, was the need for right holders to have a 30 per cent plus one black person shareholding within a year.

The 30 per cent target is split between an eight per cent for employees through share ownership schemes, 14 per cent for black entrepreneurs and eight per cent for mining communities. The shares issued to a community must be held in a "community trust", which must be created and managed by the yet to be constituted Mining Transformation and Development Agency (MTDA). Fin24

ANC IS NOW MO UNITED - JACOB ZUMA


JOHANNESBURG-President Jacob Zuma used the start of his closing address at the ANC's national policy conference to emphasise that the party had come out of a week of discussions united.

Hawks HQ burglary linked to probe of Ntlemeza appointments

JOHANNESBURG

Computers and hard drives stolen from the Hawks national headquarters in Pretoria contained sensitive information relating to anti-corruption investigations involving the directorate's disgraced former head Berning Ntlemeza.

The Times has learnt that the electronic hardware stolen on Tuesday night contained information about the apparent irregular appointment of numerous people to senior and administrative positions within the elite crime-fighting unit.

The alleged irregular appointments were apparently made by Ntlemeza, who is fighting his dismissal by Police Minister Fikile Mbalula in the Supreme Court of Appeal in Bloemfontein. Hawks spokesman Brigadier Hangwani Mulaudzi confirmed that an internal investigation into appointments within the organisation was under way.

"It [the investigation] was ordered by acting Hawks boss Lieutenant-General Yolisa Matakata."

A Hawks source said the computers were stolen from the offices

of staff who deal with logistics and human resources.

"It wasn't only the computers taken. It was also the hard drives. There is information there which is highly sensitive about the appointments of certain people.

He said that police anti-corruption officers were investigating certain of these appointments.

"Those that were appointed were not the ones who scored the highest when it came to the employment tests.

They were well below on the rankings, yet somehow they landed up in positions of colonels and above," said the officer, who has insight into the appointments.

The officer, who cannot be named as he is not authorised to speak to the media, said other staff who were being investigated were administrative clerks.

"They occupy positions where they deal with sensitive information. Just because they are an admin clerk does not mean that their appointments must not be above board, especially given the information which they work with.'

"We've been pretty upfront and open on all of those things. What you've got is a few people having a bit of a gripe and a grumble."



TSVANGIRAI CALLS FOR NATIONAL PROTESTS

HARARE – Zimbabwe's main opposition leader Morgan Tsvangirai of the Movement for Democratic Change has called for national protests in the southern African country to demand key electoral reforms ahead of the 2018 polls.

The former Zimbabwean prime ministers told a news conference on Wednesday that the opposition was ready to defeat President Robert Mugabe's ruling Zanu-PF party in elections due next year but the electoral playing field was not evenly balanced.

Without specifying the exact date of the protests, Tsvangirai said the mass action would be conducted

"soon".

Said Tsvangirai: "The MDC national executive today resolved to embark on a national action soon to force Mugabe and his illegitimate government to implement key democratic reforms ahead of next year's elections," said Tsvangirai.

"We want the Zimbabwe Electoral Commission [ZEC] to be truly independent. It must not only be said to be independent but it must act independently."

Last year, Zimbabwean police crushed protests organised by social movements such as #ThisFlag and #Tajamuka and arrested hundreds of protesters in what the opposition and human rights activists described as "dragnet arrests". Some of those arrested are still facing charges in the courts.

Tsvangirai also demanded a new voters' roll before the next elections.

"We want ZEC to ensure that a new voters' roll is put in place in line with the new Constitution and we want the government to adhere to the Constitution in its entirety to ensure that there is rule of law in the country," added the former premier.

ZEC Chairperson Rita Makarau could not be reached for comment as she was not answering her mobile phone.

Twitter reacts to Zambian leader's declaration of state of emergency

LUSAKA – Social media was abuzz yesterday after Zambian President Edgar Lungu declared a state of emergency on Wednesday, following a series of apparent arson attacks in the southern African country.

Reports indicated that the move was likely to trigger fresh accusations of government authoritarianism.

See reaction on social media below "My government has decided to invoke article 31 [leading] to a state of public emergency," Lungu said in a nationally televised address.

"Practical measures as outlined tonight have had to be invoked."

Several fires, including one that burnt down the main market in the capital Lusaka on Tuesday, were described by Lungu as "premeditated acts which if left unchecked could have serious socio-economic consequences". Lungu vowed to take "stringent action" against those he suspected of having caused an inferno that razed the market. He maintained that the market was deliberately set on fire in an act bordering on "economic sabotage".

Political tensions have been high

in Zambia this year after the arrest and continued detention of opposition leader Hakainde Hichilema, a wealthy businessman who has run for president five times.

Hichilema narrowly lost elections last year to Lungu, and has alleged that the result was rigged.

In April Hichilema was arrested on treason charges after his convoy allegedly refused to give way to the presidential motorcade.

He has since been moved to a maximum security prison and it is unclear when he will return to court.

QATAR CALLS FOR DIALOGUE TO RESOLVE GULF CRISIS

LONDON – Qatar's foreign minister called for dialogue on Wednesday to resolve the Gulf diplomatic crisis, accusing Arab states that had cut ties with Qatar of trying to undermine the nation's sovereignty.

"Qatar continues to call for dialogue," Sheikh Mohammed bin Abdulrahman Al-Thani told the Chatham House think tank in London, as the Arab states held talks in Egypt to discuss their next move.

"We welcome any serious efforts to resolve our differences with our neighbours," he said, adding: "we don't accept intervention in our own affairs." He accused Saudi Arabia and its regional allies of "demanding that we must surrender our sovereignty as the price for ending the siege." A group of Arab states led by Saudi Arabia had severed air, sea and ground links with Qatar, cutting off vital routes for imports including food. They also ordered Qatari citizens to leave their territories and took various steps against Qatari firms and financial institutions. The crisis raised concerns of growing instability in the region, home to some of the world's largest energy exporters and key Western allies who host US military bases.

Energy-rich Qatar had been defiant throughout the crisis, insisting it can weather action taken against it.

Top Mali court orders changes to controversial referendum

BAMAKO - Mali's Constitutional Court dealt another blow to embattled President Ibrahima Boubacar Keita over a controversial referendum, saying changes his government wants to make to the national charter require "corrections".

A referendum on Mali's national charter was due on July 9 but was postponed indefinitely in the face of internal opposition in government and following protests by thousands of Malians.

The project is controversial as it would establish a Senate with a third of the seats appointed by Keita himself, leading critics to accuse him of consolidating his own power.

In a decision issued on Wednesday, the court noted that senators had a clear mandate of five years, except for those appointed by the president, whose terms were not specified. "There is room to correct this omission," it stated.

However the court sided with Keita over the most controversial aspect of the referendum - that the vote cannot be held democratically given the state of security in the country's north.

The court stated that given there were no "foreign troops occupying Malian territory," this argument was void.

A separatist rebellion in Mali's north was hijacked by jihadists in 2012, throwing the nation into chaos as they took over key northern cities. A peace deal signed in 2015 was aimed at curbing separatist uprisings but Mali's jihadists did not sign and have continued to wreak havoc despite an ongoing French-led military intervention to remove them.

Meanwhile former rebels still control the city of Kidal, and the state remains absent in large swathes of Mali's north.

Keita has attacked those who accuse him of seeking greater power by saying critics want to derail the nation's fragile peace process, given that the referendum would enshrine certain parts of the 2015 accord into the constitution. *News24*

Indian guru's body to stay in freezer, says court

NEW DELHI - An Indian court on Wednesday allowed disciples of a spiritual guru to preserve his body in a freezer, as they believe he is in a deep state of meditation and will return to life.

Ashutosh Maharaj, founder of the multi-million dollar sect, Divya Jyoti Jagriti Sansthan (Divine Light Awakening Mission), apparently died of a cardiac arrest in January 2014.

But his followers insist he is in a deep spiritual state called samadhi and have controversially kept his body in a commercial freezer at his heavily guarded 40ha ashram in the northern state of Punjab.

On Wednesday the Punjab

and Haryana High Court dismissed a three year old petition by Dalip Kumar Jha, who claims to be his son, and who wanted his father's body to cremate him as per Hindu rituals.

Jha's lawyer, S P Soi told AFP that it was unclear whether or not the court approved the sect's argument that Maharaj was alive."But they dismissed our petition which is disappointing and we will challenge it in the Supreme Court," said Soi.

The court while rejecting their plea set aside a 2014 judgement that had ordered his cremation after doctors confirmed him clinically dead.

His disciples had challenged the court's cremation order say-

ing he had simply drifted into a deeper form of meditation, something he did often in subzero Himalayan temperatures.

The guru, who is in his seventies, established the sect in Punjab's Jalandhar city in 1983 to promote "self-awakening and global peace", with millions of followers across the world and properties worth an estimated \$120m in India, the United States, South America, Australia, the Middle East and Europe.

Jha claims that the guru's real name was Mahesh Kumar Jha and he left his native village in eastern Bihar state in late 1970's before founding the sect.

MOSUL - About 300 Islamic State fighters remain in the small patch of territory still controlled by the group in Mosul's Old City, a senior Iraqi commander said on Wednesday. Lieutenant General Sami al-Aridi of Iraq's special forces told The Associated Press that the militants' hold on Mosul has shrunk to a 500m² area. A large number of civilians are believed to be trapped in the ISIS-run enclave, with around 1 500 fleeing with every 100m advance by Iraqi forces.

Belgium seeks suspects in terror case

BRUSSELS - Belgian prosecutors said yesterday they were looking for further suspects in an emerging terror investigation and that they feared a possible attack."We are still looking for several terrorism suspects," Eric van der Sypt, the spokesman for the federal prosecutors' office, told VTM television. He, adding, "we fear they may feel comered. We therefore fear there could be the same reaction as on March 22 (2016)," said. AFP



'Radicalised workers repatriated

SINGAPORE - Singapore has repatriated two Indonesian domestic workers who were "radicalised" by Islamists using social media, bringing the total number of such cases to nine since 2015, the second minister for home affairs has said. Authorities in the city-state said last month they had detained the first Singaporean for suspected Islamist radicalism as concern grows about the spread of the Islamic State (IS) group in Southeast Asia. The government has reiterated over the past year that the island nation is a target for Islamist groups and has urged the public to be alert. *Reuters*

G20 protesters dispersed

HAMBURG - Riot police used a water cannon overnight on Tuesday to disperse several gatherings of protesters ahead of the G20 summit in Hamburg. Police first dislodged protesters who had set up tents in a park in the western district of Altona, according to police and media reports."This is not a legal rally but unauthorised camping," said a police spokesman. Master P Drops single on his birthday



"People will soon know who these people are and what they do. They go for soft targets. These are trumpedup charges borne of people who have scandals of their own and are









THE British Royal Family is the oldest monarchy in the world. But with the pomp and ceremony of its many traditions, some question their purpose in the 21st century.

We meet some of those young people in London, Kenya and Bratislava. Philip was also a founding member of the World Wildlife Fund and has been speaking out about the environment for decades.

Prince Charles is one of the biggest charitable entrepreneurs on the planet.

He's raised hundreds of millions of pounds for his charitable causes. The Prince's Trust began 40 years ago - it's now the biggest charity network in the UK helping countless people start new careers

and businesses. 'The Royal Good Guys' tells the story of a convicted drug-dealer who turned his life around thanks to a grant from the Prince's Trust. He started his own software company that he later sold for millions of dollars.

Works

The Royal Family's approach to charity work changed in 1981 when Prince Charles married Lady Diana. Diana was well known for her hands on approach to her charitable causes, famously visiting with people suffering with HIV Aids. After her untimely death her sons William and Harry decided to carry on with her good works.

Prince Harry created Sentebale, a charity in Africa where HIV affects one in three children. "I think that Prince Harry is certainly trying to model himself on the way that his mother approached charity, he wants to continue that legacy. He's not afraid to speak about what she did." says Robert Jobson, royal commentator. Harry is also the driving force behind the Invictus Games, an organisation that gives wounded soldiers a chance to recover through sport.

Prince William is patron of Centrepoint, a homeless charity that was close to his mother's heart. We see him singing at a fundraising gala with Jon Bon Jovi and Taylor Swift. He also works with Tusk Trust and WildAid to save Africa's wildlife from poachers enlisting help from sports stars Yao Ming and David Beckham.

In 2011, William, Harry and Kate created The Royal Foundation to take a more business-like approach to charity. We attend the launch of their latest initiative, Heads Together, supporting mental health; it will be the 2017 London Marathon's official charity. The four royal charity entrepreneurs raise millions of pounds and help millions of people-and in so doing, hope to ensure the survival of the British Monarchy.

MANCHESTER - Manchester United have agreed a fee of around £75m to sign striker Romelu Lukaku from Everton, according to British media reports.

The 24-year-old, who joined Everton permanently in 2014, scored 25 goals and provided six assists in 37 league games last season to finish as the league's second highest scorer. His exploits helped Everton secure a seventh-placed league finish.


The Belgium international rejected a new contract at Everton in March and has since been linked with former club Chelsea and German champions Bayern Munich.

Lukaku said that he had decided on his future in June and now looks set to reunite with United Manager Jose Mourinho, under whom he played at Chelsea.

Media reports also suggest that Lukaku's deal will have no impact on United forward Wayne Rooney's switch to Everton.

Klopp upbeat over improved Liverpool

LIVERPOOL - Liverpool can handle the pressure of opening their Premier League campaign and taking part in a Champions League playoff within the same week as they have a stronger squad than last season, Manager Jurgen Klopp has said.

Liverpool's fourth-placed league finish sealed a spot in the playoff round for next season's Champions League, the first leg of which will be held on August 15-16, with the second leg to be played the following week.

The Merseyside club start their league campaign on August 12 at Watford and Klopp believes that they can make a good start and seal a return to the Champions League after two seasons.

"We all know in a few weeks we have these qualifiers and there will be pressure on the game," Klopp told the club's website. "But now we have the time to prepare for this and we have to use the bases we created last year.

EICESTER CITY SIGN IBORRA

LONDON - Leicester City have made defensive midfielder Vincent Iborra their second summer signing after agreeing a deal with Sevilla.

The Foxes have put their faith in the 29-year-old Spaniard by giving him a four-year contract and paying out a transfer fee of around £15million, although the club said it is undisclosed.

Iborra, who stands at six foot three, had spent four years with Sevilla and played both legs against Leicester in their Champions League Round of 16 clash last season.

He played 172 games for the La Liga side and won the Europa League on three occasions, but now is tasked with taking Leicester back up the Premier League table.

Iborra, who began his career at Levante, is the Foxes' second summer signing after centre back Harry Maguire joined from Hull City for £17m, and



the club say he will immediately go out to join the preseason tour of Austria.

Iborra told the club website: "I'm very happy to be here with Leicester City and I'm looking forward to experiencing the Premier League with my new team-mates next season.

"Everything about this club seems good and it's been great to meet my new team-mates. I've already spoken with them about the city and the club so I can't wait to get started."

West Bromwich Albion and Sunderland have also watched Iborra, who helped Sevilla to a fourth-place finish in La Liga last season, but he was free to leave after they resigned Ever Banega from Inter Milan. Leicester Manager Craig Shakespeare said, 'I'm absolutely delighted that Vicente has joined us. He's player with such a good pedigree from his time in Spain with Sevilla and he adds some really strong competition to our squad." Daily Mail

Anderson, Klaasen advance at Wimbledon

LONDON - South Africa's best have got off to a great start on the grass at Wimbledon.

Kevin Anderson surged through to the third round on Wednesday, with a comfortable win against Andreas Seppi (ATP 87), 6-3 7-6(4) 6-3

SA's top doubles player Raven Klaasen and his American partner Rajeev Ram also bagged a straightforward first-round win.

Anderson continued to dominate with his serve as he did in the first round, as he fired off 16 aces. After struggling with some niggling injuries after his phenomenal French Open run and a lacklustre appearance at Eastbourne, which provided Anderson with just two matches on grass before Wimbledon, the South African number 1's prospects were looking dull.

However, Anderson's section of the draw has opened up significantly, as he ousted the dark horse of Fernando Verdasco in the first round. *Independent Media*



WIMBLEDON FINES FOR TOMIC, MEDVEDEV


WIMBLEDON - Wimbledon bad boys Bernard Tomic and Daniil Medvedev have been fined for "unsportsmanlike conduct" following their controversial behaviour at the All England Club.

Tomic was hit with a £11 600 (\$15 000) fine after the temperamental Australian claimed he was "bored" during his lacklustre Wimbledon first round defeat against Mischa Zverev.

In an astonishingly frank press conference, Tomic also admitted he called for the trainer even though he was not injured to try to disrupt his opponent's momentum.

The International Tennis Federation responded by taking a significant chunk of the world number 59's £35 000 earnings from the tournament.

The 24-year-old's level of effort has frequently been called into question, and he said on



Tuesday: "I couldn't care less if I make a fourth round at the US Open or I lose first round.
"To me, everything is the

same. I'm going to play another 10 years, and I know after my career I won't have to work again. *AFP*



SUSHI DEMAND AT WIMBLEDON

WIMBLEDON - The world's top tennis players are ravenous for sushi, with Wimbledon catering chiefs having to lay on twice as much of the Japanese dish this year to meet the growing hunger.

Pasta was the traditional carbohydrateheavy dish of choice for tennis professionals but demand for sushi at Wimbledon has doubled year on year, said Anthony Davies, the All England Club's head of food and beverage.

BOTSWANA TO HOST 2018 COSAFA CUP

SOCCER-SWAZILAND has again been overlooked as Botswana will host the 2018 edition of the COSAFA Challenge.

Sihlangu has already returned to the country after failing to win even a single match in this year's on-going COSAFA cup played in South Africa.

This was revealed by outgoing Botswana Football Association (BFA) President, Tebogo Sebego.

"We have been in contact with COSAFA and they reminded us that the 2018 tournament will be held in Botswana. We have since started our preparations and engagements with the government are on going," Sebego said. He further said the BFA could have hosted the tournament earlier, but had to meet some of the objectives. Meanwhile, Sebego said the BFA is worried about the poor performance of the national teams. In the last season, all the national teams (women and men) were taking part in the various competitions but neither managed to qualify for a major tournament, "Our national teams continue to lose in the first attempt of the qualifications. This is due to inadequate preparations; we intend to help in any possible away to stop this grow-

ing trend."
"There is need for adequate staff at



the BFA Secretariat. The BFA should appoint positions that will improve the image of the association. We have proposed a new management structure, that will take our football to the next level," he said. He further said there is a need for a full time legal officer as it is in line with the new constitution.

Still at the gathering, the BFA chief executive officer, Kitso Kemoeng made a case for a motion calling for the Premier League board to be independent. He said there is a need for the board to be made up of individu-

als who are not attached to the clubs. "The BPL board is made up of chairpersons of the clubs. The way it is structured, it does operational matters and that has hurt our game. Independent members should be elected into the board. The individuals should not be involved in day-to-day business of running any club," Kemoeng said. The motion was however rejected by the members thus meaning the chairpersons of the clubs will run the league board management structure, that will take our football to the next level," he said.

NFAS media officer Muzie Radebe said this was in line with the implementation of the project. The NFAS



SIHLANGU DROP 42 PLACES IN RANKINGS

SOCCER – FOLLOWING the 0-0 draw against Niger in the 2019 AFCON Qualifiers and the dismal run in the on-going Castle COSAFA Cup in South Africa, Swaziland has dropped 42 places in the latest (July) FIFA rankings.

Sihlangu dropped from position 90 to 132 this month and this can be attributed to their 0-0 loss in the first leg of the AFCON Qualifier played last month in Niger and the poor run in the COSAFA Cup where the team failed to win even a single match.

Sihlangu lost 1-2 against Zimbabwe in their opening match of the quarterfinals and Felix 'Fela' Badenhorst scored the lone goal for Sihlangu.

They also went on to lose 0-1 in the plate semifinals against Namibia on Tuesday night at the Moruleng Stadium.

Concern

Interestingly, the Pieter de Jongh-led charges were on position 88 before they played their first official match under the new coach and this sudden drop is a cause for concern in as far the national team's performance is concerned.

Noteworthy is that their AFCON 2019 Group L opponent, Niger and Tunisia have moved up with only Egypt dropping by four places.

The pride of the nation, however, remains above islanders Mauritius (1153), Comoros

Nation's pride now is position 132 from 90



(140), and Seychelles (184) in the Council of Southern African Football Associations region.

Sihlangu's next opponents, Zambia have moved up seven places to 92 in the latest rankings, as Germany have moved to the top.

Egypt, Senegal and DR Congo, Tunisia and Nigeria are the top five ranked sides in Africa.

The national team's failure to win a match in the competition means they will compete in the group stages of next year's edition unlike this year where they joined in the quarterfinals.

Resume

The team will on Sunday resume camp in preparations of the CHAN qualifiers against Zambia and the match will be played next weekend at Somhlolo National Stadium.

Coach Pieter de Jongh could not be drawn for comment as his phone was out of network when tried last night.
