

Electricity blackouts was sabotage - SEC

THE Swaziland Electricity Company (SEC) described the electricity blackouts that were experienced in some parts of the country yesterday as sabotage.

A press statement issued by the SEC management states that there was some kind of sabotage on the part of their employees.

"SEC management has learnt with disappointment that some of the network switches have been interfered with, which is tantamount to sabotage. The SES-MAWU executive has been warned that such conduct is a crime and unacceptable. We would like to extend an apology to all our customers and stakeholders for the disruption of power supply and other services over the last two days. This was due to circumstances beyond our control, particularly the unlawful abandonment of work by some of our employees, reads the statement.

The statement states that the company made every effort over the weekend to avert the unfortunate situation by reaching a consensus with the Swaziland Electricity Supply Maintenance and Allied Workers Union (SESMAWU) to have all employees report for work.

"Furthermore, the Industrial Court of Swaziland issued an order interdicting the workers from participating in an unlawful strike action. Unfortunately, these were not heeded to," the statement reads.

It further urges customers who are still experiencing outages to report such to the Call Centre on 800 9000 (toll free line) when using a landline or 25083333 (standard rates apply) when using a cellphone.

"Management has put in place a makeshift team to respond to the customer concerns and this means that our response time may be below normal. We appeal for your understanding and patience while the matter is being addressed amicably," reads the statement.

Blackouts not intentional – Staff

SEC staff refuted suspicions and allegations that they tempered with network switches, which resulted in a number of areas in the country experiencing power outages.

A staff member who did not want to reveal his identity refuted the allegations and said employees cannot do such an act.

Some parts of Mbabane, Manzini, Bhunya and Big Bend reported to have electricity outages from Sunday night up until yesterday afternoon.

"It is still early for us to play that card. We are going to do that if the management fails to cooperate with us. 'Sisatamucisha logesi,' he said.

Meanwhile, social media was abuzz, about the power outages, blaming it on the strike.

Some Facebook users however, condone the act of power outages, encouraging the SEC workers to press on and fight for their bonus.


SWAZILAND Electricity Company (SEC) workers yesterday defied the Industrial Court and engaged in a devastating strike action that left many parts of the country in total darkness for hours.

The workers went ahead with their proposed strike despite an order interdicting them from embarking on such.

The workers left their various work stations and coincidentally most areas were left in the dark and had nowhere to run since their nearest depots had been left empty as workers engaged in the strike.

SEC strike concerns MPs

MEMBERS of Parliament (MPs) expressed concern on the risk the country is being put through by striking Swaziland Electricity Company (SEC) workers.

The legislators' concern was that some areas of the country were already switched off because the SEC workers were on strike.

The bone of contention of the strike is the bonuses, which were demanded by the workers, because they believe they should get them, based on the performance of the company.

The lawmakers stated clearly to Deputy Speaker Esther Dlamini that they were not in a position to sit back and pretend as if everything was normal yet the country was in darkness because of the strike.

Mangcongco MP Patrick Pha Motsa yesterday stood up on Standing Order 58 to move a motion to direct Cabinet to urgently work on the matter because the country could come to a stand-still in a short space of time.

Motsa said when he was driving to Parliament, some areas like Malkerns Research Station did not have electricity.

About 11 MPs had a say on the matter. They all spoke in one voice in directing acting Minister for

Natural Resources and Energy Jabulani Mabuza to act on the matter.

The MPs said if things were to be done their way, Cabinet ministers would work on the matter as soon as they finished Parliament business yesterday.

Siphofaneni MP Gundwane Gamedze said Cabinet should treat this matter urgently because in a few days' time, the rate of accidents would rise because some roads had traffic lights.

This would also affect government because the problem would have to be resolved by the same government.

Nkhaba MP Menzi Dlamini stated that the situation in some areas was bad that some of so his colleagues in Parliament would have to use other forms of power to survive because they could not be able to use electricity in the next couple of days.

LaMgabhi MP Sicelo Jele said he was also affected by this situation. He also received numerous phone calls from Swazis in his Constituency. They wanted to enquire on what the situation on the ground was because they had no electricity. The MP yesterday rushed to a Malkerns SEC depot, where he found that workers were boarding hired vehicles to Mbabane to take part in a strike action. Jele pleaded with Cabinet to work on normalising the situation as a matter of urgency.

MD mum about 2015/2016 bonus

THOUGH SEC employees engaged in the strike action with the hope of getting answers about when they will receive their 2015/2016 and 2016/2017 bonus pay, they were disappointed when the Managing Director Meshack Kunene told them he cannot address the 2015/2016 bonus issue since it was in court.

Kunene told them the only matter up for discussion was that of the 2016/2017 bonuses not the 2015/2016 one as it is currently in court.

Difficult

"It will be difficult for me to address the matter of the 2015/2016 bonus as it was taken to court," he said.

One employee questioned the MD on why he does not withdraw the matter from the court

"SEC has an army of legal advisors, why are they not dealing with the matter in-house, instead of it being in court.

It is time management conducts a little introspection on how they run the company instead of being careless about such issues," he said.

BY SERIOUS BLACKOUT

Some areas started experiencing darkness on Sunday night the day when the SEC workers were preparing for yesterday's wildcat strike,..

Hundreds of company workers assembled at the headquarters in Mbabane demanding their bonuses for the financial years 2015/16 and 2016/2017.

The strike action did not however yield the desired results as the employees returned back to their workstations empty handed without any bonuses, let alone a date on when their bonuses would be paid out by the company.

The court order dated November 5 (Sunday) stated that SEC employees were an essential service hence they do not participate in a strike action.

It further stated that engaging in the intended work stoppage would be in breach of employee terms and conditions of employment.

The SEC employees did not only defy the court order but also failed

A memo which was addressed to "all SESMAWU membership" stated that the strike action should be called off to allow the SEC management to address the issue without jeopardising their efforts.

MD refuses to commit on bonus pay date

SEC Managing Director Meshack Kunene yesterday flatly refused to commit his management to a fixed date for the payment of the 2016/2017 bonus.

Kunene told the SEC employees who had converged at the SEC headquarters that he could not commit on giving them a date on when their bonuses would be paid as the matter is currently before the SCOPE.

He said after the yearly company financials were completed, SEC management met and decided that the employees had done well and deserved a bonus as per the company law.

"After that, the matter was put before the board of directors who also approved of the bonus being paid out. As you may all know that SEC is 100 per cent government owned, the bonuses could not be effected without having the matter being referred to SCOPE for approval.

The matter has been with SCOPE times, but we are hoping that the matter will soon be resolved and we can get the approval to effect the bonuses. You know that at times government processes take longer than normal, but we are

Kunene further said though October 31, which was previously stipulated to be pay day for the bonuses has passed, the company still have an extra two months which they can still make the bonus payment within.

"The company law stipulates that the bonuses may be paid between the month of August and October, and if due to unforeseen circumstances the company fails to pay it, they have an extra two months which they should make the bonus payment within," he said.

The MP said the situation was an eye-opener in the sense that the country should hastily find a solution to use alternative sources of producing electricity. The Dvokodvweni MP said in Mpaka, there was enough coal that could be used to produce electricity to make the country self-sustainable.

Mabuza said they were equally surprised to wake up yesterday morning to be told that SEC workers were striking.

The minister said they appreciated that electricity was a need to Swazis and they would do all they could to work on the matter.

The minister pleaded with the affected parties to ensure that all channels were used before they could engage on a strike action because innocent Swazis would suffer at the end of the day.

I pulled SEC from E70million overdraft - MD

Far from the employees' belief, SEC Managing Director Meshack Kunene said he saved the company from going down.

Kunene was described as lacking leadership skills by the union, stating that he failed to solve problems brought to his office.

Kunene told the SEC employees that when he assumed office as MD, the company was in about E70 million over draft and he pulled the company through. He

said this act also shocked the board of directors, whom, when he made the proposal to give the company's staff bonuses this year, wanted to know where the money was from because as far as they knew the company was struggling financially.

He said it was then that the board approved the giving out of bonuses to the employees after learning that the company made a huge turn around and met its targets.

One employee questioned the MD as to why is that every time he holds MD's position whether fulltime or acting, the employees always face the same problem, which the MD failed to answer.

Meanwhile, the SEC employees urged the company to pay up their bonuses fast otherwise the company will continue to lose millions due to strike action.



EXPLOSIVES FOUND NEAR MPAKA SHOPPING COMPLEX

AMID incidents of Automatic Teller Machines (ATM) bombings by unknown criminals who went away with an undisclosed amount of money, some explosives were found near Mpaka Shopping Complex last Wednesday.

The explosives are said to have been found just under the bridge leading to Mpaka Railway depot, which is situated about 300 metres away.

This is also about 100 metres away from three ATMs belonging to Standard Bank, Swazi Bank and First National Bank which are situated within the shopping complex.

According to a source close to the matter, the explosives are normally used for blasting rocks in the mining industry. They were discovered by a resident who was crossing the rail line just before. The resident is said to have first thought it was some metal which may have been stolen from the railway depot.

Upon a closer inspection, it transpired that the 'metal' had some tiny cables connected to it, something which gave the impression that it could be a ticking bomb. The resident then called the police who made a prompt response.

The source disclosed that the railway line had to be temporary blocked while

police under the Bomb Disposal Unit made an assessment of the area.

It was eventually confirmed that the said metal was indeed a live explosive which was not yet set to make an explosion. The recovery of the explosives was also confirmed by Chief Police Information and Communications Officer Khulani Mamba when sought for comment yesterday.

'It is true that some explosives were found near Mpaka Railway depot last week, and we are currently conducting intensive investigations on the matter,'

When asked whether or not the explosives could be linked with the bombings of ATMs which took place recently, Mamba said so far there was not much information on the matter.

Meanwhile, police said there have been no arrests on the recent ATM bombing incident which took place in Mbabane last week. It is however believed that some Swazi criminals are collaborating with others from outside the country in carrying out the bombings.

SCU staff finally gets paid

STAFF from the Swaziland Christian University (SCU) will from tomorrow start getting their long awaited

The staff of the university which has been recently engulfed by controversy has not been paid their salaries for the past two months after operations were suspended by the ministry of education and training. The staff members which include administrative, academic and support will tomorrow smile all the way to the bank to get their long awaited two months' salaries. SCU Executive Director Sipho Vilakati revealed that the processing of the staff payment is on-going and the first batch is expected to start receiving their salaries today. He said ty has already done all the paperwork and have submitted to the relevant banks. "The banks have been very helpful and have been very cooperative with us in the whole process and definitely some will start getting their pay tomorrow (today). The ministry of labour and social security and the ministry of education have been very helpful too in the whole process," he said. Questioned on when the university's graduation will be held, Vilakati said the university's senate is looking into the matter. He revealed that the senate had their meeting yesterday and part of their agenda was formulating a new calendar for the university. He said the decision to set a graduation date for the final students only lies with senate.

Govt's new cost of living offer hearsay – civil servants

THE latest cost of living adjustment (COLA) offer by government for civil servants is nothing but hearsay.

Civil servants unions say they are unaware of the new COLA offer made by government as there is nothing new that has been tabled on the negotiation

Speaking on behalf of the Public Servants Associations (PSAs) Swaziland Nationals Association of Teachers (SNAT) Secretary General Zweli Mndzabele said they were unaware of the new offer made by government as there was still zero per cent on the negotiation table.

Arguments

"Government hasn't given us a new offer, these reports that we see we regard them as nothing but hearsay because there is nothing new on the negotiation table. We talk about what is on the negotiation table nothing else," he said.

Mndzebele said what was said in court during proceedings was nothing but arguments and submissions so they were good as hearsay he said. "No disrespect to the court but we can't take an argument made in court to be a fact unless it is a court order," he said. He said the only thing they would take from the court proceedings would be an order.

"If the court orders that we are given so much then we will take that as a fact but for now there is still nothing," he

He said civil servants mustn't be fooled as there was still nothing new on the table.

Issues

"Our members mustn't be fooled there is no new offer. The offer that government has tabled remains zero per cent unless we get a court order making the five per cent an offer," he

Government making her submissions in court in the ongoing court case with the civil servants following government's refusal to sign a deadlock in the COLA negotiations between the two parties, said they were now offering the civil servants five per cent.

Mndzebele added that they were still exploring the option of taking yet another of their disputes with government to court. "We are still exploring the option of taking yet another of our disputes with government to court. Our membership hassaid it clearly that we must deal with this issue and elevate it to the courts as well if we need to, as long as government is brought to order," he said. The other issue Mndzebele was referring to was that of senior government officials whose salary grades were reviewed. Civil servants have called for the reversal of these reviews because they are unlawful and unfair.

Woman raped by lover, discovers he's on ARVs

A young woman has been left hurt and devastated after her boyfriend forced himself on her without protection only to later discover a packet of Anti-Retrovirals (ARVs).

The young woman is on the verge of taking her life after her partner did not disclose his HIV status to him. The young woman has laid a rape charge with the police against her boyfriend.

Narrating her ordeal Thuto Mdluli* said she had been in a relationship with her boyfriend Lindelani Nzima* for a while but on this particular day the boyfriend grabbed and forced himself on her even though she didn't want to engage in sexual intercourse with him.

Children

The emotional Mdluli said she discovered a week after this ordeal that her beloved boyfriend who had forcefully had unprotected sexual intercourse with her was on ARVs. Explaining to this publication the events to her terrible discovery stated that it all started when he forced himself on her.

"I went to visit him and he grabbed me, telling me that he wanted me to be his wife. He told me he wanted to have children with me. I told him I was too young for that but he insisted. I didn't agree with him but he still had his way with me," she

Like every other woman who has been raped by her partner in the name of love, Mdluli let this pass and continued her relationship with her boyfriend. She then asked Nzima to get her morning after pills (MAPs) to prevent pregnancy something he agreed to.

"The following morning I went home as he had promised he would bring the MAPs but didn't. He then started

being

funny the whole week because he kept promising he would come see me, which he didn't do," she said.

She said a week went by with Nzima promising to come see her but he didn't.


"I then bumped into him with a friend of his on Saturday in one of the big supermarkets in Mbabane where he said as soon as he was done with his friend he would come see me something that didn't happen," she said.

Mdluli said later that night she went out with her friends and after the party she had them drop her off at Nzima's house. On arrival, Mdhili alleges Nzima tried to have sexual intercourse with her again but this time she was able to stand her ground.

"He then stood up and went out after I refused to have sexual intercourse with him. Before going out he convinced me to stay the whole night so we would talk in the moming but I told him I wanted to talk at that moment and then go home,"

She said it was then that she discovered the shock of her life. "I looked for my cap because I had lost it but instead I found the ARVs which I didn't know he took," she said in between sobs.

Mdluli said it was at this point that she felt her world fall apart. "I realised then what he had done and why he had done it," she said. The betrayed Mdluli said she then went home to tell her mother who advised her to go to the police to lay a charge which she did.



Boyfriend opens case with police

THE boyfriend who allegedly engaged in a brawl after Mdluli raped his girlfriend has filed a case of malicious injury to property with the police against the girlfriend.

The couple is at odds after the girlfriend, Thuto Mdluli* discovered her boyfriend who had forcefully had unprotected sexual intercourse with her was on ARVs.

Mdluli is said to have upon finding the packet of ARVs at her boyfriend, Lindelani Nzima's*house lost her cool and destroyed furniture, windows and everything that she could come across.

According to a well placed source, the couple is said to have been (22) discovered her boyfriend was on ARVs yet the previous weekend he had forced her to have unprotected sexual intercourse.

Mdluli upon finding the pills is said to have lost her cool and damaged everything that she came across. "She vandalised everything that was there," the source said.

When reached for comment, Mdhuli refuted this saying she had only smashed a window using a stone because she was angry and felt betrayed. "I didn't damage everything I just smashed one window using a stone," she said.

HUNTER PLEADS NOT GUILTY TO FLOUTING AVIATION REGULATIONS

PRIVATE Investigator Vusi Hunter Shongwe has pleaded not guilty to flouting aviation regulations in all three counts he is facing.


Shongwe has also pleaded not guilty to contravening the Swaziland Administration Order by allegedly failing, refusing or neglecting to appear before the Ezulwini Umphakatsi when called to answer certain issues regarding his forceful stay as a tenant in his office despite an order by the Royal

Shongwe made these pleas when he made his appearance on his first day of trial before High Court Judge Cyril Maphanga after the Crown represented by Nomkhosi Dlamini had put them to him.

Act

The private investigator is facing a total of four counts in that on the first count he is charged with contravening Section 3 (1) of the Civil Aviation Regulations in that he allegedly piloted a drone while at Mvutjini without being a holder of a valid Civil Aviation licence.

On the second count, Shongwe is alleged to have contravened Section 59 (1) of the regulations in that he flew the same drone in the Swaziland Air Space and thus flouted the Convention of International Aviation.

Shongwe on the third count is charged vened Section 60(1) of the same reg-

with contravening Section 54 of the Civil Aviation Regulations in that while at Mvutjini, he flew the same drone without being a holder of an Aircraft Certificate while on the fourth count he is alleged to have contraulations in that he flew a pilotless air-

Licence

Meanwhile, on the last count he is alleged to have gone against the Swaziland Administration Order in that while at Mvutjini, he refused to appear before the Ezulwini umphakatsi after being summoned by Indvuna Ndlavela Mavimbela on behalf of Chief Sifiso 'Mashampu' Khumalo.

Represented by lawyer Derrick Jele from Robinson Bertram Attorneys, Shongwe remorsefully, pleaded not guilty to all the four counts when they were put to him before the trial commenced.

According to the Swaziland Civil Aviation Authority (SWACAA) Act of 2009, all people who want to fly an aircraft for whatever reasons are supposed to obtain a licence from SWA-

Shongwe reported the drone missing while flying in the direction of Somhlolo National Stadium during

Ester Services where the League of Churches had descended for the annual services and he had claimed the drone cost about E20 000.

Giving evidence in the matter was Terence Tsela of Mbekelweni, who told the court that he had gone for a visit at her granny's place at Mvutjini and was busy with other family members in the maize fields when he noticed the small 'aircraft' and picked it up.

Tsela said upon inspection, he discovered that this was an 'aircraft' which was fitted with cameras and reported same to his elders who advised that they keep the object pending the appearance of someone who would come and claim it.

Tsela told the court that it was not until they heard an announcement through national radio that Shongwe was the owner of the 'aircraft' as he pleaded with anyone who might have come across it to call him through his cell phone.

"Indeed, Shongwe arrived and we gave him the 'aircraft' and that is when he demonstrated to us through his Ipad how it functioned," Tsela said.

Nhlanhla Maphalala also of Mbekelweni collaborated Tsela's evidence on how the drone was found.

Meanwhile Ezulwini Royal kraal elders indvuna Ndlavela Mavimbela and umgijimi Hlalalemphi Vilakati were also paraded by the Crown and stated how Shongwe was summoned on three different occasions to the umphakatsi after his landlord had complained about his continued occupation at his rented offices.

MOB OF 8 PETROL-BOMBS TWO HOUSES, ARRESTED

EIGHT people have been arrested for a mob justice attack at Masekweni village at Lwandle on Sunday afternoon.

The group was arrested after allegedly petrol bombing two houses and also vandalising three more houses belonging to a woman who was accused of hiding two suspects who were wanted by the police. They are Mfanukhona Dlamini (32), Magida Dlamini (30), Machawe Dlamini (51), Mcimba Dlamini (19), Sibusiso Dlamini (22), Menzi Dlamini (25),Banele Dlamini (25) and Mlungisi Dlamini (20). They made their first court appearance yesterday before Magistrate Lucia Lukhele.

All the accused persons are facing a malicious injury to property charge. Information gathered is that the complainant, Nomphumelelo LaNgwenya was accused of having harboured two suspects Sifiso Mavuso (27) and Bongani Mavuso (25) who were on the police wanted list for an assault

they allegedly committed some time back.


The alleged suspects were spotted in the area by a resident who then alerted one of the people who was assaulted with a slasher in the head during the incident, which the Mavuso brothers were wanted by the police for.

The resident is said to have gone and informed the affected parties who came together and organised a mob to attack the homestead where the suspects were said to be hiding.

A mob of about 20 people arrived at Masekweni, which is an area under Lwandle Chiefdom, and ransacked every house at Nomphumelelo Ngweya's place.

The mob which carried every sort of weaponry dragged the woman outside the house and assaulted her with slashers and stones. It is said the suspects fled the scene after causing havoc and came back later at night and petrol bombed two houses.

Sources close to the matter said when the group was not allowed to search each and every house they started breaking down doors to gain entry to locked houses.

The mob is said to have started vandalising whatever they came across as they pelted the place with stones breaking every house window including glass doors at the homestead. Police were called to the scene and eight people were arrested for vandalising five houses. The property

which was damaged during the skirmish is alleged to be amounting to E9 460. The eight accused persons were remanded into police custody and informed that should they want to be out on bail they must pay E1 500 each. They were warned to appear back in court next week Thursday.

Meanwhile, the two suspects who were alleged to be hidden by LaNgwenya were also arrested and charged with assault with an intent to cause grievous bodily harm in that they acted jointly and assaulted Machawe Dlamini (51) by hitting him with a slasher on the head.

The two were also remanded back into police custody and told that should they want to be released on bail they must pay E2 500 each. This brought the total number of people arrested at the burnt homestead to 10.



Acts of vengeance condemned by police

SUCH an incident occurred at a time when the National Commissioner of Police Isaac Magagula has raised his concern on the practice that is slowly taking root in communities.

Magagula condemned such a reprehensible practice of violence in the form of vengeance or retribution whenever people in communities do not see eye to eye on a particular matter. Worth noting is that the people of Moneni and Lwandle communities have a history of mob justice attacks whenever they have disputes.

Just last year about 11 people were arrested when a mob attacked and set a homestead on fire during a land dispute battle that has rocked the area for many years.

This is not the first time that the homestead belonging to LaNgwenya has been under attack as back in 2012 it was petrol bombed by a mob during a chieftaincy dispute matter.

Charges faced by the accused:

Mfanukhona Dlamini (32), Magida Dlamini (30), Machawe Dlamini (51), Mcimba Dlamini (19), Sibusiso Dlamini (22), Menzi Dlamini (25) Banele Dlamini (25) and Mlungisi Dlamini (20).

ty in that on November 5, the accused persons acting jointly and with a common purpose used slashers, knives and stones to vandalise property belonging to Nomphumelelo LaNgwenya.

The accused according to the charge sheet damaged a door valued at E200 and another valued at E220, they also broke a sliding glass door valued at E1 100 and broke windows for five houses which were worth E6 840. The amount of

ED CAPITAL PROJECT GIVES BIRTH TO CONSTRUCTION FIRM

MTN Foundation and TechnoServe officially launched a partnership to the value of E350 000 in March this year.

This was not a first. Last year, MTN Foundation invested E300 000 towards the same initiative targeting young people between 19 and 35 years.

The project seeks to empower young entrepreneurs establish, or expand their current businesses through providing seed capital, training and men-

torship. Covering seven chiefdoms in rural communities, the project has already changed lives, and created employment opportunities.

Celumusa Ngcamphalala (30) is one

happy beneficiary of this project who gladly shares how much value the project has added to his business.

Ngcamphalala ventured into the world of business in 2014. Then, it was low-key as he specialised in drawing house plans. A few months into this trade, he diversified into construction, a highly contested and costintensive sector. The move to diversify was triggered by his clients who often asked him to convene a team of builders to undertake various construction projects.

RELATES JOURNEY IN BUSINESS

BEFORE received seed capital from MTN Foundation through Technoserve, Ngcamphalala was recuperating from a huge loss which he incurred because of inexperience.

Understandably, he was new in the business world, which is essentially a school of knocks. "One of the many challenges I experienced was that I had no equipment. And, timely execution of assignments was a mission. Because of this challenge, I was forced to rent working tools from other people.

In some instances, part of the rented equipment would either be unavailable, or break down while in use. This meant that often, the project deadlines, were often not met. Further, costs would quite naturally escalate, something that made it difficult for me to keep the business afloat," he explains.

However, after Ngcamphalala received funding from MTN Foundation he prioritised securing working tools like a grinder, drill, and a power generator, to mention but a few. And since then, things began to change, for the better. He was nowable to meet project deadlines through timely execution, cutting back on rental costs in the process.

"Additionally, this change allowed me to maximise the money I was saving by not renting working tools. I was able to attract more clients too. Further, through this new business, I have further bought my own brick moulding machine that will help me establish my own block yard," he explains with pride.

Subsequently, his company has been awarded a construction job worth E250 000 - something that has since given wings to his busi-

Ngcamphalala and his team are currently constructing twenty units of bedsitters and two bedroom houses at Siphofaneni. He is also looking forward to securing two construction tenders worth about E300 000. And, chances of securing the construction deal are not just in the horizon.

"I am confident that my business has capacity, and experience to secure this assignment. After all, I am now equipped with less need to rent most of the required equipment to execute assignments. Importantly, I remain grateful for the Seed Capital project jointly implemented by MTN Foundation, Technoserve," says Ngcamphalala. Additional to providing financial resources through MTN Foundation, Technoserve provided training on documenting all business operations, processes and transactions. Ngcamphalalahas also been hand-held through Technoserve's mentorship program.

"This has helped my business grow in the right direction because Technoserve is readily available to provide business counsel which helps guide me on any major business decisions I need to take," says Ngcamphalala.

In two years' time, Ngcamphalala plans to diversify his business beyond just pursuing construction tenders.

"Over time, I am looking at growing into property development. Later on, I see an opportunity to advance into precast business - where I could sell pavers and tiles," concludes Ngcamphalala.

DRUNK TOURIST BEATS GUEST HOUSE EMPLOYEES

A drunk client caused havoc at Crisovik Guest House as he assaulted employees and broke windows over a payment dispute.

The tourist and businessman based in South Africa appeared in court with a bandaged hand and a gloomy face as he was slapped with four counts of malicious injury to property and assault common he committed on Saturday.

Johannes Petros Duplesis (54) of Pretoria was in a remorseful state as he realised his conduct was unlawful and uncalled for.

Duplesis appeared before Magistrate Sifiso Vilakati.

He was charged with intentionally damaging windows valued at E400 by breaking them with his fist. He furHe allegedly refused to pay and fought with the employees by assaulting them with fists and juice containers.

ther confirmed he assaulted three female employees of the guest house using a plastic juice container and his fist.

The property damaged by the visiting man belongs to Larry Sokuu and he was quick to let the court know he was ready to compensate the owner of the guest house by forking out the E400 to fix the broken windows.

Offender

Duplesis, who is in the country for business purposes, was caught up in a misunderstanding with the staff after he allegedly did not want to pay for the room he had booked.

According to reports, the offender went to the guest house while already intoxicated and he caused a commotion when he was asked to make a payment.

He allegedly refused to pay and fought

with the employees by assaulting them with fists and juice containers. He further pushed them against the wall as he refused to follow the guest house's protocol. It is said he then demanded receipts from the employees as proof of payment.

Upon realising that the employees were not relenting, Duplesis then locked himself inside the room and started breaking windows whilst locked inside.

According to reports, he broke the windows because he could not exit through the door.

While in court, Duplesis was represented by attorney Sabelo Chicken Dlamini, who told the court that his client was provoked by the employ-

"None of this would have happened had it not been the manner the employees approached my client. He ended up losing his cool due to how he was treated. My client is remorseful, he understands that his conduct was unlawful," Dlamini said.

Business

He further observed that the actions of his client must have been influenced by being intoxicated.

He admitted it was not good for his defence to highlight such but he revealed his client also got injured during the

"He injured his hand and received about 10 stitches. I plead with the court to exercise its leniency as the offender was in the country for business, he usually visits the country," he said.

Vilakati advised the man not to take the law unto his own hands whenever he is provoked.

"It is saddening to see a man like you conducting himself in this manner. You must refrain from such behaviour," the magistrate said.

Duplesis assaulted Gugu Khumalo with a plastic juice container once on the neck and further assaulted Phindile Gwebu with a fist once on the face and pushed her against the wall. His actions caused the complainants hurts and injuries.

As if that was not enough, Duplesis also assaulted Vuyiswa Dlakudze by pushing her against the bathtub and thus caused her hurts and injuries.

He was fined E500 or five months for breaking the windows and E1 000 or a year imprisonment on each of the three counts of assault common.

However, the court made count two to four to run concurrently.

Children gang up, attack dad

A family has been left torn apart following a dispute between a father and his two children.

This transpired after the children were told by their father to vacate the homestead as they were no longer needed. It is not clear why Duma Msane took the decision to chase his children away from his home soon after the passing away of their mother about two years ago.

However, Msane told the court he noticed lately that his children were plotting to eliminate him hence he told the court he no longer needed them near his homestead.

Relationship

"I know they are my biological children but I have had enough, I do not want to see them coming near my home. They must go away before they kill me," Msane said.

Msane added that he was losing his property at his home due to his children. "Our relationship is no longer healthy as we do not see eye to eye," he added.

He told the court everything seemed fine until the passing away of his wife. He said the two siblings, an elder sister and a boy, teamed up against him.

The siblings denied they were rebellious against their father but said he was the one who was always on their case.

Plots

"He chased us away early this year but we did not go because of the two

school-going children who are still young. We had planned to leave after their done this year and go live at our mother's parental home," Philile Msane said.

She also confirmed that she was not on talking terms with her father to an extent that he no longer provided for them as the head of the family.

However, the court frowned upon the issue which brought the two siblings to court. They are charged with malicious injury to property after Philile broke the windows of the main house occupied by her father. She further attempted to set it alight while her father was locked inside.

National Court President Chief Lembelele Dlamini said he was disappointed at the siblings for failing to show respect to their parent.

According to the father, his son joined the plot as he supported his sister. "We were fighting over a mobile phone charger I had used. My daughter attacked me and assaulted me. We fought as she entered my house and demanded to take the charger," he said.

Msane said he was disappointed with the conduct of his children.

Speaking for herself, Philile said her father pushed her to the ground over the charger which belonged to her. "He assaulted me until I was injured. When my brother arrived, he found me crying and bleeding.

He only came to rescue me, he did not attempt to assault our father," she

Bheki also confirmed he never assaulted his father.

"I was trying to help my sister but my father came out with a knobkerrie and chased after me, I ran away and picked up a stick to defend myself as I was afraid he would hit me. He once threw a bush-knife at me while I was running away from him," he said.

The court said Msane should meet with family and resolve the matter or approach the court for peace binding order. The siblings were each fined with E400 or six months imprisonment. They were further ordered to pay for the damaged windows.

Cops bash us in cells – suspects

TWO suspects bitterly raised their complaints in court over recorded brutal assaults in police cells.

Maswazi Simelane and Fani Simelane told Magistrate Sifiso Vilakati they were brutally assaulted during investigations.

They added they were further humiliated by the police as they alleged the officers took pictures of them while injured.

Injuries

Fani told the court he was heavily assaulted all over his body such that the police postponed his court appearance due to his serious injuries.

"I was taken to hospital by the police; they must explain why I was admitted in hospital if they are denying that they assaulted me. They further did not take me to court as they were scared the court would notice my injuries," Simelane said.

However, the arresting officer, Blessing Mamba denied such allegations. He said every offender had a right to be admitted at hospital if he complained of not feeling well.

"I never assaulted any of the

suspects, I only investigated on the theft case against them and they assisted me by pointing out where the stolen items were," he said.

Items

The second accused person, Maswazi also said he was assaulted in one of the rooms at the Mbabane Police Station. "I was handcuffed during the assault and the handcuffs injured me badly.

They took pictures of me whilst I was being assaulted. I did not go to court for a week due to the injuries," he said. The two are facing charges of theft where they are accusing of stealing 10 car tyres from different cars in

They allegedly stole the tyres at Makholokholo and Thembelihle.

It is alleged they further broke into a shop and stole property that included a printing machine.

The duo pleaded guilty to stealing some of the items but denied some. The investigating officer told the court they pleading guilty to all the items and helped the police in recovering them. He added that one of the suspects, Fani, was still at large when Maswazi mentioned he was with him.

The matter was postponed to Thursday for continuation.

Kaluhleko assassination: How Lukhozi was roped in

HAVING been convinced that the suspects in the KaLuhleko assassination were indeed the ones who allegedly committed the murder offence, the Serious Crimes unit (Lukhozi) was roped in by Bhunya Police.

This was yesterday revealed by Bhunya Desk Officer Detective Inspector Bongani Mhlanga when giving evidence before Judge Sipho Nkosi in the marathon trial.

According to Mhlanga, upon receiving a docket on the murder of Camber Dlamini, he acted on it and his investigations led him to Zinhle Dube who was the second accused Khanya Dlamini's girlfriend.

Khanya was made accomplice witness in the matter and he gave damning evidence against the accused persons Bhekwako Dlamini and Mxolisi Mabuza in as far as the killing of Camber is concerned.

Mhlanga told the court that when Dube was interrogated, she assisted the police and informed him that two of the people involved in the killing were arrested and kept at the Zakhele Remand Centre on another charge of stock theft.

Dube's information also led to the arrest of mkhulu Bhekwako according to Mhlanga, who voluntarily recorded a statement after he was cautioned and positively identified the murder



weapon a Silver Star pistol.

Mhlanga told the court that since the two Khanya and Mndeni Mndzebele were to appear at the Magistrate's Court for the stock theft, he applied that the stock theft case been struck off from the roll since the two were involved in a now serious crime of murder.

The two were also brought to the Manzini Regional Headquarters, where they appeared before investigating officers from Lukhozi and also had something to say after being cautioned and later recorded statements.

Giving her evidence under oath, Dube had related the events that led to the assassination of the Inner Council Member Camber, as she told the court that it all started when her boyfriend

Khanya, was arrested for a criminal offence and was fined two years plus an additional two months or E2 500

Since her boyfriend had no money, Dube said she was approached by the third accused in the matter Mxolisi Mabuza who informed him that the first accused Bhekwako Dlamini was willing to pay for his fine and that she should visit him at His Majesty's Correctional facility to find out how much was needed.

Indeed, she informed Mabuza about the fine and he gave her the E2 500 which he said was from Bhekwako as he paid the fine for him because he wanted a job done for him by Khanya, Mxolisi and Mndeni Kunene, who was referred to as Mdodi boy.

She told the court that upon his release, Khanya was ordered by Bhekwako to come to him in order to be cleansed with muti as he was fresh from jail.

Dube told the court that she was in the company of Khanya when he told him that Bhekwako wanted them to assassinate seven people whom he had differences with and amongst them

"Mkhulu Bhekwako said E20 000 would be paid to Khanya, Mxolisi Umfana and wakaMdodi after killing one of the people in the hit list Linda Maseko and for the killing of Inkhosikati bebatawu badalwa tinsambansamba," Dube told the court.

She narrated that there were two attempts to kill Maseko and both failed as his wife came out of the house each time they went for him.

However, she told the court that after Bhekwako had instructed that Camber be next on the hit list, Khanya, Mxolisi and Mdodi boy successfully carried out the assassination and she was the one who hid the gun after Khanya had been arrested in connection with stock

Khanya in his evidence had told the court that the chief, her mother and five members of the inner council were to be assassinated.

The six targeted persons including Chief Zulelihle and Inkhosikati La Makhungu survived the carefully

orchestrated plot to assassinate them, while Camber could not make it as he was shot and killed in cold blood at his homestead.

He said the old man offered then a silver pistol with 13 live rounds of ammunition and that they should proceed to the deceased homestead and gun him down.

Given the responsibility to use the pistol was Mxolisi Mabuza and after being promised that they would be paid E5 000 plus a cow each, they proceeded to the deceased's homestead.

"Upon arrival at Camber Dlamini's homestead, approached the main door and knocked before he answered the knock and that is when Mxolisi wasted no time, he shot at the deceased five times with three shots hitting the target while two missed," Khanya told the court.

Khanya further told the court that Camber had been killed, Mndeni who had been carrying a note with information on it, dropped it on the ground within the deceased's yard and the note was framing a Malkerns resident. The note contained information to the effect that one Jabulani Nkambule was the one responsible for the killing reflecting that the deceased had sold land to the said Nkambule, a land deal that went wrong.

This according to Khanya was meant to lead all suspicions on the murder to Nkambule who knew nothing about all this.

MAN ASSAULTS FEMALE **NEIGHBOUR FOR NUDITY**

THE Pigg's Peak Magistrate's Court heard how a man (20) who spends all his time with female friends was arrested for assaulting his naked neigh-

The arrest happened at a Simelane homestead in Horo on Saturday evening. Appearing in court yesterday, Thabiso Simelane pleaded guilty to assaulting his neighbour Nhleko Motsa for alleged nudity. "The bone of contention was that I spend a lot of time laughing with my neighbours who are females only, so it makes other females who are not in our group very jealous of me.

On Friday afternoon one of my neighbours was cooking in the kitchen like she usually does during that time, she told me that the other girls in our team were jealous of me because I was pop-

This hurt my feelings so I went back to my homestead but as I was going home four older girls then approached me and started to insult me but I ran home," he said. He said the next day while standing beside his fence Motsa, who was in the company of the four women who had assaulted him the previous day, then stripped naked and exposed her buttocks to his direction.

"This infuriated me and led to me going next door and assaulting her with a stick all over her body. I then went back home and was arrested a few hours later," he added.

A very amused Senior Pigg's Peak Magistrate Siphosini Dlamini told Simelane to try and stop spending all his time socialising with women only. "I see that you spend a lot of time socialising and laughing with women, as a man that is not very healthy unless you don't see any problem with it. I like the fact that you said you will continue to be friends with Motsa but I will have to sentence you to spend two years in a correctional facility if you fail to pay a E2 000 fine for the assault," he said.

Truck driver admitted to E2 000 bail





SOME of the 14 Members of Parliament from the Shiselweni region will face tough and tight competition to return to the August House as some of the constituency headmen and women (*Tindvuna Tetinkhundla*) have set their eyes on being MPs.

It has been gathered that some of the *Tindvuna Tetinkhundla* from the 14 constituencies are already set to contesting for the hot seat with others having even already made their intentions known to the communities.

In other constituencies the working relationship between the MPs and *TindvunaTenkhundla* has become sour after the intention to contest the election was announced.

There are rumours that in other constituencies the tension has become unbearable such that the MP and *Indvuna Yenkhundla* no longer talk to each other.

Any activity organised by the Inkhundla, even if it's an innocent activity, the MP always feels it's a ploy to see the *Indvuna* winning the hearts of the people. Others have revealed that in other constituencies



the MP has advised all those he works with at *Inkhundla* to first alert him on any event in order to see if it was not organised with the aim of 'ousting' him in 2018.

"There are now those MPs who always make sure that anything organised at constituency level he has to be alerted first. They (MPs) fear that there could be some of the *Tindvuna Tetinkhundla* who are organising activities just to send a signal on what they (residents) should expect in 2018.

Some of these MPs want anything organised at Inkhundla to go via them.

Even if it is a minor event, the MPs in some of the constituencies demand to know the agenda," said one of the members of *Inkhundla* council in one of the constituencies.

It has also been disclosed that so uncomfortableare some of the current MPs that others want any activity taking place in some of the areas under their constituencies to be approved

Bucopho from one of the constituencies in the region also revealed that not long ago during their meeting the MP suggested that each one of them should declare which of the categories they were to be showing interest to occupy, come 2018.

"When this year began, our MP wanted each one of us to state which position we would be interested in. It was easy to tell that he is feeling threatened as Indvuna Yenkhundla is the hot favourite to succeed him. We all wondered when he asked us to declare now when elections are a year or many months away," said the *Bucopho*.

Some of the *Tindvuna Tetinkhundla* said MPs were now restless and com-

fortable as they feel threatened by them. "They are of the view that each time they are away in Parliament we take advantage by discrediting them to the electorate.

Most of the time we are the ones dealing with the people directly and-some MPs do not feel comfortable with this at all and others have even decided to plant spies who are to be their eyes and ears on anything taking place," said one of the Tindvuna Tetinkhundla.

Mouthing

Other reports are that some former MPs who are keen to make a comeback in politics now go around badmouthing the current MPs with some also scheming with *Bucopho* and the *Tindvuna Tetinkhundla*.

"At our constituency, there is this former MP who is campaigning already and he badmouths the current MP to the people and even says he was replaced by a failure," said *Indvuna Yenkhundla* from another constituency.

On the other hand, some of the MPs said they were aware how some of the *Tindvuna Tetinkhundla* were desperate to succeed them.

"We are aware and they are doing this under our nose. Some of the people scheming with *Tindvuna Tetinkhundla* and *Bucopho* are those (former MPs) who lost the election and are still bitter," said one of the MPs.

In this age of instant communication everyone seems to be in such a rush to communicate what is on their mind, they fail to realise the value of everything that can be gleaned from the minds of others. Hyatt (2012) says show me a leader who does not recognise the value of listening to others and I will show you a train-wreck in the making"

It is simply not possible to be a great leader without being a great communicator. This partially accounts for why we do not encounter great leadership more often. The big miss for most leaders is that they fail to under-

stand that the purpose of communication is not to just send a message, but to engage and that requires "listening"

Leaders should not be fooled into thinking that being heard is more important than hearing. The first rule in communication is to seek understanding before seeking to be understood.

Communication is not a one way street but a two way street.

Simply broadcasting your message and nauseum will not have the same result as engaging in meaningful conversation, but this assumes you understand the greatest form of discourse takes place within a conversation, and not a lecture or a monologue.

When you ask questions and elicit feedback. Use your vast array of medium of communication and other platforms, toolsets and connections to listen.

In essence, leadership is about action. That said, leaders who act before they understand do not tend to achieve the outcomes they desire.

Hyatt (2012) share some tips on how to become a better listener:

It is not about you: Stop worrying about what you are going to say
and focus on what is being said. Do
not listen to have your opinions validated or your ego stroked, listen to
be challenged and to learn something
new. You are not always right, so you
have to stop pretending you know
everything and humble yourself to
others. If you desire to be listened to,
then give others the courtesy of listening to them.

● You should never be too busy to listen: Anyone can add value to your world if you are willing to listen. How many times have you dismissed someone because of their station or title when what you should have done was listen?

Wisdom does not just come from

peers and those above you – it can come from anywhere and at anytime, but only if you are willing to listen. Expand your sphere of influence and learn from those with different perspectives and experiences and you will be glad you did.

Listen to non-verbal communication: People say as much (if not more) with their actions, inactions, body language, facial expressions, etc., as they do with their verbal communications. Don't be lulled into thinking that because someone is not saying something they are not communicating. In fact, most people will not blatantly verbalise opposition or disagreement, but they will almost always deliver a very clear message with their non-verbal communication.

Listen for opportunity: Intuitive listeners are looking for the story behind the message, and the opportunity beyond the issue. Listening is about discovery, and discovery does their time and input. It acknowledge those we energy, ideas, actions things go as far in built as recognising others.

not only impact the present, but it can also influence the future.

● Let listening be your calling card: One of the best compliments you can be paid is to be known as a good listener. Being recognised in this fashion will open doors, surface opportunities, and take you places that talking never could. Listening demonstrates that you respect others, and is the first step in building trust and rapport.

Recognise the contributions of others: One of the most often overlooked aspects of listening is thanking others for their contributions. If you glean benefits from listening to someone, thank them. Even if no value is perceived, thank them for their time and input. Never forget to acknowledge those who contribute energy, ideas, actions or results. Few things go as far in building good will as recognising others.



Why the private sector's hype about the African middle class isn't helpful

PRETORIA - The African middle class is of huge interest to business. This was confirmed again recently by well attended seminars in South Africa's big cities to discuss "African Lions: ground-breaking study on the middle class in sub-Saharan Africa".

The study was motivated by the African Development Bank's diagnosis that (the African middle class) has grown by over 240 percent in just over a decade, and the bank defines 15 million households as now being middle class.

The narrow focus of the study is guided by a particular interest and echoes a poorly informed narrative about the structure of societies in Africa. It is void of any class related analysis and offers little bearing on reality. People are seen only as consumers with no political relevance

The study was done by the University of Cape Town's Unilever Institute of Strategic Marketing and the global market research company IPSOS over 18 months in ten cities – Abidjan,

Accra, Addis Ababa, Douala, Dar es Salaam, Kano, Lagos, Nairobi, Luanda and Lusaka.

It defines as middle class someone who has a daily income of between USD\$4 and USD\$70. He or she also has a disposable income; is employed or is running a business or studying at college; and has some secondary school education.

According to this criteria, a whopping 60 per cent of the urban population surveyed fall into this definition of middle class.

The researchers conclude that those who qualify as middle class have an average income of USD\$12 a day and an average household income of USD\$17 a day. Of these, a third had a full time job, while many ran mainly informal businesses.

According to the study, an estimated 100 million people outside South Africa have an aggregated spending power of more than USD\$400 million a day. It's clear that the

research is motivated by economic interests, targeting the so-called middle class as the object of desire for retailers. As the head of the institute explained, the core of the interest in the estimated ZAR1.3 trillion-amonth market was a better understanding of the consumer landscape on the continent, (by exploring) aspirations, media consumption, buying patterns, brand relationships and much more (of such middle class).

Similar interests by the private sector exist in business circles beyond the continent. Large companies paid US\$1160 and small ones US\$510 to gain insights into the investment opportunities at a recent "Middle East and Africa Summit" in Stockholm. The second day was devoted to sub-Saharan Africa, which was described as having a bulging middle class hungry for inclusion and more sophisticated consumer demands.

Such approaches perpetuate the original hype over the discovery of the emerging middle classes in the global South, defined in terms of higher living standards.

KIM PORTRAITS, DEATH THREATS

NORTH KOREA - Portraits of North Korea's late leaders hang proudly in the classrooms of the Korean High School in Tokyo, where the recent surge in tensions over Pyongyang's nuclear weapons programme have seen faculty and staff subjected to death threats.

It is one of 60 so-called "pro-Pyongyang" schools in Japan catering to an ethnic Korean community that -- over decades -- developed and maintained a link to North Korea despite never living there.

There are around 500 000 ethnic Koreans in Japan - mostly descendants of civilians taken from their homes during Japan's brutal colonisation of the Korean peninsula from 1910 until Tokyo's defeat in World War II in 1945.

The division of the peninsula into North and South and the devastating 1950-53 Korean War that followed also divided the community and schools like Korean High emerged with backing from pro-North organisations and funding from Pyongyang.

They continue to teach Korean language and history under the guidance of the General Association of Korean Residents in Japan, which acts as the North's de-facto embassy in Japan in the absence of formal diplomatic relations.

Ethnic Koreans have long suffered discrimination in areas like employment and social welfare, and principal Shin Gil-Ung said anger over North Korea's nuclear programme - expected to dominate US President Donald Trump's visit to Japan starting Sunday — has only made things worse.

- Bomb scares -

Japan has been at the sharp end of recent provocations from Pyongyang,

which fired two missiles over its northern islands in quick succession, prompting terrified residents to rush for shelters.

And with the belligerent regime in Pyongyang threatening to "sink" Japan into the sea, the sense of tension and anxiety has left many ethnic Koreans feeling conflicted - especially the younger

generation for whom modern Japan is the only home they have known.

One Korea High student, 17-yearold Hwang Song-Wi, says he watches the news with "mixed feelings" and that he both "trusts and doubts" reports from both sides in the crisis.

Ri Chun-Hui, a Tokyo-based lawyer, said the anger directed at his com-

provocations are nothing new -- noting a similar backlash that followed the abduction of a number of ordi-

nary Japanese citizens by North Korean agents in the late 1970s and early 80s.

"Koreans were once thought of as victims of Japan's colonisation but we are now treated as if we were all perpetrators of the abductions," said

"The sentiment that you can attack

anything linked to North Korea now prevails in Japan," he added.

The kidnapped citizens were taken to the North in order to train spies in Japanese language and culture.

Then-leader Kim Jong-II later allowed five of them and their families to return to Japan, but many believe Kim did not come clean about other

abductees, including Megumi Yokota who vanished when she was 13.

Trump, who mentioned Yokota in his recent UN General Assembly speech, is scheduled to meet abductee families during his trip.

- 'One ethnic people' -

For Korean parents in Japan who want their children to learn the Korean language and history, a "pro-Pyongyang" school is virtually the only option -- no matter their own political persuasion.

"Because they are not Japanese, I want my children to go to a Korean school ... and learn the language and the ethnic spirit. Those are the most important things," said Hwang's mother, Oh Jong-E, adding that shared ancestry trumped the division of the Korean peninsula.

"I basically believe there is no North or South. We are one ethnic people," said Oh, herself a former pupil of the school.

According to one official from the General Association of Korean Residents in Japan, Pyongyang has channelled 48 billion yen to schools in Japan since 1957, although it was unclear what, if any, funds the cashstrapped North provides today.

Some teachers at the school voice sympathies with North Korea, but ideological teaching in the curriculum has thinned out over the years and a relatively neutral version of Korean language and history is now taught - albeit overseen by the portraits of Kim Il-Sung and Kim Jong-

Oh's 17-year-old son plays in goal on the school football team and dreams of playing in Japan's professional league.

One day he wants to play international football -- not in the colours of Japan but of North Korea.

"I hope someday I will be able to play for the country," Hwang told AFP. (AFP)

Suffering in silence or speaking up – the impossible choice

We're finding ourselves in the midst of a necessary and hugely important debate focusing on rape and rape culture. Talking about it, listening to people's stories, debating, opining are all necessary elements.

It's here though, in the application of all these elements, where in my opinion, we struggle the most as a society to make proper headway.

Rarely are we ready or perhaps able, in our discussions, to embrace or even just consider all views. We want to hear our version of things and it must sit well with us - for the most part. Last week strongly brought this to the fore.

Soccer boss Danny Jordaan finally broke his silence after being accused of rape by artist Jennifer Ferguson. We didn't hear his actual voice on the matter, by the way - his lawyer released a statement denying all the allegations levelled against him. So there was no press conference and a chance to engage him or ask about his mentioned empathy for the victims of gender based violence articulated in the statement.

It took two weeks for that statement to surface. Two weeks in which media queries were just ignored. The prominence and public nature of Jordaan's job made little difference to how the matter was dealt with by the organisation he represents. The word 'lacklustre' comes to mind. Another three women have in the meantime claimed Jordaan violated them at various times. They are treated as if they don't really matter in this saga because they haven't revealed their identities.

Some also claim on various pla women speaking out, are part of an elaborate conspiracy or plot to get rid of Jordaan.

Just a FYI here: the woman who told her story to me last week doesn't know Ferguson from a bar of soap. BESIDES having faced numerous stumbling blocks in running her fruit and vegetables business Lubombo Entrepreneur of the year street vendor winner and national winner Mlilo Regina who runs R and J fruits and vegetables has gone against all odds to see her business grow.

"I am very grateful to have gotten to this stage and emerge as a winner in the street vendor category. This is all because of hard work, determination and the love for business, we can never overlook the power of respecting customers because customers are kings," she said.

The business was awarded with a trophy, a certificate, and E15 000 cheque, from the prize money Mlilo is planning to grow the business and venture into retailing. The Lubombo based business is currently selling different fruits and vegetables.

The business is supporting eight people with three of those still in school and it is their only source of income. The prize money came at a right time as there are plans to revive selling banana.

"I am also working on fixing my car which helped a lot in stocking banana. The process in stocking banana requires that I travel very early to get stock in order to be able to sell," she said.

Mlilo said she has been running the business as a sole trader for a long time as she is avoiding running the risk of losing customers in getting someone who does not understand the values of a customer. This comes from experience she had when one of the employees was not able to treat customers the right way.

The business is currently selling different fruits and vegetables and is part of a women business scheme in the Lubombo region. The business scheme is where different women assist each other in their different businesses whilst helping each other grow.

Youth category winner's dream came true

The EYA competition also awarded Mpendulo Zwane in the youth category and the E15 000 prize money came as a dream to the 24-year-old business man.

"This is a dream come true for me as a young businessman. This award will help boost the business I am running. I have always had a dream to run a business from an early age. This will help me in growing my business further," he said.

The young business man who runs MJC grocery is competing with five grocery shops in his area (Jericho in Nhlangano) and is grateful to the people of his area for the support he is getting.

The business started after his high school journey in 2013 where he started with E20 000 running a mobile money Spaza and the business grew to accommodate a grocery shop in 2016. Zwane is planning to restock the shop which will help him grow.

He also has plans to open a tire business as the area is far away from the nearest town (Nhlangano). This has also been a concern for the people of the area as they are forced to travel to town to get tire services.

"I would like to thank the people in my area for the support they have shown me and I would like to encourage business people to work in the open. Paying tax to SRA is paramount and using a trading licence is also a very important aspect. Business premises should also be welcoming with everything inorder to present a professional business look," he said.

IMF solutions country specific

THE International Monetary Fund no longer uses the copy and paste approach for different countries when assisting with their economic challenges.

Neville Mandimika, during the public lecture on economic growth where he talked about the Macroeconomic Outlook for Africa, was responding to a question posed by Nkosinathi from Swaziland College of Technology (SCOT) who wanted to know about the IMF's role in the local economy.

"I have heard from other people that the interventions by IMF are good on paper but may not be good on implementation. How are we as Swazis, supposed to view the role of IMF and their interventions? How are we to handle them when we have people who are of the view that they may not be good practically?" he asked.

In response, Mandimika said, "On the issue

of the IMF and its role in the continent, it is important to understand why the organisation is typically called into action in some of these countries. I think the perception you are trying to clarify is whether 'Big Brother' is good for specific countries emanates from way back where it was an almost a copy and paste approach which the IMF tended to take. Where if a programme worked in country A, by their logic, it could work in country B."

He stated that by his view, of late, their programmes tended to be more specifically tailored as they were designed to look into prevailing situations in specific countries; "I will make a very recent example of Kenya and how Kenyans resolved not to go for an extended full credit facility programme but rather for a precautionary facility.

"The reason they went for that, is that they realised how in terms of their fiscal balance and space; they were more than capable of showing that there is sustainable fiscal dynamics within that economy."

He stated that in case there was a balance of payment shock, they needed a nest egg to fall back on. Referring to Ghana, which he recalled-how previously, had a tendency of overspending in terms of their fiscal numbers decided to go for a full extended credit facility programme. "What we are seeing across the continent from those two examples is a more dynamic approach by the IMF in terms of negotiations, particularly towards the targets they tend to be quite keen on, on a semi-annual basis," Mandimika said.

He said it was understandable that countries felt they were relinquishing their own sover-eignty simply because they are being dictated to; "That is not really a bad thing because we obviously need to ensure that there is sustainability in terms of how we spend the revenue in times of plenty and need."

Mandimika said the situation could be likened to a coin that had two sides when one looked at it, "My personal view is, we need the IMF in certain countries for a certain period of time... as an intervention sort of policy."

Need for innovative agricultural methods

COLLABORATION between the youth and experienced farmers can give birth to innovative methods of ensuring sustainable agricultural production.

"There is need for the creation of a platform where experienced farmers can teach the youth about the latest agricultural produce which will enable them to have high yields," said Sibongiseni Nkosinathi Dlamini from Ethandweni High School in Sikhuphe. He was presenting an essay during the Innovation and Technology in the Financial Sector

presentation by First National Bank. He said such efforts should be paired with investments from government channelled towards the youth. He however cautioned that requirements for youth to invest as a group was challenging seeing as it was at times difficult to find a person who matches their passion.

He said it was in this regard that he suggested that every individual who was at the very least eligible should get a loan enabling them to live their dreams.

"This is because they (the youth) have proven that they are hard workers by the energy they have been using in growing dagga," he said.

He further highlighted the need for subsidised farming inputs, "One of the deterrents to entry into the agricultural sector for the youth is the pricey inputs. When you go to veterinary supplies or trading stores, to buy medication for livestock, you find that the costs are usually higher than the income that one expects."

Ignorance

He decried the level of ignorance in the sourcing of funds for agricultural ventures, "Most of the youth are willing to start agricultural enterprises and have the potential to start new ones. However, you find that they don't know how to go about sourcing funding."

Posing the question to his peers, he demonstrated how none of them were aware of how to go about getting fund-

ing.

"The process of acquiring funds is cumbersome, it is tiring. A youthful person would prefer to engage in an enterprise that takes a very short time to bring him profits because that is all he is interested in," he said adding how growing dagga became more attractive to the youth who seek fast gratification.

Expressing disappointment about the low prices farmers are expected to sell their produce for, he said the youth would be shocked by revelations such as the price at which Swaziland Diary Board buys milk from farmers, "The dairy board is buying a litre of milk for E6; yes in 2017."

He said such was discouraging to

farmers who were willing to engage in this type of farming and then finding that they are unable to make profits.

"Even Namboard, you find that the prices at which the entity buys vegetables from farmers with are very low," he said.

He said such hardships led to those who acquired loans for their agricultural enterprises, being unable to service them.

After being confounded by low prices at the markets and failure to service loans, he said farmers were further affected by unpredictable weather phenomenon which reduces their chances of realising proper harvests. Some of the solutions he brought up included studies into genetically modified foods.

SUBMISSION OF RETURNS

he submission of returns is a statutory quarterly requirement for licenced financial services providers.

It enables the Authority to efficiently conduct its off-site monitoring of regulated entities as part of its wider scope of supervision.

Rationale for the submission of returns In terms of Section 4 of the FSRA Act, 2010, the Authority is responsible for ensuring the safety and financial soundness of the non-bank financial services sector in Swaziland.

This can only be achieved through continuous monitoring of the financial soundness of all entities operating in the market.

The submitted returns are analysed for the following reasons;

- To assess the financial soundness of each entity;
- To group entities according to their size based on assets, profitability or other relevant measurements;
- Based on the groupings the Authority is in a better position to prepare the supervisory plan which includes;
- The identification of entities to be inspected in the following year or immediately; and
- The identification of entities that need close monitoring.

APPLICATION OR RENEWAL OF A FINANCIAL SERVICES PROVIDERS LICENCE

Section 36 (1) of the FSRA Act, 2010 states that the application for a licence or renewal of a licence shall be made to the Authority in the form and manner prescribed by the FSRA and shall be accompanied by the prescribed fees. The Act continues to state that 'in the case of an application for renewal of a licence, such an application shall be made not later than one month before the expiry of a licence.'

Section 36 (2) states that the Authority may require further information deemed necessary from the applicant.

GRANTING OF A FINANCIAL SERVICES LICENCE

The Authority requires prospective licencees to meet certain requirements. This point is emphasised by the FSRA Act, 2010. Section 37 (2) states that a licence shall only be granted if the applicant meets and the Authority is satisfied that the applicant will continue to meet;

■ Capital adequacy, solvency or other



prudential standards;

- Minimum financial requirements;
 Licencing conditions set by the
- Requirements of the applicable financial services law.

CONDITIONS AND RESTRICTIONS

As per the provisions of Section 38 of the FSRA Act, 2010, the Authority may grant or renew a licence subject to conditions or restrictions that it may deem fit. At any time the Authority may by written notice to a financial service provider, vary any condition or restriction or impose further conditions or restrictions. It is a transgression not to adhere or comply with this provision. It is therefore expected that for harmonious relationship between the Authority and market players compliance with the necessary legislation be adhered to. In terms of Section 38 (3) of the FSRA Act, 2010 failure to comply with the condition or restriction is an offence and the individual is liable to a fine not exceeding E 100 000 and a further E5 000 every day for which transgression continues.

FAILURE OR INABILITY TO COMPLY WITH THE ACT

If an authorised financial services provider fails to comply with require-

ments under provisions of the Act or financial services law, the Authority may;

- Publish a statement where it thinks it is necessary or expedient in the interests of the public or for the protection of stakeholders;
- Issue a written warning;
- Direct financial services provider to do something or refrain from doing something;
- Impose administrative penalty as per Section 68. Irrespective of whether criminal proceedings in terms of the Act have been or may be instituted against an authorised entity, the Authority may by written notice issue an administrative penalty.

CONSEQUENCES OF ENGAG-ING AN UN-LICENCED FINAN-CIAL SERVICES PROVIDER

Consumers are urged to cease and desist in dealing with un-authorised financial services providers.

The Ombudsman Financial Services may not offer any remedy in terms of complaints as a result of transgressions should such happen, since they only have jurisdiction on licenced non-bank financial services providers.

Capitec named SA bank with best social media buzz

CAPE TOWN - Capitec is the SA bank that has been garnering the best buzz on social media, according to BrandsEye.

In a new "opinion mining" study released on Monday, BrandsEye, in partnership with customer experience expert Julia Ahlfeldt, analysed the sentiment of SA social media users to local banks.

The findings were based on 1.8 million social media posts by 554 600 unique users about South Africa's big five banks between September

2016 and August 2017

The banks included in the study were FNB, Capitec, Nedbank, Absa and Standard Bank.

"The unsolicited nature of social media makes platforms like Facebook and Twitter ideal sources to gauge public opinion. Unlike traditional polling surveys, people take to social media to post their views without prompting or guidance on what to say or how to say it," said BrandsEye in its report.

BUMPER CROP LIFTS SA FROM ABYSS

JOHANNESBURG-The Rand firmed against the US dollar after data released last Tuesday showed that Africa's two biggest economies, Nigeria and South Africa lifted out of recession in the second quarter of the year, with South Africa's growth supported by a resurgent agricultural sector.

However, economists and Finance Minister Malusi Gigaba quickly pointed out that the country was not yet out of the woods. The rand was bid at R12.87 against the greenback at 5pm, from R12.98 it was bid at prior to Statistics South Africa (Stats SA) official gross domestic product (GDP) announcement.

Stats SA said the country's economy grew 2.5per cent in the second quarter of the year from first quarter's 0.7per cent contraction. This marked an end of two-quarters of contraction and beating market expectations of a 2.1per cent rise in GDP.

Mamello Matikinca, a senior economist at FNB, said while further policy easing could provide a mild boost to GDP, structural difficulties will likely prevent any meaningful lift in economic growth.

"We are hesitant to read too much into this and expect the recovery to be shortlived given persistently weak consumer

confidence and real wage growth. Gross fixed capital formation plunged 2.6per cent quarter on quarter, reflective of weak business confidence," Matikinca said.

Meanwhile, Nigeria's economy shrugged off five painful quarters in the red zone, after its GDP expanded 0.55per cent in the second quarter of the year.

Statistician-General Pali Lehohla said the second quarter growth was driven by a rise in the production of field crops, in particular, maize and wheat, as well as increased production of horticulture products such as vegetables.

Lehohla said production in the agricultural sector soared during the quarter, expanding 33.6 per cent compared to the similar period last year. "The bumper crop has already provided some relief for cash-strapped South African households.

Higher stocks of maize and wheat have begun to dampen prices, with bread and cereal prices falling month-on-month for six consecutive months," Lehohla said.

Recent figures from the Crop Estimates Committee (CEC) expects the country to produce 16.4 million tonnes of commercial maize this year, more than double than last year's harvest, and higher than the current record of 14.7 million tonnes produced in 1981.

John Ashbourne, an Africa economist at Capital Economics, said that the rebound in the second quarter supports its view that the economy will perform stronger than most expect in over the coming quarters. "We believe that a combination of a strong agricultural recovery and better performances from consumer-facing sectors will take headline growth to 1.5 per cent over 2017 as a whole." Business Report

Another hurdle for commencing fracking in South Africa

JOHANNESBURG-The plans of companies seeking to commence with deep drilling or hydraulic fracturing (fracking) in parts of the Karoo exceeding 120 000km² hit a stumbling block after the Eastern Cape High Court declared the Regulations for Petroleum Exploration and Production (the fracking regulations) invalid on October 17, in the case of John Douglas Stern NO and Others versus the Minister of Mineral Resources.

The court held that the minister of mineral resources lacked the authority to promulgate the fracking regulations and that they were not published in a procedurally fair manner.

The applicants, which comprised several farmers and farmers' organisations from the greater Karoo area (applicants), sought an order reviewing and setting aside the minister's decision to promulgate the fracking regulations, alternatively declaring his promulgation of the fracking regulations, alternatively the content of the fracking regulations, inconsistent with the constitution.

The applicants' challenge to the fracking regulations' validity essentially was that:

The minerals minister was not authorised under the Mineral and Petroleum Resources Development Act, No 28 of 2002 (the MPRDA) to promulgate the fracking regulations and therefore acted unlawfully, rendering them invalid.

The fracking regulations' purpose was to regulate the environmental consequences of fracking.

However, the authority to regulate the environmental aspects of fracking fell outside the minister's powers, as this power was removed from the scope of his authority as part of the amendments made to the MPRDA during 2013.

The fracking regulations were not published in a procedurally fair manner, as its "Schedule 1" (which listed the substances prohibited from use as additives to fracturing fluids during the fracking process) was not included in the draft fracking regulations when they were initially published for comment from interested and affected parties.

The fracking regulations' purpose was to: (a) conserve the environment; (b) manage the environmental impacts of the production operations; (c) rehabilitate disturbances of the surface of land where they take place due to fracking; and (d) prevent, control and combat pollution of air, land, sea or other water (including groundwater).

More bad news for motorists as oil price peaks

JOHANNESBURG - Motorists are likely to feel the effects of strengthening oil prices in due course.

Yesterday morning, the price of crude oil hit its highest level since July 2015, trading at R62.90 per barrel.

Last week, the Automobile Association warned that motorists were yet to feel the full effects of strengthening oil prices.

A weaker rand is also a contributor to higher fuel costs. Last Wednesday, the petrol price was increased by 4c to R13.62 a litre.Reuters reports that oil jumped to its highest in more than two years on Monday as Saudi Arabia's crown prince cemented his power through a crackdown on corruption.eNCA

STANDARD BANK CREATES R1.8BLN DEBT FUNDING MODEL FOR SA AGRICULTURAL SECTOR

JOHANNESBURG - Standard Bank yesterday announced the creation of a new R1.8 billion debt funding model for the South African agricultural sector.

Standard Bank will go into partnership with agribusiness, Transvaal Wattle Growers Co-operative Limited (TWK), and the Land Bank.

The 77-year-old business, TWK, provides a broad range of products and services to its stakeholders including timber, grain, trade and mechanisation, financial services, and vehicles and tyres.

The transaction is a first in agricultural finance in terms of the col-



laboration in a syndicated loan to TWK between Standard Bank as a

commercial financial services provider and Land Bank as a parastatal financer. It is also a first in terms of Standard Bank and TWK working together to restructure the co-operative's balance sheet in a way that enables the bank to apply its financial insight from the corporate business world to agriculture's operating environment.

Standard Bank Head of Agribusiness, Nico Groenewald, said that the new debt structure was aligned with TWK's growth strategies and enhancing the balance sheet of the company. He said it was a perfect balance between the optimal financing mechanism and financing products. African News Agency (ANA)

NUM CALLS FOR INQUEST INTO MINE FATALITIES

JOHANNESBURG - The National Union of Mineworkers (NUM) has called for an investigation into rising fatalities in the mining industry after two mineworkers died following a seismic event at AngloGold Ashanti's Mponeng Mine, near Carletonville in North West.

Mponeng is the deepest mine in the world at a depth of 4km.

Two Mponeng mineworkers died and six others are recovering in hospital following a fall-of-ground incident that was triggered by a seismic event of 1.1 magnitude at 3.6km around 9.30am on

Thursday.

"A thorough investigation is needed to get to the bottom of the fatalities," Erick Gcilitshana, NUM health and safety secretary said on Friday.

Gcilitshana said the increasing number of fall-of-ground incidents, particularly in Klerksdorp and Carletonville, was worrying. Two mineworkers died at the Mponeng mine in October, while two others died at AngloGolds' Kopanang mine in September due to fall-of-ground incidents.

Four mineworkers died in July at the Tau Lekoa mine owned by Heaven Sent,

Play I Sant To Type was

a Chinese venture capital firm following a fall-of-ground incident and five others died at Harmony Gold's Kusasalethu mine in August.

There were 73 fatalities in the industry last year, down from 77 in 2015, excluding the three mineworkers at the Lily Mine in Barberton.

Pretty Nkambule, Solomon Nyarenda and Yvonne Mnisi, who went missing after the shipping container they were working in was buried when an underground supporting pillar collapsed last February.

'Roodt's advice was irresponsible'

JOHANNESBURG - Dr Conrad Beyers, Barclays Africa Chair in Actuarial Science at the University of Pretoria, said that public advice by prominent economist, Mr Dawie Roodt, urging South Africans to take their money out of the country, should be taken with caution.

He noted that "physically taking money out of the country" is not the only way to protect savings against a weakening South African economy.

According to Beyers, the advice by Roodt appears to be a hysterical reaction to recent events. He cautioned that people should be aware of the risks that accompany hasty decisions to take savings out of the country.

Interest rates are typically very low in developed countries and exchange rate fluctuations can have a significant influence on the value of overseas savings.

For example, typical interest on savings instruments in developed countries are much lower than in South Africa - in Australia it is around one per cent.

DR Congo sets elections for December 2018

KINSHASHA-The said Independent National Democratic Republic of Congo announced Sunday that muchdelayed elections to replace President Joseph Kabila would take place in December 2018, but the opposition demanded the longtime leader step down sooner.

Elections were due to take place this year under a deal whereby Kabila would leave office but repeated wrangling has hobbled the process.

The election commission said, "direct voting" will take place on December 23, 2018, covering presidential, legislative, regional and local elections, Electoral Commission (CENI) official Jean-Pierre Kalamba.

But the Congolese opposition said the timeframe was not acceptable, insisting that Kabila quits by the end of this year.

"We reject the (CENI) calendar... what interests us right now is the departure of Kabila by December 31, 2017," said Augustin Kabuya, spokesman for the main opposition Union for Democracy and Social Progress (UDPS).

The electoral commission said provisional results of the presidential election would not be published until a week after the voting, on December 30, 2018, with definitive results not issued until January 9, 2019.

The new president will then take office on January 12, 2019, CENI said.

That calendar is based on "rationalisation of the electoral system so as to reduce the costs," said CENI chief Corneille Nangaa.

But senior opposition figure Moise Katumbi dismissed the plan."This predatory regime wants to prolong the instability and misery of the people,' Katumbi said.AFP

'Angry' Grace wants Mugabe's VP Mnangagwa gone

HARARE - Zimbabwean First Lady Grace Mugabe has reportedly declared that under fire Vice President Emmerson Mnangagwa should be gone from both the government and ZANU-PF, before the ruling party's extraordinary congress in December.

Grace said this as she addressed thousands of indigenous church followers during what was termed a "Super Sunday Rally" at a stadium in Harare on Sunday.

According to NewsDay, the "angry" First Lady said: "Trouble causers in the party must go before the next congress.

He (Mnangagwa) must be dropped before we meet at congress in order for us to have unity in the party."

Mnangagwa, who had been touted as a possible successor to President Robert Mugabe, 93, has recently fallen out with the first family.

On Saturday Mugabe threatened to fire Mnangagwa, accusing him of fanning factionalism to garner support ahead of the special congress.

Amid party divisions over who should become leader - an event only likely to occur when the incumbent dies - Grace 52, said the party will soon change its constitution to allow a woman to be vice president, reports indicated. News24

Liberia holds breath as court rules on presidential vote

MONROVIA - Liberians nervously awaited a Supreme Court ruling yesterday on the timing of a runoff presidential vote after the process was thrown into uncertainty by fraud allegations.

The court was expected to rule at 10 am whether to set a new date or to prolong the vote indefinitely while a legal complaint by the opposition Liberty Party is resolved.

The runoff between former international footballer George Weah of the Coalition for Democratic Change (CDC) and Vice President Joseph Boakai of the governing Unity Party was originally set for 7 November.

But Liberty Party candidate Charles Brumskine, who came third in the first round on October 10, claims fraud and irregularities tainted the results, leading the Supreme Court to put a temporary stay on preparations.

Brumskine and Boakai have accused incumbent President Ellen Johnson Sirleaf of "interference" and of secretly supporting Weah over her own vice-president, claims she has strongly denied.

International donors have poured billions of dollars into Liberia since Sirleaf was elected in 2005, and are eager to see completed what will be the country's first democratic transition in seven decades.

Some experts believe a short delay will not necessarily derail the process but will require delicate handling.

"Even if there is a delay, as long as it does not undermine the integrity of the entire electoral process, then the Liberian people will still have an opportunity to make their voices heard," said Christopher Fomunyoh, regional director at the US-based National Democratic Institute, which sent observers to Liberia. AFP

Tons of hashish seized

Khartoum - A controversial Sudanese counterinsurgency unit said on Sunday it had seized 19 tonnes of hashish in war-torn Darfur, in one of the largest hauls ever reported in Sudan Sudan's Rapid Support Forces (RSF), usually used to crush rebels in the country's conflict areas, seized two vehicles loaded with hashish after a gunfight with smugglers in the state of South Darfur last week.On Sunday, the security forces showed tonnes of seized cannabis to reporters at an RSF camp in Khartoum. Dozens of blue plastic sacks full of hashish were on display, while some was spread out on a carpet in the compound of the camp. AFP

No letup in standoff

JUBA - Troops remained deployed around the home of South Sudan's powerful former army chief Paul Malong on Sunday in a dispute over the fate of his 30 bodyguards, an army spokesperson told AFP. The standoff began on Friday evening when more than 100 soldiers surrounded his residence in central Juba, South Sudan's capital, in a move which prompted people to flee to their homes for fear the standoff would erupt into clashes. Malong is a hardline ethnic nationalist whose dismissal in May by President Salva Kiir had sparked fears of a major clash between supporters and troops loyal to the president, though that never materialised. AFP

11 improsoned in raid

BAMAKO - An anti-terrorist raid by French forces at the end of last month left 11 imprisoned Malian soldiers dead, military sources said Sunday. The incident occurred in the northeastern Kidal



region on 23-24 October, after the Malian military had received proof that their soldiers, who had been captured by jihadists, were still alive. After what appears to be a botched raid, however, they were dead, a defence ministry official said, adding that officials had been in touch with the French military. Pictures of the soldiers' corpses confirmed the nature of their death. AFP

European envoys summoned

CAIRO - Egypt summoned on Sunday the ambassadors of Germany, Italy and The Netherlands after they criticised the arrest of an Egyptian human rights lawyer opposed to enforced disappearances, the foreign ministry said.

The ministry added that they will also summon the ambassadors of the United Kingdom and Canada later in the day. Authorities arrested in September Ibrahim Metwally, who is linked to the case involving murdered Italian student Giulio Regeni, as he was about to fly to Geneva for a conference on enforced disappearances.

Threat to diplomatic staff

NAIROBI - The United States' diplomatic mission in Somalia has directed all non-essential staff to leave the capital Mogadishu, saying it had received a "specific threat" against its employees. The move came a day after Washington carried out its first air strikes against Islamic State militants in the country, in raids it said killed "several terrorists".

"Due to specific threat information against US personnel on the Mogadishu International Airport, the US Mission to Somalia has directed its nonessential US citizen employees to depart Mogadishu until further notice," said a statement. It did not give further details. Islamic State has been gathering recruits in the region, but it remains a small player compared to the al Shabaab group.Reuters

WOMAN KILLED, MAN INJURED IN SHOOTING

JOHANNESBURG - A woman was killed and a man critically injured in a shooting incident outside a residence in the Blyvoor informal settlement outside of Carletonville.

ER24 Spokesperson Russel Meiring said when paramedics arrived on the scene on Sunday night they found the man and woman had sustained gunshot wounds to their heads.

"The man was found in a critical condition while the woman showed no signs of life," said Meiring yesterday, adding, "unfortunately, the woman had already succumbed to her injuries.

Nothing more could be done for her and she was later declared dead".

Meiring said the man was treated for his injuries and provided with advanced life support interventions before he was transported by the Provincial Services to a nearby hospital. Details of the shooting remain sketchy, but local authorities are investigating the fatal shooting.

RAMAPHOSA PICKS NALEDI AS PRESIDENTIAL RUNNING MATE

JOHANNESBURG - Deputy President Cyril Ramaphosa named Minister of Science and Technology Naledi Pandor as his running mate, it has been reported.

Ramaphosa is a leading contender to replace President Jacob Zuma as ANC leader in December.

The deputy president has been under pressure to pick a female running mate as gender equality is a key ANC policy goal and his main challenger is Nkosazana Dlamini-Zuma, a veteran politician, former African Union head.


The Mail & Guardian reported on Sunday that Ramaphosa made the announcement that Pandor would be the ANC deputy presidential candidate on his ticket during a rally in the northern province of Limpopo.

"It's a smart move. Pandor's smart and she does not appear tainted by any corruption allegation nor is she close to either the Zuma or Ramaphosa camps. And as a woman, she ticks a number of boxes that make a lot of sense," said Gary van Staden, a political analyst with NKC African Economics.

Pandor is an articulate technocrat with a professorial manner who has also done a stint as education minister. Her spokesman could not immediately confirm the reports and said Pandor was travelling to Jordan for a science conference.

President Zuma remains committed to nuclear project and Russia

JOHANNESBURG - Those who do not support South Africa's nuclear project are backing western agendas, President Jacob Zuma said during his Oliver Tambo centenary address in Kagiso, Johannesburg on Sunday.

Zuma went into detail explaining the ANC's relationship with Russia and why the government was pursuing its nuclear power plans."When we started negotiations the west told the apartheid government to destroy their nuclear power because communist cannot get hold of them.

"They said they can never control nuclear because they are communist. That is the history of nuclear," he said.

Zuma's statement follows a report by City Press Sunday

newspaper that his newly appointed Energy Minister David Mahlobo was working tirelessly to finalise a reviewed energy resource plan. This despite Finance Minister Malusi Gigaba saying that a nuclear project was not necessary and the country cannot afford it. Zuma was critical of those who do not support a nuclear project. "There are those who support this notion without even knowing the background. They go around saying we don't want nuclear. They are supporting the wrong forces," he added.

In his two hour long address, Zuma reconfirmed his commitment to a partnership with Russia. He told ANC supporters that Russia had supported the ANC during its struggle for liberation.

Keep politics out of policing - Mbalula

JOHANNESBURG - Police officers must stay out of politics and focus on combating crime, which is "out of hand", Police Minister Fikile Mbalula said in Tshwane on Sunday.

"Comrades, let us depoliticise [the SA Police Service]," he said.

"Let this be a professional organisation free of political parties head office gossipers who move from ear to ear with various promises of auctioned power," he told Police and Prisons Civil Rights Union (POPCRU) members at their Central Executive Meeting in Irene.

"[The SA Police Service] must be led by management that cares for our people and the job at hand which is crime prevention and fighting," Mbalula said in a speech prepared for delivery.

Management and officers should not concern themselves with which minister may be reshuffled or not, or lobby for certain politicians to be the minister of police.

This behaviour invokes the Gestapo,

the secret police of Nazi Germany, he said. According to Mbalula interparty partisanship is going as far as illegal intercepts and attempts to frame politicians. He went as far as warning against a reincarnation of Fulgencio Batista, a Cuban army stenographer who elevated himself to pull presidential strings in the background and eventually rose to the presidency himself.

Mbalula warned that this situation often "starts at the top".

He identified current security threats to South Africa as: threats to territorial integrity, the authority of the state, the well-being and safety of South Africans and threats to the country's economic development.

He also told police officers to be vigilant of the growing private security industry whose employees are guarding key public institutions such as the National Prosecuting Authority.

In a wide-ranging speech, Mbalula paid tribute to police officers who were working in difficult conditions, and offered his condolences to families whose police officer partners or relatives had been killed in the line of duty.

He reiterated that criminals would have their "balls crushed" as police continue their fight against crime and urged officers themselves to behave with integrity. news24

'Public Protector never said 'don't buy' Pauw's book'



"John wanted to go to Syria, and I said I wasn't ready, not while the children are small,"she recalls.

But then they did go, even though Tania was some five months pregnant, and they brought along their young children.

After fleeing Syria, she has visited a social networking site used by her husband to post his extremist articles and 'liked' a final post made before the site was closed down.

Nine people drown

NEW DELHI - At least nine people have drowned in two separate incidents in eastern India's Bihar state. Police officer Sunil Kumar said five boys aged 9 - 12 and one woman, all from a single extended family, drowned on Sunday in the Ganges River while on a picnic near Patna, the state capital. They were swept away by the strong current. The Press Trust of India news agency reported that three other people drowned when their boat capsized on Sunday in the Sarswati River in the state's Sanjastipur district. Such incidents occur frequently in India, where few people use life jackets. AP

Harassment scandal spreading

LONDON — The scandal surrounding Britain's political class deepened on Sunday with more allegations of sexual harassment, abuse of power and other misdeeds, including new claims involving a key ally of Prime Minister Theresa May.

The allegations dating back more than a decade involve behaviour that ranges from inappropriate touching and sending suggestive text messages to matters serious enough to be reported to police for possible prosecution. First Secretary of State Damian Green, a senior Cabinet figure who is in effect May's deputy, emphatically denied a Sunday Times report that police had found "extreme" pornography on his computer during an investigation nine years ago. *AP*

At least 75 dead in IS attack

BEIRUT - At least 75 civilians were killed in an Islamic State group car bombing that struck a gathering of people displaced by fighting in eastern Syria, a monitor said on Sunday. Saturday's attack in the eastern province of Deir Ezzor killed "at



least 75 displaced civilians including children" and wounded 140, said Rami Abdel Rahman, head of the Syrian Observatory for Human Rights. Abdel Rahman said the victims had fled battles in the province, where Syrian regime forces and a US-backed Kurdish-Arab alliance, the Syrian Democratic Forces, are fighting the extremist group in separate offensives. *AFP*

Saudi Arabia seals borders

RIYADH - The Saudi-led coalition battling Shiite Huthi rebels in Yemen closed the country's air, sea and land borders Monday and accused Iran of being behind a weekend missile attack on Riyadh, saying it "may amount to an act of war". Saudi Arabia intercepted and destroyed the ballistic missile, which was launched from Yemen as rebels appeared to escalate hostilities, near Riyadh's international airport on Saturday. The missile was the first aimed by the Shiite rebels at the heart of the Saudi capital, underscoring the growing threat posed by the raging conflict. AFP

Romanians against reforms

BUCHAREST - More than ten thousand Romanians demonstrated in Bucharest on Sunday to "defend the independence of the judiciary" in protest against a government bill that critics say will weaken anti-corruption measures.

The protesters gathered in front of the government headquarters in the capital and then marched to the parliament chanting "thieves". Protests were also held in dozens of other cities across the country opposing the parliamentary bill that would reduce the powers of the anti-corruption prosecutor's office (DNA) and prevent it from investigating magistrates. *AFP*



Donald Trump opens door to North Korea

TOKYO - President Donald Trump appeared to strike a more conciliatory tone on North Korea as he got down to business yesterday on an Asian tour dominated by the nuclear crisis with Pyongyang.

Trump's high-stakes visit to the region was overshadowed by what the president described as a "horrific shooting" in Texas, where a gunman killed 26 people and wounded 20 more during Sunday services.

"Our hearts are broken," he told business tycoons in Tokyo. Trump began his marathon trip in belligerent form, warning on Sunday that "no dictator" should underestimate the US' resolve, a clear swipe at North Korea and its young leader

However, in a pre-recorded interview broadcast on US TV,

Kim Jong-Un.

he held out the prospect of talks with Pyongyang, saying he would "certainly be open" to meeting Kim.

"I would sit down with anybody," he said. "I don't think it's strength or weakness, I think sitting down with people is not a bad thing," he said on the "Full Measure" show.

"So I would certainly be open to doing that but we'll see where it goes, I think we're far too early." AFP

Gunman kills 26 at Texas church service

WASHINGTON - A black-clad gunman armed with an assault rifle opened fire on a small town Texas church during Sunday morning services, killing 26 people and wounding 20 in the latest mass shooting to shock the United States.

Authorities did not identify the gunman, saying only that he was a "young white male, maybe in his early 20s," who was wearing a bulletproof vest and found dead in his vehicle after being confronted by a local resident.

Exactly five weeks after the worst shooting in modern US history, the latest tragedy prompted an outpouring of condolences, led by US President Donald Trump.

The victims, who ranged in age from five to 72, were gunned down at First Baptist Church in Sutherland Springs, a rural community of about 400 people located 50 kilometres south-east of San Antonio. The gunman fired outside at the church before entering the building and continuing to spray bullets, said Freeman Martin, Regional Director of the Texas Department of Public Safety. "As he exited the church, a local resident grabbed his rifle and engaged that suspect. The suspect dropped his rifle, which was a Ruger AR assault-type rifle, and fled from the church. Our local citizen pursued the suspect at that time," Martin said.

Man linked to Texas shooting faced military court-martial

HOUSTON - The man authorities have identified as the gunman in a mass shooting at a Texas church faced courtmartial and was discharged from the Air Force for allegedly assaulting his wife and child, according to an Air Force spokesperson.

Ann Stefanek said on Sunday that Devin Kelley was sentenced to 12 months' confinement after a 2012 court-martial. He ultimately received a bad conduct discharge and reduction in rank.

She said Kelley served in Logistics Readiness at Holloman Air Force Base in New Mexico from 2010 until his discharge.

Authorities did not announce his name at a news conference on the shooting, saying only that the suspect was a white male in his 20s.

But a US official and a law enforcement official identified Kelley as the person who opened fire on Sunday at the First Baptist Church of Sutherland Springs, Texas, killing 26 people and wounding about 20 others. The US official told The Associated Press that Kelley lived in a San Antonio suburb and that he doesn't appear to be linked to organised terrorist groups

The official said investigators are looking at social media posts Kelley may have made in the days before Sunday's attack, including one that appeared to show an AR-15 style semiautomatic weapon. The official requested anonymity because the person did not have authorisation to speak publicly. AP

Sacked Catalan leader freed on bail in Belgium

BRUSSELS - Catalonia's sacked separatist leader Carles Puigdemont and four of his former ministers were released with conditions in Belgium on Sunday after turning themselves in to face a Spanish warrant for their arrest.

A judge ordered the five, who fled Spain earlier this week after being accused of rebellion and sedition, not to leave Belgium until their extradition case is heard.

It is the latest twist in the crisis unleashed by the Catalan separatists' push to break away from Spain, sending shock waves across Europe.

Puigdemont and his allies escaped to Belgium on October 30 after Spain dismissed the Catalan executive and imposed direct rule on the semi-autonomous region following the declaration of independence by the parliament there.


"They were taken into custody at 09:17 (08:17 GMT)," said Gilles Dejemeppe, a spokesperson for Belgian prosecutors.

A white van believed to be carrying Puigdemont raced out of the Belgian prosecutor's office around 15 hours later, AFP reporters witnessed.

"The request made this afternoon by the Brussels' Prosecutor's Office for the provisional release of all persons sought has been granted by the investigative judge," said the statement by the prosecutor's office shortly afterward.

The next court hearing will be in the following 15 days. Belgium has up to 60 days to decide whether to send the Catalans back to Spain.











This was revealed by the club's National Supporters Committee (NSC) Chairman Lucky 'Majaivane' Dlamini.



Shongwe checked in at Manzini Clinic together with the team's goalkeeper Khanyakwezwe Shabalala, who also sustained a facial injury in the same game. The pair was discharged but local

doctors have referred Shongwe to SA for facial surgery on the bone known as the zygomatic.

This season is seemingly plagued by injuries as multiple other players have been ruled out for a prolonged period after sustaining critical injuries.

They include among others Mbabane Swallows' forward Sabelo 'Sikhali' Ndzinisa and Young Buffaloes' Mphile 'Nyandoro' Tsabedze
