# UNISWA STUDENTS TO STAY AWAY FROM CLASSES TODAY

UNIVERSITY of Swaziland students have resolved to boycott classes today owing to a number of allegedly unresolved issues.

The class boycott resolution dubbed a 'stay away' was relayed to students by the Student Representative Council (SRC) President Sibusiso Siyaya yesterday.

Siyaya stated that the decision for the stay away comes as a result of students' complaints not being attended to by the institution.

Students allege that life is now unbearable at the university and the environment is not at all conducive for learning.


Siyaya stated that since the opening of the university, they as the SRC, engaged all relevant structures to quickly address their mistakes because they don't want at the end having to see anyone labeling students as rowdy and protest-oriented.

He stated that they gave all concerned parties time to correct their mistakes but up to now, nothing has been done.

"We appreciate that the university's administration never avoided us on any day, they have been always willing to listen to our complaints but unfortunately they cannot be resolved by empathy alone but need practical solutions," Siyaya stated.

He said they want to avoid being accused of pursuing secret agendas and they want it to be visible enough that they carry the mandate of students as they have been expressing themselves whilst they listened as leadership.

AT IT AGAIN: UNISWA students have resolved to boycott classes today owing to a number of allegedly unresolved issues.

He stated that they are now wrapping up the third week of lectures but they still have no book allowances thus they can't access books. Siyaya stated that pertinent issues affecting students include the lack of meal allowances and refectory prices randomly hiking up with food quality still low.

He said scholarships are still not enough to cater for all students and the fact that first year students have still not signed for theirs.

Siyaya said another pressing issue is that up until now, they face a challenge of accommodation at the university.

Other issues include bookshop prices

being too high. Siyaya stated that they have noted a circular or policy that has been circulating all over social media from the ministry of labour and social security whereby other institutions have signed for scholarships.

He said, however, for UNISWA it is a different story as nothing has yet been officially given to them as students.

Siyaya alleged that seemingly what they have learnt is that it was still being debated if the policy is yet to come back with E9 900 or a better offer.

He added that it would seem that those debating the policy need motivation.

## SRC warns students against vandalism during boycott

SRC President Sibusiso Siyaya sent a strong warning against any form of vandalism during the class boycott

He told students that they must not break any windows nor burn any material that they will again need. "We must as much as we can be able to strike a balance of addressing our issues as well as protecting the university from any damage because we understand very well that a university is necessary to be there in a society for development," he

warmed.

The SRC president also made it clear that as students, they do not want to go home as they want to learn.

He appealed to all relevant parties to make the environment conducive for learning. He said the university must stop chasing them away and provide solutions to their problems so they can learn.

"In all campuses we are dropping down pens. Tomorrow (today) will just be a stay away then we will communicate later what happens next," he said.

### SNUS calls for SRCs to defy restrictions of meetings

SNUS President Brian Sangweni has called upon all SRCs and students in general to defy what he called unjust measures of restricting students' freedom of assembly.

Sangweni urged students to hold meetings whenever they feel necessary without any fear.

This comes after the university of Swaziland banned meetings at the institution following an incident of vandalism which saw the institution's property being destroyed by protesting students.

### Banned

Even though students have been banned from meeting, the SRC used various social media platforms to communicate with students and update them on what is happening and what should be done as a way forward.

## UNISWA unaware of class boycott

UNISWA Registrar Dr Salebona Simelane expressed surprise when told about the pending class boycott.

Simelane stated that as a university they were not aware of the students' intention to engage in such.

He stated that they were in a meeting with the SRC on Tuesday evening where they discussed issues affecting students and tried to forge a way forward.

Simelane stated that as a university they even asked for suggestions from the SRC members.

The registrar mentioned that one pertinent contention discussed during the meeting was the issue of accommodation.

He stated that they asked for the SRC to contribute suggestions on how best to tackle the issue.

The registrar stated that from the

meeting they had with the SRC there was nothing that might have led to students to decide to engage on a stay away protest as one would have thought that the parties reached a mutual understanding.

Simelane stated that he would discourage students from engaging in such an action.

They are also happy about the fact that with the contract, once exceeded, the customer can top up airtime and data bundles until their 30 days elapses and are due for reloading. They are greatly fascinated by the fact that once a customer has E295 contract they stand a better chance of owning the shares if they follow the terms and conditions of acquiring shares with the company.

### Shares

This is the first of its kind in Swaziland that a company can start giving away shares before they make profit themselves," said Sibandze.

Sibandze said they are looking at having the entire Swazi nation connected to Swazi Mobile as they offer great services at affordable prices.

He said the company has already surpassed the new customer linking targets they had set for themselves at the Trade Fair.

GOVERNMENT'S controversial 0.0 per cent pay rise offer to public servants has sparked a serious division

amongst teachers. Some are now accusing the National Executive Committee (NEC) of pushing its own agenda.

This division has resulted in the Manzini Branch of the Swaziland National Association of Teachers (SNAT) Chairperson Mbongwa Dlamini being served with a letter informing him that he could be charged with misconduct.

He has been asked to explain in writing to the teachers' body within five days why he should not be charged for statements that were viewed by the executive to instil division among SNAT membership.

Reliable sources revealed that when NEC presented the 0.0 per cent offer to members of SNAT there were questions that were posed by the General Council

Allegations are that there was no one who responded to the questions, something that did not go down well with Dlamini. It is alleged that Dlamini then posted a message on one of the social networking sites for teachers which was taken by SNAT leadership as derogatory.

The letter signed by SNAT Secretary General Zweli Mndzebele addressed to Dlamini states; "it has come to the attention of the National Executive Committee of SNAT that you have published a statement on the official WhatsApp group site (GC talk)....which has the effect of undermining the credibility and reputation of the NEC in the perception and estimation of its members". In the post, Dlamini is said to have accused the NEC of forsaking teachers.

'Uyabona angiyati arrogance lenjena NEC uyasikhobosa akanendzaba natsi. Basuke lapha baya eMbabane bayovumelana kutsi abanike hulumende litfuba lekuyakuma principals abo bona batohlala nje bangasinaki ngoba batitfumile" allegedly posted Dlamini.

According to the letter from SNAT signed by Mndzebele these words are viewed by the NEC as highly derogatory insulting, provocative and irresponsi-

### Vote of no confidence

SOME teachers have expressed lack of confidence on their NEC.

A section of teachers is of the view that if they re-elect any of the 10 members who are in leadership in 2018, they will be receiving more of such

threatening letters.

Some even suggested that branch leadership should consult with representatives and consider instituting a vote of no confidence motion on the NEC. "We are a year from elections, but

I have a feeling that the damage they'll do to the union in the next year will be too big and it will take years to repair," a member commented.

## SADC condemns assassination of Lesotho's Lt. Gen. Motsomotso

SADC has learnt with shock, sadness and dismay about the assassination of the Commander of the Lesotho Defence Force (LDF), Lieutenant General Khoantle Motsomotso.

He was killed on Tuesday. Some senior officers of the LDF are reported to have also lost their lives in the shooting incident. "SADC strong-ly condemns this inde-liquitement General scribable and inexcusable Lieutenant General barbaric and heinous act," Khoantle the statements states. SADC Motsomotso.

said this development was a serious blight and setback to the ongoing efforts to restore peace, security and stability to the Kingdom of Lesotho.

"It is an unfortunate occurrence which threatens the prevailing peace and security of the SADC region as a whole. In order to avert the possibility of further deterioration of security in the Kingdom of Lesotho, SADC is immediately deploying a ministerial fact finding mission to Lesotho from September 7 to 10, 2017. The mission will comprise organ Troika ministers plus SADC chair accompanied by defence and security experts," states the statement. SADC added that the fact finding mission was

expected to conduct an assessment of the security situation and to hold meetings with all key stakeholders in Lesotho in order to establish the root causes of the assassination and subsequently recommend the appropriate courses of action.

It further states that SADC wishes to reassure all citizens of Lesotho, member states and the entire international community that SADC remains seized with developments in Lesotho and will spare no efforts in ensuring the maintenance and restoration of lasting peace and security to Lesotho.





# Moza man arrested, faces 10 counts of house-breaking

A Mozambican man was boldly told by Magistrate Sifiso Vilakati in a half-empty courtroom that he would not be granted bail as he might escape back to his country.

Vali Sibukiso Nuva (23) first appeared before court last Friday, where he was facing three counts. However, when he appeared yesterday Crown Counsel Chris Sibandze moved an application to amend the charge sheet, wherein seven counts of house-breaking and theft were added.

Nuva will effectively spend eight days in custody before his third remand on September 15, pending his trial date on October 12."The crown has opposed your bail application due to the fact that you are from another country and you might escape before the trial



date, hence you will be kept in custody until the matter is finalised," Vilakati said.

This statement left Nuva disappointed as he was eager to regain his freedom.

The suspect, who cut a figure of a worried man, is facing 10 charges of house-breaking with intent to steal and theft, and contravening the Immigrations Act after he entered and remained in the country without a valid residence permit. He allegedly stole items valued at E138 710 last year between the months of June and November in different areas situated at Ezulwini. However, he was officially charged on September 1 for contravening section 14 (2)

of Immigration Act 17 of 1982.

He was slapped with this count soon after his arrest at Ezulwini.

Soon after his appearance before Vilakati, he was whisked away by a police van to the police station pending his transfer to the Sidvwashini Correctional Services.

According to the charge sheet, Nuva allegedly brought grief and fear to areas such as Emareld Park, Mantenga and Gelekeceni. Amongst those affected by his alleged crimes include the Mantenga Lodge and Cultural Village where valuable items were stolen.

Nuvawas not asked to plead and his trial has been setfor

### The house-breaking counts Nuva stands accused of:

In that or on June 21, 2016 while at Ezulwini, Emareld Park, he allegedly did wrongfully, unlawfully and intentionally broke and entered the house of one Mpendulo Nhlengetfwa and stole property valued at E24 070. Amongst others, the items included two laptops external hard drive and a cellphone.

### Count 2

On November 3, 2016 while at or near Ezulwini he allegedly broke and entered into the house of Nkosinathi Nkonyane and stole property valued at E6 440. The items included a black Sansui plasma and silver JVC home theatre.

On October 26, 2016 while at or near Mantenga, he allegedly broke and entered into the house of Lionel Chambers and stole a black 38-inch television set valued at E10 000.

On the month of August, 2016, while at Gelekeceni he allegedly broke and entered into the house of Sipho Dlamini stole a black Samsung television set valued at E7 000.

On the month of August, 2016, while at or near Cultural Village. He allegedly broke and entered into the house of Francis Bhembe and stole a white master fridge valued at E1 500.

On June 14, 2016, while at or near Mantenga Lodge he allegedly broke and entered into the house of one Karen Comins and stole property valued at E4 300. The stolen items included a black LG 26 inch television, two duvet covers and two pillows.

On September 28, 2016, while at Ezulwini, he allegedly broke and entered into the house of one Jacobs Leon and stole property valued at E80 000. The stolen items included a black sony Bravia television worth E30 000 and a Yamaha amplifier tuner receiver worth E50

On the month of August, 2016, while at or near Mantenga, he allegedly wrongfully, unlawfully and intentionally broke and entered into the house of Happiness Banda and stole a black Sony television valued at E5 000.

On the month of August, 2016, while at or near Ezulwini, he allegedly wrongfully, unlawfully and intentionally broke and entered into the house of Rashid Mohammed and stole a steel salton fan valued at E400.

The accused is charged with contravening section 14 (2) of Immigration Act 17 of 1982. In that upon or on September 1, 2017 while at or near Ezulwini, while not being a Swazi citizen did wrongfully and unlawfully entered and remained in the country without a valid residence permit.

# MAN MURDERS WIFE, CELEBRATES BY DRINKING BEER AFTERWARDS

IN a brutal and inhuman murder incident, a man is said alleged to have killed his wife by severely assaulting her and banging her against the wall of their house before leaving her for dead.

As if washing his sins away, the man, Thokozani Samson Mngometulu, is alleged to have proceeded to a tree within their homestead where he sat and drank beer before disappearing.

Mngometulu has since been indicted at the High Court on charges of murder of his wife Nokulunga Ndwandwe and according to the summary of evidence, the prime

witness stated that the accused who is employed in Johannesburg, South Africa was from work on the fateful day.

It is said upon arrival at Somtongo he took his wife for a shopping spree at Nhlangano and bought her furniture and some groceries before they proceeded back home.

However, things changed when he upon arrival started accusing his wife of having a sexual affair with another man.

That is when he started assaulting her severely before banging her against the wall. He left her bleeding profusely on the floor of their house.

After the killing he grabbed a bottle of beer and proceeded to a tree within the compound, sat there and watered down his sins with the beer before

after hearing the screams emanating from the assault, they proceeded to investigate and found the deceased already dead lying on the floor with the walls in the house covered with blood.

One of the witnesses stated that

Police were called and the deceased was taken to hospital where he was certified dead and a search for the accused person ensued. He was arrested and subsequently charged with the murder of his wife.

At least 14 witnesses including neighbours, investigating officers and pathologist would be paraded by the crown when the trial begins.

# About 18 000 Swazi women risk rape in foreign countries

NATIONAL Director of Women and Law Swaziland Xolani Hlatshwayo has said the country has 18 000 informal traders who risk getting raped in foreign countries.

Hlatshwayo was speaking during an interview at a packed Women and Law stand at the on-going Swaziland International Trade Fair in Manzini on Sunday.

Hlatshwayo said the informal traders were mostly women who literally put their lives at risk every time they visited foreign countries where they do business.

"The bulk of the informal traders in Swaziland are women who have to go outside the kingdom to do business, unfortunately, they start to struggle right at the border gate that has adopted very complex and ever changing rules and regulations regarding the import or export of products.

The border personnel do not always understand that the bulk of these

traders lack a higher education caused by extenuating circumstances, so they cannot always fill out the forms at the border gates. This in some cases results in some woman having to pay boys money at the border gates to fill the forms for them. The women risk getting raped because they are forced to sleep in very unsafe areas when they travel into foreign countries. We have reports that rapes sometimes do occur abroad," she said.

Also at the Women and Law stand was President of the Women's Cross Border Committee Thobile Dube who confirmed that their organisation had about 18 000 members

who crossed the borders regularly for business, thus risking rape in the process.

"Our members do encounter various problems such rape because they lack adequate protection. We,as as a committee, are very proud of SWEET (Swaziland Women Economic Empowerment Trust) for helping these women with micro finance," she said.

### Dissemination

Meanwhile, Legal officer at Women and Law Swaziland Dumsani Dlamini said correct dissemination of information was key to helping informal traders avoid being taken advantage of in foreign countries.

"As Women and Law our doors are open to help women gain information that will allow them to know their rights.

Government also needs to start recognising the fact that informal traders are very important to the country's economy because if we allow these traders to have money it will stay in the country and circulate here but if they continue going to foreign that is money lost," he

## HIV/AIDS pandemic has new face

WHILE the world might have assumed that the HIV and AIDS pandemic battle had been won, Regional Psychosocial Initiative (REPSSI) Chief Executive Officer (CEO) Noreen Huni has stated that infact the pandemic has just started.

Making her remarks yesterday in Arusha during a media briefing session, Huni said the world needed to be alive to the fact that the pandemic was just actually starting over as it had returned in a new form with a new face which is adolescents.

"It is true that the world has made strides in controlling the spread of the

virus and there aren't many new infections reported in the adult bracket, but the world has left behind the adolescents who are now the most infected group and the ones who record new infections.

So, essentially that means that the pandemic is only just starting again, just in a new form as it is affecting another generation," she said.

Huni, an advocate for children through addressing their psychosocial and mental well-being, said because of this development the world needed to explore ways in which they could engage young people who were now the most affected and the ones exposed to new infections on a daily basis.

She said governments and all other stakeholders had a challenge ahead of them to work out ways in which they could curb and nip in the bud this new form of the pandemic.

"This new form is as energetic as a teenager, as fast and innovative as social media hence when addressing it we need to be vigorous. As long as Africa, especially, is still faced with challenges like teenage pregnancies, intergenerational relationships, child marriages and rampant sexual abuse then our adolescents are in trouble in extension meaning the world is in trouble and zero infections by 2030 will remain nothing but a dream," she said.

Psychosocial

Huni implored each member state to mainstream psychosocial support as that would allow the adolescents to think critically and in turn ask the difficult questions which would spark conversations within homes. She said it was her belief that the victory was in these conversations as this would keep the adolescents open minded.

She further urged all the member states to go home and create a conducive environment for adolescents not only to ask questions but to be able to live their best lives possible regardless of their background.

She encouraged member states to deal with the challenges that these youngsters were faced with like child marriages, intergenerational relationships, sexual abuse and teenage pregnancy.

"We need to put in place culturally appropriate frameworks that will protect the adolescents," she said.

Huni is part of the over 400 participants at the Psychosocial Support (PSS) Forum in Arusha, Tanzania. The forum, hosted by REPSSI in collaboration with Southern African Development Community (SADC) and East African Community (EAC), is a platform for member states to share on how member states can mainstream

psychosocial and mental well-being in the fight against HIV and AIDS and poverty. REPSSI is operational in 13 countries in the SADC and EAC regions including Swaziland but 34 countries participated in this forum with 11 of them being European and Asian countries

### Delegates

Swaziland was represented in the forum as there were delegates from the Deputy Prime Minister's Office, ministries of education and health and the civil society.

The forum was preceded by a conference for adolescents where they deliberated on issues affecting their countries and Swaziland was represented. One of the adolescents representatives from Swaziland Xolani Magongo further made a presentation at the forum on issues affecting African adolescents and further made recommendations.

# DR LIKOJI SUSPENDED

# ...as direct payee for health services for SwaziMed

PROMINENT private medical practitioner Dr Tshibungu Jean Pierre Likoji has been suspended by the Swaziland Medical Aid Fund (SwaziMed) as a direct payee for the provision of health services for Swazi Med.

Dr Likoji of Smart Clinic in Manzini is alleged to have over utilised services provided to SwaziMed clients and his suspension was with effect from April, 2017.

He has since filed an urgent application at the High Court, where he is seeking an order of court declaring the suspension unlawful and wrongful, also he wants SwaziMed to set aside and uplift his suspension.

Dr Likoji, a specialist physician is amongst two other doctors who were suspended by SwaziMed in April, has been cited as the applicant in the matter while SwaziMed is the respondent.

SwaziMed represented by senior attorney Mangaliso Magagula of Magagula Hlophe Attorneys is yet to file its responding papers and the matter is



before High Court Judge Sipho Nkosi. Prior to his suspension, a meeting was convened by SwaziMed where Dr Likoji was present and management registered their concern regarding his claims for medical and health care services provided to its members.

He is alleged to have amongst other things, performed certain medical procedures on member patients implying that such procedures performed appeared to be routine and were strictly necessary and thus being an exploitation of the medical aid scheme for financial

In his papers filed before court, Likoji submitted that he was questioned on the use and costs of certain medical procedures and consumables on member patients, the allocation of codes for certain treatments and also questioned on the number of patients he treats.

He said he requested that reference be made to specific cases where the Fund had queried claims or matters.

### **Patients**

He stated that he only attended to patients that were within his scope of practice pertaining to medicine or referrals from general practitioners.

Likoji stated that he does not attend to gynecological, pediatric or surgical patients and that they were welcome to refer him to specific matters that fell outside of his area of expertise.

He said he undertook to cooperate with the respondents to resolve any or all concerns regarding claims including the reconciliation of his outstanding claims submitted to the amount of E90 915.

"I submit and verily believe that the process leading to my suspension from direct payment as a medical and health care provider was procedurally incorrect, unlawful and arbitrarily obtained leading to a unilateral variation of the parties' contractual relationship."

# ... 'Two patients have died following my suspension'

DR Likoji has claimed that two of his patients have already died after failing to get medical assistance from him following his suspension.

He alleged that since he is no longer a direct payee for the provision of health services for the fund, vices for the fund, some of his patients could no longer access his services.

Likoji further alleged in his affidavit that on average he would attend to approximately 10 to 15

patients per day, depending on the medical condition.

As a consequence of the suspension, he has lost 80 per cent of his patients who would otherwise access his services under cover of the medical aid.

The implications of the suspension according to Likoji had serious and dire consequences for his medical practice, and consequent-

ly his livelihood, his name and reputation both as respected medical doctor and professional within the Swazi community.

> He said the publication of the notice of his suspension on August 21, was unnecessary and that such could have been communicated privately to members of the fund through electronic means or otherwise.

He viewed the general conduct of the respondent against him as being malicious, vexatious, unwarranted and defamatory.

He said the closure of his medical practice will result in the loss of his livelihood, loss of employment for all staff members and damage to his credit worthiness to creditors and suppliers of pharmaceuticals and medical equipment.

# SwaziMed wonder why Likoji filed after months

SWAZIMed is yet to file its responding papers at the High Court and Judge Sipho Nkosi who is handling the matter postponed it tomorrow.

However, senior attorney Mangaliso Magagula representing SwaziMed on Tuesday wondered as to why the applicant, Dr Likoji filed his application after so long.

### Submitted

Magagula submitted before Judge Nkosi that the letter of suspension was served on Likoji in April yet he has come to court on an urgent basis five months down the line,

However, Magagula submitted that they are yet to file their papers as they have only been served with the application on Monday and had not prepared their responding papers as the application was brought before court on Tuesday.

# Dr Likoji resorts to selling assets to sustain medical practice, family

IN his papers Likoji submitted that the matter is urgent on account that if his suspension was to continue indefinitely, it may and will result in the imminent closure of his medical practice.

In the meantime, he stated that he has resorted to selling off certain assets and surrendering medical equipment to creditors and financiers to sustain the operations of the clin-

He claimed to be failing to meet the financial upkeep of his family and dependants as he had three children in university and one at high school. **Papers** 

He submitted in his papers that all his children were dependent on him for their education, welfare and upkeep and are now at risk of dropping out of university to their extreme

prejudice.

Likoji said he could not continue to resort to selling assets or obtaining loans to sustain his medical practice in the hope that the matter would be resolved amicably.

He said the matter is further exacerbated by the fact that the suspension is indefinite whereas his name and reputation and livelihood is under immediate jeopardy and threat.







## Public transport operator takes RTB to court over permit

A public transport operator has run to court where he is seeking an order to have his public transport permit released to him forthwith.

Mathokoza Mgwane who runs a public transport business (kombis) has taken the Road Transportation Board (RTB) to court where he is seeking an order

for the release of the permit to him.

He argued that his permit was taken by the RTB although it has not even expired and argues that following his grounded business, he is suffering prejudice in that his public vehicle is lying idle without generating any income.

Although the matter is yet to be argued in court High Court Judge Sipho Nkosi however noted that according to law, no one has the right to shut down a business except an order of court.

He observed that there have been a number of cases involving public transport operators whose permits have been taken by the RTB.

The Attorney General's office is opposing the application filed by Ngwane and is yet to take further instructions on the matter which is yet to be argued.

Judge Nkosi postponed it to a later date as the RTB is yet to respond through its responding papers to be filed before Friday.

# Companies must respond to media's questionnaires promptly

MEDIA Institute of Southern Africa (MISA) Swaziland Director Vuyisile Hlatshwayo says local companies should respond to media's questionnaires within the pre-agreed time period.

Hlatshwayo said Swazi companies who hired public relations officers (PROs) had no excuse to delay answering questionnaires seen as urgent.

"It all depends on the sensitivity and urgency of the story, therefore it is fair for companies to answer a questionnaire coming from a media house within the pre agreed time period, that a journalist and a Swazi company have agreed on, this could be 24 hours, 48 hours or even 72 hours. We understand that most written media houses have their own vary-

ing deadlines as well as competition from others in the industry, so it is fair for companies to answer questionnaire promptly or within five days, unfortunately some companies like to delay answering to questions," she said.

### Victim

He said currently journalists were falling victim to companies that delay responding to questionnaires due to an infinite number of reasons.

Hlatshwayo said more often than not, these companies delay to comment if the story is bad for their publicity and with such stories 14 days is enough time to answer.

Meanwhile, during the compilation of this story the Secretary General of the Swazi Editors Forum (SEF) Jabu Matsebula was not available for comment as both his cellphone numbers were not responding on his selected cellphone network.

# SACAU ROUNDS UP AGRF 2017 IN COTE D'IVOIRE

# 'COURTS SHOULD BE ALLOWED TO DECIDE ON GRACE MUGABE DIPLOMATIC IMMUNITY MATTER'

CAPE TOWN - South Africa Deputy President Cyril Ramaphosa says the courts will decide whether or not the government did the right thing in granting Grace Mugabe diplomatic immunity.

Zimbabwe's first lady was given diplomatic immunity by International Relations and Cooperation Minister Maite Nkoana-Mashabane after allegedly assaulting a young woman in her sons' hotel room. Ramaphosa says Parliament's international relations committee is seized with the matter, while the decision's also being taken to court by Afriforum.

"Through the exercise of the powers that our judiciary has, they will be able to deliver a solution, an end or a judgment in this regard and we will then be able to know what should have happened." Ramaphosa wants the Mugabe matter left there. But the Inkatha Freedom

Party's Mkhuleko Hlengwa suggested he "get real".

"We cannot possibly have a situation where a South African is left helpless because there is power on the other side, of Mrs Mugabe. So I'd like to hear your views. Do you think it is correct?" Ramaphosa did not answer the question directly, insisting that the African National Congress was founded on its respect for human rights and that the

courts should be allowed to decide the matter. Ramaphosa has affirmed lawmakers' powers to sanction Cabinet ministers who fail to account to Parliament.

He was responding to the Economic Freedom Fighters (EFF) question about what he's doing about Minister Faith Muthambi who snubbed a meeting of the Public Service and Administration Oversight Committee last month.

# COPS RAID POLICE CAMP, FIND DAGGA SEEDS

ABOUT 1 000 dagga seeds have been found in the possession of a suspended Pigg's Peak policeman during a raid conducted by his own colleagues.

The raid happened at the Pigg's Peak police camp last Friday afternoon.

It has been confirmed that the policeman in question has been on suspension since 2013 for prior narcotics violations and he continued to live at the Pigg's Peak police camp where he allegedly wears his police uniform.

Speaking to this publication on Friday after the raid, a source said the raided

policeman threw the dagga seeds outside his window. "The policeman has been on suspension since 2013, yet he continues to live at the police camp instead of going home to his family. This is because as a civil servant he is still entitled to accommodation, the raid happened after the police received a tip-off that the suspended police officer was dealing in dagga. During the raid, he threw out 1 000 dagga seeds out of his window only to be spotted by other police officers. Also E30 000 cash was found inside the policeman's bedroom as well as his dirty police uniform and boots," said the source. The source alleged that the police officers who conducted the raid suspect that the

policeman knew he would be raided so he removed all the drug paraphernalia ahead of time but forgot the dagga seeds. When reached for a comment, the suspended policeman said if he was guilty he would have been arrested already. "There is no point hiding my name because I need help, I am Busta Vilakati I have been a police officer for the past 17 years. All I can say is if I was found with the dagga seeds, I would have been charged already remember that I live in a block of flats which I share with 72 other officers. On Friday, about 10 police officers came to my residence with the deputy station commander. My colleagues then started to search me, they allege that I was seen

counting large sums of money. The search was done illegally and without due care for my personal belongings. My food was spilt on the floor and my belongings were scattered all over the place infront of my children who could not understand what was happening to their father.

I was preparing to run a bath when the raid was conducted. During the raid nothing was found, the police left my house and phoned me later saying that they found dagga seeds outside my residence window. This was very suspicious to me," he said. Meanwhile, Chief Police Information and Communications Officer Superintendant Khulani Mamba confirmed the incident. He added that the police had found the dagga seeds but Vilakati might have already destroyed all the available evidence.

In May, 2013 two police officers Busta Vilakati and Mthokozisi Mkhatshwa, were arrested along with three others for selling dagga to a police informant.

# Country submits Global Fund application

Information Centre Assistant Manager The National HIV and AIDS Information and Training Centre EARLY this year we met the news

that the Global Fund had availed a resource envelope of US\$49.7 million to the Kingdom to support HIV, TB and Malaria programmes. The Malaria proposal was submitted in March this year amounting to \$2.6 million and has since been approved by the Global Fund.

A joint TB/HIV balance of \$47.2 million was set aside, where \$35.3 million is for HIV and \$11.9million for TB.

Following one of the most consultative processes ever embarked on in the history of Global Fund (GF) applications, the country has recently submitted a TB/HIV funding request for US\$ 93.8 million under Window 3. Broken down as, \$47.2 which is within the country's allocation; \$1.5 million as a request for catalytic funding to prevent HIV among adolescent girls and young women (AGYW); and \$45.1 million as a prioritised programme above allocation request (PAAR)."Through tremendous support from government and partners, the Country Coordinating Mechanism (CCM) Funding Request Development Team conducted extensive consultations with all relevant stakeholders, including adolescent girls and young women," said Vulindlela Msibi, CCM Executive Secretary. The country held dedicated sessions with HIV and TB key populations, including people living with HIV (PLHIV), TB survivors, ex-mine workers, exprisoners, sex workers, men who have sex with men, and people who use drugs among others."We even held several focus group discussions, down at community level" he added.

Principal Secretary in the Ministry of Health, and Chairperson of CCM says Swaziland is grateful to the GF for this significant investment in our next implementation phase, beginning in October 2018 to September 2021 and he has no doubt that the funding will help us achieve our vision of an AIDS-free Swaziland by 2022

### THE PROPOSED MATERIAL CHANGES IN THE FUNDING REQUEST

CCM Executive Secretary, Msibi notes that the funding request is tailored to material change, which is intended to be less comprehensive than full review applications. As per funding request instructions, the country's application identifies material changes that have occurred in the country, leading to the need to revise and / or re-prioritise certain programme areas funded by the GF. The 'triggers' for material change, have resulted in the proposed 'strategic modification' below:

### INNOVATION FOR 'LAST MILE' IMPACT

This innovation was triggered by the relevant changes in the country's epidemiological context. New data from the second Swaziland HIV Infections Measurement Survey (SHIMS II) reveals remarkable progress, since the first in 2011. New infections have fallen by almost half, and viral load suppression among PLHIV has more than doubled. Similarly, new (unpublished) 2016 TB data from the World Health Organisation (WHO) indicate that the country continues to close the gap in missing TB cases - 16 per cent of TB cases went undetected in 2016, compared to 56 per cent in 2013. These changes in the country's epidemiological context mean that it will get harder to reach those not yet tested for HIV or screened for TB, and to put them on treatment. Many of these unreached people may be hidden or criminalised populations or those that face barriers to accessing services. To reach these populations, the country has proposed several innovative activ-

ities for 'last mile'. These include the roll out of HIV testing among HIV and TB key populations, including sex workers, men who have sex with men, people who inject drugs, factory workers, and TB contacts, among others. For TB screening, a cadre of active case finders working in the community, will be guided by geographic information systems (GIS) mappings of high risk groups, including mine workers and ex-mine workers.

### EXPLOITING NEW POLICY OPPORTUNITIES FOR **INCREASED IMPACT**

This was triggered by the many new policies and guidelines that have recently been launched in the country, which warrant modification to the GF program to align with the new approaches. As of June 2016, community antiretroviral therapy (CommART) has become a national policy, enabling PLHIV on treatment to travel infrequently to facilities to collect their HIV medication. Similarly, in October 2016 Swaziland launched the 'Test and Start' policy, which offers immediate antiretroviral therapy upon an HIV positive diagnosis, irrespective of the CD4 count. Also, in April 2017, the country moved to routine viral load testing which provides at least one test per year to all PLHIV. Then there is a new (draft) defined core package of HIV prevention, tailored by age, sex and population. For TB, in January 2017, the country launched new guidelines for management of drug-resistant TB (DR-TB), including the new short-course treatment regimen and the use of new TB drugs. The funding request harnesses opportunities within all these new policies - and several others. In support of the 'Test and Start' policy, government has committed to procuring all firstline ARVs for the country. The GF grant application request is, therefore, to modify drug procurement to only second and third-line ARVs. In addition, more than 10 per cent within allocated budget goes towards ensuring viral load testing scale-up, aiming for

routine offering among all PLHIV. The newly defined core packages for HIV prevention are used as the basis for all services to be delivered to AGYW, men who have sex with men, and sex workers. Investment in nutrition and transport support for DR-TB patients will nearly double compared to the current grant, scaling up in line with the new guidelines.

### ENHANCING INTEGRA-TION FOR GREATER IMPACT **AGAINST TB/HIV**

Changes in resilient and sustainable systems for health (RSSH) investments are needed to maximise reproductive maternal, neonatal and child health impact (RMNCH) or other areas. There are significant missed opportunities because not all health facilities offer integrated HIV, TB and reproductive health services. Swaziland has a 70 per cent TB/HIV co-infection rate, yet only 118 out of 170 ART sites also offer TB treatment. In addition, while 41.1 per centof pregnant women are living with HIV, there are 13 antenatal care sites which do not offer ART. To improve integrated service delivery, the funding request prioritises theroll out of the essential healthcare package, training community workers, and introducing integrated management of childhood illnesses. The training of community health workers is to ensure that the integrated service delivery can happen at the community level, while more facilities transition to offer a full package of services. In the PAAR, funding is requested for necessary refurbishments so that more facilities can become accredited TB basic units.

### A MORE LOCATION- AND POPULATION-SPECIFIC PRE-**VENTION APPROACH**

The focus on HIV prevention is significantly enhanced in the funding request, accounting for more than a fifth (21.1 per cent) of the total budget. This is more than seven times greater than what was in the country's last application, which, at just 3 per cent, was one of the smallest HIV prevention request of any African country. The clear majority of this prevention funding is focused on AGYW, as young women aged 20-24 have the highest rates of new HIV infections in the coun-

The funding request for young women is highly targeted - mostly focused on

13 high-density, low income areas with high rates of teenage pregnancy (as a proxy for low condom use). The proposed programme includes community health fairs; provision of sanitary pads and educational subsidies to keep girls in school; and peer clubs for outof-school girls. The matching funds application requests money for the piloting of a voucher system to link girls to pre-paid health services at their preferred health outlets. This strategic modification also includes peer outreach for newly prioritised key populations, as well as allocates money for people who use drugs - a first for Swaziland's

### IMPLEMENTING A PHASED TRANSITION OF MSF-TB **PROGRAMMES**

MSF, which contributes over \$4 million to the country's total TB budget has made an executive decision to handover and close all MSF-supported activities by 1 July 2018. The funding request proposes that some of the money from the GF should be used to enable a responsibly managed transition, ensuring that there are no major program disruptions or reversed impact against the disease.

### TECHNICAL, ALLOCATIVE AND IMPLEMENTATION **EFFICIENCIES**

This strategic modification is driven by the significant reduction in the country's GF allocation which has been reduced to \$51.3 million in the 2017-2019 funding cycle, from \$80.4 million in the 2014-2016 funding cycle.

To try and "do more with less", the funding request proposes aligning the GF programme to the country's investment case (Umgubudla), which suggests those strategic investments that should be made in the short term that can lead to cost saving later. In fact, investing in the high-impact Umgubudla interventions, has the potential to bring down the cost per HIV infection averted from \$1.135 in 2014 to just \$250 by 2030; and to generate a 70 per cent financial savings for the TB program...

# Can Cyril survive?

IN May this year I wrote a piece under the title "Could Zuma be planning an ambush?" In it I warned that such an ambush could take the form of "damaging disclosures (truthful or otherwise) about the other side".

In conversations with business I repeated my belief that the Zuma camp will almost certainly use stories of a sexual nature against Cyril Ramaphosa closer to the electoral conference.

And so it came to pass.

The story published over the weekend was totally predictable and, if it wasn't for the very worrying possibility that state resources were used to hack Ramaphosa's private emails, almost boring.

Of course there was also the irony of the Zuma camp trying to tarnish the opposition with stories of infidelity.

The question is now whether Ramaphosa can survive this in and outside the ANC?

I think he can under certain preconditions. The first pre-condition is that he cannot lie. I suspect that the majority of people could not care less what consenting adults (politicians or anyone else) do behind bedroom doors.

If infidelity was a crime possibly half of this country and most politicians would be in jail. It might be hurtful to the other party in the marriage, but that is for those involved to sort out.

Thanks to our current president South Africans don't really blink about polygamy. It is also widely accepted that the president has numerous girlfriends. He is unapolo-

getic about it and at most the nation laughingly wonders where he gets all his energy from.

So Ramaphosa's sexual escapades should only make for a bit of salacious reading and perhaps a couple of funny memes ... unless he doesn't come clean.

As Bill Clinton found out, it wasn't so much the romping around in the Oval office with Monica Lewinsky that got him impeached, as it was the I-did-not-have-sex-with-thatwoman denial. It raised questions about his honesty, integrity and ability to run the country.

As a nation we have also become totally numbed by our politicians lying incessantly not only to the electorate, but even to their own colleagues in Parliament - which is in fact a crime.

However, the vast majority of people inside and outside the ANC want change and thus need Ramaphosa to be different.

We need a Madiba-like leader: someone to be proud of, who can

be trusted, who can re-calibrate the nation's moral compass and of whom we can assume the best, rather than always expecting the

And so if there were more than one woman, Ramaphosa should not try and spin this or play around with words. He must confess right now, apologise and sort things out with his spouse (not necessarily in that order). Then he will most probably be seen as 'just human' and given brownie points for coming clean. But not if he betrays our trust.

Secondly, Ramaphosa can survive this crisis if there are no other scandals that stick.

The Zuma camp has already tried the "he-beat-his-wife" tactic (again, so predictable). The Ramaphosa camp handled the accusation with aplomb, but what will the Zuma camp try next?

Ramaphosa's team must use their own intelligence to get ahead of these stories and expose them as smear tactics (assuming that is all they are) and so possibly even secure a few additional sympathy votes.

Thirdly, Ramaphosa must now pick up the sword and enter the battle - with 100 per cent commitment. Two weeks ago I raised the question of why Ramaphosa was

As tempting as it was to write a column titled, "Now I know why he is so quiet", I don't believe that would have been correct. I think something more serious was revealed during this past weekend's dramas.

During his late night bid to stop the publication of the story Ramaphosa's legal team argued

that he has a right to privacy and that certain parts of his life is not of public interest.

That is not true and it is worrying that Ramaphosa would allow his lawyers to even go there.

The women who were falsely mentioned in the leaked text messages absolutely have a right to privacy. They could have stopped the story and should still consider legal action against those who linked them to these accusations.

Of course, if Ramaphosa was still in business and had stopped all political activity he could also have claimed the right to privacy. But as deputy resident and presidential hopeful everything about him is of public interest.

Suggesting otherwise possibly explains why there is at times a sense of ambivalence around Ramaphosa's presidential campaign.

He is no longer the billionaire businessman who can claim certain things that come with that lifestyle - such as privacy when it comes to bedroom matters.

He simply can't be both businessman/private citizen and deputy president/presidential candidate. Becoming president requires more

than resigning board seats and letting go of business interests.

It also demands letting go of a certain state of mind and becoming totally focussed in this gladiator-like battle.

Like the fighters in Roman times, he cannot enter the arena with any ambivalence if he wants to survive. Nor can he, when the lions are storming down on him, try Codesa-like to negotiate his way out.

The only choice he has is either to stand and fight or run like hell.

On Sunday Ramaphosa said that he wasn't going to run away.

WHEN I was a teenager - I can't remember exactly how old, but younger than 16, I think - my grandmother gave me a birthday present of R1 000. She was living in Portugal, but still had a bank account to receive her Wits pension in South Africa, and she paid the money into my bank account out of that.

My rather sketchy memory of the past tells me that at the time, I held a Bob-T account, but I could have fabricated that.

I drew the money and spent it on a few choice purchases, including buying something for my mom (R1 000 went quite a lot further in those days). And then I went back to my life of teenage pauperdom, and didn't use my bank account for anything for a while.

# When R14 million appears Exactly nine months later, I ran-

domly did a balance query at an ATM. I don't know what compelled me. Perhaps I was hoping that the few loose cents rattling around in there had somehow multiplied with the magic of compound interest and grown to an amount that I could actually withdraw.

The ATM issued a little white slip of paper and I glanced, not very optimistically, at the balance. To my great surprise, there was rather a bit of money in there - R9 000 to be exact. I had a fleeting notion that I'd won some kind of banking lottery. Then I wondered if there was some technical error, so I checked again. I tried to convince myself that the interest on R5.50 could add up to R9 000 in nine months. And then I assumed some kind of mistake had been made, and I went into my nearest branch to discuss it with a teller.

It hurt me. I knew that this money was not mine, and I knew that the R9 000 could have bought me a lot of whatever I was into in those days (probably books and CDs). I considered withdrawing it all and putting it under my mattress, but I was driven by a desire to do the right thing (and a fear of being caught doing the wrong one). At the tender age of not yet 16, I knew what I had to

It emerged that my grandmother had somehow created a stop order instead of a once-off payment, and so R1 000 was being deposited into my account every month. Because I hadn't been checking my bank account, it quietly accrued. I called her in Portugal to let her know, and she told me to hang on to the balance until she next came to South Africa – but to take another R1 000 for my troubles.

It wasn't exactly paydirt, but it was enough to take some of the sting out of the loss.

Even so, it hurt me to have to give the rest back. So when I read about Sibongile Mani, the Walter Sisulu University student who was accidentally paid out R14 million by the National Student Financial Aid Scheme (NSFAS), and then spent R800 000 of it at a frightening speed, I get it. I get all the heartbreaking thoughts that must have gone through her head.

They must have been a million

times more heartbreaking than the thoughts that went through mine because she clearly comes from a disadvantaged background, and I do not, and because R14 million is a mindblowing and lifechanging amount of money. She made the wrong decision - of course she did

- but to present a student from a disadvantaged background with unimaginable wealth is a cruel and unreasonable thing to do.

It's like holding a caviar and champagne party in front a person who can't afford bread.

Yes, the money was never hers. Yes, she knew that, and still behaved like it was. She owes that money back and rightly so. But the company distributing the NSFAS funds who did this to her put her in a very difficult position. Yes, she hasn't come out of this smelling of roses (although her weave is lovely, and apparently the Johnny Walker Gold was delicious), but she should never have been put in that position - and she should never have had months to dig herself deeper and deeper into a financial hole that she'll have to find a way out of.

# Sex and politics: keeping an eye on the right prize

PUBLIC matters and private affairs; the not so fine but sometimes porous line between what happens in politics, and what happens between individuals behind closed doors.

In European modernity, and in those parts of the world which fell under its sway during the centuries of colonial conquest and imperial rule, there were supposed to be clear divisions between them; whole institutions constantly policed those barriers, and do so still, making sure that there is no overreach of power from one sphere into the domain of the other.

These domains are also gendered, the private and the public seen as feminine and masculine respectively. Sheila Rowbotham and Nancy Armstrong have written extensively on how the contemporary gender regimes were constructed over the same decades and centuries as the change in economic organisation across Western Europe that would become capitalism, and the division between the public and the private spheres of power in society. Women ruled the hearth, men ruled the marketplace.

### Consumption

There were certainly versions of this arrangement in antiquity, but it is the emergence of capitalism which shifted the meanings of those older forms.

Those ways of organising the world and the people who live in it have been reinforced in and by public institutions, and in the texts of the entertainment industrial complex. In the fantasies and dreams manufactured for consumption on television and in cinemas, the ways in which we think of the privatefeminine and the public-masculine have been endlessly repeated as truth, rather than as ideology, just the way of the world, not a belief about how the world is and should

But feminism allowed many of us to criticise this easy division, which kept the majority of the Earth's

human population out of the spaces in which public power is supposed to be exercised. We could see that this division did not apportion power equally to men and women, and only pretended that there was equal importance between the public and the private.

Feminism allowed us to see the intimate and intricate relations between the private and the public, such that we began to think about the value of work done in domestic spaces and the erasure of that work because the people who did it were devalued.

Some of that domestic work is quotidian domestic labour, some of it is reproductive labour which ensures the continued existence of the social arrangements in which we live, and some of it is the sexual labour which is not only restricted to reproduction, but involves the giving and taking of pleasure. That labour has long been seen as the index of morality, and was policed to render individuals and groups legitimate or illegitimate.

South Africa took this policing to levels both farcical and tragic, formulating laws like the Immorality Acts of 1927 and 1957. Who people could have sex with and under

what circumstances became matters of legal restriction. Lines were drawn, even as they were crossed. This prurience has lingered, often in worldviews steeped in religiosity. Invoking God to subject everyone to specific sexual mores is not a new strategy, but it is returning to South African politics.

### Discredit

In these new sermons in which people's consensual sexual habits are policed, moralising has been conflated with moral judgement. Prurient judgement about people's private lives has become mistaken for political commentary. In a socially conservative society like contemporary South Africa, the admittedly artificial distinction between the private and the public is often deliberately and opportunistically erased to open up individuals' private conduct for public shaming.

Much ink has been used, and much more will be used to discredit public figures based on their private consensual sexual conduct. The mantra for such policing is that people's private sexual mores reflect their public administrative functions because both domains involve questions of trust, and trustworthiness. What is lost in such exercises, these indignant and moralising sermons about trust meant to embarrass individuals, is the larger context of contemporary South Africa's crisis-ridden political economy.

Our politicians, and those who benefit from their conduct in office across the private sector, have worked together to create a country in which, 23 years after the abolition of legislated white supremacy, more than half of the people who live here are still poor.

### Celebrating

The health and education sectors are in crisis, the problems of homelessness and landlessness continue to blight the lives of millions. Gainful and dignified employment in humane conditions remain issues unresolved, and growing increasingly precarious. As the femicidal plague to which more than half the people who live in post-millennial postapartheid South Africa are subjected, we seem to have reached a state of paralysis in the country.

It is not that the consensual sex public officials have does not matter in how we see them; it is that it is less important even if possibly more interesting to talk about. After all, some people still think it is worth celebrating people who acknowledge they have homosexual relations when such individuals are ministers of government, members of the judiciary, or members of Parliament. Marital infidelity, though, is a private matter between the adults in that marriage, and it is for them to work out how they will proceed with their lives together or apart.

Selective, moralising condemnation of public figures for not adhering to the mores by which we claim to live our own private lives and lies will not be politically productive. It distracts us from focusing on the reasons we elected or appointed those public officials to begin with. Their job is to manage the public resources we entrust them with, and ours is to hold them to account on how they perform that job. eNCA

# WADE INITIATED COMPAN RAKE IN E14 BILL ...in the past five years

BUSINESSES initiated by the Swaziland Water and Agricultural **Development Enterprise (SWADE)** have generated over E1.4 billion in the past five years.

This income was generated from businesses such as those in sugarcane, maize farming and other crops, as well as those in piggery and beef production.

**SWADE Communications Officer** Nokwazi Hlophe said they have been working hard to improve the lives of people who reside at the Lowveld through various projects.

She said these results came after government disbursed a total of E1.2 billion during the past five years for the implementation of the Lower Usuthu Smallholder Irrigation Project

(LUSIP). Hlophe said the money was disbursed to assist in different areas under the project including labour, harvesting, electricity, loans and repairs.

"A total of about E12.8 million was allocated to assist in areas such as

labour. Harvesting is also one of the areas that were allocated money which amounted to E35.1 million and this is one of the areas that have contributed significantly to the employment of locals.

"The project also helped the beneficiaries with electricity where a total of E17.8 million was allocated whilst repairs got a total of E2.7 million and loans that have been disbursed amounted to E105.9 million," she said

To date, SWADE has impacted more than 80 000 people within the project development areas. "We had a target of 50 690 people that we were looking at impacting and we were able to go reach even more and this has in assisted the community," she said.

Hlophe said they had also been able to increase their delivery and to impact

many lives. She said the companies have contributed over E210 million in different taxes including Value Added Tax, Pay As You Earn and Dividend Tax.

SWADE was established by govemment in 1999 to facilitate the planning and implementation of the Komati Downstream development Project (KDDP) and Lower Usuthu Smallholder Inigation Project (LUSIP) and any other large water and agricultural development projects that government may assign the company.

The company seeks to empower communities to improve their quality of life through projects in commercial agriculture and other enterprises; providing innovative services in infrastructure development and management as well as expertise to public and private entities.



# Njengebantfu tags South African manufacturers to drive growth

IN order to avoid failing new businesses need to start working on new strategies according to Micro Finance Unit (MFU) Director David Myeni.

Myeni said businesses often fail due to various reasons and in order to avoid the same mistakes that have been done by others, new businesses need to employ new strategies.

"Some of the businesses that fail get into that because of poor business plans or lack of understanding. Some businesses are not viable or feasible; there is also lack or poor market research. Other reasons that can lead to the failure of businesses include over capitalisation, lack of technical expertise, experience, monitoring, poor management, corporate governance, integrity, record keeping, taxation," he said.

Myeni said entrepreneurs need to understand that before getting into business there are requirements that have to be met especially with financial institutions.

"Business plan and cash flow projection forms are part of the requirements that businesses need to adhere to. Financial institutions also need to check business viability and feasibility, market availability and sustainability, with technical expertise," he said.

"It is also important that businesses get to understand that financial institutions will look into risk mitigation measures, credit worthiness of the business and company registration documents," he added.

Myeni said there are a number of interventions that businesses could look into, which include development of sustainable business plans, capacity building, continuous mentorship and complete value chain assessment and quality.

"There is also a need for establishment of categories for SMEs versus corporates, reserve specific industries for SMEs, segment payment processes SMEs versus corporates and engage on youth participation and technology innovations whilst reserving enterprises for youth," he said.

"We now have postpaid contracts that last 24 months called Postpaid Elite Packages which come with elite bundles and this is affordable to almost everyone and it comes with with a free cell phone," he said.

Lastly, he said they want to go haywire with the new and exciting MTN Pulse which is specifically targeting the youth. "We looked at how young people use their phones. They often use them for data which is also mostly used in social networks. # High-ranking officers accused of Motsomotso's assassination

MASERU - Lesotho's Chief of the Defence Force Lieutenant-General Khoantle Motsomotso was assassinated on Tuesday morning, allegedly by a group of high-ranking officers, sending shock waves through the mountain kingdom.

Unconfirmed reports suggest the Chief of the Defence Force was ambushed by Colonel Sechele and Lt Col Hashatsi. It is claimed that both officers had received suspension or dismissal letters in a move by the Defence Force Chief to implement the SADC Commission's recommendations in order to restore stability in Lesotho. Motsomotso and one of the officers were killed in the shootout, while two high-ranking officers were critically injured at the Ratjomose Barracks in Maseru. It is alleged that the assassination took place on the heel of a number of soldiers being arrested by the police. The arrested soldiers are believed to be suspects in the murder of Lisebo Tang, who was killed near the residence of the former Army Commander Tlali Kamoli in 2014. Group Foreign

## Britain calls for new sanctions on North Korea

LONDON - Britain's Foreign Minister Boris Johnson on Tuesday called on the international community to impose further sanctions on North Korea following the country's latest nuclear test.

"We are now pressing the Security Council to pass a new resolution as swiftly as possible, imposing further sanctions and showing the unity and determination of the international community," Johnson told Parliament in London. He said North Korea's ambassador to Britain had been summoned to the Foreign Office "to receive a formal protest".

North Korea on Sunday triggered a global alam with by far its most powerful atomic test to date, claiming it was a hydrogen bomb that could be mounted on a long-range missile.

US Ambassador Nikki Haley told an emergency meeting of the UN Security Council on Monday that Washington will present a new sanctions resolution to be negotiated in the coming days, with a view to voting on it next Monday.

Haley did not spell out what measures Washington was seeking, but diplomats said they could target oil supplies to North Korea — potentially dealing a major blow to the economy.

New sanctions could also seek to curb tourism to the country and ban North Korean labourers sent abroad, AFP

# SADC DEPLOYS FACT-FINDING MISSION TO LESOTHO

MASERU - Following the assassination of Lesotho army commander Lieutenant General Khoantle Motsomotso, the Southern African Development Community (SADC) has moved swiftly to deploy a fact-finding mission to get to the bottom of the killings that sent shockwaves to the nation on Tuesday.

Apart from Motsomotso, Lesotho Prime Minister Thomas Thabane has confirmed that the other two Lesotho Defence Force (LDF) officers, Brigadier Bulane Sechele and Colonel Tefo Hashatsi have also died after they were shot in an incident that occurred between 9 and 10 am on Tuesday.

He said investigations are in progress to find out exactly what happened in this "unfortunate, untimely and totally illegal deaths".

Thabane said that his government has already reported to the SADC and that he is sure they will respond in their characteristic manner when a tragedy like this occurs in a member state.

Immediately after his briefing, the Minister of Public Service Thesele Maseribane who is also a partner in a quartet coalition revealed that the SADC had already responded, indicating the



## UN chief warns over N.Korea rhetoric, urges new strategy

ership and at US President Donald Trump who has warned that Pyongyang would face "fire and fury" if it keeps threatening the United States. "Confrontational rhetoric may lead to unintended consequences.

The solution must be political," Guterres told reporters.

### Death toll from Nigeria cholera rises to 21

KANO - The death toll from a cholera outbreak in restive northeast Nigeria has risen to 21, with most of the victims living in a camp for people displaced by Boko Haram violence, the health ministry said Tuesday. On Saturday, the ministry had said the cholera toll was 14 in the town of Maiduguri, with most of the victims living in a camp for people displaced by Boko Haram violence. "As of 4 September, 21 deaths have been reported," the Borno state health ministry said Tuesday, as the toll mounts." The total number of suspected cholera cases is now 375 in Maiduguri," it said, up from 186 at the weekend. News24

### Nigeria summons SA envoy over police killing

ABUJA - Nigeria on Tuesday summoned South Africa's envoy over allegations that South African police suffocated a Nigerian national to death while he was in custody. The Nigerian foreign ministry said Kingsley Ikeri, a 27-year-old living in South Africa's eastern Kwazulu-Natal province, had been "suffocated to death by the South African police on the allegation that he was involved in drug trafficking". The ministry "summoned the South African Acting High Commissioner to Nigeria, Kenneth Pedro, to protest the extra-judicial killing", it added in a statement. Ikeri, an Ibo from southeast Nigeria, had been living in the South African town of Vryheid. He is reported to have died on August 30. AFP

### Tales of murder, suffering in ivory ban debate

HONG KONG - A Kenyan park ranger who said his closest friend was shot dead while protecting elephants urged Hong Kong not to compensate the city's ivory traders in



an emotive speech to lawmakers yesterday. Hong Kong is a major hub for ivory sales and last year announced that it would introduce a total ban on the trade. But authorities later clarified they would only completely abolish the trade by 2021, drawing criticism they were dragging their feet and trailing China, where officials last year pledged to halt the enterprise by the end of 2017. *AFP* 

### Legal action launched to halt Australia

SYDNEY - Same-sex marriage advocates launched legal action in Australia's highest court on Tuesday against a controversial government plan for a postal vote on the issue, calling it divisive and harmful. Polls indicate popular support in Australia for marriage equality, but a standoff has dragged on for more than a decade amid political wrangling over the best way to decide the matter. After Parliament's upper house, the Senate, last year rebuffed plans for a national plebiscite involving 15 million people, the government in August said a voluntary postal ballot would be held. Both options are strongly opposed by gay marriage advocates, who argue that a national vote is expensive and will subject gay people and their families to hate speech.

### North Korea nuclear test 'caused landslides'

SEOUL - North Korea's weekend nuclear test triggered landslides in the detonation area and beyond, satellite pictures showed yesterday, but left no crater visible from a collapse. The underground blast on Sunday caused a 6.3-magnitude earthquake, according to the US Geological Survey, and was followed a few minutes later by another with a magnitude of 4.1, leading to suggestions that the rock over the site had caved in, potentially releasing radioactive material into the atmosphere.

# SA OPPOSITION IN NEW BID TO IMPEACH ZUMA

JOHANNESBURG - South African President Jacob Zuma endured fresh criticism Tuesday as opposition parties pursued a court case to impeach him and Parliament debated early elections.


The opposition petitioned the country's highest court in an attempt to impeach the president who already is embroiled in multiple legal cases and corruption allegations.

The Constitutional Court was asked to order Parliament to set up an investigation into Zuma's conduct over publicly-funded upgrades to his private residence.

The court last year ruled that Zuma failed to "uphold, defend and respect" the Constitution when he refused to comply with an anti-corruption watchdog that recommended he repay money spent on the residence.

At Tuesday's court hearing, lawyers argued that parliamentary Speaker Baleka Mbete should launch a process to determine if Zuma was guilty of an impeachable offence.

Zuma has survived several parliamentary attempts to oust him from office, most recently last month when a vote of no-confidence against him was defeated. The Parliament on Tuesday debat-

ed a proposal by the opposition Democratic Alliance (DA) calling for early elections, in another bid to force Zuma from office before the 2019 elections.

"We can't afford another two years of this government. The ANC can no longer be trusted to govern," senior DA lawmaker John Steenhuisen told Parliament in Cape Town.

"South Africans have had enough. We need a reset," he said ANC lawmaker Richard Mdakane castigated the call for emergency early elections as an attempt "to effect regime change through clandestine ways".

The proposal was rejected with 229 lawmakers voting against it compared to 83 who voted in favour of the motion.

The 75-year-old Zuma is due to step down as head of the ruling ANC party in December, and as national president before the 2019 general election. *AFP* 

# EFF warns DA not to take other opposition parties for granted

CAPE TOWN – The majority of the ANC caucus would have voted with the opposition in the motion of no confidence against President Jacob Zuma had it not been for the DA's grandstanding, said EFF chief whip Floyd Shivambu before he warned the DA not to take other opposition parties for granted.

Shivambu was speaking during the debate on the DA's motion to dissolve the National Assembly, which, had it succeeded, would have necessitated early national elections.

The motion seemed doomed early in the debate, as all of the other opposition parties except COPE and AGANG, which only had four MPs between them in the House, rejected it as opportunistic, irrational, illogical, and an act of grandstanding on

the DA's part. "The DA must not take the vote we've given them for granted," said Shivambu.

"Don't undermine us, don't undermine other political parties, the EFF in particular, we're not going anywhere," Shivambu said.

IFP chief whip Narend Singh said the motion of no confidence against Zuma had "changed the trajectory of the country".

"Let's not be in a hurry to do a Theresa May (Conservative UK Prime Minister); rushing into a general election that could leave us with a hung Parliament," said Singh.

He finished with a colloquialism from his father: "If you want to kill a snake, do so, but without breaking the stick."

"In the line of political duty, Magaqa had become a brother who when even threats of death were made on our lives, he always remained faithful to his convictions and mission. This very feature about him, his bravery and daring personality, may have robbed us of his youthful life," Malema said. "May the soul of Sindiso Magaqa rest in a revolutionary and perfect peace. I send my heartfelt condolences to his wife and children, the family and all comrades. In his name and spirit, we must end all political violence and unite our people in the

mission for the attainment of economic freedom in our lifetime that Magaqa stood for. His death will never deter us from continuing this struggle for the attainment of economic freedom in our lifetime."

Magaqa, a former African National Congress Youth League (ANCYL) secretary general, was hospitalised in July after he and two other colleagues were shot at several times by unknown assailants, succumbed to his injuries on Monday. African News Agency

# ANOTHER SASSA DELAY GAGS POST OFFICE AT SCOPA MEETING

CAPE TOWN - South African Post Office (SAPO) officials flew to Parliament only to be told they couldn't make a presentation, after the South African Social Security Agency's (SASSA's) self-imposed timelines were moved back two weeks.

Both SASSA and the SAPO appeared before the standing committee on public accounts (SCOPA) on Tuesday evening to inform MPs on the agreement for SAPO to assist with the social grants scheme. But yet another snag in the SASSA procurement chain ensured SAPO and its CEO Mark Barnes were unable to present its detailed and thorough plan for the post office to come on board.

Acting SASSA CEO Pearl Bhengu said they had been instructed by the inter-ministerial task team to do "due diligence" on SAPO's proposal before finalising SAPO's agreement. As a result, yet another third party, the Council for Scientific and Industrial Research (CSIR), was brought on board to undertake said due diligence, at a cost of R410 000. Due to a snag in Treasury's rules, it could only start work this week, pushing the SAPO agreement back by two weeks.

A visibly frustrated Barnes and his colleagues sat through to 11pm on Tuesday while Bhengu and company explained the latest delay. *News24* 

# Zuma condemns killing of Lesotho's defence force chief

JOHANNESBURG – President Jacob Zuma on Tuesday, condemned the killing of the Commander of the Lesotho Defence Force, Lt-General Khoantle Motsomotso, who was killed reportedly by an army officer.

"On behalf of [the Southern African Development Community] SADC, President Zuma condemns in the strongest terms possible the senseless and regrettable killing of Gen Motsomotso, especially because his killing happens two years after the killing of former Lesotho Defence Force Commander, Brigadier Maaparankoe Mahao in June 2015, thus creating a dangerous pattern in the Kingdom of Lesotho," the depart-

ment of international relations and cooperation (DIRCO) said.

"This unfortunate incident happens so soon after the Kingdom of Lesotho had conducted peaceful and democratic elections which SADC had thought they were to bring political normalcy and stability in the country."

DIRCO said SADC will dispatch a ministerial fact-finding mission to Lesotho today, to assess the situation and determine the required intervention mechanism.

### Man gets life sentence for raping ex-girlfriend

DURBAN – The Pietermaritzburg Regional Court has sentenced a 26-yearold man, who kidnapped and repeatedly raped his former girlfriend, to life behind bars, KwaZulu-Natal police said in a statement yesterday.

Police spokesperson, Colonel Thembeka Mbhele, said the 31year-old victim was walking with friends at Taylor's Halt outside Pietermaritzburg on August 20 when her ex-boyfriend confronted her. He assaulted her and forced her to go with him to his home.

"While at his residence, the accused continued assaulting the victim with a mob stick and repeatedly raped her. Later the victim managed to escaped and reported the matter to the police at Taylor's Halt police station", Mbhele said. African News Agency

## Home Affairs officials arrested for fraud

DURBAN - Seven people, including three Department of Home Affairs officials, have been arrested for fraud and contravention of the Immigration Act and Identification Act, the Hawks said yesterday.

Hawks members from Durban Commercial Crime unit together with the Home Affairs Counter Corruption Team made the arrests, Hawks spokesperson Captain Simphiwe Mhlongo said.

# THE DIFFERENCE BETWEEN TITHES AND OFFERINGS

WHEN trying to distinguish between tithes and offerings, it is important to first understand the concept of

Christians today often think that what they give to their local church is a tithe, when in reality it is an offering. Christian tithing is a misnomer because Christians are under no obligation to fulfill the command to tithe as given to the Israelites as part of the Mosaic Law. The tithe was a requirement of the Law in which all Israelites were to give 10 per cent of everything they earned and grew to the tabernacle/temple (Leviticus 27:30; Numbers 18:26; Deuteronomy 14:24; 2 Chronicles 31:5). The New

Testament nowhere commands, or even recommends, that Christians submit to a legalistic tithe system. Paul states that believers should set aside a portion of their income as an offering, but this is not a tithe (1 Corinthians 16:1-2).

God expected the Israelites to honor Him by giving the first fruits of what He gave to them. Leviticus 27:30 states: "And all the tithe of the land. whether of the seed of the land, or of the fruit of the tree, is the LORD'S: it is holy unto the LORD." Giving the 10 per cent tithe was commanded of the Israelites and was therefore an obligation. When Christ died on the cross, He fulfilled the require-

ments of the Law and made the mandatory 10 per cent tithe obsolete. To continue to insist that it is still in effect is to nullify, at least in part, the sacrifice of Christ and return to the idea of justification by works and lawkeeping. The first fruits offering found its fulfillment in Jesus. "But Christ has indeed been raised from the dead, the first fruits of those who have fallen asleep" (1 Corinthians 15:20).

An offering is that which is freely given by Christians to the work of the Lord, the local church, and/or ministries and missions. But offerings are far more than simply the

cheque we write on Sunday. We are to offer much more to God than our monetary resources. Romans 12:1 exhorts us to offer our bodies "as living sacrifices, holy and pleasing to God" as part of our worship. Romans 6:13 gives the reason for offering ourselves: because we are "those who have been brought from death to life," and, as such, we are to "offer the parts of your body to him as instruments of righteousness." God is not nearly as interested in our monetary offerings as He is in our submission and obedience.


The truth is that He doesn't need our resources to accomplish His plans and purposes. After all, He owns the cattle on a thousand hills (Psalm 50:10) and needs nothing from us. What He desires, however, and what He values, is the heart that overflows with gratitude and thanksgiving to the God who saved us and who gives us all things, knowing our needs before we even ask (Matthew 6:8). Such a heart gives generously, willingly, and cheerfully in response to the love and grace that abound in Christ (2 Corinthians 9:6-8).












## 'Lukaku would have cost £150m'

LONDON - Jose Mourinho believes Romelu Lukaku would have cost Manchester United £150million had he not rushed through a deal before Neymar's record-breaking move to Paris Saint-Germain.

United paid Everton £75m for Lukaku in early July, weeks before PSG smashed the world transfer record with their £198m buy of Barcelona's Neymar.

And Mourinho says had his striker purchase been left until the final days of the window, United would have faced a doubling of their transfer bill.

The Premier League leaders also brought in Nemanja Matic for £40m from Chelsea and Benfica's Victor Lindelof for £30.7m as United got their business done early this summer.

And their manager says that was a deliberate ploy to avoid the bombshell Neymar's move was set to drop on the transfer market. "I think we were very clever," Mourinho said in an exclusive interview with The Times. "We thought that something could happen that could change the market forever."


However, Mourinho doesn't believe extending his current contract, which expires in 2019, is very important.



# VENUS BEATS KVITOVA, TO

Grand Slam champion Venus Williams became the oldest semi-finalist in US Open history at age 37 on Tuesday by defeating two-time Wimbledon champion Petra Kvitova 6-3, 3-6, 7-6 (7/2).

US ninth seed Williams, seeking her third US Open crown, advanced to a matchup today against 83rd-ranked compatriot Sloane Stephens for a spot in Saturday's final.

"I'm so fortunate to have won that match. It came down to the wire," Williams said.

"I try to tell myself enjoy the competition, enjoy the battle and I think I was able to do that." In the men's event, South Africa's Kevin Anderson reached a Grand Slam semi-final for the first time where he will face Spain's Pablo Carreno Busta who will also be appearing in his maiden last-four at a major. Stephens, who missed 11

before returning at Wimbledon, matched her best Grand Slam showing by outlasting Latvian 16th seed Anastasija Sevastova 6-3, 3-6, 7-6 (7/4).

"This is just incredible," Stephens said.

"When I started my comeback at Wimbledon I could never have dreamed of coming back and having these results. It's indescribable."

### Del Potro has no chance against Federer - Wilander

**NEW YORK-Juan Martin** del Potro may be a magician on court but there is nothing in his bag of tricks that will allow him to beat Roger Federer when they meet in the US Open quarter-finals yesterday, says Mats Wilander.

The quarter-final will be a rematch of the 2009 US Open final when Del Potro claimed his only grand slam title but former world No.1 Wilander

is not expecting the same result. "Obviously (del Potro) has everything to win and nothing to lose," said Wilander, who is at the US Open as analyst for Eurosport.

But a move failed to materialise for the former Chicken Inn and Ajax Cape Town forward, who could now potentially hold out until his contract with Sundowns expires in June next year before joining the club of his choice as a free agent.

But Mosimane has challenged Billiat to up his game in order to earn a move earlier, while also warning potential suitors they could risk losing the Zimbabwean star if they wait until the middle of 2018.

"The right time is now (for Billiat to go overseas). Let the business happen. I speak to Khama and told him 'if you can bring the performance you brought when you had all the balls (trophies) at the (PSL) awards', then that release clause will be triggered," Mosimane told KickOff website.

"So I say 'come back and play at that level. You are worth that money (in the release clause).

"Do you want to wait six months to get him? Somebody is going to buy him in that six months. Trust me I have been there. Wait for six months and someone will buy him and you will be like 'I thought I would get him for free'." Sport24

# ARSENE WENGER CALLS FOR THE JANUARY TRANSFER WINDOW TO BE SCRAPPED

LONDON - Arsenal Manager Arsene Wenger believes the January transfer window must he scrapped as it leads unsettled players to focus on their next move rather than playing for their clubs.

Arsenal forward Alexis Sanchez and Liverpool playmaker Philippe Coutinho were among several players who failed to secure their desired transfers in the close-season window that ended on Aug. 31 and could try again in January.

Wenger believes that want-away players and fringe squad members will not be fully committed to their clubs as they try to negotiate their next transfers.

"The players who do not play or the players who are tapped up in October they already start again to think: 'Where do I go in January?'. That's not a way to be on board with a football club..." Wenger told beIN

"We are here to entertain people and you can do that with people



who are really on board together, to achieve something together and not every minute that it doesn't go well to think: 'Where can I go next?"

Several Premier League managers had previously voiced their support for the close-season window to be shut before the start of the league campaign in August.

Wenger said that having a single annual transfer window at the end of the season would ensure complete focus from players during the campaign and restore the decency of the sport.

### Decency

"I believe that we have to bring some decency. We all complain today that it has become too much a business, but we can do something about it. We have that responsibility in the game," he added in the interview released on Tuesday.

"You can't have a player preparing for a vital football game and still be on the phone at 4 o'clock: 'Do I go or not?' or 'How much is it?', 'Where do I go?"

"The ideal situation would be to have a transfer period that is closed 48 hours before the first game of the championship and to close it completely until the season after."

Arsenal return to Premier League action on Saturday, hosting Bournemouth at the Emirates, having had a disappointing start to the season with one win and two defeats.

## Argentina, Chile stumble; Uruguay on brink

JOHANNESBURG - Argentina and Chile's World Cup qualification hopes were left on a knife edge Tuesday after the South American heavyweights slipped up once again on the road to next year's finals in Russia.

Argentina needed a second-half own goal to help them snatch a 1-1 draw against alreadyeliminated Venezuela in Buenos Aires while Chile crashed to a 1-0 defeat against Bolivia in La Paz.

The results left 2014 World Cup finalists Argentina and reigning Copa America champions Chile outside of the automatic qualifying places and sets up a nail-biting final two rounds of matches next month.

Argentina are fifth in the standings with 24 points from 16 games while Chile are sixth with

The Argentinians - who would face a playoff against New Zealand if they remain fifth host fourth-placed Peru next month in Buenos Aires before an awkward final game at altitude against Ecuador.

Chile meanwhile will face Ecuador in Santiago on October 5, before heading to Brazil for their final qualifier five days later.

# FALCAO STRIKES AS COLOMBIA HOLD BRAZIL

**BRASIL** -Radamel Falcao scored a second half equaliser as Colombia snatched a 1-1 draw to halt Brazil's remarkable run of nine consecutive World Cup qualifying victories on Tuesday.

Falcao headed home on 56 minutes to cancel out William's superb opener for Brazil in a result which boosts Colombia's hopes of qualification for next year's finals in

Brazil have already qualified for the World Cup and are guaranteed first place in South America's standings. The draw saw second-placed Colombia move to 26 points from

Colombia had started brightly, with James Rodriguez testing Brazilian goalkeeper Alisson with a low shot after a deftly worked one-two on

Brazil had another scare in the

33rd minute when Thiago Silva saw a headed clearance loop towards his own goal forcing Alisson to tip over the bar.

Alisson, meanwhile, was alert shortly before half-time, comfortably dealing with a Rodriguez freekick after Paulinho's foul on Juan Cuadrado. On the stroke of halftime however Brazil conjured a goal out of nothing.

A long ball forward found Neymar just inside the area and the Paris Saint-Germain star produced a sublime touch to roll the ball invitingly into the path of Willian.

The Chelsea midfielder glanced up and uncorked a stunning halfvolley with the outside of his right boot which flew into the top corner. Colombia, however, did not have long to wait to get back on level terms with a goal through Falcao on 56 minutes. AFP

### Salah fires Egypt, Ghana cruise JOHANNESBURG -African into the net to decide the top-


Salah sneaked behind the defence and after goalkeeper Denis Onyango parried his first attempt, he poked the rebound of-the-table showdown.

## Iniesta unwilling to sign new deal under current board

**BARCELONA** -Andres Iniesta has denied he is on the brink of signing a new contract at Barcelona, heaping more pressure on under-fire Josep Bartomeu.

The club president has had a vote of no confidence put to him, with opponents trying to force an election. In a bid to fight for his job, Bartomeu has claimed in the last few days that both Lionel Messi and Iniesta are poised to commit their futures to Barcelona.

But coming back from international duty - where Iniesta was outstanding in Spain's 3-0 win over Italy and their 8-0 win over Liechtenstein - the player was asked if it was true he had agreed in principle to sign a new deal and his reply was a very clear 'no'.

Sportsmail understands the player has no intention of putting pen to paper with the current board.

Iniesta's decision to rule out signing a new contract at Barcelona sets up the possibility that one of the club's greatest ever players leaving on a free next summer.

Messi is also in the last year of his contract and has also told friends that he has no plans to sign any time soon.

Iniesta won his 30th trophy with Barcelona at the end of last season, lifting the Copa del Rev, only Messi can match his silverware haul. As well as being unsure of the

direction the club is going under Bartomeu's presidency, Iniesta has also said in the past that he does not want to sign a lucrative new deal and then not be able to produce for the team on the

pitch. "What I'm not going to do is be here just for the sake of being here," he told Cadena Ser last season. The World Cup and double

European Championships winner only started 13 La Liga games for Barcelona last season. Not since the

2004-05 campaign, when he was trying to break into the side under Frank Rijkaard, has Iniesta started so few matches. There were mitigating circumstances in that total, injury problems and Luis Enrique's decision to protect the midfielder's legs in a bid to keep

him fresh for the decisive games at the end of the season cannot be overlooked.

The style of play under Luis Enrique often played to the strengths of the forward line at the expense of the midfield. It's no coincidence that Injesta often looks more comfortable in the Spanish national side -still flooded with ball-

playing midfielders - than in a Barcelona team geared towards the needs of the forwards. Daily Mail



"Those who want these directors to step down should come up with people who will do the job. They must make us see these people have the power to run the team as opposed to forcing directors yet they will do nothing for the team," he said.
