

TUCOSWA ROPED IN TO DISCOURAGE STRIKE

THE SESMAWU NEC yesterday roped in the Trade Union Congress of Swaziland (TUCOSWA) to discourage the SEC employees from engaging in the strike action.

Second Deputy Secretary General Muzi Mhlanga said the federation was invited to the address the SEC employees about the implications of defying a court order. Mhlanga explained to the hundreds of employees that defying a court order has three implica-

SEC employees march to Parly

IN their quest to have the matter of the pending payment of the 2016/2017 bonuses being fast-tracked, employees decided to march to Parliament to lobby Members of Parliament (MPs).

Upon realising that singing and tovi toving at the Stonehenge depot was not yielding any results, the employees led by the union's general council decided to pack and go down Malagwane to Parliament to seek audience with parliamentarians.

Within 10 minutes of their decision to go to Parliament, over 10 kombis servicing the Mbabane-Lobamba route were seen driving into the depot and loading the employees, ferrying them to Lobamba.

The kombis dropped them off next to the Somhlolo National Stadium where they gathered for sometime to strategise on their next step.

The employees appointed six members from the union's general council and they went into the Parliament to seek audience with the MPs.

To their disappointment, the general council found that the MPs were not available for any sitting. They were met by the Principal Hansard Editor of Parliament Zanele Gamedze, who advised them to write a follow up letter to the petition they had initially sent to Parliament over a week ago.

Assured

"She assured us that the MPs will address the matter in their next sitting which is tomorrow (today). She told us that once the matter is before Parliament, our members will be invited to be at the gallery while the matter is addressed," said a member of the general council who wanted to remain anonymous in fear of being slapped with contempt of court charges.

SEC management finally bent to the demands of striking Swaziland Electricity Company (SEC) workers by agreeing they be paid their bonus-

This effectively means the two-day strike that left devastating inconvemiences has been called off.

SEC management announced that the payment of the 2016/2017 performance bonus has been approved.

The strike which started Monday, entered day two yesterday and it was meant to enter day three today.

The bone of contention between the employer and the employees is the delay in the payment of the 2016/2017 performance bonus which the company has since committed to pay.

Last night, the SEC management sent out a press statement announcing that the company's operations are expected to return to normal. The management pleaded with the employees to resume work at their respective workstations as of last night.

This comes after SEC employees yes-

terday refused to back down but continued to defy the court order issued on Sunday and engaged in an illegal strike, costing the company millions of Emalangeni.

Advise

So determined were the employees that they also failed to take heed to SES-MAWU's National Executive Committee's (NEC) advise to abandon the strike action and return to work to avoid being in contempt of court.

SEC employees from all the depots in the country yesterday braved the cold weather and again gathered at the Stonehenge depot which is located just

SEC strike may ground the whole country - MD

THE Swaziland Electricity Company is concerned that the strike action by its employees may result in a massive disruption in the supply of electricity nationwide.

The electricity company stated that the action by the employees stands to affect all aspect of normal operations in the country both commercially and domestic with power cuts resulting in loss of production with commerce essentially grinding to a halt and a high possibility of loss of lives as hospitals rely on electricity for their patients operations. This is contained in papers filed by the electricity company in its urgent application filed at the Industrial Court following a move by its employees through its Union Swaziland Electricity Supply Maintenance and Allied Workers Union (SESMAWU) to engage in a strike action. However, the strike was called off yesterday after government approved the payment of bonuses to the employees which was the bone of contention.

In his court affidavit, the SEC Managing Director Meshack Kunene submitted that the matter is rendered urgent in that the stoppage by the workers which started on Monday will affect the whole country as the company is the sole distributor of electricity in the Kingdom.

Kunene submitted that the applicant (SEC) and the respondents (SESMAWU) and its members are parties to various agreements which regulate payment of bonuses and the conditions which must be met for such payments to become due to the employees.

In respect of the financial year 2016/17, Kunene submitted that the employees have met conditions for payment of their bonuses however the company as a Category A public enterprise is obliged to seek approval of the Standing Committee on Public Enterprises (SCOPE) before making payment of the bonuses available to the employees. Kunene further submitted that as a company they duly applied to SCOPE for such approval, however the matter was still being considered as they have been advised that SCOPE is in the process of developing guidelines for the payment of bonuses in public enterprises and accordingly directed that payment of bonuses to the employees await the completion of these guidelines.

Appeal "We further sent an appeal to SCOPE to reconsider the request in light of the fact that in respect of the company and the union there are standing agreements which govern payment of bonuses and had been hoping for a response from SCOPE over the past two weeks which unfortunately we still await," Kunene submitted. He stated that in the meantime they have been communicating with the executive of the workers union however the union called a mass meeting on Saturday November 4 to discuss the payment of bonuses a meeting that saw resolved to engage in the strike action on Monday.

Kunene submitted that SEC is an essen-

tial service so designated by the Industrial Relations Act and such a strike action is prohibited and same is a breach of the employees terms and conditions of employment and is unlawful.

Following the urgent application, Industrial Court Acting Judge President Nkosinathi Nkonyane issued an order interdicting the employees from participating in the industrial action (strike) or participating in any action calculated to be likely to constitute a deviation from normal working activities or disrupt same. The court further ordered that a rule nisi is issued calling upon the respondents (union) to show cause on Friday, November 10 why an order of court should not be made final.

Appearing for SEC in the matter was lawyer Musa Sibandze while there was no appearance for the union and its employees and the matter was heard on Sunday as of urgency.

SEC employees are unionised under the Swaziland Electricity Supply Maintenance and Allied Workers Union (SESMAWU).

Yesterday, employees had vowed not to abandon the strike action until the 2016/17 bonuses are paid. The employees dubbed their illegal strike as "Waya waya".

Strike

The strike action resulted in a number of areas in the country experiencing power blackouts for hours on end.

"Management would like to extend appreciation to all who have assisted to have this matter resolved amicably and speedily. We also wish to thank our employees for their patience and co-operation as the approval was being sought from the relevant stakeholders," reads the statement.

The company sent an apology to all its customers who had been without power during the difficult times.

"We would like to assure them that the company will do everything practically possible to have the situation normalised within the shortest time possible.

"We plead with our customers to continue to bear with us as we restore the electricity network, a process which might take a while considering that the outages countrywide had risen to unprecedented levels," reads the statement.

The statement further encouraged customers to report outages and any other electricity related issues to the Call Centre on 800 9000 (toll-free line) or 2508 3333 (standard rates apply).

'Bonuses to be paid on Friday'

SESMAWU has welcomed the news that the company will pay their members performance bonuses with joy.

President of the union, George Maseko revealed that management promised to pay out the 2016/2017 performance bonuses on Friday.

Maseko said as a union they were very happy that the employees would finally receive their bonuses.

"We have welcomed the good news from the management and we are glad that our effort has not gone unnoticed," he said.

When called last night, Maseko said the NEC was busy informing all its members that they must return to work tomorrow as their employer agreed to pay their performance bonus on Friday.

Charges

Earlier, in the day (yesterday), SEC employees learnt with shock that their leaders were on Monday afternoon slapped with charges of contempt for engaging in the strike action and that they could not participate or lead them in the strike action.

SESMAWU Vice President Bongani Kunene informed the unfazed employees that the NEC had been forced by circumstances to withdraw their involvement and participation in the strike action as they had been slapped with contempt of court the previous day.

This did not deter the spirit of the employees as the strike action went ahead without the NEC.

Good Shepherd Hospital, Siteki in 12-hour electricity blackout

OPERATIONS at Good Shepherd Hospital and the entire town centre were affected during a blackout that lasted for approximately 12 hours.

Even though the reason behind the power cut could not be ascertained, the general knowledge is that workers of the Swaziland Electricity Company (SEC) were continuing with their strike action which started

on Monday

A source at the hospital disclosed that they experienced the blackout just after 2 am yesterday.

From that time, the hospital had to swiftly switch to its standby source of power, a generator which ensures that the most critical departments have power at all times.

However, the generator is said to have also experienced mechanical problems just after 9 am, and this lasted for slightly over an hour.

Within this hour, the hospital was in complete darkness, resulting to

patients who require a constant supply of electricity being affected.

It is said that the generator was eventually repaired, and resumed functioning just after 10 am.

Blackout

For the better part of the day, the hospital relied on the standby source of power. Hospital Administrator Dumsile Simelane acknowledged the electricity blackout which was experienced by the hospital yesterday.

She stated that they however managed to contain the situation with the availability of a standby source of

nower

In the meantime, major shops in the town centre also relied on the use of generators in order to continue operating.

However, some outlets such as eateries remained closed for the better part of the day.

Business owners who spoke during random interviews said they were not informed of any scheduled power blackout by the supplying company.

They complained of losses they incurred as they could not do business without electricity.

SEC CUSTOMERS VENT ANGER ON SOCIAL MEDIA

THE Swaziland Electricity Company (SEC) might find itself not only having to deal with angry customers who will dump rotten food at their company's offices but might also have to defend itself from court battles resulting from damages caused by the blackouts experienced in the country.

The blackouts happening in many areas in the country including Bhunya, Ngculwini, Malkems, Manzini and other areas resulted from the ongoing strike by Swaziland Electricity Company as employees are at loggerheads with their employers over bonuses for the year 2015/16.

Aggrieved members of the public have made it clear that if the strike continues and their food items stored in refrigerators get rotten they will dump such items at SEC offices.

Others even went on to say previously they have had to go to court in order to get compensation from SEC after their appliances got damaged during blackouts and it would seem even this time the same will happen.

In the Manzini city yesterday it was

business unusual as most businesses had to rely on other alternative sources of energy after a power outage that lasted for almost the whole day.

The power outage did not only disturb the commercial sector but also the private sectors as residential areas were also left without electricity. However the power outages seemed to be well calculated as crucial areas such as Raleigh Fitkin Memorial Hospital remained with electricity throughout the day.

RFM Administrator Leonard Dlamini confirmed that they were not affected by the power outage.

Power

Most shops around town had to rely on generators as their source of power. Filling stations were not spared from the wrath of the strike as some also experienced power shortages and had to also use back-up generators as a source of

TWO diplomats travelling in a Jeep Cherokee are lucky to be alive after their car rolled several times and crashed into a wall fence at Malunge Township.

The car, driven by a lady, failed to negotiate the meandering corner along Malunge towards golf course and crashed into a wall fence.

"The car went through the wall fence destroying a stationery water tank and windows of some offices at Malunge Township," said an eyewitness.

Landed

The car overturned and landed on its roof. "The passenger was severely injured while the driver escaped with minor injuries," he

said.

Both the driver and passenger were rushed by the Emergency Medical Services (EMS) to Mbabane Clinic for treatment.

Statements

The Royal Swaziland Police (RSP) Services were found at the scene recording statements on what may have transpired.

Deputy Chief Police Information and Communications Officer Assistant Superintendent Phindile Vilakati confirmed the accident.

Compiling

"A Jeep Cherokee driven by diplomats was involved in an accident at Malunge, we are, however, not sure who the diplomats are and their country of origin," she said.

At the time of compiling the report, Vilakati said details on what happened were still scanty since the victims were still in hospital.

■ We have always been promised that we would be provided with toilet facilities in Mangwaneni but it has not happened. Please push for that to happen when you become a coun-



Man stabs stepmother over food

A woman described her survival as a miracle after she recuperated from a deep stab wound in the neck which was inflicted by her step-son after an argument.

Colile Dlamini narrated before the Magistrate's Court on how her unruly step-son locked her inside a room before stabbing her once in the neck and further assaulted her with a slasher.

This was during the trial of Mcebo Dlamini (25) who faced a charge of assault with intent to cause grievous bodily harm. The matter was before Senior Magistrate Donald Mavuso.

The complainant first told the court that the initial bone of contention was an unexpected cutoff of electricity which occurred at the family house.

The accused person is said to have been occupying a rondavel situated nearby, wherein the metre box is installed.

When the complainant went into the rondavel to check on what caused the sudden power cut, the accused person is said to have pounced on her and locked her inside the rondavel.

The complainant said the accused

then started questioning her about her attitude of denying him access into the main house and further not dishing him food.

In the midst of the argument, the accused is said to have withdrawn a slasher and started hitting the woman all over the body.

He is said to have also grabbed a table knife nearby and stabbed her on the neck.

The complainant said she was saved by the arrival of a neighbour who was visiting her husband, who was however not present at the time of her attack. She was rushed to hospital where she was admitted for three days before being allowed to recuperate at home.

In his defence, however, the accused told the court that the complainant was the one aggressive and refusing him entry to the main house.

He said this also resulted to him having to prepare his own food from the rondavel he occupied while his step-mother wanted him out of the homestead.

This was, however, disputed by the complainant who stated that over the past many years, she has been treating the accused person like her own children. The matter was eventually postponed to November 14, 2017 for continuation of trial.



Girl (10) drowns in water canal

A 10-year-old girl of Siphetsaphi area in the Shiselweni region drowned while playing in a water

Sources said the incident occurred on Monday afternoon when the child went to play next to the water canal located just near her homestead after returning from school. "She was playing along the banks of the water canal when she got stuck in the mud before drowning," said the source.

The 10-year-old girl was discovered dead by her 62-year-old grandfather. "His grandfather was almost close to the canal and hurried to rescue the child but she had already been swept away by the water," said the source. Her lifeless body was discovered by her grandfather who then called other residents to help rescue her.

According to residents, the water canal reportedly had no safety fence or caution signs to alert the public that it was restricted to swim or play in. Chief Police Information and Communications Officer

Superintendent Khulani Mamba confirmed the matter.

"On Monday at 16H15 a 62-yearold man of Sibetsaphi discovered that his 10 year-old granddaughter had drowned in a water canal."

He reported the matter to the Royal Swaziland Police who came to take a police report before taking the lifeless body to hospital.

Mamba requested parents or guardians to know the whereabouts of their children as most drowning cases were recorded at this time of the year. "During hot days it is very tempting to go for a swim in order to cool off, however, swimming comes with many dangers such as drowning," he said.

900 TO BENEFIT FROM NKWENE WATER PROJECT

OVER 900 people from Nkwene community jubilated when Minister of Natural Resource and Energy Jabulile Mashwama through Minister of Commerce Jabulani Mabuza opened the Nkwene potable water supply scheme at the area's Inkhundla.

The water scheme was initiated in 2015 and completed in 2016.

Minister Mashwama said the water scheme will benefit a total of 160 homesteads would about 900 people through a network of 36 standpipes spread over a 13-kilometre distance.

"The project will also benefit Nkwene Primary and High schools, which have a

total enrolment of 800 pupils. It will also benefit a clinic and a royal kraal," said the minister. Mashwama said the government invested a total of E2.2 million through the Regional Development Fund. She started the ministry of natural resources and energy also collaborated with the ministry of Tinkhundla and regional development for the water project.

The minister appreciated the community members' active participation in the realisation of the water project. "I have been informed that you have also contributed a total of E51 000 towards the operation and maintenance fund.

This is greatly appreciated and these contributions should continue as this is the only way to ensure availability of financial resources for the proper upkeep of the project," she said.

Mashwama further highlighted that the Shiselweni region has been blessed this financial year with a number of water projects in the region.

The minister revealed that in May 2017, the ministry officially opened three water schemes at KaMfishane, Lugedzeni and Bekezela which are all in the Shiselweni region. He said the projects benefitted a total of 5 000 people. "In April 2017, the ministry also witnessed the official opening of the SISOMA project which benefited a total of 61 000 people of which 25 000 are located at Somntongo and Matsanjeni areas. The ministry looks forward to the delivery off more similar projects to increase the rate of coverage in our rural areas from the 52 per cent currently observed to at least 65 per cent by the year 2022," said the minister.

South Africans behind Summerfield robbery

SOUTH Africans are suspected to have colluded with locals in committing a daring robbery at Summerfield Botanical Garden, where an employee was shot in the thigh as alleged thieves made away with cash amounting to E29 000.

This was revealed by an accused person who has since turned into a state witness in the case which has seen six people arrested for the robbery which took place earlier this year. The accused Niabulo Gwebu (22), Mkhulisi Selepe (21) Sibusiso Dlamini (38) and Thembela Ndwandwe (25) appeared before Matsapha Circuit

Court Magistrate yesterday for their trial. Ndwandwe, who has since pleaded guilty to the offence of robbery, informed the court that during the commission of the offence two vehicles were used and they ferried the suspects who were about seven in number from Mhlaleni to Summerfield.

He stated that of all the suspects he met in the cars he could only recognise two who were locals and said some of the suspects had a strong Zulu accent. He however denied ever assaulting one of the security guards but confirmed that he was part of the crew that stormed the place and stole a cash till and also expensive liquor from the hotel such as Red Wine, Sky Vodka and Jack Daniels and

DISABILITY BILL ON BRINK OF BEING PASSED

PEOPLE living with disability will now breathe a sigh of relief as Members of Parliament are on the brink of enacting their law.

On Monday, the House portfolio committee of the Deputy Prime Minister's Office (DPMO) tabled a report before the House of Assembly. It was tabled by Sandleni MP James Simelane, who is the Chairperson of the Portfolio Committee.

The report intends to inform the House of Assembly on how the committee worked on The Persons Living with Disabilities Bill of 2015, which is supposed to be enacted as soon as possible. The Bill is yet to be debated and adopted by the legislators. After adoption of the report, the Bill can then be passed into an Act of Parliament.

Deputy Prime Minister (DPM) Paul Dlamini was of the view that it was imperative for the country to pass the Bill. The country ratified the United Nations Conventions on the Rights of Persons Living with Disabilities in 2012. The main aim of the convention was to ensure the full and equal enjoyment of all human rights by people living with disabilities. The country's Constitution (Section 14(3)), the DPM said in the preamble of the report, provided for the protection and



promotion of fundamental rights and freedoms of people of whatever disability. Section 30 (2) provided further that Parliament had to enact laws for the protection of persons living with disabilities in order to enable them to live a fulfilling life.

The Children's Protection and Welfare Act No. 6 of 2012 (Section 4) provided that a child should not be discriminated on the grounds of disability. Section 11 of the Act provided that a child with disabilities should have special care, medical treatment, rehabilitation, family and personal integrity, sport and recreation, education and training to help him/her enjoy a full life with dignity.

The National Disability Policy of 2013, from which this Bill emanated, drew its strength from the Poverty Reduction Action Plan and other policies and programmes that outlined the commitment of this country in protecting disabled people.

The objectives of the Bill included to provide for

The general wellbeing of persons with disabilities.

The registration, protection, rehabilitation, and development of persons with disabilities.

The establishment of a statutory body to be known as the National Disability Advisory Council of Persons with Disabilities. A secretariat is to be set up and staff to be employed by the Civil Service Commission (CSC), independent of the Social Department. The secretariat will be responsible for the day-to-day management of the council. Organisations like CANGO, FODSWA, Cheshire Homes, and the League of African Churches have made their submissions for their opinions to be included in the Bill. They all spoke in one voice and that was to encourage Parliament to enact a legislation that would protect the disabled.

Facebook 'friend' lures minor girl, trafficks her to Swaziland

A minor girl from South Africa narrated before court on how she was lured by her 'Facebook friend' who presented himself as a chief's son before trafficking her into Swaziland.

The girl was presenting her evidence before Principal Magistrate Dumsani Magagula. This is in the case of Machawe Dlamini (29) of Nceka who was arrested and charged with two counts of contravening the People Trafficking and People Smuggling Prohibition Act.

On the first count, he is alleged to have unlawfully recruited and transported the 15-year-old girl

while using means of deception and harboured her at his homestead for purposes of exploitation.

On the second count, he is alleged to have unlawfully arranged and assisted the girl of South African origin to illegally enter into Swaziland while knowing that she did not have any travel documents.

At the time of committing the offence, the accused is said to have intended to subject the minor girl to exploitation. The accused also faces an alternative charge, that of contravening the Girls and Women Protection Act. When the charges were read to him, the accused pleaded not guilty to all the charges.

The girl told the court that she met the accused person through popular social media, Facebook after he sent her a friend request. At the time, the accused person was residing in South Africa but stated that he was from Swaziland.

Trial

The girl said a few phone calls between her and the accused led to them eventually meeting in Pretoria.

The girl said she had informed the accused person through their Facebook conversations that she was looking for her father who deserted her and her mother many years ago. The accused is said to

have promised to assist the minor girl to find her father.

She said this led to them crossing into the country through the infor-

mal crossing point situated near Oshoek Border Gate.

The accused person is said to have then changed tune and subjected the minor girl to sexual abuse.

In the meantime, the girl said the accused further introduced her to his family as his girlfriend. The abuse is said to have went on for a couple of weeks until police officers arrived at the homestead, presumably after receiving a tip-off.

The girl said she was not aware of how the police got to know about her plight as they eventually rescued her. The accused is representing himself in the matter which is expected back in court next week for continuation of trial.

Tempers flare amongst warring factions

WITH the situation threatening to boil out of control at Ekuphumleni royal residence, police from three different police stations, namely Lavumisa, Hluti and Sigwe had to rush to the Umphakatsi to ensure that law and order was maintained.

At least over 20 police officers were seen arriving in different vehicles, some being plain clothed and also those in

They stood strategically with the purpose of being ready for any eventualities. It is said David successfully chaired the meeting and had even reminded anyone who cared to listen that he was doing what 'Emalangeni' had ordered him to do.

When called, David confirmed that there was a near fracas after Ngobese was seen arriving at Ekuphumleni royal residence yet he was no longer needed.

"Ngobese thought that we were going to be intimidated when he arrived with Sikhwehle (Mshiyeni Simelane) who was leading a delegation sent by Gasa

WaNgwane.

We maintained our stand and told him and those who had accompanied him that he was no longer needed. He had no choice but to go back dejected.

I then had to take over as chair of the meeting and nothing else happened. Even the police that were sent were convinced that there would be no violence except only to order Ngobese to back off. It was a peaceful meeting and we hope no one will provoke 'Emalangeni' again. We are not fighting anyone here but we are putting things into perspective," said David.

David said 'Emalangeni' will be visiting the Shiselweni Regional Administration offices to seek advice on the ongoing debacle which now is impacting the whole community.

Chief Police Information and Communications Officer Superintendent Khulani Mamba confirmed that police were sent to the Umphakatsi to maintain law and order. "Police went there after being informed that the situation had the potential of becoming volatile. Fortunately, the parties concerned never clashed but we are still following the situation," said Supt Mamba.

Computer engineer handed 15 year sentence for child porn

CAPE TOWN - A Plettenberg Bay computer engineer was yesterday handed a 15 year jail sentence after being convicted on 18 644 counts of possession of child pornography.

William Beale, 39, was sentenced in the Thembalethu Regional Court after pleading guilty following his arrest for being part of an international syndicate. He was found in possession of thousands of images, as well as dagga.

Prosecutor Gerda Marx in a statement described the accused as a "paedophile" with a disorder that cannot be treated.

She said Beale had acquired the necessary software in order to obtain online anonymity and resist censorship. He was thus evading justice by keeping his identity a secret, Marx explained.

Beale, she said, had "created and con-

tributed to a market where rape, abuse and even murder of children are the order of the day".

"Without a market these children will not be subjected to the abuse and suffering they had to endure in order for Beale to satisfy his urges."

She considered 15 years behind bars "a good sentence".

EVERY INKHUNDLA SHOULD HAVE A CDP

MINISTER of Tourism and Environmental Affairs Christopher Gamedze has said every Inkhundla should have a Chiefdom Development Plan (CDP).

Gamedze was speaking at Mvembili Inkhundla last Thursday during the official launch and handover of the Mvembili Chiefdom Development Plan (MCDP).

Present at the launch were Hhohho Regional Administrator Prince Tshekedi, United Nations Development Program (UNDP) Deputy Resident Representative Lars Tushuizen, Chairperson of the Centre for Disease Control (CDC) Swaziland Zeblon Dlamini, Representative of the Minister of Tinkhundla Administration and Development Dumsani Sithole, Mvembili *Umphakatsi*'s Prince December as well as Ntfonjeni Member of Parliament (MP) Sompisi Magagula.

Gamedze said the people of Mvembili Inkhundla in northern Hhohho must count themselves as very lucky because

their chiefdom is only the second in the country to receive its very own Chiefdom Development Plan (CDP).

"Government is grateful to all our international and local stakeholders who have worked tirelessly since May 2017 in the development of this very important and sustainable development plan.

The plan itself prioritises optimum land use or a proposed land use plan under the community development

opinion. Mvembili is only the second chiefdom to receive this type of plan so the people of this area should consider themselves very lucky.

The first chiefdom was Ntondozi and as the ministry of tourism and environmental affairs we are focusing on the natural reservation, restoration and positive exploitation of land through positive agriculture that can aid the development of the local community in both commercial and sub-

sistent ways for the affected communities," he said.

He explained this development plan if followed will allow the community to develop to 2022 and beyond.

He said so far he has been told that 1 000 fruit trees were donated and planted at 100 homesteads, which means that each of the identified homesteads has about 10 fruit trees to nurture and turn into an orchard. Furthermore, he said the orchard will grow and provide fruit that will first feed the immediate homestead and then over time the region through commercial fruit agriculture, which is the way of the future of Swaziland farming and living off the land. Also present at the launch was United Nations Development Program (UNDP) Deputy Resident Representative Lars Tushuizen who said it takes 500 years for just one piece of plastic to decompose in rivers.

"Unfortunately, a lot of people do not know how important it is to dispose of certain materials correctly, through research, we under the UNDP, have found out that one piece of plastic when thrown into a river to decompose takes about 500 years.

This is very scary and means that every time someone throws plastic into a river that plastic will live in that river for many decades and become hazardous to wildlife or people who live off of the river, therefore we urge people to avoid improper waste disposal and reserve natural ecosystems that are slowly disappearing with modernisation," he said. The launch was preceded by a tour of a swamp reservation at Mvembili as well as a tour of the Bhembe residence were litchitrees were planted three days prior.

Senator Mdluli tells pupils not to commit suicide if they fail exam

SENATOR Ndumiso Mdluli has told pupils who perform poorly in their examinations not to commit suicide.

Mdluli was speaking at the Sidwashini Methodist Primary last Thursday during the school's annual speech and prize giving day. Present at the event was Ntfonjeni Member of Parliament (MP) Sompisi Magagula as well as the school's administration.

Mdluli said even though the school had 112 pupils preparing to sit in the Swaziland Primary Certificate Examinations for 2017 not all of them will perform well.

"Life is about wins and losses, this school has a very large number of Grade Seven pupils, I have been told that there is about 112 pupils in Grade Seven alone; which is a substantial number of pupils.

As you all know some of the children will not do as well in the upcoming Swaziland Primary Certificates examinations (SPC) and others will do far better than they expected.

This is the law of life itself some win and some lose but even if you do lose, all it means is that God who

loves us all has another plan for you and your beautiful life, we all know that each and every individual is important to God therefore, I urge all pupils to be strong even if you fail it does not mean that you will always fail therefore avoid depression, try to stay around positive people that way you avoid becoming suicidal in spirit," he said.

He added that a suicidal spirit often leads to depression that can either direct a young person to drug abuse or even worse lead them to commit suicide.

"This is wrong and not in God's plan for you the young person of today. All the pupils who I am seeing here in grade 7 during this speech and prize giving day will be in Form Five by the year 2022 and that year has been commissioned by our King as a special year for Swaziland.

Therefore, I urge all young people to focus on their studies and avoid destructive people who promote drugs and crime, let me tell you all a secret, I too was not a super student during my youth but I learnt a very important lesson and that is you can do anything in this world if you are com-

mitted and persistent so work hard and make your God, King and Parents proud of you," he added.

Also speaking at the event was Ntfonjeni Member of parliament (MP) Sompisi Magagula who donated stationary to all the 112 Grade Seven pupils at Sidwashini Methodist Primary.

"I admire all the teachers who are unsung heroes at this school for preparing a very large class of grade seven pupils.

Fingerprints case:

GOP SENZO'S BAIL REVOKED, RE-ARRESTED

ONE of the police officers in the fingerprints case has had his bail revoked after allegations that he interfered with Crown witnesses.

Senzo Matsenjwa is alleged to have called some of the witnesses through his cell phone and advised them to give untruthful evidence before court as the trial continues.

Matsenjwa has since filed an urgent bail application at the High Court as

 He allegedly breached bail conditions by interfering with witnesses, called them through a cell phone and advised them to give untruthful evidence before court Files urgent new bail application at the High Court

following his re-arrest.

He appeared before High Court Judge Cyril Maphanga who after hearing submissions by both counsel reserved judgment for a later date as counsel will be informed of same in due course.

The crown represented by Ngcebo Lukhele vigorously opposed the bail application and submitted that Matsenjwa

he wants to be released on bail again had breached his previous bail conditions in that he interfered with the crown witnesses and his release might jeopardise the whole case.

> Ironically the crown cited the Musa Waga Kunene case in which Kunene was denied bail in his second attempt after breaching his previous bail conditions by committing the same offence he is charged with while out on bail.

Kunene is also a police officer who was suspended after his arrest.

The crown submitted that it would not be in the interest of justice to have Matsenjwa released from custody as he has proven that he might interfere with more witnesses in the case applying before court that bail not be granted to him.

However Matsenjwa thought his lawyers submitted that the crown had failed to prove that indeed the cell number that is alleged to have called the witnesses indeed belongs to him.

In fact Matsenjwa denied that the cell number in question belongs to him and prayed before the court that he be granted bail pending finalisation of the trial.

Senzo is co-charged with the other police officers Lucky Matsenjwa and Apollo Mabila together with an elderly woman Elizabeth Matsebula for allegedly illegally clearing finger prints for ex- convicts at the Police Headquarters.

The officers implicated in the sale of fingerprint clearances are alleged to have deleted or cleared 41 criminal records of ex-convicts.

The police officers, are alleged to have received a total of over E40 000 from the ex- convicts to have their criminal records cleared.

This is the total amount of money reflected on the charge sheets as in some of the charges the amount allegedly received by the officers is not stipulated. The ex-convicts, who, some of them are now in gainful employment after being cleared, were reportedly made to pay different amounts by the two law

They were made to pay money raging from E2 000 upwards.

Some of the ex-convicts are reported to have managed to get jobs in the armed forces after their criminal records were allegedly cleared or deleted by the officers. They are alleged to have committed the offences from 2009.

ACC, POLICE GET TRAINING ON CYBERCRIME

POLICE officers from countries such as Namibia, Botswana, Mozambique and Zimbabwe are currently attending training hosted by the country on cybercrime.

The visiting participants are at Matsapha Police Academy, where they are training alongside police from the Royal Swaziland Police Service and Anti-Corruption Commission.

The training is facilitated by French International Technical Expert and Regional Advisor Christopher Bellouard.

National Commissioner of Police Isaac Magagula, who was represented by Senior Deputy National Commissioner Sula Dlamini during the official opening of the First Responders Training Programme in Cybercrime, said the training programme is aimed at capacitating investigative practitioners within the SADC region with requisite skills to tackle one of the most formidable and insidious contemporary crime phenomenon facing the country today, which

is cybercrime. Magagula said as a country and

Highlighting the significance of the training intervention, Magagula said the course couldn't have come at a more appropriate time than now when

cybercrime which is spurred on by the dizzying changes in computer based technology, which is making its presence felt in the crime landscape and in the process causing a great deal of damage to the economies

of countries. Magagula said in 2016 cybercrime cost the global economy over US\$450 billion, which is such a massive loss whose reverberations have also been felt here in the SADC region given the interconnectedness of countries economy.

The national commissioner stated that as police, their role is to support socio-economic development programmes through fighting the various crimes that impinge on economic growth and vibrancy such as cybercrime, he added that this is particularly so, as this crime mainly targets the banking and Allied Financial Institutions and the business community which are sectors that are the driving forces of socio economic growin and development.

Some of these criminal activities as listed by the national commissioner include ATM Fraud, Internet Fraud which involves fraudulent electronic fund transfers and issuance of false banking instructions to business entities and individuals as well as hoax job offers among many others.

He said it is therefore the police responsibilityto ensure that the business sector is hedged from these forms of criminality through enhancing the police level of vigilance and circumspection which is what is aimed by the training intervention.



INCEST

THIS is a term used to describe sexual intercourse between persons so closely related that they are forbidden by law to marry and also the crime of engaging in such sexual intercourse.

For many years most countries have illegalised incest. In 2015 a Sexual Offenses and Domestic Violence Bill was re-drafted.

For a Bill to be law it must be passed by Parliament following which is the House of Senate where submission of the Bill are made and are again debated on. When the Bill is accepted by the House of Senate it is then forward for Royal assent and if accepted, the King as the head of State signs the Bill and it becomes law. Last week the House of Parliament passed the Bill. There are a few clauses in the Bill that I have singled out and find it important that light be shed on them. You can look forward to the next articles where the other clauses will be discussed, but first to be discussed is the clause on Incest, The SODV Bill has defined incest as when a person who engages in an act of sexual; penetration or attempts an act of sexual penetration with that person's offspring or sibling, parent, grandparent, uncle, aunt, nephew or niece and another person whom it is reasonable for that person to know that the other person bears that relationship to him or her, or some



relationship of that type to him or her.

This means that no man may marry his mother, grandmother, daughter, granddaughter, sister, aunt, niece, stepmother or stepdaughter, and no woman may marry her father, grandfather, son, grandson, brother, uncle, nephew, stepfather or stepson. Where persons with degrees of consanguinity somehow get married, that marriage is incestuous and void.

The Bill proposes on conviction that the perpetrator be liable to the following penalties.

- Imprisonment without an option of a fine, for a term not exceeding twenty five years, if the victim is less than the age of fourteen years.
- Imprisonment without an option of a fine, for a term not exceeding twenty years, if the victim is above the age of fourteen years but below the age of eighteen years;
- To a fine not exceeding fifty

thousand emalangeni or imprisonment for a term not exceeding ten years or to both, if the victim is eighteen years old and above.

■ To a fine not exceeding twenty thousand emalangeni or imprisonment for a term of four years or both if both parties agreed to commit the incest.

Where both the victim and the offender are of the age of eighteen years or below, the Court may use its discretion in sentencing the offender. It shall be immaterial that the act or attempted act of sexual penetration happened with the consent of either person. This means that consent does not change the illegality and consequence of incest.

It shall be a defence to a charge under this section to prove that the accused person or persons were, at the time when the act or attempted act of sexual penetration happened, acting under the coercion of another person. A reference to an off-spring or other lineal descendant includes a relationship of the type that is a half, adoptive or step. A step relationship includes a relationship corresponding to a step relationship arising because of cohabitation in a relationship akin to a marriage or because of a foster relationship or other legal arrangement and does not include a step relationship that first arose after the relevant persons became adults.





DAGGA IN HIGHEST GOURT IN THE LAND



ON Valentine's Day 2010, Myrtle and I appeared in the Krugersdorp Magistrate's Court charged with possession and dealing in drugs.

In the months awaiting our first court appearance, we had written an affidavit claiming our constitutional rights to use cannabis as responsible adults in the privacy of our home. We charged seven State departments with enacting an unlawful law.

The 1992 Drugs and Drug Trafficking Act in its present form pertaining to cannabis, is virtually a cut and paste from the 1971 'weed law'; a law that saw over 70 000 African males arrested and imprisoned in its first year.

These laws have been tweaked to fall in line with international conventions over the years since 1961, and remain the single most destructive piece of legislation in the land, based on absolutely no science whatsoever. Unrealistic. irrational legislation from a dim and distant past.

In the Krugersdorp Magistrate's Court, the elderly magistrate looked up at us over his round horn-rimmed glasses and said: "You do know you are opening a can of worms?"

Fighting

At the same time, a case was developing in the Western Cape. Leader of the Dagga Party Jeremy Acton was fighting a R50 fine for a stop of weed in his local constituency. He took his grievances to the Western Cape High Court at roughly the same time our founding affidavit was being lodged with the North Gauteng High Court. (NGHC)

Ras Gareth Prince, the only South African to have taken the 1992 Act to the Constitutional Court, where he was narrowly defeated in 2000, teamed up with Jeremy. Over a period of years, they added more aggrieved South Africans to the list of plaintiffs sickened by the way State had treated them for having a relationship with a plant.

The culmination of their challenge was heard at the end of 2016 in the Western Cape High Court (WCHC). Judge Dennis Davis handed down what has been a hotly debated 'privacy' ruling. He found that the arrest and detention of someone for using and growing cannabis in their home was unconstitutional. The cops couldn't bash down your door and trash your

'Weed is legal' was the breakfast click bait. Then the questions started to fill our inbox. Is it only Cape Town? What happens if you're in your vehicle? If you can smoke it, where do you get it?

What about work? What if you live in a caravan, or a first floor apartment with no garden?

It was like legal but not legal. Illegal anywhere but your home, and if you grew it yourself.

Surely that's not legal? What about the health benefits or

the industrial uses. What about hemp? Can we all grow hemp now?

The judgment seemed to create more questions than answers but the Plaintiffs had actually managed to overturn the 'last apartheid law'. Laymen, representing themselves in a South African High Court had convinced a presiding judge that parts of the 1992 Drugs and Drug Trafficking Act per-

taining to cannabis dagga were indeed unconstitutional.

The State appealed the judgment almost immediately which came as a surprise to some. They had little or no effective argument in the High Court. Would could possibly change in a higher Appeals Court?

Months later, convinced we could fill the gaps in the evidence that wasn't ventilated in the WCHC, Myrtle and I walked into what we dubbed the 'Trial Of The Plant' (TOTP) in the NGHC. Nineteen court days to present the definitive argument for and against the legalised regulation of dagga, live streamed to the world.

The State had one thing to achieve and only one. They had to prove that their 100-year-old method of controlling and reducing the sale and consumption of dagga by arresting users and putting them in cages was

Was the use and sale of dagga decreasing by locking peaceful citizens in holding cells and denying them bail because they had no resources? Was their obsession with criminalising generations of young dagga

users really helping society? Was sentencing a breadwinner to jail for peddling a couple of bankies in his hood helping the family environment?

The State and co-defendants, Doctors For Life, did an exemplary job of grinding our definitive trial to a

standstill with days of tedious circular cross examination and last minute file submissions.

It could be seen by all who watched expert witness Prof David Nutt on the live feed for 42 hours that that was the sole intention of the defendants. Stall the trial, bankrupt us, and be in no hurry to set a new date.

They achieved that in part, but not before Nutt could put on the court record the relative harms of alcohol, tobacco and cannabis. That cannabis is not a killer; that death from overdose is clinically impossible; that it

has important therapeutic pharmacology - and alcohol and tobacco

I'll never forget the pressure of those weeks in the NGHC. The media presence, the defence attorney's demeanours. the stuffy, wood panelled low ceilinged court, the contrived anti dagga campaigning in the street outside with Tshirts paid for by local government, the tactics, psychology, delays, and a house full of crew and supporters for a month.

We were having our day in court. We didn't really seem to get anywhere with our evidence. However, we received a huge amount of international coverage from cannabis networks worldwide. It was a busy and exciting time.

South African cannabis activism is coming from a place of human rights, sovereignty and cognitive liberty. It simply hasn't been done like this before, anywhere in the world.

Cannabis users were the plaintiffs. The government were the defendants and the world was watching it all unfold on YouTube.

When we heard a date had been set in the Constitutional Court to hear the State's appeal to the WCHC judgment, our legal team advised us to attempt to join the hearing as co-plaintiffs. A move that if successful would mean Advocate Don Mahon and our legal team could introduce our 'Trial Of The Plant' arguments to assist the court in making their judgment.

All our evidence concerning hemp and medicine that seemed to somehow get ignored or circumvented by the WCHC, could now be considered.

Incredible

Over the last couple of weeks, the pertinent documents have been received by the Constitutional Court from our incredible legal team. Doctors for Life, the irritating thorns in our side for the last six years, have joined as Amicus Curiae. The Griqua Nation, a people marginalised by history are mobilising for the hearing. King Adam Kok V, their present leader has personally filed an application, as have representatives of the San Nation. Traditional healers and teachers of indigenous knowledge systems want their arguments heard as to why dagga should be re-legalised.

After all, it is the San people who are responsible for introducing the original use of the word 'dacha', eons

BLACK LIBERALS SHOULD NOT BE AFRAID TO CELEBRATE SUZMAN

THROUGHOUT the year, African National Congress (ANC) has celebrated and commemorated the party's late president Oliver Tambo. Having passed on in 1993, Tambo didn't live to see the democratic South Africa he and so many others fought for.

Born in 1917, he would have turned 100 in October this year and it is befitting that the ANC pays tribute to him by honouring his contributions to the struggle for freedom.

Also turning 100 this year would have been the late anti-apartheid liberal heroine Helen Suzman. She was born exactly a century ago today (7 November 1917) and spent her career opposing the apartheid regime.

From 1961 to 1974, she sat alone in the opposition benches in Parliament calling out the racist government and drawing attention to the appalling conditions faced by black people. Her contributions were different from the likes of Tambo, who went into exile, but this should not render her endeavours insignificant.

She too has a place in our complicated history. Considering that November is her birthday month, there has been little to no mention of Suzman in the public domain to mark this occasion.

Conspicuous by their silence are black liberals who I believe are actually afraid to be seen to be praising the likes of Suzman. We have accepted and practice a trend in our country where the only struggle credentials we recognise are those associated with the ANC. This is not only unfair, but it is wrong.

In the case of Suzman, this is made more difficult by the fact that she was white. You see, because of the fact that apartheid was engineered and enforced by a white government, it is easier to make a blanket statement that all whites were in favour of black oppression. It is much harder to honour white people who opposed white minority



rule, particularly if you are black, out of fear of being seen as a 'house negro' or a 'sellout'. This is the position black liberals find themselves in today.

There are two great ironies here. First, Suzman was revered by black liberation leaders who continued to pay homage to her after freedom was won in 1994. When President Nelson Mandela signed the Constitution into law in 1996, he asked Suzman to stand by his side. Winnie Madikizela-Mandela has spoken of how Suzman would visit her in Brandfort where she was banished by the regime and credited her with fighting to improve the living conditions of political prison-

During a lecture at the Wits Great Hall in 2008, Deputy Chief Justice Dikgang Moseneke spoke about how he heard of Suzman as a child in Atteridgeville. He said he heard how the adults remarked how different Suzman was from "them"; I assume that was a reference to other whites. Leaders of all political persuasions agree that Suzman played

an important role in our country and they have not been afraid to publicly declare this. You'd have better luck drawing blood from a rock than getting black liberals to do this.

The second irony is that black liberals have no qualms paying homage to white struggle leaders of other political backgrounds. They don't hold back in praising people like Helen Joseph, Ruth First or her husband Joe Slovo, for example. Again, this is an example of how black liberals are playing a game based on rules set by opponents of liberal-

Liberalism

As someone who identifies as liberal, I understand firsthand how difficult it is to advance liberal values in a country where liberalism is not fully understood or broadly accepted. Liberalism is often viewed as promoting selfishness over ubuntu; seeking individual advancement over community benefit. Liberalism is largely seen as a 'white idea' and therefore not a black one. So how then should black liberals operate in this environment?

I think the starting point is that black liberals must accept that there is nothing wrong with being liberal. If the nationalists, socialists and right-wingers in our country have the audacity to wear their political identities with pride, then why shouldn't we?

There are political parties like the Freedom Front Plus who only proudly represent Afrikaner interests and conservative parties like the African Christian Democratic Party who oppose certain freedoms like same sex marriage. Such parties and individuals who support them carry no sense of shame in what they stand for and it is high time that black liberals took the same approach.

If black liberals do not stand up for liberalism in a country in which blacks are the majority, then the ideals of liberalism will die. Black liberals have internalised wholesale the idea that they have to be a certain way in order to be better accept-

We should not seek to dress ourselves in ANC cloaks, for example, in hopes of making liberalism more popular. The truth is, there is discomfort amongst black liberals in being openly liberal and we see this with the overwhelming silence on Suzman. To successfully sell liberalism, we need to start believing in our own message.

Suzman was not perfect and I certainly do not agree with everything she did or stood for. I can say the same about Mandela. But if we want to keep liberal values alive then we need to be willing to pay homage to leaders who share our values no matter what their colour. The idea of liberalism is that we recognise one's character over their colour or any other aspect of their identity, and so the fact that Suzman was white should not stand in the way of boasting about her achievements. Now that would be selling out.

KIM PORTRAITS, DEATH THREAT

PORTRAITS of North Korea's late leaders hang proudly in the classrooms of the Korean High School in Tokyo, where the recent surge in tensions over Pyongyang's nuclear weapons programme we seen faculty and staff subjected to death threats.

It is one of 60 so-called "pro-Pyongyang" schools in Japan catering to an ethnic Korean community that -- over decades -- developed and maintained a link to North Korea despite never living there.

There are around 500 000 ethnic Koreans in Japan - mostly descendants of civilians taken from their homes during Japan's brutal colonisation of the Korean peninsula from 1910 until Tokyo's defeat in World War II in 1945.

The division of the peninsula into North and South and the devastating 1950-53 Korean War that followed also divided the community and schools like Korean High emerged with backing from pro-North organisations and funding from Pyongyang.

They continue to teach Korean language and history under the guidance of the General Association of Korean Residents in Japan, which acts as the North's de-facto embassy in Japan in the absence of formal diplomatic relations.

Ethnic Koreans have long suffered discrimination in areas like employment and social welfare, and principal Shin Gil-Ung said anger over North Korea's nuclear programme - expected to dominate US President Donald Trump's visit to Japan starting Sunday has only made things worse.

"Every time news (about North

Korea) breaks, we get anonymous calls threatening to bomb the school or kill students at a nearby station," Shin tells AFP.

"Female students have had to stop wearing the ethnic school uniform on their commute," he adds

Japan has been at the sharp end of recent provocations from Pyongyang, which fired two missiles over its northern islands in quick succession, prompting terrified residents to rush for shelters. And with the belligerent regime in Pyongyang threatening to "sink" Japan into the sea, the sense of tension and anxiety has left many ethnic Koreans feeling conflicted -- especially the younger genera-tion for whom modern Japan is the only home they have known. One Korea High pupil, 17-year-

old Hwang Song-Wi, says he watches the news with "mixed feelings". and that he both "trusts and doubts" reports from both sides in the cri-

Ri Chun-Hui, a Tokyo-based lawyer, said the anger directed at his community as a result of Pyongyang's provocations are nothing new -- noting a similar backlash that followed the abduction of a number of ordinary Japanese citizens by North Korean agents in the late 1970s and early 80s.

"Koreans were once thought of as victims of Japan's colonisation but we are now treated as if we were all perpetrators of the abductions," said Ri.

"The sentiment that you can attack anything linked to North Korea now prevails in Japan," he added.





The Public Service Pension Fund (PSPF) 2017 Annual report has revealed that the company's Return on Investment is standing at five per cent.

This comes after the company recorded nine per cent in the previous year on Return on Investment.

The newly installed equipment has reduced costs of maintenance and power usage, this enables the IT staff to work more effectively in other technical tasks. The need to upgrade the data centre arose from old fund severs which were

64 per cent produce increase recorded by farmers

HAVING survived a hard hitting drought season in the previous year, farmers have been able to recover and get back on a more productive pattern.

This is according to the ministry of agriculture second quarter performance report (National Agriculture Marketing Board (NAMBOARD) for 2017/18 financial year.

"A total of 680mt of produce was purchased from contracted and nonfarmers during the quarter and in turn the market paid farmers a total of E3 803 857 for their produce.

Result

"This shows an increase of 64 per cent when compared to the previous quarter, this is as a result of good summer rains in most parts of the country, and thus farmers were able to plant and provide the market with

horticultural products," the report

There are different vegetables that contributed to the recorded increase which included tomatoes which recorded the highest produce, (224mt E1 014 922). Poultry recorded (41.2 mt E716 343) beetroot (84.22mt E 386 321) and green pepper (36.14 E 279 086).

The high produce resulted in key producer prices eventually decreasing at the beginning of the quarter and the decline is attributed to an increase in the available products in the market.

Decreased

Tomato prices decreased sharply from a peak of E 140 per crate to lows of E80 per crate due to oversupply in the market, green pepper prices also took a knock from highs of E100 per crate to as slow as E65

Beetroot prices also took a nosedive as volumes continued to increase in the local and regional markets.

According to the report increase in production in South Africa especially in tomatoes and beetroot has increased pressure on all regional markets and significantly.

This dropped prices for major commodities in all local markets. The increase in commodity prices is expected to sustain as the festive season approaches and hold through to the start of next winter.

ket at Tikhuba Trader, creating a business opportunity for the eight women and indirectly benefiting 58 people. The belts are environmentally friendly and are made from recycled waste material and have been designed with a QR code to help farmers keep track of their livestock. The team from SANU then saw an opportunity to address waste and food security through the use of a planting system called hydroponics. The team worked with pupils with disabilities from St. Joseph's

and taught them basic business skills and how to grow organic vegetables using recycled bottles and boxes. This type of planting reduces the amount of water and land needed to grow produce. Through this project 259 people have been directly impacted and 1 554 people indirectly impacted.

The team was awarded the Most Improved Team Award and League Runner-Up at this year's National Competition, which amounted to a cash price of E2,000.

In addition, two SANU faculty advisors were presented with Long Service Awards for their 10 years of dedication to Enactus. Finance Minister Malusi Gigaba tabled a bleak picture of the nation's finances last month, with growth and revenue falling below projections while public debt may exceed 60 per cent of gross domestic product by 2021.

An inability to rein in spending growth and increasing debt threaten to trigger a downgrade of rand-denominated bonds by rating companies.

SAA seeks investor to revive its fortunes - CEO

JOHANNESBURG - South African Airways will revive a plan to seek an equity partner that's able to provide cash and operational savings to help turn around the state airline, according to its new chief executive officer.

A strategic investor would ideally come from within the aviation industry, CEO Vuyani Jarana, 47, said in an interview at Bloomberg's Johannesburg office on Monday. That will enable unprofitable SAA to share costs, improve customer service and gain a capital injection, he said.

"You don't just want a pure investor such as private equity," said Jarana. "With a strong equity partner that has operations elsewhere, you are able to leverage from each other's capabilities."

A successful search for a new investor would solve the most pressing challenge facing Jarana - that of putting SAA on a sure financial footing without need of a further

government bailout. It's also a revival of a plan raised by former Finance Minister Pravin Gordhan in his budget speech in February 2016, though the formation of a new board to lead the search was only finalized last month. Jarana, who started November 1, is SAA's first permanent CEO for more than two years.

Swiss Air bought a 20 per cent stake in SAA in 1999, only for the South African government to buy it back after the Swiss carrier went bankrupt. SAA is also part of the Star Alliance, a global code-sharing network that includes Deutsche Lufthansa and Singapore Airlines.

One of SAA's main strengths is a 55 per cent share of the South African market, which also includes contributions from low-cost carrier Mango and SA Express, Jarana said. A merger of the three airlines would help to secure a strong partner, he said, while also contributing to the cost-cutting plan.

ECB warns of empty shell banks post-Brexit

BRUSSELS - The European Central Bank fears that international banks based in London are overly relying on "empty shell" units to continue working in Europe after Brexit, while keeping key services in the UK capital, sources said on Monday.

The ECB's chief supervisor Daniele Nouy voiced her concern to a meeting of eurozone ministers in Brussels, with the effects of Britain's divorce from the European Union becoming a major worry.

According to sources familiar with the matter, Nouy sounded an alarm that global banks are setting up headquarters on the European continent in name only while keeping most operations still standing in London.

This is a huge issue as the UK tries to hold onto the dominance of its London financial hub despite Brexit, all while Frankfurt, Paris and Dublin strive to take advantage of Britain's euro-divorce.

Big

London, for its part, is fretting while big banks sound out regulators in different EU nations as they look for a new base to do business in Europe once Britain leaves.

If Britain goes ahead with a so-called "hard Brexit", in which the UK loses all special ties to the EU, banks based in London will lose the "passports" that allow them to do business out of the UK across the remaining 27 members of the bloc.

Instead, to continue operating in Europe, financial firms will have to set up new business headquarters in EU countries.

Frankfurt has already claimed some major financial players as a post-Brexit headquarters, including US investment bank Morgan Stanley and Japanese giants Sumitomo Mitsui Financial Group, Daiwa Securities and Nomura.

Goldman Sachs Chief Executive Lloyd Blankfein last month caused a firestorm on twitter, touting Frankfurt's "great" weather among other attributes, but stopped short of naming the German city as a post-Brexit headquarters.

Not another day in paradise as EU vows tax action after leaks

BRUSSELS - The days in paradise may be numbered for those seeking refuge from heavy tax burdens in remote islands.

Finance ministers representing the world's largest market vowed to take action following the leak of records exposing prominent members of the global business A-list.

"We will examine the new documents and will discuss the consequences this has for upcoming EU legislation," acting German Finance Minister Peter Altmaier said ahead of a meeting with his eurozone counterparts on Monday. "We will take a very close look at this," he said, referring to the so-called Paradise Papers reports by the International Consortium of Investigative Journalists and partner news outlets.

The new set of data taken from an offshore law firm again exposed the

hidden wealth of individuals and shows how corporations, hedge funds and investors may have skirted taxes.

A year after the Panama Papers, this new massive leak of confidential information from the Bermuda law firm Appleby has shone another light on the use of offshore accounts. Apple, which has clashed with the European Commission over taxes, was ensnared in the leak. FIN24

Facebook to make mobile payments service available outside US

LONDON - Facebook is enabling people outside the US to send money to each other via its Messenger texting app for the first time.

The social network said on Monday that Messenger users in the UK will be able to send money to each other when the feature rolls out in the next few weeks. People will need to sign up with their debit cards to send or receive money. "In the US most people use payments in Messenger to send less than \$50 at a

time," David Marcus, Head of Messenger, said in a statement, adding that the feature is most commonly used during social occasions.

Facebook began letting its users in the US send cash to each other in 2015 but doesn't charge for its use. The move is part of an increasing trend by tech giants to muscle in on the global payments industry. Apple's forthcoming Apple Pay Cash will let the company's device owners send money to each other through its iMessage service. Square



has a similar product called Square Cash, and PayPal's Venmo has been a popular choice for younger users in particular. *Fin24*

Top cop funders net **R5** billion tenders


JOHANNESBURG - The businessman who allegedly paid for ex-acting police commissioner Khomotso Phahlane's vehicles has, according to IPID, received at least R5bn in tenders for the SAPS since 2010.

This was revealed in a letter sent from the Independent Police Investigative Directorate (IPID) to acting National Police Commissioner General Lesetja Mothiba.

The letter, titled "Investigation of Corruption against Lieutenant General Phahlane and service provider Keith Keating, of FDA", laid out how Phahlane, his wife and sister received "sponsored" vehicles from a businessman.

The letter said that during the course of their investigation into Phahlane, IPID was able to uncover an allegedly corrupt relationship with FDA (Forensic Data Analyst), owned by Keith Keating.

"The investigation has detected possible crimes of corruption, fraud and money laundering, facilitated by car dealer Durand Snyman," the letter said. Phahlane, his sister, his wife, and a

Colonel Potgieter (from the SAPS unit known as TMS) received vehicles allegedly sponsored by businessman Snyman.

The letter said that the vehicles were purchased under the fake name, John Doe, and that Keating paid for them by

putting money into Snyman's account. Keating, IPID said, has a contract with

the SAPS for the supply and maintenance of Rolfin lights, alleged to be worth R1bn.

State capture inquiry pointless without Zuma: Madonsela

JOHANNESBURG - Former Public Protector Thuli Madonsela says President Jacob Zuma's proposal that he be excluded from a state capture inquiry makes no

"That defies logic for me because this whole investigation was only about him," she told eNCA reporter Karyn Maughan in an interview.

If the president's proposal that he be excluded was granted, the inquiry may as well not go ahead, she said.

Madonsela said there was already evidence that Zuma violated the Constitution in his handling of the state capture scandal.

"With due respect, in terms of the report that I issued, the president is already implicated. But yesterday [Sunday] he was openly telling the nation in Kagiso that the people criticising him are foreign agents, he's done nothing wrong.

"But that's disrespecting the Constitution. Because a constitutional body, given the power to investigate, already found that

...there's evidence of wrongdoing, and one year down the line, he still hasn't answered. But he's defying the law by firstly telling people he's done nothing wrong, and then casting aspersions on people who believe he's done something wrong."

Madonsela said though she was grateful that the president was now promising that a state capture inquiry would be instituted, she could not understand his proposal that the investigation into his conduct be excluded from that public investi-

"That defies logic for me because this whole investigation was only about him...The allegation is that him and companies related to his family, the Zuma family and the Gupta family are being allowed to influence state decisions regarding who should be a minister, who should be a DG, who should be on boards of state-owned enterprises. And the allegation is that he probably violated his executive ethics code in allowing this."

Zuma wants that probe referred back to Madonsela's successor. Busiswe Mkhwebane. Madonsela said there was evidence of the Guptas' involvement in the shock 2015 removal of Finance Minister Nhlanhla Nene and his four-day long replacement by Des van Rooyen.

Mixed reaction to Ramaphosa's 'slate'

JOHANNESBURG-One of the frontrunners for ANC leader, Cyril Ramaphosa, will have a tough time convincing some of his supporters to throw their weight behind his preferred deputy ahead of the party's December elective conference.

The surprise announcement that he wants current ANC National **Executive Committee member** Naledi Pandor to be his deputy has been defended and criticised by his campaigners in various provinces.

Ramaphosa announced his slate on Sunday during a rally in Ga-Sekhukhune, Limpopo.

He expressed his support for Pandor as his deputy, current ANC Secretary General Gwede Mantashe as National Chairperson, former KwaZulu-Natal chairperson Senzo Mchunu as Secretary General and Gauteng Chairperson Paul Mashatile as the party's Treasurer General.

While Mantashe, Mchunu and Mashatile are seen as bringing support from their respective provinces, Pandor is regarded as bringing on the ticket a scandal free record in government, which Ramaphosa is hoping will stand him in good stead

if he wins the elective conference and then have to face an increasing ANC hostile electorate in the 2019 elections.

Until now, Pandor's name has not appeared on any of the CR17 campaign top six.

A source close to Ramaphosa's campaign said initially he backed Sisulu but her "presidential ambitions" and public spats with some in Ramaphosa's campaign did not help her cause. "He wants to be deputised by a female comrade so that when the precedent system [is] applied after his presidency, we have a woman president - but Sisulu's complicated it because she wanted to be president and thought even if she fails she can still be Ramaphosa's DP," he said.

However, some inside his campaign are not happy with his choice.

"He is imposing this name on us it's not well thought out," said one CR17 campaigner in the Free State.

The same campaigner said he was worried that Ramaphosa was forcing ANC members to support Pandor's bid to become president, should she one day decide to pursue it.

'Lack of appointments hits morale'

JOHANNESBURG - The lack of permanent appointments in the SA Police Service (SAPS) and the Department of Correctional Services (DCS) is affecting employees' morale, the Police and Prisons Civil Rights Union (Popcru) said yesterday.

"We do not have permanent national commissioners both in the SAPS and the DCS. This has had serious implications on the strategic direction within the SAPS, which has led to hampering of service delivery and negatively affecting police officers' morale," the union said after holding a central executive committee meeting over the weekend.

Poperu also said it was concerned about over crowding in prisons and understaffing at national and regional levels in correctional services.

The union demanded the appointment of two commissioners and the filling of vacant regional head posts.

The SAPS organisational structure has been changed more than six times in the past five years, with each commissioner "bloating it further" and concentrating at top managerial levels, Poperu said, adding that this led to duplication of duties and compromised service delivery. At the DCS, the Occupational Specific Dispensation (OSD) was yet to be finalised, affecting workers' income.

LONDON - The NHS is offering patients the opportunity to consult a doctor via their smartphone in the latest attempt to cut wait-

More than 3 000 people have already signed up to take part in a pilot scheme.

They have been promised that thanks to new technology they will be able to 'see' their GP within two hours, rather than have to wait anything up to two weeks for a conventional appoint-

Mobasher Butt, a partner in the company behind the scheme, said: 'We do everything from grocery shopping to banking online yet, when it comes to our health, it can still take weeks to see a doctor.

"With the NHS making use of this technology we can put patients in front of a GP within minutes on their phone." To speed things up, the health service is also considering using something called a chatbot - a computerised system which employs facial recognition and artificial intelligence to check symptoms and issue a diagnosis, writes Richard Littlejohn

To speed things up, the health service is also considering using something called a chatbot - a computerised system which employs facial recognition and artificial intelligence to check symptoms and issue a diagnosis.

Clearly the system is not designed to deal with anyone suffering from a serious condition.

But obviously for minor ailments, it makes sense and saves time to talk to your GP over the phone.

You can always schedule a follow-up appointment in person or be redirected to hospital if the doctor thinks it's necessary.

Ali Parsa, founder of the technology company involved, said: "I think this is the beginning of the end for the old-fashioned way we use healthcare."

That's what worries some people. The Royal College of GPs fears that it could lead to a twotier service, given that a significant number of elderly people — those most in need of seeing a doctor - still don't have a smartphone and have no intention of getting one.

There are also concerns many doctors will opt to give up their traditional practices and only offer consultations over the phone.

Speaking as someone who refuses to bank online, being only too aware of the security and privacy implications, "I'd certainly be wary of divulging personal health information to a chatbot," writes Richard Littlejohn

CAIRO - A prominent Egyptian rights lawyer says he will run for president in next year's elections. Khaled Ali announced his candidacy on Monday to a packed news conference at the headquarters of the opposition al-Dustour party, saying "Egypt is in crisis... we are working with other democratic parties to ensure real guarantees for this battle. NAIROBI - The chief photographer for Agence France-Presse (AFP) in east Africa appeared in court on Monday after 48 hours in police custody, charged with trespassing on a property belonging to the president's family.Japanese photographer Yasuyoshi Chiba, 46, was arrested on Friday afternoon at a farm belonging to the Brookside dairy company which is owned by President Uhuru Kenyatta's family. He had gone to photograph the company logo after the opposition National Super Alliance (NASA) named Brookside as one of three companies its supporters should boycott as part of a "resistance" campaign following disputed presidential elections. 3 Britons freed; 1 killed

LONDON - The British government says one UK missionary who was kidnapped in Nigeria last month has been killed but three others have been freed. The Foreign Office said on Monday that Alanna Carson, David Donovan and Shirley Donovan have returned to their families, but Ian Squire "was tragically killed." The four were abducted in the Niger Delta region on October 13. In a statement, their families thanked Nigerian authorities for negotiating their release. It was unclear when and how they were freed or how Squire died.

Climate change hits hard

MIAMI - With sheet metal roofs, concrete floors, poor ventilation and spotty electricity, crowded urban slums in Kenya can expect to get even hotter and deadlier due to global warming, US researchers



said. Scientists at Johns Hopkins University analysed three informal settlements in Nairobi, including the largest, Kibera, home to nearly a million people. Along the settlements' narrow alleyways, mud-walled homes and metal roofs, they found stifling temperatures, "2.7-5.5 C higher than those reported at Nairobi's official weather station less than half a mile away," said the study in the journal PLOS ONE. *AFP*

LOME - Togo's government on Monday said it was working towards talks with its political opponents after more than two months of protests calling for President Faure Gnassingbe's resignation. AFP




Bashir says time to empty camps of Darfur displaced

KHARTOUM - Sudanese President Omar al-Bashir said on Monday it was time to shut camps hosting millions of displaced people from the conflict in Darfur as the war in the region had ended.

Bashir, wanted by The Haguebased International Criminal Court for genocide and war crimes related to the Darfur conflict, said internally displaced people should return to their villages and not stay in camps any more.

"Darfur has now recovered, and the next step is to empty the IDP camps as we don't want any more IDPs," Bashir said in a speech at a youth convention in Khartoum.

"IDPs and refugees have to return to their villages. We will provide

security and services to their villages." Bashir alleged that the IDP camps had become business ventures for foreign aid groups. "They come and offer humanitarian aid, take pictures of our people to get donations and then take 80 per cent of these donations themselves," he said, without naming any aid organisation.

"They are investing in the suffering of our people and doing business in the name of helping IDPs."

Bashir has regularly criticised foreign aid organisations, and in 2009 he expelled several that were operating in Darfur.

Sudanese officials including Bashir say that the war in Darfur has ended, and have consistently demanded that the United Nations peacekeeping force deployed in the region be dismantled.

Earlier this year, the UN Security Council approved a reduction in the number of the peacekeeping forces, citing an overall fall in violence in Darfur.

Three dead as Nigerian police shoot at Shiite procession

KANO - At least three people were killed when police opened fire on supporters of a pro-Iranian Shiite Muslim group during an annual religious procession in northern Nigeria, locals said on Monday.

Awwalu Ismail, a trader in the Dengi roundabout area of Kano, said the shooting happened on Sunday, as members of the Islamic Movement of Nigeria (IMN) marked Ashura. Ashura commemorates the death of Hussein, the grandson of the Prophet Mohammed.

IMN members from across the mainly Sunni Muslim north typically converge on Kano to walk to Zaria in neighbouring Kaduna state, where their leader Sheikh Ibrahim Zakzaky has his headquarters?

"When the procession by the IMN adherents moved towards Zaria Road, the police began firing tear gas followed by live bullets," Ismail

told AFP. "Many people were hit and at least three people were believed to have been killed."

Abdurahman Usman, a civil engineering student at Bayero University Kano, said: "I was shown the picture of one of the victims whom I recognised as my course mate, Husaina. "Her father is a lecturer at the university."

Kano police strongly denied using live bullets and killing any protesters.

IMN leader Zakzaky has been at loggerheads with Nigeria's secular authorities over the years because of his call for an Iranian-style Islamic revolution.

He has been in custody since troops clashed with his followers in Zaria in December 2015. Troops allegedly killed more than 300 IMN supporters and buried them in mass graves to hide their crimes, rights groups say. *AFP*

Liberia court indefinitely delays presidential vote

MONROVIA, Liberia - The Supreme Court on Monday indefinitely delayed a vote for Liberia's new president, ordering the electoral commission to resolve an opposition party's complaint for fraud before the runoff can be held.

The decision throws Liberia's first democratic transition in seven decades into uncertainty. Africa's first elected female leader, the Nobel laureate Ellen Johnson Sirleaf, is stepping down after transitioning her nation out of a long civil war.

Supreme Court Chief Justice Francis Korkpor said the National Elections Commission (NEC) was prohibited "from conducting the runoff election until the complaint filed by the petitioners is investigated," referring to the opposition Liberty Party. Former international footballer George Weah and incumbent vice-president Joseph Boakai were due to face each other in a runoff vote yesterday.

But they must now await the result of an ongoing NEC complaint as well as any Supreme Court appeal, which could take weeks. The case was brought by Liberty Party presidential candidate Charles Brumksine, who came third on October 10 and has alleged ballot stuffing and false voter registration cards marred the election. "Liberty Party has rested evidence fully and we, the National Elections Commission (NEC), will now take the stand. So in a matter of days, we hope that there can be some conclusion to the investigation," said Musa Dean, a lawyer with the commission. AFP

Mnangagwa: Mugabe's sunken 'crocodile'

HARARE - Emmerson Mnangagwa, who was removed by Zimbabwe's leader Robert Mugabe as vice president on Monday after a bitter tussle with the first lady over succession, had waited almost four decades for his chance at the top job.

Nicknamed "Ngwena" (The Crocodile) because of his fearsome power and ruthlessness against rivals, the 75-year-old had a reputation for taking no

prisoner

But he was ultimately outfoxed by Grace Mugabe, who is 41 years younger than her husband, after she apparently convinced the veteran head of state to ditch his long-serving minister.

An acrimonious weekend in which Mugabe's wife was openly booed at a rally prompting the president to blame Mnangagwa, who was present, probably sealed the fate of the

outgoing number two. It was the climax of long-running tensions between the first lady and Mnangagwa.

Analysts have suggested that Mnangagwa's sacking would effectively disqualify him from the race to eventually replace Mugabe, now aged 93. In the early days after independence from Britain in 1980, Mugabe made the young lawyer his minister for national security.




CHILE WILLING TO GRANT ASYLUM TO VENEZUELAN OPPOSITION LAWMAKER

SANTIAGO - Chile is prepared to grant political asylum to a Venezuelan opposition lawmaker who sought refuge at its embassy in Caracas claiming that his safety was in danger, the foreign minister said Monday.

Venezuela's government is locked in a vicious political fight with the opposition, which dismisses President Nicolas Maduro as a leftwing dictator who has gutted the oil-rich and economically ailing country's democracy.

Freddy Guevara, the oppositionheld National Assembly's number two official, sought refuge at Chile's embassy in Caracas Saturday, a day after the pro-government Supreme Court stripped him of his immunity and said he would be prosecuted on charges punishable by a decade in prison. Chile has taken in Guevara as a guest "for humanitarian reasons and in light of international law," Chilean Foreign Minister

Heraldo Munoz told reporters. And Chile is willing to grant Guevara, 31, political asylum but so far he has not requested it, the minister said.

The prominent opposition leader

became the seventh Venezuelan to seek protection at the embassy in less than three months.

They include four judges who sought protection at Chile's embassy in Caracas, escaped to Colombia and then made their way to Santiago, Chile, where they asked for political asylum.

Venezuela's top court last Friday announced the suspension of Guevara's immunity to enable him to be tried for crimes of "association, persistent public instigation and the use of an adolescent to commit crimes," without specifying when the allegations date from. The pro-government Constituent Assembly -which governs crisis-stricken Venezuela with absolute power and replaced the congress where Guevara had a seat - is investigating the lawmaker in connection with mass protests against the embattled Maduro that left 125 dead between April and July. AFP

Japan's 'Black Widow' to hang for murder

TOKYO - A Japanese court yesterday sentenced to death a one-time millionairess dubbed the "Black Widow", who tricked elderly lovers into drinking cyanide and pocketed millions in insurance payouts and inheritance.

Kyoto District Court condemned Chisako Kakehi (70) to the gallows for the murder of three men - including a husband - and the attempted murder of another, ending a highprofile case that has gripped the country.

Kakehi became notorious after using the poison cyanide to dispatch a number of elderly men she was involved with, drawing comparisons with the spider that kills its mate after copulation.

"The accused made the victims drink a cyanide compound with a murderous intention in all the four cases," Judge Ayako Nakagawa told the court, according to public broadcaster NHK.

Nakagawa rejected defence lawyers' arguments that Kakehi was not criminally liable because she was suffering from dementia.

Prosecutors said she killed the men after they made her the beneficiary of life assurance policies that ran into millions of dollars

She reportedly amassed one billion yen (R124-million) in payouts over 10 years but subsequently lost most of the fortune through unsuccessful financial trading.

She had relationships with many men, mostly elderly or ill, meeting some through dating agencies, where she reportedly stipulated that prospective partners should be wealthy and childless. AFP

TOKYO - US President Donald Trump says the mass shooting at a Texas church "isn't a guns situation", but is a "mental health problem at the highest level".

Devin Kelley, the man authorities have identified as the gunman, was discharged from the Air Force several years ago for allegedly assaulting his spouse and a child, according to an Air Force spokeswoman.

While no officials have publicly questioned Kelley's mental health, Trump said that "is your problem here". He offered no details. "This was a very, based on preliminary reports, a very deranged individual. A lot of problems over a long period of time", Trump said when asked about the shooting as he and Japanese Prime Minister Shinzo Abe held a joint news conference in Tokyo during Trump's first official visit to Asia."

TOLEDO - A judge has imposed a 27-year prison term for a man accused of supporting terrorism and trying to arrange the killing of the Ohio federal judge who originally oversaw his case.

Monday's sentence from Judge Edmund Sargus for defendant Yahya Farooq Mohammad also requires the Indian citizen to be deported at the end of his sentence and to pay a \$25 000 fine.

Mohammad is one of four men with Ohio ties who were accused in 2015 of working to send money to Anwar al-Awlaki, an al-Qaeda leader killed by a US drone in 2011. **AP**

Family dispute in shooting

TEXAS - A family dispute may have sparked the rampage by a US Air Force veteran who killed 26 people with an assault rifle in a small-town church, the deadliest mass shooting in Texas history, officials said. Ten people remained in critical condition a day after Devin Patrick Kelley, a 26-year-old private security guard, burst into the rural Baptist church during Sunday morning services and sprayed bullets at the congregation. Reuters

Shark kills swimmer

HAVANA, A shark attacked and fatally wounded a young man taking a nighttime swim at a beach in Cuba, a newspaper said. The attack 10 feet offshore at Guardalavaca beach is believed to be unprecedented, the provincial newspaper Ahora said.

Friends swimming with the 22-year-old man hit the shark with a bottle and wrested him from its jaws, then rushed him to a clinic in the city of Holguin, located 730 kilometres northeast of Havana.





Loew faces tough decisions v big guns

MUNICH - Germany coach Joachim Loew says he will use the forthcoming friendlies against England and France to start making some "tough decisions" ahead of next year's World Cup defence in Russia.

Germany face England away at Wembley on Friday and host France in Cologne four days later, which Loew will use to review his options.

The German squad gathered in Berlin yesterday to prepare for the double-header with goalkeeper Manuel Neuer, plus forwards Thomas Mueller and Marco Reus sidelined by injury.

Even without the star trio, Germany has an embarassment of riches with new names pushing the established stars who won the 2014 World Cup.

The gamble of taking an inexperienced squad of fringe players to Russia for the Confederations Cup in June paid off for Loew.

Rising stars Timo Werner, Lars Stindl, Niklas Suele and Sebastian Rudy all seized their chance to impress.

Now Loew has numerous options for the England and France friendlies which are set to spark a fight for places in his 23-man World Cup

"We have to make tough decisions,"

said Loew in Berlin with Germany also to face Spain and Brazil in friendlies next March.

"If you want to be world champion, you need world-class players.

"We have to have an incredibly strong squad where every player is in top shape - every day and every minute."

Midfielders Mario Goetze and Ilkay Gundogan, who have been in form for Borussia Dortmund and Manchester City respectively, must prove themelves after lengthy spells on the sidelines.

"I am very happy to be back after nearly a year out and I'm just as pleased for Ilkay," Goetze wrote on Twitter afer his recall.

The challenge for the Germans will be to repeat their Brazil 2014 success as the name to beat at the World Cup in Russia.

"We are the only team that can get worse - everyone will compete against us with huge motivation," said Loew.

"We are the world champions and Confederations Cup winners - the world's number one."



Murray, Djokovic, fall out of ATP Top 10

PARIS - Andy Murray and Novak the Wimbledon quarter-finals when Djokovic dropped outside the ATP Tour's top 10 for the first time in years in the latest rankings released on Monday.

The 30-year-old Murray plummeted from third to 16th after not playing since July with a hip injury.

The Scot's last appearance outside the top 10 was in October 2014.

The three-time Grand Slam winner last appeared on court at Wimbledon, losing in the quarter-finals to American Sam Querrey. Shortly after that he was nudged off the top of the world rankings by Rafael Nadal, who sealed the end-of-year top spot at the Paris Masters last week. Murray faced world number two Roger Federer in a charity exhibition match in Glasgow yesterday before start his preparations for the Australian Open by playing in Brisbane.

Djokovic, struggling with an elbow injury, was also last seen in action in he retired against Tomas Berdych.

The 12-time Grand Slam winner ends the year in 12th, down five places, for his lowest ranking since March 2007. Djokovic is hoping to make a comeback at the exhibition World Tennis Championship in Abu Dhabi next month.

American Jack Sock, who beat Filip Krajinovic 5-7, 6-4, 6-1 in the Paris Masters final on Sunday, climbs 13 rungs to ninth in the ATP chart. Sock's exploit in the French capital earned him a ticket to the World Tour Finals next week. Nadal's participation in the season-ending tournament in London is in doubt after the world number one and 16-time Grand Slam champion pulled out of Paris before his quarter-final with a knee injury. AFP

Italy legend Pirlo calls time on career

LOS ANGELES - Italy legend Andrea Pirlo on Monday called time on an illustrious career during which he won the 2006 World Cup, two Champions League titles and six Serie A trophies.

The 38-year-old former Juventus, Inter Milan and AC Milan midfielder made a late appearance for his club New York City against Columbus Crew, the day before announcing the end of his playing career.

"Not only my adventure in NY comes to an end, but my journey as a football player as well," Pirlo wrote on his Twitter account.

"That is why I would like to take the opportunity to thank my family and my children for the support and love they always give me, every team that I had the honour to play for, every team-mate I have been pleased to play alongside, all the people that made my career so incredible, and last but not least, all the fans around the world that always showed me

> "You will always be on my side and in my heart. Pirlo headed for the United States at the end of the 2014-2015 season after winning anoth

er Serie A title with Juventus - his sixth in total - including two with AC

He had already announced that this season would be his last as a player but his team lost his final game, Sunday's Major League Soccer playoff match against Colombus Crew.

Pirlo, who started his career in Brescia, also played at Inter Milan and Reggina before joining AC Milan, where he won two Serie A crowns and two Champions League trophies in 2003 and 2007.

Known as a free-kick specialist he was dubbed 'the architect' for his playmaking skills and uniquely cool and elegant playing style.

In 2011, while out of contract he joined Juventus, a deal which Italian international goalkeeper Gianluigi Buffon dubbed the "the deal of the

In Turin, Pirlo continued to impress despite his age winning

four titles and an Italian Cup.

His final match in Europe was in Juventus's Champions League final defeat in 2015 to Barcelona. Capped 116 times for Italy, scoring 13 goals, during a 13-year career until 2015, Pirlo played

Bilic spent all the credit he had left in the bank and left owners David Gold and David Sullivan no choice but to make a change.

But it remains a complete mystery how the pair of them can justify giving the job to someone like Moyes.

It appears that Moyes is still dining out on the success he enjoyed at Everton.

But here is a measure of how far his stock has fallen since he took the fatal decision to leave Goodison Park and become Sir Alex Ferguson's successor at Manchester United in 2013.

When the 'Chosen One' took the reigns at Old Trafford he signed a six-year contract that ran until 2019.

Hapless

In that time the Scot has managed United, Real Sociedad, Sunderland and now the hapless Hammers.

That's four different clubs, with 12 months still remaining on the deal he struck with United. Moyes is damaged goods now. Circumstances might have conspired against him at some of his

previous clubs and not least at Sunderland, where owner Ellis Short fed him a pack of lies about how much funding would be made available for new signings.

But the fact remains that Moyes has failed wherever he's been since leaving the Toffees and done nothing whatsoever to prove he can repeat the success he had on Merseyside.

He lasted just 10 months at United. The job was way too big for him and the scars from what happened have still to heal.

But his attempts to find redemption and rehabilitation since then have floundered and the Hammers have made a brave call indeed. *Daily Mail*

Serero snubs Bafana Bafana again

JOHANNESBURG - Thulani Serero has told SAFA that he won't report for camp unless he is guaranteed to play against Senegal.

This is not the first time Serero has done this, having shown South Africa the middle finger during Gordon Igesund and Shakes Mashaba's tenures.

Bafana Bafana coach Stuart Baxter confirmed that Serero is not joining the Bafana camp.

"He gave the indication to Barney Kujane that if he is not going to play he does not want to come to camp," Baxter told the media yesterday.

WHO CAN QUALIFY IN AFRICA

JOHANNESBURG - The third and last round of African qualifiers for the 2018 FIFA World Cup RussiaTM draws to a close this weekend, with three of

the five berths at next year's tournament still to be determined.

Egypt and Nigeria have already secured their spots, but there is all to play for in

Groups A, C and D.

Fifa.com looks at the various permutations as African teams head into the final straight.

Egypt (Group E), Nigeria (Group B)

WHAT'S AT STAKE?

Group A: Congo DR-Guinea, Tunisia-Libya

Tunisia only require one point at home to Libya to return to the World Cup stage for the first time since 2006. In the event of a Libyan victory, the Carthage Eagles could still make it if Congo DR fail to defeat Guinea.

However, if the Tunisians lose and the Congolese win, the following criteria will be applied to determine the ranking the two teams, as described in Article 20 of the 2018 Fifa World Cup Russia™ regulations:

a) Goal difference in all group

b) Greatest number of goals scored in all group matches.

If the teams are still equal on the basis of the above, then their ranking shall be determined as follows:

c) Greatest number of points obtained in the group

matches between the teams concerned;
d) Goal difference resulting from the group match-

d) Goal difference resulting from the group matches between the teams concerned;
 e) Greater number of goals scored in all group matches.

es between the teams concerned;
f) The goals scored away from home count double

between the teams concerned;
g) Fair play points system in which the number of

yellow and red cards in all group matches is considered according to the following deductions:

First yellow card: minus one point

Second yellow card/indirect red card: minus three points

Direct red card: minus four points
Yellow card and direct red card: minus five points;
h) Drawing of lots by the Fifa Organising Committee.

Group B: Algeria-Nigeria, Zambia-Cameroon Nigeria have already qualified for Russia 2018.

Group C: Ivory Coast-Morocco, Gabon-Mali In the crunch match in Group C, the situation is quite



simple: the Moroccans will qualify if they avoid defeat against Ivory Coast in Abidjan on Saturday. Les Eléphants, meanwhile, must win if they are to top the section and pip Morocco to the post.

Group D: Replayed match: South Africa-Senegal Senegal-South Africa, Burkina Faso-Cape Verde

On paper, all of the teams in the group have a chance of qualifying, especially as there are actually three matches still to be played, including South Africa-Senegal, which originally took place in November 2016 but will now be replayed on 10 November 2017, as per the recent decision of the Bureau for the Fifa World Cup Qualifiers.

In the event of Senegal pocketing three points in South Africa, they would be assured of finishing in first place and travelling to Russia next year. A draw may also be enough for Les Lions de la Teranga if, four days later, the Burkina Faso-Cape Verde match ends in a stalemate. Conversely, a South African victory in the replayed encounter would leave all four sides still very much in the hunt with one match remaining.

Group E: Congo-Uganda, Ghana-Egypt
With Egypt having earned their ticket to Russia on
the previous matchday, only pride will be at stake during the two scheduled games in Group E.



Poison being spilled in SA football - Komphela

JOHANNESBURG - Kaizer Chiefs coach Steve Komphela is warning fellow coaches to be careful in their analysis of other team's tactics and formation because he says "poison is being spilled".

"I must warn my colleagues, without my coming across as an expert, but our coaches are sometimes misleading people in the way they read numbers," Komphela said.

"It is often so inappropriate we are sending a wrong message.

"I don't know why people believe everything that coaches say, especially when it is wrong."

Komphela's outburst came after a radio reporter accused him of using six players in defence in the game against Chippa United on Sunday when Chiefs won 1-0 at the Nelson Mandela Bay Stadium in Port Elizabeth to book a spot in the Telkom Knockout semifinals.

Komphela made a patient explanation of the way Chiefs approached the game, using wingbacks and three central defenders, refuting the reporters' assertion and then using the opportunity to appeal to other coaches, without mentioning names.

But his focus was clearly on Mamelodi Sundowns coach Pitso Mosimane, his former colleague with Bafana Bafana, who accused Chiefs of "parking the bus" in the last encounters.

This Komphela refuted: "The match we played at Loftus when we lost 2-1 (in November last year) we were playing 3-4-3.

"The match we just played at Loftus (on October 17) when we beat then 2-1 we played 3-4-3.

"It is so easy to spill poison rather to spread something that is progressive. "How I wish we could say right stuff for our people to pick up on the positives of the game.

"We are building a product there, the PSL, that we must be proud of. We are all eating from this table.

"I get my pay cheque from this. All of us need to protect this industry and then we can go places.

"But we seem to be kicking the very same table we are eating from. It's amazing," said the Chiefs coach, who has yet to win a trophy in his third year in charge of the Cup kings.






Sifiso, Tanele are United General Insurance National Championship champs


