

THREE men suspected to be rhino poachers were shot and killed on Saturday at Hlane Royal National

The men are said to have before their death exchanged fierce fire with the Royal Swaziland Police (Lukhozi Unit) and Big Game Parks rangers deep within the park.

Two of the killed alleged poachers are



believed to be from South Africa.

Police Chief Information and Communications Officer Khulani Mamba confirmed the death of the three suspected poachers after an exchange of gunfire.

"It was a joint operation between the Royal Swaziland Police and Big Game Parks after we responded to a tip-off about a possible poaching scare at the national park and they were found deep inside the park when the fire exchange began," Mamba said.

He added, however, that the identities of the deceased persons have not yet been confirmed.

"We can confirm however that no rhino was harmed during the process, the Royal Swaziland Police and Big Game Parks managed to save the rhinos as they acted on the tip off earlier, so we outsmarted them," he added.

The bodies of the deceased are currently kept at an unknown mortuary.

MAID INSISTS SHE WAS TRAFFICKED TO LONDON

Kingdom FORMER United Commissioner Dumsile Sukati's one time maid Zanele Shongwe stands by her stance that she was trafficked to London.

In an eight-page letter written by the maid in response to the former UK High Commissioner's submissions to the Public Accounts Committee (PAC) where she had to answer why government had paid Shongwe over E90 000 long after she had stopped working, Shongwe said it is not true that government overpaid her and that the former minister wasn't aware that she was being paid for doing nothing. Shongwe explains why she has been quoted saying Sukati trafficked her and she maintains her stance on that issue. Shongwe states that she realised she was trafficked

when she allegedly asked Sukati about copies of a visa application she had stumbled upon. Narrating in her letter, Shongwe alleges that the visa application, it seemed, was made on her behalf and it had a signature which was supposedly hers but she had never seen or signed these papers. She said she realised then that her signature had been forged.

Contract

"I stumbled across copies of the visa application/contract, which was made on my behalf stating that I am being paid £12 000 per annum with a bonus of £300 rising to £15 000 per annum with a bonus of £300. That then occurred to me that the signature on the application form which was submitted to the home affairs office by the High Commissioner didn't bear my signature. It dawned on me that the application form was completed and signed by someone, so that I may not be aware of the money I was supposed to have been paid since the first visa was renewed in 2012 as the application form is attached with a new contract to be filled up with a pen. I consider that this was exploitation of labour and a fraudulent activity by the embassy," she narrates. The former maid alleges that when she approached Sukati seeking an explanation on the papers she had stumbled upon, she told her that she should speak to her employer about this as she was only her line manager.

She alleges that she then approached the then minister of foreign affairs and international cooperation who said she was not a civil servant but Sukati's relative who was also her domestic worker.

"Who really was my employer? Hence I call it human trafficking," she said.

She substantiates her stance by narrating how Sukati allegedly convinced her parents that moving to the UK with her





SENIOR OFFICIALS IMPLICATED IN E291 000 STATIONERY THEFT

SOME senior officials in the ministry of education and training have been implicated in the theft of stationery worth E291 244 from the Lubombo regional education offices.

The theft of various text books is said to have taken place between 2016 and 2017.

A groundsman, Thembumenzi Dladla was arrested in connection with the theft of the books.

He was charged with two counts; that of house breaking and theft.

In the first count, he is alleged to have wrongfully and intentionally

broke and entered into the ministry's

He is also alleged to have committed a similar offence in February 15, 2017 wherein he is said to have stolen text books worth E192 074.

The accused person, who is represented by Lawyer Mzobanzi Dlamini, was back in court last week for com-

mencement of the matter.

When the charge sheet was read to him, the accused pleaded not guilty to both counts. The crown then called in witnesses to prove commission of the offences. First to present evidence was one Musa Tfwala who is the inspector of primary schools in the region. During his evidence, Tfwala told the court that only a few senior officials were allowed to enter the storeroom which kept the books alleged to have been stolen.

He also stated that however, the accused person was also allowed to enter the storeroom to conduct his cleaning duties, but under close supervision

The witness however did not mention any break-in incident which is

alleged to have taken place at the storeroom.

Through impeccable sources, it has transpired that however, the alleged theft of the text books was collaboration between some senior officials within the same office and a principal from one of the privately owned schools in the Lubombo region.

This however, is information which has been gathered outside of the court proceedings. Evidently, the evidence presented by the first witness seemed to have been in favour of the accused person as there was no mentioning of an incident whereby the storeroom was broken into.

The matter was eventually postponed and is expected back in court today.

Swazis safe in Qatar - govt

THE ministry of foreign affairs and international cooperation has allayed fears amid the diplomatic scandal that has rocked Qatar.

Qatar was in recent days rocked by a diplomatic scandal following a recent hack of the country's state-run news agency. The Qatari government has called the information that was leaked 'fake' saying their agency was hacked.

Qatari emir Sheikh Tamim bin Hamad al-Thani allegedly criticised Saudi Arabia on state media outlets while calling for improved ties with Iran

Ministry of Foreign Affairs Principal Secretary Joel Nhleko when asked about the safety of Swazis in that country amid the crisis said the nation must calm down as they were closely monitoring the situation.

He said Swazis in that country were currently safe. "We have touched base with our embassy in that country and they have assured us that Swazis in Qatar are safe, they had nothing to fear just as yet," he said.

Nhleko explained that they had called to find out how safe the diplomats were and the rest of the Swazis living in the country.

"We have also contacted the government, through their embassy in the country to find out about the chances of the situation there being a danger to Swazis living in Qatar and they have also assured us that there is nothing to worry about," he said.

Nhleko said they would continue assessing the situation by being in close contact with both the country's embassy in Qatar as well as the Qatari government to make sure that Swazis are safe at all times. He emphasised that as it stands there was nothing to fear and Swazis must keep calm.

"Swazis are safe, there is nothing to fear, we are monitoring the situation," he said.

The scandal that rocked Qatar over a week ago has seen five Arab countries; Bahrain, Egypt, United Arab Emirates, Saudi Arabia and Yemen cut diplomatic ties with Qatar and have recalled their diplomats in that country; they have also given Qataris living abroad 14 days to return home. Regional airlines have also suspended services to Doha.

69 ARRESTED FOR DRINK-DRIVING

THERE were 69 drink-driving cases recorded by members of the Royal Swaziland Police (RSP) over the weekend.

These cases were recorded in all four regions of the country from last Friday to yesterday, announced Chief Police Information and Communications Officer Khulani Mamba.

Mamba said most of those arrested had already appeared before the different Magistrate's court in the country while others will appear this morning. He added that generally it was a calm weekend as there were no major incidents reported over the weekend. He said there was only one fatal accident in the police records which happened along Luyengo/Malkerns public road at Emseleni this past Saturday.

He said a Mercedec Benz Sprinter driven by a 19-year-old man of Gundvwini knocked down a 58-year-old man of Hluthi.

The pedestrian sustained serious injuries and was rushed to RFM Hospital, where he was certified dead on arrival. The driver has been charged with Culpable Homicide and will appear at the Manzini Magistrate's Court today.

ASHRAFF INDISPOSED, CASE FAILS TO RESUME

THE civil case in which Indonesian Consul Kareem Ashraff has filed an urgent application seeking the court to issue an order to evict two directors from GIGATECH Investments out of his premises was postponed because the businessman was indisposed.

This was after lawyer Lindifa Mamba, representing Ashraff, informed Judge Sipho Nkosi that his client was indisposed and could not make it in court.

The judge postponed the matter to this week for continuation as both counsel Mamba for Ashraff and Sabela Dlamini for GIGATECH Investments were still making submissions when the court last adjourned.

Ashraff has run to court where he is seeking an order to eject thecompany and its directors from his property in Matsapha.

He wants GIGATECH Investments, a technology company, together with its directors George Fetbia and King Collin, ejected from the property which is situated within the industrial hub of the kingdom.

According to Ashraff, who owns a number of properties in the country, he entered into a lease agreement with the two directors sometime in 2007 and they signed a two-year lease which was renewable for a year in 2009.

He had told the court that he got to know the directors through a friend who advised that the two High Court Judge Sipho Nkosi postpones case as Indonesian Consul reported sick

were specialists in technological equipment and they wanted to secure a domicile where they would operate their business.

"They told me that they had done business with the ministry of health and were to secure another business deal through a South African based company. Since I have assisted a number of people financially, I had no problem in assisting the two whom I offered my property for lease," Ashraff had earlier told the court.

When asked by his lawyer on whether they had agreed on the purchase of the property, Ashraff replied to the negative, stating that never at any stage had he reached such an agreement.

This was after the directors had, as having instructed their lawyer Dlamini, put it to Ashraff that he had infact reached an agreement with the two to the effect that the money they would have spent in rentals would be almost equivalent to that of purchasing the property.

However, Ashraff vehemently denied this, stating that there was no way he would have agreed to such. Giving evidence further, he told the court that what has now brought him to court is the fact that GIGATECH Investments and the two directors have not been paying for the property in question since they signed the lease agreement.

"Although I have not had occa-

sion to inspect the inside of the property of late, I, however, noticed that the outside is in a dilapidated state and needs renovations, while the yard now has overgrown grass all over," Ashraff said.

Adjacent

The property is a three-bedroom house, and a servants quarters which is adjacent the same plot which Ashraff stated that Amani Family Trust in where he is a trustee, has been paying rates till today while GIGATECH and the two have been contributing nothing.

He now wants the company and the two, who are also using the servant's quarters as their home while the three-bedroom house is used as a business domicile, to be ejected henceforth, as a result he filed the application before court, seeking an order to that effect.

The two businessmen who approached Ashraff, had nowhere to stay nor work in, hence he gave E20 000 financial assistance to them and the property.

With the view that they would work together as Ashraff said he has had a good working relationship with government, he offered them the money and the property where business was expected to be carried out.

This he did as he had anticipated a good working relationship with the two and their company.

However, upon realising that the two were no longer living up to their promises, Ashraff said he decided to release them from the partner-

They had informed me that they were also working closely with a dentist in Manzini, who had promised that a South African based business was bringing in a 95 per cent business offer they would enter in with the ministry, but this never happened.

Having assisted a lot of Swazis in realising their dream, he said he had no problem with assisting the two as they had displayed trust when they approached him.

The matter is before Judge Nkosi for argument and the director's defence had not finished cross examining Ashraff, at least by the time this report was compiled.

Local govt elections; some candidates already campaigning

AS registration for the local government election continues, some aspiring candidates are said to have already started campaigning, something against the elections rules and regulations.

Voters' registrations started early last month, and will be concluded at the end of this month.

Residents within urban boundaries have been raising concern about the on-going process, saying it has been made complicated by the list of requirements. Apparently, residents are required to produce tittle deeds, proof of residence, affidavits (for tenants) and, or trading licences as part of the long list of requirements.

Meanwhile, some aspiring councillors complained that others have started campaigning and are assisting residents to compile the required documents for registration.

In fact, some are said to be also hosting parties for eligible voters, especially those living under organised settlements such as police officers, teachers and nurses. Apparently, most civil servants in Siteki are eligible voters as the government of the six wherein they are accommodated fall within the boundaries of the town. The aggrieved aspiring councillors are of the view that campaigning at this stage of the election process is prohibited. They have blamed the ministry of housing and urban development which have been mandated by the Elections and Boundaries Commission (EBC) to overseer the elections. Speaking during separate interviews, the aspiring councillors pointed and itiwas expected that the ministry would conduct voters' education before the beginning of the registration process. "It seems there will be chaos during the elections since some people are literally buying votes already, and you cannot blame them since the regulations are not known as yet," said one Sabelo Maziya. Meanwhile, the registration process is said to be going smoothly as a considerable number of people have already registered.

Micro-Projects funds E2.7m roads for Moneni, Lwandle

AFTER being involved in a land dispute which has seen Moneni and Lwandle areas not benditing from development projects, Micro-Projects is bringing a road project worth E2.7 million.

The project was officially handed over by Manzini South Member of Parliament (MP), who is also Minister of Public Service Owen Nxumalo and Paul Mwekhio, Micro-Projects representative.

Pots Construction has been contracted to undertake the project, which also

involves the re-gravelling and paving of a stretch of road from Moneni to Lwandle area. Speaking during the handover on Friday, Nxumalo said as parliamentarians, they requested that Micro-Projects take a developmental role in the area.

This is not the first project that has been undertaken in Manzini South as there have been low level bridges and a community hall, which have been built at Lwandle.

The community was ecstatic about the development as they stated that transport was scarce in the area, more especially when it was raining as the road become slippery.

Ndiphethe Dlamini, who is Bucopho

of the area, stated that as community members, they will work hard to ensure that the road is well looked after.

Meanwhile, Pots Construction Director Sanele Mashwama, who was also present during the handover, stated that they expected to finish the project in threemonths.

He said the project would be done in phases.

Nxumalo emphasised that the contractors should hire local labour and urged community leaders to provide support for the project. This project has been hailed as one of huge magnitude when it comes to road projects that are financed by Micro-Projects in all the tinkhundla in the country.

VICTORY FOR NURSES ASSISTANTS AS GNT, SNA REACH AGREEMENT

GOVERNMENT Negotiating Team (GNT) and the Swaziland Nurses Association (SNA) have reached an agreement that will see nursing assistants being afforded equal relevant training and development opportunities in line with the government In-Service Training and Development Policy.

This was confirmed by a collective agreement signed by Principal Secretary (PS) in the Ministry of Public Service Evart Madlopha on behalf of GNT and Swaziland Nurses Association President Bheki Mamba last Friday.

Such a development comes after a petition which was delivered to the prime minister that demanded that nursing assistants be allowed to further their studies without them having to resign.

The petition said there must be an improved quota for nurses who are allowed to train utilising in-service, not the three per year that have been seen previously, which according to nurses is an insult to the profession. According to a document released by Sibusiso Lushaba who is Swaziland Democratic Nurses Union Secretary General on May 17, GNT together with SNA commenced discussions to address concerns raised by SNA through a petition deliv-

ered to the premier's office and consequently an Industrial Court Order. The document states that training for nursing assistants was one of the concerns raised through the petition which the Industrial Court directed for both parties to resolve in negotiations.

After negotiations, the parties according to the document agreed that nurs-

ing assistants were nurses, recognised and regulated by the Swaziland Nurses Council.

It was also agreed that nursing assistants are public civil servants and shall be afforded equal relevant training and development opportunities in line with government's in-service training policy.

SNAT members to accompany executive to GNT meeting

MEMBERS of SNAT will on Wednesday accompany their executive to meet with the Government Negotiating Team (GNT) to discuss the issue of finalising the salary review exercise.

This comes after negotiations failed to continue last week between the two parties.

SNAT is the Swaziland National Association of Teachers.

This past Saturday during an extra ordinary meeting held at the SNAT centre, members were informed that the GNT continued to frustrate and to impede the salary review exercise, with the pending issues being appeals and allowances.

The members were informed that appeal process was supposed to start by November, 2016 and the nine months that were initially planned for this exercise would end in August this current year.

During the meeting it was agreed that the executive would meet with the GNT last week.

However, just like last time SNAT Secretary General Zweli Mndzebele said the negotiations could not proceed as government continued to maintain its stand of refusing to recognise the existence of the National Public Servants and Allied Workers Union (NAPSAWU).

It was stated that there were no engagements that were made between the GNT and PSAs with regards to allowances since government refused to sign a deadlock claiming she does not know NAPSAWU.

Mndzebele said even last week, there was nothing which was done as government stated that she was dealing with the NAPSAWU issue.

Mndzebele said last Wednesday, the executive team would go with SNAT members to the negotiations and the members would be outside to get feedback on the negotiations as they progress and will decide there what the way forward is

The issue of government refusing to acknowledge NAPSAWU existence has also hindered the negotiations on the Cost of Living Adjustment (COLA) for the previous year 2016/17 since a new government financial year has started. This has not happened as according to SNAT executive GNT arguing that she is still finalising bilateral issues with NAPSAWU. According to a statement made by Deputy Secretary General of SNAT Sikelela Dlamini the delaying tactics by GNT are a well calculated move to frustrate SNAT members so that by the time the negotiations ensue, they are ready to take anything that she offers without further scrutiny.

Dlamini stated that the cost of goods and services is unbearable and there is a need to compensate members for the erosion they suffered.

SAVING ON YOUR ELECTRICITY USAGE THIS WINTER

Saving electricity at home has become increasingly important in recent years. Using electricity without regard to conserving energy contributes to global warming and leads to massive electricity bills. Choosing your appliances wisely, being mindful of your energy consumption habits, and getting creative with household chores can help save money and give you the peace of mind that comes with knowing you're doing your part to reduce strain on the environment. Below we look at some of the "DO IT YOURSELF" tips that you can practise in order to cut down on your electricity spending;

Use more natural lighting. Do you tend to keep the curtains and blinds closed and flip on the overhead lights? Letting your house flood with natural light instead can lead to big electricity saving. Unless you need strong, focused light to complete a particular task, try leaving the lights off during the day and embracing the sun's rays in the rooms you're using.

- Try to set up your family's daytime work and play space in the brightest room in your house. That way everyone can read, work on art projects, use computers, and so on without relying on artificial lighting.
- Use light-coloured curtains and blinds as window coverings. Find coverings that provide privacy but still allow diffused light to flood your rooms.

Use energy-efficient lightbulbs. Replace all of your incandescent bulbs with compact fluorescent bulbs (CFLs) or LED bulbs. Incandescent bulbs release most of their energy through heat, rather than light. Newer bulb styles are much more energy efficient, and they save a lot of

electricity and money over time.

- CFLs use only about 1/4 the energy of incandescent bulbs. They come in many shapes and styles. Be sure to dispose of these bulbs properly, since they contain small amounts of mercury.
- LED bulbs are slightly more expensive than CFLs, but they last longer and don't contain mercury. LED bulbs are slightly more efficient than CFLs. If you like the ability to customize your environment, LED bulbs come in multicolour and dimmable variants.

Unplug everything. Did you know that appliances and electronics continue sapping electricity as long as they're plugged in, even when their switches are turned off? Making a habit of unplugging these items when they aren't in use saves a lot of energy over time.

- Power down your computer and unplug it when you aren't using it. Computers are one of the main culprits when it comes to using a lot of energy in a household, so unplugging them when you're finished checking your email for the night is worth the hassle.
- Unplug your TVs, radios and sound systems. Leaving these plugged in day in and day out is a waste of electricity and money.
- Don't forget smaller appliances like coffee makers, toasters, hair dryers and phone chargers. These use small amounts of energy, but it really adds up over time.

Insulate your house. It's important to make sure your house isn't releasing too much air-conditioned air during the summer or heated air during the winter. If you have cracks in the frames of your windows, under your doors, in your

houses basement or foundation, in the attic, or anywhere else in your home, you may be leaking electricity and money.

- Have a contractor inspect your home to determine whether additional insulation may be needed.
- Use caulk and door seals to seal the areas around your window and door frames. You can also buy plastic sheeting to cover your windows during the winter

Keep your house at a lower temperature in the winter. You can save a lot of money by turning the thermostat a few degrees lower during the winter instead of heating your house until it's toasty. Set it just low enough so that you're still comfortable while wearing thick layers of clothing. Wear wool socks and sweaters to keep warm instead of relying on your home's heating system.

How can I create awareness regarding the waste of electricity?

Talk to your family, friends and classmates about the issues with electricity usage in the home and classroom. Talk to them about how standby mode still consumes power, about the need to use efficient light bulbs and about needing to put appliances on timers rather than forgetting to turn them off. It's the little things that add up and count long term.

"I think it saw me long before I saw it, so it then escaped into the water and all I saw was its fat body all the way up to its tail. I did not see its head and I thank God for that

because I would know no sleep if I saw the head. With my neighbours, we once heard the snake move outside at night during our sleep," the employee said.

Another Plantation Forestry Company worker said the snake in question must be at least two metres long.

Another plantation worker confirmed that the snake was living near the water as weeks before, he had seen dogs which patrol with the local security guards barking wildly at the water.

Mbuso Shiba a ranger at Big Game Parks, said the workers should first try identify the snake and then call them to remove it.

"The only snake that is protected in Swaziland is the python. If it is indeed a python, then we will come and remove it without hurting it,"

MALAWI MOVING SWIFTLY TO COMMERCIALISING GMO CROPS

MALAWI stood out as one of a few African countries already on the brink of commercialising genetically modified crops (GMOs) where it is now monitoring nine varieties in the controlled field trials growing cotton, cowpea and banana.

Participants at a three day COME-SA/ACTESA communication training workshop for media practitioners on biotechnology and biosafety held in Lilongwe, Malawi this week were told that that country passed the Biosafety Act in 2002, biosafety regulations in 2007 and the National Biotechnology and Biosafety Policy came into effect in 2008.

On the other hand Swaziland is among six countries that conducted location trials in preparation for general release approvals. Burkina Faso (cowpea), Ethiopia (cotton), Ghana (cowpea), Nigeria (cowpea and sorghum), Swaziland (cotton) and Uganda (banana and maize).

A year after the second decade of commercialisation of biotech/GM crops in 2016, a total of 18 million farmers in 26 countries grew 185.1 million hectares of biotech crops – an increase of 5.4 million hectares or three per cent from 179.7 million hectares in 2015, says the 2016 Global Status Report on Biotech crops launched in Malawi last Wednesday.

Malawi has a biosafety regulatory committee that discusses applications for trials, and a biosafety registry office both institutions that saw the country progress with trials of three different genetically modified crops, which are now at different stages, as Malawi gears up for commercialising GM crops. Bt cotton is at the variety registration trial stage, while Bt cowpea is in its second year of confined field trials (CFT) and virus resistant banana is in its first year of CFTs at proof of concept stage.

The trials are being conducted in nine field sites in all the regions of the country. At a filed visit last Tuesday participants learnt that farmers were already

upbeat, demanding a rollout of the seed. Despite major strides in combating hunger over the last 30 years, 800 million people go to bed daily on an empty stomach, and there are 40 000 hunger-related deaths every day. This 'silent holocaust' is 'unconscionable', pleads Ismail Serageldin of the World Bank. Mahatma Gandhi, the apostle of peace, called hunger the greatest of all violence.

Worldwide, one in three children is underweight, and one in five is stunted due to undernourishment. Nearly 40 000 people - half of them children - die every day due to hunger related causes. By 2020, the number of undernourished could well surpass 1 billion.

In many developing countries, where subsistence farmers eke out meager livings, and the ability to provide enough food for survival is often less than assured, the vital importance of staple AgBioworld asserts that crops such as rice, sweet potato and cassava cannot be overstated. In many places, the loss of a crucial crop to pests, diseases or weather can mean the difference between

life or death, straining the resources and threatening the well-being of entire communities.

In rapid succession, the leading scientists around the world are attesting to the health and environmental safety of agricultural biotechnology, and now they are calling for genetically modified crops to be extended to the people who need it most - hungry people in the developing world. More than 2 900 eminent scientists, including three Nobel laureates, have signed a statement of support. Expert panels with the World Health Organisation, the Food and Agriculture Organisation of the United Nations and the Organisation for Economic Cooperation and Development have made strong statements supporting the safety of the crops. Numerous scientific societies are passing proclamations

And just last April, six national science academies (U.S., Britain, Brazil, China, India and Mexico) and the Third World Academy of Sciences, issued a joint statement, not only endorsing biotechnology but urging companies,

governments and charities to extend it to the developing world.

The need for new technologies is great, as the seven academies describe:

"Today, there are some 800 miltion people who do not have access to sufficient food to meet their needs."

"Malnutrition plays a significant role in half of the nearly 12 million deaths each year of children under five in developing countries."

"In addition to lack of food, deficiencies in micro-nutrients (especially vitamin A, iodine and iron) are widespread."

"(Global climate change) and alterations in land use will exacerbate the problems of regional production and demands for food."

"In developing countries about 650 million of the poorest people live in rural areas where the local production of food is the main economic activity. Without successful agriculture, these people will have neither employment nor the resources they need for a better life Farming the land is the engine of progress in less developed countries."

Similarly in Swaziland after frequent visits to trial fields in both Malkerns and South Africa farmers, especially cotton farmers, are already calling for a speedy distribution of the Bt cotton seed. This followed facilitations by the Swaziland Cotton Board to engage all stakeholders including members of Parliament who must fastback the legislative aspect of things.

Juris Manufacturing management, employees moving on after chaos

GRIEVANCES which led to chaos a couple of months ago at Juris Manufacturing, one of the textile companies in Nhlangano are being attended to by management.

Already there are signs that both parties will soon reach an understanding

The close to 2 000 employees went berserk a few months ago where they also attacked management and assaulted one of the senior managers who was stabbed in the process.

The chaos which lasted for days saw all operations coming to a halt and almost led to a catast ophe as even the company's properties as well as the buildings were vandalised. It is said while the misunderstanding was sparked after some of the employees had an altercation with one of the senior managers who was planning to fire them; it is believed the other reason for the chaos was related to the working conditions the employees were subjected to. Claims are that the setup in the company was against labour laws.

Now, it is said grievances that the employees raised after the issue was reported to the relevant bodies such as the labour department, there is tangible change which is something the employees appreciate. The employees who all along were given 30 minutes as their lunch period, now have a full hour for lunch.

Again, as all this time the employees were not allowed to move out of the premises for their lunch, such has also been given attention as now they are allowed to leave the premises to have their lunch anywhere but expected back at work on time.

Employees interviewed said the changes were now being implemented adding that they commended

such a move.

"Even the delay on our salaries, we have been assured that it has also been given the attention it deserves. It's a clear sign that the riot we staged worked to our advantage even though we do not condone it. Management should learn to address issues affecting us at their infancy stage. We were pushed to a corner to demand what we feel is our right as employees," said one of the leaders of the employees.

On the other hand, the union Amalgamated Trade Union of Swaziland (ATUSWA) leadership said even though there was nothing official communicated to them that things were now in order at Juris Manufacturing, it was encouraging to learn that progress has been made in addressing some of the grievances.

ATUSWA Secretary General Wonder Mkhonza said they had ears on the ground regarding what was endorsed as a way forward at Juris Manufacturing. He said since there has been no other riot after the one which brought the company on its knees, he was of the view that all parties were now moving on the same direction.

"Nothing has been communicated by our office in Nhlangano which could need our attention as ATUSWA. This means all is well as we did tell our officers that should they have a problem, they should not hesitate to contact us. It looks like all is fine and this is what we expect in a working environment. Employers should listen to their employees just like they (employers) expect the employees to listen to them," said Mkhonza

Mkhonza said it was however not the right time to celebrate whatever progress had been made at Juris Manufacturing up until as a union they were convinced that the issues were really addressed.

Health centre fails to take off at Mashayikhatsi

A health centre project which was blessed by His Majesty King Mswati III has failed to take off at Mashayikhatsi and many are concerned.

The decision to have the health facility constructed came about after it was found that the New Haven Clinic's state was no longer up to standard and no longer good enough in providing the necessary health service to the public.

The launch of the project where His Majesty was represented by Princess Tsandzile took place towards the end of last year.

Private Secretary to His Majesty Mbongeni Simelane who was also one of the speakers remarked how the country's leaders are eager to see the project materialising.

Witness
Also present to witness the sod cutting which meant the beginning of work included Minister of Health Sibongile Simelane as well as Shiselweni Regional Administrator Themba Masuku who was tasked to ensure that the project was implemented.

Regional Secretary Zwakele Dlamini was also present.

Neighbouring chiefs such as Chief Velebantfu attended the ceremony where the gathering was informed that this was a project blessed by the highest authority in the land and no one was therefore expected to question it and its location.

Architects also came to display the designs of the health facility whose cost amounts to millions of emalangeni.

Sandleni MP Jameson Simelane was also present and many other dignitaries.

It is however a concern to others now as to why a project of this magnitude is still not taking off and most importantly, after it received blessings from the country's leaders.

The New Haven Clinic is now many years old, its ceiling walls are in a total

mess and everything is congested and falling apart.

MP Simelane said he was not sure as to what exactly has caused the delay of the project. He said such a project was important as it would help have the communities of the relevant chiefdoms receive the required health services than having to travel long distance.

Answers

"I may not have answers as to what is delaying the project but I am optimistic that it will materialise more especially that the site where it is earmarked received blessings from His Majesty. Others may want to politicise the project by questioning its urgency and if it is a priority but the bottom line is that when something has received blessings from the country's authorities, no one should debate that," said MP Simelane.

On the other hand the RA said he was optimistic that the project would definitely be implemented.

"I don't want to believe that there can be someone politicising such a project. Politics versus service delivery, I think one should know which should win. If the health facility is not there, it means there is also going to be no service delivery. Service delivery is needed at all costs especially when taking into account that as a country we are eyeing the 2022 vision," said Masuku.

Construction

On that note, Minister of Health Sibongile Simelane said the construction of the health facility would definitely take place. She said she was not aware of any talks or plans to block it or anyone politicising it.

"There are many things involved and it's a process to have this kind of project started. Tendering as well as many other requirements should be in place before seeing the actual work such as putting up the structures and infrastructure. I don't have even the slightest doubt as I am fully confident that the health facility at Mashayikhatsi will definitely take off the ground. There are similar projects which also have taken time to be implemented and such is usually caused by many factors," said Minister Simelane.

GOGO (89) ABUSED BY OWN CHILD, SLEEPS IN CHICKEN DEN

AN 89-year-old woman is being forced to sleep inside a chicken shed by her 41-year-old abusive son.

Timphisini Constituency Headman Makhelekehlane Matfunjwa said Gogo Melleny Ndawe has been living in the chicken shelter for seven years, however, she refuses to report her son to the police for abuse.

"The abuse that the old woman has been forced to endure at the hands of her own son Mpiyakhe Shiba is just too much. She tells me that she is regularly assaulted by her son when he comes home drunk in the evenings, and this started in 2011," Matfunjwa

Ndawe, who lost her husband in 2002, had three children; two girls and one

The girls, after completing school, went to live and work in Matsapha and Shiba went to South Africa to look for a job.

He returned in 2011, and started demanding money from his mother.

When he was visited by his girlfriends, he would tell his mother to move out of the bedroom as he wanted to use it. "At first Ndawe would sleep inside

it, but Shiba then started locking the kitchen as well as the bedroom, forcing his mother to sleep with the chickens. Shiba would leave the homestead for a whole week, locking the food away from his mother who will be helped by neighbours who pitied her," said Matunjwa.

Imprison

When interviewed, Ndawe said she did not want the police to imprison her only son. "I am just waiting to die, I rely on handouts from generous residents to survive. I do not know what is wrong with my son, he gets violent when he is drunk, like his father.

Money

He hits me when I have no money, I do not want him to go to jail as this will leave me all alone," said Ndawe. Meanwhile, Timphisini Member of

Parliament (MP) Apton Ndlovu said

some of the abuses that go on at the area were horrific and deserved media attention.

"I have told the headman in the area to help the community by alerting us of any abuses that may be going on. We cannot always help people if we do not know what is going on, unfortunately some of the abuses are never reported," said Ndlovu.

On that note, Acting Police Public Relations Officer Assistant Superintendent Phindile Vilakati said they were open to dialogue and mediation. "We sometimes understand that there are situations when a victim does not wish to open a criminal case against an individual for whatever reason. In cases like those, we then mediate the situation and open dialogue between the affected parties; this is a very good way of controlling and sorting out situations amicably," said Vilakati.


SENATOR NDUMISO MDLULI HAILS KING



#GUPTALEAKS: HOW CAPTURED AMBASSADOR LOBBIED THE DUTCH

JOHANNESBURG - The government official who helped the Guptas obtain permission to land a private jet at Air Force Base Waterkloof has been using his position as South Africa's ambassador to the Netherlands to negotiate business deals on behalf of the controversial family.

New information from #GuptaLeaks indicates that Bruce Koloane, who got his diplomat job after being suspended as chief of state protocol at the department of International Relations and Cooperation (DIRCO), also forwarded information on the base directly to Gupta lieutenant Ashu Chawla around the time of the 2013 Waterkloof debacle.

The #GuptaLeaks also show that:
• Koloane, appointed as ambassador to the Netherlands in August 2014, met with Dutch businessmen in The Hague in 2015 to negotiate a deal with a manufacturer of greenhouse

systems on the Guptas' behalf;
• Koloane's friends were allowed to stay at the Guptas' upmarket private game lodge in Limpopo around the time of the negotiations with the Dutch greenhouse company;

 Koloane sent Chawla documents on a prospective coal mining site in KwaZulu-Natal in the midst of the Waterkloof fallout; and

• He attended the Gupta wedding at Sun City and stayed at the resort for three nights.

The Dutch Deal

Correspondence between Koloane, the owners of Dutch company KPG Greenhouses and Rajesh "Tony" Gupta suggests Koloane used his position as ambassador to help the Guptas clinch business deals in the Netherlands. In July 2015, KPG Greenhouses' Marco van 't Hart sent an email to Koloane's official embassy email address and CCed Herman van der Kroef, the department of trade and industry's representative to the Netherlands, in the email.

"Thank you for visiting our company in Maasland. In the meeting you asked if we would consider to sell our company for at least 50 per cent and if we would be interested to start a production site in South Africa," he wrote.

It is clear from the email that Koloane and Van der Kroef were representing someone else's interests during their visit to the company, situated a 30-minute drive away from the South African embassy in The Hague's city centre.

"...for this your investor can better talk too Mr Koppert himself (sic)," wrote Van der Kroef, referring to KPG Greenhouses' owner, André Koppert.

A day later, Koloane forwarded the email to Tony, the youngest Gupta brother, saying, "As promised".

Koloane's bidding set in motion protracted negotiations between Tony Gupta and Koppert, although it is not clear from the emails whether a deal was clinched.

Later in July 2015, Koppert emailed

Tony Gupta to enquire about the family's intentions and Gupta replied: "Dear Mr Andre, thanks for your mail. Our group is very diversely invested eg OAKBAY resources, Sahara computers, JIC mining services, The new age newspaper etc. we are looking to invest in agriculture sector (hydroponic) so we are looking to takeover or invest in your company also... (sic)."

But Koppert apparently was not keen to sell such a large stake in his company.

He did, however, suggest that KPG Greenhouses and the Guptas explore opportunities together to invest in a greenhouse manufacturing facility in South Africa.

Tony Gupta, though, was not overly excited by this offer, responding in late July 2015:

"Honorable Mr. Koppert, thanks for your mail and sorry to delay my reply. I will not be keen for your below mention idea... Once again thanks (sic)."

Tony Gupta and Koppert kept in touch throughout August and September to try to set up a meeting, but it is not clear from the emails whether they ever did.

News24 contacted Van 't Hart on WhatsApp this week. He said he was in a meeting, but did not respond to later queries. Koppert did not respond to phone calls or messages.

'Brother Tony'

A month after Koppert and Gupta had exchanged emails, Koloane again made contact with a member of the Gupta business network, this time to help two of his friends score a weekend stay at the Guptas' luxury Clifftop Lodge in the Welgevonden private game reserve in Limpopo.

"Please find forwarded an email confirming arrival dates for my friends from the USA.

Brother Tony has asked that I forward you the info so that you can make arrangements at the Lodge for a game visit. (One couple) Please check with him on this matter and confirm reservation with me by email and please copy Chelsea Jennings as

well (sic)," Koloane wrote to Chawla in August 2015, using his Yahoo email account.

A few days later, Chawla responded to Koloane with an email that included a PDF document for the booking at the lodge, saying:

"Dear sir. As discussed here is the booking attached for your reference (sic)."

The document indicates that Jennings and her partner stayed at Clifftop for two nights in September 2015. Their stay included three meals and two safaris and from the booking it appears that they were not charged.

Koloane's relation to Jennings is unclear from the emails.

News24 sent queries via WhatsApp to a cellphone number she included in an earlier email to Koloane. The messages appear to have been read, but Jennings did not respond.

Coal Asset

In October 2013, barely six months after Koloane helped the Guptas secure the Waterkloof landing, he received documents from one Funokwakhe Cedric Xulu detailing a study done on a prospective coal mining site near Empangeni, KwaZulu-Natal.

The study was conducted at Xulu's request by Pietermaritzburg scientist Chris Whyte, and details the viability of coal mining in the Mpisi prospecting area. Koloane subsequently forwarded the study and other documents on the Mpisi coal reserve to Chawla.

"Dear Ashu. Please find attached a geological report for a coal asset as discussed with Tony," wrote Koloane. The #GuptaLeaks trove shows that Chawla eventually forwarded the documents to Tony Gupta in March 2014. Whyte confirmed he had compiled the study and was commissioned by Xulu. He said he had no idea the report would end up with the Guptas.

Xulu did not respond to an SMS and did not answer his cellphone.

Back to Waterkloof

The #GuptaLeaks contain further details about Koloane's direct communication with Chawla during the planning of the Waterkloof landing of the chartered Jet Airways plane carrying guests to the Sun City wedding of the Gupta brothers' niece, Vega.

In February 2013, Chawla emailed Koloane, then chief of state protocol:

"As discussed can you please get me the following info regarding the Waterkloof airport. We would need the following information for us to plan any operations to Waterkloof airport. All charts for operation (airfield charts, SID/STARs if any, ILS/VOR/NDB approach charts) under Instrument Flight Rules (IFR) (sic)"

On March 20, former air force official Christine Anderson sent Koloane an email discussing operational matters at Waterkloof:

"AFB Waterkloof ILS/VOR (WKV) is out of service form 4 March 2013 until the end of April 2013 for a new system. In bad weather aircraft must plan to divert. SID/STARs will not be able to perform when ILVS/VOR is unserviceable (sic)."

Koloane then forwarded her message to Chawla.

According to the string of emails, a "flight information manual" for Air Force Base Waterkloof was also sent to Chawla by a Sahara Computers employee called Sandeep.

But this exchange only occurred in June of that year, after Vega Gupta's wedding, and it is not clear whether this document originated from Koloane.

A spreadsheet containing the names of about 260 guests for Vega Gupta's wedding at Sun City also suggests that Koloane attended the lavish affair, and spent three nights at one of the resort's hotels with an unknown guest. According to the document, which appears to reflect invitees who had RSVPed by April 22, "Vusi B Koloane" was marked as "attending".

The spreadsheet indicates he and a partner were to stay at Sun City for three nights.

News24 made numerous attempts to obtain comment from Koloane and from Dirco spokesperson Clayson Monyela, but no responses were forthcoming.

IT'S COLD OUTSIDE ZUMA'S ANC

IN the liberation struggle against apartheid, a small number of white people joined the battle to overthrow the South African regime.

One of them, academic Raymond Suttner, was first arrested in 1975 and tortured with electric shocks because he refused to supply information to the police. He then served eight years in prison because of his underground activities for the African National Congress and South African Communist Party.

After his release in 1983 he was forced - after two years - to go underground to evade arrest, but was re-detained in 1986 under repeatedly renewed states of emergency for 27 months - 18 of these in solitary confinement. First published in 2001, Suttner's prison memoir 'Inside Apartheid's Prison', has been made available again, now with a completely new introduction. The Conversation Africa's Charles Leonard spoke to Suttner.

Why did you write the book? I was hesitant to write it because there is a culture of modesty that is inculcated in cadres. I used to think it was "not done" to write about myself. I also thought that my experience was a "parking ticket" compared with the sentences of Nelson Mandela and others. But I came to feel that I have a story to tell. Nevertheless, I hope that resources will be found so that more stories are told, not only of prison but the many unknown people who pursued resistance in different ways in a range of relatively

unknown places. You were imprisoned and on house arrest for over 11 years. It was based on choices you made. Would you make the same choices today?

Yes. I did what I believed was right at the time and even if things are not turning out so well at the moment, that does not invalidate those choices. I saw the liberation struggle as having a sacred quality and considered it an bonour to be part of it. I was very influenced by the great Afrikaner Communist Bram Fischer. He had nothing to gain personally and could have been a judge, the president of the country or anything else. Instead he chose a life of danger and later life imprisonment. I was inspired by that example, amongst others, to do what I could. When one embarks on revolutionary activities, there are no guarantees of success. I was not sure that I would come out alive. I did what I believed was right and would make the same choices again.

So those choices were worth

Definitely. This was not a business venture where one could answer such a question through balancing profits and losses. For me joining the struggle, as a white, gave me the opportunity to start my life afresh by joining my fortunes with those who were oppressed. It gave me the chance to link myself ...But there's little warmth left inside



with the majority of South Africans.

That was a more authentic way of living my life than whatever successes I may have achieved, had I simply focused on professional success. Most importantly I see this choice – to join the liberation struggle – as giving me the opportunity to humanise myself as a white South African in apartheid South Africa.

Do you still feel the damage after all these years in prison?

Yes. I have post-traumatic stress. I am not sure that it will ever be eliminated or that I always recognise its appearance. Many of us live with scars from that period.

I have not always acknowledged or understood that I have been damaged but it is directly related to my having fibromyalgia (a disorder characterised by widespread musculoskeletal pain accompanied by fatigue, sleep, memory and mood issues), according to the specialist who diagnosed it. She cautioned me about returning to my prison experiences, in this book, fearing the possibility of it setting off physically painful symptoms. That didn't happen as far as I am aware and returning to the scene of trauma may be part of healing, according to some.

Why did you break with the ANC over 10 years ago?

I had not been happy with many aspects of Thabo Mbeki's presidency but that did not mean I should

align myself with his successor Jacob Zuma. Zuma's candidacy was promoted not only by ANC people but especially the South African Communist Party (SACP) and trade union federation COSATU's leaderships, presenting him as having qualities that were not valid. In particular, the claim that Zuma was a man of the people with sympathy for the poor and downtrodden was untrue. It was already known that he was linked with corrupt activities before he was elected as ANC president in 2007. But what was decisive for me was Zuma's 2006 rape trial. There was something very cruel in the way the complainant, known as 'Khwezi', was treated, in the mode of defence that Zuma chose. I found that unacceptable.

Is it not lonely outside the ANC? I miss the comradeship that I

understood to bind me to people with whom I had shared dangers, joys and sorrows. When you are together in difficult times, it creates a special bond. I did not conceive of that being broken.

But when you break away in a time of decadence, what is it that one misses? I cannot resume relationships on the same basis as those which I previously counted as comradeship. Our paths diverged. I went out into the cold and some with whom I used to be very close chose to link themselves with a project that has meant corruption, violence and destroying everything that was once valued in the liberation tradition. These former comrades have all been accomplices in Nkandla (Zuma's private rural home which was upgraded at a cost to the country of R246million to taxpayers), the social grants scandal and many other features of this period which have seen some individuals benefit unlawfully and at the expense of the poor. I do not say that every person I know has been improperly enriched. But all those who been in the have ANC/SACP/COSATU leadership have endorsed, indeed even provided elaborate defences of some of the worst features of the Zuma period. In the new introduction to the book, I use the word "betrayal" and I chose it to refer to these people, many of whom were once brave, who turned their backs on those from whom they came or whose cause they once adopted as their own. Yes, it's lonely. But that loneliness cannot be remedied by resuming bonds with people who have taken fundamentally different paths. I now build relationships with others from whom I am learning and grow-

MONTIGNY'S ANNUAL TURNOVER EXCEEDS E1BN FOR THE FIRST T

MONTIGNY Group's annual turnover exceeded E1 billion for the first time in 2016.

The company has set a target to grow its turnover to reach at least E3.7 billion per year in 2020.


Responding to a questionnaire from the Business Desk, Montigny Executive Director Andrew Le Roux said the group has projected to grow its annual turnover by an additional E300 to 500 million this year.

He said based on last year's performance, the company was still on track to meet its 2020 target. He said there were four reasons

"Firstly, it will be due to the increase in the total available volume of timber, which is sustainably becoming available from the plantations.

This comes after a significant reestablishment of plantations subsequent to the devastating fires of 2007. Secondly, it will be due to the establishment of additional processing and value-add processes at Montigny and Usutu that are now taking place, providing higher value products. Thirdly, the

regional shortage of timber will allow for above inflation price increases.

Lastly, we have concluded the purchase of a port facility in Maputo and the first shipment of wood chips has already been dispatched to Europe," he said.

According to Le Roux, South Africa remains the company's main market, where it supplies up to 40 per cent of the volume of timber to select sectors.

"Namibia, Mozambique, Japan and Europe also remain important, and growing, markets," he

The company has grown impressively over the past five years.

Le Roux said one of the main reasons for this, was the investorfriendly environment in the country.

However, their primary chal-

lenges included the 24 hours border access to their main regional market, South Africa, very laborious Value Added Tax (VAT) processing mechanisms between the country and South Africa.

"Swaziland is a landlocked country and more can be done to facilitate cross-border trade," he said.

With regards to the electricity generation project, Le Roux said good progress had been made thus far.

The company intends to set up a 35 megawatt renewable energy power plant through the use of resources at the sawmill site, which would include all available forest residues and sawmill off cuts.

This publication earlier reported that the company was negotiating for a 20-year contract with the Swaziland Electricity Company (SEC).

"We are now in the final stages of negotiations with finance and technology partners, as well as the Swaziland Energy Regulatory Authority (SERA) and SEC," said the director.

THERE is still a huge market for beef both locally and internationally, Swaziland Meat Industries (SMI) has revealed.

Though by the end of last year 2 440 rural farmers sold 6 500 cattle to SMI, Managing Director Jon Williams said they were still struggling to meet even the local demand for beef and its by-products.

He was speaking during the company's training of farmers held at The George Hotel in Manzini last Friday.

SMI exports beef mainly to Europe and Mozambique.

The company also sells beef and its equivalents in the country under the brand Simunye Beef.

"There is still a huge potential for beef in the export market. Also, in the country there is still a shortfall of beef to meet local demand. In fact, the country imports significant amounts of beef to meet the existing local demand, especially by retailers. This shows that farmers still have a huge market to supply," he said.

Williams said the main reason why

the country remains a net importer of beef was due to low cattle production by farmers.

"For example, the calving rate has remained low amongst farmers and the mortality rate of calves remains

very high. The adult mortality rate also remains very high, despite during the drought period," he said.

Adding, he said the cattle size was also increasingly getting smaller and this affects production as well as farmers return on investment.

Williams further challenged farmers to look at these issues and address

"We will always be available to offer technical assistance and help farmers. We have initiated a number of interventions which we believe could be of great help to farmers," he

For example, he said they often visit dip tanks to talk about the problems that affect farmers and to help them come up with possible alternatives.

Williams said the company also offers technical assistance to feed-

He said they have also set discounts for farmers using the Embiveni reward card, which is given to all farmers who sell cattle to SMI.

During the training held on Friday, farmers benefited from different presentations by animal experts.

"There is still a huge potential for beef in the export market. Also, in the country there is still a shortfall of beef to meet local demand."

These included animal health specialist Johan Ferreira from Bayor South Africa and nutritionist Cronje Marais, who offered technical advice to the farmers.

One of the concerns raised by farmers during the training was the increase of the blue tick which was dubbed the 'common problem'.

Ferreira said they have come up with a number of products designed for tough times.

He urged farmers to invest heavily on the health of their herd.

"If the animal is sick, it will not reproduce the way it should. But, if you treat the animal, it will reproduce at the most perfect rate and offer a good return on investment," he said.

"It is costly, but worth the investment," he added.

He said they were willing to partner with the country and through SMI, can work with dip tanks together with government officials.

'Let's take youth from margins to mainstream economy'

THE country, just like the majority of other developing countries, faces a stern task to ensure that its youth are incorporated and absorbed in the mainstream economy.

Junior Achievement Swaziland (JAS) Executive Director Siboniso Madlopha says it's high time for the country to address how this could be done in the course of the burgeoning youth population coupled with shrinking employment opportunities.

"Our approach is that young people need to go beyond just participating in income generating projects to become key players in the mainstream economy as the saying goes, 'young people are the future leaders," he said.

He said the youth should not b viewed as future leaders politically, but also in the economy.

"When we talk of the next business person, the next millionaire, we are talking about the current youth. But, the question is what are we doing today to ensure that happens?" he stated.

For example, he said if parents put their children in schools and ensure that they get the best education through forking out more, then it was equally important to also do the same in entrepreneurship.

"Let us also prepare future leaders in entrepreneurship. So that even when ...JA to introduce young women entrepreneurship programmes in 2018

JAS seeks to introduce young women entrepreneurship empowerment programmes in 2018.

JA Executive Director Siboniso Madlopha said though they currently run all inclusive programmes, the new programme was aimed to specially focus on the mindset of the blossoming women entrepreneurship leaders.

"We believe that is where we have to start, entrepreneurship is a mindset. So we need to move the girl from being a supporter into being a leader. But, it starts with the mindset, not the opportunity. That is why we want to zero down to girls and provide them the best opportunity to extensively learn about business," he said.

He said this came after they realised that there were very few girls participating in their programmes, especially under the Out of School Youth Programme.

"We believe that if we can zero down and specifically target them, go where

investors come in, they can find ready people to partner with locally," said Madlopha.

He said JA envisions a future where investors will not come into the country and own 100 per cent of their businesses, but find readily available partners in terms of skills, the mindset and the adventure of doing entrepreneurship.

they are and have them interact with us, then we can be able to achieve the desired impact," he said. As a start, he said, they have already started radio programmes on Swaziland Broadcasting Information Services (SBIS) on both Siswati and English channels.

"We want to also use this platform to engage girls, get them to talk with us and participate in shaping their 2018 programme," said Madlopha.

He said the objective was not to have young women only in handcraft, but participate in proper economic driving enterprises

He said they have a number of young women who have graduated from their programmes and were now engaged in meaningful trade activities and running thriving businesses. "There's one thing I have observed with girls, once they grasp something, they do it better because they then throw a lot of passion and zeal into the project," said Madlopha.

Madlopha thanked government, especially the head of government, Prime Minister Sibusiso Dlamini, the ministry of commerce industry and trade and the private sector for supporting youth entrepreneurship and JA programmes. "But, we also have to move to the how part. As JA, we believe that though government cannot have enough money to fund youth entrepreneur-

ship, but government doesn't need that much money. Government needs to look into what are we doing as a country, where are we spending our money and how can young people be part of that," he said.

For example, he said from the tenders that government issues out, at least a small fraction of those tenders, about 10 per cent for a start, could go towards empowering the youth and have them participate in the mainstream economy. "Here we do not refer to hiring the youth, but we refer to the youth being part of the project, contractors, subcontractors and suppliers for major projects," he said.

For example, he said from a E25 million project, about E2.5 million could be generated to support youth businesses, "and that doesn't come from government coffers, but it comes within the project."

Adding, he said main contractors could also sub-contract part of their minor works like paving to youth owned businesses

"It can be difficult for government to fork out E100 million to support youth businesses. But, that money could be easily generated if young people can be given that piece from let's saying a total of about E1 billion tenders given out by government," he said.

Madlopha said often, the argument was that young people don't have the experience and capacity to do such significant works.

"But, where will they get the experience if we don't give them ourselves?"

he said. "That is why then we also have to train our young people and expose them to these opportunities. We need to also mentor them so that they can get the required experience and prepare them to partner with stalwarts in the world of business," said the executive director.

He said that's what JA stands for, to train young people to manage businesses. "It's not only about them getting tenders, but they should also be able to pay their suppliers, pay loans, supply consistently, be tax compliant, ,create and manage relations with their key stakeholders," he said.

"Experience cannot be brought, let's let these young people get the experience and grow," he added.

Madlopha said this could apply across different areas where tenders are issued out, including agricultural supplies.

He said a lot of opportunities could e amassed from private public partnerships (PPP).

"If government and the private sector could come together and aim to equip young people with the experience that they have, this can go a long way to support our economy," he said. He said the same could be done for

small and medium enterprises (SMMEs). "Let's not create jobs for these young

people, let us also help them create jobs for themselves.

Therefore, even when we give them these opportunities, they would have to show how many people they would hire, so that there will be no greediness from such initiatives," he said.

CANGO HAILS SARFED FOR CURBING UNEMPLOYMENT



Eskom's 20% uses 'impossible' assumptions

JOHANNESBURG: Eskom's plans to ask for a 20 per cent tariff increase for next year assumes higher economic growth than just about anyone expects – and assumes a physically impossible doubling of sales by renewable energy independent power producers (IPPs), despite Eskom actively fighting against their coming online.

It also assumes that Eskom will get rid of about 4 300 workers – 10 per cent of its workforce – by March 2019 by not filling the posts left vacant when a member of staff retires.

These assumptions make the application likely to once again result in an enormous additional tariff request later on using the so-called Regulatory Clearing Account (RCA), which is a monitoring and tracking mechanism that compares certain uncontrollable costs and revenues with actual costs and revenues incurred by Eskom. A confidential draft of Eskom's planned application for next year's tariff hike to the National Energy Regulator of SA (Nersa) made its way into the public domain this week. It spells out all the mechanics regarding how the utility came to the 20 per cent figure.

Importantly for most consumers in the country, the application is actually for 27.29 per cent from municipalities.

Eskom's tariffs are set by establishing an "allowable revenue" to cover costs, which gets divided by the expected volume of electricity sales. The five-year tariff determination from NERSA, which ends this year, had made hopelessly overoptimistic assumptions about growth and power demand.

When Eskom failed to sell the amount of power the tariff was designed around, it repeatedly asked to use the RCA to add more tariff hikes in the next few years to make up the shortfall in revenue. Fin24

MADIBA-ZUMA TO EXPLAIN **MILLIONS OF RANDS IN ACCOUNT**

JOHANNESBURG - ABSA is said to have threatened to close down a bank account held by President Jacob Zuma's wife Tobeka Madiba-Zuma, flagging unexplained millions of rands passing through her account.

The bank's move comes a year after it ended business relations with Zuma's son Duduzane. It follows the major banks taking a firm stance against commercial entities linked to the Gupta family, in spite of pleas by Cabinet ministers close to Zuma.

Last year, it emerged that the banks had closed all the business accounts of Gupta-owned companies; leaked e-mails also show that around the same time Absa closed both Duduzane's transactional accounts (cheque and

It is not clear whether the action against Madiba-Zuma is linked to the Gupta-related controversy with the banks.

Sources said the bank wanted her to explain large sums of money in her account.

Madiba-Zuma has denied receiving a letter from Absa about its concerns. The Sunday Times understands she has yet to respond to the bank.

The Guptas have been waging a public and private battle against the major banks since they gave notice of their intention to shut the accounts of Gupta entities, including their holding company Oakbay, in late 2015.

Gupta e-mails leaked to the Sunday Times detail how Duduzane played the race card in his appeal to Barclays Africa CEO Maria Ramos to reverse the bank's action.

Revelations that the bank is targeting accounts held by the Zuma family may explain the political pressure that has been put on Absa since last

year. There appears to have been a well-orchestrated strategy by Zuma backers to take on the bank.

The fight has been led by ANC Youth League President Collen Maine, who led a march on its head office in February demanding that it pay back R1.5-billion that the Reserve Bank gave Bankorp, which later became Absa.

Madiba-Zuma said questions put to her by the Sunday Times about her bank account were an invasion of privacy. "I have no knowledge of Absa's intention to close my account. I have not received anything which has been communicated to me." Timeslive



Is sugar tax doing its work already?

JOHANNESBURG - There are more signs that the heavily contested proposed tax on sugarsweetened beverages is starting to effect change as the soft drink industry fights it tooth and nail.

Coca-Cola Beverages SA this week presented its various imminent reformulations and product size reductions at a hearing before Parliament's standing committee on finance.

By the end of the year, 330ml cans will be displaced by 300ml versions and 500ml bottles by 440ml ones, while sizes above two litres will disappear. By next year, the company claims it will have reduced the average sugar content of its products by 24%, compared with 2016. In March, Clover said it had put on hold most of its new projects to focus on mitigating the mulumillion-rand effect of the impending sugar-sweetened beverage tax. Clover has launched its first sugar-

free beverage, Tropika Slenda, in response to the impending tax.

Velaphi Ratshefola, the Managing Director of Coca-Cola Beverages. told City Press that the bulk of the company's reduction was through actual reformulation of well-established local brands.

Selling more bottled water and diet brands also helps drive the aver-

According to Ratshefola's presentation in Parliament this week, different products' sugar content is being cut by between 10% and 70%.

This includes Fanta and Schweppes, but Coke itself is notably absent.

NUMSA SPURNS 5.3 PER CENT WAGE OFFER

JOHANNESBURG - On the second day of wage negotiations, the National Union of Metalworkers of South Africa (NUMSA) rejected the offer by the bargaining council for employers in the engineering sector.

The offer is a 5.3 per cent increase but NUMSA is asking for a 15 per cent increase based on the rate an employee is working and not on the minimum rate.

NUMSA said it also wants the agreement to include non-parties, such as the National Employers Association of South Africa (NEASA) and the Plastics Converters Association of South Africa (PCASA) who fall under the Metal and Engineering Industries Bargaining Council.

Agreement

The current wage agreement ends on June 30. The union wants a twoyear agreement while the employers are pushing for three years.

The employers are offering: an increase of four per cent in the second and third year, if the consumer price index (CPI) is below four per cent. But if the CPI in those years is above eight per cent, then they are offering an increase of eight per cent. NUMSA said the employers also want new employees to earn half of the minimum rate.

In a statement on Friday, NUMSA said it is "shocked by the offer", particularly that equal pay for work of equal value will be violated through the 50% offering to new entrants to the sector. Wage talks resume on Thursday. TMG Digital.

R11bn Coega investment in jeopardy

JOHANNESBURG - The completion deadline for South Africa's largest motor investment in 40 years will most likely be missed following disagreements between small local businesses and the main contractor over the allocation of work.

This adds to the note of gloom tollowing the announcement by General Motors SA last month that it would exit the country before the end of the year, resulting in the loss of more than. 500 jobs.

The R11 billion car plant at the Coega industrial development zone in Port Elizabeth, a joint initiative between China's Beijing Automotive International Corporation (BAIC), which is the majority shareholder with a 65 per cent stake, and the Industrial Development Corporation (IDC), is a product of 26 bilateral agreements signed between and the state of

China and South Africa in 2015.

It was launched in August last year with construction earmarked to start in December the same year. The plant was meant to be fully operational during the first quarter of 2018.

The hold-up is a dispute between BAIC SA and small, medium and micro-enterprises (SMMEs) affiliated to the National African Federated Chamber of Commerce and Industry (NAFCOC) in Nelson Mandela Bay.

Jobs

About 2 500 jobs are expected during the construction phase of the plant that will produce trucks and sport utility vehicles. The 47-hectare site earmarked for the project remains untouched with no sign of construction machinery. The IDC this week could not give a forecast for when the project would start. fin24

demics, professionals, people in business and civil society". FEDUSA calls for Zuma's resignation after Moody's downgrade

JOHANNESBURG - The Federation of Unions of South Africa (FEDUSA) on Saturday added its name to those calling for President Jacob Zuma's resignation.

FEDUSA is shocked by ratings agency Moody's Investors Services' decision to downgrade South Africa's foreign and local currency debt from Baa2 to Baa3

with a negative outlook, the trade union federation's Acting General Secretary Riefdah Ajam said.

Moody's downgrading of South Africa followed similar actions by S&P Global and Fitch earlier this year.

At the time, Moody's placed South

Africa on review for downgrading.
"Moody's has cited the weakening of South Africa's institutional framework; reduced growth prospects reflecting policy uncertainty and slower progress with structural reforms; and the continued erosion of fiscal strength

due to rising public debt and contingent liabilities as the principal triggers of the downgrade to Baa3 from Baa2," Ajam said. Moody's said there was evi-

Moody's said there was evidence of systemic erosion of the independence of key South African institutions such as the judiciary, the SA Reserve Bank, and National Treasury.

Deputy finance minister implicated in more corruption claims

JOHANNESBURG - The Deputy Finance Minister Sifiso Buthelezi is under the spotlight again, for his former role as chairperson of PRASA's board.

According to media reports, Sfiso Buthelezi ignored over a billion rand of financial irregularities at the rail agency during his six-year tenure.

It says National Treasury's probe found that Buthelezi and the board failed to carry out their duties. The

report calls for criminals charges against them for contravening the Public Finance Management Act. Out of over 200 contracts, it found

only 13 were legitimately awarded between 2012 and 2015.

Buthelezi was recently accused of improperly benefiting from R150million in PRASA tenders, a claim he has denied.

The Democratic Alliance opened a criminal case against him last Friday. *eNCA*

Scrap the R9bn we owe to Eskom, say mayors

Cape Town - Mayors have asked for the Southern African Local Government Agency (SALGA) to lobby for the scrapping of their R9 billion debt to Eskom as a way of ensuring the financial viability of their municipalities.

This was one of the major issues thrashed out at the SALGA inaugural Council of Mayors meeting that took place in Cape Town this past week.

Mayors from across the country came together to discuss challenges facing their municipalities, engage with national ministers and try and find solutions.

Collectively municipalities owe Eskom R9.6bn but are also owed R116bn by other creditors which include government departments.

This week, Co-operative Governance and Traditional Affairs Minister Des van Rooyen said 59 municipalities owed money to Eskorn, with the Free State, Mpumalanga and North West owing the most.

In the Free State, municipalities owed the power utility R3.6bn, followed by Mpumalanga with R2.2bn and North West with R780 million.

Gauteng, municipalities owe Eskom R508m, KwaZulu-Natal R6m and Western Cape R11m.

And in the Northern Cape, municipalities owe the power utility R465m.

In the Eastern Cape they owe R328m and in Limpopo the debt was R287m.

Some municipalities have been in bitter wars with the power utility over unpaid debts which resulted in Eskom threatening to cut power supplies.


Not to mention the three Styles By Chey custom-made outfits for the lucky teen.





Egypt's Al-Sisi praises Trump's stance on Qatar

CAIRO - Egypt President Abdel-Fattah al-Sisi has praised President Donald Trump for his role in "the formation of a united front to combat terrorism" after he called on Qatar to stop its financial support of extremist groups.

Al-Sisi's praise-filled phone call on Saturday came after the US president echoed accusations made against Qatar by a Saudi-led group that cut diplomatic ties with the small oil-rich country earlier this week.

Al-Sisi thanked Trump for his participation in a counter-terrorism summit in Riyadh last May, in which he abandoned some of the harsh anti-Muslim rhetoric of his presidential campaign and vowed to fight terrorism in partnership with Middle East leaders. The escalating crisis in the Persian Gulf erupted this week when Saudi Arabia, the United Arab Emirates, Egypt and Bahrain cut diplomatic ties with Qatar. AP

Ethiopia warns drought aid to run out next month

WARDER - Ethiopia's government is warning it will run out of emergency food aid starting next month as the number of drought victims in the East African country has reached

An international delegation visited one of the worst-affected areas on Friday near the border with Somalia, which suffers from widespread drought as well.

Ethiopia's disaster relief chief Mitiku Kassa told The Associated Press that the country needs more than \$1bn for emergency food assistance.

Seasonal rains have been critically small and local cattle are dying. The number of drought victims has risen by two million people in the past four months. The risk of an acute food and nutritional disaster is "very high," the disaster relief chief said. The International Organisation for Migration said hundreds of thousands of people have been displaced, with the problem compounded as people pour into Ethiopia from Somalia. A United Nations humanitarian envoy said donor fatigue and similar crises elsewhere have hurt aid efforts. Both Somalia and neighbouring South Sudan are among four countries recently singled out by the United Nations in a \$4.4bn aid appent to avert catastrophic hunger a d famine. AP

Gabon TV host suspended after Bongo 'death' blunder

LIBREVILLE - A newsreader for Gabon state television has been taken off the air after mistakenly announcing the death of President Ali Bongo, the channel said on Saturday.

Journalist Wivine Ovandong made the error during a Gabon television news bulletin on Thursday when she read from notes saying that Bongo had died in Barcelona.

In fact, on Thursday was the eighth anniversary of the death of Bongo's father and predecessor, Omar, who did die in Barcelona on June 8, 2009, after more than four decades in power.

Current President Ali Bongo is alive and well.

Gabon television Director General Mathieu Koumba told AFP that Ovandong had been suspended as "a precautionary measure".

"We need to protect her, too,



because social media has had a field day," he added.

Koumba appeared on the channel on Friday and said it had apologised to Bongo and his family for the "blunder".

"It can happen to anyone. But

this was a bit much because it was confusion over the head of state," he said.

Ovandong had only been in the job for a few days after spending several years as a field reporter. AFP

Al-Qaeda-linked group claims deadly UN base attack

BAMAKO - A powerful Al-Qaeda-linked group on Friday claimed an attack on a United Nations camp that killed three Guinean peacekeepers in Kidal in Mali's troubled north.

The Group to Support Islam and Muslims, a fusion of three Malian jihadist groups with previous Al-Qaeda links, posted a statement on its Telegram channel saying it had targeted the UN base "with a set of mortar shells," wounding soldiers and causing significant material damage, the SITE extremism monitor reported.

The UN mission in Mali, MINUSMA, said earlier on Friday its Kidal camp "came under heavy rocket/mortar fire" and "a little later a position nearby was attacked" outside their base, killing three peacekeepers and wounding eight more.

The Group to Support Islam and Muslims, also known as Jamaat Nusrat al-Islam wal-Muslimeen in Arabic, is a fusion of three Malian jihadist groups with previous Al-Qaeda links formed in March.

Led by the Malian jihadist Iyad Ag Ghaly, a former leader of the Ansar Dine Islamists, the group has claimed multiple attacks on domestic and foreign forces since its formation.

The UN mission said it "condemned in the strongest terms these cowardly attacks against its personnel and the danger they cause for the civilian population."

The Guinean government said "terrorist attacks" had killed "three valiant soldiers (and) wounded three others" at a checkpoint just outside the camp, adding that one of its contingents remained unaccounted for.

It also calls for the development of polymer injection technology to increase oil extrac-

In October, a Chadian court had imposed heavy fines on the consortium over unpaid taxes, claiming \$75bn.

No financial details of the agreement were disclosed, though Madet denied that the consortium would pay the government \$200m.

"We are very happy with these agreements which will allow us to relaunch the consortium's operations in Chad," said Christian Lenoble, a spokespersonn for the group.

The consortium also includes

Malaysia's Petronas, and once included Chevron of the US, which has since been replaced in the group by Chad's national oil company.

As one of Africa's poorest countries, Chad relies heavily on revenue from oil sales, though President Idriss Deby has pledged to diversify the economy to protect it from sudden price drops.

We are pursuing economic diversification," Madet said, adding: "Producing more oil creates more wealth and jobs. That is going to help our economy."

Guterres concerned about UN attacks

LIBREVILLE - UN Secretary General Antonio Guterres voiced concern on Friday over the "widespread instability" and attacks on UN troops in the Central African Republic, which has been wracked by renewed sectarian violence since last month. One of the world's poorest nations, the Central African Republic has been struggling to recover from a threeyear civil war between the Muslim and Christian militias that started after the 2013 overthrow of leader Francois Bozize. A new flare-up of sectarian violence since the beginning of May has forced tens of thousands to flee conflictravaged areas. AFP

5 killed in Somalia over food aid

MOGADISHU - Five people were killed in crossfire between two groups of government soldiers on Friday when fighting broke out during the distribution of relief food in the southern Somali city of Baidoa, police and witnesses said. The incident happened in the afternoon at a site where food aid was being distributed to people displaced by drought earlier this year. Baidoa is about 245 km northwest of Mogadishu. "Two groups of soldiers clashed on the scene where food was being distributed. Five people, mostly women, died in the crossfire and 14 others were wounded. It was an accident and the case is being followed and investigated," Major Hussein Edin, a police officer, told Reuters. Reuters

Police officer dies in DR Congo attack

DR CONGO

Unknown gunmen attacked the court office on Friday night, burning several vehicles parked on the premises. A police



officer was killed in an attack on a court compound in the Democratic Republic of Congo, a judicial source said Saturday, weeks after a mass jailbreak from Kinshasa's main prison. A magistrate in the Matete district in the east of the capital told AFP that unknown gunmen attacked the court office on Friday night, burning several vehicles parked on the premises. He said one police officer was killed and another wounded in the assault, adding that three prisoners held at the compound were later found to be missing. AFP

Buhari won't return this weekend

ABUJA - Nigeria's President Muhammadu Buhari will not return home from medical leave in Britain at the weekend, presidency sources said on Saturday, having previously told Reuters the ailing leader would be returning by then. Buhari's doctors said they will need to carry out testing on him today, and the test results will determine when he returns to Nigeria, the sources said. The president's undisclosed ailment has left his deputy, Yemi Osinbajo, in charge. Reuters

Boko Haram claims attack on Nigerian city

MAIDUGURI- Islamist insurgency Boko Haram has claimed responsibility for the attack on Nigeria's northeastern city of Maiduguri on Wednesday night that killed at least 14 people, the first major assault in 18 months on a key stronghold against the militants. The raid took place six months after Nigerian President Muhammadu Buhari said Boko Haram had "technically" been defeated by a military campaign that had pushed many insurgents deep into the remote Sambisa forest, near the border with Cameroon. Maiduguri is the centre of the government's eight-yearold fight against Boko Haram, which has been trying to set up an Islamic caliphate in the northeast. Reuters



Protests erupt after US police kill a Tulsa black man

OKLAHOMA - Three Oklahoma law enforcement officers triggered a protest on a city street that prompted the appearance of dozens of officers in riot gear, showing force.

This followed the fatal shooting of a black man while trying to pick him up for a mental health issue this last Friday.

The Tulsa County sheriff's deputies were attempting to pick up 29-year-old Joshua Barre near his house, but the man walked away to a nearby convenience store instead, Tulsa police spokesperson Leland Ashley said.

Two deputies and a Tulsa police officer opened fire before Barre could enter the store when they discovered he was carrying two knives and became concerned about the safety of the people who were inside the place of business, Ashley said. The deputies who fired the shots are white and the police officer is black. All three have been put on routine administrative leave.

THERESA MAY APPOINTS FORMER HOUSING MINISTER GAVIN BARWELL

LONDON - Former housing minister Gavin Barwell has been appointed as the new Downing Street chief of staff,

Mr Barwell, who lost his Croydon Central seat in the snap election called by May, will bring 'considerable experience' to the post, the Prime Minister said

His appointment comes following the resignation of May's closest aides Nick Timothy and Fiona Hill, who had served as joint chiefs of staff.

Speaking today, May said, "I'm delighted that Gavin Barwell accepted the role as my chief of staff. 'He has been a first class minister and is widely respected. "He will bring considerable experience of the party to the post." As I said yesterday, I want to reflect on the election and why it did not deliver the result I hoped for. 'Gavin will have an important role to play in that.

"I look forward to working with him." Barwell said: "I voted for Theresa May to become Prime Minister. "I believe she is the best person to heal the divisions in our country that

last year's referendum and the General Election have laid bare, getting the best Brexit deal for the whole country and leading us towards a brighter future outside the EU.

He was in CCHQ for nearly two decades before moving into Parliament.

Germany to test facial recognition software

BERLIN - Germany will start testing facial recognition software at a Berlin Train Station in a few months that could help police identify and locate terror suspects more quickly, a minister says. Interior Minister Thomas de Maiziere said this past Saturday the software would be tested with volunteers at Berlin's Suedkreuz Station and if successful would be expanded to other locations and also used for a range of criminal investigations."We already have video surveillance in train stations, of course. But we aren't able, for example, to put a picture of a terrorist on the run into software that would alert us when he appears in a station," Maiziere said in an interview on the website of the Tagesspiegel newspaper." AFP

Spaniard dies of stab wound to the back

BARCELONA - Spain's Foreign Ministry says a British autopsy concluded that Ignacio Echeverria, the Spaniard who confronted assailants during last weekend's attacks in London, died after being stabbed in the back. A Foreign Ministry spokesperson said this past Saturday that Echeverria's family shared the information with the ministry after the autopsy was performed. Witnesses described seeing the 39-year-old Echeverria using a skateboard against attackers before he fell to the ground during last Saturday's attacks on and near London Bridge. He was employed in London by HSBC bank. Seven other people also died in the attack on June 3. AP

3 men detained after Jet landing

BERLIN - Three male passengers were detained

this past Saturday evening in Cologne, Germany after their easyJet flight from Ljubljana, Slovenia to London made an unscheduled landing there, Cologne police said in a statement.



The aircraft landed in Cologne after passengers reported that the men were talking about "terrorist matters," according to the statement. The men were not identified. Police carried out security checks of the aircraft and questioned passengers after all 151 passengers were evacuated safely from the Airbus 319 aircraft using emergency slides, the airport said in a statement on its website. *Reuters*

'Notre Dame attacker a novice'

PARIS - An Algerian man who attacked a policeman with a hammer outside Notre Dame cathedral was a loner with a deep interest in Islamic State jihadist propaganda, the Paris prosecutor said this past Saturday. Farid Ikken, a 40-year-old doctorate student, was shot and wounded by another policeman during Tuesday's attack in which he shouted: "This is for Syria". He was officially charged late Saturday with the attempted murder of law enforcement officials and association with terrorists, and jailed ahead of a hearing. He had previously been receiving hospital treatment for a gunshot wound to the leg. AFP

IS abducted Iraqi girl reunited with family

IRAQ - The Ashti camp in Iraq's northern city of Arbil this past Saturday celebrated the return of a girl whose abduction by jihadists three years ago sent shockwaves through her Christian community. Joy filled the prefab unit that is now the home of six-year-old Christina Ezzo Obada's family, who were forced to flee the town of Qaraqosh, which lies between Arbil and Mosul and was taken over by the Islamic State group in mid-2014."Seeing my daughter is a miracle," said her 46-year-old mother Aida."I was shocked because she has changed so much, I didn't recognise her." AFP

Trump's tantrum: President says he won't go ahead with state visit to UK

NEW YOKE - President Donald Trump has called off state visits to the UK until the British people are prepared to meet him with open arms.

The commander-in-chief told UK Prime Minister Theresa May in a phone call that he didn't want to visit the UK if there were going to be largescale protests against him - likely meaning his visit will be indefinitely postponed.

The call was made at some point in recent weeks, shocking the British leader an insider close to her told The Guardian.

The source said they were present in 10 Downing Street - the prime minister's official office - when the call came through.

May was the first foreign leader to visit Trump in the White House when she made an appearance in DC just seven days after his inauguration.

She extended a formal invitation from Queen Elizabeth II to Trump during that visit, and told press she was 'delighted that the president has accepted that invitation'.

But there has been very little public talk about Trump visiting the country.

Some of May's advisors told her that the offer was prenature and should have been 'put back a bit' in the wake of his controversial Muslim travel ban, but could not be rescinded once made.

Strained

Trump's relationship with the British public has been highly strained for years - particularly in Scotland, where his golf developments have upset locals.

But things have become considerably worse since he became president.

Most recently, he attacked the Mayor of London, Sadiq Khan, in the immediate aftermath of the terrorist attack on London Bridge.

Trump tweeted that Khan had told people 'not to be alarmed' in the wake of the attacks - but he ignored the con-

text that Khan was talking about the increased police presence, not the attacks themselves.

After Khan dismissed the remarks, pointing out the error, Trump doubled down, saying Khan had to 'think fast' to come up with his 'pathetic excuse' of a response.

The response from the British public was strong, with UK politicians and even Harry Potter author JK Rowling taking Trump to task online.

And in February, a petition to the British Parliament signed by more than 312 000 people triggered a debate on whether Trump should be allowed to visit.

The petition read in part: "Donald Trump's well-documented misogyny and vulgarity disqualifies him from being received by the Queen or the Prince of Wales.

'Therefore during the term of his presidency Donald Trump should not be invited to the United Kingdom for an official state visit."



INFANTINO 'CONFIDENT' IN 2022 DESPITE QATAR CRISIS

QATAR - FIFA is confident the diplomatic crisis sweeping Qatar will normalise and not threaten the 2022 World Cup, the organisation's President, Gianni Infantino, said in an interview published yesterday.

"We are facing a diplomatic crisis," Infantino told Switzerland's Le Matin Dimanche newspaper. "I am confident the region will return to a normal situation."

He told the paper FIFA was "closely watching the evolving situation and we are in regular contact with the highest authorities in Qatar."

But he stressed that Qatar's World Cup was five years away.

"Obviously, if football can offer a small contribution to improve the situation, I won't hesitate to offer my help," he said, while adding that FIFA should stay clear of "geopolitics."

Saudi Arabia and allies, including the UAE and Bahrain, cut diplomatic ties with Qatar last Monday, accusing it of supporting extremism.

The move triggered the most serious diplomatic flap to hit the region in years and experts have said it could impact the 2022 World Cup.

Since being controversially chosen by FIFA in 2010 as the host, Qatar has maintained that it is a politically secure nation, despite its location in a volatile region. Doha has also emphasised that the tournament serves the entire Gulf, and not just the tiny gasrich emirate. Those claims have faced fresh scrutiny during the crisis, possibly invigorating a cam-



paign by critics of Qatar to strip Doha

Southgate insists players passed huge test

LONDON - Gareth Southgate described Harry Kane's dramatic stoppage-time equaliser against Scotland as 'a huge moment' for his England team, implying that they had buried the ghosts of last year's shock defeat by Iceland.

After Southgate saw Leigh Griffiths propel Scotland into a 90th-minute lead with the second of two stunning freekicks, Kane underlined his credentials as the new national team skipper with a stunning goal of his own.

"The questions around us centre on character when events go against you," said Southgate. "So we have to be a team that is never beaten.

"For 80 minutes, we had been in control of the game and I felt we deserved to be in the lead, but then we had a mad minute and a half and witnessed two outstanding technical finishes. You didn't see anybody sink to their knees and you didn't see anyone throw in the towel.

"We came here looking for more but after the narrative of that game we have to be pleased with a point. The way we came back is fundamental to being a top team. This is only one step in that direction but it's a significant moment."

Southgate said he would not make a judgement on whether keeper Joe Hart was at fault for the Scotland goals until he had watched them again. Instead he praised him for being "composed with the ball at his feet".

Not everyone was so generous to Hart, however.

Gary Neville, who was England's assistant coach when Hart and his colleagues succumbed to Iceland last year and was here working for TV, suggested the goalkeeper was at fault for Scotland's goals.

"I have to say it's a good strike, but Joe Hart is beaten a metre inside his post. Should he get there? Maybe," he said of the first. While on the second he said: "I think Joe Hart should save it, again. People can criticise me if they want but that's poor from the goalkeeper. Griffiths knows if he gets it up and down it's a goal and Hart doesn't move his feet quick enough."

Kane echoed Southgate in praising England for the manner in which they fought back. "To get the equaliser in stoppage time showed unbelievable character," he said.

Gordon Strachan described the game as 'one of most emotional games ever as a manager'.

"It was like watching a heavyweight boxer against a middleweight," the Scotland manager said. "These guys are giants given the level they play at compared to us.

He said of goalscorer Griffiths: "He's a wonderful character. Strange but wonderful."

Roberto Carlos dragged into doping scandal

LONDON - Former Real Madrid legend Roberto Carlos has been dragged into a doping controversy after a German documentary alleged he was one of at least two Brazilian international footballers who took banned performance enhancing drugs around the 2002 World Cup in Japan and Korea, a tournament Brazil won.

During a long investigation into doping in Brazilian sport, led by the acclaimed journalist Hajo Seppelt, undercover reporters obtained substances, including steroids and EPO from a doctor, Julio Cesar Alves, who has claimed to provide doping substances to dozens of Brazilian stars across multiple sports for more than a decade.

Runner Eliane Pereira, who has represented her country, told Seppelt she had been given doping products since the age of 17 by Alves.

Marco Aurelio Klein, who was until recently the head of Brazil's anti-dop-

ing organisation, told Seppelt that a dossier of sportsman's statements about their visits to Dr Alves had been handed to prosecutors in 2015. Among paperwork compiled as part of a potential case against Dr Alves was a claim that Roberto Carlos, who won the Champions League three times with Real among many trophies in his career, visited Dr Alves in July 2002, within weeks of the World Cup. Filmed by undercover reporters pretending to want drugs for performance-enhancing reasons, Dr Alves told them: "I treated Roberto Carlos. The national player. He came to me at the early age of 15.

He was a lanky boy. I developed his thighs. It was me who made Roberto Carlos' thighs into what they are today."

Seppelt and his team from ARD television made multiple attempts to obtain a response from Roberto Carlos, including at last weekend's Champions League final in Cardiff. The 44-year-old, widely regarded as one of the greatest left-backs of all time, declined to make any comment.

MADRID - Real Madrid footballer Cristiano Ronaldo has reportedly become the father of surrogate twins.

The children, a boy and a girl called Eva and Mateo, were born on Thursday, according to Portuguese TV channel SIC.

"Mateo and Eva, those are the names of Cristiano Ronaldo's twins," the channel claimed.

"The boy and girl were born to a surrogate mum. It's a secret that Cristiano Ronaldo hasn't yet revealed to the rest of the world."

The TV station did not initially say where it believed the children were at the moment and revealed there were no pictures yet of the babies.

There has been immediate no official confirmation of the news from the footballer or his agents, but several Portuguese websites

and newspapers, including leading Portuguese daily Correio da Manha, were running the story on Friday.

A UK newspaper reported in March that Ronaldo was due to become the father of twin boys.

It said a surrogate mother on the west coast of the US was heavily pregnant and was expecting the babies "very soon."

Ronaldo, who is dating Spanish beauty Georgina Rodriguez, stunned the world in July 2010 by announcing on Twitter and Facebook he had become a father.

Cristiano Ronaldo Jr, known as Cristianinho, is now six.

The child's proud grannie Dolores Aveiro revealed in an approved biography published in July 2014 in Portugal that she had picked the youngster up from a private hospital in Florida.

Chelsea lead race to sign R Madrid star Rodriguez

LONDON - Chelsea are frontrunners to sign Real Madrid's Colombian attacking midfielder James Rodriguez.

According to Spanish publication AS, the Premier League champions have stolen a march on their rivals for Rodriguez who was on the periphery for Real last season.

It is thought that £70m would be sufficient to bring the 25year-old to Stamford Bridge.

Real would want to conclude negotiations in a swift fashion in order to reinvest the transfer fee into a bid for Monaco starlet Kylian Mbappe.

Rodriguez has struggled to break into Zinedine Zidane's star-studded starting line-up and the Champions League winners have plenty of depth to accommodate his exit.

Antonio Conte is thought to have spoken to the Chelsea board of his desire to bring in Alvaro Morata and Rodriguez and is confident a deal will be concluded for the latter.

Morata on the other hand looks set to join former Chelsea boss Jose Mourinho at Manchester United. Despite his relative lack of game-time last term, Rodriguez still netted 11 times in all competitions for the club.

But with only 13 La Liga starts to his name, the Colombian is looking to take the necessary steps to play regular football.







MANCHESTER -Sanchez would earn £275k-a-week at The Etihad if he's reunited with his former Barcelona boss, Pep Guardiola.

City are also hoping Arsenal will accept an offer of £50million for Sanchez, 28.

The Chilean scored 30 goals for Arsenal in all competitions in the season just

That underlined his importance to the Gunners and Arsenal boss Arsene Wenger is adamant that he'll be staying.

But Sanchez has only a year remaining on his contract, has not agreed a new deal and Arsenal face losing him for nothing next year.

City, having already signed Benfica goalkeeper Ederson Moraes and Monaco midfielder Bernardo Silva for a combined outlay of £78m, are also in the market for a centre-back and two fullbacks. They remain interested in Southampton Virgil Van Dijk, 25, but won't meet the Saints valuation of £70 million.

Tottenham right back Kyle Walker, though, is expected to be a City player by the end of this week, when his England commitments are completed.

Walker, 27, is valued at £40 million by Tottenham, but Manager Mauricio Pochettino is prepared to sanction his sale. Pochettino intends using Kieran Trippier, 26, as his first-choice right back next season.

Wenger, a former Monaco manager with contacts still at the heart of the club, is the man driving the bid to bring Mbappe to the Emirates. He knows it is a tall order but he has been stung by the suggestion last season that he is now expendable at the age of 67. This could be a test of the pulling power Wenger still has. Daily Mail

Germany hit seven, Kane rescues England

Julian Brandt made it six 18 minutes from time before Wagner completed his hat-trick on 85 minutes as Germany continued their perfect start to qualifying, a feat matched only by Switzerland in Group B.

In Glasgow, Kane marked his first match as captain with an equaliser three minutes into injury time in a match between old enemies that burst into life in the dying moments.

There had been little warning of what was to come during a largely uninspiring encounter that only started to warm up once English substitute Alex Oxlade-Chamberlain had given the visitors a 1-0 lead on 70 minutes. But two sumptuous freekicks from Leigh Griffiths in the final three minutes looked to have given Scotland a stunning turnaround victory. Yet a first win over the English since 1999 was denied Gordon Strachan's team deep into stoppage time as Kane fired home a cross from Raheen Sterling to earn a 2-2 draw.

"At 60 years old, that would have been the best result of my footballing career," said Strachan.

"To do what they did was phenomenal. You can't do any more than they did. It was like a middleweight fighting a heavyweight."

It meant England avoided a first qualifying defeat since October 2009. However, their lead at the top of Group F was cut to two points as Slovakia won 2-1 in Lithuania.

NADAL SEALS HIS VERY OWN LA DECIMA

Spanish superstar takes Wawrinka apart at Roland Garros to claim historic tenth Paris title

PARIS - To Rafael Nadal 'La Decima' - a tenth French Open title, with his astonishing hold on Roland Garros extending beyond his 31st birthday.

The Spanish clay-court master became the oldest Paris champion of the post-1968 era and the first to win a Major 10 times when he smashed Stan Wawrinka 6-2, 6-3, 6-1 in two hours and five minutes.

Nadal fell onto his back on the clay after the Swiss made a mess of a mid-court volley, having claimed the Coupe Des Mousquetaires for the loss of just 35 games.

Even by his standards Nadal has dominated this tournament, and Wawrinka had no answer to his power and consistency off both flanks, plus a dominating display off his first serve. Come injuries, career hiatuses, Roland Garros has never seen a player like it, and surely will not do so again

It was actually his 15th Grand Slam title and his first since winning here in 2014.

Had he converted that fifth set lead at the Australian Open he would have been breathing down Roger Federer's neck.

Brilliance

You could never call winning something 10 times a non-event, but as a contest the fact was that this was no thriller, and that was down to Nadal's brilliance.

A contributor too, perhaps, was what Andy Murray took out of the Swiss last Friday.

Wawrinka came in with two hopes, the first that he could recreate the big occasion form that has seen him win all three Grand Slam finals he has played.

The second was that Nadal has not come under any pressure this fortnight, and that if he could be pushed close then his nerve might be tested.

Points

On another sultry Paris afternoon with the ball fizzing through the court Wawrinka actually created the first break point at 1-1.

But a missed forehand let the opportunity go and then Nadal missed three in the next game, with his returns going awry.

On a fifth break point at 3-2 the Spaniard gratefully received a simple netted backhand to move ahead and then he clinched the set at 5-2 with a forehand long from his oppo-

nent. It was actually the Nadal backhand that was doing much of the damage, and he rammed home the advantage by breaking to love for a 2-0 lead in the second set.

Wawrinka did revive a bit after that and tried to move his man around a little more but he could not find the accuracy or depth. His body language sagged and two points from the end of the second set he angrily smashed his racket into the court.

It was now turning into a masterclass, and even though Wawrinka kept fighting he could not find any solutions. Nadal's cross court backhand was especially devastating, and the game was effectively up when he broke for a second time in the third set after a marathon fifth game.






COMPANIES UNITE FOR SOCCER, NETBALL TOURNEY

"Fire damages large tracks of plantations, and at times lives are lost in trying to manage the fire. The company also makes huge revenue losses due to damaged stock, overtime from firefighting crews, rental of air support from as far as South Africa to fight fires and huge insurance premiums, which may also result in job losses. Retrenchments are imminent

at times due to the damaged plantations. The biggest losses are economic losses to the country's revenue. Fires also kill wildlife and the environment. Property is damaged at times as fires travel fast to surrounding communities." Anyone who identifies a wild bee-hive within the plantations is urged to report it on toll-free number (1313).

He urged the players to continue working hard for the next games.


"I hope the team will have a safe trip back

FA DISQUALIFIES MASHUMI'S NOMINATION FOR PRESIDENT

SOCCER - THE National Football Association of Swaziland (NFAS) has disqualified the nomination of the association's Vice President Mashumi Shongwe for the position of president. Shongwe was nominated for the position of president alongside the incumbent Adam 'Bomber' Mthethwa and former vice president Timothy Shongwe, contesting the forthcoming elections to be held at Sibane Hotel on June

According to a circular released by the NFAS CEO Frederick Mngomezulu last Friday, Shongwe's nomination was disqualified following his suspension from football activities and also pending the outcome of the High Court case, where Shongwe is challenging the sanctions

cation, Shongwe said he would wait for the outcome of the court case which is slated for this week.

"I have been made aware of these developments but I am not going to comment any further because the matter is still in court," he said.

Shongwe was suspended by the football association after claims he was defiant from both FA and the then Shiselweni Regional Football Association (SRFA) executive committee led by Enos Vilane on the issue regarding the association's elections held in July last year.

The FA vice president said the suspended parties defied a directive by the football mother body and went on with the elections despite a stand by the organisation asking Shongwe to resign as an executive member if interested in standing for elections at regional level.
