President Zuma coming to SD for SACU Summit

SOUTH African President Jacob Zuma is coming to Swaziland to attend the Southern African Customs (SACU) Summit.

According to the Citizen newspaper, President Zuma will attend the 5th SACU Summit to be held on Friday in the country. The heads of state and government of SACU meet on an annual basis to discuss progress in implementation of the agreed work programme. The summit also follows high level consultative meetings by Zuma in 2016 to discuss the SACU work programme, the presidency said in a statement.

Minister of Foreign Affairs Chief Mgwagwa Gamedze confirmed that President Zuma will be attending the SACU Summit.

"Yes, it is true that South African President Zuma will be attending the SACU Summit," he said.


Discussions

Swaziland, as the current chair of SACU, successfully led a process that facilitated discussions within SACU on the transformation towards a developmental integration agenda. The summit would receive and consider

a report from council on its activities with the purpose of providing strategic direction on development integration in SACU and to ensure that the SACU agreement facilitated implementation of this agenda.

Zuma will be accompanied by Trade and Industry Minister Rob Davies, International Relations and Co-operation Minister Maite Nkoana-Mashabane, and Deputy Finance Minister Sifiso Buthelezi, the presidency said.

OVERLOADED MINI-TRUCK ROLLS WITH 26, TWO DIE

AN overloaded Toyota Dyna mini-truck overturned with 26 passengers after its driver lost control of it, killing two on the spot.

The truck was driven by a 25year-old man of Ka-Shoba. He was from Manzini to his home

It is suspected that the accident resulted from one of the truck's tyres bursting, thus the driver lost control.

According to an eyewitness, two passengers died on the spot.

"Two female passengers aged 35 and 17 both from Ka-Shoba sustained serious injuries and were rushed to Good Shepherd Hospital where they were certified dead on arrival," said the witness.

Six other passengers were admitted to the same hospital with a further two at Manzini RFM Hospital.

Confirmed

Deputy Chief Police Information and Communications Officer, Assistant Superintendent Phindile Vilakati, confirmed the accident and said the minitruck was ferrying mourners from a funeral to their respective homes.

"Two passengers were certified dead at Good Shepherd while some were admitted at the same hospital and some transferred to RFM," she said.

Those admitted are still in hospital and they are recovering, according to an observation by doctors. The driver has been charged with culpable homicide and will appear before Siteki Magistrate's Court.

Meanwhile, a two-year-old girl died after she was run over by a tractor on Sunday at Mabhensane area.

Mabhensane is an area in Sithobelweni in the Lubombo region. The child was a passenger on the tractor and fell while it was in motion before it crushed her, according to a relative. Chief Police Information and Communications Officer, Superintendent Khulani Mamba, confirmed the accident and death of the child.

IT is all systems go for the 37th Ordinary Southern African Development Community (SADC) Summit of Heads of State and Government to be held in South Africa.

Media accreditation from Member States is now opened. South Africa will assume the role of Chairman of the SADC in August 2017, taking over from Swaziland.

Host

The country will host the 37th Ordinary SADC Summit of Heads of State and Government from August 9th to 20th in Pretoria.

The summit will take place under the theme: 'Partnering

with the private sector in developing industry and regional value-chains'.

Meeting

The summit will be preceded by the senior officials' meeting on August 11-14, ministerial meeting on August 16 and the double troika on August 18.

All the meetings will take place at the Department of International Relations and Cooperation (DIRCO), O R Tambo Building in Pretoria.

Deputy loses application for promotion to be school head

A deputy headteacher at Dvumbe High School lost an application for an order compelling the Teaching Service Commission (TSC) to promote him to the position of school head.

Bongani Dlamini had taken the TSC, under secretary in the ministry of education and the attorney general, respectively, to court.

Dlamini submitted that he was made to act as head teacher of Dvumbe High School from his substantive post of deputy head teacher from the period of October 4, 2012 in terms of three instruments and continued to do so until February 2014 when he was advised to cease to act.

He invoked General Order A245 in his application and had prayed that the court orders that the TSC confirms or promote him to the position of head teacher on the basis that he had acted for more than six months. The court, however, found that his application in this regard is ill-conceived in that the government general order will only apply where an officer has been acting for six months, only in a vacant position and on this matter the position was not vacant until October 2013 in that the then incumbent head teacher Johannes Shongwe was on suspension until his dismissal on October 17, 2013. In the premise, the court noted that not only was the post not vacant for a period of six months whilst applicant was acting but also, the applicant did not serve in the position for six months after Shongwe's termination of services.

"In the current matter, we find that there is no reasonable basis that created the impression that the applicant would be promoted and the period of acting, in the circumstances the applicant's application is dismissed in its entirety with no order as to costs," acting Industrial Court Judge Musa Sibandze pronounced.

The court had further noted that the applicant was appointed for fixed periods when the position was not vacant and the incumbent could have returned at any time and furthermore the period of this acting appointment was not inordinately extended. S'KHOTHANE RUNS E20 000 BILL ON BOOZE, RUNS, ARRESTED

A South African man believed to be part of the villainous 'tikhothane' gang has been arrested for defrauding The George Hotel after he failed to settle a bill of E18 321 he ran on one night.

In simpler terms, 'tikhothane' is the bunch of spoilt children who predominately come from rich families and go about flaunting their wealth in bizarre ways.

They go for expensive items on offer, purchase and burn them for the fun of it. In a nutshell, they are stupid, observers concluded.

Bongani Linda Mhlongo (26) of South Africa is said to have arrived at The George Hotel and started buying drinks, food and cigarettes for everyone at the bar.

Mhlongo is alleged to have made a false payment using a Nedbank account which later the hotel staff discovered when the accused had already left the place.

The George Hotel Manager Sjabulile Lukhele stated that the accused was arrested after he was tracked down by police and found at Ngwane Park area.

He made an appearance yesterday before Manzini Magistrate Philsiwe Simelane facing a fraud charge. Narrating the events which led to the hotel losing thousands of Emalangeni, Thabiso Mokoena, who is a barman at the hotel, told the court that Mhlongo arrived at

the bar alone and was later joined by two friends a male and a female.

The accused is said to have ordered 12 Flying Fish ciders, 12 Hunters Dry ciders, 12 Castle Lite and 12 Savannah Dry the moment he arrived at the pool bar, which is just next to the swimming pool.

Mokoena stated that Mhlongo further ordered Sky Vodka shots. The barman told the court that later on the day, two other ladies arrived and the accused approached them and asked what they would like to drink and they told him that they

wanted Hunters Dry beverages.

The accused then ordered 12 bottles of Hunters Dry and told the ladies to join him in his table where he was seated with three others already. Mokoena further told the court that after he was joined by the other women, the accused ordered 10 shots of Black Sambuca and 12 shots of Tequila.

When the bill reached E2 130, the concerned barman said he then called the accused and told him about his bill.

He said the accused told him not

to worry but he must tell him once the bill reaches E4 500.

Mokoena said the accused proceeded to order 24 Castle Lites and 12 Hunters Dry ciders. Mokoena informed the court that the accused approached a random customer who was seated enjoying his drinks at the bar and ordered eight shots of 1880 Smirnoff Gin.

The barman said at around 7pm, the bill stood at E5 000 and he again informed the accused who told him to relax.

Mokoena said he began to get suspicious and decided to call the reception to enquire about the accused person.

He said he was worried that he might not be able to pay for his accommodation but he was told that he must relax as the South African man's bill was going to be paid for by Grace Travelling Agents.

Mokoena said at around 9pm, more ladies arrived at the bar and again Mhlongo approached them and asked what they were having and they told him that they wanted cocktails.

The accused then bought the ladies cocktails known as 'Sex on the Beach'.

The bar man said there were about six packets of Lays potato chips which were for sale at the bar and the accused person opened all of them at once and ate them.

Later on when asked to pay, the accused told the barman to come

INFORMATION revealed in court is that the accused deceived the hotel staff by booking a room using Grace Travelling

The hotel's Manager Sjabulile Lukhele told the court that it is normal for travelling agents to make booking for clients by either sending a voucher or proof of payment.

Lukhele stated that, however, as a hotel they had never worked with a company called Grace Travelling Agents which is why he asked for proof of payment from the accused.

She said she soon received an email from the travelling agents saying they must give their client alcoholic beverages amounting to E2 000. She said after that, the travelling agent sent a proof of payment for E15 731.

However, later it was discovered that the payment the accused made through Nedbank had bounced and by that time the accused was long gone.

The taxi, which he hired to ferry him to Ngwane Park, was called and police were able to track him down and arrested him. The total bill ran by the accused according to the hotel manager, was E18 321.

When the bill hit E6 331, the accused is said to have ordered another 24 Hunters Dry beverages and 12 Castle Lite. The barman told the court that he then went home as his shift ended.

He said on Monday, he received disturbing news that the accused did not pay his bill which stood at E18 321.

IMF insists govt has to cut spending, contain deficit

THE International Monetary Fund (IMF) insists government has to cut spending and at least contain the 2017/18 8.2 per cent fiscal deficit.

This recommendation comes after the IMF staff end of mission to conducted the 2017 Article IV consultation discussions with the country, following their visit from June 7 until yesterday.

During the Article IV consultations, the IMF team of economists visits a country to assess economic and financial developments and discuss economic and financial policies with government and central bank officials and then give a diagnosis report about the economy.

Noteworthy, the IMF made the same recommendation during the country's last Article IV consultation in 2015.

Speaking during a press conference held yesterday at the ministry of finance, IMF Mission Chief for Swaziland Geremia Palomba insisted that in light of the economic outlook, the country requires significant fiscal adjustment starting from the 2017/18 fiscal year, to ensure macroeconomic stability and debt sustainability. "Policies need to be carefully designed to address the main sources of recent fiscal deterioration and include both expenditure and revenue measures that can support long-term growth," he said.

He said strengthening public financial management and improving the management of public entities outside the central government remains critical to implement fiscal adjustments plans.

"To this end, the mission welcomes the authority's intention to consider additional actions to contain the 2017/18 fiscal deficit within the original limit (8.2 per cent) and start fiscal adjustment in the next year's budget," said Palomba.

He insisted that public debt should not keep increasing, but be stabilised.

Adding, Palomba said there was a need to strengthen financial management and improve the management of public entities outside the central government to implement fiscal adjustment plans.

Government's total expenditure for the current financial year was estimated at just over E21.8 billion, with the fiscal deficit edging at about E4.9 billion.

Responding to the IMF recommendations, Minister of Finance Martin Dlamini said they were looking at possibilities of at least maintaining the budget deficit of eight per cent which was budgeted at the beginning of the financial year.

"We are going to engage within the ministry and try to find out where we can introduce measures to reduce spending to substantially reduce the arrears that we have accumulated during the past two years," he said.

He said the three years adjustment period suggested by the mission could be adequate for the country to introduce measures that could keep the country within acceptable budget deficit levels.

Dlamini said they would also ensure that they reduce government debt to sup-

Preceding its initial recommendations, the IMF mission met with the ministers of finance and public service, Central Bank of Swaziland (CBS) governor, other senior officials, market and business representatives.

... Recovery to remain muted in 2017

MEANWHILE, the IMF has projected economic growth to remain muted going forward this year.


IMF Mission Chief for Swaziland Geremia Palomba noted that the country's economy was hit by two large shocks during the past year, which were the prolonged El Nino induced drought, coupled with the sharp decline of the Southern African Customs Union (SACU) revenue which has had a negative effect to both the budget and the country's gross official reserves.

He noted that government in turn, also provided an expansionary budget to support the economy.


However, he said that expanded the fiscal deficit, weakened the fiscal account and led to the accumulation of payments which were still overdue. "This was a sign of pressure and weakness of the fiscal account," he said. Therefore, he said in the past year, growth was projected at zero per cent and going forward, he said though growth

would recover a bit, given the pressure of the economy, it would stay below one per cent. "Risks to the outlook are titled to the downside and include further tightening in budget financing, volatile SACU revenue, lower demand for key exports and tightened global monetary conditions," said Palomba. He said the main challenge that the country faces was to define a policy position that preserves microeconomic stability, but at the same time be able to sustain growth and reduce the current high level of poverty and income inequality. He noted though that the financial sector remains sound and commended authorities for taking steps to monitor and manage possible risks and advance key financial sector reforms. "There are strong links between the financial sector and government. A strong government will help the financial sector and a weak government will weaken the financial sector," he said.





Nkhaba Inner Council member shoots subject in land dispute

THE High Court has heard how the on-going land dispute at Nkhaba turned nasty when a member of the Nkhaba Inner Council allegedly pounced on a subject and attempted to kill him over a piece of land.

High Court Judge Nkukuleko Hlophe heard how two men charged with attempted murder fired a hail of bullets at the land owner after claiming that the land he occupied belonged to one of the assailants.

Mefika Matsebula was charged together with Solomon Malambe for attempting to kill Mandla Ngwenya at Hawane under Nkhaba *Umphakatsi*. Leading evidence in court was Albert Jele, who is an overseer of Hawane (Sibondza) who told the court that while inside his house, he heard two gun shots fired on different intervals below his homestead.

Jele said in no time, Matsebula's daughter who is married to Matsebula and his grandchildren, stormed into his house running for cover. Later he was told that Matsebula and Malambe were involved in a fight with Ngwenya.

Inspected

Jele said after the incident he was taken by the police who inspected the area where two empty cartridges were found at the scene of crime.

This, after Ngwenya in the company of other family members, approached Matsebula and enquired why he had built on land that belonged to the Ngwenya family. This was when corrugated sheets to the main house were ripped off by the angry Ngwenya family and left on the ground before leaving for their Mbabane home.

Ganged

They, however, later came back in the evening only to find that Matsebula had allegedly ganged up with Malambe armed to the teeth with their shot guns and this was when they shot at Ngwenya whom they seriously injured in his arm, further shattering windows with the bullets.

A ballistic expert Inspector Vincent Mbingo also gave evidence to the effect that he examined the firearms and further tested the ammunition of which results confirmed that the cartridges found at the scene were those of the two firearms used in the shoot-

ing.

In defence, Matsebula told the court that he was merely protecting his children in the whole scenario since Ngwenya had chopped off the corrugated iron sheets which might have killed his family.

Matsebula blamed his father-in-law (Jele) for setting him up with the *Umphakatsi* and the Ngwenya family since Jele failed to inform the *Umphakatsi* as *Sibondza* that the land had been allocated to him (Matsebula).

Representing the Crown in the matter is Stanley Dlamini while the two Matsebula and Malambe are conducting their own defence in the matter. Judge Hlophe postponed the matter to July 5, 2017 for continuation of trial as the crown is expected to parade two more witnesses.

SECTIONAL TITLES BILL PASSED INTO ACT

SENATE yesterday passed the Sectional Titles Bill Number 20 of 2014 with amendments into an Act.

The Bill, which had been in Parliament for a longtime, was finally passed into an act after making the necessary amendments to it, which were the same amendments that had been adopted by the House of Assembly.

Passing the Bill the Senators said it was long overdue yet it would benefit the country economically as well as empower and allow people to own property. This Act provides for the division of buildings into sections and common property and for the acquisition of separate ownership in sections coupled with joint ownership in common property.

Senator Mike Temple said it was time that the House passed the Bill into a law as Swazis stood to benefit the most and the country would benefit economically.

Princess Phumelele said the Bill

was in line with vision 2022 as there were certain standards and yardsticks that a country needed to meet for it to be called a first world.

"There are things that we need to have accomplished before reaching 2022 and one of them is having this law in place so that all Swazis have a chance at owning property," she said. She also applauded that it had addressed the issue of citizenship, as this had been an area of concern for senators. After the senators had passed the Bill into an Act, the Minister of

Phiwayinkhosi Mabuza thanked the Senators for working around the clock to have this Bill passed. He said they had drafted the Bill, responding to the needs of the people and they had been getting calls from members of the public enquiring what was holding the Act up. "We would get calls from the public from time to time asking why there was still no law allowing them to purchase sectionals," he said. He said he was happy that this was now an Act as Swazis would now be able to sell and buy property, something that would benefit the country economically.

Zakhele-Ngwane Park road upgrade begins

RESIDENTS of Zakhele and Ngwane Park in Manzini will soon breathe a sigh of relief as the road linking the two townships is being rehabilitated.

The Municipal Council of Manzini had promised the residents the rehabilitation earlier in the year and has finally delivered on its promise.

The rehabilitation of the road starts from the Zakhele Remand Centre traffic lights via Skom, KaZakhali High and further down to Mathayini near the Ngwane Park cemetery.

Municipal Council of Manzini Public Relations Officer Mathokoza Thwala said motorists should take extra caution since the project has begun hence the section of the road between Sihlahleni and Mathayini has been closed.

He said the section would be closed for a maximum period not exceeding a month. "The contractor, Kukhanya Civil Engineering Contractors, has planned on executing the reconstruction works in three phases. The first section is closing the road, laying a new bitumen surface, the contractor then will move on to the next phases," he said. The public relations officer further urged motorists to use the detours that have been arranged and that they will observe all traffic signage that has been put along the road. He further urged parents to ensure that children do not play on the road as there are heavy trucks moving up and down.

"The Municipal Council of Manzini trusts that users of the road will cooperate with the contractor so that it can be completed as soon as possible.

Kukhanya Civil Engineering Contractors has promised to ensure the road is of high quality and that it completes the project within the shortest period possible," said Thwala.

Suspect sneaks dagga into police holding cells

A man from Luhlangotsini has been found in possession of dagga seeds while in a holding cell at the Pigg's Peak Police Station.

Fana Hlatjwako (38) of Luhlangotsini had initially been arrested for theft only for the Pigg's Peak police to find him with 9 grammes of dagga concealed in his jacket.

The theft allegedly happened on May 23 near Luhlangotsini where Hlatjwako allegedly stole clothes worth E1 150 belonging to one Patrick Dlamini. Hlatjwako was arrest this past Saturday afternoon. After his arrest he was taken to the Pigg's Peak Police Station where he was booked before seeing a magistrate. Unfortunately, while at the police station the accused was then found hiding of 9 grammes of dagga leaves and seeds by the police. Appearing inside the Pigg's Peak Magistrate's Court vesterday, Hlatjwako pleaded not guilty to both offences of theft and dagga possession. Senior Pigg's Peak Magistrate Siphosini Dlamini then asked Hlatjwako if he wanted to be admitted to bail and the accused replied to the negative. Dlamini then informed Hlatjwako that his trial date is set for December 18, meaning he will be remanded into custody pending his appearance for trial. According to a press release issued by Elections and Boundaries Commission Chairman Chief Gija yesterday, the misleading and false information circulating in the social media forum on job opportunities invited] the public to apply for the upcoming 2018 General Elections.

"The Elections and Boundaries Commission would like to distance itself from such false infor-

The commission urged the

public to keep calm and that be informed of any developments pertaining the recruitment of the public at the Tinkhundla centres.

"Therefore, the chairman would like to clarify that the Elections and Boundaries Commission is an independent body under the ministry of justice and constitutional affairs not a department in the ministry of home affairs. However, the commission urges the public to continue attending the ongoing civic and vVoter education exercise in their respective chiefdoms in order to be empowered on electoral issues," he said. The country will be going to polls next year, where members of Parliament will be elected to form the 11th Parliament.

Pamela Motsa wins against govt

SHE had taken government to court where she sought relief that the principal secretary in the ministry of natural resources and energy, the Civil Service Commission (CSC) and Attorney General (AG), comply with the government gazette appointing her as Secretary to the Land Control Board.

Pamela Motsa has, however, won an alternative relief of being paid acting allowances.

The PS had been cited as the first respondent, while the CSC and the AG were cited as the second and third respondents respectively.

Acting Industrial Court Judge Musa Sibandze ordered that the PS, who has been cited as ...e first respondent, should pay the applicant the applicable acting allowance she would have been paid for acting as land a dministrator for the period from May 23, 2015 when she last received her acting allowance to date of judgment

Allowances

In her application, Motsa had further sought relief for not changing her job title as Secretary to the Land Speculation and Control Board with respect to grade D4 for remuneration and paying her arrear wages and or allowances with effect from January 2015 in terms of grade D4 and paying her wages in terms of grade D4 as opposed to B4.

The court noted that the applicant was appointed in November 2015 to act in the position of secretary to the land control board due to the retirement of the incumbent to that position and she continued to so act until January 2016.

The applicant during her acting appointment was paid an acting allowance in addition to her normal pay and was not paid at grade D4 during this period as she alleges

The allowances according to papers filed in court, were actually higher than her basic salary as observed by Judge Sibandze.

After her acting appointment elapsed, the applicant was appointed as Secretary to the Land Speculation Control Board by Legal Notice No 8 of 2015, in terms of Section 5 (5) of the Land Speculation Control Act of 1972, and the appointment still subsists and will terminate on December 31 2017 unless renewed.

The court found that an appointment as Secretary to the Land Control Board is not the same as employment as Secretary to the Land Control Board in the ministry of natural resources and e energy.

The substantive secretary to the LCB it appears would also double as secretary to the LCB under the Land Speculation Control Act hence Motsa confused things.

In these circumstances, the court found that Motsa is not entitled to the relief as praued,

however based upon papers filed before it, the court noted the application made in terms of having executed the functions of the office of the secretary to the LCB diligently.

Orders

"The court is alive to the fact that the applicant was paid sitting allowances in respect of various boards, however this does

not detract from the fact that she would still be entitled to an acting allowance for doing the work of the land administrator, in the circumstances, under the prayer of further and or alternative relief, the court orders that the first respondent is to pay applicant the applicable allowance she would have been paid for acting as land administrator for the period from May 23 2015 when she last received an acting allowance to the date of judgment," Judge Sibandze ordered.

With the court having noted that with regard to the Swaziland government, acting appointments are accompanied by allowances and it was therefore unfair to allow the applicant to perform the duties of the land administrator with no acting allowances, the first respondent was ordered to pay costs of the application.



TURN-OUT FOR EZULWINI CIVIC EDUCATION IMPRESSIVE

Stories by Observer Reporter Ezulwini

THE Ezulwini Municipality has been commended for its good turn-out of residents and business community for civic education on the upcoming elections.

It was noted, however, that there were still a substantial number of people who did not attend the civic education meetings.

The civic education meetings were held at the Swaziland Water Services Corporation (SWSC) auditorium and the Royal Villas last week. The civic education exercise is meant to empower residents and stakeholders with information about the upcoming elections before they can register to vote or be voted for.

Coordinator of Local Government Elections from the ministry of housing and urban development Melusi Hlanze made a presentation in both sessions, highlighting key items voters need to know about the elections.

Remarked

"We have been going around different places conducting such civic education and I must say we are quite impressed with the turn-out of residents of Ezulwini," he remarked.

The theme of the elections is 'Be a Champion, form your own government' with sub-themes of accelerating sustainable local development, delivery of sustainable development goals, implementation of a new urban agenda and attaining vision 2022.

The participants in the meetings also asked questions about their voter rights.

The meetings were opened by the town's Chief Executive Officer Vusumutiwendvodza Matsebula, who thanked the residents and stakeholders for coming in their numbers.

Participate

"We thank your interest on how the town is run and we have this forum to give you more information about how you can actively participate in the elections," he said.

The presentation by Hlanze gave an overview of the system used in elections and also highlighted how residents qualify to vote or stand for elections.

He also assured the residents that with each elections, they strengthen the sys-

tems so that there are less incidents of malpractice from voters or candidates.

"The system is computerised and we match your finger prints with your Personal Identification Number card so that we have no situations where an individual produces someone else's card in a bid to have people voting for them," he said.

The elections are provided for by the Constitution of Swaziland in Section 226 and conducted in terms of the Urban Government (Elections) Regulations.

The interactive meetings were both held for about two hours as the residents and stakeholders were taken through each and every step of the elections process. Registration for local government elections started on May 5 and will end June 30.

Residents want to recall councillors

RESIDENTS have expressed a desire to be able to recall councillors who do not perform to their expectations.

This was raised during the civic education for the fast developing town where one of the residents even questioned the length of the term of councillors.

"Why do councillors have a five year term, can this not be reduced to at least three years because if we are not happy with the person voted for now we are stuck with that candidate for the full five years?" asked one of the residents.

In response, Hlanze said the term was stipulated in the constitution. He, however, advised the residents to be very careful

when voting so that they vote for someone they are certain will deliver for them, otherwise they will have the unfortunate situation of being stuck with that individual who was not delivering for the whole term.

Another concern was with the nomination system on why it was the candidates coming with a nomination form instead of them being in a group like in the national elections.

Hlanze said each of the processes had its advantages and disadvantages because even in the group process, some could claim that the officer did not look in their directions and they did not get a chance to nominate their preferred candidate.

'COMMISSION OF ENQUIRY AIMED AT IMPROVING TOWN'

EZULWINI stakeholders have been told not to be disturbed by commission of enquiries or audits as such only serves to improve the town.

This was noted by the Coordinator of Local Government Elections Melusi Hlanze when responding to a question from one of the residents on when the findings of the recent enquiry would be given to residents.

"It is not for me to answer such, I am here to speak on the elections. However, do note that such exercises are merely set up to establish the true picture of any situation that may not appear clear to the honourable minister.

It is not a witch-hunt to get any one out or whatsoever. Take the commission of enquiry to be like an audit.

In the past, some people used to fear auditors yet today many see them as necessary such that they even invite them to come through to the organisation because they help them improve their systems and service delivery," he said.

As such, he stated that an official feedback about the commission of enquiry report could only come officially from the minister and not him since he was very junior to deliberate on such.

Warning against bribery, parties, threats to voters

RESIDENTS participating in local government elections have been warned against engaging in illegal practices in order to be elected.

This warning was sent by the Coordinator of Local Government Election Melusi Hlanze, who highlighted the various outlawed acts that one must not engage in.

"The regulations are clear in terms

of illegal practices. While campaigning is allowed, we do not expect people to start throwing parties to bribe voters to vote for them nor are they expected to threaten other candidates with violence," he said.

Hlanze invited the stakeholders to get a copy of the Urban Government (Elections) Regulations to acquaint themselves on what can be done and what cannot be done.

At both meetings, the residents and business people also asked for an electronic copy of the regulations as well as Hlanze's presentation so that they can study them further.

Hlanze said in some instances, individuals were banned from participating in future elections if found guilty of some of the crimes.

A security guard employed by Sharp Eye Security was fined E15 000 after he was arrested and charged for the possession of

dagga weighing 71.33kg.

The accused person, Kaizer Maziya of Maphungwane, was arrested together with Thembinkosi Matsenjwa, who is alleged to

have been a passenger in the company's vehicle used to transport the said illegal herb.

They appeared before Principal

Magistrate Dumsani Magagula where they faced a charge of contravening Section 12(1) of the Pharmacy Act No. 38 of 1929. The accused persons were represented by Kush Vilakati Attorneys.

When the charge sheet was read to them, the first accused pleaded guilty

to the charge while the second accused pleaded not guilty. Matsenjwa told the court that he was on ly offered a lift

by the first accused person, and was not aware that the vehicle was carrying dagga.

The crown, which was represented by Melusi Lukhele, accepted the pleas without leading evidence to prove commission of the offence. Lukhele, however, handed in a forensic report as part of the evidence. Maziya was accordingly found guilty by the court while the second accused was acquitted and discharged. In mitigation, Maziya asked the court to be lenient when passing sentence, saying he was a first time offender of the law. He stated that he was only taking a chance to make some extra money as he had a family to provide for with the little income he gets as a salary from his employment. Meanwhile, Director of the security company, Mduduzi Dlamini, filed an application to have the company vehicle released to his possession. Dlamini stated that he had no knowledge of his employee engaging in illegal business while using the company's vehicle. He said normally, he allowed Maziya to use the company's vehicle when on duty and also when visiting home. But

> on the day of his arrest, he had not permitted him to take the vehicle anywhere. The motor vehicle was eventually released to Dlamini.

Tindvuna, bucopho want govt to employ participatory communication models

TINKHUNDLA headmen andbucopho are calling upon development officers to engage the people on the ground when bringing and planning development projects in communities.

The community leaders were speaking during a workshop for the constituency headmen and bucopho under Manzini region on Sustainable Development Goals, which was hosted by the ministry of economic planning and development (MEPD) at The George Hotel recently. The politicians said development should start from the people not being imposed on them after being defined and designed by officials. This is the same view that is outlined by the participatory communication approaches.

This was after the principal economist from the ministry said Swaziland had prioritised seven out of the 17 SDGs. The prioritised goals included: decent work and economic growth, quality education, good health and well being, affordable and clean energy, industry innovation and infrastructure, zero hunger, clean water and sanitation.

The officer said it would be difficult for government to allocate funds to fund projects outside these Goals. "The main issue is that all development projects should be

aligned to these SDGs, otherwise if it doesn't speak to them you it won't get funds for that project,' added the officer. This raised the question on who decided on these priority areas. First to question this was Manzini Regional Administrator Chief Gcokoma who asked when did the ministry do consultations and engaged the people before choosing the priority goals. "Do you know that the people from the ministry once constructed a road from Mafutseni to some area? Now when do the people from the ministry come to us to gather our views or consult us before prioritisation?" he said.

On that note, Nhlambeni bucopho said the ministry simply did the planning on its own and such resulted in the planning of capital projects that benefits a few individuals. The Mhlambanyatsi indvuna yenkhundla supported the other speakers as he added that it appeared that the ministry was focusing on the development of structures and leaving out developing the ordinary Swazis.

He noted that more funds were allocated for infrastructure development as opposed to improving lives of the poor.

He also mentioned that they were facing pressure from the people as they now view development as being sold to them, citing the 10 per cent requirement for them to have clean water.

Man arrested for tying, whipping nephew

A man of Malindza appeared before the principal magistrate after he was arrested for allegedly beating up his nephew in a cruel manner.

David Lima was said to have wrongfully and unlawfully assaulted *Senzo with a stick and a plastic pipe several times on the body with intent to cause accused is said to have done this after tying up the boy with a cow's rope on both hands and legs.

Pastor threatens to stab another in fight over debt

A pastor in one of the prominent churches in Matsapha is alleged to have threatened to stab another in a bitter battle over an unsettled debt

This information was revealed to this publication by a congregant, who attends one of the churches belonging to the two

When one of the pastors, Pastor Shabangu was contacted about the matter, he alleged that the feud between him and the pastor in question came after he borrowed Mabuza* (not his real name as he hasn't been reported to the police) his vehicle.

Shabangu stated that he rented out his vehicle to Mabuza who wanted to take his congregants on a trip. The two pastors are alleged to have entered into an agreement that Mabuza was to pay around E3 500 because they were friends and were not strictly doing busi-

However, according to Shabangu, while Mabuza was using his vehicle it broke down and the latter called a tow truck to take it to a garage.

Mabuza is said to have done this in good faith not knowing that the vehicle was not supposed to be towed, as a result as it ended up being damaged.

Shabangu said after that incident, Mabuza

promised to pay him E17 000 or have his vehicle fixed. He also agreed to pay him the E3 500 they agreed on earlier on.

But Shabangu said the only thing Mabuza did was to pay him E800 and never gave him

any money after that.

Shabangu said he decided to call Mabuza in order to get his money back but he did not get a promising response from the pastor as he was met with insults.

Shabangu stated that he even took this matter to court under civil matters, unfortunately due to financial implications and the matter dragging before court, it was dropped.

Shabangu said he did not give up hope of getting his money and decided to visit Mabuza at

his home but that only made matters worse as he found that Mabuza was not present at his homestead.

He alleged that he received a call from the pastor who hurled unpalatable insults at him and

GOVT DRIVER FAILS TO PAY E800 FINE FOR NEGLIGENT DRIVING

ed to the verdict by asking if he could pay E500 first and then at the end of next month pay the E300 balance. Dlamini agreed but warned Dunne to reappear before the Pigg's Peak Magistrate's Court on June 20 with proof of payment.

A Botswana national, who was arrested and charged with money laundering, has been allowed to go to back to his country of origin.

Gwakuba Majebe, who hails from Selebi Phikwe, approached the Mbabane Magistrate's Court seeking to be granted permission to go to Botswana to attend to his medical health last Thursday.

Majebe was arrested on April 21 and charged with money laundering, as he was found with E97 800, which was in South African Rands.


The case appeared before Mbabane Principal Magistrate Fikile Nhlabatsi.

Majebe also submitted, through his lawyer Noncedo Ndlangamandla that he also had to attend to his family issues, as he had his own family back home.

Ndlangamandla, when making submissions on behalf of Majebe, said her client had to be given permission to go to Botswana.

Ndlangamandla added that being in Swaziland was an inconvenience to her client because he had to squat in his friend's place (in the country).

His medication had already run out and he had to go to Botswana to get it.

Majebe is currently out on E5 000 bail and has all along been in the country pending trial, which was set for July 2. He was admitted to bail on April 24, 2017.

Arrested

Ndlangamandla said it was a pity that since April 21 when Majebe was arrested, the state had been unable to gather enough evidence to show that indeed her client committed the said crime.

She also pointed out that it was unfortunate for her client to be arrested before investigations could be done. Such a situation could be prejudicial to him.

The situation could even be worse as the investigation officer took a long time to gather enough evidence that could point out that Majebe committed the crime indeed.

Ndlangamandla pleaded with the court to set a trial date for her client.

She also pleaded with the court to grant Majebe his passport to go to Botswana as he once travelled to that country and came back

Investigations

Meanwhile, the state, which was represented by prosecutor Mbutfo Mbingo, had opposed Majebe's application to go to his country. The state submitted that Majebe's case was still under investigations.

The investigation officer was reported to be in Botswana working on the case. The state pleaded with the court to postpone the matter for another two weeks to allow the investigations to go on.

The officer was reported to be coming back home the past weekend.

RA HOPES FOR BETTER ATTENDANCE FOR MLAWULA - MAGADZAVANE WALK

Mthethwa reported that this would be the second walk following another which was held last year.

She stated that even though last year's event was successful with slightly over 1 000 participants, the organisation was looking forward to an improvement on the number of attendants.

Mthethwa highlighted that the challenge walk offered a variety of experiences as it also allows people of different fitness ability to participate.

The walk has two categories; it consists of the medium trail which is about 6.72 kilometres with an estimated duration of approximately two hours and 40 minutes while the long trail is about



21 kilometres with an estimated duration of approximately six hours.

This event being hosted for the second time with more sponsors and we're hoping for a record breaking attendance from members of the public.

"This will basically be a fun-filled day where people of different ranks will also share ideas while taking part in the walk which will eventually benefit the entire country," said the RA.

LCMC LAUNCH FREE ICT LESSONS FOR PUPILS

PUPILS from the three Siteki giant schools will be delighted to learn that Lubombo Community Multimedia Centre (LCMC) has since launched lessons for Information Communication and Technology (ITC) at almost no cost.

The benefitting schools are Lubombo Central High, Siteki Nazarene High and Good Shepherd High.

LCMC Chief Executive Officer Ambrose Zwane said the organisation has implemented the programme which aims at empowering the pupils with internet usage skills.

Zwane said from this Saturday, they would be providing the lessons at their offices situated behind Lubombo Central High School. To cater for administrative costs, each pupil is required to pay only E5 (five emalangeni) upon arrival. Zwane explained that this amount is mainly for transporting the teachers who will be coming to assist the pupils.

He stated that the programme is mainly aimed at helping the children upgrade in research skills where the use of internet is required. He pointed out that many chil-

dren attending the aforementioned schools come from rural areas, something which limites their knowledge and skills to internet usage. During the lessons which will be provided only on Saturdays, the pupils will get to know of other uses of a cellphone, other than making calls and logging into social networks.

Zwane said they were aiming at encouraging the pupils to use cellphones for purposes of learning to refrain from spending more time on social networks. He further pointed out that there was currently an evident gap between pupils from well-developed schools between the corridors of Mbabane-Manzini and those from the Lubombo region. Zwane said therefore, their aim is bridging this gap.

Meanwhile, Zwane reported that they will be taking in at least 50 pupils from each of the three schools on each day (which will be a Saturday). "We want pupils to know benefitting uses of a cell-phone, rather than social networks," he said. He then urged principals from the schools to encourage pupils to take part in the lessons.

WFP EXTENDS FOOD BY PRESCRIPTION PROGRAMME TO DECEMBER

WORLD Food Programme (WFP) has extended the Food by Prescription programme in the country to December this year.

WFP provides assistance to people living with HIV and TB through the Food by Prescription programme. The programme offers nutrition assessments, counselling and support services to malnourished clients receiving antiretroviral therapy (ART), treatment for TB, or the prevention of mother to child transmission (PMTCT) services, as well as support to their families.

WFP and government aim to improve treatment and recovery outcomes by mainstreaming nutrition into HIV and TB support services. The WFP Report for June reveals that concerns over the food security situation during the lean season and its impact on people under ART and TB/Drug Resistant-TB treatment is compounded by the limited funding for this programme.

On another note, WFP provides a social safety net for young orphans and vulnerable children. The organisation provides nutritious on-site meals to 52 000 ophans and vulnerable children under eight years of age who attend Neighbourhood Care Points (NCPs), many of whom live with relatives or in childheaded households. NCPs provide a safe place for boys and girls to equally access early education and care services.

The report reflects that due to the drought impact, the project has been extended throughout 2017, to allow for assistance to continue in a time of increased need. WFP also continues to support government to strengthen social protection systems.

In April, WFP conducted the last food distribution under the Emergency Operation (EMOP), reaching 71 090 people with a 45 day ration. The primary objective of the EMOP was to provide emergency food assistance targeting the most vulnerable households affected by the El. ..ño induced drought through in-kind food distributions and cash based transfers (CBT). The project

supported the government's response under the National Emergency Response Mitigation and Adaptation Plan (NERMAP), to improve and stabilise household food consumption for drought-affected groups.

The EMOP targeted 250 000 people and ended in May 2017 coinciding with the next harvest. CBT assistance, which was extended through May, reached 142 000 people in April and 56 973 in May. Food distribution ended in April, but CBT were extended one month and phased out in May.

WFP closely monitored the food security situation to tailor its assistance to best meet the needs on the ground. CBT assistance, which was extended through May, reached 142 000 people in April and 56 973 in May.

Furthermore, government is coordinating a multi-sectoral assessment to update information on impact of the drought at the peak of the lean season and the final report will be published in the coming weeks. Preliminary findings from the agricultural survey point to a 37 per cent increase (68 240 hectares) of land under cultivation compared to last year. The 2017 Annual Vulnerability Analysis Assessment started early June with results expected by end of the month and the report finalised by end of August. WFP is the implementing partner for USAID's PEPFAR project which focuses on nutrition intervention targeting people

living with HIV and AIDS and orphans and vulnerable children. Project implementation started in March for selected health facilities in the most food insecure areas. WFP's Food by Prescription project has been extended to December 2017. It remains underfunded and pipeline breaks are expected in July 2017.

"Thanks to recent funding, assistance to orphans and vulnerable children through DEV 200422 will resume in 2017. The project has been halted since May 2016 due to lack of resources. Results from the Swaziland Vulnerability Analysis Committee and IPC analysis indicate that 350 000 people are in need of emergency food assistance, with 640 000 potentially affected by some degree of food insecurity at the peak of the lean season (November 2016 - April 2017). Swaziland faces fiscal and economic challenges, with poor predictions for Southern Africa Customs Union revenue, continued slow economic growth and the devaluation of the South Africa Rand, to which the local currency is pegged. Swaziland's economic situation may also hamper advances in WFP's country strategy approach, which aims towards full national ownership, financial and operational, of food and nutrition security initiatives. The government has endorsed the priorities of the draft strategy," further states the report.

SADC maize output expected to rise by 45%

REGIONAL production in Southern Africa of cereal is expected to jump by almost 45 per cent compared to 2016 when crops were affected by El Niño, with record maize harvests forecast in South Africa and Zambia.

This should help to reduce food insecurity in countries, such as Lesotho, Malawi, Mozambique, Swaziland and Zimbabwe. While worldwide cereal output is near record levels, production outcomes are mixed across the globe. According to a UN report, South America is expected to post strong increases,

However, at the start of the 2017 season, East Africa has suffered insufficient rainfall, armyworm infestations and local conflicts, leaving in the sub-region a record 26.5 million people in need of humanitarian assistance.

The report warns that the situation could be aggravated further as the lean season peaks, saying, "An estimated 7.8 million people are food insecure in Ethiopia, where drought has dented crop and pasture output in southern regions."

Moreover, cereal domestic prices reached exceptionally high levels in May, with the local cost of maize jumping by as much as 65 per cent this year in parts of Kenya, Tanzania and Uganda. The report also notes that a severe drought in Sri Lanka, followed by heavy rains and local flooding in late May, will likely reduce the country's paddy production by nearly a third, compared to the average. Meanwhile, protracted fighting and unrest are swelling the ranks of the displaced and hungry in some parts of the world, even as

large agricultural harvests in some regions are buoying global food supply conditions, according to a new report by the United Nations agriculture agency.

"Civil conflict continues to be a main driver of food insecurity, having triggered famine conditions in South Sudan and put populations in Yemen and northern Nigeria at high risk of localised famine," said the UN Food and Agriculture Organisation on its Crop Prospects and Food Situation report.

FAO also notes that adverse weather conditions are exacerbating the threat

of famine in S o m a l i a . Refugees from civil strife in countries such as Iraq, Syria and Central African Republic are putting additional pressure on local food supplies in host communities.

It also points out that some 5.5

million people are estimated to be severely food insecure in South Sudan, where maize and sorghum prices are now four times higher than in April 2016. In Somalia, about 3.2 million people need food and agricultural emergency assistance, while in Yemen the figure is as high as 17 million. In northern Nigeria, disruption caused by conflict has left 7.1 million people facing acute food insecurity in the affected areas, with even more deemed to be in less dire but still "stressed" conditions, according to the report.

According to FAO, 37 countries require external assistance for food including Swaziland. They are namely; Afghanistan, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Congo, Democratic People's Republic of Korea, Democratic Republic of the Congo, Djibouti, Eritrea, Ethiopia, Guinea, Haiti, Iraq, Kenya, Lesotho, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Mozambique, Myanmar, Niger, Nigeria, Pakistan, Sierra Leone, Somalia, South Sudan, Sudan, Syria, Uganda, Yemen and Zimbabwe.



ORGANISATIONS are successful or not, partly on the basis of how well their leaders lead, but also in great part on the basis of how well their followers follow. Surely improving the performance of followers should be worthwhile for any leader.

Often, people think the leader plays a solo game when leading a group yet the people being led also play an important part, hence the leader/ follower relationship is symbiotic. The leader is the visible person in the relationship such that many people do not think on what is the role of the follower and how does it affect the leadership behaviour and effectiveness.


The Job of Effective Followers

When followers recognise and accept their significant position, then they can fully develop responsible, synergistic relationship in their organisation. According to Chaleff (2003), there are three positions that followers need to understand in order to fully assume responsibility as followers.

 Understand the power - followers need to understand the power dynamics of both the leader and that which they possess as followers and know how to use it. Followers have far more power than they know. They just need to understand; the sources of the power, whom they serve and the tools they have to achieve the group's mission. Followers have a unique vantage point as follower or team member, but they have to know that and use it effectively.

 Appreciate the value of the leader— Appreciating the value of the leader and the contributions he or she makes to forward the organisation's mission. Followers need to understand the pressures upon the leader that can wear down creativity and good humour. Followers can learn how to minimise these forces and contribute to bringing out the leader's strengths for the good of the group and for the common purpose.

E LEADER-FOLLOWER RELATIONSHIP



 Work toward minimising the pitfalls of power-by helping the leader to remain on track for the long-term common good. We are all witness to how power can corrupt, and it takes courage and skill to speak up. Followers can learn how to counteract politely the dark tendency of power.

The five dimensions of courageous followership

Chaleff (2003) identifies and defines what is required of followers to become equal partner with the leader in fulfilling the purpose of the organisation.

 The Courage to assume responsibility - courageous followers assume responsibility for themselves and the organisation. They do not hold a paternalistic image of the leader or organisation, nor do they expect either to provide for their security and growth or give them permission to act. They initiate values based action. Their "authority" comes from their understanding and ownership of the common purpose.

• The Courage to serve - courageous followers are not afraid of hard work and they assume additional responsibilities to unburden the leader and serve the organisa-

They stand up for the leader and the tough decisions he/she must make. They are as passionate as the leader in pursuit of the common purpose.

• The Courage to challenge courageous followers give voice to the discomfort they feel when the behaviours or policies of the leader or group conflict with their sense of what is right. They are willing to stand up, stand out, to risk rejection and to initiate conflict in order to examine the actions

of the leader or group when appropriate.

 The Courage to participate in transformation - courageous followers champion the need for change and stay with the leader and group while they mutually struggle with the difficulty of real change. They examine their own need for transformation and become full participants in the change process as appropriate.

• The Courage to take moral action - courageous followers know when it is time to take a stand that is different from the leaders. The stand may involve refusing to obey a direct order, appealing the order to the next level of authority, or tendering one's resignation. This may involve personal risk but service to the common purpose justifies and sometimes demands such action.

Robert Kelley (1988) stated that

"In an organisation of effective followers, a leader tends to be more an overseer of change and progress than a hero. He assets that as organisational structures flatten, the quality of those who follow will become more and more important. Kelley observed four essential qualities of effective followers.

They manage themselves well: The key to being effective as a follower is paradoxically the ability to think for oneself. Followers also see themselves as equals to the leader they follow.

 They are committed to a higher purpose: They work towards the purpose of the organisation, and to certain principles and values outside of themselves. If they see a misalignment with personal values, they may withdraw their support either by changing jobs or by changing leaders.

• They build their strengths: They have high standards of performance and are continually learning and updating their skills and abilities. They seek out extra work and responsibilities gladly in order to stretch themselves.

• They take risks: They are credible, honest and have the courage to speak up. They give credit where due, but also admit mistakes. They are insightful and candid and they are willing to take risks. They can keep leaders and colleagues honest and informed.

Emotional Intelligence when interacting with the boss

Part of the problem in following responsibly and courageously lies in the tendency for people to relate to authority figures as they would in a parent-child relationship. Early childhood memories are deeply embedded in the subconscious and trigger old patterns of behaviour and emotion in a split second. These memories are often outside of our awareness, and it does not take much; a look, a tone of voice, to trigger anger or anxiety when confronted by the boss. Developing one's emotional intelligence as Daniel Goleman(2002) puts it can help regulate the split second reactions and allow more productive and satisfying interactions.

BISHOP KEITH HARRINGTON'S CORNER

SHIMEI was of the same family as King Saul and evidently opposed the accession of David to the throne of Israel.

We first meet him on one of the darkest days in King David's life.

David's son, Absalom, has gained the upper hand in his bid to replace his father on the throne. David and his entourage flee Jerusalem in disarray. Adding to the humiliation of the hour is a young Benjamite running parallel to the road, cursing David and pelting him with dirt and stones.

The humility of David in this instance shines

Not only did he take Shimei's critical words kindly, but he attributed them to the Lord, saying, "for the Lord hath bidden him." It is one thing for any of us to accept criticism when offered graciously, but quite another not to react when attacked publicly and in an unkind manner, let alone accompanied by curses and vio-

David's flight took him to the mountain retreat of Mahanaim where he regrouped his forces and went forth to defend his kingdom against the usurpation of his son. The battle went successfully for the king. His son Absalom was killed to the deep grief of his father. David returned to Jerusalem in triumph to continue

As he re-crossed the Jordan river we again meet Shimei, this time in a far different attitude. No longer cursing David with bold braggadocio, he assumes the position of the humble penitent. Once again David rejected the counsel of his nephew Abishai, and graciously forgave the groveling Shimei.

He refused to mar the joy of his triumphant return with a show of vengeance on his enemies. Judgment Deferred If the Bible narrative stopped here, we would have a lovely anecdotal account of forgiveness for sins against our-

But the record of Shimei picks up again many years later, when David is old and about to turn over the kingdom to his son Solomon. We find our scripture reference in 1 Kings 2 verses 36 to 46:36. The king sent for Shimei and told him, "Build yourself a house in Jerusalem and live there, but don't go anywhere from there. 37 If you ever leave and cross the Kidron Brook, you can be sure that you'll die. You'll be responsible for your own death." 38 Shimei replied to the king, "What your majesty has decreed is acceptable to me. I'll do what you've said."

Escaped

So Shimei lived in Jerusalem for quite some time. 39 But three years later, two of Shimei's servants escaped to Maacah's son Achish, the king of Gath. Somebody told Shimei, "Look! Your servants went to Gath!" 40 So Shimei got up, saddled a donkey, and travelled to Gath to find his servants. He found them and brought them back from Gath.

ARE ZUMA'S ALLIES JUMPING SHIP


a challenge to Zuma's staunch allies including the Free State premier and the ANC Youth League.

IT isn't hard to see that the reason why Nkosazana Dlamini-Zuma was installed as the chairperson of the African Union (AU) was to keep her at arm's length in a way that wouldn't compromise her esteem or give her access to influence here at home.

After all, she was always set to be a proxy-president, on behalf of Jacob Zuma.

I suppose it's not a bad game plan, and the candidate, lured by the promise of executive power, would be all too willing to play along. The same can be said of the former Mayor of Johannesburg, Parks Tau, who remains president of a forum called the United Cities and Local Governments. Science has the power to boost farming in Africa

THE agricultural sector is the world's largest single employer. It provides jobs for more than 40 per cent of the global population. It's also the largest source of income and jobs for poor, rural households.

It is, by and large, a successful sector. There have been huge improvements in yields and food production over the past five decades. More cereals have been produced annually during the past 40 years than in any earlier period. It is also predicted that more grain will be harvested in 2017 than in any year in history. This is as a consequence of scientific advances, increased fertiliser use and favourable rainfall patterns. Many of these gains have been felt in Africa. Improved seed varieties, new fertilisers and pesticides, improved credit and market access have all played a role. So have scientific innovations such as improved and more reliable weather prediction, improved drought tolerance and increased resistance to extreme climatic conditions, and cross-breeding for improved efficiency. And yet hundreds of millions of people in Africa are going hungry every day. Globally, 800 million people are categorised as chronically hungry. Around 30 percent of them - 227 million people live in Africa.

A project in Uganda provides an excellent example. Ugandan scientist Robert Mwanga won the 2016 World Food Prize for his work in addressing Vitamin A deficiencies. So where is the disconnect between

Farmers can pocket E14.6m from pork import substitution

IF the country could be able to substitute the current import volume of pork through local supply, pig farmers could pocket over E14.6 million more.

This is according to data presented by the ministry of agriculture during the pig industry seminar which was recently hosted by the Small Enterprises Development Company (SEDCO) in conjunction with LULOTE and Sefika Piggery.

Ministry of agriculture's Xolani Ndlangamandla said pig farmers were currently cashing just about E16 327.

He said looking at the current import volume, there was a potential that pig farmers could cash in over E14.6 million more. However, he said the country still remains a net importer of pork and pork products.

"There is a need for developmental interventions to help uplift the level of local production of this commodity," he said.

In line with developing and improving the pig industry, the ministry has come up with interventions which were informed by the department's strategic plan and the Swaziland National Agriculture Investment Plan (SNAIP).

As part of the developmental interventions, Ndlangamandla said farm-

ers were encouraged to form organised commodity groups or cooperatives from grassroots to national level in an effort to enable bargain power in; bulk buying, input price negotiation, establishment of central meat centres or markets, pig/pork price negotiations and other associated benefits.

He said farmers were also urged to explore other possible markets within the Southern African Development Community (SADC) region.

"Other interventions also include

the provision of pig production training to farmers to promote commercial production and entrepreneurship, and the provision of animal health services to treat and control pig diseases, thereby ensuring veterinary public health, so that the country's meat products access both local and external markets," he said.

The ministry is also at the forefront of the implementation of the Pig Industry and Enhancement Project

The ultimate objective of the project is to stimulate job creation, income generation, food and nutrition security.

Ndlangamandla said under the project, they were also looking to renovate and expand the existing pig houses, increase the supply of breeding stock to smallholder farmers and construct an Artificial Insemination (AI) centre.

He said the AI centre was now 80 per cent complete.

The aim of the centre is to locally produce pig semen straws to meet national demand.

"The centre is projected to be fully operational by end of July 2017," said Ndlangamandla.

Also, he said currently, an inventory of pig producers/farmers was being conducted and GPS coordinates were recorded for the Hhohho and Lubombo regions.

"The Shiselweni region is almost done while the Manzini region is still pending," he said.

He said the aim was to come up with a pig identification system and enrol all pig farmers in the country and their pigs into the Swaziland Livestock Information and Traceability System (SLITS) data base.

Ndlangamandla urged farmers to ensure sustainability of the PIEP project and that it serves the purpose for which it has been established, that is job creation, income generation and food and nutrition security, culminating in the improvement of livelihoods.

AMID the recent marginal increase of the country's inflation rate, **NKC African Economics says** they see further hikes of the bank rate by the Central Bank of Swaziland (CBS) in the near term as unlikely.

The CBS kept the bank rate and prime rate unchanged at 7.25 per cent and 10.75 per cent in May, respectively.

Dlamini said this partnership comes with economic opportunities that also have positive long term tourism boost.


"This partnership comes with a lot of value to us because we now have a niche of people who will add to the number of tourists who were already coming to Swaziland.

The rally started at Malelane on Friday and proceeded to the country, where the group spent a night at Pigg's Peak Hotel where they were hosted for a dinner.



Sibanye fires 1 500 wildcat strikers

JOHANNESBURG - Sibanye Gold has fired around 1 500 workers taking part in a wildcat strike at its Cooke mine, it said on Thursday, prompting an angry reaction from the National Union of Mineworkers (NUM).

Workers at the mine downed tools over a week ago, angered by a company drive to root out illegal miners which has included the arrest of employees for collusion and taking food down to the illegal miners working underground.

Illegal gold mining has plagued South Africa for decades, and Sibanye has vowed it will clear all illegal miners from its shafts by January 2018. The Cooke mine employs close to 4 000 underground miners and Sibanye said the sacked workers could appeal their dismissals. NUM said earlier that nearly 2 000 miners were fired. Sibanye said 793 NUM members had been dismissed. Reuters

... Sibanye Gold secures two-year wage agreement

JOHANNESBURG - Sibanye Gold announced yesterday that it has secured a two-year wage agreement with the United Steel Workers of America, International Union, the representative union at its Stillwater Operations in Montana, USA.

Last month, Sibanye completed the acquisition of Stillwater, the United State's sole provider of platinum and palladium, for \$2.2 billion (about R30 billion), in a bid to create a premier global precious metals miner. Sibanye said negotiations with the United Steel Workers of America, International Union at East Boulder, would take place at year end. In terms of the agreement, there will be a two per cent general wage increase for all job categories effective from June 2, this year to January 1, 2018, with a further one per cent increase effective from January 1,

2018 to June 1, 2018. A two per cent annual increase will be in effect for the second year of the agreement, from June 2, 2018 to June 1, 2019.

Sibanye Chief Executive, Neal Froneman, said they were very pleased to have secured this wage agreement soon after having acquired the Stillwater Operations. "We note and are encouraged by the sensible and mature manner in which stakeholders have engaged, to agree on a mutually favourable outcome for the company and employees,' Froneman said.

"We look forward to similar engagement with all of our stakeholders at the Stillwater Operations and are optimistic about the important role these operations will play in the future of the Sibanye Group." Sibanye is the largest individual producer of gold in South Africa. African News Agency

UK pleads for increased aid to drought-stricken

ADDIS ABABA - The United Kingdom called for increased aid to East Africa and pledged R1.5trillion to the region, which was gripped by a drought. Two-thirds of the money would go to Somalia, while the rest would be allocated to Ethiopia. The funds were expected to assist the more than two-million people in need of food, water and medical supplies. "This health centre shows exactly why UK Aid is making a difference here in Ethiopia," said UK Development Secretary Priti Patel about aid in that country. CAIRO - Dalal Abdel-Qader, a 43-year-old mother from Cairo, is doing something that has for centuries been the exclusive domain of men being a "mesaharaty," or the person who walks the streets before dawn calling out to wake up the devout for their last meal, "sahur," before their dawn-to-dusk fast. It's a seasonal job that lasts for the duration of Ramadan, the holy month for Muslims during which they refrain from food and drink from dawn until sunset. It's neither salaried nor full time, but those who take up the job do so in part to serve their community and make a little extra money in tips. Abdel-Qader, also known as Hajjah Dalal, does not deviate from the methods of her male peers, following in the footsteps of her late brother Ahmed, a mesaharaty before he died. AP

Human rights defenders face death sentence

KHARTOUM - Sudan's authorities are under pressure to release prominent human rights defenders facing the death penalty or life imprisonment for allegedly inciting an uprising against the state. Ibrahim Adam Mudawi and his colleague Idris Eldoma Hafiz face six charges such as "undermining the constitutional system" and "waging war against the state". Rights groups have denounced the allegations as trumped up and linked to their human rights advocacy. The trial is underway in the capital Khartoum. "Human rights work is not a crime, so Dr Mudawi and Hafiz must be immediately and unconditionally released," said Muthoni Wanyeki, Amnesty International's Regional Director. African News

BAMAKO - Gunmen on Sunday attacked a luxury resort popular with Western expatriates just outside Mali's capital, Bamako, killing two people in what the security minister called a terrorist attack, while 36 guests were rescued. Four gunmen arriving on motorbikes and a car stormed Le Campement Kangaba, near Dougourakoro, to the east of the capital Bamako, a resort that foreign residents visit for weekend breaks. Malian security forces backed by French troops deployed to push them out."At first we thought they were armed bandits but we know how armed bandits operate, they don't hold territory, so now we think it is a terrorist attack, Mali's Security Minister Salif Traore told journalists.

US ENVOY ASSESSES DARFUR AHEAD OF **UN FORCE DRAWD**

EL-FASHIR - The top US envoy in Sudan on Sunday embarked on a four-day trip to Darfur to assess security in the war-torn region as the United Nations prepared to downsize its 17 000-strong peacekeeping force.

The visit of Steven Koutsis, Washington's charge d'affaires in Khartoum, also came just weeks before President Donald Trump's administration was set to decide whether to permanently lift a two-decades-old US trade embargo on Sudan.

A joint report sent to the UN Security Council last month by the African Union and the United Nations recommends that the ceiling should be set for military troops to be cut by 44 per cent and the maximum number of police reduced by 30 per cent in the joint peacekeeping force, UNAMID. Ahead of the expected drawdown, Koutsis embarked on a visit to Darfur for a firsthand assessment of the situation in the region. The envoy met several Sudanese and UN officials, as well as tribal chiefs, academics and members of civil socicapital of El-Fashir.

Zim minister's home 'so huge police failed to notice break-in'

HARARE - Zimbabwe Defence Minister Sydney Sekeramayi's home in an affluent suburb of Harare is so big that the police officer guarding it "failed to notice" a break-in, state media reported on Sunday.

Thieves early on Friday morning jumped a wall, used bolt-cutters to cut an inside fence and then broke a window to gain access to the minister's house, in the leafy Borrowdale suburb, according to the official Sunday Mail.

Said the paper: "A police officer guarding the house is said to have failed to notice the incident because the property is huge and may require more people to monitor it.'

President Robert Mugabe, 93, also has a palatial home in Borrowdale: a blue-roofed pagoda-style mansion where he hosted his only daughter Bona's wedding in 2014. Finance Minister Patrick Chinamasa has a home in the suburb too: in fact, Sekeramavi and Chinamasa have houses that are close to each other.

The lavish lifestyles of some ruling party officials - and those connected to them - is regularly a matter of debate in Zimbabwe, which is mired in a worsening cash crisis. It's not clear exactly how much a Cabinet minister earns.

But in February this year it was revealed that Mugabe and his two vice-presidents were likely to earn a combined \$672 000 in 2017. Most Zimbabweans earn less than \$500 per month. News24

"How high monthly instalments for his Toyota Quantum are crippling his business."

LAST Thursday saw Gauteng (South Africa) taxi drivers bring parts of the province to a standstill when they staged a protest over the price of the Toyota Ouantum taxi - which costs more than R400 000 - and the high interest they're being charged by SA Taxi Finance

The issue was brought to light during a taxi protest in Durban


Sipho Mabuza* has worked in the taxi industry for more than a decade and says he's become "a slave to his instalment" because he's not making any profit. Mabuza


bought his taxi about two years ago and still has two years to pay it off. He says he won't reap any rewards for the next three years. "For me, for the taxi industry, the price is too exorbitant," he Instalment

"I'll give you an example: I have a Quantum operating from Manzini to Matsapha. This Quantum is making me E16 000, and I have to pay an instalment of R10 000. Now I'm left with E6 000. I still have to pay the drivers. So you're left with nothing."

Mabuza alleges he bought his taxi for more than R300 000 because it had been a repossessed car from one of the local banking establishments and was a 2010 model. He had to pay instalments of E10 250, which amounts to E615 000 for the taxi over a five year period. He adds that the association also has no assistance whatsoever whenever he has problems with the Quantum, yet he has to pay exorbitant amounts for membership subscription. "One can only hope government will look into and act accordingly in the immediate future" said the businessman.

Mercedes-Benz issues global recall of 1 million cars

MERCEDES-BENZ - which recently surpassed BMW as the biggest selling luxury car manufacturer in the world for the first time in more than a decade - has had to recall certain A-Class, C-Class, E-Class and CLA cars as well as GLA and GLC SUVs manufactured between 2015 and 2017 after 51 cars caught alight as a result of a faulty starter fuse.

No deaths or injuries have been reported thus far, but the automaker isn't taking any

chances and will begin a US recall in July this year to fit affected vehicles with an additional fuse.



LONDON VAN INCIDENT IS 'POTENTIAL TERRORIST ATTACK'

LONDON - British Prime Minister Theresa May said an incident in which a van ploughed through pedestrians near a mosque in north London overnight was being treated "as a potential terrorist attack".

"I will chair an emergency meeting later this morning. All my thoughts are with the victims, their families and the emergency services on the scene," she said in a statement yes-

A van ran into pedestrians near a north London mosque, killing one man and injuring eight others in an incident that police on Monday said was being investigated by counterterrorism officers.

The 48-year-old driver of the van was detained by members of the public and then arrested by police, as Muslim leaders said worshippers were specifically targeted after leaving prayers at the mosque shortly after midnight.

The incident comes after two deadly Islamist-inspired attacks this year that used vehicles to ram pedestrians -- a stabbing spree earlier this month in the London Bridge area and a March attack in which a man drove a car into crowds on Westminster

"One man was pronounced dead at the scene... Eight people injured were taken to three separate hospitals," police said in a statement, adding that two other people were treated for minor injuries.

The Muslim Council of Britain said the vehicle hit people as they were leaving the Finsbury Park Mosque, one of the biggest in the country. The attack comes during the Muslim holy month of Ramadan, when people attend prayers at night.

The Finsbury Park Mosque gained notoriety more than a decade ago for sermons by radical cleric Abu Hamza al-Masri, who was sentenced to life in a US prison in January 2015 for his conviction on terrorism-related charges. A new board of trustees and management took over in February 2005, a year after Abu Hamza was arrested by British police, since when attendance has greatly increased among worshippers from various communities, according to the mosque's

Schoettes, counsel and HIV Project Director at Lambda Legal, resigned last Tuesday from the Presidential Advisory Council on HIV/AIDS, along with Lucy Bradley-Springer, Gina Brown, Ulysses Burley III, Michelle Ogle and Grissel

The council can have up to 25 members.

"The Trump administration has no strategy to address the on-going HIV/AIDS epidemic, seeks zero input from experts to formulate HIV policy, and - most concerning - pushes legislation that will harm people living with HIV and halt or reverse important gains made in the fight against this disease," Schoettes wrote.

Russia slams Trump's 'Cold War' policy on Cuba

MOSCOW - Russia said it was reaffirming its "unshakeable solidarity with Cuba."

Russia's foreign ministry on Sunday said it regretted US President Donald Trump's policy reversal on Cuba, calling it reminiscent of the Cold War

"The new line towards Cuba announced by US President Donald Trump takes us back to already half-forgotten rhetoric in the style of the Cold War," the ministry said in a statement on its website.

Decessor

Trump vowed last Friday to overhaul his predecessor Barack Obama's deal to restore ties with Cuba, promising instead to support the Cuban people against Raul Castro's government.

Moscow said Trump's policy changes showed that "anti-Cuban discourse is still widely in demand. This cannot but cause regret."

It said that easing of sanctions under Obama was a "wellthought-out political decision in which there were no losers except marginal Castro opponents." Russia said it was reaffirming it's "unshakeable solidarity with Cuba."

Cuban President Raul Castro visited Russia in 2015 while President Vladimir Putin visited the island on a tour of Latin America in 2014, meeting both the president and the revolutionary leader Fidel Castro, who died last year. AFP

Macron wins clear majority in French parly, but falls short of landslide

PARIS - French President Emmanuel Macron's centrist party swept to a large majority in parliamentary elections last Sunday, although it fell short of a predicted landslide.

Macron's year-old Republique en Marche (Republic on the Move, REM) and their allies won 351 seats in the 577seat National Assembly, final results showed after the second round of an election which has eliminated many high-profile figures. The party Macron founded just 16 months ago has re-drawn the French political map, although the winning score was considerably lower than the 470 °ats predicted by some pre-vote surve But it gives the 39year-old presiden. ne of France's biggest

LISBON - More than 1 500 firefighters in Portugal are still battling to control major wildfires in the central

region of the country, where one blaze killed 62 people.

Reinforcements arrived yesterday including more water-dropping planes from Spain, France and

Italy as part of a European Union co-operation programme.

Portugal is observing three days of national mourning after the wildfire which broke out this past Saturday night


around the town of Pedrogao Grande. It is by far the deadliest wildfire on record.

Syria, Iraq troops link at border

BEIRUT - Syrian troops and allied militias met up with Iraqi forces at one crossing point along their shared border this past Sunday for the first time in years, in a step described as a major achievement by the Syrian military in their fight against the Islamic State group. The development reported by pro-government media this past Sunday comes a day after Iraqi forces captured a border crossing point with Syria, al-Waleed, from the ISIS militants. It was not immediately clear if the Syrian forces reached a new point along their border with Iraq or whether it was the Iraqi forces that had moved northeast of their newly captured point.

Qatar accused Arab nations of 'publicity stunt'

DOHA - Qatar hit out yesterday at four Arab nations for cutting diplomatic ties and transport links, over Doha's alleged support for terrorism. Qatar accused the group of a "publicity stunt" aimed solely at attacking its image and reputation. Saudi Arabia, the United Arab Emirates, Bahrain and Egypt cut ties with Qatar on June 5 in the worst diplomatic crisis in the region in years."The blockade has been ongoing for two weeks and the blockading nations have offered no formula for resolving the crisis," said Sheikh Saif Bin Ahmed al-Thani, Director of Qatar's government

The venue remains the classy Royal Swazi Sun Gigi's Resturant. Mamba revealed that James will be serenading the crowd with his soulful and RnB set.


"We moved the dates to June 29 so to accommodate Alexander's guest appearance. We have been working together for a while and this opening compelled us to stretch the date," said Mamba.

Perez to remain as Real Madrid president until 2021

MADRID - Florentino Pérez will remain as president of Real Madrid until 2021 after no other candidates ran against him, the Spanish champions announced yesterday.

"As no other candidature was put forward to the board ... it is proclaimed that Florentino Pérez Rodríguez is President of Real Madrid," the club said in a statement.

It will be the third term for the 70-year-old construction magnate who has spent 15 years at the helm of Europe's most successful club -- 2000-2006 and since 2009.

However his opponents criticised reforms in the club statutes which have toughened criteria

GLASCOW - Celtic could be set

for aspiring candidates.

Candidates must now have been a member of Real for over 20 years, compared to the old requirement of 10 years, and have a personal fortune of over 75 million euros (R1.07 billion). Under Perez, Real Madrid have won three Champions League titles in four seasons. The club -- which also won La Liga last season -- lead the way in the elite European competition with 12 trophies.

Among the issues Perez will have to deal with is Portuguese superstar Cristiano Ronaldo who is threatening to leave Spain after running into problems with Spanish tax authorities. *AFP*

MUNICH BRAND RONALDO LINK 'HOAX OF THE DAY'

MUNICH - Cristiano Ronaldo might be leaving Real Madrid this summer but he certainly won't be turning up at Bayern Munich.


The Bundesliga champions emphatically rubbished reports linking the Portuguese with a move to the Allianz Arena yesterday.

On their website, Bayern billed the suggestions the 'hoax of the day', as they issued a categorical denial of interest in the 32-year-old.

Ronaldo has grown unhappy in Spain after being accused of hiding money, earned through the sale of his image rights, from the taxman.

Manchester United and Paris Saint-German have both been mentioned as potential destinations in the event of the superstar leaving Madrid, while the Italian newspaper Gazzetta dello Sport said Bayern were in the mix.

But Chairman Karl-Heinz Rummenigge has broken protocol to nonsense the



speculation. "We're used to being the subject of intense transfer speculation during transfer windows," he said in a statement. "Normally we don't comment on rumours, but in this case, we

would like to make our position on Cristiano Ronaldo absolutely clear: This rumour is completely unfounded and must be consigned to the realms of fantasy." **Daily Mail**

OSCAR SPARKS MASS BRAWL IN CHINESE LEAGUE

SHANGHAI - Brazilian international Oscar triggered a mass brawl in the Chinese Super League as players and staff from his Shanghai SIPG side and opponents Guangzhou R&F scrapped on the pitch.

After the former Chelsea midfielder appeared to fire the ball deliberately twice at Guangzhou players, he was rushed by several opponents, fell to the ground and a melee broke out.

One player from each side was sent off as the opening of the CSL transfer window was marked in rambunctious style.

The fight erupted just before halftime of this past Sunday's CSL clash at Guangzhou R&F, where Andre Villas-Boas's SIPG were attempting to keep up the pressure on league leaders Guangzhou Evergrande.

Oscar, who cost SIPG a whopping 60 million euros (\$67-million) in the last transfer window to become the biggest transfer in Asian football history, sparked the confrontation when

he deliberately lashed the ball twice at R&F players. When order was restored after pushing and shoving, R&F's Li Tixiang and Shanghai's Fu Huan were dismissed and three others were booked.

Oscar was unhurt and the fiery encounter finished 1-1 to leave SIPG four points behind reigning champions Guangzhou Evergrande.

ABIDJAN - Former Ivory Coast teammates of Cheick Tiote attended his funeral service in the country's capital of Abidjan.

The former Newcastle United midfielder passed away earlier this month after suffering a heart attack during a training session with his Chinese club Beijing Enterprise.

Members of the Ivory Coast squad were present, including Tiote's former international colleagues Kolo Toure, Wilfried Bony and Salomon Kalou.

Tiote left Newcastle in February after nearly seven years at St James' Park, during which time he made 156 appearances and scored one goal.

After a memorial service was held in Beijing earlier this week his body was flown back to Ivory Coast ahead of

Sunday's funeral.

Wilfried Bony was among the pall-bearers as his coffin arrived last Thursday.

Ex-Newcastle team-mate Papiss Cisse, who plays for Shandong Luneng, paid tribute to Tiote during the memorial in

China.

I lived some extraordinary moments with this man and today he's gone,' said Cisse at the service as he fought back tears.

Beijing Enterprises players were also present at that service as they paid their respects to Tiote.

Sportsmail revealed earlier this week that Beijing Enterprises had no emergency cardiac equipment at their training base which which to treat him.

And Manchester United legend Andy Cole questioned whether more can be done to protect players who suffer from heart problems.

If someone is only 30 and they pass away, the question that is naturally going to be asked is 'Why? What's gone on there? Why has he passed away so early?', Cole said to BBC Radio Five Live.

'It's a strange one. Cheick Tiote hadn't been in China that long - a few months -so he must have had a medical to complete the transfer. Was nothing picked up in that medical?

'Is anything actually being done? Is it being looked into? We need to nail it down and get to the bottom of why and what it is.

Because it seems to be happening to more and more professional footballers -fit, strong men.'

REAL MADRID BOSS PEREZ TACKLES RONALDO PROBLEM

Madrid -Florentino Pérez's first task after being re-elected unopposed as Real Madrid President yesterday will be to appease superstar Cristiano Ronaldo amid speculation the four-time world player of the year wants to leave.

"As no other candidature was put forward to the board ... it is proclaimed that Florentino Pérez Rodríguez is President of Real Madrid," the Spanish and European champions said in a statement. The 70-year-old construction magnate's third term in charge of Europe's most successful club spanning 15 years - 2000-2006 and since 2009 - was rubber stamped at a ceremony at the Santiago-Bernabéu Stadium yes-

And among the first issues he will have to deal with is superstar Ronaldo - who he bought in 2009 from Manchester United for a record 94 million euros (\$105.3 million).

Ronaldo is threatening to leave Spain after running into problems with tax authorities.

The frenzy of speculation began soon after Ronaldo was accused last week of a 14.7 million euro tax evasion through offshore companies.

The Portuguese international is currently in Russia competing for the European champions in the Confederations Cup.

And according to Spanish sports daily Marca, Ronaldo has told his teammates: "I'm leaving Real. I have made a decision. There is no turning back."

Portuguese sports daily A Bola also claimed that Perez had already been informed of the 32-yearold's decision.

There has been speculation that Ronaldo is trying to put pressure on Real so that they will bear some of the burden of an eventual fine as Barcelona did for Lionel Messi.

Among the clubs reported to be interested in Ronaldo is former club Manchester United for a fee which could hit 200 million euros, with a possible getout clause of one billion euros.

They have also split coaching duties with head coach Stuart Baxter guiding the "domestic" team and assistant Kait Tembo the "CAF" side.

England-born Baxter officially leaves SuperSport after the final to coach South Africa having masterminded a shock Africa Cup of Nations qualifying win in Nigeria when in temporary charge.

A SuperSport side lacking many first choices came from two goals behind to hold Mazembe 2-2 in Lubumbashi this month with Teboho Mokoena nodding the equaliser. AFP

CHIEFS RESPOND TO BYUMA R5 000 WAGE CLAIMS

JOHANNESBURG - Kaizer Chiefs have responded to the reports that their goalkeeper, Bruce Bvuma, is earning just R5 000 per month, although stated that the terms of his contract are 'confidential'.

The Sunday World reported over the weekend that the 21-year-old is earning what has been described as a 'slave wage', with the South African Football Players' Union having recently voiced their concern about some of the wages in the Premier Soccer League.

Angry Shenhua fans turn on Tevez

CHINA - Carlos Tevez faced growing calls yesterday to be shipped out as angry Shanghai Shenhua fans turned on the Argentine forward and underpressure manager Gus Poyet.

Shenhua fans are fast losing patience with Tevez, who only moved to the Chinese club at the start of the year from Boca Juniors on a reported 38-million-euro salary that makes him one of the highest-rewarded footballers on the planet.

In April Tevez, 33, came under fire from supporters after being spotted at Disneyland Shanghai on the same day he missed an important match

important match due to injury.

With big-spending Shenhua in the lower half of the Chinese Super League (CSL) following a home 2-2 draw with Chongqing Lifan, some have had enough.

Argentine media quoted Tevez as saying he could leave Chinese football at the end of the season and Poyet apologised after Saturday's stalemate, telling state

media: "We did well in attack today, but made two big mistakes in defence and conceded two goals." Tevez, whose itinerant career has seen him take in Manchester City, United and Juventus, has failed to fire because of injury and inconsistent form.

He has scored only once this season, although he did grab an assist in the 2-2 draw, and last month called Chinese players "clumsy" and "very naive".

Tevez has a history of falling out with clubs and managers and one infuriated fan wrote on China's Twitter-like Weibo website after his latest underwhelming showing: "Tevez's attitude is the worst in the team's history."

Another fed-up fan wrote: "Tevez should leave Shenhua. Compared to other players running on the field, Tevez is scared to close down and is afraid to get hurt... Tevez's deal is really not worth it".

One using the name RONAL-DO7wbfp wrote: "He is here for the high salary and the Disney membership.

"If you really can't bear it and is disappointed with the team, then do something to lead the team through the rough times instead of taking strolls on the pitch like a master."

Chinese football fans on social media speculated that the Uruguayan Poyet, a former Chelsea and Tottenham Hotspur midfielder, could be the latest CSL

coach to get the chop after a run of six games without a win.

CSL clubs are not afraid to wield the axe and six coaches were shown the door in the space of just one month recently.

"I ask the players to fight hard and show strong desire for victory. But as the coach I am responsible for the result," the Shanghai Daily quoted the 49-year-old Poyet as saying.







The soft-spoken mentor joined the 'Kappa Boys' at the beginning of


the past season where he eventually parted ways with the side sixmonths after his appointment.






