



# BRILLIANT PUPIL (15) HANGS HIMSELF, LEAVES SUICIDE NOTE

A Form II pupil at Dvokolwako High School reportedly committed suicide by hanging himself.

He is said to have left a suicide note. The 15-year-old schoolboy is said to have left home last Thursday evening apparently for his usual study with his schoolmates, but unfortunately his relatives woke up to find his lifeless body dangling from a tree in the home backyard.

Sources revealed that he was a brilliant and loving pupil in his classroom.

The late pupil was amongst the top pupils in Form II. The pupil who lived with his relatives at Dvokolwako wrote a suicide note hinting why he opted to take his life.

However, it could not be ascertained what exactly he wrote since police regarded the suicide note as confidential.

Deputy Police Information and Communications Officer, Assistant Superintendent Phindile Vilakati confirmed the matter.

Dvokolwako High School Principal Sabelo Sibandze described the incident  No matter what the problem is, committing suicide is not an option. There is no problem shared with friends and relatives that can not be solved. Today is a sad day for the school

as unfortunate and shocking.

"No matter what the problem is, the best is not to commit suicide. There is no problem shared with friends and relatives that can not be solved. Today is a sad day for the school," he said.

He said he was surprised and shocked about what could have led the young boy to take his life.

Sibandze described the late pupil as a peace-loving and brilliant one who was forever on his books. Sibandze said no one knew why he committed suicide.

"Even the suicide note does not state why he resolved to suicide," he said. He said he didn't see the suicide note but the police read it to him over the

# SIPA DISTANCES ITSELF FROM ASIAN INFLUX

**THE Swaziland Investment Promotions** Authority (SIPA) is distancing itself from the questionable influx of the people of Asian origin.

SIPA appeared before the Parliament select committee that was appointed to probe the questionable influx of Asians into the country.

Currently, the committee is taking contributions from stakeholders to compile a comprehensive report that they will table in Parliament, probably next month.

Members of the committee present last Friday included Zombodze Emuva Member of Parliament Titus Thwala, who is the chairperson of the committee. Other members present included Mtfongwaneni MP Mjuluko Dlamini, Nhlambeni MP Frans Dlamini, Manzini North MP Jan Sithole, and Committee Clerk Celumusa Khoza.

SIPA Chief Executive Officer (CEO) Phumelele Dlamini said her organisation facilitated the start of businesses that were to be done by investors, not traders. The CEO referred to the Asians, that were talked about last Friday, as traders, not investors.

"People who are in the business of buying and selling are traders and investors are people who will buy raw material and process them into finished products, right here in the country," Dlamini said.

The CEO was asked to explain what made these people to be called investors yet they did not come into the country because of SIPA. She was asked by Nhlambeni MP Frans Dlamini, The CEO said she could not be sure what made such a situation exist because they also saw them in the country. She then related an incident they once experienced at SIPA, in relation to the Asian business

# SIPA brings investors worth E26m a year

THE Swaziland Investment Promotions Authority (SIPA) brings in investments worth E26 million

This was said by SIPA CEO Phumelele Dlamini when asked to state how many businesses they brought into the country each year.

This question was asked by Mtfongwaneni MP Mjuluko Dlamini. Dlamini wanted to know the number of investors, on average, that entered through SIPA.

Dlamini said in the textile industry, they brought investments worth E26 million in a year.

Investors they bring per year are about 10 to 15. Last year, they brought two to three investments in the textile industry.

Other investments they brought were in the manufacturing assembly, agribusiness, and mining industries. They brought one in each of them. She said

for an investment, it took nine months to set. For those that needed land, it could take from 15 to 24 months.

She said on a certain weekend back in 2013, they received a call in their office. The call was coming from a police officer based in Matsapha International

### Investor

"They were telling us about an investor that had just landed at Matsapha International Airport. We went to check on the investor and we found that we had not been in contact with the investor. However, we found that the investor already had a trading licence and other documents to work in the country," Dlamini said. Dlamini said they then booked the businessman at a hotel and

was turned back the following Monday. The chief executive officer said they were not convinced the Asian was an investor because she could not fit in their policy that guided their scope of work. The investor had only E12 000 that he intended using to start his business as an investor in the country. The CEO, when asked what the solution could be, said Swazis needed to be aggressive in doing business. She said Swazis used to drive the economy in the yesteryears because they operated as general dealers and in transport businesses. Dlamini mentioned that the situation could still be reversed because access to credit had improved now.

## 'Schaza; Suspect's bar broken into

THUGS at Ludwala area broke into a bar which is believed to be run by incarcerated murder suspect Lucky Matsenjwa in the early hours of yesterday morning.

Matsenjwa stands accused of killing fellow police officer Mduduzi 'Schaza' Matsebula.

Information gathered is that the culprits gained forced entry at the bar and helped themselves on money from the pool table and stole volumes of cigarettes and booze.

The items stolen including cash is alleged to have amounted to E4 000. Residents of the place stated that they were shocked to see police officers in the early hours of yesterday flocking into the place. When this reporter visited yesterday morning the bar lady who was on duty confirmed that there had been a robbery.

However, the bar lady refused to entertain further questions and asked to call her manager in order to get authority to comment or let the manger

address the media herself.

After a brief call, the bar lady came back and informed this reporter that her boss said she could not address the media. Such an incident comes at a time when Matsenjwa who runs the bar is in police custody for allegedly murdering Matsebula.

Charges

Matsenjwa resigned as a police officer after he and others faced charges in a case where they are alleged to have had fingerprints for people who were convicted for criminal matters cleared from the police system.

Deputy Police Information and Communications Officer Phindile Vilakati confirmed that a case of a break-in at Fontana Bar was reported to the Manzini police.

She said no one had been arrested in connection with the incident and police were still investigating the mat-

Such an incident comes at a time when a number of bars in Manzini have been broken into and some suspects have already been sentenced for such offences while others are still attending trials.

# BUSHFIRE WEEKEND SEES 126 ARRESTED FOR DD

THE busy MTN Bushfire Festival weekend saw about 126 motorists arrested for driving under the influence of alcohol.

Deputy Chief Information and Communication Officer Superintendent Phindile Vilakati confirmed the figures yesterday. She said the number showed an increase from last week's reported cases. There were 115 drinkdriving cases reported.

Those arrested have either appeared

# 20 MTN BUSHFIRE TOURISTS ARRESTED FOR DRINK DRIVING

THE internationally acclaimed MTN Bushfire Festival was a sweet-sour affair for over 20 tourists.


They apparently took their excitement to the road yet they had taken one too many alcoholic drinks.

They were nabbed for driving while under the influence of alcohol and appeared in court on Saturday and yesterday where they were punished for their deeds.

The Lobamba traffic police were not in a compromising mood on Saturday and in the early hours of yesterday morning as they arrested over 15 traffic offenders who were tourists who came for the 11th edition of the MTN Bushfire. Over five had been taken in the previous day bringing the number to well over 20. There were locals too that were arrested as the figure of drunk motorists stood at 126. Even though this left most of the tourists unhappy, they did acknowledge it was wrong of them to drive their motor vehicles whilst under the influence of alcohol. They pleaded with the court to be lenient on them as they were not aware of some of the country's traffic laws. Most of them said they were in the country for the first time.

According to the charge sheets, the offenders' breathalyzer test results ranged from 1.00mg/l to 2.00mg/l whilst the lowest recorded only 0.84mg/l.

The two spots, where roadblocks were mounted and proved effective were

Nkhanini and Ludzidzini.

As the number of tourists hauled before court for driving under the influence of alcohol swelled, the court opted to exercise leniency. Both Saturday and yesterday saw Senior Magistrate Nonhlanhla Dlamini having to deal with tourists who were nabbed for driving their motor vehicles whilst under the influence of alcohol. Most of the arrested tourists were from South Africa and they told the court they were here for the MTN Bushfire festival, which ended yesterday.

Offenders

The traffic offenders stated their concerns before the court as they felt they were the target over the weekend.

The senior magistrate also noted there were many tourists before her court and she said she would exercise leniency.

"Judging from the quantity of the alcohol content found in your blood systems the court is supposed to give you the maximum fine of E5 000 but since you are

our tourists, you will get lenient fines," the senior magistrate said. The senior magistrate fined the close to 20 tourists E1 200 or six months imprisonment each. The offenders spotted wrist bands from the weekend-long festival. Reuben Kamashinda (50) of Mahodison in Botswana said the court should have mercy on him after spending hours sleeping on a cold floor in the police cells. He was nabbed at 3:30am yesterday whilst driving a Jeep Cherokee at Nkhanini along MR 103 public road. The alcohol content found in his blood system stood at 1.62mg/l. He pleaded guilty to the offence. He was fined E1 200 or six months imprison-

Misjudged

Another offender Tsepo Mosibi of South Africa said he misjudged his soberness after sleeping it off.

"I take full responsibility of the offence, I follow the law. It was a mistake on my part as I thought I was sober after taking

## TOURIST LOSES WALLET, WANTS NOTHING TO DO WITH SD

NTSIKENI Mtobe of South Africa told the court he was only interested in leaving the country following the bad experience he had whilst here.

Mtobe spent the hours of early morning yesterday behind bars after being nabbed for driving a Toyota Corolla whilst intoxicated. He was also charged for driving the car without his valid driver's licence.

He said this experience added to his already piling woes after losing his wallet at the festival.

"I found myself in a difficult situation after I lost my wallet as I had planned to hire a driver to take me to the hotel but I could not. I was forced to drive myself there as I thought it would not be a problem since I was booked at Ezulwini," he said. He said he did try to explain to the police about his lost wallet and driver's licence but he was

charged anyway. He said he would have a problem raising the money since he was now using the internet to access his funds.

"I have my passport back at the hotel and all I need is to go back home, I have to be at work tomorrow (today). If the court can allow me to leave as my car has a full tank, I only have a problem with money," he said.

Cautioned

The court insisted he must make means to pay the fine then he would be let go. He was cautioned and discharged on his second count after the court understood his explanation on why his driver's licence was not in his possession when he was stopped by the police whilst at Lobamba.

He was also fined E1 200 or six months imprisonment after the alcohol content detected in his blood system stood at 2.00mg/l.

a nap," he said. The alcohol content in his blood system stood at 1.66mg/l. He was fined E1 200 or six months imprisonment Another offender, Mphumelelo Gama, who was also driving a South African registered car, complained before the court that the Lobamba traffic police were only stopping foreign registered motor vehicles. "This did not go down well with us as we discussed this whilst kept at the cells and discovered we all suffered the same fate. The local registered cars were not pulled over and it felt like we were targeted," he said with a disappointed face. "I will talk to the police and refer your comments to them since it is not within the courts,

but the court does acknowledges that this is a wrong practice especially because you are here on visit," the senior magistrate responded to the concerns. Gama apologised for being found driving while intoxicated at or near Ludzidzini in the early hours of yesterday morning. He pleaded with the court to reduce the E1 200 fine after noting it was being given out to all the other tourists. "Your worship, I have noted you have been using the same figure, please reduce it," he said much to the amusement of the court. However, he was told the court was already exercising its extreme leniency on them. He was fined E1 200 or six months imprisonment.

## Bushfire fan falls sick in court

SHANGANI Zitha, a visiting tourist saw her matter being briefly suspended after she fell sick inside the

Senior Magistrate Nonhlanhla Dlamini opted to ask the police to take her to hospital or get her the necessary medication before being convicted.

Zitha told the court her medication was left behind at Lobamba police station. A police officer was ordered to assist her with getting the necessary medication. After the court had completed dealing with other offenders, the drunk-driver was recalled and she told the court she was better and ready for conviction. She was charged with drink-driving after being nabbed driving along Ludzidzini. She pleaded guilty to the charge. "I apologise, I tried to avoid the situation by sleeping, I am sorry for breaking the law in your country as a tourist," she said before attempting to walk out of the accused dock without her conviction. She was fined E700 or five months imprisonment.

## I was going to buy bread – tourist

A fun lover from South Africa said the police nabbed him whilst he was on his way to buy bread yesterday morning.

Simphiwe Hlophe was arrested while driving a BMW sedan along Ludzidzini public road.

He was slapped with two traffic counts. He was charged for drinkdriving and driving without a valid driver's licence.

He told the court his driver's licence was left behind at the campsite. The less pleased 31-year-old man of Secunda told the court he was surprised to be arrested as he explained to the police he was only going to buy bread and other essentials to use at the campsite.

"I told the traffic police I had left everything at the campsite since I believed I would find a shop close by," he said. Hlophe was also left unhappy with the experience. However, he apologised to the court and pleaded for leniency.

Tsepo Mosibi also from South Africa

asked not to say anything before court whilst showing signs of his displeasure. He was arrested at 12:35 am while at Nkhanini driving a Hummer. The alcohol content detected in his blood system stood at 1.66 mg/l.

He was fined E1 200 or six months imprisonment.

Charged

Nhlakanipho Mkhize of South Africa also opted not to say anything before court after he mentioned that he lost his wallet while enjoying himself at the festival. He pleaded guilty to all the traffic counts he was slapped with. He was charged for drink-driving, reckless driving and driving without a valid driver's licence.

He is said to have failed to stop while at a compulsory stop sign and when asked about his valid driver's licence, he said it was inside the lost wallet.

The court found him guilty and convicted him as per his pleas. He was only fined E1 200 or six months imprisonment.



CONTRARY to police suspicions that Manzini businessman Timothy Dlamini shot himself, friends of the late businessman believe it was not a suicide incident and have vowed that those responsible for the death of the businessman would follow him soon.

Friends who attended Dlamini's memorial service at St Paul's Methodist Church last Friday made it clear that they suspected foul play in the death of Dlamini.

Dlamini was found dead with bullet wounds in his right cheek after his wife heard gunshots in the compound, where the late businessman resided.

Police when asked about the incident confirmed that the deceased had two bullet wounds and stated that they suspected a case of suicide.

However, they stated that investigations were ongoing.

One of Dlamini's friends, who was also speaking on behalf of and Moneni Football Club, stated that they were aware of the stories circulating pertaining the death of the businessman.

He said as a soccer team they were aggrieved by the passing away of Dlamini. The speaker said the deceased loved the team and supported it with everything.

- : Bongani Timothy Dlamini was born on the 24.04.1967 at Balfor North South Africa he was the last born of Wilson B and Esther Nkosi.
- He began his education at St Michael's Primary School, and then proceeded to Salesian High School where he obtained his O'level Certificate. Upon completion, he started working at Swaziland milling for a period of two months.
- He joined Mhlume Swaziland Sugar Company and was employed as an apprentice and in 1989 he was confirmed and was promoted to that of artisan.

- In 1991, he furthered his studies at Umlazi Technical College where he obtained his N1 and N6 Certificates in boiler making. He worked for Mhlume until December 1992 when he resigned from the company.

In 1994 he was employed on a fulltime basis as an artisan at the main workshop and was later promoted to charge-hand when Sappi did a restructuring exercise and in 1996, a multi skilled person was needed and Dlamini was

# Night patrols have reduced crime in Pigg's Peak

Methula said this has helped reduce the crime statistics which were reported to have dropped a lot in the past two months.

### **Patrols**

The station commander is often part of the night patrols with his junior officers who comb out the dangerous streets of Pigg's Peak to reduce all bad elements.

Speaking to this newspaper, officers involved in the Lunyazi programme said one of the key successes in their fight against crime was the fact that Methula was actively involved on the frontline, working hand in hand with his junior officers.

"We are very happy that our station commander is actively involved in the crime prevention exercise as we have seen him talking to the bar owners and educating them on the importance of closing their business within the stipulated times.

This has allowed their customers to

leave town for their homes early enough while the police are patrolling the streets, which has reduced crime," said the sources.

The station commander has further equipped members of the public with crime precautionary measures like teaching residents of Pigg's Peak to walk in groups at night and advising them to avoid certain areas if they will be walking alone added the source.

When interviewed Methula said his only joy was seeing crime in Pigg's Peak completely eradicated.

"We, the police in Pigg's Peak, are unified and motivated in our fight against crime. Our target is to see Pigg's Peak being crime free. We are very disappointed when we see a crime because we have taught people basic crime prevention techniques.

We hope we will see more improvements in the future as more people are sensitised about our duties. We have set ourselves a deadline of December 30 to see how much the crime in Pigg's Peak would have evolved during that period." said Methula.

# Algerian minister sacked three days after appointment

ALGIERS - Algeria's President Abdelaziz Bouteflika sacked his tourism minister yesterday days after he was appointed to the post, the presidency said, with one television channel claiming he had a criminal record.

A terse statement from the presidency, carried by the APS news agency, did not say why Bouteflika had fired Messaoud Benagoun, who became minister of tourism and crafts just three days earlier. Algerian media had criticised Benagoun's appointment, claiming that the 38-year-old had never had a job before joining the new government that was formed on Thursday. Yesterday, private television station Enahar claimed Benagoun


held a fake university diploma and had a criminal record, with several convictions, but did not specify for what offences.

According to Enahar, the sacked minister had submitted a doctored curriculum vitae in order to stand in the May 4 parliamentary election. Benagoun belongs to the Popular Algerian Movement (MPA) which won 13 seats. Bouteflika's party and its coalition ally won a clear majority while Islamists came in third place.

On Wednesday, Bouteflika appointed a new prime minister, Abdelmajid Tebboune, replacing his ally Abdelmalek Sellal in the wake of the election. Tebboune formed his government the following day. AFP

# FAMILY FORCED OUT OF HOME BY 'GHOSTS'

...a Ndlovu family in Siteki tells a gory tale of how they

WITCHCRAFT and some evil spirits may remain just a myth for those who have not experienced such, but it is a reality for a Ndlovu family in Siteki which has since been literally kicked out of its homestead by vicious invisible beings.

The family has become the talk of the densely populated Ntama-kuphila Township as residents talk in hushed tones about the occurrences which would take place in broad daylight. So serious is the matter that children from the area have been sternly warned by their respective parents not to dare go anywhere near the homestead.

This became evident when this reporter visited the homestead on this past Saturday to ascertain the authenticity of the matter. At about 100 metres away from the homestead, a group of children were found playing football on the roadside just before sunset.

This reporter asked for directions leading to the Ndlovu homestead which was said to be situated near a shop operated by a man of Asian origin. With a questionable smile on his face, one of the boys pointed at the homestead.

When asked on what significance the homestead had, the boy stated that they have been warned of ghosts beating people inside the homestead. "Bantfu bakulelikhaya abasahlali kulo bacoshwa tipoko," said the boy, before he quickly returned to join his peers.

However, three senior family members were found at the homestead, seated near the gate. They narrated the family's ordeal which they said would mostly take place when there were visitors. Isabel Ndlovu said they had been expe-

riencing attacks from invisible

beings since last year where they

would be pelted with stones.

Intensified

She stated that the stones would come from the eastern direction and hit anyone within the premises. Isabel said the attacks had recently intensified, compelling them to seek refuge in neighbouring homesteads where they would spend the night and then return home in the morning.


She said at first, they thought they were being attacked by some unruly boys from their neighbourhood. They even opened a case at the police station, accusing their neighbours of pelting them with stones.

This was until the invisible beings started using house utensils such as plates, cups and broomsticks to assault them both during the day and at night. Isabel stated that at a particular moment, a plate would suddenly fly from the shelves and hit anyone nearby while they would be seated in the main house.

### Attacking

"We only see the stones and the other things being thrown at us but not the people or whatever kind of beings which are attacking us," said Isabel.

Following this attack, Isabel said they were no longer occupying the main house (a three-bedroom house belonging to their late father) as the attacks intensify when they are inside it.





Gogo Victoria Ndlovu, a wife to the late man, was said to be the most affected by the attacks. The elderly woman would at times be compelled to sleep at a veranda of a shop situated near her home during the attacks. She was reportedly taking a nap when this publication visited the homestead. She was said to have sustained injuries during a recent attack which took place last week Monday.

"We are now being isolated by our neighbours as they would also be pelted with stones when they visit us," said Isabel.

# COPS GET THEIR FAIR SHARE OF BEATINGS

TWO police officers had to run for their lives after a hail of stones were thrown at them during their visit at the Ndlovu family about two months ago.

The officers are said to have been at the homestead to record statements of the alleged attacks. This was after the family reported that they were being pelted with stones by unknown people; at the time, they were suspecting their neighbours. While the officers were going about their duties and inspecting the damages, a flood of stones is said to have come from the same direction, hitting anyone in the vicinity.

There was no one seen to be throwing the stones. Isabel Ndlovu said it was then that they affirmed that the attack was spiritual. The family eventually resolved in extending their apologies to their neighbours for wrongly accusing them. "We wrongly accused our neighbours, and after we realised that this was spiritual, we asked the *umphakatsi* to assist us to extend our apologies to them," said Isabel.

She disclosed that the *umphakatsi* had arranged a reconciliation meeting which was scheduled for yesterday.

### FAMILY NEEDS SPIRITUAL DELIVERANCE - PASTOR

ATTACKS from invisible beings are real, and the affected persons may only be assisted with spiritual deliverance.

This was said by Reverend Sifiso Mantimakhulu of Alliance Church of God during an interview. Mantimakhulu was asked whether or not such attacks were a reality and what could be done to assist the affected individuals.

The renowned preacher stated that there could be a number of factors which could have led to the paranormal activity taking place. He said, however, regardless of the intensity of the situation, a sincere prayer by specific men of God could stop the attacks.

"Such attacks need a sincere prayer from prophets with a specific anointing to cast out demons. It is not just any prophet who can withstand this kind of demons as they may have a history with that particular family," said Mantimakhulu.

### IT'S WITCHCRAFT PRACTICE - INYANGA

WELL-KNOWN traditional healer Colani Matse has shared similar sentiments, saying similar attacks may be linked with witchcraft.

Matse said it was most likely that the family was not wanted in the area. He said, however, some specific traditional healers may be able to stop the attacks. He advised the family to consult traditional healers and seek help before it is too late.

He said such incidents were quite explainable when it comes to traditional healing but the attacks could be stopped for good. He highlighted that there were traditional healers who were good at stopping such evil spirits who could be of assistance to the family.

However, he did not specify the names of the traditional healers who were knowledgeable in dealing with ghosts.

# BAR OWNER STABBED, ROBBED E20 000 CASH

### A bar owner was stabbed multiple times and robbed E20 000 by a gang inside his own yard.

Owner of the Jazz Time bar Celimphilo 'Mandoza' Matsebula is lucky to be alive after he was brutally stabbed and robbed of his money while outside his own home.

The incident happened at around 3am yesterday at Matsebula's residence that is located close to the Mhlatane teachers' quarters before Macembeni area.

Sources close to the matter said that the attack was carefully planned by the gang of about 10 men who behaved like 'hunters' and waited for their victim in the dead of night in complete silence.

"The attack was brutal, fast and well planned because when Matsebula drove up to his front gate and exited his new vehicle to open the gate, the gang pounced on him. They stabbed him on the neck, back, leg and face while the other men ran to the car and stole the money that was placed inside a boxer store plas-

tic," said a source.

The gang then ran into the blanket of the night leaving their victim in a state of shock and pain.

His screams were loud enough to awake his family who then called emergency services, who took him to the Pigg's Peak Government Hospital for treatment for the stab wounds that were inflicted. Acting Police Public Relations Officer (PRO) Superintendent Phindile Vilakati confirmed the robbery.

# Youth fund gets E10m but there is no board

The Swaziland Youth Enterprise Revolving Fund (SYERF) has been given E10 million in this financial year, yet it has no board of directors to monitor how that money works.

This transpired last Friday when the authorities of the fund appeared before the Public Accounts Committee (PAC). The SYERF had appeared before the PAC to state why they had not submitted their audited financial statements to the Auditor General (AG), as dictated by the Public Enterprise Unit (PEU) Act

The Act requires all public enterprises (parastatals) to submit their audited financial statements to the AG at the ministry of finance.

That happens after the statements of the parastatals have been audited by private auditing firms.

This also binds SYERF, which is a parastatal under the ministry of sports, culture and youth affairs.

The Auditor General found the fund to be wanting in terms of submitting its audited financial statements. The fund last submitted its statements in 2014, according to the 2016 report of the Auditor General. This was not accepted by the PAC, which is a government financial watchdog that scrutinises the way in which government money is used.

SYERF Chairperson Siboniso Mdluli said the report of the Auditor General was true.

The problem that made the statements not available was that there was no board of directors for a long time. What made this very difficult was that there was no chief executive officer (CEO), who also forms part of the board of directors. The PAC was informed that the fund had been dormant for the past three years. The office had been run by the finance officer, who paid for all the expenses that were incurred by the office. There was no activity at the organisation since 2014. Mdluli further told the PAC that they found no financial statements when they were appointed into the board in September last year. Mdluli then promised the PAC that by September this year, audited financial statements for 2015, 2016, and 2017 would be available. Mayiwane Member of Parliament (MP) Eric Sifiso Matsebula wanted to know if the fund had a way of collecting the money that was for the youth. Mdluli told him that even that activity was halted since there was no substantive board of directors.

PAC Chairperson Thuli Dladla advised Mdluli to seek an audience with Minister for Sport, Culture and Youth Affairs David Cruiser Ngcamphalala, with the intention , according to Dladla, was to speed up the process of the employment of a CEO of the SYERF.



# Drunk driver nabbed metres away from drinking hall

A drink-driver told the court how he was nabbed for the offence just a few metres away from the bar which is situated near a public road.

Sandile Maseko appeared before the Magistrate's Court, where he faced the charge of contravening the Road Traffic Act. He was alleged to have wrongfully and unlawfully driven his motor vehicle while under the influence of alcohol.

A breathalyser test is said to have indicated that the accused had alcohol content amounting to 0.97 mg/l in his system, which is above the legal limit set at 0.38 mg/l.

In the particulars of the matter, the accused was said to have been driving the vehicle in a manner which posed a danger to other road users. When the charge sheet was read to him, the accused pleaded guilty to the charge.

His plea was also accepted by the crown without leading evidence. During mitigation, the accused stated that he was arrested a few minutes after getting behind the steering wheel as he was on his way home.

He told the court that he was about to take a gravel road going through a residential area when the police pounced on him.

He asked the court to be lenient when passing sentence, saying that he did not intend to break the law. Magistrate Donald Mavuso, however, pointed out that the accused was still on a public road when he got arrested.

He was therefore found guilty of the offence, and was accordingly sentenced to six months in a correctional facility with an option to pay E1 500 fine.

# POOR ROAD LEAVES TIKHUBA WITH NO POLICE VEHICLE

THE state of the road connecting Siteki and Mambane is said to have seen Tikhuba Police Post running for over two months without a motor vehicle.

The police vehicle is said to have broken down early in March. Police at the post now use phone calls to summon criminals who would be reported by complainants.

This publication learnt of the situation after a resident of Tikhuba raised a concern. The resident stated they were facing an increase in criminal activity as criminals were well aware that the nearest police post had no vehicle to respond to emergency incidents.

### Occured

The resident, who did not reveal his name, stated in most instances police will only attend to a crime scene two days

after an incident has occurred.

This would be police from Siteki Police Station. Upon inquiring about this irregularity, the residents were told that the vehicle had broken down due to the bad state of the road.

Apparently, the police vehicle would at times be available for a few days before being taken back for repairs.

Due to the unavailability of a police vehicle criminal activities such as house breaking, theft and assault were said to have drastically increased.

"Criminals are now having a field day here since they are aware it would take police at least two days to get to a crime scene," said a resident.

Chief Police Information and Communications Officer Khulani Mamba acknowledged the lack of a vehicle at Tikhuba Police Post,

In fact, Mamba stated that it was most likely for vehicles posted in rural stations to develop mechanical problems. "Generally as a service, we still lack sufficient motor vehicles in some stations around the country," said Mamba.

It is recalled that residents of Mambane, Tikhuba and Maphungwane have over the past many years been complaining about the bad state of the road.

The Mambane-Siteki gravel road is said to have also seen some public transport operators pulling out of the route as they complained that their vehicle experienced frequent break downs.

MP Phila Buthezi blamed the ministry of public works and transport of not taking the constituency seriously. Buthelezi said the ministry will always lament unavailability of trucks to upgrade the

# SADC Industrialisation Strategy based on 3 pillars

THE overall goal of the Southern Africa Development Community (SADC) Industrialisation Strategy and Roadmap (2015-2063) is to engender the structural transformation the economy of the region.

This is according to SADC's Dr Stergomena Lawrence Tax, who was commenting on the SADC Industrialisation Strategy which was adopted in the Extra Ordinary Summit in Zimbabwe in 2015 and approved by SADC Summit in Swaziland in March.

The SADC Secretariat has since published a detailed and Costed Action Plan for the implementation of the strategy, and design, developing an appropriate institutional framework to implement the strategy.

The Costed Action Plan covers Phase I and II of the strategy, with specific focus on the first fifteen years (2015-2030).

Dr Tax said the release of the strategy is anchored on three pillars: industrialisation as champion of economic transformation; competitiveness as an instrument of efficiency and new source of competitive wealth creation; and deepened regional integration.

She said it endeavours to converge SADC economies into the high development level of present day developed countries as well as with the African Union Agenda 2063. Dr Tax said the industrialisation strategy was developed as an inclusive long-term modernisation and economic transformation scheme that enables substantive and sustained raising of living standards, intensifying structural change and engendering a rapid catch up of the SADC coun-

tries with industrialising and developed countries.

"The strategy sets out three potential growth paths, agro-processing, mineral beneficiation and downstream processing and industry along with service driven value chains.

The paths are mutually supporting and inclusive, encompassing the combination of downstream value addition and backward integration of the upstream provision of inputs, intermediate items and capital goods," said the Dr Tax.

She highlighted that the central challenge facing Africa is how to transition from the commodity-dependent growth path in which African countries find themselves to value-adding, knowledge-intensive and industrialised economies.

She said the goal is to occupy a higher place in the global division of labour. She noted that Africa at present is predominantly viewed as a producer and exporter of primary commodities and an importer of value-added manufactured goods.

"There are deep structural faultlines in the economies of the SADC countries that remain entrenched, characterised by resource-dependence, low value-addition and low levels of exports of knowledgeintensive products.

This is reflected in the low levels of private sector investment into the manufacturing sector of the economy," she said.

The executive secretary highlighted that the concern of policymakers is that if the declining share of manufacturing, 11.3 per cent in 2014 across SADC, down from 15.9 per cent in 2004, is not reversed, the "ladder" to address the deep structural problems in these economies will be effectively removed.

# Moment of truth - Macron

PARIS-France's new President Emmanuel Macron says he was ready for his "moment of truth" with US counterpart Donald Trump - when they shook hands for the first time.

"You have to show you won't make little concessions, even symbolic ones," Macron, 39, told the French weekly Journal du Dimanche yesterday.

Footage of the handshake as the pair met for lunch at the US embassy in Brussels ahead of a NATO summit last Thursday has gone viral.

As cameras rolled, Macron held on tight to Trump's notorious power grip as the two men sat next to each other, the Frenchman's mouth clenched and eyes firmly fixed at the 70-year-old tycoon's squinty stare.

After some five seconds, Trump was the first to open his hand but Macron insisted on being the last to let go.

"It's not the be-all-and-end-all... but a moment of truth," Macron said.

"I don't miss a thing, that's how you get

respect."
The French leader had another chance later in the day to be his own man, making a beeline for German Chancellor Angela Merkel to embrace her before turning to greet Trump - who smilingly pumped and wrenched Macron's arm as other leaders laughed.

Macron said Trump and the Turkish and Russian presidents Recep Tayyip Erdogan and Vladimir Putin "think in terms of power ratios, which doesn't bother me".

But Macron, who became France's youngest president just three weeks ago, said he does not believe in "the diplomacy of public invective but in bilateral dialogue".

He faces his next diplomatic test today, when he hosts Putin at the palace of Versailles outside Paris. AFP

# COSATU invites Ramaphosa to central committee meeting

Spokesperson Sizwe Pamla says they are building a relationship with Ramaphosa ahead of the ANC elective conference. "We do have a standing decision to say the president of the republic will no longer be allowed to address COSATU meetings.

# Egypt blocks financial newspaper website, widening media blackout

CAIRO - Egypt has blocked the website of one of its most prominent financial newspapers, the paper's owner said yesterday, expanding a media blackout initiated last week to curb what authorities called support for terrorism and fake news.

Egypt blocked access to a number of news websites including Al-Jazeera and Huffington Post Arabic last Wednesday after similar actions by its Gulf allies Saudi Arabia and the United Arab Emirates.

The censorship of Al-Borsa, a widely read financial newspaper that generally steers clear of politics and reflects the views of a largely prostate business community, suggests a more expansive attempt to control private media coverage.

The website of Al-Boursa's sister publication, the English-language Daily News Egypt, was also blocked, a statement by parent company Business News said. *AFP*


Meanwhile, RSP's Superintendent Phindile Vilakati confirmed that Komati handed himself to the police on Tuesday.

# MASHUMI-LED COUNCIL'S E7 M PROJECT BEGINS

THE outgoing Nhlangano town council is pleased that the last major project which

was part of its strategic plan, which is the revamping of Sililo Avenue road down to the Elim Church has begun.

The eproject worth close to E7 million took off the ground a couple of weeks ago and it's expected

to be complete

around July this year.

The council led by Mayor Mashumi Shongwe is believed to have delivered more than any previous councils of the town.

It is also believed that in its five-year reign, the council managed to make a notable turnover and bail the institu-

tion from debts it inherited from previous council teams.

Shongwe said when they were ushered into office nearly five years ago, the municipality had a deficit of over E2 million where some of its accounts were not even serviceable but managed to turn the situation around. Talking about the tarring of Sililo Avenue road, Shongwe said it was pleasing that as they were bowing out of office, such a project has

commenced and the time frame was communicated to all parties.

He said Pots Construction has been contracted to undertake the E7m project adding that they were confident that Pots would deliver as it had done previously.

Shongwe appealed to all stakeholders including nearby businesses that could be affected as work progresses to be cooperative.

He said he expected the same cooperation everyone has been giving to companies working on the improvement of the road infrastructure.

"Such inconvenience is expected as development comes with temporary challenges. The residents close by as well as road users, have to exercise patience and this is a spirit people of Nhlangano are known for hence we have been able to succeed in a number of things that touch on development," said the Mayor.

# Residents don't want dumping site

RESIDENTS at Extension six near Mathendele Township are bitter at the Mashumi Shongwe led council for turning an area close to their 'doorsteps' to a dumping site.

The new Nhlangano dumpsite has caused uproar with property owners accusing the town council of violating their rights as the dumpsite is a health hazard.

The town council has relocated the dumpsite which all along has been at the foot of the Nhlangano Industrial Site.

At the new site near Mathendele, is a developed residential area.

One of the issues raised about the establishment of the dumpsite near Extension Six, was that property owners feel exposed to serious health risks.

They want council to act on the matter and give it the urgency it deserves.

One of the property owners is former SwaziBank Managing Director Sam Kuhlase who has since questioned the logic behind relocating the dumpsite to residential doorsteps. In a stinging letter dated April 28, 2017, Kuhlase informed the town council that he had interest in the issue as owner of Lot 636 at Extension Six. He asked the council to do something about the situation.

"The waste on the hillside facing the extension will indeed significantly contribute

to ill health, increase in serious irreversible illness from the smoke that the site invariable generates. This will pose a substantial present and future hazard to human health and is unfriendly," reads part of the letter Kuhlase has written to the town council.

Kuhlase also pointed out that there were a number of concerns that the town council should have considered before deciding to relocate the dumpsite to the said area.

"Land disposal site that pollutes and contaminates the atmosphere in the vicinity should be avoided in the interest of the community and good health standards. Please revisit the said land disposal site for your own assessment, and take corrective measures deemed necessary to address the situation. It will be appreciated if appropriate action is taken without much ado," the letter reads partly.

When contacted, Kuhlase confirmed having brought to the town council's attention the danger of relocating the dumpsite to the area in question.

"Yes I have taken up the matter with the (town council). It is a serious matter and we want action or else we are going to seek help elsewhere if they don't take this serious," said Kuhlase sounding furious.

Many residents have heaped Kuhlase with praises for taking up the issue as others said it was indeed a concern even to them but were not sure which route to take.

It's not the first time that Kuhlase challenges a matter affecting the public. In one instance, he was in the forefront when the current Nhlangano Park was identified to be suitable for another project. At the end whatever project that was planned for the park, it never materialized.

On the other hand, outgoing Nhlangano Mayor Mashumi Shongwe said he was not aware of any correspondence from anyone regarding the new dumpsite.

He said he was still to find out from the management team as it could be a matter that was handled by them (management). He was however quick to point out that procedures were followed when the decision to relocate the dumpsite to the present area.

"All stakeholders were involved and we followed all laws in as far as deciding where it should relocate. It is up to standard and it is well looked after as we have a full time labourer making sure that all is done in

It is a dumpsite that we think can be approved by all those who are experts and it is user friendly. But having said that, I have to first know the contents of the said letter and that is then where I can publicly make a comment based on what I know in as far as this matter is concerned," said Shangwe

It was then that a decision was taken and that they should move," cried some of the airtime vendors who added that they were greatly affected by what happened.

Some of the airtime vendors said this has affected their revenues as they had declined.

# SUSPECTS ALMOST RAN OVER MY LANDLORD WITH CAR-ABDUCTED PARAMEDIC

THE female paramedic, who was allegedly abducted, humiliated and assaulted by four women told the court that her landlord survived from being hit by a car driven by one of the suspects.

Ntombifuthi Dlamini (paramedic) was almost tearful as she related before court how her alleged kidnapping came about on September 29, 2016.

The state witness alleged on the evening of this fateful day, after completing a massive shopping spree at the Corner Plaza, one of the female suspects approached her before she reached her rented flat at Mvutijni.

Dlamini told the court that she did not suspect anything sinister since she knew Phindile Ziyane as they went to the same school together. The emotional complainant said while she was talking to Ziyane, a Toyota Auris with three female occupants approached and she was forcefully pushed inside.

"I fought back and they had a tough time pushing me inside the car. I then raised an alarm since I was by the gate and my landlord was present at the homestead. After several minutes of pushing and shoving, my landlord, Fikile Vilakati, ran towards the car as she attempted to rescue me," she said.

According to the evidence shared by Dlamini, Vilakati was almost hit by the car driven by Gugu Ziyane, who is said to be the mastermind of the abduction after learning that Dlamini was dating her husband.

She said the four women managed to squeeze her in before Vilakati came to her rescue and when she tried to stop

the moving car, it moved at high speed in her direction.

"I was sandwiched and both the women at the back assaulted me with open hands and fists, they even pinched me several times. The driver also assaulted me with one arm whilst driving," she added.

### Silence

She said there was a brief moment of silence inside the car, which then prompted her to blurt out the words "If you are not going to kill me, I will report you to the police."

She said these words saw Gugu Ziyane reacting with anger as she claimed that they would not be arrested as they had money. "She told me I would be the one arrested as I snatched her husband," she continued.

The complainant said while inside the car, she was asked about Ziyane's husband, whom she told them he was her boyfriend of two years. She said she informed them that she was not aware

the man in question was married.

"They then asked for my phone, I told them I had left it inside my rented flat, however, a few minutes later it rang and one of the women took it and discovered Ziyane's husband was calling, they then continued assaulting me while asking why he was calling me not his wife," she said.

Moreover, the four women, Gugu Ziyane (32), Phindile Ziyane (30), Happy Maphalala (30) and Matsidiso Mbetse (26) are facing five counts.

They are charged with kidnapping, robbery where a white ZTE cell phone valued at E1 500 was stolen from the complainant and money in cash amounting to E2 600 was taken, indecent assault, assault common and *crimen injuria*.

They are alleged to have indecently assaulted Dlamini by forcefully removing her clothes and parading her naked at the Luphohlo Dam area. They are alleged to have further slapped her and called her a prostitute as they invited men from the area to come and 'buy' her.

They are alleged to have taken a further step of taking a video and pictures of her while naked and shared them on social networks. They allegedly dipped the woman inside Luphohlo Dam as they allegedly continued assaulting her.

The women, who are represented by NoncedoNdlangamandla, pleaded guilty to only two charges that of indecent assault and *crimen injuria* and refuted the other charges.

The crown is represented by Counsel Mbutfo Mbingo. Senior Magistrate Nonhlanhla Dlamini postponed the matter to May 29 soon after Dlamini told the court Mbetse suggested to Ziyane that they drive to Mbabane where they would deal with her.

# Bricklayer buys stolen laptops, fined E4 000

A 26-year-old bricklayer was fined E4 000 for receiving two stolen laptops.

Sifiso Bulunga of Sidvwashini was happy he was cleared from charges of robbery and theft committed in the same area, but he was not entirely let off the hook as the court charged him for receiving property he knew very well was stolen.

Principal Magistrate Fikile Nhlabatsi slapped him with two counts. Bulunga pleaded guilty to both counts and he was found guilty and convicted as per his own pleas.

The professional bricklayer is said to have committed his first crime in the month of April while at or near Makholokholo.

He unlawfully and intentionally received a black Acer laptop valued at E5 000 while knowing same was stolen.

In the very same month, Bulunga did again commit the offence after a stolen ASUS laptop valued at E5.000 was brought to him and he accepted it while knowing it was stolen.

The offender was cleared off on count four and five after the charge sheet was amended by the crown.

The items are alleged to have been stolen from students studying in the nearby institutions.

In court, Bulunga said he had learnt his lesson and would never commit the offence again after spending two months in jail.

"I deserve a second chance in life since this is my first offence and that I am only 26 years old. I have a child who is dependent on me. I cooperated fully with the police during their investigations and never gave them a hard time," he said.

Bulunga pleaded with the court to exercise its leniency since he did not waste the court's time by pleading guilty to the offence.


Nhlabatsi warned him to stay away from black market deals as it was unlawful. He advised him to focus on his business of bricklaying.

Bulunga was fined E2 000 or two years imprisonment on each of the two counts he was facing.



David Olaniyi Oyedepo was born in September 27, 1954 in Osagbo, Nigeria. Oyedepo was born again in 1969, through the influence of his teacher, Betty Lasher, who took special interest in him during his high school days.

He studied architecture at the former Kwara State Polytechnic, now Kwara State University and worked briefly with the Federal Ministry of Housing in Ilorin before resigning to concentrate on missionary work. He received a Ph.D. in Human Development from Honolulu University. Hawaii, United States.

In 1982 he married Florence Abiola Akano (now known as Faith). They have four children together (David Jr, Isaac, Love and Joyce). David Jr and Isaac Oyedepo were ordained as Pastors in May 2007 by Kenneth Copeland. David Ir pastors the London Branch of the Church with His wife, Kemi while Isaac Oyedepo is the present Resident Pastor of Winners' Chapel International South Africa.

He received a mandate from God through an 18-hour vision in May 1981, to liberate the world from all oppression of the devil through the preaching of the word of faith. This is the mangural vision that led to the founding of the Living Faith Church World Wide (LFCWW), first called Liberation Faith Hour Ministries, in 1981.

Two years later, in September 17, 1983, Pastor Enoch Adebove, General Overseer of the Redeemed Christian Church of God, ordained David and his wife, Florence Abiola Akano forown as Faith Abiola Ovedepol to become pastors and officially commissioned the new church. Five years later, Oyedepo was ordained as Bishop.

Living Faith Church (AKA Winners Chapel) started in Kaduna but moved to Lagos, the former capital of Nigeria in July 1989, to start a new branch of the church after Oyedepo claimed to have received instructions from God to reach out to the people of Lawns.





# ZUMA'S DUBAI EXIT PLAN



AN email trail between the controversial Gupta family and their employees has blown the lid off how they have managed to do business with government, ingratiate themselves with senior officials, and go so far as to help move President Jacob Zuma and his family to Dubai.

The emails, obtained by City Press this week, also reveal how the Guptas seduced many senior government role players in their bid to capture departments and state-owned entities.

One of the most astonishing emails is from Gupta-owned Sahara Computers' Chief Executive Officer (CEO), Ashu Chawla, to Zuma's son Duduzane. It contains a draft letter from the president to Abu Dhabi Crown Prince General Sheikh Mohammed bin Zayed Al Nahyan, and shows how close Zuma is to the Guptas.

In the letter, Zuma writes: "I fondly remember our meeting in the UAE [United Arab Emirates] and the gracious hospitality and warmth extended to me during my visit. It is with this sentiment that I am happy to inform you that my family has decided to make the UAE a second home. It will be a great honour for me and my family to gain your patronage during our proposed residency in the

Last night, Zuma strongly denied any plans to leave the country, saying through his spokesperson Bongani Ngulunga: "I have my home in Nkandla and I have no intention of living anywhere else. When I retire I will go home to Nkandla. This is a pure fabrication. Duduzane has never spoken to me about living in any other country. He has never shown me any letter. It's shocking in the extreme. It's absolute mischief aimed at sowing confusion".

The emails also show how the Guptas seduced Cabinet ministers and CEOs of state-owned companies with opulent hotel stays and chauffeur-driven trips in luxury cars to their home in the exclusive Dubai suburb of Emirates Hills, where they bought a R445m

One was Eskom executive Matshela Koko, whom they flew to Dubai in January last year, putting him up at the posh Oberoi Hotel. Others included Mineral Resources Minister Zwane, Mosebenzi Communications Minister Ayanda Dlodlo, Denel chairperson Dan Mantsha, businessman and arms deal protagonist Fana Hlongwane, Duduzane Zuma and two of Free State Premier Ace Magashule's sons, Thato and Tshepiso.

### THE GUPTA'S GRIP

The emails are the latest indication of the grip that the Guptas have on

the South African government and state-owned entities. They come in the week in which the SA Council of Churches and a collective of academics from top South African universities released reports showing the extent of state capture in South Africa. They come as pressure mounts on Zuma, inside and outside the ANC, in relation to his close association with the Guptas.

For Koko's trip in 2016, an email, from employee Reya Pomar, confirms Koko's reservation and the arrangement of transfers to the hotel from the airport. He also asks for billing instructions.

Chawla responds: "Sahara will pay the entire bill. Please do not ask any credit card guarantee from the guest at the time of check-in". The hotel concierge informs Chawla: "Please note the chauffeur details mentioned below for the drop towards Emirates Hill (sic).'

At the time, Koko was Eskom's group executive for power generation and the Guptas were busy buying the Optimum Coal Mine from Glencore.

The Oberoi Hotel was a favourite of the Guptas, and Duduzane Zuma also stayed there the month before Koko arrived.

The email trail also shows that, on the day Chawla booked Koko's trip to Dubai, he also made Mantsha's travel arrangements. An email shows that Mantsha, who swiftly axed Denel CEO Riaz Saloojee and replaced him before engineering the joint venture between Denel and Gupta-owned company VR Laser Asia, was booked to arrive by chauffeur from the Oberoi at the Guptas' mansion at 7am.

In the December of that year, the Guptas booked Zwane into the Oberoi and hired him a BMW 7-Series to chauffeur him to and from the Dubai airport and the Guptas' house in Emirates Hills.

The emails also show that the Guptas appear to regard Zwane - the man they took with them to Switzerland to persuade Glencore boss Ivan Glasenberg to sell the Optimum mine to them - as their personal property.

An email from JP Arora - CEO of Gupta-owned JIC Mining Services to the Gupta brothers' nephew, Kamal Singhala, and Oakbay CEO Ronica Ragavan, is included in the tranche. In it, Arora invites them and their partners to a "private - by invitation only - dinner with ... Zwane during the Mining Indaba 2016 in Cape Town".

Another email from Chawla confirms the passenger manifest for the December 2015 trip on the Guptas' private business jet, ZSOAK. The seven passengers, which included Zwane, and three crew members travelled to Zurich, Switzerland, via Delhi, India. Also on the plane were Rajesh Gupta, business partner Salim Essa and Maleatlana Joel Raphela, the deputy Director-General of Mineral Regulations in the department of mineral resources.

The email tranche also indicates the level of involvement of the Guptas in the appointment of Zwane to his ministerial position. Included is an email to Gupta brother Tony on July

31 2015 - two months before he was appointed. The email was sent by Oupa Mokoena of Koena Consulting and Property Developers, which is situated in Zwane's home town of Vrede, Free State, and reads: "Please find attached the CV of Mosebenzi Zwane for your attention.'

The email tranche also contains one written in February 2016 from former Oakbay CEO Nazeem Howa in which he anticipates a question from the media about Zwane's involvement in the landing of a chartered Boeing containing Gupta wedding guests at Air Force Base Waterkloof in 2013. In it, Howa writes to Duduzane Zuma and Tony Gupta: "I need some help on some of the answers. I think we should also prepare for a question of his role around the Waterkloof landing." Zwane invited an Indian provincial minister to the Free State, which became the ruse by which the Guptas could land their wedding guests at Waterkloof.

### OTHER REVELATIONS IN THE EMAIL TRAIL INCLUDE THAT:

lic relations firm Bell Pottinger, whom the Guptas had hired to clean up their image, had prepared a press release which would have implicated former deputy finance minister Mcebisi Jonas in receiving bribes and other benefits such as flights upgrades and luxury hotel rooms from a South African businessman;

 The Guptas, Bell Pottinger and Black First Land First's leader Andile Mgxitama cooperated to mount a campaign to discredit state capture allegations, including that the Gupta family had offered Jonas a R600 million bribe and former ANC MP Vytjie Mentor a ministerial position

 The Guptas lobbied Zuma to arrange that the June 2015 departure of their guest, for Mauritius, should be through Fireblade Aviation, a luxury terminal at OR Tambo International Airport, owned by the Oppenheimer

Another controversial deal involving a state-owned entity and the Gupta family also appears in the email tranche: that of the Denel and VR Laser Asia joint venture. An email from the department of public enterprises to Minister Lynne Brown, also sent in December 2015, was of an internal confidential memorandum to which the Guptas appeared to have easy access.

The memorandum shows that public enterprises was uneasy about the joint venture for which Denel was trying to obtain permission from Brown or then finance minister Pravin Gordhan.

The memorandum says: "The two companies estimate that the new [company] will require a R100 million cash injection over a five-year period for operational costs.

"At face value, the proposal is attractive; however, there are numerous fundamental gaps that need to be clarified by Denel in terms of the Public Finance Management Act before comprehensive advice can be given to the minister with regards to the merits of the application.

The department is not comfortable with the impression that project funding will be provided by the shareholders ... It is also not clear whether the R100 million investment by VR Laser in the establishment of Denel Asia is a loan and what the repayment terms are." News24

# ELECTRICITY ACCESS INDEX NOW STANDS AT 75 PER CENT

FOUR agencies pumped in over E193.4 million towards rural electrification during the preceding financial year.

These were the Republic of China on Taiwan, ministry of natural resources and energy, Micro Projects and the Rural Development Fund

According to the Swaziland Electricity Company (SEC) annual report 2016, this was amongst the key highlights for the 2015/16 financial year.

The money invested in rural electrification doubled compared to the E92.7 million invested in 2015.

SEC reported that the number of homesteads to benefit from the funded projects also doubled to

"To date, the electricity access index in Swaziland is about 75 per cent and this is attributable, in part to the sustained efforts on the rural electrification programme since its inception in the early 1990s," said the report.

However, the utility noted that the challenge with rural communities was in the majority of cases, the homesteads that were stretched too far apart from each other.

'This situation makes it rather

expensive to provide the grid infrastructure necessary for supplying power to rural communities," reads the report in part.

During the reporting period, SEC had a total of 164 231 customers, this was a nine per cent growth from the previous year.

Customers

The number of major customers increased slightly by 1.7 per cent from 1 130 in the previous year to 1 149 during the 2015/16 financial year. Small and commercial domestic customers grew by 9.2 per cent and 9.0 per cent respec-

'Overall, domestic customers have increased significantly over the last four years, by 36 per cent, from 109 873 to 149 762, small commercial by 31 per cent from 10 161 to 13 320 and major customers by nine per cent from 1 057 to 1 149," said the report.

Commercial

Backed by the growth in customers, the utility's units sold increased from about 1 074.1 GWh in 2015 to about 1 084.1 GWh.

However, the report said both the small commercial and major customer categories indicated a decline during the 2015/16 financial year compared to the previous year.

The utility has relied heavily on imported power during the past financial year as its internal generation in hydro-power stations was halted because the water volume dropped below the required level for electricity production.

As a result, the report said the cost of imported power also increased from E757 million to E908 million during the period.

In the report, SEC Managing Director Meshack Kunene said with the utility's 2015-2020 strategy in motion; he was convinced that the company is towards a self sustaining status in the medium to long term.

SEC's ultimate objective is to increase internal generation capacity from 60MW to 150MW by

Effective from April 1, the utility effected a 15 per cent electricity tariff increase after an approval from the regulator, Swaziland **Energy Regulatory Authority** (SERA).

In its application to the regulator, the utility said it required E4.4 billion in the next two years for generation expansion, revenue diversification, improved levels of customer service, improved quality of supply and safety for all its stakeholders.

# 'YOUTH SHOULD BE EXPOSED EARLY TO ENTREPRENEURSHIP'

PRIME Minister Sibusiso Dlamini says it is important for the youth to be exposed early to entrepreneurship.

# PRIVATE SECTOR URGED TO EXPLOIT SACU-MERCOSUR PTA

THE private sector has been urged to make use of the market access preferences presented by Preferential Trade Agreement (PTA) between the Southern African Customs Union (SACU) and the Common Market of the South (MERCOSUR).

The productive sectors of MER-COSUR which benefit from tariff preferences include chemical, textile, steel, plastic, automotive, electronics and capital goods, in addition to agricultural products.

SACU hosted the inaugural Joint Administration Committee (JAC) of the PTA between the MERCOSUR and union in Kempton Park, Gauteng from last week Thursday to Friday.

The country is party to the PTA between SACU and MERCOSUR which entered into force on April 1, 2016.

In a joint statement released to this publication endorsed by South Africa Department of Trade and Industry Deputy Director Xolelwa Mlumbi-Peter on behalf of SACU and Republic of Argentina Ministry of Foreign Affairs and Worship-National Director

for Economic Issues Ambassador Roberto Salafia, the parties announced that they agreed to jointly promote trade to enhance access to information on market preferences under the agreement.

Advantage

"The parties called upon the private sector in SACU and MERCOUSUR member states to take advantage of the market access preferences presented by the agreement," reads the statement as part.

Mlumbi-Peter, the SACU-MER-CUSOR PTA was signed on December 15, 2008 in Salvador, Brazil, on the side of MERCOSUR, and on April 3, 2009 in Maseru, Lesotho, on the side of SACU.

The PTA is the first trade agreement concluded by SACU as a single entity, following the SACU Agreement of 2002.

"This agreement is also the first with another developing region, giving meaning to the objectives of South-South cooperation," said Mlumbi-Peter. The PTA covers over 1000 tariff lines from each side and the preference margins range between 100 per cent and 10 per cent.

In addition, SACU offered a tariff rate quota on four agricultural products; soya beans, soya bean oil and sunflower to MERCOSUR.

According to the statement, the next meeting of the JAC will be held in MERCOSUR at a date to be still announced next year.

The PTA contributed to the promotion of trade exchange in the South Atlantic with the MERCOSUR countries expected to have easier access to a potential market consisting of about 65 million consumers.



# INVESTORS SHOW INTEREST IN GOVT'S SHORT TERM DEBT

INVESTORS continued to show interests in government's short term debt instruments.

In last Wednesday's Treasury Bills auction, government raised E90.40 million from a total possible E100 million for the 91 and 182 days T-Bills.

This follows a 100 per cent successful auction where government raised a total of E100 million from the E60 million 91 days T-Bill and E40 million 273 days T-Bill.

The average competitive yield rate for the last successful auction was 8.334 per cent for the 91 days T-Bill, 8.739 per cent for the 182 days, 9.212 per cent for the 273 days and 9.350 per cent for the 364 days T-Bills. According to the recent Central Bank of Swaziland (CBS) T-Bills announcement, the matu-

# GIGABA OPPOSES DENEL VR LASER DEAL

JOHANNESBURG – National Treasury reiterated its opposition to the application by the Stateowned arms manufacturer, Denel, to establish a joint-venture with Gupta-linked VR Laser SA.

This comes after Denel on Tuesday said that it was forging ahead to reestablish itself in the East Asian market via its joint-venture with VR Laser despite a high court bid to halt the undertaking.

Denel wants to create Denel Asia through a partnership with the Asian-based business of VR Laser as a vehicle to penetrate the Asia-Pacific markets. VR Laser Asia is owned by Salim Essa, an associate of the politically-connected Gupta family.

## \$100 of bitcoin in 2010 is worth \$75 million today

WASHINGTON - Bitcoin has received a lot of attention over the past few weeks in the wake of the recent malware attacks that impacted dozens of countries and thousands of businesses.

Victims were required to pay a "ransom" in the digital currency to unlock files that were encrypted by the virus. The question for many business owners is that, given its growing acceptance, is it ready for prime time? Should we accept bitcoin?

There's no question that it's been a good investment, particularly if you bought at the right time. According to a report from CNBC, the price of a single bitcoin has recently soared to \$2 200 from just \$0.003 seven years ago. We know this because on Monday its fans celebrated the anniversary of Bitcoin Pizza Day, when Laszlo Hanyecz, a programmer, spent 10 000 bitcoin for two Papa John's pizzas. Times have definitely changed.

Oil

So what's driving the run up in price? CNBC's tech correspondent Arjum Kharpal cites factors such as new legislation in Japan that allows retailers to accept the cryptocurrency (40 per cent of all bitcoin trade is in Japan), the resolution of a dispute in the digital community that could've created competing currencies and the general market turmoil brought on by global economic uncertainty.

President Donald Trump's stated desire to weaken the dollar and make American goods more attractive overseas may also be contributing. Not only that, but according to a report on CNN.com, a few high ranking members of his administration, like budget Director Mick Mulvaney and Vice President Mike Pence's Chief Economist Mark Calabria, have both supported the cryptocurrency.

It was revealed in court papers that VR Laser SA might be a technically insolvent company and as such did not appear to be in a position to raise the funds that would enable VR Laser Asia to establish the joint-venture with Denel.

In a statement last Friday, Treasury said it had noted Denel's statements in relation to the Denel Asia transaction.

"National Treasury would like to place on record that Minister Malusi Gigaba held a meeting with the Denel Chairperson, Daniel Mantshe to discuss the Denel Asia joint venture.

At the meeting, Minister Gigaba reiterated his opposition to the joint venture with VR Laser Asia given the fragile financial situation that Denel is in," Treasury said.

"The minister further invited Denel to withdraw its litigation against National Treasury.

The position of the minister of finance has not changed in this regard. He remains opposed to the transaction for reasons stated elaborately in the National Treasury affidavit to the court."


Treasury further said that it would not be making any further comment until the matter has been finalised as it is currently before the courts.

# Return of Eskom CEO 'unlawful'

JOHANNESBURG -Even if Eskom's convoluted explanation for Brian Molefe's return is accepted, it is still unlawful.

That is the crux of a new affidavit filed by the DA's James Selfe last Friday in response to Eskom's argument that Molefe in effect never resigned and that reinstating him was simply the easiest way to correct the unlawful "early retirement" pension payout he was given last year.

Eskom this week argued in court papers that Molefe's R30.1 million pension may have been unlawful, but it was an honest mistake.

His retirement was "rescinded" on the basis of his pension deal being unlawfully based on pension fund rules for early retirement – for which he is too young.

This led to a reinstatement agreement which the DA said counts as a new contract of employment, meaning Public Enterprises Minister Lynne Brown had to approve it.

Brown, for her part, said she was happy to let the court decide this point.

If the DA was correct, then the reinstatement is invalid, she said. Her own affidavit this week made clear that the dilemma around Molefe's pension payout had

Bringing Molefe back was one. The others where to have him leave with an agreed smaller payout or to fight him to lower it.

Selfe said that the choice to bring Molefe back, rather than opting for any of the other solutions, amounted to an exercise of public power, meaning it could be challenged on the basis of rationality.

As with almost every decision taken on the Molefe matter, Brown seemingly had no real input at all.

The legal fight is being pursued by the opposition, but the ANC itself has expressed almost exactly the same condemnation of Molefe's re-employment and the "irrational and untenable" situation created by the convoluted explanations for Eskom's behaviour.

The argument made by Eskom chair Ben Ngubane in his affidavit this week is that it was all an honest mistake.

However, Ngubane's explanation involves two distinct mistakes.

First, Ngubane claims that no one on the Eskom board realised that the rules of the Eskom Pension and Provident Fund (EPPF) do not allow for employees to go on early retirement before the age of 55

They accidentally granted this to Molefe not knowing it was unlawful, Ngubane said in the papers. Second, the board gave Molefe his outsized pension based on a rule of the pension and provident fund for retrenched employees – not early retirees.

Ngubane dismissed this as a typing error. According to his affidavit, his letter accepting Molefe's retirement "incorrectly refer(s) to



# PE to feel the pain as GM exits

PORT ELIZABERTH -The unexpected exit of General Motors SA (GMSA) from South Africa will cause massive pain and suffering in Nelson Mandela Bay communities.

In addition, the ripple effect on downstream industries will be just as devastating.

GMSA said it was pulling out of South Africa at the end of this year, and its operations would be taken over by Japan's Isuzu Motors.

This brings the company's 90-year-old association with Port Elizabeth to an abrupt end, with 600 employees facing possible job losses.

The decision to pull out will also adversely affect numerous social responsibility initiatives which the company has been involved in through its GM Foundation.

These include education, housing and charity projects.

"This is not a time for one to lose one's job, especially when the country has been declared 'junk' status. I am panicking because I don't know whether I am one of the 600 to lose their jobs," 54-year-old Mlamli Vellem, who has been with the company for 21 years, told City Press this week.

"I started working for GM in 1996 as a general worker. Now I am a team leader. I have five kids, with the eldest being 29 years old and still living with me. This is going to affect me big time since I am the sole breadwinner. Fin24

# Hawks bust visa fraudsters

DURBAN - In the wake of the Manchester bombing and a heightened global terror threat, Durban has emerged as a conduit for people trying to gain illegal entry into the US.

In a counter-terrorism crackdown, 30 people have been arrested in the city by the Hawks Organised Crime Unit which is working alongside the local US embassy.

Two of the arrests took place this week. US Embassy spokesperson Heidi Ramsay referred questions about the operation to the police.

"Due to law enforcement sensitivities and privacy considerations, we are unable to provide any further information," she said.

Hawks KZN spokesperson Captain Simphiwe Mhlongo confirmed the 30 arrests and said more were imminent.

"This operation is ongoing," he said.

All the suspects used counterfeit South African documentation to apply for US visas, apparently paying a local syndicate R25 000 to get them through the system.

It is understood that Durban was red-flagged when there was a disproportionally high number of out-of-town applicants using the local visa and immigration office for their travel documentation. The latest arrests include a couple from the Democratic Republic of Congo (DRC) who were nabbed outside the US Consulate in Durban on Wednesday.

The couple, Morgan Biandosila, 40, and Belbiche Bitwadisi, 33, allegedly used their DRC passports and fake SA work permits to apply for US visas. They have been charged with fraud under the Immigration Act and will appear in the Durban Magistrate's Court for a plea bargain tomorrow.

The other arrests, which have taken place over the past six months, included people from Pakistan, Nigeria, Cameroon, Bangladesh, India and China. Fin24



# NORTH KOREA LEADER OVERSEES 'NEW' WEAPON SYSTEM TEST

SEOUL - North Korean leader Kim Jong-Un has overseen a test of a new anti-aircraft weapon system, state media said Yesterday , amid mounting tensions in the region following a series of missile tests by Pyongyang.

Over the past few months, the young leader has overseen several military drills, including the test-firing of a medium-range ballistic missile last Sunday, as Washington seeks to ramp up pressure on Pyongyang to curb its nuclear ambitions.

The North's official Korean Central News Agency said Kim "watched the test of a new-type anti-aircraft guided weapon system", which was aimed at "detecting and striking different targets flying from any direction". KCNA did not give the exact date and location of the drill.

Pyongyang first tested the new weapon system in April last year when some defects had been discovered, but Kim said the latest test verified that all glitches had been "perfectly overcome", KCNA said.

The efficiency of the weapon system "to detect and track targets has remarkably improved and its hitting accuracy has also increased" compared to last year, the young leader was quoted as saying.

Expressing his satisfaction, Kim said: "(It) should be mass-produced to deploy in all over the country like forests so as to completely spoil the enemy's wild dream to command the air, boasting of air supremacy and weapon almighty."

Tensions are high in the region

over the nuclear-armed North's weapons ambitions and its regular test-firing of ballistic missiles.

The North has carried out two atomic tests and dozens of rocket

firings since the beginning of last year in its quest to develop a missile capable of delivering a nuclear warhead to the continental United States. *AFP* 

# Morgue workers jailed for stealing drugs

NAIROBI - Tanzanian police said on Saturday that they had arrested two morgue employees in Dar es Salaam after they admitted to cutting open a dead man's corpse and stealing the drugs hidden in his stomach.

"The two morgue workers admitted to cutting open the body" a week ago to take the drugs, local police official Simon Sirro said in a statement, adding that the dead man had died of an overdose.

Drug traffickers regularly employ drug "mules" to transport merchandise by stuffing the drugs in small airtight bags which are then swallowed or inserted in someone's stomach. But the technique is hardly foolproof as the bags can be eaten away by stomach acid and cause an overdose - which is what may have happened to the dead man. The man, a Ghanaian national, was found dead in a hotel room in Dar es Salaam, Tanzania's economic capital, and transported to the morgue at Mwananyamala hospital, where the two employees worked, Sirro said.

According to police, the workers said they then sold the 32 drug capsules to an unidentified businessman, who in turn sold the merchandise to Ally Nyundo, a suspected drug trafficker.

Those two men were also arrested, police said, without identifying the drugs. Africa's east coast has long been used as a transit point for drugs bound for Asia and Europe.

"Both Theresa May and Jeremy Corbyn are offering, in very different ways, a retreat from international liberalism and globalisation," Osborne, who now edits the Evening Standard newspaper, told the BBC. News24

# Egypt launches second day of Libyan air strikes

CAIRO - Egypt launched a fresh round of air strikes over Libya last Saturday, Egyptian military sources and an eyewitness told Reuters, targeting militant camps it said were responsible for a shooting spree that killed dozens of Egyptian Christians.

Last Friday, Egyptian fighter jets struck eastern Libya just hours after a shooting that killed 29 and wounded 24 in the southern Egyptian

province of Minya when masked militants boarded vehicles en route to a monastery and opened fire at close range. Islamic State claimed responsibility for the attack, the latest directed at Egypt's increasingly embattled Christian minority following two church bombings last month that killed more than 45, also claimed by the group.

President Abdel Fattah al-Sisi said last Friday he had ordered air raids on militant camps in Libya, where he said the Minya gunmen had trained, though he did not name a specific group responsible.

Sisi, who has presented himself as a bulwark against Islamist militants in the region, said Egypt would not hesitate to carry out additional strikes inside and outside the country to quash future threats.

## Man arrested for killing special agent

RICHMOND - US authorities said a man had been taken into custody following an overnight manhunt in the fatal shooting of a Virginia State Police special agent. Virginia State Police said that Travis A Ball of Richmond was being held without bond on charges that include malicious wounding and use of a firearm in the commission of a felony. Additional charges are pending. The 27-year-old Ball is charged in the shooting of Special Agent Michael T Walter, who died early on Saturday.

### Clashes break out in Venezuela

CARACAS - Demonstrators clashed with Venezuelan police again Saturday as they descended on the offices of the state media regulator, the latest in nearly two months of often-violent protests demanding the ouster of President Nicolas Maduro. Youth with their faces covered blocked the main motorway running through Caracas, cutting it off with trucks that they then set on fire. They also erected barricades of rubble. Police fired tear gas to disperse the rally, and demonstrators fought back by hurling Molotov cocktails and stones.

### UK's Petrofac resumes gas production

TUNIS - British energy firm Petrofac has resumed production at a plant in Tunisia after a stoppage that lasted several months, the company and a trade union said."Yesterday (Friday) natural gas was brought by pipeline to Sfax" from the Chergui field operated by Petrofac, Abdelhadi Ben Jemaa, Secretary General of the powerful UGTT trade union in second city Sfax, told AFP.Petrofac confirmed that work had resumed at the Chergui gas field concession on Kerkennah island in southeast Tunisia. AFP

### '52 dead' in militia clashes

TRIPOLI - Forces loyal to Libya's unity government said Saturday that 52 of its fighters were killed as they repelled rival militias in fierce clashes in the capital Tripoli. Apart from sporadic gunfire in southern Tripoli, calm returned to the city on Saturday, the first day of the Muslim holy month of Ramadan. Among the 52 killed in Friday's clashes which centred on the southern district of Abu Slim said Hashem Bichr, a security official of the Government of National Accord, were 17 members of pro-GNA forces who had been "executed". There was no immediate confirmation from medical or other independent sources of the death toll, updated from Friday's health ministry figures of 28 dead and more than 100 wounded that did not give a breakdown of the casualties. AFP

### Morocco authorities arrest 20

RABAT - Moroccan authorities have arrested 20 people following violent clashes between police and protesters in the northern city of Al-Hoceima on Friday evening, the local prosecutor said. Clashes erupted in Al-Hoceima after authorities sought to arrest a well-known activist who led recent demonstrations and who interrupted a Friday prayer sermon, activists and local residents said. Political protests are rare in Morocco, but tensions in Al-Hoceima have been simmering since October after the death of a fishmonger who was crushed inside a garbage truck while trying to retrieve fish confiscated by the police. His death sparked anger. AFP

# LEAKED GUPTA EMAILS EXPOSE JACOB ZUMA

## ..ZUMA'S DUBAI EXIT PLAN

JOHANNESBURG - A trail of emails between the Gupta family and their employees has blown the lid off how they have managed to do business with government, ingratiate themselves with senior officials, and go so far as to help move President Jacob Zuma and his family to Dubai.

The emails, obtained by City Press this week, also reveal how the Guptas seduced a number of senior state actors in their bid to capture government departments and state-owned entities. The emails include:

- A draft letter from Zuma to Abu Dhabi Crown Prince General Sheikh Mohammed bin Zayed Al Nahyan in which he asks for "patronage" in his bid to "make the UAE a second home":
- How the Guptas seduced Cabinet ministers and CEOs of State Owned Companies with opulent hotel stays and chauffeur-driven trips in luxury cars to their home in the exclusive Dubai suburb of Emirates Hills, where they bought a R445m mansion;
- How two months before Zuma appointed him, Minerals Resources Minister Mosebenzi Zwane's CV was sent to the Guptas for their "consideration";
- The identities of the other passengers, besides Zwane, who were on the Guptas' private jet when they took Zwane with them to convince Glencore boss Ivor Glassenberg to sell them the Optimum coal mine;
- That in March 2016, British public relations firm Bell Pottinger, whom the Guptas had hired to clean up their image, had prepared a press release which would have implicated former deputy finance minister Mcebisi Jonas in receiving bribes and other benefits such as flights apgrades and luxury hotel rooms

from a South African businessman; and that

The Guptas lobbied Zuma to arrange that the June 2015 departure of their guest, for Mauritius, should be through Fireblade Aviation, a luxury terminal at OR Tambo International Airport, owned by the Oppenheimer family.

Zuma strongly denied any plans to leave the country, saying through his spokesperson Bongani Nqulunga: "I have my home in Nkandla and I have no intention of living anywhere else. When I retire I will go home to Nkandla. This is a pure fabrication. Duduzane has never spoken to me about living in any other country. He has never shown me any letter. It's shocking in the extreme. It's absolute mischief aimed at sowing confusion".

### Trips

The emails also show how the Guptas seduced Cabinet ministers and CEOs of state-owned companies with opulent hotel stays and chauffeur-driven trips in luxury cars to their home in the exclusive Dubai suburb of Emirates Hills, where they bought a R445m mansion.

One was Eskom executive Matshela Koko, whom they flew to Dubai in January last year, putting him up at the posh Oberoi Hotel.

Others included Mineral Resources Minister Mosebenzi Zwane, new Communications Minister Ayanda Dlodlo, Denel Chairperson Dan Mantsha, businessman and arms deal protagonist Fana Hlongwane, Duduzane Zuma and two of Free State Premier Ace Magashule's sons, Thato and Tshepiso.

### THE GUPTA'S GRIP

The emails are the latest indication of the grip that the Guptas have on the South African government and state-owned entities.

They come in the week in which the

SA Council of Churches and a collective of academics from top South African universities released reports showing the extent of state capture in South Africa.

They come as pressure mounts on Zuma, inside and outside the ANC, in relation to his close association with the Guptas.

For Koko's trip in 2016, an email, from employee Reya Pomar, confirms Koko's reservation and the arrangement of transfers to the hotel from the airport. He also asks for billing instructions

Chawla responds: "Sahara will pay the entire bill. Please do not ask any credit card guarantee from the guest at the time of check-in".

The hotel concierge informs Chawla: "Please note the chauffeur details mentioned below for the drop towards Emirates Hill (sic)."

At the time, Koko was Eskom's group executive for power generation and the Guptas were busy buying the Optimum Coal Mine from Glencore.

The Oberoi Hotel was a favourite of the Guptas, and Duduzane Zuma also stayed there the month before Koko arrived.

The email trail also shows that, on the day Chawla booked Koko's trip to Dubai, he also made Mantsha's travel arrangements.

An email shows that Mantsha, who swiftly axed Denel CEO Riaz Saloojee and replaced him before engineering the joint venture between Denel and Gupta-owned company VR Laser Asia, was booked to arrive by chauffeur from the Oberoi at the Guptas' mansion at 07:00.

In the December of that year, the Guptas booked Zwane into the Oberoi and hired him a BMW 7-Series to chauffeur him to and from the Dubai airport and the Guptas' house in Emirates Hills. *News24* 

# Crime has no nationality - Makhura

JOHANNESBURG - Gauteng Premier David Makhura cautioned political leaders against making "reckless remarks" which generally characterised foreign nationals as criminals.

"Africans from all over the continent, those who have chosen our province as their home, we want you to contribute positively to the growth and development of Gauteng province.

If you are a criminal, we must deal with you, whether you are a South African or an African from any other country. The first thing which defines you is that you are a criminal," Makhura told an Africa Month celebrations event in Johannesburg.

"Criminals must be dealt with [but] we must not criminalise a nationality. A criminal is a criminal, whether it is a Nigerian or a South African, that criminal belongs in jail. I want to warn those that

keep criminalising nationalities, sometimes it is the mayors who take platforms and condemn a whole nationality.

If there is a drug dealer who is a Nigerian, it is not that [all] Nigerians are drug dealers. We must deal with the drug dealer."

Makhura warned political leaders to avoid generalisations. He called for concerted efforts by all who lived in South African communities to fight crime, particularly drugs-related crime.

"If we have a South African who is a rapist you cannot then say all South Africans are rapists. We must deal with that rapist and put that rapist to jail. We work together with the African Diaspora Forum. Let us make sure that in our communities there are no drugs. God's people, drugs are killing our children. The drugs are finishing our communities.

# R9m bill to set up Rand West City

JOHANNESBURG-The merger of the troubled Westonaria and Randfontein municipalities will cost the taxpayers nearly R9 million, which will fund the setting up of a new organisational culture, workshops and branding, among others.

The new local municipality, Rand West City, has been granted more than R8.6 million to fund the costs of new municipal boundaries determined by the Municipal Demarcation Board, according to Gauteng Finance MEC Barbara Creecy.

The new boundaries came into effect after the 2016 local government elections. Rand West City spokesman Tshidiso Tlharipe said the grant was also a "transformational budget".

Tlharipe said the funds would be used for branding of the new municipality and creating a new organisational structure from the two merged entities. He said part of creating a new organisational structure and outlook would entail workshops for employees.

# 100 INMATES ESCAPE THROUGH A 90 FOOT TUNNEL

- More than 90 crawled through a 90ft tunnel under Parnamirim State Penitentiary
- Prisoners discarded their jail uniforms before changing into civilian clothes
- Eight were recaptured before being stripped and handcuffed by Brazilian guards

BRAZIL - Almost a 100 inmates escaped from a jail in Brazil after digging a 90ft tunnel under the prison walls, it has emerged.

Guards at the Parnamirim State Penitentiary in Rio Grande do Norte found the tunnel and the empty cells in the early hours of the morning.


They also found piles of clothes by the exit to the hole after prisoners discarded their uniforms, changed into civilian clothes and sprinted off to find getaway cars.

However, eight inmates were later recaptured and prison guards posted pictures of them lying handcuffed and naked on the floor.

The escapees somehow had time to wriggle along the 90ft homemade tunnel. As they emerged the other side of the prison wall, they left piles of abandoned prison uniforms and jail issue flip flops.

Then they reportedly waited at a nearby road for getaway cars to ferry them away from the jail, according to local reports.

More escapes were only thwarted when the heavily armed Military Police surrounded the jail and sealed the tunnel. Prison officials told local media they had no accurate figure for the number of successful escapees but it is reported to be as high as 82. Daily Mail

## MEET THE **MANCHESTER**

MANCHESTER - Leaning back nonchalantly with his hands thrust casually into the pockets of his black body warmer, there is nothing about Salman Abedi's relaxed demeanour that betrays his monstrous intent.

Yet minutes after these photographs were taken, he detonated the nail bomb in his backpack, killing 22 people, many of them children, and maiming dozens more.

Though facing his own death, too, there is nothing about his manner or his appearance to separate him from the countless other young men hanging around Manchester city centre last Monday night. He blends in with the crowd with his casual attire: a £65 Hollister body warmer, his best £150 Nike Air Jordan trainers, a black baseball cap, navy jeans with turnups. In one still, he stares ahead as his hand rests in his pocket, perhaps checking the trigger of the explosive device that he would use to murder teenagers and young children at the Ariana Grande concert in the Manchester Arena.

These images, taken from CCTV cameras, were released yesterday by detectives piecing together the final movements of the callous killer.

And in both pictures, the police have blacked out the background, suggesting they wished to protect the identities of people standing next to him at the time. The exact loca-







# **MAGIC INSPIRES BARCA**

MADRID - A Lionel Messi masterclass salvaged some silverware to end Barcelona's season and gave coach Luis Enrique a victorious send-off as the Catalans retained the Copa del Rey with a 3-1 win over Alaves on Saturday.

Messi opened the scoring then helped tee up Neymar and Paco Alcacer to lead Barca to a record 29th Cup triumph after Theo Hernandez's brilliant free-kick had briefly brought Alaves level.

Victory means Enrique bows out after three seasons in charge with nine trophies to his name, including the Cup in every year of his reign.

However, once again it was Messi who inspired Barca to bounce back from the disappointment of losing their La Liga title to Real Madrid last weekend with a stunning individual display.

Barca was without the suspended Luis Suarez and Sergi Roberto and Enrique was forced into another reshuffle just 11 minutes in as Javier Mascherano was forced off with a head injury.

Yet, whilst Barca's depth has been much-criticised this season, Andre Gomes deputised ably at right-back after replacing Mascherano and Alcacer took his chance in a rare start on the big stage in Suarez's absence.

Three minutes later Messi kicked off a thrilling four-goal spell in the final 15 minutes of the half as he exchanged passes with Neymar before curling his 54th goal of the season.

# Owen da Gama out of Baxter's Bafana

JOHANNESBURG - Owen da Gama will have to find a new role within the SA Football Association (SAFA) after Bafana Bafana Coach Stuart Baxter this week made it clear that he had his eye on someone else, not Da Gama, to be his assistant.

"I have got nothing personal against Owen, let me get that out of the way," said Baxter, who named his 25-man squad to face Nigeria in their opening 2019 Africa Cup of Nations qualifier in Uyo on June 10.

"When Louis van Gaal came to Manchester United, did he ask David Moyes to stay on as his assistant? If Pitso Mosimane is going to take over SuperSport United tomorrow, will he be asking Stuart Baxter to stay on as his assistant? That's football life, that I come in here and wouldn't have the person that was sitting in before as my assis-

Da Gama was asked to serve as Bafana caretaker coach in November last year when Shakes Mashaba was initially suspended for his tirade - aimed at his bosses - minutes following the national team's crucial 2-1 victory over Senegal in a qualifier for next year's World Cup.

Da Gama carried on in that capacity again in March for the two friendly matches against Guinea-Bissau and Angola, Mashaba having been sacked three days before Christmas.

Baxter has not discussed his backroom staff much since his appointment earlier this month, with reports suggesting that he'd asked SAFA to bring in his son Lee as the goalkeeper coach as well as Joshua Smith, who is currently the fitness trainer at SuperSport United, where Baxter is also coach until the end of June. "If SAFA have Owen under contract and want to put him into another role and he agrees, then yeah, but it won't be with the senior national team," the Scotsman explained.

"I am not going to give out names because I haven't gone to my employer yet. In principle, I think Thabo Senong (Under-20 coach and second assistant to Mashaba) has done a good job with the junior team and I think he should follow that group and see how

can take them, and maybe he can still be with us as someone we could men-

tor a little bit. Sunday Independent

Heavily criticised by Arsenal fans furious at the club's failure to qualify for the Champions League for the first time in 20 years, Wenger is yet to confirm if he will stay in charge

### Contract

Wenger's contract expires at the end of the campaign, but he remains popular with Arsenal's players and Ramsey made it clear he wants his boss to extend his 21-year reign.

Pinpointing Wenger's decision to switch to a three-man defence late in the season as the key to Arsenal's FA Cup glory, Ramsey said: "Of course I want him to stay at the club. He deserves this. "We changed the formation and had a lot of success.

"Fair play to him, he changed the system. Hopefully, he'll be there next season." Arsenal has won the FA Cup three times in the last four seasons and Ramsey has now bagged the winner twice. AFP

Courtois blames ref for Cup defeat

MANCHESTER - Zlatan Ibrahimovic will stay in Europe when he returns to action next season, despite rumours of a move to the United States.

Ibrahimovic will stay

in Europe - agent

Ibrahimovic faces missing the remainder of 2017 after injuring his cruciate ligaments last month, with the Swedish striker's situation unclear at Manchester United.

United had been expected to trigger an option to extend Ibrahimovic's contract at Old Trafford, yet that was before the 35-year-old sustained a long-term injury. Ibrahimovic's agent, Mino Raiola, insists that the former Juventus and Inter Milan striker will continue playing, although he is unsure whether that will be at United or not.

But if Ibrahimovic does depart, he will join another European club, rather than moving to the MLS.

"I do not know if he will stay at Manchester United, many clubs want him," Raiola told Sky Sports.













This is because of the statements he issued against the president of the FAF, Khireddine Zetchi, according to the professional association published on its official website.


MC Alger is expected to land in the country any day from today for their CAF clash with the 'Beautiful Birds' slated for the country's only mecca and kickoff is 3pm.
