

# KAKONA SENTENCE TO 72 YEARS I

ONE could hear a needle drop in Court C at the High Court when Judge Nkululeko Hlophe delivered a sentence against businessman Johannes Mfanukhona Kakona Dlamini yesterday.

Dlamini was sentenced him to 72 years in prison for 57 car theft related offences.

There was total silence as Judge Hlophe read his more than one hour sentence following a marathon trial for Dlamini and his co-accused Siza Sibeko, who were arrested in January 2013.

However, Dlamini will spend about 36 years of the 72 years as some of the sentences are to run concurrently.

Justice Hlophe yesterday passed the sentence at a packed Court C after handing down judgment where he found the two guilty of 57 car theft related offences last week.

#### Report

Seated calmly in the accused's dock with his co-accused, Dlamini followed the proceedings closely as Justice Hlophe read the sentence.

When passing sentence, Justice Hlophe stated that on counts 1, 3, 4, 6, 8, 9, 18 and 33 where Dlamini was found guilty of having stolen cars form various people, he was sentenced to three years in prison on each particular count, which tallied to 24 years in jail and the sentences are to run consecutively.

On the other counts where Dlamini was convicted for failure to report some of the car parts that were stolen from cars in South Africa, the court sentenced him to 20 years imprisonment or E20 000 fine. On the counts in which Dlamini failed to declare stolen parts which were found in his possession, the court sentenced him to 20 years imprisonment with an option to pay E27 000.

Meanwhile, on the other counts, the businessman was sentenced to 10 years and five years in prison, respectively, while he was sentenced to six months

### Kakona's E160 000 bail frozen

THE bail money that had been deposited by businessman Dlamini with the government treasury has been frozen following an order issued by the court yesterday.

This, after an application filed by the Director of Public Prosecutions (DPP) that the bail be frozen following an application they have filed to have Dlamini's assets investigated for possible forfeiture to the state. Deputy Director of Public Prosecution (DPP) Israel Magagula filed the application yesterday and defence counsel Linda Dlamini from Mabila Attorneys in Association with N. Ndlangamandla and S. Jele did not oppose the application by the DPP. The DPP has also applied that one of the victims, whose car was stolen from South Africa, be compensated by Dlamini after conviction and sentence

in prison with a fine option to pay E500 on count 71, which was that of contravening the Immigration Act.

When passing sentence, Justice Hlophe stated that he tried all he could to reach a fair sentence which, however, would serve as a deterrent to would-be offenders. "I have also considered the personal circumstances of the accused person and that he cooperated with the police during investigations, did not violate his bail conditions while out on bail before it was revoked and further he is a married person who has children, however, I can not lose sight of the seriousness of the offences and that some of the victims could have been killed when the offences were committed," Justice Hlophe said.

#### **Investors**

Justice Hlophe mentioned that as much as the defence counsel had submitted that the sentences should run concurrently, some of the sentences could not as it is impossible according to the offences that fall under Sections 3(1) and 6 (2) of the Theft of Motor Vehicle

Diplomatic relations and investor confidence, according to Justice Hlophe, affects both the Kingdom of Eswatini and the Republic of South Africa, hence these offences are viewed as of a serious nature

"I have tried to approach sentencing with leniency as possibly as I could but could not avoid harshness, I have however considered the health of the accused

tence to Dlamini's day of arrest, and the period he has been in custody after his bail was revoked. Dlamini has already spent more than a year in jail as he has been kept at the Sidvwashini Correctional facility. Witnesses paraded by the Crown were about 48, who gave damning evidence against Dlamini and his co-accused with some of the witnesses being car theft experts from the South African Police Service (SAPS).

In the other count of contravening the Immigration Act, Justice Hlophe found Dlamini guilty of illegally harbouring Vincente Muambo from Mozambique whom he had employed in his business.

The businessman and his co-accused were found to be specialising in stealing Toyota Hilux brands as they were convicted to have stolen nine Toyota Hilux cars and a Toyota Quantum in the Republic of South Africa

The court stated that from the evidence brought before it, the cars were stolen in Durban, Rustenburg, Lalucia, Pongola, Marikana, Badplass and Sulphursprings Plaas in the Republic of South Africa.

Most of the cars were stolen while parked outside malls or parking areas.

They were then smuggled into the country and conveyed to Ngwane Park in Manzini where they were altered, tampered and their engines repaired.

### MP Magongo warns King of gossipers

OUTSPOKEN Motshane MP Robert Magongo warned His Majesty King Mswati III about gossipers who are hell-bent on crippling the economy of the country.

Magongo was speaking yesterday as he introduced himself to the King at the Mandvulo Grand Hall.

Magongo decided to be different from the rest of his colleagues and went straight to the three important topics he talked about.

Even before Magongo he could start his address, people in the hall began laughing, an indication that they expected fireworks. He too, had something to say about the laughter of his colleagues.

"Your Majesty, these people are reacting this way because they know that I am about to speak nothing but the truth," Magongo said.

He said the act of gossiping was also detrimental to the country's economy. MP Magongo said the King should not open any room for people to gossip in front of him.

Magongo said it was better for the King to hear two sides of a story whenever someone decided to gossip. He stressed that hearing only one side of the story and acting on it was very dangerous.

"If someone decides to gossip about Robert Magongo, I urge you, Your Majesty, to call me so that you can hear my side of the story," he said. Magongo further asked the King to ensure there was a judicial commission of enquiry set up for the looting of state funds to be investigated.

"Now we are complaining about money that is not there. The truth is that the money was there but mysteriously got lost due to corruption. We should set up the commission of enquiry to find out how the money got lost," he said.

Magongo further advised the King to make it easy for MPs and senators to pass a vote of no confidence against ministers. He said the vote of no confidence was a very important catalyst in ensuring efficient service delivery among Cabinet ministers.

Magongo said there should be an ad hoc committee that should be set up to ensure that it gave good advice to MPs as they implemented the vote of no confidence. He said after they had moved the vote of no confidence, the King should then sign it.

The Motshane MP further asked the King to solve the chieftaincy disputes that were becoming prevalent in the country.

This could be solved by hastily replacing chiefs who had passed away. The chieftaincy disputes were a hindrance to economic development and should be discouraged.

# KING CALLS FOR BUDGETING WORKSHOP FOR LAWMAKERS

IT is imperative that legislators should be trained on budgeting so that their decisions are informed when coming up with the national budget.

This was said by His Majesty King Mswati III yesterday when addressing legislators at the close of the two-day introductory session by the lawmakers at the Mandvulo Grand Hall.

#### Reality

The King said it was important for legislators to have a workshop before they embarked on the exercise of forming a national budget.

His Majesty said the legislators should come up with a budget that could not end up being wishful thinking, but a reality.

ing the parliamentarians on the revenue base of the country.

The knowledge on how the country generated money would help government not to speculate when budgeting, but formulate the budget based on money that was already generated.

#### Responsibility

The King said MPs should know exactly how the country generated money. This would help them in coming up with other solutions that would boost the country's income.

He said that was when the MPs would be able to come up with sensible budgets.

He further informed the legislators that it was not only the responsibility of the Executive to ensure the sensibility of the budget, but Parliament should equally share the responsibility with the Execu-

#### Taxes

The King said failure to come up with a proper budget would mean that Parliament failed as well.

Ingwenyama expressed concern on the non-payment of government suppliers, saying this hugely affected the growth of the country's economy. "This causes a situation where government and suppliers engage in what is known as a tug-of-war. Suppliers fail to pay taxes and blame government for not paying, while government, on the other hand, shifts the blame to suppliers for not paying taxes, hence they fail to pay for services," the King said.

The King said the country should align itself with the Sustainable Development Goals (SDGs) of 2030. This called for the MPs to work hard and turn the economy around to ensure that the nation had a better life.

#### **Difficulties**

The King concluded by telling the legislators he wanted to see the country becoming a financial hub.

That should be doable because other countries were able to do it. He made an example of countries like Singapore, saying it was able to do it, despite the difficulties.

The King said the country was lucky because it was small and Emaswati were a group of people that spoke the same language and belonged to one tribe.

# His Majesty talks on challenging laws in court

THE spirit of challenging laws of the country in courts is not a strategy that will take the country to the first world status by 2022.

This was said by His Majesty King Mswati III yesterday when giving advice to parliamentarians yesterday at Mandvulo Grand Hall.

The King said he did not understand why people would challenge the laws that were already in place.

The King said the process of enacting legislations gave opportunities to people to make their own contributions.

He wondered why people would not go there and make their submissions so that their opinions could be considered before being enacted.

Laws

He said the spirit of challenging laws just because they did not conform to other laws was not the right attitude to take the country to the first world status by 2022.

The King further told the MPs to ensure that the country had peace because that was the necessary ingredient for the country to developed.

He further urged the legislators to know the constitution because they had the task of defending it and abide by it at all times.

He said the legislators could not be able to defend the constitution without reading and knowing it.



# 2 SANDLENI PRIMARY PUPILS DEAD AFTER BEING STRUCK BY LIGHTING

TWO pupils from Sandleni Primary School died after being struck by lightning on their way home from school on Tuesday afternoon.

The pupils have been identified as Sibulelo Zwane (13) and Bongeka Simelane (14).

They were struck by the lightning on Tuesday just after 1600 hours. Both pupils were in Grade Seven. They were pronounced dead on arrival at hospital, where they were ferried for treatment after sustaining serious

She alleged that she found both of the pupils lying unconscious on the ground with their clothes burnt.

Simelane said the two were friends and also neighbours."They had bruises on the face and were rushed to hospital by police officers from Sandleni Police Post," she said. She said both families were traumatised by what befell their daughters. "We are still going to meet as a family and discuss the funeral logistics," she said further adding that teachers from Sandleni Primary School came to comfort the families of the deceased pupils. On that note, Chief Police Information and Communication Officer, Superintendent Phindile Vilakati confirmed the matter.

She said two pupils from Sandleni Primary who were in Grade Seven were struck by lightning and were certified dead by a medical doctor.

"On Tuesday around 1615 hours, a 55-year-old man of Sandleni reported he had discovered that his daughter (15) and 14-year-old niece were struck by lightning while at Sandleni area," she said.

### Heroin, dagga exhibits worth E14.3m destroyed by furnace

MEMBERS of the Royal Eswatini Police (REP) Anti-Narcotics Unit (ANU) destroyed heroin as well as dagga exhibits which were collectively worth E14.3 million.

The dagga exhibits were worth E2.3 million, while the heroin amounted to E12 million.

The drugs were destroyed by furnace yesterday at an undisclosed location around Pigg's Peak.

Heroin which weighed 30kg was confiscated at the Ngwenya border post late last year. To date, the heroin exhibit is recorded as the highest (heroin) exhibit ever confiscated and destroyed by REP.

The dagga exhibits collectively weighed over three (3) tones (3 880 kg), and were sourced from different courts and police stations around Eswatini.

The last time dagga exhibits were destroyed by furnace was on June 24. Present at the drug exhibit destruction exercise was Pigg's Peak Senior Magistrate Siphosini Dlamini, Public Prosecutor Dolly Shongwe and Superintendent Ephraim Mshiyeni Maphalala of ANU.

Dlamini said the new parliamentarians should explore ways to reduce dagga dependency in Eswatini as dagga cases were rife in courts.

"Dagga cases continue to be heard

in the courts on a daily basis, and that is unfortunate.

This means that criminals are heavily dependent on the selling and cultivation of dagga. The new parliamentarians should find innovative ways of reducing the dagga dependency in Eswatini by creating more employment opportunities for the people. It is important to mention that dagga is a gateway drug, meaning a person usually starts by smoking cigarettes then that individual moves on to smoking dagga. After sometime, that person then tries hard drugs like heroin. Eswatini has already spent large amounts of money treating people who have been adversely affected by dagga abuse at the psychiatric centre," he said.

On that note, prosecutor Shongwe

said the current anti-drug laws in the Kingdom were out dated as they were originally passed in 1920 and 1922. "Public prosecutors are asking that our new parliamentarians update all the laws pertaining to drug possession in Eswatini. Currently, every person apprehended with drugs is charged with breaking two main drug laws.

The problem with these laws is that they are out-dated as they were originally introduced in 1920 and 1922. These laws need to be updated to suit the current landscape. Also we are happy that Parliament has passed the new Prevention of Crime Act that will require people to explain how they got their wealth, this is important to further discourage people from selling and cultivating dagga," she said.

# COURT ORDERS BOARD

**HUMAN Rights Lawyer Thulani Rudolf** Maseko who was seeking an order of Court to have the Liquor Licencing Board (LLB) and its chairman sent to jail for contempt, yesterday became victorious as the court ordered that the board should grant him a liquor licence.

Maseko had filed an urgent application at the High Court where he was seeking an order amongst others, directing the chairman and his board to issue to him a trading licence in accordance with an order by Justice Titus Mlangeni and committing the chairman and his board to prison for contempt of the judgment of Justice Mlangeni delivered on October 6, 2017 where the honourable Judge ordered that the board should grant Maseko a permit to operate the liquor store.

When the matter was supposed to be heard before Justice Nkululeko Hlophe yesterday, lawyer Xaba from the Attorney General's office who was representing the board, informed the court

that by consent, the applicant (Maseko) would now be granted the licence to operate the liquor store. She submitted that the board would meet on Monday and Maseko would be issued with the licence to operate the liquor store as per prayer two of Maseko's notice of motion.

Lawyer Sifiso Magnificent Nhlabatsi of TR Maseko Attorneys who was representing the applicant confirmed that by consent the respondents (board) have agreed to issue the permit.

Judge Hlophe then issued the order that the responde...s are hereby directed to issue the trading licence to the applicant.

In his application. Maseko had also sought an order directing the Sheriff of the High Court to apprehend the respondents (chairman and his board) on sight and keep them in custody at His Majesty's Correctional Services (HMCS) facility at Sidvwashini forthwith.

Maseko had further sought an order of court directing the gaoler at HMCS to accept into his custody the respondents and keep them there for a period of 30 days until further orders by the

### 'I WAS WRONGFULLY DENIED LICENCE'

MASEKO in his affidavit submitted that the Court as per Justice Mlangeni delivered a

the matter where he (Maseko) had complained of being unlawfully and wrongfully denied a liquor trading licence by the respondents.

He had submitted that the court in the initial matter heard that he had complied with all the provisions of the Liquor Licencing Act, hence the respondents should have issued the permit in his favour forthwith.

However, Maseko submitted that following the judgment by Justice Mlangeni, the respondents noted an appeal and had to wait for it to proceed and that he moved an application to execute the court order pending the appeal, but the High Court dismissed it. "The matter was called before the Supreme Court on October 10, wherein the court struck the matter off the roll and ordered that it cannot be reinstated without leave of court as the respondents did not file their papers on time," Maseko submitted.

He stated in his affidavit that despite that the appeal had been struck off the Supreme Court's roll, the respondents have wilfully, deliberately

and intentionally refused to abide by the order of court issued by Justice Mlangeni in spite letters written by his attorneys to them to that effect.

He submitted that he had been advised and verily believed that in order to succeed in an application to have the respondents committed to prison for contempt, he only had to show three elements which were in their order.

These were that the order was issued, that the respondents were either served with the order or were informed of the grant of the order against them and that they had no reasonable grounds to disbelief the information and lastly that the respondents had either disobeyed the order or have neglected to comply with it.

As alluded to the above, all three elements according to Maseko were established in this matter and at all material times thereto, both in relation to the court order of Justice Mlangeni as well as the order of the Supreme Court, the respondents were fully aware and represented.

He stated that the respondents were fully aware of the orders but they deliberately and with malice neglected to obey same hence the honourable court should grant the prayer sought.

They are said to have been playing when the victim allegedly unleashed the stone which landed on Shabangu's daughter. Upon making this discovery, Shabangu without uttering even a single word pounced on the minor.

He assaulted the minor with an electric wire cable all over the body such that he had to be attended to by doctors at the Mbabane Government Hospital due to the nature of the injuries that he sustained.

Shabangu said he didn't disregard that his conduct was unlawful.

# 'Mental health services isolated in Africa'

#### IN Africa, mental health services have been isolated and not integrated into health services.

Countries have struggled with placement of mental health in the systems, leaving mainly families to carry the burden, care often with little or no support from the system. This is the view of World Health Organisation Health and Promotions Officer Moagi Gaborone.

"Unless countries embed and expand mental health into general health services in hospitals, clinics, health centres and ensure universal coverage, therefore, the growing and understated mental health crisis is set to escalate dramatically," Gaborone said. Gaborone was speaking on Tuesday during the first African Mental Health Symposium for civil society held at Blue Tree in Gaborone, Botswana.

However, he said some countries are beginning to experience a growing mental health crisis, especially among young people who abuse substances out of frustration from unemployment and unful-

filled destinies.

# SUGAR CANE COMPANY LEADERSHIP BATTLE GROUNDS PROJECT

IT is not so sweet for a newly elected board of director and employees to a sugarcane farming company based at Ngcamphalala area in the Lubombo region as salaries for employees have not been paid and farming chemicals cannot be purchased as its bank account has been frozen.

Factionalism within Tikane Investments (Pty) Ltd, a sugar cane farming company run by residents within Ngcamphalala area under Chief Ngcamphalala is grounded due to an on-going leadership battle following two factions both claiming to be the rightful directors of the company.

The newly elected directors have taken the former board members to court where they are seeking an order decaling an alleged forged registrar of companies document set aside as it was submitted by the other former board.

This is the second urgent application filed within a space of three months. In the initial application, the other board (now applicants) sought an order that the new one submit keys to the company offices and all relevant company documents including books of accounts.

Initially, Chairperson Sabelo Dlamini (now part of the respondents) in their application had stated that on September 12, and in accordance with the company's constitution, the members of the company conducted elections to replace the previous board of directors (now applicants) who had been in office since September, 2017.

Dlamini had submitted that Fakudze and the other applicants, who were the executive members of the replaced board, boycotted the elections and did not participate and a new board is now in office having duly filed all the requisite documents with the registrar of companies and relevant financial institutions.

He said the new board thereafter requested the outgoing one to do the official handover of company documents and the other members agreed save for the



respondents. They refused to hand over the documents.

On Tuesday, the applicants Sisana Fakudze (first), Catherine Dlamini (second), Dumsile Sikhondze (third) Sikelela Ngcamphalala (fourth) and Simo Dlamini (fifth respondent) filed yet another urgent application at the High Court where they are seeking other orders amongst others, directing Eswatini Development and Savings Bank (EDSB) cited as the ninth respondent, to unfreeze or allow access to them to continue transacting on the bank's Siphofaneni branch.

#### Order

They are also seeking an order of court that a rule nisi operating with immediate effect in terms of the prayers sought be issued and returnable and calling upon the respondents to show cause why the prayers should not be made final.

According to Sisana Fakudze in her founding affidavit, owing to some misunderstandings amongst other members of the company (Tikane Investments), there now exists two factions within its members. She submitted that the second respondent (Sabelo Oscar Dlamini) has decided to boycott his duties as chairperson as per the results of elections held on September 29, 2017. She alleged that Dlamini has been causing all sorts of chaos in as far as the administration of the company is concerned and allegedly holding meetings that take decisions without following the provi-

sions of the company constitution.

"On September 2, the second respondent and his faction held a meeting at Engevini Royal Kraal and held elections where they purported to elect new members of the board of directors whilst the sitting and current board (applicants) were still in office.

On October 22, myself and the treasurer went to the bank to withdraw money to purchase needed farming utensils and prepare salaries for employees, but were shocked when we were informed that the account had been frozen owing to the fact that the second respondent and his faction lodged in Form J," Fakudze submitted.

She said she was advised that in terms of J, there was now a new board of directors for the company who were introduced to the bank and was advised that the bank was informed that all the applicants had resigned as directors thus giving room to the new directors.

She submitted that the matter was of urgency since employees of the company need to be paid their month end salaries, hence they have been seriously prejudiced unduly arguing that was good reason to access the funds since they also have to purchase fertilisers and other pharm chemicals for the treatment of the sugar cane within the fields. The matter was before Judge Maxine Langwenya on Tuesday and representing the applicants is Lawyer Manda Mdluli and the matter is yet to be argued.


"He was rushed to Nhlangano Health Centre and the owner of the car remained at the scene. He is fully cooperating with the investigators," alleged the source.

Chief Police Information and Communication Officer Superintendent Phindile Vilakati confirmed the accident.


"A 30-year-old man of Sigcineni knocked down a pedestrian a man aged 28 of Mahlabatsini," she said.

# EKUKHANYENI HIGH SCHOOL **PUPILS BACK IN CLASS**

PUPILS at Ekukhanyeni High have been called back to class after they were banned from setting foot at the school following a violent class boycott which saw the learners burn-

The decision to call the pupils back to school was communicated on Tuesday after the school committee and Manzini

Regional Education Officer Mlimi Mamba called an urgent parents' meeting. During the meeting who was held at the school, parents resolved that their children should be called back so that they continue with their tests. Learners who were banned from setting foot at the school were those in Forms One, Two and Four.

The learners ran riot following allegations that there was a child from the same school who had hanged herself. This being the fourth reported incident

of a learner who died under mysterious circumstances, the pupils lost their tempers and ran amok.

Despite that the rumours of the fifth child who was alleged to have committed suicide were not true, most of the learners believed the rumour and out of anger, they started vandalising and burning property. School committee Chairman Elliot Shabangu confirmed that they have since decided to allow learners back to class immedi-

THE Eswatini National Youth Council (ENYC) and the Food and Agricultural Organisation (FAO) have commenced a site monitoring exercise for the farming projects initiated to capacitate various youth groups across the country. # Govt employees staying at William Pitcher College at expense of lecturers

WILLIAM Pitcher Principal Philemon Gumedze has complained about government employees who are working for different ministries and departments but staying at the residential houses at the college premises at the expense of lecturers who are without accommodation.

The principal has reported this anomaly to the ministry of education and training. He said there are 20 houses which are not occupied by William Pitcher College staff but civil servants from different government departments and ministries. Gumedze was speaking during the graduation ceremony held at William Pitcher College on Monday. Speaking about the challenges faced by the institution, Gumedze said the college faces an acute shortage of staff accommodation. He said this has been a persistent problem over the years, and every year the problem keeps compounding as new lecturers join the college. Gumedze said, unfortunately, there are residential houses within the college residential compound which are occupied by other government employees from other departments and ministries at the expense of William Pitcher College lecturers who reside as far as Nhlangano, Big Bend and other far-flung places. "You may wish

to note that these lecturers have to start work at 7.00am and there are people who are occupying these houses and start work at 8:00am, I don't think that this is fair." said Gumedze. He further added that some claim that these are pool houses and not institutional houses. Gumedze said if these houses, which were originally used by William Pitcher College staff and are within the institution premises, are now open to every civil servant even if there is a William Pitcher College employee who needs to use it, when did they become pool houses?

"Perhaps we need to revisit the definition of a 'pool house' and an institutional house? Can a civil servant who is not a teacher be housed in a teachers' quarters within a defined boundary in any school around the country. I do not think that can happen," Gumedze stated. He said they were looking forward to the ministry of education and training rescuing them in the area of staff accommodation. He said an assessment made indicated that more than 20 houses are occuppied by the NCC and INSET who are known to them as they fall under the ministry of education. Gumedze said another issue which needs to be addressed was that of lecture rooms which must be used to accommodate all the students. The principal also said due to the shortage of staff offices, they had to turn two classrooms into a staffroom.

# Cop hospitalised after DD suspect pushes him into ditch

A member of the Royal Eswatini Police (REP) Service under the traffic department is fighting for his life in hospital after being allegedly pushed into a 20 metre ditch by a drink-driving suspect who was evading arrest.

Sthembiso Mncina (39) of Nkwalini area has been arrested and charged in relation to the incident.

Appearing at the Magistrate's Court, the accused person pleaded guilty to only one of the charges preferred against him whilst pleading not guilty to the three others. Initially, Mncina was facing a total of four counts.

It is said last Thursday, at about 0853 hours near the Eswatini Electricity Company (EEC) in Mbabane, Mncina, being a driver of a vehicle registered DSD 465 DM Toyota Noah, allegedly

drove the said car whilst under the influence of alcohol or drug having narcotic effect. Content dictated by a breathaliser specimen on the accused read 0.47 ml/g, which is above the legal limit.

He is also said to have tried resisting arrest effected by Constable Mabuza by fighting and pushing him, as a result, he fell into a ditch which was more than 20 metres deep.

The officer was admitted at the Mbabane Government Hospital as he was apparently seriously injured during the scuffle. Mncina was also accused of attempting to escape from lawful custody by jumping out of a police vehicle and running away.

The accused is said to have been later apprehended by another police officer. He is also said to have failed to adhere to police instructions by failing to fur-

nish them with his driver's licence. The crown said it would parade witnesses to solidify its case in the matter.

It, therefore, applied for a trial date which would be suitable to the court. The crown further submitted before court that the accused person be remanded back into police custody pending trial, but bail was not opposed.

The accused person swiftly made a bail application after being advised to do so. He informed the court that he is also making visits to the hospital as he was also injured during the scuffle with the police. Bail was eventually granted and fixed at E2 000. The accused person is expected back in court November 6 for trial.





# RECONSTRUCTION OF LUKHULA -BIG BEND ROAD TO FINALLY KICK OFF

FINALLY, re-construction of the potholed riddled Lukhula-Big Bend road which has, for many years, been giving motorists a hard time, will commence early next year, it has been confirmed.

The approximately 55-kilometre road has been a nightmare to motorists for over a decade now. Motorists, especially public transport operators have been complaining about it's state, while government also made promises to attend to it as a matter of urgency.

At least on three occasions, former minister of public works and transport, Lindiwe Dlamini conducted a tour along the road during the tenth Parliament, and promised that it would be reconstructed before the end of her term in office. This did not happen. Dlamini was last week elected the

President of Senate, replacing the long-serving Gelane Zwane.

Motorists will heave a sigh of relief after learning that the reconstruction of the road will be kicking off in less than three months from now. This was disclosed during a preliminary meeting at Mpolonjeni Inkhundla on Tuesday where the construction companies met with stakeholders who included the regional administration office, traditional authorities and residents of the constituency.

The road will be reconstructed by well-established construction companies, AG Thomas Construction and WBHO. The companies were represented by Simon Queen during the preliminary meeting. Queen disclosed that they had already set base in the area in preparation for the road works and the companies involved had booked some of their expert staff members at Lituba Lodge as recontruction plans were underway.

He disclosed that by year end, they would be working on clearing the roadsides from the Big-Bend direction towards Lukhula. Upon completion of the clearing exercise, reconstruction of the road will then commence from the Lukhula direction towards Big-Bend. Queen said they were hoping to have the reconstruction of the road completed by the end of next year. Apparently, talks between government and the construction companies are said to have been finalised, hence the start of the reconstruction of the road.

Meanwhile, Lubombo Regional Secretary Nhlanhla Nxumalo commended government for finally financing the project. Nxumalo noted that the state of the road was now a crisis and had also contributed to a number of fatal accidents. A recent accident which occurred about five months ago claimed four lives on the spot when two Quantums collided head-on while trying to negotiate potholes. Moreover, Nxumalo said the road had the potential to promote tourism as it connected three countries being Eswatini, South Africa and Mozambique. The road is also greatly used for exporting sugarcane products as it is situated along the sugar belt. "We are very happy to see this project finally taking place as it will contribute immensely in the country's economic development," said Nxumalo.

# Hundreds queuing for employment at AG Thomas offices

HUNDREDS of job seekers from around Mpolonjeni and other places are reportedly cramming AG Thomas Construction's offices at Lituba Lodge as they hope to be employed for the reconstruction of Lukhula- Big Bend road.

The construction company have set base at the said lodge. Speaking during a preliminary meeting at Mpolonjeni yesterday, Simon Queen who represented the construction companies disclosed that hundreds of people were already flooding their offices to seek employment. Queen said however, the companies had not yet started employing people for the project as the reconstruction of the road would only start next year.

Queen said for now, they were receiving applications from qualified individuals under the engineering and construction departments. He said the companies will then hire labourers next year when the project takes to the ground. Queen explained this after he was asked whether the companies would prioritise locals for employment during the exercise. He further invited local companies which would like to be subcontracted to submit their paperwork at the company offices set at Lituba Lodge.



# HIV testing: The first step to ending AIDS



"MASWATI you are encouraged to know your HIV status as one of the basic requirements of healthy living. Likewise, no Liswati should be denied access to healthcare, including HIV treatment."

These are the wise words of His Majesty King Mswati III, Ingwenyama of the Kingdom of Eswatini, shared February 12, 2016, during the official opening of the 3rd Session of the 10th Parliament.

In his speech, the King addressed key issues that the country had to grabble with that year, noting that 2016 set the pace for implementing initiatives aimed at ending AIDS through strategies that are inclusive of all individuals and deeply rooted in community ownership.

The previous year, in opening the second session of the 10th Parliament, the King had categorically denounced all HIV stigma and discrimination, emphasising that 'Lokukhombana akuphele kutsinya!'

This was said in recognition of the negative effect of denial, silence, rejection and discrimination of people living with and/or suspected to be living with HIV and AIDS, on the country's HIV programmatic responses.

HIV-related stigma affects those living with HIV and by extension, those that they are associated with – including their partner or spouse, children, and other members of their household. His Majesty's call for all Emaswati



to make HIV testing a life-style, bodes well with the country's 95.95.95 initiative that is meant to be the national ladder to ending AIDS.

The initiative is building on the current narrative on HIV treatment with the following targets for 2020: 95 per cent of all people living with HIV will know their HIV status; 95 per cent of all people with diagnosed HIV infection will receive sustained antiretroviral therapy; and 95 per cent of all people receiving ART will have viral suppression.

# THE PREVAILING HIV SITUATION IN THE COUNTRY

The Extended National Strategic Framework (2014-2018) saw new HIV infections decline from by 44 per cent; 84 per cent of people living with HIV put on ART, an effort accelerated to reduce vulnerabilities to HIV infection among key and priority populations.

To reach the last mile however, more needs to be done to reduce new infections and ensure no one is left behind. As it is, about 6 500 new infection occurred in 2017; 15 per cent of PLHIV are not on care, TB/HIV co-infection rate is at 70 per cent and other co-morbidities are emerging as a threat to the life of PLHIV.

Annual incidence of HIV among

adults ages 15 years and older in Eswatini is 1.36 per cent – 1,70 per cent among females and 1.02 per cent among males. This corresponds to approximately 7 000 new cases of HIV annually among adults 15 years and older. HIV prevalence among people 15 years and older was 27.2 per cent in 2017, with women at 32.5 per cent being more affected than men at 21.3 per cent.

In the same year, prevalence among adolescents and young people was estimated at 9.6 per cent (16.2 per cent for females and 3.0 per cent for males). This is particularly worrying because HIV prevalence among adolescents and young people is an indicator of new infections acquired rather than a survival effect of the treatment programme

### IMPORTANCE OF TESTING FOR HIV

In the country, HIV testing and counselling (HTC) is a critical entry point for HIV prevention and treatment, care and support services. It also enables individuals to access other services such as male circumcision (MC), post exposure prophylaxis (PEP), prevention of mother to child transmission (PMTCT), treatment (ART, TB/HIV) and control and management of sexually transmitted infections (STIs). For service providers, HTC also provides a unique opportunity to offer health

information and education, create awareness of HIV and AIDS, and create demand for other services.

HIV Testing Services (HTS) are offered through facility and community-based service points. At health facilities, Provider Initiated Testing and Counselling (PITC) is offered to all clients across several service points while at community level, HTS is offered through mobile clinics, outreach campaigns, VMMC platform and wellness programmes.

HTS is offered to key populations - Female Sex Workers (FSWs) and Men Who Have Sex with Men (MSM) - at hotspots and through referral to health facilities. Index case testing and self-testing have also been adopted to scale up HTS. The SHIMS 2 results indicate that 84.7 per cent of people living with HIV ages 15 and older report knowing their HIV status.

There are 88.6 per cent of HIV positive females and 77.5 per cent of HIV-positive males that know their status. It further indicates that among these PLHIV ages 15 and older who know their HIV status, 87.4 per cent self-report use of antiretroviral treatment –86.9 per cent of HIV-positive females and 88.6 per cent of HIV-positive males. Of these self-reporting 15 and older PLHIV, 91.9 per cent self-report viral load suppression: 92.2 per cent females and 91.3 males.

In the quest to end AIDS by 2022, it is important therefore, for all Emaswati to know their HIV status because:

- Many new HIV infections are caused by people unaware of their HIV positive status;
- HIV medicines are much more effective when started early;
- Starting treatment late, limits treatment options so it is best to find out an HIV positive status before the disease reaches advanced stages.

The 15.3 per cent that are unaware of their HIV status pose a real challenge to the national effort to end AIDS.

In both men and women, being unaware of a partner's HIV status confers almost four and threefold increase in risk respectively, compared to knowing one's partner to be HIV-negative. Knowledge of HIV status enables HIV-negative individuals to make specific decisions that can reduce the risk of contracting HIV.

For those that are HIV-positive, knowledge of their HIV status allows them to take action to protect their sexual partners, access treatment, and to plan for their future. For HIV positive pregnant and lactating mothers, they can take action to receive a course of ARV to reduce mother-to-child transmission in accordance with nationally approved protocols.

Knowledge of an HIV positive status will also have a profound impact on the quality of care that pregnant women receive at facility level, especially during labour and delivery.

#### THE WORK AHEAD

Over 73 per cent of the population in the Kingdom of Eswatini is HIV negative. This means that the primary focus of the country's HIV response (as outlined in the NSF 2018-23) is to ensure those who are negative remain so, with special attention on those populations most vulnerable to HIV infections. The proportion of men tested for HIV ranges from 33 per cent to 60.9 per cent while coverage for women ranges between 45.5 per cent and 74.2 per cent. There is also lower coverage among males 15-19 (33 per cent) than females of the same age (47.9 per cent). About 66 per cent of adolescents and young people (AYP) living with HIV and 77.5 per cent of males 15 years and older have been diagnosed.

Sharply increasing the proportion of people living with HIV (especially men and young people) that know their HIV status requires moving beyond a passive approach to testing – one that relies on the individual to recognise his/her risk and come forward without coercion, to learn his/her status.

As His Majesty long proclaimed, "I-HIV YindzabaYetfu Sonkhe". Let us do away with the practices that perpetuate stigma and discrimination, to allow all to embrace and access HIV testing.





#### THE NATIONS PRAY



IT was my father who first opened the door for me to look at the world events as connected with God's Word and His purposes unfolding on planet earth.

It has been a joy, an exciting adventure to watch the News on TV, on social media or read a newspaper and see it as something more than a depiction of events that are of my control. Instead, the very things taking place around us are an indication that God is indeed in control. Why are we seeing a revival of Old and New heresies and strange doctrine in our days? It is time for us to intercede against curses, spell, and lying spirits attacking the church and our government.

All often, we feel powerless and at the mercy of a very big world. Watching or reading of news events can feel like an exercise in futility and even worse, bring a sense of anxiety and worry into our lives. One way to deal with that is to shut yourself off from the world. You could turn off the television news and stop reading the news.


It may provide temporary relief, but certainly does not change the situation.

There is a better way. It involves a commitment to change your world through prayer. It happens as you see God's commitment to prayer as a change agent.

You begin to see yourself as a player on the world stage. Rather than passively watching and worrying, or ignoring and hiding, you begin to take significant action to bring God's power to bear on situations going on in the world: You pray!

Throughout church history, the prayers of believers have been used by God to change the flow of events and alter what might have been. One of the more dramatic instances of this occurred during World War II and involved the small group of intercessors that gathered in Great Britain under the leadership of Ress Howells. Again, and again, God led them to pray over battles and situations, many which they could not have even known about through their natural senses. In numerous situations, the Lord used their prayers to ensure victory and to change human history.

Obviously, in a case like this, the prayers by themselves did not bring about victory. Men and women in dangerous places fought fierce battles and some paid the ultimate price. But the prayers of Ress Howells and his band of intercessors brought the power of God into the battle and altered history.

For further reading on this amazing story, I recommend Norman Grubb's book, 'Ress Howells: Intercessor.'

Most of us don't feel like world changers. We're just trying to get through day by day. But God has provided an amazing opportunity for us to join with Him in intercession and see His power bring transformation on all the nations. It will just take a change of attitude and different way of responding to the news.

The attitude is probably the most difficult. If we believe God, then our attitude will begin to shift from being passive to being proactive. Rather than sitting and complaining about things we see or read in the news, we will begin to pray to bring about change.

A changed attitude...agreeing with God that someone ought to do something and that He (God) is probably the best someone...will bring us into serious prayer.

That changed attitude will cause us to redeem the time we are using for frivolous things to become aware of the world and national events. We begin to approach the news as serious times of prayer. Instead of passively in the news, we move into aggressive intervention. I call it prayer! This is very intentional praying. It does not happen accidentally. Make a decision to consider the news as a prayer event.

Ask the Lord to guide you as you pray. There are so many times we respond to events by

telling God what He should do, but He is not looking for our advice. He is, however, looking for our cooperation with Him releasing His power into situations. So many times, the best question we can ask is: "God, what are you doing in this situation?".

Ask Him to allow you to see things from His perspective.

Things that did not formerly upset you may cause you to weep in sorrow. Other things that used to make you mad, now becomes side issues. His ways are so far beyond ours! Pray God's heart into what you are seeing.

Ask the Lord if there are any actions-steps for you to take as a result of what you saw and prayed. Prayer is always the first step, but rarely the last. You may need to write a letter to someone involved in a news story.

You might be called to give money to someone or something. There might be action -steps for your family, especially as it relates to preparation for difficult days ahead. Prayerful- watching can help prepare you to be a more effective servant in the lord's hands.

Of course, consider the news through the lens of the Bible. As you are paying closer attention to the prophetic Word of God, you will often be reminded of a passage of scripture as you are watching or reading the news.

### Apartheid, guns, money: book lifts the lid on Cold War secrets

IT'S not very often that a book really reshapes our perception of an issue, but Hennie van Vuuren's 'Apartheid, Guns and Money: a tale of profit' is one.

It is a massive work: over 600 pages and the result of a decade of meticulous, painstaking work.

From a modest office in a rundown suburb of Cape Town, Van Vuuren has been beavering away to probe into the stories that could never be told during the apartheid years. Formerly director at the Institute for Security Studies, he now runs Open Secrets, which peers into economic and human rights violations. This volume, first published in South African in 2017, is the result.

### How Nigerian women are using WhatsApp to chat, learn and earn

MOBILE phones have become widespread all over the world, including in rural and low-income communities.

As research shows, these devices have the potential to bring about significant societal change - a fact acknowledged in the United Nations' Sustainable Development Goals.

But while the promising role that mobile phones and other information and communication technologies could play in empowering women - particularly in Africa - has long been discussed, relatively little is known about how, when, and why this happens.

We conducted a study with women from the Nigerian city of Kano to see how they were using the mobile messaging service WhatsApp. We wanted to know whether the app had opened up opportunities and freedoms that contributed to empowering them.

Many women said that WhatsApp had allowed them to communicate better, particularly with local politicians. They felt empowered to talk about their concerns openly in WhatsApp discussion groups. And they had more access to information. Others joined religious study groups on WhatsApp, sharing questions and knowledge with other women.

Some women converted their access into opportunity. For instance, they advertised small businesses or services on WhatsApp groups, and earned money as a result.

The women in our study were able to use WhatsApp groups to push the barriers of societal norms that typecast them in gendered roles of mothers and housewives. Using this technology, they were able to become agents of their own change as well as make and exercise choices.

#### WhatsApp and the Women in Kano

Kano is a predominantly Muslim community. It is in Kano state, which has one of Nigeria's highest smartphone densities - about 7.81 million of the country's 60 million smartphone users live there. First, we identified two women leaders in community groups to help us find participants for the study. These were selected based on how actively they were engaged in community groups. They also needed to own a smart mobile phone. We did interviews and focus groups with a diverse group of women, asking how they used WhatApp and what benefits they felt this had. Some had become more politically empowered. Murja'atu\*, a 34-yearold housewife, said: "Initially I always wondered on how to communicate with elected officers, especially those of them located in Abuja."

# CONSTITUTIO MATTERS INDE

WE read with keen interest the article penned by Ambassador Lisa Petersen titled 'Constitution a Matters'.

For years now, we have been decrying the lack of political will on the part of our leaders with regard to women's emancipation in general, and conformity with the constitution in particular.

Not only have we failed as a nation to comply with the provisions of the constitution on the issue of women participation and representation in Parliament, but the august House itself has failed to comply with its constitutional mandate; Section 86 specifically provides that at the first meeting after any general election and if it appears that women do not constitute 30 per cent of Parliament, the House must form an electoral college for the purposes of electing a minimum of four women on a regional basis into the House.

The Elections and Boundaries Commission failed to discharge its duties in terms of S. 95 (3) (a), which states clearly that the chairman of the EBC is responsible for ensuring that the election of the four women is carried out. What a dereliction of duty!!

In the jostling and shenanigans surrounding the appointment of senators by the House, this provision was not complied with. But why should we bother about that? After all, "women failed to vote for each other" and therefore there is no reason why anyone should put in any extra effort to redress



the situation. WRONG!! Women in the country face decades of systematic exclusion that has been built into every institution in the country, in the guise of culture, which relegates women to third class citizens at best.

Appointment

With allegations of corruption rife during the election and appointment stages, it is no wonder that women were left behind.

Access to financial resources seems to have become the critical criteria upon which a person may be elected into office; without finances, many candidates (a majority of which are women) have failed to sway the voters because votes have become a "hot off the shelves, for sale commodity". As correctly articulated by the ambassador, women will continue to be under-represented due to lack of finances for campaigns.

However, not only women are bearing the brunt of lack of political will from our leaders. People from 'marginalised groups' were not appointed into Parliament as per Section 95 (2) (b).

People living with disabilities have no representation and face worse challenges than those faced during the previous Parliament, as they have no voice. Women normally speak on behalf of other marginalised groups, but with such low numbers of representation currently, they have a steep hill to climb with regard to any changes that they may want to bring.

All said and done, as long as the constitution is selectively complied with, women will always remain on the sidelines and this has negative ramifications for the socioeconomic development of the country because it is trite that no country can develop if it leaves its women behind. This under-representation will continue to breed a legislative framework full of discriminatory laws that will further perpetuate the stereotypes and assumptions around women and other marginalised groups.

minute of a meeting between the head of the South African Defence Force, Jannie Geldenhuys, and his senior officials in connection with operation 'Daisy'. This was an attempt to recover \$20 million that Starckmann had allegedly swindled out of the South Africans.

The story is of mind-boggling complexity, but involves Starckmann doing a deal with an East German firm called IMES, run by the East German deputy foreign minister with Stasi employees - members of the East German secret service. The result was an arrangement which involved 60 shipments of weapons to South Africa via a Danish shipping company. The shipments were



to be trailed half way around the world to disguise their final destination.

These shipments were for vital military equipment, including 1 400 anti-tank missiles. The weapons, which had Peruvian end-user cer-

tificates, ended up off the coast of Panama where the ruler, General Noriega, had apparently given the green light for the operation. In the end, the dictator reneged on the deal. When the Pia Vesta arrived in Panama on 14 June 1986, its crew was arrested and the vessel impounded. In 1989, General Noriega was ousted by the Americans. How the ship ended up sunk off Venezuela is a bit of a mystery, but then, as Van Vuuren points out, so is much of this story. He concludes that South Africa state arms dealer, Armscor, was involved:

But for all the smoke and mirrors, one thing is as clear as day. There is more than sufficient evidence that Armscor bought arms from IMES, a Stasi-run East German company operating behind the Iron Curtain. During the Cold War, much was not as it seemed.

Nor was this an isolated incident. Van Vuuren says he has evidence that Armscor had a team of military experts working inside the Soviet Union with an office in Leningrad. The Conversation


This was discussed at the Liberty Life retirement seminar held at Royal Villas yesterday.

SWADE has embarked on a mission to review its financial policies so they conform to current changes in

the country's socio-political landscape.

**SWADE** is the Swaziland Water and Agricultural Making a difference Development

Agency and was established in 1999 to facilitate socio-economic development for communities downstream the Maguga Dam along the Komati River using water from the dam. The parastatal is now seeking for a consultant to help formulate its financial policies which were recently revisited. # AFRICA'S NEW DEBT CRISIS

ACCRA - Ghana is usually seen in a positive light abroad. It's associated with a peaceful change of government, functioning democracy and a government that wants to move away from development aid.

Yet Ghana is still relatively dependent on foreign countries because the seemingly model country is in big trouble.

At the end of 2017, national debt was equivalent to 70 per cent of the West African country's gross domestic product. The International Monetary Fund (IMF) considers 40 per cent feasible for developing countries.

The IMF and the World Bank are particularly concerned that Ghana represents a dangerous trend in Africa. "It's not looking so good at the moment," Jürgen Zattler, Executive Director for Germany at the World Bank, said. "After the debt relief and rather positive economic developments over the last 15 years, debt has been rising again." Last year, Africa's foreign debt reached the highest level since 2001, according to the British lobby group Jubilee Debt Campaign. Eighteen countries are experiencing an acute debt crisis or are on the brink thereof, according to the World Bank.

#### Streets, railways, ports as sources of debt

"I think the fall in commodity prices or the fluctuations in commodity prices in the last two, three years has really affected the revenue inflows of a number of African countries.

This has led to huge budget deficits, so governments have tried to plug the gaps. They've resorted to borrowing, especially from commercial sectors,' said Tirivangani Mutazu, an analyst at the African Forum and Network on Debt and Development (AFRO-DAD).

The other reason is that Africa urgently needs roads, railways or ports. Without infrastructure, there would be no development and not enough jobs for millions of young people.

There is an infrastructure development shortfall of \$93-billion, accord-

ing to the South African Institute of International Affairs (SAIIA). As a result, many governments are going into debt. Kenya, for instance: Last year the new rail link between the port of Mombasa and the capital, Nairobi. became operational. The \$4-billion project, Kenya's biggest since independence, was financed through Chinese credit.

#### Appetite for easy money

Money has been easy to come by for many countries in recent years. Aside from regular donors such as western governments or the IMF, new possibilities have emerged. Times of historically low interest rates in Europe have seen private investors eagerly eyeing fresh opportunities, and discovering African countries in the process. "Some countries saw positive development and could turn to the capital markets. They took out credit, partly with very high interest rates," said Zattler.

China has also played a role: 14 per cent of Africa's overall debt is to Beijing, which has secured influence and access to Africa's natural resources through easy credit. All this makes it harder to counter the current crisis.

"Previously, it was only the so-called Paris Club creditors that gathered at the table," said Zattler. The group negotiated relief for states in debt with added. Deutsche Welle The last of the control of the state of the

"That is no longer the case because neither the private creditors nor the new players such as China or Saudi Arabia are sitting at that table."

#### IMF comeback in Africa

In the current crisis, classic lenders such as the IMF are being asked to help once more. Ghana is among the countries that are receiving financial support from the fund. When Africa's debt peaked in the 1990s, the IMF and World Bank imposed structural reform programmes. State-run companies were swiftly privatised and public spending reined in. Because social programmes, in the training or health sectors, were also subject to cost cutting, it was the poor who were most affected.

The IMF stresses it wants to take a different approach this time around. Experts such as Tirivangani Mutazu are nevertheless concerned.

"There are a number of countries already that are going to the IMF for bailouts so to speak.

The IMF will of course demand they implement austerity measures," Mutazu said. "Quite a number of those measures we saw in the 1980s are still the same and once these countries go to the IMF, they don't seem to escape some of those conditionalities," he

# 11 DIE IN VIOLENT STORMS

MILAN - Heavy rains and high winds buffeting much of Italy have killed 11 people over two days, officials said on Tuesday.

Many of the deaths were due to falling trees crashing down on cars or passers-by, but they also included a woman who was buried by mud when a landslide invaded her home near Trento in northern Italy, and a man who was slammed against rocks while windsurfing in Emilia-Romagna.

The other fatalities occurred in Naples, Liguria, Lazio and Veneto, where authorities found a 61-year-old man whose body had been swept more than a kilometre (half a mile) from his running car.

High winds created an exceptional tide in Venice on Monday, covering three-quarters of the city for the first time in a decade. Water levels were forecast Tuesday at 105 centimetre (41.3 inches), flooding 8 per cent of the famed lagoon city.

"It was the perfect storm during which adverse meteorological conditions contributed to the situation

in the sea and winds," civil protection chief Angelo Borrelli said.

News agency ANSA reported damage to the mosaic floors inside Venice's famed St. Mark's Basilica, where waters reached 90 centimetres (35 inches). The bronze metal doors and columns also sustained damage. The wooden floors in the nearly 300-year-old Florian cafe nearby were also seriously dam"Venice is an amphibious civilisation, we need to get used to this," Art Director Stefano Stipitivich said, while laying out his hope to reopen as quickly as possible.

# India inaugurates world's tallest statue to honour independence hero

KEVADIA - India yesterday inaugurated the world's tallest statue, a \$400-million effigy of independence hero Vallabhbhai Patel that towers nearly twice the height of New York's Statue of Liberty.

The 182-metre (597-ft) steel and bronze 'Statue of Unity', in the prime minister's western home state of Gujarat, is part of his Hindu nationalist party's efforts to re-brand what it calls "forgotten" leaders. "Patel wanted India to be a forceful, strong, sensitive, vigilant and accommodative nation, and we're working towards that," Prime Minister Narendra Modi said at yesterday's ceremo-

Modi, who ordered the statue built on the Narmada River when he was Gujarat chief minister, said last year there had been efforts to "belittle" or "remove from history" the contributions of Patel, who helped unite India's 562 princely states as the first home, or interior, minister. Funds for the statue came from the federal government, state-run companies and other institutions, and it was built in 33 months by construction and engineering company Larsen & Toubro Ltd.

Depicting the bald Patel in traditional attire, with a shawl over the shoulders, the statue used 210 000 cubic metres of cement, 25 000 tonnes of steel and 1 700 tonnes of bronze.

Some of the leaders Modi has branded as "forgotten" came from the opposition Congress party, and fought for independence from colonial ruler Britain in 1947.

# Crashed Lion Air jet's previous flight left passengers terrified

JAKARTA - Relatives numbed by grief provided samples for DNA tests to help identify victims of the Lion Air plane crash that killed 189 people in Indonesia, as accounts emerged on Tuesday of problems on the jet's previous flight, including rapid descents that terrified passengers.

Hundreds of rescue personnel searched seas where the plane crashed, sending more than three dozen body bags to identification experts, while the airline flew dozens of grieving relatives to the country's capital, Jakarta. The two-month-old Boeing 737 MAX 8 jet plunged into the Java Sea early on Monday, just 13 minutes after taking off from Jakarta for an island off Sumatra. Its pilot requested clearance to return to the airport two to three minutes after takeoff, indicating a problem, though the cause is still uncertain. Aircraft debris and personal belongings, including ID cards, clothing and bags found scattered in the sea, were spread out on tarps at a port in north Jakarta and sorted into evidence bags. The chief of the police's medical unit, Arthur Tampi, said it has received dozens of body parts for identification and is awaiting results of DNA tests, expected to take four to eight days.

The disaster has reignited concerns about safety in Indonesia's fast-growing aviation industry, which was recently removed from European Union and US blacklists. Two passengers on the plane's previous flight from Bali to Jakarta on Sunday described issues that caused annoyance and alarm. AP


# Kanye West quits politics, attacks Donald Trump over immigration

#### Typhoon leaves 6 dead



# Mihalik's wounded son out of danger

CAPE TOWN - The young son of murdered lawyer Pete Mihalik is out of danger after he was wounded in an apparent hit on his father during the school run in Cape Town on Tuesday.

"They are all fine," Mihalik's colleague, Bruce Hendricks, said yestersday.

He said that was all he was prepared to disclose about the grieving family, which has suffered severe losses over the years.

Mihalik was shot dead outside Reddam House Atlantic Seaboard school in Green Point as he drove up to the school on Tuesday morning.

His daughter was not injured, but his young son was taken to a hospital for initial treatment before he was transferred to a different medical facility.

It is understood that the bullet became lodged in his jaw, according to Netwerk24.

#### Detained

Police are questioning two people in connection with the shooting after their anti-gang unit detained one person hours after the attack and a second person later.

"Two men have been taken in for questioning," said police spokesperson Sergeant Noloyiso Rwexana. Their questioning had not been escalated to arrest at the time of writing but Netwerk24 also reported that a Khayelitsha resident, who is one of those in custody, may be a senior figure in the taxi industry running a route between Delft on the Cape Flats to Cape Town.

Shocked Cape Bar Association Chairperson Advocate Ismail Jamie SC said after the shooting that no specific threats had been reported and that lawyers accepted that sometimes they would be unpopular and take the necessary precautions. News24

# WELL MKHIZE SLAMS DEFAMATORY CLAIMS

JOHANNESBURG - Former ANC Treasurer General Zweli Mkhize has denied reports that he solicited R2 million in funding for the ANC from VBS Mutual Bank.

Mkhize has labelled the reports as "defamatory and a fabrication devoid of any truth and as such should not be believed".

His denials follow a Sunday Times story which reported on text messages exchanged between former VBS executives who claimed they had paid R2 million to Mkhize while he was the treasurer general of the ANC back 2016.

The funds were allegedly used to pay a service provider during the party's elections drive in 2016. The VBS executives had paid the money while under the impression that Mkhize would assist the bank in attaining funding from municipalities.

Mkhize, who is now the minister of cooperative governance and traditional affairs, has poured cold water on these claims and said he knows nothing about text messages.

"I wish to emphasise

once again that I, in my capacity as the treasurer general of the ANC, I have never assisted VBS in securing any funding from municipalities or any other state institution," said Mkhize in a statement issued yesterday.

"I have no direct knowledge or personal recollection of the R2million donation by VBS during my tenure as TG as reported. It needs to be made explicitly clear that the SMS messages exchanged by VBS directors as reported in the media article were not a conversation with me," he said.

He said he had met with VBS directors before, but that he had not promised to help them in their quest to draw funds from municipalities. "I have confirmed :

before that I met with VBS management

and directors. This was a formally-arranged meeting with the TG's office. This meeting was meant to introduce the bank to the organisation and to make one understand its business model. This was nothing uncommon as I constantly met and interacted with representatives of various institutions, including other financial institutions.

#### Expectation

"It is also important to clarify that there was never, at any time, any expectation created by me that I would assist them in securing state funding including that of municipalities. Not only is this

> suggestion untrue and laughable, but it's also a clear illustration of the arrogance, bad faith and destructive intentions that the implicated VBS representatives had about the bank." said Mkhize. IOL

# 'BLADE NZIMANDE IS THE MOST CORRUPT OF ALL'

JOHANNESBURG - Some department of transport employees have written to President Cyril Ramaphosa asking for an investigation into their boss, Minister Blade Nzimande.

In a letter, the group alleged that Nzimande was "the most corrupt of all", and accused him of illegally hiring "his people" at the transport ministry.

Nzimande, through his spokes-man Ishmael Mnisi, dismissed the letter as "yet another attempt by his detractors" to "defocus" him.

The letter addressed to Ramaphosa was copied to Public Service and Administration Minister Ayanda Dlodlo and Police Minister Bheki Cele.

#### Tore

It tore into Nzimande, accusing him of hiring staff from his previous deployment as minister of higher education and training. It claimed that Nzimande had appointed several of those people in his office on a permanent basis, in contravention of the Ministerial Handbook and public service regulations.

It claimed that officials he had appointed were unskilled, clueless and not qualified for the task - particularly to be employed on a permanent basis.

"This guy (Nzimande) is the most corrupt of all. He came with all his ministry staff from his previous deployment as minister of higher education. All the staff have now been appointed on a permanent basis. This is against the Ministerial Handbook and public service regulations," read part of the letter.

"Please assist us in your various capacities and functions to either investigate, prosecute or dismiss all the characters involved in this situation."

Mnisi said Nzimande was not going to entertain the group and dismissed their allegations "with the contempt it deserves".

"I say, if you want to serve the people of South Africa, in any form, you must be above reproach. But there are



### Nigerian troops shoot, kill 27

NIGERIA - Nigeria's main Shiite Muslim movement says Nigerian troops shot and killed at least 27 of its members during a procession to the capital of Abuja. Islamic Movement of Nigeria spokesperson Ibrahim Musa said six people were killed on Saturday and another 21 on Monday. Nigeria's military said it killed six people and that the Shiite protesters fired first at soldiers. Musa said on Tuesday that many members were taking part in a religious procession, which coincided with a protest calling for the release of their movement's pro-Iran leader, Ibrahim Zakzaky.

### Baptist missionary killed

YAOUNDÉ - A Christian missionary from Indiana was killed in Cameroon on Tuesday when he was shot while travelling in a region where the military and separatists have been fighting, a family member said. The US State Department confirmed on Tuesday that an American citizen had been killed in Cameroon and said it was offering all appropriate consular assistance to the family, but provided no further details about the person. Charles Wesco, a 44year-old Baptist missionary, had been in Cameroon for less than two weeks when he was killed, his sister-in-law, Joy Williams, said.

#### Rebel leader arrives in capital

JUBA - South Sudan rebel leader Riek Machar returned to the capital Juba yestersday, according to a Reuters witness, more than two years after he fled the country after the collapse of a 2016 peace deal. Machar, the former vice president, fled to neighbouring Democratic Republic of

Congo in 2016 after fierce fighting broke out in Juba, killing hundreds of people. He later travelled to South Africa, where he was held under



house arrest until earlier this year. Last month, he and President Salva Kiir signed a new peace deal in the latest attempt to end the five-year

#### **Book arrested economist freed**

CAIRO - Egyptian economist Abdel Khalek Farouk said he has been released from jail after being arrested over his new book, which takes a critical look at the country's finances. "I got out last night," he told AFP, cautioning that the public prosecutor had yet to decide whether to dismiss the case or to put him before a judge. Farouk, a well-known economist, was arrested on October 21 and accused of spreading "false information". His detention followed the publication of his book 'Is Egypt Really a Poor Country?', which argues the state suffers from bad management of public funds rather than a lack of resources.

#### Focus off Asia to Africa

BERLIN - Chancellor Angela Merkel urged companies to take a closer look at Africa's "huge" economic opportunities, as Germany hopes that development of the continent will help curb illegal migration to Europe. "For many years, we have been very focused on Asia. I think that in future we should turn our sights more on Africa," Merkel said at an investment forum in Berlin, stressing Africa's "huge potential for growth". The gathering, attended by leaders from around a dozen African countries, is part of Merkel's so-called 'Compact with Africa' initiative launched last year during Germany's stint as G20 president.



# DR CONGO 'NOT READY' FOR DECEMBER POLLS

KINSHASA - The Democratic Republic of Congo is 'not ready' to hold long-delayed elections in December, the main opposition party said the day after the army handed over 150 trucks and a dozen aircraft for use by the electoral commission.

"One hundred fifty trucks can't cover our vast national territory which doesn't even have the road infrastructure," said Augustin Kabuya, spokesman of the main opposition Union for Democracy and Social Progress (UDPS).

An opinion poll released on Tuesday showed that, regardless of any logistical problems, two opposition candidates are leading voting intentions in the lead-up to the presidential election.

UDPS leader Felix Tshisekedi led the poll with 36 per cent support,

followed by Vital Kamerhe, Head of the Union for the Congolese Nation who came third in the 2011 election, with 17 per cent.

Emmanuel Ramazani Shadary, the hardline former interior minister backed by President Joseph Kabila, was in third place on 16 per

Kabila himself has bowed to international pressure to step aside after nearly two decades in power.

According to the same poll, carried out by the BERCI consulting group and the Congo Research Group at New York University, two-thirds of voters backed the call for the elections to be delayed. Credibility

UDPS spokesman Kabuya said the handover of the trucks, planes and helicopters, conducted with great fanfare on Monday, was "staged" to lend international credibility to the elections.

"We know (however) that ... Corneille Nangaa is not ready to organise the elections on December 23," Kabuya told AFP, referring to the head of the Independent National Electoral Commission (CENI).

### Farmer to sue Nambian government

...for leasing four farms to Russian billionaire

WINDHOEK - A Namibian farmer, who claims he has been applying for resettlement in the southern African country for 15 years without success, has reportedly threatened to sue the government for leasing four farms to a Russian billionaire.

Reports last week indicated that the Namibian government recently agreed to lease four farms valued at N\$43 million and measuring a combined 17 000 hectares to a Russian billionaire, Rashid Sardarov, for 99 years.

According to The Namibian, the aggrieved farmer, Asser Katjinaani, who owned at least 300 livestock, said the government's deal with the Russian billionaire was "in violation of various provisions of several laws of Namibia".

"Our further instructions are to make an application to the High Court of Namibia to set aside the lease agreement as violating various provisions of several laws of Namibia," Katjinaani's lawyer, Norman Tjombe was quoted as saying.

The four farms were paid for by the Russian and registered as state property by the land reform ministry.

Sardarov's company Comsar Properties SA will be paying rent annually to the government, which would be equivalent to the land tax paid by commercial farmers, the report said.

## Rwanda's new 'win for women' Cabinet

KIGALI - Africans are celebrating the gender-balance of Rwanda's Cabinet following a recent reshuf-

Half of Rwandan President Paul Kagame's new 26 member Cabinet are women. According to a Rwandan government website, Kagame said that including women in decisionmaking positions would help address the socio-economic challenges facing the central African nation.

According to the Gender Monitoring Office, the president added: "This does not mean that men should feel that this does not concern them because this works better if both men and women work together."

Besides the fact that the Rwandan

Cabinet has achieved a 50-50 split between male and female representatives, here's why the Cabinet changes are such a huge deal:

#### **RWANDA JOINS ETHIOPIA** AS AFRICA'S LEADERS IN GENDER-PARITY

Earlier this month, Ethiopian Prime Minister Abiy Ahmed trimmed his Cabinet down from 28 ministers to 20, 10 of whom are women.

#### THE COUNTRY TAPS INTO THE FOUNTAIN OF YOUTH

According to Rwandan newspaper, The New Times, the average age of ministers in the new Cabinet is 47.5 years, with the youngest being 31-year-old Jean de Dieu Uwihanganye. Only one minister is over the age of 60 and five are older than 55.

### News24 'EU TO RENEW SANCTIONS ON CONGOLESE OFFICIALS'

**BRUSSELS-The European Union** is set to renew sanctions in December on senior officials in Democratic Republic of Congo, including presidential candidate Emmanuel Ramazani Shadary, four Western diplomats told Reuters.

The EU imposed sanctions last year on Shadary, who served as interior minister, and 15 other Congolese after a crackdown on protesters who opposed a delay in holding elections. The delay has let President Joseph Kabila stay in office two years past his legal mandate, although an election is now set for December 23.

Congo's government has said the sanctions, which include travel bans and asset freezes, are illegal, and renewing them is pointless because Kabila plans to step down after the election.

Renewal requires a unanimous vote from the EU's 28 member states, with a decision expected just 11 days before the election in Congo. Two diplomats said the EU had agreed

on renewal despite initial opposition from Spain, which proposed to take Shadary off the list.

A Spanish-led consortium two weeks ago signed a joint deal with Congo to develop a US\$14 billion hydroelectric project. Two diplomats said the project influenced Spain's position. A Spanish spokesperson was not immediately available to comment.

As interior minister, Shadary oversaw the police during the crackdown, in which demonstrators protesting against Kabila's extended rule were killed. He is now running for president and has been hand-picked by

He faces some popular opposition candidates hoping to take advantage of Kabila's decision to step aside after 18 years in power.

Felix Tshisekedi, who leads Congo's largest opposition party, would receive 36 per cent of the vote ahead of 16 per cent for Shadary, according to a poll released on Tuesday by the Congo Research Group at New York University and Congolese polling firm BERCI.

However, the poll showed that 64 per cent of people do not trust the electoral commission to conduct a free and fair election.

Major would-be contenders, including former vice president and militia leader Jean-Pierre Bemba and millionaire businessman Moise Katumbi, have been barred from running. Katumbi faces criminal convictions for real estate fraud and Bemba a conviction for witness tampering.





# MAN UNITED IGNORED BY RIVALS CITY OVER PLEA FOR EXTRA DERBY TICKETS

MANCHESTER - Manchester United's plea for extra tickets for the derby game has been largely ignored by hosts City.

United complained about a reduced allocation for last season's fixture but have been given only 70 more for the game at the Etihad on November 11.

United were hoping that last year's allocation of 2 792 would be upped to the 3 000 given to other Premier League visitors. However, in a move which may stoke cross-city fires, the Old Trafford club have been given 2 862 tickets, an increase of only 70. United declined to comment and are not expected to write another letter of complaint to their rivals, as they did last season. However, privately there is some disappointment at the club, especially after similar talks with Liverpool in recent seasons have led to improved behaviour and increased allocations for clashes at Anfield. A source close to the issue said: "The extra 70 is seen as a bit of a mickey-take, and it hasn't gone down well. United aren't

happy with it, but they don't want to get involved in a slanging match.' Sources at City say that the decision is based on the police's categorisation of the match, which deems it an 'increased risk' fixture, and that the allocation reflects safety concerns for all involved. Ahead of last April's derby, which United won 3-2 to delay City's title celebrations temporarily, rival fans clashed on the outskirts of Manchester city centre, hurling road signs at each other and using planks of wood as weapons. *Daily Mail*

# PSL LEGAL HEAD DENIES PERCEIVED CHIEFS BIAS

JOHANNESBURG - Premier Soccer League (PSL) legal head Michael Murphy has said the decision for Kaizer Chiefs to not play their Telkom Knockout match against SuperSport United in Durban on Saturday behind closed doors is completely in line with a sentence Amakhosi received.

Chiefs have decided to play their TKO quarterfinal against SuperSport at Moses Mabhida Stadium.

This has sparked questions and speculation over bending the rules and favouritism for Amakhosi, because the club have a PSL disciplinary committee (DC) sentence saying they have to play two games in KwaZulu-Natal behind closed

This relates to the violent pitch invasion by Amakhosi supporters following their team's 2-0 Nedbank Cup semifinal defeat against Free State Stars at Moses Mabhida last season in April. Chiefs have already played one ABSA Premiership game in front of an empty Moses Mabhida Stadium, losing 1-0 against Polokwane City on October 6. They have a second league

game scheduled to be played behind closed doors there on

November 10 against Chippa United.

Chiefs moved their TKO game against SuperSport to Durban, prompting a storm of questions from the public and media as to why it should not be played behind closed doors instead of the Chippa league game.

Murphy fiercely denied accusations of the PSL bending the rules for Chiefs, and said the league was acting on the letter of the law of Amakhosi's sentencing. The DC ruling states: "Chiefs shall play (three) League matches without spectators."

One of those three matches was suspended in the DC ruling. Murphy said any public or media perception of favouritism was incorrect. "Despite what people like to portray, we've got these independent tribunals," he said.

"No-one ever says, 'Hey look, in the Tendai Ndoro matter [the eligibility case involving Ajax Cape Town last season] the tribunal [the dispute resolution chamber] crucified the league and it shows how independent that is. JOHANNESBURG - Orlando Pirates assistant coach Rhulani Mokwena believes their Brazilian defender Marcelo has "a hell of a lot more potential" than Mamelodi Sundowns' Ricardo Nascimento.

[Marcelo] is slightly younger, with a little bit more potential to be a hell of a lot better, and possibly even be exported to Europe, because of the Brazilian tag attached to him. # SAFA head of referees praises Soweto derby officials

JOHANNESBURG - The South African Football Association's (SAFA) head of referees Tenda Masikhwa has praised the standard of officiating in Saturday's Soweto derby between Orlando Pirates and Kaizer Chiefs.

# NEYMAR RISKS PRISON OVER BARCA MOVE - SPANISH MAGISTRATE

PARIS - A Spanish magistrate leading an investigation into alleged irregularities in Neymar's move to Barcelona in 2013 said yesterday the Brazilian superstar could face up to six years in prison.

"The term imposed, in principle, could be between four and six years," said a decree issued by judge Jose Maria Vazquez Honrubia, a copy of which was seen by AFP.

Neymar, his parents, Barcelona President Josep Maria Bartomeu and his predecessor Sandro Rosell are all awaiting trial over alleged corruption concerning Neymar's move to the Spanish La Liga giants in 2013.

The Brazilian international forward is now with Paris Saint-Germain in France's Ligue 1. The case, which follows a complaint by DIS, a Brazilian group which part-owned the rights to Neymar, surrounds allegations of "corruption" and "fraud" in the player's move to Barcelona.

Neymar moved to the Spanish La Liga giants in May 2013 for a reported fee of 57.1m euros. Although no financial details of the deal were revealed by either Barcelona or his Brazilian club FC Santos, Neymar's parents were said to have received 40m euros and FC Santos 17.1m. In January 2014, prosecutors in Madrid began investigating the transfer because documents request-

ed by the authorities contained contradictory information.

Rosell resigned from his post as president a week later and Barcelona subsequently revealed they had actually paid 86.2m euros for the Brazilian star.

DIS, who received 6m euros of the 17.1m given to FC Santos, alleges that Barcelona and the Brazilian club colluded to mask the true cost of the deal.

Bartomeu, Rosell, Barcelona, FC Santos and its former president, Odilio Rodrigues Filho, are now expected to answer charges of fraud, according to the decree. Because the prison term involved exceeds five years, three judges are set to preside over Neymar's trial which is expected to be heard at the Audiencia Nacional, a High Court with jurisdiction over Spanish territory as well as over international crimes which come under the jurisdiction of Spanish courts. Whether Neymar faces a prison term remains to be seen, however. In May 2017 the Spanish authorities said Neymar should stand trial but no date has yet been set.

### FIFA boss says 48 teams 'feasible' for Qatar World Cup

ZURICH - FIFA President Gianni Infantino said yesterday that expanding the 2022 World Cup to 48 teams was "feasible", as hosts Qatar pledged to come to a decision in the early part of next year.

Infantino said "Why not?" bring forward the expansion from 32 teams to 48, which is currently due at the 2026 tournament in the United States, Canada and Mexico.

"We have decided... to increase the number of teams participating in the World Cup final tournaments from 32 to 48," Infantino told the Asian Football Confederation's annual congress in Kuala Lumpur.

"It will happen in 2026. Will it happen in 2022? You know me. It is possible. It is possible. Why not?" he added.

Infantino said an expanded tournament would see Asia's allocation rise from 4.5 places to 8.5, raising cheers from the delegates assembled at a luxury hotel in the Malaysian capital.

"You will have (a bigger) chance.

It is possible. It is feasible. We are discussing with our Qatari friends. We are discussing with many other friends in the region. We hope we have it happen. We always have to try," he said.

Egypt, who have cut off diplomatic relations and imposed a blockade on the resource-rich country, accus-

ing it of endorsing terror activities.

Hassan al-Thawadi, head of the 2022 organising body, told AFP that Qatar was studying the 48 teams proposal and would make a decision before qualifying gets under way.

"We are still looking at the feasibility studies and we will be in a better position to provide feedback in the future," he said.

> "But it will be decided before the qualifications... sometime in the first quarter of next year."

He added that preparations remained on track despite the blockade, and that the budget of \$200 billion for the entire infrastructure, including metro and expressway, has not been affected.

"We are very happy and excited with the progress. It is on track. By 20202021 all our (eight) stadiums will be ready," Al-Thawadi said.

"This is the first World Cup in the Middle East and is a perfect opportunity to bring people together and contribute to the process of healing," he added.

Ahead of FIFA's presidential 'election next year, Infantino said 180 out of the 211 federations had given him their support.

"You know there is an election coming. I have announced I will be a (presidential) candidate. I have received over 180 letters of support," he said.

"And when it comes to Asia, only a couple are missing."

"I actually do [dream of winning it]," Griezmann told ESPN FC. "I'm not afraid of saying it. I dream of the Ballon d'Or, of the Champions League, of winning the World Cup. I dream of a lot of things.



# HORROR AS YOUNGSTER TRUCK BY CRICKET

SRI LANKA - The risks adherent in modern cricket were demonstrated in disturbing fashion yesterday when Sri Lankan fielder Pathum Nissanka was taken to hospital after suffering a sickening blow to the head.

The incident came just before tea on the second day of England's low-key warm-up ahead of next week's first Test at the sleepy Nondescripts Cricket Club as Joe Root and Jos Buttler gained valuable batting

practice. It was then that the peace was shattered when Buttler, one of the hardest hitters in the game, pulled a long hop from off-spinner Nishan Peiris fiercely into the top of the helmet of Nissanka taking evasive action at short

Nissanka, a Sri Lankan Under 19 international batsman, collapsed to the floor as anxious players from both sides quickly realised the seriousness of the situation and urgently called for medical help. Three members of the England staff - doctor Moiz Moghal, physio Craig de Weymarn and massage therapist Mark Saxby - quickly rushed onto the outfield to assist the local doctor assigned to the Sri Lankan Board XI. The sight of the England staff carrying oxygen packs onto the field was both a concern and a sobering reminder in the wake of the Phil Hughes tragedy of how dangerous cricket can be in the brutal power-hitting era. 
# Ramos 'likes' Instagram post criticising teammates




SOCCER - THE recently hiked tariffs of Pigg's Peak Black Swallows home ground, Killarney Stadium has forced the club to reach a decision to charge E20 for all their games.

It has become the norm in recent seasons that MTN First Division games are E10. Killarney Stadium, a property of the Pigg's Peak Town Council recently hiked fees by over three fold, a decision that has hit hard on the First Division returnees. In a statement, Black Swallows Chairman Charles Matsebula said they had to hike entry fees to cover costs. The MTN First Division rules and regulations allow teams to charge between E10 and E30 while it can go up to E50 for Premier League. "From this coming weekend onwards, we are now charging E20 to watch our home games. We acknowledge that it is a first of its kind as it has been a norm that First Division teams charge E10. This change has been caused by the over 300 per cent increase of the Killarney Stadium rent," Matsebula said. To use the Killarney facility cost E300 before but it is now E1 100.

Matsebulå highlighted that as a team they had pleaded with the council to reduce the fees on the grounds that trey were a community team and did not have much resources but no common ground was reached. He added that in future, he for saw a challenge where the Malandalahle-based outfit would be forced to host their games away from Pigg's Peak. We are seriously considering drouping the Killamey Stadium for another venue and we are yet to meet as a team and discuss the matter further. In the mean time we will be monitoring the situation and see if the E20 entrance fee does make a difference." Matsebula encouraged the club supporters to come in their numbers wherever the team is playing and also by available merchandise at games.
