

KING CHALLENGES MTN TO INTRODUCE 5G TECHNOLOGY

is Majesty King Mswati III has challenged Swazi MTN to fast track the introduction of the 5th Generation (5G)Technology to improve communication facilities in order to match first world countries come

The King made these remarksduring the Swazi MTN 20 Years' Celebration held Mahlalekhukhwini House at Ezulwini on Friday night. His Majesty spoke at length about the importance of fast and advanced technologies in a country like Eswatini. "We would like to encourage Eswatini MTN to fast-track rapid development of the network infrastructure.

You should consider working towards introducing the latest mobile telecommunication system such as the 5G, 6G and 7G technology in the country in order to improve our communication facilities," he said, to a massive round of applause from the gathering.

The King said enhancing communication platforms was necessary to keep the country at par with the rest of the world.

"It is pleasing to note that the company has invested to date E1.5 billion in infrastructure. We are told that network coverage statistics are as follow: 2G network stands at 98 per cent. 3G at 98 per cent while 4G network coverage stands at 19 per cent," he said.

The 5G mobile cellular communications system provides a far higher level of performance than the previous generations of mobile communications systems.

The new 5G technology is not just the next version of mobile communications, evolving from 1G to 4G, but instead, it is very different.

The United States of America, South Korea, Sweden, Turkey, Japan and China are among the leaders in countries that are using the 5G mobile communication system.

The King said such technologies were going to usher in other technological advancements and innovations in the education and health

SECURITY FIRM IN E1.3M SWADE TENDER MESS

itadel Investments, trading as Awesome Security Services, stands to lose E1.3 million tendersafter allegedly presenting a fraudulent labour compliance certificate. Awesome Security Services is the same company that had been providing its services to Eswatini Posts and Telecommunications (EPTC) last year, where they had an impasse over payments which resulted in the company failing to pay its employees on

The company had recently been listed for an intention to award contract tender worth E1.3 million for provision of security services at SWADE's Lower Usuthu Smallholder Irrigation Project (LUSIP 1). SWADE is the Swaziland Water and Agricultural Development Enterprise.

The ministry of labour and social security has since disowned the labour compliance certificate dubbed Citadel Investments, trading as Awesome Security Services, as the company is accused of forging it to obtain the ten...Awesome Security Company loses tender for allegedly forging compliance certificate



der at the parastatal.

Commissioner of Labour Sipho Tsabedze said the document that was shown to this publication did not exist

in the ministry's system.

"This is a forged document, Awesome does not have a labour compliance certificate as there is none like this in our files and system.

They have already lost the tender," he said, after scrutinising the document, satisfying himself and thoroughly searching from both his files and computer.

The commissioner then took out the original document with the purported certificate identity number, which belonged to another company and was issued on a different date.

The document that was shown to this publication by the company was registered on December 21, 2017and valid until December 20, 2018 and had its certificate identity 643/17 which was granted to CITADEL INVEST-MENT (PTY) LTD T/A AWESOME SECURITY SERVICES.

The commissioner said this would have meant that the company would have required two certificates, one for the mother company and another for the security company which would be a subsidiary of the former.

He said the above had been forged as their inspectors only inspected the parent company which had fewer

had been added in the document. The commissioner of labour then searched for Citadel Investment's compliance certificate which was found in the system registered as CITADEL INVESTMENTS (PTY) LTD with the certificate no: 415/18, the document was issued on May this year and is valid until May 30, 2019. He clarified that this certificate

should not be mistaken as that of the

subsidiary company (Awesome Security

Services) as it is only for the parent

company.

He then advised employers to crosscheck documents with the relevant offices within government which are tasked with issuing them to ensure that only companies with valid documents are granted tenders.

"This crime is now common as almost every document is now being forged, such as licences, these labour compliance certificates and tax clearances. There are so many cases like this one which have been reported to the police. One would request the nation to assist us by verifying all documents to ascertain if they are authentic or not," he

Awesome Security manager, who refused to be quoted, said they were not aware that the copy that was presented to this publication was forged even though he did not show the Sunday team the authentic document for CITADEL INVESTMENTS (PTY)

Nine other security companies disqualified

Awesome Security Services, had beaten nine other companies to win the E1.3million tender for provision of security services at SWADE's Lower Usuthu Smallholder Irrigation Project (LUSIP 1).

These other companies had submitted bids for this tender but were unfortunately disqualified for reasons which were not clearly stated by SWADE Chief Executive Officer Samson Sithole in documents published in the Swaziland

itadel Investments, trading as Public Procurement Regulatory Agency (SPPRA).

> The companies which had registered an interest for this tender include:

Black Mamba Security Services, Nkulu Investments trading as Top Two, Maximum Security Services, Bhandile Investments, Mzalsi Investments, Reaction Force Security, Mphohlo Investment and Guns and Batons Cuffs Security Services. All these companies which participated in the bidding process are locally based.

Fears as six Biggest Braai cattle delivered at volunteer's home

oncerned citizens have questioned the safety of the Philani Maswati Charity Organisation's assets after it'transpired that six cattle donated for the recent Biggest Braai were delivered at a volunteer's home.

Apart from the cattle, the volunteer is said to have also offered to safeguard one of the mobile kitchen trailers donated by Swaziland National Provident Fund (SNPF) last year, as well as used wheel-chairs that are yet to be refurbished and donated to the needy.

Sources close to the matter confided to this publication that six cattle donated by the chiefdoms in support of the recent Philani Maswati Biggest Braai event hosted on July 22 were delivered at their neighbour's homestead.

"In September 2017, SNPF donated a mobile kitchen worth E200 000 that will be used by Philani Maswati Charity Organisation whenever they have an event for the elderly people but it (mobile ...Mobile kitchen worth E200 000, wheel-chairs also kept at the same home

kitchen) is parked under a tree at the homestead in Mzimpofu," said a source who elected to remain anonymous.

When the Sunday Observer team visited the said homestead, the mobile kitchen was found as well as the wheelchairs kept in a shed.

The volunteer, when called, referred questions to the chairman of the organisation, stating that he was not allowed to address the media.

Information gathered suggests that that the volunteer offered to keep the organisation's assets because of space and safety in his homestead as it is secured and not easily accessible.

Furthermore, it was gathered that his location being central made it efficient for the organisation to access the assets whenever they are needed, either for

use or donation. "The cattle were kept at the volunteer's home because that place is central and most of the buyers are near that place. The trailer and the wheel-chairs are also kept there for safe-

The organisation is the owner of the assets, thereby reserved a right of storing them and does not owe anyone an explanation on where the assets are kept. Do you know where we keep the other assets, no," said the source.

Another source said the cattle were temporarily kept at the homestead as they would soon be taken to a farm in Malkerns where other donated cattle . are kept.

Philani Maswati Charity Organisation Chairman Lutfo Dlamini, responding to a questionnaire sent by this publication, said he was aware that the assets and the donations were kept at Mzimpofu as the volunteer and himself were tasked with being care-takers of the all donations. He said as a result, they kept some of the assets at their homes and places they deemed safe.

Dlamini was speaking through Mfundo Xaba, who he had tasked to respond to the questionnaire. Xaba is also a volunteer in the organisation. He clarified that the cattle were taken to the farm because it was chosen as a selection point.

"Thirty chiefdoms donated cows, although some paid them as cash. Not all the cattle were slaughtered as after scrutiny, some were left and transported to Malkerns. Only four were slaughtered while the rest are at the farm.

Even those that had been kept at the volunteer's home have since been taken there as we speak," he added.

"We can account for all the donations made to the organisation but for now we are preparing a report that is where further details will be availed and if there are objections and comments let them be brought forward once the report is out," said Xaba.





DRUNK VOTERS AT NOMINATION CENTRES

... Concerned citizens call for breathalysers at polling stations

Some voters feel there is need to introduce breathalysers at polling stations after a number of voters were suspected to have turned up intoxicated at nomination centres last weekend.

This comes as the law clearly prohibits registration to vote and voting of people who are certified to be insane or otherwise adjudged to be of unsound mind.

The voters feel the breathalysers would help to ascertain the state of sobriety of the voters so that those who are highly intoxicated are declared unsound, especially during the nomination and voting process.

This view was voiced by concerned voters as elections officers had a torrid time controlling the situation where intoxicated voters needed to be reprimanded for interrupting the nomination process. Concerned citizens from different constituencies voiced out their concern on drunk voters as they argued the phrase 'unsound mind' in the Constitution could also be referring to people who are intoxicated and won-

dered why the voters' state of sobriety was not tested.

They argued that since drunk people were not allowed to drive or appear before a court of law because their judgement, decisions and whatever they would say would not hold water; by the same token, drunk voters should not be con-

sidered. Under the law, a person with an unsound mind is considered incompetent to go to trial.

According to lawteacher.net, excessive drinking or smoking of dagga or other drug can cause insanity and such insanity will also amount to unsoundness of mind, if it makes a person inca-

pable of understanding what he is doing or that he is doing is something wrong or illegal. Human rights lawyer Thulani Maseko, when sought for comment, said this kind of unsoundness of the mind is temporal and the fact that one was capable to leave his own residence and bring the documents needed to vote to the polling station indicated some degree of sanity on the person, thus in his view, such a person should be allowed to vote.

EBC, on the other hand, said the current laws were not specific on drunk voters and thus there was no need to have breathalysers at polling stations. However, that said, the commission encourages people to go to the polling stations in their sober minds.

EBC Communications Officer, Mbonisi Bhembe, condemned an unbecoming behaviour from people who participate in elections due to group behaviour. The commission stressed that nominations are a very important exercise in shaping the future of the country, thus they should be respected.

"We request that when people go to such an important exercise, they must

SECTION 87 OF THE CONSTITUTION STATES THAT A PERSON MAY BE DISQUALIFIED IF:

(a) is certified to be insane or otherwise adjudged to be of unsound mind under any law for the time being in force in Eswatini;

(b) is, for an act which is a criminal offence under the law of Eswatini, under sentence of death or life imprisonment imposed on that person by a court in any country; or

(c) is disqualified for registration as a voter under any law for the time being in force in Eswatini relating to offences connected with elections.

be in their sober senses. We can't enforce banning of people who are drunk without proper legislation.

Another factor is how the international community will react as we would need to know if such has been practiced anywhere," he said.

He said until there is a law that prohibits those who would be seen to be drunk and specifying the limit and gadgets to test them, the commission will always welcome everybody.

"Unless he/she disturbs the meeting, that is where the problem arises then the discretion lies with the presiding or the returning officer. Upon realising that this particular individual is now disrupting the meeting, the officials can simply arrest that person without any warrant for the meeting to continue in an orderly manner," he added.

Emaswati under threat as SA mine cuts 13 000 jobs

here are fears that Emaswati in neighbouring South Africa will lose jobs after reports that the world's second largest platinum miner, Impala Platinum, will slash 13 000 jobs in the next two years.

This has brought uncertainty not only among Emaswati but the Swaziland Migrant Mineworkers Association (SWAMMI-WA) as well, which as predicted, saw the likelihood of the unemployment rate shooting up in the country.

On Thursday, eNCA reported that Impala Platinum will slash the 13 000 jobs and cut the number of mines from 11 to six as it restructures its business to manage costs. The media outlet further reported that this move will see future production drop by just over 30 per cent. Restructuring costs will set Impala Platinum back by E2.7 billion, which it says will come from internal cash reserves and sales of revenue.

SWAMMIWA Secretary General (SG)

Vama Jele, confirmed that a number of Emaswati are employed by the Anglo Platinum. He said most were employed through Teba recruitment.

"Beside those employed by Teba, we have some who took up South African citizen and those who reside close to the boundary line separating South Africa and Eswatini who are able to obtain SA national identity documents (IDs) as well as those who were recruited directly," Jele said.

He further stated that in Eswatini most people working at Anglo Platinum, were from the Hhohho and Lubombo regions, although there might a few othersfrom Manzini and Shiselweni.

At the time of compiling this article, Jele said he had no statistics of Eswatini miners employed by Impala Platinum.

"In 2014, we worked with the ministry of labour and social security to review bilateral cooperation with South Africa. It resulted to an MoU which was developed and validated by the ministry of labour and social security," Jele stated.

Jele said this agreement included the-

matic areas of migrant labour basic employment conditions, compensation and social security benefits issues and others. Recently, as government is drawing up the labour migration policy, SWAMMIWA was roped in as a member of the Technical Working Group (TWG) which ensures efficient handling of labour migration and its components. He stressed that SWAMMIWA's participation in TWG is to ensure the policy addresses labour migration issues and opportunities in SADC and at the international level.

He said a major issue at the table is working permits for Emaswati granting them opportunities to work abroad, including in South Africa and the rest of the globe. Jele continued to state that currently, South Africa does not recruit anymore Emaswati to work in the mines.

He added that the recent development demands governments to meet and discuss bilateral agreements or treaties between South Africa and Eswatini. He said SWAMMIWA would influence policies and ensure labour migration was a priority for the Eswatini government.



FLAS LOSES E10.7M IN 2017

amily Life Association Swaziland (FLAS) Resource Mobilisation and Communications Officer Maxwell Dlamini has revealed that the organisation was forced to cut down on 56 jobs after it suffered a staggering E10.7 million loss in 2017 due to the loss of the USAID funding.

FLAS lost the United States Agency for International Development (USAID) funding in September 2017 after the United States President Donald Trump's 'Mexico City Policy' or 'Global Gag Rule'.

Due to the fund loss, over 26 staff members and 30 community workers lost their jobs. The 'Global Gag Rule' is a separate rule that goes further, and requires foreign non-governmental organisations receiving US global health assistance to certify that they do not use their own non-US funds to provide abortion services, counsel patients about the option of abortion or refer them for abortion, or advocate for the liberalisation of abortion laws.

On January 23, 2017, Donald Trump released a Presidential Memorandum regarding the 'Global Gag Rule'.

"I further direct the Secretary of State to take all necessary actions, to the extent permitted by law, to ensure that US taxpayer dollars do not fund organisations or programmes that support or participate in the management of a programme of coercive abortion or involuntary sterilisation," President Trump stated in the memorandum.

Dlamini confirmed that FLAS was no longer receiving funds from USAID/PEPFAR since September 2017. He said this was because the restrictions on the funds were not in line with FLAS' principles. "FLAS believes that people should be allowed to receive all services that they require without restriction of any kind. The loss of funding was indeed related to the Mexico City Policy," Dlamini explained.

Analysing the damage caused by the loss of the funding, Dlamini said the organisation had four projects that were supported by USAID or PEPFAR and, these related to providing integrated sexual and reproductive health and HIV services to vulnerable hard to reach populations. He added that these projects targeted young men; key populations such as men having sex with men,

sex workers and adolescents living with HIV, among others. Dlamini mentioned that with these funds, in a year, FLAS circumcised over 2 800 men, reached over 600 key populations with HIV and SRH services per month, just to make an example of how important the funds were.

"The loss of the projects resulted in the loss of income and means to reach and provide services and information to young people and the populations above. Just for 2017 alone, these projects would have brought E10.7 million," Dlamini stated.

He went on to mention that FLAS also received technical support from PEPFAR partners to provide the best quality of care. "As a result of the loss of the projects, over 26 staff members and 30 community workers lost their jobs," Dlamini said. Furthermore, FLAS currently has infrastructure that was used by the projects and it is now lying idle (such as mobile clinics). Dlamini said the association was, therefore, desperately looking for funding from other sources so that it can continue to provide the much-needed services in the country, nationwide.

CANGO URGES US GOVT TO REVIEW POLICY

he Coordinating Assembly of Non-Governmental Organisations (CANGO) has urged the United States government to review the policy that resulted in FLAS losing the USAID funding.

CANGO Communications Officer Nkosingiphile Myeni said many non-governmental organisations (NGOs) providing sexual and reproductive health (SRH) services believe that the policy does not reduce abortions but increases more unsafe and unhealthy ones, leading to more women's deaths which could be averted.

"Therefore, we urge the United States government to set aside the Global Gag Rule," Myeni said.

Myeni added; "CANGO is aware about the extended Mexico City Policy/Global Gag Rule as a United States government policy aimed at blocking US federal funding for non-US NGOs providing SRH services such as abortion counselling or referrals, advocating to decriminalise abortion or expand abortion services which is discriminatory to women's access to SRH rights."

Myeni went on to state that the policy has negatively impacted NGOs globally and in the Kingdom of Eswatini, setting conditions for some that to continue receiving US funding, they must choose

between one of two options.

The first option being to accept US family planning funds and be prohibited from providing abortion counselling, referrals, or even advocacy efforts and from providing abortions outside of the three exceptions.

The second option was to either refuse US family planning funds and attempt to secure alternative sources of funding to keep health clinics open, continue providing a range of SRH services to clients, and advocate for law reforms to reduce unsafe abortion.

Efficiently

"These are hard conditions to comply with as NGOs and harsh to women's health rights. NGOs are forced to stop providing comprehensive SRH services and loyalty to clients in their clinics as they fail to run SRH programmes efficiently.

This does not only reverse helping people in need but also erodes established trust with clients if they are to cease providing services to them," Myeni explained.

The mouthpiece went on to add that the impacts had shown that the policy restricts fundamental rights including; the basic right to free speech; the right to make informed decisions and to right to access family planning which increases harm to women.

Does FLAS support abortion?

oes the Family Life Association Swaziland (FLAS) support abortion?

This is the question that has since arose because the 'Mexico City Policy' or 'Global Gag Rule' strongly frowns upon organisations that support abortion.

Clarifying FLAS' stance on abortion in the country was its Resource Mobilisation and Communications Officer Maxwell Dlamini, who said the organisation realises that unsafe abortion was a major killer of women in Eswatini. He added that its recognition as a health problem was essential as well as designing preventive measures for it. He mentioned that at the clinics, FLAS comes across several women each day with unwanted pregnancies.

"There is need to promote the use of contraceptives or family planning as well as addressing the high-levels of gender-based violence, which also contribute to the reasons for not wanting a pregnancy," Dlamini elaborated.

He went on to assure that the Family Life Association of Eswatini operates within the ambits of the laws in the country.

The spokesperson said all their conduct and activities were done within the prevailing legal framework and requirements of the law.

He stressed that clinical services provided were in accordance with guidelines provided by the ministry of health. He defined abortion as the expulsion or removal of an embryo or foetus from the uterus before it has developed sufficiently to survive outside the mother (before viability). He said abortion may refer to induced and spontaneous abortion (referred to as miscarriage). Dlamini stated that unsafe abortion is a procedure for terminating an unwanted pregnancy either by persons lacking the necessary skills or performed in an environment lacking the minimal medical standards or both. He added that unsafe abortion also includes the inappropriate management of spontaneous abortion.



MINISTER OWEN'S GUARD CRIES EXPLOITATION, DEMANDS E 18 785

night watchman who was employed by government and assigned to guard the homestead of outgoing Minister of Public Service Owen Nxumalo is demanding over E18 000 for unfair dismissal.

The exact amount is E18 785.

According to documents seen by this publication, Mandlenkhosi Magic Dlamini was employed by government on October 12, 2016 and was dismissed on April 16, 2017. He claims his dismissal was verbal.

According to Finance Circular No. 1 of 2009, night watchmen are employed by ministers who opt not to employ the services of a security firm. The circular states that a night watchman will be appointed by the minister on a fixed term contract on Grade A2.

Other terms of such a contract are agreed between the parties and shall be governed by the Regulation of Wages (Security Services) Order issued from time to time under Wages Act, 1964

Terminated

The circular further states that the appointment of a night watchman would be for the duration of the term of office of the relevant minister unless terminated earlier by the night watchman or by the minister, and either party is compelled to give reasons for such termination.

"Upon such termination, a night watchman will receive gratuity payment of 25 per cent based on total basic salary earned over the period

of employment. A night watchman shall be entitled to annual leave of fifteen working days per annum, which will be taken with the approval of the Minister," reads Circular No.

Among other things the night watchman is entitled to uniform which includes two shirts, a jersey, hat/cap, two pairs of stockings and a winter suit annually.

Initially, Dlamini wanted E54 183 65 as compensation. He calculated this as E46 740 being 12 months compensation. Unlawful deduction which was E2 500 (500* 5 months), notice pay was calculated to be at E3 895 and leave pay (seven days) which amounted to E1 048.65.

However, the certificate of unresolved dispute issued by the Conciliation Mediation and Arbitration Commission (CMAC) on October 26, 2017 reflects that Dlamini wanted E18 785. A sum of E17 340 was for compensation for unfair dismissal while E1 445 was for notice pay. The respondent in the certificate of unresolved dispute is the Civil Service Commission (CSC) and another part which was not identified by its name.

The appointed commissioner by the commission on October 16, 2017 under Section 80 of the Industrial Relations Act, 2000 (as amended) certified the dispute unresolved.

The commissioner stated that reasons to the verdict was that Dlamini claimed he was verbally dismissed by his immediate supervisor without any disciplinary procedures being taken, and that he did not commit any offence warranting his dismissal.

"The respondent on the other hand

argues that the applicant's immediate supervisor rightly exercised his powers in terms of the Finance Circular No. 1 of 2009," reads part of the certificate of unresolved dispute.

The commissioner noted that both parties maintained their positions and thus he declared the dispute unresolved.

Attached

In his affidavit, Dlamini said he was getting a basic monthly salary of E3 895. He went on to add that at first he was attached to Minister Owen Nxumalo's residence as a nightwatchman at Ngwane Park.

The veracity of Dlamini's allegations contained in his affidavit are yet to be tested in court.

"I was there after transferred by the minister to Emfabantu, which is his business area, where I was working as a general labourer on or about the month of November 2017," Dlamini stated in his affidavit 2016.

He counted that while employed as the general labour, he dug the foundation of bedsitters that were under construction at Mfabantu.

Dlamini further alleged that he was thereafter taken to Bulandzeni which is Minister Nxumalo's parental homestead to do some errands for approximately three days. "Thereafter, I resumed my position of a night watchman at Ngwane Park," Dlamini said.

Dlamini said towards the end of February 2017 he was taken back to Bulandzeni as general labour during the day, whereas in the night he was guarding Minister Nxumalo's shop at Bulandzeni.

He further stated that all this time he was being paid by government for the position of a night watchman. "On or about March 25, 2017, the minister delegated his driver

(Malungelo Khumalo) to fetch me from Bulandzeni and he took me home. I thereafter received a call from Malungelo who instructed me to come to Manzini to be taken back," Dlamini alleged in his affidavit.

CERTIFICATE OF UNRESOLVED DISPUTE

He went on to state that he stayed at Bulandzeni up until April, 16, 2017, whereof he decided to go back home as the minister allegedly failed to pick him up on April 14, 2017.

Dlamini said on April 18, 2017 he did not receive his salary. "The minister ordered me to stay at home and not report for duty thereafter. This was on April 16, 2017 when he called me," Dlamini stated in the affidavit.

He continued to state that he would monthly give the minister E500, which Nxumalo said he was taking to the Swaziland Revenue Authority (SRA). He alleged to have paid the money for five months.

Msunduza neighbours quarrel over plot



wo neighbours at Msunduza location in Mbabane are at loggerheads over the ownership of a plot, which they both claim as being the rightful owners.

The two are now relying on the High Court to assist them determine the right owner after the matter was reported to court by one of the quarrelling neighbours.

"The above honourable court is seized with the jurisdiction to hear and determine this matter because all parties to it are domiciled in the area of its jurisdiction and the cause of action equally arose in its area of jurisdiction," reads the third paragraph of the particulars of claim by Florence Bhembe, who is the plaintiff. Other residents who are also neighbours argue that the bone of contention is that the numbering of the plots is not chronological hence confusing the two.

They said plot 52 is currently, list-

ed as plot 51. The same goes for other plots which are not named in chronological order in the location.

Instead of the plot numbers following in the sequence 50, 51, 52 they are numbered as 50, 52, and 51 which the residents claim was the source of the controversy between the two parties. Florence Bhembe and Minah Simelane are neighbours who should be sharing the same fence and probably the same driveways as their plots are centimetres apart.

However, Simelane has since 2016 been uncertain of whether she will be a neighbour to Bhembe or she will remain homeless leaving a vacant plot when the matter concludes in

This follows that in 2016 she received summons informing her that her new neighbour, who she believed had purchased the plot next to her homestead, turned up and claimed to have purchased the very plot she is occupying hence wanted her to vacate it.

Encroachment

Furthermore, Bhembe wanted her to remove the "encroachment and make good land upon which it stands within two weeks" after being served with the court order.

In her particulars of claim filed in court, Bhembe accused Simelane of occupying her plot (lot 51 situated in the Msunduza township in Mbabane as she produced a deed of sale to that effect dated January 1997.

Simelane on the other hand argues that she is not occupying the plot in question as she claims to be occupying plot number 52 and produced her father's title deed to that effect, dated September 1967.

"The correct facts of this matter are that while I was growing up in occupation of the plot no 52 as set above

the said plot No 51 which is a neighbouring plot used to be owned by a certain Zeni Fakudze who transferred the same to Henry Mgcibelo Dlamini who eventually transferred same to the plaintiff, proof of the said facts are set out in annexure in the particulars of claim," reads part of the response.

Simelane further states that these facts prove that the plaintiff is a new and novice owner of plot No. 51 regarding the boundaries and the vicinity of the plots neighbouring her plot and should, in the circumstances have sought clarification from relevant professionals and from her neighbours.

"On 20 August 2016, the attorneys of record of plaintiff and defendant undertook an inspection in loco of the said properties in issue plot no51 and 52 and made an attempt to interpret the professional arial view diagram as well as locate the structures set out thereon and the defendant's truthfulness was confirmed when looking at the number of structures being three the layout and the shapes thereof," further reads the affidavit.

The current year has been described as disastrous after 46 homesteads were destroyed by fire in four months, which claimed over 10 lives.

The number of homesteads reported to have been affected by the fire disaster was within four months of the winter season.

These figures are based on data collected by the Baphalali Swaziland Red Cross Society (BSRCS), the National Disaster Management Agency (NDMA) and Royal Eswatini Police Service (REPS)

According to the statistics availed to this newspaper, over 46 homesteads were affected by fire in four months, from April 2018 to July 2018.

NDMA Chief Executive Officer (CEO) Russell Dlamini described 2018 as a rather disastrous year, saying what was shocking was that only 12 homesteads were reported to have been destroyed by fire during the same period in 2017.

"Only 12 homesteads were attended after being affected by fire in 2017 compared to the 46 cases reported within four months in 2018," he said. He added that the number might increase as the summer season is around the corner and most homesteads might be affected by lightning. Dlamini said out of the 59 Eswatini Tinkhundla 29 of them experienced and reported fire disasters to the NDMA, making up the 46 homesteads.

He explained that 24 of the burnt houses were beyond repair and the NMDA had the task of reconstructing them from the ground.

He said eight of the 46 were repairable and the agency was able to patch them where necessary. Dlamini further added that the cost of responding to all the fire disasters amounted

to over E990 000, which was spent by the agency. He urged Emaswati to always to be extra careful when they are around or in contact with

He said the high number of reported fire disasters is an indicator that Emaswati need to be extra vigilant when it comes to fire.

Dlamini said in some of the reported fire incidents, it was not clear what really caused the fire whereas in some cases family feuds impacted. Meanwhile, Eswatini National Fire and Emergency Services Public Relations Officer, Hebert Shabangu said the reported fire cases were caused by a range of incidents including negligence amongst Emaswati.

He explained that some families would leave fire unwatched which resulted to the fire accidentally spreading to neighbouring compounds, causing damage.

He added that during the winter seasons they attended to a vast number of cases caused by exploded hand gas or imbhawula where some lost their lives because they left those things on. Shabangu highlighted that in some of the reported incidents, the Fire Services was unable to save the burning compounds as Eswatini has a limited number of fire stations and they were not able to reach some places in time to save the structures. He also said most Emaswati call for the fire services' assistance when they notice that the fire has become uncontrollable.

He urged Emaswati to report fire incidents the instant they occurred and avoid trying to put out the fire on their own first.

"In most cases, we always find fire incidents having already escalated because people try to put out the fire on their own.

Then when they see that the fire is spread out and uncontrollable that is when they call the Fire Services, which is wrong," he said.





LISWATI INVITED TO SERVE IN USA, SINGAPORE EDITORIAL BOARDS

Professor Zodwa Motsa-Madikane, a woman whose humble beginnings are deeply rooted in Mankayane, has been invited to serve as a member of the Editorial Board in two different countries: Singapore and the USA.

This is her latest milestone in many successful and notable undertakings in her professional career within academia.

Motsa-Madikane currently serves as the University of South Africa (UNISA) Change Management Director and as explanation on how she was invited by the two countries says, "Both invitations have been inspired by the paper: 'When the lion tells the story' which was found in the journal: Higher Education Research & Development (2017)."

The first invitation was from PiscoMed Publishing Pte. Ltd. (Singapore), a highly reputable publishing company. She has been invited to work in the journal, titled 'Lifelong Education'. The second invitation from EnPress Publisher (USA) reads, 'We consider that this article is of high academic value. Therefore, we would like to invite you to join the Editorial Board of the Region - Educational Research and Reviews". "From an ordinary African woman's perspective, these invitations are truly humbling. The significance of such a membership in the profile of an active scholar is prodigious," says the Manzini Nazarene High School product. She acknowledges that board mem-

bership is hard-earned and that her involvement in these scholarly boards will grow her scholarship as it will expose her to the high level thinkers in diverse fields beyond her own; "I am certain that my family is very proud of this - my husband and sisters have been celebrating since I received the news. I hope my country is equally proud."

Recalling her rich curriculum vitae which steered her towards this latest success, she recalls how she previously served as the University of South Africa's Ethiopian Country Director for six years and was at

the forefront of the institution's only campus outside RSA.

"At the end of my term, the centre had graduated 166 PhDs and 325 Masters students. This project has become the prototype for teaching doctoral and masters students in the whole university. I am happy about this success." Prior to that, Motsa-Madikane cut her teeth in teaching as a junior lecturer at the University of Swaziland (English Department). She then taught at Hebron College in South Africa followed by a short stint at MEDUN-SA and she has spent the longest

career time at UNISA.

She served as a senior lecturer, a head of department – she was the first African to head the English department (2006 -2011);

She currently works in the Vice Chancellor's office driving Change and Transformation; "I am responsible for the agenda of transformation of scholarship in the institution. Beyond being a full time academic, I have trained writers of siSwati both in South Africa and Eswatini, advised on language policies and I have served as the Deputy Chair of the Pan-South African Languages Board which is a Chapter 9 Institution that looks after linguistic justice."

She is also President of the Wole Soyinka Society and the founding member of the international body called Classrooms Beyond Borders where they teach students in Palestine, Nigeria, the USA and South Africa without expecting any pay.

The Fulbright scholar is an active researcher, writer, theorist, critic, interpreter, translator and teacher of English, isiZulu and siSwati; "My research interests are in Theatre of Relevance, Literature and Language in Africa, Decolonising Higher Education in Africa, siSwati Oral Lore, Leadership in Africa and teaching Masters and Doctoral students of English in the Humanities."

She was inaugurated into Full Professorship in 2010 and has more than 40 publications to her name and hundreds of books in siSwati for schools from Grade One to high school level used in the RSA; "Some of my books are prescribed locally."

'African Universities should impart indigenous knowledge'

ften times, the more educated one becomes, the more they tend to assimilate the perspective and beliefs of the western world.

Not so with Luhlendlweni's greatest export, Professor Zodwa Motsa-Madikane, who remains adamant that African principles need to be driven by her scholars in order to break away from the misnomers that remain as a result of the colonial agenda in education.

"It is of grave concern that our forefathers fought for independence and the preservation of our sovereignty as a people of Africa, but our universities still continue to import and perpetrate the colonial agenda in education."

She says African knowledges deserve a central location in post-colonial African universities.

The woman, who is passionate about education, calls for relevant education that hones in the skills of the people while it addresses the needs of the community as an enterprise that cannot be sustained by depending on external supply. She highlights that Africa is rich with human capital, diverse skills and many resources for everyone's upkeep.

"To correct the tendency of foreign epistemologies that perpetrate our dependency on systems which suppress Africa, universities as spaces of knowledge generation, should take the lead," she challenged, whilst calling for scholarly debates and publications to lead in the decolonising of thinking and practice to locate Africa in the centre, not in the margins of European in education.

She calls for Africans to be masters and crafters of their education system which is primarily about them. "We should make central our own languages, epistemologies and governance systems—tell our own story and grow our own timber for future generations. As they say, the story will always favour the hunter and not the prey."

God and family keep me grounded

y God is both my radar and anchor."

Despite all the worldly recognition, Professor Zodwa Motsa-Madikane says she believes in God who made heaven and earth.

She admits to have read all sorts of theories, even to the point of being "coerced" by her academic discipline, at times, to argue in support of theories which profess that God does not exist.

She is grounded in her faith as a believer in Jesus Christ; "It is an experience that impacted me at the age of 14 and has never waned." She counts her different fami-

lies as anchor to her success.
"I have a very close-knit Mvulane,
Dlamini and Madikane nuclear
family whose existence always

makes me know I belong."

She recalls the attention which was accorded to her by her parents despite being part of a big family as her sounding board; "The family ethics we all lived by work in synergy to ensure that I

remain comfortable in my identity."

"Finally, I have had a solid education in my field. This ensures that I know what to conduct research on and what to teach. These are virtues which I am hopefully passing on to my children and to my students."

Professor Motsa-Madikane can recall several generations of her family on both sides and counts this knowledge as supportive in her identity and confidence.

"I am the daughter of Sokhonjiwe Motsa, the son of Ndzaba Motsa, the son of the legendary Chief Mhlaba Motsa of Lushikishini. Born of the Mkhonta and Ndwadwe (LaZidze) matriarchs, my mother -- HRH Velephi Nkhosi Dlamini -- is the daughter of Mtikubola, the son of Mhuli, the son of Tfontfwane of Mbandzeni. She hails from uMphakatsi weLuhlendlweni."

She counts this genealogy as important as it grounds her and keeps her head up even if it may not translate to anything of importance to the next person.

She was born in Mankayane and grew up in Manzini.

She completed her high school education at Manzini Nazarene, then attained her first degree at the University of Botswana and Swaziland, (majoring in English and African Languages).

She would later attain her second degree at Michigan State University (MA in English).

Thirst for more knowledge in siNtfu saw her enrol for another degree in African Languages (Linguistics and Literature) at the University of South Africa, a BA Honours, pursuing Linguistics and Literature. Her highest degree was conferred by the University of the Witwatersrand (PhD in English). Additionally, she has several certificates in management fields such as Financial Management, Project Management, Leadership in Higher Education, etc. because in the past 15 years or so she has had to work as a manager in the university domain.

Synopsis of Professor Zodwa Motsa-Madikane's paper

Starting with a little background to the genesis of this paper may help. I was invited by Prof Bruce Macfarlane of Southampton University in the UK to contribute the southern African perspective to the scholarly debates about the relevance of colonial education in the African universities today. My paper titled: 'When the lion tells the story: a response from South Africa' was published by Routledge: Taylor and Francis Groups.

The thesis of the paper is that the present Africa has colonial universities which are essentially universities in Africa, not African universities. The epistemologies, the curriculum, language and culture of universities in (southern) Africa are a continuation of the colonial legacy which requires urgent transformation. As I was responding to certain ideas presented with a largely "northern" lens, my paper argues that Africa had universities in the 11th century, which offered a curriculum that was good enough to attract thousands of scholars from the continent. The university in Egypt, for instance, attracted Aristotle and Pythagoras as students from Greece. But this legacy has been stolen, sub-

jugated, eradicated or overshadowed by the western colonial narrative of the origins of knowledge. It further points out that: ... what destabilised Africa's continuation of her own home-grown university curriculum was the bustle of Euro-universities across the colonies with near-zero concomitant research capacity in those institutions. These universities perpetuated an epistemological dependency on Europe and modelled the psychological reverence of Euro-American knowledge systems as the only admissible canon riculum and its protégés were focused on the Eurocentric mode, naturally, a wide chasm emerged between the African student and his/her pre-colonial knowledge system which has always been perceived as an unworthy entity, located in the 'zone of non-being', while its foreign competitor enjoyed the privileged location in the 'zone of being' (Motsa, 2017). The #FeesMustFall movement is therefore, inter alia, decrying the absence of the representation of the African epistemologies and practices within the higher education system of post-colonial African universities. This is epistimecide."

ELDERLY GRANTS SLASHED BY E600

...DPM pleads ignorance, vows to investigate matter.

lderly citizens are infuriated by government's inconsistency in the payment of elderly grants.

The elderly people of Eluvinjelweni alleged that they were given money short of E600 during their payday the past week.

Some of those interviewed said other senior citizens under the Hhohho region who were paid on Monday received E1 200.

However, to their shock, the elderly citizen of Eluvinjelweni only received E1 000 instead of the expected E1 600.

What angered some elderly citizens under the Hhohho region was that they had to wait for six hours in the scorching sun to collect their monthly grants of E400, only to be paid E1000 on Monday.

Not only that, they said what was more annoy-

ing was that there was not even anyone who cared to explain to them the disparities.

Apparently, the elderly people were expecting to receive E1 600, which money that covers four months.

"We only got E1 000 while we were expecting to receive E1 600," said an elderly woman of Eluvinjelweni in the Hhohho region.

Dispersed

She said the officers only dispersed the E1 000 without even explaining anything to them.

Another senior citizen of Mpolonjeni shared the same sentiments as he said they were expecting E1 600 but were shocked to receive money that was E400 less.

"Nothing was explained to us. We just had to accept what was given to us and go home," he said. Last Monday, elderly people arrived at the designated areas to receive their monies as early as 0800 hours, only to be paid at 16:30 hours.

Eswatini Posts and Telecommunications Corporation (EPTC) started processing the elderly grants for the Hhohho region at 16:30

Payments of elderly people who receive their money through the post office and manual pay were delayed due to unforeseen technical problems at the Central Bank of Eswatini (CBE).

According to an elderly, who receives her money through the post, they had to wait for hours in the scorching sun before they received their grants.

Eswatini Post and Telecommunications Corporation Corporate Communications Manager Nqobile Magagula said unforeseen circumstances on their side caused glitches in the payment of grants and they ended up paying the elderly citizens late.

She apologised for the delay, saying they had no control of the situation, adding that they hoped such situations would be avoided in future.

She explained that the delay which occurred on Monday was caused by the shortage of money at the Central Bank of Eswatini.

eputy Prime Minister (DPM) Paul Dlamini says he was not aware that the elderly grants fort the Hhohho region were slashed.

The DPM has promised to leave no stone unturned as he investigates reports that some elderly people's grants were short. He said he was not aware of the matter at the time he was contacted by this publication on Friday.

He sounded shocked when he was informed that some elderly people at Eluvinjelweni received their grants short by E600. "I haven't heard such reports, however I am going to investigate the matter," the DPM promised.

Hhohho Regional Education Officer (REO) Tamari Langwenya confirmed this in a telephonic interview with this publication on Thursday.

This was after the Annadale Primary administration had referred all questions on the matter to Langwenya.

The publication had gone to the school to inquire about reports of extreme corporal punishment practice.

However, the administration of the school said their findings on the issue were already with the REO.

Addressing the matter, Langwenya said some concerned parents had registered their complaint with her office three weeks ago.

She said after receiving the reports, she took it upon herself to summon the school administration to hear their side of the story.

"They told us that it was not true that the school was practising corporal punishment. They said they do not beat pupils," Langwenya said.

Langwenya went on to state that the initial reports of corporal punishment at Annadale did not suggest the issue was a concern.

She said the ministry had alerted the school that it was not expected to be still practising corporal punishment. She said this was because government was now endorsing positive discipline in schools in the country.

When asked if the ministry had conducted its own investigations on the reports, Langwenya said; "In terms of the investigations, it could have not

been very intensive when the matter was reported somewhere else."

Langwenya said she summoned the school, Principal Elson Muponda, who told them that the school was not practicing corporal punishment. Be that as it may, Langwenya said she emphasised to the principal that the ministry was not expecting them to be using corporal punishment.

Issue

"We never thought it was going to be a big issue which would end up reaching the media. I am now surprised about the developments," Langwenya said.

However, Langwenya failed to come out clear on whether the ministry will initiate investigations on the matter

She said this was because the ministry had addressed the issue with the school administration and said she expected them to refrain from corporal punishment if they were still

practising it.

She said the ministry does not take lightly reports of corporal punishment in private schools because they are also registered under government.

"We are saying the schools have Emaswati pupils so we won't expose them (pupils) to any harm. It is a mandate of the ministry of education and training to oversee pupils' education at any time and level," Langwenya explained.

She also did not rule out the possibility that the school administration might have given them false information on the matter.

Be that as it may, she was quick to clarify that honesty rests on an individual and they can't force someone to tell the truth.

She said the main intention of discussing the allegations of corporal punishment at the school was to warn them to stop it if they were still practising it. She promised to personally

visit the school to discuss the matter further.

Information which led-to the pursuing of the matter was that there was a certain teacher in Grade Four B who was allegedly heavily beating pupils.

Concerned parents told this publication that the teacher would beat the young pupils with a stick all over the body.

Teachers

This resulted in some of the pupils left with bruises. The name of the implicated teacher is known to this publication but will not be revealed for now.

Addressing these allegations, Langwenya said should such reports resurface even after she had warned the principal, she would not hesitate to tell parents to report the matter to the police. She said this was because the said teacher was now committing an offence of assault.

"If I were to advise the parents I would tell them to report the teacher to the

police; this is called assault," Langwenya said.

The REO promised to pursue the issue in order to ensure that such allegations are put to rest once and for all. Of note, is that the issue of corporal punishment has previously led to government being sued E2.5 million after a pupil from one of the Northern Hhohho schools was maimed by a teacher.

Organisations such as Save the Children have been at the forefront, advocating for the banning of corporal punishment in schools.

Those who exceeded the bounds of 'moderate chastisements' are arrested and charged according to the Children's Protection and Welfare Act No. 6 of 2012.

In fact, schools have been told to instil positive discipline, which some teachers still find too hard to comprehend.

BEING OVERLY EMOTIONAL

Begining property investors should always buy property based on analytical research. Will it provide the gains and returns you require? It is in the best location to attract quality tenants?

By answering these questions, rather than buying a house because you loved the curtains or thought it would make a good holiday retreat, you're thinking based on financial gain rather than personal feelings. At the end of the day, investing is all about the economics, not the emo-

LACK OF PLANNING

The key aim of most beginning property investors is to build a lucrative property portfolio. However doing so without a plan of attack is like setting out on a road trip without a map: you'll inevitably take a wrong turn and end up lost. Successful wealth creation through real estate requires you to set goals, determining where you want to end up, and then devising a cohesive plan to get there.

You need to focus on both the short and long term and ensure your investment decisions gel with your overall strategy. Work out what you want to achieve with regard to income - are you chasing short term yields or long term capital growth - and how you can best manage your cash-flow as a smart investor.

What type of property do you need to buy in order to meet your income goals? With a carefully

MAKE A RUG FROM UPHOLSTERY FABRIC

great way to decorate any room in your house, this is a simple projects that can be done in half a day. You'll need:

iron

sewing machine

scissors/rotary blade


ironing board

heavy-duty needle (18/110)

coordinating thread

Directions

Step 1: Lay the no-slip rug pad on the floor. Press it flat to remove all creases. Lay the cotton batting on top of the rug pad, also pressing out any creases or folds. Then lay the fabric right-side up on top of those two layers, making sure it is nice and flat as well. Cut off any excess



around all four sides so that all three layers are the exact same size.

Step 2: Pin the three layers in place in various spots around the rug. Make sure the three layers stick together and do not shift. You should now have a nice large three-layer rectangle or square, pinned all around the edges and center.

Step 3: From the outer edge fab-

ric, cut four 4" strips of fabric from selvage to selvage (width of fabric). You may need to cut more strips if your rug is larger than the width of your fabric and sew the strips together. Iron the strips as if you were making your own homemade bias tape. Fold each strip in half wrong-sides together, straight down the middle and iron to create a crease. Open

up the fold and then fold in the outer edges 1/4" towards the wrong side and press flat. Repeat for all four strips. Fold the strip in half again, enclosing the 1/4" edge folds in the center, and press. Repeat for all four strips. Now you're ready to bind your rug.

Step 4: Unfold one strip and place it right-side down (with the folds facing up) along the edge of one side of your rug. Keep the edge of your binding about 1-1/2" away from the edge of your rug, and pin along the 1/4" folded line. Do this for only ONE side of the rug.

Step 5: Sew the binding in place using a heavy-duty needle. Sew directly on the 1/4" fold line so you won't see the stitches when the binding is folded back over. Remove the pins as you sew. Fold the binding

over the raw edge of the rug, enclosing the side of the fabric. The center fold of the binding should be the outer edge of the rug. Pin in place. Sew directly on top of the binding to secure in place. You can also hand sew the bottom binding in place with a whipstitch if you do not want to see a stitched line along the top.

Step 6: To work on the adjacent edge, place the binding along the edge as you did the first time, but allow a few inches to hang off of each end.

Fold the excess fabric over the corner towards the back of the rug and pin in place. It should look something like this. Sew the binding onto the rug as you did for the previous sides. If your rug has some wrinkles in it, use an iron on a low-setting to carefully get them out. Just make sure to press gently, and not let the iron linger because you do not want to melt the no-slip rug pad underneath.

QUESADILLA FILLINGS TO DIE FOR

ake your home made flour tortillas up a notch by turning them into delicious quesadillas. A quesadilla (pronounced "kay-sadee-ya") is a traditional Mexican meal of two tortillas stuffed with cheese and a meaty filling, then toasted.

You can make them sweet or savoury, it's really up to you and the extent of your imagination. Make a large batch of tortillas and freeze them in batches of 12 for a quick and easy weeknight dinner. To make the quesadillas, defrost the tortillas in the fridge overnight or during the day while you're at work. Prepare the fillings, lay one tortilla down and spoon the filling on top, cover with another tortilla and grill or toast for a few minutes on each side, until golden brown. You can dry toast the quesadilla or use butter to coat the pan for a little crunch.

Pizza

Is there anything better than combining our two favorite cuisines: Italian and Mexican? We think not, and these quesadillas, which are stuffed with ground beef, tomato sauce, pizza sauce, pepperoni, and shredded cheese, prove it. This recipe serves four and is completely customizable; just choose the pizza toppings of your choice, pack them in fresh tortillas, heat up your skillet, and go. In a large skillet over medium-high heat, brown 500g mince until cooked and crumbly. Once cooked through, stir in 1 cup of pizza sauce and 1 cup tomato sauce. Heat through for about 3 or 4 minutes. Next, preheat your indoor griddle or a second big skillet to medium-high heat. Spray lightly with cooking spray and then lay out your six tortillas on the counter. Spread the mince down across the bottom half of each tortilla. Add sliced pepperoni, one and a half cups shredded cheese and basil to each one. Fold the top part down to cover the bottom portion. Place each quesadilla in your skillet one at a time and brown on both sides. Remove once browned up and slice in half. Repeat with your other tortillas.

Three Cheese

Meat-free never tasted so good. This recipe for three cheese quesadillas with garlic butter calls for only six ingredients. Regardless of whether you serve these as an appetiser or a main meal, just make sure you make them and save one for yourself; they'll go fast. In a small pot, bring two cups water to a boil over high heat. Add the garlic cloves and cook until soft, about five minutes. Drain the garlic, let it cool slightly, peel, and put it in a small bowl. With a fork, mash the garlic to a coarse paste and then add the butter and mix well. In a medium bowl, combine 2 cups cheese of your choice. I like to use white cheddar, mozzarella and feta. Spread the garlic butter on one side of each tortilla and set the tortillas on a work surface, buttered side down. Distribute the cheese mixture among the tortillas, covering only half of each and leaving a 1-inch margin at the edge. Fold the tortillas in half to enclose the filling, creating a half-moon.

In a 10- or 12-inch nonstick skillet over medium heat, cook two of the quesadillas, covered, until golden brown, about four minutes. Uncover and flip the quesadillas. Cook until the second side is golden brown and the cheese has melted completely, about two minutes.



RAVIOLI

Ravioli | Serves 6 Prep time: 2 hrs Cook time: 10 mins Ingredients

In a medium sized bowl, combine the flour and salt. Make a well in the flour and add the egg, then mix to combine until it forms a stiff dough. If needed, stir in one to two tablespoons of cold water. Turn onto a floured surface; knead until smooth and elastic, about 8 to 10 minutes, adding remaining flour if necessary to keep dough from sticking. Cover and let rest for 30 minutes.

Step 2

While your pasta rests, combine the sauce ingredients in your large pot. Bring to a boil and then reduce heat to the lowest setting. Cover and simmer for one hour, stirring occasionally. In a large bowl, combine the filling ingredients. Cover and refrigerate until ready to use.

Step 3

Divide pasta dough into quarters. Roll one portion to 1/16-inch thickness and keep the rest of the pasta

covered until ready to use.
Working quickly, place
rounded teaspoonfuls
of filling one inch apart
over half of the first
pasta sheet. Brush
around each teaspoon
of filling with water to
moisten. Fold the sheet
over and press down to seal.

Cut into squares with a pastry wheel or sharp knife, and then repeat with the remaining dough and filling.

Step 4

Bring a large pot of generously salted water to a boil, and then add the ravioli. Reduce heat to a gentle simmer and cook for two minutes or until the ravioli float to the top and are tender. Drain with a colander and spoon sauce over the ravioli before serving.

HOMEMADE FLOUR TORTILLAS

This recipe has been a long time coming, years actually. I've been trying out recipes for homemade flour tortillas for what seems like forever, but I've never been thrilled with any of them.

Most have turned out too dry, too sticky, too crisp, too bland, too soggy, too complicated. I even started to think maybe the problem was with me.

Then I came across this recipe on a blog and wow, the results were amazing. I made a small test batch of these tortillas and immediately regretted having made so few. The next morning, I used the last two to make a delicious creamed spinach quesadilla for breakfast. These tortillas are tender, soft and flavorful. Because they keep well, they can be made in advance and warmed in the microwave or on the stovetop, just before serving. Store them in an airtight container or zippered

bag at room temperature for 24 hours or refrigerate for up to one week. To freeze, separate the tortillas with parchment or waxed paper and place in a zippered bag before placing in the freezer for up to three months.

Flour tortillas | Makes 12 Prep time: 20 mins Cook time: 40 mins |

Ingredients

3 cups all-purpose flour

• 1 teaspoon salt

1 teaspoon baking powder
½ cup vegetable oil

• 1 cup warm water Tools

Directions

Step 1 Combine the flour, salt and baking powder in a large bowl. Using your wooden spoon, mix all the dry ingredients until well combined. Add oil and water while stirring and continue to mix until the dough is smooth.

Step 2

Transfer your dough to a well-floured work surface and divide into 16 equal portions. Turn each piece to coat with flour. Form each piece into a ball and flatten with the palm of your hand. Cover flattened balls of dough with a clean kitchen towel and allow to rest for at least 15 minutes (or as much as 2 hours) before proceeding.

After the rest period, heat a large pan over medium heat. Roll each dough piece into a rough circle, about 6 to 7 inches in diameter, keeping your work surface and rolling pin lightly floured. Don't stack uncooked tortillas on top of each other or they will get soggy.

Brazil's Lula launches presidential candidacy from behind bars

BRAZIL - Even behind bars, Brazil's Luiz Inacio Lula da Silva yesterday will secured his leftist party's nomination Saturday and continue to overshadow more likely candidates in the country's most unpredictable presidential election for decades. Yesterday saw three big party conventions, two months before the first round of voting on October 7 in Latin America's dominant economy. Center-left environmental campaigner Marina Silva will get the nomination of her Rede party in Brasilia. Also in the capital, former Sao Paulo governor and establishment heavyweight Geraldo Alckmin will secure the nod from the center-right Brazilian Social Democratic Party, or PSDB. But while both Silva and Alckmin are serious contenders in a battle against controversial right-winger Jair Bolsonaro, it's the third convention taking place in Sao Paulo that will suck up much of the atten-

Trump hits back at LeBron James over racial division comments

WASHINGTON - US President Donald Trump sniped back at NBA great LeBron James late Friday, days after the basketball player and philanthropist accused him of fueling racial divides in the United States. "Lebron James was just interviewed by the dumbest man on television, (CNN presenter) Don Lemon. He made Lebron look smart, which isn't easy to do," the president tweeted of the Los Angeles Lakers player. In an interview on Tuesday -also broadcast late Friday -- James told CNN he believed Trump "is kind of trying to divide us." "He's kind of used sport to... divide us and that's something I can't relate to because I know that sport was the first time I ever was around someone white. You know?" said James, who on Monday opened an elementary school for at-risk youth in his native Akron, Ohio. AFP

Mali president urges big turnout in run-off vote

BAMAKO - President Ibrahim Boubacar Keita on Friday urged Malians who voted for him to turn out for a second round next week while his run-off opponent Soumaila Cisse called on parties to forge a 'broad democratic front' against the incumbent. Keita won 41.42 per cent of votes in the first round of voting in the sprawling, landlocked African nation, easily ahead of Cisse with 17.8 per cent. The second round will be held on August 12. The first round, held on July 29, was marred by sporadic violence and threats from armed groups that led to several hundred polling stations being closed, mainly in the lawless central region. "You proved all the naysayers wrong," Keita told crowds of rapturous supporters in Bamako. He urged followers to "up this momentum and confirm the choice of peace and progress". AFP

Eleven found dead in Mexico border ahead of president-elect's visit

CIUDAD JUAREZ - Eleven bodies were discovered on Friday in a Mexican town close to the US border, days before president-elect Andres Manuel Lopez Obrador is due to visit for a series of forums seeking to stem the violence in the country. The bodies of eight men and three women were found in a home in Ciudad Juarez, the government of the northern state of Chihuahua said in a statement. It said the people were victims of homicide. The incident may be related to clashes between criminal groups, the government added. The prosecutor's office is investigating the killings and identities of the victims. Ciudad Juarez was for many years one of Mexico's most violent cities, drawing comparisons to a war zone.

YONGYANG - North Korea has pressed ahead with its nuclear and missile programmes and continues to evade UN sanctions through increased illegal ship-to-ship transfers of oil products at sea, a UN report said Friday. In a 62-page report sent to the Security Council, the UN panel of experts also listed violations of a ban on North Korean exports of coal, iron, seafood and other products that generate millions of dollars in revenue for Kim Jong Un's regime. Pyongyang "has not stopped its nuclear and missile programmes and continued to defy Security Council resolutions through a massive increase in illicit ship-to-ship transfers of petroleum products, as well as through transfers of

coal at sea during 2018," said the report, seen by AFP. The transfer of petroleum products to North Korean tankers at sea remains "a primary method of sanctions evasion" involving 40 vessels and 130 associated companies, it added.

The violations have rendered the latest batch of sanctions 'ineffective' by flouting the cap on oil, fuel and coal imposed in a raft of UN resolutions adopted last year, it added.

At a historic June summit with US President Donald Trump, North Korean leader Kim Jong Un signed up to a vague commitment of "denuclearisation of the Korean Peninsula" in the hope of getting UN and US sanctions relief.

Tariff threat against US justified - China

INGAPORE -China's foreign minister said yesterday that his country's threat to impose retaliatory tariffs on \$60-billion (R800-billion) of American goods in an escalating trade spat was 'fully justified'.

Beijing threatened Friday to bring in the levies on products ranging from beef to condoms after US President Donald Trump's administration upped the ante in its plans for additional tariffs on Chinese goods worth \$200-billion.

Washington suggested the rate on the proposed extra tariffs could be increased from 10 to 25 per cent.

The two countries have been embroiled for months in a trade conflict that has threatened to hurt consumers in both countries.

Washington claims that China's export economy benefits from unfair policies and subsidies, as well as theft of American technological know-how. Speaking on the sidelines of a security forum in Singapore, Foreign Minister Wang Yi said China's threat of retaliatory tariffs was "fully justified and necessary".

"These are measures taken out of consideration for upholding the interests of the Chinese people," he said, speaking through a translator.

He said the move was also aimed at upholding the "global free trade regime" that was underpinned by the World Trade Organisation.

Zimbabwe President Mnangagwa calls for unity as opposition cries foul

ARARE - Zimbabwean President Emmerson Mnangagwa has called for unity in the wake of allegations his election victory was tainted by fraud, hailing the vote as a fresh start for the country after the repressive rule of Robert Mugabe.

As defeated opposition leader Nelson Chamisa decried the official results as a sham, Mnangagwa, a former Mugabe ally, defended the vote.

"With the eyes of the world on us we delivered a free, fair and credible election," Mnangagwa told reporters on Friday. He added that while "no democratic process is flawless", Zimbabwe's first post-Mugabe election was a far cry from the fraudtainted polls seen during Mugabe's 37 years in power. His plea for unity came after allegations of foul play sparked a deadly crackdown on protesters in Harare on Wednesday when troops opened fire, killing six. Mnangagwa, who is seeking to end Zimbabwe's international isolation and attract badly needed foreign investment, said he would set up an independent commission to investigate the bloodshed. The United States on Friday said the election was marred by violence in the

aftermath of the vote and called on the winner to show 'magnanimity' and the opposition to show 'graciousness in defeat'. Final results showed Mnangagwa won 50.8 per cent of Monday's vote against Chamisa's 44.3 per cent - a knife-edge 0.8 per cent above the threshold needed to avoid a run-off. News24

Chamisa calls for SADC meeting over election result

ARARE - Zimbabwe's opposition leader Nelson Chamisa has called on President Cyril Ramaphosa to intervene in the post-election situation.

He has also called an urgent meeting of the Southern African Development Community (SADC) heads of state.

Chamisa announced on Friday that his party will follow all legal and constitutional routes to challenge the election results that confirmed Emmerson Mnangagwa as president.

"There is no way there can be a legitimate government in Zimbabwe."

The Zimbabwean Electoral Commission announced that Mnangagwa received 50.8 per cent while Chamisa scored 44.3 per cent.

Chamisa has made it clear his party and supporters don't recognise Mnangagwa as president. 'We want to give him our perspective and request him to intervene. This situation is so serious. You know Zimbabwe has not known peace."

Chamisa insist Zimbabweans have voted for him overwhelmingly.

"To the people of Zimbabwe, wait for your moment. The celebration is coming."

US calls for release of all Zim's poll data

ASHINGTON-The chair of the subcommittee on African affairs wants full transparency.

United States Arizona Senator Jeff Flake on Friday night called on the Zimbabwe Electoral Commission (ZEC) to stand by its word on transparency and release all polling data.


Flake said in order to instil confidence in the July 30, election results, ZEC must make good on its commitment to release comprehensive polling data in a transparent manner that includes results from each polling station signed off by party agents who were present for the casting of ballots and the tabulation of results.

Challenges to the results must be pursued through legal channels," he said.

Flake, who is also chairman of the Senate Foreign Relations Sub-committee on African Affairs, also said the post-election violence in Zimbabwe rekindled the memories of the oppressive days of former president Robert Mugabe.

"The use of the Zimbabwean military to respond to political protests, or the use of the police force to disrupt press conferences, does not signal a new era. Rather, it echoes a dreadful past," he said. "After decades of misrule by Robert Mugabe, Zimbabwe deserves to have a government worthy of its people." Flake was in Zimbabwe to observe the elections and said that on July 30, citizens walked for miles for the chance to cast a vote that mattered. "During my visit to nearly a dozen polling stations scattered throughout rural Zimbabwe ... I saw representatives of Zanu-PF and MDC-Alliance sitting together, chatting amicably and helping each other keep proper tallies," he said.

He emphasised that the recently held elections presented Zimbabwe with an opportunity to break from the past. African News Agency

frican jewellery is known for its quality and beauty all over the world.

There are many types of African jewellery's such as pendants, bracelets, earrings, necklaces, and other types of tribal African jewellery. Jewellery made from Africa can be great gifts for men, for women even for children.

We all know that the continent of Africa is the birth place of human and mankind civilization. It is also the place where people first wore and made jewellery.

Did you know that in Kenya more than 40,000 years prior, beads were produced using distinctive materials and more often than not wood and diverse stones were the principle materials. As time proceeded African skilled workers enhanced and built up their adornments making procedures and today those results to the most beautiful jewellery in the world.

The oldest African jewellery was discovered in 2004, in the place called Blombos cave on the southern tip of South Africa. Those jewelleries are estimated at being over 75 500 years old and most of them are pea-sized or mollusk shell beads that had been pierced a long time ago.

Throughout history Africans have tended to develop their work and they have started to use different organic materials and other materials that were readily available and suitable in their region to create their jewellery.

Africans use different materials to make their products.

First they started with those materials that they used to find in nature and then as the time moved they started to make different combinations and today they use almost every material for their jewellery.

It is very interesting to know that jewellery may indicate an individual's power, wealth and of course their standing in the society. The materials that Africans use today range from sea shells, beads to gold and silver and even materials that is used to make clothing.

Some materials to make handmade African jewellery include amber, carved stone, glass, wood, paper, wood, ivory, animal hair, egg

shells, bone, sea shells and a lot of other things. A long time ago African people have cherished different beads and appreciated a lot of their heauty.

They have always made beautiful jewellery of various materials, perforated, beads are small and often rounded small objects found around



In some elements of Africa, a person's wealth is measured by the number of livestock he owns. As soon as livestock is killed regarding food, every part in the animal is used. So the bones usually are crafted into jewellery for them to be used for a thing. They believe that if a person is wearing many bits of bone jewellery, he may be pretty wealthy and lucky.

AFRICAN JEWELLERY MAY HAVE BEEN THE FIRST TYPE OF JEWELLERY

Historians have found the first signs of







jewellery ever being worn in Africa, almost 75,000 years ago. Shell jewellery found at Blombos Cave, Cape Town, was made from sea snails, whilst jewellery made from ostrich eggs has also been found, dating back around 40,000 years.

Many types of jewellery have meanings Rather than just being a part of African fashion, jewellery has different meanings, especially African beads, which come in a wide variety of colors. Different colours mean different things, relating to things like social status and wealth.

Red beads are used for tribal festivals, celebrations and rites of passage; black beads symbolize age and knowledge; yellow beads are used to identify a person who is of a high rank; and gold is for a long life. Bone jewellery also identifies a person's social status, as each piece is created from an animal that has been killed for food. A person with a lot of bone jewellery can be considered wealthy.

AFRICAN JEWELLERY CAN BE MADE FROM ALMOST ANYTHING

When it comes to creating jewellery, Africans will use everything they have access to. For this reason, African jewellery can be made out of a wide variety of materials, from bone and shells to animal teeth and hair. Some jewellery will be made out of just one material, whilst others will combine a number of them for a really interesting and eclectic look (LALIBELA).

Africa craftsman continue to produce beautiful traditional bead work unique to their region or tribe. Often this is for sale to tourist and through online websites. There is also a lot of African inspired jewellery produced that is often unique and stunning. Producing and selling beads has been a major source of income for many of the tribal people of Africa.

Cowrie shells have an ancient history in Africa and are prized for their durability and their shape symbolizing female fertility.

Tribal African jewelry is dependent upon three things: What is available locally, what has been traded and bartered for over the centuries and what the customs and traditions are in the different cultures.

Beaded African jewelry can give out as much information as is written or spoken, it has its own language and much can be derived about history, culture and status. In southern and eastern Africa, most inhabitants can wear beaded refinement but in Yoruba culture it is confined to rulers and in the Cameroon, beads are an expression of privilege.

Bead culture, hugely and enthusiastically adopted by many tribes, is a relatively new one in Africa. The earliest known Maasai and Samburu items are dated around 1850; large red beads that were taken back to Holland.

With the introduction of small, colourful glass beads from Italy and other parts of Europe, a whole mythology built up around the beads with colours and band or block patterns playing a significant role. Neckbands became the primary piece of African jewelry for men and women.

African gemstone jewellery is surprisingly

less popular for using its precious stones that its earth is so rich with, as it is for its semi-precious stones of which there are vast resources of. Stones used by African artisans include turquoise, lapis lazuli, sapphires, emeralds and rubies as well as topaz, amethyst, rose quartz and moonstone.

Diamonds are culturally seen as devoid of colour and were not traditionally favoured by the indigenous people of Africa.

African jewelry is interpreted in many ways in the contemporary fashion world. Black models are very in vogue and tribal adornment embellishes and enhances many necks and bodies of all races.

Today jewelry manufacture has become an art form and a way to express one's personal-

ity, a form of individual expression.

Since 'jewelry' is derived from a Latin word 'jocale' which means 'plaything' we can see that historically it has been used as a form of adornment that gives pleasure and status to its wearer.

With access to beautiful stones, precious metals and other unusual material source like fossils and ebonised wood, there has been an explosion of phenomenal design in the jewellery world.

Creativity is at an all time high.

Many cultures in Africa historically used jewellery as a sign wealth, power, and their standing in the society. For example, Fulani


women in Northern Nigeria acquire their wealth through jewellery (often large gold earrings, and bangles) gotten as dowry and through trade. Also in the beginning of the fifteenth century, the people of equatorial Guinea used gold and ivory and traded it for glass beads, copper, brass and coral. In Benin, people of royalty wear hip ornaments made from brass that is worn for very special events.

The popular Zulu bead jewelry has plenty meanings beyond just fashion and style. For example, the design and colors on the bead jewelry send messages between men and women on marriage availability. A particular beaded necklace worn by women may let men know that she is unmarried. In other instances, if she's married a different design is worn. Some examples of colors and their meanings include blue for faithfulness, white for love, and yellow for wealth.

In the Maasai culture, Red stands for bravery, unity & blood, White stands for purity, peace & health, and Orange sends out a hospitality message.


Till date, most African jewelry is handcrafted.














NOMZAMO MBATHA -QUEEN OF THE AFRICAN EVERYTHING





WHEN JUSTICE SERVES ONLY A FEW!

...Perhaps, that's what has won over my interest about the poor guy from Kubuta. A gentleman who has relentlessly and vigorously fought for justice. Shall I hasten to add, even if unsuccessfully so.

HARLES Myeza. I do not personally know the gentleman, yet it seems like I have known him as my next door neighbour.

In fact, just the mere mention of the name Charles Myeza brings memories of one desperate man who has hit against the brick wall wherever he has gone in search for justice.

Perhaps, that's what has won over my interest about the poor guy from Kubuta. A gentleman who has relentlessly and vigorously fought for justice. Shall I be hasten to add, even if unsuccessfully

I like the courage, vigour and determination he's shown in pursuit for justice, only if he lived in another coun-

I will get to the latter part at a later stage. But for now, it's only fair that I tell you the brief I know about Myeza.

I know he was a police officer who travelled an uncharted territory of owning business while still employed.

I say unchartered because Myeza was a smart officer and he ran not just a business but a successful one. How he made it successful perhaps is catered in the part about being a smart officer.

Yet, perhaps, it was the very reason that won him over enemies, from within the police force and government. Yes, in Eswatini you sometimes pay dearly for being too smart for the liking of many people. It's true, but that's



a subject for another day.

So, as Myeza's business flourished thus the attraction of many unwanted enemies who did not like what they saw. Obviously, knowing the world of policing, Myeza was becoming too big for his boots and was obviously ruffling feathers.

However, to prove he's such a fearless police officer, Myeza went on to win the national elections and become a Member of Parliament for Kubuta. He served as MP during the 2008-2013 term for the 9th Parliament, toppling former Minister of Health Njabulo Mabuza. It was during this time that

Myeza as a legislator was charged with theft of over E600 000 from the police service. He was later to be found guilty of the offence, in which he is said to have siphoned money from the police service using his company.

The former legislator and his company, PPC Electrical were found guilty of fraud, forgery and uttering by High Court Judge Nkululeko Hlophe. That marked the beginning of his troubles with justice in the country. I have absolutely nothing wrong with Myeza being taken through the justice system and found guilty for his wrong-doings.

However, it has made me curious how

the guy has tried to fight and defend himself in court - unsuccessfully so.

Since his conviction and sentencing, Myeza has been to all courts in the country trying to fight his indiscretions. It makes you wonder if the playing field in our justice system is entirely level for everyone concerned.

I'm not suggesting Myeza should be given what's undue to him but it's peculiar if the same individual goes to all courts in the land - even the highest of them all - yet find no justice.

It triggers a lot of thinking, if really Myeza is that dumb not to see that the matters he is pursuing in court are dead rubber or if he's so blinded by his pursuit for justice that he's even lost focus.

It has made me suspicious really, and I'm pretty sure I'm not the only one who's had this question in mind.

What's even more suspicious is that we are living in a country where a High Court judge recently threw a tantrum, cursing everything under the sun in the country's justice system and even threatening to spill beans.

As if that was not scary enough, the same judge comes back the following week and apologises for losing his mind.

However, what's even scarier is the fact that the matter as it appears is being tip-toed around by the echelons of the country's justice system, especially the Chief Justice. It makes you wonder if what the judge said really carries any weight or he hit the nail on the head.

You would expect that the matter was pursued and the judge concerned taken to task - even if it means being sent home. But NO, I would not be surprised to find that he was coerced to make the apology in order to massage egos of certain people.

It's no small feat by any means, for a Judge of the High Court to make such a damning statement, yet it seems normal within the justice system and the matter is spoken of in hush tones.

Or is it because the things alleged by the Judge are best being swept under the carpet. If that's the case, then how many more rot is being swept under the carpet at the High Court.

It's a huge dent for the highest court of the land, hence we are inclined to question if the playing field is level for everyone - Myeza included. He deserves justice like all human beings.

The latest court ruling which saw his effort to c' "nge his participation in the ongoing sections thrown out must be seriously hurting for the man. Not to mention the financial effect that comes with approaching such a court for a reprieve, yet the outcome is an open secret.

That's why I salute Myeza, he's a brave man indeed. Give the man a break, he's already served his punishment - why must he be made to suffer twice for the same offence.

The subtle art of saying everything, nothing at the same time

The title of this article may ruffle a few feathers, and perhaps it is a bit mischievous to do so, but it is exactly what is currently happening with statements related to amending the Constitution to allow for expropriation without compensation.

The recent statement by President Cyril Ramaphosa after the ANC lekgotla caused quite a reaction from commentators as well as from markets. However, if you dissect exactly what was said it becomes clear that the statement was carefully crafted so that it could mean multiple things to multiple people.

To say everything and nothing at the same time is far from an insult, quite the contrary. What the president attempted to do was to couch the language in such a manner that it could appeal to both sides of the debate on expropriation without compensation without straying too far from the party's original decision back in December (which in itself attempted to appease

both sides).

Without wanting to downplay the importance of the statements made, we must be cautious not to fall into the trap of only hearing what we want to hear.

Cast your mind back to the ANC's elective conference in December

Stated

The chairperson of the economic transformation committee, Enoch Godongwana, stated that the meeting resolved to amend the Constitution to allow for expropriation without compensation subject to the proviso that it must not endanger food security or other sectors of the economy, and that the ANC will further deliberate on the detail of how this is to be done.

This announcement stimulated the debate which eventually led to the National Assembly's decision to mandate the Constitutional Review Committee but that was not the only level of debate taking place.

The public hearings led by the Constitutional Review Committee



have been largely dominated by people's aspirations and desires as ordinary members of the public have been coming forward to have their say. While this is their good right to do so, many members of the public are not constitutional law experts and therefore often conflated the notion of expropriation without compensation, and indeed land reform more generally, with an amendment to Section 25 of the Constitution.

At the same time, intellectual debates have been taking place on less conspicuous platforms as to what the actual content of Section 25 means and how an amendment would affect the qualifications around food security and the economy. Because the extent of 'just and equitable' has never been tested, the debates are largely based on calculated estimates rather than clear cut legal facts.

It is therefore small wonder that prominent legal scholars cannot agree on whether or not the current provisions would allow for zero compensation, but a number of interesting arguments have surfaced. Some argued that it could be just and equitable to award zero compensation in terms of Section 25(3) when the right set of circumstances presented themselves.

Others argued that just and equitable compensation under Section 25(3) cannot be zero but concede that Section 25(8) read with Section 36 could allow an owner's right to compensation to be limited is it is reasonable and justifiable to do so in the circumstances. News24


Such a long walk and struggle is definitely not a walk in the park but calls for well strategic intervention. Like building a high building, let us ensure that there is a firm foundation for the future.

he integration of indigenous knowledge with development is long overdue; unfortunately, thus far policy makers have dismissed the significance of this

As they are preoccupied with defending their western education and religion, which has stripped them off their indigenous identity. They have been preoccupied with mimicking western knowledge and religion, eager to prove how sophisticated they are. However, they are proving to the western world, whilst leaving out the majority of the people they lead within their countries of origin. This mimicking, cut, and paste of western knowledges and religion, has resulted in the western leaders and policy makers, not taking Africa seriously. Evidently, when you are cutting and pasting, indicate a lack of originality, hence, the western world does not take this continent seriously. How can they take copycats seriously, who are negating their own indigenous context while failing dismally to implement these western policies and governance systems? The integration of indigenous knowledge and development is necessary; this requires restoring indigenous dignity, critically reviewing whether the state is indigenous. This requires public policy makers to accept that they have no monopoly of the state, and African problems require indigenous solutions for sustainable development towards the African we want Agenda 2063.

IS THE STATE INDIGENOUS?

Yet, the fundamental question on whether the state indigenous becomes imperative and critical for the integration of indigenous knowledge and development. am not stupid to approach a state that only recognises Christianity as the sole religion, when it practices African religion embedded within culture and tradition. Which is the baseline required to argue for the integration of indigenous knowledge and development, as developmental education must be holistic and contextualise the reality of learn-

Nevertheless, this state has been probing my thoughts on whether it is indigenous, when it fails to implement the contributions of Sibaya system of governance. How can the state, ignore the highest policy making body, as per the constitution, maybe it is because the state is not indigenous. The state is disconnected from indigenous governance systems such that when we actively participate in these structures we are irrelevant to its objects and nothing but a big joke. These thoughts became profound in my mind, I asked when does the indigenous governance systems talk to the government, and it dawned to me this occurs in parliament.

As parliament is constituted through Tinkhundla indigenous governance system, which is the core anchor of public policy makers. However, when the state represented by cabinet, does not believe that they are responsible or answerable to parliament, then how can we say this state is indigenous.

Members of Parliament represent the indigenous people of this coun-

try, and when the cabinet does not report to parliament, it is certainly above the people. Therefore, we ask how members of parliament, represent the indigenous state, when it disconnected from the people. The indigenous state anchored through Tinkhundla and Sibaya indigenous systems of governance. The state becomes problematic when ignoring the people whom they are required to serve, thus creating intractable problems of modernity. As this state will pay allegiance to the head of state and his family, while creating a major disconnection between head of state and the people. This manifests in impossible intractable problems of development, eroding the indigenous dignity of the people, indicating the state is not indige-

INTRACTABLE PROBLEMS OF MODERNITY

When dealing with the state whose core is not rooted within the context of its people. Then intractable problems of modernity manifest and this becomes a vicious cycle, eroding indigenous dignity. Thus clearly indicating that the state is not indigenous, its core is rooted within the individualism of western

Whenever the state is in trouble, its solutions will come from the 'motherland' as it does not believe there are local solutions to these intractable problems. These 'international best practices' are imported and imposed on a state that is physically located within an indigenous context. Ignoring this indigenous context as the state does not believe in its own indigenous knowledge systems for solving intractable problems.

Communities continue to exist without the state, as they have indigenous knowledges on how to solve these intractable problems. They find solutions that are rooted within their context, such that they are able to solve their problems using their indigenous lens. However, when the state captures the communities through handouts and social grants, then communities disconnect themselves from their indigenous knowledge. They develop a dependency syndrome, indicating how they have lost their power and rendered themselves state captives, as recipients of handouts and social grants. This is how the intractable problems of modernity become dominate culture, when communities develop dependency syndrome. They cannot function without the state, which enjoys the power to manipulate and control communities when they are vulnerable.

Yes-global climate change is a contributing factor, to community dependency syndrome; however, communities have uprooted themselves from all their indigenous knowledges. Knowledges that enabled their ancestors to survive historical calamities, but present day communities are not willing to try. As

they are captives of the state and active participants in creating intractable problems of modernity. Hence, we required the Sexual Offences and Domestic Violence Act, a significant indicator on how indigenous dignity is eroded. There are fundamental indigenous knowledges that communities have disconnected themselves from, which nurture the behaviour of males and females. The Tinkhundla governance system provides an excellent base for ensuring that communities take charge of their lives, at a chieftaincy and constituency levels. We have Gogo centres as existing infrastructure to provide children and youth with the knowledge of eDladleni, eGumeni and eSangweni, the indigenous dignity centres that must deal with the intractable problems of modernity.

CONCLUSION

In conclusion, as urban development specialist integrating indigenous knowledge and development is my passion. For, I am continuously preoccupied with the question on who are these people that will utilise these developments we are financing through loans. The roads, the buildings, water infrastructure, telecommunication and all developments that contribute to economic development and growth. If our indigenous dignity is eroded as all indicators reveal, and the state is not rooted within the indigenous chaos, then what chaos are we creating for the future generations.

As the eMazimu and Chakijane that were encountered by our ancestors are still active within our psyche, and they strive on intractable

Our ancestors encounter was different from us, as they were rooted within their indigenous context, applied indigenous knowledge to solve intractable problems. My question is if we do not integrate indigenous knowledge and development, what future are we creating for our progeny. Alternatively, should I ask, do we wish our future progeny to have a future or do we wish to be the last emperors? Yet we are planning agenda 2063 the Africa we want, whilst we are excluding indigenous knowledge, eroding our own dignity and exacerbating intractable problems of modernity.

However, before young people are placed in a work environment, JA Swaziland takes time to capacitate young people with the much needed knowledge on what it takes for an individual to be a successful employee, thereby leaving a lasting impression with potential employers in the five days of attachment.

This week, JA Swaziland managed to host this training for young people and today we shall briefly discuss the course content, and share some testimonials from young people who attended the training on the kind of skills they were able to gain.

The first skills that young people were able to discuss through the training were listening and communication skills. In a working environment, communication is always key between colleagues to ensure understanding of tasks that each individual is responsible for. It is therefore important that young people are able to express themselves clearly in a manner that can be understood. Listening to instructions is just as crucial and asking for clarity where one does not understand is very important.

The second set of skills that were discussed with young people entailed planning and eviluating the plan after implementation. Being in a working environment entails executing different tasks on a daily basis to attain the overall organisational goals. This therefore means young people should be able, during their five days' attachment, to plan their activities according to priorities. The most important activities should be placed as a priority and executed first. At the end of the day, young people should be able to evaluate their progress. They should be able to go back to their plan and ascertain if planned activities were executed and how much progress was made.

During the training, young people were also capacitated with problem solving skills and also the use of information technology for research. Young people were encouraged that when there has been a difference of opinion in the work place which may result in a conflict, it was

Zandile Hlandze from Maphilingo High School: "When I first heard the news that I have been one of the lucky students to be chosen for the work readiness programme, I was very excited.



art of being human is occasionally becoming angry.

Expressing anger in a healthy way can be beneficial for mind, body, and soul. The ability to release pent up frustration in a constructive way such as with yoga, meditation, sport or even an engaging hobby enables us to positively redirect the stress which causes anger. With today's world running at such a fast pace it is not uncommon to have problems with temper, many of us have experienced losing it at the wrong time. I also include myself in this last statement. I remember going

to the phone company once, and freaking out because they had disconnected my phone when I had paid the bill. I felt like such an idiot afterwards.

The question here is how often do you lose your temper and how

severe are the episodes?

Transference and projection of anger is one of the most common problems. We transfer and project anger onto one another without really understanding the damage it causes. We distance those we love, lose friends, and alienate family. Often we don't even know where the anger comes from, we just feel angry. The thing about becoming angry is no one is exempt from it, if you are human you can become angry. The issue here is, are you in control of your temper or is your temper in control of you?

Acting out and blowing off steam because of a bad mood, is common, quite frankly in that moment when temper flares caring about how ones anger affects anyone else is usually less than a consideration! The unfortunate truth is that the person most privy to a temper tantrum such as this is someone close. No matter what variance anger takes whether it is passive aggressive or blatantly aggressive taking responsibility for that anger is crucial otherwise one runs the risk of projecting it on to some innocent party such as a partner, child, co-worker, or even a pet. How often has the family pet ended up the brunt of someone's anger? Projecting anger onto others causes misunderstanding, malcontent, and communication breakdown.

Divorce statistics are full of couples who were unable to interact with one another with nothing but anger and dissension. Many of these self same people came into the marriage with anger issues rootopportunity to receive training that has painted a picture for me of what I am to do in a working environment. I am now aware that I should be able to plan my activities and execute all the planned activities for each day. I am ready to communicate well within the institution that I will be attached to and most importantly I am ready to accept feedback and grow from the entire process."

Wanele Magagula from Nkiliji High School: "I was not quite sure as to what I would gain from a training before my job shadow programme and having gone through the process, I realise that I really needed to go through the training. When we got the opportunity to role play an interview set up, I was taken aback, and I had no idea that a job interview is so extensive. It has opened my eyes into realising that it is very important for an individual to understand their skills and be able to convincingly share them with the next person with the hope of being dimmed a perfect match for the job. I have learned a lot and I am convinced that the skills I have will assist me in my adult life."

Lindokuhle Mashaba from St Francis High School: "I feel like a completely different person now that I have under gone this training. I am much more confident and self-assured as to how I am supposed to fit in the adult world of work. I am armed with my planning skills, I know that I have to apply my thoughts in my responses because they tell the next person the kind of person I am. I was also able to gain resume writing skills and I get to go home with my first ever resume. I feel like I am way ahead of my peers right now as I am armed with skills for success."

CONCLUSION

Investing in the lives of young people through training is always a worthwhile initiative.

Young people are the future hence they need all the skills that will ensure that they perform at their best. A motivated work force directly translates to improved production which intern feeds into the development of the economy. It is therefore important that young people are guided through the process of choosing a career path that will take away the most active years of their lives.

ed in their past. These married couples point fingers at one another when in reality their partner merely reflects back to them an issue left long unresolved within their own history. It is common place to bring childhood anger issues into a marriage.

he Eswatini Tourism Authority (STA) and Sense Africa's fruitful partnership over the years has seen the latter being more than just a tour operator dedicated in showcasing the kingdom as a prime tourist destination to the global community.

This past month, July, Sense Africa brought four groups of volunteer tourists' students from the UK to the Kingdom of Eswatini for more than just sightseeing but charity work. According to Sense Africa's Director, Jenny Bowen, three of these have been from St Helen and St Katharine High school, in Abingdon, Oxford, UK. Remarkably, these are teenage girls between the ages of sixteen and eighteen, which means they have just completed their IGCSE's and doing their A-Levels, Bowen said.

Sense Africa's volunteer tourists' students builds playgrounds for eNhletjeni pre-schools.

Last Thursday, the latest of the four groups to be brought to Eswatini by Sense Africa partook in the building of playgrounds for the underconstruction Madacaza and Mboweni pre-schools.

According to Jenny Bowen, Sense Africa's Director, this is the third group from St Helen and St Katharine School that visited the country this past July.

Worth noting is the fact that they are also an out-reach tourists' group that contributed cash amounting to E51 000 towards the building of the playgrounds that boasts jungle-jumps and swings for both pre-schools.

The pre-schools are being built by The Shamba Trust in conjunction with Hands-in-Hands. The former is an organization committed to initiating self-help projects in remote disadvantaged communities to mitigate the effects of the HIV/Aids pandemic through early child development.

The latter is also a local organization dedicated to the same cause as The Shamba Trust: building preschools and care-points to capacitate children with modern-day literacy skills at a tender age.

believes that such initiatives by her organization are worthwhile contributions to the society.

Sense Africa has been involved in numerous charity projects in the monarchy, and the eNhletjeni project has been the tour operator's latest philanthropic aids to the Eswatini nation.

The tour operator is an interna-

tional tour operator from the UK working with the Eswatini Tourism Authority (STA) to showcase Eswatini at the global stage as a prime tourists' destination.

ny woman who would ask a man to lie with her, even by today's base standards, would be considered very loose. Ruth, an idolatress - born and bred - stalked Boaz, and when he fell asleep she moved cosily close to him.

Boaz was startled to find her lying next to him; but what's worse, she asked him to cover her with his blanket. Her intentions could not be more obvious. But wait! This woman is an ancestress of our Lord and Saviour Jesus Christ; she was the mother of Obed, the father of Jesse, who sired David, the King - after whose name Jesus is called Son of David.

But even worse, Ruth was a Moabitess. What? Does something ring a bell? Yes, you guessed it right - Ruth was a descendant of Moab, the son of Lot whom he sired from one of his own daughters. Genesis 19:30-38 recounts the incestuous affair between Lot and his daughters, who were determined to preserve their father's bloodline;

Now Lot went up from Zoar, and lived in the mountain together with his two daughters, for he was afraid to stay (any longer) in Zoar; and he lived in a cave with his two daughters. Come let us make our father drunk with wine so that we may preserve our family through our father." After the encounter, the first born gave birth to a son - Moab, who later founded a nation called the Moabites. The Moabites were a nation of outcasts, who, while being descendants of Lot, Abraham's nephew, were banned from the 'congregation of the Lord' because . heir hostility to Israel. King Eglon, who fought Israel for eighteen years, was killed by Ehud, the judge (Judges 3:12-30).

Saul fought the Moabites; David fought them; while Solomon, to the Lord's chagrin, married their women and built a shrine to

their god, Chemosh.

The prophets of Israel spoke against the Moabites. But Ruth, through what appears to be very clandestine means to the human mind, still somehow became an ancestress of the Prince of Peace. Indeed God qualifies the unqualified.

The story of Ruth, from the viewpoint of the canal observer, cannot get any worse; when Ruth made the pass on Boaz, she had been the widow of one Mahlon, the son of sojourners Elimelech and Naomi, who left Bethlehem and went to live in Moab at the height of the famine. When her mother-in-law, Naomi, decided to return to Bethlehem after the death of her sons and husband, Ruth insisted that she would go back with her, in spite of Naomi's entreaty that she should return to her people and god.

They arrived in Bethlehem just at the beginning of the barley harvest. Ruth went out to glean for the purpose of procuring support for herself and Naomi, and it was while she was gleaning upon Boaz's field, that she met this nobleman, a kinsman of Naomi, who later married her, according to the right of a nearer redeemer. In the process of time, Ruth became the mother of Obed, the father of Jesse and grandfather of David, a descendant of Christ.

GOD LOOKS AT THE HEART

Even though she may not, at the time, have known the full import and outcome of her decision to remain loyal to Naomi, Ruth sowed kindness and reaped abundant blessing as she became the great grandmother of King David and had a place in the genealogy of Jesus.

Ruth 1:14 'Then they wept aloud again; and Orpah kissed her mother-in-law (good bye), but Ruth clung to her. Then Naomi said, "Look, your sister-in-law has gone back to her people and her gods; turn back and follow your sister-in-law." But Ruth said, "Do not urge me to leave you or to turn back from following you; for where you go, I will go and where you lodge I will lodge. Your people will be my people, and your God, my God.'

Ruth's conviction brings to the fore very profound Godly principles. When we sacrifice our best for another's welfare, God rewards us.

Ruth's desire to stay with Naomi not only lightened Naomi's load, but it also brought Ruth into the Messiah's ancestral line. But most importantly, Ruth chose the God of Israel, the God of her motherin-law over the idols of the Moabites, her people.

Another very important principle is brought to bear; when we love God's people, we are staking a claim with God Himself.

Then the King will say to those on His right, 'Come you blessed of My Father (you favoured of God,

appointed to eternal salvation), inherit the kingdom prepared for you from the foundation of the world.

'For I was hungry, and you gave Me something to eat; I was thirsty and you gave Me something to drink; I was a stranger and you invited Me in; I was naked and you clothed Me; I was sick, and you visited Me (with help and ministering care); I was in prison and you came to Me (ignoring personal danger).'

Then the righteous will answer Him, 'Lord, when did we see You hungry, and fed You, or thirsty and gave You something to drink? And when did we see You as a stranger, and invite You in, or naked and clothe You? And when did we see You sick, or in prison, and come to You?

"The King will answer and say to them, 'I assure you and most solemnly say to you, to the extent that you did it for one of these brothers of Mine, even the least of them, you did it for Me(Matthew 25:34-40)." God extended His protection to Ruth even though she was a foreigner and a member of a nation which had been the enemy of God and Israel (Numbers 22-25).

The story of Ruth demonstrates clearly that God will always raise

he Kingdom of Eswatini agrees with the rest of the world: discrimination against women is bad and something has to be done about - ultimately gender equality is good for everyone.

To demonstrate commitment, in 2004 we ratified the Convention on the Elimination of all forms of Discrimination Against Women (CEDAW); adopted a constitution recognising equality and women's rights in 2005 and a National Gender Policy in 2010. In 2012 we ratified the African Women's Rights Protocol; thereafter we committed to the post-2015 Development Goals and recommitted to the SADC Gender and Development (Revised) Protocol in 2016. Gender equality is also a central pillar in engagements with the EU, Commonwealth and other development bodies. When a country ratifies such agreements, it binds itself to take action to implement the provisions of the agreement by protecting, respecting and fulfilling the rights therein - through policy, law and other measures. The current electoral process is sharply exposing the lack of progress. But it is also providing an opportunity to craft actions for the next legislative term. Reports indicate that despite the monarchy's encouragement, EBC effort and NGO advocacy, numbers of women nominees are low. There are concerns that this might translate into low numbers of elected women in all three elective offices, and in turn portends difficulty in prioritising gender-equality. Regardless, parliament will still have a duty to play its part in eliminating discrimination and promoting gender equality. Some immediate former MPs acknowledge that the 10th parliament "failed." It is hard to disagree. Parliament contributed to notable achievements such as the amendment of the Public Order Act, Suppression of Terrorism Act; restoration of AGOA status; and recent enactment of the Sexual Offences and Domestic Violence Act.

Nonetheless, an objective account based of parliament's actual functions would find a severe deficit in the promotion of gender equality. This leaves a challenge to incoming legislators to do better. The 11th Parliament has the mammoth task of restoring socioeconomic and political stability while pursuing the ambitious goal of first world status, and implementing development frameworks, visions and commitments that Eswatini is a part of. But parliament cannot succeed on its own - other stakeholders must also play their part.


A woman, under pressure from her in-laws and community to observe mourning rites, was forced to leave both her marital home and employment at local grocery shop, despite the family's agreement prior to her husband's death, that due to her religion, she would not. The case stands out for, amongst other things, the gap between law and practice and the need for political will. The chief and Indvuna of the community, were at the time of the case, both Cabinet ministers. The constitution's section 28(3) allows women choice in undergoing customary rites, yet she was told, "that is just a paper from Mbabane that has nothing to do with us." Dismissiveness towards the country's obligations violates rights and ultimately affects development of the very communities chiefs administer. Culture and tradition are the pride of the nation, and are central to the identity of emaSwati - we need a national conversation about what this means in the 21st century.

"Independent" justice-delivery structures/ institutions

Without getting into the judicial activism debates, it is inconceivable that a judiciary of the 21st century in a constitutional dispensation in which the courts, as "ultimate

MAKING THE PROMISE THE REALITY: ELIMINATING DISCRIMINATION

Interpreters of the Constitution" and are enjoined to uphold and enforce the bill of rights, would issue regressive judgments. Yet, during the constitution's 12-year operational life, women have struggled to assert their rights through the courts. Nonetheless, decisions such as those in the Doo Aphane case on land and Sihlongonyane case on marital power that examined the import of the constitution's articulation of equality women's rights are encouraging because they suggest the potential of the judiciary to grow in this area.

The Commission on Human Rights is mandated to investigate and take appropriate action where violations of human rights are alleged. Discrimination is a violation and has also led to egregious violations against women and there is an expectation for the Commission to act.

But its effectiveness will be continue to be hampered so long as there is no legislation (that complies with the Paris Principles) governing its operations.

These structures are often confronted with difficult questions at the intersection of constitutional rights and culture and tradition. Nonetheless, their designation as "independent" requires them to ensure non-discrimination in the delivery of justice, including enabling access, particularly for the poor, the majority of whom are women.

Civil society holds itself out as the "voice of the voiceless." However, it seems that in an effort to cultivate good relations with government, the "watchdog" aspect of civil society work is severely compromised.

It is said this approach emphasises collaboration over confrontation, as an adversarial approach alienates those that advocacy seeks to influence. There is nothing wrong in seeking constructive engagement with government, but when such initiatives suggest ingratiation and co-option, the cause suffers. CSOs now shy away from pointing out what is wrong and in calling for accountability. Successfully tackling discrimination needs strong, independent voices to call out political laxity, lip-service and delayed justice.

● Faith-based organisations and religious leaders

The question of religion and gender equality remains enduringly

contentious. Religion has been used in women's subordination, with the justification male superiority and female inferiority is the "natural order" of things by the Creator. This view continues to be expressed, for example, by elements of the Christian faith while others assert that the creation narrative clearly teaches that both female and male are a creation of God(Genesis 1:27). It would appear that it is unacceptable to consider one sex better than the other, because by doing so discriminates yet both are made in His image. The influence of faith in people's lives makes it imperative that religious leaders understand gender equality and not perpetuate discrimination.

Corporate sector

Eswatini's business sector is rife with human rights abuses such as discrimination against women. The "Guiding Principles on Business and Human Rights: Implementing the United Nations 'Protect, Respect and Remedy' Framework," comprehensively sets out the applicability of human rights obligations to the corporate sector. This responsibility "applies to all enterprises regardless of their size, sector, operational context, ownership and

structure."

According to the Principles, "States must protect against human" rights abuse within their territory and/or jurisdiction by third parties, including business enterprises;" and "all business enterprises domiciled in their territory and/or jurisdiction respect human rights throughout their operations." This means businesses "should avoid infringing on the human rights of others and should address adverse human rights impacts with which they are involved." Businesses are encouraged to operationalise the Principles by, amongst other things, making the requisite policy commitments and conducting human rights due diligence. Eswatini, business must examine its current condition and identify how it can contribute to ending discrimination.

● Individuals

Promoting gender equality can also be done at the individual level. Everyone can play a part by themselves not being discriminatory nor being passive spectators when discrimination does occur. Eliminating discrimination against women requires active citizenship, which is willing to challenge wrongdoing and hold duty-bearers to account.







ama Mahlelela is a Swazi-Canadian basketball coach, who is currently the head coach for the Raptors 905 of the BA G League.

The mentor, who has been hoisting our beautiful kingdom's flag, took time off his hectic schedule to talk to us on his childhood, the journey thus far and his advice to young people.

He begins the interview by seeking to know the topical issues in the kingdom and of course the standard of the game in the country, and after a few minutes of niceties, we get down to business. Enjoy.

"I was born in the capital city of the Kingdom of Eswatini, Mbabane, at the Mbabane Clinic to be precise. I moved to Mozambique when I was about three, spent about a year there and later on joined my mother in Canada. It was a very interesting childhood that I had if I may say, and of course I was exposed to basketball when I got to Canada and that's where I started with the basics," he states.

Jama then moved back into the country for his high school, and studied at Waterford KaMhlaba. Albeit basketball being his first



love, Mahlalela says he used to play nearly 'all' sorts of sports.

"I was quite active, hey. I was a good athlete because I played everything, not just bas"I got a scholarship to study at the University of British Colombia and all this was through my burning passion and love for the sport. ketball. Your swimming and cricket, I was also involved. Coming back to the Kingdom, Swaziland at the time - was a very exciting period for me.

I was re-uniting with my father and as well as with my roots. I was 13 at the time, and I played a lot of basketball games. I was a bit better than the other children mainly because of my basics in Canada, but I made a lot of friends whom I am still in contact with even today. Again, I was so in love with the school because of the many cultures that were infused there. The education was also open-minded and channelled me to my path," he says.

Upon completing his high school, Jama was awarded a basketball scholarship where he got to study and also play basketball. He then graduated in 2004 with a Bachelor of Kinesiology and the Jama Mahlalela Award was created in his honour.

During his time at tertiary, Mahlalela played basketball for the UBC Thunderbirds. He played for five years, served as a team captain, and helped the team win a Canada West title. Mahlalela graduated from UBC thereafter.

"I got a scholarship to study at the University of British Colombia and all this was through my burning passion and love for the sport. I noticed something whilst I was there and it was my strength as a leader. Like, I wasn't the best player in my team, but I was the captain. There are games where I would not feature, but I'd still be captain, and that's where I saw my strength."

my strength." Mahlalela then started with the Toronto Raptors in 2006 as a member of the community development staff, leading the Raptors Basketball Academy and various clinics throughout Canada. He was named director of basketball operations for NBA Asia three years later and oversaw the League's clinics, youth programmes and elitelevel development from his base in Hong Kong, before returning to Canada for his tenure as an assistant coach in the 2013-14 NBA season

"I didn't just jump up the ladder with Toronto. It doesn't work like that. You have to prove yourself. I started in community development and I cleaned the courts. I gave it my all and made sure that they were perfect and I worked with the same men-

tality and motto. It has been a wonderful journey and I would like to thank all the coaches I've been under for the mentorship and the kind words of advice.

I have leant valuable lessons from each and every one of them and I promise to give it my all and deliver.

MOTIVATION: Your talent and passion alone will not guarantee you success. You need to be dedicated and that calls for scarifies and all. From a young age, I haven't had much time to just laze around and spend on folly things; I am always on my toes. If you want to perfect yourself in any sport, it requires you to eat healthy and also take care of not just the body but the mind as we". IN TOUCH WITH BHEKIZWE MAZIYA

re you a Swazi aged 18-35 and really passionate about entrepreneurship? Well then this is your chance!

The Government of the Kingdom of Eswatini has availed E10 million for the Youth Fund, a fund set up to give loans to young people who prove their burning passion and willingness to start up busi-

Well, upon breaking this news to you last year, your favourite youth section took some time to visit the Fund's current captain Bhekizwe Maziya this past week, and the soft-spoken Maziya simply availed himself and tried to break down the nittygritties of the fund.

The first thing Maziya wanted to point out was that they were looking for passion amongst young people.

"The most important thing that we will be looking out for is passion. We want to make sure that this young person really loves his business.

That will give us surety that he will do whatever it takes to see it succeed. For example, we have a young person who is passionate about music coming through and asking for a loan to start-up a knitting business. That's tricky because when things get a bit tough, he/she will be quick to jump ship because that project isn't in their hearts. So, we urge young people to start businesses that they truly love," he said.

Business

Another thing that Maziya made mention of was the issue of a viable business plan with a proper marketing strategy.

"On top of everything, it is our responsibility to keep you in check as to how and when you will pay back the loan. This is why we will make sure that you have a market for your product and that the market is sustainable. We will ensure that they go and get signatures from people who have guaranteed the support, and all this is done to make sure that we get the money back and keep the fund operational," he explains. Maziya also reveals that they will have mentors to provide business training for all the successful applicants.

"Starting and running a business isn't a joke and we do acknowledge that it is tough. For this very reason, we will start

with business training for all the successful applicants and they will have a mentor in SEDCO who will also monitor their progress and keep them in check," he said. An interesting point I picked from Maziya this time was that the fund was not going to hand out cash or deposit the lump sum, instead the entrepreneur will provide at least three quotations.

"We learn from the last time the disadvantages of giving money to a young person.

We have now decided that each person will provide at least three quotations of what they need and bring it to us, thereafter we will get in touch with the supplier and pay upon delivery of the item. It makes life easier for all of us," he said.

utes are musically engaging. Paternity has been a long-standing source of anxiety for Drake, one that's persisted as he's become exponentially more

From the 'The Resistance,' on 'Thank Me Later', he highlights a one-night stand who wishes she'd kept Drake's baby.

He bemoaned the paperwork that comes with superstardom on 2015's project with Future '30 for 30 Freestyle,' talking about the paternity tests he's legally obligated to complete for women he's never slept with. And the issue resurfaced on this year's 'Diplomatic Immunity,' a song released when his son was just a few months old "I got the sauce and now shorties keep claimin' preggo."

The project invites you to pretend that becoming a dad hasn't been one of Drake's foremost concerns for the last decade.

He makes the disclosure for the first time on the stunning 'Emotionless,' coasting on top of an instantly recognisable Mariah Carey sample "I wasn't hidin' my kid from the world, I was hiding' the world from my kid." He refutes Pusha's claim that he's a deadbeat dad on the opulent '8 out of 10' "The only deadbeats is whatever beats I been rappin' to."

'Scorpion' has a sumptuous sound. With glistening production from his favourites and close friends in '40' and

I love the fact that he revisits sounds from his earlier career, I mean the tough-talking, rap-centric emotional 'Dreezy'. This means that 'Scorpion' is the first Drake album to double back instead of chart a new course, and its conservatism is disappointing given the near-decade he's spent at pop music's front liner.

Splitting 'Scorpion' into two distinct sides—rap and R&B—detracts from his pioneering synthesis of those two genres, but the best songs here don't sound like retreads; they're the most refined possible expressions of familiar aesthetics. Soulful, sample-

centric cuts like 'Emotionless,' '8 out of 10,' and the long-awaited DJ Premier collaboration 'Sandra's Rose' are pure comfort food, a reminder that Drake idolised Kanye West long before they became each other's nemeses.

Sweet

It's on 'Scorpion's Side B that Drake comes closest to finding his sweet spot, that inimitable zone where aromatherapy candles never burn out. The Michael Jackson 'feature' on 'Don't Matter to Me' is a flex—consider how many artists have the funds to clear a sample like that, Jesus!

On the sublime 'After Dark,'- a personal favourite, he upgrades 'Thank Me Later'-era slow jams with filthy, funny smooth-talking and assists from the late Static Major and Ty Dolla

The album ends with 'March 14,' an extended reckoning with fatherhood in place of Drake's usual state-of-OVO status report. He describes finding out about his paternity as "the first positive DNA we ever celebrated," which is both a remarkably unsentimental way to react to becoming a father and hard to believe given the content of songs like 'I'm Upset.'

And just like I had said before the album, I only love the songs where Drake gets emotional and pours his heart out - whether it's about the baby or rappers mentioning his name.






Kolasinac faces up to 10 weeks out with knee problem

LONDON - Arsenal defender Sead Kolasinac will be out of action for eight to 10 weeks after suffering an injury to his left knee, the Premier League club said on Friday. The Bosnia international was forced off during Wednesday's pre-season win over London rivals Chelsea in Dublin after a clash with Victor Moses. Wales midfielder Aaron Ramsey missed that game with a tight calf and will aim to return to training next week, the club added. Arsenal start their Premier League campaign at home to Manchester City on August 12.

Mirallas completes €7.5m Fiorentina move

LONDON - Everton attacker Kevin Mirallas has completed his move to Fiorentina, both clubs have confirmed. The Serie A outfit will have the option to make a deal permanent for the Belgium international winger should he impress during his time in Florence. They will pay a reported €500 000 (£445 000, \$579 000) subject to a medical - to take him on loan for the duration of the 2018-19 season, and should they wish to retain his services, he will cost a further €7 million (£6.2m/\$8m). "Fiorentina wish to announce that we have acquired, on a temporary basis with the right to retention, the rights to the sporting performances of footballer Kevin Mirallas from Everton," a statement from the Italian side read. MCGREGOR TO MAKE LONG AWAITED UFC RETURN AGAINST NURMAGOMEDOV

ONDON - Conor McGregor will return to the Octagon against Khabib Nurmagomedov in Las Vegas in October.

The UFC announced late on Friday night that McGregor and Nurmagomedov will headline UFC 229 on October 6 at T-Mobile Arena in Las Vegas.

Speaking at a press conference to mark the UFC's 25th anniversary, president Dana White fielded questions and then said: 'We have one last thing we want to show you.' A promotional video then played to promote the bout.

It drew rapturous applause from the the watching media and fans, with White adding: "They're not here unfortunately. But the fight is done, October, Las Vegas, it's on ladies and gentlemen."

McGregor will return to the Octagon after avoiding prison on assault charges following his attack on a UFC fighter bus in Brooklyn earlier this year

The charismatic Irishman said the assault was in retaliation to a previous run-in between his team-mate Artem Lobov and Nurmagomedov, who was on the bus at the time of the attack.

The 29-year-old Russian Nurmagomedov later invited McGregor to settle things out in the Octagon and it has now become an exciting reality.

The fight is tipped to be the biggest in the history of the promotion due to the intense personal rivalry and the fascinating stylistic match-up.

McGregor hasn't fought within UFC since November 12, 2016 against Eddie Alvarez and he will be desperate to light up the sport once again.

CASTER MAKES 'DREAM COME TRUE' IN NIGERIA

APE TOWN - South Africa produced another dominant performance on Day 3 of the 21st CAA African Senior Championships, raking in another 9 medals as they extended their lead at the top of the overall table in Asaba, Nigeria at the end of Friday.

Caster Semenya again showed her class by smashing the South African record in the 400m final, storming across the line in 49.96 to become the first SA woman to dip under 50 seconds in the one-lap dash. She broke the previous mark held by Heide Seyerling, which had stood for nearly 18 years. "It's always been my dream to run under 50, and I think it was the right time.

The conditions suited me," said Semenya, who was nearly a full second ahead of her nearest opponent. "For me, it's always about having fun and waiting for the right time to execute." Semenya is set to compete again in the

800m and 4x400m relay events today.

The national squad relay took no prisoners in the 4x100m Relay, charging home in 38.25 seconds, with Akani Simbine, Simon Magakwe, Emile Erasmus and Henricho Bruintjies missing the SA record by just 0.01.

"The more we believe in each other the better we become," Bruintjies said.

The SABC announced to public dismay on Friday that they would not broadcast PSL matches on radio this season following unsuccessful negotiations with the league.

"The minister would meet all role players and try to get a solution to this matter," said spokesperson for the Department of Sport and Recreation Vuyo Mhaga.

"In the main it will affect people in rural areas, the working class who drive trucks and many others who depend on radio to follow the most popular sport, soccer."

In a statement, the SABC said they were only advised on Friday afternoon that they will not be allowed to broadcast league matches in this move that is going to starve millions of South Africans who rely on this platform for coverage of the country's biggest sport. Sport24



DRAMA AS THULANI GULE WINS 2018 INYATSI G2G

YCLING - Seasoned cyclist Thulani Gule was named the champion of the drama filled Inyatsi G2G Challenge held at the Enkoyeni Estate yesterday.
