

However, Prime Minister Sibusiso Dlamini expects to get a new vehicle at the end of his term, which is expected to take place prior to the general elections in September.

The premier admitted that he was not aware of the nitty-gritties pertaining to the type of car he would get but stated that he did not expect people to get, shocked when they saw him driving a new one on retirement, which will be of the same status as for the incoming PM.

He does not even know the value of his current vehicle, as he is only aware that it is a Range Rover, nothing more.

"The car I am travelling in does not belong to a former Prime Minister, it is a serving PM's vehicle, so I will not leave with it," he said, adding that he would take whatever it is he would be given and as such, he was not aware of its size or model.

According to the Finance Circular No. 2 of 2013, "The state shall provide a vehicle to a retiring prime minister and his deputy of the same status as those that are in service. These will be owned and maintained by the government beyond their term of office. On the death of the former prime minister or deputy, the official car shall be sold to his estate at depreciated value."

"I haven't seen any communication concerning my car. I will not be shocked in the event I get one because you (the nation) asked for this," he said, adding how the ministry of public works would be the decider in coming up with the make of the vehicle. Sources revealed that the premier's vehicle, a Range Rover, could cost up to E3 million, a figure which was not confirmed by the ministry as both the Minister, Lindiwe Dlamini, and her Principal

Secretary, Makhosini Mndawe's cellular phones rang unanswered on Thursday and Friday. The premier said his current vehicle was past its usefulness as it had surpassed five years of regular use and as such, and according to government policy, it was supposed to be removed from its fleet.

'Whatever they decide on, I don't care much for it as I will not decide for them because I don't know much about vehicles as I just get in as long as I get to my destination," he said.

Perusal through several websites revealed that a Range Rover which could cost along the region of E3 million was the Range Rover L Autobiography P400e, priced at E2 674 600 before extras.

Others are the Range Rover L Autobiography Supercharged and the Range Rover SVAutobiography Dynamic Supercharged which are both priced at E2 716 200 and E3 248 952 respectively before modifications.

hat may come as good news to ministers; government is working against time to fix their faulty BMWs before the end of their term of office.

According to Ministry of Public Works and Transport Principal Secretary Makhosini Mndawe, some of the vehicles have already been serviced, while others are still being serviced.

"Like any other car, the BMWs do develop some faults and are taken for service and then returned, it is a cycle. Maybe in this situation, in this case around, the cycle affected a lot of the vehicles but it is nothing out of the ordinary, cars develop faults and are taken for repairs and returned. I cannot confirm that all the cars have been repaired but I'm sure there are those that have been fixed," said the PS. Mndawe assured the ministers that

they would be taking home fully-serviced vehicles, saying such was their right, as the motor vehicle allowance provision of Circular no: 2 of 2013 includes running and maintenance

"By the time they vacate office they will all be fixed, we cannot give them vehicles in the garage we have to give them repaired cars. There is no two ways about it, it is not a favour or something, we have that obligation as government," he added.

This follows an outcry by the ministers last month, where they lamented that the end of their term was nearing yet the vehicles were still not fixed. The ministers revealed that as a result government was renting them cars for their official duties.

Government is believed to be spending at least E1 million a month on rented cars for ministers.

This is because the ministers' lux-

However, government's cash flow crisis resulted in failure to pay the dealerships, something that has led to the cars being kept for long periods. This newspape several cabinet ministers are either driving cars rented by government, while others are chauffeured in vehicles borrowed from the Central Transport Administration (CTA) as government has been failing to service their BMWs X5s. Ministers, in an interview with this publication, confirmed that it has been a while since they drove in the luxury vehicles, stating that they were in the garages, while others said theirs were kept at CTA.

"Even mine (BMW) has been away for some time now it is at CTA, they said they were not going to be given

the car allowance as they said we will be entitled to them. I'm not the only one as others are also in the same predicament, we now rely on CTA," said Minister of Housing and Urban Development Phiwayinkosi Mabuza.

Other ministers shared the same sentiments, saying their vehicles were having mechanical faults and needattention and as such they v no longer using them but other vehicles provided for by the government. Minister of Sports, Culture and Youth Affairs David Ngcamphalala said his car had shocks problems and was being fixed at Carson Motors.

"They promised us that they will fix them soon, I was talking to them, they said they have ordered parts. We would be glad if they speed up the process, there are a few day left for us in office. We are quite a lot who have the same problem," he said. Similarly, the ministry of agriculture PS said the minister's car was still in the garage still being fixed.

"Communication with key stakeholders during the project was considered vital. Open communication provided awareness, understanding and commitment to the project, as well as promoting its vision, scope and the implications for both the Swaziland Government and its

In particular, communication was needed to address key inputs and concerns, and early embedding of core messages was required to ensure effective understanding of the objectives of the project," reads part of the communique detailing approach and methodology. Economic conditions considered included revenue or income of the country, gross domestic product (GDP), growth, inflation, unemployment, inflation, unemployment rate, pay equity ratio, monarchial democracy, as well as socio-economic stability.

Despite the increased perks, some of the contents which were done away with from the 2010 circular, included decreases in salary rates for the PM, presiding officers, DPM as well as ministers.

It also did away with interest free

loans which had previously been afforded politicians by government, as well as tax reimbursive allowance, which provided tax exemptions for parliamentarians.

Funeral

The PM said it did not help for one to complain about his package, "Don't complain too much about my package because cabinet had decided well on the circulor (pertaining to circular no. 1 of 2010)."

He said the benefits which he was supposed to get prior to the November 2013 circular on retirement, included medical aid as well as a personal assistant however, the circular gave him too much as per calls by

His benefits include a home, car, state funeral as well as others; "I have no sympathy because the nation did not want that which was done

by cabinet. Presenters during Sibaya all complained about circular one." Of note, despite bearing lucrative benefits for the PM, the 2013 circular excluded all his predecessors as it was deemed forward-looking and did not put into account the issues raised by Sibaya of former premiers and parliamentarians living in deplorable conditions. He advised dissenters to visit the commission looking to review the terms and conditions of the 11th parliament, because nothing would change his package so late in the day, with weeks left in office.

"What I would ask of you, is that you do not complain too much because nothing will change. Even labour laws do not allow for changes in terms and conditions in the absence of consulting with the affected party."

According to the 2013 circular, it came into effect on the date of appointment of the PM, DPM, Cabinet Ministers and Regional Administrators; and the date of swearing in for Members of Parliament and Members of Senate. The premier said whatever terminal benefits determined in the new circular would be effective at the end of the term of the 11th parliament.

Fears over government being ESNPF guarantor

he business community on Friday afternoon, in an urgent meeting held at the Happy Valley Hotel, raised some serious concerns over the governing of the pro-Posed Eswatini National Pension Fund

Section 55 reads, "A loan or collateral support shall not be made to any person or institution, unless the loan or collateral support is secured."

Section 57 (1) reads, "the Fund shall

set by the Board from supplementary contributions, made on a voluntary basis." Sub-section two of the section states that the granting of loans to a natural or legal person, including Government, shall comply with the provisions of Section 55.

Most of the employers gathered in the conference room mumbled and laughed when they learnt that government would be able to borrow from the fund.

Another speaker said she feared that the fund would end up killing businesses when means to sustain it are being made as it would have to hand out loans to government.

Before ending the not more than an hour meeting, FSE&CC President Andrew Le Roux invited all parties who would like to make submissions on the bill. He said they should submit their comments to the FSE&CC offices before the end of business on Tuesday. He encouraged the business sector to make submissions and further assured there that should the bill be passed without considering the submissions then legal routes can be taken. The bill was gazetted on June 21, 2018 and was brought to Parliament on a certificate of urgency, last week

The FSE&CC has submitted that it was not against the conversion but that there had been insufficient consultations on the details of the bill and the secretariat needed to consult its members for it to be in a position to give a definite response to the bill.



ACC speaks out:

CORRUPTION CASES PILING UP AT THE HIGH COURT SINCE 2016

The Anti-Corruption Commission (ACC) has disclosed its challenges and its position regarding the recent probe.

The commission has also assured the nation that the country can win the fight against corruption if all arms of government work coherently in the fight against corruption.

This was revealed by the ACC Director Jabu Phakathi during an interview on the breakfast show on Eswatini TV.

One of the questions that she responded to was why it appeared as though the commission had not been active or carrying out its duties for the past two years and if that meant that there was no more corruption in the country.

Phakathi said the commission continued to strive with its investigations as mandated by the enabling legislation.

"Yes, nothing much has happened after 2016. The nation will recall that the 2016 judgment in the case of the former minister, the CJ said we had failed to make a prima facia case warranting prosecution.

...Punches holes on the probe, stands with AG

The CJ then touched on the key sections of our Act, saying they are unconstitutional. Currently, we do have cases pending applications before the High Court.

Since DPP has appealed the judgment, we are hoping that it will be heard by the Supreme Court," she said.

The pronouncement of the chief justice came as a result of the case between the ACC and the former minister of commerce industry and trade, where the Anti-Corruption Commission was seeking orders to enter and search the premises of Gideon Dlamini, who was the first respondent, with the sole purpose of seizure of properties and consequently arrest them.

Chief Justice Bheki Maphalala said certain sections of the Prevention of Corruption Act were unconstitutional and contravened the principles of natural justice.

He said the sections of the act that empower the Anti-Corruption



Commission (ACC) to enter and search people's premises in order to seize property and consequently arrest them without having notified the person first flies against the provisions of the Constitution which protects the dignity of a person and bars degrading treatment of a person.

Parliamentary probe eroded public trust

he director of the ACC said Parliament has a right to probe institutions under government and ACC is not opposed to a probe if there is a

She said, however, ACC is a law enforcement entity which is also guided by the law in terms of its operations, therefore, the probe on it requires clear policies and processes.

The attorney general opined that when conducting a probe of this nature, there must be no perceived or real conflict of interest, therefore, the probe would be neater if done by an independent body.

"Firstly, institutions tasked with probing the Commission should be mindful as it is a key institution in the governance of any country. Therefore, we should be mindful that public trust is not eroded since a probe is investigating allegations which may be true or false," she said.

SEC internal audit debacle:

We are registered - Supplier responds

he South African based supplier which has been cited several times in part of a Swaziland Electricity Company (SEC's) internal audit has refuted that they were deregistered and further disowned the email listed as their contact on a South African company's website.

In a letter dated July 3, the company, through lawyers Ndlangamandla Attorneys at Law, stated that they sought to clarify and respond to last week's article wherein this publication revealed how an audit report revealed that the company was not registered with the Registrar of Companies in the country either as a local trading company or as a foreign company.

Audit

The internal audit had stated that the company was sought on the internet and when the same search was initiated by this publication, information gathered was to the effect that its status was a deregistration process and no information, other than on two websites which states this was found about it.

"Reputational issue of dealing with a company that does not comply with local trading laws and regulations.

Registration with and returns to SRA also doubtful. To be probed further," reads part of the internal audit.

Further, in another subsection titled Supplier Selection and approval consignment stores (WIP) the report stated that the company's filed documents were attached and a printout of information in the internet was found in the internet about the company;

Identification

"The identification number ties with the one quoted in their invoices and their registration documents (filed by Commercial Services)."

Responding to the Sunday Observer article which stated that the information on the website is only for 2013, the last time this company appears anywhere online, the lawyers representing the company wrote; " (South African company) is a legally registered company with the now CIPC formerly known as CIPRO under the Department of Trade and Industry (DTI). When we find reason to or chose (sic) to prove this then we will do so.'

The South African company, in the letter addressed to this publication, revealed that they were a tax compliant company and have been for years.

The company stated that

their annual returns are in place and their clients have all their contact details where they can get assistance.

"The company's profile and catalogues have constantly been sufficient to advance its course and if we find need for a certain website (as expected by your newspaper) then we will develop one."

...charluzaza@yaho o.com not ours

The company high-lighted several times in the SEC internal audit has distanced itself from an email listed as their contact detail in the South African company's website. "For the record, the charluzaza@yahoo.com email you claim belongs to our client actually does not as that was an agent the company used when registering back in 2008 which is the norm in RSA.

Our clients details are clear to its clientele," wrote the lawyers.

Last week, the Sunday Observer revealed how the email address was listed as a contact for the company as well as of four other entities with different concerns, something which was found to still be the case yesterday evening.

SEC not our only client

The company has refuted that they have only one client.

Through their lawyers, they wrote, "We do not know how many clients a company should have at a particular time as you suggest that SEC seems to be our client's main/only client.

Our client (the company) has several renown partners hence to deliver quality products (SABS) approved all the time to its client, SEC inclusive."

On the other hand, SEC's internal audit report stated, "Observing the sequence of the invoice numbers issues by (SA based company) to SEC for payment, SEC seems to be their major or only

Invoice

Of invoice range 001200-001244 paid in December and January, only one invoice number 001239 is missing from this range."

Further, on a different page, the report stated, "VAT declarations for goods supplied by (SA based company) could not be verified. No declaration forms attached with delivery notes and/or invoices on delivery documentation could not be traced to SRA VAT credit statements.

Supplier is either a middle man between SEC and another company or they are recycling the same stock i.e delivering stock to SEC, taking the same stock somehow and delivering it back to SEC."

SEC owes us for goods delivered in January

MAYOR ZEPHANIAH DISOWNS STATEMENT IN HIS NAME

ayor Zephaniah Nkambule has denied being the author of a press statement from the Mbabane City Council purporting to be from him.

The mayor, yesterday evening, denied that he was aware of the damning press release, which details inflammatory statements allegedly made by Mbabane resident Ndlavela Dlamini, outgoing Member of Parliament Esther Dlamini, as well as former mayor, Reverend Solomon Nxumalo prior to its release on June 29.

This is in line with his stance during interviews where he distanced councillors and himself from the contents of the statement, which sent shockwaves through residents and the municipality alike.

Concerning yesterday's statement which was alleged to have been a council resolution after a meeting on Thursday, the unshaken Nkambule said his assertions still stand; that he was not informed of the first statement and would not have endorsed it. He said he was disappointed by the CEO's tactics of using ratepayers' money to serve his agendas and hide behind councillors. Even

though the call was made before 8pm, he said he had not read the paper as he had been away.

This latest distancing from a press release was similar to the one made on June 29 when approached briefly by this reporter personally.

On the day of the publication of the June statement, Nkambule was found outside the Mbabane branch FNB ATMs going towards the parking lot, facing the circle leading to the municipal council offices and he revealed his shock to this reporter about the contents of the press statement.

Dressed in a Chinese collar purple shirt and black slacks, he stated that he was not in communion with the contents of the council's statement, and further asked not to comment as he was yet to consult on its origins as he was not aware of the author, but was shocked at its intention. Yesterday, a press release headlined, Council Press Statement and signed off, Mbabane Mayor, Councillor Zephaniah Nkambule, revealed that the publicised statements were properly authorised and reflected the position of council as he was also made aware of its contents prior to publication. The mayor was said to have been appraised prior to its issuance to the two print media houses.

Of note, prior to the release of the official statement, the mayor was

The recording was made during a meeting which was attended by Minister of Housing and Urban Development Phiwayinkhosi Mabuza, who was meeting residents from Mbabane, comprising Zone Leaders, ratepayers' representatives, as well as an association of elderly Mbabane residents, Lalufadlana.

Nkambule was asked about the recording's contents a few days after he was elected mayor, during the height of the investigations by the Council in Committee, led by Councillors Sabelo Magagula and comprising former Mayor Sikhatsi Dlamini, as well as Councillor Dube.

He was called on Saturday, May 19 and he categorically stated that if there was such a recording, it was made illegally, without the knowledge of all attendees of the meeting which he was part of.

He went to the extent of refuting a lot of the recording's contents, which he said must have been made a long time ago as a lot had changed, making such statements invalid to be used as reference during Chief Executive

Officer Gideon Mhlongo's sus-

'As you are aware, the balance of power has been restored within council, as there is an equal number of councillors for and against Mhlongo, which makes for healthy debates," he said during the May 19 telephonic

interview with this reporter. As a result, some of his clarifications appeared in the Sunday Observer May 20th edition headlined, 'Mhlongo to know his fate come month end' without reference to the recording.

He had been asked to substantiate if there were eight councillors who sided with Mhlongo against a small clique of four, which, according to his assertions in the recording, he was part of. In the recording, which the Sunday Observer has in its possession, Nkambule can be heard telling the minister that he was not supposed to communicate with Mhlongo, but to consult the because the CEO was hired by coun-

He warned the minister that whatever he spoke with Mhlongo would not be discussed at council level because they would have to come through the CEO, who cannot suggest the agenda.

"In the hierarchy of council proceedings, you, as a politically elected person, your stature is equal to that of the mayor, not the CEO. After talking to the mayor, the mayor is able to table whatever it is you want to say to the rest of the councillors orderly.'

Prior to that, Nkambule warned those in attendance that they were going about the wrong way as they were attacking symptoms of their problems instead of going back to the beginning where things went awry, the day they signed community leaders' powers over to the Local Community Committee, headed by councillors.

In the recording, Nkambule makes it known that even though there is no journalist present as all those in attendance are residents, he can identify, he reveals that there are always clandestine moves to get information of what happens in such meetings, but adds that he does not care as what was being said was the truth.

The recording is one hour 17 minutes, where Nkambule talks uninterrupted for over 20 minutes save for a few interjections, either in agreement or disagreeing with what he

he country has received its E1.4 billion quarterly inflow from the Southern African Customs Union (SACU)

The receipt of the revenue was confirmed by the Ministry of Finance Principal Secretary Bheki Bhembe on Friday.

"We always receive it every first week of the first month of each quarter, the amount is always the E5.8 billion divided by four, which is E1.45 billion thereabout. It is always received at this time, even if I can contact the

Accountant General who manages our accounts she will tell me it has been deposited or it will be soon be received," he said.

The principal secretary said the injection would relieve the country's cash flow situation considering the askew status that was presented by the minister last month in parliament.

The minister stated that government was faced with an acute cash flow shortage in the recent past and it was reasonable to assume that this trend would continue into the medium term.

The minister said for the month of June alone, about E1.1 billion was required to settle priority expenditure that could not be postponed.

Temporary relief as Eswatini gets E1.4 billion SACU injection

Of this amount, E702 million was for salaries for that month and this included payment of on-call allowances of E56 million, while E363 million was for outstanding deductions for pension and cooperatives due in May

Talking about the impact, this will relieve us on the cash flow, you will recall that the minister made a statement in parliament indicating that the government cash flow was not

good. It is bad, however, within the first month of each quarter, it usually becomes better because of the relief we get from SACU," said.

On another note, Bhembe revealed that last week heads of state said they were giving SACU an additional 12 months to conclude the revenue sharing arrangement.

These 12 months will fall in December 2019, this, therefore, means there is no implication of the formula because of the two reasons which are: the budget has already been passed using the old formula and that there is no new formula," he said.



WORKS' TOP OFFICIAL IN HOT SOUP OVER VEHICLE MISUSE AND DAMAGE

fter intense investigations, the ministry of public works and transport has finally found the remains of the government vehicle that was allegedly last authorised to a senior government official who failed to return and report it as per the stores regulations.

Ministry of Works and Transport Principal Secretary Makhosini Mndawe has confirmed the breakthrough and has promised to crack the whip and to leave no stone unturned.

"The car has been found, we are now carrying out the assessment of the damage since we have recently found it. Once the assessment report is out, all the regulations pertaining to the authorisation and reporting of government vehicles will be implemented. This is where we will divulge who was driving it and whether he had the authority and if there was any criminality, it will be dealt with accordingly," he said.

The PS stated that the damage of the vehicle was extensive. He emphasised that the law would be followed to the letter and would like to see justice being done as the ministry was against the misuse of government vehicles.

The ministry has been without the vehicle registered GSD 129 CT since mid-February, after allegedly being authorised by the Deputy General Transport Manager, who was acting on behalf the General Transport manager who was out of the country. The vehicle was reportedly involved in an accident while in Mozambique, it is

not clear whether it was being driven by the officer who had requisitioned for it or not. This was so because the vehicle is wrecked to a point that the repair costs would actually amount to its purchase cost.

The ministry has stated that the car was recovered last week and is currently parked in another garage for an

assessment of the damage and its value. When the Sunday Observer team visited the garage, the car was found in a ravaged state. Personnel from the garage told the team that the vehicle had been there for some time as some

"It would cost government about E400 000 to repair this car, I doubt they would want to fix it, rather they would scrap it and perhaps auction some of the parts," said one of the offi-

Four months of investigation

In April, Central Transport Administration (CTA) General Transport Manager Washington Khumalo reported to the Sunday Observer that he had received a letter from the principal secretary, requiring him to explain how the vehicle disappeared. The manager said he was yet to launch investigations on how the vehicle vanished.

"It is a fact that the vehicle has disappeared and I recently enquired about it. I just received the letter from the principal secretary seeking clarity and facts on the matter," he said at the time.

Khumalo stated that he was out of the country on the day the vehicle was released and as such he was not instantly aware of the officer who had requested the car, but gave assurance that soon the investigation would be con-

Khumalo said the probe would provide clarity on who was the last officer to get authorisation to use the vehicle, to which destination and its mission wherever it was, as well as who had authorised it.

The senior officer being probed is alleged to have on February 15, 2018

requested for authority to cross the border to Mozambique, though it is unclear whether the trip was for official work or not.

The officer who was authorised to use the vehicle was said to have violated the stores regulations, which require that the vehicle should have been reported within 24 or 48 hours. The procedure involves filling in an accident form, accompanied by a police report. However, in this case all of these documents are not available.

Chief Police Information and Communications Officer Superintendent Khulani Mamba said the vehicle had not been reported to the police, either as missing or being involved in an accident. He confirmed that the procedure required a government officer to report an accident and fill in an acci-

Mamba said it would be easy to establish and identify the officer who last used the vehicle as there were records at the Central Transport Administration

Sources are of the view that the flouting of the procedure was deliberate as there were allegedly moves to replace the vehicle with another one within the ministry of public works and transport.

"There are rumours that there are moves being made by the officer to bring in another vehicle from the ministry to replace the damaged one. This was going to be done by registering the other vehicle with the same registration details as the damaged one, and also append its tax details. This would be foolish of them because the deputy had verbally reported the matter to the general manager," said one of the sources.

HOUSING PROJECTS HANDO

he Fund has a Corporate Social Responsibility to the country as supported by the SNPF Order, which provides for social responsibility initiatives targeted at the elderly and disabled. One of the initiatives under the program this year is the identification and construction of housing for the elderly in the four (4) regions of the country. The CSR committee partnered with Red Cross Swaziland to help identify four candidates for the housing project.

In 2018, the Fund's CSR committee revisited the site to inspect progress, this began other initiative by the Fund to complete the structure it had started by plastering, flooring, installing windows and curtain rails, painting, and wiring the house. To cater for both male and female occupants on the premises the Fund oversaw the construction of two (2) external toilets.

As a result of the completion of the structure, two (2) elderly people (MkhuluTfwala and Mkhulu Ngcamphalala) took occupation of the house. However, the number of occupants has since increased. For this reason PhumulaNgwaneis now a home and our thirteen (15) beneficiaries who are now able to assemble at the home at least every two (2) months to receive their food hampers and spend a day together.

SNPF NEWS took a moment to interview the CSR Chairperson, Sindi Mango, to find out more about the various community projects that the Fund was involved in this year.

SNPF NEWS: You have built 3 houses for the elderly, how were they identified?

SM: Actually we have built 4 houses in total, these cover all the regions of Swaziland. There's another house in

Lavumisa. However due to the distances between all location we weren't able to hand them all over within the same day. Plans are in place to also handover that project soon. The committee was able to identify the houses with the help of Red Cross Swaziland as they normally have daily access to remote areas of the country. In January the committee went to visit all four sites to assess whether the situation needed the intervention of the Fund...the SNPF Board approved all four locations that were presented by Red Cross.

SNPF NEWS: Who was used to build the houses, can companies apply for a tender.

SM: From the onset the committee made a commitment to empower local businessmen for any of the housing projects, so all resources were sourced from the same locale. Which means we asked for builders from Umphakatsi, river sand and crush stone were also

sourced from suppliers within the same neighbourhood. Everything else was done by our experienced property team.

SNPF NEWS: Besides Red Cross were there other companies involved in the housing projects?

Yes there some that were quite instrumental to the success of the projects. During construction we realised that most of the areas suffered from a shortage of water and we had no means of drawing water from the nearest rivers to deliver them to the construction sites. The Rhodes Food Group came to our rescue and donated 300L water barrels which were used to bring water to all the construction sites. The committee then realised that because we had brought water closer for not only the project beneficiaries but also the nearby community, many individuals were now making use of the water meant for construction. We asked Conco

Swaziland for a donation of 1000L water barrels so we could build a rain water collection system. As a committee and a Fund we would like to thank both companies for their valuable contributions to the success of the projects. We also thank umphakatsi for the various contributions they made.

GUNDVWINI RECIPIENT'S PROFILE:



Name of Pupil: Mr. Mabuza Region: Manzini Area: Gundvwini Age: 80+

BACKGROUND:

On the 16th January the Fund's CSR committee identified the Mabuza family from Gundvwini as deserving of inclusion into the Housing Project. Mr. Mabuza and his wife are an elderly couple who live in a dilapidated structure which at the time was on the verge of collapsing. As the structure was deemed not safe for them to live in, when the committee came to make an assessment the couple were living in a tent supplied by the Red Cross Swaziland.

Mr Mabuza suffers from mental illness and is thus unable to provide for this family through normal employment. The family solely depends on the income that can be raised by his wife from doing manual labour jobs around the community. The couple have no children to take care of them as all but one of their 8 children passed away. The couple do not know the whereabouts of the only

eel it, it is here! That is how best to describe the vibe around the long-awaited graduation of about 190 Swaziland Christian Medical University students, which has now been officially slated for July 27, 2018.

The exhilaration about the graduation ceremony is triggered by the fact that they waited roughly 10 months for the event, delayed by, among other things, irregularities in the courses that needed to be fixed before the students could grad-

This resulted in the institution being suspended by the Swaziland Education Higher Council (SHEC) on August 30, 2017.

Speaking on behalf of the university, Executive Director Administration Samuel Sipho Vilakati, also known

as SS, has explained the importance of the graduation, saying a graduation ceremony mark a significant accomplishment to students, staff, parents and those who witness such ceremonies.

"This will be our first graduation ceremony. It will be a historic day of jubilation for all as we see the candidates walk to the stage as graduands and leave as graduates," Vilakati said

Vilakati added that more importantly, staff and students of the university were most grateful to His Majesty King Mswati III for his wisdom and foresight. Furthermore, he thanked His Majesty's Government for its role and the former Members of Parliament (ex-MPs) for their unfailing support during the time of challenges. Vilakati added that preparations for the graduation ceremony were on course. He further gave all thanks to God.

"We are aware that a few students transferred to other institutions at the time the university was closed. This had nothing to do with the graduation ceremony," Vilakati said, when asked if there were any challenges caused by the graduation delay.

Vilakati said the Senate was still checking the final list of graduands, however he said about 190 students were expected to graduate.

Moreover, he passed condolences to the family of a student who was stabbed to death last weekend. He said the university was shocked by the untimely passing on of one of the students.

"Our heartfelt condolences go to his family, relatives and friends. We are praying that the murderers be found and brought to book," Vilakati said. On the other hand, Students Representative Council (SRC) president Thabani Mkhwanazi said students were excited about the graduation ceremony. He viewed the upcoming graduation as a breakthrough for other students enrolled in the university.

"The first graduation means that there is credibility of the university, so as students we are very happy to see that the graduation date hasbeen stipulated," the president said.

SCU Mathematics, Physics and Statistics Lecturer Phila Dlamini said he was happy and looking forward to the graduation, further hoping there would be no hiccups.

"It is a proud moment for me as lecturer who trained the students in the beginning of their programmes," Dlamini said.

He said his biggest wish had always been to see the students joining the workforce. Dlamini said he would be heartbroken to see the students loitering the streets because of being unemployed.

"It's prayer answered because it has been really tough on us. He said this was because the only highest qualifications held by some students at that moment wereForm five certificates.

Of note, on October 2017, eight students were reportedly arrested in relation to the costly arson attack on outgoing Information and Communications Technology (ICT) Minister Dumisani Ndlangamandla's property.

Ndlangamandla's property is located at Mahwalala, Lomkiri, Zone 4, a few metres from SCU. On the other hand, as an interested party, the National Workers Union in Swaziland Higher Institutions (NAWUSHI) has also expressed its happiness over the graduation.

NAWUSHI Secretary General (SG) Fundizwi Sikhondze explained that the dream to have a university that dealt with medical sciences was being realised by the graduation. He said the future of the graduands and those still studying looked brighter because of the upcoming graduation.

The SG added that the students would realise their dreams.

He said the health fraternity was crucial in building a healthy working population in a country.

Sikhondze added that the health sector also helped in increasing production.

"We are happy that the health sector is growing, we hope to see it continuously growing with trained students," Sikhondze said.

The experts have expressed interest in forming part of the team that will equip Eswatini students with the necessary and suitable skills to be best players in the area of medicine.

Currently three of the eight experts are in the country to examine the current status of the facility where the medical school will be operated.

Fields

All three experts boast of over 30 years of medical education and experience and administration of medical institutions worldwide.

The three visiting professors are Professor Chae Hong Suh, Professor Sungil Cho and Professor Hyun-Cheol Lee.

Professor Chae Hong Suh, Professor of Pathology, holds a Ph.D and MD in Pathology. He has about 35 years'

Professor Cho holds an MD and Ph.D in Physiology and also brings with him 40 years' experience in medical education, with areas of practise covering Korea, USA and Germany.

He served as Dean of Medical Schools in Korea, and has been nominated as medical coordinator for the Swaziland Christian University.

Lastly, Professor Lee, a Professor

holding a Ph.D and MD in Microbiology, boasts of over 35 years of medical education experience in medical institutions in Korea and in the United States of America. He was a dean and has managed a faculty with over 300 medical professors at the Medical College of Chonnam University in Korea. Lee is the current President of Korean Society of Microbiology in academics

and administration.

Chancellor of the Swaziland Christian University Professor Yoon expressed great appreciation for receiving interest from people with such rare skills. He acknowledged that Basic Medical Science professors were difficult to find and even more difficult to secure.

"They all have experience in establishing medical institutions and developing step by step from humble beginnings up until they are at world class medical schools" he noted.

He added, "We are fortunate to have the experienced Basic Medical Science professionals willing to join us to help."

Professor Yoon expressed confidence that the medical school, though starting at a humble level, will flourish steadily over the years.

"Let us start the Medical School with best available resources, even though humble at the beginning stage, work together to make it grow into a world class university," he added.

The three experts managed to visit the structure where the medical school will be situated and assessed the infrastructure.

They acknowledged that though lower the standard compared to Korean institutions, what was available at present was good enough to start operating the medical university.

ZION CHURCHES WALK AGAINST RITUAL KILLINGS

bout 10 Zion Churches took to the streets of Mbabane to walk against ritual killings yesterday morning.

The churches included Restoration House, Faith, Mountain of God, Sisekelweni, Gagasini, Ekuphileni and Ebekizandla to name but a few. Their slogan was 'Union in Zion'.

According to the Coordinator of the walk, who is also Ekuphileni Church in Zion Secretary General (SG) Wandile Dlamini, the Zion church learnt with concern the escalating number of ritual killings reports in the print media. Dlamini said it was for that reason the church came together and agreed on the awareness campaign walk

The walk, which was attended by roughly 55 congregants, started and ended at the Supply Centre after the congregants had gone around the city. They carried placards with messages that condemn killings. After the walk, the congregants held a meeting, where speeches were delivered. After the brief gathering, they proceeded to Waterford for their sports

During the walk, the enthusiastic Zion churches members sang Zion songs and also performed siguco. Strangely, the church members were not in their normal church gowns. Dlamini said the

reason they were not wearing gowns was that in the evening they were going to have an all-night vigil at Mangwaneni. He said they feared that the gowns were going to get dirty during the walk.

"Churches are not only for preaching the word of God but also to deliberate on issues arising in the society, like the ritual killings," Dlamini said.

When asked why they chose to organized the walk during this time of the year, Dlamini said it was because alarming numbers of killed people were usually reported on each national election's year. He said they also wanted to con-

demn the killings as well. Recent ritual killings associated cases

that have rocked the country include Phiwayinkhosi 'Thithi' Kunene's (8)

She was from Hholoshini; Phiwayinkhosi was later allegedly found beheaded kilometrers away from her home. Another incident is that of a 16-year-old boy, who escaped from the jaws of death with a slit throat after three men believed to be ritual killers pounced on him in a forest at Mafutseni.

These and other incidents led to the National Commissioner of Police Isaac Magagula forming a task team dubbed 'Sting Operation Strategy'. Its main mandate is to assist in combating violent crimes. It was launched on June 15.

Mystery surrounds death of Moz. man

ystery surrounds the death of a Mozambican man who was found floating in a dam, holding a rabbit firm-

The Mozambican, Telmo Eugenio Muhlongo, was found dead last Sunday in a dam at Phumlamcashi around Siphcfaneni. However, Muhlongo's wife Lorda Sabno Maziwe suspects foul play.

She believes that if Muhlongo drowned, then he would have let go of the rabbit as he would have tried to swim his way out of the dam. The wife suspects that her husband was killed and later thrown into the dam. The wife now points an accusing finger at one of her husband's previous employers who allegedly owed Muhlongo around E21 000. The man suspected by the wife was ordered by the Conciliation Mediation and Arbitration Commission (CMAC) to pay Muhlongo for labourer ser-

She believes that the previous employer allegedly eliminated her husband to avoid paying the money.

The suspect's wife, however, although acknowledging the debt, said Muhlongo's death had nothing to do with her husband, instead raising suspicions of witchcraft, given that he was found holding onto a rabbit.

To compound the matter further, the suspect's wife has also claimed that as Muhlongo's wife was married before, her first husband could not be ruled out as a

The suspect's wife further defended her husband by stating that her family and the deceased were still in good talking terms despite the CMAC issue.

For this reason, they offered to cater for Muhlongo's funeral costs. disappeared Muhlongo lastSaturday after having left home to work in the sugarcane fields in the area. He never returned and was discovered the following morn-

Muhlongo was found with stains of blood in his nostrils.

According to his wife, Maziwe, she was amazed that the man who owed her husband money was offering to cater for all funeral costs. She claims to have rejected the offer as she wanted to locate her husband's relatives.

Relatives

She complained that the police were no-longer willing to give her the court papers they took, which have the CMAC agreement between Muhlongo and the woman'shus-

"I want the police to give back the court papers, I'm now suspecting that the police are colluding with the woman's husband to destroy the agreement between the two parties," she suspected.

She said the police should at least take her husband's patient card instead of the Court papers because the relatives might continue with the CMAC case.

Chief Police Information and Communications Officer Superintendent Khulani Mamba confirmed the incident. He clarified that no criminal offence has been opened at the moment.

Addressing the issue of seized court documents, Mamba said the police wanted to use them to track down the dead man's relatives.

atcry over forestry workers injuries

he health and safety standards of the local forestry industry are being questioned because of the statistics of people sustaining serious injuries while at work.

The union, nearby hospitals and the ministry of labour and social security have raised a concern over the increasing injuries of employees, especially in the saw mills. The union has, however, commended the efforts made by some of the companies in improving the safety of the workers. Similarly, the major players said this year's statistics indicated a decline in the incidences.

Safety

"Yes, there are some workers who have sustained injuries, especially in the saw mills. Issues of health and safety were not up to the expected standard, we have engaged the employers several times on the matter," admitted Federation of Swaziland Trade Unions (FESWATU) President Mashumi Shongwe.

Mankayane Government Hospital Casualty and Emergency Services Department staff told the Sunday Observer that on average they attended three atients who had been injured from the different mills weekly, which made them question the occupational safety of the

company. "I won't lie, we have seen several patients with all ranges of injuries, some with broken bones, open fractures, those who needed to be repaired the muscles to mention but a few. If it was not for the confidentiality policy, we would be showing you this injury book, where we record the injuries on duty," said one of the doctors at the hospital.

A nurse from the hospital also cited that they had witnessed the amputation of a young man's hand, and recently she had to accompany one of the patients to the Mbabane Government Hospital.

Three of the victims who sustained serious injuries and were given different jobs within their different work stations (Bhunya and Nhlangano) said the compensation they received was meagre and as such they had to return to

Jobs

"You are forced to come back to work soon as the wound heals, because the compensation is very little, it cannot sustain you for the rest of your life, hence most of us return to work depending on your condition and the company then gives you another job," said *Musa Dlamini "There are different reasons for the accidents, some of them may be attributed to the pressure from the supervisors who are concerned with an increase in production and meeting targets. The company is reactive other than being proactive, they only upscale the safety measures after a number of accidents have been reported. For instance, the chains were only covered after my case," said one of the victims, who requested not to be named.


Ministry of Labour and Social Security Principal Secretary Thulani Mkhaliphi said there was an under-reporting of injuries in the workplace hence the ministry would engage employee education. "There is an under-reporting of injuries at work, hence we suspect lack of knowledge, we need to go to the factories and educate the employees of their rights, indulging the human resources officers. A person who gets injured in the workplace or on his /her way to work or way home is still considered as injury at work. It is a criminal offence for employers not to report injuries, while some emplyers hide incidents for whatever reasons," he said.

Control

Mkhaliphi said the ministry did visit some companies to inspect and educate them about safety measures.

Montigny Usutu CEO Andrew Le Roux said he was certain that the accidents had declined this year and the company had strengthened the safety measures. "We take health and safety seriously, and I get a monthly report, but I must say in general incidences are going down significantly, nothing has been reported to me in the past few weeks. I can assure you that the trend is definitely down and it is because of policies that we have put in place to look after health and safety," he said.

The CEO said not all the reported cases were from his company alone, as some may be from their subcontractors which they had no direct control of their safety. "What happens is that sometimes we have contracted people, it may not be a Montigny employee, it might be one of the contractors in the compound, and obviously, they are indirectly, we can't look after everybody because we are not always in direct control of all the safety issues. I will need to find exactly what the figures are and then respond accordingly," he said.





Preheat the oven to 180°C. Butter and flour two round cake pans and then line the bottoms with wax or baking paper. In a medium bowl, sift together the flour, baking powder, baking soda and salt and then set aside.

Step 2

In a medium pot, combine the sugar with two cups of water. Bring to a boil over high heat and

stir until the sugar dissolves; then pour into a large bowl. Add the chocolate and butter and let sit, stirring occasionally, until melted and slightly cooled. Stir in the vanilla.

Step 3

Beat the eggs into the chocolate mixture at medium speed until combined. Add the dry ingredients all at once and beat at medium speed until smooth.

Divide the batter evenly between the prepared pans and bake for about 25 minutes, or until the top springs back when pressed lightly and a cake tester or toothpick comes out clean.

Cool the cakes in their pans for about 25 minutes, then invert onto a rack to cool completely.

Step 4

In a medium saucepan, bring 1 1/3 cups heavy cream and 1 1/2 cups sugar to a boil over medium-high heat.

Reduce the heat to low and simmer, stirring occasionally, until

the liquid reduces slightly, about six minutes. Pour the mixture into a medium bowl and add 180mls unsweetened chocolate, 120 mls plus two tablespoons of butter, two teaspoons of vanilla and a pinch of salt. Let the mixture stand, stirring occasionally, until the chocolate and butter are melt-

Set the bowl in a larger bowl of ice water. Beat the frosting on medium speed with your mixer, scraping the sides occasionally with a spatula to make sure you

incorporate all of it. Beat until thick and glossy, about five minutes. Use immediately.

Step 5

Set one cake, right-side up, on a serving platter. Using your offset spatula, spread one-third of the Chocolate Frosting evenly over the cake.

Step 4

When the croutons are done to your liking, remove them from the oven and cool on the pan.

If not using right away, store croutons for a few days in an airtight container, or freze in a large freezer bag for up to three months.



Parliament welcomes Ramaphosa's plans to ease petrol price hike burden

APE TOWN - Parliament's select committee on economic and business development has welcomed President Cyril Ramaphosa's announcement that government is seeking to soften the blow following fuel increases

Ramaphosa will announce economic measures in the coming weeks, to help South Africans deal with rising fuel prices and the recent value-added tax increase. Committee Chairperson Mandla Rayi explains: "We appreciate and commend him for his quick response on the establishment of the panel, to look at how to ease the effect of these hikes."

The price of a litre of petrol has more than doubled over the past decade and, as always, the pain is being felt the hardest by ordinary South Africans.

Fuel prices have gone up again; 93 octane will cost 26 cents more, while 95 is going up by 23 cents per litre. Motorists will also have to fork out up to 26 cents more for diesel, while illuminating paraffin is going up between 22 and 30 cents.

Many South Africans are struggling to make ends meet, as this woman explains: "As low-income people, we are unable to cope because there's no increase in my salary."

This man says he is tired of the increas-

es. "I don't really know who to blame for the whole thing. I'm getting tired of it."

On Wednesday, Economic Development Minister Ebrahim Patel said there was very little government can do to stem fuel price increases. At the same time, the African National Congress requested an increase in petrol reserves freezing or decreasing the fuel levy.

Meanwhile, EFF leader Julius Malema on Friday blamed Ramaphosa for the continued rise in petrol prices and said it was a sign that he doesn't care about the poor.

Duduzane Zuma may be trapped in SA after detention

OHANNESBURG - Duduzane
Zuma's return to South Africa
may have been more difficult
than he anticipated, but trying to leave
the country could be even more challenging. The controversial son of former President Jacob Zuma was stopped
for two hours at OR Tambo
International Airport on Thursday
night on his return from Dubai, after
his passport was flagged - allegedly
because of a criminal case opened
against him.

While it's unclear what the charges in this matter entail, it's understood the case was opened in Rosebank in 2016. According to Duduzane's lawyer, Rudi Krause of BDK Attorneys, his client was briefly detained at the airport to allow Hawks officers to "confirm his identity". When this process was completed, he was free to leave.

However, Krause was adamant that no arrest warrant had been issued for his client, despite the case opened against him. He also added that the reason his client had returned was to attend his brother Vusi's funeral this weekend, as well as to appear in court on Thursday on charges of culpable homicide.

The culpable homicide matter stems from an inquest at the Randburg Magistrate's Court in 2014 that determined Duduzane's negligence in an accident that claimed the life of

Phumzile Dube. On February 1, 2014, the young billionaire's reckless driving led to him crashing his Porsche 911

Four years since Magistrate Lalita Chetty determined there was evidence of his culpability in Dube's death, the National Prosecuting Authority has finally indicated it wishes to charge him, with his first appearance set down for Thursday. Earlier this year, a summons was issued to his now former lawyer, Gary Mazaham, warning Duduzane to appear as they could not be served on the 34-year-old after he had seemingly fled to Dubai after a series of revelations on his involvement with the controversial Gupta family.

DA vows to 'clean up' Gauteng province if it wins 2019 vote

He says his job is to ensure that South Africans trust the DA as an alternative to the African National Congress at the ballot papers.

'SA will not expropriate traditional leaders' land'


URBAN - Government is in damage control mode after the Zulu king made threats to secede this week. The South African government on Friday said a wrong impression was created that the discussion on land expropriation included land in the hands of traditional leaders. "Government wishes to clarify categorically that when government talks about land expropriation, we are referring to the 87 per cent of the land, not the 13 per cent that is under the control of traditional leaders and black people. We wish

to emphasise that the 13 per cent of the land is not under any dispute," Cooperative Governance and Traditional Affairs (Cogta) Minister Zweli Mkhize said. In the statement, released by Cogta, Mkhize said that government noted the "serious concerns raised by traditional leaders with respect to the report of the High-Level Panel appointed by Parliament on the Assessment of Key Legislation and the Acceleration of Fundamental Change, led by former president Kgalema Motlanthe".

Traditional leaders say their land is no-go area in traditional leaders say taking land away from them would be

taking it from its rightful owners.
The leaders made their views heard when they met with the Cabinet-appointed ministerial task team. Headed by Cooperative Governance Minister Zweli Mkhize, the team saw leaders express concerns around proposals to amend the Constitution to allow for land expropriation without compensation. "The 13 per cent of land

in traditional leaders' hands where 80 per cent of our communities are residing should not be touched when it comes to the issue of expropriation," said iNkosi Sipho Mahlangu from the Mpumalanga House of Traditional Leaders. "That land belongs to the people and traditional leaders." While title deeds and land tenure were also discussed, the tribal leaders were not happy about being labelled tinpot dictators.

WHAT ARE THE HEALT BENEFITS OF YOGA?

-n case you're an enthusiastic yoga professional, you've most likely seen some yoga benefits, perhaps you're sleeping better or getting less colds or simply feeling more casual and quiet.

However, in the event that you've at any point had a go at informing an amateur concerning the advantages of yoga, you may find that clarifications like "It builds the stream of prana" or "It brings vitality up your spine" fall on hard of hearing or incredulous ears

Studies of the benefits of yoga are only beginning to accumulate, and so the evidence is not overwhelming or conclusive at this point. Here are some benefits that would be easier to explain to a person who is interested in practising yoga.

High blood pressure (hypertension): Many people believe that practising yoga can help lower blood pressure by teaching breathing techniques and reducing stress. It is true that lifestyle changes, like regular physical activity and stress management, can help lower and manage blood pressure, but it doesn't do so in all cases. As for yoga, there hasn't been enough research to make firm claims.

Diabetes: There is some evidence to suggest that yoga may lower blood glucose. After just eight days of yoga in 98 men and women 20-74 years of age, fasting glucose was better than at the beginning of the study, but subjects in this study were also exposed to dietary counselling and other lifestyle interventions, and so it's difficult to know if the yoga on its own was responsible for the changes.

Carpal tunnel syndrome: Individuals with carpal tunnel syndrome who did yoga twice a week for eight weeks had less pain in their wrists than people with carpal tunnel who wore a splint. The effect may be due to improved grip strength in the yoga subjects.

Strength and flexibility: In one of the most persuasive yoga studies, men and women 18-27 years of age who participated in two yoga sessions per week for eight weeks increased the strength in their arms by 19% to 31%, and by 28% in their legs. Their ankle flexibility, shoulder ele-



vation, trunk extension, and trunk flexion increased by 13%, 155%, 188%, and 14 per cent, respectively!

Asthma: There is some evidence to show that reducing symptoms of asthma and even reduction in asthma medication are the result of regular yoga. Again, this doesn't mean that you should stop taking your asthma medication if you start practising yoga, but it does suggest that there could be some positive result, and you should ask your doctor if you have a question about it.


Independent of studies: I think it's fair to say that the majority of people who practice yoga regularly enjoy it and find it beneficial. The preliminary data from the studies reviewed seems to indicate that there is benefit from the regular practice of yoga. If your interest has been piqued and you have chronic medical problems, discuss adding yoga to your medical routine with your primary care physician.

"I believe more people need yoga, we are at a time where we are always busy and on the road and believe it when I say 10 minutes of yoga can make my everyday life better."







Both sides seek to 'clarify' as Pompeo holds second day of North Korea talks

Secretary of State Mike Pompeo began a second day of talks in North Korea yesterday attempting to agree details on how to dismantle the country's nuclear programme, and both sides said they had things to "clarify" from the previous day.

After spending his first night in the North Korean capital in three visits so far this year, Pompeo left the government guest house where he spent the night to make a secure phone call to US President Donald Trump to provide an update on the talks.

Pompeo then sat down again with Kim Yong Chol, a top North Korean party official and former spy agency chief who played a key role with Pompeo in arranging the 12 June summit between Trump and North Korean leader Kim Jong Un in Singapore.

Kim Yong Chol said that the two had had "very serious discussion on very important matters yesterday" and joked that as a result, Pompeo "might have not slept well last night" at the prestigious Paekhwawon, or 100 Flowers Garden, guest house.

Pompeo replied: "Director Kim, I slept just fine. We did have a good set of conversations yesterday. I appreciate that and I look forward to our continued conversations today as well."

Pompeo reiterated that Trump was "committed to a brighter future for North Korea."

"So the work that we do, the path toward complete denuclearisation, building a relationship between our two countries, is vital for a brighter North Korea and the success that our two presidents demand of us," Pompeo said. Kim agreed that the work was important. "There are things that I have to clarify," he said.

"There are things that I have to clarify as well," Pompeo responded. US State Department spokeswoman Heather Nauert told reporters that US and North Korean officials had set up working groups to deal with "nitty gritty stuff," including verification of efforts to achieve denuclearisation, which would be headed on the US side by Sung Kim, a Korean-American who is also Ambassador to the Philippines. AFP

OBAMA WARNS OF 'RISE IN NATIONALISM'

ADRID - Former US president Barack Obama warned in Madrid on Friday of "a rise in nationalism" and the potential of new media to accelerate social divisions.

"We're in a difficult time, politically, socially... people feel very anxious," said Obama, who left office last year.

"Change is happening very quickly. People are wondering can I adapt to these changes? People are fearful," the former president told an audience of 2 000 people at a conference in Madrid on technological innovation and the circular economy, which minimises waste.

"We see a rise in nationalism," Obama told his audience.

"The world needs to consider how to use the new technology to improve lives and ensure that it does not accel-

erate division," he added.

"Today because of the internet, and because of the multiplicity of media what we see more and more is that we don't agree on the same reality."

The former Democrat pres-

ident highlighted in particular the US Fox News network,. "If you watch Fox News you

"If you watch Fox News you see a different reality than if you read the New York Times, he said. "Climate change is not happening at all" in media like Fox.

Exploited

This phenomenon "has been "exploited by some forces internationally", which "feed their biases". The solution, according to Obama, is to train young people "to think differently".

Obama, who was to travel on to Porto in Portugal on Friday to attend a climate change conference, has criticised his successor President Donald Trump for failing to consider scientific research on the subject.

'Don't emulate Mugabe, he's bad example for elderly'

describing him as a "bad example for the elderly".

According to the privatelyowned NewsDay, the founder of Destiny of Africa Network (DANet), Obadiah Msindo, made this statement while donating food hampers while on an outreach drive that aims to benefit 5 000 senior citizens across Zimbabwe.

DANet is a religious organisation providing housing solutions to low-income earners.

"Mugabe is a very bad example for the elderly and you should not emulate him," Msindo was

quoted as saying.

Msindo blamed Mugabe's attack on President Emmerson Mnangagwa last November for his downfall.

He urged the elderly to go out

and vote on July 30, saying: "You must be given a chance to decide on a president who spearheads your interests and improves your welfare."

Msindo said he was campaigning to mobilise voters for Mnangagwa, who he described as a mature leader able to address the needs of Zimbabweans.

The ZANU-PF linked cleric is a former outspoken backer of Mugabe, once describing him as 'Black Moses'.

He pledged to gain two million votes for Mugabe in 2013 during the previous Zimbabwe's election, according to NehandaRadio.

Msindo has also been involved in quite a few controversies. In 2006, he was charged on five counts of repeatedly raping his maid, the privately-owned Standard newspaper reported.

Ivory Coast's Ouattara to name new govt

ABIDJAN - Ivory Coast President Alassane Ouattara plans to name a new government on Tuesday, after dissolving its predecessor because of a row within his ruling coalition, three government sources told Reuters on Friday. Two sources close to the president and one to Ouattara's RDR party also said discussions between the RDR and its coalition partner, the PDCI of former president Henri Konan Bedie, had begun on Friday in a bid to resolve their differences. *Reuters*

Car bomb explodes near presidential palace

MOGADISHU - A suicide car bomb exploded metres away from the presidential palace in Somalia's capital Mogadishu yesterday and smoke was seen rising above the scene of the explosion although it was unclear who was behind the blast, police said. "A car bomb exploded ... it is too early to know (the) casualty," Major Mohamed Hussein, a police officer, told Reuters moments after the blast. A second blast nearby occurred opposite a police building, a police source said. It was not immediately clear whether it caused any injuries. A Reuters witness saw smoke emanating from many burning vehicles at the scene around the blasts.

Woman breaks silence on PM groping allegation

OTTAWA - A former journalist broke her silence on Friday to stand by her allegation that Prime Minister Justin Trudeau groped her nearly two decades ago, when he was not politically involved. "I issue this statement reluctantly, in r onse to mounting media pressure to confirm that I was the reporter who was the subject of the Open Eyes editorial, published in the Creston Valley Advance in August of 2000," Rose Knight said in a statement to the Canadian Broadcasting Corporation (CBC). She was referring to the original Canadian report on the allegation, which said that Trudeau, who was 28 at the time and not involved in politics, had apologised to the reporter in question. Reuters

May faces Brexiteer backlash hours

LONDON - Theresa May faces angry backlash from Tory Eurosceptics after senior ministers agreed a Brexit policy that would effectively keep the UK in the EU single market for goods.

Anti-EU backbenchers refused to rule out triggering a leadership contest against the prime minister, amid anger that she had convinced the Cabinet to support a softer Brexit. ANKARA - Turkey's President Tayyip Erdogan said yesterday he would name the Cabinet he has selected tomorrow, as he renewed a promise to tackle what he called the "structural problems" of the country's economy. Moving to reinforce his authority in his first parliamentary speech since being re-elected on June 24, he said Turkey would enter a new era when he takes the presidential oath tomorrow. Erdogan emerged triumphant from his biggest electoral challenge in 15 years, giving him the sweeping executive powers he has long sought and extending his grip on the nation of 81 million until at least 2023. "As the first president of the new executive presidential system, I will announce the Cabinet at 9 pm on Monday... God willing, we will hold our first Cabinet meeting on Friday," he told deputies of his AK

"He came back a few minutes later asking for my mobile phone to install the WhatsApp software. I am now on WhatsApp and I will let Mnangagwa break away from former president Robert Mugabe's hardline stanced social media accounts on Facebook and Twitter to ask Zimbabweans not to fight in the forthcoming elections."

Judge Nkosi's Uturn a statement

here could only have been one winner, and there is now. High Court Judge, Sipho Nkosi has backed we from his stance of taking on the lowers that be at the High Court, by isisting that he is seized with the bail nearing of murder suspect Sipho Shongwe. As such Judge Nkosi had promised to go ahead with the hearing tomorrow-come what may!

But, this won't be the case any longer, well, if Friday's apology to the chief justice by the judge is anything to go by. Judge Nkosi has apologised for his action, what he has termed in his letter as a misunderstanding between him and the chief justice.

In doing so, the judge has performed an amazing about turn to what he threatened to do a week prior when he publicly stated that he would proceed with Shongwe's bail hearing; claiming that there was an injustice in the manner the suspect was being treated; threatened to spill the beans on what was happening regarding the case; and that his name was being tarnished by certain forces.

But, a week later, the Judge has apologised and promised to behave, so-tosay.

It is astonishing. Firstly, because it does not remove the doubt that was planted when the judge screamed injustice in a matter that he said he was seized with. It also does not remove the comments that he made when threatening to spill the beans.

It leaves us gasping for air; what has happened to the judge since thenhas he been spoken to? Who was wrong, the judge or whatever that he thought he saw was the problem?

What does this mean to the charge of professional misconduct, that he was being accused of?

Oh, and, if Judge Nkosi believed he was right and following procedure by arguing for the case to be brought to him, as he was seized with it, what then does this mean? He was wrong?

Phew! So many questions, and yet, no answers. What remains, however, is that this incident says a lot about the administration of the criminal justice system. Whatever it is that has happened, we must underscore the importance of justice being seen to be served.

We must also be wary of a lack of independence of our justice, or judges, because we all want the confidence that the rule of law in this country is above anyone's whim.

Of course, in the same breath, we must encourage the notion of collective responsibility and subordination of judges, only to the extent that no one must do what they please. If the judge's apology achieves this, then so be it. But, if it is because it seeks to subjugate, then it is a statement of indictment on our Judiciary.

Hidden Agenda

The PSPF has been dragged into controversy by the FSRA following a failed attempt to launch an inspection into its operations; something that the PSPF believes is motivated by hidden agendas, more than a desire to bring it to book. It challenges the FSRA's motive based on the sequence of events, as laid out in its published statement a fortnight ago, in which the PSPF revealed, rather interestingly, that as a result of the failed inspection, the FSRA was demanding that it pays E3m for the SA audit firm it forced down the throat of the PSPF.

Don't ask me how they qualify that amount, if it is justified, but take note that from this, an easy E3m should be found lying around. That is telling.

This is in addition to a litany of questions that arise from the engaging of the SA audit firm, known as Prodogy, as well as the procedure or conduct by the FSRA while forcefully undertaking the inspection. It smirks of questionable behaviour on the part of FSRA that we should all be alarmed about, especially from a regulator. Admittedly, the PSPF has found itself being backed into a corner where it has to defend itself, and lay bare some of the issues it believes warrant serious introspection as to the role of the regulator. But

because people are focused on the target-which is, without doubt,

at the helm. This has been raised by PSPF in its statement, pointing out that it views the FSRA as a body that should provide fair and objective oversight of the retirement funds industry as a whole.

The Fund then disclosed that the FSRA, unlike in this attempt to launch the inspection, has always issued a pre-inspection list detailing areas of intended inspection and whatever information and documents that they would require, 'to which the PSPF has acted in full compliance resulting in a successful inspection'.

Criminal Conduct

It then states; 'Coming to this year's inspection, the FSRA, for reasons unknown, drew up terms of reference to govern the exercise which go far beyond the scope and actions legally prescribed in their own Act. Upon considering their substance and legitimacy and from obtaining credible legal counsel, came the very basis of PSPF's objection to the terms of the inspection. The items of contention are: the intentions by FSRA to carrying out life style audits on employees of the Fund; investigating suspected fraud, corruption and money laundering; and investigating suspected acts of criminal conduct.'

This statement is loaded. In fact, it could have also added, 'the timing of conducting this audit, something that does not sit well with

Why now, and why the haste, and why the demand? If, as the PSPF alleges, the FSRA did not act in the manner it has in the past, and not rushed into occupying the offices of the PSPF, using foreign auditors who were given access to the Fund's books, then we should be wary of the intensions and motive behind it. Interestingly, the company engaged by FSRA has, according to the statement by PSPF, some 'disturbing corporate practices by its members', that would otherwise have disqualified them from carrying out such an inspection.

These are very serious allegations that call to question the conduct of the FSRA, in addition to allegedly not following laid down proce-

This is what should also concern us as the public, given that we do not want the FSRA to be a law unto itself, or that it will be used as a bulldog, set off against any perceived enemies and opponents of those who pursue other agendas.

We want the FSRA to be what it was set up to be. We want it to perform its function without fear and favour. But, it must not be used, and veer off its mandate, just because

There is a big stinking rat in the manner this issue is being pursued, and for that I was in agreement with the Cabinet decision to have it withdrawn from court. I assumed that this decision meant that there was still room for further engagement, between the parties involved, and also because Cabinet would have applied its mind to the application itself by the FSRA to the extent that it was overarching.

But, I was also equally concerned when I noticed that the public sector unions had joined in the fray, demanding that Public Service Minister Owen Nxumalo withdraw the directive taken by Cabinet. I found this interesting because you would expect that unions would raise an alarm that the FSRA wants the Fund to dish out E3m of its fund-for what!

I also would have expected the unions to challenge the authority of the FSRA, or at least be aware of what the issues on the table are before it jumps into the fray. As is, the idea that the union backs the inspection, regardless of the laid down parameters, or the cost thereof, or in effect, the notion that the Authority is being used, tells us that they do not bother with the

While it is true that the FSRA must be allowed to perform its function, the PSPF should also be protected from bullies, and political interference, so that the workers funds are protected.

Of course in saying all of this, one is not saying that the PSPF is an angel, or that it should be allowed to misuse the funds it administers. Rather, the contrary. The PSPF has also stated that it has previously allowed for an inspection, when the laid down procedure was followed. It came out clean, and the same FSRA was singing praises along Gwamile Street to its offices. It told everyone who cared to listen that the Fund was a shining example of how to manage public funds.

There is a lot to suggest, therefore, that there has been a sudden paradigm shift in the relationship between the two. If it is true that the inspection was sprung on the PSPF, then it raises more questions than answers on the part of the FSRA than the PSPF.

We should then be careful not to allow those wolves in sheepskin to achieve their selfish agendas. When we do, we will only have ourselves to blame.

In this article, we will delve into the presentation talking points and items that were brought up by the participants during the seminar. The objective we want to achieve here is to look inwards through a solemn introspection, embrace our realities, and ultimately internalise the lessons that we learnt from the seminar.

We also want to look outside in the environment to identify issues that we need to address as a collective and investigate some of the approaches that could be used in the combat of the corruption pandemic.

The fight against corruption is not going to be easy and it is not going to be won overnight. Some of the lessons are covered in the below discussions:


1. Everyone has a Role to Play (connect the lights to expose corruption)

The Afrobarometer survey revealed one of the insights that were shared by participants in the seminar – there is an aura of fear around exposing corruption in our communities. It was established that a shocking 82 per cent of the respondents felt that they risk retaliation if they speak out against corruption.

This minimises the inclusive nature of

the solution to the issue because everyone has a role to play in the alleviation of the crisis. The doers of corruption thrive on this situation at the peril of all the victims who believe that the solution is out of their control. Everyone has a role to play by either desisting from enabling corruption or exposing corruption through the use of the anti-corruption structures.

2. Educate Society About Corruption

It has been established that in an environment where corruption has evolved and has been deeply engraved into the lifestyles and culture of society, it becomes difficult to demarcate the red flags.

The systems in this situation become

contaminated to an extent where "corrupt" and "not corrupt" becomes a hazy grey area. Like any other societal ill, the starting point is education around the subject in order to create awareness about the issue, its impact, and then – what mechanisms should be put in place to alleviate it. The Afrobarometer Round 7 survey in Eswatini had some insights which are consistent with the need for society to be educated about corruption. Out of the respondents interviewed, only 51 per cent believed that corruption has somewhat increased

A combination of respondents who believed that corruption levels stayed the same, decreased, and those who do not know of the status made up

between 2015 and 2018.

a total of 49 per cent.

This is stark evidence that there is a deficiency in the knowledge system of society to identify, expose, and prevent corruption because the reports that analyse the incidence of corruption reveal an upward trend on the ground.

There has been a lack of activity in the redress of the pandemic, which would be in the form of cases being concluded and individuals being prosecuted for corruption.

Therefore, it is conclusive that the rising trend of corruption is occurring and going unnoticed by society. We are then suffering the consequences of it without even knowing that we are the victims of it.

Education on the subject could help for society (all stakeholders) to appreciate that they are the losers in the presence of corruption.

3. Strengthen Anti-Corruption Mechanisms

The state of the anti-corruption structures is another issue that needs attention as the credibility, thereof, also determines whether citizens would have the confidence in them to an extent that they would actually consider to use them.

If the confidence levels in the struc-

tures are low, they would simply be a formality. The corruption alleviation structures also play the critical role of providing protection for the individuals and institutions who utilise them. Protection of users should ideally go to then level where the users of the system feel motivated to use it because they feel it is to their benefit.

4. Anti-Corruption Efforts Should be Connected with Human Rights

Corruption was cited as an impediment to doing business, a major contributor to a weakened economy, skewed opportunities, compromised law enforcement processes, loss of development funds, poor and costly social services, and a host of other challenges. The lack of amends to corruption is tantamount to an infringement of basic human rights as it leads to the "survival of the unfittest". A closer look at the United Nations Sustainable Development Goals (SDGs) shows that corruption is directly in conflict with such goals.

5. Pay now or Pay Later

As a way of closing in the seminar, another notable quote by the presenters was that in the end, the perpetrator of corruption will pay for the consequences.

The advice given to those who practice corruption was that they have to pay now and desist from the practice, or they would have to pay later in many ways such as prosecution or/and losses caused by being used to a lifestyle of greed whose revenue would be unsustainable in the long run. Lives are lost through corruption when improperly built structures fail, below-standard goods are procured and the perpetrators have to face the brunt of the law.

from dead works to serve the living God?' (Romans 9:13-14) (NASB).

Apostle Paul demonstrates more graphically how the blood of Jesus accomplished our forgiveness in Ephesians 1:7-8, "In Him we have redemption (that is, our deliverance and salvation) through His blood, (which paid the penalty for our sin and resulted in) the forgiveness and complete pardon of our sin, in accordance with the riches of His grace which he lavished on us." (AMP)

On the eve of His crucifixion, Jesus instituted the Lord's Supper, as He took His disciples a step further towards the fulfilment of the promise in the Lord's Prayer. In Matthew 26:26, it is written thus: While they were eating, Jesus took some bread, and after a blessing, He broke it and gave it to the disciples, and said, "Take it; this is My body."

And when He had taken a cup and given thanks, He gave it to them, saying, "Drink from it, all of you; for this is My blood of the covenant, which is poured out for many for forgiveness of sins." (NASB)

Apostle Paul introduces the disci-

ples to the symbolical invocation, so to speak, of the blood of Jesus in 1 Corinthians 11:23: For I received from the Lord that which I also delivered to you, that the Lord Jesus in the night on which He was betrayed took bread; and when He had given thanks, He broke it and said, "This is My body, which is for you; do this in remembrance of Me." In the same way, He took the cup also after supper, saying, "This cup is the new covenant in My blood; do this as often as you drink it, in remembrance of Me." This is why it is important for all believers to partake in the Lord's Supper as an endorsement of their signature on the dotted line of the new covenant, especially after being born of water and the Spirit (read John 3).

The use of bread and cup (wine) was the fulfilment of Jesus controversial statement, where He said in John 6:53-55, "Truly, truly, I say to you, unless you eat the flesh of the Son of Man and drink His blood, you have no life in yourselves.

He who eats my flesh and drinks My blood has eternal life, and I will raise Him up on the last day. For My flesh is true food, and My blood is true drink."(NASB).

As I explained last week, 'flesh' refers to bread in this context, while bread in the Lord's Prayer refers to Jesus; similarly 'drink' refers to the blood of Jesus.

Jesus crucifixion immediately accomplished the forgiveness of those sins between man and God; more specifically the sins related to the first five commandments summed up in Matthew 22:37-38 by the Lord Jesus as the first and great commandment: "You shall love the Lord Your God with all your heart, and with all your soul, and with all your mind."

Through this one act on the cross, Jesus fulfilled the first part of the forgiveness prayer in the Lord's prayer.

The last part: '...as we also have forgiven our debtors', while also very much an act of grace, is the pivot that allows one to claim the full benefit of Jesus' act of forgiveness on the cross.

This prayer relates to the last five commandments in Exodus 20, summed up by Jesus in Matthew 22:39, as He answers the questions posed to Him by the Pharisees:

"The second is like it, 'you shall love your neighbour as yourself." In verse 40 Jesus adds that the whole Law of Moses and the writings of the Prophets lay on these two commandments.

I hope the reader now appreciates how Jesus commands us to pray for the fulfilment of the act of forgiveness by which we are able to relate with both fellow man and God in our everyday life.

Matthew 6:13

"And do not lead us into temptation, but deliver us from evil. (For Yours is the Kingdom and the power and the glory forever. Amen)". (NASB)

The reader would have found it interesting that Jesus went on to add, in what comes across as an afterthought; "For if you forgive others for their transgressions, your heavenly Father will also forgive you.

But if you do not forgive others, then your Father will not forgive your transgressions." (Matthew 6:14). By no means is this an afterthought. This very last line speaks to verse 13, where Jesus commands us to pray that God does not lead us into temptation, but instead deliver us from evil.

In essence, Jesus is saying the punishment for failing to forgive our fellow men opens us up to temptation, disease and evil attack.

We learn when Jesus encounters the paralytic who was brought through the roof of a house where Jesus was ministering healing that the 'forgiveness' of sins translates to the healing of bodily ailments and deliverance from evil. Mark 2:5: And Jesus seeing their faith said to the paralytic, "Son, your sins are forgiven."

But some of the scribes were sitting there and reasoning in their nearts, "Why does this man speak that way? He is blaspheming; who can forgive sins but God alone?" Immediately Jesus, aware in His spirit that they wer reasoning that way within themselves, said to them, "Why are you reasoning about these things in your hearts? Which is easier, to say to the paralyt ic, 'Your sins are forgiven'; or to say, 'Get up and pick up your pallet and walk? But so that you may know that the Son of Man has authority on earth to forgive sins" - He said to the paralytic, I say to you, get up, pick up your pallet and go home."


Introduction

A Swaziland implements the cooperatives program in collaboration with the ministry of commerce, industry and trade, under the cooperatives department who provide the technical assistance on how to set up the cooperatives. The ministry has played a very critical role in terms of educating the school children on cooperatives and how to manage it, including their funds. As the programme has shown great success, JA has gone a step further in terms of ensuring that the funds that have been saved by the children are invested where they can accumulate interest and Lubane has played a big role in this. At least 4 200 children have been registered under Lubane Savings and Credit Cooperative where their funds are deposited on a weekly or monthly basis. This has been a very huge milestone for Junior Achievement.

This week, I took time to visit the leading school in the cooperatives programme which is Dvokolwako High School, a school that has saved over E20 000 in four months. Each learner has a minimum saving of E5 per week. This basically entails that a learner is required to at least save a minimum of E1 per day. It is, therefore, an affordable amount that most members in the cooperative are able to comply with and even go beyond the stipulated amount. The cooperatives members were able to also stipulate a guiding principle which entails that "any member of the cooperative that will not save for four weeks will be forced to pay a penalty of E2 the next time the member presents their savings".

Muzi uvukile Mnisi, a teacher at Dvokolwako High School, who also facilitates the programme, explained that it has become an easy process to get the Form Two leaners to be fully engaged in the programme as they have fully understood the initiative and have taken 'to heart. "Every now and then, I become insurumental in motivating and encouraging the learners to keep up the good work, as this will benefit them in future,' he said.

He further mentioned that the school administration played a crucial role in addressing parents in a meeting about the cooperatives programme. This made the parents more interested in their children saving money for themselves to the extent that some parents call to check if his /her child is really saving on a weekly basis. The pupils are also running a lot of businesses which also contribute to their constant savings and the whole school is allowed to join, which makes the number of members increase as well

The opportunity to speak to some of the pupils on how this programme has transformed their lives and enhanced their understanding of money was very eye-opening and was able to present some very interesting testimonials.

Mzwandile Msibi was identified as the highest saver in the cooperatives with over E600 saved. "I get my pocket money on a daily basis. I have had to learn to put aside money that I can be in a position to save each day.

I have to admit that I realised that discipline is very hard when there are all these temptations to buy when you have money saved up. I, therefore, decided to make my mother a custodian of my daily savings and only take my money when we have collections at school. She has been faithful to give all my savings as per my daily submission to her," he said.

Lindelwa Skonela was identified as the most faithful saver within the cooperative. She has been able to save money in al the 13 collections that the cooperative has had.

MIND THAT **ERROR**



eople who categorise themselves under such are highly confused and their intention is to confuse others."

Can you spot the faulty diction in that sentence? You should, if you know what the word, "alphabet," means. One popular dictionary defines it as "a set of letters or symbols in a fixed order used for writing a language." Given the peaning of the word, "alphabet," you can see that it is the wrong word to have been chosen by the writer to express his idea in that sen-

Why is the choice of alphabet wrong, you ask? Ha, because it is impossible to include the alphabet in any abbreviation, especially the ones the writer had referred to in the story, these being: LGBT, LGBTI, LGBTOI, and LGBTQIP. The English alphabet, the last time I checked, is made of 26 letters, and the longest abbreviation we have here has just eight letters. Can you now see why "alphabet" is a faulty diction?

That, however, is just the first part of the question. The second part is judging whether the lexical misappropriation is one of ABUSE,

ESTIMATING FAULTY DICTION

CONFUSION, or MISUSE of words - the trifactor we abbreviate as ACM. If you ask me, I will put this error of faulty diction down to the middle member of the tri-factor, to wit, CON-FUSION.

The writer has confused "alphabet" with "letter." It is like mistaking a team for one player, or a forest for one tree. The sentence should be revised to read: "The fact that the LETTER is included as an abbreviation for Queer shows that even the people who categorise themselves under such A GROUP are highly confused and their intention is to confuse others."

The fourth paragraph of the same news story reads, thus: "The letter speculates that Emaswati will not tolerate the destruction of morality and acceptance of morality and acceptance of sodomy and they should also be aware that there is no such thing as 'gay rights.'" "Speculates?" Is "speculate" the correct word that we can use about a letter making the claim that a group of people is destroying the culture of Swaziland?

Well, certainly not! Two other words may be more appropriate. They are "assert" and "asseverate." We may choose the latter for purposes of elegance and emphasis. So we may revise the sentence, thus: "The letter ASSEVERATES that Emaswati will not tolerate the destruction of morality and acceptance of morality and acceptance of sodomy and they should also be aware that there is no such thing as 'gay rights."

Now for the harder part of the question: Do you judge this faulty error to be that of lexical abuse, confusion, or misuse? Your guess is as good as mine, but if you say it is that of MIS-USE, I will second the motion with no qualms!

"Corruption, bane of public procurement" was the title of the first editorial in the Times of Swaziland, January 30, 2018. Its opening sentence read, thus: "Public procurement is one of government's activities most vulnerable to corruption."

The word at fault here is "vulnerable." I cannot say for sure that this is an abuse, confusion, or misuse of words.

However, if were forced to choose among the three, I would say: MISUSE. Instead of "vulnerable," we should say, "susceptible." Whereas "vulnerable" means, "weak and easily hurt emotionally or physically," "susceptible" means, very likely to be influenced, harmed, or affected by something. According, the sentence should be revised, thus: "Public procurement is one of government's activities most SUS-CEPTIBLE to corruption."

PLAYING NICELY WITH EACH OTHER is the title of an article in the LifeStyle Magazine, Sunday Times, June 17, 2018. Paragraph 12 of the piece reads, thus: "The real issues around racism are institutional and SYSTEMATIC but

This programme has made me responsible with money to the extent that I am now able to recognise business opportunities. My outlook in life when it comes to money has shifted from self to considering other people.

My current business is able to assist me buy bread for my family every day, which is something that we were not able to do previously," she said. Conclusion: As JA Swaziland continues to roll out the financial literacy programme, the priority remains ensuring that young people fully understand what money is and how it can work for them.

The sooner they are able to grasp that concept; the sooner they will recognise that wealth accumulation relies on how one is able to use money. In order to create an economically stable Kingdom of Eswatini, it become a necessity to expose young people to financial literacy education and prac-

his past Wednesday, the Eswatini Tourism Authority (STA) announced the commencement of the voluntary grading exercise for hospitality accommodation facilities.

Such facilities are hotels, lodges, B&BS, self-catering, and campsites. Application for voluntary grading starts on August 1, 2018. While the entire hospitality industry is excited over this development, the STA would like to encourage all establishments to embrace this initiative, given that it comes with multiple benefits. With competition higher than ever before, and customers quick to grab a bargain with their increased access to online booking sites, accommodation establishments in the hospitality sector need to be able to 'pitch' themselves as effectively as possible. Although people have always been taught not to judge a book by its cover, all the rules fall to the wayside when the hospitality industry is involved, mainly because guests make very quick decisions based on sometimes superficial information.

The accommodation star rating is an effective way to tell potential customers exactly what the establishment has to offer. In most instances, the ratings also determine pricing, hence affording guests an opportunity to budget accordingly. The STA will be awarding ratings from one to five star, with five star denoting high-end facility. Ordinarily, establishments will be expected to display their star plaques at the entrance, door, as well as reception areas. They will also quote the same star rating in all their official advertising paraphernalia, both print and online, so as to send a consistent message.

However, with the advent of the digital world, many travel sites have developed their own ratings, which is based mainly on user opinion as opposed to regulations adherence. Online star ratings are not as straightforward unfortunately, by and large because ratings vary between travel sites which base much of their information on the customer feedback that is submitted to them. Unfortunately, this can make consistency an issue.

While, now that grading in Eswatini will be voluntary, there may be some few industry players who may still be contemplating whether the exercise will be of any benefit or not. Paying attention to one's star-rating (or indeed just having one in the first place) can impact the business for the better. As already stated; guests are drawn to concise and, what seems to be, truthful information. Furthermore, the stars

could very well be the first thing prospective customers see; hence they play a major role in helping guests choose between one's venue and others in the same area.

It is important to realise that each and every star that represents any accommodation facility means something and can affect that establishment's revenue. It is critical, therefore, that industry players take absolute pride in their establishments, as well as the time to get rated. It could prove all the difference to the overall success of their hospitality business.

Explaining the grading procedure to industry players, the STA revealed that soon after applying for grading, an assessor will call the establishment to set an appointment. The assessor will then visit the facility, and assessment will be done in strict adherence to the grading guidelines, which are readily

available for download from www.thekingdomofeswatini.com. The assessor will then compile a report, which will be then submitted to a grading committee. The committee will study the report, and either query or accept it. Having satisfied itself, the committee will either recommend re-assessment (in the event of queried reports) or award a star rating (in the event of an accepted report). It is essential to note that while grading is voluntary, only registered accommodation facilities can apply to be graded. Registration of accommodation facilities is compulsory, and is done by the Ministry of tourism and environmental affairs, while grading is voluntary and will be done by the Eswatini Tourism Authority (STA). 

Not to make you wrack your brain too much, we have highlighted the word that the writer has wrongly chosen to use in that sentence: SYS-TEMATIC. To what can we attribute this lexical misappropriation: abuse, confusion, or misuse?

I would say: Confusion. The word, "system," is quite familiar, and so is the adjective that comes from it, "systematic." The problem is: "System" is noun with many meanings. It may refer to a way of doing things or to an entity, something that includes many other parts that can be considered as things by themselves.

The adjective "systematic" pertains to a way of doing things, not to an entity. Find the correct word in the revised sentence that follows: "The real issues around racism are institutional and SYSTEMIC; but I tell you what: I am far more comfortable in a whole lot more spaces than I ever was before."

Methinks it is rather easy to confuse the two words: SYSTEMIC and



SYSTEMATIC. Whether you concur or not, I do not know! 50 YEARS OF UHURU YET FREE-DOM STILL ELUSIVE (1) is the title

of an opinion piece in the Times of

Swaziland, January 15, 2018. This is

its opening sentence - quite a long one: "This the year of our Lord 2018 is a milestone in the history of this the Kingdom of eSwatini and the Swazi nation at large in more ways than one, as it is half a century since

independence from the British in 1968 and, similarly, the 50th birthday anniversary of the Sovereign, His Majesty Kind Mswati III - ably termed 50/50 anniversary."

Unless my sense of phonetics is terribly awry, I cannot say that the faulty diction in the foregoing sentence is a malapropism, because the word, "ably," does not sound the same to me as "aptly." But this is the correct word that should have chosen for use in that sentence. The phrase should be revised, accordingly: "APTLY termed 50/50 anniversary." "Apt" means, suitable or appropriate in the circumstances."

If you ask me to estimate the kind of mistake, I would say that choosing to use "ably" instead of "aptly" in that sentence is a faulty diction of misuse. But what do you say: Is it that of abuse, or of confusion?

Oh, lest we forget, there is yet that kind of faulty diction which we cannot say is an abuse, a confusion, or a misuse of words. It is that which is a MISPRINT of words, and it is known simply as a TYPO.

"Well said Your Majesty!" is the title

of the first editorial in the Times of Swaziland, June 22, 2018.

The second sentence of the first paragraph of the editorial reads, thus: He would not have put it any better as he stated that those who committee such acts were bringing a curse to themselves."


the signing.'

Coutinho ready for World Cup backlash

OSCOW - Brazil star Philippe Coutinho said he was ready for the backlash after the surprise World Cup quarter-final loss to Belgium.

A Fernandinho own goal and Kevin De Bruyne's fine strike helped Belgium to a 2-1 win in Kazan, where substitute Renato Augusto's second-half header gave Tite's men hope.

However, they were unable to find an equaliser despite a frantic finish, the favourites bowing out in the last eight.

"We wanted to go all the way to the final but we've given our best shot. Everyone gave everything," the Barcelona playmaker told SporTV.

"I'm sure will be beaten up by criticism from all sides. Life goes on, that's football. You win and you lose.

"We're sad because we wanted to win badly, like all Brazil. Unfortunately, we couldn't."

The 2018 World Cup may have been the last for several Brazil players, with nine of their 23-man squad in their 30s.

Defender Miranda, 33, was unwilling to confirm his international future, unsure whether it was his last appearance at the showpiece tournament.

"It's hard to talk about it ause all players here are part of a generation," he said.

"I won't say goodbye, but I also won't confirm that I'll be there for the next World Cup." *Goal*



'BITTER' BRAZIL BOSS TITE KEEPS QUIET ON FUTURE

OSCOW - Brazil coach Tite left questions hanging over his future but refused to point the finger as the five-time champions crashed out of the World Cup after a 2-1 quarterfinal defeat to Belgium.

Four years after the drama of Neymar's injury and a humiliating 7-1 semi-final defeat to Germany on home soil, Brazil were forced back to the drawing board as they followed neighbours Argentina, Uruguay and Colombia in exiting the tournament earlier than hoped. Brazil had been undefeated in their last 15 games under Tite, a streak in which a resurgent Selecao had conceded only three

goals

Their World Cup hopes were turned upside down in 31 first-half minutes when Fernandinho's 13th minute own goal put Belgium ahead before a superb strike from Kevin De Bruyne left Brazil, and Neymar, staring at a spectacular defeat. Tite admitted it was a "bitter" defeat, but he brushed aside suggestions he could resign.

"I'm not going to talk about the future, I'm not thinking about the future," said the 56-year-old.

"I will do a general assessment of the match and our campaign, but I won't be making any comments on individuals.

"This is not very human. And

we also have to look at the global context. "We played a match in which we had lots of possession, a lot of opportunities, but in terms of effectiveness... Belgium managed to turn their opportunities into goals. "They weren't superior to us on the pitch, but more efficient. That's certain." Neymar, who appeared in great form when scoring once and setting up another in a 2-0 last 16 win over Mexico, failed to spark on the night despite testing Belgium keeper Thibaut Courtois at the death. The Paris Saint-Germain star, left in tears at the final whistle, refused to talk to waiting media. Real Madrid defender Marcelo, who was a threat

to Belgium throughout, thanks to his marauding runs down the left flank, summed up feelings when he said: "It was a horrible night." Tite could only concur.

"It's a heavy, bitter feeling. This was very hard for us to swallow," he said. "I'm not going to say we were unlucky. Belgium have top quality players like De Bruyne, (Romelu) Lukaku, (Eden) Hazard and even (Vincent) Kompany and Courtois. "They're top players."

As Brazil's dream of a recordextending sixth World Cup ended, Roberto Martinez's Belgium ended a 32-year wait to reach the final four of the tournament.

Lukaku shows he is capable of more

OSCOW - Belgium's
Romelu Lukaku moved
closer to his desire to be
considered more of an all-round
footballer with an assist that set
up Kevin De Bruyne for the decisive goal in Friday's World Cup
quarterfinal win over Brazil.

The powerfully built striker showed a quick turn of pace as he moved out of defence after Belgium won possession from a corner, crossing the halfway line and driving upfield before feeding De Bruyne, who then advanced a few metres before striking a superb shot into the corner.

It ensured Belgium a 2-0 half-time lead and although Brazil pulled one back after the interval, proved the difference at the Kazan Arena, propelling Belgium to the last four of the World Cupfor only the second time.

"Everyone thinks comelu Lukaku is ust about goals, goals," said the Manchester United player, "but I want to be seen as an all-

rounder. Providing assists is also important, and this year I have provided more than ever.

"Of course, I want to score but, at the same time, I try to work as hard as I can for the team. I don't have to prove myself any more (as a goal-scorer). Everyone knows I can score with every chance provided to me in the box, but the individual doesn't count here."

For De Bruyne, the euphoria that followed Friday's win needs some tempering with nothing achieved yet by Belgium's "golden generation".

"In football it's all about the winning of titles and it is when I've won trophies that I have had my greatest memories in the game. Scoring against Brazil is not the best moment of my career.

"We haven't won the World Cup. For that we still need to win two more matches," De Bruyne added. It starts with the semifinal against France in St

Scoring his first goal of the World Cup, France defender Raphael Varane has turned his thoughts to how his team can stifle Belgium's potent attack when the sides meet in Tuesday's semi-final in St Petersburg.

Varane, who headed home Antoine Griezmann's free kick to open the scoring for France in their 2-0 quarter-final victory over Uruguay on Friday, said he was pleased at how France's relatively young team was maturing as they progressed.

"I'm happy to have been decisive (by scoring). It's a great pleasure," the Real Madrid centre back told reporters yesterday. "We were faced with a physical challenge yesterday and we dealt with it.

"Experience counts in these big competitions and it helps to avoid small mistakes. We have a relatively young team, but we've shown maturity and have been growing since the tournament started.

"We're solid defensively and have been able to adapt to our opponents. We can also vary our game, which it is a massive strength." Belgium showed plenty of attacking flair in their 2-1 win over Brazil in the other quarter-final and Varane singled out forward Romelu Lukaku and playmaker Eden Hazard as two of the players the French would have to be wary off. "It's a World Cup semifinal... there are no favourites," he added. "We'll have to outdo ourselves and give our best, take each match as it comes, and see how far we can go. "Belgium are young, but they are maturing. We know it will be a tough match.... Romelu Lukaku's physicality can trouble any defence. We can't leave him any space because he's a quality player. "As for Eden, I've already played against him when he was at Lille. He has great qualities and is a good dribbler. We can't give him any space either, so it is going to take a collective effort." Goal





AMARA - England have booked their place in the semi-finals of the World Cup after bettering Sweden in Samara and coming out on top with a 2-0 victory.

The Three Lions took first blood in the fixture courtesy of Harry Maguire, rising highest on the half, hour mark to meet an Ashley Young corner and send the ball crashing into the back of the net.

After surviving an early scare early in the second half, England soon had their second, with Dele Alli heading home Jesse Lingard's first-time, curling cross.

Harry Maguire and Dele Alli scored headers as England booked their place in a first World Cup semi-final since 1990.

The Three Lions will face either Croatia or hosts on Wednesday.

Russia England dominated after making a slow start, Maguire scoring from Ashley Young's left-wing corner after half an hour to put Gareth Southgate's side on track. Jordan Pickford made tremendous saves to deny Marcus Berg and Viktor Claesson either side of Alli doubling England's lead, the midfielder nodding in Jesse Lingard's centre.

Although the World Cup's top scorer Harry Kane was muted, England held Sweden at bay to follow up their penalty success against Colombia with a more comfortable victory.

Sweden had advanced from three of their four previous World Cup quarterfinals but could not find a way to beat Pickford as the Three Lions marched on to the semis.

Claesson hammered the game's first shot over the crossbar in the 12th minute as a cagey start saw both sides play loose passes due to early nerves.

Raheem Sterling then set up Golden Boot leader Kane, who slotted wide, with England - playing in their first World Cup quarter-final since 2006 - starting to find their feet.

And they took the lead in the 30th minute with their eighth set-piece goal of the tournament.

Young's outswinging corner found Maguire to power home his first international goal, goalkeeper Robin Olsen and Ola Toivonen on the line unable to stop the defender's downward header.

The offside flag spared Sterling's blushes when Kieran Trippier's long-range pass sent him clear to miss and the forward soon wasted another chance from Jordan Henderson's lofted throughball.

Olsen did well initially with a strong hand to deny Sterling, who dallied with the rebound and allowed Andreas Granqvist to make a vital block.

Pickford was called into action for the first time shortly after the restart, diving to his left to palm away a header from Berg, who climbed above Young at the back post. *Daily Mail*

Anderson predicts next African star '10-20 years away'

ONDON - Kevin Anderson believes it could take "10-20" years before Africa produces another Grand Slam contender such as himself.

The big South African, ranked at eight in the world, reached the Wimbledon last 16 on Friday for the fourth time. He has already struck a blow for the continent by becoming the first South African man in 33 years to reach a Grand Slam final when he finished runner-up to Rafael Nadal at the US Open last year.

However, the cupboard is bare otherwise. He is the only South African man in the top 200. The leading Egyptian is 27-year-old Mohammed Safwat ranked at 175, while Morocco's

top man is Lamine Ouahab at 629.

That is particularly heartbreaking for the proud North African nation which in the 1990s boasted the likes of Younes El Aynaoui, who reached 14 in the world, Hicham Arazi, a former No. 22, and Karim Alami who peaked at 25.

Alami even defeated the great Pete Sampras in his prime.

"I have been at the top of South African tennis for pretty much a decade now," said Anderson.

"I have always said my biggest hope is that players, especially junior players in South Africa, watch me on TV or wherever, I'm a sort of source of inspiration for them to pick up the game of tennis, to pursue it." AFP


World No. 1 Simon Halep knocked out of Wimbledon

ONDON - World No. 1 and French Open champion Simona Halep was knocked out of Wimbledon yesterday, losing to Taiwan's Hsieh Su-Wei 3-6, 6-4, 7-5 in the third round.

Hsieh, the world N0. 48, battled back from 2-5 down in the final set and halted Halep who served for the match at 5-3 in the decider.

It will be Hsieh's first appearance in the last 16 of a Slam where she will face Dominika Cibulkova of Slovakia for a place in the quarterfinals.

"It's my first win against a world number one," said 26-year-old Hsieh. "It's amazing. I was 2-5 down in the final set but the crowd pushed me to fight." *AFP*



Hamilton pips Sebastian Vettel to land record sixth British Grand Prix pole position

ONDON - Lewis Hamilton is perfectly placed to win a record sixth British Grand Prix after snatching a dramatic pole position at Silverstone.

Hamilton and title rival Sebastian Vettel traded blows during a topsyturvy qualifying session, but the Briton took his fourth consecutive pole and sixth in total at his home race with his final lap.

Hamilton's 1:25.892 was a new lap record at Silverstone and edged out Vettel by less than a tenth of a second.

Vettel – who leads Hamilton by a single point in the championship after nine races – will start alongside his fellow four-time world champion on the front row with Ferrari team-mate Kimi Raikkonen in third and Valtteri Bottas fourth. The Red Bulls of Max Verstappen and Daniel Ricciardo will line up on the third row. 'I gave it everything I could,' said a breathless Hamilton. 'It was so close between these Ferraris, the Ferraris just pulled something out when it got to Q3 and I was just praying I could do it for you guys [the fans].'

Vettel said: 'I was very happy with the last lap but we seemed to lose a lot of time on the straights. I'm happy with second and it gives us a good chance for tomorrow.'

Vettel had treatment on a neck strain before qualifying, but showed no ill effects as he drew first blood.

The German's 1:26.585 was more than two tenths better than Hamilton's opening salvo.

Hamilton responded with a 1:26.256 in the second session to edge Vettel out by a tenth.

Hamilton became the first man to dip below the 86-second mark at the start of the final session, but Vettel eclipsed his effort by just six one-hundredths of a second moments later. *Daily Mail*

Nadal, Del Potro, Raonic reach fourth round

ONDON - Two-time champion Rafael Nadal reached the Wimbledon last 116 yesterday and made sure of keeping the world N0. 1 ranking at the same time. The second seed comfortably defeated Australian teenager Alex De Minaur 6-1, 6-2,6-4. Nadal, the 11-time French Open champion and bidding for an 18th career major, will face either Italy's Fabio Fognini or Jiri Vesely of the Czech Republic for a place in the quarterfinals.

Fifth seed Juan Martin del Potro overcame service troubles and Benoit Paire's fine serveand-volley game to beat the Frenchman 6-4 7-6(4) 6-3 on Court Two and reach the Wimbledon fourth round for the fourth time yesterday. The big Argentine world number four, who has yet to drop a set, looked on for a routine win before meeting sterner resistance in the second set from Paire, who delighted the crowd with his drop shots and a break of serve to go 4-2 up. Del Potro, a semi-finalist in 2013, immediately broke back after a slip by Paire and fears he might have hurt his heavily bandaged knee, but the Frenchman resumed and saw the set through to the tiebreak, but lost it 7-4. The 47th-ranked Paire, who reached the fourth round last year and won his only previous meeting with Del Potro in Rome in 2013, then had a rant at the umpire after a successful challenge to an out

"What are you doing, it was right on the line," he shouted evidently unimpressed with the umpire's calls. Del Potro, looking for a second Grand Slam title after the US Open in 2009, marched into a 3-0 lead in the deciding set only to allow Paire back to 3-3 with a broken service game that included three double faults. *AFP*

'Nothing left in the tank over 1500m'

OHANNESBURG - Go hard or die trying. That was pretty much Caster Semenya's approach in Thursday night's metric mile at the Lausanne Diamond League meeting where she finished in sixth place.

Semenya still managed to post the second fastest 1 500m time of her career, crossing the line in 4:00.44. Covering the first three laps in Lausanne at a suicidal pace, Semenya's wheels came off with 200 metres to go. "The last 200m I just had nothing left, I thought I would be able to change the last gear but it wasn't there and it wasn't meant to be," Semenya said.

"There was just no movement, there was no power from 200m. I ran a good race but at 200m I couldn't lift the legs."

Semenya decided to stay with a flying Gudaf Tsegay of Ethiopia, who desperately tried to shake the South African. "I've never chased someone like that in my whole life but I knew we are going to chase Tsegay," she said. "Of course you need to run your own race and at the end of the day you need to try your best but it just wasn't meant to be." With her tank running on empty, the world's best two-lap racer had to watch as the rest of the pack moved past her. American Shelby Houlihan produced a ruthless kick, winning the race clocking the second fastest time in the world this year of 3:57.34.

She was followed by Great Britain's Laura Muir in second place with 3:58.18 and Sifan Hassan of The Netherlands in third place posting 3:58.39. Semenya was left perplexed about how she had let the race slip from her grasp, with coach Samuel Sepeng looking to find answers in the post-mortem.

"It is about planning, we will have to go back to the drawing board and see what happened today," Sepeng said. *AFP*


especially after encountering an accident in the opening stage of the race.


The player, who was a marvel to watch during the match, dribbling and passing with unmatched accuracy and precision, deservedly grabbed three goals in the match.

'Birds' have a month to sort out Kola issue

OCCER - Mbabane Swallows have about a month's time to sort out the issue of striker Kola Aledeon and successfully register him for the 2018 CAF Champions League group stages.

Swallows are desperately trying to register the Nigerian striker whom they have a three-month contract with specifically for the Champions League. However, the player has not obtained his clearance certificate from Manzini Wanderers, the side he turned out for last season. Wanderers claim that Aledeon has a contract with them and is thus their player.

The matter has now been taken to the Eswatini Football Association (EFA) Players' Status Committee where it will be discussed today after its postponement last week Thursday. Even though Aledeon has begun training with Swallows, it now seems certain that he will not feature for the 'Birds' in their third Champions League group stage match against Etoile Du Sahel next Tuesday.

Swallows will now hope to finalise the issue before August 10, which is the second registration deadline for clubs playing in CAF interclubs competitions.

"A player who is qualified to play in the CAF Champions League must: (a) Possess a licence in his club issued by its national association and registered in his federation on the 15th January of the year of the competition at the latest for the first period of registration and on 10th August of the year of the competition, at the latest for the second period of registration," reads part of the Champions League rules and regulations.

In a letter dated June 27, Swallows General Manager Sandile 'Beyond 2000' Zwane wrote to the EFA, reporting Wanderers to the football mother body for refusing to hand them Aledeon's clearance.

"We are, however, experiencing difficulties in registering the player with us and for the CAF Champions League because his former club (Manzini Wanderers) is refusing to hand us the requisite player's clearance certificate.

We, therefore, request the Football Association's assistance in the matter so that we can dully register the player in readiness for our match against Club Etoile Du Sahel on Tuesday July 17," reads part of the letter which this publication is in possession of.

After the Sahel home match on July 17, Swallows will then travel to Tunisia to face Sahel on July 27. The 'Birds' will then take on Zesco United on August 18 before completing their group campaign with a clash against Primeiro De Agosto on August 28.

Swallows will now be hoping that incidents like Thursday's, which saw the Player's Status Committee fail to form a quorum and ultimately result in the postponement of the case, will not happen again.

'Bull' star off to Malta

CROATIAEDGE RUSSIA ON PENALTIES, FACE ENGLAND

OCHI - Croatia will face England in the semi-finals of the 2018 World Cup after they defeated hosts Russia 4-3 on penalties yesterday evening.

The match started at a high tempo, with Russia not giving the Croats space and time to play in the middle of the park.

Ivan Rakitic had a chance to open the scoring for the Croats in the 15th minute with a free-kick on the edge of the box but his strike sailed over the crossbar.

Denis Cheryshev broke the deadlock for Stanislav Cherchesov's men on the half-hour mark with a sensational strike from outside the box. Andrej Kramaric replied for the

Croats five minutes before halftime

with a power header inside the box following a delicate cross from Mario Mandzukic.

Both sides were probing for the second goal in the closing minutes of the first stanza, but they went into the dressing room deadlocked at 1-1. After a lively start to the second half. Ivan Perisic should have sent Croatia ahead on the hour-mark but his low strike from the edge of the box crashed against the post.

Russia increased their tempo 20 minutes before time, combining well in their passing rhythm but the Croatians kept their shape at the back.

Neither side could find a winning goal in the closing stages of the second half, forcing the clash into extra,

which both nations had experienced in the previous round.

Domagoj Vida made it 2-1 for Croatia 10 minutes into the second stanza with a fine header that sailed into the bottom corner. Cheryshev's troops were pressurising the Croats looking for the equaliser but the Vatreni managed to go into the break of extra time leading 2-1.

The hosts sent the clash into a shoot-out as Mario Fernandes equalised for Russia five minutes before time by heading home a cross from Alan Dzagoev. However, it was the Croatians who held their nerve in the shoot-out to triumph 4-3 and will now face England on Wednesday.
