# Shongwe's bail application continues to pack them

AS usual the day started with the unique sound of police sirens as vehicles from both the Royal Swaziland Police Service and His Majesty's Correctional Services made their way into the High Court premises.

However, this time the police OSSU division used an armored truck to transport Shongwe.

The convoy arrived at or about 8:30am where two open canopy correctional services vans were leading the armored truck which was being closely followed by a white Toyota double cab also from the correctional services.

As the fleet made its way into the High Court tunnel which leads to court D, a blue Toyota RunX, blocked its path as it was negotiating its way to find a parking space, this seemed to infuriate and enrage the armed correctional officers who alighted and violently ordered the driver to make way, while blasting their sirens sending the female driver into a frenzy.

While in that panic mode, more officers joined the fray, some hurling all sorts of unpalatable words at the shaken woman who was frantically trying to move her car to make way for Shongwe's cavalcade until she was finally directed towards the court building.

#### Shaking

The woman who was still shaking when she alighted turned out to be a Mbabane Swallows fan who was conveying others in her car, three of them females and one male were clad in the Mbabane teams regalia as they also had come to hear how the matter would proceed. Inside courtroom D, over 60 people overflowed the relatively small court, while the accused Shongwe who was flawlessly dressed in a blue suit and white shirt was seen inside a booth where he sat while he conversed with his lawyers Sipho Mnisi, Ben J. Simelane and Advocate Van Vuuren who was present in court for the first

# Mbabane Swallows, Matsapha United fans clash at High Court

AS Sipho Shongwe's Matsapha United FC fans made their way out of the High Court premises, a huge altercation erupted which saw police running helter skelter trying to control the situation that almost saw blows being traded.

Information gathered was to the effect that the whole fracas began when a Mbabane Swallows fan parked his car in the middle of the road leading to the High Court, causing a traffick jam.

When Matsapha United fans that had come to the High Court to attend Shongwe's bail application were making their way out, they were blocked by the Swallows fan's car.

This is what allegedly started the

altercation where expletives and insults were exchanged between the now bitter rivals.

However, due to the heavy police presence it all ended with exchange of words and no physical contact.

Case

Chief Police Information and Communications Officer Superintendent Khulani Mamba, in an interview with this publication yesterday confirmed the incident however, he said that no case had been reported.

Mamba condoned such behaviour as it was unbecoming and said as the police they would continue to ensure safety of the public at the High Court even after the latest incident that almost saw blows being exchanged.

EVER since the filing of his bail application, arrested businessman Sipho Shongwe had remained silent in court without uttering a word save for what is contained in his court papers.

Things changed yesterday when Shongwe who is accused of killing businessman and soccer boss Victor Gamedze was put on the spot by Judge Sipho Nkhosi when he proposed postponement of the bail hearing.

Judge Nkosi asked Shongwe if he would be agreeable to remain remanded in jail for another week.

The judge was motivating for a postponement of the matter and wanted Shongwe's concurrence.

Judge Nkosi stated that he had only received Shongwe's responding papers to points raised by the state in its papers where it is opposing bail.

He said the papers were filed outside the permitted time on Tuesday at about 4pm.

He said the papers were bulky and had

many contradictions in them from his mere perusal and he was convinced that he would need more time to read through them with appropriate scrutiny in order for him to decide from an informed perspective.

# Public demands a bigger courtroom

AS Sipho Shongwe, murder suspect in Victor Gamedze's assassination made his third High Court appearance for his bail application yesterday morning, most people who had come for the case registered their concern on the unavailability of space inside Court D.

They pleaded with the Chief Justice Bheki Maphalala to provide a bigger courtroom in the future as Court D proved to be too small for the crowd that took up all the space with a lot more remaining outside the courtroom.

By 9am the court was packed to capacity with most people forced to remain seated on the floor while awaiting for the arrival of Judge Sipho Nkosi who

is presiding over the matter.

Members of the security forces comprising both the Royal Swaziland Police (Service) and His Majesty's Correctional Services had a tough time controlling those who wanted to force their way inside the packed court as they were turned back due to shortage of space.

#### Corridors

This situation resulted in the close to 100 people forced to squeeze themselves along the corridors leading to Courts E and F as most people were eager to follow the proceedings and in turn this proved to be a disturbance to the other courts as more noise was generated.

As the people in the court awaited the

arrival of Judge Nkosi who is presiding over the matter, more people flooded the court only to find that there was no longer space.

#### Function

One would have sworn that there was a function similar to that of the High Court opening which normally attracts a lot of people.

Immediately after Judge Nkosi had announced that the matter was post-poned due to late filing of papers by the applicant (Shongwe), a process that lasted slightly more than 10 minutes, the people left.

As the people left the court, they continued expressing their concern on the usage of the small courtroom.

These documents are very colossal and long, they were filed late on Tuesday. I have not been able to read them as they contain many incongruities, I therefore need more time so I can satisfactorily apply my mind to the issues raised especially those relating to the accused's past," said Judge Nkosi.

He also stated that he had received the letter supposedly written by Senior Crown Counsel Absalom Makhanya to the effect that Shongwe's lawyer had failed to file his responding papers on time and he therefore foresaw delays.

#### Letter

"Yes Mr Makhanya J received your letter pertaining to the issue of late filing of papers by the accused person's lawyers and I was also of the view that it would not be prudent at this point to advance with the bail application, however I don't know the attitude of Advocate Van Vuuren," said the Judicial Officer.

As Makhanya nodded in agreement, this also prompted Advocate Jacobus Van Vuuren to also speak for the first time in these proceedings where he said that he was also in consensus with what the judge was proclaiming.

"My Lord I couldn't agree with you more as indeed the documents are capacious and confidently require your Lordship superfluous time to go through,

it is indeed prudent my Lord that the matter be deferred," said the advocate.

This is when the ball was placed in Shongwe's court where he was asked if he would be agreeable to spending another week behind bars.

A calm Shongwe politely said he was comfortable and agreeable with spending another week behind bars as that would be in his best interest.

"As it pleases the court, my Lord I am agreeable and comfortable with spending another week at the remand as you have said that more time is needed in my matter," said Shongwe in a polite tone.

#### Attitude

Judge Nkosi on hearing the accused's attitude to a postponement said Shongwe should find it in his heart to forgive him and also that he should also forgive his lawyer and advocate for the inconvenience caused by the delays as he was cognisant to the fact that a day in prison is worth a thousand outside.

"Mr Shongwe please forgive me because the situation that is playing itself out is unfortunate as well as unintended, also forgive your lawyers for the inconvenience I know it's not easy," said Judge

The proceedings were then adjourned and are set to resume next Wednesday.

Most people had hoped that the matter would be put to rest yesterday after previous postponements.

It was this proclamation (postponement) by Judge Nkosi at the start of the hearing that seemed to disappoint the over 60 people in the jam-packed court D, including friends, relatives, attorneys and well-wishers who had come to show support to the accused businessman.

#### Trailed

First to arrive was Shongwe's lawyer Sipho Mnisi together with Advocate Jacobus Van Vuuren who were trailed shortly by the family, relatives, friends and sympathisers most of whom arrived in a white foreign registered VW 22 passenger Crafter bus.

Shongwe is currently facing a charge of murder, where it is alleged that he, acting in the furtherance of a common purpose with three others did kill Gamedze on the January 14 at Ezulwini Galp Filing Station.

The three others who were allegedly involved in the daylight killing of the late Gamedze include, Mbuso 'Ncaza' Nkosi, Siphiwe 'Ntjebe/Tata' Ngubane and one Sicelo 'Dzodzo' Zikalala who is still at large while Nkosi and Ngubane were arrested over the past weekend in South Africa.

# Swallows supporters paint High Court red

**MBABANE** Swallows supporters yesterday painted the High Court of Swaziland red as they came in numbers to follow proceedings in the ball application by murder suspect Sipho Shongwe.

Shongwe has filed an urgent bail application at the High Court as he stands accused of the murder of their team's boss Victor Gamedze who was killed in cold blood on January 14.

As early as 8:30am people started flocking in at the High Court premises as they wanted to be part of the proceedings in court and Swallows supporters who were clad in the team's replica shirts were seen arriving in groups and proceeding to Court D.

However, only a few made it inside the courtroom while the rest remained outside as police officers prevented them from gaining entry due to shortage of space. While squeezing themselves along the corridors of Court F, the Swallows supporters were overheard discussing something in hushed tones. As more people waited for the arrival of Judge Nkosi inside Court D, more and more Swallows supporters flocked in but some found the matter already postponed to a later date by the court. Immediately after the postponement, the Swallows fans who seemingly had organised themselves, started chanting slogans as they marched out of the main entrance of the High

Court building before they paused at the steps leading to the parking lot.

While paused there and waiting for others, they chanted slogans to the effect that "noma sihlupheka, noma sithwele kanzima" with police officers following closely as they monitored the situation. This happened as the convoy of heavily armed officers escorted Shongwe out of the court premises from the back entrance of the court.

This was not only the scene as Matsapha United supporters were also seen in a larger group walking past towards their Sprinter bus at the parking lot.

The Matsapha United supporters were also part of the people who were inside the court following the proceedings.

# Tight security as more escorts, police presence

WITH the numbers of people coming to follow the proceedings of Sipho Shongwe's bail application, the heavy presence of police continues to be felt.

Police and correctional services officers were littered in all strategic points within the High Court premises while there were armed officers from the Operational Support Service Unit (OSSU) and the Correctional Rapid Response Unit inside Court D.

Also noted was that senior officers from both security forces were present in court as they monitored proceedings while plain clothed

officers also did their part.

Immediately after the convoy of vehicles comprising four from the correctional services and that of OSSU approached from the direction of the Cabinet offices, members of the public including vendors and taxi men near the government hospital had their attention drawn to the convoy.

All those who had come to the High Court also had their eyes glued to the convoy as Shongwe was driven into the back of the High Court building before being led into Court D through the holding cells underground.



# Shongwe's wife shielded by close relatives, supporters

SIPHO Shongwe's wife Vuyiswa was delicately shielded by relatives, friends and supporters of Matsapha United FC when she entered the High Court premises and when leaving.

Upon arrival just before 10am Shongwe's wife who came a little bit late yesterday obviously with the hope that the matter would proceed, was driven in a silver Range Rover Sport as opposed to last week where she was driven in a white Toyota Fortuna whilst for the first appearance she was dri-

ven in a white Range Rover Discovery. Upon entering court, she followed the proceedings before the postponement and immediately after, was again shielded by the relatives outside the courtroom as the Mbabane Swallows supporters started chanting slogans outside. The group of relatives and supporters were seen taking Shongwe's wife to the car which was parked closer to the steps leading to the left wing of the High Court before she was eventually whisked away.







# SOUTH AFRICA'S VAT HIKE WONT AFFECTSD

THE hike in Value Added Tax (VAT) pronounced by South African Finance Minister Malusi Gigaba yesterday will not have a direct effect to Swaziland.

This was revealed by Finance Minister Martin 'Gobizandla' Dlamini in an interview yesterday.

Dlamini said he won't be negative or positive on the move as he and the ministry's officials were still working on finalising the budget speech to be delivered on Tuesday.

"I think the VAT hike will only have an effect when one is in South Africa. I don't wish to get that much into the subject as we are still busy finalising the country's budget speech and maybe the issue will be addressed on Tuesday," he



said.

South Africa's Finance Minister Malusi Gigaba announced an increase in value added tax by one percentage point from 14 to 15 per cent when he delivered the 2018 budget speech yesterday afternoon. Continuing with the "tough" theme from his mid-term budget last year, Gigaba announced that South Africa's first hike

in taxation on goods in 25 years. The increase is set to take effect at the beginning of the next financial year, on April

The hike in South Africa means that VAT will bring in R348bn in revenue with the cost of living for all households raising R22.9bn for the fiscals while below-inflation adjustments to personal income tax will yield 6.8bn.

Meanwhile, House of Assembly Speaker Themba Msibi announced that the budget speech will be held on Tuesday.

The speaker mentioned that the House would convene its first sitting on Monday and it is most likely that Finance Minister Martin Dlamini would present the national budget speech the following day.

The latest developments come after the opening of the fifth session of the 10th Parliament by His Majesty King Mswati III last Friday.

# We don't have 'Dzodzo' yet - Cops

POLICE have refuted claims that Victor Gamedze's suspect killer Sicelo 'Dzodzo' Zikalala/Luthango has been apprehended.

Rumours circulated on Facebook yesterday that 'Dzodzo' is in police custody after being apprehended while trying to cross the border to Namibia yesterday.

It turns out that there is no substance in the allegations as the police denied apprehending the prime suspect in the Victor Gamedze murder.

When sought for comment on the matter, Chief Police Information and Communications Officer (PICO) Khulani Mamba said there is no truth in these allega-

"No, we did not apprehend Dzodzo," he said briefly.

There was a debate among Facebook users on the matter as some disputed the claims while others sounded confident when asserting that he was indeed apprehended.

Worth noting is that the capture of two South African suspects in the Victor Gamedze murder case Mbuso 'Ncaza' Nkosi and Siphiwe 'Ntjebe/Tata' Ngubane first made rounds in social media, particularly Facebook, and the capture of the two was later confirmed by the police.

It remains to be seen if the rumours about the capture of 'Dzodzo' will take the same turn. National Commissioner of Police Isaac Magagula announced a reward of E450 000 over two weeks ago for anyone who might have information on the whereabouts of the Mbabane socialite, who is believed to be hiding in Mozambique.

# PM tells Parly to enact SODV into law soon

PRIME Minister Dr Sibusiso Dlamini has pleaded with parliamentarians to have at least passed the Sexual Offences and Domestic Violence Bill into an Act by the time the fifth session of the 10th Parliament comes to an end.

Making a submission yesterday in Senate, the PM said the legislators had a challenge to wrap up work they had already begun and to make sure that bills that would benefit the nation like the SODV became law.


The premier said the SODV Bill was an important one that needed to be made law soon because a lot was riding on it.

He said the bill had been in an out of Parliament for so long and was about time that legislators passed it in order to protect women, children and men alike from sexual offences and domestic violence.

He said His Majesty, in his speech during the official opening of Parliament, had observed that violence was very rife in the country hence this bill would help in curbing it, especially towards vulnerable communities.

"Swazis are watching us and they want this bill to be passed into an Act. We must, therefore, not slack or appear to do be slacking because it is not just Swazis who are watching us as far as this bill is concerned but the international community is also watching us. The United Nations is also watching us so we must act fast," he said.

Dlamini pointed out that the bill also needed the legislators to apply their minds when dealing with it because while it was important to have it passed into an Act it was also important that Swazi Law and Custom be considered.

"It is common knowledge that some necessary instruments in dealing with parts clash with our law and custom so while dealing with it we must apply ourselves because while we tant that we apply ourselves and find ways to balance out the two so they co-exist," he said.

The PM stated this when moving a motion that the legislators thank His Majesty for his presence and address during the official opening last Friday.

People are violent and this is evident by the murder that recently took place in broad daylight in front of people where a person took out a gun and shot another.

That is not normal in peaceful Swaziland. Every day you go through papers you read stories of women and children being subjected to brutality," she said.

# Don't use corruption to spite people - Senator Shongwe

SENATOR Sibusiso Shongwe has warned against the use of corruption cases to spite people.

The senator was speaking yesterday in Senate after Prime Minister Dr Sibusiso Dlamini had moved that senators thank His Majesty for the speech from the throne delivered last Friday.

Making his submission, Shongwe said corruption would continue to be a problem in the country so long as people who were corrupt were being allowed to roam the streets while there were people who were charged with corruption just to spite them.

Shongwe said the fact that His Majesty King Mswati III had started in 2005 directing Parliament and the other two arms of government to uproot corruption was a sign that nothing was being done on that front.

"We have failed as far as uprooting corruption is concerned, His Majesty has been talking about this since 2005 and to date corruption continues to be a problem in the country and our biggest problem is that corruption is used to settle scores. People are charged with corruption to spite them," he said.

The senator said it would, therefore, be unfair to pass on the button to the Judiciary or even blame the Judiciary for the rife corruption.

"We can't say corruption is rife because the courts or Judiciary isn't doing enough. They are actually doing well under the circumstances," he said. The senator stated that a minister had once said in Parliament that government lost E90 million a month but there was no investigation into that and no one had been brought to book for that.

"As we speak, there was a person whose image was tainted just to spite him. He was a managing director of a company and when you follow the charges levelled against him you don't even make sense of the case," he said.

Senator MoiMoi Masilela said it was time legislators admitted that they had failed as far as the fight against corruption is concerned.

"We must just admit to Their Majesties that we have failed," he said. Prince Fipha said while it was clear that there was no improvement in the fight against corruption, it would be a shame to give up. He said government should send investigators to learn from other countries that uprooted corruption.

The PM, responding to the submissions, said the downside of it all is that people who had been charged with corruption never at any point admitted that they were indeed corrupt hence the process must take place and let it be the one to prove either they are guilty or innocent.

The prime minister further said corruption cases were taking forever to be finalised at the counts. "Some cases are 20 years old and people are out on bail.

What are the odds the witnesses are still alive? Obviously the accused is dragging out hoping and praying that the witnesses die in such instances," he said.

Senator Shongwe currently stands accused of corruption after he was charged by the Anti-Corruption

# DR AT CALLS FOR SISWATI PRESERVATION

SWAZIS should know that for them to achieve sustainable development, they must preserve their indigenous language, which is SiSwati.


This was said by Tibiyo TakaNgwane Managing Director Dr Absalom Themba Dlamini during the Mother Tongue Day celebrations yesterday at Royal Swazi Convention Centre in Ezulwini.

This is a day held the world over, in remembrance of children who died in Bangladesh just because they wanted to be taught in their mother tongue in schools on February 21, 1952.

Yesterday's event was hosted by Macmillan Swaziland and United Nations Education, Scientific, and Cultural Organisation (UNESCO).

Dlamini commended the Swazi nation for striving to keep their culture. He said even though the language was proving to be slowly losing its originality, something could still be done to preserve it. Swazis should not lose hope and think that everything has gone away.

Swazis, according to Dlamini, were a lucky nation because they could still communicate in SiSwati. They had not reached a stage whereby they had to pay exorbitant amounts of money to restore their cultural identity. The MD advised this nation to take a leaf from countries such as



France and China.

These countries were proud of their languages and they did not want anyone to deviate them from speaking their mother languages.

#### Native

"One day I was in France, I wanted to go to offices of their communication ministry. I found a certain lady there, who happens to be a native of France. I started speaking in English and she just looked at me. She then reminded me that I was in France, where only French was spoken, and not any other language. She told me to ask her to speak in English if I wanted our conversation to be in English. I had no choice, but to

earnestly beseech her to do so," Dlamini said.

It became clear to the director that the people of France had agreed amongst themselves to preserve their own language, which differentiated them from other nations. He urged Swazis to adopt such an attitude as they strived to achieve the first world status, of which France was part.

He said what should be noted about language was that it was a priceless asset that could be able to define a nation. Swazis were defined and differentiated because of their language. Even if a nation had money, without culture, it was nothing. He made another example.

"There was a conversation between an American and an Indian. The American mocked the Indian of his poor state back home in India. The American told the Indian that Indians were poor because they were densely populated and lived a low lifestyle. They did not have money. The Indian, in response, said America was poorer because its people were uncultured. They did not have a unified way of doing things that could differentiate them," he said.

He concluded by saying Swazis should always think about future generations as they practised culture, which included the SiSwati language. It would not be fair for the future generations to find that the present generation failed to preserve the language yet they found the original language preserved by the past generation.

# INDIGENOUS LANGUAGES LOST EVERY TWO WEEKS

INDIGENOUS languages are lost in every two weeks in the world, UNESCO Secretary Hazel Zungu has said.

Speaking during the World Mother Tongue Day celebrations yesterday at Royal Swazi Convention Centre in Ezulwini, Zungu said this was not an exciting fact because people were going to lose the way they communicated with one another.

What was more unfortunate, according to Zungu, was that the languages did not just diminish on their own but with other important aspects of a nation's culture, like idioms and proverbs. Some languages were more enjoyable when spoken with their proverbs and written with their idioms

Zungu said as UNESCO, it was their mandate to ensure that every February 21 of each year, the SiSwati language was commemorated. She said this year marked the 70th year since the United Nations (UN) adopted the Universal Declaration of Human Rights.

One of the human rights enshrined in that charter was for every human being in the world not to be despised because of his or her language. That human right should also be protected in order to protect indigenous languages from extinction.

She also reminded Swazis about the importance of learning other languages. That was important because Swazis did not leave in their own place in the world.

They also needed to cooperate with people who spoke other languages in order to achieve sustainable development.

# Sands hailed for marketing SiSwati

RENOWNED Swazi musician Sandziso 'Sands' Matsebula has been hailed as a hero for putting SiSwati on the map with his music.

Sands is popularly known for his hit song 'Tigi', which has been making waves in the international music arena. Most of the musician's songs are in SiSwati and the people, including non-Swazis, love it the way it is. The musician, who delighted most of the event's attendees with his presence, said SiSwati changed his life for the better.

"I have been singing for the past 10 years and during that time, I tried singing in different languages. However, the day I decided to sing in SiSwati, everything changed and my life was better. I started being invited for performances abroad," Sands said.

He encouraged Swazis to do whatever they did in SiSwati in order to market the language. People needed to know that Swazis were also part of the international community. This made most soapies to include people who were Swazis.

He said he once went to perform in Zanzibar, Tanzania. That place is one of the most visited and many different kinds of people were found.

Sands ensured that by the time he left the place, the people knew that there was a language called SiSwati which was spoken in Swaziland.







# Car smuggling rife at Kosi Bay border

THE tinkhundla report has indicated that Mdzimba/Lofokati Umphakatsi has been moved from Nkhaba to Mbabane East.

This was announced by the Elections and Boundaries Commission (EBC) yesterday when the commission visited Nkhaba Inkhundla.


EBC Commissioner Noumbi Maziya said the primary reason behind the move was that the people of Mdzimba were travelling long distances to the Nkhaba Inkhundla yet the laws governing tinkhundla entails that they should be accessible to the people.

"We have also recommended that Ekuvinjelweni Umphakatsi need to have bucopho who will be on the ground in the area as Nkhaba Inkhundla is very big hence the people of Ekuvinjelweni area will lag behind in development projects if they don't have someone driving their missions," he said.

The people did not object the move by the EBC to announce Mdzimba under Mbabane East, instead one Lusentfo Shabangu posed a question to the commissioner on what will happen to people of Mdzimba who were facing charges on wrongdoings while still under Nkhaba Inkhundla.

Maziya said 'licala kaliboli' and thus they will be recalled to face consequences for wrongdoings at Nkhaba.

"We have had many communities across the country requesting to have the remaining *inkhundla* in their areas but we have decided that we are not going to grant it to any of them for now. What we did was craft sub-tinkhundla that will divide big constituencies for the satisfaction and fair service

provision to the people.

The staff members of the main inkhundla will spend two days in a week at the sub-inkhundla and spend the other three days at the main one," he said. Nkhaba Member of Parliament Menzi Dlamini said he was content on the developments and expressed happiness for the people of Mdzimba for being attached to Mbabane East as they had difficulty coming to Nkhaba.

"They were utilising Mbabane for

most of their services and it was only fair that they get attached to Mbabane East because they couldn't have direct access to Nkhaba, instead they had to go via Mbabane which is against the regulations that govern tinkhundla.

I must say though, that I invested a lot in the area as far as development is concerned and I was going to have a fair share of votes going to the elections but I'm happy for them," he said.

# Ncumbi pledges financial support to accident victims

ELECTIONS and Boundaries Commission (EBC) Commissioner Neumbi Maziya pledged to give financial support to the victims of last Friday's kombi accident that claimed eight lives.

Six people died on the spot while the seventh and eighth died while undergoing treatment at the Mbabane Government Hospital after a truck from the Swaziland Electricity Company (SEC) collided with a kombi along the Pigg's Peak public road this past Friday. He did not, however, reveal the amount he would contribute. "To the families, who lost their relatives, we are deeply saddened by the horrific occurrence and we pass our sincere condolences. The MP (Menzi Dlamini) should liaise with me so that we give financial aid to the families of the accident victims," he said. A memorial service in honour of the victims will be held at Nkhaba Inkhundla today and prior to that, will be a short prayer at the accident scene that will commence at 10am.

# Man gets 7 years in jail after buganu drinking spree

THE Marula (Buganu) season is already being felt in different quarters of society as evidenced by the jovial mood amongst lovers of the traditional brew.

This is also the time where abusers of the brew find themselves landing into trouble after committing various crimes

Most offenders would give the excuse that they acted under the influence of liquor. A similar excuse was given by one Siphamandla Shongwe (35) of Lubuli when appearing before Principal Magistrate Dumisani Magagula yesterday.

Shongwe was facing a charge of attempted rape.

He was alleged to have wrongfully and unlawfully attempted to have sexual intercourse with a 44-year-old woman without her consent. The incident allegedly occurred at one of the drinking spots at Lubuli last week.

When the charge sheet was read to the accused person, he pleaded guilty to the charge. He further elected to enter a statement of agreed facts with the prosecution.

In his statement, the accused person narrated that on the fateful day, he went for a drinking spree at a homestead which normally sells traditional brew in the area. He alleged that he imbibed on buganu with his friend and other members of the community. The accused said while having the drinks with his friends, he noticed a woman whom he instantly developed feelings for. Later on the day, the woman is said to have gone into one of huts at the homestead where she intended to take a nap. The accused person said he found this moment as a perfect one for him to express his love for the woman. He followed her into the hut just a few moments later, wherein he found her to have already fallen asleep. This is the time that he attempted to have sexual intercourse with the woman after undressing her.

The complainant is said to have woken up to find the man in the process of the attempt, and she raised an alarm. She was saved by the prompt response of other patrons who were enjoying their drinks just outside the hut.

the alcohol and I was not thinking straight," he said, during his mitigation

The accused person was accordingly found guilty by the court. When issuing judgment, the principal magistrate pointed out that the accused person committed a serious offense which could not be mitigated by the mere fact that he was under the influence of alcohol. He subsequently sentenced the accused person to seven years in a correctional facility without an option of a fine.

"You can just pray that you behave well while at the correctional facility and maybe if you are lucky enough, a third of the sentence could be remitted," said the principal magistrate. Magagula said the sentence would also act as deterrence to other would be offenders.



# You will die like an ant - Bhekwako told Camber

PRIME suspect in the KaLuhleko assassination Bhekwako Dlamini is alleged to have threatened his rival Camber Dlamini that he would die like an ant before he was eventually killed.

This was yesterday disclosed by the crown represented by Principal Crown Counsel Macebo Nxumalo who is yet to parade two more witnesses after the court re-opened the murder case that had already been closed.

High Court Judge Sipho Nkosi felt that the two witnesses should be paraded by the crown in order to give an insight into the raging KaLuhleko war which has turned

Nxumalo stated that one of the the inner council memwitnesses was present at the ber and his co accused Umphakatsi when Bhekwako confronted the deceased Camber Dlamini threatening him before Dlamini was eventually assassinated at his home-

Bhekwako is the prime suspect in the murder of the inner council member and his co accused Mxolisi Mabuza is alleged to be the one to have pulled the trigger which ended Dlamini's life.

Khanya who was made an accomplice witness in the trial that has generated interest from the community and members of the public, related how he together with Bhekwako Dlamini (first accused) Mndeni Kunene (second accused) and Mxolisi Mabuza who is the third accused, killed one of the inner council members Camber.

Khanya told Judge Nkosi that he together with Mabuza and Mndzebele were approached by the first accused (Bhekwako) who informed them that he wanted to end the lives of some people who were enemies to him.

Khanya said Bhekwako gave them the hit list which included Chief Zulelihle, Inkhosikati LaMakhungu, the deceased Camber Dlamini, Silence Simelane, Zacharia Maseko and Aaron

He told the court that first on the hit list was the deceased Camber Dlamini and narrated much to the shock of those in attendance in the public gallery how Bhekwako carefully arranged the plot to have him killed.

He said the old man offered them a silver pistol with 13 live rounds of ammunition and that they should proceed to the deceased homestead and gun

Given the responsibility to use the pistol was

Mxolisi Mabuza, they were promised E5 000 plus a cow each. After, they proceeded to the deceased's homestead.

"Upon arrival at Camber Dlamini's homestead, we approached the main door and knocked. When he answered the knock and that is when Mxolisi wasted no time, and shot at the deceased five times with three shots hitting the target while the two missed," he submitted.

Khanya further told the court that after Camber had been killed, Mndeni who had been carrying a note with information on it, dropped it on the ground within the deceased's yard to frame a Malkerns

The note contained information to the effect that one Jabulani Nkambule was the one responsible for the killing reflecting that the deceased had sold land to the said Nkambule, a land deal that had gone wrong. This, according to Khanya was meant to lead all suspicions on the murder to Nkambule who knew nothing about the killing.

# Attempted murder convict pays E20 000 compensation to shot victim

A man who shot at another using his father's gun has paid E20 000 as compensation to the victim as he is now partially paralysed as a result of the shooting.

Sipho Magagula, who was convicted for attempted murder, was ordered to pay E30 000 as compensation to the victim Mbuso Hlatjwako, an order that was issued by High Court Judge Sipho Nkosi after the conviction.

Having paid the E20 000, Magagula is now expected to pay the remaining balance of E10 000 and all the monies have to be deposited to the Registrar of the High Court's Account at the High Court.

Magagula shot Hlatjwako with his father's gun

behind the head rendering him partially impaired, an incident which happened at Nginamadolo area near Mankayane.

Magagula was keeping guard at his father's shop when Hlatjwako approached carrying sugar cane (umoba), when the trigger happy Magagula opened fire and shot him.

His father was also charged for giving an unlicenced person a gun much against the Arms and Ammunition Act. Yesterday, Judge Nkosi ordered that E5 000 be released to Hlatjwako and that the Home Affairs Department should assist him in obtaining a birth certificate and a national identity card so that he can open a bank account.

The money will not be released to him all in cash in fear that he might misappropriate it as Judge Nkosi felt that a certain commercial project should be started for him in order to make ends meet.

# MAN (58) BLAMES BUGANU FOR DRINK-DRIVING CHARGE

THE court was thrown into stitches when Vusi Malamba Nhlabatsi (58), who pleaded guilty to four counts of contravening the Road Traffic Act, explained that he only took a sip of the Marula brew as per the cultural dictates where one takes a sip in order to show that it was not poisoned.

Nhlabatsi was explaining his case to Magistrate Lenhle Zulu when he appeared before court to answer charges of breaking traffic laws. He revealed that while he was a man of sober habits, he had been sent by his father-in-law to procure the brew from a certain place in the Lubombo region, only for him to return and take a sip that ended up in him taking more than he was supposed

According to the charge sheet, on count one, he was charged with driving while intoxicated in that on or upon February 20 at or near Nandos in the capital city, he drove a Toyota Hiace while drunk. His alcometer reading was 0.75mg/l.


On count two, he was charged with failing to comply with a police officer's instruction to drive to Total Gardens Filling Station, where instead he ran away and when the police caught up with him, he refused to board the police vehicle and further fought with Constable Nhlabatsi, thus contravening the said Act.

On the third count, he was charged with driving while speaking on his mobile phone and on the last count, he was charged with parking his car in the middle of a public road.

In mitigation, Nhlabatsi said he had been sent by his father-in-law to buy a few 20 litres of the brew and upon return he took a sip and it tasted more like juice and he didn't notice that he had had more than enough.

Magistrate Zulu was shocked when Nhlabatsi revealed that during his trip he was accompanied by his children. He pleaded for leniency and said he was a father to 10 children and a wife.

"Mr Nhlabatsi it means you are a rich man with a lot of drama and the whole time you were travelling with your chil-

The court condemns such behaviour and you can't justify what did with culture, it was irresponsible and you know that," said Zulu.

Nhlabatsi was sentenced to a fine of E2 000 on count one, E500 on count two, E500 on count three and E500 on count four. However, the sentences were ordered to run concurrently, meaning he only had to pay E2 000 or spend two years behind bars.

# Copper thieves strike at Bhunya Mill, steal E63 000 copper

COPPER thieves continue to cause a major setback for the economy of the country.

Yesterday, four suspects appeared at the Manzini Magistrate's Court for stealing copper cables worth E63 000 at Bhunya Montigny Mill.

Mfanimpela Mkhwanazi (31), Fortune Tiplady (31), Mduduzi Dlamini (21) and Mduduzi Mtsetfwa (21) appeared before Manzini Magistrate Philsiwe Simelane and they were charged with theft. The three elected to conduct their own defence during trial.

According to the court record, the accused persons are charged with theft in that they acted jointly and with a common purpose while at Bhunya Montigny Mill, in the Manzini district and allegedly stole an electric cable valued at E63 000.

The cables were said to be in the possession of Victor Makonna (Usuthu Forest Product Company). The list of items allegedly stolen by the accused person when broken down by the court included four (core) armoured cables valued at E40 000 and another four (core) armoured cables valued at E23 000. The total value of the items amounted to E63 000.

During their appearance before court, the accused persons denied

ever stealing the copper as they alleged that their car broke down while they were on their way out of Bhunya since they had borrowed the vehicle from one of the employees at the place.

They alleged that they saw officers coming out of a nearby forest carrying bags which were loaded with copper.

However, a police officer who was speaking as a witness during the case, informed the court that it was not true that the copper came with them.

He said as officers, they saw the car parked in a pathway which is used by people and at first they thought that the car had broken down but upon further inspection, they saw bags of copper nearby. The officer said when they asked who the owner of the vehicle was, Mkhwanazi stated that it was him. However, it later emerged that the vehicle belonged to a Sandile Terrence Magongo.

When Magongo was called and informed that his vehicle has been used for a criminal activity he informed officers that he borrowed the vehicle to Makhanya.

He said Makhanya had told him that he was going to use the vehicle to ferry his children from Matsapha and was not going to take more than two hours. The matter was postponed after Magongo gave his accounts of what he knew pertaining the case.

# Five nabbed with pump action shotgun

IT would seem the country is facing an influx of illegal guns these days as not a week goes by without someone being arrested for possession of a gun without a valid permit or licence.

Some of these weapons are confiscated by police officers while others are seized by members of the Umbutfo Swaziland Defence Force at illegal crossings.

Police reported that on Sunday at 16:00 hours in Mliba, they arrested and charged five men of Luhlangotsini, Mbelebeleni and Sihhoye aged 37, 39, 31, 30 and 29, respectively, for being found in possession of a pump action shotgun loaded with live rounds of ammunition without a valid permit or licence while at

Ekutsimuleni area.

The arrest was confirmed by Chief Police Information and Communications Officer Superintendent Khulani Mamba.

Weapons

Worth noting is that a pump-action or slide-action firearm is considered to be one of the most dangerous assault weapons as it is said it is much faster than a bolt-action and somewhat faster than a lever-action, as it does not require the trigger hand to be removed from the trigger while reloading.

Information sourced from the internet is that once fired, the forearm is slid forward by hand and the expended cartridge ejected.

It is then reloaded by manually moving the forearm to the front. Just recently, members of the army reported that they nabbed two South Africans trying to cross into the country with guns and 35 live rounds of ammunition.

# Man's jacket buried with neghbour's clothes

A man from Lavumisa wants his neighbours to dig the tomb of their relative as he suspects that his jacket was buried with the body.

Cyprian Dlamini claimed that his jacket was thrown into the grave with the clothes of the neighbours's relative who was buried a couple of weeks ago.

He claims that he had given one of the deceased's relatives his jacket but it was not returned to him, only to hear rumours that it was thrown into the grave as relatives had thought it belonged to their loved one they were burying.

It's normal that when someone is buried some of his or her clothes are also buried. In this case, Dlamini said the neighbours have something to explain as among the clothes that were buried with their relative was his jacket, which he loved so much.

Dlamini is living with a disability as he is confined to a wheelchair. He said ever since he became disabled, life has been difficult for him

and his family.

He said the story of his jacket was also troubling him as he now has a feeling that it could be that those who buried it had ulterior motives.

"I gave my jacket to someone from the neighbours' homestead as he was feeling cold.

"He never brought it back and as someone who works far away, I had to call him and enquire about my jacket.

He told me he gave it to one of his relatives and asked her to give it to me.

Mistake

However, this did not happen but what I later heard was that there was a funeral at my neighbours' home and the jacket could have been included in the deceased's clothes that were buried with his body by mistake. I'm still trying to come to terms with this because no one has come out clearly on what happened to my jacket," he said.

Dlamini said he also suspected that the neighbours were up to some mischief by throwing his jacket into the grave of their relative.

He said as a Swazi, he suspected that such action meant evil intentions and he was not going

to rest until the neighbours tell him what happened to his jacket.

He said the neighbours have asked him to give them time as they were still mourning their dead relative.

"They have not denied the possibility of having the jacket buried with the body of their relative but at the same time they seemed to be also uncertain.

"They asked me to give them time as they can only attend to the issue after they are done with the cleansing ceremony.

I am going to wait but I will also be consulting vigorously.

"For someone's clothes to be buried while still alive and by neighbours is unusual.

As Swazis, we know these things and if someone has done this with a purpose, then I will leave everything to my God," said Dlamini, with a sorrowful voice on the other side of the phone.

He said if this was done on purpose he would definitely demand that they dig up the body and retrieve his jacket, as that would give him peace.

He feels a part of him had already been buried yet he was still alive.

# Sipho Shongwe innocent until proven guilty - Ngculwini chief

CHIEF of Ngculwini Prince Mgebiseni has said prominent resident of the area Sipho Shongwe, who has been charged with the murder of businessman and football administrator Gamedze, will face the umphakatsi should he be found guilty.

However, the prince was quick to say at the moment they would not interfere with the case as they will allow justice to take its course. He added that for now they will assume that he is innocent until proven otherwise. He pointed out that as per the procedure the umphakatsi summons individuals to answer for their indiscre-

Shongwe, who hails from Ngculwini with his son, Sifiso Mbusi Shongwe (24), were arrested last month at Ngwenya Border Gate following investigations to the murder of Gamedze.

Sifiso was charged with contravening Section 41 (1), as read with Section 41 (2) of the Money Laundering and Financing of Terrorism (Prevention) Act of 2011, as amended. He was allegedly found in possession of E60 000 on the day of his arrest.

Complained

He was later released on bail for his offences. Following serious cases committed by people who are from Ngculwini there has been a public outcry as people have complained that a number of suspects who have been involved in high profile criminal activities are from the same area. Just last year, police were dealing with a E320 000 robbery case which happened at Hhelehhele at Taga Investments where one of the suspects Lungani Shongwe, happens to be a resident of Ngculwini.

Lungani is alleged to have been in the company of five South Africans when he allegedly committed the offence.

It could not be ascertained however if Lungani is related in any way to Sipho, who is currently in custody on murder charges among others.

When asked about his subjects, especially the matter of Sipho Shongwe, the prince said it was too premature for him to make any com-

He said since the case is already with the police, as a community they were just observing how the case would proceed in court. However, he did confirm that Shongwe is a resident of Ngculwini.

# Businessman almost swept away by floods

**HLUTI** businessman Bahle Sibandze has related how he was nearly swept away by floods following rains which fell across the Shiselweni region on Monday until Tuesday morning.

The businessman said he was on his way to an area known as Welcome under Shiselweni I Constituency when he found water overflowing the local bridge. He said his intention was to drive to the other side of the bridge but just before he could drive any further, he felt the waves pulling the front part of his sedan where he immediately engaged the reverse

Sibandze, who is a well known businessman owning proper-

ties at Hluti and operating a butchery business, said he was headed to a dip tank at Welcome when he almost got swallowed by the raging river. "I woke up at around 4am with the intention of meeting some the cattle farmers. The plan was to buy a cow from the farmers which I had intended to slaughter for my butchery.

When I reached the bridge, I found water overflowing but since the rain had subsided a bit compared to the previous night, I took the risk and tried to drive across.

I took a chance but realised late that I was in danger. Luckily, I managed to engage the reverse gear as the strong current was pulling my car," said Sibandze.

Sibandze said he managed to reverse but with some difficulty as the road was slippery. "The vinde swung from one side to the other but I eventually managed to drive away from the slippery part of the

I parked the car and waited for the water overflowing on the bridge to subside. This did not happen and I decided drive back. I did not want to take a risk after the scare I had experienced earlier on. I could have been swept away along with the car had I decided to continue driving across the bridge. He said he also heard that several other roads as well as bridges were damaged and also overflowing which made work for others difficult.

'Some schools were affected and a number of other businesses as it was not easy to move from point A to B," said Sibandze.

# Mugabe 'finally' sends condolence message to Tsvangirai's family

HARARE - Zimbabwe's expresident Robert Mugabe has reportedly "finally broken his silence" and sent a last minute condolence message to his late rival, opposition leader Morgan Tsvangirai's family.

According to New Zimbabwe.com, the message from Mugabe was confirmed by the Movement for Democratic Change's acting President Nelson Chamisa just before the coffin of Tsvagirai was lowered into his final resting place in rural Buhera, 220km south of Harare, on Tuesday.

Chamisa said the message was private and could not be read in public.

"It would be improper for me to do that. We are Tsvangirai's



political family, but this is a private message to his real family. Unless they want it read out but that would their choice," Chamisa was quoted as say-

According to NewsDay, the message was from both Mugabe and his wife Grace.

As Chamisa announced the receipt of the letter the mourners responded with "rapturous applause", the report said.

Tsvangirai, the country's fiercest opponent of Mugabe's tyrannical 37-year rule, died last Wednesday aged 65 at a hospital in South Africa where he had been undergoing treatment for colon cancer.

His body was flown to the burial ceremony aboard a military helicopter, accompanied by his mother Mbuya Tsvangirai.

Tsvangirai's dreams of unseating Mugabe through the ballot box were dashed at several elections. But he lived to see Mugabe resign in November, amid moves by his own party to impeach him. news24


PALLIATIVE care has in recent years been highlighted as an urgent need for patients with HIV and AIDS and other life-threatening illnesses, both malignant and non-malignant.

Traditionally, the palliative care approach was developed in response to the plight of cancer patients. However, with the rise in other terminal, debilitating and life-threatening conditions, these were also added as conditions for palliative care.

The World Health Organisation (WHO) has broadened its approach to palliative care and defines it as an approach to improve the quality of life of patients and their families facing the problems associated with life-threatening illness, through the prevention and relief of suffering by means of early identification and impeccable assessment and treatment of pain and other problems - whether physical, psychosocial or spiritual. Palliative care provides relief from pain and other distressing symptoms; affirms life and regards dying as a normal process; Intends neither to hasten or postpone death; integrates the psychological and spiritual aspects of patient care; offers a support system to help patients live as actively as possible until death; offers a support system to help the family cope during the patient's illnesses and bereavement; uses a team approach to address the needs of patients and their families, including bereavement counselling, if indicated; Enhances the quality of life and may positively influence the course of illness; and is applicable early in the course of illness, in conjunction with other therapies that are intended to prolong life, such as chemotherapy or radiation therapy, and include those investigations needed to better understand and manage distressing clinical complications.

People living with HIV (PLHIV) are at risk for developing different cancers such as Kaposi's Sarcoma, non-Hodgkin Lymphoma, and cervical cancer. For PLHIV, these three cancers are often referred to as 'AIDS-defining conditions', meaning that if a person living with HIV has one of these cancers, it could signify the progression from HIV to AIDS. Women with HIV have a higher risk of developing cervical intraepithelial neoplasia (CIN), a precancerous growth of cells in the cervix.

Palliative care in Swaziland

In Swaziland, palliative care has historically focused on the end of life care provided in hospices and other facilities. Recently, however, the approach has expanded to all the regional and referral hospitals. Its main aim is still to improve the quality of life for people with life limiting conditions and it focuses on the delivery of qualitative and quantitative treatment, care support and follow-up services for delivery through all healthcare programmes to achieve access to health for all Swazis. Prior to 1990, palliative care had been provided as a normative service in the health care system in Swaziland but the establishment of the Swaziland Hospice at Home in that year pioneered palliative care beyond traditional health

Since then, palliative care services have been provided in varying packages by health facilities and non-governmental organisations (NGOs), faithbased organisations (FBOs) at facilities and in communities. The care is provided as in-patient, day care, outpatient and / or outreach basis, depending on the patients' condition and availability of patient's bed space. Homebased palliative care is the most common model of palliative care service delivery for patients who have been well diagnosed and have reached a stage where the condition cannot be cured. Some of the FBOs providing aspects of palliative care in the country include: Cabrini Ministries, Rocking Horse, Claypotts Trust, Hope House, Nazarene HIV/AIDS Task Force, Salvation Army, and the Shiselweni Dutch Reformed Church, Non-governmental organisations providing palliative care in Swaziland are AMICAALL, Cheshire Homes, NATICC, Swaziland Hospice at Home, Swaziland Positive Living (SWAPOL), and Swaziland Breast and Cervical Cancer Network.Often, counselling, symptom control and pain management are the most provided elements of palliative care, with limited rehabilitation, owing to the effects of the treatment and the prognosis of the condition.

A review of palliative care services held in 2009 showed that its demand is huge, mainly resulting from HIV/AIDS, cancer and other life-threatening illnesses like cardio vascular, kidney diseases and diabetes. The survey also revealed that the capacity to provide palliative care among the service providers was challenged by the lack of training and coordination of services nationally and regionally - which was then addressed through the setting up the palliative care programme within SNAP and the development of palliative care guidelines, published in 2011to enhance the provision of quality palliative care services as part of the national health sector response to life-threatening ill-

Most patients who need palliative care reside in rural areas, often far away from the nearest health facility. In the public sector, chemotherapy services are provided at the referral hospital and regional hospitals focusing on the treatment of HIV and AIDS related cancers, especially Kaposi's Sarcoma. There is no radiotherapy service available in the country and currently, few patients are being managed through referral to neighbouring countries such as the Republic of South Africa.

Cancer rates in Swaziland Information sourced from the 2016 Swaziland National Cancer Registry (SNCR) - a national 'incidence only' population-based cancer registry that seeks information from multiple sources, especially those in which cancer cases may be diagnosed or treated, including screening programmes - indicates that both the prostate and cervix cancers remain the top cancers in Swaziland. The other cancers include cancer of the breast, liver, colon, rectum and anus, lung, trachea, bronchus, oesophagus, corpus and uterus NOS, mouth and pharynx, and ovary and adnexa.

According to the SNCR, cervix Oteri has the highest age specific rates, followed by breast cancer and cancer of the ovaries, among females. The age group 70-74 has the highest number of age-specific rates. Kaposi's Sarcoma, liver cancer and the cancer of the ovary presented a sharp upward trend between 60-75 age group. In 2016, a total number of 88 cancer-related deaths were recorded at in-patient, the leading cause of death being cervical cancer accounting for 38per cent of all reported cancer deaths.

Prostate cancer, which affects males accounted for 18 per cent of the deaths. Additional to inheritance issues, prostate cancer is also linked to age, diet and life style - and of these risk factors, diet and life style can be controlled. Sexual reproductive health (SRH) related cancers accounted for over half (64 per cent) of all mortality cases in 2016.

#### Swaziland Hospice at Home

As one of the key serviceproviders of palliative care, Swaziland Hospice at Homecontributes to the improvement and attainment of the best possible quality of life for terminally-ill patients and their families, irrespective of their religion, nationality and social status. They provide a holistic approach to caring, comprehensive management and an array of interventions that ensure that patients' physical psycho-social, psychological, emotional and spiritu-

al distress is managed and suffering attenuated - through appropriate counselling and support measures, supportive treatment (such as offering advice and training of their families and communities) throughout the four regions of the country - and ultimately assist the dying to pass-on with comfort, dignity and love, while the survivors are assisted to cope with their situation, before and after death of their loved

Between April and December 2017, theSwaziland Hospice at Home attended to 223 home-based clients, consisting 128 (Manzini), 62 (Hhohho), 12 (Lubombo), and 21 (Shiselweni). Cancer specific patients included 45 cervical cancer, 23 prostate cancer; four cancer of the breast; three Kaposi's Sarcoma; with 25 suffering from other cancers. In the period, there were 19 deaths. Inpatients totalled 184 clients; - 127 females and 57 males who were affected by non-communicable diseases and other forms of illnesses.

As part of its response to HIV and AIDS, Hospice at Home collaborates with other organisations (NGOs, FBOs, and CBOs) that have introduced homebased care in their programmes, in various ways including advocating for better services for the terminally ill patients, sharing of hospice palliative care information and knowledge and providing in-service education on terminal issues.

#### Everyone has a role to play in ending AIDS

The success of the country's antiretroviral treatment (ART) programme means that more and more PLHIV are living well into old age. This increase in life expectancy means that the numbers of PLHIV who are ageing with the disease are also increasing. Therefore, as the country plans to end AIDS by 2022, there is need to prioritize the issue of long-term effects of ART and ageing diseases. We need to bring it into the agenda, so it can be dealt with.

For now, however, companies and individuals can support initiatives like the Swaziland Hospice at Home Fundraising dinner to be held from 20:00 hours tomorrow, at the Happy Valley Hotel. 

# JUINING THE DOTS: WHY EDUC

Your own education

THE evidence is clear: education changes lives, in ways that are often not fully understood.

For instance, quality education can help you live a longer, healthier life. This is because education equips you to approach health on a rational, informed basis stripped of superstition. Your own education can benefit others' health, too: research from Malawi has showed that having educated people as close neighbours enhances your health.

Evidence from Indonesia, meanwhile, points to education being a particularly strong predictor of who survived the aftermath of the 2004 tsunami. Cuba copes with hurricanes far better than Haiti in part because its citizens are more edu-

Wolfgang Lutz and Reiner Klingholz recently completed a book, in German, on education's role in resolving pressing current problems of inequality and sustainability, drawing extensively from history and recent scientific research. In 2017 it was translated into English with the title Education First! From Martin Luther to Sustainable Development.

Lutz is a world authority on population trends and climate change. Klingholz is a biologist and demographer. The pair worked on the book in South Africa, while based at the Stellenbosch Institute for Advanced Study in 2015.

#### Education as a driver of history

Lutz and Klingholz explore how mass literacy became a revolution that changed the course of Europe's and, via colonialism, the world's history.

Up to around 500 years ago, a defining feature of world inequality was that in those parts of the world where writing existed only around one per cent had access to the schooling and texts that made literacy possible. Virtually all of this tiny minority were men. In Europe, the Muslim world and China, 99 per cent of people were illiter ate.

Martin Luther, in rebelling against Europe's Catholic order, insisted that literacy should be universal. It was a view which would have appeared fanatical at a time when no one - probably including Luther - imagined just how much economic benefit would flow from literacy and education more broadly.

The impact of the Reformation on literacy was not immediate, but the genie had been let out of the bottle. By 1800 around half of Protestant Europe was literate. By 1900 literacy was near universal.

Japan, eager to modernise, replicated many aspects of t h e German can benefit others' education health, too: research system, starting in

the 1870s. Britain's and, much later, Japan's empires proved efficient in

their brutality largely thanks to an exceptionally educated population at home. The rise of the United States can be attributed to the fact that this champion of private enterprise also pioneered the mass public funding of secondary schooling.

It is argued that Germany became susceptible to the lies of the tiny Nazi party because its secondary schooling had fallen behind its counterparts across the world.

#### **Enablers and disenablers**

Modern technologies are undoubtedly education enablers. Their absence has also played a big role in how education has - or hasn't - evolved. One sobering case of technology suppression happened in 1485 when the Ottoman sultan imposed a ban on printing. It lasted for two centuries, throttling the technology that Luther's revolution relied on. This partly explains why the Islamic Golden Age, with its scientists and thinkers, was unable to evolve into a mass education movement.

Communism, for all its failings on the economic policy front, was generally an excellent promoter of education. Inspired by Marx, himself originally a first-generation Lutheran, Mao laid the foundations for mass quality schooling in China, which made an astounding economic takeoff possible several decades later. Julius Nyerere and

Robert Mugabe were in some respects similar education pioneers in Africa.

Education already serves as a bulwark against existential threats. It helps communities to understand each other, weakens rampant nationalism, assists in population control and widens the talent pool from which innovation must come. But parts of the world need much more of

#### African Sun Media

Africa has made important strides: today around 80 per cent of African children attend primary school and around 50 per cent secondary schooling. But some countries are doing much better than others. Take Nigeria, for example. The oil-rich country should be an education leader in Africa, but is in fact a laggard. African countries with far worse resource endowments have performed much better educationally.

At the other end of the spectrum is Mauritius, which took a decision to massify quality education in the 1960s. The impact is still being felt today. It stands out as the only African country (other than tiny Seychelles) to have virtually eradicated poverty. The island's post-independence leadership in the 1960s was neither ulism.

communist nor Lutheran. It simply understood the value of education.

Ethiopia, the only non-Muslim sub-Saharan African country with a long history of literacy - albeit limited to a tiny minority - benefited from good leaders in the 1980s. They refused to follow instructions from the International Monetary Fund to cut education funding. This stubbornness, also seen in Ghana and Mozambique, bore fruits in the form of Ethiopia's recent economic growth, and reduced fertility rates. In Addis Ababa they are as low as in Switzerland. Nigeria, which essentially gave in to the IMF, has paid a high price for this.

Elite capture in places such as Malawi have held education back. 68 per cent of public spending on education goes to the richest 10 per cent of the population, partially because spending is heavily skewed towards one university.

#### The role of foreign donors

International development funding debates display a short-sighted lack of appreciation for education's long-term benefits. The evidence suggests that a significant portion of the funding being made available for climate change adaptation is best spent on education.

UNESCO's estimate of the annual cost of plugging the financing gap to bring schooling, up to the lower secondary level, to all the world's children equals less than one per cent of what the United States spent on its war in Iraq, or a tenth of what Qatar has committed to the 2022 World Cup. The world moves fast. In the three years since the book was first published in German, much has changed. Then, US participation in global climate agreements still seemed assured. Now its English title can clearly be read as a sideswipe at the Trump administration and its insistence on "America First". One wonders how the authors would have dealt with a newly emerging risk: a tragic mix of a high level of education, as in the US, with an anti-science pop-

"Technology is pushing us towards another direction where the whole education system must be overhauled," he said, adding that Swaziland has no option but to grasp the technology wave and ride on it, if the country perceives ICT as being an industry that can make a meaningful difference towards GDP growth.

# MECHANIC TO COMPANY DIRECTOR

...Blueline Auto Consultancy Director Muzi Dlamini shares how ENACTUS helped him become the entrepreneur he is today

MUZI Dlamini one of three Blueline **Auto Consultancy Directors sold** his BMW convertible to contribute towards start-up costs for his com-

His investment is now paying off quite well as Blueline Auto Consultancy is growing to become a household name in the fleet management, speed limiters and vehicle tracking sector. Dlamini's company is fully accredited by all insurance companies in Swaziland and began offering fullyfledged vehicle consultancy services after undergoing all the drills required for a business of this nature to operate at full capacity.

A former SCOT student and ENAC-TUS alumni, Dlamini's business acumen and the passion of being an entrepreneur were all nurtured in his days as an ENACTUS member. "Before, I had never seen myself owning a business. When I enrolled at SCOT, all I wanted to do was to study transport economics.

The love of business was cultivated when I joined ENACTUS," he said in an interview held at the ENACTUS

offices. Now Dlamini does not ever imagine himself working for someone else as his focus is fully on being an entrepreneur.

Before establishing Blueline Auto Consultancy, he worked at MVTel as an automotive engineer where his duties included fixing the company's cars and seeing to it that speed limits were put in proper control, among other things.

He says the major breakthrough came when he got to know of a fleet management workshop in Johannesburg and set his sights on attending it. "When I heard about that workshop, I sought

Dlamini said it was after the workshop that he and the two other directors nurtured and pursued their

business idea until it came to fruition in 2014.

The company currently employs five people and Dlamini believes that if he

and the other directors had not been in business they would have deprived their employees of jobs. He praised ENACTUS for having given him the platform to learn about business and leadership skills.

"As an ENACTUS member, you are able to meet CEOs and you also have a networking experience that you would otherwise not have had under normal circumstances," he said, adding that being an ENACTUS member in his days at college gave him the courage to pitch his ideas to influential people because he knew that he was with a well-known brand.

#### **Students**

He advised other tertiary students not to overly set their sights on getting a job after graduating.

"The Swazi economy is quite small and I notice that many companies are overstaffed already which makes getting into business really important for everyone," he said, also recalling the words of former ENACTUS Country Director Khosi Dlamini who once said: "Society needs people who'll understand that not all of us can get hired or make it in the corporate ladder. But some of us must be in business because we can surely make it there". Dlamini confessed that these words had never quite left his mind.

He also encouraged those who want to go into business to refrain from doing this solely to make money. "One thing you need to understand about being in business especially in Swaziland is that you can stay up to three years without making money.

But that is where a true entrepreneur is differentiated from a mere businessman because businessmen go into business just to make money overnight and they don't quite have proper longterm goals.

The entrepreneur on the other hand goes into the market after identifying a gap and also because they love doing what they do even when things may seem not to be going well at a given moment," he said.

# More job opportunities as Blueline Auto Consultancy is on expansion path

# BANK WANTS 'MISSING' GUPTA JET GROUNDED

JOHANNESBURG - The bank that helped the Guptas purchase a private jet wants the "missing" aircraft to be grounded.

Business Day reported yesterday that Canada's state export bank, which lent the Guptas \$41-million towards the purchase of the Bombardier Global 6000 jet registered as ZS-OAK, has taken legal action.

Export Development Canada (EDC) applied for an urgent court order last week to force the Guptas to return the aircraft or face having it deregistered. The bank took legal action to ensure it wasn't "implicated in any

illicit or illegal usages".

"The location of the aircraft is now completely unknown," said the bank in an affidavit filed at the High Court in Johannesburg.

A flight tracking device aboard the aircraft had been switched off, masking its movements, which made the bank concerned that it could be used for illicit purposes.

Ahmed Gani, a lawyer representing the Gupta family, said the court application would be opposed. The family have reportedly defaulted on some payments for the aircraft.

The Sunday Times reported in

January that millions of rands from a Free State government dairy farm project meant to alleviate poverty had been spent by the Guptas on a private jet and a fleet of luxury cars.

Partnership
The project, set up in partnership

with Gupta-linked company Estina, allegedly saw R220-million siphoned off to the Guptas and others. It is the subject of an ongoing investigation by the Hawks.

EDC said in its affidavit that allowing the Guptas to continue using the jet represented "substantial reputational harm" to the bank.

ZS-OAK was chartered by the SA National Defence Force in 2015, taking off from Waterkloof Air Force Base, to ferry "military and civilian dignitaries" to the SA Army Combat Training Centre at Lohatla in the Northern Cape.

Minister of Mineral Resources Mosebenzi Zwane was revealed by the Sunday Times to have flown in the past with the Guptas on their private jet on a trip to Dubai and Switzerland. An application to have the aircraft grounded will be heard on March 6. *Times Live* 



# Cell C debt reduction target of R6bn reached

JOHANNESBURG - Cell C, South Africa's third-biggest cellular provider, had met its target to reduce debt to R6billion from R17bn in the year to December, following last year's successful capital restructuring of the business led by Blue Label Telecoms, the company said yesterday.

Blue Label spent R5.5bn for a 45percent stake in Cell C, while Net 1 UEPS Technologies paid R2bn for a 15percent stake in Call C last year.

Cell C chief executive José dos Santos said yesterday the company was "back in business" after cutting debt via the completion of the recapitalisation programme.

Total subscribers grew 6percent to 16.3mil-

"It (subscriber growth) could have been better. You need to understand that, in the first seven months of the year, we were hampered in any expenditure.

"Our cash flows were not there - literally nonexistent. Funding was difficult to come by.

"It was difficult to go out there and compete until the restructuring was complete. Now that it is complete, we are back in business," said Dos Santos.

Cell C's mobile virtual network operator (MVNO) strategy and the growth in the wholesale division had also been key contributors to revenue growth, with wholesale revenue increasing 79percent to R717million.

Do Santos said Cell C was reaping the rewards following a decision to get into the MVNO business four years ago.

"We supply services to Mr Price, FNB, Virgin Mobile. We are talking to other financial institutions. Four, five years ago, people said MVNO would never work in South Africa, and we proved them wrong," he said.

Cell C is the biggest cellular provider in South Africa after Vodacom and MTN. However, Dos Santos said the company was punching above its weight in terms of voice, data and content services. "If you said: 'Where are we today in terms of content?', we are number one in content; no one does what we can do.

# Discovery plans for a R1.5bn banking launch build-up

JOHANNESBURG - Financial services group Discovery plans to spend a total of R1.5billion in the build-up to the launch of its much-anticipated bank, set to start operating later this year.

The group said it had already spent R1.2bn following the granting of its banking licence by the registrar of banks and the South African Reserve Bank last October.

It said the Discovery Bank would test its capabilities with live testing of system infrastructure, operating processes and regulatory engagement.

"As previously announced, the licence is subject to certain conditions imposed by the registrar relating to the shareholding in Discovery Bank. Shareholders of the bank are currently in discussions to agree how best to manage these conditions," Discovery said.

Presenting the results for the six months to December, Discovery said the purchase of the Discovery-branded but FirstRand Bank-issued credit card business and book remained subject to Competition Commission approval.

Discovery reported a 19 per cent increase in normalised operating profit to R4.06bn, while normalised headline earnings increased by 30 per cent to R2.83bn.

"I think these were a solid set of results and the share price confirmed this by trading higher after their release," said Ron Klipin, a Senior Analyst at Cratos Capital. *Business Report* 

# KFC's Colonel flies in his American executives to fix UK distribution crisis

LONDON - An American team of executives from KFC's state-side headquarters are being parachuted in to help solve the distribution crisis that has left hundreds of chicken shops closed with tons of meat unused.

Senior executives have already started to arrive in London to meet with bosses at its UK head-quarters to discuss the disaster which is said to be costing the food giant in the region of £1million a day. Some of the chain's 450 stores remain shut today, with reports of it taking up to a month until all 900 restaurants are back open for business.

It was claimed last night KFC which has 24 000 workers in the UK, was warned by the GMB Union last October that switching from Bidvest Logistics to DHL could cause problems.

This comes after pictures emerged showing piles of chicken wasted at a DHL delivery centre in

The meat, destined for some of KFC's 900 UK stores, remains redundant after the delivery firm's new computer system 'failed' forcing the popular fast food chain to close almost two thirds of its branches. Up to 570 outlets across Britain were temporarily shut when delivery problems meant

they ran out of chicken - sparking a furious reaction from customers. So panicked were KFC fans that they even resorted to calling police - prompting a stern warning from Scotland Yard officers - amid fears it could be up to a month before some restaurants re-open. One Twitter user, 'Kara', wrote: "Still can't believe KFC was shut because they ran out of chicken", while Emmie Twyford tweeted: "Can't believe the two KFC's in my town are shut... at least we have a Chicken Cottage".

KFC's chicken shortage fias-

co began last week shortly after the fast-food giant switched its delivery contract to Germanowned DHL. It was triggered by an accident that shut the M6, causing traffic gridlock and reportedly leaving DHL lorries sat in traffic for hours, sparking a huge backlog of deliveries.

The chaos had a knock-on affect which centred on a DHL delivery hub in Rugby, with KFC saying it first became aware of a problem in the software around a new computer ordering and delivery system on Friday.

# SIBANYE-STILLWATER EXPECTS ATTRIBUTABLE LOSS OF R4.4BN

JOHANNESBURG - Mining company Sibanye-Stillwater said yesterday it expected an attributable loss of R4.437 billion (US\$333 million) for the year ended 31 December 2017, compared with attributable earnings of R3.473 billion (US\$237 million) for the previous year.

The company said the loss was due to impairments, pro-

vision for occupational healthcare claims, restructuring and transaction costs and significant differences in commodity prices and the average rand: dollar exchange rate.

It forecast a headline loss per share of 12 cents (1 US cents) compared with 162 cents (8 US cents) previously, a decrease of 107 per cent.

# THEY MUST GO: CABINET MINISTERS WHO SHOULD GET THE CHOP

JOHANNESBURG - Newly swornin State President Cyril Ramaphosa is expected to make changes to his Cabinet soon. And while it's a matter of when rather than if, the question remains: who should be on the chopping block?

The publication believes there are seven ministers who should be worried about

#### 1. Public Services and Administration - Faith Muthambi

Ever the one to dispense of patronage, Muthambi apparently flew more than 30 relatives, friends and neighbours from back home to Cape Town to listen to her budget speech - although she will deny any wrongdoing. She was one of the first ministers to be exposed as beholden to the Gupta family after she leaked an unsigned presidential proclamation detailing her powers to the family. She is said to have sent a series of e-mails containing confidential information about executive policy and the scope of her ministerial powers to Tony Gupta.

Then there is MultiChoice's larger than normal payments to the Gupta-owned news channel ANN7 that happened under her watch. Was this the money that pushed for unencrypted set top boxes in MultiChoice's favour?

#### 2. Finance - Malusi Gigaba

A known fence-sitter when it comes to ANC contests, Gigaba's silence in the face of numerous allegations in connection with state capture leave us with only one conclusion. The former ANC Youth League leader left a trail of question marks over his tenure as Minister of Public Enterprises and Home Affairs, where the family often benefited from special treatment.

Gigaba is yet to fully explain his decision to restructure board sub-committees and their powers at Transnet and Eskom, giving more powers on large procurement that coincidentally assisted in the capture of these organisations. During his tenure there he also appointed a number of key individuals to SOE boards, namely Eskom, Transnet and SAA, where an Indian national was appointed to the board by Gigaba.

Show Leaked Gupta e-mails later show that Rajesh Naithani owed his presence on the board of SAA to the Gupta family.

At Home Affairs, Gigaba's adviser Thamsanqa Msomi was the Guptas' fixer, personally organising visas for family and employees.

The family, which seems to have had all access to the department, also got their citizenship applications fast-tracked. In his defence, though, Gigaba's removal from Public Enterprises speaks to a possible refusal to follow some instructions from the influential family. Or it could just be that his fallout with Dudu Myeni another Zuma friend - trumped his usefulness to the family?

# Five policemen die in attack on station

# North West legislature lays charges against health HOD over contract

JOHANNESBURG - The North West legislature has laid criminal charges against the Head of the province's Health Department, Dr Thabo Lekalakala, following a marathon interrogation over a contract given to a Gupta-linked company, which also paid for his junket to India in 2017.

The committee, which held a sitting from early Tuesday evening until the early hours of yesterday morning, was looking into claims that a healthcare organisation called Mediosa was awarded a R30m, three-year contract by the province's Department of Health, in advance and without it going out to tender.

Lekalakala admitted on Tuesday evening, while being interrogated by the committee, that a delegation from the department was taken to India just seven days after the health group received the payment.

Committee Chairperson Madoda Samabatha told News24 that the HOD was facing numerous charges, which include fraud and corruption, contravening the Public Financial Management Act as well as being in contempt of the legislature.

"We say this because the rules of the legislature allow us to force anyone who appears before us to submit documents. He confirmed that there was a contract and, when we asked for the documents, he made us wait for four hours then refused," said Samabatha.



# New hunters hope to find human remains

SYDNEY - Salvagers are confident debris and human remains can be recovered if Malaysia Airlines MH370 is finally found, despite the pitch-black darkness, crushing pressure and ice-cold water awaiting them. The disappearance of the Boeing 777 carrying 239 passengers and crew almost four years ago is one of aviation's greatest mysteries, with an Australianled hunt across a 120 000 square-kilometre (46 000 square-mile) zone failing to reveal the crash site. Yet a new probe now underway by private firm Ocean Infinity - commissioned by Malaysia on a "no find, no fee" basis - has revived hopes the doomed plane might be found. AFP

# 'NO TO ACCESSORY THAT INCREASES GUN'S FIREPOWER'

WASHINGTON - Faced with an outpouring of grief and anger over a deadly school shooting in Florida, US President Donald Trump on Tuesday threw his support behind moves to ban "bump stocks" - an accessory that can turn a semi-automatic weapon into an automatic one.

Trump also said school safety was a "top priority" for his administration, with meetings on the subject planned through next week, when he holds talks with governors from all 50 US

Calls to ban bump stocks have been mounting since Stephen Paddock, a retired accountant, used them on several of his weapons to kill 58 concertgoers in Las Vegas in October 2017 in the deadliest mass shooting in recent US history. Although the former student who shot dead 17 people in Florida last week did not use bump stocks, there has been a renewed focus on the devices because outlawing them is a rare point of agreement between Democrats, some Republicans and the powerful National Rifle Association (NRA) gun lobby.

Less than a week after the shooting, the Florida state House of Representatives rejected a ban on assault weapons and large capacity magazines in a 36-71 vote, during a session that opened with a prayer for the people killed in the tragedy. About 100 survivors of the tragedy held a gun control rally and spoke with lawmakers about gun control and school safety yesterday at the

state Capitol in Tallahassee.

Trump - who received strong backing from the NRA during his White House run - said he had signed a memorandum "directing the attorney general to propose regulations to ban all devices that turn legal weapons into machine

The president said he expected the measures to be finalised "very soon."

"We must move past cliches and tired debates and focus on evidence-based solutions and security measures that actually work," Trump said at a White House event to honour 12 Americans

"We must actually make a difference... We must do more to protect our children."

Trump said he would meet this week with students, local leaders and members of law enforcement to develop "concrete steps" to protect schools, pupils and communities. AFP

# US condemns violence at Tsvangirai's funeral

HARARE - The United States embassy in Zimbabwe's capital has condemned the violence which broke out at the burial of former Prime Minister and MDC-T leader, Morgan Tsvangirai, who succumbed to colon cancer.

One of the three MDC-T Deputy Presidents, Thokozani Khupe, was physically attacked on Tuesday afternoon. The other two Deputies Nelson Chamisa and Elias Mudzuri were spared the

Suspicions were that the attacks, which occurred at Humanikwa village, rural Buhera, were carried out by youths thought to be aligned to interim Party President, Chamisa.

Commenting on the attacks, the US embassy in Harare said the violence was contrary to Tsvangirai's beliefs. The popular MDC leader died last Wednesday in Johannesburg.

"During his life, Mr Tsvangirai stood in opposition of such violence," said the US consulate, whose representative Harry Thomas Jnr witnessed the incident.

"We encourage all Zimbabweans to move for-



ward together towards elections that are free, fair, transparent and, most of all, non-violent."

MDC-T Secretary-General Douglas Mwonzora, who was also vilified, tweeted: "The politics of hate and violence should not have any place in our society. Really sad developments at Dr Tsvangirai's funeral. The attack on Dr Thoko Khupe was cow-

ardly and sadistic." AFP

# Lebanese president makes landmark visit to Iraq

BAGHDAD - President Michel Aoun led a delegation Tuesday to Iraq on the first visit by a Lebanese head of state to the war-scarred country, for talks that included ways to eradicate terrorism.

Aoun held talks with Iraqi President Fuad Masum and Prime Minister Haider al-Abadi before travelling to Armenia yesterday. "We had constructive talks which reflect the historical and brotherly ties that link our two countries and our people," Aoun told a joint news conference with Masum.

"I would like to take advantage of this occa-

sion to congratulate the Iraqi people for their firmness, patience and determination in the face of adversity... and terrorism," he said.

Iraq has been scarred by decades of conflict.

After an eight-year war with neighbouring Iran in the 1980s, and the 2003 US-led invasion, Iraq was targeted by the Islamic State group which seized swathes of the country following a 2014 offensive. In December, Abadi declared "the end of the war" against IS and complete control of Iraq's borders with neighbouring Syria, where the jihadists still control pockets of territory.

# Moza govt takes responsibility of deadly garbage dump collapse

MAPUTO - The Mozambican government on Tuesday assumed all responsibilities for the garbage dump collapse on Monday, which killed 17 people and injured another seven.

Maputo Municipality's President, David Simango, told the press that searches in Hulene garbage dump for bodies or survivors will end later on Tuesday, based on statements by residents that no more bodies are expected.
"We assume all the responsibilities for the

Hulene accident.

"We will not try to justify ourselves with the closure or the resettlement, otherwise we would be evading our responsibilities.

"At this point ... the number of accommodation in the host centre has increased from 32 to 80," he said, adding that the families of the victims resettled and receiving psychological treatment.

"We are securing meals for the resettled

"And the funeral of the victims depends on the availability of the families concerned. The government has everything ready to take on," he said. The mayor also revealed that emergency work in the city of Maputo has resulted in the closure of some flooded schools.

An FA statement said the London club "failed to ensure its 'club whereabouts' information was accurate on three occasions within 12 months".


West Ham have until February 27 to respond.

Wigan player Chey Dunkley also played an important role in calming the situation, first dragging Aguero back as he responded to the attack, and then placing himself between fans and the Argentinean before shepherding him away.



# I WAS **PROTECTING** FELIX FROM FANS - 'KOKI'

SOCCER - MBABANE Swallows coach Thabo 'Koki' Vilakati has defended his action to substitute Felix Badenhorst, saying was meant to protect him from the team's supporters.
