# EX-POLITICIANS DITCH MOPADO

FORMER politicians have taken a decision to switch from Members of Parliament and Designated Officers Bearers (MOPADO) to **Public Service Pensions Fund** (PSPF).

This decision was taken by the former politicians this past Saturday during the meeting organised by Eswatini Former Politicians Association.

The meeting took place at Caritas in Manzini. It transpired that the former politicians were not happy with what MOPADO offered them.

Their problem, according to sources at the meeting, was that the former politicians felt their money was not safe with MOPA-DO. They also stated that they had no confidence on the MOPADO newly-elected board, as they felt there were certain issues that needed to be ironed out with them.

Some of those recently elected into the board include Lobamba Londzala MP Marwick Khumalo. ...This is just a bunch of losers — MP Marwick

who was re-elected by current MPs in the House of Assembly to represent them in MOPADO. The former politicians said they were not out to fight with anyone, but to find out what was happening with their money.

The former MPs wondered how the proposed probe at MOPADO would happen when some of the members of the board were re-

One of the former politicians also stated that even if one was investigated at work, that particular person would be suspended so that the probe could continue without any disturbance.

It further emerged during the meeting, according to sources, that PSPF had a better offer than MOPA-DO. They said the basic monthly annuities at PSPF were E1 000, compared to MOPADO, where it was E400.

They said earning E400 as a former legislator was an insult because that was lower than even a govemment watchman, who could be

paid around E1 000 in monthly annuities. They also complained about the access to their pension

They stated that it was not fair for them to access to their pension funds before they reached the age of 55.

One former legislator said this was not fair on them because chances were high that they will not receive the money at all.

He said life expectancy in the

country was around 52 years. That would mean chances of them accessing the money would be low.

"If an MP wins elections at 30 years and finishes the term at 35, that MP would have to wait for another 20 years before accessing E400 per month," said the former politician.

He further said PSPF had a better offer because at 45 years, one could access his or her money. So it would be better for them to switch to PSPF because their deal was better than that of MOPADO.

The meeting was attended by former politicians that included former MPs, senators, constituency heads (tindvuna tetinkhundla), constituency councillors (bucopho) and former members of Emabandla.

Some of them contemplated on approaching the current MPs with the view of moving a motion to nullify the recent elections held in the House of Assembly, which were won by Khumalo.

The MPs were invited to the meeting, but could not go there.

PSPF Chief Executive Officer (CEO) Langalakhe Dlamini said he was not aware of the matter and referred this newspaper to PSPF spokesperson Elkan Makhanya for comments.

Makhanya also stated that he was not aware of the matter and asked for a questionnaire to be sent so that he could give a clear position of PSPF on the issue.

# Ex-politicians slam burial benefit

THE former politicians have slammed the burial benefit offered by Members of Parliament and **Designated Officers Bearers** (MOPADO).

The former politicians punched holes on the benefit, which they said was worth E40 000. They said such a funeral benefit was expensive and some of the money should be given to them so that they could enjoy it while they were still alive. For the former politicians, it did not make sense for them to live lives of paupers after their term of office, only to be given dignified funerals and buried in big and expensive caskets. One former politician stated that PSPF offered something better. They had a burial policy of E15 000

and they could have access to the remaining E25 000. Eswatini Former Politicians Association Secretary Saladin Magagula only stated that members were bitter about **MOPADO** 

He said what made them bitter about the pension fund was that they were in the dark about what was happening with their money. What further disgruntled the association's members was that they were not afforded an audience with MOPADO.

"Our chairman [former MP Patrick Pha Motsa] went to seek an audience with the Principal Officer [Comfort Tshabalala]. He was denied an opportunity to meet the officer. This was not well received by the members," Magagula said.

# Ex-MP Masilela contemplates approaching court

FORMER Lobamba MP Michael Masilela contemplates approaching the courts over the MOPADO saga.

This also transpired during the meeting held by Eswatini Former Politicians Association.

According to sources at the meeting, it was revealed that the former Lobamba legislator wanted to approach the

courts to find a way of transferring his money from MOPADO to institutions where it would be safe.

Asked on the matter, Masilela said he had not yet decided on the way forward. He was still waiting to hear from his former Parliament colleagues' views. Masilela said it was clear to him that he was not the only one affect-

ed by this. So it was best for him not to hastily act on it. He said sometimes, there were laws that governed their pensions as former politicians and influencing changes on such laws could be done in many ways. Sometimes people could approach Parliament so that the laws could be amended or better still, the courts. Masilela said the prob-

lem with Parliament was that the amendments could take a very

long time yet they were affect-The former politicians,

according to the sources, said they were ready to approach the court on this matter.

They would approach the courts whether Masilela backed them or not. They said the matter was so serious such that they even set up a legal fund to instruct a lawyer to take it up.

Various local and international construction companies were expected to submit their bids in an effort to win the tender, a process which is expected to finish in the next month or two.

# OVER 400 QUALIFIED NURSESATHOME

OVER 400 qualified nurses are sitting at home as government has frozen their recruitment, thus crippling the health sector of the country.

This was disclosed by the Director of Health Services Dr Vusi Magagula when addressing Mbabane Pensioners branch on Wednesday.

The director was called by the pensioners to address the issues faced by the elderly at Mbabane Government Hospital.

The director's visit to the pensioners was what the senior citizens longed for as they lodged over 10 issues that they experienced in the biggest hospital of the country. Dr Magagula, reacting to one of the burning issues

which was the unavailability of medical professionals in the hospital, said the hospital and other health care centres in the country were under-staffed.

His revelation is supported by the reports which assessed the health ministry's staffing concerns and a fact which was also admitted by the Prime Minister Ambrose Dlamini in his breakfast meeting with editors recently.

One of the elders stated that they queue for hours at the hospital without being attended to by a single nurse or doctor.

Former medical professional Bertram Dlamini stated that sometimes they are turned back home because of the unavailability of doctors at the hospital.

"At times we are turned back from the hospital after queuing for hours," he said.

Dr Magagula started by explaining that the ministry of health has a serious shortage of staff, mainly nurses and doctors.

He added that the shortage of staff is beyond the ministry as the government has frozen recruitment. He disclosed that over 400 qualified nurses are sitting at home unemployed yet they have serious staff shortages. Dr Magagula said

t h e nurses currently unemployed could improve the rate of service delivery. Coming to the issue of shortage of doctors, Dr Magagula said he believes this issue would be addressed soon as there are doctors who are currently undergoing training and



# Talk to politicians

THE director of health services urged pensioners and elderly people to communicate the challenges they face at hospitals or healthcare centres to politicians so that government can act promptly to issues affecting the healthcare sec-

Dr Magagula said in order for some of the challenges facing the ministry to be solved, the elders should engage their MPs so that policies can be drawn and be implemented. Dr Magagula was reacting to the issue of drug shortage in the country healthcare facilities.

The Chairperson of the Mbabane branch Dr Osvart Sukati said there is a shortage of medication at the hospital, mainly diabetic medication.

Elderly people are given prescription to go and purchase the medication from pharmacies. Dr Sukati said looking at the little money elderly people earn, they are unable to purchase these medication. The director of health services said the shortage of drugs in the country is indeed a national crisis.

He said this goes back to the shortage of finances facing the ministry of health. He further stated that he understands how expensive diabetes medication is from pharmacies, thus politicians need to find a way of dealing with the challenges facing the ministry.

Dr Magagula said the current issues facing the ministry no longer conform to universal health coverage. According to the World Health Organisation, people should be able to access health services in each hospital. The current situation no longer conforms to the standards

However, he added that Eswatini is not the only country that is facing crisis in the health sector. "The issues facing the country happen even in other countries such as Namibia who face similar crisis," he said.

# **ON-CALL STAFF**

ANOTHER burning issue raised by the pensioners with the director was the unavailability of on-call doctors.

The pensioners stated that on -call doctors in the hospital only exist on paper.

The pensioners said at times when they reach the hospital during off-work hours, they are left unattended or attended late.

They stated that most of the time they are told that there are no on- call doctors or staff at all.

Dr Magagula said he had received so many complaints about the on-call doctors.

He said this was discouraging as the country spends huge amounts of money paying the on-call staff because they are assumed to be working overtime. However, Dr Magagula said it is not always

the case where the medical professionals are not willing to come

Dr Magagula said the shortage of vehicles sometimes delays the service of on-call medical practitioners.

He added that some of the night drivers have a tendency of indulging in alcohol while on the job, and because they also fear for their lives they are delayed as they make means of finding alternative transportation to work.

Besides the on-call staff, the elders also complained about the rising number of people jumping queues at Mbabane Government Hospital. The pensioners stated that friends and relatives of staff jump queues while elderly people are left to die on the lines.

Toddler's murder:

# Mom shocked by teen son's behaviour

THE mother of a teen boy who is said to have slit a toddler's throat with a knife is mystified by her son's behaviour.

Khanyisile Khumalo (39) of Mbikwakhe said after hearing about the incident last week, she was shattered because she had been to courts and the psychiatric hospital about issues caused by her son. Khumalo said this was extreme in that the child died yet in a past incident; the minor only fainted and recovered after some time.

Khumalo's son \*Bongani was arrested last Thursday after he allegedly used a kitchen knife to slit open the throat of two-year-old Nkosiyazi Maphanga. The two boys lived with their parents in the same compound, where they rented flats at Mbikwakhe. After committing the offence, the teenager allegedly cleaned the knife and placed it in his mother's house before walking to Nhlambeni, where he was later apprehended. When interviewed yesterday, Khumalo said her son was troublesome in that not only does he have a pending case in court in connection to the incident where he strangled a three-year-old while at Gebeni, but he was also not attending school because on several occasions he dropped out without explanations.

Amid all this, Khumalo said she tried to take him back to school with the hope that he would not turn to his antics. However, her efforts were futile as yearly, he did the same thing. Since she was no longer employed, Khumalo said Bongani had not been attending school because his father did not buy him uniform when he bought for the other children due to that he feared that Bongani would drop out again.

### Behaviour

"Due to this behaviour, he was still in Grade Two when he last attended school. I don't know how to take all this because I'm too shocked. Maybe my son was bewitched," she

When asked what Bongani told them after the first incident at Gebeni, Khumalo said when he explained what had happened, her son told her that he was playing with the threeyear-old when the toddler picked a stone and

"He said he was too angry so he strangled the child. Luckily, the toddler recuperated because he only fainted," Khumalo stated. After this incident, the mother said she took her child to the psychiatric hospital where he was examined.

Khumalo said although she was not told what her son was suffering from but he has been on treatment ever since. Back to the recent incident, Khumalo said when she visited Bongani in jail last week, he asked for his grandfather to whom he apologised.

Bongani is said to have told his family that he did not know what came over him because for some time, there was unaccounted for time. Meaning he did not know how or why he killed the toddler.

'Utsi nje kwatsi khwishi! Naye akati kwentekani," Khumalo said. Even so, Khumalo said his son regretted all that he had done. Bongani has been charged with murder and he appeared before Magistrate Mthokozisi Dlamini at Matsapha Circuit Court last Friday. The teen was remanded in custody and will make his second appearance again today.

# Govt disassociates itself from MPs China visit

GOVERNMENT has disassociated itself from a visit to Mainland China by the country's Members of Parliament.

In a statement issued by the Government Spokesperson Percy Simelane, he reiterated Eswatini's unshaken relations with the Republic of China (Taiwan).

The statement is in reaction to an article run by one of the local weekly newspapers yesterday where some Members of Parliament are said to have visited Mainland China on a familiarisation tour.

Government reacted by saying the country had unshaken diplomatic ties with Taiwan and were expected to continue for a long time to

come. Simelane said the Kingdom of Eswatini and the Republic of China (Taiwan) have continuously enjoyed long and unbroken diplomatic relations since the country's independence in 1968.

According to Simelane, tionship was based on mutual respect, friendship and loyalty.

"Both countries engage, in principle, at a level of equal partnership. This is a 51-year-old relationship based on an understanding and appreciation of our respective profound cultural and traditional systems," Simelane said.

He further narrated that Eswatini and Taiwan ties were defined by successful cooperation across a broad spectrum of areas, as well as real commitment to realising the conceived by the United Nations. Sustainable Development Goals (SDGs). "Government did not sanc-




tion the familiarisation tour of some parliamentarians to the People's Democratic Republic of China and, as such, their conclusions from the excursion are purely personal and have no bearing on the relationship between the Kingdom of Eswatini and Taiwan," said the spokesper-

He emphasised that the country's commitment to strong diplomatic ties with Taiwan remained unshaken and enduring.

"Any cynical campaign of coer-

cion threatening the relationship shared by the two countries would not succeed. The Kingdom of Eswatini and Taiwan remained resolute in working together for the greater good and building a better future for the country," Simelane stated.

# Stick to King Somhlolo's vision, King tells nation

HIS Majesty King Mswati III has urged Emaswati not to depart from King Somhlolo's vision of choosing the Bible over money.

His Majesty was speaking during the last day of the Somhlolo Festival of Praise services at the National Church in Lobamba, where he was represented by Minister of Housing and Urban Development Prince Simelane.

The minister said His Majesty was grateful to the nation for deciding to come together to worship. He said the King attributes the success of the event to all those who took part in it one way or another. He also thanked visitors from the United States of America who graced the event.

Vision

Prince Simelane also gave a brief background of the services, highlighting that His Majesty said it was a way of thanking God for showing Himself to King Somhlolo in his vision.

The minister said King Somhlolo chose the Bible over money.

This was hailed as a good move which benefited Eswatini because it is a peaceful nation now. The minister said a lot of countries are engaged in never ending wars because of money, which he described as the root of evil.

The prince said His Majesty has urged him to remind the nation to always choose the Word of God instead of money.

He said the Bible comes with warning and advice. He said the warning that has been relayed to him to send to the nation by His Majesty was for people to always know that the sin of a single person does not affect only that individual but has far-

reaching consequences as other people also suffer in the end.

"Sono semuntfu munye asigcini kuhlupha umuntfu munye kepha sihlupha nalabanye," the minister said, relaying the message from King in vernacular.

To support this message, the minister referred to the Book of **Jonah 1:12** where it reads thus; "Pick me up and throw me into the sea, and it will become calm. I know that it is my fault that this great storm has come upon you."

Sailing

He said Jonah did not obey God as he did not want to go to Nineveh but instead he boarded a ship that was sailing to another city. Prince Simelane said God sent a bad storm and everyone in the ship was terrified and all this happened because of Jonah.

He said Jonah told them to throw him into the water because he knew that God sent the storm because of him as he had not obeyed Him.

Another example that was used by the minister was the story of Achan who went against God's orders. Prince Simelane said God had warned that no one must take the spoils of the city of Jericho and the Israelites obeyed, except for Achan, who stole gold and silver and hid these things in his tent.

He said for that sin committed by Achan alone, his entire family and his livestock suffered as they were all stoned to death.

# KaShewula inner council to meet Ndabazabantu on RSSC graves case

THE inner council of KaShewula is reportedly doing everything possible to finally have the issue of graves which were accidentally damaged by an RSSC assigned TLB resolved amicably and put to rest.

Hundreds of graves near Mafucula were last month destroyed while the sugar company was preparing a piece of land for the cultivation of sugarcane. The land is situated near Mhlume under Mafucula, a community which pays allegiance to KaShewula royal kraal.

Following the incident, which the Royal Swaziland Sugar Corporation (RSSC) has repeatedly described as an accident, the company and the affected relatives reached an agreement to have the deceased persons reburied in one large grave, and a memorial stone with their names put there. The costs of the reburial would be catered for by RSSC.

At least, this was until the main traditional authority objected to the agreement, citing some breach of protocol and norms. The reburial arrangements were subsequently put on hold pending finalisation of further deliberations.

This publication yesterday managed to reach KaShewula's Acting Chief Bernard Sifundza for an update on the matter after some of the affected relatives expressed their concern.

Even though Sifundza also expressed his discontent in engaging with the media, he disclosed that his council will be meeting with the King's Liaison (Ndabazabantu) tomorrow for further deliberations of the matter.

Sifundza said his council was taking the matter seriously, hence his unwillingness to have it discussed on the media. "The matter has been reported to Ndabazabantu, and it would be improper to discuss it with the media while we are yet to put

our side of the matter before the relevant structures," said Sifundza, before disclosing that the discussions will take place at the King's Liaison's office tomorrow.

Meanwhile, relatives of the deceased persons have expressed their concerns on having their loved one's graves left lying in the current 'un-respectful' manner

"All we want is to have our relatives" remains given a dignified reburial as per our norms and customs," said one of the relatives. On the other hand, RSSC has apologised to the affected relatives for the unfortunate incident.

# Man stripped naked, killed

A man who was believed to have been smuggling dagga into the Republic of South Africa (RSA) was brutally murdered after being stripped naked and tortured.

His naked body was then dumped in an open field with a long piece of cloth forced down his throat.

Next to the body were two empty sacks that smelt of dagga.

The murder took place on Saturday evening along a well-known informal border crossing near Horo.

Due to the fact the police are actively investigating the incident, the name of the deceased is known but has been withheld for now.

Interviewed yesterday, a police officer, who wanted to remain anonymous, said the man died after being shot twice in the chest.

"Information we have at the moment suggests that the deceased was a known dagga smuggler from Horo who made a living through smuggling dagga into South Africa from Eswatini.

Smuggler

Unfortunately, there is no honour amongst thieves, so other criminals who we are yet to identify found the dagga smuggler along the informal border crossing trying to make his allegedly illegal trip on Saturday

The other criminals then assaulted the deceased using fists, kicks, a bush knife and a leather belt," said the police officer.

He added that the assault occurred after the criminals stuffed a cloth in the man's mouth to muffle him. During the assault, his hands were tied together and he was stripped

After the assault the criminals shot him twice in the chest," added the officer. Police believe the individuals who committed the crime stole the dagga. "At the scene we found two empty sacks that had a strong smell of dagga which led us to believe that the criminals who committed the murder stole the dagga from the deceased."

Chief Police Information and Officer Communications Superintendent Phindile Vilakati confirmed that a man was brutally

shot and killed but said she was not in a position to provide details of the crime as the incident was still being investigated by the police.

# E4m for rehabilitation of police buildings

THE current state of police buildings has prompted the need for revamping.

With the upcoming refurbishment of Matsapha and Nhlangano correctional facilities, the Royal Eswatini Police Services (REPS) has also identified the need to refurbish its own structures.

This was outlined in the REPS performance report on recurrent and capital expenditure for the period from April to June 2019.

The police have been allocated a budget for the rehabilitation and security fencing of police buildings. During the period under review,

a total of E4 million was allocated for the rehabilitation of police buildings. This project is to be implemented by the police in collaboration with the ministry of public works and transport and the procurement plan is ready to be utilised. The organisation has sent a request for authority to incur capital expenditure and awaiting approval from the ministry of finance. During the period under review, the police leadership has already commissioned task teams to conduct inspections at all police stations countrywide. These inspections were meant to assess a number of variables impacting on the provision of quality policing services. The inspections unveiled three major operational concerns.

The first concern uncovered during the inspections was on the state of police buildings. It was discovered that most police formations were very old and dilapidated which pointed to an urgent need for massive rehabilitation works. The second concern identified was the shortage of transport as police stations around the country were severely constrained by the shortage of transport. This was said to hinder the REPS daily operations as it greatly reduced the response time to reported criminal incidents.

The third concern was that of the shortage of policing equipment. It was also established there was an acute shortage of operational equipment mainly for the crime scene collection and analysis tools.

# 3 killed in road accidents over weekend

THE last weekend of July ended badly for relatives of three people who lost their lives in the country's roads.

Police are seeking assistance from anyone who might have information which may lead to the arrest of a suspect who was involved in a hit and run incident, which saw a 26-year-old man of Mdonjane knocked dead near Mawelawela Prison along Malkerns and Mhlabubovu public road on Saturday at around 1910 hours. The pedestrian sustained serious injuries and was certified dead upon arrival at RFM Hospital.

One passenger, being a 24-yearold man of Boyane, was seriously injured and taken to RFM Hospital, where he was certified dead. Meanwhile, the driver and the other three passengers were treated and discharged.

On Saturday at 2310 hours, near Bhareni Bus Stop along Langeni to Lozitha MR3 public road, a Ford Ranger driven by a 38-yearold man of Dalriach, Mbabane knocked from behind an unregistered motorbike driven by a 30-yearold man of Mtabanttu.

Certified

The driver of the motorbike was seriously injured and rushed to Mbabane Government Hospital. where he was certified dead. The driver of the Ford Ranger was not injured. Chief Police information and Communications Officer Phindile Vilakati confirmed all three accidents and pleaded with the nation to help them locate the unknown hit and run suspect. She also urged mechanics and garage owners to look out for a person who will bring with a car which is suspected to have hit something

# FEMALE COP ARRESTED **FOR SHOPLIFTING**

# A female police officer was arrested and charged for theft of gro-

Nkosingiphile Mkhweli (31), who is based at the Manzini Police Station and resides at Zakhele Police Camp, is said to have shoplifted grocery items at Shoprite situated at Bhunu Mall in Manzini.

Among the items she stole are two Nivea roll-ons, 5kg mealie-meal, chillie wors, 3kg brown sugar, and a packet of chicken soup pack valued at E35. This is a mixture of chicken insides and necks.

The total value of the items is E251.81. Information gathered was to the effect that on the day she committed the crime, the officer of the law was seen pushing a trolley with the items around the store. One of the floor security guards noticed the roll-ons in the trolley.

However, after some time, the guard reportedly also noticed that these were no longer in the trolley. The security guard noted that when the officer was heading for the door, her bag had droplets of water to indicate that some-



thing frozen was in it.

At this point, the police officer reportedly carried the other items in Shoprite plastic bags as if she had gone through the pay point where her items were loaded into the bags as per the norm for customers.

Meanwhile, the security guard had his eyes on her due to his suspicion. He then communicated with his colleagues who were stationed at the exit of the store to search the officer. This is then that the frozen chicken pack and other items were found in her bag.

The other items in plastic bags were not paid for since there was no receipt to prove it. Reliable sources revealed that before committing the crime,

Mkhweli went past the pay point where she grabbed several plastic bags in which she packed the stolen items before she tried to exit the store.

According to her court records,

Mkhweli pleaded guilty to the offence. In mitigation, she informed the court that she did not intend to steal the items but was disturbed by a phone call that bared shocking news to her.

The mother of three claimed that apart from being a civil servant, she had a shop business on the side, hence she did not know how she ended up in the situation that led to her being

She was sentenced to five months imprisonment with an option of E2 000 fine.

# Natural resources exceeds revenue target by E2 million

THE ministry of natural resources and energy has surpassed the projected revenue collection by over E2 million for the first quarter of the financial year.

With other ministries facing enormous challenges, the ministry of natural resources and energy seems to be coping well, amid the current economic crisis of the country.

Minister Peter Bhembe in the ministry's first quarter financial performance report stated the ministry has realised some achievements during the period under review.

### Amounted

Bhembe said revenue collected in the first quarter totalled E 16 664 137.46 against a target of E14 376 400. He said there was an increase of E2 287 737.46, which is an increase of 16 per cent against what was targeted to be collected within the reported peri-

The minister said the increase was attributed to an increase on the fuel oil levy, amongst other things. "However, it should be noted that the sales of maps and bulletins have drastically dropped as compared to other years due to limited funds for re-printing these items,"

The projected 100 per cent electrification of Eswatini counts among other

achievements observed as well as the implementation of the rural electrification phase 24. Bhembe said the project had identified 23 rural electricity group schemes comprising of 1 459 households for implementation.

He added that field appraisals for all 23 group schemes were completed to trigger the release of the first disbursement for implementing the project amounting to E14 million from the Embassy of the Republic of China

"It is worth noting that Eswatini Electricity Company in collaboration with government has entered into negotiations with the World Bank to provide finance for the network strengthening project in the Shiselweni region," said Bhembe.

He added that the project entailed new transmission and distribution infrastructure to provide reliable electricity supply in the region.

The funds from the Republic of China (Taiwan) will also benefit households located in Manzini, Hhohho, and Lubombo regions.

Bhembe also mentioned that the department of water affairs managed to drill 10 boreholes in the first quarter. The feasibility study for the Nondvo Dam is ongoing having produced a draft feasibility study report. Subsequently, the Environmental and Social Impact Assessment (ESIA) for the dam was progressing well with production of the revised ESIA report.

# Fire dept responds to 10 fire cases a day

THE Fire and Emergency Services records almost 10 fire cases on a daily basis.

Chief Fire Fighter Herbert Shabangu said the department records these fire incidents from household and wild fires. Shabangu said he was disappointed how Emaswati, despite all the awareness campaigns, were still using fire carelessly. He stated that sometimes they were unable to respond to fire cases because of the high numbers reported. He said their staff is over-worked because of the high number of cases. "Sometimes when we receive the reports we are unable to reach the scenes on time because our vehicles and staff would be engaged in other incidents," he said.

Shabangu said all fire stations in the country were currently fighting several cases of fire. Meanwhile, the National Disaster Management Agency has come to the rescue of some households that were affected by fires.

The relief material provided by the agency included six blankets and five mattresses, two tents and food items. These were for two houses burnt down, where the agency has also been seen donating building material. Not long ago, the NDMA had an event at Nginamadvolo, KaLaZwane commu-

nity under Pig's Peak Constituency, where they staged an awareness campaign. The agency continues to raise awareness and to sensitise communities exposed to the risks of fire induced disasters. The aim is to build a risk and impact mitigation capacity of communities. NDMA also appealed to the nation to ensure responsible use of fire. "As the windy season is in full swing we appeal to the general public, overseers of communities, particularly chiefs and inner councils, to ensure that fires are used accordingly." The ministry of agri-

culture also recently issued out a stem warning against irresponsible use of fire. Minister of Agriculture Jabulani Mabuza pleaded with members of the public to seek or obtain appropriate permit from the ministry and seek safety precautions whenever they want to use fires. He said this was in compliance with provisions of the Prevention of Grassfires Act. The minister pleaded with the public to notify the police as well as the National Fire and Emergency Services Department to assist in managing fires.

# WILD FIRE LEAVES FAMILY OF 14 OUT IN THE OPEN

A family of 14 in Ludzeludze near Matsapha has been left in disarray after wild fires devoured their homestead.

One of the displaced members of the Kunene family, Linda who was visibly emotional, said the fire engulfed her home at around 2200 hours a week ago. She said on the day she was in

church and when she came back she was confronted with the reality of losing everything she owned due to the destruction of her homestead. "Luckily no one was hurt as everyone was able to vacate the houses when the fire engulfed her homestead," she said. She said the fire destroyed three houses in her homestead and they were not able to salvage anything as all their furniture, clothing as well as food items were completely lost during the raging fire. She lived in the homestead with her seven siblings, her mother and father as well as five grandchildren (batukulu). Kunene said the only house that survived was a two-room flat which they have all been squatting in since the day of the unfortunate ordeal. She added that her father; Mkhulu Kunene who earned a living through vegetable farming, has been left feeling hopeless since the fire burnt all his irrigation equipment which included pipes, sprinklers as well as the garden fencing.

She said while *mkhulu* was trying to salvage his garden fence and irrigation equipment, he realised his home was being engulfed by the raging fire and he was left helpless.

Disheartening

She said what was most disheartening was that *mkhulu* was preparing his garden for planting and had saved the money for purchasing seedlings in his house. All his money was totally bunt by the fire. "We are in desperate need of assistance and we would welcome any help from whoever is willing to lend a hand as the current situation is dire," she said.

She said they were advised to contact the National Disaster Management Agency, which they did and were informed the agency was under stocked. Kunene requested anyone who is willing to offer them assistance of any form to contact 7607 2399. Any help would be appreciated, she added.









# Magistrate adamant licences be revoked for repeat DD offenders

MAGISTRATES are increasingly growing tired of repeat drink driving offenders hence the notion to evoke Section 43 of the Road Traffic Act 6, 2007 which provides for the suspension or cancelation of driver's licenses.

What will surely be a frightening reality check for multiple offenders was revealed by Manzini Magistrate Mthokozisi Dlamini on Saturday.

Following the reading of the first offenders charges, Dlamini pointed out that since drunk drivers were not getting the message to stop of not drinking and driving, it was high time for the justice system to evoke Section 43 (1) of the Road Traffic Act which calls for the suspension or cancelling of an offender's driver's license. "Apparently people seem

not to be getting the message, I think it is high time we evoke section 43 and suspend or cancel repeat offender's licenses," said the magistrate.

He said driving while under the influence of an intoxicating substance, was one of the major causes of accidents along the country's national roads. He said they have repeatedly raised awareness on the matter, but from the look of things, offenders were seemingly ignoring the warning.

He said the only way people would get the message was for the court to render much severe punitive measures provided for in the Road Traffic Act 6 of 2007.

The magistrate said the court had been lenient far enough and now it is time to hit hard on drink drivers to get the message across. "It is no longer enough to allow offenders to break the law and get away with paying a mere fine only to repeat the offense again," said Dlamini.

# DD accused leaves court in stitches

A drink driving offender on Saturday left the Manzini courtroom in stitches when he was rendering his mitigation in front of Magistrate Mthokozisi Dlamini.

Enock Dlamini (63) of Nkiliji area was charged with the offence of contravening section 91 (1) as read with section 122 (1) and (2) of the Road Traffic Act 6 of 2007.

Dlamini's charge sheet read, upon (or about) July 26, at or near IDM along D38 public road, in the Manzini district the said accused being a driver of a motor vehicle YSD 266 BH a Nissan truck, wrongfully and unlawfully drove the said motor vehicle upon a public road while under the influence of intoxicating liquor or narcotic drugs with the reading of 0.86 mg/l above the legal limit of 0.38 mg/l and thus contravened the said Act.

In his mitigation Dlamini said he was baffled by the reading recorded by a breathalyser test as he only drank one 750 ml bottle of beer. The magistrate said Dlamini's reading indicated he had taken more than one bottle as he was way above the legal limit.

In his defence, the offender said he had an explanation for the high reading to which he pointed out that he was a mechanic and a few hours before he was arrested, he was working on a car and was forced to draw petrol from the car using his mouth.

"Ngicabanga kutsi ngulo petrol longibulele Nkhosi yenkantolo,' he said. His statement led to a burst of laughter in the courtroom as people in attendance whispered among themselves that Dlamini

Dlamini insisted that he only drank one beer bottle to which the magistrate responded he did not believe his story. Dlamini was

> found guilty and sentenced to 12 months imprisonment or pay a fine of E2 000.

# DRIVER'S SEAT, ARRESTED

A 22-year-old mother wept in court as she narrated how she was nabbed for being found on the driver's seat while intoxicated.

Lindokuhle Vilakati was arrested yesterday morning at Mafutseni after she was found on the driver's seat of a VW sedan with abreathelyser recording at 0.41 mg/l, exceeding the legal limit of 0.38mg/l. She appeared before Magistrate Sindisiwe Zwane yesterday.

When explaining why she contravened the law, Vilakati said she was not aware that occupying the driver's seat was a crime. She also stated that her intention was to sleep in the car as it ran out of fuel.

The young mother of one said the idea was the vehicle's driver who said they would make means to get fuel the following morning. The magistrate asked who bought the alcoholic beverages for Vilakati and the response was that it was the car owner with whom she would sleep in the car. When mitigating, Vilakati pleaded for leniency citing that she was unemployed and had a two-year-old child. She

said the child was with her mother who was also unemployed. When saying this. the young mother's voice sounded animated as she spoke without stopping for breath while tears rolled down her light skinned face.

# Drunk driver berated by magistrate

"WHY should I consider your children when you managed to spend their money on alcohol? "

Magistrate Sindisiwe Zwane directed this question to Sonnyboy Ndzinisa (47) of Ticantfwini after he pleaded for a lenient sentence as he had children who depended on him. Ndzinisa was arrested on Saturday near William Pitcher College for driving his Toyota sedan while under the influence of alcohol. His

specimen reading was 0.92mg/l, exceeding the legal limit of 0.38mg/l. The magistrate asked why Ndzinisa could not think of his children before he committed the crime or even imbibed because alcohol was expensive. Magistrate Zwane asked how much a quart cost and Ndzinisa said it was E17. He further informed the court that he had taken four of them.

This meant that he had spent about E70 on his drinks. In her response, the mag-

istrate said E17 was enough to buy some bread and soap, let alone E68.

He was sentenced to two years imprisonment with an option of E2 000 fine.

# UNICEF employee in court for E9 000 fraud

BY VUYILE DLAWINI Mbabane Magistrate's Court

A UNICEF employee stationed in Nigeria is preparing for her trial in December after she was arrested for allegedly defrauding St Mark's High of E9 000 earlier this year.

UNICEF is an abbreviation for the United Nations Children's Fund. The 37-year-old Primrose Fakudze of Motshane was arrested and charged with fraud and theft by false pretences earlier this year, when she was said to have, in January 2019, defrauded St Mark's High of money amounting to E9 000.

According to her charge sheet, with respect to the fraud charge, Fakudze was said to have unlawfully and with intent to defraud and steal to the bursar of St Mark's High Nontsetselelo Dlamini, that she had deposited money amounting to E9

000 in respect of school fees for a Form 2 pupil. This Fakudze did by means of the said misrep-

resentation, induce the school to the actual loss and prejudice to the sum of E8 910. Fakudze was said to have made the misrepresentation knowing full well that she had deposited E90, thereby committing the crime of fraud.

With respect to the charge of theft by false pretences, Fakudze is said to have, in January 2019 near Manzini, did unlawfully and with intent to defraud and to misrepresent to Sithembile Mamba, that she had deposited money amounting to E9 000, at NedBank Eswatini for school fees for the aforementioned Form two pupil.

This Fakudze is said to have done by means of the said misrepresentation induce the above person to the actual loss and prejudice to the sum amounting to E8 910.

Fakudze was said to have made the misrepre-

sentation knowing full well that she had deposited E90, thereby committing the crime of theft by false pretences.

During her first appearance before Magistrate Sifiso Vilakati in April 2019, Fakudze was admitted to bail set at E2 000.

## Cited

This was after her attorney cited that as she was an UNICEF employee in Nigeria, the court's ball conditions should not be stringent especially with regards to her passport. Fakudze's attorney also informed the court that his client intended to plead guilty to both charges.

However, as Fakudze's trial was set to commence on Thursday, the prosecution applied for the malter to be postponed for December 2019 due to developments that had arisen. The court was further informed that Fakudze was set to leave for Nigeria on Friday, thus the postponement.

The court granted this application, informing the prosecution and Fakudze that the continuation of trial was set for December 9 and 10, 2019.

# 91 arrested for drink-driving

DESPITE all the awareness campaigns and stiff fines imposed by the magistrate's courts, people still imbibe on alcoholic beverages and get behind the wheel.

This is evidenced by the high number of drink-driving cases recorded by the police. According to information from the police, there were 91 drink-driving cases reported over the past weekend. This is a slight reduction from last week's 100 cases.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati said all drink-driving suspects made their court appearance before magistrate's courts in all four regions of the country. She added that these motorists had exceeded the legal limit of 0.38mg/l.

"Section 91 (1) as read with section 122 (1) of the Road Traffic Act 6 of 2007 states that any person found behind a stirring wheel with an alcohol content exceeding 0.38 mg/l will face the law. For contravening this Act a person may faces up E5 000 fine," she said.

### Numbers

She added that the numbers were likely to increase by yesterday evening as police officers were all over the country ensuring that people were safe as they used the road. She concluded by saying traffic police officers would continue to be all over the country's roads ensuring that people are safe as they use the roads.

She condemned the act of driving while under the influence of alcohol, saying alcohol reduces driving ability to make proper judgement, thus exposing other motorists to fatal road accidents and causing damage to public roads.

Meanwhile, on Saturday at 2130 hours, Mbabane Police arrested and charged a 45-year-old man of Nhlazatshe (South Africa) for being found in possession of dagga weighing 10kg with a street value of E8 000 without a license or permit while at Ngwenya Border.



The residents were later informed that EEC could not help them with issues of restoring power. This meant another day without power for the six houses which were affected by the outage. After seeing that no help was forthcoming, the residents had to come together and decided to hire contractors to help them fix the power box. After various quotations were made they settled for E12 000 and each effected household had to contribute E2 000 towards fixing the problem. During a brief visit to Mbangweni, a group of workers was found fixing the power box and getting it ready to work again. When contacted, EEC confirmed that they indeed received complaints from Mbangweni residents about a power outage but the reason they could not help is because this Housing Board as the landlord. # Constituency projects to be rolled out soon

CONSTITUENCY projects will get a major boost as the ministry of finance has released E55 million for the first and second quarter of the Regional Development Fund (RDF).

Minister of Tinkhundla Administration and Development David Ngcamphalala on Thursday announced the various constituencies that would access the funds in the coming weeks. This was during the debate of the ministry's first quarter performance report at the Senate.

When addressing the ministry's portfolio committee and alternate members, the minister said he was grateful to the members for the role they played in ensuring that the RDF money was released.

"I am pleased to report before the honourable House that the RDF first and second quarter funds have been released," said Ngcamphalala.

He stated that the released funds amounted to E55 million, of which five per cent amounting to over E2.75 million were administration costs which resulted in a balance of about E52.25 million for the RDF projects.

He said these funds were now in the treasury department due to be transferred for the commencement of work.

Members of the portfolio committee wanted to know the exact date the money would be accessible as a number of projects had already been delayed as they waited for the funds to be released. Amongst the MPs who raised concerns about the expected distribution of the

funds were Somntongo MP Dumisani Mbamali, Nhlambeni MP Manzi Zwane and Motshane MP Robert Magongo. Constituencies

Mbhamali wanted the minister to come out clean on when the funds would be distributed to the various constituencies as it was not clearly stated in the report. Zwane said the late distribution of the funds was detrimental to the Tinkhundla system which was supposed to be the backbone of the nation.

He said the report would not be passed unless the money was available for distribution to the various constituencies.

Magongo said the late release of the funds resulted to the people who elected them losing faith in them as their representatives as they accused the legislators of making empty promises.

"I am even afraid to visit my Inkhundla as I am always bombarded with questions with regards to the funds while I have no clear answers," he said.

He further urged the minister to defend his ministry as its importance was losing value to the people it was meant to put first, Minister Ngcamphalala assured the committee members that he had personally engaged the ministry of finance on the matter and was assured the money would be available for distribution this week. "I personally went to the ministry to enquire about the release of the funds and was assured the funds were now at the treasury department," said the minister.

He added that Micro-Projects had submitted all the required documents to the treasury department and the funds would be released soon. Ngcamphalala also urged the committee members to work hand-in-hand with government as they were fully aware of the current finan-

He mentioned that the arrest of the alleged serial rapist was a major breakthrough, but did not mean the crime rate had lessened.

"The Municipal Council of Mbabane has been engaged by the ministry and is in the process of addressing the issue," said the minister.

Minister Prince Simelane said the Fire Services Department was a challenge to them as fire services employees were recruited as civil servants using the Civil Service Act while their code of conduct was spelt out in another law, namely the King's Order in Council of 1975. "This

### Background

The Government of Eswatini through the Department of Gender and family issues and the Department of Social Welfare under the Deputy Prime Ministers office in partnership with UNFPA Eswatini and Autism Eswatini as part of the 6th country programme implementation and with joint support from UNDP and UNICEF, plans to conduct a baseline survey on persons with Autism Spectrum Disorders (ASDs) in the Kingdom Eswatini.

The early diagnosis, appropriate research and effective interventions are vital to the growth and development of people with ASD. Early intervention is crucial for addressing their needs, thus improving their opportunities to live a quality life with the ability to participate in the greater community and increasing the likelihood that they will need lower levels of support later in life. A cure for ASDs is not available. Evidence-Based psychosocial interventions, however, such as behavioral treatment and skills training programmes for parents and other caregivers, can reduce difficulties in communication and social behavior, with a positive impact on the person's well-being and quality of life.

According to WHO, available scientific evidence suggests that there are probably many factors that make a child more likely to have an ASD, including environmental and genetic factors. However, epidemiological data is conclusive that there is no evidence of causal association between measles, mumps, rubella or any other

People with ASDs, as well as other disabilities, are significantly more vulnerable to the risk of HIV infection. A lack of education, of awareness of their rights, and of the possibility of seeking protection (due to social stigma, isolation and lack of access to communications, information and services) makes them more susceptible to deceit, while making it easier for those who abuse them to go unpunished. Communication barriers, affecting people with developmental disabilities, make it difficult to ask for and receive help, to make themselves understood or to be even taken seriously, in addition to professionals (law-enforcement and medical staff) seldom being adequately trained to deal with such individuals.

### II. Purpose

The baseline survey is intended to obtain reliable and relevant data on the prevalence of ASDs in the Lubombo Region, their access to basic services and prevalence of violence against people with ASDs. The information obtained from the study will be used to inform programmatic interventions focused on ASDs and protection of their human rights. This will further enhance capacities of Government institutions to identify, diagnose and treat people with ASDs; Improve information related to ASDs and challenges faced by these individuals; and promote active advocacy and monitoring on es related to people with ASDs.

### IV. Survey Besign and methodology

The baseline survey will gather information using a combination of quantitative and qualitative data collection methods and tools. Four techniques will be used to collect data, namely the desk review, questionnaires, interviews with key informants and focus group discussions. Wide range of sites, including communities, Government officials and partners will be interviewed.

The consultant/company selected to undertake the assignment will present a detailed inception report indicating how it will undertake the baseline survey before the actual data collection process. All interviews, with appropriate consent, will be recorded. The data collectors will take notes during the group discussions and individual interviews carried out with respondents. The number of teams for each community/district will be identified by the consultant/company and included in the inception report. Each data collection team will be comprised of a supervisor and data collectors. The team supervisor will be directly reporting to the consultant/company and getting guidance on the data collection issues as well as soliciting guidance from Autism Eswatini on the issues related to ASDs.





# RESTRAINT ORDERS

POCA 2018 PART V

Cases in which restraint orders may be made

15. (1) The High Court may exercise the powers conferred on it by Section 1- when-a prosecution for an offence has been instituted against the respondent concerned; either a confiscation order has been made against that respondent or it appears to the court that there are reasonable grounds for believing that a confiscation order may be made against that respondent; and the proceedings against that respondent have not been concluded; or when-the court is satisfied that a person is to be charged with an offence; and it appears to the court that there are reasonable grounds for believing that a confiscation order may be made against that person.

(2) Where the High Court has made a restraint order under subsection (1)(b), the court shall rescind the restraint order if the relevant person is not charged within such period as the court may consider reasonable.

Restraint orders

16. (1) The director of public prosecutions may apply to the High Court for a restraint order prohibiting any person, subject to such conditions and exceptions as may be specified in the order, from dealing in any manner with any property to which the order relates.

(2) If the High Court when considering an application made in terms of subsection (1), is satisfied that the facts referred to in Section 15(1) appear on the face of it from the application, it shall make, without requiring that notice of the application be given to any other person or the adducing of any further evidence from any other person, an order having immediate

in respect of realisable property which may be specified in the restraint order and which is held by the person against whom the restraint order is being made;

in respect of all realisable property held by the person against whom the restraint order is being made, whether it is specified in the restraint order or not;

in respect of all property which, if it is transferred to the person against whom the restraint order is being made after the making of the restraint order, would be realisable property.

(3) When the High Court makes a restraint order under subsection (2) it—may include in that order any ancillary orders that the court considers appropriate for the proper, fair and effective execution of



the order; and

may at the same time include an order authorising the seizure of all movable property concerned by a member of the police.

(4) A restraint order shall provide for notice to be given to persons affected by the order and the minister shall prescribe the manner in which the notice will be served on the affected persons.

(5) Property seized under subsection (3) shall be dealt with in accordance with the directions of the High Court.

(6) A restraint order made under subsection (2) expires when the proceedings against the respondent are concluded.

(7) When making a restraint order the High Court may also make any further order in respect of the discovery of any facts, including facts relating to property over which the respondent may have effective control, and the location of that property as the court may consider necessary or expedient with a view to achieving the objects of the restraint order.

Provision for expenses from restrained property

17. (1) Without derogating from the generality of the powers conferred by Section 16(1), the High Court, when it has made a restraint order may, on application by a person against whom the order is made, make provision as the court may think fit for the payment from the property of that person which is subject to the restraint order—of reasonable living expenses for

of reasonable living expenses for that person and any person whom that person is legally liable to support or maintain; and

that person is legally liable to support or maintain; and of reasonable legal expenses for that person in connection with any proceedings instituted against that person in terms of this Part or any criminal proceedings to which those proceedings may relate.

(2) A court shall not make provision for the payment of any expenses under subsection (1) unless the court is satisfied that—the person applying for the payment of those expenses, and every other person whom that person is legally liable to support or maintain, has disclosed under oath or affirmation all their interests in the property from which such a provision is to be made and has submitted to that court a sworn and full statement of all their assets and liabilities; and

neither the person applying for the payment of those expenses nor any other person whom that person is legally liable to support or maintain can meet the expenses concerned out of their unrestrained property.

Variation or rescission of orders 18. (1) The High Court may vary

or rescind a restraint order or an order made under Section 24(2) if it is satisfied that-the order concerned-will deprive the person against whom it was made of the means to provide reasonable living expenses; and will cause undue hardship for the person against whom it was made which outweighs the risk that the property concerned may be estroyed, lost, damaged, concealed or transferred; or there is an ambiguity or a patent error in or omission from that order, but only to the extent of that ambiguity, error or omission.

(2) When the court orders the variation or rescission of an order authorising the seizure of property in terms of subsection (1)(a), the court

shall make any other order which it considers appropriate for the proper, fair and effective execution of the restraint order concerned.

(3) The High Court may rescind a restraint order or an order made under Section 34(2) if—

it was erroneously sought or erroneously made in the absence of the person applying for its rescission; or it was made as a result of a mistake that is common to both the director of public prosecutions and the person against whom it was made.

(4) Only the director of public prosecutions or the person against whom the order was made on notice to the director of public prosecutions may apply for an order under sub-Section (1) or subsection (3). (5) A restraint order or an order made under Section 24(2) may not be varied or rescinded on any grounds other than those provided for in this section.

# ESWATINI INCORPORATED: 2022 & BEYOND

'MOVING FROM RHETORIC TO ACTION'

GOVERNMENT MUST LEARN FROM KING

A week ago, Education and Training Minister Lady Howard Mabuza met with school principals at Prince Mfanyana Hall in Manzini where she declared and re-emphasised government's position when it comes to the hiring freeze in the public sector, which also affects the filling of vacant positions and promotions.

She told principals that her ministry has been equally affected by this Circular.

From the onset, let me state that we support all the efforts of this 11th administration to rescue the country from the economic abyss.

However, our support must be informed by public interest. We cannot continue to support programmes or policies that compromise not only the quality of life of our society but threaten the future.

Our health and education sector is facing serious challenges which can be easily unlocked by reviewing our position when it comes to this Circular.

I want to believe that the implementation of this circular did not come about as a result of poorly diagnosing our economic situation.

Granted, the International Monetary Fund (IMF) has been concerned for a long time with our huge public spending and claimed that our public service is amongst the largest in the region.

Recommendations were made on how we should go about dealing with this challenge of which some studies were done and only awaited implementation.

In 2011/2012 at the height of our fiscal challenges, it was recommended that government needed to reduce the bloated public service by cutting 7 000 jobs.

This move or recommendation was rejected by His Majesty the King hence the Dr Barnabas Sibusiso Dlamini-led government resolved to cut politicians' salaries by 10

The idea was to cut salaries across the board by 10 per cent but civil servants rejected the move.

The hiring freeze which is being implemented through Circular No. 3 of 2018 we hope is not one way of implementing what was rejected by the King.

In fact, if we were to implement such a plan, it has to be well coordinated and ensure that key services are not compromised in the alter of public expenditure savings and, meanwhile, gratify demands made by such institutions as the IMF. Any savings that compromises the quality of life and the future of the Nation is no good savings at all and must be discarded immediately.

Government needs to take a cue from His Majesty King Mswati III who despite acknowledging the challenges faced by the country continues to ensure that key positions are filled.

### Replaced

In the past two weeks, he replaced the Umbutfo Eswatini Defence Force Commander Sobantu Dlamini with Jeffrey Shabalala.

On Friday he did the same by replacing His Majesty's Correctional Services (HMCS) Commissioner General Mzuthini Ntshangase with Phindile Dlamini.

In the next two weeks, we hope the same shall happen to the Royal Eswatini Police Service where Senator Isaac Mmemo Magagula's position remains vacant.

He understands that such positions are crucial for peace and order and should not remain vacant to the extent that they start to compromise the smooth functioning of those institutions.

Now, both in the health and education sectors, we cannot afford to have vacancies that are not filled.

We have had nurses and teachers who have retired from service and others who have passed away. It goes without saying, therefore, that for the smooth running of our key institutions we need people to serve the multitudes of our Nation.

It cannot be understood that we have not replaced or filled any vacancies on the basis that we don't have money.

We are not saying government must create new vacancies yet, but only saying those that have been created as a result of retirement, death or suspensions need to be filled immediately because our hospitals, clinics and schools cannot afford to run without

# **Expected**

There is no class in the school system that must function without a teacher, neither hospital that is expected to run functionally without services of nurses, doctors and their support staff.

We urge government to immediately review this circular, it is not good for the country and definitely not good for Prime Minister Ambrose Mandvulo Dlamini and Finance Minister Neal Riikenburg.

We want to believe that they have correctly spotted other areas or sectors where government needed to make some sav ings and human resources is not one of them under the current circumstances.

If government want to tackle the huge public service question, it must confront it headon and stop implementing it through

If we were to do so, we need to be honest and correctly identify the areas where there is too much fat. Definitely schools and hospitals are not such areas.

If we poorly manage these sectors, the results are going to be immediate.

This will be an indication of a bleak future, hence we urge the prime minister and the finance minister to withdraw this circular immediately.

### Resources

What worsens our situation is that we are not only failing to provide the human resources but also failing to deliver drugs on time and money to ensure that schools run efficiently. With no nurses, doctors, teachers, money and drugs, these is a con-

coction for disaster. Let's quickly deal with this situation before we add loss of life and bleak future to what is already a scary scenario.

"The two countries are neighbours and have had good political relationship for a long time, but what needs to be strengthened are economic relationships.

The Kingdom of Eswatini has an agro-based economy and therefore any relationship based in agriculture and other related sectors are of great importance to the entire nation," he said.

He then expressed gratitude to the people and Government of Mozambique for hosting them and also accepting the country's request to have access to fishing in the sea aswell have access to make use of their harbours.

# Message of WHO Regional Director for Africa, Dr Matshidiso Moeti, on World Hepatitis Day 2019

Dr Matshidiso Moeti Regional Director, WHO Regional Office for Afric



On July 28, WHO in the African Region joins the global community in commemorating World Hepatitis Day 2019.

Despite the availability of diagnostic tools and effective treatment, less than one in 10 of the 71 million people with hepatitis B or C in Africa have access to testing and more than 200 000 die each year due to complications like end-stage liver cirrhosis and liver cancer.

The theme this year, *Invest in Eliminating Hepatitis*, is a timely reminder that this disease can be eliminated by 2030 with adequate resources and strong political commitment.

In June, the World Health Organization developed the first hepatitis scorecard to track progress across the Region. The scorecard shows that:

 the highest burden of hepatitis B infection in children under five years is seen in countries without hepatitis B birth-dose vaccination in combination with suboptimal coverage (under 90%) of the childhood pentavalent vaccine; and testing and treatment as a public health approach remains the most neglected aspect of the response.

Funding hepatitis testing and treatment services as part of universal health coverage is a cost-effective investment. WHO commends Rwanda and Uganda for providing free access to hepatitis testing and treatment.

Today, I call on Member States to invest in a public health approach towards elimination of viral hepatitis B and C in Africa. Countries should invest in hepatitis B vaccination for all newborns and integrate hepatitis interventions as part of health system strengthening. This includes building on existing laboratory capacities for HIV and TB, embedding hepatitis surveillance in the national health information system, and securing supplies of affordable medicines and diagnostics.

WHO commends Gavi, the Vaccine Alliance for supporting hepatitis B birth-dose vaccination and the Global Fund for providing hepatitis C care for people receiving HIV therapy.

We salute Egypt for the recent proposal to support hepatitis testing and


treatment for one million people across 14 African countries


I call on partners and pharmaceutical companies to reduce the cost of hepatitis B and C diagnostics and medicines. Together with the research community, we can collectively explore ways to simplify testing and treatment, and promote innovation towards a cure for hepatitis B and a vaccine for hepatitis C.


In addition to governments and partner efforts, civil society and people living with viral hepatitis should continue playing a central role in raising community and political awareness.

WHO will continue to support collaboration across Member States – last month the African Hepatitis Summit in Kampala, Uganda was attended by more than 600 people from 32 countries.

In the words of the "African Hepatitis Song" launched at the Summit, "let's all unite and invest to win this war on viral hepatitis, let's sensitize all the people and let all play our unique roles". This is what is needed to reach the goal of elimination of viral hepatitis by 2030.

# TRUMP BRANDS MOSTLY **BLACK BALTIMORE** THE ESTED MESS

**USA - US President Donald** Trump was hit with new accusations of racism on Saturday after he attacked a prominent African American congressman and branded the majority-black city of Baltimore an "infested mess".

Trump's outburst came in a series of sharply worded tweets aimed at Democratic Representative Elijah Cummings - a high-profile critic of Trump's administration whose district covers much of Baltimore.

"Cummings District is a disgusting, rat and rodent infested mess," the president wrote, calling it "the worst run and most dangerous anywhere in the United States".

"No human being would want to live there," he said - in an attack ostensibly provoked by Cummings's criticism of the harsh conditions facing would-be asylum seekers at the Mexican border.

"Rep Elijah Cummings has been a brutal bully, shouting and screaming at the great men & women of Border Patrol about conditions at the Southern Border, when actually his Baltimore district is FAR

WORSE and more dangerous," Trump alleged.

'Racist' attack

The president's morning diatribe ignited a storm of criticism, less than two weeks after the US House of Representatives condemned him for "racist" comments targeting a Somali-born congresswoman.

The top Democrat in Congress,

Nancy Pelosi - whose father served as mayor of Baltimore - accused Trump of a "racist" attack.

"@RepCummings is a champion in the Congress and the country for civil rights and economic justice, a beloved leader in Baltimore, and deeply valued colleague," Pelosi wrote on Twitter.

"We all reject racist attacks against

him and support his steadfast leadership." The Democratic mayor of Baltimore Bernard "Jack" Young - who is black - rejected Trump's rhetoric as "hurtful and dangerous". "It's completely unacceptable for the political leader of our country to denigrate a vibrant American City like Baltimore, and to viciously attack US Representative Elijah Cummings," Young wrote in a statement. Prominent Democratic presidential candidate, Kamala Harris, tweeted that she was "proud" to have her 2020 campaign headquarters in Cummings's district.

"It's disgraceful the president has chosen to start his morning disparaging this great American city," said Harris, one of two leading black candidates in the race to succeed Trump.
'Go back'

Cummings himself tweeted: "Mr President, I go home to my district daily. Each morning, I wake up, and I go and fight for my neighbours. It is my constitutional duty to conduct oversight of the Executive Branch. But it is my moral duty to fight for my constituents."

# U.S. Marines 'likely' to enter Venezuela

CARACAS - Venezuelan Socialist Party Vice President Diosdado Cabello on Saturday predicted US Marines will "likely" enter the South American country, speaking a week after a confrontation between aircraft belonging to the two countries' armed forces.

"We are few, a small country, we are very humble, and here it is likely that the US Marines enter. It is likely that they enter," Cabello told the Sao Paulo Forum, a gathering of leftist politicians and activists from across Latin America, without citing evidence.

"Their problem will be getting out of Venezuela." US-Venezuela tensions have escalated this year since Juan Guaido, leader of the opposition-controlled National Assembly, invoked the constitution to assume an interim presidency in January, arguing socialist President Nicolas Maduro's 2018 re-election was illegitimate. The United States and most Western democracies have recognised Guaido as the rightful leader. The Trump administration has said it prefers to continue to use sanctions and diplomacy to pressure Maduro to step down, but has not ruled out military action as an option.

Cabello presides over the Constituent Assembly, a legislative superbody loyal to Maduro which is not recognised by the opposition. He is widely viewed as the second most powerful official in Venezuela's government, after Maduro.

The US military accused a Venezuelan fighter aircraft of "aggressively" shadowing a US Navy plane in international airspace over the Caribbean Sea on July 19. Venezuela's government said the "reconnaissance and intelligence aircraft" had entered its airspace. AP

# SA Court approves R5 billion class action settlement

JOHANNESBURG - A Johannesburg High Court on Friday approved a R5 billion rand (\$353 million) class action settlement between gold mining companies and law firms representing thousands of miners who contracted the fatal lung diseases silicosis and tuberculosis.

The settlement follows a long legal battle by miners to win compensation for illnesses they say they contracted over decades because of negligence in health and safe-

"All the parties made an effort to ensure that the settlement agreement is reasonable, adequate and fair," the High Court said in its judgement.

The gold producers agreed in May last year to the settlement but it needed to be approved by the Johannesburg High Court before being implemented.

The class action suit was launched in 2012 on behalf of miners suffering from silicosis, an incurable disease caused by inhaling silica dust from gold-bearing rocks.

It causes shortness of breath, a persistent cough and chest pains, and also makes people highly susceptible to tuber-

The companies involved are Harmony Gold, Gold Fields, African Rainbow Minerals ARIJ.J, Sibanye-Stillwater SGLJ.J, AngloGold Ashanti and Anglo American South Africa. The latter no longer has gold assets but historically was a bullion producer. Reuters

# UN receives Uganda soldiers following attack in Somalia

MOGADISHU - The United Nations in Mogadishu received a new batch of Ugandan soldiers a day after the deadly suicide attack that claimed the lives of six and injured five including badly wounding the Mayor of Mogadishu.

"Do your work. It is about the mission all the time. Forget about all other things. For the next one year you are going to be here, please forget about any other thing and focus on the mission," said Lt. Gen. Peter Elwelu, Commander of Uganda's Land Forces.

UN Secretary-General's Special Representative for Somalia, James Swan welcomed the soldiers that are reinforcement to the UN's security in the East African state, on Thursday. Africanews

Afghan-Taliban talks could happen

LAW

KABUL - Direct talks between the Afghan government and the Taliban could begin in Norway within the next two weeks, officials and sources said Saturday, marking a potentially crucial step in efforts to end the war.

The Taliban have so far refused to speak to the government of President Ashraf Ghani, which they see as illegitimate, except for at a recent summit where Ghani officials attended in a "personal capacity".

"We are preparing for direct talks," said Abdul Salam Rahimi, the state minister for peace affairs, noting that the government would be represented by a 15-member delegation. AFP Labour plot ways to block no-deal Brexit

LONDON - Former Chancellor Philip Hammond, who quit the government last week before Boris Johnson took over as prime minister, has held secret talks with the opposition Labour Party about how to stop a no-deal Brexit, a newspaper said. Hammond, who has long opposed leaving the European Union without a transition deal to soften the economic shock, met Labour's top Brexit official, Kier Starmer, shortly after he quit the government, the Observer said.

The newspaper said Hammond and Starmer agreed to work with other senior lawmakers including former Conservative minister Oliver Letwin to thrash out the deal. Reuters

Zim tourism minister charged

HARARE - Zimbabwean Tourism Minister Prisca Mupfumira was charged in court on Friday with corruption involving \$95 million from the state pension fund after questioning by the newly formed Zimbabwe Anti-Corruption Commission (ZACC). Mupfumira is the first senior government official to be interrogated by the commission, which was appointed by President Emmerson Mnangagwa last week after he promised tough action against graft. The prosecution laid out charges ranging from alleged abuse of state pension fund money to finance Mupfumira's political campaigning to directing investments. Reuters

# BRIEFS Africa must boost industrial capacity

ABUJA - African nations will need to boost output of goods and services and integrate payment systems if they are to take advantage of a new \$3.4 trillion economic initiative, according to the head of the African Development Bank. A continental free-trade zone was launched this month in Niger which, if successful, will usher in a new era of development for an area with a population of 1.3 billion people. It is hoped that the 55-nation African Continental Free Trade Area - the largest bloc since the creation of the World Trade Organisation in 1994 - will help unlock Africa's long-stymied economic potential.AFP

MPUMALANGA - EFF leader Julius Malema said, on the party's sixth birthday, that many thought it would be irrelevant after the departure of the former president after it "humbled him", but it continued grow-

"They said it will die after Jacob Zuma, that it exists because Jacob Zuma is there. Hey, we fought Zuma. He is looking after cattle because of this EFF," he said during his address at KaNyamazane Stadium in Mpumalanga on Saturday.

"[Public Enterprises Minister] Pravin [Gordhan] will go. The same way the EFF said [Athol] Trollip in PE will go; he's gone. The same way we said [former minister] Malusi Gigaba will go; he's gone. The same way we said [former minister] Nhlanhla Nene will go, he's gone.

"So Pravin Gordhan, let us tell you now... you can scream and kick, your

door is open. You are avoiding the unavoidable. The powerful have fallen. You are nothing. We are not scared of the cabal. You must ask Zuma, we have humbled him."

This week, Malema said the EFF will head to the Constitutional Court if Gordhan's urgent application over Public Protector Busisiwe Mkhwebane's remedial action against him, in the socalled SA Revenue Service "rogue unit" matter, is approved by the Gauteng High Court in Pretoria.

Mkhwebane instructed President Cyril Ramaphosa to initiate disciplinary proceedings against Gordhan within 30 days of the release of the report, however the minister wants the remedial action suspended until his judicial review of the report is finalised.

Malema, who at the time said the party had nothing against Gordhan, called for the public enterprises minister to be fired, saying he "doesn't

deserve to be a minister" and behaved like "an untouchable politician in South Africa". During his address on Saturday, Malema warned that the EFF "has pronounced on" Gordhan.

"They said Zuma will go and the EFF will be irrelevant. They said the EFF is obsessed with Zuma. What did Zuma do to these people? This is personal between Malema and Zuma.

"That nonsense they are repeating today. They just replaced it with a name. It's no longer Zuma, it's Pravin. 'Why are they obsessed with Pravin? This is personal. They are scared of SARS, they are scared of the Hawks' ... We are not scared of anything. Nothing can scare us; when we see an injustice, we go after it."

Racists and the corrupt were out to destroy the EFF because it is the "only party in SA that is fighting for a black person", Malema told a sea of supporters. News24

# AG unable to confirm corruption in Alexandra Renewal Project

ALEXANDRA - The office of the Auditor General was unable to confirm on Friday to a South African Human Rights Commission hearing if it had found instances of corruption in the embattled Alexandra Renewal Project (ARP).

Earlier this year, the SAHRC and the Office of the Public Protector launched an investigations into what had happened to the ARP funds, following protests in the township earlier this year.

Concerns had been raised by Alexandra residents that the R1.3bn that had been set aside for the 2001 project had been squandered.

On Friday, the AG's office sat for the last day of the fourth sitting of the Alexandra inquiry. Here is what it revealed:

Initially, R1.3bn was budgeted for the project, aimed at revamping Alexandra. Officials from the AG's office testified that R2.2bn was spent, however the office could not confirm if all that money was used exclusively for ARP;

Government officials, who were responsible for the smooth running of the ARP, failed to comply with auditors. The Gauteng Department of Human Settlements failed to provide relevant documents to auditors, as well as approved business plans of how some ARP projects were going to be implemented;

Auditors found a lack of cooperation from all three spheres of government - local, provincial and national - during its auditing of funds spent.

Audit procedures were only limited to electrification and some building projects. Auditors did not have sufficient information to audit water and sanitation, roads and storm water projects, and procurement from the Gauteng Department of Human Settlements. The lack of documentation for auditing resulted in auditors not being able to answer all relevant questions at the

The AG's office found there was poor project planning and lack of documentation to assess the planning of the ARP. In addition, individual projects within ARP were not effectively implemented and monitored;

Going forward, the office of the AG recommended the establishment of proper documentation and filing systems to track information and monitor projects.

The hearing adjourned on Friday. News24

NELSPRUIT - EFF secretary-general Godrich Gardee has defended under-fire Public Protector Busisiwe Mkhwebane, saying she should be allowed to complete her seven-year

Gardee, who was speaking on the sidelines of the party's sixth anniversary celebrations at KaNyamazane Stadium in Nelspruit, Mpumalanga, said Mkhwebane was wanted out by white monopoly capital, white people and disgruntled people.

"We have no problem with that office, we respect that office," he

Gardee said Mkhwebane must be allowed to finish her term.

Mkhwebane has been under siege since the Constitutional Court confirmed an earlier North Gauteng

The apex court found that Mkhwebane had misled the high court by, among others, withholding information about a meeting she held with former president Jacob Zuma during her investi-

gation of the R1.125 billion lifeboat the central bank gave to Bankorp, one of the banks that amalgated to form Absa. The DA has

asked National Assembly speaker Thandi Modise to institute proceedings to remove Mkhwebane and the matter has been referred to the portfolio committee on

justice. Mkhwebane has also been threatened with being disbarred with the Legal Practice Council by a non-governmental organisation.

Meanwhile, thousands of EFF supporters gathered at the stadium ahead of party leader Julius Malema's address on Saturday afternoon.

"We are going to communicate decisions tomorow," said Mabe. ANC secretary general Ace Magashule is expected to address the media at the briefing next week. Sources said the matter of senior party member Derek Hanekom was also raised at the meeting.

BNo conclusion was drawn. Hanekom has angered some people in former president Jacob Zuma's faction. Zuma has said on social media Hanekom was a known enemy agent. 














### COULD Sengwayo be the father Qaphela never had?





HOCKENHEIM - Max Verstappen won a helter-skelter German Grand Prix after Lewis Hamilton crashed off while leading - the world champion was dealt blow after blow all

The rain fell steadily on the track for most of the afternoon, but nothing else was steady. It was bonkers. Aquaplaning, strategy blunders, pitstop botches. Comedy and upset abounded.

For Verstappen, when all the carnage was over, it was his second win of the season and another validation of his abilities in the wet, that true test of the best. Hamilton, who finished 11th, had looked on course for most of the first half of the race to win from pole but his own errors and those of his team cost him that early near-certainty.

He suffered the ignominy of run-

This is what rain does to Formula One. It turns the tables until the feet are pointing to the sky.

The pivotal moment came on lap 29, when Hamilton ran wide at the final corner, the wettest point. By this time he had been shod on slick tyres - like the rest - but it was an error to have done so. The teams had been seduced into thinking that the track was dry enough. No, it wasn't; it was a curate's egg and that last sector had perdition written all over it even if other swathes of asphalt were becalmed.








