



EMPLOYEES LOCKED

IT was business unusual for a day care centre as some children had to spend the night after their parents were allegedly locked in at work.

The affected employees are said to work for Africa Chicks; a Poultry and Egg producing company situated at Ngwenya in the Hhohho region.

The incident happened on Wednesday night.

According to sources privy with details to the matter, when employees were about to knock off at 5pm on Wednesday they were told not to leave the farm's premises. It is said that they were told that they should wait for a truck that was expected to deliver some eggs from South Africa. The

arrival of the delivery truck is said to have been expected since morning but when their knock-off time approached without the truck arriving at the farm, the employees thought they could leave because it was not communicated to them whether the truck was still coming or not.

Premises

After being told to remain within the farm's premises, it is alleged that superiors indirectly hinted that if anyone left against the order to remain within the premises would face the music.

Out of fear, the employees are said to have been skeptical about leaving so they stayed.

After 5pm, the premises' gates were locked, meaning no one

could either enter or leave the premises unless authorised to do so. The truck is said to have eventually arrived at 9pm and employees were expected to sort the eggs and leave them in the incubation machine until the next morning.

The about 20 employees are said to have worked under duress until around 11:30pm.

This, according to sources, inconvenienced most of them, especially the females because they had left their children at day care centres with the hope that they would fetch them after work as usual. Although they were transported home after they finished the task, some of the women are said to have failed to fetch their children from the centres because

the company vehicle was only authorised to go on permitted routes, meaning it could only ferry employees to their respective places of abode and not go via the day care centres.

An insider said this was not the first time that employees worked overtime into the night due to delayed deliveries.

The source said in most cases, employees fear speaking out even when inconvenienced.

When contacted for comment, the Managing Director Ross Mackie and Hatchery Manager Mphikeleli Ntshalintshali could not be reached through their cellphones as they rang unanswered. However, Motshane Member of Parliament Robert Magongo confirmed knowl-

E1.2M SPENT ON ONE PATIENT THROUGH PHALALA

ABOUT E1.2 million was spent on one patient through Phalala Fund.

This was disclosed by Deputy Speaker Phila Buthelezi on Wednesday during the 2019/20 first quarter performance debate for the ministry of health where he called for an audit into the

Buthelezi said value for money was no longer realised in the fund because many people took chances while looting. He said the problem was that an exorbitant amount of E1.2 million was spent on one patient.

The Matsanjeni North MP explained that in most instances, patients taken for treatment through Phalala Fund suffered from cancer.

"The problem here is that a patient is taken for treatment when the cancer is in the last stages.

Patient

This causes a situation where a patient has minimal chances of survival when going for treatment through this fund. The costs then escalate.

Another problem is that there is a serious lack of controls on the fund, as people help themselves with the money," said the deputy speaker.

Buthelezi said in his constituency, about 80 per cent of patients who went for treatment through the fund ended up dead.

He also called for contributions from people to be done on this fund because government alone could not sustain it. Khubuta MP Musa Mlamuli Mabuza was also of the view that there was a need for Phalala Fund to be sustained another way.

He said the way that Phalala Fund was managed did not help as there were a lot of problems surrounding it.

The legislators said time had come for the fund to be sustained in a way

that would be helpful to Emaswati so that it could continue to do what it was made for.

Commended

The Kubuta MP commended the ministry of health for the improvement shown in the decrease of the number of people going for treatment through Phalala Fund.

This was after Minister of Health Lizzy Nkosi highlighted that the numbers were decreasing.

However, she did not quantify the decrease.

E132m owed for ARVs

THE ministry of health has arrears amounting to E132 million in respect of antiretroviral (ARV) drugs.

This was said by Minister of Health Lizzy Nkosi on Wednesday during the debate of the 2019/20 first quarter performance debate.

The minister said this showed improvement on the side of the ministry because they owed about E1 billion during the start of the 11th Parliament.

Nkosi said the arrears were due to the fact that the ministry was not able to pay the debts because of cash flow problems experienced.

The ministry now has to settle the bills from the 2019/20 budget and that would create a shortfall in this year's budget.

However, the minister said her ministry was in a process of settling old bills. The ministry had to deal with problems such as having the National Tender Board extend the validity period of the last financial year tenders so as to facilitate payment to suppliers.

Nkosi said the ministry would shortly be finalising the current year's tenders for ARVs, where they had to negotiate prices for one of the medicines since they were not satisfied with the received offer.

She told MPs that negotiating the tender prices in government required special permission from the National Tender Board.

The process had further delayed the placement of ARV orders, but the ministry hoped to finalise the process soon as to place orders to replenish stock. The minister said all health facilities had reported frequent medicine stock-outs, which affected the management of their patients in a negative way.

While the majority of patients were negatively affected, highly impacted patients were those on psychilatric medication, which stocked out for longer periods, and those patients that took anti-hypertensive treatment

The main cause for the stock-out was failure to pay suppliers on time due to fiscal challenges facing government.

The minister said most facilities had been negatively affected by the delayed payment and subsequent withdrawal of services by service providers.

These included catering, security, servicing of medical equipment, external referrals, cleaning materials, protective suppliers, among others. Some of the most affected facilities in this regarded included Mbabane Government Hospital and Nhlangano Health Centre, particularly with regards to catering and security.

The frequent shortage of fuel has also affected the operations of the ministry. Activities of the ministry that required the use of fuel included transportation of medicines, laboratory samples, collection of blood donations, medical waste incineration, conducting outreach, among others.

PHALALA FUND IN E94M ARREARS

AN amount of E94 million is owed by government through Phalala Fund.

Phalala Fund is a facility set up by government so that patients from Eswatini can go and access health services that are not available in the country.

The government pays medical expenses on behalf of Emaswati that need the medical attention.

Minister of Health Lizzy Nkosi said in the beginning of the current fiscal year, the ministry of health received a budget of E97 million allocated for this fund.

"We are currently sitting at E94 million arrears, which include arrears from the last fiscal year and expenditure incurred in this quarter," Nkosi said.

The minister further said out of only 58 referrals to South Africa, about 78 per cent were related to cancer. This, according to Nkosi, emphasised the need for the country to invest in the local treatment of cancer.

Ministry to subvent over E250m

THE ministry of health is expected to subvent an amount of E251 926 730 to about 19 organisations within the health sector.

The money for the subvention has been allocated for the current 2019/20 fiscal year. The organisations to receive the subvention include RFM Hospital in Manzini and Good Shepherd Hospital in Siteki.

Minister of Health Lizzy Nkosi said an amount of E62 722 742 had already been paid to these organisations.

Of the E62 722 742, RFM Hospital received E34 071 134, while Good Shepherd received E20 750 000. Despite the challenges faced by the health ministry, Nkosi promised that her ministry would continue to do all it could to provide quality services to the people of

Eswatini. On a positive note, the five-year funding by PEPFAR (Cop 19) of USD 79 630 000 (about E1 139 505 300) had been approved. These would cater for HIV/AIDS, ARVs for children, and other technical support.

Global Fund had approved USD 3.4 million (about E48 654 000) for the roll-out of the client management information system, which would improve efficiencies across the health sector. An additional USD 700 (about E10 017) for male voluntary circumcision was approved by Global Fund. The ministry of finance had also released the health ministry's medicines' budget to enable the ministry to prepare for vaccines, as well as to pay suppliers to expedite orders.

Ratepayers, street vendors give mayor ultimatum

DISGRUNTLED ratepayers and street vendors have given Mbabane Municipal Council Mayor Sikhumbuzo Dube an ultimatum to deal with their grievances or else they will not stop their demonstrations until Chief Executive Officer Gideon Mhlongo resigns.

This was revealed during the second day of the ratepayers and street vendors picket at the Municipal Council offices yesterday where they listed a number of issues.

They described Mhlongo as stubborn and disrespectful.

Dan Mavuso, who is the Secretary of the Zonal Leaders Association, alleged that Mhlongo has become untouchable which has made him to grow stubborn and disrespectful of his position.

The former Premier League referee said Mhlongo has undermined everyone, including councillors, the mayor and the ratepayers at large.

"Mhlongo is uncooperative, a stiff neck and with him out of the office the Municipal Council can function very well," Mavuso said.

The ratepayers vowed to ensure that Mhlongo was ousted for a fresh blood to take over with immediate effect and if that was not materialising, they will picket outside the Muncipal Council's offices until their grievances were attended to. The vendors and ratepayers convened outside the council's offices where they demanded to see the Mayor Dube, whom they said was the right person to hear their grievances.

When addressing the mayor, Isaac Masombuka said there was something fishy with the way the council is run.

He said the E150 they are paying for permits was not fair on them, alleging that the mayor was not aware that they were paying so much as street vendors.

"What we knew was that we would pay E50 for a picture and the E50 for the permits but now Mhlongo has increased the money to 150 which we are sure the mayor was not aware of," Masombuka said.

He mentioned that they had earlier negotiated that the permit fee be paid in instalments because the E150 was exorbitant considering the low buying power from customers.

Masombuka went to the extent of ordering the mayor to fire the CEO (Mhlongo) with immediate effect because he was letting the council down.

He even claimed that Mhlongo didn't deserve to be in office because he was once probed by an inquiry led by now High Court Judge Mzwandile Fakudze.

That probe recommended that Mhlongo be removed from the Mbabane Municipal Council and he worked at RSSC. His return to Mbabane was questionable as his charges were dropped and he was reinstated with no conditions, said the protesters.

On another note, Sive Dlamini, who represented the ratepayers, said their welfare was not prioritised by Mhlongo.

He urged the mayor to always listen to the people whom he serves and refuse to be misled by the CEO.

He stated that there is not even a single mayor who in his or her tenure took time to visit the townships and street vendors to see their working conditions and to hear what their challenges were.

PSPF distances itself from Ex-politicians Association plan

IT appears the idea to withdraw the newly-formed Eswatini Former Politicians Association (EFPA) members' pension savings from Members of Parliament and Designated Officers Bearers (MOPADO) may not materialise after-all.

The association, which had its meeting at Caritas in Manzini, resolved to withdraw their savings from MOPADO for the Public Service Pensions Fund (PSPF).

PSPF has since distanced itself from the former politicians' issue.

PSPF spokesperson Elkan Makhanya made it clear yesterday that PSPF is not aware of such developments.

Makhanya went on to state that PSPF does have the capacity to manage their pension. However, he indicated that MOPADO is a creature of legislation and so is PSPF. He said any changes on these pension schemes can only be effected by change of legislation.

"It is therefore not within our powers to direct who administers their pension," Makhanya stated.

Amongst the reasons given by the former politicians was that their money was not safe with MOPADO.

They also stated that they had no confidence on the MOPADO's newly-elected board, as they felt there were certain issues that had to be ironed out with them.

It further emerged during the meeting, according to sources, that PSPF had a better offer than MOPADO.

They said the basic monthly annuities at PSPF was E1 000, compared to MOPADO, where it was E400.

They also said they were informed that PSPF did not have a problem with keeping their money.


...Call for reinstatement of suspended councillors


Dube said during an interview that they had accepted the grievances of the parties involved and would come back with a solid response as soon as possible. Ward Four Councillor Sikhatsi Dlamini said the issue of the carwash was once addressed but nothing concrete was done about it.

It is alleged that Dlamini once moved a motion about the carwash but it was thrown out of the window by the mayor. The publication gathered that the carwash was operated by 20 young men and the current owner since 2014. It is alleged that the two parties were both given permits to run the carwash jointly but what later happened this year, the 20 young men's contract was terminated, leaving the current owner to operate it.

Dlamini said he hoped the mayor would call an urgent council meeting to address the issues that were raised by the affected parties.

CORRECTING THE DEFAMATION AND INTENTIONAL MISINFORMATION AGAINST MEDSCHEME ESWATINI

"Cherry picking, suppressing evidence, or the fallacy of incomplete evidence is the act of pointing to individual cases or data that seem to confirm a particular position while ignoring a significant portion of related cases or data that may contradict that position. It is a kind of fallacy of selective attention, the most common example of which is the confirmation bias."

This definition of cherry picking in Wikipedia best describes the article "How Medscheme tried an E30 million medical aid heist at Swazimed," and the accompanying editorial headlined "Speaking My Mind" in the July 2019 issue of The Nation Magazine.

Both articles were misleading, defamatory and at best intentional misinformation against Medscheme Administrators Eswatini Limited (Medscheme Eswatini) on a number of counts, particularly the interpretation of the legal dispute that is currently pending before the High Court of the Kingdom of Eswatini.

It is deeply regrettable that Medscheme Eswatini was not afforded an opportunity to set the record straight, a departure from the basic standard of ethical reporting. This omission confirms that The Nation never intended to report in a fair and balanced manner to advance the interests of one particular party in the dispute currently before the High Court

It is common knowledge that Swazimed and Medscheme Eswatini were engaged in arbitration proceedings. At the conclusion of the arbitration, Medscheme Eswatini prevailed and the award was in its favour. Swazimed's counter-claims were dismissed. Medscheme Eswatini therefore views the lead article published by The Nation as highly defamatory as it alleges that Medscheme Eswatini conducted a "medical aid heist" against Swazimed. The company secured an arbitration award in its favour through lawful means by exercising its contractual right to have the dispute resolved through arbitration.

The parties are currently in further litigation arising from the award because Swazimed has refused to comply with the award, Medscheme has brought a High Court application, in terms of normal procedure under the law, to enforce the award. Swazimed thereafter has lodged an application for the High Court to review and set aside the award.

FOREIGN COMPANY

Whilst it is true that Medscheme Eswatini is a subsidiary of Medscheme Holdings Limited, Medscheme Eswatini is a company that is registered, licenced and domiciled in the Kingdom and has been operating in the Kingdom for 39 years. For the bulk of this period, Medscheme Eswatini was appointed by Swazimed as its administrator, a fund we successfully ran.

The fact that Medscheme Eswatini is a subsidiary of a foreign company is not unique in the Kingdom and there are a number of other subsidiaries of foreign brands that are operating locally. This type of irresponsible writing that characterises *The Nation's* lead article is in fact counterproductive to the country's efforts in attracting FDI.

FACTUAL INACCURACIES

Our Management fees paid by Swazimed have never at any point reached E40 million per annum. Our fees have at all times been at rates as agreed contractually with Swazimed, and were charged for the services we have provided to the Fund.

Medscheme has never refused to negotiate any terms of the agreement. If anything, at some point, Medscheme Eswatini approached Swazimed in a bid to resolve the dispute by way of a mutually agreeable settlement which Swazimed was not interested in, this despite the fact that it would have brought the litigation to an end which would have been in the interests of the parties to the dispute and members of the Fund.

These errors could easily have been avoided had *The Nation* sought to secure our comments before going to print. We can only attribute such inaccuracies in reporting to the deliberate failure of *The Nation* to get our side of the story before publishing the lead article.

DISPUTE CURRENTLY PENDING BEFORE THE HIGH COURT

In his column, the editor also seeks to improperly and impermissibly influence the judges of the High Court to rule in favour of Swazimed by calling on the judiciary "to come to the party". This is not only contempt of court in that it seeks to influence the outcome of a case yet to be decided, but also goes against the *sub-judice* rule which holds that parties cannot comment about a matter pending before Court. This is a flagrant abuse of press freedom.

Implication of Judiciary and Legislature

Without naming them, and without setting out the supporting facts, the lead article states that "there are also prominent local figures, some of whom are serving in parliament and others are judges who are lining up to bag the riches that could come from this windfall".

Medscheme Eswatini views such a statement as highly defamatory to the company as it suggests an improper relationship between the company and these two arms of government. Such a statement is also contemptuous of Court and implies that the judiciary has been captured or is not independent and neutral.

We would like to put it on record that the matter between Medscheme Eswatini and Swazimed is a contractual matter. Medscheme Eswatini exercised its contractual right to refer the dispute to arbitration, as did Swazimed in referring its counter-claims to the same arbitration process. The dispute was decided in favour of Medscheme Eswatini. We are now seeking the enforcement of that award in the High Court.

Medscheme Eswatini believes in the integrity and the independence of the judiciary and we remain confident that this matter will be resolved on the basis of the sound application of legal principles after the Court has considered all the material placed before it.

Schaza murder:

'Blood samples were extracted from Schaza's body

AS the trial for murder suspect Sergeant Lucky Óbama' Matsenjwa continued yesterday morning, the Court was told the blood samples from the late police officer Mduduzi 'Schaza' Matsebula were extracted from his lifeless body.

This was yesterday disclosed by the Prosecution's witness (PW) number 26 Detective Constable Mpendulo Nxumalo when led in evidence by Principal Crown Counsel Macebo Nxumalo.

The police officer told the Court that he received a call from the late ace detective Solomon Mavuso who asked they proceed to the Mbabane Government hospital mortuary for a postmortem.

Found

The officer told the Court he, together with his colleague Sergeant Sandile Choncho, proceeded to the mortuary as instructed and found Police Pathologist Dr Khomma Reddy already there and as scenes of crime officers, they covered

"After having conducted the photo shoot, we then requested Dr Reddy to extract blood samples from Matsebula's body which he did before we sealed the samples in police seal bags," this wit-

From there he, told the Court that he, together with Choncho, proceeded to the Police Headquarters where they kept the samples in a refrigerator ready for the science laboratory for forensic exami-

Schaza blood samples contradiction in pathologist, officer evidence

DURING cross-examination, Advocate Lucas Maziya, who is representing Matsenjwa as instructed by lawyer Sipho Gumede, put it to the scenes of crime officer that what he told the Court was incorrect.

Maziya put it to constable Nxumalo that in fact in his evidence in chief during the ongoing trial, the Pathologist, Dr Reddy, informed the Court that never at any stage were blood samples taken from the body of the deceased during the post-

"Officer, would you be surprised that in his evidence in chief before this Court, Dr Reddy told the Court that never at any stage were blood samples of the deceased taken from his body, I put it to you that what you are telling this Court now is incorrect," Maziya said.

Posing for a while, officer Nxumalo replied to the negative as he told the Court that what he said about the blood extraction was correct.

'SCHAZA' FINGERED 'OBAMA' IN SCANDAL - INVESTIGATOR

ANOTHER witness who was led in evidence by the crown was assistant Superintendent Isaac Dlamini who was based at the Hhohho Regional Police Headquarters (RHQ) in 2012. In his evidence, he told the Court that he, together with two other officers detectives David Gwebu and Ashmond Shongwe, were assigned to investigate the fingerprints scandal.

Dlamini told the court that during their investigations, one of the suspects proved to be the accused person Lucky Matsenjwa. He informed the Court that further investigations led them to the late Matsebula (Schaza) who was the one who fingered Matsenjwa hence he was their principal witness in the fingerprints case. "Following our investigations, the late Matsebula fingered Matsenjwa as the main suspects further investigations led to the arrest of three other police officers who are now co-charged with Matsenjwa," detec-

tive Dlamini. He further told the Court that subsequent to that, the four police officers were arrested and charged for contravening the Prevention of Corruption Act of 2006. However they were all granted bail by the High Court and he later learnt that Matsenjwa had been arrested at the Ngwenya border for allegedly flouting bail conditions.

Govt accountant in electricity units fraud scam fired, granted E15 000

THE second suspect fraudster in the electricity units scam has been admitted to E15 000 bail after filing an urgent application at the High Court yesterday afternoon.

Lindiwe Nkonyane of Ngwenya filed the application following that of her co-accused Thabo Mswane who was also granted E15 000 bail by the same Court on Wednesday.

Represented by Manzini based senior attorney Ben J Simelane of Ben J Simelane and Associates, Nkonyane made her appearance before High Court Judge Titus Mlangeni while the Crown, which indicated that it was not opposed to the bail, was represented by crown counsel Melusi Lukhele. When granting her bail, Judge Mlangeni however ordered that she pay E5 000 in cash and the E10 000 in a form of a surety.

Affidavit

In her founding affidavit filed before Court, she stated that she was called by the Mbabane Police under the Commercial Fraud and Vice Section who advised her to report to the station and she duly did so. However upon her arrival she was advised that she had been charged with the offence of

She assured the Court that she shall abide by all bail condition as imposed by the Court and shall not interfere with any of the crown witnesses since they are not yet known to her.

She also submitted that as result of the offences she is suspected to have committed, she was dismissed for her employ by Government in April this year and she has been without gainful employment since then.

She told the Court that she is married and resides at her home at Ngwenya with her family including her husband and children.

Judge Mlangeni gave her the normal

bail conditions and that she shall surrender her passport or travel document to the investigating officer and attend all Court remands when ordered to do so

Nkonyane, who was attached to the Ministry of Public Works and Transport as an accountant, is co-charged with Mswane an Estate Assistant, and according to the charge sheet, they are facing a total of 44 counts of fraud, with offences having been committed between August 2016 and December 2018. According to their charge sheet, Nkonyane and Mswane are said to have acted jointly in furtherance of a common purpose, when they defrauded and misrepresented to Ministry and Public Works and Transport Financial Controller Nikiwe Maphalala that the electricity units which the duo purchased, were to be used for the Ministry of Works' depots. Nkonyane was entrusted with the due care and custody of monies and purchasing of electricity

Employed

Mswane, who was employed as an Estate Assistant of the Central Bank of Eswatini, was entrusted with the due care and custody of monies and purchasing of electricity for the Central Bank's properties.

Through their misrepresentation, the duo is said to have induced the Ministry of Public Works and Transport to the actual loss and prejudice to the sum of E772 333 which such units they purchased and used for their personal use or gain for varying

They are said to have committed these offences knowing very well that the said units were not purchased and loaded in the Ministry of Public Works and Transport depots.

No food here, stay home - schools tell pupils

SOME primary school pupils in Manzini are already enjoying some time away from school after they were told to remain home due to lack of food.

The pupils are said to have been told by their schools' administrations that they should remain at home because the school no longer had food to feed them. This was communicated to the learners and parents on Wednesday, the day the pupils finished writing their mock examinations.

The early closure means that pupils will have about a week more than the official four-week period they were expected to have as stipulated in the academic calendar. Officially, schools will close on August 9, 2019 and are expected to reopen in September 10, 2019.

One of the schools of this arrangement is Ludzeludze Primary, situated near Matsapha, where parents were informed to keep their children at home because the school no longer had food to feed them.

The letter that is dated July 31, 2019, states that all pupils from Grades One to Five should not come to school. The letter also notified parents to report to the school for an open-day on August 9, 2019, the official closing day. When sought for comment, the School Principal Joana Zwane confirmed that learners were to remain at home ahead of the official closing date. She also conceded that the main reason for this was that there was not food. Although government delivered the school supply for this term, Zwane said it only sustained them until the beginning of this week

Under normal circumstances, Zwane said when the food supply was finished, the school would use some of the money paid by government to purchase some to last until the school closed and even to the next term. However, due to that government had not paid the pupils' second term fees, the school does not have enough cash in its coffers to take care of some necessities.

In this regard, the principal said there had been challenges even with the mock examinations since some material was unavailable. "We had to redirect funds that were meant to purchase electricity to buy some material to be used by the learners in the mock exams.

We even credited others because the situation was too bad," she said. Zwane said she hoped teachers would be able to finish marking and preparing reports while using the limited resources that the school has left.

The only pupils in the school are those doing Grades 6 and 7 who are still working on their Home Economics and other school projects. When contacted on the matter, Principal Secretary for the Ministry of Education and Training Dr. Sibongile Mtshali confirmed that there were schools that were still not paid. She attributed this to the financial constraints faced by government. When asked when the schools might be paid, the PS asked not to answer as she was not in control of the situation.

THE family of the woman who was shot and killed blank by her estranged husband says they will bury Zanele Manana at Ezulwini tomorrow morning.

There is definitely no coming back from that," narrated the source.

"We are not taking instructions from someone who brutally murdered our sister; this man does not exist to us and he should let us bury our sister with the dignity and the respect she deserves after killing her like an animal," said the seemingly furious member. The family member also confirmed that they were preparing for the burial of their sister at Ngonini, Ezulwini. "We are going to have a memorial service tomorrow (today) but we are still awaiting to confirm

the time with her church but we are going ahead with everything," confirmed the source. The source also confirmed that the memorial service will be followed by a vigil tonight, which will be then followed by a funeral service and burial tomorrow morning

The informed source also confirmed that they met as families and discussed everything that needed to be discussed and they are only going forward with everything.

COMMISSIONER of Labour ditions of employment should Sipho Tsabedze ordered that all funds that were unlawfully withdrawn from SMAWU's old bank account by ATUSWA should be paid back with immediate effect.

party fails to find toddler

A search party for a toddler who went missing since last week Wednesday came back empty handed on Tuesday as residents and police joined efforts to find the child.

The community of Ezulwini together with the Royal Eswatini Police Service went on a door to door search and combed surrounding forests in a desperate search for the missing child in the early hours of Tuesday morning.

The child, Melusi Emmanuel Tfwala (four) disappeared while he was on his way to school.

Information gathered is that police received information that the child was last seen walking with an unknown woman.

This new information led to community members gathering at Ezulwini Police Post, where they together with the police began an intense search for the missing child.

Over 50 residents, including the parents of the missing child, took part in the search.

Residents expressed their worry that of late there have been many reports of missing children, especially in areas around Mbabane like Mahwalala.

According to police reports, the child who attends Mbeleko Pre-School, was wearing white school shorts, a navy blue T-shirt and black school shoes. It is said he was also carrying a blue spiderman backpack when he went miss-

Lobamba Regional Operations Officer Tibonisile Mdziniso, who led the search party, said as the police and the community of Ezulwini they went door-to-door and also combed for nearby forests for the missing child.

Mdziniso revealed that the information at their disposal is that the child was spotted in the company of an unknown woman.

The officer appealed to members of the public to be always vigilant.

She asked the nation to be on the lookout for any suspicious person that will be seen with a child that is not his or hers.

10 judicial officers appointed into new positions

DESPITE the infamous Circular No. 3 of 2018 which directed that all vacant posts, including the creation of new ones and promotions across government be frozen, the Judicial Service Commission (JSC) has appointed 10 judicial officers.

According to a government gazette released on July 12, the appointment includes one alternate member of the Industrial Court, four assistant registrars, three acting magistrates and two acting senior magistrates.

The first appointment at the Industrial Court is that of Nkosingphile K Dlamini as an alternate member of the Industrial Court for a period not exceeding three years. This appointment is with effect

The second appointment is that of an Assistant Registrar Chakazile Tsabedze with effect from May 7.

Three others who were appointed for the same position of Assistant Registrar were Khanyisile Masilela, Xolile Nkambule and Gugu Siwela

Meanwhile, Thulani Dlamini, Chazile Thwala and Jabulani Maphalala were appointed into Acting Magistrates and these positions were for a period from April 10 to August 10.

The Judicial Service Commission also appointed Magistrates Sindisile Zwane and Nonhlanhla Dlamini into Acting Senior Magistrates with effect from April 1 to August 2.

Hiring

The appointments come at a time when government issued a statement last year freezing hiring and promotions due to the current financial situation faced by government.

Then Principal Secretary in the Ministry of Public Service Evart Madlopha announced this to principal secretaries and heads of departments through Establishment Circular No. 3 of 2018.

The circular reads as follows: "Principal secretaries and heads of departments are hereby informed that Cabinet has directed that all vacant posts, including the creation of new posts and promotions across government, be frozen.

This state of affairs has been necessi-

tated by the current financial situation in the country and the cash flow problems faced by government.

All service commissions and other designated appointing authorities are therefore urged to heed to this directive and ensure that there are no appointments and promotions made against any vacant post.

Ministries and departments are further encouraged to explore other service delivery methods for the provision of services that require the human capital through consultation with the ministry of public service."

The effective date of this circular was marked to be August 1, 2018.

Home affairs employee arrested for fraud

CRIMES committed by government employees are seemingly prevalent these days as yet another civil servant has been arrested for fraud.

Zipho Thwala (32) of Sigangeni was arrested and charged with fraud, when he was found to have misrepresented to a home affairs official that an Ethiopian national had crossed into South Africa through Ngwenya Border Gate.

According to his charge sheet, Thwala was found to have, on July 17 at Ngwenya Border Gate, defrauded and misrepresented to immigration officer Alfred Gule that on May 18, one Ethiopian national Belay Darlio Bunero went to South Africa through the Ngwenya exit

Thwala is said to have misrepre-

sented that Bunero's passport was stamped with exit stamp number 1817.

This Thwala was said to have done by inducing the ministry of home affairs to the actual loss and prejudice into believing that the said Bunero has been through the Ngwenya Border Gate.

Passport

When Thwala made the misrepresentation, he knew very well that Bunero had not used the passport to go to the Republic of South Africa.

During his appearance before Magistrate Sifiso Vilakati on Tuesday, Thwala invoked his right to legal representation, as he had instructed an attorney to represent him in the court proceedings.

Thwala was remanded into custody until August 9, pending his trial set on October 24.

The court granted him bail of E1 000 to gain his liberation until his trial in October.

Over 900 dagga related arrests in three months

OVER 900 dagga related arrests were recorded by the Royal Eswatini Police Service (REPS) in a period of three months.

These arrests were made during operations which include raids and swoops to curtail crime all over the country.

These statistics are contained in the REPS performance report on recurrent and capital expenditure for the period from April to June. The report revealed that drugs and cannabis (dagga) continued to be a perennial problem in society.

This was illustrated by the fact that, during the period under review, 982 suspects were arrested for being found in possession of the illicit drug consignments without a per-

Of the above mentioned figure, 816 of the suspects were males whereas 166 were females. It is

worth noting that even minors were involved in the dagga drug trade as eight of the suspects were juve-

The potency of the local herb has gotten to the attention of non-locals and also attracts drug traffickers from neighbouring countries as 65 of the suspects were from countries such as South Africa, Mozambique, Lesotho and some from as far as the Democratic Republic of Congo and Tanzania.

Trade

In the fight against the drug trade, farmers were not spared as the police destroyed dagga fields totalling to 226 hectares all around the king-

The police have reportedly seized over 6017 kilograms of cannabis.

Another alarming statistic is that of gender based violence cases as they have increased by 39.3 per cent. During the period under review, 209 cases were recorded against 150 recorded in the same period in

Ten fresh cases brought before one judicial officer

THERE is reportedly a backlog of cases at Siteki Magistrate's Court as there is currently only one judicial officer to deal with both civil and

Principal Magistrate Dumisani Magagula is currently the only judicial officer available at the court. Some officers of the court have expressed concern on the fact that cases are once again piling up due to insufficient staff.

The court has over the past two years been functioning with two judicial officers, being the principal magistrate and Senior Magistrate Donald Mavuso.

However, early this year Mavuso was redeployed to Big Bend Magistrate's Court after it was officially opened by



Chief Justice Bheki Maphalala.

On Wednesday, a total of 10 fresh cases were brought before the principal mag-

These added to other cases which were for remand, resetting and trial.

Apparently, the principal magistrate is the only judicial officer at the Magistrate's Court who has the prerogative to preside on serious cases such as rape.

According to the law, the principal magistrate is the only one mandated to issue a maximum sentence of 15 years while the senior magistrate cannot exceed 12 years. This, therefore, results in rape cases piling up before the principal mag-

Some lawyers expressed their concern on the fact that cases were piling up at the court, resulting to a delay in finalising them.

"We cannot expect one judicial officer to preside in over 10 cases per day," exclaimed a lawyer who had his client's case postponed to a later date.

Meanwhile, the fresh cases which were brought before the court included those of house breaking and theft and assault with intent to cause grievous bodily harm. Most of the cases were postponed to later dates pending setting of a date


He said their election into office was because God had his eyes on Mbabane branch.

If you are not happy with an FSP you can bring a complaint to our office at no charge and we will investigate the matter and make a decision in terms of Sections 74 and 75 of the Financial Services Regulatory Authority (FSRA) Act, 2010.

How do you lodge a complaint?

Step 1: Contact your Financial Services Provider (FSP) and submit a written complaint giving them 30 days to respond. If you do not get a response or are not satisfied with their response, that's when you can come to our Office with your complaint.

Step 2: Get a copy of our Complaint Form at our Office or the nearest CMAC branch to you or from our website

Step 3: Bring your completed Form together with all your supporting documentation in person or fax or email.







Over 4 600 registered for Sibebe Survivor

WITH only a day to go, 4600 have registered for the 16th edition of the annual Sibebe Survivor Walk.

This was revealed by the Rotary Club of Mbabane Public Relations Officer Hezekiel Mabuza in an interview, where he said this year's event would be bigger and better

Mabuza said this initiative seeks to raise funds to help the needy people from different communities in the country through various projects.

He said some of the projects the organisation usually does fall under the education, natural resources, health and agriculture sectors.

Participation

"It is through the participation of individuals, families and companies that we are able to give back to needy communities and even this year we are happy that there is huge interest being shown by the public towards the annual event," he said. Mabuza added that some of the projects they have carried out include the renovation of schools in various regions of the country.

He made one example of a project where the organisation is currently building toilets at Ncabaneni Primary.

The PRO highlighted that building of toilets for communities was the first project of the Rotary Club dating back to 1905. Another school that benefitted from the Rotary Club generosity is Mahlangatja Primary, which had an accessible road network.

The Rotary Club of Mbabane, in collaboration with the ministry of public works and transport, renovated the road leading to the school and that project has been completed.

"Not only that, we have distributed furniture to schools in Hlatikulu, Ngcoseni and Mahlangatsha, where we found that the pupils from these schools were learning under unconducive environments," he added.

Projects

Other projects include the provision of fencing for gardens which are used by communities for took subsistence and commercial purposes.

"We also provide school tanks for water harvesting, and drill boreholes for communities that are in dry areas," Mabuza said.

On another note, Mabuza said some of the projects pursued by the Rotary Club would be showcased during the hiking. He further added that it was going to be great for the organisation to show those who would be in attendance what they are doing for the less privileged in the communities.

"We hope that organisations, sponsors and all individuals will be happy to see that their contributions are indeed channelled to worthy undertakings," he said.

Parking will be provided

THE Public Relations Officer of the Rotary Club of Mbabane Hezekiel Mabuza has assured those who will attend this year's hiking event that parking there would be provided.

Mabuza said this was aimed at reducing the high rate of traffic that could possibly flow to Mbuluzi during the day. Some of the parking spaces will be next to the Central Bank of Eswatini and the Municipal Council of Mbabane offices. "This year we will provide a park and ride around the city of Mbabane and all the participants will be ferried to and from Mbuluzi on buses," Mabuza said

He said the buses would be ready as early as 0530 hours on

Mabuza said for emergencies, they have paramedics as per the norm in recent years.

"For those who will have health related complications during the hiking, we have organised ambulances that will rush them to hospital and this is to avoid fatalities," he said.

Mabuza said water would be provided along the hiking trail on designated stations for the hikers. He then urged the nation to come in their numbers to support the annual event for a good course.

Man assaulted with tomahawk, survives

BY VUYILE DLAMINI Mbabane Magistrate's Court

A man is caught up in a court case which will see go to jail for hacking another with a tomahawk.

A tomahawk is a type of single handed axe resembling a hatchet.

Sifiso Shongwe of Ezulwini area was arrested and charged with assault with intent to cause grievous bodily harm, after he was alleged to have hacked Vusi Sihlongonyane.

According to his charge sheet, Shongwe was found to have, on May 3 at KaBellinah in Ezulwini, wrongfully, unlawfully and intentionally assaulted Sihlongonyane by hacking him with a tomahawk.

Shongwe was hacked several times on the head, back and upper chest, as well as punched with a fist on the left cheek.

The injuries that Sihlongonyane sustained caused him to bleed profusely, to which he was admitted and received treatment at a medical facility.

According to Sihlongonyane's evi-

dence in chief, an argument ensued between the two resulting in Shongwe losing his temper, thus committing the offence. When Sihlongonyane was asked to identify the weapon submitted as evidence, he claimed that the one presented in court was different, as it was missing the sharp allegedly used to injure him.

During his appearance as the prosecution's second witness, Detective Linda Mkhonta of the Lobamba Police Station claimed that he received a file which contained assault charges against Shongwe.

STORIES BY NONDUDUZO KUNENE Mbabane

OVER 3 000 people benefited from the community mobilisation programme under the ministry of tinkhundla administration and development.

The community mobilisation results to the identification of projects.

Lubombo region had the highest number of beneficiaries with 1 375 followed by Mbabane region with 922 beneficiaries. While Manzini and Shiselweni share the bottom spot with 851 and 726, respectively. According to the 2019/20 quarterly report, the ministry aimed at increasing these numbers by sensitising and mobilising communities to start community projects.

The ministry aimed at encouraging communities to access the available develop-

ment fund.

It also aimed at sensitising and mobilising communities for the construction and development of royal kraal structures.

The first community development project that has seen the highest number of beneficiaries is the training and group capacity building.

In this programme, the ministry held 50 meetings in all four regions of the country. Lubombo Region had the highest number of meetings held which were 19 in total. Lubombo is followed by 12 meetings at Shiselweni region, 11 in the Hhohho region and only eight in the Manzini region.

A total number of 33 Tinkhundla were sensitised. The report stated that in the trainings, community members were capacitated on various topics.

These topics included the roles and responsibilities of inneer councils and development committees, group dynamics, Regional Development Fund, and-conflict resolution, amongst others. About 1 156 people benefited under the capacity building meetings.

To ensure that the all chiefdom councils understood their roles, the ministry would continue to conduct trainings for inner councils and chiefdom development committees on their roles and responsibilities, leadership skills and sustainable development.

The ministry also aims to train Tinkhundla councils on project identification, appraisals and prioritisation.

Only 5 chiefdoms have CDPs

ONLY five chiefdoms in the country have developed and launched their Chiefdom Development Plans (CDP).

Four of the development plans were in the Sishelweni region at Lulakeni, Qomintaba, KaPhunga and Buseleni Chiefdoms and one in the Lubombo region at Maphilingo Chiefdom.

The plan itself prioritises optimum land use or a proposed land use plan under the community development opinion. The first chiefdom to launch the plan in

2018 was Ntondozi community.

More communities must be mobilised to establish their CDP.

Plans

The ministry said it would do followups on these plans to ensure proposed projects are implemented. It is also stated that the ministry has deployed community development officers

These officers ensure that all community projects being implemented are completed within the expected time frame.

They also ensure that the completed and implemented projects are effective, efficient, profitable and sustainable. During these visits, the community needs are identified and appropriate corrective measures applied.

So far out of 76 community projects that are monitored by these officers in 36 constituencies in the country, only 51 are doing well, the report states. Hhohho region has the highest number of projects doing well which equals to 21 projects in 14 constituencies, followed by Lubombo region. Manzini has the least number.

BY VUYILE DLAMINI Mbabane Magistrate's Court

A woman's wish to feed her six children saw her commit an unthinkable crime, leading to her being arrested for stealing a car radio in Mbabane.

Calisile Magagula was arrested and charged with theft after she was found to have, on Saturday at Reliable General Dealer in Mbabane, stolen a black car radio valued at E800.

WOMAN STEALS CAR RADIO TO SELL FOR FOOD

During her appearance before Magistrate Sifiso Vilakati on Monday, Magagula was alongside her brother-in-law Mandla Kunene and was found guilty as per her own plea.

Acquitted

Kunene was acquitted and discharged of the offence after he explained that he only went to town to meet Magagula.

When she was given a chance to mitigate for

a lesser sentence, Magagula claimed that she earned a meagre salary of E600, and it was not enough to maintain her six children.

"A salary of E600 is not enough to sustain my family and I had no choice but to take the radio to sell. I intended to buy maize with the proceeds in order to feed my family. I am unmarried and the fathers of my children are deceased," Magagula stated.

After hearing her mitigation, Magistrate Vilakati warned Magagula to desist from such conduct.

"I understand the circumstances that you are facing; however you still do not have the right to commit a crime, even to feed your children. Desist from such conduct," the magistrate warned.

Magistrate Vilakati then sentenced Magagula to serve five months in a correctional facility, with the option to pay a fine of E500.

"Immediately after I received the file, I called Shongwe to the station to ascertain what had happened. When he arrived, I informed him of his rights, and further questioned him about the incident. We then went to where his hammer mill business was located and that was where he retrieved the assault weapon submitted as n exhibit evidence before the court today," Mkhonta testified.

During cross-examination, Shongwe's attorney questioned Mkhonta on whether the weapon before court was the exact one used during Sihlongonyane's assault.

Responded

Mkhonta responded to the affirmative, emphasising that that was the weapon handed to him by Shongwe.

This, the defence stated, was an untruth, as the complainant had previously testified that the weapon was missing a piece.

In its closing submissions, the prosecution led by Chris Sibandze concluded that the court should find Shongwe guilty as per his own plea.

"His plea of guilt meant that he has aligned himself with the commission of the offence. The prosecution paraded two witnesses whose evidence was not disputed by the defence. The court should consider that a medical report was submitted as evidence which proved commission and injuries sustained by the complainant on the day of the incident," Sibandze stated.

In his counter closing submissions, Shongwe's attorney urged the court to consider the aspect of the case where the complainant failed to identify the weapon used.

"The court should consider that the complainant testified that the weapon used to assault him that day was different to the one submitted as an exhibit before court.

The prosecution failed to prove beyond reasonable doubt that the weapon presented in court was the one used during the assault," Shongwe's attorney stated.

Shongwe's attorney further stated that his client was provoked by Sihlongonyane.

"Sihlongonyane interacted with my client three times before the altercation. All those times my client made it clear that he did not wish to conduct business with him. Shongwe even chased him out of his mill because he had no interest on what Sihlongonyane had to say," the attorney stated. The court is yet to mete out Shongwe's sentence, as it ordered him to appear before the court on Tuesday for his sen-

A 26-year-old man of Nkoyoyo has been fined E300 for stealing bread, emasi and other items.

Mduduzi Magagula unlawfully and purposefully stole items valued at E168.97 which were the property of Khetsiwe Dlamini.

He stole the items at Mantjolo on

"I plead guilty to the offence, but I did not steal the items as per the charge sheet. I only took the items

from Dlamini's children because her husband owes me E6 300," said

Dlamini told the court that Magagula was her in-law and he grabbed the items from her children.

She added that the accused emotionally abused her. Magagula took amongst other things; two loaves of bread, two litres of emasi, a 10kg bag of mealie-meal, scones and a six pack of yogurt, all totalling to

Dlamini was then sentenced to six months in custody with a fine option of E400.

THE nation has abandoned and neglected traditional methods of curbing violence and abuse among communities, it has been observed.

Senators said traditional methods and structures had been effective for generations and the stripping of powers from traditional leaders such as chiefs has contributed to the current scourge of violence occurring among commu-

They recognised the role such structures play in raising awareness of the infamous SODV Act of 2018 provided they were properly capacitated.

Senators insist there is a need to do more-eradicating violence and abuse, especially in the domestic settings of

This was outlined during the final day of the gender and development workshop for women's parliamentary caucus, the gender sector and children sector committees held at the Parliament conference room.

Senator Prince Hlangabeza said the tried and tested traditional methods of addressing violence should not be abolished as they have been used for centuries. He said there was a need to do more in capacitating traditional leaders on the SODV Act and gender based violence as they were normally the ones responsible for maintaining peace and harmony in communities.

Status

Senator Chief Zameya Nhlabatsi said the authority and status of the chiefdom (Indlunkhulu) should be reinstated and utilised. "indlunkhulu has traditionally been effective in resolving disputes among families and community members. All homesteads are under the authority of the chief and no one has a right to abuse or even threaten to hurt anyone regardless of their relationship," he said.

Senator Alberto Samuels said even though Eswatini was signatory to a number of conventions which instructed the country to align its ways to international methods, the country was renowned worldwide for its unique culture.

"We have a culture that we need to preserve and not throw away in favour of international aid, allowing the world to dictate how we live our lives is unacceptable," he said.

He concurred with the other senators that the issue of violence was a major concern; however, it should be dealt with without compromising the nation's cultural values. Deputy Prime Minister Themba Masuku acknowledged the crucial role that could be played by chiefs in the fight against violence.

Majority

He said a majority of criminal activities were committed in rural areas which are under the authority of the chief.

He said there was need to capacitate and empower chiefs as they could play a role in resolving disputes in their various communities.

"Cases should be reported to the chiefs and they would then facilitate the intervention of social workers who can be roped in to resolve disputes as that was the case traditionally," said Masuku.

One of the resolutions made by the senators moving forward was to revive the role of indlunkhulu.

Govt to construct high school at Luhlangotsini

THE ministry of education and training has identified an area where they plan to construct a new high school at Luhlangotsini.

The land, which is located behind Luhlangotsini Primary School, was inspected by the ministry's officials on Wednesday.

"The idea of constructing a high school at Luhlangotsini was brought forward by the community and the ministry of education and training in 2007. However, due to financial constraints, government was slow in identifying a site best suited for such an important project. In 2015, a site at Luhlangotsini was identified by the ministry, however, the site needed to be approved before plans of construction could begin. In late 2017, a site was identified and on Wednesday officials of the ministry of education visited the site officially."

The details about the school are yet to be made public.

"Currently, government has a lot of issues pertaining to funding, but we are happy to see some sort of progress. The size and name of the school is yet to be announced and facilitators of the project are also waiting for other details before construction can begin."

Bugwadzi lobo - DPM

A number of people have been crying foul over the enactment of the SODVAct as they view it as a hindrance for men to express their romantic interest in women (kusoma).

Deputy Prime Minister Themba Masuku emphasised that the Act did not hinder anyone from proposing love (kusoma). "Kute lovale kusoma, this is an old traditional method of expressing feelings and if done with respect; no problem," said Masuku.

Masuku said kusoma had always been part of the Swati culture and traditionally, men approached women with respect and observed certain unspoken boundaries such as a women's body language and if done properly, this has no prob-

He said people who misquoted the SODV Act and asserted that proposing love to a women was an offence, were simply hiding behind the Act. "Bugwadzi lobo," added Masuku.



OLD WOES HAUNT ZINBABWE

HARARE - Langton Chiwocha chose Emmerson Mnangagwa among 23 candidates in Zimbabwe's presidential elections a year ago.

Today he says he deeply regrets his choice.

"We had high expectations as many promises were made, but things have turned worse since the elections," Chiwocha told AFP.

"I wish I could take back my vote, or maybe I shouldn't have bothered to vote

Mnangagwa, 76, who took over from long-time autocrat Robert Mugabe, went into the July 30 2018 elections vowing to revive Zimbabwe's sickly economy, end cash shortages, mend fences with former western allies and lure foreign investors.

Chiwocha, who holds a business studies diploma from a college in the capital Harare, says his hopes have been cruelly dashed."I graduated in 2012 and I have not had a job. I thought after winning the elections, Mnangagwa would fix the economy and all who had

qualifications would get jobs."

But within months of Mnangagwa's election, the ghosts of Zimbabwe's economic past returned: severe power rationing and shortages of fuel, bread, medicine and other basics.

Third Ebola case detected in DR Congo's Goma

GOMA – A one-year-old girl became the third patient to test positive for Ebola in the densely populated DR Congo city of Goma, local officials said on Wednesday, adding that she was the daughter of the second patient who died earlier in the week. "I have been informed of another confirmed Ebola case at the Goma Ebola treatment centre," said Aruna Abedi, the chief Ebola coordinator in North Kivu, the worst-hit province since the outbreak began on August 1 last

year. "Vaccination has started at the Kiziba health centre to cut the chain of contamination. Medical staff and those who had contact with the patient, and those who had contact with them, have been prioritised," Abedi told AFP. AFP

Nigeria insists Boko Haram 'defeated' after 10-year insurgency

ABUJA - Nigeria's presidency claimed Boko Haram's 10year-old insurgency had been "defeated" but admitted that international jihadists posed a growing threat.

"The position of the Nigerian government is that the Boko Haram terrorism has been degraded and defeated. The real Boko Haram we know is defeated," the presidency said in a statement late Tuesday.

It said the country was now facing "a mixture" of Boko Haram remnants, criminal groups and jihadists from the Maghreb and West Africa fuelled by turmoil in Libya and the collapse of the Islamic State caliphate in the Middle East.

"As a consequence of these international gangs, we have seen an increase of trans-border crimes and the proliferation of small arms in the Lake Chad Basin area," the statement said. President Muhammadu Buhari, a former general who vowed to crush Boko Haram when he became president in 2015 for his first term in office, has previously said the group

were "beaten".

The uprising began in northeast Nigeria in July 2009 when fighting between the hardline group and government forces left hundreds of jihadists dead, including leader Muhammad Yusuf.

Since then, the bloody campaign has killed some 27,000 people, displaced over two million people and spilled over into neighbouring countries.

In 2015, the Nigerian army forced the jihadists out of major towns but they remain at large in remote strongholds. Fighters still launch persistent attacks and a breakaway faction loyal to IS, the Islamic State West Africa Province (ISWAP), has ratcheted up assaults against the military since last year.

Over the weekend an attack by the Boko Haram group headed by long-time leader Abubakar Shekau killed 65 villagers close to the regional capital Maiduguri.

The army has often been criticised for failing to safeguard local communities, with vigilante groups stepping into the void left by the authorities. *AFP*

Rwanda shuts border with Ebola-hit DRC

GOMA - The announcement came just hours after a third case of Ebola was recorded in Goma.

Rwanda has shut its frontier with Ebola-hit Democratic Republic of Congo after a third case of the deadly virus was detected in the border city of Goma, the Congolese presidency said Thursday.

In a statement, it said there had

been a "unilateral decision by the Rwandan authorities" that affected citizens from both countries who had to cross the border as part of their daily life.

Goma, a city of two million people and a major transport hub, shares the border with the Rwandan city of Gisenyi, which has a population of more than 85,000. Cross-frontier links are intense. Many people have jobs on the other side of the border while others have homes or put their children in schools in the neighbouring city.

"On the basis of a unilateral decision by the Rwandan authorities, Rwandan citizens cannot go to Goma and Congolese cannot leave Gisenyi but are prevented from

going home," the statement said.

"This decision harms a number of Congolese and expatriates who live in Gisenyi but work in Goma."

The announcement came just hours after a third case of Ebola was recorded in Goma, widening the scope of the epidemic on its first anniversary.

Since August 1 2018, 1,803 lives

have been lost in the second-worst outbreak of Ebola on record, according to figures released Wednesday.

Two of the three cases in Goma have died, sparking a race to find people who have had contact with these patients.

Health experts fear outbreaks of contagious diseases in major cities.

In an urban setting, the density of population, anonymity and high mobility make it far harder to isolate patients and trace contacts compared to the countryside.

Nyusi made the announcement during an address to parliament on Wednesday, adding that the signing will take place at Renamo's remote military base in the Gorongosa mountains in the central region of the southem African country."...Tomorrow I will sign a definitive peace agreement with the Renamo President Ossufo Momade in the Gorongosa Mountain," he said. In the mid-1970s, Renamo fought a brutal 16-year civil war against the Frelimo government. Reuters

Bashir trial to begin August 17

KHARTOUM - The trial of ousted Sudanese leader Omar al-Bashir on corruption charges will begin on August 17, his lawyer said, after the ex-president failed to appear in court on Wednesday for the first session.

"Today was the first session of his trial, but the authorities were unable to bring him due to security reasons, so the judge informed us that the trial will now start on August 17," Hashim al-Gaaly told AFP.

Kenya's dusitD2 hotel reopens

NAIROBI - The five-star dusitD2 Hotel in Nairobi will reopen its doors to guests on Thursday, six months after 21 people were killed in an attack on a hotel and office complex by Somalia's al Shabaab militants.

Nairobi is a major hub for expatriates working in East Africa and in addition to the hotel the complex hosted offices of various international companies. The attack was an echo of a deadly 2013 assault on a Nairobi shopping centre in the same neighbourhood.

At a ceremony on Wednesday ahead of the hotel reopening, an orchestra played and motorcycle outriders accompanied runners led by 800 metre world record holder David Rudisha who carried the hotel's flag. *AFP*

Military rulers to hold transition talks

KHARTOUM - Negotiators from Sudan's ruling military council and main opposition coal tion have made progress on the sticking points in discussions on the transition from military rule and are set to hold direct talks within 48 hours, an opposition leader said. The on-off talks on how to run the country after the overthrow of long-time ruler Omar al-Bashir had been halted on Tuesday after the killing of six people at a rally on Monday, at least four of whom were children. But on Wednesday, Khalid Omar, from the opposition Forces for Freedom and Change (FFC) coalition, said their lower-level technical committees isolated the key points of contention in a constitutional declaration that will set the path from military rule. IEC appoints George Mahlangu as head of new political party funding unit

JOHANNESBURG - The Independent Electoral Commission of SA (IEC) has appointed a new executive to manage its political party funding unit.

The IEC said George Mahlangu, a financial expert, commenced his duties yesterday. "He previously served as chief financial officer at Gauteng's Department of Health and Department of Local Government, and before that, Mr Mahlangu was chief financial officer at the National Youth Commission.

He joins the IEC from the private sector where he was most recently CEO at a transport company. Mr Mahlangu is a seasoned

financial expert having served as a chief financial officer in the private and public sectors for many years," the IEC said in a statement yesterday.

"He is qualified with both an LLB and a BCompt (Honours) which provide him with an ideal blend of legal and financial knowledge to fill this important new role as head of the new party funding unit.

He will operate at the level of a deputy chief electoral officer and report directly to the chief electoral officer, Sy Mamabolo."

The IEC is holding public hearings into the new political party funding law in Cape Town. The Act seeks to regulate party funding and ensure that all political parties disclose private donations to promote trans-

The Party Funding Bill was passed by Parliament in 2018 and signed into law by President Cyril Ramaphosa earlier this year. The new law requires parties to report their funding to the commission, which would publish the information on a quarterly basis. There is no need for parties to declare donations of R100 000 or less, while an individual's donation to a party is capped at R15 million. ANA

ANC urged to fire Zandile Gumede or face wrath of residents

DURBAN - The ANC should fire suspended eThekwini Mayor Zandile Gumede and 62 councillors linked to fraud and corruption within 14 working days or face the wrath of the city's residents.

These are the views of the SACP's eThekwini branch. The comments come after the ANC PEC asked Gumede to take leave of absence after she and 12 co-accused, which include councillors, managers, business owners and companies, were in May charged with criminal offences in connection with R208 million worth of Durban Solid Waste (DSW) tenders

Some ANC members in the region, including the Women's League, have protested against Gumede's suspension. It is believed Gumede enjoyed the support of the majority of the ANC regional executive committee (REC) members.

Addressing a press briefing in Durban on Wednesday, the communist party's Regional Secretary Phumlani Mthembu said if the ANC, as the SACP's alliance partner, failed to comply with their demands, the party would mobilise communities to force those implicated in corruption to step down.

He revealed that the SACP on Wednesday penned a letter to the ANC's national and provincial executive committee asking them to remove implicated councillors and managers from the council. Mthembu said the councillors were eroding the integrity of the municipality.

"When you have been implicated in corruption, it is better that you resign," he said. Mthembu accused the now-disbanded ANC REC of having stifled its relations with the SACP in the region by repeatedly snubbing the invitations to discuss chal-

lenges facing the municipality. "As we are in alliance with the ANC we (are) supposed to be discussing the issue of the councillors who must be recalled. Whave been calling for the ANC to come he meetings. Hence we are now writn open letter to the provincial leaderso that something can be done. If the fails to listen to us, people will have ake action and we are going to mobilise n to take action," he said.

Barack Obama silent in Democratic nominating contest

WASHINGTON - Former President Barack Obama was not on the Democratic presidential candidate debate stage on Wednesday night, but he was omnipresent as 2020 hopefuls struggled with attacking the legacy of their party's most popular member.

Coming under heavy attack from more liberal, lower-polling candidates, front-runner Joe Biden frequently invoked Obama in his defence, the first black president, for whom he served as No. 2 for eight years.

Obama enjoys vast popularity not just in his party, but among all Americans, including African Americans whose backing is crucial to win the Democratic nomination to take on Republican President Donald Trump in the November 2020 election. A June poll by the think tank Pew found Obama is now considered the best president in the past 100 years. "We've now had about 105 straight months of positive job growth, the longest streak in American history," said Democratic candidate Julian Castro, who was federal housing chief in the Obama administration. "Over 80 months of that was due to President Barack Obama. Thank you, Barack Obama." That left some of Biden's rivals in the Democratic primary contest struggling to find a way to criticise the former vice president and his pledge to continue and enhance Obama's legacy, while also avoiding disparaging the former president. BANGKOK - US Secretary of State Mike Pompeo yesterday criticised China's actions in Asia after meeting his Chinese counterpart for the first time this year amid political tension between the two coun-

Pompeo spoke out against Chinese "coercion" of Southeast Asian neighbours in disputes over the South China Sea and its dambuilding on the Mekong River.

His comments highlighted the U.S. divide with China at a meeting in Bangkok of the Association of Southeast Asian Nations (ASEAN). After meeting China's top diplomat, Wang Yi, Pompeo said both countries wanted to improve ties that have soured on issues ranging from trade, US sanctions on

Pompeo said. "But we are also very candid about the places we are hoping China will behave in ways that they are not behaving today and we talked about each of those as well."

Earlier, Wang had struck a more conciliatory tone, saying he and Pompeo had discussed ways to promote China-US ties.

"There may be at various times issues and problems between China and the United States, but no matter how many face-to-face discussions," Wang said after the meeting of about 30 minutes.

US and Chinese negotiators ended a brief round of trade talks in Shanghai on Wednesday with little sign of progress and agreed to meet again in September, prolonging an uneasy truce in a year-long trade war between the world's two largest economies.

In Bangkok, Pompeo said he had urged regional allies to speak out against Chinese coercion in the South China Sea and earlier said Chinese dambuilding upstream on the Mekong River had caused decade-low water levels in the river's lower basin in Southeast Asia. Both officials are in the Thai capital of Bangkok for security meetings with countries of the Association of Southeast Asian Nations (ASEAN) grouping, on the front line of rivalry between the United States and an increasingly muscular China. AP

Boris Johnson visits N. Ireland, heart of Brexit battle

BELFAST - British Prime Minister Boris Johnson on Wednesday visited Northern Ireland, the key battleground in Brexit and the focus of increasingly tense rhetoric on both sides of the Irish Sea.

He arrived in Belfast on Tuesday, amid warnings from Irish leaders that his vow to leave the European Union, with or without a deal, risks breaking up the United Kingdom. Those warnings continued on Wednesday.

But during meetings with the province's main political parties, he reiterated his determination to split with the EU."

The prime minister made clear that the UK would be leaving the EU on October 31st come what may," a Downing Street spokesperson said.

After meeting Johnson, Mary

Lou McDonald, the head of Republican Sinn Fein party, said he had "set the compass for a disorderly and a crash Brexit," meaning that there had now to be the opportunity for Northern Ireland to consider joining the Republic.

"We've made it clear to him that the extensive planning that he tells us he is carrying out in respect of a crash Brexit has to include the constitutional question," she told the BBC.

DETROIT - Democratic front-runner Joe Biden was again the main target of his rivals at the second presidential debate on Wednesday, as many of the nine other candidates on stage took aim at his track record on race, criminal justice, immigration and healthcare.

"Go easy on me, kid," the former vice president told Senator Kamala Harris of California with a smile as they greeted each other on stage before the debate began in Detroit. But neither one had any plans to go easy, and they went after each other in a series of tough exchanges. As the highest-profile candidates on the stage, both of them were also repeatedly targeted by the other candidates.

Osama bin Laden's son is dead

JERUSALEM - Hamza, the son of Al-Qaeda founder Osama bin Laden, is reported to be dead, according to news reports. US President Donald Trump also said he did not want to comment on the matter when he was questioned by reporters at the Oval Office. Hamza, who was dubbed the 'crown prince of Jihad', had a US government \$1 billion bounty on his head and was reported to be emerging as a leader of the Al-Qaeda franchise as he called for attacks on the US and other countries in revenge for the killing of his father by US forces in Pakistan in 2011. US intelligence has received information that he died while three US officials confirmed the death but without providing details of the date or place where the younger bin Laden's life ended. AFP

Military exercises still on despite warnings

WASHINGTON - Joint military exercises between the United States and South Korea will go ahead, a Pentagon official said on Wednesday, after missile tests and calls for the drills' cancellation by North Korea.

The affirmation of the annual, joint exercises came amid a series of missile launches by North Korea, one of which it called a "solemn warning to the South Korean warmongers" over the planned military drills. But despite Pyongyang's warning that the exercises could also derail further talks with Washington in the long-running diplomatic process over its nuclear and missile programmes, the senior US official said there is "no adjustment or change in plans that we're aware of." AFP

US renews waivers for nuclear projects

DUBAI - The United States said on Wednesday it was extending waivers for three civilian nuclear projects in Iran, despite Washington's withdrawal from the 2015 nuclear agreement.

"This is a short 90 day extension," said White House National Security Advisor John Bolton, a champion of the hawkish policy towards Tehran. "We are watching those nuclear activities very, very closely, they remain under daily scrutiny," he told Fox Business.

The projects include the Bushehr nuclear power plant, the Arak heavy water reactor, which has been modified under the supervision of the international community to render it impossible to produce plutonium for military use, and the Fordow fuel enrichment plant. AP

The judges were DT Masina, Sakhile Mthethwa, and SBIS's Lofana Mavuso.


They noted that they were strict as the person who would win should represent the talent search in the country.



RONALDO NO-SHOW **LEAVES K** LEAGUE FUMING

TURIN - The row between Juventus and South Korea's K League shows no sign of abating as the latter released a statement accusing the Serie A champions of "shamelessness, untruth and deception."

Korean fans have pursued legal action against Juventus for the cost of tickets and 'mental anguish' after Cristiano Ronaldo did not play in a pre-season match between Juve and a K League All-Star team.

Maurizio Sarri put out a strong side which played out an entertaining 3-3 draw, but it is claimed the Portuguese star was contractually obliged to play for at least 45 minutes. He sat the game out due to muscle fatigue after playing against Inter two days previously. There were further issues as the squad arrived to the stadium significantly late, which Juve claimed was due to a flight delay and traffic congestion.

The statement claims that a contract was agreed to ensure Ronaldo would play, and that all precautions would be taken by the club to avoid any timing issues.

It read: "K League cannot help but feel disappointed and cheated by Juventus for its shame-

lessness. "Juventus said in its reply that Ronaldo's absence was due to muscle fatigue from previous matches that had forced him to take a rest. If Ronaldo was unable to play, it would be a blatant deception to include Ronaldo as a substitute on the start list. "Also, according to a phone recording between the promoter and an official from

Juventus released in the media, everyone from Juventus, including Ronaldo himself and the Manager Sarri, knew it clearly that Ronaldo was supposed to play."Yet, Juventus has so far avoided responsibility for Ronaldo's no-show without any explanations.

"Other assertions from Juventus are also filled with untruth and deception.

"K League clearly register our profound indignation and disappointment to Juventus' irresponsible behaviour and manners, and we strongly urge Juventus to offer a sincere apology and explain the reason for Ronaldo's no-show."

"Subscription for members costs E480. This is part of the FIFA Club licensing and we expect all referees to register even those who officiate in the Super League."

On another note, Shongwe said referees covered 13.4 kilometres in 90 minutes, therefore, they must be always fit to withstand the pressure.

"It's easy to run, so don't be afraid to go for the fitness test and lets also do medical check-ups as it will also help health wise," he said.

Former Premier League top referee Enock Nkambule urged referees to familiarise themselves with the laws of the game. He said the new laws came into effect on June 1.

"Referees must be aware of the amendments before the 2019/20 season begins."




