

Need to reduce HIV infections

IN as much as the numbers of people being infected with HIV and AIDS have been reduced, the Prime Minister Ambrose Mandvulo Dlamini says the country can still do more.

The premier said enrolling all people who test HIV positive on ART, regardless of their CD4 count, has contributed to the significant reduction of new HIV infections by almost 50 per cent between 2011 and 2017.

He said it has been a worthwhile investment that the government continues to commit to with the knowledge that this life saving endeavour would contribute immensely to the epidemic control in the country.

"It is also important to note that 75 per cent of our population is HIV negative, we collectively need to reduce the number of people who get infected annually by 85 per cent by 2022, "he said

Therefore, the premier said there was need to focus on preventing new infections to ensure that the negative status is maintained.

Communities

He said it could be achieved if people can work together as communities.

Since different dialogues were held in different regions where thoughts and ideas were shared on how the country can intensify the goal towards ending AIDS, he encouraged more people to join the dialogues.

"May I now take this time to honour all those people living with HIV who have taken an HIV test, enrolled and adhered to treatment. Under, the theme 'Communities make the difference" I implore you, the community of people living with HIV, to support each other and to adhere to treatment,' he said.

He also pleaded with everyone to denounce all HIV related stigma and discrimination which is as devastating as the illness itself because it results in abandonment by a partner or family, failure to access medical services, and genderbased violence.

The premier said the stigma consequences mean that people would be less likely to come for HIV testing, to disclose their HIV status, adopt positive HIV prevention behaviour or access treatment care and support, which retards the progress in the HIV response.

"In our communities, be it at work or in our social groupings, let us embrace and support those who are living with HIV," he said.

PM COMMITS TO ART PROVISION

DESPITE fiscal challenges faced by the country, Prime Minister Ambrose Dlamini has assured that the country will not by any chance run out of antiretroviral treatment.

The prime minister was speaking during the commemoration of World AIDS Day yesterday at Swazi Sun Sports Ground in Ezulwini. He was represented by Deputy Prime Minister Themba Masuku.

The theme for the World AIDS Day commemoration this year is 'Communities make the difference.' It recognises the benefits of working together as different communities to succeed in achieving a common goal.

The premier said the strength of any community is in bringing together ideas, energy and resources so that gaps and weaknesses of each other are overcome.

"The community then becomes a strong and formidable force that can overcome any difficulty," he said. He added that it is crucial for communities to work together as it will effectively accelerate the HIV response towards ending AIDS.

He further indicated that the country is on the

right path towards ending AIDS. He stated that Emaswati will only achieve the target of ending AIDS within the set timeframe, if they all accelerate the uptake of HIV services to further reduce HIV infections among men, adolescents, young women between 15 to 24 years

of HIV infection.

"There is an urgent need to close the tap. It is worrisome to note that there are still about

7 000 new HIV infections every year," he said. **Assured**

and among key populations at substantive risk

The premier assured everyone that government is relentlessly supporting the delivery of HIV programmes, despite the current fiscal challenges.

"For example, government has committed to procure all first line ARVs for citizens to ensure availability and accessibility to all people who test HIV positive. The ingenious adoption of ARVs has allowed people who are living with HIV to live longer and healthier lives," he said.

HIV in Eswatini is no longer a death sentence, therefore, the PM encourages everyone across the country to know their HIV status so they take the necessary action whatever result.

"If you test HIV positive, take ARVs, and if negative, use all the options available for you

o stay so " he said

He urged young people to delay sex as it is the only way to avoid HIV infection.

He also pleaded with the nation at large to refrain from the abuse of drugs and alcohol as these do not only make one vulnerable to HIV infection, but is a threat to the desired prosperous future.

"Condoms are available for those who have started engaging in sex and ARVs are available for pregnant women who are HIV positive for them to give birth to uninfected babies," the premier said. He added that voluntary medical male circumcision is available for men to reduce chances of being infected with HIV.

Expressed

He also expressed profound gratitude to Their Majesties whose personal commitment and wise leadership in the HIV and AIDS response has created an enabling environment for all the positive progress made thus far.

He said the successes that the country has made in the response is a result of concerted efforts by the different communities ranging from collaborating partners, the donor community internal and external, civil society, churches, public and private sectors and *imiphakatsi*.

INTERSTATE BOSS ARRESTED, CHARGED FOR JOMO'S MURDER

ALTHOUGH it may not bring back their family member, the Khumalo family may have some form of closure as two suspects have been arrested and charged for the murder of businessman Jomo Khumalo.

Eswatini Interstate Association Secretary General Maxwell Nkambule and Fanaleni Sithole were yesterday charged for the murder of Khumalo.

The two suspects were said to have been involved in the plot to murder Khumalo over what was allegedly a feud regarding cross-border permits.

Khumalo was gunned down on Wednesday around Manzini traffic circle in the presence of his wife and two children.

Judging by the number of shots fired at the late businessman, his family was lucky to escape the attack as Khumalo was reportedly shot seven times.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the two suspects were charged with murder and will make their court appearance ...police threaten more arrests

today at the Manzini Magistrate's Court.

Vilakati added that the two suspects also faced two other charges; being three attempted murders as well as contravening the arms and ammunition legislation.

She said the two suspects have been in police custody assisting them with their investigation and were yesterday formally charged.

She said police were continuing with their investigations and the number of suspects could rise depending on information gathered by the police.

Charging The charging of the secretary general has confirmed suspicions that Khumalo's death was a result of a long standing disagreement between the businessman and Eswatini Interstate Association which resulted in Khumalo obtaining a court order allowing him to continue transporting his customers who were mainly hawkers.

A number of questions remained unanswered with most people after Khumalo even went to the extent of reporting to the police about possible hired hands that were threatening his life.

In August, one of Khumalo's drivers and cus-

tomers had a run-in with at least seven armed South African men believed to be hired hitmen

The men reportedly threatened with death the driver of a 16-seater Mercedes Benz Sprinter styled 'Mahle Emantungwa' and his passengers, who were 16 hawkers from the country that buy their wares in Johannesburg, South Africa.

This was before detaining them for over an hour at a filling station while occasionally dangling their guns and issuing the endless threats to kill all of them. Eswatini Interstate Association Chairperson Bambumuti Sithole expressed his doubts that the shooting incident had anything to do with the misunderstanding that Khumalo had with the interstate association.

Sithole said Khumalo had even withdrawn his matter in court and added that they were set to meet in a round table to discuss the matter and find an amicable solution.

When contacted for comment yesterday, his mobile phone rang unanswered.

In a brief statement on Saturday, Public Works and Transport Minister Chief Ndlaluhlaza

Ndwandwe condemned the senseless murder of Khumalo.

Domestic electricity to hike significantly

WITH most commodity costs hiking sporadically, consumers should brace themselves to pay more for electricity, especially domestic users as there will be a significant hike of power going forward.

Though this might not happen sooner, Eswatini Energy Regulatory Authority (ESERA) Regulation Manager Simphiwe Khumalo said domestic customers prices (of electricity) had to go up by 60 per cent so as to correct what he termed 'cross subsidisation'

He explained that the reason electricity for the respective homes is quite reasonable now is because businesses, including the small scale ones like salons, were paying up to 40 per cent because of cross subsidisation.

"Cross subsidisation is the practice of charging higher prices to one type of consumer

so as to artificially lower prices for another group.

The trend in Eswatini now is that businesses pay more for electricity so as to cushion domestic customers. Salon owners, for instance, pay more for electricity, they subsidise domestic customers some of whom are rich. Cross-subsidisation is a challenge for the sustainability of the industry.

Customers

Worth noting is that domestic customers are increasing rapidly, thus cross-subsidisation if not sorted, it will continue to harm businesses. Once it is reviewed, electricity for domestic customers will increase up to 60 per cent," he said during a meeting with editors held at Pigg's Peak Hotel on Friday.

Khumalo said businesses viewed current non-cost reflective tariffs as unsustainable, thus are exploring alternative self-generation

He said higher tariffs deterred business people from settling in a country.

Khumalo added that there should be a

rebalance of the tariffs and cross-subsidisation be removed.

"If cross-subsidisation is removed there will be a significant increase in domestic

Khumalo said cross-subsidisation came with challenges, one of them being that business customers (especially industrial), were growing at a very slow pace.

He said another challenge was that the migration of business customers off-grid would decrease economies of scale and significantly increase tariffs for remaining customers.

"Excessively high tariffs will make it unaffordable for most of the local population," Khumalo added.

He said they had a subsidy framework which would result to the development of a tariff support mechanism for vulnerable households.

It would also send correct signals to consumers in terms of their consumption levels and behaviour.

DVOKOLWAKO ACTING CHIEF BURIED AMIDST DISPUTE

DVOKOLWAKO Acting Chief Mohammed Magagula was finally laid to his final resting place at Mvelo Umphakatsi yesterday, despite an intense dispute amongst the Magagula ruling clan.

Some members of the Magagula clan objected to the norm that their senior members are seen off from the royal kraal (aphumele endhukhulu).

The bone of contention was that Mohammed cannot use indlunkhulu because he was not a chief, a point which was disputed by the other members of the Magagula household.

They argued that being a senior member and acting chief, just like their father, who acted before Chief Malamlela took over, he came from the royal kraal and the late chief respected that practice.

So serious was the tension that Manzini Regional Administrator Chef Gija's view was sought on the matter, and he seemed to have concurred with those who objected on the use of the royal kraal.

He is reported to have advised them that only the chief, his wife and children can be buried from the royal kraal (indlukhulu).

A member of the Magagula household told the Observer that finally the acting chief was buried in the usual family burial site, which is within the royal kraal.

"That was not an issue, but the objection was on the body being ushered out from indlunkhulu.

Upon interrogation, we finally got the reason behind their objection. It had nothing to do with him not being a chief but the major reason was that the Magagula household is of the view that had he gone past indhunkhulu it would have delayed the installation of the new chief. This would have meant that the umphakatsi would have had to wait for a long time before it is considered cleansed to host such a ceremony. Mvelo Royal Kraal is the seat of power and any formal installation has to take place there. The other two umiphakatsi are secondary," the member of the family said. The late Acting Chief Mohammed's body came via his home, which is about two kilometres from the umphatsi to be buried at the family burial site.

He has been holding this position since 2012 after the demise of Chief Malamlela, his brother.

"The letter from the Manzini RA did not look authentic as it did not have a signature and a stamp which proved that it was coming from his office. It looked more like an opinion than an order," he added.

He further stated that after receiving the letter the elders tried reaching out to Manzini RA Chief Gija to get more information on the matter and reasons behind the refusal to use the umphakatsi, but they could not get hold of him.

'EEC MUST RESTORE POWER IN 24 HRS'

ELECTRICITY consumers should expect Eswatini Electricity Company (EEC) to restore power in just about 24 hours once a power outage happens.

This is according to ESERA Legal Counsel/Board Secretary Felix Matsebula. He said the restoration of power in 24 hours was stipulated in the Electricity Licensing By-Laws which would be implemented in the near future. Matsebula said failure by the power utility to abide to the by-laws, it would be penalised by ESERA. He added that ESERA and government wanted locals to have access to electricity with minimal

E33m coffers for rural electrification

ABOUT E33 million is sitting with ESERA as money collected when customers buy electricity.

ESERA Legal Counsel/Board Secretary Felix Matsebula said the E33 million had accumulated in the last two years. It is money which is charged when each customer buys units of electricity.

He said this money for now was with ESERA, being kept there as a way was paved for the operationalisation of the Rural Electrification Fund. "The minister of natural resources and energy has to come up with regulations which will guide how this money will be used," he said, adding that the rural electrification plan was in ESERA's efforts to promote access to electricity. Electrification

Matsebula said rural electrification was a priority for the power sector policy.

"Government has the task to promote, support and provide rural electrification programmes through public and private sector participation. The minister is mandated to prepare a rural electrification plan," he said.

Women still denied right to own land in Eswatini

SINGLE women are still deprived their right to own land in the country.

The Southern Africa Litigation Centre Research Report has cited Eswatini to be one the countries in the world that still discriminates women and children in owning land. The report is based on alignment of Eswatini's domestic laws with recommendations of United Nation's Human Rights Mechanisms. The land in Eswatini is divided into two categories: Eswatini Nation Land and land owned by freehold or concession, including tenure farms and commercial land. Eswatini Nation Land is further divided into two; land under customary tenure and land which is leased by private companies. Despite Section 211(2) of the Constitution emphasising gender equality, Swazi Law and Custom limits the right to land for cultivation and residence to the male head of a household.

The land is allocated to Emaswati through local chiefs and is based on a patronage system. Therefore, females who wish to own a piece of land under Eswatini Nation Land are deprived by customs. The report also talks on women being forced to be attached to a male counterpart in order to acquire a piece of land. The report recommends that Eswatini should enforce the Constitution even on ENL. This is because the most women deprived these rights are rural women.

Farm dwellers also marginalised

ANOTHER group of people who are constantly deprived fairness when it comes to land rights are farm dwellers.

The report talks more on farm dwellers who are constantly evicted without following what is stipulated in the Constitution. The report states that lack of transparency in the allocation of title deed land and concessions means that communities who lived on the land for many years believing that it is Eswatini Nation Land, can be evicted if such land is subsequently allocated through title deed to others. "Many of the large-scale evictions that have taken place are accordingly at the instance of agricultural and other companies," states the report. The Farm Dwellers Control Act No. 12 of 1982 makes provision for when the tribunal may order the recovery of possession of land occupied by a farm dweller.

The Tribunal is not empowered to make such order without reasonable accommodation or compensation for the farm dweller.

The Act further provides that a person may not be evicted between September of one year and May of the next year, to ensure that crops are not lost. Subsistence farmers who live on title deed land are only protected under the Farm Dwellers Act if they have a formal agreement with the owner of the land. The Vagrancy Act No. 39 of 1963 has further been used against people who are homeless. The Act defines a vagrant as a person who: "Having neither lawful employment nor lawful means of subsistence which provide him regularly with the necessities for his maintenance; or having no fixed abode and not giving a satisfactory account of himself; or wandering abroad and placing himself in a public place, to beg or gather alms, or procuring or encouraging a child or children to do so; or living or lodging in a place of area which the minister has declared by notice in the Gazette to be unfit for living in.'

The Act allows the police to arrest without a warrant any person who appears to be a vagrant. The court can then order such person to be detained in a place of detention or to leave the area, leave the country, or order the person to return home.

The Manzini, Matsapha and Mbabane prisons have been declared places of detention under the Act. The Act continues to be enforced and has led to the detention of homeless persons in prison, despite not having committed a criminal offence.

'GO TO INCWALA'

POLITICAL activist Maxwell Dlamini has raised a debate amongst his ideological equals, urging members of progressives to take part in this year's Incwala.

Incwala is regarded by some traditionalists as a 'national prayer' through which the nation thanks God for His guidance.

It is open for every Liswati to attend.

This is an event which some individuals have opted to shun due to either their religious or political beliefs. It is a general knowledge that members of some political formations have over the years elected to stay away from the event.

A suggestion by one of the most vocal political activists calling for progressives to take part in the event has over the past five days been a topic for discussion on social media.

Maxwell Dlamini, one of the youthful political activists who have spent time behind bars for their political ideology last week posted on Facebook, urging members of political formations to take part in this ... Maxwell tells progressives

year's Incwala.

In his post, Dlamini acknowledged that Incwala was a Nguni culture which had been inherited from the forefathers, hence it was culture which was open for every Liswati to partake in despite political affiliation. "This year we must attend the Incwala Ceremony as the progressives led by the PPA (Political Parties Assembly (PPA)", reads part of Dlamini's post, drawing hundreds of comments from other users of the Facebook platform.

"We, as the Insika regiments, must put on the traditional regalia and have the President Mlungisi Makhanya lead us", he continued.

It was gathered that 'Insika' refers to members of the proscribed People's United Democratic Movement (PUDEMO).

Dlamini is known as a member of the formation, even though at some instances, he was reported to have resigned from the group.

His post drew both support and criticism from users of the Facebook platform, with some labelling Dlamini as misinformed.

Even though they acknowledged that Incwala was an African culture, some of the Facebook users stated that it would not be proper for progressives to take part in the event.

However, renowned political activist, Mbho Shongwe supported Dlamini's idea, saying members of political formations were free to take part in the event.

In his reactions, Dlamini also stated that taking part in the event would indicate that progressives were not against culture.

Meanwhile, it is also recalled that sometime last year, Dlamini also indicated his interest to partake in the national elections. When reached for comment, Acting Ludzidzini Indvuna Lusendvo Fakudze first highlighted that Incwala was a national prayer whereby all Emaswati convene a prayer using the traditional way. Fakudze said it was however difficult to ascertain the motives of individuals who elect to take part in this event. He said it would be difficult therefore to prevent members of progressives from

taking part in the event.

"The problem is that we may not be sure whether those individuals are coming with a clean heart or they just want to cause trouble," he said.

Fakudze said however, traditional leaders from which those individuals come from may assist in finding the motives behind them wanting to take part in the event.

"We have had instances where some alleged progressives attempt to cause trouble in this event in the past, hence we may need to be sure about the motives in this case," Fakudze said. He said however, people who have repented were allowed to join the libutfo.

Mentally challenged man hacks two at Manzana

TWO people from Manzana have been admitted in hospital after they were hacked by an alleged mentally challenged man from the same area.

The man is said to have acted strangely over the past few days, where he is reported to have attacked people whenever he came across them.

Ndleleni Sihlongonyane is said to have hacked a nine-year-old child with a bush-knife injuring her on the cheek.

According to the residents found at the scene, Sihlongonyane hacked the child and then went back to his house where he stays, not knowing that he was being tailed by the relatives of the child he hacked.

When the relatives of the child arrived at Sihlongonyane's house they knocked and asked him to come out and he refused.

It is then that they decided to use force and Sihlongonyane is said to have come out carrying the same bush-knife in an attempt to defend himself.

Upon realising that, the gang escaped but one was left behind and Sihlongonyane is said to have hacked him with the bush-

knife.

It is said he hacked the second victim in the head and he sustained serious head injuries.

When narrating the ordeal, Manzana Zonal Leader Dan Mavuso said the others then came

back and beat up Sihlongonyane. He said they beat him until he was unconscious and some elders intervened and asked that he be left alone as he was not fighting back anymore.

Mavuso said Sihlongonyane has been a menace in the area as he had numerous cases where he was reported to be beating people for no reason. He said they even called the police to come and arrest him but the police did not which angered the residents.

Promised

"He even harassed the other tenants from where he stays and his landlord has tried to talk to him but he did not cooperate," he added.

He pointed out that he even took it upon himself to report the matter to the police but all his efforts were in vain as they promised to come but never did.

"As residents of Manzana we are very disappointed in the police service.

We have contacted them on numerous occasions to come and arrest Sihlongonyane but they did nothing until now that he has hurt innocent people," Mavuso said.

Sihlongonyane's landlord Thomas Dlamini when reached for comment said he had tried to talk to him about the allegations levelled against him but he did listen not to him.

Dlamini said he even called Sihlongonyane's brother to inform him about the said behaviour.

He said Sihlongonyane was staying in his rented flats because his brother had asked that he be allowed to stay there and Dlamini obliged because he knew him as someone who grew up in the area, not knowing that he would eventually develop such unbearable behaviour.

Among those he assaulted is Thulani Mdluli from Manzana whom he attacked using a metal. When police came yesterday to fetch him after the latest incidents, he saidhe was angry because people did not see that he wanted to be a royal guard.

He said a powerful spirit protected him and thus he wanted to be a royal guard.

"I am a soldier and I know that I can make a good bodyguard," Sihlongonyane said.

Information gathered pointed out that Sihlongonyane was once admitted at the psychiatric centre a few years ago but was discharged.

However, the residents feel he has been drinking too much alcohol and smoking which might be the result of his actions.

When contacted, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the matter, saying two people had been admitted in hospital after they were injured by a man from Manzana.

ANOTHER MAN BEATS HIS WIFE TO DEATH

A crime of passion reared its ugly head again when yet another man killed his wife.

In an incident that happened around the wee hours of Saturday, Sicelo Magagula (31) at Mahhomu, near Mliba is said to have assaulted his wife Ntobeko Shongwe (29) with the sacred shrub (Lusekwane) all over the body until she sustained fatal wounds.

The bone of contention is said to be that Shongwe was found by her husband standing with another man outside the Magagula premises at around 3am on Saturday.

Worth noting is that this happened five days into the 16 Days of Activism against Gender-based Violence; an international campaign for the elimination of violence against women.

Information gathered from impeccable sources was that there was a night vigil at the Magagula homestead and a funeral was scheduled for the Saturday morning.

Unidentified

At around 3am, it is said Magagula went out of the homestead only to find Shongwe standing with an unidentified man, who upon seeing Magagula, took to his heels.

Out of curiosity, Magagula is said to have asked Shongwe what she was doing outside the home because it was dark

In her response, Shongwe is said to have told her husband that she had gone to relieve herself.

This, apparently, did not satisfy Magagula as he kept asking her why she had gone all the way out of the premises when there was a toilet within the home.

Sources close to the matter further alleged that Magagula then ordered Shongwe to take him to where she had relieved herself as proof.

It is said the couple went around in circles as Shongwe failed to point out the exact location.

This is said to have angered Magagula and a verbal altercation ensued.

Just when the couple was engaged in the heated argument, a source said Shongwe's phone rang and when she answered, Magagula heard a man's voice on the other end of the line.

Dragged

This aggravated Magagula to boiling point and he allegedly dragged Shongwe to a nearby forest, where he assaulted her all over the body with the sacred shrub until she was unconscious.

When all this happened, somehow, not a single soul is said to have wit-

nessed the fight

"The cause for all this seems to be trust issues.

We cannot be sure of the cause of this though," said a source who preferred anonymity.

When he noticed that she was unresponsive, Magagula allegedly called a relative and told him that he had killed his wife.

The relative is said to have proceeded to call a community police to report the matter.

When the community police arrived at the scene, Magagula is said to have relayed the events leading to him brutally killing his wife.

It was further gathered that Shongwe was badly injured as her arms were broken and she had gaping wounds in most parts of her body.

When quizzed on the matter, a member of the community police, identified as David Ndwandwe, confirmed that he was notified about the matter.

He said he had a chance to talk to Magagula, willingly told him that he was angered by the fact that the man who left as soon as he saw himwith his wife.

"I cannot say much about the matter because what I know is only one side of the story.

However, I can confirm that he did not run away after committing the crime," Ndwandwe said.

Confirmed

Chief Police Information and Communications Officer, Superintendent Phindile Vilakati confirmed the incident and that Magagula faced a murder charge.

This is the second incident to happen since the beginning of this year's 16 Days of Activism against Genderbased Violence as on the first day of the campaign, a 30-year-old woman of Thulwane was murdered by her husband with a Langa brick.

This is the second shocking incident to happen since the start of the 16 Days of Activism against Gender Based Violence.

The first happened last Monday when a man killed his lover with a brick. He has since been arrested and charged with murder.

STOP EXPLOITING YOUNG GIRLS – US EMBASSY

AMERICAN Embassy representative John Moyer says it is high time men reject the idea of exploiting young women to consent for sex as it is the main reason new HIV infections remain high amongst young women.

Moyer was speaking during the World AIDS Day Commemoration at Royal Swazi Spa sports ground yesterday.

He added that this assertion was proven by statistics which showed a high increase of HIV infections amongst young girls between the ages of 15 to 19.

He added that young women in the country faced an unacceptable high risk of being a victim of sex-

ual assault.
"Until that epidemic is addressed,
girls will continue to suffer dual

burden of sexual violence and HIV and AIDS," he said.

He also emphasised on empowering young women so that they share the same social, political and

economic quality with men

Moyer added that the President's Emergency Fund for AIDS Relief (PEPFAR) which is run by the US Embassy understands the difference that can be made by communities in eradicating HIV, thus they work a lot with rural communities.

He said this is because 70 per cent of the country's population lives in rural areas therefore PEPFAR works hand in hand with traditional structures. The local communities develop their own plans for providing health services.

Moyer said in 25 Constituencies in the country across all four regions PEPFAR has supported 135 chiefdoms in taking ownership of plans, policies, and health service provision in their communities. "PEPFAR's work in Eswatini is also firmly focused on the populations that data shows are being left behind," he said.

He added that this year PEPFAR launched a programme to work in close collaboration with traditional communities to address key gaps in achieving HIV epidemic control to ensuring justice for children.

Key populations left behind in AIDS fight

AS the world is working towards eradicating HIV and AIDS key populations seem to be left behind in most programmes.

Patrick Kunene, who was representing the key populations which include sex workers, drivers and the lesbian, gay, bisexual, transgender, and intersex communities (LGBTI), said they still encountered challenges when accessing healthcare in the country.

Kunene, who was speaking during the commemoration of World AIDS day, said some healthcare professionals discriminate key populations whenever they visit healthcare centres. As a result, Kunene said the work put in by government and stakeholders to eradicate HIV will not be truthful as key populations are crucial in the epidemic.

He added that they were not only discriminated by healthcare professionals but also communities and families.

He said he believed key populations also added to the 95 per cent of people needed to eradicate the epidemic and if left behind all the work would be for nothing.

Kunene suggested that a ministry for key populations was needed as it would focuse on them. He also said with key populations the rate of unemployment was very high.

Meanwhile, Ezulwini town Mayor Bongile Mbingo said Ezulwini town has dedicated itself to have healthcare centres that can be used by everyone and eliminate discrimination.

She added that the town has programmes that give people the opportunity to unite.

"The municipality has worked hard to promote equal rights," she said.

She added that they have even opted to distribute condoms in schools because they understand that adolescents engage in sexual activities.

She added that they realised that there were key populations therefore they also have programmes that incorporate them as well.

- 2.ESHEC was established in 2015 in terms of the Higher Education Act of 2013 to, among other responsibilities, develop and implement a system of quality assurance for higher education in the country; ensuring that there is adequate and sustainable generation of nationally and internationally competitive skilled workforce capable of spearheading the country's production and knowledge based growth.
- 3.In line with its mandate and in conformity with Part IV of the Higher Education Regulations of 2016, ESHEC verifies foreign qualifications to ensure that only credible and trustworthy qualifications and credentials are in circulation in the country. Verification is done to establish:
- The status of the institution that issued the qualification in the country of origin;
- The accreditation status of the qualification in the country of origin;
- The reliability of the qualification documents;
- The genuineness of the award;
- If the person presenting the qualification is indeed the person who obtained the qualification;
- The local equivalence.
- 4. The Public is reminded that seeking verification of qualifications in organisations outside the country establishes the qualification parity in those countries, but not locally.





91 ARRESTED FOR DRINK-DRIVING

A total of 91 motorists were arrested for driving while under the influence over the past weekend.

The figures were announced by the Royal Eswatini Police Service (REPS) yesterday. They are slightly lower compared to last week's 103.

In fact, they are the lowest figures compared even to the previous weekend, which had 98 motorists charged for drink-driving.

In total, the past three weekends have seen 292 motorists charged for contravening Section 91 (1) of the Road Traffic Act of 2007. The Act stipulates 0.38 milligrams per litre (mg\l) as the legal alcohol content for motorists. Meanwhile, the first weekend of November saw 95 motorists nabbed for driving under the influence of narcotic drugs and alcohol while the fol-



lowing week was 87.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati urged motorists to avoid driving while under the influence of alcohol. She condemned the habit of driving while under the influence of alcohol and narcotic drugs. She said alcohol reduces

costs. The appellant Simanga Gina (husband) had filed the application at the Supreme Court where he wanted and order to the effect that the car be repossessed from the buyer and brought to his (Gina) possession.

This was an appeal from a ruling of Judge Sipho Nkosi wherein the judge ordered that the motor vehicle forming the subject matter of dispute between Gina and his wife Gcebile Dlamini, should be returned to the buyer Clement Simelane cited as the respondent in the appeal.

Handing down judgment, acting Supreme Court Judge Sabelo Matsebula who was sitting with the Chief Justice (CJ) Bheki Maphalala and acting Judge Judith Marry Currie, stated that justice was not done in this case. He cited that it was unfortunate that the Supreme Court cannot order any remedial action as both counsel informed the court that the case has been overtaken by events. He noted that the parties indicated during hearing of the matter that they were no longer pursuing the appeal.

"Accordingly the court makes the following orders, the appeal is struck off the roll and may not be reinstated without leave of court being sought and granted. There is no order as to costs," Judge Matsebula said.

The court noted that from the papers filed before it, it was clear that the appellant (Simanga) is married to Gcebile under Siswati Customary law and that although Gcebile is not party to the proceedings, she is the genesis of the dispute and was party at the Magistrate's Court as an applicant.

The court observed that Gcebile applied and was granted a personal

Woman arrested for occupying driver's seat while intoxicated

A night out partying ended on a sour note for a woman who was being arrested for occupying the driver's seat while intoxicated.

Tengetile Tsela was arrested in the early hours of yesterday morning near Mhlaleni. Information gathered is that when police arrived they found the accused occupying the driver's seat as the car had developed a tyre puncture.

When a breath specimen was taken from Tsela, it read 0.52mg/l.

The accused pleaded for a lenient sentence, saying she did not know that it was an offence to do so. She was sentenced to a month's imprisonment with a fine option of E300.

Drunk driver causes accident

A driver who was heavily intoxicated ended up causing an accident as he rammed from behind a BMW vehicle.

Sifiso Vilakati appeared before Manzini Magistrate Xolile Nxumalo. He was charged with two counts; the first being that of driving while intoxicated and that of negligent driving.

Guilty

The accused pleaded guilty to both counts.

In mitigation, Vilakati apologised for committing such an offence and pleaded for the court to be lenient. He promised to pay for the vehicle which was damaged during the accident.

ownership of wife's car

loan at Nedbank and purchased a car being an Isuzu KB 250 LDV which is the subject matter in the present appeal application. Returned

However, on the return date of the first nisi, the Magistrate's Court returned possession of the car to her husband and when this order was issued, the car was already in Simelane's ownership and the deputy sheriff for that region forcefully took the car from Simelane on behalf of Gina. Gcebile then approached the High Court which found that the proceedings at the Magistrate's Court were flawed, the attachment of the car from Simelane was unlawful noting that Simelane's was an innocent bona fide purchaser and finally ordered that the car be returned to his (Simelane's) possession. The appellant (Gina) being dissatisfied with the order of the High Court then approached the Supreme Court on grounds that the court on a quo erred or misdirected itself in making the ruling primarily on points which were never a ground for Simelane's application.

Church member defrauds ACM's Pastor Kim E90 000

A member of the Africa Continent Mission stands accused of defrauding Pastor Chong-Yang Kim of E90 000.

Thando Magongo had a date with the High Court where his trial resumed before Judge Mzwandile Fakudze.

When committing the offence, he is alleged to have deposited the money in a bank account of Gilt-Ndo Investments, where he was a co-director with one of the crown's witnesses Gilbert Ndukuzempi Masilela.

Masilela's charges were withdrawn against him after investigations had been concluded by members of the Royal Eswatini Police Service (REPS) and had already paid bail fixed at E10 000.

According to the indictment, Magongo and the company are guilty of theft by false pretences in that while at Mbabane and in furtherance of a common purpose, did unlawfully and with intent to defraud and steal, misrepresented to Pastor Kim, of Mahwalala Africa Continent Mission (ACM) that they were going to facilitate the supply of 50 cattle to the mission and did by means of the said misrepresentation obtain from the pastor payment

He allegedly misrepresented to Pastor Kim that he would purchase 50 cattle for mission

by cheque in the total amount of E89 653.00.

Alternatively, they are charged with fraud in that they defrauded Pastor Kim of the said amount of money, by claiming that the company will facilitate the purchase of the cattle and induced the pastor to his actual loss and prejudice to pay Gilt-Ndo Investments the money by cheque well knowing that the company was not carrying out the business of supplying cattle.

In his evidence, Pastor Kim stated that he entered into an agreement for the supply of cattle with Magongo, who was known to him as a member of the church.

The accused person, according to the pastor, claimed he knew cattle farmers who would supply the cattle and that an upfront payment was needed to facilitate the supply and indeed Pastor Kim gave him the cheque to the said amount.

Subsequently, no cattle were supplied and the accused did not pay back the money despite several attempts to have him pay and investigations revealed that he was a director at Gilt-Ndo, where the cheque was discovered to have been deposited. Taking to the witness stand was His Majesty's Correctional Services (HMCS) senior officer

Nhlanhla Mbingo who informed the court in his evidence that he has known Pastor Kim since the year 2000 and that this witness told him about a fraud case committed by the accused person.

He told the court that this witness had made arrangements with the accused person that he will pay back the money through a lawyer but Magongo at some point failed to pay back the money

Also giving evidence was Masilela who told the court that his arrest which was perpetrated by his co-director (Magongo) adversely affected him such that when he made a court appearance at the Magistrate's Court, the media captured him and his wife eventually dumped him after accusing him of squandering the money.

Masilela also told the court that he did not benefit from the money deposited to the company account but tried to assist Magongo in repaying same but Magongo ended up failing to pay back the money to Pastor Kim.

The trial continues before Justice Fakudze as more witnesses are to be paraded by the crown represented by Brian Magagula. Magongo is represented by senior attorney Ben J Simelane in the

Businessman loses E140 000 bid for refund

A businessman has lost a bid to have his E140 000 refunded to him following the purchase of a caterpillar tractor he found not in a good condition.

This, after the High Court of Eswatini dismissed his application for a summary judgment to compel the seller to pay him back the E140 000.

Mfanawenkhosi Sihlongonyane cited as the plaintiff in the matter had taken the seller Gilberto Pereira of Welcome Transport (Pty) Ltd to court, where he was demanding the refund of the said amount after he allegedly discovered that the tractor was not in good condition as promised by the defendant (Pereira).

Observed

High Court Judge Mzwandile Fakudze, when handing down judgment, observed that the defendant raised triable issues in the matter in resisting the summary judgment. He had raised an issue pertaining the sale agreement between the parties both oral and in writing as he argued that the written agreement was signed by Louis Pereira as opposed to him (Gilberto).

in the agreement as the plaintiff alleged that he entered into the agreement with Gilberto whereas the first defendant (Gilberto) alleges that he does not remember anything about the agreement as the person who entered into and signed the agreement was Louis.

"The first defendant evidences this by a purported agreement signed by the said Louis as the seller. This issue is therefore triable, oral evidence can assist in determining it. In light of all that has been said, the application for summary judgment is dismissed with costs," Justice Fakudze ordered. The background of the matter is that the plaintiff (Sihlongonyane) instituted summary judgment proceedings against the defendants Gilberto as the first and Welcome Transport as the second following issuance of combined summons for payment of the E140 000 in respect of a caterpillar tractor that was bought by the plaintiff. The plaintiff alleges that there was an agreement between him and the first defendant to the effect that the defendant would sell to him the caterpillar and he would pay the full amount as The second triable issue as observed by the the tractor was in good condition yet he alleged-

The plaintiff contended that he made full payment of the purchase price by depositing the money into the defendant's company account as per the instructions of the first defendant.

Inspected

After payment, the plaintiff averred that he inspected the tractor only to find out that it was not in a good condition as promised by the defendant and, therefore, sought a refund from the defendants.

Meanwhile, on the other hand, the defendant denied any dealings with the plaintiff and raised the non-joinder of Louis as he is the one who dealt with the plaintiff in as far as the purchase of the tractor is concerned.

The first defendant put it in no uncertain terms that he never at any point in time sold a tractor to the plaintiff but Louis did. He further alleged that the plaintiff's particulars of claim stated that the agreement between the parties was oral.

Representing the plaintiff in the matter was lawyer Sanele Mabila and the defendant was represented by Mbabane based attorney Sifiso Maseko.



ICT ministry to ensure cyber security in Eswatini

THE Computer Crime and Cyber Crime Bill of 2017 is now at an advanced stage.

Minister of Information, Communication and Technology Princess Sikhanyiso said the Bill was one of the many means of ensuring cyber security in Eswatini.

She said working together with a majority of stakeholders, her ministry with the support of the International Telecommunications Union (ITU) developed the national cyber security strategy in 2107 which describes the coherent national approach for protecting Eswatini data, systems and networks form cyber threats.

The minister was speaking during the Eswatini Cyber Security Awareness Month closing ceremony which was held at the Royal Villas on Thursday. She was represented by Director of Computer Services Sipho Vilakati.

"The strategy will also provide guidance to all relevant stakeholders on their specific roles and responsibilities for cyber security by setting the national vision and strategic objectives with respect to cyber security in the country," she added.

She said new threats and a new era strategic competition demanded a cyber-strategy that responds to new realities, reduces vulnerabilities, and safeguards opportunities for the people of the Kingdom of Eswatini to

technical advancements and administrative efficiency across government and the private sector," she said.

She said consumer awareness and capacity building were important elements and first steps necessary in dealing with cyber threats.

The minister said she was happy that the campaign had made consumer education centric and consumer knowledge as it is paramount to cyber secu-

She added that there was need that the public is kept up to date with such matters to promote a cyber-hygienic society.

Awareness

Meanwhile, Eswatini Communications Commission (ESCCOM) CEO Mvilawemphi Dlamini said the cyber security awareness month had provided them with an opportunity to reflect on their role as a communications regulator.

Dlamini said the commission's broad competencies in the ICT sector and the expertise in ICT networks and infrastructure had naturally positioned the commission as a key player in the field of cyber security.

"It is clear then that the commission has to ensure that our communication infrastructure is secure for it is this infrastructure that is at the heart of all online activities," he said.

He said the fight against cybercrime called for multi-stakeholder approach and collaboration. He was happy to report that during the campaign, an unprecedented convergence and collaboration of partners committed to the cause was experienced.

Some of the stakeholders of the campaign are the DPM's office, ministry of ICT, ministry of education and training, the Central Bank of Eswatini, Financial Services Regulatory Authority and UNESWA.

There were also schools that were visited under the initiative and they included Timphisini, Nyetane, Nyamane and Nyatsini High.

Mkhatshwa did not object to any of the evidence which was presentenced before court.

He was accordingly found guilty. The court sentenced him to three years in a correctional facility with an option to pay E5 000 fine on each count. The sentences were ordered to run separately.

MOVING FROM RHETORIC TO ACTION

RE-THINKINGURBAN DEVELOPMENT

LET me start with a disclaimer today.

This article is not aimed at the Minister of Housing and Urban Development Prince Simelane or his officials, but my view of how things have moved since we attained independence.

But at the same time, let me be clear, I am not happy with the progress we are making as a country, nor am I happy with the quality of our councillors and the leadership provided by the ministry.

It would seem the kind of development we have enjoyed, in particular in both our major cities, Manzini and Mbabane has been accidental than a deliberate programme of the two

Not even the development taking place at Ezulwini can be credited to the council, but private investors who fell in love with the locality than it being a plan of either government or the council.

A lot of what has happened in the country has been through the vision of His Majesty King Mswati III, but it has received poor support from local authorities to ride on those new

The King has pronounced his vision for a futuristic city to be known as Swazi City, and I am sure with the country's name change, it will now be known as Eswatini City.

The plans around that idea have been on the cards for about 10 years now.

In Manzini in the early 2000s, the Ministry of Economic Planning and Development built and completed around 2004 the Mavuso Exhibition and Trade Centre accompanied by the Sports Centre.

Despite that this remains a government project, you ask yourself what has the local authority of Manzini done to leverage on that development? Any ideas about leasing the structure from government to keep it alive for the entire year except for the weddings, gospel shows, gigs, church services and the annual trade fair which comes once a year?

Contributed

Other than the Eswatini National Provident Fund which has contributed immensely, in terms of property development, what else do we have other than shops in Manzini?

It is not about Manzini, Mbabane, which remains the country's capital by virtue of hosting government offices, has lagged behind in terms of its clarity of vision.

A lot of what is happening in the capital has been thanks to the Public Service Pension Fund, FINCORP, Tibiyo TakaNgwane whose developments have really improved the capital's

Again, such projects have very little to do with the municipality, but projects of public enterprises looking on how they can plough back into society and in the process develop

His Majesty the King's thinking of developing a Swazi city should have stimulated the two major cities into thinking outside the box and ensure that by the time such a city comes,

they don't become irrelevant.

I don't want believe that we have too much of a problem with the management of those two cities. Our biggest challenge in the development of our municipalities rests with the law and lack of transformation and new thinking within government.

The central government needs to realise that it cannot provide solutions for everything. But at the same time it needs to be ahead of us in terms of strategic thinking and implementation of programmes.

There is a great need that we interrogate the whole idea behind the ministry of housing and urban development. The mandate needs to align with our vision for a First World country. Such should not be left to individual corporations to decide what they need to establish and where?

We need to tell these organisations, if we have a clear vision of what we need to do and where that sorry your idea of a project does not talk to our development as a municipality, can you try it somewhere else?

Urban development needs to balance. We cannot keep on developing shopping smalls in every small space we get. We need housing, proper offices and recreational facilities including stadia.

Then my proposal is that we relook the Urban Act of 1963 and try to sort the way in which we get councillors into their positions. Some of these people who find themselves in these positions don't have the capacity to think strategic hence our towns will remain a shame.

This has resulted in the tensions between the

management and councillors. The ministry of housing too has not been helpful as well because it has a narrow view of how things have to go.

We need the people who are behind the existence of these municipalities to be in council. The current law would only achieve to bring in residents and not property owners into coun-

Unfortunately their area of interests remains in who gets what tender and what trips. In fact, they are self serving than focusing on the broader issues development.

Poverty

They cannot think beyond the development of their zones or wards. Yet, a proper and sound municipality can draw many communities out of poverty.

My message to the Prime Minister Ambrose Mandvulo Dlamini and the rest of Cabinet is to rethink urban development and be at the centre of the Strategic Roadmap.

We need to develop our cities to talk to the First World we aspire to achieve by 2022. We cannot achieve it within the current set-up. We need to start now to properly align our munic-

This will start with amending the Urban Government Act to get the right caliber of people into council.

Prince Simelane must assist Cabinet here as well, if he looks into 2022 what does he see? If he can't envision properly, run and developed cities, then he needs to ask for some help.

Urbanisation alone can draw thousands out of poverty and we need to start now planning for the future.

We don't need these petty squabbles within our municipalities as that only achieves in us losing a lot of precious time and energy, focusing on wrong things. We need to develop proper systems that will deal with inefficiencies in our council management.

American born Senegalese musician, Akon is building a city in Senegal and is determined to finish it within 10 years.

President Cyril Ramaphosa recently in his Parliament address after re-election also spoke about the need to develop a new city. His Majesty the King has spoken about a Swazi City. We need our existing municipalities to align themselves properly to transform into world class cities.

An aggressive government would reform the current Urban Act to give us people who can transform the urban space. As things are, we will not reach the promised land.

National Refugee Appeals Board

6. (1) There is established a National Refugee Appeals Board.

(2) The Board shall consist of three members appointed by the Minister, in writing, with due regard to the suitability of a person to serve as a member by virtue of the experience, qualifications and expertise of that person.

(3) At least one member of the Board shall be a person who qualifies to be appointed as a principal magistrate, and shall be the Chairperson of the

- (4) The functions of the Board are to receive and determine appeals referred to it in terms of section
- (5) The appellant shall be invited to appear before the Refugee Appeals Board.
- (6) The appeals board may consider new evidence submitted by the appellant when determining the appeal.
- (7) The Board shall be independent in the discharge of the functions assigned to it under this

Commissioner and Deputy Commissioner for

- 7. (1) There shall be a Commissioner and a Deputy Commissioner for Refugees both of whom shall be appointed by the Civil Service Commission.
- (2) The Commissioner shall be responsible for all issues pertaining to refugees and, in particular,
- (a) formulate and implement policies and programs on refugees; and
- (b) generally safeguard the welfare of refugees in the country
- (3) The Deputy Commissioner for Refugees shall assist the Commissioner in the performance of the duties of the Commissioner under this Act.
- (4) There shall be Refugee Status Determination Officers who shall interview and prepare recommendations on asylum applications for consideration by the National Refugee Advisory Committee.

Illegal entry and presence

- 8. (1) Without conflicting anything contained in the immigration laws of the land, a person claiming to be a refugee, who has illegally entered or is illegally present in Swaziland (Eswatini), shall not be declared a prohibited immigrant, detained, imprisoned or penalised in any other way merely by reason of the illegal entry or presence of that person, pending a determination of the application of that person for recognition as a refugee.
- (2) A person to whom subsection (1) applies shall personally appear before the nearest authorised officer without delay, after the entry into Swaziland (Eswatini) and the authorised officer shall refer that person to the office of the Commissioner for Refugees.

Procedure for Applying for Refugee Status

- 9. (1) A request for protection made to an authorized officer, either at the border or within the territory of Swaziland, shall be considered an asylum application and may be made verbally or in
- (2) The Commissioner for Refugees shall issue to the person who makes an application under subsection (1) a document in the prescribed form showing that the person has made an application to be recognised as a refugee and that document shall remain valid until the person is granted or refused refugee status.
- (3) The application referred to in subsection (1) shall be submitted to the Commissioner for Refugees and the applicant shall be invited to appear before a Refugee Status Determination Officer for an interview
- (4) Where an applicant who appears before the Refugee Status Determination Officer cannot understand the language used during the interview, the Commissioner for Refugees shall provide that applicant with an interpreter.
- (5) The office of the Commissioner shall ensure that, during the interview, adequate arrangements are made for asylum applicants with special needs.

THE REFUGEES ACT 2018

- (6) A person who is invited to appear before the Refugee Status Determination Officer, who without a valid reason, fails to appear at two consecutive interviews shall become subject to the immi-
- (7) The Office of the Commissioner for Refugees shall refer the recommendation of the National Refugee Status Determination Officer to the National Refugee Advisory Committee for consideration.
- (8) The Committee shall consider the recommendation submitted by the Refugee Status Determination Officer and make a final determination on the merits of the asylum claim within 180 days from the date the application is lodged with the authorized officer.
- (9) The Committee shall, through the Commissioner, inform each person whose application has been successful of that fact, and shall issue to that person an identity card attesting to the status of that
- (10) Where the Committee decides not to grant the application for refugee status, it shall inform the applicant of that decision and the reasons thereof through the office of the Commissioner for
- (11) An applicant who is aggrieved by a decision of the Committee may, within 21 days of notification of the decision, appeal to the National Refugee Appeals Board.
- (12) Pending the conclusion of the appeal under subsection (11), the applicant shall be permitted to remain in the country under the provisions of this Act.
- (13) If the Appeals Board rejects the appeal, the Appeals Board shall give notice to the Minister who shall give the applicant notice to leave Swaziland (Eswatini) in accordance with the provisions of the immigration laws or seek redress with the High Court.

Members of family

- 10. (1) Where a person recognised as a refugee is the head of a family, that person's dependents shall be granted refugee status in accordance with the principles of family unity.
- (2) Where, subsequent to the recognition of the head of a family as a refugee, there is a change in

the family status or ties resulting from marriage, divorce, legal separation, or death of the head of the family or attainment of the age of majority by a dependent, the members of that family shall continue to be recognised as refugees under this Act.

(3) Where a person is recognized as a refugee, the Commissioner shall, in accordance with the principle of family unity, facilitate entry into the country for members of the family of that refugee.

Non-refoulement

11. A person shall not be refused entry into the country, be expelled, extradited or returned to any other country or be subject to any similar measure, if as a result of such refusal, expulsion, extradition, return or measure, such person is compelled to return to or remain in a country where -

(a) that person may be subjected to persecution on account of the race, religion, nationality, membership of a particular social group or political opinion of that person; or

(b) the life, physical safety or freedom of that person would be threatened on account of external aggression, occupation, foreign domination or events seriously disturbing public order in a part or the whole of that country.

TWO years into his presidency, Angolan leader João Lourenço is treading a difficult course between continuity and radical reform.

Faced with a persistent economic crisis, the new president needs to take bold action to open up the economy to competition and renewed foreign investment, and reduce the country's dependency on oil.

To do so, he has to loosen the stranglehold of the country's elites on key sectors of the econ-

These are competing networks of interests within the ruling People's Movement for the Liberation of Angola (MPLA) and the security forces that the previous president, José Eduardo dos Santos, had carefully cultivated in his 38 years in power, by using the country's vast oil revenues.

This political dispensation resulted in, among other things, wasteful spending, inefficiency, the establishment of politically connected monopolies and large-scale embezzlement.

But to loosen that stranglehold, Lourenço relies on continued support from the MPLA, and so he cannot openly antagonise all these different interests at once but rather has to advance very cautiously.

The initial euphoria that accompanied Lourenço's new presidency has ebbed away. Angolans are faced with the stark realities of a profoundly dysfunctional political economy that has proved more resistant to change than they had hoped

Yet things started out so well. Lourenço entered the 2017 electoral contest as the MPLA's lead candidate to succeed dos Santos. He campaigned under the motto improve what is good, change

Seen as a dos Santos loyalist and a man of continuity, he at first failed to ignite much enthu-

The MPLA won the elections with 61 per cent of the vote - a result that was contested by the opposition. Still, the outcome reflected a reduced dominance for the party, which has governed the country since it gained independence from Portugal in 1975.

But Lourenço stands accused of dithering and being indecisive. And the promises of change he made when he took over have yet to translate into improvements in the living conditions of a majority of Angolans.

PROMISING START

Shortly after his swearing in, Lourenço surprised everyone, including his critics, when he started using the almost absolute constitutional powers of the president to unleash a dizzying flurry of dismissals that swept away many old dos Santos allies. Most prominently, he removed dos Santos' children from most of their positions of economic influence. He even allowed criminal investigations into their dealings to be launched.

Lourenço also opened up state media to more diverse and critical voices, and invited dissidents, jailed and persecuted under dos Santos, to the presidential palace.

He even recently decorated two prominent human rights activists with a medal of nation-

These actions were truly noteworthy in the context of a country in which open expression of political dissent had been curtailed by a pervasive "culture of fear" and active repression.

But it's the failure to improve peoples' lives that has led to disappointment.

ANGOLANS FEEL LET DOWN

DISAPPOINTMENT

When the price of crude oil on world markets dropped, in late 2014, from about \$110 to under \$50, the country was plunged into a deep economic crisis from which it has yet to recover.

The crisis revealed how fragile and unsustainable Angola's miracle growth of the preceding decade had been.

While oil prices have gradually recuperated this year, the situation continues to be dire. The cost of living has soared. And the national currency, the kwanza, continues to consistently lose value. Despite the spectacle of high-profile dismissals that followed immediately after Lourenço took power, it appears that entrenched economic interests are prevailing.

Some even claim that rather than truly clearing out the stables, he is simply replacing one network of elites with a new one, albeit with some significant overlaps with the previous

Doubts about his commitment to rooting out corruption have been voiced in light of his handling of former vice-president Manuel Vicente, who faced corruption charges in Portugal. Lourenço negotiated with the Portuguese judicial authorities that he be tried in Angola, under his country's laws. But, once the case was transferred to Angola, the country's attorney general declared that as a former vice-president, Vicente enjoyed immunity from prosecution. Vicente went on to become Lourenço's advisor for the oil sector, a low-profile but highly influential position.

Similarly, in a major corruption case involving the Sovereign Wealth Funds, the former president's son, José Filomeno "Zénú" dos Santos, and his partner Jean-Claude Bastos

This was after the alleged recovery of the embezzled assets, raising questions about impunity for the political elites.

Finally, while international attention is largely focused on the economy, the militarised crackdown on any demands for greater political and economic autonomy in the oil-rich province of Cabinda continues.

AUSTERITY THE WRONG REMEDY

The approval of an extended fund facility from the International Monetary Fund has been hailed as one of Lourenço's great successes. But Angolan economists are skeptical about its impact. They say that orthodox economic recipes such as austerity measures and the introduction of value added tax would hit the pop-

More importantly, the facility failed to address the structural problems of the economy, which are a consequence of years of corruption and inefficient, wasteful spending.

The real issue to Angolans remains why their former leaders have been allowed get away with stashing the country's wealth offshore for so long.

'Agencies face challenges in utilities budget allocation'

The ministry of finance is aware that spending agencies continue to face challenges when it comes to budget allocations for their utilities.

This is according to a budget call circular memorandum from the Principal Secretary in the Ministry of Finance Sizakele Dlamini to all controlling officers.

It states that all ministries and agencies should endeavour to develop evidence-based estimated expenditures for utilities (water, telephone and electricity).

Realistic

The utilities estimated to be not paid up to March 2020 and in arrears due to lack of sufficient budgets should be incorporated in the budget of 2020/21 to achieve realistic estimates. To complement this, efforts to reduce spending on this item should continue in order to realise the intended savings.

It further urges that all government offices

must switch off all electrical appliances such as computers and heaters when not in use, especially during the night and weekends. Spending

"Every spending agency should provide relevant information on the number of vehicles on the ground by directorate/department/ section, and by type, boarded vehicles, new ones acquired in the past one year by workplace/workstation/school.

This information should be updated and submitted to CTA for their analysis and recommendations," the memorandum says.

It further states that all ministries should provide a separate statement of estimated receipt and expenditure under each operational trading account under its jurisdiction. Warrants under the trading accounts for FY 2020-21 will be issued as per the estimates.

"Trading accounts which are not budgeted for FY 2020/21 will be closed. All extra-budgetary expenditures should also be estimated and included in the budget estimates," it states.

Eswatini leather artisans now produce handbags, wallets, belts

FOLLOWING the successful production of Eswatini's first leather footwear last month, the Kingdom's leather artisans are now producing leather handbags, wallets and belts.

A total of 36 leather artisans graduated from the National Handicraft Training Centre following two weeks of intensive training on leather production on Friday.

The leather project has been made possible through the technical assistance of the Common Market for Eastern and Southern Africa's Regional Integration Support Mechanism (COMESA-RISM). Previously, the ministry trained the leather artisans on leather tanning as well as footwear and design.

This project is a culmination of the Leather Value Chain Strategy 2016-2025. Eswatini loses an estimated USD 72 million (E938 million) due to the exportation of raw hides and skins whereas the demand for footwear is estimated at 1.4 million pairs per annum, which is currently being serviced with imports. This, therefore, warrants the need to ensure that national programmes on value addition are put in place. Speaking during the graduation ceremony, Acting Principal Secretary Sizwe Ntshangase said the current leather Value Chain Strategy fitted well with the country's vision by supporting value addition of hides and skins and promoting the growth of Micro Small Medium Enterprises (MSMEs) in the leather value chain.

"Such strategic interventions resonate with the National Strategic Roadmap aimed at economic recovery anchored on past national policy directives mainly the National Development Strategy," Ntshangase

leather crafters, leather processors, private sector stakeholders, government officials and academia. At least 10 of the artisans were women and people living with disabilities; in line with Strategic Pillar No: 7 of the MSME Draft National Policy; which calls for the development and improvement of the position of MSMEs owned by women, the youth and other disadvantaged groups. The MSME Policy recognises that women, the youth and people living with disabilities continue to be disadvantaged in virtually every economic dimension, and that government has not yet been adequately equipped to deal with their specific needs, hence the reason we are targeting them through this pro-

Response

These trainings are a direct response to a feasibility study that the MSME Unit, under the ministry, conducted with the support of the Africa Leather and Leather Products Institute (ALLPI) which revealed that the kingdom currently has about 0.6 million bovine herds, with an estimated hides and skins production capacity of 220 000, and annual average earnings of E5 million. The leather footwear, handbags, wallets and belts are currently available at the NHTC for demonstration purposes. However, Emaswati can also start placing orders from the leather artisans through our MSME Unit. We are currently targeting the local market as we continue to equip the leather artisans for the export market, in line with our export-driven approach.

FNB sees record increase in Black Friday transaction volumes

CAPE TOWN - Between midnight and 2pm on Friday, the total number of transactions processed through First National Bank's (FNB's) Merchant Acquiring Systems were 7.4 million compared to 5.6 million in 2018, the lender said in a statement on Friday.

This represents a 40 per cent increase in transaction volumes compared to the same period last year. Transactions processed through the bank's Merchant Acquiring Systems peaked at an average of 306 transactions per second.

The Chief Executive of FNB Merchant Services, Thokozani Dlamini said while transactional volumes were expected to normalise later in the day, last minute shopping was anticipated to lead to intermittent spikes in volumes until retailers close their doors. "Online merchants have the luxury of opening until midnight while traditional retailers may consider opening for longer than usual to accommodate the after-hours rush," said Dlamini. Online merchants like Takealot, Zando and eBucks Shop were among the top online retailers where FNB customers bought discounted goods and services. Cilliers Kriel, the Chief Executive of FNB Credit Card said overall, the lender expected card present transactions to make up the majority of card spend by close of business, however, there was a firm indication that South Africa's consumers were growing accustomed to shopping

JSE share prices looking gloomy for 2020

JOHANNESBURG - JSE share prices are likely to present another year of "abysmal returns" in 2020 as forecasts of weak global and local economic growth translate into lower earnings growth for locally listed companies, market analysts said on Friday.

On Friday the JSE All Share index was up 7.17 per cent, while the FTSE Top 40 Index, where most of the constituent companies have globally focussed operations, was up only 10.13 per cent. This follows an 11 per cent decline in the JSE All Share Index in 2018.

Citadel Investment Portfolio Manager Nishlen Govender said South African focused-listed companies were likely to continue to struggle in 2020.

"Retailers are battling to grow revenue, and especially selling price inflation, and so, too, the financial sector. Both segments have tried to maintain margins by trimming costs. This has been earnings supportive, but I see little of this left," he said.

"In South Africa, low confidence and sentiment is associated with weak fiscal figures, leading to the continued threat of a credit downgrade. Continued uncertainty means business spending has remained weak and, with little in the way of room for government to assist, this has placed additional pressure on consumers. Monetary policy is also constrained," he said.

For instance, we may interact with a person who wants to lodge a complaint against a non-bank Financial Services Provider (FSP) regarding a financial matter that affects their children or spouse. We may also interact with FSP 'A' who has a complaint against FSP 'B' relating to a financial services product that does not seem to be yielding the expected returns, therefore threatening the atmosphere of unity or family amongst the employees of FSP 'A'. Given these types of complaints, the Ombudsman is committed to resolving disputes in a quick manner with minimal formality, to uphold good practice in the non-bank financial services industry. By extension, we are committed to contributing to financial stability in families, whether on the community or corporate level.

To reaffirm this commitment, the Office of the Ombudsman continues in its efforts to make the public aware of how we can assist with resolving non-bank financial services complaints against FSPs that are licenced by the Financial Services Regulatory Authority (FSRA). We are excited for you to learn a bit more about our family—the Ombudsman team—and find out what family and the festive season means to us. The Officers are presented here in no particular order.

Case officer

The Case Officer (CO) assesses and registers complaints that the Ombudsman receives. Where suitable, the CO may then step in to guide a discussion about a dispute settlement between a complainant and an FSP for example, and possibly also begin investigating the matter should the complainant and FSP not agree on a settlement. The CO is instrumental in making sure we handle complaints in a way that is fair, reasonable and easy to understand.

Ombudsman

The Ombudsman oversees all functions as the Head of the Office. This includes assignments at business strategy level, providing legal oversight as well as being involved in consumer education and stakeholder management events. Another key function of the Ombudsman is to issue and sign off determinations or decisions that are made about complaints after investigation. The vision and values of the office are exemplified by the Ombudsman who inspires the team to do the same.

Administrative assistant

The Administrative Assistant (AA) manages the running of the office. PROTESTERS MARCH TO UP PRESSURE

HONG KONG - Pro-democracy protesters renewed pressure on the Hong Kong government yesterday with three separate marches, appealing to President Donald Trump for help and demanding that police stop using tear gas.

A group dressed in black and wearing masks carried American flags as it headed to the US Consulate to express gratitude for legislation aimed at protecting human rights in Hong Kong that Trump signed into law last week.

Some held banners reading "President Trump, please liberate Hong Kong" and "Let's make Hong Kong great again" - a riff on his 2016 campaign pledge to make America great again. One showed him standing atop a tank with "Trump" emblazoned on the front and side. The marches came one week after pro-democracy candidates won a landslide victory in districtlevel elections. Hong Kong's protests have been relatively peaceful for the two weeks around the election but could turn violent again if the government doesn't bend to demands for more democracy and an investigation into police use of force against



the protesters.

A peaceful crowd of about 200 adults and young children marched to government headquarters in the morning and chanted "No more tear gas."

Entrance

They leaned a pole with an American flag that flapped in the wind over a high metal gate, while the Chinese and Hong Kong flags flew on tall poles in front of the entrance.

"A lot of parents are worried that their children are affected, because their children are coughing, breaking out in rashes and so forth," said march organiser Leo Kong, a 40-year-old social worker. A third march was called for late afternoon in the Tsim Sha Tsui district near Polytechnic University, the site of the last fierce clashes with police two weeks ago.

Iranian opposition leader compares supreme leader to toppled Shah

GENEVA - Iranian opposition leader Mirhossein Mousavi has compared Supreme Leader Ayatollah Ali Khamenei to the Shah, the monarch deposed in a 1979 revolution, following the government's crackdown on protests this month.

The unrest began on November 15 after the government of the Islamic Republic, one of OPEC's biggest oil producers, announced gasoline price hikes. But the protests quickly turned political, with demonstrators demanding the removal of top leaders.

Khamenei has described the violence as the work of a "very dangerous conspiracy". The Tehran government has blamed "thugs" linked to its opponents in exile and the country's main foreign foes, namely the United States, Israel and Saudi Arabia.

Iran has given no official death toll, but Amnesty International has said that at least 161 people have been killed. Tehran has rejected this figure.

Mousavi's comments about Khamenei, the highest authority in the Islamic Republic, were posted in a statement on the opposition Kaleme website. He made a reference to an infamous 1978 massacre which rallied public support and led to the toppling of Shah Mohammad Reza Pahlavi.

"The killers of the year 1978 were the representatives of a non-religious regime and the agents and shooters of November 2019 are the representatives of a religious government," he said. "Then the commander in chief was the Shah and today, here, the supreme leader with absolute authority."

He called on the government to "pay attention to the repercussions of the Jaleh square killings" of 1978.

Lost

Mousavi and Mehdi Karroubi ran in a presidential election in June 2009 but lost out to hardliner Mahmoud Ahmadinejad. The two men became figureheads for Iranians who staged mass protests after the vote, which they said was rigged.

Karroubi, Mousavi and Mousavi's wife Zahra Rahnavard have been under house arrest in Tehran since 2011 after the opposition leaders called on supporters to rally in solidarity with pro-democracy uprisings in Arab countries.

Ukrainian officials discussing ways to improve standing with Trump

KYIV - Ukrainian officials are discussing ways to improve their country's standing with President Donald Trump amid the continuing fallout from the impeachment inquiry, two sources told CNN.

Those sources, who recently met with Ukrainian officials, said that the Ukrainian government could still announce new investigations which could be seen as politically beneficial to the US President. However, it is unclear what exactly those potential investigations would cover or when they would be announced. One source told CNN that Ukrainian officials recognised that any potential

investigations would need to look into current issues and not just those of the past.

The Ukrainian Embassy in Washington did not reply to a request for comment.

Trump's request for Ukrainians to investigate their country's interference in the 2016 election — a debunked theory — and former Vice President Joe Biden and his son, Hunter Biden, is a cornerstone of the House Democrats' impeachment investigation. Whether that request was tied to a White House meeting and the withholding of military aid to Ukraine is at the crux of the impeachment inquiry. *CNN*

London Bridge attack sparks terrorists' jail release review

LONDON - An urgent review of the licence conditions of people jailed for terror offences has been launched by the ministry of justice following Friday's London Bridge attack.

Two people were killed and three were injured by Usman Khan, 28, a convicted terrorist who served half of his time.

PM Boris Johnson claimed scrapping early release would have stopped

As many as 70 convicted terrorists released from prison could be the focus of the government review.

Khan, 28, who was shot by police on Friday after carrying out the attack, was jailed over a plot to bomb the London Stock Exchange in 2012.

He was sentenced to indeterminate detention for "public protection" with a minimum jail term of eight years.

This sentence would have allowed him to be kept in prison beyond the minimum term.

But in 2013, the Court of Appeal quashed the sentence, replacing it with a 16-year-fixed term of which Khan should serve half in prison. He was released on licence in December 2018 - subject to an "extensive list of licence conditions", Met Police Assistant Commissioner Neil Basu

"To the best of my knowledge, he was complying with those conditions," he added.

As part of his release conditions, Khan was obliged to take part in the government's desistance and disengagement programme, which aims to rehabilitate people who have been involved in terrorism.

Khan was living in Stafford and wearing a GPS police tag when he launched his attack inside Fishmongers' Hall, where he was attending a conference hosted by Learning Together, a prisoners' rehabilitation programme.

The attack then continued onto London Bridge itself.

The Sardine has become a symbol of protest against the far-right firebrand leader Matteo Salvini, who served as interior minister and deputy prime minister in the previous coalition government with the Five Star Movement. Students, young professionals and families with children joined the march, where the carrying of political banners was discouraged. Demonstrators gathered in the city's Piazza della Repubblica sang the anti-fascist song "Bella Ciao" and shouted "Every Sardine has the right to exist!" AFP

Malta PM to step down

VALLETTA - Malta's Prime Minister Joseph Muscat will step down on January 18, party sources told AFP Saturday, following mounting criticism of his response to the murder of journalist Daphne Caruana Galizia. The announcement came as the main suspect in the 2017 car bomb killing, tycoon Yorgen Fenech, 38, was charged with complicity in the murder. The court also ordered Fenech's assets to be frozen and he was returned to custody. Party insiders said Muscat would step down once those behind the killing have been charged and his Labour Party has chosen a new leader.

"He always said that he will be leaving soon and he feels that now is the time to go," said one party source. *AFP*

At least 14 killed in gunfight

MEXICO CITY - 10 suspected cartel gunmen and four police were killed during a shootout on Saturday in a Mexican town near the US border, days after US President Donald Trump raised bilateral tensions by saying he would designate the gangs as terrorists. The government of the northern state of Coahuila said state police clashed at midday with a group of heavily armed gunmen riding in pickup trucks in the small town of Villa Union, about 40 miles (65 km) southwest of the border city of Piedras Negras. Standing outside the Villa Union mayor's bullet-ridden offices, Coahuila Governor Miguel Angel Riquelme told reporters the state had acted "decisively" to tackle the cartel henchmen. *Reuters*

SUDAN'S NCP PARTY REACTS TO GOVT BAN

KHARTOUM - Sudan's National Congress Party (NCP) on Friday condemned the government's decision to dissolve it, and confiscate its assets, insisting that its 'ideas will prevail'.

The NCP, which is ousted president Omar al-Bashir's party, accused the new "illegal government" of trying to confiscate its properties to help tackle Sudan's economic crisis.

"To rely on the assets of the party, if there are any, is nothing more than a moral scandal, an act of intellectual bankruptcy and a total failure on the part of the illegal government," the Islamist NCP said on its Facebook

"The party is not bothered by any law or decision issued against it as the NCP is a strong party and its ideas will prevail."

The authorities late Thursday approved a law ordering the NCP to be dissolved, its assets confiscated and the

regime dismantled as demanded by the protest movement that led to the veteran leader's fall in April.

They also slapped a ban on any "symbols" of the former regime from taking part in political activities for 10

Bashir was ousted on April 11 in a palace coup after a nationwide protest movement against his iron-fisted rule of three decades.

Complacency a concern as AIDS treatment improves in Africa

HIV is still here. But some people are forgetting that.

Those are some of the bold messages Uganda's leader is emphasising as health officials try to stem stubbornly high infection rates among young people in this East African country that years ago won praise as a global leader in fighting the epidemic. In many parts of sub-Saharan Africa, the region most affected, fewer people are dying from AIDS as treatment is more widely available and patients live normally. Yet some officials and activists worry that success may be encouraging a sense of complacency. The head of HIV prevention at Uganda's AIDS agency, Dr. Daniel Byamukama, recently asked leaders of a popular church that organises a retreat for young people to give him 20 minutes to make a presentation about AIDS. They turned him down, saying "AIDS is common sense" these days. Many young people believe "HIV is gone," he told The Associated Press. In Uganda and neighbouring Kenya,

KAMPALA - AIDS has no cure. countries with two of the world's highest AIDS rates, campaigners point to lower-than-satisfactory HIV testing rates among adult men, early sexual experiences among many adolescents, inadequate knowledge of HIV and reproductive health and even what UNAIDS calls "a crippling fear of buying condoms" among many Ugandans.

Focused

Now Ugandan President Yoweri Museveni, who earned praise in the 1980s for his government's openness in public campaigns against HIV, believes officials have focused too much on treatment in recent years and wants them to speak simply to young people with messages noting that "HIV is here with us."

An estimated 500 Ugandans die weekly from AIDS-related illnesses.

"Why are you in a hurry to have sex at 16, at 18, at 20 and then you die, or you start having problems which you may live with all your life? Why don't you wait, hold on, you study, finish your degree and then look for a partner at the right time?" AP

President Hage Geingob wins re-election

WINDHOEK - Namibia's President Hage Geingob has been re-elected for a second term, the country's electoral commission says.

Mr Geingob polled 56.3 per cent in Wednesday's election, well ahead of his nearest rival Panduleni Itula with 29.4 per cent.

However, Mr Geingob's tally was well down from the 87 per cent with which he won his first term in 2014.

He went on social media to thank Namibians for returning him to office, promising to bring tangible improvements to their lives.

His Swapo party has ruled Namibia for nearly three decades since it gained independence from South Africa.

The sparsely-populated country has suffered from economic recession, hit by serious drought and low prices for its main mineral exports, diamonds and uranium. The Bank of Namibia

is predicting a third year of recession, with the economy due to shrink by 1.7 per cent in 2019. Swapo has also been hit by a fisheries scandal, with two former ministers under arrest for allegedly taking bribes to give licences to the Icelandic fishing firm Samherji.

Former Justice Minister Sakeus Shanghala and former Fisheries Minister Bernard Esau have been charged with money laundering and fraud.

"I am just a proud Namibian that we could have free and fair elections, no fighting, no attacking each other, free movement was allowed," said President Geingob after the result was announced.

His main rival Itula is also a Swapo member, but stood as an independent, The official opposition candidate -McHenry Venaani of the Popular Democratic Movement (PDM) - finished third with 5.3 per cent.

An anti-corruption drive or political witch-hunt?

LIBREVILLE - Authorities in on Wednesday along with eight oth-Gabon this week arrested eight people who are suspected of theft and money-laundering in what is seen as follow-up to Operation Mamba, an anti-corruption campaign launched in 2017 by President Ali Bongo, who has been battling serious illness.

The revived anti-graft drive has seen a string of top-level arrests in the central African country, as accusations that millions of euros have disappeared from state coffers swirl around top officials.

"Eight people have been placed in preventive detention," Gabon's prosecutor Andre Patrick Roponat said on Thursday, adding that they were accused of "siphoning off public funds and money-laundering.'

The group appeared before a judge

ers who were released on bail, Roponat said. Pro-government newspaper L'Union reported this week that more than 85 billion CFA francs (\$142 million) have "evaporated" over the past two years from the funds of the Gabon Oil Company.

60-year-old Bongo said last month he was "fiercely determined" to push ahead with the campaign against graft.

Political witch-hunt?

One high-profile political figure embroiled in the affair is Brice Laccruche Alihanga, Bongo's former Cabinet director who took the lead and spoke for the president after he suffered a stroke in 2018.

Laccuruche had held his Cabinet post for more than two years but was dismissed on November 7, at the start of a wave of arrests.

He has announced on social media that he will undertake a new mission for "the president and for Gabon".

Earlier this week, lawyers told AFP that presidential spokesman Ike Ngouoni and a dozen others were arrested and questioned over their ties to Alihanga.

The lawyers also insist that "there is a political vendetta" in the current process, a claim the country's prime minister refutes.

During his months-long absence abroad for treatment, speculation over Bongo's fitness surged and the army quashed a brief attempted coup.

Bongo has ruled Gabon since 2009, following the death of his father Omar Bongo, who was in power from 1967.

Protesters march in favour of govt

ALGIERS - Algerian citizens in support of the government have taken to the streets in demonstrations in several cities across the North African country to show their support for next month's elections. The December 12 poll has been decried by members of a long-running nationwide protest movement who've been protesting each Friday since mid-February against the status quo and forced president Abdelaziz Bouteflika out of power in April.

Saturday's protests, with some several thousand participants, are the largest pro-government demonstrations of their kind seen in Algeria. They were organised by the General Union of Algerian Workers, or UGTA.

Armed forces kill extremist leader

OUAGADOUGOU - Burkina Faso's armed forces say soldiers have killed an extremist leader and five supporters in Nahouri Province in an operation to dismantle the group operating in the country's south-central region. The statement Friday by the armed forces' chief of staff said forces also seized a large cache of weapons. It identified the leader as Abdoul Hadi, who is known to have helped extremist group Ansarul Islam establish a presence in the area.

Extremist groups have been increasing attacks in the West African nation in recent months, forcing nearly a half-million people to flee their homes.

Outtara will stand in 2020 election if...

KATIOLA - Ivory Coast President Alassane Ouattara said on Saturday he would run for a third term if his predecessors decided to compete in the 2020 election, a vote seen as a major test of stability for the country after two civil wars this century. The election already looks highly unpredictable. Ouattara's main coalition partner defected last year, and his bitter rival, former president Laurent Gbagbo, could return after being acquitted of crimes against humanity at the International Criminal Court in The Hague. Ouattara has said he intends to hand power to a younger generation but he has also argued that a constitutional change in 2016 has canceled previous term limits, enabling him to stand again. Reuters

Protests after man sets himself alight

TUNIS - Tunisian police used tear gas to disperse dozens of protesters who blocked roads in the southern town of Jelma on Saturday following the death of a young man who burned himself to death, witnesses said.

Abdelwahed Hablani, 25, set himself on fire and died in hospital on Friday in protest at poverty and poor living conditions, echoing the 2010 self immolation of Mohammed Bouazizi, whose death triggered the Arab Spring.

The protesters on Saturday afternoon burnt tires before police intervened to reopen roads, firing tear gas canisters, the witnesses said, but the demonstrations were continuing late into Saturday evening. Reuters

ANC INTEGRITY COMMISSION TELLS BONGO TO 'STEP ASIDE'

CAPE TOWN - The ANC's Integrity Commission, chaired by party veteran George Mashamba, has called on former State Security Minister Bongani Bongo to step aside from all party positions and activities, pending the finalisation of his criminal case.

Bongo was arrested by the Hawks in Cape Town and was released on bail of R5 000. He is due back in court in January.

The charges relate to the alleged bribery of the former evidence leader of the Eskom inquiry in Parliament.

Bongo declined to comment on Saturday after the call by the integrity commission. Commission Chairperson Mashamba said Bongo should step aside. The ANC's National Executive Committee must take a lead in this by restoring public confidence in the party, said Mashamba.

"The integrity commission recommends that the NEC take swift and decisive action to restore the confidence of the public in the ANC's stat-

ed position of zero tolerance against corruption. To that end comrade Bongo should be instructed to step aside with immediate effect from all positions and activities of the ANC, including his deployment into public office by the organisation until his name has been cleared of the criminal charges levelled against him," said Mashamba.

'White people must acknowledg they are land thieves'

DURBAN - Black First Land First (BLF) leader Andile Mngxitama has called on his party's special policy conference to systematically succumb to the pressure of AfriForum and Electoral Commission of South Africa (IEC) by removing a racist clause from its constitution.

Mngxitama was addressing about 100 delegates who attended the one-day conference in Durban on Saturday, which was called in reaction to the IEC deregistering the BLF from participating in the country's elections.

The IEC deregistered BLF following complaints from AfriForum that the party was racist since its policies did not allow white people to be members. The Equality Court would this week rule on the case against the IEC's decision, which was launched by the BLF.

Despite the call to amend its constitution, Mngxitama and other members of his party kept chanting "one settler, one bullet", the slogan that could be interpreted as a call for an attack on white people.

He said the party should amend its constitution only to meet the IEC's requirements, but he said white people would have to prove beyond reasonable doubt that they subscribed to the BLF's pro-African people ideology.

"It is just a very fair condition as white people are beneficiaries of land theft, therefore they should demonstrate if they say they support a pro-black movement like ours," he said.

He said it would be "a tough luck" for those white people who would fail to meet the BLF's stringent conditions.

"That means that they are not serious about joining the black struggle, then they must not," said Mngxitama.

He said the conference would make a declaration, which would retain the BLF's blackness objectives

"We are a black liberation movement and that cannot be compromised, otherwise we have no reason to exist. *Politics Bureau*

ANC confident it will unseat DA ahead of JHB mayoral election

JOHANNESBURG - The ANC's negotiations with other parties remain a closely guarded secret ahead of the Johannesburg mayoral elections on Wednesday but the ruling party says it's confident it will unseat the

Senior ANC officials were unnerved when speaker Vasco da Gama postponed the election and even threatened to take legal action.

They accused him of buying time for the DA at the expense of service delivery.

If no winner emerges from the first round of mayoral elections, the candidate with the lowest votes will be eliminated, and a runoff will decide the winner between the remaining two candidates.

The point of disagreement is should that winner just have more numbers or have at least a majority of 50 per cent plus one?

Da Gama is seeking legal clarity on this matter especially with the high likelihood that it will be a tight race.

But ANC Gauteng spokesperson Bones Modise sees no need to worry.

"The ANC commands the numbers followed by the da and eff - so if all of us are fielding candidates it tells you that the ANC will emerge victorious."

The ANC has the highest number of councillors but its 50 per cent plus one so what work is the party doing to ensure it win the runoff should it happen?

"The main concentration will be to make sure we have all our 121 councillors seated, anything beyond that we will engage as and when the situation arises." Meanwhile, parties are now waiting for the speaker to pronounce what majority means based on the legal advice that he postponed the election to seek. *EWN*

EFF could hold the key to winning Joburg mayoral race

JOHANNESBURG - With the postponement of the Johannesburg mayoral council sitting on Thursday, the EFF could hold a strong hand going into this week's negotiations with the ANC and DA.

This, despite the failure of its noconfidence motion against embattled Tshwane Mayor Stevens Mokgalapa.

The three major parties have been in a wrestling match over control of Gauteng's two biggest metropoles in recent weeks.

The cities of Johannesburg and Tshwane both have hung councils, with no party winning a 50 per cent plus one majority in either metro in the 2016 local government elections.
This forced the DA in both coun-

cils to enter into coalitions or voting agreements to secure two of the most powerful mayoral positions.

Herman Mashaba's surprise resignations.

Herman Mashaba's surprise resignation from the DA last month, as well as Mokgalapa's recent sex tape scandal, have paved the way for a power grab between the EFF, ANC and DA.

While the EFF is the third biggest party in both the Johannesburg and Tshwane councils, it could use its blocks of seats to convince the DA or ANC to back it for mayor in either of the metros, in return for the sup-

port of the red berets in other municipalities.

Last week, EFF leader Julius Malema said it was the DA's turn to support his party as the EFF had backed the DA in the past.

At the time, he said the EFF would consider a trade-off in Tshwane.

The ANC, for its part, has been tirelessly exploring every avenue to regain power in Johannesburg ever since it lost the city in 2016.

Mashaba's sudden resignation allowed the national governing party room to explore and woo DA coalition partners in a bid to regain control of the council. News24

Embattled DA politician resigns from Tshwane city council

TSHWANE - Transport MMC for Tshwane Metro Municipality and PR councillor Sheila Senkubuge has resigned, the party confirmed to News24 on Saturday morning.

"I can confirm that we have received her resignation letter," provincial leader John Moody said.

According to Moody, a private citizen had also laid charges against Senkubuge, questioning whether she was eligible to hold a council seat, claiming she initially held permanent residency before becoming a naturalised citizen.

When asked if her resignation was linked to an alleged leaked sex recording scandal, Moody said: "It is up to her at the end of the day, she needs to face whatever action she needs to face." Senkubuge has been embroiled

Taking it a step further was MC Nicky when she presented her boyfriend Sgitha with a cake





Moonchild back after malaria scare

JOHANNESBURG: Moonchild Sanelly thinks she cheated death after she was hospitalised with debilitating symptoms of malaria.

She contracted the life-threatening disease in Malawi where she had gone to perform at Lake of Stars international festival last month.

Despite her near-death experience during her four-day hospitalisation, Moonchild still sees the funny side out of the whole ordeal.

"I did see Jesus and His eyes are squint," she joked, albeit with a nervous giggle.

Before she was hospitalised, the 32-yearold born Sanelisiwe Twisha had travelled to Los Angeles and Austria unaware she had contracted malaria.

"It was scary. I remember telling myself there is no way this is going to come out and [have people] say, 'rest in peace Moonchild'," she recalled.

"I was in and out of consciousness. I was so weak and we initially thought it was just jet lag. So, I was travelling and didn't know that I had malaria in my system.

"Apparently when they called the ambulance I was so delirious that I pushed my friend. It was crazy I got so lucky. Every doctor kept saying your timing was so vital."

Messi and Rapinoe expected to take Ballon d'Or honours

PARIS - The biggest names in world football will descend on Paris today for the 2019 Ballon d'Or ceremony, with Lionel Messi and USA women's World Cup superstar Megan Rapinoe tipped to leave with the honours.

It would be an enormous shock if Rapinoe did not depart the Chatelet Theatre with the women's prize as she returns to the country where she was the driving force on and off the field for the United States as they retained their title.

The suspense surrounds the identity of the men's winner, 12 months after Croatia's Luka Modric claimed the crown thanks to his exploits in dragging his country to the World Cup final and winning the Champions League with Real Madrid

That ended a decade in which Messi and Cristiano Ronaldo had won the Ballon d'Or five times each, but the smart money now is on the Barcelona man claiming number six.

There are 30 nominees in total for the prize, organised by France Football magazine and voted for by 180 journalists from around the world. Among the names is Ronaldo, as well as several of the stars of the Liverpool side who won the Champions League, chief among them Dutch defender Virgil van Dijk.

At one point he looked like the favourite, but Messi already pipped him to FIFA's The Best title in September.

WORLD CHAMPION FRANCE DRAWN IN 'GROUP OF DEATH'

BUCHAREST - Every tournament needs a "group of death," and the draw for next year's European Championship has produced an eye-watering prospect.

Europe's top nations discovered their fate in Saturday's draw in Bucharest, and all eyes now will be on Group F, where reigning champion Portugal was drawn against World Cup winner France and three-time European champion Germany.

The respective managers of the three big teams couldn't help but laugh -- perhaps nervously -- as the draw was made, with the final position in the group still not decided.

It means the likes of Portuguese captain Cristiano Ronaldo will



face French superstar Kylian Mbappe in the early stages of the competition.

Elsewhere, we now know Italy will open the tournament when it faces Turkey in Rome on June 12. And there also will be a repeat of the 2018 World Cup semifinal as England faces Croatia in its first group game of the tournament

In a break to tradition, many of the group positions were decided before the draw took place.

Due to the unique nature of next year's tournament (it will be hosted in 12 countries), qualified hosts had been allocated to a group prior to the event.

To confuse matters further, there are 16 teams still looking to book their place in the tournament, and they will compete in separate playoff paths for the four final positions up for grabs.

The groups can therefore not be confirmed in concrete until all qualifying is over on March 31.

The draw has attracted criticism due to its confusing nature. Belgium, for example, knew three of its opponents ahead of the draw.

The European Championship final will be at Wembley Stadium in London on July 12.

Low happy to see Germany in 'group of death'

BUCHABEST - Germany coach Joachim Low had no doubt that Group F was the 'group of death' after Saturday's Euro 2020 draw, but was surprisingly happy about his side's draw.

France Manager Didier Deschamps accepted that his side will face a huge test in Group F, which will be played in Budapest and

"It's a difficult group, but I think that Joachim Low and Portugal head coach [Fernando Santos] think the same thing. It's the hardest group, but we have to accept it," Deschamps said.

"We will need to be ready at the beginning of the competition because our first game will be against Germany in Munich. They will play at home.

"On paper, it's a tough group. These two teams have many qualities and they recently had good results."

France's first match will be against Germany at the Allianz Arena on June 16 before playing two games in Budapest.

Deschamps said: "It could be better, but what can we do? Germany and Portugal are in our group. We know when we will play and where.

Hamilton stunned by 'first Ferrari compliment in 13 years'

ABU DHABI - Lewis Hamilton said on Saturday that Mattia Binotto's glowing comments about him represented the first time in 13 years that anyone from Ferrari had paid him a compliment.

Asked if he would be interested in Hamilton's availability on the driver market in 2021, the Ferrari team chief had praised him as a driver and said "knowing he's available in 2021 can only make us happy".

The six-time world champion, who grabbed his 88th pole position by topping qualifying for Sunday's Abu Dhabi Grand Prix, said: "I think that's the first compliment I've had from Ferrari in these 13 years.

"I honestly don't remember them ever mentioning me, ever. So, thank you, and I'll take it. It doesn't really mean anything. It's all talk, but it's nice that, finally, it's taken all these years for them to recognise me, but I'm grateful."

The 34-year-old Briton has been linked with a possible move to Ferrari when his current deal with Mercedes ends next year.

Respect

He said Ferrari were "a team that I've always appreciated over the years, so to earn respect from someone from there, that's obviously very high up, is not a bad thing."

He dismissed suggestions that he was looking for a move to Maranello whose drivers this season are former world champion Sebastian Vettel and Charles Leclerc.

"I think they've got two great drivers as it is. Who knows what the driver market's going to be doing over the next year, but, if I'm really honest, I'm not really focused on that right this second."



Mourinho was offered £12m by Real Madrid

MADRID - Tottenham boss Jose Mourinho was reportedly offered £12million by Real Madrid to reject a top job in football and instead wait for Zinedine Zidane to depart.

The Portuguese manager took over the hotseat in north London after the club sacked Mauricio Pochettino, but the 56-year-old had been linked with a return to Los Blancos, with the Spanish giants initially suffering a shaky start in La Liga.

Zidane ended up staying put after overseeing a turnaround in form, while Mourinho opted to join Spurs despite a host of interest in his services from a host of clubs.

The likes of Borussia Dortmund, AC Milan, Lyon and Chinese Super League outfits were all rumoured to be willing to offer him a route back into the game after taking a year out following his sacking by Manchester United in 2018.

But according to the Sun, Madrid would have spent big just to guarantee that the two-time Champions League winner would remain a free agent and take over if they decided to dispense with Zidane.

However, it is believed Mourinho had been eyeing up the Spurs job for some time, and once the possibility of a vacancy opened up, the Portuguese knew it was the role he wanted and was prepared to turn down his other

"It is just a great honour and that is what I told the players - you guys have to do the job, I can help and support, but for me, it is a great, great honour. "I was proud, honoured that they trusted me to do it and deliver that. I felt excited because I feel we have some very good football players here and it is a great club. I felt excitement at such a big thing." The search for Emery's full-time replacement has begun, with Max Allegri and Brendan Rodgers on the Gunners' shortlist. Sky Sports

Spurs fans don't love me, they accept me - Mourinho

LONDON - Jose Mourinho says Tottenham supporters do not love him yet, but he hopes a run of three successive wins to open his reign in north London has him heading in the right direction.

Spurs turned to the Portuguese after taking the decision to move on from Mauricio Pochettino after five-anda-half years.

Mourinho's glittering CV attracted him to Tottenham, with a side longing for tangible success turning to a proven winner for inspiration.

Impact

An immediate impact has been made by the new boss, with six points claimed from two Premier League games and a come-from-behind success enjoyed over Olympiacos in the Champions

Spurs' latest triumph saw them survive a fightback from Bournemouth to prevail 3-2 on home soil, with Mourinho stating afterwards that he hopes to earn the affection of the club's loyal fan base. He told BBC Sport:

"The fans love the club, I'm not saying they love me but they accept me as a top professional who wants to give everything for the club.

"People have more reasons to love me if they like my work, but the fans are behind the team and they see us working hard to get to a position in the table that is more suitable to the talent of this squad."

Spurs, who slumped to 14th under Pochettino, have clambered back into fifth spot in the Premier League table.

A return to form for Dele Alli has helped to make them upwardly mobile once more, with the England international bagging a brace against Bournemouth.

Mourinho added on a player who had looked a little out of sorts prior to his arrival: "He plays in a position where he feels happy and comfortable, we also give him space for his creativity which he always has.

"I think he played three pher matches since I arrived."

While Mourinho has Tottenham ticking over as an attacking force, he is still waiting on a first clean sheet.

"We hung in there for long enough and we were able to get those rewards late in the day for all the toil we put in.

"If things aren't happening you keep on trying."

With Root and Burns putting on 177 for the third wicket, England found the "bat-long" partnership they had been searching for in their attempt to follow the same recipe New Zealand used to win the first Test.

But following the dismissal of Burns, Ben Stokes was gone for 26 while Zak Crawley made one on debut.

Root was under added pressure to not only guide England to a position of strength but also to end his own run dearth amid suggestions the pressure of captaincy was affecting his form.

Ferguson confirmed for UFC lightweight showdown



Hamilton cruises to victory

ABU DHABI - Lewis Hamilton finished his sixth world championship-winning season with a commanding victory at the Abu Dhabi Grand Prix.

Fireworks lit the night sky as the Briton crossed the line after a race he totally dominated from pole position.

It was his 11th win of the season, his 84th in total, just seven short of the record 91 victories held by Michael Schumacher. There was never a moment's doubt about the identity of the winner throughout the twilight-to-night race, the concluding instalment of a 21-round sea-

Hamilton, 34, was off cleanly at the start and soon established a comfortable lead over Ferrari's Charles Leclerc, who had passed Max Verstappen on the first lap.

However, it was Verstappen who finished second, passing the Monegasque impressively halfway through the evening's action. He piled down the inside of the Ferrari and poked himself ahead into Turn 8, pushing Leclerc aside.

Leclerc fought back and the two touched wheels soon afterwards but there was no way past Verstappen, who claimed third place in the drivers' championship behind the two Mercedes.

Banged

But Hamilton, in a golden crash helmet, was miles down the road, winning by 17 sec, lapping all but the top handful. He also banged in the fastest lap late on. Leclerc finished third to confirm his mastery over his Ferrari team-mate Sebastian Vettel this year.

However, Leclerc faces a postrace investigation into a possible fuel irregularity.

Speaking of Ferrari, there was no let-up in their ability to shoot themselves in the foot. They botched Vettel's pit stop. It took them nearly seven seconds to reboot him as both left tyres proved hard to fit.





TAEKWANDO - IN readiness for the COSATA Games to be hosted by the country, fighter Wandile Maziya trained with the world's third best taekwondo artist Lee Dae-Hoon in Seoul, South Korea.

Eswatini will host the Confederation of Southern Africa Taekwondo Association (COSA-TA) Games next Saturday at Mavuso Sports Centre and Maziya who is part of the squad in the senior male category has gotten the best possible sharpening up in South Korea.

Lee Dae-Hoon is the third best fighter in the world and has won 123 of his total 139 registered

Countries that have confirmed participation for the COSATA Games are Botswana, Lesotho, Mozambique, Angola, Zimbabwe and South Africa among others. In a caption on the Eswatini Taekwondo Federation (ETF) Facebook page, Maziya who was posing with Dae-Hoon in one of the sessions said, "It has always been my wish to train with you. Finally my dream came true.

Most notably, Lee Dae-Hoon won the

Bronze medal in the 2016 Summer Olympics and a Silver in the 2012 Summer Olympics. Lee grew up practicing martial art at his father's taekwondo academy from age five. He won gold medal at the 2010 Asian Games and repeated his success at the 2014 Asian Games in Incheon. Originally a bantamweight (under 63 kg), Lee temporarily went down in weight to flyweight (under 58 kg) after the 2011 World Championships in order to compete in the 2012 Olympics, where there were only four weight classes.

According to Wikipedia, Lee made his international flyweight debut at the 2011 World Taekwondo Olympic Qualification Tournament

Baku, Azerbaijan where he had his first international loss to

2008 Olympic silver medalist Gabriel Mercedes 14-12 in the semifinals. In May 2012, however, he captured his first flyweight gold medal at the 2012 Asian Taekwondo Championships, beating reigning Asian flyweight champion Pen-Ek Karaket 8-4 in the final bout.

In 2016 Summer Olympics Lee captured bronze medal beating Jaouad Achab from Belgium 11-7 and in 2016 WTF World Taekwondo Grand-Prix, Lee won gold against Konstantin Minin. According to ETF Secretary General Ndo Sibandze, in readiness for the COSATA Gamesthe local squad is currently training together every Saturday at Palaistra, Manzini.

"This Championship will be a test event for the AUSC Region 5 Games. Taekwondo has been shortlisted among the sports that might be included in Region 5 Games next year, so COSATA has decided to use this Championship as a test event. It will help our athletes, especially those preparing for Olympic qual-

ifiers, African Seniors championships and World Junior Championship 2020 to be at par," Sibandze said.

"The situation was bad after the match as the players vowed not to return to training on Tuesday until they receive their salaries. They feel that they are being neglected by the team after encountering same last month where they received half their pay very late," the

The players are said to have made it clear that they would even boycott the next match if they don't get in-contacts.

The source said the three officials tried to manage the situation as they promised the players that they would be paid eventually.

"The players just want their money. They threatened not to continue with training unless they are given what is due to them," he said. Manzini Wanderers Public Relations Officer Sandile 'Ntofo' Dlamini said he was not aware

"I did not attend the match on Saturday as I had some personal issues to attend to, there-

"The letter was emailed to Moneni Football Club yesterday morning. The team is yet to sit down and discuss the latest developments," said the source.

If 'Magiyane' finally joins the senior national team as head coach, he will be following on the footsteps of Harries 'Madze' Bulunga who is now the Minister of Sports, Culture and Youth Affairs and Anthony Mdluli, among others.
