

Bogus 'cop' cons

28-year-old Mangaliso Dlamini of Madonsa in Manzini was arrested and has since been granted bail set at E75 000, after he pleaded not guilty to the charges of theft by false pretences.

According to the charge sheet, Dlamini was said to have, on December 15, 2017 near Mbabane, misrepresented himself to Mlungisi Nxumalo as a police officer.

Dlamini was then said to have told Nxumalo that he will not arrest him with regards to an illegal substance he had in his backpack, while Dlamini was inside Nxumalo's vehicle.

After having made these statements, Dlamini was reportedly able to obtain from Nxumalo money in cash amounting to E150 000 thus committing the offence of theft by false pretences.

Dlamini was

further charged with contravening the Police Act, after he was said to have,

not being a member of the

Royal Eswatini Police

Service, impersonated or represented himself as a member of the police service to Nxumalo.

In his appearance before Magistrate Lenhle Zulu yesterday, Dlamini was remanded back into custody until Thursday. pending the setting of his trial date.

After a brief consultation in chambers, Dlamini was further granted a bail of E75 000, which is half the amount that Dlamini obtained from Nxumalo.

Businessman assualted for impregnating brother's wife

BY SIZWE DLAMINI Pigg's Peak

A Pakistani businessman was heavily assaulted by his relatives after he impregnated his elder brother's wife and then fled to Pigg's Peak.

Muri Patel was assaulted by his elder brother Ali and two others at Glen Township last week.

According to well-placed sources, both brothers lived and worked together since 2012 in Johannesburg, South

However, in 2018 when elder brother Ali visited Pakistan for two months. he returned to find his wife had been impregnated by his younger brother and business partner Muri.

The pregnancy led to the birth of a son, however, after the birth Muri then fled South Africa and settled in Pigg's Peak where he works with his fellow countrymen in a grocery shop.

Speaking to this publication on Saturday, police said Muri left South Africa and stopped paying child sup-

port for his son causing an angry Ali to locate him in Pigg's Peak.

"Ali, who witnessed his wife giving birth to his younger brother's son in 2018 drove from South Africa to Pigg's Peak last week and demanded that Muri pay child support.

Refused

Muri is said to have refused and stated that, Ali owed him seven years of unpaid salaries while the two worked together in Johannesburg.

This then led to the assault," they said. The police added that Muri was

heavily assaulted by Ali and two other relatives who could not be identified by the victim. "Muri was assaulted all over the boy with kicks and punches. However, during the assault Muri never fought back but chose to flee to another Asian's home to find refugee.

The next morning the assault was reported to the police and Ali was arrested and is currently waiting to face the Pigg's Peak Magistrate's Court," they added.

Chief Police Information and Communications Officer (CPICO) Superintendent Phindile Vilakati confirmed the incident but said only Ali was charged with the assault of Muri.

PHATHAPHATHA'S WIFE WANTS DIVORCE

NELISIWE Mdluli, Senior Magistrate Phathaphatha Mdluli's wife, wants out of her marriage.

Neliswa a week ago recorded a statement with the police after allegedly being assaulted by the veteran judicial officer.

Information gathered from reliable sources, who are working on the matter, revealed that Nelisiwe in her statement made it clear that she was not laying assault charges against her husband but wanted divorce.

As a result of the assault, Mdluli, nee Maphanga, was admitted at the Mbabane Clinic where she was treated for bruises and cuts on her face following the alleged altercation with her husband.

The cuts on her face measured about three centimetres deep. She mentioned that the only amicable solution to the matter would be ending the marriage through a divorce. It was gathered that not only did she record this sentiment in her statement but also had an audience with the Chief Justice Bheki Maphalala to plead that they do not dismiss her husband from work.

It is alleged that Nelisiwe's actions are motivated by the fact that Mdluli is the breadwinner and being out of work would compromise the children's welfare. Nelisiwe was not the only one who recorded a statement with the police but Magistrate Mdluli also recorded his. Sources close to the matter revealed that in his statement. Phathaphatha admitted assaulting Nelisiwe but only with an open hand and seemed shocked that she suffered such injuries.

The source added that they found it difficult to believe that the he only assaulted her with an open hand as she sustained a gashing wound on her face of about three centimetres deep, indicating that more force was used during the assault. Ever since the incident, Mdluli, who is Pigg's Peak Magistrate's Court acting principal magistrate, has been absent at his place of work. The matter has been the talk of the town as women activists last week demanded an audience with National Commissioner of Police (NatCom) William Tsintsibala Dlamini. The women activists on Thursday had a meeting with Dlamini where they are said to have wanted updates on the matter regarding Mdluli as they felt that the police were not acting fast enough on the matter.

However, Dlamini assured the activists that the police were working on the matter as they were engaging various stakeholders due to the nature of the matter as the victim did not press charges. A source revealed that the victim made it clear that she did not want to press charges as she only wanted out of the marriage following a fall-out with her husband.

It was also alleged that the couple were sleeping in different bedrooms indicating that they had long standing issues. This publication has also been informed that the police investigating the matter had a meeting on Friday with the office of the Directorate of Public Prosecutions regarding the matter.

However, the outcome of the meeting is still not known.

Popular mechanic commits suicide

A family was left with more questions with no one to answer after the head of the family was found hanging on Saturday evening at Woodlands forest in Mbabane.

Mpolonjeni (Gosheni) popular Isuzu mechanic, Richard Silindza (47) was found hanging on a tree.

According to Andreas Nobela, who is the deceased's brother, Silindza left home on Saturday morning for Jubukweni to visit his friend. Nobela said they were not ready for what they heard in the evening.

Nobela said they received a call from one of the family friends that they have spotted Silindza's car by the road near the forest where he took his life in.

Nobela said the car was noticed by police officers. He said the car, according to the police who started being suspicious, had been parked by the forest.

"His car was parked since 1400 hours by the road," he said.

Upon the change of shift, the police noticed that the car was still parked by the road near forest. Nobela said they then received a phone call from their friend Themba Mahlalela, who noticed the car as he parked by the road. He said they called his cellphone and it was unavailable.

"They called his other number and it rang unanswered," he said. Nobela said together with the police, they searched his car and there was no one inside.

He said upon realising that he was not in his car; with the help of the police they searched the nearby forest.

Nobela said they discovered his body hanging on a tree with a rope on his neck. Nobela said it was around 1900 hours when they discovered his brother.

Nobela said they learned that he did not even reach Jubukweni.

The father of six did not leave even a note. His brother said it would have been easier if they knew why he decided to take his own life.

According to Nobela, his deceased

brother was diabetic.

But at the time of his untimely passing, he was much better from the illness as he was taking his medication and was back in business.

In addition, Nobela said he used to have episodes of anger but even those episodes he was able to manage them.

Nobela said as a family they were shattered by his death. He said if there was a time where they would not be shattered by his untimely death it would have been a few months ago when he was very ill.

This is because at the time he was stressed that he was unable to carry on with his work.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that a 47-year-old man from Mpolonjeni was found hanging at Woodlands forest.

Meanwhile, clinical psychologist Ndoniyamanzi Mdlalose said it was painful that in the black community do not believe in sharing whatever is troubling them.

She said people believe the best way of dealing with problem is bottling them up, hence an episode of suicide strikes.

She said some people were good at pretending that everything is okay until they commit suicide and leave everyone with questions.

She emphasised in the culture if regular visits to psychologists. She further pleaded with the public to do away with the assumption of labelling people as metally unstable whenever they visit psychologists.

He was spotted through the window by another tenant, who saw him hanging by the rope from rafters inside his



house

It is said that upon the discovery they called the police, who when trying to enter his house faced difficulties, as Dlamini had locked the door.


When the relative was asked if the deceased had left a note which stated his reasons of him taking his life, they mentioned that he hadn't.

They, however, mentioned that the

deceased had family problems and he had recently found out that the man he thought was his father was not.

The discovery is reported to have concerned the deceased.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the matter, saying they were still investigating the circumstances leading to his death.





Patron, His Majesty King Mswati III over the last 12 years. His Majesty has always challenged us to think ahead of times and be innovative," Simelane said.


He assured the King that as an organisation they would continue to support the government's Strategic Roadmap where they can, especially when it comes to the fight against hunger amongst children in Eswatini.



Baby daddy demands E5 000 child support back

A young man disoriented by reports that a child he was supporting was not his, stormed a Dlamini homestead at Mantabeni and demanded back child support from his 18-year-old baby mama.

The furious young man, who resides at Moneni in Manzini, arrived at the Dlamini homestead unannounced at night and demanded his E5 000 back.

According to Phindile Dlamini, who is a mother of the 18-year-old teenage mother, the young man arrived at around 2100 hours when they were already asleep. Dlamini said the young man was in the company of two others.

"The other two boys are more or else the same age, one was driving while the other was a passenger," she said.

She said the three easily entered her home since it is not fenced. She said upon entering her home they went to knock at her two-room door demanding to see her daughter.

She said she was startled by the loud banging sound and answered the door. Upon opening the door, she said the ...after discovering that child he was supporting is not his



young men demanded to see her daugh-

"The two young men who were with the baby daddy remained in the car watching the whole episode," she said.

Dlamini said she refused that the young man sees her daughter in the state he was in. She stated that the man was seething with anger as he paced up and down the yard demanding to see her

However, she was unable to prevent the young man as she pushed her and entered the house. Besides, Dlamini said her daughter had already been woken up by the loud noise.

Upon entering the house the young man demanded that his baby mama refund him child support. The two teenagers are parents to a 14-monthsold baby boy. Dlamini said she was surprised by the young man's demands. 'He said he had found out that the baby boy was not his," she said.

Dlamini said he was taken aback by the man's utterances since his family knew the child and they were the ones who said the boy resembled some of the family members.

She said after they argued that with the young men it was obvious that everything they were saying fell on deaf ears. He started threatening them.

Dlamini said they then called for help but the young men stuck to his story and demanded his money back even in the presence of neighbours who responded to the cry for help.

'She ruined my future, I had to drop out of school'

WHEN asked about storming the baby mama's homestead to demand his child support back, the young man denied such

He wondered if he was in the wrong by visiting the Dlamini homestead after hours. Coming to the issue of demanding his child support, he confirmed that he still wants his money back. He said he was forced to leave school in order for him to find a job to support his child.

"My parents ordered me to quit school and find a job since I had opted to be a parent," he said.

The young man said he was supporting the baby boy since January this year.

"Had I not quit school I would be writing my final examinations like any Form Five pupil." The young man said his former girlfriend ruined his life about lying about the paternity of the child.

Narrating how he found out about the paternity of the 14months-old, he said he was told by a neighbour that there was a man secretly visiting his baby mama who looked exactly like his supposed son.

He said his parents had already

started suspecting that the child was not his.

"As the baby grew older he looked nothing like me or any of my family members," he said. He said he was paying E500 child support per month.

In total the young man had already paid E5 000 towards the support of the child, which he is demanding back. He denied storming the homestead and causing chaos but said he only came to ask that they reimburse him all his child sunport. According to a traditionalist Lusendvo Fakudze, such issues are discussed by elders. Fakudze said the young man should have relayed the matter to his parents.

In addition, Fakudze said the traditional way of paternity was a complicated one but whenever the paternity of a child is required close scrutiny was done by close family members.

The baby mama was asked about the matter but flatly refused to comment, referring all questions to her mother.

The mother denied that there was another man secretly supporting the child but said they have always known that the child belonged to the young man.

"GOVERNMENT deliberately wants to take the country to the dogs."

This was an assertion by Eswatini Witchdoctors Association Chairman Makhanya Makhanya when describing what the end result of government's neglect on citizens would be.

Makhanya was speaking after tinyanga's consultation huts (tindumba) were raided by members of the Royal Eswatini Police Service (REPS)

According to the chairperson, the police stormed their homes and unlawfully confiscated their muti and other items that are used in their area of expertise. This is said to have happened at homes of the witchdoctors from all over the country.

Speaking from experience, Makhanya said over 19 police officers stormed his home last Thursday and took away some herbs, horns and other tools pertinent in the healing profession. This is said to have happened despite the fact that the chairperson was authorised to possess such animal bones and skin as dictated by the law.

The agitated traditional healer told this publication that he tried to reason with the officers whom he showed the receipts of all the items, some of which were bought in South Africa and are said to be costly, but they were not keen in listening to him. Instead, Makhanya said one of them told him that he would explain everything in court.

"They even told me that government was financially stable in case I sued," he said.

For this arrogance by the police, Makhanya said it was clear that they were acting on an order from someone who wanted to settle scores and implement a plan from someone higher in the country's hierarchy. He said government was responsible for all this, and wanted to wipe out Emaswati by not availing either the traditional or modern modern medicines.

"Government first failed to avail medication in the country's hospitals, and when citizens turned to us for traditional assistance, the police, acting on an order, raid and take away our herbs. This shows that by using ancient laws that were made by white people, our government is collaborating with the whites and turning their backs on the people," Makhanya said.

He added that this kind of behaviour by Eswatini government was a direct opposite of what is prayed for in the national anthem in its line, "Sinike kuhlakanipha lokungenabucili...." In translation, this means, "grant us wisdom without deceit or mal-

"Loku lokwentiwa nguhulumende kubucili; bafuna kubulala lesive semaSwati," Makhanya said

He added that neither was he nor witchdoctors against the enforcement of the law but they were not for the idea of the police barging into their homes to disturb their peace without search warrants. He said the police's 'illegal' raids were spoiling the witchdoctors' herbs.

"We also know that some of the three security forces' superiors sought traditional healers' assistance that's why we strongly believe that such raids are more than just upholding the law but a platform where the concerned leaders prove their authority by taking away muti belonging to healers who are their tinyanga's competition," Makhanya alleged.

Further, he said it was folly for law enforcers to seize tinyanga's muti and bones if the goal was to stop them from poaching because after their herbs and relics are taken away, there would be a need for replacements. This, according to Makhanya, was bound to tempt them to posch. thus breaking the law.

To do away with such treatment of tinyanga by the law enforcers, Makhanya, on behalf of tinyarga called for an amendment of the Game Actor 1953 which was last amended in 1991. Makhanya said when amending this Act, witchdoctors and

other relevant stakeholders need to be consulted. When quizzed on the matter, the Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the police undertook an operation that aimed at preserving wildlife according to the Game Act

She also confirmed that some of the witchdoc tors' relics and muti were taken.

"Unfortunately, the full report on the operation is still not out for a few more weeks so I cannot say anything much about it," Vilakati said.

SODV ACTILLEGAL - MP

THE much-talked about Sexual Offences and Domestic Violence (SODV) Act of 2018 is operating unlawfully.

This was said by Dvokodvweni MP Mduduzi Magagula yesterday. He was interviewed by this publication on why he attempted to move for the review of this piece of legislation in Parliament.

Magagula made it clear that he was not against the SODV Act, but he wanted some of its sections to be clearly explained to Emaswati. He said there was an outcry from the people about the law. Many citizens complained that they had fallen victim of the legislation, because some

people were out to abuse the law, just to settle personal scores with others.

The Dvokodvweni legislator said it was very painful to see individuals falling victims of abuse. The SODV had come at the right time to ensure that the abuse stopped.

However, the law did not address what it was set out to do. Evidence of that, according to the MP, was that some people continued to fall victim. They were not protected from the law.

Magagula said he was not rubbing anyone the

wrong way by speaking out about loopholes in this law.

He believed no one was immune from the law. That was the reason why as MPs, they called upon Deputy Prime Minister (DPM) Themba Masuku to table the regulations in the House of Assembly.

He said Section 195 of the very SODV Act called upon the DPM to ensure that the legislation worked with the regulations in place. However, what was happening now was that the SODV

Act was working without the regulations, hence the MP said this was unlawful.

He said they hoped that the regulations would be helpful in clarifying some sections of the law, which seemed to be a problem to many people. Magagula said he was not vocal about this legislation because he felt guilty or was trying to save his skin.

He said he would not do that because he was a married man and was a Christian, a religion against doing bad things to other human beings.

He also said he was aware that women were also affected by that the SODV Act had some loopholes that needed to be attended to.

Women and Law in Southern Africa (WLSA)
Director Colani Hlatjwako said she could not
comment on the matter, as she was committed.
She asked to be given more time to comment.

DPM facing contempt charges

DEPUTY Prime Minister (DPM) Themba Masuku might be slapped with contempt of Parliament charges.

The bone of contention is the SODV regulations that have not been tabled in the House of Assembly, as the MPs had directed. The

DPM is the minister responsible for ensuring that the SODV regulations are tabled.

Dvokodvweni MP Mduduzi Magagula said he was aware of such a motion. He said it was still in the Notice Paper. This means the motion is yet to make it into the House of Assembly. Sources close to the matter also stated that there is an intention from the MPs to slap the DPM with such charges.

Last month, the MPs stated that they wanted the DPM to table

the regulations. This was through a motion, which was moved Magagula himself.

He was seconded by Hosea MP Mduduzi

The seconder was supposed to be Mangcongco MP Oneboy Zikalala, but could not, as he was absent in Parliament.

Magagula, when motivating the motion, said the regulations would help in easing the misconceptions that people had about the Act. He said some sections of the Act had to be explained for Emaswati to understand them.

The Dvokodvweni MP said people were inter-

ested in the Act such that they talked about it.

However, there were certain sections that needed to be explained in the Act by the regulations. Mabuza, when seconding, said the regulations were needed so that they could explain some contents of the Act.

He said the problem currently was that the people did not want anything to do with the Act. They viewed it as a monster and that was not a good

sign at all.

He further said it was hard for them to successfully host meetings without residents asking about the SODV. Police officers also hijacked their meetings, wanting to teach about SODV. He urged the DPM to speed up the regulations so that people could be helped.

130 PEOPLE WITHOUTSHEETICR

THE number of citizens affected by the storm that hit Eswatini in the past weekend has reached 130.

Manzini region was hit hard by the storm as 56 homesteads were left roofless during the storm that occurred last Sunday evening, according to an assessment carried out by National Disaster Management Agency (NDMA).

Nine households were affected at Pondo Inkhundla, Mahhashini Umphakatsi, 15 at Manzini North, two at Ngwempisi, 16 at Kwaluseni, including a pre-school, whilst Mntfongwaneni reported eight households and Nhlambeni had six.

Most damage affected the roofing of the houses as corrugated iron sheets were flung all over. There have been no loss of life. Relating his ordeal, Banda Mkhweli (60) of Gundvwini said he was experiencing a catastrophe of this magnitude for the first time. "It was around 7pm on Sunday whilst I was with my eight children in one of the huts when we saw clouds forming, accompanied by strong winds.

Whilst we were concerned with that, it started raining heavily and that was when the roofing was blown away," he said. Mkhweli said it happened so fast that they panicked and bolted out of the hut seeking cover.

Roofless

The unemployed father of eight said the rain was heavy such that they were unable to move anything, including food, clothing and blankets.

All the food they had was soaked in water. Another victim of the heavy wind-storms Sibongile Dlamini (40) from Gundvwini also lamented the Sunday storm. Together with her seven children, they were left roofless.

"I do not know what to do.

The little food we had was soaked in water, my children's uniform was soaked in sand after the roofing of the house was blown away, about 100m from our house," she said.

She added that the storm lasted for about 10 minutes, but they were helpless because they feared for their lives as it was raining and thundering very heavily. On that note, NDMA Communications Manager Wandile Mavuso said relief assistance in the form of a tent, beans, rice and cooking oil were sent to the victims of the storm. "The tents will be of assistance in covering the huts so that they do not experience rainfall in the interim whilst they try to rebuild their huts,"

Mavuso further appealed to the public to prepare for the rainy season.


"We urge Emaswati to keep track of weather updates and patterns because that is preparedness on its own," he said. He further urged the public to fix leaking roofs and practice retrofitting on their structures, as this would minimise extreme damage to roofing.

Electricity Efficiency and Alternative Energy Sources in Eswatini

he energy sector has a significant contribution to the economy of T h e Eswatini. expansion of the sector, changes of the market structure and the pricing of the services provided across the energy value chain affect how the economy responds and trickles to all other sectors such as agriculture and manufacturing. Therefore, energy efficiency is one of the mitigation actions which can assist in cushioning the consumer from feeling the shocks within the energy sector.

Eswatini's energy demand is

currently served by a significant percentage of imports, and very minimal percentage from local production. The local resources constitute of hydroelectricity and biomass in the form of wood fuel mainly from the indigenous forests for households and solid biomass for industry from plantation forests and bagasse from the sugar industry, and the imports are in the form of petroleum products, electricity, and bituminous coal.

Electricity Efficiency

Nowadays the by-product of great interest is electrical energy

(electricity). To use the coal resource as an example, the production of energy involves the conversion of potential energy, kinetic energy, mechanical energy and electrical energy. During this process there is waste heat energy produced due to the movement of mechanical parts and also sound energy produced. In such a system, if tonnes and tonnes of coal are consumed to produce relatively small amounts electricity, this could be our inefficient use of the present

Given the electricity sector challenges of security and reliability, electricity efficiency can drive the energy demand lower and boost the economy tremendously. The key aims for electricity efficiency

practises are to: Enhance electricity security by optimising existing local energy sources such as solar, biomass

· Mitigate the detrimental effects of climate change and environmental degradation. Some of the practices that can be used to

increase the efficiency of existing energy systems could be the: · Enforcement of building standards which will encourage the majorly use of the natural

· Use of efficient appliances, for both domestic equipment and industrial equipment;

Alternative Energy Sources

Given the electricity security issues currently in the country, domestic and commercial electricity consumers are opting for the option of generating their electricity through solar photovoltaic and biomass. This has led to the development of minor generation plants whereby a customer can generate enough for self-consumption. According to the Electricity Act, A generator who generates electricity with a plant of less than 100 kilowatts exclusively for own use shall not apply for a licence, however, a generator who generates electricity with a plant of more than 100 kilowatts exclusively for own

use shall apply for exemption to hold a licence from the Energy Regulator. These generation tools include solar systems such as solar geysers and solar lighting systems which have become common in our society, and available at electric appliance shops.

With the current developments within the electricity space, the authority is driving the country towards adapting to these exciting times. The authority is in the process of conducting a market study within the Electricity Supply Industry in Eswatini, which will determine the impact of the recent energy developments and how they will influence the current electricity market structure in the country.

Furthermore, we are developing a regulatory framework for the small-scale embedded generation in the country. These initiatives are to aid in ensuring the security of electricity supply, reliability, and sustainability of the Eswatini Electricity Supply Industry in these fast-changing times.

Zwelakhe Gwebu was arrested in the early hours of yesterday morning after he failed to make it home as he ended up passing out on the road.


Appearance

Lindiwe's behaviour divides citizens - PAC

SENATE President Lindiwe Dlamini's behaviour now creates class divisions among citizens of Eswatini.

This was said by Deputy Speaker Phila Buthelezi, who said this behaviour drew a line that distinguished the citizens of Eswatini as either first class or second class citizens. Dlamini refused to appear before the Public Accounts Committee (PAC) during its 2019 session.

Buthelezi said the issue of Lindiwe drew the line. It appeared as though there were first class and second class citizens in the country. He said such should not be allowed.

"People who are not prosecutable are the King and Indlovukazi and it is unfortunate that there are citizens who want to take advantage of that. This line being drawn is now distinguishing between first and second class citizens," Buthelezi said. The PAC chairperson said such a situation was unfortunate in the country. In the future, such situations were not supposed to happen. They did not amuse them in any way, as they could not be able to execute their duties as public officers. They could not allow it to happen.

Responding

Buthelezi was responding to a question posed by Ntfonjeni MP Sifiso Sompisi Magagula, who felt as if the PAC was easily letting some people off the hook during its sessions. Magagula wanted to know why the PAC let some prominent people off the hook during its session. He made an example of the key witness that was talked about in the report. The same concern was raised by

Lugongolweni MP Enos Magongo, who said it was unfortunate that there were citizens who refused to appear before the PAC.

Dodged

Dlamini is said to have dodged the PAC and ran into a place where she could not be called to account. This was said by Buthelezi on Wednesday, when pleading with his colleagues in the House of Assembly to adopt the 2019 report of the PAC. Dlamini, who was supposed to be the key witness according to Buthelezi, cited the Privileges Act of 1967, which she said did not allow her to appear before the PAC until she asked for permission from that chamber.

It was not established whether she had asked for permission from that chamber or not. Buthelezi said they even engaged House of Assembly Speaker Petros Mavimbela on the matter. However,

Govt system creates pores on national purse

PAC Chairperson Phila Buthelezi said there was an audit on the office of the DPM, where about E300 million was disbursed. However, it was found that any person with access to the system could deplete the

He further said there was an instance where money was received yet it was not signed for. The certificate had to pass through many stages, but it was not signed until that person received money.

Buthelezi said by the time they engaged the speaker, the president had run to a place where she could having received money. Buthelezi also made example of the Poverty Alleviation Fund, where many Emaswati owed government millions of Emalangeni. He said there were two Emaswati that owed government but were suddenly cleared of their debts.

One Liswati owed E50 000 to government in respect of the fund. The person only paid E5 000, but the system recorded that he had paid E50 000. The one owing E100 000 paid only E1 000, but the system recorded that the Liswati had repaid the debt

Man on crutches sent to buy fuel, arrested for 'DD'

A man not in a good physical state to walk, let alone drive, was amongst the nine drunk drivers to appear in court yesterday.

Telling the court his rather unfortunate story, Mfanzile Khumalo stated that he was sent to buy fuel when he was nabbed by police officers.

"I had already started drinking when my neighbour approached me to take his vehicle to buy fuel, as his vehicle tank was low on fuel. Unfortunately for me, I was nabbed before I could even reach the filling station," Khumalo

Khumalo was nabbed driving an Opel Corsa while under the influence of alcohol along the Mbabane-Ngwenya highway on Saturday evening.

When a breathalyser test was conducted on him, Khumalo was found to have a blood alcohol content reading of 0.84 mg/l. Before entering the accused's dock, Khumalo, who was visibly injured as he used the assistance of crutches while walking, told the court that he had been previously injured in a car accident.

"I acquired these injuries due to a car accident, which is one of the reasons why I am unemployed today," he stated. Presiding Magistrate Lenhle Zulu commented that Khumalo had the guts to drive after having been injured in an accident.

Injuries

"You have the guts to drive while under the influence of alcohol yet you have serious injuries from having been in a car accident. You should not have been driving in the first place, and for that, the court has to make an example of you," she warned.

After having found him guilty as per his own plea, Khumalo was sentenced to serve 18 months in a correctional facility, with the option to pay a fine of E1 800.

Six of nine drunk drivers 'unemployed'

A total of nine drink-drivers appeared before Magistrate Lenhle Zulu from both Lobamba and Mbabane Police Stations.

Of the nine drink-drivers, six unemployed ones are set to contribute E9 900 in fines, after they were arrested for having been driving while under the influence of alcohol.

With the highest alcohol content reading of 1.41 mg/l recorded, Njabulo Sithole claimed to have eight dependants looking to him for support.

"I have three children of my own to support and in addition to that, I have five siblings who I have to support as well as both of our parents have passed on. I plead with the court to be lenient as I already have enough on my plate," Sithole pleaded.

Sithole was nabbed along Pick n Pay road in Mbabane on Saturday evening, where he was found driving his Toyota RunX sedan while under the influence of alcohol.

Sithole was also charged with negligent driving, after he was found to have bumped the boom gate while entering The Mall.

After having been found guilty as per his own plea, Sithole was sentenced to serve 30 months in prison, with the option to pay a fine of E2 600 for both offences.

While risking his own life to drive his inebriated friend home, an unemployed Sanele Gumbi told the court that he saw no choice to do so, as his friend had passed out in his drunk state.

Unfortunately for Gumbi, he was arrested before he could drop his friend off, while driving under the influence of alcohol. When a breathalyser test was conducted on him, Sithole was found to have an alcohol content reading of 0.63 mg/l.

Give me small fine - Asian national

AN Asian man with a sense of humour asked the court to give him the lightest sentence, as he had had too little to drink.

Jin Chu (34) was arrested and charged with contravening the Road Traffic Act, when he was found to have been driving his Toyota sedan yesterday morning at Lobamba, while under the influence of alcohol. When a breathalyser test was conducted on him, Chu was found to have a blood alcohol content reading of 0.47 mg/l. Chu was further said to have failed to produce his driver's licence when police officers requested it. In his appearance before Magistrate Zulu, Chu expressed that his command of the English language was limited. "Give me some small fine and I will go home," Chu expressed, much to the amusement of the court. Nonetheless, the prosecution made several attempts to simplify the charge sheet to Chu, for him to be informed of the charges pressed against him. After having admitted to the court that he had left his driver's licence at his home in Manzini, Chu was sentenced to serve 10 months in prison, with the option to pay a fine of E1 000. For failing to produce his driver's licence, he was sentenced to five months in prison, with the option to pay a fine of E500.

Woman goes berserk after finding lover with another woman

REVENGE is a dish best served cold, or rather in a cold prison cell for one woman after she damaged her lover's property upon finding him in the arms of another woman.

According to Nonhlanhla Hlophe, she had long suspected that her lover Morris Zitha had been cheating on her with their neighbour.

"My suspicions were confirmed when I found them drinking and sleeping in the house that I share with Zitha. However, I was peeping through the window so I elected not to say anything just yet. I did, however, instruct our children to tell their father that I would be out drinking, and would not be home until later that night," Hlophe stated.

It is said upon her return to her shared flat with Zitha, he refused to open the door for her, and that was when both their tempers flared.

Convincing

"After convincing him to open the door for me, we started arguing to the extent that the situation became volatile. While attempting to get ready for bed, Zitha strangled me and that was when I broke the windows of our flat," she recalled.

This was revealed in Hlophe's mitigation before Magistrate Sifiso Vilakati during her appearance on Friday.

Hlophe was arrested and charged with contravening the Sexual Offences and Domestic Violence Act of 2018, after she was alleged to have damaged windows in the rightful possession of Morris Zitha. The total value of the windows was E400.

Zitha, who was present during

the court proceedings, told the court that Hlophe was being melodramatic about the whole inci-

"We were both intoxicated that day, and our tempers flared because we were unable to reason with each other. This all started when she grabbed my clothes, causing me to retaliate by strangling her. She was bringing up old issues that I was tired of hearing about, even after I told her that our neighbour was just my friend," Zitha claimed.

Upon hearing Zitha's submissions, Magistrate Vilakati warned the couple to stop drinking as they were obviously unable to handle their alcohol addiction.

Respect

"Please Zitha; respect the mother of your children. How can you bring another woman to the house you share with her? You either need to separate from each other or just take care of yourselves. Lastly, please stop drinking, especially in the presence of your children," the magistrate cautioned.

After issuing the warning, Hlophe was sentenced to serve one year in a correctional facility, with the option to pay a fine of E1 000. Her sentence was wholly suspended, on condition that she was to compensate Zitha for his damaged property.

Msibi said the purpose and objective of the campaign was to promote public awareness on cyber security by increasing the level of understanding of cyber threats, simple mitigation actions, and empowering the nation to be more secure online.

"Consumer education and knowledge is paramount to cyber security and must be the centre of this campaign," he said.

In the course of the campaign, consumers would be capacitated on the threats and dangers when using the internet in order to ensure cyber security as they have become primary targets during cyber attacks in pursuance of data mining.

Msibi further stated that given that cyber security is a cross-cutting issue, it is important to ensure broader cooperation across all stakeholders as cooperation goes hand-in-hand with capacity building, and helps to reinforce collective efforts to be more efficient and effective.

He also commended all user companies who have willingly declared that cyber security is one of the challenges they are facing in this space. "That is how we have been able to match those challenges with these calls for innovation, creating the opportunity for the solution providers to step into this space," he added. The US said the type of collaboration across the industry and across the economy would be vital to drive our agenda as a country forward for further digitalisation and to guard the cyber security risks associated with it.

'Govt needs to strengthen resilience on cyber bulling'

GIVEN the country's interconnectedness and the trans-boundary nature of cyber threats, Eswatini must strengthen its security and resilience.

Ministry of ICT Under Secretary Nqobizitha Msibi said as the digital economy grows in scale and complexity, cyber security becomes of utmost importance to provide the much needed and requisite assurance and trust in the digital technologies that permeate all sectors of the economy, that are increasingly being adopted.

He said cyber attackers continued to evolve and develop ever more sophisticated tools and techniques. They are no longer motivated merely by economic gains, but also seek to disrupt critical information infrastructure. "Cyber defenders have to secure an increasingly challenging terrain, including a growing attack surface and new technology domains such as internet of things and 5G," he said. The US added that at national level, government had identified information communication and technology as one of the key sectors for the socio-economic transformation of the country and its citizens.

"Government is putting in place initiatives and programmes aimed at ensuring that ICT is used as a strategic resource, a commodity

Enabled World offers Emaswati access to social media on the free using an App called WORLD.

Enabled World Director Desmond Griggs said WORLD was a truly African initiative and while WORLD services would be beneficial in most emerging markets, the primary focus was Sub-Saharan Africa.

"Eswatini is the first country where WORLD has been introduced," he said.

He said Eswatini was the perfect environment to launch this new service because the people were early adopters of technology and embraced new services with enthusiasm.

He said the App enabled users to receive communication without having to share their name, phone number or any other personal information, because the App was not cellphone number based. He stated that the app helped people stay connected by subsidising mobile data so that they could communicate with each other and businesses around them.

He stated that WORLD was free to use in Eswatini so there was no need for airtime and users will not be charged for mobile data.

"You still need an internet connection though, so make sure your mobile data is switched on or use Wi-Fi," he said,

ITALIAN GOVT DONATES E55M TOESWATINI

AS part of climate change cooperation, the government of Italy has donated E55 million towards the greening of the Raleigh Fitkin Memorial (RFM) Hospital.

The donation is aimed combating the impact of climate change and promoting clean energy. Launching the first ever two projects was Minister of Tourism and Environmental Affairs Moses Vilakati on behalf of Prime Minister Ambrose Mandvulo Dlamini.

In his speech, he highlighted the importance of the event, and the impact the money would have on the country's increasing frequency and severity of droughts.

"It is my singular honour to launch the first two projects under the cooperation between the two countries to the tune of E55 million. 
Maziya, who was a regular feature in Mbabane along Gwamile Street (formerly Allister Miller) was buried over a week ago at the Nhlangano Cemetery.

Having been a regular feature at the capital city where he would be seen strolling and marching along Gwamile Street, Maziya disappeared only to resurface in Nhlangano town, where he again found himself a spot at the entrance of the Mall, where he spent most of his time.

Here, he used to draw a lot of attention, especially from bus and kombi drivers as well as commuters who were seemingly left entertained for all that he was doing, moving up and down and also talking to himself.

Some of the kombi operators were entertained by Maziya while doing some of his activities, such as few pressups while clad in an army uniform.

It's believed he served in the army (Umbutfo Eswatini Defence Force (UEDF) and while once spending time at the mall, he used to also tell all those who cared to listen how it felt to serve in the army.

Sifiso Kunene, a kombi owner said he read from this newspaper that Maziya had passed on and had already been buried. He said Maziya had befriended them as transport operators.

He said Maziya was known to most of the kombi owners and drivers.

"I did not believe that he had been buried. We never managed even to attend his funeral as someone we all considered as one of our own as each time we were at the bus rank, we used to stand next to the Mall entrance and listened to all the stories he was telling.

He was an interesting character. The man was always talking sense and some of us used to enjoy watching him, especially when clad in the army uniform," said Kunene.

Kunene then passed his condolences to the Maziya family on behalf of other operators, saying had they known about his demise, they would have attended his funeral.

"Unfortunately, we only read about his passing on from the newspapers and was already buried," Kunene explained to Shiselweni News.

Man believes coins can make him a millionaire

Cancer diagnosis care, treatment brought to Eswatini

CANCER has remained a painful and expensive thorn in both the health care provider and patients among the Eswatini population.

A solution has come in the form of a medical staff team that will offer all sorts of medical help, which includes chemotherapy and chemo drug for treatment.

The good news was announced during the yearly cancer conference cooperating with Eswatini, Taiwan Wanfang Hospital and Taiwan ministry of for-

This is the second year of the cancer project and the Taiwan team has brought on board oncologist Dr Paul

Coluzzi. The programme had over 90 people

participating. It started last year where the team embarked on a cancer journey where they had a cytologist from Taiwan for cancer screening and an oncologist from Zambia for patient's cancer treat-

When addressing the gathering, Dr

Coluzzi said they were looking at ways of minimising cancer and be broad with treating cancer and diagnosing

"Cancer has become a global burden therefore we need to strengthen the screening services, raise awareness in self-breast examination and establish national cancer registry," said

Dr Coluzzi when delivering his speech. It was also during the conference that the most common cancers were revealed. The most common cancers in Eswatini include cervical, breast and prostate. Cervical was the overall leading cancer in both females and males, with 87 per cent diagnosed since 2016 to 2018.

Only 41 per cent underwent cervical cancer screening in 2018.

Most cancer deaths are said to be caused by leading behavioural and dietary habits.

Cancer patients or cancer diagnosied tend to have high body mass index, low fruit and vegetable intake and alcohol use together with tobacco intake.

Dr Coluzzi advised that people visit their nearest health facility and be tested for cancer.

Be on the lookout for symptoms and signs

THE most crucial information discussed during the conference is that people should always be on the lookout for cancer symptoms.

Cancer often has no specific symptoms, so it is important that individuals limit their risk factors and undergo appropriate cancer screening.

Most cancer screening was specific to certain age groups. At primary care, doctors will know what screening to perform depending on one's age.

People with risk factors for cancer (for example, smokers, heavy alcohol use, high sun exposure, genetics) should be acutely aware of potential cancer symptoms and be evaluated by a physician if any develop. The best way to fight cancer is by prevention (eliminating or decreasing risk factors) and early detection. Cancer treatment advances every year and combined with early detection, has made many cancers treatable.

Consequently, individuals need to know which symptoms might point to cancer. People should not ignore a warning symptom that might lead to early diagnosis and possibly to a cure.

"Government does not condone a hospital with filthy surroundings as this reflects poorly on the ministry and patients. I will be investigating the matter further. It will be addressed as soon as possible," he said.



Nurse not confirmed after six years

A nurse who has been working at the Pigg's Peak Government Hospital for six years has not been confirmed as she is a foreign-

She was even hospitalised in 2018 at the same hospital due to stress.

Her name has been withheld for ethical rea-

The nurse claimed that she is being victimised by the matrons and other nurses who refused to appraise her as that would guarantee her permanent employment under the ministry of

"I haven't been confirmed since my arrival in 2013. This is because the Civil Service Commission (CSC) can only employ a nurse if she performs gallantly in appraisals.

"The appraisals should be conducted after two years, unfortunately only matrons and sisters at hospitals can conduct such so I waited for three years, with no help.

"Out of frustration I asked the matrons and sisters to appraise me in 2016, but they refused.

"I decided to wait another year but the sisters started to victimise me by lying to my superiors saying I was always absent from work or I was rude to patients and other staff," she said.

The nurse added that the matrons disallowed her when she submitted a transfer request and was forced to pay E3 000 for rent.

"I suffered from stress in 2017 and I was hospitalised at the female ward. After that I applied to be transferred from Pigg's Peak on four occasions, however, the matrons declined.

"I also developed a back injury and the doctor told me to perform light duties which means I would work while seated.

"But the matrons assigned me to the filing room where I was required to stand all day and lift boxes of files; injuring my back in the

"I decided to complain then the matrons stopped assigning me duties, forcing me to loiter at the hospital all day. Last week while working, one matron just started shouting at me saying when will I leave Eswatini?" she

'MOVING FROM RHETORIC TO ACTION'

TIME IS RUNNING OUT

AS a country we are really running against time.

We need things to happen now or else we will all be accused of misleading the nation.

His Majesty King Mswati III has championed Vision 2022, which is targeting the kingdom to be amongst the developed nations by the year

His vision is based on a 25-year development programme known as the National Development Strategy (NDS) crafted and endorsed in 1997.

The King borrowing from the strategy before the turn of the century pushed government to deliver on infrastructure projects known then as Millennium Projects.

These delivered the Mavuso Exhibition and Trade Centre, which also includes the Sports Centre, improved road network, in particular, the Ngwenya to Manzini Highway (MR3), the King Mswati III International Airport and factory shells to name but a few.

Currently, we have as part of these projects the International Convention Centre and Five Star Hotel, which is on schedule to be completed in July 2020 plus the Sikhuphe to Manzini Highway and the Royal Science and Technology Park (RSTP) still under construction.

Projects

Also coming along these projects has been the development of the Lubovane Dam, as part of a big Lower Usuthu Smallholder Irrigation Project (LUSIP), which has benefitted thousands of otherwise disadvantaged communities.


Whilst some of the projects have been completed like the Mavuso Exhibition and Trade Centre and the King Mswati III International Airport, they have hardly justified the investment in terms of expected economic returns. Their below par performance has created huge doubt that even the upcoming projects may end up not living up to their expectation hence becoming huge losses.

So in short, what we have achieved so far as a country has been the change in landscape, but meaningful economic growth and standard of living has not improved.

Worse still is that corruption has meant that the construction of these projects has become so expensive that it is starting to take resources meant for key social services like health, education and resulted in food insecurity.

Late former United Nations Secretary General Kofi Annan had coiled it better when he said: "Corruption hurts the poor disproportionately – by diverting funds intended for development, undermining a government's opinent, unaction of the provide basic services, feedaning inequality and injustice, and dis-

...the biggest question we need to ask ourselves is; what will happen if we get to 2022 and discover that we have done nothing



couraging investment and aid."

His Majesty the King also speaking about the same subject in 2006 in his inaugural address to Parliament said: "If left unchecked, corruption destroys our economy and reverses the gains of the past."

Amidst many of the well-intended projects we have embarked upon as a country, we have continued to struggle to control the scourge of corrup-

It has indeed reversed the gains of the past and continues to undermine the lives of the poor.

We have as evidence today a road project that has stalled with literally nothing to show for the millions of Emalangeni poured into it. What holds a nation together is hope plus action! It is dangerous to give people hope and no action, hence I say we are really starting to run out


By 2022, we need to be careful and refrain from using the current economic situation as an excuse for not delivering on our promises. We need to explore every option now to deliver on our promises.

THE MARRIAGE BILL 2019

Recognised marriages

5. (1) Subject to subsection (2) and section 6, a marriage shall be either -civil marriage; or

(b) customary marriage.

(2) A marriage contracted in a foreign country in accordance with the laws of that foreign country where one or both of the parties is subject to the laws of that country, shall be recognised in Eswatini as a valid marriage.

(3) The provisions of subsection (2) shall not apply in respect of any marriage that is, and to the extent that it is inconsistent with the principles of humanity or morality as recognised in Eswatini or Eswatini Law and Custom.

(4) For the avoidance of doubt, all marriages recognised under this section have the same legal status.
(5) Without prejudice to any procedures prescribed for marriages under this Act, any other institutions or practices which traditionally facilitate a marriage shall continue to be recognised.

Powers of minister to recognise other types of marriages

6. (1) A person, body or denomination may apply to the Minister in writing to have a form of marriage referred to in section 5(2) be declared a recognised marriage in Eswatini. (2) An application under subsection (1) shall be in the prescribed form and shall set out all the particulars of the form of marriage, its essential elements and the required procedure.

(3) The minister may allow the application but the Minister shall notify the party concerned by notice published in the Gazette and at least in one newspaper circulating in Eswatini.

Cohabitation.

7. (1) Cohabitation shall not, by itself, constitute a marriage or give rise to a presumption of marriage under this Act.

(2) Notwithstanding subsection (1), the following provisions shall have effect in relation to the rights of the parties to the relationship of cohabitation.

(a) One or both of the parties may, during the subsistence of the cohabitation register the particulars of any monetary and non-monetary contribution each party may have made during the cohabitation with the office of the registrar;

(b) Where the parties cease to cohabit, a court on application by either or both of the parties, shall distribute the property in accordance with the registered amounts of contribution made by either party;

(c) Failure to register shall not affect the rights of the parties but the burden to prove the facts of cohabitation or any contributions made shall be on the party alleging the existence of those facts;

(d) Where the court is satisfied that

the parties cohabited, and that there was some contribution, the court may distribute the property equitably between the parties.

(3) The particulars of the monetary and non-monetary contributions referred to in subsection (2) shall be in a prescribed form.

(4) For the avoidance of doubt, the rights conferred by this section on persons cohabiting are available only to persons who have the capacity to get married to each other under any marriage recognised under this Δct

PART III ESSENTIAL REQUIREMENTS OF MARRIAGE

Minimum age of marriage

8. (1) A person shall not have the capacity to marry unless that person has attained eighteen (18) years of age.

(2) A person who is twenty-one (21) years of age and of sound mind may, with the free, full and informed consent of that person, enter into a valid marriage in accordance with this Act.

Consent to marriage.

9. A marriage shall be entered into with free, full and informed consent of the parties to an intended marriage subject to information on the legal and proprietary consequences provided under the law governing matrimonial property.

Widow or widower marriage restric-

10. (1) A widow or widower with minor children from a previous marriage may not marry unless the law regulating the administration of the estate of the deceased is complied with.

(2) A relative of the deceased may marry a widow or widower where both that man or woman and the widow or widower, with their free consent, adopt any form of marriage provided for under this Act. (3) Any person who contravenes this section commits an offence and is liable, on conviction, to a fine not exceeding two thousand Emalangeni (E2, 000) or imprisonment not exceeding one (1) year or both.

Prohibited degrees of relationship

11. A person shall not be a party to a marriage where the other party is related to that person within any of the degrees of relationship set out in the First Schedule to this Act.

Status of parties

12. (1) A party intending to contract a marriage under this Act, except a party already married under a customary marriage or converting a marriage under Section 37, shall first prove by way of a declaration before a marriage officer that that party is not a party to any other subsisting marriage.

(2) Except with the written approval of the minister, the party intending to contract a marriage under this Act shall be a citizen of Eswatini or a person lawfully resident in Eswatini or in possession of a residence permit or a temporary residence permit issued in terms of the immigration laws.

Status of marriage

13. (1) A marriage under this Act may either be—

(a) a monogamous or polygamous customary marriage; or

(b) A civil rites marriage contracted with or without community of property.

(2) Parties who marry in community of property may -

(a) Elect to bring to their joint estate some or all of their assets without encumbrances acquired by them before the marriage; or

(b) Elect that only assets acquired by them after the marriage should form part of their joint estate.

(3) Parties who intends to marry out of community of property shall execute an ante-nuptial contract before a notary public prior to the solemnisation of the marriage.

(4) Parties who marry out of community of property are entitled to share in the assets of each other in the event of death of one of them. *Mixed marriages forbidden*

14. (1) A party married under a polygymous type of marriage shall not convert their marriage to a monogamous marriage.

(2) A party married under a potentially polygymous marriage may, subject to Section 37, convert the marriage to a monogamous marriage.

Void marriages

15. (1) Subject to the provisions of this Act, a marriage shall be null and void if contracted in contravention of any of the provisions under this Part.

(2) A person who goes through a marriage ceremony knowing that the marriage is void under this section commits an offence and shall, on conviction, be liable to a fine not exceeding two thousand Emalangeni (E2 000) or to imprisonment for a term not exceeding two (2) years.

Voidable marriages

16. (1) Where one of the parties to a marriage -

(a) Is pregnant by or is expecting a child with another person at

the time of the ceremony and the fact is unknown to the other party;
(b) Refuses to consummate the marriage for a period of three

months from the date of the marriage;

(c) Is unable to consummate the marriage within nine months; or (d) Is permanently impotent, the injured party may, at the option of that injured party, apply to a court

to nullify the marriage.

(2) A marriage contracted in terms of this Act shall be voidable by virtue of non-registration within the period prescribed under the law applicable to registration of mar-

riages.

(3) A voidable marriage is for all purposes a valid marriage until it is annulled by a decree of a court.

COUNTRIBSWITERINGS BEST TO BE A WOMA

NORWAY and Switzerland are the best countries to be a woman and Yemen and Afghanistan the worst, said research on Tuesday which found the state of women's rights is not "all doom and gloom" around the world.

While life for women has improved in some 60 countries, it has deteriorated in Yemen and other war-torn nations, research organisations Georgetown University's Institute for Women, Peace and Security and Peace Research Institute Oslo concluded.

The researchers looked at 167 countries since 2017 when the first Women, Peace and Security Index was compiled, weighing variables such as access to bank accounts, jobs and

Rounding out the top of the list were Finland, Denmark, Iceland, Austria, United Kingdom, Luxembourg, Sweden and Netherlands tied for ninth place, followed by Canada.

At the bottom were Yemen, Afghanistan, Syria, Pakistan, South Sudan, Iraq, Democratic Republic of the Congo, Central African Republic, Mali and Libya.

"There are important areas of progress. It's not all doom and gloom," said Jeni Klugman, Managing Director of the Georgetown Institute and lead author of the index.

Gains were strongest in women's access to financial accounts, either mobile or at conventional banks, in fewer discriminatory laws and through increasing legislative representation.

"A national election can bring about big changes, both positive and negative," Klugman told the Thomson Reuters Foundation.

"We have a number of countries which boosted the share of women in their national Legislatures. We also had several countries which went the other way," she added.

Iceland lost its top spot from 2017

after elections brought a drop in the number of women in Parliament.

The United States inched up to No. 19 from No. 22 two years ago, in part due to 2018 elections when a record number of women were elected to Congress. But Klugman said the United States continues to lag in the area of domestic violence.

The research is intended to inform and inspire action, Klugman said, noting that the factors it weighed are integral to the global development goals adopted unanimously by the United Nations in 2015. "It's not like it's something we invented out of thin air. It's something which is grounded in those long, hard-negotiated agreements, so we're holding them to account for

The UN adopted 17 goals, including gender equality and an end to hunger, poverty and other ills, to be achieved by 2030.

The new research found deterioration in women's lives was often linked to security, which worsened in almost 50 countries.

As to legal reforms, Moldova moved up 22 places owing to changes in its sexual assault laws.

Saudi Arabia persisted in having the most extensive legal discrimination against women, followed by Yemen, Sudan, the United Arab Emirates and Syria.

The report said legal discrimination means about 2.7 billion women globally are restricted from working in the same jobs as men.

ASKING for a pay rise can be stressful.

Many of us wince at the prospect of talking about money, and placing a value on your workplace contribution can be tricky.

But the idea that women in particular shy away from these tough conversations has been challenged by new research.

The report by the Cass Business School and the Universities of Warwick and Wisconsin finds women are just as likely as men to ask for a pay rise. It also finds that they are less likely to get one.

Found

The study found that men were 25 per cent more likely than women to get a pay rise when they asked. It also dispelled the myth that women are reluctant to request a salary increase because they worry about their relationships with their managers and

of Warwick, says the findings support the existence of bias against women in the workplace. "Having seen these findings, I think we have to accept that there is some element of pure discrimination against women," he told the BBC.

The gender pay gap

The gap between women and men securing a pay rise when they ask for an increase is one factor in the disparity between men and women's

overall remuneration.

The 2015 Global Gender Gap Report shows the extent of the pay gap between men and women.

In 2006, men were earning on average \$5 000 more than women. By 2015 that gap had doubled to \$10 000. The Global Gender Gap Report shows a quarter of a billion women have entered the global workforce since 2006 but they are only earning on average what men did 10 years

ago. Younger workers close the gender gap. This latest study did identify one positive trend.

The study found that in workers below the age of 40, there was no difference between women and men when it came to asking for and receiving a pay rise. The researchers concluded that this could lead to a shrinking in the gender pay gap as these younger women progress through their careers.

Agriculture ministry gets more Extension officers

According to the ministry of agriculture, government has approved the employment for more Extension officers, a move that will approve the field at grassroot level.

Minister of Agriculture Jabulani Mabuza revealed this during the National Agriculture Extension Review and Planning conference held at Mphophoma on Thursday, and added that they were hoping to get more when the country's economic situation improves.

He said government was responding to their engagement with respect to having more extension staff employed in order to improve the declining number of those available to help farmers drive the economic growth of the country at grassroots level.

Desire

"We will continue pursuing this matter with the hope of eventually being allocated a reasonable number to continue supporting our farming communities.

"I want to mention that it is our desire to see extension service delivery becoming relevant and responding to the everyday needs of farming communities. This is with regards to the technical capacity, skills as well as the adequacy in numbers," he said.

The minister also highlighted that innovative ways of adequately reaching the farming community without having big numbers of Extension officers be one of the outputs of the

"I am of the opinion that one Extension officer is adequately capacitated and empowered with relevant working tools that can service one Inkhundla centre. Please consider this and come with recommendations for consideration by ministry management," he said.

He added that the Agriculture Extension Review and Planning Conference was an essential annual activity and a foundation of the Eswatini's agriculture extension delivery system and process.

He said this was because it brought together all the different players in extension and message delivery system to brainstorm and agree on how they will work together in harmony, analyse the prevailing situation with regards to challenges of farming and then agree on the types and quality of interventions that are to be packaged for use by farmers.

"This conference also provides an opportunity to interrogate the adequacy and relevance of the interventions that are intended to meet the demands of the clientele of the extension service.

I have therefore been reliably informed that today's function is the last step in the chain of events. I have also been told that today's participants are; the farmers, National level extension practitioners, agriculture input suppliers, and processers, Academia, Farmers' organisation and NGO community," he said.

He also mentioned that agriculture extension is an important and indispensable activity in support to the development and economic prosperity of the people of Eswatini. The sentiment is well expressed in the specific responsibility that govemment has placed on the ministry of agriculture.

It is important for the public to be aware of how we can assist in resolving non-bank financial services complaints, and, as such, we have compiled these frequently asked questions for anyone who would like to get in touch with us before the year ends or in the near future. Do you offer loans?

We do not offer loans or any financial service product.

Why 'Ombudsman'? Surely it should be 'Ombudslady' or 'Ombudsperson'?

The term 'Ombudsman' is used globally to refer to an independent official or office that is established to investigate complaints. More so, we are of the notion that 'man' in Ombudsman refers to humanity, as opposed to a male or female distinction.

In Siswati the office is called Umlamuli Wetindzaba Tetimali, and the term 'Umlamuli' in this case is an interpretation or translation of 'Ombudsman.' This means that the Ombudsman or Umlamuli serves as a judge who resolves non-bank financial services disputes outside of the courts.

How much do you charge for your services? Our services are free! You do not have to pay us to lodge a complaint and we do not take any portion of the money that can be paid to you as we are here so that money is not a barrier for someone to get assistance.

What would you advise us to do about money schemes, like the ones we are invited to join on WhatsApp?


We do not offer financial advisory services and cannot advise you where to place your money. We only deal with complaints against nonbank financial services providers (FSPs) who hold a licence issued by the Financial Services Regulatory Authority (FSRA). The FSRA encourages EmaSwati to only deal with licensed entities and you may contact them to confirm if a business/individual is licensed, as the FSRA is responsible for regulating players in the nonbank financial services industry. How does the Ombudsman go about resolving my complaint?

We exist to investigate complaints against nonbank FSPs in Eswatini that are licensed by the FSRA. Members of the public can lodge a complaint at our office by following these steps: 1. Contact your FSP first and submit a written complaint giving them 30 days to respond. If you do not get a response or you are not satisfied with their response, that is when you can come to our office with your complaint

2. Fill in a Complaint Form that you can access at our office, a CMAC office near you or on our website, www.ombudsfs.org.sz

of Oaths and attach all supporting documents Our officers then work towards facilitating or mediating an agreement between the parties. Where no settlement is reached, the Ombudsman makes a final and binding decision which is the equivalent of a court judgement.

THE OMBUDSMAN

What certainty do I have that the Ombudsman won't favour the FSP because they have more power and money?

One of the functions of the Ombudsman is to encourage FSPs to abide by the rules of their relevant industry codes of conduct, and we would therefore view their use of power and money as unjust. Additionally, we value our independence and commitment to handling complaints without taking sides and we only consider what is fair and reasonable in each case, which aligns with the mandate in our slogan to be "Free, Fair and For All."

We were not aware that your Office exists. How do you educate the public about the work you do?

The Office is relatively new, having started operating as the Ombudsman of Financial Services in 2016. We have been working to increase public awareness about the Office

This year for example, we engaged in numerous outreach activities, such as the Buhleni and Hlane Buganu festivals; we attended the Utech and Waterford Career Fairs; and engaged in several FSRA outreaches including regional roadshows and visiting Tinkhundla centres across the country.

We also feature periodically on print media such as the Swazi Observer and The Financial MarketPlace. We are working to grow our radio presence so that people in the most remote areas of our country can hear about us. PM Johnson rejects no-deal Brexit in election pitch

LONDON - British Prime Minister Boris Johnson drew an angry backlash from Brexit Party leader Nigel Farage on Saturday after he rejected calls to drop his Brexit deal and embrace a clean break from the European Union, potentially splitting the eurosceptic vote.

Johnson had previously pledged to take Britain out of the EU with or without a deal on October 31, before lawmakers voted to force him to seek an extension until January 31.

But he has abandoned the threat of a no-deal Brexit in his Conservative Party's manifesto for the December 12 election, the Times newspaper reported on Saturday. It added that the focus would be on getting his Brexit deal approved.

On Friday, Johnson rejected a call from the Brexit Party to drop the deal he negotiated with the European Union last month in order to form a new electoral pact, saying that he could put his deal through parliament after any election

"What we've got is a fantastic deal that nobody thought we could get,' Johnson said. "As soon as we get back in the middle of December, we can put that deal through."

In Britain's tortuous journey since the

2016 referendum vote to leave the EU. businesses and economists have cautioned that leaving the bloc without a deal to smooth the transition would hurt the British economy.

Proponents of a no-deal Brexit say it provides a clean break from EU rules and regulations.

"If The Times are right and Boris Johnson will abandon a clean break Brexit, and he wins an election on this, we will never be free of EU rules," Brexit Party Leader Nigel Farage said in a tweet.

"The deal is simply not Brexit and does not get Brexit done." Reuters





KHAMA DENIES CLAIMS HE OPENED OFFSHORE ACCOUNTS


JOHANNESBURG - Former Botswana president Ian Khama has denied allegations that he instructed the Reserve Bank of Botswana to open offshore accounts now linked to South African businessperson Bridgette Motsepe-Radebe and terrorism.

In an affidavit deposed in the case of arrested intelligence agent Willeminah Maswabi, investigators said Khama issued the instructions in 2008 when he assumed office.

However, the former stateman's lawyers have accused government of a clandestine conspiracy to assassinate his character. Affidavits before the Gaborone High Court said in 2008 that three intelligence accounts were created by the Reserve Bank of Botswana, with the instruction of Khama and then-director general of intelligence Isaac Kgosi.

The affidavit said in 2009 that funds from one of the accounts were transferred to HSBC Bank in Hong Kong with the intention to purchase intelligence equipment. EWN

CHINA READY TO WORK WITH ASEAN



Mueller interview notes obtained by CNN

WASHINGTON - President Donald Trump and other top 2016 Trump campaign officials repeatedly privately discussed how the campaign could get access to stolen Democratic emails WikiLeaks had in 2016, according to newly released interview notes from Robert Mueller's special counsel investigation.

CNN sued the Justice Department for access to Mueller's witness interview notes, and this weekend's release marks the first publicly available behind-the-scenes look at Mueller's investigative work outside of court proceedings and the report itself. Per a judge's order, the Justice Department will continue to release new tranches of the Mueller investigative notes monthly to CNN and Buzzfeed News, which also sued for them.

A retelling of events from former Trump deputy campaign chairman Rick Gates, who served alongside campaign chairman Paul Manafort, is the fullest detail revealed by the Justice Department yet on discussions within the Trump campaign as it pursued damaging information about its Democratic opponent Hillary Clinton. The documents were stolen by the Russians, the American intelligence community has found.

"[Rick] Gates recalled a time on the campaign aircraft when candidate Trump said, 'get the emails.' CNN

Protesters block roads to Iraqi port

BAGHDAD - Security forces killed a protester and wounded 91 others in Baghdad on Saturday, security and medical sources said, as tens of thousands of Iraqis gathered in mass anti-government protests in the capital and blocked roads leading to a major port. Protesters have been congregating in the capital's central Tahrir Square for weeks, demanding the fall of the political elite in the biggest wave of mass demonstrations since the fall of Saddam Hussein. Protests have accelerated dramatically in recent days, drawing huge crowds from across sectarian and ethnic divides.

They have been comparatively peaceful by day, becoming more violent after dark as police use tear gas and rubber bullets to battle self-proclaimed 'revolutionary' youths. Reuters

Lebanon seeks to solve 'complications'

BEIRUT - Lebanon's president said on Saturday he will soon set a date for formal consultations with lawmakers to pick a new prime minister following Saad al-Hariri's resignation this week, but is working to resolve some complications first. President Michel Aoun is obliged to hold a formal period of consultations with members of parliament and designate the figure with the most support as the new prime minister who will be tasked with forming a government.

Aoun has not yet set a date for those consultations to begin, but said he had been making the 'necessary calls' to lay the ground for them to start.

Malawi court suspends 'colonial' wigs

LILONGWE - Malawi's Constitutional Court has suspended its requirement that lawyers and judges wear traditional white wigs and black robes in the courtroom as an early season heatwave sweeps the southern African nation. Temperatures in some parts of the country have hit 45 degrees Celsius (113 degrees Fahrenheit) last week, the country's Department of Meteorological Services said. Malawi, a former British protectorate, still follows the British legal system, with the wearing of wigs and robes a requirement for judges and lawyers. But Chikosa Silungwe, one of the lawyers in court this week in the capital, Lilongwe, said the heatwave was making the court's work challenging.

Egypt pays allegiance to Islamic leader

CAIRO - Egypt's Islamic State affiliate, Sinai Province, has sworn allegiance to the new leader named by the group following the death of Abu Bakr al-Baghdadi, the affiliate said on Telegram on Saturday. Sinai Province, which has waged an insurgency against the Egyptian state, posted pictures of around two dozen fighters standing among trees, with a caption saying they were pledging allegiance to Abu Ibrahim al-Hashemi al-Quraishi. Quraishi was named on Thursday in an audio message that also confirmed Baghdadi's death and vowed revenge against the United States. US special forces killed Baghdadi in a raid in northwest Syria.

ZUMA FILES COURT PAPERS TO APPEAL RULING ON STAY OF PROSECUTION

DURBAN - Former president Jacob Zuma filed court papers on Friday amid panic that he would miss the deadline to apply for leave to appeal the Pietermaritzburg High Court ruling against his application for permanent stay of prosecution in the arms deal matter.

NPA Spokesperson Natasha Kara confirmed on Saturday that Zuma filed the papers exactly on the cut off date. His legal representatives would not comment.

"I can confirm that Zuma had filed his application for leave to appeal," said Kara. However, she said she did not have a clue of the Zuma's key argument in the papers.

"You will have to wait for Monday as the papers will be with the register of the High Court in Pietermaritzburg," she said. Zuma indicated his intention to appeal the ruling, which the High Court judges judges Bhekisisa Mnguni, Thoba Poyo-Dlwati and Esten Stevn delivered on October 11.

The high court ruling had quashed his hopes of escaping prosecution on charges of racketeering, money laun-

dering, fraud and corruption stemming from the R30 billion Arms Deal of

He is accused of having accepted a bribe from French arms manufacturer Thales in 2005. When contacted, Zuma's spokesperson Vukile Mathaba said he was not sure if lawyers had managed to file papers before the court closed on Friday. He said he was still trying to get hold of attorney Dan Mantsha to establish if the documents

had been filed. Mantsha did not reply to text messages sent to him and he also did not answer his phone.

When contacted, Zuma's advocate Thabani Masuku said: "I am bound by ethics not to speak on this matter".

"My attorney is the only one who can give interviews and answer media inquiries. I am sorry that Mantsha is not answering. I will speak to him," said Masuku.

DA FEDEX TO MEET URGENTLY

JOHANNESBURG - The Democratic Alliance (DA) has announced that its federal executive (FedEx) will 'urgently' convene a meeting 'in order to assess the impact' of Herman Mashaba's resignation as mayor of the City of Johannesburg and 'ensure political stability' and how the part responds 'in the best interests of the' city's residents.

In a statement following Mashaba's announcement that he would resign as mayor of Johannesburg, DA national spokesperson Solly Malatsi said the city is better today 'than it was three years ago'. Malatsi said the DA respects Mashaba's decision and wishes him 'all the best with his future endeavours'. 'The resignation of Mr Mashaba as Mayor of Johannesburg does not signal an end to the DA's commitment to the people of Johannesburg and South Africa," Malatsi said.

He said the DA and its coalition partners in the Johannesburg council have made significant progress in turning the city around 'specifically in the areas of unlocking opportunities, stopping and acting against corruption, and accelerating the delivery of quality services'.

Malatsi listed a number of areas he said the DA-led multiparty coalition government 'has made huge progress in' within three years, which include the recruitment of 1 500 Metro police officers 'to assist in the fight against crime' and 'he city's newly established corruption busting unit', which he said 'has recorded over 5 335 cases worth more than R34 billion in transactions'.

DA review report calls accepting EFF support a 'mistake'

JOHANNESBURG - This is one of the recommendations contained in a review panel report on the state of the organisation.

The document and findings were discussed at the DA's two-day federal council meeting in Johannesburg over the weekend. A total of 155 delegates gathered for the party's highest decision-making body outside of the federal congress to receive the report. The report was put together by former leader Tony Leon, former CEO Ryan Coetzee and Capitec founder Michiel le Roux.

An assessment of the DA was called for following its poor showing during the May 2019 general elections. The party failed to grow its national support base.

"While appreciating the complexity and difficulty of the decision at the time, our view is that forming governments with the EFF's support in Johannesburg and

Tshwane was a mistake," the panel suggested in the report. It cited two major issues with the decision, saying their own DA governments were unable to implement a DA agenda as they were beholden to the red berets and that it was corrosive of their own party brand to rely on the EFF's support, given that party's policy agendas, philosophy and behaviour.

Sharing her thoughts on this position, newly elected federal council chairperson and former leader Helen Zille seemed to agree with the call for the DA to assess this relationship.

"They said that it's very difficult to govern with people who don't share your core values and that it's very important to do that assessment of the impact on service delivery and on the broad set of voters because that is who we are fundamentally accountable to," said Zille.

DA criticises MEC's R51m spending on life skills courses

department of social development spent more than R51 million on unaccredited training courses in the 2018/19 financial year as part of its Youth Development Programme, DA MPL Refiloe Nt'sekhe said in a statement yesterday.

"This was revealed to me by the Gauteng MEC for social development, Thuliswa Nkabinde-Khawe, in a written reply to my questions tabled in the Gauteng Provincial Legislature," said Nt'sekhe.

Nt'sekhe made no mention of the fact that Nkabinde-Khawe had passed away in hospital on Friday evening.

According to Nkabinde-Khawe, Nt'sekhe said, the department had trained 53 780 youth as part of the Youth Development Programme to be "empowered with life skills and technical training".

However, said Nt'sekhe, life skills

JOHANNESBURG - The Gauteng training, which the department defined as a 'soft skill' was meant to enhance one's interpersonal skills such as communication, teamwork and problem solving, and was not accredit-

"The reasons given by the department on why life skills training is not accredited are: these courses are of short duration and are meant for capacity building and life skills; cost implications; basic preparation for the workplace; and basic training and attendance certificates are sufficient for entry level jobs."

He said it was worrying that the department was spending millions on unaccredited courses, "yet our youth lack the essential skills needed in the employment sector".

"The youth will benefit more from skills that will increase their employability and enable them to sustain their lives.

Mashaba using Zille as excuse to get out before being exposed - ANC

JOHANNESBURG - During a media briefing in council chambers last Monday, Mashaba announced that he would step down.

His announcement was made shortly after Helen Zille was elected the DA's federal council chairperson.

But in a statement issued on Monday, regional spokesperson Jolidee Matongo said Mashaba's resignation had very little to do with Zille's election.

"His resignation is informed by the dire financial crisis that he has plunged the City of Johannesburg into," Matongo said.

"Mashaba is running away from the soon-to-be-exposed truth that the City of Johannesburg is broke and may not be able to finance the day-to-day basic costs of providing water and electricity to Johannesburg residents, including paying salaries to

Matongo also labelled Mashaba a 'sore loser', adding that he used Zille's election as an excuse to exit.

Meanwhile, the South African Municipal Workers' Union (SAMWU) said it welcomed Mashaba's resignation as it brought to an end his "reign of terror in which workers and unions have been victims". The union

said since Mashaba came into office following the 2016

local government elections, he undermined collective bargaining.

"Under Mashaba, there have been no sound labour relations, with the City failing to convene local labour forums," it said. The Citizen

DA wants Parliament's ethics committee to investigate Mantashe

This is despite Mantashe backtracking this week.


Mantashe had earlier said he had paid two Sunday World journalists R70 000 to quash a story over his extramarital affair with a Pretoria student Lerato Makgatho.

With Lukaku's penalty won by strike partner Lautaro Martinez, there were plenty of promising signs for Manager Antonio Conte as his project at San Siro continues to take promising shape. His side showed superb character to come from behind late on after Conte had fielded their youngest starting line-up (25 years and 266 days) in Serie A since August 2015. They are now also the only club left in Europe's

"We talked about what pressure is," revealed Erasmus, who has turned his team's fortunes around since taking over two years ago.

"In South Africa pressure is not having a job. Pressure is one of your close relatives being murdered," added the 47-year-old, set to step aside as coach and continue in his other role as director of rugby.

"There are a lot of problems in South Africa - which are real pressure.

Rugby shouldn't be something that creates pressure, rugby should be something that creates hope."

"(Gennady) Golovkin is not a challenge for me. If it's business, than why not?" Both fighters fought cautiously for the most part, with Kovalev content to use his jab from long distance and Alvarez looking to land hooks to the body.

The crowd at the MGM Grand booed on several occasions, unhappy with the lack of action. Alvarez was a 4-1 favourite despite moving up two weight classes to fight for a piece of Kovalev's 175-pound



"But in saying so, you know I think we should also have freedom of speech. We should be able to say what we feel and what we see."

Larsen believes the PSL can easily afford the use of technology such as Video Assistant Referee (VAR) and goal-line technology. Due to the recent incidents where poor officiating has been the order of the day, it is clear the League is facing refereeing crisis.

Pitso, Sirino facing more than one charge?

PRETORIA - Mamelodi Sundowns' legal and commercial Manager, Yogesh Singh has responded to the latest notice he's received from the Premier Soccer League's prosecutor, Nande Becker.

Pitso Mosimane received a letter last week from the PSL regarding comments attributed to him on match officials, while Gaston Sirino is currently being investigated for assault after an incident during Sundowns' clash against SuperSport United.

"Yes, I can confirm that I received an email on Friday night from Nande Becker. This notice deals with alleged statements made by our Head Coach, Pitso Mosimane after the Chiefs match and we are



required to respond in Five days to confirm or deny whether this statement was made or not," Singh said on Sundowns' official website. "We are being hit left, right and centre...so this brings to three the number of potential charges our Coach could be facing. But you never know because it seems that every time Pitso speaks there is a charge sheet in my Inbox. And then there are two assault charges against Gaston Sirino."

"As Mamelodi Sundowns we do not ask that we be treated differently from other clubs but we do insist that we be treated fairly. I made a statement last week that fining coaches, clubs and club owners all over the show does nothing to address the real issue... which is that we need to deal with the poor standard of match officiating and look at ways to fix this. Sundowns and all the other clubs in the league want the same thing... fairness and consistency and we should work with the PSL and SAFA to find a solution to this as soon as we can," he added.

TOKYO - A stellar year for the Springboks was triumphantly crowned last night when the team collected the three top awards in the World Rugby Awards at a glittering event in Tokyo.

Rassie Erasmus was named as Coach of the Year, the Springboks were named Team of the Year and Pieter-Steph du Toit was named as World Player of the Year. The awards were rich reward for a year in which the Springboks completed the unprecedented double of winning both the

Rugby World Cup and the Rugby Championship in the same season. The team finished the year at No 1 in the world rankings, for the first time since 2009. The Springboks won 10 out of 12 tests, scoring 424 points and 52 tries and conceding only 138 points and 10 tries – only four of them in seven matches at the Rugby World Cup. Statistically, it was the most successful Springbok season since 1998 when the team was in the middle of a 17-match winning streak. It was the first time South Africa had won any of the top three awards since 2009. The titles came a little over 24 hours after the team had collected the

Rugby World Cup for the first time since 2007, with a 32-12 win over England at the International Stadium Yokohama in Japan. The Springboks were chosen in preference to fellow Rugby World Cup semi-finalists England, Wales and New Zealand and Japan. The Coach of the Year nominees along with Erasmus were Eddie Jones (England), Warren Gatland (Wales), Steve Hansen (New Zealand) and Jamie Joseph (Japan).

"It's a massive honour for me to accept this award," said Du Toit.

from the Bernabeu ahead of the potential arrival of reinforcements.


