

'We are engaging our counterparts'

MINISTER of Labour and Social Security Makhosi Vilakati has said they are in engagement with the Department of Labour and **Employment in South Africa to** get details of the scale of the truck drivers' strike and possible solu-

This was a response on the tension and violence allegedly perpetrated by the South African truck drivers on their foreign counterparts, including Emaswati.

Vilakati said a meeting was held at the level of ministers and senior officials of both countries. Their counterparts in South Africa confirmed the existence of the tension and sporadic violence between South African workers and foreign drivers and that a high level South African inter-ministerial committee has been established to try and resolve the impasse.

He said it was also shared in the meeting that there were criminal elements creeping in and exacerbating the complexity of the prob-

Some South African employers were said to be taking advantage of the vulnerability of the foreign nationals and preferred to hire them over South African drivers because they are cheap and also avoid paying social insurance contributions.

"Our ministry was firstly informed of the tension and violence on foreign nationals in early 2019 by a group of affected Emaswati truck drivers. The ministry was invited to a meeting of the concerned truck drivers in Manzini on the Saturday of 2019 Easter Holidays. The Emaswati truck drivers informed the ministry that South African workers were against foreign nationals, including Emaswati taking their jobs and that the perpetrators were resorting to violence and some lives have already been lost in the process. Further complicating the issue of non-South African drivers was that most did not have work permits and this exposed them to arrests in road-

blocks and subsequently losing their jobs and social insurance contributions. It was reported in the meeting that Emaswati drivers in the Republic of South Africa are about 20 000, most of them employed in the KwaZulu/Natal and Mpumalanga Provinces," stated Vilakati.

WORK PERMITS NEGOTIATED

The minister said negotiations were opened with the South African Government to regularise the employment contracts of Eswatini truck drivers in South Africa through work permits and also to ensure that all those who lost their jobs and contributions to social insurance schemes were fully compensated.

The South African Department of Labour and Employment indicated that the issue of work permits was under the jurisdiction of Home Affairs; their role in the issuance of these permits was advisory.

However, this did not mean a special dispensation agreement could not be negotiated.

"It was agreed that negotiation of such a special dispensation agreement will have to include a broad range of stakeholders, including the ministries of labour, home affairs, industry and trade, transport, security and foreign affairs as well as representatives of business and workers. Processes towards setting up a negotiation table between the two countries involving these ministries and stakeholders are on-going and at an advanced stage. Suffice to say, this matter affects all countries neighbouring South Africa and therefore it is also touted as an option to deal with this issue in the SADC employment and labour sector structure so that whatever agreement is finally reached speaks to all the affected countries," he said.

Minister of Labour and Social Security Makhosi Vilakati said they have been advised that the South African government was doing all it could to contain the escalation of violence and avert the impending blockade as this will affect the free

200 000 Emaswati threatened by violent SA's trucks strike

ABOUT 200 000 Emaswati might go to bed on a hungry stomach if the ongoing violent attacks on foreign truck drivers persist in the Republic of South Africa.

Chairperson of the Eswatini Drivers Association Sikhumbuzo Mkhulisi said if the on-going strike against foreign truck drivers persists about 20 000 of Emaswati will be jobless.

Worth noting is that the ratios state that one employed person feeds 10 people, hence 200 000 people in the country might go to bed on empty stomachs.

He said they tried to engage the government several times but till today they have not received any feedback.

"The last time we met the ministry at the beginning of August we were told that they were yet to meet with their South African counterpart on August 12, 2019," he said.

The president stated that if the situation worsen a lot of Emaswati are set to come back home.

" It is unfortunate that if they leave South Africa now they will leave their money and benefits behind as they will be trying to escape from the deadly

"It is painful that they will come back home and be jobless," he said.

Mkhulisi said the reason they left for South Africa was because they were not getting jobs in the country and there

are fewer job opportunities here,

Currently, over 1 000 Emaswati who were employed in South Africa are back in the country.

"Of which this month alone 10 000 people's lives will be affected.

"All these people who will come back home have families to feed and bills to pay," he said.

Mkhulisi mentioned that they had pleaded with the government to assist them in getting work permits and deduct at least E100 from their salary but till today nothing is happening.

The chairperson voiced out their concerns about the dragging of feet by the government as this situation could have been avoided.

Vilakati appealed to Emaswati to make efforts to obtain all the necessary documentation to work in South Africa and to further request those who were already employed as truck drivers to submit their employment details to their leaders for these in turn to be submitted to the ministry so as to have accurate data of the number of Eswatini drivers affected by the problem and negotiate for known and confirmed people.

flow of goods, trade and business between that country and its neighbouring states, including Eswatini.

He said since the violence and the blockade was planned and perpetrated from the South African side, Eswatini government had very little control on this save to appeal for patience to allow the negotiations between the two countries or the Southern African Development Community (SADC) multi-lateral discussions to start and be concluded.

"On the aspect of drivers who are already home and did not get their social insurance benefits but contributing, the South African Department of Labour and Employment assured our ministry that all those will be compensated in full upon submission of employment details. Those affected drivers may submit their details to the Principal in the ministry Thulani Mkhaliphi for onward transmission to the Department of Labour and Employment in South Africa," said the minister.

BUSINESS AS USUAL FOR INTERSTATE TRANSPORT

Despite reports of on-going protests and riots in South Africa against foreign truck drivers, public transport that travels across borders isn't affected.

Interstate Transport Association Chairperson Bambumuti Sithole said regardless of the violence, the bus ranks and stations they use were not affected. He added that their vehicles reached the final destinations as they normally did. Their customers were not affected as yet.

"It is business as usual for us. The trucks violence hasn't affected us as yet. Our vehicles reach the stations they are destined for. Marshals in the respective ranks will advise us should there be any need to stop the flow of transport to South Africa," stated Sithole.

MPs sold cannabis to go to Parliament

SOME MPs allegedly sold cannabis to be able to canvass for votes to get to Parliament.

This allegation was made by Ludzidzini Committee Members Neumbi Maziya and Mnguni Simelane.

This was revealed yesterday during the meeting held by Ludzidzini Committee and MPs who are members of the ministry of health's portfolio committee.

The meeting was held at Nkhanini Offices, Lobamba.

Maziya was the first to raise the allegation. His concern was whether their submissions on the subject matter would be considered by Parliament or not. He said the problem was that they could raise submissions that could not be favourable to the legislators because

they could have their own interest on the subject.

He said they knew that some MPs took advantage of the illegal cannabis trade to win the national elections for their respective Tinkhundla last year.

He said they had wasted their time in past incidents where their views were not considered because they expressed views that rubbed other MPs the wrong way

Meanwhile, Simelane raised concern about the security issues around cannabis licensing.

He said the way in which the consultations were moving was too fast. He suspected that there could be ulterior motives aimed at speedily concluding the whole process, without carefully considering the security aspect of cannabis farming.

Simelane, who is the secretary of the committee, said it could be possible that some MPs were pushing the process so that their interests could be served by making it easy for them to be granted licences to grow cannabis.

He said it was possible that some MPs made it to Parliament because they took part in illegally producing the cannabis.

He further said the country could be placed in a very bad position in the international community because the world would be looking at the country with a negative eye.

He said the people of the country could soon find themselves having difficulties to get into other countries just because cannabis was grown anyhow in the

He said the people could find themselves having to apply for visas when going to other countries. They would be subjected to serious searches when going to other countries just because they would have lost trust in the inter-

Trains to be affected by trucking industry strike

Eswatini Railway Communications Officer Sive Manana when speaking to this publication said so far, as people who move goods across countries they have not been affected by the strike action.

He said trains frequent the Durban to Eswatini route and if this strike

Eswatini is one of the countries benefiting through fuel imports from South Africa and will be affected should this take a longer time.

There will be fuel shortage. However, currently no crisis has been reported as a result of the sanctioning by Total South Africa.

The Ministry of Natural Resources and Energy Communications Officer Sikelela Khoza said as a ministry they couldn't comment until a crisis was reported.

"Currently no crisis of fuel shortage has been reported to us. For now this touches more on the fuel company itself, Total Eswatini. Please contact them first in this regard," said Khoza.

Another twist as Shongwe challenges Crown's legal team

MURDER suspect Sipho Shongwe's trial hit a snag yesterday when Shongwe's legal team challenged the legality of the Crown's Senior Counsel Michael Hellens.

Hellens who is well known for representing former South African President Jacob Zuma during his corruption trial was hired by the Crown in order to ensure that justice is served in the Victor Gamedze murder case and also ensure that the people responsible for this crime are found guilty as charged.

Hellens also represented Zuma's son Duduzane in his culpable homicide trial and has also represented the controversial Gupta family in South Africa.

This month the trial for Shongwe was allocated eight days as it was expected to start on Monday, break tomorrow and resume next Tuesday, ending September 13.

The matter couldn't continue on Monday as it was Umhlanga holiday.

Yesterday the matter was supposed to commence before High Court Judge Nkosinathi Maseko, however there were challenges which emerged between the

Upon coming back from the cham-



working on the matter at all as he is not an admitted attorney in the country.

The parties came back and packed their bags and left the High Court.

A message which was relayed to the officers from His Majesty's Correctional Services was that in the chambers it was explained that since Shongwe's legal team were challenging the government's advocate then an application addressing that issue must be filed.

Time

His Majesty's Correctional Services team were informed to bring Shongwe back to court today and they were told to try and keep time.

The officers were informed that today they must bring Shongwe before the court while the matter of the Crown's Advocate is dealt with then tomorrow (Thursday) the main case which is the murder case would continue.

The high profile case is now before Judge Nkosinathi Maseko who took over from seasoned Judge Mbutfo Mamba, who had recused himself from proceeding with it.

Shongwe on the other hand hired top South African lawyer Laurence Hodes to represent him in the murder case.

Hodes is known for handling a number of high profile cases including charges of corruption, fraud, racketeering and money laundering against the EFF's Julius Malema in relation to the R52 million contracts with the Limpopo Roads and Transport department.

Shongwe's trial had been going smooth all along as the Crown was parading witness after witness.

Yesterday's setback came unexpected and shocked everyone who had attended court with the hope of hearing what witnesses had to say.

Director of Public Prosecutions' Principal Crown Counsel Macebo Nxumalo confirmed that the case couldn't continue yesterday as Shongwe's legal team argued that the Crown was using an attorney who was not admitted.

Nxumalo said the Judge had ordered them to file papers with the legal structures which is something they were working on by yesterday.

Lucky Howe who is on Shongwe's legal team said they had indeed challenged the Crown's Advocate since he was not admitted to practise in Eswatini.

We are waiting for papers - Law Society

LAW Society of Swaziland Secretary General Thulani Maseko said the information at his disposal is that the attorney in question is yet to submit papers with the Law Society as per the court's directive.

Maseko said it was procedure for everyone coming from outside the country to be formally registered with the Law Society in order to practice in the country's courts just like is the case with other countries like South Africa.

Maseko said he was advised that the attorney was ordered to serve them with

papers to see if he could practice in the

The attorney would also be expected to submit his application with the Attorney General.

According to the International Commission of Jurists (ICJ) the High Court is the body that admits advocates and attorneys to practice.

It is said applicants must first serve a copy of his or her petition to practice on the Attorney-General and the Secretary of the Law Society.

The latter two provide certificates to

this effect, which are essential for the application to the High Court. According to the ICJ the certificates usually record non-objection to the petition; if there are grounds for opposition, they are filed with the court for argument. The ICJ states that a person who is neither a citizen nor a resident of Eswatini may seek permission to appear as counsel or attorney and to do so; they must apply to the Attorney General and the Secretary of the Law Society.

The Chief Justice takes the decision on the right of audience, for each case.

Eswatini cannabis might not be regulated

THE illegal cannabis currently grown in the country might not be regulated by the regulations currently in Parliament.

This might leave the illegal cannabis growers in the bushes, where they are currently plying their illegal trade. This transpired yesterday When Ministry of Health Legal Advisor Zandile Dhlamini (nee Mkhwanazi) educated the Ludzidzini Council about cannabis.

She said cannabis was divided into two. The two categories were Cannabis Indica and Cannabis Sativa. She said the Cannabis Indica was the one they were focussing on because it had the potential of making medicine that could have health benefits.

She said Cannabis Sativa could be used for industrial purposes,



where clothes and building material could be made.

The committee members, after Dlamini's presentation, wanted to know the category in which illegal cannabis grown in the country was found. The ministry of health officials gave no answer. They stated that they did not know about the cannabis because it was still illegal. They could not research about something that was still illegal.

Ministry of Health Deputy Director of Pharmaceutical Services Fortunate Bhembe told the Ludzidzini Committee that if they were to research on the cannabis, they could be arrested. They could be forced to state why they went to illegal fields to do research on illegal plants.

She said the regulations were made to allow them to conduct research on the plants so that they could give an answer on the kind of cannabis

the country had. She said for now, they did not know whether the cannabis to be regulated was the one illegally grown in the country or not. She said it could be possible that its seeds could be import-

She said for now, the cannabis was still illegal and people who participated in growing it would be jailed. Chief Mdlaka Gamedze and Ludzidzini Council Member Sobantu Dlamini called for research on the cannabis to be conducted because the cannabis in the country could

Dlamini openly stated that at Nkhaba, his home area, the illegal cannabis was grown and he believed that if people constantly used it, they would end up not being negatively affected.

ESRIC WORKERS ON SECOND WEEK OF STRIKE

EMPLOYEES of the Eswatini **Royal Insurance Corporation** (ESRIC) have entered the second week of their protest.

The strike action which started on August 27 has seen the corporation complaining that they have suffered in millions of Emalangeni in delayed transactions. The employer also complained that the picketing workers were disturbing operations as they picket at the entrance of the company's premises. There was a disagreement on the designated area to be used by the picketing workers, which led to the company taking the workers to court. The Industrial Court ruled that the employer must meet with the aggrieved workers on the

place to be used for picketing.

The meeting was expected to take place soon after the Industrial Court ruling, but that never happened as the union leaders claimed that the company has been avoiding having a meeting with them. The employees are represented by Swaziland Union of Financial Institutions and Allied Workers (SUFIAW) which is negotiating on their behalf. Yesterday, SUFIAW General Secretary Jabu

Shiba said employees continued with their picket and they will do so until their demands are met.

Shiba said the only thing that they have agreed on with the employer was the area of picketing, which is something that the parties were arguing about in court last week.

ESRIC informed the court that the company had suffered a major blow because of the strike action as millions of transactions which were meant to be made to clients were delayed. The company through its lawyer said last Tuesday cash in transit personnel were blocked by picketing personnel. The employees who are on strike are complaining that the company is denying them ablution facilities. Hence, they have to use nearby facilities. Meanwhile ESRIC Marketing Manager Sizwe Shongwe said they have no power to stop the strike. He said the issue of ablution facilities is not that much of an issue because it is standard procedure that striking workers are not allowed inside company premises.

FALSE PROPHET TO SPEND 15 YEARS IN JAIL FOR RAPE

A 'false prophet' was sentenced to 15 years imprisonment without an option of a fine for raping a 23-year-old woman, whom he deceived by pretending to remove to tikoloshi in her body.

Velezweni Vusi Mngomezulu (44) of Mbelebeleni was sentenced by Manzini Principal Magistrate David Khumalo on charges of contravening the Sexual Offences and Domestic Violence (SODV) Act of 2018 by having sexual intercourse *Primrose under the false pretence that he was removing evil spirits that prevented her from getting married.

Court records were to the effect that Mngomezulu approached his victim while at Ntondozi and he told her that he was a prophet and that his divine powers suggested that she was unlucky in life.

The accused person is alleged to have informed Primrose that if she did not let him help cast out the tokoloshi in her body, she would have misfortunes and more to tokoloshi's would invade her body.

Also, Mngomezulu allegedly told his prey that if it were not for the bad spirits following her, she would have long been married and the bride price would have been paid to her family.

Out of curiosity and wish to be fortunate in life, Primrose believed him. To proceed with the plan to help her, Velezweni allegedly told her to buy some Vicks, xxx sweets, Sprite fizzy drink and water which he would use to make a concoction to be used in the ritual. Since this was their first time meeting, the two are said to have exchanged contact details and planned to meet the following day. Before departing, Velezweni is said to have warned Primrose against spreading the news of his powers to heal as this would result in her not being healed.

Indeed, in the morning of the next day, Velezweni is sad to have called Primrose to ask if she had bought the items, only to find that she had not purchased them.

After a while, Mngomezulu is said to have called Primrose again and told her that he would buy the items himself and that she should avail herself at a local bus station where the ritual would be performed. Truly, he is said to have come with the items when they met at the bus station.

There, he allegedly told Primrose that the spirits told him to perform the ritual under a certain tree and when they got there, he allegedly instructed Primrose to hold the items while he prayed. After this, he then ordered her to sit down while he sat next to her.

The accused person then took the water bottle and shook it and while at it, he allegedly told Primrose that he could see that her illness was in the form of a tokoloshi which was moving from her chest down to the stomach. He mixed the xxx sweets and Sprite and told Primrose to apply the Vicks on her private part as the tokoloshi had entered her body through it. She was later made to drink the sweets, Sprite and water concoction, which is said to have been meant to aid flush out the tokoloshi through her private parts. After following this order, Primrose said she was then told to remove her pants and underwear and lie facing upward as the imaginary tokoloshi was supposed-

ly about to leave her body. After she complied, Primrose said she was told to change positions and she duly obeyed. "He said when the evil spirits came out I would feel vaginal fluids. He started massaging me when he asked if I felt anything but I told him that nothing was happening." she said. "Mngomezulu told me that my system was difficult so he would have to help me by inserting his private parts. He then imposed himself on her. "He said I would see the tokoloshi in a form of a short man. After inserting his private parts, he said felt the tokoloshi coming out," Primrose said. After this encounter, Velezweni showed her some fluids from her body and claimed that there were tokoloshi

"I told him that I did not see the supposed eggs and he told me that I could not see them because I did not have divine powers. He then ordered me to give him E150 with which he would purchase special oils that I would have to continuously apply to complete my stated healing," Primrose, An additional E15 for the items purchased was also requested from the rape survivor. "Had it not been for that he promised me to be fortunate and be married, I would have not allowed him to do what he did to me," she added.

Primrose said she only felt violated a day after the incident as she suspected that all the promises made by Velezweni were empty. It is then that she informed her mother about it and it was reported to the police.

When given the oppornunity to state his defence before judgement was meted out, Velezweni opted to remain silent. *not her real name

MAN (33) GETS 30 YEARS FOR RAPE

A 33-year-old man will be a pensioner by the time he finishes serving his 30-year sentence in jail.

*Sipho Dlamini of Ekutsimuleni area was arrested and charged with two counts of contravening the Sexual Offences and Domestic Violence (SODV) Act of 2018.

According to court records, Dlamini had sexually violated two of his relatives aged 11 and 56 in different incidents. The two offences were committed between October 2018 and February 2019.

Manzini Principal Magistrate David Khumalo presided over the matter.

In the rape of the 11-year-old who is his cousin, Dlamini is said to have snatched her from her parental home where she was with two other children and her mother.

The 11-year-old *Thembela told the court that on October 4, 2018, she was at home in a cooking hut with two other children.

While there, Thembela said her cousin; Dlamini entered the hut where he warmed himself next to the fire

A while later, the minor said the accused went out of the hut and while outside, he met the two other children she was with. One of the children then borrowed his phone because she wanted to listen to music. After giving her the phone, the other child later joined in and enjoyed the music on the phone.

Opportunity

Dlamini is said to have used this opportunity to call Thembela into the cooking hut. At first, the minor said she resisted but later complied. Once inside the hut, Thembela said the accused directed her to sit on his lap and she sat in a position that allowed her to face him.

"He started to spread my thighs and kissed me. He said when I grow old I would be his wife," Thembela said.

As he was kissing her, the bench that Dlamini was sitting on broke, but he managed to quickly rise before he could fall and he held the minor up. He then went out of the hut and called out the name of the girl who had his phone and demanded it back.

The child handed the phone over to Thembela so that she could pass it on to the accused.

"I went to give the phone to Dlamini who was by the gate at the time. He took the phone and dragged me to my grandfather's house while still saying that I would be his wife," Thembela said.

The grandfather's house is said to be out of the premises of Thembela's home but so close by.

At this time it was dark. Upon entering the grand-father's house, Dlamini is said to have met the 84-year-old man who asked where he was taking the girl.

The accused is said to have threatened to kill the grandfather and so he kept quiet and retreated to his bedroom.

Dlamini then proceeded to his bedroom, where

he dropped Thembela on the bed, lifted her skirt and removed her underwear.

He then used a blanket to cover the girl before he removed his pair of trousers and joined her on the bed. He then raped her and did not stop when Thembela pleaded that he should leave her alone.

Thereafter, he told her to dress up before he took her back to her parental home.

When they were by the gate, Dlamini is said to have threatened to kill Thembela and her parents should she report the incident to them.

The 84-year-old elderly man was also paraded as a witness in court where he said he witnessed the accused rape the minor.

He told the court that he saw the blanket moving and he told Dlamini to stop what he was doing but to no avail.

In the other incident involving the 56-year-old woman, who is also the accused's relative, the court was told that he broke a window to gain entry into the house. The incident that happened on February 16, 2019, resulted to a 10-year-old witnessing the ordeal.

The victim; *Nomsa, told the court that she was asleep with her two-year-old grandchild. In the house were other children, with the oldest being a 10-year-old boy. Narrating the incident, Nomsa said while asleep she felt something cold on her neck and when she woke up she realised that there was a bushknife held against her neck.

Shocked

While still shocked by what was happening, Nomsa said she heard a male's voice saying she should give him all the money in the house.

The accused then hit the woman with the bush-knife on the head, body and face. She said she got hold of the weapon and they engaged in a fight over it. While at it, Nomsa said she injured her hand with which she held the bush-knife. With the cut on the hand, Nomsa said she gave up the fight but continued to raise an alarm.

The cry for help was heard by the 10-year-old grandson who was asleep in another room.

He entered his grandmother's bedroom and called Dlamini by his name since he recognised him with the assistance of light that shone through the window that he broke to gain access into the house. The accused threatened to chop the boy to death and further ordered that he should return to his bedroom.

The lad complied and went out of his grandmother's room. Thereafter, Dlamini pushed her onto the bed and when she resisted, he forcefully pressed her on the bed before raping her.

After he was done, he is said to have spread a mattress that was leaning against a wall in the bedroom and he slept on it.

When doing this, the accused was still carrying the bush-knife. Before he left the woman's house just before day break, Dlamini is said to have forgotten his hat, which was later handed over to the police.

The Principal Magistrate David Khumalo sentenced Maziya to 15 years imprisonment without an option of a fine for each of the charges.

Man arrested for raping lover at knife-point

IN a rather bizarre incident, a man filled with intense sexual desire forced himself onto his girlfriend and raped her at knife-point.

Siyabonga Mabuza (23) of Makholokholo has to face the full brunt of the law after he was found to have raped his girlfriend Bongiwe*.

Mabuza was arrested and charged with contravening the Sexual Offences and Domestic Violence (SODV) Act of 2018, when he was said to have unlawfully had sexual intercourse with his girlfriend According to his charge sheet, Mabuza was said to have committed the offence at Makholokholo area on August 29.

Mabuza was found to have wrongfully and unlawfully had sexual intercourse with Bongiwe, using force in the form of a knife, to induce submission, thus contravening the Act.

During his first appearance before Principal Magistrate Fikile Nhlabatsi, Mabuza informed the court that he wished to conduct his own defence in the case.


This prompted the prosecution represented by Chris Sibandze to move an application for Mabuza to be remanded back into custody until tomorrow for the setting of his trial date.

Pupil arrested for murder

A 20-year-old Form Five pupil from Manzini Central High School has been arrested and charged for murder.

Mbongeni Mkhwanazi is said to have been arrested on Sunday after he committed the crime at a drinking spot known as Sitiba Wine and Malt in Madonsa.

Leading to the murder of the 28-year-old unidentified man from Mbhuleni in Matsapha, eye witnesses said there was an argument that quickly escalated to a physical altercation between one Thokozani and others at the drinking spot.

The two factions; one from Matsapha and the other from Madonsa, are said to have engaged in a brawl

A source said the fight was further perpetrated by the fact that the other party was not originally from Madonsa but Matsapha, hence there was also a scuffle to show dominance in the area.

"The Matsapha men are suspected to be members of the K9 gang so maybe they fought because each wanted to show who was more fierce than the other," said a source.

It is said that Thokozani had confronted the other parties on suspicion that they were the ones who had stolen his shoes at his home recently.

While the men were fighting, sources said the deceased man saw them and he asked why they were fighting. Without answering him, Mbongeni is said to have pierced him with a knife. The deceased man is said to hail from Mbhuleni in Matsapha and is suspected to be a member of the K9 gang.

When sought for comment, the Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the murder incident. She said the police were investigating the matter.

Members of the public flocked to the stall to browse through the different services offered in the all-inone stall.


A contributing factor for the positive turnout is believed to be the fact that almost everyone was catered for in the HMCS stall.

REPORT sexual harassment to the police.

This was said by Directorate of Public Prosecutions (DPP) Principal Crown Counsel Lomvula Hlophe during the SODV Act education of Eswatini Bank employees recently. The Sexual Offences and Domestic Violence (SODV) Act of 2018 does not discriminate on where offences occur. She said the SODV Act did not have a provision for any work place's internal processes when it came to violation of any of its sections and as such, sexual harassment remained a criminal offence.

This was emphasised during an awareness exercise of the importance of the Act.

"As such, sexual offences are not categorised as per the location of occurrence, but the Act criminalises the commission whether they occur within the workplace, bus rank or any place. As such, in cases such as sexual harassment, it is not categorised as having occurred in the work place but within the Kingdom of Eswatini," she said.



ing the crops were also taught on how best to manage their crops so as to give the best products.

She said in the event a person is conflicted after being sexually harassed in a private area, such as an office, they should not be concerned about gathering evidence as this could only be done by the police along with the office of the DPP.

So if I call you, and talk to you; as you speak, I can already deduce as to what crime has been committed and at the back of my mind I draft the charge sheet. Hence, I plead with you not to bother yourself with the evidence," she said.

Social workers at elderly grants pay-points

SOCIAL workers will now be visible in all elderly grants payment points going forward.

Deputy Prime Minister's Under Secretary Hlobsile Dlamini said this was a response to complaints from the nation that social welfare officers were not available to help them.

She said the officers in each area would listen to the complaints and help where possible, then escalate if need be.

Dlamini said some elderly grant beneficiaries and proxies were turned back last week when the disbursement of the grants started.

"It is either they come not on the stipulated date or the person coming to fetch the money isn't the proxy who was regis-

However, those who have missed the said dates are given a grace period after the last day of the payments. This started last week Thursday and will run up to tomorrow, this is called special payment," she said.

On August 20 there was a setback at Mbabane Post Office

when elderly people some of them living with disabilities were turned back for not appearing on the system.

Proxies were also turned back although they had registered when the registration window was opened. They were told that they didn't appear in the system which caused commo-

"It is sad to que then be told that you don't appear in the system especially in this cold weath-

I came with my grandmother and she signed that I will fetch her money from then onwards as she is sickly, today I am told that I cannot be helped. Look around, out of 38 proxies only five appear in the system, this shows that their verification process is inefficient," said Tengetiwe Simelane.

Minister of Sports, Youth and Culture who is also Mbabane East MP Harries 'Madze' Bulunga was at the scene and he said he had gone to help his constituents to make sure the processes were smooth when the problems arose.

"I had gone there to make sure processes were smooth as some of my constituents were turned back as they were omitted in the system and told that they didn't register.

Even with the proxy issues some didn't appear in the system apparently," Bulunga said.

Meanwhile DPMO's Director of Social Welfare Moses Dlamini said his office was fixing the problems and apologised for any inconvenience caused. He said these problems that arose helped because the elderly showed afterwards to verify that they were still alive.

Dlamini said it was very worrying that suddenly almost everyone was a proxy. He said they were preparing for a period where the elderly will use finger access control at the pay points so that they could be verified as right now it was easy to defraud government.

"There are so many proxies and something is wrong with this picture. The proxy option was made for elderly people who are bedridden. It is unbelievable that all of a sudden every old person in the country is bedridden. To me it appears that people don't take this process seriously. We also want to avoid situations where the money doesn't reach the destined person," Dlamini said.

THERE was a seven-hour power outage on Sunday in Pigg's Peak.

The situation, which left consumers not pleased, was a result of the maintenance of electricity poles. It began at 0800 hours and ended at 1500 hours. We had communicated through the local print media on Friday and on our website last week. We decided to do the maintenance on Sunday as this day would affect fewer businesses compared to other days of the week," he said.

Mavuso added that members of the public should phone the 24-hour EEC call centre if they have any queries.

"We encourage members of the public to contact the EEC call centre if they have any queries pertaining to electricity disturbances. The call centre is always operational to assist members of the public. The public should contact us on 800 9000 if you are using a landline or 2508 3333 for cellphone users," he added.

CLOSE to 80 per cent of working Emaswati are deep into debts, an economist has said.

This followed after SELECT Management clients were turned back from the company after attempting to borrow money to sustain them.

The clients were seeking help from a company Debts Souls, which promised to assist them clear their debts.

According to one of the clients, debtors deducted a lot of money from their salaries, as a result they were left with nothing at the end of the month.

SELECT Chief Executive Officer Bongani Motsa said they did not reject their clients. In fact Motsa said they should not take loans more than what they could afford.

He said negotiations between SELECT and Debt Souls had not been finalised, hence the clients could not continue

borrowing her money.

Meanwhile, an econo

Meanwhile, an economist said more people were sinking into debts due to a combinations of factors, including the rising commodity prices with disproportionately lower salary increases (if at all, with particular reference to civil servants).

Unemployment

"There is also the matter of high unemployment (especially youth) and escalating poverty levels," the economist said.

Ultimately it means, without a proper state-funded social protection or social assistance programmes, the burden of taking care of all this falls on the working population, who in turn get into more debts as they try to meet the increasing obligations.

The economist said people should stop taking loans as they only perpet-



uats the debt cycle.

The economist added that in some cases, it might assist to consolidate multiple loans into one that takes account the affordability, but that would require an assessment on a case by case basis.

"I also think employers should ensure their employees are taught or have access to basic household financial management lessons," he said.

For the employer, the incentive here is that happy employees are generally more productive.

He added that on the macro level, government should finalise the draft Social Protection Policy, which would address the underlying cause of why people are finding unavoidable to borrow

"The basket of goods that one used to get with a salary five years ago (for instance) has shrunk drastically, due to inflation and other factors," he said.

The economist said individuals have to adjust their standard of living to reflect the more modest disposable income, by way of cutting unnecessary spending.

"There are various examples, using public transport more instead of driving, or car-pooling to work, avoid using credit for frivolous spending," said the

said the economist.

He urged Emaswafi to consider having a savings account, with whatever little money is available. This would make people less vulnerable to any external shocks that may affect their usual spending cycle thus they would need to borrow on a much less frequent basis.

UNESWA wants to be varsity of choice

UNESWA Vice Chancellor Justice Thwala says the institution's vision is to be seen as the university of choice in Africa.

Aragones said in 2001, the National Emergency Response Council on HIV and AIDS (NERCHA) started the first 18 neighbourhood care points (NPCs) to protect vulnerable children in the respective communities.

"Other development partners such as UN agencies and civil society organisations supported this effort. NCPs are around 1 500 and in that aspect, the EU is supporting the deputy prime minister's office to survey and map these NCPs to measure quality of care and set minimum standards."

As African leaders meet on growth, SA and Nigeria are a drag

JOHANNESBURG - The two nations that account for almost half of sub-Saharan Africa's gross domestic product are proving to be a damper on the region's economic expansion.

Nigeria and South Africa, which view with each other to be the continent's biggest economy, both release second-quarter growth data yesterday.

While the figures will probably show South Africa dodged a recession and Nigeria's growth quickened, according to two separate Bloomberg surveys, both are expected to show they expanded at a limp pace.

The publication of the data comes as political and business leaders from at

least 28 African countries prepare to meet in Cape Town yesterday at the World Economic Forum on Africa. The discussions will focus on how Africa, which has some of the world's fastest-growing economies in Ghana and Ethiopia, can expand its potential.

'Major Drag'

"It is obviously going to be a major drag on the continent's growth if the two largest economies are not performing," said Ronak Gopaldas, a Director at the Cape Town-based consultancy Signal Risk.

The data is expected to show the South African economy grew an annualized 2.5 per cent from the first quarter, and Nigeria's expanded by the same margin year-on-year. While the slowing global expansion is contributing to South Africa and Nigeria's tepid growth, the two nations' economic woes are largely of their own doing.

The ANC-led government in South Africa has failed to decisively deal with the finances of debt-laden power utility Eskom, which is straining the nation's budget and caused a contraction in GDP in the first quarter. Nigeria's failure to diversify its economy, which relies on oil for 90 per cent of its foreign exchange, leaves it vulnerable to international price movements. *Bloomberg*

"Bazalwane I wonder what your God does for you." Shouting Sis Dumsile as she stands in front of the church.



OFFENCES RELATING TO MISUSE OF INFORMATION, OTHER MATTERS

78. (1) A person who knows or ought reasonably to have known-(a) that information has been disclosed under section 76 or 77; or (b) that an investigation is being, or may be, conducted as a result of the disclosure referred to in paragraph (a),

and who directly or indirectly alerts, or brings information to the attention of another person which will or is likely to prejudice the investigation, commits an offence.

(2) A person who intentionally refuses or fails to comply with an order of court made in terms of this Act, commits an offence.

(3) A person who hinders a curator bonis, a member of the police or any other person in the exercise, performance or carrying out of the powers, functions or duties in terms of this Act, commits an offence.

(4) Any person convicted of an offence contemplated in-

(a) subsection (1) or (2), unless the offence is not one of a failure to comply with a confiscation order or a forfeiture order, is liable to a fine not exceeding one hundred and fifty thousand Emalangeni, or to imprisonment for a period not exceeding fifteen years or to both:

(b) subsection (2), if the offence is one of a failure to comply with a confiscation order or a forfeiture order, is liable to a fine not exceeding ten million Emalangeni, or to imprisonment for a period not exceeding thirty years; or

(c) subsection (3) is liable to a fine not exceeding twenty five thousand Emalangeni, or to imprisonment for a period not exceeding three years.


(5) A conviction and sentence under subsection (4) for a failure to comply with a confiscation order or a forfeiture order does not discharge the order in respect of which a court had convicted or sentenced an offender.

Rules of court

79. The Chief Justice shall make rules for the High Court and the Magistrates Court regulating the proceedings contemplated in Parts IV and VIII or regulating the proceedings or matters referred to in sections 23, 24, 53, 74, 75 and 77 of this Act.

Procedure for certain applications 80. (1) Every application under sections 16, 34, 42, 50 and 55 shall be made in the prescribed manner.

(2) The Director of Public Prosecutions may, in cases of urgency, apply to the High Court to dispense with any requirements



(3) In an application in terms of subsection (2) the court may accept oral or hearsay evidence if that evidence will not render the proceedings unfair.

(4) In an application in terms of subsection (2) the court may-(a) direct the applicant to file complete papers or to adduce further evidence at a date and time specified by the court before deciding whether or not to make an order, including an order referred

to in paragraph (b); (b) make a provisional order having immediate effect and may simultaneously grant a rule nisi calling on the person against whom the order is made to appear on a day mentioned in the rule and to show cause why the order should not be made final.

Functions of curator bonis

81. (1) Immediately after a curator bonis is appointed in terms of this Act, the curator bonis shall take into custody all the property in respect of which the curator bonis was appointed, as well as any document in the possession or custody or under the control of any person referred to in section 19(1), 34(2)(c), 46(1)(b) or 58(3) if that document relates to the property.

(2) Except as otherwise provided in this Act, the Administration of Estates Act, 1902 (Act 28 of 1902), does, with the necessary changes, apply in respect of a curator bonis appointed in terms of this Act.

(3) The High Court may dispense with any requirement in terms of any law that applies to the appointment of a curator bonis or to the

execution of any power or function by a curator bonis, including a requirement for a curator bonis to provide security.

Staff member may take care of property

82. Where a court may appoint a curator bonis in terms of this Act, the court may dispense with such an appointment and direct instead that a staff member will, subject to the directions of the court, take care of the property concerned. Costs

83. (1) A court may make an order as to costs as it deems appropriate in favour of the Director of Public Prosecutions in respect of any proceedings arising out of Part IV or VIII.

(2) Any amount paid in terms of an order referred to in subsection (1) shall be deposited into the

Taxation of costs

84. (1) Where the High Court makes provision for reasonable legal expenses for a person, the Director of Public Prosecutions or the curator bonis may apply to the High Court for an order that the expenses be taxed in accordance with the prescribed rates.

(2) The curator bonis or the Director of Public Prosecutions shall give notice of an application under this section to the person concerned.

(3) The High Court shall, on receipt of an application under this section, order that the expenses be taxed as provided in the order.

(4) After an application is made for an order under this section, the curator bonis need not, unless ordered by the court to do so, take

any steps for the purpose of meeting the expenses provided for under section 17(1) or 48(1) unless and until-

(a) an order under this section in relation to the expenses is complied with; or

(b) the application, and any appeal arising out of it, are finally determined, or otherwise disposed of, other than by the making of such an order.


Maximum legal expenses

85. (1) A provision under section 17(1) or 48(1) for the meeting of legal expenses out of any property which is subject to a restraint order or a preservation of property order shall not exceed the prescribed maximum allowable costs for legal services to be met out of that property.

(2) This section limits the amount of the legal expenses which the High Court may provide under section 17(1) or 48(1) to be met out of property which is subject to a restraint order or preservation of property order and does not limit or otherwise affect any entitlement of a legal practitioner to any amount which exceeds any applicable maximum for a legal service.

Jurisdiction in respect of sentence 86. (1) A magistrates court has jurisdiction to impose any penalty mentioned in section 78(4), even though that penalty may exceed the penal jurisdiction of that court

(2) A magistrates court has jurisdiction to make any order referred to in section 23(2) even though the amount payable under that order may exceed the civil jurisdiction of the magistrate's court.

I hopes Watson wasn't 'removed from the scene'

PORT ELIZABETH - Former president Jacob Zuma has called Gavin Watson a real comrade.

Speaking at the funeral of the former Bosasa CEO at the Feather Market Centre in Port Elizabeth yesterday, Zuma said Watson was "a soldier of our struggle, who understood the need to build SA to be a better country that takes care of its citizens. A real democrat, a revolutionary in practice and not just in theory."

Watson, 73, died in a car crash at OR Tambo International Airport in Johannesburg last Monday morning. He was driving in the airport precinct in a white Toyota Corolla registered under Bosasa in the early hours of the morning when he allegedly lost control of the car and collided with a concrete pillar holding up a highway bridge.

Watson, who was alone in the car, was certified dead on the scene and a case of culpable homicide has been opened. His death has raised many questions.

At the funeral, Zuma said he hoped that Watson had not been "cleverly removed from the scene like others who had died mysteriously especially during the Apartheid era".

Zuma, who arrived at the funeral to ulu-

lation, said Watson was preparing to go to the Zondo commission (of inquiry into State Capture) to respond to a number of allegations made against him so that he could clear his name.

"Perhaps those in the company will also have an opportunity to do so. We are living in a strange era where those who fought for freedom and were vilified by the Apartheid system are now seen as the worst people in the country. The media narrative is deliberately

shaped to undermine our freedom," Zuma said.
"Some of the comrades who have been taken away are those who are very close to me in terms

Z u m a warned that South Africa was strategically placed geographically, politically, economically and globally and outside interests were a threat to the country.

"They are always looking at people who need to be removed and I hope we are not dealing with that case here.

"The Watson family has been under the spotlight of our enemies for many years and it has not stopped.

"Somehow we got to the stage where the (Zondo) commission was further used to deal with this family. I hope sincerely there will be explanations of many things."

Interests

Zuma said the ANC was riddled with class interests. "It has now emerged that once a comrade who was willing to die with you, today that comrade is willing to kill you for personal interests.

"Gavin was a different kind of a person. We still need to wake up and the ANC has to work hard to ensure that this country does not disintegrate into something else because of how important it is globally. This Watson family has suffered because if its political clarity and commitment to freedom in this country.

"I wish we can learn from him that we need to address our ills differently. If we don't, we all will die one by one, especially those who are known to be problematic. (This can happen in different ways) A heart attack, I know it can be induced. I have been poisoned himself. I am not talking about something I don't know." IOL

ESWATINI, US TO DEVELOP AGOA RESPONSE STRAT

ESWATINI in conjunction with the United States Trade and Investment Hub wants to develop an Africa Growth Opportunity Act (AGOA) National Response Strategy.

Minister of Commerce, Industry and Trade Mangoba Khumalo said as the lead ministry for AGOA issues, they are in the process of constituting a steering committee which would manage the exercise of developing the strategy.

"This strategy is aimed at assisting the country improve the utilisation of AGOA and allow the private sector to form linkages with other businesses; with the aim of taking advantage of AGOA benefits. "The National AGOA Response Strategy was introduced to address issues of low utilisation of AGOA," he said in a statement. He said Africa is currently utilising 14 pe rcent of the 6 500 tariff lines under AGOA.

It was on this premise that African ministers of trade met during the 18th AGOA Forum held in Abidjan, Cote d'Ivoire, last month where they attributed the low utilisation to challenges faced by businesses when trying to take advantage of AGOA benefits. "Challenges identified included low production capacity and regulations that are imposed in the US. "The ministers also noted that some businesses were not aware of AGOA, thus did not know how to utilise its benefits.

USAID is assisting countries to develop the strategies. Out of the 39 benefiting African countries, only 18 have developed their national strategies," he said.

Khumalo said during the AGOA Forum, countries were advised to identify key products which the national strategies could focus on.

It was noted that AGOA benefits were uneven with petroleum products dominating in export volumes.

Countries were advised to add value to their products so that higher benefits could accrue from the export of higher value products as opposed to the raw products that are currently being exported.

"With coming into force of the African Continental Free Trade Area (AfCFTA), the feeling in the forum was that the AfCFTA will shape the relationship between Africa and the US.

The meeting highlighted the need to plan for the future as AGOA is coming to an end in 2025 and the USA has not indicated an extension or not. Meanwhile, Eswatini has already started developing its own national strategy with Manqoba Khumalo.

the help of USAID," he added.

The minister said this strategy would cover the period from its launch up to 2025 when the current round of AGOA comes to an end. In addition, the strategy would explore the options available for Eswatini in trading with the USA, in the event that AGOA is not renewed post 2025.

"Going forward, the ministry will engage many stakeholders including the private sector, micro small

medium enterprises (MSMEs), academia and unions to ensure the outcome represents the views of all key stakeholders," he said.

"The smart feature phone, which comes with a 3G capability, addresses all your communication needs in a manner that is sensitive to your pocket," explained Nhleko.

SUGAR INDUSTRY KEYINSADC

THE sugar industry in the Southern African Development Community (SADC) is a key driver of economic development, through backward and forward linkages, supporting industrial development and sustainable economic growth.

Central Bank of Eswatini (CBE) General Manager Sikhumbuzo Dlamini said in one SADC country, the sugar industry represented roughly 6.1 per cent of the country's GDP and 93 per cent of the agricultural sector.

He was speaking FSSP conference that was held at Royal Swazi Convention centre last Wednesday.

"In terms of supporting local communities, the sugar cane industry also plays an important role in local communities, from helping establish small grower schemes to providing healthcare, education, housing and infra-

Building revenue and skills into the national economy, the sugar industries provide much needed export earnings and tax revenues to each host country, while the sugar production process supports the development of a range of engineering skills that transfer to other parts of the economy," he said.

He added that the sugar industry also contributed to poverty reduction in

SADC. In one country, the poverty levels had dropped by over four per cent due in part to opportunities for rural people in the sugar industry.

He added that in terms of trade within SADC Intra-regional trade Africa has for some years been an important centre of discussion in the regional integration agenda.

"Most intra-regional trade tends to happen between developed nations and it is still small among African

Despite numerous efforts by African Heads of States to promote intra-Africa trade, there has not been significant increase in intra-regional trade especially in Southern Africa," he added.

Southern Africa integration plan short of sector specifics

CENTRAL Bank of Eswatini (CBE) General Manager Sikhumbuzo Dlamini says SADC has placed industrialisation at the centre of its regional integrated development plan and a roadmap has been drawn up to guide the

However, he said implementation has been poor and not a lot of headway has been made to integrate the economies of the region.

He said recent studies on value chains in the region highlighted high transport costs and continued use of non-tariff barriers in some countries as some of the main reasons for poor progress.

These studies suggest that the region needs a coherent sectorspecific approach to support the development of regional value chains. That should be supported by efforts to reduce trade barriers. In addition, the impact on industrialisation that large multinationals have had should be considered.

"This is where the sugar (sugarcane) industry comes in.

The importance of developing regional value chains is more critical than before, if the region is to benefit from investments in the sugar industry. FSSP should prioritise developing a regional roadmap to industrialise the sugarcane industry. This would help attract investments and ensure the region reaps the benefitsof the Continental Free Trade Area," he said.

He added that the industrialisation strategy stresses the urgent need for the region to make use of its abundant and diverse resources, particularly in agriculture and mining. Its key aim is to foster industrialisation through beneficiation a process of transforming primary raw materials into a more value added finished product and value

"This approach is informed by two big challenges related

First, is that intra-regional trade is low and that trade between countries is dominated by low value products.

There is a need to develop regional value chains - only a regional approach to promoting value addition will work.

It must focus on building productive capacity of industries, developing infrastructure and promoting technology," he said.

Intra-SADC Trade still remains very low

A study by OECD, states that intra-SADC trade has increased slightly since the creation of the Free Trade Area (FTA) in 2008 with an estimated 85 per cent of intra-regional trade subject to zero duty.

Intra-SADC trade hovered around 10 per cent, and this is low compared to other regions like the South-East Asian Nations which is at 24 per cent and the EU at 40 per cent.

This implied that about 90 per cent of SADC's trade is happening with external countries, which is why the sugar industry contributes significantly

"If any trade does happen within SADC, it could be influenced by South Africa which enjoys a significant trade influence in the region due to her eco-

nomic size relative to the other member states within SADC.

RSA's imports from SADC are low compared to its exports toward SADC countries, which create a structural trade imbalance with the regional partners. This shows that there is a huge market in SADC since SADC region is a non-negligible market for RSA," Dlamini said.

WITH government adopting an export-led economic strategy, businesses of all sizes will now be capacitated on the export industry through the launched export readiness training manual.

Duncan Edmund Claxon from the International Business and French, a company based in the United Kingdom said the over reliance of businesses on government was not going to get businesses exporting to foreign markets. He said the way Britain allowed companies to export was through a dedicated UK export finance department which involved private companies who facilitated loans and insurance policies to businesses. LAST WEEK, we discussed the Small Scale Loan Guarantee Scheme (SSLGS) and how the government of the Kingdom of Eswatini intends to assist budding and established entrepreneurs to have easy access to finance.

Today, we address the issue of how leather can be used to replenish the kingdom's economy in line with the Strategic Roadmap 2019-2022's vision of sustainably growing the economy of Eswatini for the benefit of all who live in it.

The Micro, Small, and Medium-sized Enterprise (MSME) Unit, under the ministry of commerce, industry and trade, recently commissioned the African Leather and Leather Products Institute (ALLPI) under the COMESA Region Integration Support Mechanism (RISM) to conduct a feasibility study on the establishment of an industrial leather tannery. This week, we have the pleasure to share extracts from the study.


The Leather Value Chain

POTENTIAL OF THE LEATH VALUE CHAIN IN ESWAT

The Livestock industry is the resource base of the leather industry. In this study, the focus is on processing bovine hides and skins.

The size of the bovine herd has been on a down trend in Eswatini, standing at 633 535 in 2012 and 501 643 in 2018. This has been attributed mainly to drought.

As in many Sub-Saharan countries, the livestock sector in Eswatini is characterised by a two-fold dualism between "commercial" and "communal" livestock and between "modern" and "traditional" systems. The ruminant sector is dominated by cattle, which are an important source of food and cash income, for different wealth categories in various areas. The generic Leather Value Chain is illustrated below:



Generic Leather Value Chain

ENGINEERING AND TECHNOLOGY

Production Process and Plant Capacity

Tanning is the process of converting skins and hides into leather. A tannery is the place where this process takes place. Tanning of hides and skins into leather involves a process which permanently alters the protein structure of these commodities making it more durable and less susceptible to decomposition, and also possibly colouring it. Traditionally, tanning used tannin, an acidic chemical compound from which the tanning process draws its name (tannin is in turn named after an old German word for oak or fir trees, from which the compound was derived). The use of chromium (III) was adopted by tanners during the Industrial Revolution. The general tanning process is illustrated below:

Estimation of Finished Leather Market in Eswatini

Production of footwear and leather goods in Eswatini is at a very small scale. Consequently, the consumption of leather is also very low. Annual footwear demand is estimated at 1.4 million pairs, which is currently being serviced with imports. Eswatini has an

average enrolment of 240 000 pupils per annum and almost 100 per cent of the footwear are imported. Efforts should be put in place to strengthen craftsman/women to make school shoes. This will then create the necessary demand for leather. Production of school shoes in Eswatini may stimulate the demand for finished leather domesti-


Eswatini Imports of Leather and Footwear

Footwear production in Eswatini is very rudimentary, focusing mainly on the production of traditional sandals. Importation of footwear into Eswatini rose from slightly below US\$10 million in 2001 to reaching around US\$18 million in 2017. On average, Eswatini is importing around one million pairs per year, almost equivalent to its annual footwear demand which is estimated at 1.4 million pairs.

In addition to the rising footwear demand, the imports of finished leather into Africa is also increasing, due to increased production activities of footwear and other leather goods by SMEs who are operating both formally and informally. It is believed that most of the leather imports into the continent are not accounted for as they are imported in small packages and thus not declared.

There are few countries producing finished leather in Africa and the rest of the countries export 95 to 100 per cent in semi-processed state, therefore depriving the region of finished leather. In Eswatini, there is no Tannery producing finished leather. Consequently, the enterprises involved in the production of footwear and other finished leather goods are forced to travel to South Africa. Most of the leather is imported informally, and significant production time is forgone, as owners of SMEs spent an average of three days travelling back and forth to Durban.

SA ECONOMIC GROWTH SURPRISES, RECESSION AVOIDED

JOHANNESBURG - South Africa avoided a second recession in two years, with the economy growing by 3.1 per cent in the three months to end-June, according to Stats SA.

This is much stronger than expected: A Reuters poll of economists had forecast growth of 2.4 per cent. SA's economy shrank in the first quarter after more than 270 hours of load shedding, weak investment levels, a gold mining strike and a weak grape harvest. In the second quarter, the mining sector rebounded with growth of 14.4 per cent contributing a full 1.0 percentage point to GDP growth. This was thanks to the end of strikes at gold mines, but also due to a major rally in metal prices.

Rand strengthens slightly before second quarter GDP data

JOHANNESBURG - The rand strengthened slightly in early trade yesterday in the build-up to the release of second quarter economic growth

At 0630 GMT, the rand was 0.11 per cent firmer against the dollar at R15.2400 per dollar compared with a close of R15.2575 overnight.

Africa's most developed economy contracted 3.2 per cent in the first quarter, hit by nationwide power outages by cash-strapped state power firm Eskom.

some analysts said weak demand and political uncertainty would continue to weigh on the economy.

Nigeria must stop extra-judicial killings by security forces

A UN human rights expert on Monday urged Nigeria to stop extra-judicial killings by security forces in the coun-

In a preliminary report at the end of a 12-day visit to Nigeria, United Nations Special Rapporteur Agnes Callamard said the perpetrators of such inhuman acts should face justice.

"Every death or serious injury in police custody, and every alleged extrajudicial execution, ought to be adequately and impartially investigated by an independent body," the UN top official told a news conference in Abuja.

Suspected

According to her, officers suspected of being responsible for the killings should be suspended pending investigation, while those implicated should be dismissed and brought before a civilian court.

"The government should condemn publicly all extrajudicial executions and other unlawful killings, including of suspected armed robbers, and announce



that perpetrators will be brought to justice in fair trials before ordinary civilian courts and without recourse to death penalty," she said.

Callamard met with various stakeholders, including government officials, right groups, civil society groups, the media and victims of abuses, including survivors, witnesses and family members whose relatives have been

brutally killed.

ACCOUNTABILITY

"I considered violations allegedly committed by state security agencies and by non-state actors, particularly in the northeast, Middle Belt and south of the country, as well as actions taken by the state to hold perpetrators accountable for their crimes," she said.

'ENOUGH IS ENOUGH'

LAGOS - The Nigerian government says it will take further steps to ensure safety and protection of its citizens in South Africa.

The position comes in the wake of a round of xenophobic attacks that hit Johannesburg on Monday.

The government described the incidents as unacceptable adding: 'Enough is enough. Nigeria will take definitive measures to ensure safety and protection of her citizens.

Leaders of the two countries -Muhammadu Buhari and Cyril Ramaphosa are scheduled to meet in October for bilateral talks and also on matters relating to security of Nigerians in South Africa.

The two met on the sidelines of the 7th Tokyo International Conference on African Development, TICAD; held last week in the Japanese city of Yokohama.

Another government to have reacted to the Johannesburg chaos is Zambia which tasked all its drivers plying the route to and from South Africa to suspend their trips till further notice.

Zimbabwe's Cross Borders Transportation Association also warned that it could halt all South African cross border transport over the situation.

The provincial and national governments have called for restraint in the affected communities and cautioned against use of criminal avenues to express grievances.

The ruling African National Congress, ANC, also expressed their worry over the situation as has the main opposition Democratic Alliance and the Economic Freedom Fighters. Africa News

'I would 'quit' if she could'

HONG KONG - Embattled Hong Kong leader Carrie Lam said she has caused "unforgivable havoc" by igniting the political crisis engulfing the city and would quit if she had a choice, according to an audio recording of remarks she made last week to a group of businesspeople.

At the closed-door meeting, Lam. told the group that she now has "very limited" room to resolve the crisis because the unrest has become a national security and sovereignty issue for China amid rising tensions with the United States. "If I have a choice," she said, speaking in English, "the first thing is to quit, having made a deep apology." Lam's dramatic and at times anguished remarks offer the clearest view yet into the thinking of the Chinese leadership as it navigates the unrest in Hong Kong, the biggest political crisis to grip the country since the Tiananmen Square protests of 1989.

Hong Kong has been convulsed by sometimes violent protests and mass demonstrations since June, in response to a proposed law by Lam's administration that would allow people suspected of crimes

on the mainland to be extradited to face trial in Chinese courts. The law has been shelved, but Lam has 🗻 been unable to end the upheaval. Protesters have expanded their demands to include complete withdrawal of the proposal, a concession her administration has so far refused. Large demonstrations wracked the city again over the weekend. Lam suggested that Beijing had not yet reached a turning point. She said Beijing had not imposed any deadline for ending the crisis ahead of National Day celebrations scheduled for October 1. Reuters

Dorian triggers massive flooding in Bahamas; at least 5 dead

NASSAU — Hurricane Dorian unleashed massive flooding across the Bahamas on Monday, pummeling the islands with so much wind and water that authorities urged people to find floatation devices and grab hammers to break out of their attics if necessary.

At least five deaths were blamed on the storm.

"We are in the midst of a historic tragedy," Prime Minister Hubert Minnis said in announcing the fatalities. He called the devastation "unprecedented and extensive."

The fearsome Category 4 storm slowed almost to a standstill as it shredded roofs, hurled cars and forced even rescue crews to take shelter until the onslaught passed.

Officials said they received a "tremendous" number of calls from people in flooded homes. A radio station received more than 2 000 distress messages, including reports of a five-month-old baby stranded on a roof and a grandmother with six grandchildren who cut a hole in a roof to escape rising floodwaters. Other reports involved a group of eight children and five adults stranded on a highway and two storm shelters that flooded.

The deaths in the Bahamas came after a previous storm-related fatality in Puerto Rico. At least 21 people were hurt in the Bahamas and evacuated by helicopters, the prime minster said.

Police Chief Samuel Butler urged people to remain calm and share their GPS coordinates, but he said rescue crews had to wait until weather conditions improved. "We simply cannot get to you," he told Bahamas radio station ZNS. Forecasters warned that Dorian could generate a storm surge as high as 23 feet (seven metres).

Meanwhile in the United States, the National Hurricane Centre extended watches and warnings across the Florida and Georgia coasts. Forecasters expected Dorian to stay off shore, but meteorologist Daniel Brown cautioned that "only a small deviation" could draw the storm's dangerous core toward land.

Officials declare state of economic emergency

BEIRUT - Lebanon's political leaders declared what they called an economic state of emergency Monday following a meeting aimed at finding a solution to the country's economic crisis, raising concerns that more taxes will be imposed. Lebanon has one of the world's highest public debts in the world, standing at 150 per cent of gross domestic product. Growth has plummeted and budget deficit reached 11 per cent of GDP as economic activities slowed and remittances from Lebanese living abroad shrank. AP

Ebola, MONUSCO top agenda

KINSHASA - United Nations Secretary-General Antonio Guterres called on donor nations to give the money they've pledged to fight Ebola on Monday, saying further delays could mean "we lose the war against Ebola."

Speaking on a visit to the President of the Democratic Republic of the Congo, Felix Tshisekedi in Kinshasa, Guterres said the UN had received only 15 per cent of what it needed to fight the disease over the rest of this year. Reuters

Zimbabwe state doctors go on strike over pay

HARARE - Zimbabwe's public sector doctors went on strike yesterday after the government failed to meet their demand to have their wages benchmarked in the US dollar.

"We met with the government representatives yesterday and they promised to expedite other allowances for health personnel but so far it has just been empty promises," Zimbabwe Hospital Doctors Association President Peter Magombeyi told Reuters.

Long wait as ANC top six meet with KZN ANC

DURBAN - The national top six of the ANC was for the better part of Monday locked in a meeting with the top of the ANC in KZN getting their side of the story regarding the issue of eThekwini Mayor Zandile Gumede.

On Wednesday last week Gumede surprised many when she withdrew her resignation as mayor after she was advised that the process followed was flawed. Prior to that, Gumede had petitioned the national top six alleging that she was being unfairly removed from office. She also met with the Secretary General, Ace Magashule to state her case.

As the top six meet with the provincial leadership led by Sihle Zikalala, the backers of Gumede expect the top six to charge the



provincial leadership if found to have acted outside their scope of powers when removing the embattled mayor.

If found to have violated no law of the party, Mzomuhle Dube, the spokesperson of the backers of Gumede, said they will also write

to the top six to clarify whether or not it has become a norm for the provincial leadership to remove mayors of big cities.

"If the top six says the provincial leadership acted unlawfully they must charge them. Again, if they said there was nothing wrong with their decision, then we will be happy to be told that this is now normal," Dube said.

Mayors of metros and other big cities are normally appointed by the national offices after getting recommendations from the provinces where they cities are.

Dube said since the meeting would run until late on Monday, they expected to have a clear picture on Tuesday morning.

"I don't think we will know what happened today because the top six meeting will run until very late."

On Sunday, the Spokesperson of the ANC in KZN, Ricardo Mthembu, insisted to Independent Media that the party's councillors in eThekwini would on Wednesday elect Mxolisi Kaunda as new mayor of eThekwini, replacing Gumede.

Kaunda would be deputised by former KZN finance MEC, Belinda Scott and the speaker would be another former MEC, Weziwe

Zondo commission hears how SABC suffered

JOHANNESBURG - SABC **Board Chairperson Bongumusa** Makhathini has told the Zondo commission that the SABC's mandate as a public broadcaster has been compromised over prolonged years of mismanagement and lack of government support.

Makhathini was testifying at the commission's investigation into state capture at the SABC.

He was appointed as board chairperson in 2017 and saw a number of his fellow Board members resign last year.

Makhathini spoke frankly about the financial challenges facing the broadcaster which led to its Board considering retrenchments - which were later halted at the request of Communications Minister Stella Ndabeni-Abrahams.

He said the SABC had failed, due to financial constraints, to live up to its mandate of providing a platform for community involvement and content that reflects that rich background of South Africa.

Makhathini was part of the Board appointed after the SABC had faced years of mismanagement which culminated in the removal of former SABC COO Hlaudi Motsoeneng who was largely blamed for the challenges

facing the organisation.

Motsoeneng brought massive changes to the organisation's mandate in providing news and was accused of interfering with editorial independence. He also purged several senior staff while promoting those that were loyal

Makhatini told the commission that state capture manifested itself at state-owned enterprises as many people with integrity were victimised and pushed.

He said the most concerning issue was that those with integrity were replaced under the guise of 'transformation.'

"My understanding of how capture has materialised or happened in most of these SOEs, certainly credible competent experienced people of integrity get victimised, they get pushed out and frustrated. They get frustrated in several ways. What has resulted in this commission doing the work that is doing is still a reality for us," he said.

"We are still living under those circumstances where you worry about your own safety for just trying to do what is right. And what is the most frustrating things, at times, they will cover some of these things as 'transformation'."

Right2 Know blames Mashaba, Ramaphosa, Zwelithini

JOHANNESBURG - The Right2Know Campaign has blamed the recent attacks on foreigners squarely at the feet of government.


In a statement sent out on Monday amid the continued looting and burning of foreign-owned shops in Gauteng, the organisation blamed Joburg Mayor Herman Mashaba, Zulu King Goodwill Zwelithini and President Cyril Ramaphosa.

The organisation said the attacks on non-South Africans can be directly linked to calls by politicians to 'defend the sovereignty of the state' and confirms a dangerous emerging trend of 'xenophobic populism' which leads to attacks on foreign nationals.

"We recognise that there are many sources of the violence but it is also clear that statements of outrage and condemnation by state officials at all levels (Cabinet, Parliament, the Gauteng Province, SAPS and Metros) fuelled the actions of ordinary citizens who interpreted those statements to be licence to take the law into their own hands.

"Senior political leaders find an easy target in the vulnerable Africans seeking to make a new home in South Africa.

"Indeed, there is a dangerous emerging trend of xenophobic populism that leads to attacks on foreign nationals. In 2015, Zulu King Goodwill Zwelithini's speech, President Cyril Ramaphosa's 2019 election campaign pronouncements, the Minister of Health's comments on the strain placed on health services by foreign migrants, and the xenophobic blaming for Johannesburg's ill by Mayor Herman Mashaba have been followed by xenophobic attacks in different localities.



"In all these instances, even when not responding to a direct call, political populism is used as justification by instigators and perpetrators who would have been waiting for an opportunity to strike for their own reasons.

The chaos erupted over the weekend after residents went on a rampage following a blaze at a building that claimed three lives in Jeppestown.

Foreign-owned shops were looted, car dealerships were torched and a metro police officer was injured during the

The chaos spread to other parts of Joburg and throughout the province.

By Monday evening, 91 people had been arrested and many foreign-owned shops remained closed as owners were scared of being attacked. Many others stood empty after being looted and burnt. Right2Know slammed the attacks,

saving they were hate crimes. They said the assaults and the looting of the for-

eigners' property just because they were not born in South Africa could never be justified.

"These actions - which are criminal in nature - when combined with the targeting of the victims as belonging to a certain group, becomes a hate crime.

"Apartheid was the experience of being stateless and homeless within one's home country. Today, we find South Africans showing the same hatred towards fellow Africans that we ourselves suffered not too long ago.

"As hosts of the World Conference Against Racism in 2001, we recognised xenophobia (and the local Afrophobia) as expressions of racism; in 2008 we experienced how the deep roots of internalised oppression enabled us to turn our own experience of racism and oppression into actions that discriminated against, targeted and in some cases killed other Africans living in South Africa.

WC DA REJECTS SPECIAL BILL FOR R59bn ESKOM BAILOUT

CAPE TOWN - The Democratic Alliance (DA) in the Western Cape has rejected the Special Appropriations Bill on Eskom as it will cut billions from provincial budgets.

According to the party, more than

R100 billion will be lost due to the bill. The legislation aims to give the power utility another R59 billion bailout.

The DA's Western Cape spokesperson on finance, Deidre Baartman, said she'd write to the

National Assembly's finance committee Chairperson, Yunus Carrim, requesting that public hearings be held in the provinces, pending the bill's consideration.

Baartman said South Africa's provincial budgets were already been by R17 billion collectively to bail out Eskom in the 2019/20 financial year as part of the adopted appropriations bill.

"The provinces currently have no say in the matter and yet we are expected to sustain and increase

the service delivery level with less money."

Eskom recently announced a loss of R21 billion in the last financial year. Baartman said national Treasury had essentially hollowed out the provinces to ensure Eskom did not default.

ANC DEFENDS MBOWENI AMID CRITICISM

OHANNESBURG - The **African National Congress** (ANC)'s top six leadership has come out in defence of Finance Minister Tito Mboweni amid criticism that he released the economic strategy document without proper consultation.

The party said its alliance partners would be consulted on the report, saying the strategy was released to give other stakeholders and South Africans a chance to have their say.

Mboweni released the economic blueprint on the Treasury website last week.

The paper looks at possible structural reforms to boost economic growth by over three per cent and to create a million jobs in 10 years.

When Mboweni released the document last week, the ANC's alliance partners the SACP and COSATU were up in arms, decrying the lack of consultation.

Mboweni met with the party's top six on Monday to explain himself.

LOOTING INTIMIDATION OF FOREIGN TRUCKS/DRIVERS A SIGN OF DESPERATION

JOHANNESBURG- The recent torching and looting of trucks and intimidation of foreign truck drivers was a clear indication of the desperation and frustration of unemployed South Africans, a crisis that needed urgent government intervention, experts

The Western Cape, Eastern Cape and KwaZulu-Natal have seen numerous incidents of trucks being looted recently, as tensions in the trucking industry refuse to die down.

The crisis led to the ministers of transport, home affairs, police and labour convening a meeting on Sunday to deliberate the issue of violent protest action and to come up with solutions to quell tensions.

Analysts have urged the government to treat issues in the industry



with a sense of urgency before they spiral out of control. George Glynos, an economist with Econometrix

Treasury Management, said: "I'm not just referring to the trucks; it's a broader picture, if you look at the

looting and riots and what is going on all around Johannesburg and other places. If people had jobs

they wouldn't be doing this; if people weren't feeling as desperate as they were they wouldn't be rioting, protesting and resorting to criminality.

It's a sign of desperation and a sign of frustration at the lack of any progress made on an economic level."He said this was a macroeconomic issue that the government needed to sort out.

Ralph Mathekga, a political analyst, said: "People are feeling that the government does not listen to them when they raise concerns in a peaceful manner.

'The trucking sector is in serious trouble, and there is a feeling that the government does not have a clear sense on how to regulate the industry."

During the seminar, the artist was treated to different topics by different industry game changers.



Mduduzi neZinceku Zamagawugawu kept the crowd entertained and dancing before Dumi took to the stage.





Neither Barcelona's form nor Bale's goals can be credited to Zidane, who spent most of the summer trying to sell the Welshman.

As well as failing to do that, he also looked on helplessly as the club failed to sign his number one transfer target Paul Pogba.

Pogba will not be arriving, neither will Neymar. Keylor Navas has left -that's something else he did not want to happen. It has not been a good close season for the returning Real Madrid

Madrid's transfer market started impressively with the signing of Eden Hazard but that was as good as it got and when midfielder Casemiro spoke after the Villarreal draw of the team 'lacking everything' he was echoing the sentiments of most of the club's supporters.

'This is a team and we should defend and attack as a team' he added after the game. He is always willing to step forward after matches and speak to the media. Criticism, however, might very well start with him or at least in the position he occupies.

Compete He is Real Madrid's only holding midfielder and he was found wanting against Villarreal. It is just one of the many failings of the summer that they have not been able to buy someone to compete with him. They appeared not to even try

Another position they seemed to

ignore was centre-back, where Sergio Ramos begins another season knowing that he is in the team every week. He was lucky that his first-half error happened early enough for it almost to have been forgotten.

He looks past his best and yet Zidane has little option to build his defence around him and Raphael Varane because there is nothing else.

The French coach left Nacho out of his squad on Sunday and clearly has little faith in Eder Militao, whose signing was agreed before he returned to the club.

Herrera in the dock as Spain match-fixing trial opens

BARCELONA - Spain's first major match-fixing trial began Tuesday with former Manchester United midfielder Ander Herrera among 42 defendants charged over a 'suspect' 2011 match between his former club Real Zaragoza and Levante.

The accused made no comments as they arrived at the court in the eastern city of Valencia for the start of proceedings which are expected to last until September 30.

Real Zaragoza's 2-1 win on May 21, 2011, the last match of the season, spared the club relegation from the Spanish first division.

But it triggered an investigation by Spain's anti-corruption prosecutors' office over suspect payments to playing staff and coach-

Midfielder Gabi Fernandez, who currently plays in Qatar, scored both goals in Real's crucial victory. He is among the accused along with Herrera, who moved to Paris Saint-Germain over the summer on a free transfer from Old Trafford.

Real Zaragoza's coach at the time, Mexico's Javier Aguirre, is also on trial. Aguirre was sacked as Japan's coach in 2015 over his implication in the scandal.

Prosecutors suspect Real Zaragoza deposited 965 000 euros (US\$1 000 000) in the bank accounts of some of its players and coaching staff so that they, in turn, could bribe Levante players to deliberately lose the game. Investigating

An investigating judge shelved the long-running probe into the match in 2017 but the case was reopened following an appeal by state prosecutors, the Spanish League and Deportivo La Coruna, the club relegated as a result of Real Zaragoza's

Other match-fixing scandals have erupted in Spain over the years. As recently as In May police arrested several current and former players as part of a probe into a match-fixing gang that allegedly operated in the country's first and second divi-

CALIFORNIA - Top-ranked defending champion Naomi Osaka was ousted from the US Open on Monday by Belinda Bencic while Croatian Donna Vekic erased a match point to join the Swiss 13th seed in a quarter-final matchup.

Bencic's 7-5, 6-4 triumph, her WTAbest sixth over a top-five foe this year, ensured 21-year-old Japanese star Osaka will fall from atop the rankings next week and won't become the first repeat US Open winner since Serena Williams in

"The challenge cannot be bigger against Naomi," Bencic said. "I had to be at the top of my game and I'm really pleased how well I handled my nerves at the end."

Victory

Bencic, 22, matched her deepest career Grand Slam run from the 2014 US Open with her third victory of the year over Osaka, having also won at Indian Wells and Madrid. "She played pretty clean. She had a specific plan she wanted to execute," Osaka said.

"I guess just being aggressive." Australia's Ashleigh Barty, the reigning French Open champion, will move atop the rankings next Monday after the loss by Osaka, who defends her Australian Open title in January.

"I can look at this and be very disappointed and mad, but I'm not mad about it," Osaka said. "I'd like to reach higher rounds. That's definitely what I'll aim for in Australia."

Osaka's exit means there will be four different women's Grand Slam winners in a season for the third consecutive year, a first in the Open era.

Vekic, the 23rd seed, saved a match

GOD has led us this far, it's the month of September and our national team Sihlangu Semnikati is already preparing for their game against Djibouti, thus today we are discussing the team travel.

One of the challenges of modern football and the international game is the need to play in different cities and countries around the world and in different time zones. There is also the matter of providing medical care for athletes in a new and foreign environment. To be able to do this effectively requires careful planning.

One of the results of international travel is jet lag - the disruption of the normal circadian rhythm and a mismatch between the 'body clock time' and the new local time. This results in a variety of mental and physical effects. The more time zones crossed, the more severe and lasting the jet lag symptoms, and the latter are usually worse after flying eastwards than westwards. This appears to be because the body's circadian set-up naturally adapts better to westward trav-

Jet lag must be differentiated from travel fatigue, which can occur even when travelling north or south without changing time zones.

Causes of jet lag

The body clock controls physiologi-

cal functions in a rhythmic manner, following a 24-hour cycle. This phenomenon is known as the circadian rhythm and has exogenous as well as endogenous inputs.

Symptoms of jet lag

There are many symptoms of jet lag. Fatigue and insomnia are the most commonly described, and recognised, symptoms. In addition to these more common symptoms, a traveller may

experience a wide range of other physical and emotional symptoms. These

- Intermittent periods of fatigue
- · Difficulty in sleeping at the appropriate time
- Delayed onset of sleep after eastward flight
- Early awakening after westward flight • Irritability and mood disturbances,
- poor concentration Lowered motivation, subjective fatigue above the norm
- · Potentially poor performance in training and matches Irritability and experiencing a buzzing
 - in the head (headaches, disorientation) Poor appetite, gastrointestinal upsets

is adjusting to the new time zone, the individual may be susceptible to a reduction in performance. In the ideal situation during this adaptation period (and especially over the over the first two to three days following arrival), light exercise rather than strenuous training or competitive matches is advisable.

Infectious diseases

Some countries have specific health challenges which must be considered. Fortunately, up-to-date pre-travel information is readily available online. The CDC and WHO websites are excellent resources and should be consulted prior to departure. Malaria and Dengue-Vector borne diseases, like malaria and dengue are preventable. Avoiding mosquito bites by wearing clothing which covers exposed areas, sleeping under mosquito netting or screens and the use of mosquito repellents are all effective strategies to prevent being bitten.

While vaccinations are generally recommended for all travelers, in some situation's vaccinations are not optional. Vaccination against yellow fever prior to travel to endemic regions in Africa and South America is compulsory.


