

Soldiers find decomposing crocodile near barracks

MEMBERS of the Umbutfo Eswatini Defence Force made a grisly find of decomposing remains of a large crocodile near Nsingizini Barracks.

The reptile was found without its head, tail and feet.

The discovery was made over the weekend near the Mlumati River.

Demand

Speaking to this publication yesterday sources said the crocodile's parts are in high demand among traditional healers, especially the liver which is believed to be highly poisonous and efficient in eliminating enemies.

"The dead crocodile was discovered

by two soldiers who smelt the reptile's decaying body near the Mlumati River at the barracks.

"The soldiers then investigated the source of the putrid smell. After this, the solders then phoned the police to report the find. The police then drove to the scene and removed the decomposing animal. It is believed that the reptile was killed by professional poachers. The poachers then removed the essential parts to sell to traditional healers or collectors," said the source.

Important

"It is important to note that traditional healers pay a lot of money to obtain animal parts on the illegal black market. Crocodiles are protected by law, so members of the public are not allowed to kill them.

Unfortunately traditional healers use animal parts in their remedies on a regular basis and this drives the market for illegal animal parts.

"Police once told me that a crocodiles brain can be used as a poison to kill somebody, but this is just theory but if animals are being killed in strange ways, it is hard to argue with this logic they added.

The source said the family was shocked to be met by a dead person inside the flat.

Teenager kills herself after lover calls other women

A young mother (17) committed suicide by ingesting two weevil tablets after her boyfriend and father of her child (25) started asking for other women's phone numbers.

The young mother committed the suicide three months after giving birth to a healthy baby girl.

The suicide happened at a certain homestead at Nkamazi over the weekend.

Due to the fact that the deceased is a minor, this publication has withheld her identity for ethical reasons.

Speaking to this publication yesterday police said the deceased felt abandoned by her 'farming' boyfriend, who was busy asking for other women's phone numbers.

"The information we have is that the deceased's boyfriend was a successful 'farmer', who had a lot of money to spend. So, in 2017 the boyfriend in question met the deceased and impregnated her at Nkamazi.

At the time, the deceased was only 16 years old. After the pregnancy, the boyfriend then started to ask for other women's phone numbers from his under-aged girlfriend," he said.

"During the pregnancy, the deceased heard rumours from the community at Nkamazi saying her boyfriend was busy chasing after other women. In October, after giving birth, the deceased went to her boyfriend's homestead to confront him about the rumours. The boyfriend denied the whole thing but over the weekend the boyfriend asked the decesed to give him a phone number of another woman. This action confirmed the deceased's suspicions that her boyfriend was a womaniser, leading her to commit the suicide," they added.

When reached for comment telephonically, the boyfriend refused to speak to the media, saying nobody could prove that he was the only man involved with the deceased

MERIT PASS GIRL NEA GOMMITS SUIGIDE

A BIZZARE error by the Examinations Council almost cost the life of a young girl who was thought to be the only failure in her school but later discovered to have passed with a merit.


This is a shocking story of Nonhlonipho Sithole (12) who was doing Grade Seven at Christ The King Primary in Hlatikulu whose name was mistakenly deleted from the Exams Council computer system among the list of the pupils that passed the 2018 examinations.

The school in the recently released results had 15 merit passes, 38 first class passes, 26 second class passes and no third class pass but only one failure. It was thought the failure was Nonhlonipho, something which was discovered to be an enormous error as the girl got 73 per cent, a score qualifying her to be in the merit category.

Considered

It is said when the school got the symbols and teachers perused through them, it was found that Nonhlonipho's name was the only one missing. That raised curiosity as no one thought the girl could be the solitary failure as she was considered one of the hard workers who, throughout the year got position one and was never below five every year which made her one of the school's trump-cards.

Her teachers had expected her to



get a merit pass and nothing below that. It was a sad scenario when results were issued as her name was not there and this worried the teachers as well. It later transpired that a serious error had occurred and needed to be rectified. That was when the school authorities last Friday went to the Exams Council to find out what had actually happened where the blunder was discovered, Nonhlonipho's name was omitted.

It is unclear how the error occurred but information provided to the newspaper is that the school had initially requested to have a correction on another learner's name which was to be changed from Tiyandza to Ziyanda. It is said a correction was done and the Exams Council even sent the corrected register to the school. It transpired that a certain officer had deleted the name of Nonhlonipho but it was not clear whether this was a mistake or an error which somehow occurred while the correction on the name of the other learner was made.

Heated

The regrettable error to have Nonhlonipho's name deleted or omitted is now a heated debate with the girl almost killing herself. Those close to the matter have also revealed that when the school inquired the Exams Council officers did hint something that could have resulted to this blun-

"The school wanted explanation on how the girl's name was deleted. It was then that an analyst officer at the Council found that there was another officer who endorsed in another form that he/she was the one who deleted the name of the learner.

"The school wanted to know who had authorised that the name be deleted from the system and no one could provide a clear explanation. They (officers) promised to find out what led to this blunder and to make sure it is avoided in future," a source close to the matter said.

When the girl learned that she had 'failed', she was shocked and that was when she threatened to commit suicide.

Accept

"After being made aware that her name was not in the list, she was restless and she even planned to kill herself. Her parents became concerned and they tried to comfort her but seemingly she was not ready to accept what had happened.

"The school teachers and authorities also made efforts to comfort her but still this did not work until the Hlatikulu police (domestic and child protection unit) who are skilled to council someone in this situation were then roped in," said a source.

Principal Nurse Simelane did not want to delve on the issue, saying as much as she was aware of it, she was not at all prepared to go into detail about it. I am aware of the issue you are asking about. I think you better seek the details from the parents of the girl and the Exams Council," it's all Simelane could say when called

On the other hand Exams Council Registrar Dr Edmund Mazibuko said

Mom thankful to teachers

THE mother of the girl who threatened to kill herself after her name was omitted in the Standard Five results is full of praise to the teachers.

Khetsiwe Kunene, the mother of Nonhlonipho Sithole said teachers played a big role in saving her daughter's life as she wanted to kill herself after she was recorded as the only failure in the school when she had passed with a merit. "I thank the teachers, especially the administration. Had they not acted and found out what had taken place, I would have lost a daugh-

"They took it upon themselves to find out what happened and my daughter was found to have passed with a merit. It's sad that such an error almost cost the life of my child," said Kunene. Kunene also thanked the role played by the police counseling the girl.

Meanwhile, other commentators are calling for the Exams Council to issue a public apology to the girl, her family as well as to the school for this blunder.

nothing official was reported to him about the issue.

"I cannot comment on an issue which has not been brought to my attention. In short, I have not been briefed on anything like that," said Dr Mazibuko.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that police were engaged to provide counseling to the girl after she threatened to kill herself.

"We were engaged as police to counsel her as she was not ready to accept that she had failed. It's encouraging to note that as police we are called to intervene in such situations," said Supt Vilakati.

Govt in talks with SA over detained 40

GOVERNMENT and South Africa are in discussions regarding the release of the 40 Swazis detained in that coun-

Information gathered is that a letter has been released by the Eswatini High Commission in Pretoria, South Africa requesting for the release of the detainees.

At least 40 Swazis were nabbed by the South African Police Service (SAPS) nearly two weeks ago, December 30 precisely, for failing to produce travel documents after entering that country through an informal crossing.

In the mist of the 40 is a -30-year old woman of Somntongo, one Lindiwe Gina, who left behind a breastfeeding three-month-old infant.

The mother and the other Swazis from communities close to the Lavumisa Boarder Gate decided to travel to South Africa to purchase items for the New Year crossover. They are said to have used the Sitilo informal crossing by the Lavumisa Border Gate.

With the required documents provided to the Umbutfo Eswatini Defence Force (UEDF) personnel, the mother and her companions were granted pas-

Boarded

When they were on the South African side they quickly boarded a kombi that was set to ferry them to their destination, Phongola when SAPS raided their station. Passports were requested from all non-South African residents.

Failing to produce the requested tr el documents, the mother, together with an estimated 40 Swazis were loaded in South African police vehicles and ferried to holding cells. They are currently being held at Magudu SAPS holding cell.

Moreover, Foreign Affairs and International Co-operation Principal Secretary Joel Nhleko confirmed that the matter had been submitted to their offices. Nhleko said the ministry through the Eswatini High Commission was on the table with the South Africa in favour of the detainees.

"The ministry through the Eswatini High Commission in Pretoria is on the table with South Africa regarding the estimated 40 detained Swazis," Nhleko said, adding that the South African courts will resume work today.

He said the matter might not move as speedily as expected due to the fact that festive holidays were still on and most people return to office in the next few weeks.

Provided

Meanwhile, former Somntongo Member of Parliament Sandile Nxumalo, who became the Gina family's helping hand regarding the arrest of their daughter in-law, said they had provided the required documentations to the ministry of foreign affairs.

He said the affidavits were requested by the ministry in order for the matter to be addressed further.

Nxumalo said the mother and the 40 detained would go on trial on Wednesday. He added that the family prayed that the matter be addressed on Wednesday and for bail to be issued for the mother to return home to her infant.







of the New Year, some had to run for cover as a speeding car with a South African registration driven by a female sped into a shopping complex parking and ran over an innocent bystander.

A group of people who were at the complex, gathered at the gate and closed it in an attempt to apprehend the man, who ran into the flat.

All hell broke loose when the man, who was armed with a pistol and a knife (Rambo), started stabbing everyone he came across while threatening to shoot whoever got in his way.

It is alleged that the man stabbed four people in total before he fled the scene.

Upon investigation, it was gathered that the man, who was in the company of a female friend, who was the driver of the vehicle, was supposedly in a relationship with a woman who lives in the flat behind the shopping complex.

The two are believed to have children together, but have not been in good terms as they are currently involved in a fight for the custody of their children. The father who lives in South Africa is alleged to have threatened to take his children without the consent of the moth-

The mother is, therefore, believed to have called her brother to come and help her protect the children from their



The woman's brother who was also involved in the chaos, pulled out his knife and started stabbing innocent people who had been trying to apprehend the man who ran into the flat.

Temper

In an attempt to help his sister, the brother is said to have misinterpreted the situation and instead of going after the father who ran into the flat, he let loose his knife on the people who were gathered at the entrance gate.

Amidst the chaos, after the father, who is alleged to have been armed with a pistol, realised that he could not take his children, is said to have come out of the house and fled the scene, leaving the car and the driver to sort herself out.

The crowd tried to overpower the man carrying a knife, but it proved futile since he was threatening to shoot whoever came close to him and was stab-

bing whoever he came across. People scattered all over the place and the man subsequently fled the scene, leaving behind a bloody scene.

The angry mob turned on the car dri-

The mob started pelting the car with stones and any object they could lay their hands on, as they demanded that the driver gets out of the car. She is said to have managed to negotiate her way through the crowd and made it to the road where she sped off with the mob hot on her heels.

On that note, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the matter. She said the Ngwane Park commotion was reported to the police and they attended to it.

Vilakati said three people were stabbed, whilst one was hit with a stone. "They were taken to hospital and discharged the same night," she said.

THE Swaziland Democratic Nurses Union (SWADNU) has described 2018 as one of the toughest years since the union's formation in 1965.

The Nurses Union mourned the loss of one of their own Lindo Mlangeni, who was brutally murdered by her boyfriend, who is a police officer a few days before the New Year.

Workers

"2018 has been a very difficult year for public sector workers and nurses," SWADNU General Secretary Sibusiso Lushaba said in a statement

He said the manner in which the nurse was murdered and the fact that she was murdered by her lover, who is a police officer, leaves a lot to be desired.

"We reject the notion and created perception that she was brutally murdered because she owed her boyfriend money for tuition."

SWADNU added that they would fly their flag at half-mast in honour of all their fallen heroines and heroes this year.

"We salute their resilience and commitment to the struggle of the working class in general and nurses in particular."

Adding, Lushaba said last year, they had seen the tightening of austerity measures championed by the Bretton Woods institutions like the International Monetary Fund (IMF) and World Bank.

SNAT President Mbongwa Dlamini said the association remained one of the largest workers' unions in Eswatini, having been formed in the year 1928.

"In 2018, SNAT was turning 90 years of existence and as such, this giant organisation has weathered many storms in the social, economic as well as political arena. A political scan of the environment within which SNAT operates reveals that the organisation still has many more hurdles to overcome," he said in a statement.

Dlamini said last year, SNAT was able to hold the 2018 75th/8th Biennial Conference of delegates-the supreme decision making body wherein narrative and financial reports were discussed, resolutions passed and elections held.

Policies

The president said the 2018 conference was a turning point in the political life of SNAT since the ratification of crucial organisational policies took effect.

He said the implementation of these policies is underway and the membership would be informed in due course regarding the how and when parts of this process would take shape.

The policies included; organisational restructuring, education and training, conference standing orders, finance, compensation, conflict resolution, general council rules of procedures and constitutional amendments.

Change

Dlamini said when these policies finally get implemented, they will change the outlook of the organisation and its structures.

Adding, the president said a major policy decision was also implemented, which was holding elective congresses once every four years.

"This is a major shift from the biennial format. SNAT is under a new leadership from branches up to the national office and they shall serve up to 2022. Schools are expected to

follow this political direction." He said environmental politics posed many challenges to SNAT in 2018.

Predecessor.

Dlamini stated that even though there has been a new national government, led by Ambrose Mandvulo Dlamini, the nature of state politics has never changed, and their disabilities had remained unchanged.

The president noted that the current cabinet behaved the same way as that of the predecessor.

"Let us engage in the discourse regarding the source of our challenges. This will assist us in coming up with solutions that will benefit the workers and the wider society. Our successes on this one shall surely reverberate in the minds of future generations for a good many years to come."

Man gets E5 000 bail for assaulting live-in lover

AN employee of Excellent Security Company has been admitted to bail fixed at E5 000 for allegedly assaulting his live-in-lover.

"I am not trying to make fun of you, I ask the questions because of the bail conditions. Firstly, you are not supposed to have any contact with the victim," she said.

Lukhele stated that the reason suspects were not supposed to be in any form of contact with victims was because they turn to influence them. As a result of that, the victims then withdraw the charges. Mngometulu assured the court that he would not interfere with her, thus he will seek shelter from neighbours.

72 motorists arrested for drink-driving

AT least 72 motorists were arrested for driving while intoxicated over the past weekend.

I was rushing to hospital - DD accused

IT seems as though many drink driving offenders are nabbed on their way to hospital.

In many instances, offenders use this excuse when asking the court to be lenient when passing sentence. It was the same story when one Mongi Simelane (32) appeared before the magistrate's court after he was arrested for contravening the Road Traffic Act of 2007.

According to the charge sheet, the accused person wrongfully and unlawfully drove a motor vehicle while under

the influence of an intoxicating substance.

When he was asked to take a breathalyser test, a content of alcohol reading as 0.72 mg/l was detected in his sys-

This is above the legal limit which stands at 0.37 mg/l.

Particulars of the offence included that the accused person was talkative and struggling to maintain his balance.

When the charge sheet was read to him, the accused person pleaded guilty to the charge.

His plea was also accepted by the crown without leading evidence to prove

commission of the offence. During mitigation, the accused person told the court that he fell sick after imbibing in alcohol while at home. He then took his vehicle and drove to the hospital as there was nobody else who could take him

The accused said he thought he had not yet exceeded the legal limit as he felt fit enough to drive. He then asked for a lenient sentence, saying he did not have enough money to pay for his fine.

He was accordingly found guilty by the court and was sentenced to four months in a correctional facility, with an option to pay E1 200 fine.

MAN ACCUSED OF STEAL TEMS WORTH OVER E86 000

THOKOZANI Bolly Ginindza (20) of Nsingweni was arrested and charged with 12 counts including attempted robbery, rape and others.

He appeared before Magistrate Sifiso Vilakati where the prosecutor made a plea that he be remanded in custody pending an application by the complainants to retrieve some of their goods back to them.

Over E86 000 worth of items were allegedly stolen by the accused.

The accused is alleged to have committed all these offences backdating to October last year to January this year.

The first offence is that of house breaking with intent to steal where on October 24, 2018, the accused is alleged to have broken into Nkosinathi Nyoni's house and stole items valued at E8 150.

These included a Grey HP laptop valued at E5 850, a grey Samsung phone valued at E2 200 and a remote control valued at E100.

The accused is also alleged to have broken into Scolile Nxumalo's house of Esitebeni on October 25, 2018 where he is said to have stolen items valued at E10 700.

These included a Sony LCD TV 49 inch valued at E6 000, a black HP laptop valued at E3 500, a thrower blanket valued at E200 and money in cash



amounting to E1 000.

On November 7, 2018 at Esitibeni, he is alleged to have broken into Nozipho Phakathi's house and stole items valued at E8 060.

Items

The items included a Sony 40 inch TV set valued at E7 000, a pink duvet worth E300, a purple bath towel at E60, a purple gym bag at E400, an Olympia perfume valued at E300 and a pair of Puma sandals valued at E250.

On November 27 at Thokwane, the accused is alleged to have threatened one a female victim with a knife and forced her to remove her clothes, cutting her leggings with a knife and allegedly raping her, thereafter, stole items valued at E20 000, a LENOVO think pad valued at E10 000 and money in cash amounting to E10 000.

The accused is further alleged to have broken into one Thabo Dlamini's house on December 8, 2018 at Mahwalala, whereby he is said to have stolen items

A black Lenovo laptop with bag and charger valued at E4 500, a Huawei white tablet worth E3 000, a pair of maroon Nike sneakers at E600, three flash drives valued at E300, a blue Nike sports bag at E500, blue Puma pushins at E150, boots valued at E1 200 and three BVD shorts at E280.

On December 13, 2018 at Mahwalala he is alleged to have broken into a house belonging to Phila Mtsetfwa and stole items valued at E7 620. A black Hisense 32cm TV set valued at E3 500, a ZTE blade gold at E3 000, a vavy Blue DH jacket worth E600, a T-MAN trouser valued at E400 and two memory cards

Lastly, on January 3, at Mahwalala the accused is alleged to have broken into Mangoba Mdluli's house and stole an LCD AIM TV 32 inch valued at E2 500. He is set to return to court tomorrow for trial.

Vilakati said when a police officer's behaviour or conduct was unbecoming, one should go to the police station and report instead of stirring more trouble in the scene.

The accused was sentenced to pay a fine of E500 or five months in jail on each count.

Siphocosini resident charged with negligent driving

SIHLE Mavuso of Siphocosini was arrested for reckless driving after hitting a 14-year-old girl of the same area on December 21. 2018.

He appeared before Magistrate Sifiso Vilakati yesterday morning.

The accused told the court that the accident was not his fault as it happened at a junction in the area. He said the pedestrian got hit accidentally because she stepped into the road after assuming that he would make a turn.

"Your Worship I agree that I did

hit her, but it was an honest mistake and I was driving at 20km/h," he said.

He also stated that after the accident, he called the police and rushed the victim to the hospital where she was attended to and found that she had not sustained severe injuries, thus was discharged same day.

He pleaded for leniency from the court and gave assurance that such would not repeat itself.

He was sentenced to five months imprisonment or pay a fine of E500.

He is said to have swerved his car on to a pavement as he had lost control due to speeding on a foggy day.



A drink-driving suspect disclosed his wish to be an ambassador for drinking responsibly after the traumatic experience spending the night behind bars.

Musa Dlamini (40) of Mbabane appeared before Magistrate Sifiso Vilakati yesterday after he was arrested for drink-driving on Saturday leading to him spending the night behind

He was arrested and charged with the offence of contravening Section 91(1) of the Road Traffic Act No6 of 2007 as read with Section 122(2) of the same act and is said to have had 0.55mg/l of alcohol in his system during his arrest.

Dlamini told the court that he was arrested at 2300hours and spending a



night in a holding cell was his worst nightmare and he intends to be an ambassador and tell others of the dangers of drink-driving.

Jail "I do not wish to ever go back to jail for drink-driving your worship, I spent

the whole night awake, akusiko mnandzi lengekhatsi. I will definitely be an ambassador and spread the word your worship," he said.

He further pleaded for leniency from the court and stated that he was a first time offender.

He promised he would not repeat such ever again.

Magistrate Vilakati warned the accused of such behaviour and stated that it was an embarrassing act to the accused's family and children.

"It also doesn't make sense that you would spend E200 on drinks only to end up parting with E1 500 or more in court just because you failed to get a taxi or an uber. Most of all this is embarrassing for you sir imagine your children saying babe uboshelwe tjwala;" Vilakati said. The accused was convicted and found guilty of the crime and was sentenced to pay a fine of E1 200 or 12 months in jail.



HOW BHOLI CLINIC DISSERVICES PEOPLE

BHOLI clinic is no longer what it used to be, says Regina Mthembu of Mahlabaneni area.

Bholi Clinic is located in the outskirts of Big-Bend in the Lubombo Region.

It was originally built by Methodist Missionaries together with Bholi Methodist Primary School. It is now a public clinic owned by Eswatini Government.

Mthembu bounced back from the health centre for two days during the festive season. It is alleged that the clinic was closed on December 25 and 26, 2018.

Normally, health care centres do not completely shut down their operations on holidays but Bholi Clinic was allegedly completely shut down.

In addition, when operations resumed on December 27, 2018 they only attended to a few patients.

By noon, it is reported that the nurses closed the doors, leaving a note on the door saying 'ongephakathi ongephakathi'

"After the clinic was closed for a good two days on the 27th, they worked a half day. By 12 noon they left a note on the door. Sick people and pregnant women were turned back," she claimed.

As if closing the clinic for two days was not enough, now they are taking advantage of the shortage of

According to the source, Bholi clinic does not have cards for pregnant women. These cards

that a woman undergoes when she is expecting.

The card is also used to monitor the growth of the foetus.

Through an investigation done by this publication, it is not only the Big-Bend clinic that does not have these cards. There is currently a shortage of them in the country.

Health care practitioners now make copies by photocopying them so that the pregnant women's records are kept until they are available. As some clinics are looking for an alternative to help the situation, Bholi clinic decided that they are not going to attend to pregnant women.

"Pregnant women who were here for their first check-up were sent back. They simply said we do not have emacard alabamitsi hambani endzevane."

Currently, Bholi Clinic is referring pregnant women

Endzevane clinic because they do not want to photocopy cards like any other health centre. Moreover, another source revealed that whenever the clinic is compiling its reports, they just shut down completely and leave a note at the door that reads 'do not disturb reports compiling is in progress'.

Nonhlanhla Ndwandwe from Bholi clinic denied the allegations.

"ngemanga laluhlata lawo," she said. She said the clinic did not shut down its operations completely for two full days. Ndwandwe also dismissed that they only worked a half day on December 27, 2018. She said the clinic did not open at its usual time.

"Actually on December 27, we did not open at 0830hrs but we were a few hours late. This was because the clinic's keys were misplaced. We were looking for them, thus delaying the opening," she said.

Adding, Ndwandwe said they would never turn back sick people and write crazy notes on doors.

"We are here to serve the community and we are regarded as the best clinic in this area.

"Those allegations come from malicious people. Even if you can come here as I am speaking, our dedicated staff is making sure that everyone receives treatment," she said.

When the Director of Health Services Dr Vusi Magagula was contacted, he said he still had to investigate the matter but declined to comment fur-

ther.

Education (FPE)? Seriously, government is failing to do its job."

Meanwhile, Minister of Education Lady Haward Mabuza when contacted said the progression policy is not new. She said it required teachers to put more effort in their work.

SWANCEFA CALLS FOR POLICY REVIEW

...after English language disaster

THE Swaziland National Campaign for Education for All (SWANCEFA) National Coordinator Nelisiwe Nhlabatsi has called for the ministry of education to have a policy that will scrap English language as a passing subject.

This comes after a total 2 935 pupils who sat for the Swaziland Primary Certificate (SPC) examination failed and 1 342 of them failed because they failed to pass the English language.

In an interview on Thursday last week, Nhlabatsi said the country could not rely on English Language because there are countries internationally whoich do not use English at all but use their native language.

"It is very unfair on the pupils to have English imposed to them as the passing subject because it implies that Liswati cannot progress without the knowledge of English, which is not true. We should be marketing our mother language and there should be a policy review that will see SiSwati being inducted as the passing subject," she said.

Nhlabatsi said a study has shown that there were high repeaters in Grade 6 because of English and government was wasting funds on the same class through the Free Primary Education (FPE), hence there was a strong need to review the policy.

Meanwhile, the Swaziland National Association of Teachers (SNAT) has expressed its disappointment after being left out in the press briefing of the 2018 SPC summary results. Apparently, there was an agree-

ment between the Examination Council of Eswatini (ECoS) in a meeting that was presided by the ministry of Education Principal Secretary Dr Sibongile Mtshali that SNAT would be informed on the external examination results in case there is an update, and that they would be part of the press briefing held on Thursday.

This was revealed by SNAT President Mbongwa Dlamini when sought for their reaction on this year's results.

He said he did not know anything about the results and it was news to him that they would be out on Friday.

"We were not involved in the whole thing, and it is very disappointing because we agreed that we would be informed. This proves that whatever we agree on with our stakeholders, they don't stick to it but buy our faces only when we are discussing about issues," he said.

After a short brief on the summary of the results, Dlamini believed the results would have been much better had government not pushed teachers into boycotting classes and striking by refusing to give them the 6.5 per cent Cost of Living Adjustment (CoLA), which saw members of the security forces take part in invigilating exams for security reasons.

"Results have become political in a way that they don't reflect any shortcomings even after the disturbance towards the external examinations, simply because the fault was with government but had it been the teachers who were at fault, they would have been pitiable," he said



purposeful, universal book with information that you can't find anywhere else. It is a Book from God, it is accurate, full of good advice, life-changing, and is inspired of God, as 2 Timothy 3:16 elaborates. It is a product of divine inspiration, a record of the relationship between God and humans and it gives us helpful principles to apply when we have problems"

The Bible is a sacred,

Romans 12:1-2 urges us to offer our bodies as a living sacrifice, holy and pleasing to God, for this is our spiritual act of worship'.

What does this mean? It means sport can also be offered to God as an act of worship and the gospel can be communicated to people through it. Sport is not some area outside of God's good creation; it is an integral part of it, a gift to be enjoyed, to His glory. And one may ask that 'if sport is a gift from God, then why is it often so bad, full of drugs, professional fouls, violence and cheating?'

Like any aspect of God's creation, sport has been distorted from its original purpose because of sin. Sin is not something 'out there' as if sport is the problem; sin is an internal disposition we all have to reject God and to distort His good creation.

We use our talents to seek our glory rather than to play to God's glory. We damage our relationships through cheating instead of playing fair; sin infects sport just as it does every area of human life. God doesn't want sport to remain tainted by sin, so He sent His Son Jesus Christ to be a substitute (a concept every sportsperson gets). He steps in to take the penalty we deserve, He is punished so that

we can go free, sent to the field of play so that we can get back in the game, how awesome is that? Now risen from the dead, Jesus Christ calls us to play to His glory as earlier stated by Romans 12:1-2, to 'offer our bodies as a living sacrifice, holy and pleasing to God, this is your spiritual act of worship.'

Illustrations

The New Testament uses illustrations of sports that were found during their specific time period, as a way to illustrate a teaching and provide more insight into it.

An example of a sports illustration to illuminate a spiritual truth is seen in the Bible when Apostle Paul writes and says; 'and everyone who competes for the prize is temperate in all things.

'Now they do it to obtain a perishable crown, but we for an imperishable crown,' in 1 Corinthians 9; 25.

In sports such illustration can be twined to the importance of self-control that sportspeople e.g. athletes need in order to obtain their prize. It goes without saying that sports people need a strict diet and an exercise plan in order to succeed to the best of their abilities.

The Bible has stories which makes one conclude that sport was there from way back, just that it wasn't

directly mentioned, but leaves one to figure out which sport was involved there. Crucially, such sporting activities(as may be depicted now, even though those people were not literally playing) were always at play to display God's power and to His glory. Some came during/after tests to the people involved and God being the provider, always made a way for His chosen ones. Take for instance: In Acts 27:41-44, we see Paul on a ship in the middle of a wicked big storm. He knew the ship he was on was going down, but was not worried? Why? Because he trusted God and a plan He would provide. The verse says" the rest were to get there on planks or on pieces of the ship. In this way everyone reached land in safety'. Planks here may have also been referred to as longboards, who knows? But it goes without saying that the sport, surfing, took place.

What about Jonah? I may not be an expert on how deep waters are sharks supposed to dominate in, but it's highly likely that the whale spit him out directly onto a piece of driftwood, and he surfed his way out to Nineveh. Another sport that is displayed in the Bible is wrestling. Genesis 32:24-25, says 'and Jacob was left alone. And a man wrestled with him until the breaking of the day. When the man saw that he did not prevail against Jacob, he touched his hip socket, and Jacob's hip was put out of joint as he wrestled with him.' Boxing also can be seen in the Bible, and more will be shared next week.

NOTE: The body is the temple of the Holy Spirit and thus worship is still tied to the temple, for wherever our bodies go, there is a sphere of worship.

Now he had begun a second term as the nation's president and secured the scrapping of term limits on the post - effectively allowing him to rule for life. Just two members of the National People's Congress voted against the change, out of 2,980.

Nine months later however, storm clouds are gathering.

China's economy has faltered in the face of US President Donald Trump's ongoing trade war, and tensions with Washington have spread to political and military issues.

There have even been rumours that Xi himself has come in for criticism behind closed doors for failing to adequately handle Trump and his policies.

"I don't think Xi's position is in any way under threat but he has a lot of enemies and critics and the collapsing relationship with the US is a stick they can use to beat him with," Richard McGregor, a senior fellow at Australia's Lowy Institute, told CNN.

Unfortunately for Xi, the trade troubles come ahead of possibly his most important year yet. The Chinese leader must navigate a series of critical and controversial dates for the Communist Party, including the 70th anniversary of the founding of the People's Republic of China.

At the same time, the clock is ticking on his trade truce with Trump, reached during their faceto-face meeting in Argentina early December, with just over two months left to bridge the gap between the two sides.

Xi's handling of events in 2019 could determine the future of China's economy and his place in the pantheon of Communist Party leaders.

Every 10 years, a series of important or controversial anniversaries creates a perfect storm for Beijing.

For Xi and the Communist Party, the 70th anniversary of the founding of the People's Republic of China on October 1 will be a seminal occasion.

The party will celebrate both its economic success and its unexpected longevity - surpassing the lifespan of the Soviet Union, the one-time communist superpower which collapsed in 1991 after 69 years.

Rana Mitter, Director of the University China Centre at Oxford University, told CNN that in the lead-up to the anniversary, Beijing would focus on glorifying the leaders of the Communist revolution. "Xi will seek to tie his current achievements to their legacy," he said.

This year also marks the 100th anniversary of the May 4th student protests in China, which were mainly a response to the betrayal of the country by Allied powers in the Treaty of Versailles following World War I -- but which the Communist Party now claims as a precursor to its own creation

Anniversaries for the Chinese government aren't only about celebration and ceremony. They're often used as highly symbolic milestones for progress or new policies.

For instance, the 100th anniversary of the founding of the Communist Party in 2021 has been set as the date for China to create a 'moderately well-off society.'

"There's obviously a sense that there will be a reckoning, a calculation up to this point of how the first 70 years have gone and plans for the next 70 years," Mitter

Not all important dates next year will be occasions to celebrate -- there are some Xi would rather the world forgot.

With US leaving, rival powers seek to move into Syria's East

BEIRUT — The planned UStroop withdrawal opens up a void in the north and east of Syria, and the conflicts and rivalries among all the powers in the Middle East are converging to fill it.

The sudden American decision to pull out its 2 000 troops has forced a reassessment of old alliances and partnerships. The Syrian government, the Kurds, Russia, Iran, Israel and Turkey have all had a hand in the country's nearly eight-year war each in a way, fighting its own war for its own reasons within Syria. Now all of those conflicts play out in the territory being abandoned by the Americans, creating new tensions, potential chaos and bloodshed.

To reassure jittery allies, Washington sent national security adviser John Bolton to Israel yesterday, to be followed by Secretary of State Mike Pompeo who is planning an eight-country tour of Arab allies this coming week.

Here is a look at what's at stake.

THE TERRITORY

The area up for grabs is around a third of Syria, forming a rough triangle. To the north is the bor-

der with Turkey, to the east the border with Iraq, and the third side is the Euphrates River. This was the heart of the Islamic State group's foothold in Syria until the United States partnered with a Kurdish militia, creating a force of some 60 000 fighters -including some Syrian Arabs and Christian Assyrians — that wrested it away from the militants.

The territory is strategically important. For the Syrian govemment of President Bashar Assad and its allies Russia and Iran, regaining it means re-establishing sovereignty. The territory was once the source of Syria's wheat

and barley, its dams generated electricity and it holds some of Syria's richest oil resources. Without it, Assad will have a harder time with reconstruction and operating long term. For the same reasons, it's been a source of income for the Kurdish militia.

For the Kurds, their hold gave weight to their long-sought goal of autonomy. For the US, the troop presence ensured American influence. Turkey sees Kurdish autonomy on its border as an existential threat and has vowed to prevent this, accusing the US. of empowering the militia Ankara says is linked to Kurdish insurNEW YORK - Mark Zuckerberg and Facebook have been inseparable since he launched the social network 15 years ago.

Shortly after it went public in 2012, it lost about half of its then US\$25 billion market value on fears it wouldn't be able to move advertising to mobile phones from desktop computers. Zuckerberg and Chief Operating Officer Sheryl Sandberg overcame that challenge, but they didn't change the basic model. What they did do was double costs. Assume the same happens in 2019 and operating expenses rise to US\$50 billion. Meanwhile, revenue growth slows to 24 per cent, according to the mean analyst estimate from Refinitiv's I/B/E/S, hitting US\$68 billion. Tax the profit at the standard corporate rate to arrive at US\$15 billion. On Facebook's current multiple of 17 times earnings, it would

be worth about US\$260 billion roughly a third less than its value at the end of November.

To survive and thrive, the company must do more than shift ads to yet another platform. As chairman, chief executive and control-

ling shareholder, Zuckerberg could continue to bumble along. But he would do better to relinquish his executive role to a manager better equipped to address the problems - perhaps someone from the heavily regulated financial world,

or a media executive. For inspiration, he could look to mentor Bill Gates. He gave up the CEO title at Microsoft nearly two decades ago. It is now one of the most valuable companies in the world.

ASSAD and RUSSIA

Without the Americans, the door opens for Assad and his Russian backers to move in.

"The only obstacle preventing Assad from gaining control of the east was the US presence and the cover that it provided to the (Kurdish militia). With that gone ... there is simply no real challenge that would prevent the regime from re-establishing control over those areas," said Ayham Kamel, of the Eurasia group.

Abandoned by the US, the Kurdish fighters are forced to move toward Russia and Assad for protection against their more feared enemy,

Turkey. Their force, armed and equipped by the US.-led coalition, is unlikely to disappear. Instead, it is seeking an arrangement with Assad to continue operating as the government extends control over the territory.

Syrian officials boast that the withdrawal is a defeat to America. Controlling the east would help seal Assad's victory in the civil

The American move also accelerates a trend by Arab states to normalize relations with Assad, whom they shunned for years. The United Arab Emirates, a close US and Saudi ally, recently reopened its embassy in Damascus.

TURKEY vs. KURDS, RUSSIA and ASSAD

Turkey's military, along with some 15 000 allied Syrian rebel fighters, is poised to launch an offensive in the east to break Kurdish control over the border.

But an offensive risks creating friction with Russia. In particular, it could wreck a cease-fire agreement the two reached over Idlib, the northwestern province held by rebels and Islamic militants where Turkey has influence enabling a Syrian government assault on the province. Russian and Turkish officials have been holding talks, trying to avert ten-

"A massive Turkish operation

is not in Russia's interest. It destabilizes the situation, risks undermining Idlib agreements and talks on reconstruction.

Plus, if Turkey decides to capture all of the Kurdish areas it will inevitably clash with Russia and Iran," said Yury Barmin, a Russia

Turkey is equally concerned over the prospect of Syrian government control over the east. In the past, Damascus has used the Kurdish militia as leverage against Ankara and could do so again. For nearly 20 years, Syria hosted the main Kurdish leader until he was captured in 1998, now imprisoned in Turkey.

LOCAL PRODUCE OUTSHINES SA IMPORTS

THE level of fresh produce supplied to retail shops by local farmers has seen an exponential increase when compared to South African imports.

This comes after the Minister of Agriculture Jabulani Mabuza reported in the previous year that local fresh produce had increased from E21 million to a record E60 million.

The index of market prices released by the ministry of agriculture last Friday for the week ending January 4, showed that the entire supply of vegetables, including cabbage, beetroot, green beans, green pepper, green mealies, carrots, butternuts, chilli pepper, green cayenne pepper, red cayenne pepper and lettuce came from local farmers.

South Africa, however, supplied peaches, litchies, plams, grapes, banana as well as red apples, oranges alongside the local counterparts. However, local farmers have raised the bar when it comes to sugar beans, jugo beans, mung beans, and sorghum as they are locally acquired. According to the index, trading was active in all the visited markets.

"In Manzini, the market was nearly out of stock with some few commodities on display due to a high volume of sales during the festive season. Prices of commodities continued to fluctuate, with some shooting up, while others remained constant. Mbabane market sales dropped than anticipated during the festive season, the report said.

drought which killed thousands of livestock and left over 200 000 people hit by food shortage. However the rainy reason is easing a lot of tension from farmers who were looking forward to this period.

Agriculture forms the base of the country's economy, as a large part of the manufacturing sector is agro-based

According to Sanele Sacolo in a study, 'Assessment of the Potential of Rainwater Harvesting for Improving Rain-fe Maize Production in Eswatini' Rain-fed agriculture is responsible for a great percentage of the food consumed by the world.

"In rain-fed agricultural systems, as the name suggests, rainfall is the most important input. In areas where rainfall is generally low and coupled by pronounced erratic patterns, low yields have always crippled farming communities," he said.

In addition, Rijkenberg said it is not unusual for banks to apply different pricing methodologies for their fees and services so long as they are not in violation of the prescriptions of the regulations. For example, bank A can decide to charge E80 for a dishonoured debit order payment, whilst bank X can decide to charge E90 with both banks still in compliance with the Legal Notice as both amounts are below the E100 limit.

Medium-scale farms are on the rise in Africa

JOHANNESBURG- Driven by population growth and growing land scarcity, most African farm households are witnessing the gradual sub-division of their land. Over time farms are getting smaller and smaller.

Today, over 80 per cent of farms in relatively densely populated countries - like Kenya, Ethiopia, Malawi and Rwanda are smaller than one hectare. Because they're so small, few can generate enough income to keep farmers above the poverty line and most of them increasingly rely on off-farm incomes.

But, from about 10 years ago, we have started to see evidence of a major rise in the number of mediumscale, African-owned

farms.

We found scale, African-owned that the rapid rise of these farms. medium-scale farms was being driven by a diverse

group of people including urbanbased professionals, influential rural people, and successful smallholder farmers who acquired more land and grew their operations.

Within the past decade, the amount of agricultural produce that these farms contribute to countries' national output has risen rapidly. In some countries, like Tanzania and Zambia, medium-sized farms now account for roughly 40 per cent of the country's marketed agricultural produce.

This isn't uniformly true across Africa. In land-constrained, densely populated areas like Kenya and Rwanda, small-scale farms still account for most of the agricultural output. Medium-scale farms are on the rise mainly where there is substantial, undeveloped land.

While much remains unknown and the story is still unfolding, we believe that medium-scale farms are an important driver of rural transformation in much of Africa - with mostly positive results.

For about 10 years there's been a prolonged surge in global food prices. This ushered in major, and much publicised, investment in African farmland by foreign investors. What happened largely under the radar were huge farmland investments by African professionals, entrepreneurs and civil servants.

The amount of land acquired by these medium-scale African farm-

ers since 2000 far exceeds amount acquired foreign by investors.

They are relatively wealthy and years ago, we have influential, often professionals, entrepreneurs or retired civil sernumber of mediumvants. Many accumulated wealth from non-farm jobs, invested in land and became

> either part-time or full-time farmers. Many are based in rural areas and have political or social influence with local traditional authorities. Others are urban "telephone farmers" who retain jobs in the cities, hire managers to attend to their farms and occasionally visit on weekends. In some countries, we also find that many current medium-scale farmers started out as small-scale farmers who successfully expanded their operations.

Medium-scale farmers bring new sources of capital and know-how to African agriculture. They have in some countries become a politically powerful group that are well represented in farm lobbies and national agricultural strategies.


WITH exactly two months away from the big move to be made by the United Kingdom (UK), leaving the European Union (EU) known as Brexit, the big question stands, is Eswatini still safe from the move?

The UK is due to leave the European Union on March 29, regardless of whether there is a deal with the EU or not. According to the ministry of economic planning and development, the country's exports will become comparatively more expensive for consumers in the UK when Brexit takes place. On the other hand, Eswatini will now be able to source imports from the UK for comparatively cheaper prices than before. The report revealed that because of Brexit, trade with the UK could be disrupted, thus decreasing potential economic growth for the country. It could also indirectly impact Eswatini's economy through the effects it would have on South Africa's trade with the UK. Exchange rates, on the include all terms contained in the European one hand, have also been impacted by Brexit, with the Pound devaluing by 20 percent compared to the Rand. This has both a positive and negative impact on Eswatini. On the one hand, an additional four billion is to be followed by a matching investment to the private

"With about 1.2-billion people on the continent, the agreement is set to create one of the largest free-trade zones in the world," the report said.

Other benefits to come with the move

Partnership Agreement (EPA) continuing to be existent, after the UK leaves the European Union (EU) trade bloc. These agreements then enable Eswatini to export primarily sugar and processed food, and in turn, import capital goods such machinery and other final consumption goods. The famous, or infamous, New Year's Resolutions are a common theme of the New Year. At the Office of the Ombudsman of Financial Services in Eswatini, the word has a great deal of significance. This significance is to who we are and what we do, not only in January but right throughout every month of every year.

What is a Resolution?

2. The action of solving a problem, dispute, or contentious matter: "the peaceful resolution of all disputes". Synonyms: solution to, answer to, end to, ending to, settlement of, conclusion to.

What is Dispute Resolution?


Dispute resolution is a term that refers to a number of processes that can be used to resolve a conflict, dispute or claim. Dispute resolution may also be referred to as alternative dispute resolution, appropriate dispute resolution, or ADR for short.

Why do we bring dispute resolutions?

Resolving disputes is central to our mandate.

The Office of the Ombudsman of Financial Services is tasked to resolve disputes arising within insurance, retirement funds, medical aid schemes, securities or investments, money lending and savings and/or credit services, which we have been doing this since November 2015.

The Office of the Ombudsman of Financial Services exists to create a level playing field between nonbank financial services providers



(FSPs) and their customers. By resolving complaints between parties, in a manner alternative to the traditional court system, we aim to give quick, reasonable and fair protection to the rights of all parties involved in a dispute no matter their varying positions and financial muscles. We do this with minimum formality and without requirement for an attorney.

OUR INTENT:

We aim to be a leading African forum in RESOLVING financial services disputes in a fair and accessible way.

OUR PURPOSE:

We RESOLVE non-bank financial services dispute in a fair and accessible way, in order to uphold good practice in the financial services industry.

How do we bring about dispute resolution?

Section 4 (1) of our Complaints Handling Procedure Guidelines states that 'in resolving disputes, the Ombudsman may make use of one or more of the methods of dispute resolution including facilitation, conciliation or mediation'.

What type of Complaints do

We investigate and resolve the following types of Complaints:

We afford all the parties an equal opportunity to respond and/or reply to all the complaint points raised in a dispute.

Our decisions can be reviewed by the High Court to test for procedural fairness and determine whether there may be bias in our dispute resolution process.

FOR ALL:

Our complaint forms are simple and easy to understand and fill; they are available at our offices and on our website in both SiSwati and English.

We also have complaint forms available in braille at our offices.

5 reasons to make sure your art is covered correctly

JOHANNESBURG - There are different risks associated with valuable art collections and it is important to make sure that you have the correct insurance cover, according to an industry expert.

Speaking to Fin24, Christelle Colman, Managing Director of Elite Risk Acceptances - a subsidiary of Old Mutual Insure, explained why it is important to get specialist cover for a valuable art collection.

Colman stressed that often people are disappointed to find that the insurance cover they have for their art collection is not adequate. She encouraged individuals to get a broker to help determine which insurance cover would be most comprehensive. "Something as meaningful as a personal art collection should not be overlooked when it comes to insurance and insuring the piece for the correct value and cover options, taking all the unique factors

such as the valuation of the artwork as well as the potential appreciation into account," she said.

Colman shared five reasons why individuals should get specialist cover:

1. Appreciating value

The value of the artwork could appreciate "dramatically", Colman said. For example, household contents would usually appreciate above inflation rate - for example between seven per cent and 10 per cent, but art appreciates

much more.

2. Death of an artist

Upon the death of the artist, the value of the artwork will also appreciate in value and the insurance cover should be adjusted for that appreciation.

3. Commissioned pieces

Sometimes individuals commission an art piece. In the case that there is a theft or damage to the artwork before it is completed, you need to have insurance cover to recover the deposit put down for the commissioned piece, explained Colman.

4. Rand exchange rate

Artwork value is subject to the randexchange rate, she explained. Insurance cover is needed in the case of the depreciation in the rand exchange rate.

5. Transit

Often pieces need to be transported from studios or galleries to the individual's property and specialist cover is needed for the risk associated with the transit. Colman encouraged individuals to do their research, either through a broker or even Google searches to compare différent insurance offerings, to make sure they will get the cover they need. Fin24



BRAZIL DEPLOYS TROOPS TO STOP VIOLENCE IN CEARA

CEARA-Soldiers will patrol there and across the state of Ceará in a bid to halt attacks on shops, banks and buses.

The justice ministry ordered the special deployment after dozens of attacks last week.

The attacks are a protest against new, tougher measures in local prisons, largely controlled by criminal gangs.

Prison authorities in the state have blocked mobile phone signals inside jails and ended a policy of separating inmates by gang affiliation.

The troop deployment comes just days after the inauguration of President Jair Bolsonaro, who was elected to office on the promise to fight rampant crime in the country.

Bolsonaro reportedly praised Justice Minister Sergio Moro's decision to send in troops as 'apt, rapid and effective'.

Moro previously led a vast investigation into Brazilian corruption known as Operation Car Wash.

Security videos aired on Brazilian

Fernando Haddad of the left-wing Workers' Party on October 28.

He is seen as a deeply divisive figure whose racist, homophobic and misogynistic remarks have angered many.

In his inauguration speech the president pledged support for the military and police, saying: "The national motto is order and progress. No society can develop without respecting these."

In an apparent reference to gun control, he said: "Good citizens deserve the means to defend themselves." He recently tweeted that he would issue a decree to allow citizens who did not have a criminal record to own guns.

Before becoming a politician, Bolsonaro served in Brazil's military, where he was a paratrooper and rose to the rank of captain.

He retains close links to the armed forces. **BBC**

DUBAI - Iran and Russia are preparing to hold joint naval exercises in the Caspian Sea, including rescue and anti-piracy drills, the commander of the Iranian navy was quoted yesterday as saying. "Tactical, rescue and anti-piracy war games between Iranian and Russian naval forces are being planned and will be implemented in the near future," the semi-official news agency Mehr quoted Rear Admiral Hossein Khanzadi as saying. Iran and Russia have held several naval drills in the Caspian Sea, including in 2015 and 2017. Iran and Russia have close ties, including in Syria where they both back President Bashar al-Assad in the country's civil war. *Reuters*

TEL AVIV - US National Security Advisor John Bolton has warned the Syrian government it should not see the impending US military withdrawal from the country as an invitation to use chemical weapons. US President Donald Trump said in December that US troops had succeeded in their mission to defeat Islamic State militants and were no longer needed in the country. Reuters



3 killed, 4 wounded in California shooting

China's population to be 1.44 billion in 2029

BEIJING - China's population will peak in 2029 at 1.44 billion before beginning a period of 'unstoppable' decline, a government report says. The China Academy of Social Sciences (CASS) study says the country must implement policies to handle a smaller workforce and an older population. Both changes combined could cause 'very unfavourable social and economic consequences', the report says.

'Yellow vests' protest at unrepentant Macron

PARIS - Rioters in Paris torched motorbikes and set barricades ablaze on the upmarket Boulevard Saint Germain on Saturday, as protests against high living costs and the perceived indifference of President Emmanuel Macron turned violent on the fringes.

The latest 'yellow vest' marches began peacefully but degenerated in the afternoon as protesters threw missiles at riot police blocking bridges over the Seine.

Officers fired tear gas to prevent protesters crossing the river and reaching the National Assembly. One riverboat restaurant was set ablaze and a policeman was wounded when he was hit by a bicycle hurled from a street above the river bank.

Two months after they started blocking roads, occupying highway tollbooths and staging sometimes-violent street protests in Paris, the yellow vests wanted to inject new momentum into a movement that weakened over the holidays.

Macron's government, shaken by the unrest, had this week hardened its stance, branding the protesters agitators seeking to overthrow the government.

No breakthrough in US shutdown talks

WASHINGTON - US House Speaker Nancy Pelosi said Democrats would pass new legislation to try to reopen parts of the government next week after talks between the Trump administration and Democratic negotiators on Saturday failed to end a two-week partial government shutdown.

President Donald Trump is demanding US\$5.6 billion to build a wall along the US border with Mexico but Democrats in control of the House of Representatives this week passed a bill to reopen the government without providing additional funding for the wall.

Trump says he will not sign the bill until he gets the money for the wall.

After a meeting aimed at breaking the deadlock failed on Saturday, Pelosi said House Democrats would seek to reopen government agencies next week through piecemeal appropriation bills, starting with the Treasury Department and the Internal Revenue Service.

"This action is necessary so that the American people can receive their tax refunds on schedule," she said.

Vice President Mike Pence led the administration's team

in the meeting with Democratic negotiators on Saturday. He said it was 'productive' but an aide said there was no in-depth discussion of a possible compromise level of funding for border security.

A Democratic aide familiar with the meeting said Democratic staffers urged the administration to reopen the government, arguing that progress on the contentious issue of border security would be difficult while the government was closed.

The aide said the administration instead 'doubled down on their partisan proposal that led to the Trump shutdown in the first place.'

With the two sides sticking to their positions, a quarter of the federal government has been closed for two weeks, leaving 800 000 public workers unpaid.

Jared Kushner, Trump's sonin-law and a senior adviser, also attended the meeting at the White House, along with Homeland Security Secretary Kirstjen Nielsen and White House chief of staff Mick

They were negotiating with senior staff for the top Democrats in Congress, Representative Nancy Pelosi and Senator Chuck Schumer. *Reuters*



RAMAPHOSA TO HAVE 'FRANK DISCUSSION' WITH ZUMA

PRETORIA - President Cyril Ramaphosa is set to have a 'frank discussion' with his predecessor, Jacob Zuma, following concerns in the party that Zuma's comments on issues such as land go against the ANC's own policies, the Sunday Times reported.

The meeting is reportedly not expected to be antagonistic but Ramaphosa's advisers also want him to talk to Zuma about his stance on controversial issues, such as state capture and his court cases.

There are reportedly fears that Zuma's speaking out on issues that do not reflect party policy could create divisions in the party.

A source reportedly said Ramaphosa will also ask Zuma to rally behind the ANC's election campaign, which is expected to focus on land and jobs.

According to the publication, while the party's official position on land is expropriation without compensation is that it is necessary, Zuma recently advocated for the nationalisation of land, which is the EFF's policy, in a tweet.

The former president has also reportedly rejected any notion of state capture, although formally, the ANC supports the Zondo Commission of Inquiry investigating state capture.

ANC Spokesperson Zizi Kodwa reportedly confirmed that Ramaphosa and Zuma were going to meet, although he told the

Sunday Times that this was no different to how Ramaphosa had sought the counsel of former presidents Thabo Mbeki and Kgalema Motlanthe.

Outcomes

Meanwhile, the ANC will brief the media yesterday about the outcomes of its list conference, News24 reported.

The party is expected to announce the names of over 200 representatives that it will send to Parliament after the 2019 elections.

The ANC held its national list conference in Durban last weekend, with Ramaphosa and Zuma in attendance.

The party's list conferences have wrapped up in the provinces with the exception of the North West, which was only expected to complete its processes this weekend.

While the party has said this will not affect its national list conference, eNCA reported that ANC sources have privately confirmed that there is great concern about this.

A team of national leaders was reportedly sent to the North West in an effort to assist the province in sorting out its issues.

SURVEY: 61% OF VOTERS SAY THEY WILL VOTE ANC

JOHANNESBURG - Six out of 10 registered South African voters say they will vote for the African National Congress (ANC) in this year's national elections.

This is according to a survey by Ipsos conducted among 3 571 South Africans in late 2018.

The ruling party is followed distantly by the DA (14 per cent), EFF (nine per cent) and IFP (two per cent). The remainder (13 per cent) either said that they would not vote, would not vote for a current party, refused to answer or didn't know which party they would vote for.

Ipsos says these results are not a prediction of the outcome of the election, but merely a snapshot of voter opinion at the time of fieldwork and that closer to the election, possible election turnout scenario's will be developed.

Currently, only 79 per cent of those South Africans who are eligible to vote are also registered to vote.

Almost one in every ten (eight per cent) of registered voters either refused to share their party choice or have indicated that they do not know who to vote for.

Four in every 10 (39per cent) agreed that there is no political party that represents their views.

Ipsos also asked voters to indicate whether they are 'extremely likely to trust' or 'very likely to trust' a party, versus an opinion that they are inclined 'neither to trust nor distrust' the party, 'not very likely to trust' or 'not at all to trust' the party.

At the end of the Zuma years, trust in the ANC was very low, but the party has recovered quite significantly in the last year.

Bushiri lawyers shift xenophobia accusations from him

PRETORIA- Attempts to dismiss a protest by the South African National Civic Organisation (SANCO) against self-proclaimed Prophet Shepherd Bushiri's Enlightened Christian Gathering Church as xenophobic are 'utter nonsense', and is an attempt at shifting the blame away from the pastor, the organisation says.

Three people died during a stampede at the service on December 28.

Police are investigating a case of defeating the ends of justice, News24 reported, after allegations that the

incident was not immediately reported to the police.

The bodies of the deceased were allegedly taken from the scene to a private mortuary.

The police were only told about the incident the following day.

It is believed that the stampede occurred when congregants stormed the church building to seek shelter during a thunderstorm.

On Friday, Pretoria residents threatened to prevent the church's services from going ahead, and blockaded the entrance to the Pretoria showgrounds where the church is situated.

Pretoria SANCO Regional Secretary Portia Mokwena said Bushiri's church should not be allowed to operate until he explained what happened.

Bushiri's lawyer, Terence Baloyi told Eyewitness News on Saturday that this was a 'xenophobic attack' by SANCO. The deceased were reportedly buried on Saturday. In a statement, SANCO's Greater Tshwane Region said the church, through its lawyer, was trying to divert attention from the matter. "We would like to dismiss such utterances as utter non-

sense and just avoidance of accountability on the side of the church. We are also not surprised that the whole matter seeks to place prophet Bushiri as a victim, while the real victims were buried today. "We are not shy to express our concerns that most foreign nationals who opened churches here are always jumping from one controversy into the other. As an organisation, we will confront the mushrooming of these churches and if need be ensure they are closed down," SANCO said.

ANC vets party election list

DURBAN - ANC bigwigs descended on Durban last weekend for the party's National List Conference, which will determine who makes it on to the list of 200 candidates nominated to represent the party in the National Assembly after next year's general elections.

The party held the conference in uMhlanga, north of Durban, on Friday and wrapped it up yesterday before proceeding with an extended national executive committee (NEC) meeting.

To kick-start a week of ANC activities in Durban, the party will tomor-

row celebrate its 107th birthday since its inception in 1912 at the Ohlange Institute in Inanda, which was founded by the ANC's first president, Langalibalele Dube.

This will be followed by its election manifesto

launch at the Moses Mabhida Stadium, on Saturday. The ANC says it expects up to 140 000 supporters to descend on the stadium and its outer fields.

ANC deputy secretary-general Jessie Duarte said that in compiling the list they were looking for demographic representation and gender parity. *IOL*

CAPE TOWN - The number of operational South African Police Service (SAPS) members will be increased from 194 000 to 250 000 and that number boosted with a strong police reservist force when the Democratic Alliance comes to power, DA leader Mmusi Maimane said on Saturday.

"When the ANC government refused our demands for a special anti-gang unit, we did it ourselves in the City of Cape Town under the leadership of JP Smith. And finally, years later, they realised that it was the right thing to do and reintroduced the specialised

unit," Maimane told a DA voter registration rally in Bonteheuwel in Cape Town.

MIRACLE MAN DECLARED 'BRAIN-DEAD' WAKES UP

...After his family turned off life support - and he's now home and thriving

OMAHA- A father-of-four whose children had decided to remove his breathing tubes has recovered and left an Omaha hospital after weeks of therapy.

Now his family members call T. Scott Marr - once nearly brain-dead - the 'miracle man.'

Marr was diagnosed with a stroke on December 12, the day after his 61st birthday, after he was found lying in his bed, unresponsive but breathing.

He was rushed to Methodist Hospital and soon placed on a breathing machine in intensive care.

Marr showed no neurological improvement by the time his family returned the following day. Brain swelling - primarily in the back of the brain - concerned his doctors.

"We were worried in this case that this was not a reversible process and that it was going to proceed to brain death," said Dr Rebecca Runge.

His daughter Preston Marr said she and the rest of the family faced a harsh reality: Scott Marr was not expected to recover.

"He had always said, "I never want you guys to see me lying in a hospital bed, lying in a nursing home," Preston Marr said.

"They told us he was on his way to brain death, so we said our goodbyes before extubating him, all the monitors were shut off and we waited by his side," she said.

He kept breathing.

He was still breathing on his own the next morning when his children returned after skipping their appointment with a funeral home.

'I asked him to move his thumbs, and he slowly moved his thumbs,



and I asked him to wiggle his toes, and he wiggled all his toes really slightly," Preston Marr said.

His doctors soon ordered another test.

It showed that Scott Marr was suffering from a rare condition called posterior reversible encephalopathy syndrome.

"It's commonly caused by high blood pressure, but there are many things that can cause it," Dr. Runge said.

The severe swelling Marr experienced is not typical of the syndrome, she said, which is why a devastating stroke was the initial diagnosis.

Marr credits his faith for his survival.

'I don't want to make this into a huge religious thing but I'll tell you what: It was pretty much a miracle,' he said. *Daily Mail*

DRC ON EDGE AS ELECTION RESULTS POSTPONED

KINSHASA - The DR Congo was on edge on Saturday as officials delayed the announcement of preliminary results from a crucial presidential election amid growing pressure from world powers to respect voters' wishes.

Preliminary results, scheduled for release yesterday, will now come out only this week, the head of the country's electoral commission told AFP just hours before the deadline.

"It is not possible to publish the results on Sunday (yesterday). We are making progress, but we do not have everything yet," Comeille Nangaa said.

Anew date has not been announced. The December 30 vote saw 21 candidates run to replace President Joseph Kabila, who has ruled the vast, conflict-ridden country for almost 18 years.

Among the frontrunners were

Kabila's handpicked successor Emmanuel Ramazani Shadary and two opposition candidates: veteran heavyweight Felix Tshisekedi and newcomer Martin Fayulu.

At stake is the political stewardship of a mineral-rich country that has never known a peaceful transition of power since independence from Belgium in 1960.

Kabila had been due to step down two years ago, but managed to cling on to power, sparking widespread protests which were brutally repressed, killing dozens.

The December 30 vote, preceded by repeated delays, was relatively peaceful. But tensions have built over the lengthy counting process, amid fears the results could be manipulated to install Kabilabacked Shadary in power.

The Independent National Electoral Commission (CENI) had promised to announce preliminary results yesterday, followed by a defini-

tive count on January 15.

The new president would be swom in three days later.

But Nangaa told AFP less than half of ballots had been counted by Saturday afternoon, adding: "Next week (this week), we will announce." The move could stoke tension in the unstable central African nation of 80 million. Nangaa has blamed the slow count on massive logistical problems in a country the size of Western Europe with poor infrastructure. *AFP*

Fight over gas fields to charge SA man

MAPUTO - A battle for a stake in Mozambique's lucrative offshore gas fields is believed to be behind the arrest of South African businessman Andre Hanekom. Hanekom, 61, known as baba mzungubaba mgungu (white father) to locals in the coastal hamlet of Palma in northern Mozambique, has been in custody for five months despite a magistrate granting him bail in October. He is charged with terrorism following his dramatic arrest last August in which he was shot in the arm and stomach by officers wearing camouflage uniforms and balaclavas.

denying there are political prisoners in Egypt, where he has overseen one of the largest crackdowns on dissent in the country's modern history. CBS, which will air the full interview Sunday on its show "60 Minutes," says it rejected a request by the Egyptian government not to show it.

Unregulated medicines flooding into Zimbabwe

HARARE - Unregulated and unregistered medicines are reportedly flooding into Zimbabwe, with consignments of expired medicines being smuggled into the country through the country's porous border posts.

Syndicates are allegedly taking advantage of steep United States dollar prices being charged by pharmacies following the collapse of the value of Zimbabwe's surrogate bond notes and electronic money.

The high prices being charged have left patients at high risk, as they are resorting to cheap and unregulated medicines coming from neighbouring Mozambique and Zambia.

Samuel Gamanya, a pharmacist in Harare's central business district, said the influx of unregulated medicinal drugs had been on the increase since November when there was an acute shortage of essential drugs.

"We have had unregulated drugs flooding the country since November 2018 after essential drugs became scarce, and later on when they were priced in the US dollar," he told African News Agency (ANA). "These drugs, we hear, have been smuggled through Chirundu and Forbes border posts," he said. Medical Control Authority of Zimbabwe (MCAZ) public relations officer Shingai Gwatidzo said the influx of unregistered drugs had been observed in the country and they were working with law enforcement agencies to curb the situation. News24

Protesters plan march as, health minister sacked

KHARTOUM- A Sudanese group organising anti-government protests has called for a march on the presidential palace as President Omar al-Bashir sacked the health minister Saturday over rising costs of medicines.

Deadly anti-government rallies have rocked cities including Khartoum since December 19, when protests first broke out over a government decision to raise the price of bread.

Authorities say at least 19 people including two security personnel have been killed in clashes during the demonstrations so far, but rights group Amnesty International has put the death toll at 37. "We call on our supporters to gather at four different places in Khartourn and then begin a march on the palace" of

the president on Sunday, the Sudanese Professionals' Association said Saturday in a statement. The association, which includes teachers, doctors and engineers, has held similar rallies in recent weeks but they have been swifty broken up by

riot police. Security forces were deployed in key squares across the capital on Saturday night.

Late on Saturday, Bashir sacked minister of health Mohamed Abuzaid Mustafa, the official SUNA news agency reported.

He has been replaced by Al-Khier Al-Nour, SUNA said without giving details. Rising drug prices and shortages have added to the anger of protestors already furious over the cost of other key products. Sudanese pharmaceutical companies have been unable to import some medicines after a years-long foreign currency shortage worsened last year. But even as protesters called for a new march on Sunday, Sudan's education ministry ordered the reopening of schools in Khartoum from Tuesday.

US sends troops for possible violence in DRC

WASHINGTON - On the eve of the first expected results of Democratic Republic of Congo's long-delayed presidential election, President Donald Trump said military personnel had deployed to central Africa to protect US assets from possible "violent demonstrations".

While the country's power-

ful Catholic church warned of a popular "uprising" if untrue results are announced.

DRC faces what could be its first democratic, peaceful transfer of power since independence from Belgium in 1960, but election observers and the opposition have raised concems about voting irregularities as the country chooses a successor to longtime President Joseph Kabila. The first results are expected on Sunday, and the United States and the African Union, among others, have urged DRC to release results that reflect the true will of the people. The US has threatened sanctions against those who undermine the democratic process. Associated Press

Police officer killed defusing church bomb

CAIRO - A policeman was killed while trying to dismantle an explosive device outside a Coptic church in Egypt on Saturday, a security source said. Two other officers were also wounded in the explosion as security personnel attempted to defuse the device in Nasr City on the edge of Cairo, the source added. It had been hidden inside a bag that was searched by police. The policeman who was killed, Mustafa Abid, was a specialist in mine clearance. Coptic Christians, who account for around 10 per cent of Egypt's population, have been targeted in a string of attacks by the Islamic State group in recent years.

KHARTOUM - A prominent Sudanese journalist who had been detained for expressing his support for anti-government protests has been freed, he told AFP on Saturday. Faisal Mohamed Salih had been arrested last Thursday from his office by agents of the country's powerful National Intelligence and Security Service (NISS). Salih, recipient of the 2013 Peter Mackler Award for ethical and courageous journalism, said security agents had taken him in for questioning over his views about the protests that erupted across Sudan on December 19.




will start next year.

Djokovic's conqueror Bautista Agut takes Qatar Open title

DOHA -Roberto Bautista Agut followed up his shock victory over world number one Novak Djokovic by lifting the Qatar Open title on Saturday.

The Spaniard ground out a hardfought victory in three sets against the Czech Republic's Tomas Berdych, winning 6-4, 3-6, 6-3 in the final.

'It's been a fantastic week for me,' he said immediately after his triumph. "Today it was not easy to manage all the emotions I had on court." It was the 30-year-old's ninth career title and his first in Doha.

Bautista Agut will rise one place in the world rankings to 23 on the back of the victory in Qatar, and said his aim was to go higher.

"Why can I not be close to the top 10?" he asked afterwards.

He added that his immediate aim was to 'be fresh' and then win as many matches 'as I can' in Melboume at the Australian Open.

The victory came 24 hours after

he beat Djokovic in the semi-final, also in three sets.

He also beat three-time Grand Slam winner Stan Wawrinka in straight sets earlier in the week.

In total, Bautista Agut only lost two sets all week in his five match-

The Spaniard made the decisive break of serve in the third game of the final set to take a lead he never lost.

Wildcard Berdych threatened to break back but squandered two points on Bautista Agut's serve in the seventh game.

"Roberto was too good, so well done for the title today, but I am happy for the week," said Berdych, whose 2018 season was blighted by a back injury.

The defeat was the second time Berdych has lost in the Qatar final, the first occasion was in 2015 to another Spaniard, David Ferrer.

Pliskova overhauls Tsurenko to win Brisbane title

BRISBANE - Karolina Pliskova used all her big match experience as she came from a set down to overhaul Ukraine's Lesia Tsurenko and win the Brisbane International yesterday.

The unseeded Tsurenko looked headed for the biggest win of her career when serving for the match at 5-4 in the second set, only for Pliskova to come storming back to win 4-6,7-5, 6-2 and claim her second Brisbane title.

Pliskova, the tournament's fifth seed, started slowly and paid the penalty against Tsurenko, who was serving superbly and winning the battle from the baseline.

Tsurenko took the first set in 38 minutes, firing 10 winners and making 81 percent of her first serves.

She took that form into the second set and broke Pliskova early.

However, serving for the match at 5-4, she tightened up and Pliskova won 13 of the next 14 points to level the match.

The third set was all Pliskova as she broke Tsurenko twice to wrap up the final in two hours, 12 minutes.

The Brisbane title is the 12th of the world number eight's career and sets her in good stead ahead of the Australian Open.

The 26-year-old has long been touted as a future winner of a Grand Slam, but despite a stint as world number one, her best result in a major was runner-up to Angelique Kerber at the 2016 US Open.

Wolves are close to agreeing a loan deal with Chelsea for Tammy Abraham.

Sportsmail revealed last week that the Molineux side was heading the chase for the 21-year-old who has scored 16 goals while on loan at Aston Villa

Abraham is keen to play in the Premier League and Wolves want competition for Raul Jimenez. Chelsea, who have until January 14 to trigger his recall, are reluctant to agree to a sale now despite Wolves intimating they would be willing to offer around £18m.

TOTTENHAM AIM TO OPEN NEW STADIUM IN MARCH

LONDON - Tottenham's new stadium has faced delays and complications for the past year, but it finally seems as though it will be opening in March.

According to The Sun, Tottenham are aiming to have their first game in their new stadium against London rivals Crystal Palace on March 16.

However, if Spurs continue to progress in the FA Cup after their 7-0 thrashing of Tranmere, the first game could be pushed back to April because of fixture clash.

There will be a meeting on Sunday with contractors Mace to discuss the progress of the project.

One report says an optimistic target for the opening of the stadium is as early as February, however a March opening seems more likely after all of the delays the stadium has seen so far.

Rumours

Both Spurs vs Newcastle and their match against Leicester in February are due to be televised, which led to more rumours about an earlier opening. With those dates looming through, the project, which has already costed upwards of £850million, would face a race against time.

Tottenham will also play arch rivals Arsenal in March, however police will reportedly oppose plans to open the stadium with that fixture.

LONDON Former Manchester United boss Louis
van Gaal believes Liverpool

Willard Katsande was coming in between two centre backs, they had more midfielders and we struggled to deal with George Maluleka because he was the one supplying the ball, and Lebo (Lebogang Manyama) was causing a bit of a problem on the right hand side.

"He knows how to find the space in the pockets and we struggled to deal with him. Their two fullbacks were aggressive coming out and it was tough having to deal with them too," said Mosimane.

"At halftime I had to sort it out and find a way to play and we settled in the second half but, to be honest, in the first half we were a little bit uncomfortable because of the way Chiefs played.

"And if you looked at the way they played against SuperSport United (last month), it was so very different, so you've got to be on your toes all the time. It is a sign of the quality of the tactical awareness of their coach (Middendorp)

"I'm wondering how many other teams will come here and get points (off Chiefs). It won't be easy.

"A draw would have been a fair result but football is what it is and I cannot say I'm not happy at taking the three points. Mistakes are part of the game. 

Rugby Premiership threaten to split from the RFU

LONDON- Premiership Rugby have threatened a radical move to break away from the RFU and form their own independent league.

In board meeting minutes seen by The Mail yesterday, club chairmen discussed an 'unregulated competition' if the RFU refuse to scrap promotion and relegation.

Amid claims that the Championship is a 'monetary disaster', the clubs are becoming increasingly rebellious following a year of tension with the governing body. But a breakaway would jeopardise the £30million a year Professional Game Agreement with the RFU, sacrifice the game's framework and could prove catastrophic for the national team.

Board minutes stated: "If the RFU were to be unwilling to support change, we shall need to ensure access to match officials and player insurance cover (as this is a joint policy), as this would potentially become an unregulated competition." With private equity firm CVC due to imminently inject £200m of capital, top flight clubs are increasingly keen to ringfence the league to provide financial security.

Formula One supremo Bernie Ecclestone, who was consulted by CVC over the deal, told the Mail yesterday: "CVC will grow it to make a profit. If you got hold of the guys and tarted them up, it would be better than American football."

CAPE TOWN - Proteas skipper Faf du Plessis insists that he and coach Ottis Gibson do not ask ground staff for anything "ridiculous" when preparing pitches for home Test matches.

South Africa beat Pakistan by nine wickets in the second Test at Newlands yesterday morning, taking an unassailable 2-0 lead to win their seventh home Test series in a row.

Under the Du Plessis/Gibson era, which began when the West Indian took the reins in August 2017, there has been a spotlight on South African Test wickets. That conversation reached boiling point in last year's home series against India when the third Test at the disastrous Wanderers strip very nearly saw the match called off because of its uneven and unpredictable bounce. After day two at Newlands last Friday, Pakistan coach Mickey Arthur took the issue even further by slamming the pitches in Cape Town and Centurion (the venue for the first Test) by saying that they were not up to Test match standards.

The bounce in Cape Town was uneven at times, but that didn't stop Du Plessis from carding a century on day two while there were no less than seven other scores of over 50 in the match.

"We never ask for ridiculous pitches. We just ask for pace and bounce," Du Plessis told media on Sunday morning after the win.

"You have to adapt your game and Temba (Bavuma) was a great example. In two Test matches in a row now on tough pitches he has scored runs and it shows you that it is possible if you apply yourself mentally and you have a technique."

Federer and Belinda Bencic beat Alexander Zverev and Angelique Kerber 4-0 1-4 4-3(4) in the mixed doubles decider to win the trophy at the Perth Arena in a repeat of the 2018

The world number three had earlier shown why he is a firm favourite for the season's first major, firing 24 winners and nine aces in a flawless 646-2 victory over ATP Finals champion Zverev.

Kerber too maintained her 100 per cent singles record with a 6-4 7-6(6) victory over Bencic to level the tie at 1-1, but the Germans failed to make the most of their opportunities as they went down in the tight mixed doubles rubber.

"I'm happy I'm feeling this good and playing as well as I am," said Federer, who has won the last two Australian Open titles after taking part in the mixed-team event.

Federer has beaten Frances Tiafoe, Stefanos Tsitsipas, Cameron Norrie and Zverev in straight sets and will be full of confidence heading into Melbourne Park later this month.

Kevin Anderson wins sixth title

PUNE - The 32-year-old South African clinched his sixth tour-level title after two hours and 44 minutes, recovering from 2/5 down in the final-set tie-break to beat Ivo Karlovic 7-6(4), 6-7(2), 7-6(5) in the tallest ATP Tour final in the Open Era.

Breaking the record previously set by Anderson and John Isner at the 2013 BB&T Atlanta Open, 6'8? Anderson won 88 per cent of firstserve points (57/65) to overcome 6'11" Karlovic.

"I really wanted to go one step further than last year... You don't get to win tournaments every week, so when you do it is very special and it is something that definitely means a lot to me," said Anderson at the trophy ceremony. Now 7-1 in Pune, Anderson notched his fourth victory in five FedEx ATP Head2Head meetings against the 39-year-old to improve his record in tour-level finals to 6-13. Last year, Anderson reached a personal-best five championship matches on the ATP Tour, picking up titles in New York and Vienna en route to his maiden appearance at the season-ending Nitto ATP Finals in

In a set with few opportunities on return for either man, Anderson earned the only break points of the set in the tenth game. The South African connected on multiple returns and fired passing shots past the World No. 100 to manufacture two set points. Despite being unable to take advantage of either opportunity, Anderson soon moved into a one-set lead.

The World No 6 capitalised on a costly double fault from Karlovic to earn the first mini-break of the tiebreak before immediately doubling his advantage for a 5/2 lead. A low return placed at the laces of his opponent opened up the three-point gap, with Anderson eventually taking the first set courtesy of another double fault from his opponent.

Pressure

Once again, Anderson applied pressure to Karlovic's serve in the second set. But, despite earning four break points, the South Africa unable to avoid a second tie-break as Karlovic found success charging the net under pressure. From there, Karlovic levelled the match as Anderson leaked uncharacteristic errors on his serve and forehand. After Karlovic saved two championship points at 5-6 (15/40) with back-to-back aces, a final-set tie-break was required to decide the champion. 


