



### SHOCK AS DRUNK MOTHER SLITS HER 8-MONTH-OLD TODDLER'S THROAT

A 12-year-old girl got the shock of her life when she witnessed a brutal murder of her eight-month-old relative by his mother.

The incident is said to have happened on Wednesday afternoon at Nhlambeni.

According to sources, the mother of the eight-month-old baby; Nontobeko Nokukhanya Mamba (23) is said to have committed this gruesome murder after an intense fight with one of her sisters who was also at home.

Leading to this gruesome murder, Nontobeko is said to have returned home from a drinking spree in the year-old and she verbally tormented afternoon and she was shouting that she was pleased with the manner in which she had dealt with one LaShongwe.

She is understood to have had a fight with LaShongwe whom she was with at the drinking hall after the two failed to see-eye-to-eye, although the bone of contention is not quite clear.

#### Shouted

When Mamba shouted at the top of her voice that she had dealt with LaShongwe for everyone who cared to listen, the unnamed sister is said to have light-heartedly said Mamba would be arrested for assaulting people when drunk.

This did not sit well with the 23-

her sister; asking why she interfered in her business. At this point, she is also alleged to have gone for a bush knife and attempted to hack the sis-

The sibling however, is said to have managed to dodge the weapon and retaliated.

The physical altercation is said to have continued for some time as none of the two wanted to give up.

The situation was eventually helped by their brother who broke them up. In doing this, the brother reportedly led Mamba into a house in which he locked her.

The intention for this was to calm her down as she was intoxicated, little did he know that this would lead to even bigger problem.

While in the house, Mamba is said to have lost her sanity and slit the toddler's throat with a bread knife.

The sound from the toddler's screams is said to have attracted the 12-yearold girl's attention.

Since she was outside the room in which the incident happened, the teen peeked through the window only for her to witness the horrific incident.

The gory sight she witnessed cannot be repeated, especially given the graphic nature of what she witnessed. Out of shock, the teen girl is said to

have called out to her uncle to tell him that Mamba was murdering her young son.

Reliable sources claimed that when asked about the matter, Mamba said she did not know what came over her that caused her to harm the innocent soul.

The child's father, according to sources, was at a loss for words when told of the shocking incident, saying that he was shocked by her actions.

#### Asked

When asked whether they had issues that might have led her to react in the manner that she did, the man claimed to have been in good relations with his partner.

Mamba was arrested and faces a murder charge. She appeared in court but was remanded in custody pending committal to the High Court.

This incident comes about two weeks after a two-year-old's throat was slitopen by a 15-year-old at Mbikwakhe. Before committing the offence, the teen boy allegedly placed the toddler's head on a log before he aimed for his throat.

#### Mkhulu (88) shot dead at Magwanyana

POLICE are investigating a case of murder where an elderly man of Magwanyana was shot dead by unknown person(s) while at a nearby forest.

The man who has been identified as Macumbane Mamba (88) is believed to have been shot on Tuesday afternoon while at the forest where he is said to have gone to cut some logs. He was eventually discovered by two women on Wednesday morning on their way to fetch water from a pond.

At the time he was discovered, Mamba was still alive and trying to crawl towards his home with a wound on his back. Sources close to the matter said the elderly man left home on Tuesday afternoon and headed towards a forest which is situated about two kilometres away from his home.

The elderly man's wife reported that her husband did not return home on the day. The forest is also used as a hunting ground as it is reportedly infested with wild animals.

During a closer inspection of the wound, it was concluded that the deceased had been shot using a gun which has not

The two women who made the shocking discovery raised an alarm while making arrangements to have the man rushed to hospital. He was taken to his homestead while paramedics and the police were called.

The man is said to have succumbed to death before the arrival of the paramedics and police. Chief Police Information and Communications Officer Superintended Phindile Vilakati confirmed the matter. Vilakati said police were still investigating the incident which is likely to be a case

"There has been no arrest as yet, but police are on the ground for investigations," said Vilakati.

### Charles Jele granted bail pending appeal

**FORMER Eswatini Royal National Airways Corporation** Chief Executive Officer (CEO) Charles 'Ace' Jele who is serving a five-year sentence, has been released on bail by the Supreme Court pending his appeal.

Jele was yesterday a happy man as he was expected to spend his first night at the comfort of his home after spending 11 months in jail following his sentence by the High Court to five years imprisonment without an option of a fine. Jele's appeal was supposed to be heard by the Supreme Court yesterday morning, however it transpired that some important information on his pension monies and rate currency issues had to be considered by the court in the appeal.

The court comprising the Chief Justice Bheki Maphalala, Justices Stanley Maphalala and Robert Cloete took an adjournment and resumed before noon.

It was then that the court ordered that both Jeles's defence counsel Derrick Ndo Jele, and the crown represented by principal crown counsel Thabo Dlamini should obtain Jele's pension and how the money he is alleged to have stolen was off-set against his pension. An application for bail pending the appeal was then made and the court ordered that he be released trial be extended pending finalisation of his present appeal on the initial E30 000 bail he paid before trial and further that the same bail conditions given by the

#### Convicted

The applicant (Jele) was convicted and sentenced to five years for stealing over E400 000 from his employer and he was further ordered to pay back the over E400 000 he stole.

Principal Judge Qinsile Mabuza suspended two years of the fiveyear sentence on condition he pays back the money. This effectively means that Jele is expected do time in jail for three years. The total sum of money he stole from his employer is E414 781 84, which was stolen on four different occasions as he was facing a total of four counts which he pleaded guilty to. On the first count, he was found guilty to have stolen E34 080, on the second count he stole E45 000 and on the third count he stole E13 736, while on the last count he



stole E321 965, totaling to the E414 781 84.

When passing sentence, Judge Mabuza took into account that Jele was 60 years of age and that he is a first time offender who lost his ob after being fired as a result of the theft from his employer.

Judge Mabuza also took into account that Jele went through a disciplinary process and that he was before court in respect of the same matter, hence the court is of the view that he was being punished twice for the same transgression. Citing the former Mhlatane principal corruption case, Judge Mabuza also took into account that a jail sentence would be hard on Jele and considered a suspended sentence ordering repayment as

per the Rex versus Makhubu matter. "The crime with which the accused is charged has become steadily prevalent, that is, in stealing from an employer, the accused in this case abused the position of trust that he occupied, th stolen may seem small but the complainant suffered prejudice as a result of the accused's theft, what is most disturbing is that he was a CEO at his place of employment which means he was completely trusted," Judge Mabuza had said during sentencing last year.

She mentioned that Jele previously enjoyed a position of respect and esteem in the community as CEO, however high standards of behaviour are expected of those who hold responsible positions.

### E77000 SALARY FOR PM

PRIME Minister Ambrose Mandvulo Dlamini's monthly salary has now been set at E77 197.

Annually, the prime minister will earn E926 370 excluding allowances.

The Deputy Prime Minister (DPM) Themba Masuku's monthly salary, on the other hand, has been set at E73 051 totaling to E876 614 annually, while Cabinet ministers will earn an annual salary of E741 095 which is set at E61 757 monthly. Chief Justice (CJ) Bheki Maphalala will earn E73 051 with the two parliament presiding officers having their monthly salaries set at E65 617.

This is contained in a new remuneration framework that will be fixed for the next three years of the 11th Parliament.

This is according to a summary report of the Royal Commission that was appointed by His Majesty King Mswati III in March last year to review the terms and conditions of service of the 11th Parliament and statutory Boards and Commissions.

#### Submitted

The report that has already been submitted to the King for approval and was also presented to Cabinet this week is in preparation of a circular to be issued by the ministry of finance on the terms and conditions of service of the politicians, the Attorney General (AG) and *Emabandla* (Commissions.

Following previous countless calls by members of the public for reviews of the politicians' hefty salaries, especially that of Cabinet ministers having fallen on deaf ears, pleas presented to His Majesty during the people's parliament (Sibaya) about three years ago were finally heard and the King took the bull by its horns. His reaction was to appoint the seven member commission headed by Swaziland Sugar Association (SSA) Chief Executive Officer (CEO) Phil Mnisi as Chairman with top Mbabane based lawyer Sidumo Mdladla being the Secretary to undertake the review.

The public reacted furiously to Circular Number 2 of 2013 that was prepared by Pricewaterhouse Coopers and approved by His Majesty also reviewing the politicians' salaries.

Appointing
This is what led to the King appointing the Commission that was com-

pleted by Dr. Sikhomba Gumbi, Nomathemba Hlophe, Kobla Quarshie, Mvuselelo Fakudze and Joe Shilubane In its summary report, the

ry report, the Commission points out that the new terms and conditions have been developed at a time when the country is facing severe cash flow challenges.

It also states that, however, due care has been taken to ensure that the remuneration framework, as developed, recognises that it is important to appoint into Parliament and *Emabandla* competent nationals so that the country can benefit from their expertise in pursuit of its development and growth agenda.

"The framework also recognises that a career in politics is a calling and a privilege, therefore, while it is important to pay competitive salaries in recognition of their skills and competencies, it is equally important to balance this against what the country can afford.

"The framework has also con-

sidered the affordability of the different levels of remuneration of the political office bearers. A bench-marking exercise to understand what obtains in the region, the government, parastatals and private sector companies were also taken," reads the report in part.

### Tigwadzi against SODV - DPM

MEN who are afraid of courting girls are the ones who say the SODV Act does not allow men to ask girls out.

'Tigwadzi' is a plural SiSwati word used to refer to men who are generally considered to be afraid of courting women or girls because of various reasons, including fear of rejection and embarrassment.

Men like these are considered a misfit in society because they fail to do what was normally done by men.

Deputy Prime Minister (DPM) Themba Masuku yesterday said men like these were the ones that were spreading such false message about the SODV Act of 2018. He said this during the workshop on SODV, and other matters under the DPM's office, which included teenage pregnancy and gender-based violence. The workshop was organised by his office for MPs who are in the DPM's office's portfolio committee and was held at the Parliament conference room.

Masuku said it was wrong for people to send wrong messages about the Sexual Offences and Domestic Violence (SODV) Act. The Act did not discourage people to court girls, but instead, it did allow people to do that very act.

Masuku said people did not realise that courting girls called for one to be respectful and sincere to the girl asked out. A man had to be brave enough to appeal to a woman's feeling and make her feel loved.

The DPM further said real men who were wise would see if the girl they approached had feelings for them or not. If the girl did not have feelings, a real man would realise and accept that.

Those signs would usually be there when the man was still courting the girl.

Masuku made an example of his wife, saying he realised when he was still courting her that he was going to win her heart.

"As I speak to you now, she is still a citizen of Lawuba and she has spent many years being a citizen of that area," Masuku said. Lawuba is one of the chiefdoms in the Shiselweni region, under Hosea Inkhundla. The DPM hails from that place.

The DPM said the SODV Act was enacted by Parliament last year because there was a need for the Legislature to respond to the rising number of violent cases in the country.

The SODV Act, according to Masuku, aimed at helping both men and women who were abused by their partners.

He said there were men out there who were beaten by their women, but were afraid to report such cases. Masuku said he personally came across such cases. He pleaded with the MPs to influence people to embrace this Act because it was there to help.

### MTNESWATINI AWARDED SABPP ACCREDITATION

MTN Eswatini has set the trend once again in human resource management by becoming the first company to be accredited by the South African Board of People Practices (SABPP).

This achievement places MTN Eswatini to be the first in the MTN Group of operations to receive such a recognition, and further becomes the first company to both undergo such an audit and attain accreditation in the country.

The accreditation certificate was handed over to MTN yesterday during a celebratory function by SABPP Head of Human Resources Audit Annetjie Moore at the Royal Swazi Spa Convention Centre, Ezulwini.

MTN Eswatini, in their quest to continuously improve people management practices, invited SABPP to audit its people practices.

MTN Eswatini acting CEO Sibusiso Nhleko likened the certificate awarding as embarking on mission to climb Mount Kilimanjaro. He said this was the beginning of a greater journey.

#### Assessment

"This is a gathering of different stakeholders to celebrate another milestone in our journey. We went through an assessment against standard people's management services. This is alongside other achievements that we attained in 2016 and 2018 respectively.

"We are the first company in Africa to achieve this. We are part of the one per cent of global companies assessed for people's management services, we are basically competing with the best," he said.

In 2016, MTN Eswatini was awarded Gold Accreditation by an international body known as

Investors in People (IIP), which is based in the United Kingdom (UK), making it one of two operations in the MTN Group to achieve this milestone. And, two years later, MTN Eswatini received Platinum accreditation, a first in the Group, Africa and part of the one per cent IIP participating organisations worldwide.

#### Grateful

Nhleko appreciated the contribution of the company's former CEO, Prime Minister Ambrose Dlamini. He said Dlamini set the tone. "We are grateful that MTN Eswatini has a very compelling employee contribution. Research has shown that when employees are happy they treat customers well and an institution's performance increases. We will reach the peak of our Mount Kilimanjaro," he said.

In May 2019, MTN Eswatini was audited against 13 standards and successfully met the qualification criteria against all the standards.

Moore said the full accreditation process takes between two to three years and it was not an easy audit.

"I can count in one hand the total number of companies who

have managed to get accreditation for these standards both this year and last year," she said.

Amongst the things that are looked into during the accreditation process, is finding out if the company's HR strategy aligns to the business targets, HR risks, and staff engagement.

#### Utilises

They also look at how service delivery impacts the business, how the organisation utilises technology, and effective communication.

"This whole process links to continuous improvement of the company's people and the business," said Moore.

Prior to the audit, Moore said MTN had to present evidence and she applauded the MTN HR team for a job well done during the assessment.

She said the accreditation will help the company to continue building a strong brand and employee value proposition to drive the country's economy.

Moore encouraged other companies to approach MTN and find out how they can get accredited for the standards.

"Never stop, keep on being the great people you are," she said.

#### Minister congratulates MTN


MINISTER of Labour and Social Security Makhosi Vilakati has congratulated MTN Eswatini for their achievement.

SENIOR Attorney Siboniso Clement Dlamini is a fugitive of justice as he is in continued contempt of court for being in defiance of court orders to pay monthly maintenance to a widow from her husband's estate.

This was a submission made by Senior Attorney Zweli Jele of Robinson Bertram Attorneys who is representing the Chief Justice Bheki Maphalala in application filed by Dlamini, where he is challenging the CJ in banning him from appearing in the country's courts.

The CJ issued a directive last year that Dlamini should not appear in any of the courts in Eswatini pending compliance with an order that he pays about E8 000 monthly towards maintenance to a widow Phindile Ndzinisa whose husband Martin died and left her with an estate worth more than E1 million. The Master of the High Court appointed lawyer

Maseko informed the court that his client came

Dlamini as an executor of the estate allegedly failed to account for the monies since 2014.

Making submissions before a full bench comprising Judges Mumcy Dlamini, Ticheme Dlamini and Cyril Maphanga, Jele informed the court that despite orders by the High Court and the Supreme Court, the applicant (Dlamini) has been in continued contempt as he is failing, refusing, or neglecting to pay the monthly maintenance to the widow.

"My Lords' and Lady, the court should take judicial notice that the applicant did not wind up the estate and file a liquidation and distribution account as per the administration of estates following the death of Martin Ndzinisa after being appointed executor even when called to do so and the widow had to institute proceedings to have the applicant account to monies from the estate," Jele submitted.

Jele informed the court that following his noncompliance with the court orders, he was held in contempt and an order was issued that he should be sent to jail for a period of 30 days. However due to his diet arrangements at the correctional facility, his incarceration was put on hold. When the deputy

IN his further submissions lawyer Zweli Jele applied that the court should not entertain the present application filed by Clement Dlamini, where he is challenging the CJ on his ban from courts as he came to court with dirty hands.

Jele submitted that the applicant (Dlamini) had defied all courts and was now approaching the court with an I don't care attitude in the present application as he did not want to contribute the monthly maintenance to the

"The court should set an example in Dlamini's case in order for society to have confidence in the justice system in as far as administration of estates by lawyers is concerned.

There has been an outcry from the public concerning monies misappropriated in estates involving widows and orphans," Jele said.

Jele said the country cannot have a society running in such a manner and implored the court to save the dignity of the country's courts by declining to hear Dlamini's application.

Jele further informed the court that so serious is Dlamini's matter that the office of the Director of Public Prosecutions (DPP) has indicted the senior lawyer for criminal charges in the same matter, a matter that is expected in Court in the next session of the

#### Madibhane arrested for theft of 20 cows

CHARGED with contravening the Stock Theft Act of 1982, a government veterinary assistant (Madibhane) has been arrested for the theft of 20 cows within the Hhohho region.

Grace Matsinye who has been charged together with five others yesterday filed an urgent application for bail at the High Court following her arrest on August 3 by the Pigg's Peak Police Stock Theft Unit.

Matsinye and one of her co-accused Thulani Dlamini were yesterday represented by Lawyer Sabelo 'Chicken' Dlamini in their bail application, while the other four have not yet moved their applications before court.

#### Charge

The charge sheet states that Matsinye together with the five are facing a total of 20 counts in that they stole cattle from 20 different people on different occasions and areas within the Hhohho region.

The charge sheet annexed to their bail application further states that the most expensive beast they stole was a bullock worth E15 000 while the lowest was red cow worth E5 000.

Motivating her application in her founding affidavit, she submitted that she together with the five Thulani Dlamini, Norman Tsabedze, Senzo Dlamini, Bheki Sengwayo and Wonder Senzo Lukhele were arrested by the Pigg's Peak Police and subsequently slapped with the 20

She informed the court that she is currently kept at the Pigg's Peak Police Station awaiting to be transferred to the correctional facility and pending hearing of her case, she is desirous to be admitted on bail.

The applicant further told the court that she is employed as a veterinary assistant and has 10 dependents who look up to her for their well being and amongst these are six of her children, four of whom are still school going with one at tertiary level in South Africa while the three are in high school.

#### Submitted

She submitted that one of the children is deaf and that she needs her attention adding that she is a sickly person with a chronic illness and also suffers from high blood pressure.

"My continued incarceration will not only be detrimental to my health and job but also to the well being of my entire family, hence the interest of justice clearly favours that I be admitted to bail," she submitted.

She averred that no one will be prejudiced as she has been verily advised that the police have completed their investigations in the matter.

Also annexing his confirmatory affidavit in the application was Thulani Dlamini who stated that he is a brick layer and has a family of 10 inclusive his wife and two minor children.

He also submitted in his confirmatory affidavit that he has a sickly mother to take care of, hence his continued incarceration will not only be detrimental to his future but also to the well being of his family as a whole.

### Home Affairs generates E8m

THE ministry of home affairs has successfulby collected over E8 million in revenue for the first quarter.

According to the ministry's first quarter performance report; the issuing of permits was the main source of revenue followed by the issuing of travel documents (passports) both international and gemeral. The total revenue collected in the reporting period was E8 207 455.

Minister of Home Affairs Princess Lindiwe said the distribution of this revenue indicated that 63.9 per cent amounting to E 5 246 950 of this amount wass generated from the issuance of permits and 19.7 per cent amounting to E 1 619 630 was from the issuance of travel documents. The remaining 16.4 per cent includes IDs, BMDs, visas, penalties to name a few.

The minister said the staggering amount collected from permits was a result of more temporal permits issued to foreigners. She said the revenue collection was an important indicator of where the ministry needed to improve and strengthen the service provision. She added that it also informed the ministry of where they needed to prioritise its resource allocation.

#### Performance

The minister said a snapshot of the performance by departments showed that regardless of the country's current economic position, Emaswati were keen to travel for various reasons.

"This is reflected by the number of travel documents that have been issued in the reporting period," she said. She said the total number of travel documents that were issued was 21 422 with the majority of the documents issued in Mbabane.

She said the ministry was taking strides that would lead to the development of a modern immigration system which will lead to the improvement of the issuance of permits and visas.

The current fiscus crisis has compounded and already dire situation and has diminished the capacity for the government and private sector to support adequately all initiatives and programmes aimed at reducing the risk of exposure to disaster and alleviating human suffering.

### Agric minister engages chiefs on commercialising **Eswatini Nation Land**

AS government pulls all available strings in a bid to resuscitate the country's ailing economy, the ministry of agriculture is looking at commercialising Eswatini Nation Land (ENL) as one of the strategies.

The ministry is currently in the process of engaging traditional authorities on a proposed Bill which will see ordinary citizens accessing loans from financial institutions to start businesses on ENL. On Wednesday, Minister of Agriculture Jabulani

Mabuza presented the Eswatini Nation Land Agricultural Commercialisation Bill of 2019 before Lubombo chiefs.

If the Bill eventually gets endorsed to be an Act, citizens would be able to use their land on ENL as surety to access loans from financial institutions such as banks. At present, most financial institutions do not accept land on ENL as surety.

This is mostly because even when one has acquired land through kukhonta, that land remains a property for the nation, entrusted to the authorities of the country.

Mabuza explained that the Bill would not change anything on that regard, but seeks to grant liability to a citizen of the country who would want to start an agricultural business on Eswatini Nation

This would be done by issuing a Commercial Khonta Certificate to an aspiring business person after proving a potential for commercial farming. The certificate would be issued to an individual after a thorough assessment has been done.

Mabuza said the assessment would be done by different committees, of which one of them would be appointed by the traditional leader of that particular community.

The certificate will state clear demarcations of that particular land, which will be used for commercial farming. Mabuza said his ministry would engage a land surveyor to ensure that the demarcations of that land are well documented.

He explained that the said certificate would be revoked if the person who was granted eventually fails to utilise the land for the intended purpose, or if he or she has breached some of the rules and

"Basically this Bill seeks to improve the economy of the country by helping the ordinary Emaswati to do business in their rural areas," said the minister. Mabuza said the Bill was necessary mostly because a greater fraction of the country was on

Meanwhile, the traditional leaders welcomed the Bill as it was presented by the minister. Prince Chief Kusa said they were happy that the ministry was looking at possibilities of empowering ordinary citizens.

The prince said however, they were still to consult with the higher authorities of the country and take a directive on whether or not they can approve the Bill. The traditional authorities then set another date for further deliberations on the Bill.

#### Asians would not be granted commercial khonta certificate

THE proposed Commercial Khonta Certificate will only be issued to Emaswati by birth, and not foreigners.

This was emphasised by Minister of Agriculture Jabulani Mabuza when presenting a Bill which seek to empower ordinary Emaswati to start agricultural businesses on Eswatini Nation Land (ENL). Mabuza said when drafting the Bill, the ministry was cautious not to change anything on the customary laws and norms.

On another note, Mabuza said the Bill also had a clause which would prevent financial institutions from repossessing the land when the debtor fails to pay back the loan.

### GOVERNMENT SCHOLARSHIP DEFAULTERS TO BE PROSECUTED

PEOPLE who have been employed for more than three months and have not been paying their study loans through by the Study Loan Recovery Consortium will be taken to court by the consortium.

This was revealed by the Study Loan Recovery Consortium Project Leader Sidumo Mdladla during a meeting with the Parliament portfolio committee yesterday.

The committee visited the ministry of labour and social security during a tour which ended at the Study Loan Recovery Consortium Offices.

The consortium is involved in a costly and time consuming exercise of tracking down those who benefitted from the government scholarship.

The consortium has even engaged Trans-Union to track down owing former students who are outside the country, staying and working in South

Advertisements and a series of articles were run in the print media urging people to pay.

The consortium even went to the extent of offering those who will come forward a chance of paying half the amount.

However, some people continued ignoring the request to visit the consortium's offices so as to start paying.

Mdladla said the cost of advertising in the print media is very expensive, as in South Africa a page cost about E90 000 while here in Eswatini it is E30 000.

Addressing the Members of Parliament (MPs) and other stake-holders at the ministry of labour and social security conference room on taking debtors who are employed but refusing to re-pay government, Mdladla said they are reluctant to take the court route. However, he said it must be

noted that there are people who have paid their study loans and there are those that are still paying.

Mdladla said these people had to be protected and to protect them, everyone must pay.

Mdladla said they are at a stage

where they were planning to go to

"By the end of August we will take those in defiance to the courts. The Study Loan and Scholarship Agreement Order of 1977 will back us. This Act allows government to implement the full repayment in the event a beneficiary fails to adhere to some of its provisions, that include reporting within three months after gaining employment."

Meanwhile, Ministry of Labour and Social Security Portfolio Committee Chairperson Lutfo Dlamini applauded the work done by Mdladla and his team.

He said now that they are taking the court route, perhaps they should consider having a parliamentary Act that will back them.

Mdladla assured Dlamini that they would be using an Act, which is the Scholarship Recovery Act.

Yesterday it was revealed that currently government is owed E2.1 billion in scholarship loans.

The consortium has been able to collect E74 million as at July 31. The consortium revealed that it makes a collection of E4.5 million per month. In the period of January to June 2019 the Scholarship Recovery Consortium was able to collect a total of E24 630 315

According to the debt recovery summary, beneficiaries who have been identified but have not yet secured consent stand at 18 000.

#### WE ARE COMING FOR DEFAULTERS-LOAN CONSORTIUM

THE Scholarship Management and Recovery team has lined up strategies so as to nab study loans defaulters.

Mdladla said there is a proposed integration of the Scholarship Recovery System with home affairs civil registration and immigration systems.

This integration would enable the pre-screening of all individuals seeking services, whether as primary beneficiaries or secondary attesters to documents to determine if they benefited from government scholarship.

Mdladla said pre-screening would be for the purpose of getting the scholarship defaulting individual to sign an acknowledgement of debt and repayment plan. Defaulting beneficiaries, according to the strategy, would be flagged at all points of entry and exit in the country.

### Uproar as over E450 000 monthly interest from scholarship loans lost

THE Parliament Portfolio Committee for the Ministry of Labour and Social Security is not happy with the way government has wasted an opportunity of saving E450 000 per month.

The E450 000 is interest of the E74 million that has been collected by the Study Loan Recovery Consortium and is kept at Standard Bank. It surfaced yesterday that the money could be generating an interest of E450 000 a month.

Mdladla said if the E74 million was generating interest, the project would be paying itself and saving government a lot of money as government would not fork out anything. Mdladla said the account for the recovered money is with Standard Bank and because the money belongs

to government, they as the consortium only check if money has been deposited monthly and if everyone who is supposed to pay has paid.

He said they have no rights or say in the accounts.

Project

The project leader indicated that with the money that is in the account being E74 million, it is supposed to be generating an interest of E450 000 a month.

When, Lutfo Dlamini, who is the chairperson of the committee asked who is getting the interest now, Mdladla said it is supposed to be government. However, it surfaced that there is no interest because of a conflict between the ministry of labour and the treasury department.

Principal Secretary in the Ministry of Labour and Security Thulani Mkhaliphi said this is one complex issue because the money was saved in a current account at Standard Bank and therefore it is not earning an interest.

Mkhaliphi said the directive is that government says it is illegal to save money in a commercial bank account.

Mkhaliphi said they were not in agreement with the treasury department, he said the treasury department was taking them to task as signatories of the account on why they were keeping the money with a commercial bank let alone an interest earning account.

Mkhaliphi said they had initially kept the money where they saw

that it has a potential of getting an interest so that when they create a fund for the recovered money, the funds find that "we are still fighting those kind of wars with the treasury department" Mkhaliphi stated.

MP Dlamini, the Chairperson of the Parliament Portfolio Committee, said it was not right for government to lose so much money because of the misunderstanding on where the money should be kept. He said they will deal with the issue as Parliament. Dlamini said such must not happen when government is in a financial crisis.

He said the saved interest can help government a long way. Dlamini said this was a serious issue as close to half a million a month is wasted while everyone knows that government is broke. The chairperson said the money could be used to help even other students who need scholarship loans.

#### First years to get allowance via e-Mali and MoMo

THIS year there might be less or no protest actions by students from intentions of higher learning.

This is because government has devised a way of paying students allowances in stages. Ministry of Labour Principal Secretary Thulani Mkhaliphi revealed that the disbursement has been inefficient before and now they have decided to disburse the money on a monthly basis.

He said they will be using Mobile Money and e-Mali.

The PS said for example if someone is supposed to get an allowance of E10 000, that money would be stretched over a period of 10 months and it will just be enough for a student to be able to use the money for rent transport food and other basic needs.

A significant number of patients are harmed or die yearly due to unsafe health care, resulting in a high public health burden worldwide.

Ministry of Health Chief Pharmacist Fortunate Bhembe said medical errors could come from both a medical practitioner and a patient due to different reasons. She was speaking during a Medical Errors Symposium held at the Royal Swazi Spa Convention on Wednesday.

Bhembe said from the side of a patient, a medical error could occur because of the information that can be very confusing which the patient will not understand. This then, according to Bhembe, could lead to a patient administering the prescribed medication wrongly leading to a medical error.

She said there was need for governments to recognise the scale of avoidable harm linked with unsafe medication practices and medication errors. governments and private medical companies to face and deal with lawsuits and claims due to a medical error.

#### Govt must set flexible budget to meet medication demand

ADVISORY Group of South Africa reactions. Doctor Brad Beira says adverse pro-14th leading cause of illnesses and mortality in the world, putting patients harm in the same league as tuberculosis and malaria.

Beira said without good guidance and training programmes for healthcare Workers in developing countries, patients could be at an increased risk of medication errors and preventable adverse

Most of the harm caused by wrong cedures are now estimated to be the use and administering of medication is

He mentioned that the possibility of harm is high, especially if adverse reactions are not monitored by a strategy aimed at good reporting and early detection, review and management.

"The complex challenge of improving medication safety during transitions of care requires long-term commitment from health care leaders and cohesive efforts from health care professionals to substantially reduce potential patient harm," he said.

He said technological advances such as computerised drug to drug interaction software packages were gaining increased recognition as means to reduce

medication errors. They are likely to represent the standard of care in all pharmacies, dispensaries and hospitals in

To minimise medical errors, Beira suggested that doctors and nurses should attend paediatric training, pharmacists working in wards could be assisted with reconstitution and dosage calculations of medications, and ward protocols need to be updated and followed.

He said there was need for government to address the drug issue with great urgency. He said the ministry of health should going forward spend enough money on the required medications at the right time. He said government should set a flexible budget that would cater for the ever increasing demand of medication.





#### Taiwan injects E1m for Tinkhundla network system

THE Republic of China (Taiwan) has pumped over E1 million for the networking of tinkhundla centres in the country.

Minister of Tinkhundla Administration and Development David 'Cruiser' Ngcamphalala extended government's gratitude to Taiwan for funding the networking of Tinkhundla at E1 021 000. He said the project was a network expansion of government infrastructure and would facilitate the decentralisation of e-govemment of the communities through the Tinkhundla centres. However, due to financial constraints the minister disclosed that the rehabilitation of Tinkhundla centres and the provision of security at Tinkhundla Centres has been put on hold in the current financial year, something which was not well received by some members of Parliament (MPs). Nkhaba MP Zakhele Magongo asked as to when the networking would be com-

The minister said the network is being implemented in two phases.

He disclosed that currently the local area network had been installed in 59 Tinkhundla centres in the country.

"Phase one has been implemented in 59 Tinkhundla centres in the country," he said.

The minister added that the second phase would be the installation of the wide area network. After the installation of the wide area network, the minister said Tinkhundla will be able to access the government main frame.

This is contained in the Tinkhundla Administration and Development portfolio committee on the debate of the ministry's quarterly performance report for the 2019/20 financial year.

#### E55 MILLION FOR RDF

The ministry of tinkhundla administration and development has received about E55 million for the Regional Development Fund (RDF).

This is contained in the ministry's quarterly report for 2019/20. Minister of Tinkhundla Administration and Development David 'Cruiser' Ngcamphalala pleaded that priority should be given to projects that had been appraised.

Somntongo MP asked when the ministry would start utilising money from RDF.

The minister explained that the funds had to be transferred to the RDF account.

"As soon as these funds are transferred, the ministry will start utilising the money. Currently, the ministry is making follow-ups with the ministry of finance weekly to expedite the transfer of funds to the RDF account."

The minister emphasised that implemented projects are those that have been appraised through the previous RDF regulations subject to the prioritising of the respective Tinkhundla.

It is worth noting that five per cent of the released money is administrative costs, which amounts to E2 750 000.

### Shiselweni chiefs rally behind 'It Takes Eswatini' campaign

PRINCES and chiefs from the Shiselweni region say they feel they have let children down as sexual violence perpetrated against them has carried on for too long unabated.

This was articulated by Mkhwakhweni Chief Prince Fipha during their meeting at the regional administration offices in Nhlangano.

The chiefs were being introduced to the 'It Takes Eswatini to End Sexual Violence against Children' campaign on Monday.

The chiefs have since resorted to forming a task team to ensure that Shiselweni worked hard at being a sexual violence free region by supporting the campaign.


The committee comprises Regional Administrator Dr Vincent Mhlanga, Prince Fipha, Chief Makhosikhosi, Chief Mbane and others.

During their meeting, the chiefs delved into reasons behind the surge in sexual violence cases.

They said they had noted a myriad of issues which should be looked into. Several of them decried the introduction of children's rights, which they said was at the expense of traditional values.

As a result, they said children are unmanageable and parents are unable to protect them from abuse or warn them against falling into abusive situations.

They noted how children now date



without informing parents, something which was not the case in yesteryears, where dating was officially acknowledged by both families and was only done by mature people who were of marrying age.

Most of the chiefs decried the deterioration of traditional values due to modern life, as well as exposure to bad behaviours at a young age. They decried how watching TV exposed children to sex at an early age as well as violence and killings.

They called for a return to traditional structures which will see children taught actively by parents and the community on how to take care of themselves so that future generations remain morally astute.

On the other hand, Chief Makhosikhosi Khumalo said the

expectation that the country would return to traditional practices is not possible because, even as they were meeting, most of them would return home late at night and no longer have time to properly sit down with their children and impart to them the values they grew up with.

"It is time that we look at ways of marrying the modern times with traditional values because our children are of a completely different era," he said.

Zombodze Emuva's Lipha Nsibandze said there were different teachings between the home and church, which sees people most likely to run to their pastors and inform them of anything that is hap-

"We should note that when some

of our children want to get married, they now run to their pastors first and tell them about their plans. In this regard, churches should also be roped in to play a role in this campaign," he noted.

Nsibandze further highlighted how parents no longer had access to their children because they had many meetings in churches whereas they would have ordinarily spent their time at home.

He also decried how members of Parliament (MPs) approved the Sexual Offences and Domestic Violence (SODV) Act of 2018, but were not assisting parents when they took children out of the homestead through the varying number of soccer competitions which caused them to return very late at home.

#### 'Rape survivors must be protected from perpetrators'

SHISELWENI Regional Administrator (RA) Dr Vincent Mhlanga says convicted rapists should be monitored so as to ensure that they do not return to their criminal ways or bother their victims.

He said this was important if children were to be protected even after their ordeal.

The RA said there had to be a way of monitoring rapists to ensure that they did not rape

He pleaded that this should

be done without the former convicts knowing they were being watched.

"I don't know how it can be done, however, there must be a way of ensuring that they do not revert to the horrendous crimes they were convicted for," said Dr Mhlanga.

He said he noted how a convict visited a victim and reminded the child that he was once arrested because of her and proceeded to rape her again.

"The child then kept quiet

after noting that the rapist could do this again despite having reported it previously," said the

He added that the child ended up falling pregnant by her rapist, something which could have been avoided had the child been protected when the convict was released.

This, he said, would be one way of ensuring that the children who are victims do not come into contact with their abusers again.

#### Counselling rooms needed in schools

ONDINGANENI Community representative Harry Nxumalo requested that counselling rooms be mandatory within schools.

He said it was paramount that children have a place of safety and solace within the school setting so that they could communicate when things were amiss.

He called for the rooms to also be used as means to prevent abusive behaviour, in that organisations such as World Vision should use them to instil values which build children to be respectable members of society.

Tempted

"Once all children are taught at a young age about respecting their fellow human beings, we will reduce incidences of sexual violence because this will have been instilled when everyone was young and no one will be tempted to do it later on in life," he said.

Nxumalo requested that each family should revert to the practise of having their own sessions of teachings so that values and principles are taught to children at a young age.

"Parents should stop leaving everything to teachers and other.

"They should take charge and take care of their own children's needs where education on character and morals is concerned," he said.



#### Company director accused of selling same property twice

THE director of a company is accused of selling the same property twice to different people for over E2 million.

Thandi Maziya, who is the Director for Swaziland Perishable Foods, is alleged to have sold plot number 684 situated at Matsapha Industrial Sites to a company operating under the name Van Wyk and Sons Property Limited in January 2015.

Van Wyk and Sons managed to pay E750 000 upfront plus two properties at Tubungu valued at E1.3 million before the sale agreement was made.

This then led to the two parties signing a written agreement in respect of the sale and exchange with the director.

However, it is said the director then failed to hold up her end of the deal, which was transferring the 4 138 square metre plot to Van Wyk and Sons despite having signed the agreement.

It is then that the company ran to court to apply for enforcement of the implementation of the agreement.

The court, after arguments, issued an order in favour of Van Wyk and Sons where Maziya was expected to transfer the property and further refrain from selling the plot to anyone else

During this period, the Registrar of Deeds is also said to have been actively involved and it was ordered by the court not to register the plot to anyone else.

This led to a meeting by Van Wyk and Sons' trustee Cindy Ann Van Wyk with Swaziland Development Finance Corporation's (FINCORP) and representatives of the other respondents that they were still interested in retaining the plot and were even willing to pay more for it.

Offer

However, the Van Wyks were told that there was another offer of E3 million for the same plot. Indeed, in February this year, Maziya, in her capacity as the director of Swaziland Perishable Foods allegedly sold the same plot to Jasha Investments, for E2.5 million despite the fact that the guarantee that was issued is to elapse on October 2,

The Van Wyks want the sale to Jasha Investments to be reversed because they are of the view that Maziya has no regard for the law since the matter was to be heard by the appeal court in October.

The Registrar of Deeds' Lindile Dlamini is said to have already authorised and issued a Title Deed in favour of Jasha, much against the order of the court.

Van Wyk said it was urgent that the reversal is made because already, the new supposed owner is executing a lease agreement with the current tenants, from whom the Indian will expect rent effective from July 1, 2019.

The trustee said this was wrong because by law, she was the owner of the property and that the tenants should pay rent to her and not Jasha

Investments.

"Your Worship, as I stand here, I am an orphan as I have no mother or father to support me.

"I have no other option but to resort to this illegal practice to make money to support my children."

After hearing her mitigation, Magistrate

Shongwe sentenced Nxumalo to pay a fine of E2 000 and in default of payment, serve two years in prison.

When questioned about the reason for his arrest, Hlophe said he was only trying to make a living out of selling dagga.

"Your Worship, although I am selfemployed, I need more money as I have children whose needs must be met, daily. I apologise to the court for committing this crime, and I hope I will never have to resort to this again," Hlophe stated.



## TRIBUTE TO VUSI TSHABALALA

VUSI Tshabalala son of the late Soweto tycoon Ephraim Tshabalala popularly known as ET died of pneumonia on July 25, 2019 in Johannesburg.

Tshabalala inherited his father's business empire that included grocery shops, dry cleaners, garages, cinemas and petrol filling stations both in Johannesburg and Manzini in Eswatini.

As a progressive young businessman he also ventured into showbiz. In 1976 Tshabalala with a little help from his brother-in-law Peter Vundla organised the biggest music festival ever in the Kingdom of Eswatini known as the Swazi Summer 1976 scheduled to take place behind Somhlolo National Stadium.

A massive music stage was created where popular US artists like Earth Wind & Fire, Commodores, Harold Melvin and the Blue Notes featuring Teddy Pendergrass, The Temptations, The Spinners and The Whispers to mention a few were supposed to perform. The festival collapsed a few hours before it took off due to reasons I can't go into. Before it was announced that the festival had been called off millions of music lovers and tourists from all over the world were already in the country. The situation was so bad that all hotels were fully booked such that tourists were stranded and Mbabane and Manzini ran out of food.

Tshabalala did not only promote music festivals in Eswatini alone but as well as in South Africa. Among those he brought to South Africa were the Staple Singers, a family group of five ladies managed by their father Pop Staple who also sang with the group. The Staple Singers performed at Orlando Stadium. Both the late Percy Sledge and Brook Benson were amongst the US music singers brought by Tshabalala to perform in South Africa.

My relationship with the late Vusi Tshabalala began at Salesian High School. The two of us were joined by the late Mike Alexander and became the three-musketeers of our time.

Upon finishing high school, I left Eswatini to study journalism at the Ghana School of Journalism. Vusi and Mike joined their family business empires. Whilst studying in Ghana Vusi sent me a card telling me he was getting married to Princess Dlalisile, King Sobhuza's daughter from Inkhosikati La-Masuku.

When I came back from studying Tshabalala, Mike and myself continued with our strong friendship. Tshabalala opened a restaurant at White City named Swazi Lounge. The restaurant was followed by a disco. He asked me to be a resident DJ at the disco which attracted a lot of patrons from Soweto.

Erupted

When the 1976 Soweto uprising erupted Tshabalala and I were in Soweto. Vusi quickly organised a car and we drove out of Soweto back to Eswatini.

In 1980 Tshabalala stole his father's Mercedes car and we drove it into Zimbabwe to witness that country's independence celebrations. As we left Harare coming back home, Tshabalala hit a dog damaging the car seriously. We drove in it as far as Rustenburg where we put it in a garage for repairs. I left him in Rustenburg and got a ride from SS Mokgokong who was in that town for a graduation back to Eswatini.

In 198, Tshabalala left Johannesburg for Boston Massachusset to study business administration.

The following year (1982) I too left Eswatini for Princeton University New Jersey to further my studies in journalism. Tshabalala's father asked me to pick up a parcel from him to deliver to him. The parcel consisted of money and several bottles of whisky. On arrival in New Jersey, US, I called Tshabalala to come collect

Two weeks previously to his death, he and his friend Eddie Dipuku checked on me in Mbabane, Eswatini. He looked well.

There was no sign of ill-health. I was however, saddened and shocked when I got a call from a friend Winston Mndebele in the middle of the night telling me about Vusi's sudden demise. Seeing Vusi just before his death is a sure sign that he came to bid me farewell before taking

Hamba kahle Mshengu Tshabalala. We shall meet in the next world.

### SNACKS ARE GOOD FOR PEOPLE ON NIGHT SHI

OVERNIGHT workers have now been given the go-ahead to grab a midnight snack by sci-

In the first study of its kind. University of South Australia researchers investigated how eating patterns can affect performance at work.

They found a snack was the best way to fuel those working a night shift, rather than a heavy meal, such as a sandwich or curry.

Their reaction times were quicker, most likely because a large meal can make us feel exceptionally sleepy halfway through the night, the scientists said.

Participants in the study were given cheese and crackers and pretzels. Millions of shift workers complain of their diet being ruined because they have got used to eating throughout the night.

Research shows nurses - who regularly work late shifts - are more likely to be obese, possibly due to the body clock being disrupted or bad food choices.

Lead researcher and PhD candidate Charlotte Gupta said many work industries are increasingly relying on employees to work round the clock.

She said: "We know many night shift workers eat on shift to help them stay awake.

"But until now, no research has shown whether this is good or bad for their health and performance.

"This is the first study to investigate how workers feel and perform after eating different amounts of food."

Over the course of a week, 44 healthy participants, who were not night shift workers, were split into three eating conditions, according to the study published in the journal Nutrients. They were observed in a laboratory where researchers made them stay awake overnight and sleep during the day.

All groups ate enough calories during the 24-hour period, ranging from 1900 to 2 600 calories -

but their meal times varied.

- Study participants were given either a snack, meal or no food at midnight
- They were involved in a seven-day study that mimicked night shift sleep times
- They performed tests and rated their level of sleepiness and hunger



at midnight and one group was given a snack at midnight, such as cheese and crackers with pretzels, or an apple with a muesli bar.

The midnight meal made up 30 per cent of the participants daily calories and the snack was just 10 per cent. One group wasn't given any food at all, having their dinner around 10pm, breakfast at 3am, and snacks throughout the day.

Gupta said: "We had them do a lot of performance tests and give us ratings on how they were feeling."

Participants also rated their level of hunger, gut reaction and sleepiness after eating at midnight.

Gupta said participants who had a snack just after midnight felt more awake than the other two groups, were the most satisfied with the amount of food and performed best

Gupta said: "They were reacting faster. We had them do a driving simulator and they were driving safer. So, there were less crashes and they were staying in the speed limit with that small snack, opposed to the big meal.

"Those that didn't have any food performed better and more alert One group was given a big meal than those that had the big meal but the snack group still felt and performed the best.

"The findings will inform the most strategic eating patterns onshift and can hopefully contribute to more alert and better performing workers."

#### **Primed**

Despite the meal causing drowsiness, the researchers do not advise skipping meal times and eating snacks instead during the day.

Gupta said: "We find there is always that post lunch lull in alertness, which is just part of our circadian rhythm. We just feel sleepier at that time of day.

"Having a really big heavy meal can make us feel sleepier, but the body is also primed to be digesting food and it wants to be digesting food and digesting it during the

"But at night when our body isn't fine to be digesting food that's when a snack is better.

The circadian rhythm is a 24-hour cycle, often called the 'body clock', that regulates people's sleep, eating, body temperature and digestion. Gupta said research should now look into the best snacks for shift workers.

She added: "We gave people a

muesli bar and an apple, which is a fairly healthy snack, but we know that many shift workers are limited in what they can buy, or are getting food from vending machines."

Crisps, chocolate, biscuits and energy drinks are a common choice to keep workers going through the night. Gupta said: "There's also a craving during the middle of the night, when you're working a hard night shift, for chocolate or something a bit more exciting to eat. So, we want to know what the different types of snack do in how people perform during the night."

One in four nurses are obese according to a study by Edinburgh Napier University and London South Bank University in 2017.

Although researchers weren't able to clarify the reasons behind the high levels of obesity seen in healthcare staff, they suggested it may be the result of disruptive work

Nurses have also reported increased rates of irritable bowel syndrome, while flight attendants who eat during the night suffer more stomach aches, bloating, disturbed appetite, diarrhea, and constipation, Ms Gupta and colleagues report.

### Just three cups of coffee a day can trigger migraine attacks

LONDON - If you suffer from migraines, it might be time to kick that coffee habit.

Researchers have found that drinking three or more cups a day substantially increases the risk of an attack.

The study tracked 98 sufferers of 'episodic' migraines - defined as having the debilitating headaches on up to 14 days a month.

They found that drinking up to two cups of coffee or other caffeinated drinks made no difference

to their chance of a migraine.

But when they drank three cups, the risk of having an attack the same day went up by 40 per cent. If they had five cups, it rose by 161 per

Study leader Elizabeth Mostofsky. of Harvard University, said: "Drinking one or two caffeinated beverages in a day does not appear to be linked to developing a migraine but three or more servings may be associated with higher odds of developing a headache."

More than eight million Britons - three-quarters of them women suffer migraine attacks, which involve dizziness, nausea and headaches. Episodes can last from four to 72 hours.

The problem affects more people than diabetes, asthma and epilepsy combined, and is the sixth most common cause of disability in the world. The researchers, whose findings are published in the American Journal of Medicine, said the impact of caffeine on migraines is complex because it depends on dose and frequency. And while it may trigger an attack, it can also have a painkilling effect.

Participants completed diaries twice a day for six weeks reporting on the frequency and severity of migraines and their intake of caffeinated drinks.

Fellow researcher Dr Suzanne Bertisch said: "There have been few studies on the immediate risk of migraines with daily changes in caffeine intake." Daily Mail

"AGRIBUSINESS start-ups are capital intensive in their nature, it is worse if they have to factor in the use of technology"

These remarks were made by Industrial Development Company of Eswatini (IDCE) CEO Phiwayinkhosi Ginindza during the young professionals breakfast meeting at the Cold Chain Summit held at Mavuso Exhibition and Trade Centre yesterday.

He said most financial institutions did not have appetite for such startups and regarded them, in particular young upcoming entrepreneurs as high

"If we continue to ignore investment into agribusiness start-ups, particularly where the youth is involved, as a country we will find ourselves with old farmers who have lost strength to continue farming. That would be when the nation is running out of food to feed itself," he said.

He added that at IDCE they have realised that if they wished to see new innovative products, they must start supporting youth entrepreneurship

initiatives, especially those that involve technology.

"Youth entrepreneurship can only be enhanced if the financier is willing to go an extra mile and invest in the capacity building of the young entrepreneurs. Youth inclusive financing models include ensuring adequate capacity to the entrepreneurs before financing, providing low cost funding with affordable terms as well as continuous mentorship and coaching to ensure sustainability of the businesses,' he continued.

Ginindza also disclosed that as they receive and assess youth business loans referred to their office by the youth fund, they realised that lack of funding for their businesses was not the main barrier for business start-ups.

Young people lack exposure to be creative, innovative and think outside the box, they cannot easily identify

opportunities at their disposal. They lack capacity to enable them to put together quality and convincing business proposals to be able to run successful businesses in a sustainable manner. He added that the youth often lack the entrepreneurial culture, to regard entrepreneurship as another option in their career choices as opposed to regarding it as a fall back plan.

#### Funds

They also lack initiatives like the youth fund or other grant funds to derisk the start-ups, to eventually increase appetite for the development finance institutions like IDCE to finance the growth of the businesses.


"As consumers living standards continue to improve, the requirements for high-quality produce also increases. In order to ensure that the products maintain the expected high quality, it is important to improve the cold chain

enterprises. It is time to attract outstanding young intellectuals to participate in the cold chain enterprises and introduce innovation and technology," he said. He further stated that such improvements could not be possible without the availability of funding.

#### Challenged

### MOLEFE DEALT FATAL BLOWBY CONCOURT

JOHANNESBURG - Former Eskom boss Brian Molefe will have to pay back the utility R10 million of a R30m golden handshake he received when he resigned from the embattled power utility after his last-ditch attempt to keep the money was dealt a fatal blow by the Constitutional Court.

Molefe will have to comply with the Constitutional Court order, as he has no other avenues to appeal the matter as the court is the apex court in the land.

Trade union Solidarity, which opposed Molefe's numerous appeals, yesterday said it would immediately institute action to collect the cost order and to ensure the R10m Molefe received from the Eskom Pension Fund was paid back without delay.

Dirk Hermann said Molefe had tried to use litigation to shirk his responsibilities.

"We are delighted with the ruling. One can only hide in the courts up to a certain point, but the law always

prevails. It is sad that the courts have to take over the role of a person's conscience. Solidarity knows its way about the courts and Brian Molefe underestimated us. We will not let injustice happen," Hermann said.

Molefe has also been ordered to pay the lions share of Solidarity's legal

Hermann insisted that the Constitutional Court's ruling opened the door for the union to pursue criminal proceedings against Molefe.

"As Solidarity is getting no response from the National Prosecuting Authority, we have already initiated discussions with Advocate Gerrie Nel about possible private prosecution."

Molefe could not be reached for comment on the Constitutional Court ruling.

Molefe resigned from Eskom in

November 2016 after a damming report by erstwhile public protector Thuli Madonsela found that Molefe had a cosy relationship with the Gupta family, a family that is alleged to be at the centre of plundering Eskom and Transnet's resources.

Madonsela in her report said Molefe and Ajay Gupta, the eldest of the Gupta brothers, had made 58 telephone calls to one another between August 2015 and March 2016.

Wayne Duvenage, the chief executive of the Organisation Undoing Tax Abuse, said he was happy with the Constitutional Court judgment.

"We always maintained that he (Molefe) did not qualify for such an exuberant amount in the short time he spent as Eskom's employee.

He was inside the state capture vehicle both at Eskom and Transnet and should now be held accountable for being a key state capture enabler," Duvenage said.

Transnet chairperson Popo Molefe in May told the state capture commission that the rail, port and pipeline company wanted (Brian) Molefe to pay it back R79m for payments made to Gupta-linked Regiments for work not done. Business Report

### BUSA, BBC and NEDLAC sign agreement

JOHANNESBURG - Two entities, Business Unity South Africa (BUSA) and the Black Business Council (BBC) have signed a working agreement.

This agreement will see both entities collaborate on broad-based black economic empowerment and socio-economic transformation, small, medium and micro-sized enterprises development, infrastructure development and the Fourth Industrial Revolution, as these are among the most pressing challenges facing the country.

In a statement yesterday, the organisations said in terms of National Economic Development and Labour Council (NEDLAC), there will be co-operation on Nedlac structures and processes flowing from the institution, under the auspices of Busa's membership of NEDLAC.

The organisations have agreed to a code of conduct; a communication and reporting protocol; and to collaborate on platforms such as the BBC Black Business Summit and the Busa Business Economic Indaba, the Investment Summit and other business forums.

"This development is a huge milestone as it will allow the BBC to participate at the Nedlac.

It will also enable business to speak with one voice on business matters. The agreement is timely as the country is crying for leadership on economic matters and BBC and Busa should rise to the equation and take leadership" said Kganki Matabane, the Chief Executive of the BBC. #### Amnesty International warns that if you travel to the US, you are likely to be shot

WASHINGTON-Amnesty International has issued a travel advisory for people going to the United States due to "ongoing high levels of gun violence in the country".

"The Amnesty International travel advisory for the country of the United States of America calls on people worldwide to exercise caution and have an emergency contingency plan when travelling throughout the USA," their alert declared on Wednesday.

Those travelling to the US would need to be "extra vigilant at all times and be wary of the ubiquity of firearms among the population," to "avoid places where large number of people gather, especially cultural events, places of worship, schools, and shopping malls" and to "exercise increased caution when visit-

ing local bars, nightclubs, and casinos".

The international rights group warned that travellers could be at a higher risk of being targeted with gun violence in the country depending on their gender identity, race, country of origin, ethnic background or sexual orientation.

"Under international human rights law, the United States has an obligation to enact a range of measures at the federal, state, and local levels to regulate access to firearms and to protect the rights of people to live and move freely without the threat of gun violence," they added in the advisory. "The government has not take sufficient steps to meet this obligation."

US President Donald Trump has called for "great" reforms to gun laws following recent horrific back-to-back shootings, but while narrow congressional measures may be taken, comprehensive change is unlikely in a divided Washington.

Trump consoled victims of mass shootings in Ohio and Texas on Wednesday, but despite promising a message of unity, he continued to rail at opponents while facing protests that his rhetoric on race has fuelled extremism. Trump flew to El Paso, Texas, where a self-declared white supremacist murdered 22 people last weekend at a Walmart heavily frequented by customers of Hispanic origin.

He spent about an hour and a half at a hospital with staff and victims before he and his wife Melania were driven to the city's emergency operations centre to meet with police officers.

### Remains of UK student who fell from plane now found

MADAGASCAR - Police in Madagascar on Wednesday said villagers had found the remains of a British student who apparently jumped from a plane after opening the aircraft door in midair.

Nineteen-year-old Cambridge University student Alana Cutland, who was on a research trip, fell from a light aircraft shortly after it took off from an airport in remote northwestern Madagascar.

Her body was found on Tuesday in the Mahadrodroka forest, police said

"Villagers have finally found Alana Cutland's body after a fortnight of searching," Chief Investigator Spinola Edvin Nomenjanahary said.

Police said she apparently jumped from the plane just five minutes after it took off from a small airport at Anjajavy on a flight to the capital Antananarivo on July 25.

The pilot and another passenger, Ruth Johnson, say they tried in vain to stop her, investigators report.

Anjajavy villagers launched a search for her body the day after the incident.

On Monday they performed a ritual called "joro" that involved the sacrificial slaughter of a prized zebu cow to seek help from a Malagasy god named Zanahary. They located Cutland's remains the following day, Edvin Nomenjanahary said. "We only found 40 per cent of the body," he said. The remains are expected be flown to Antananarivo on Wednesday.

According to investigators, Cutland had displayed erratic behaviour before the incident. The natural sciences student was supposed to have stayed 45 days in Anjajavy to study crabs but quit after 10 days.

In a statement issued through the Foreign and Commonwealth Office, the family described her as "a bright, independent young woman".

"She was particularly excited to be embarking on the next stage of her education, on an internship in Madagascar complementing her studies in natural sciences".

"Her thirst for discovering more of the world always ensured she made the most of every second of her action-packed young life."

#### MP kicked out of parliament for breastfeeding baby

JOHANNESBURG — Kenyans are divided over a decision by the Kenyan National Assembly to kick out a Member of Parliament for breastfeeding her five-month-old baby.

MP Zulekha Hassan was escorted out of Parliament on Wednesday by the sergeant-at-arms as she attempted to nurse her baby, leading to a halt in the morning's parliamentary proceedings, Africa News reported. Hassan's actions were termed as "unprecedented" by the speaker while the majority leader termed the action "out of order" and "gross misconduct".

However, the Woman's Representative for Kwale in southern Kenya, explained that she had brought her baby into Parliament due to an emergency and that if Parliament had provided a crèche she would have left her baby there.

Hassan further argued that if Kenya wanted to have more female MPs they needed to be provided with a supportive atmosphere. The incident has divided opinion on social media where a section of Kenyans, mostly women, berated her removal while others insisted her expulsion was a needless furore that she had created. *African News Agency* 

#### MP LIKENS CHINA'S RISE TO NAZI GERMANY

CANBERRA - The chair of the Australian Parliament's powerful security and intelligence committee has warned against China's rise, likening Australia's current experience with China to that of France in the face of an aggressive Nazi Germany in the 1940s.

In an opinion piece published yesterday, Andrew Hastie, a conservative government lawmaker, wrote that Australia faces its biggest economic and national security challenges in the next decade from the rise of China.

"If we don't understand the challenge ahead... choices will be made for us. Our sovereignty, our freedoms, will be diminished," he wrote. The West once believed economic liberalisation would naturally lead to China becoming a democracy, just as the French believed steel and concrete forts would guard against a German advance in 1940, he said. "But their thinking failed catastrophically," Hastie, a former SAS captain, said in an op-ed piece in newspapers the Sydney Morning Herald and The Age.

Hastie said the French "had failed to appreciate the evolution of mobile warfare," similar to Australia failing "to see how mobile our authoritarian neighbour has become."

#### Rally to protest against Kashmir move

NEW DELHI - Hundreds of people have rallied in the Indian capital to protest against the scrapping of a constitutional provision that granted special status to Indian-administered Kashmir. In the lead-up to its controversial move on Monday, Prime Minister Narendra Modi's government sent thousands of additional troops to the disputed region, imposing a curfew on parts of it, arrested political leaders and shut down telecommunication lines. Calling it as the "death of Indian democracy", the protesters in New Delhi on Wednesday demanded the recently reelected government of the Hindu nationalist Bharatiya Janata Party to reconsider its decision. #### ISIS 'resurging' as US pulls troops

SYRIA - The Islamic State (ISIS) jihadist group is "resurging" in Syria even as the United States withdrew troops, and is solidifying its insurgent capabilities in neighbouring Iraq, a Defence Department watchdog said on Tuesday. The jihadists - who suffered major territorial losses at the hands of Iraqi and Syrian forces backed by a US-led international air campaign - are exploiting weaknesses in local forces to make gains, the report from the Office of Inspector General said. "Despite losing its territorial 'caliphate,' the Islamic State in Iraq and Syria (ISIS) solidified its insurgent capabilities in Iraq and was resurging in Syria this quarter."

#### More Zimbabweans on the brink of starvation

HARARE - More than two million Zimbabweans are on the cusp of "starvation", the United Nations food agency has said, launching a \$331.5m aid appeal to help the southern African country recover from a devastating drought. David Beasley, Executive director of the World Food Programme (WFP), said on Tuesday that 2.3 million people in rural Zimbabwe were in "crisis emergency mode" and need food aid now."We are talking about people who truly are marching towards starvation if we are not here to help them," Beasley said. "We are facing a drought unlike any that we have seen in a long time.

#### Rwanda to stop Ebola from spreading from DRC

**RWANDA** - Rwanda is taking emergency measures to try and

stop the Ebola virus from spreading across the border from the Democratic Republic of the Congo. Since the latest outbreak was



discovered in the Democratic Republic of the Congo a year ago, the disease has killed at least 1 800 people. The health ministers of both countries have met to agree to a plan of action to prevent the spread of the epidemic. *AFP*

### Women still getting short end of the stick

CAPE TOWN -South African women are seemingly under siege as they are generally underpaid, under-represented and are likely to be killed by their intimate partners.

As the country marks Women's Day tomorrow, despite many strides and having one of the most progressive laws and policies on women empowerment and development, SA women still largely remain on the periphery in business, government and leadership in general. Women are also at the forefront of the country's unemployment crisis, rising poverty levels and face violence even from those who are supposed to protect them.

It has been reported that more than one in five women experience physical violence, with femicide reportedly being five times higher than the global average in SA, according to gender activists.

Every day, at least three women die at the hands of their intimate partners.

In April 2017, Karabo Mokoena died at the hands of her boyfriend Sandile Mantsoe, who was convicted and sentenced to 32 years in prison in May last year.

In almost a similar case, a 21-yearold Mangosuthu University of Technology student Zolile Khumalo was shot and killed allegedly by Thabani Mzolo, her boyfriend who's currently on trial for murder.

Despite women being in the majority of the population, only two of the country's nine premiers are women -Sisi Ntombela in the Free State and Refilwe Mtsweni in Mpumalanga.

Statistics SA estimates that women

make up 51.2 per cent, approximately 30-million, of the population but the recently elected sixth parliament's National Assembly reflects a 45 per cent women representation.

Although this reflected a slight improvement from the 42.7 per centrepresentation in the fifth parliament, women continue to be under-represented.

A report released by PwC found that SA women were consistently paid less than men, and to make matters even worse, there is no industry where they are paid more than men.

The PwC executive directors practices and remuneration trends report for South Africa released showed that in the technology industry, men are paid 22.9 per cent more, while in healthcare men were paid roughly 28.1 per cent more than women. Sowetan Live

#### Court rules in favour of Ramaphosa in Public Protector matter

PRETORIA - The North Gauteng High Court has ruled that President Cyril Ramaphosa has complied with Public Protector Advocate Busisiwe Mkhwebane's remedial action made against the Minister of Public Enterprise Pravin Gordhan by deferring disciplinary action pending judicial review.

Judge Letty Molopa-Sethosa delivered her judgment on Thursday and stressed that in Ramaphosa seeking to wait for Gordhan's review application before taking disciplinary action against the minister, the president's decision was rational.

The judge said it was 'mind-boggling' that Mkhwebane would not consent to Ramaphosa's request to suspend the remedial action against Gordhan as similar cases had recently been heard and interdicts were approved. The court battle between the president and the public protector was heard last week on an urgent

In May, Mkhwebane released her report into her investigation into Gordhan's handling of former deputy SARS commissioner Ivan Pillay's early retirement. She had found that Gordhan acted unlawfully when he signed off on Pillay's early retirement in 2010. He was the finance minister at the time. As part of her remedial action, Mkhwebane stated that Ramaphosa should take action against Gordhan for violating the constitution.

Both Gordhan and Ramaphosa took issue with the report and its remedial action. Gordhan has filed papers to challenge the report and its findings. Ramaphosa brought the interdict on Thursday and largely argued that he sought the court stay the remedial action pending Gordhan's review application. Advocate Dali Mpofu, who represented Mkhwebane, told the court that President Cyril Ramaphosa was allowing himself to be a proxy for Public Enterprises Minister Pravin Gordhan in applying to stay the disciplinary action recommended by Mkhwebane.

#### 7 cops arrested for corruption following Joburg CBD raids

JOHANNESBURG - Gauteng police have arrested seven of their own for an alleged corruption and defeating the ends of justice following the Johannesburg CBD raid on Wednesday.

According to Gauteng police spokesperson Brigadier Mathapelo Peters, the five police officers - a warrant officer and four constables - were arrested at the Johannesburg Central police station after they were allegedly caught attempting to resell the confiscated goods back to the illegal

Additionally, two officers from the Tactical Response Team (TRT) were also arrested following a police probe into a possible leak of information on the planned raid in the Johannesburg CBD. "The two were linked through investigations and on an eye witness account. Police believe the loot found

in 46 vehicles in the basement parking at Lister Building, could have been the cargo that was removed the night before, after the illegal traders had received a tip-off," she said.

Peters said the raids were set to continue and confirmed that during the Wednesday raid, police took over 560 undocumented foreign nationals under processing.

"Their status in the country will be determined by the Department of Home Affairs while the Local Criminal Record Centre from the SAPS will determine criminal records," Peters added. She further added that police recovered 16 unlicensed firearms, including six rifles, six pistols and four handguns, as well as hundreds of assorted ammunition in a room at the 12th Floor of the Medical One Shopping Centre in Rahima Moosa Street. #### olice uncover Umhlanga drug den

DURBAN - KwaZulu-Natal police have uncovered a drug den operating out of a home in Umhlanga, in the Durban north area.

The raid led to an arrest of a 39-year-old woman. Provincial police spokesperson, Lieutenant Colonel Thulani Zwane, said police received information about the den operating in the area.

"Armed with a search warrant, a joint multi-disciplinary operation was conducted at Umhlanga to follow up on intelligence with regards to the drug den. The officers pounced on the identified premises and the suspect was searched," he said. Zwane said police found 1 094 heroin capsules,

1611 mandrax tablets, 11 000 empty capsules, 689 ecstasy pills, 70g crushed ecstasy pills, 10g heroin powder and 754g of bulking powder were recovered. "The estimated street value of recovered drugs is R227,770. A female suspect was arrested and charged with dealing in drugs. She is expected to appear at the Verulam Magistrates Court on charges of dealing in drugs. The seized drugs will be subjected to forensic analysis," he said. This arrest comes after six suspects were arrested for possession of drugs by the eThekwini Outer South Cluster.

influence the quality of gospel music in the country. The talent search will run up until November while regional auditions will run up until September 7. After the regional auditions, contestants will be mentored and eliminated.





The organisers of the event believe that the culture of hip hop music gives young people a medium to express their feelings and situation in life.


They also believe that there is no big hip hop culture in Eswatini out of the lack of venues, which is what the event will try to change. It is planned to be the first edition with more to come.

Entrance to the event is E50 and the show will commence at 6pm.







Mahlangu said the Bafana job could destroy his former team-mate at this early stage of his promising coaching career and he should reject any offer from SAFA.



"I have heard a lot of people talking about Benni McCarthy to coach Bafana and it appears he wants the job," the outspoken Mahlangu said. "But if I was close to him, I would advise him not to take the job because that responsibility could destroy him "I know the good job that he has done at Cape Town City and he is definitely our coach for the future, but he is still a baby for Bafana."

McCarthy has emerged as one of the more popular choices to succeed Baxter and even his Cape Town City boss John Comitis gave him his blessing a few days ago.

Mamelodi Sundowns coach Pitso Mosimane, himself a favourite for the job, also gave his backing to McCarthy.

But Mahlangu warned that McCarthy should ignore all these endorsements of his coaching ability stay clear of Bafana at the moment until later in his career.

### Romelu Lukaku greeted by wild Inter Milan fans


MILAN – Romelu Lukaku joined Inter Milan from Manchester United yesterday with Italian media reporting he will sign a contract immediately after undergoing a medical

However, the majority of those players were signed on pre-contracts and as free agents.

"We can't buy anybody so we are not going to buy anybody," said Hunt after their 1-0 loss to Baroka FC at Bidvest Stadium on Tuesday night.

"What do you think (I'd do if I had the money) I'd buy a team, wouldn't I? I won the league by 20 points (when I had the money).

It's the South African economy, people are losing jobs. They're cutting back everywhere, but it's understandable. We are working in tough times and football is an industry that you'd pull back the plug in. We are okay. I don't know the ins and outs of everything but I know that things have been cut and people have left for financial reasons."

The 10 new players will have to work their socks off to replace some of the players that were shipped out during the transfer window. However, Hunt has already been impressed by how some of his newbies have adjusted. Macheke, Lark and Doutie have already featured for the Clever Boys.

"We've spent no money and we haven't bought anybody, so it is what it is," Hunt explained. "I've got to battle away. We've got good hardworking players (but) we are going to need hardworking players along the line.

"With all due respect to the previous players, but I think we got some good players here, for free. On Tuesday, the results were not where we wanted them especially after Saturday. But I can't fault them, they gave me all - the quality was just lacking."

While Hunt will need a few tricks up his sleeves to turn somewhat of an "average" team into "championship material", there are increasing rumours that some of his talismen are top priorities on rival teams' lists.

Captain Thulani Hlatshwayo is said to be wanted by Orlando Pirates, while Thabang Monare is sought after by Kaizer Chiefs. Wits have reiterated Hlatshwayo is not for sale locally, while Hunt admits that he's given the duo "honest advice".

"The boys are fine," Hunt explained. "Obviously it's disturbing when you open up a football paper, and there's a story about one of them.

They talk to me and I talk to them. But I'll always give them the best advice."



Mabuza has caps with the senior national team Sihlangu Semnikati as he featured during the recent 2020 CHAN second round qualifiers against Angola, which they won.
