Stern advice to pastors

THE founder of God's Glory Ministries Pastor Victor Macdonald condemned all pastors that require payment for their services and said it is against the will of God.

Macdonald said all pastors, prophets, evangelists as well as everyone who calls himself or herself a steward of God should not require or demand payment when doing the work of God. This work

that the pastor was talking about includes counselling and prayers, amongst others. "Registering of congregates and paying for counselling sessions and one-on-one with pastors must stop," he said.

He further condemned the writing of names on tithes envelops. The pastor said this was far from the true Gospel of God as offerings are between men and God not pastors and brethren.

He added that some pastors even had the nerve of calling congregates and demand tithes.

The pastors, whose statement caused a stir among those who were listening, said many people no longer worship God but their leaders, which is biblically incorrect. Moreover, he condemned all the banners and billboards by pastors. He said instead of calling people to God, people are now called to pastors. He said people should not pay in order to be helped in the house of the Lord.

Dr Dlamini said Christians were calle to minister to the world, not only through words but by action. Thus he pleaded with all Christians to imitate God's Glory Ministries.

"I have no doubt in my mind that God is pleased with this initiative." he said.

Furthermore, he said the church's mandate is to build and support, preach the Word and pray for communities. Dlamini said this is what Jesus did and it is a cornerstone of the Christian faith. "Your work here and elsewhere is not only being in line with what God expects from us, it also supports the initiatives of the whole country to eradicate poverty and its impact in families," he said.

Believing

He encouraged the church as well as the donors to continue supporting the foundation as such acts of kindness foster brotherhood, peaceful coexistence and fellowship.

The MD emphasised on the importance of believing in God. He urged Ayanda to continue trusting God and His ways. He also asked her to keep a strong relationship with God. He said this was because God lives and works through His people.

"To the people of Mpolonjeni community, please emulate this gesture and share whatever you have with those who have nothing. God will

bless you," he urged. Worth nothing is that this is not the only house built by God's Glory Ministries. The first one was built in Motshane for an elderly woman, the second one is in Siphofaneni. Ayanda's house was the third project by the ministry. The Project Manager Pastor Siyabonga Vilakati said the construction of the house cost E650 000 while the furniture cost E80 000. The project took only two months to complete.

INFORMATION sourced from AccuWeather Services shows that the week will be sunny and temperatures will increase gradually during the week.


Temperature range is between seven to 34 degrees Celsius.

MOTHER STOPS TEKA CEREMONY

IN a rather shocking incident, a man's dream of having a wife has been short-lived as his wife to be was taken from him while she was being teka-ed by her mother.

The incident is said to have happened at Nsalitje in the Shiselweni region a week ago. Thembelani Zwane, who is the victim of the scenario, said he was saddened by the act of her fiancé's mother because they have been in an intimate relationship for long time and felt it was the appropriate time to take their romantic relationship to the next level.

Zwane said the act of his mother-in-law shocked him as he had not anticipated that she will not approve of their marriage.

"We have been in love for quite some time and I felt it was the right time to take our relationship to another level, hence I teka-ed the love of my life only to be met with this unexpected act from my mother-in-law," Zwane narrated.

According to witnesses, the incident happened at around 6am where the mother of the bride came unno-

ticed and went straight to the kraal where her daughter was being tekaed. It is said when she got into the kraal she shouted at all those who present saying unpalatable words to the 'groom's' family.

Zwane said if this meant that he was not supposed to marry the love of his life, it was very painful because he did not do anything that is against the law as they unanimously agreed with his fiancé to get married that

Threatened

Attempts were made to prevent the mother-in-law from disturbing proceedings but it was all in futility as she is reported to have grabbed the spear from her daughter and threatened to stab anyone who could try stand on her way.

This has left a lot of the area's residents shocked and wondering what made the woman to do such a thing.

When all that unfolded, the members of the Zwane family watched in disgust and when one elder tried to talk sense to the woman, she could not even give him a chance to explain himself.

"She took her daughter and did not even care that she was only wearing sidvwaba and that left us with many unanswered questions on why she was doing that because this is allowed in our culture," said one witness.

One went on to say that the mother of the 'bride' had for a long time disapproved of the relationship between the two and the fact that she was now being teka-ed was another story.

When contacted, the would-be bride said she did not know what got into her mother as she has never even once raised any concern about her relationship with Zwane.

Deliberating

Primrose Msweli said despite the fact that her mother had done this, she would continue her relationship with Zwane and if this is not sorted out they will get married in a different way.

"The two families are still deliberating this issue and if there is no sound solution we will have no choice but get married at the District Commissioner's (DC) offices," Msweli added.

She went on to say that her relationship with Zwane was known by everybody in the community as they have been in love for three years. She said there was nothing wrong her fiancé did as this was proper Swati culture which has been practiced by many and for

years

"I was very embarrassed by what my mother did. I don't think it was the right call to do what she did on that day, especially in front of my in-laws and the members of the community who had come to witness the ceremony," she said.

Msweli, who said her father died eight years ago, believes he would not condone what her mother did. She said her mother did this because she knew that no one in the family will challenge her.

Msweli's mother could not be reached for comment as she was reported to be in South Africa where she stocks some merchandise as she runs a hawker business.

Hlengiwe Mhlaba hospitalised after serious road crash

MELMOTH - South African gospel star Hlengiwe Mhlaba was involved in a serious car accident on Saturday afternoon.

The accident happened in Melmoth, northern Zululand. The singer, who is known for her powerful voice, was travelling to Mpumalanga where she was booked to perform.

Mhlaba was in the Kingdom of Eswatini last week where she performed at the 2019 Eswatini International Trade Fair's official opening by His Majesty King Mswati III.

According to her spokesperson Nkululeko Khanye, the singer's car rolled when she tried avoiding an oncoming car that was driving towards her.

Mhlaba sustained serious internal injuries and was admitted at a hospital in Empangeni, Kwa-Zulu-Natal, where she is under doctors' supervision.

"On Saturday it was very wet when the incident happened. Hlengiwe saw a car that was driving straight towards her and tried to avoid it but lost control and the car rolled."

"We ask the nation to continue to pray for her speedy recovery as well," Khanye said.

THE funeral of the late former Zimbabwean president Robert Mugabe is scheduled to take place

on Sunday.

This is according to a statement issued by Zimbabwe's ministry of foreign affairs and international trade.

The ministry has extended an invitation to all diplomatic missions accredited to Zimbabwe.

According to the statement, the state funeral service will be held on Saturday at the National Sports Stadium. Times at which the event will start will be communicated in due course.

Heads of State/Government wishing to attend the ceremony are advised to arrive in Harare on Friday. Heads

of State/Government are also expected to depart from Harare immediately after the ceremony on Saturday, taking into consideration that government authorities of that country will be fully occupied with preparations for the burial service /ceremony reserved for Sunday.

"The full programme for the funeral service will be made available in due course.

The government has block booked

accommodation for 1+2 per delegation," reads part of the statement. The trade ministry of the Republic of Zimbabwe has promised to be of assistance to all those who would need help.

The late Zimbabwe's strongman is said to have died on Friday last week while undergoing treatment in Singapore. According to reports, Mugabe's body is expected to arrive in Zimbabwe on Wednesday.



WORLD ECONOMIC FORUM ON AFRICA: -

ESWATINI COMMITS TO MEDICINEMANUSACTURE

THE Government of Eswatini has committed itself to formulating strategies which may enhance the manufacturing of medicine in Africa.

This was during the 2019 World Economic Forum for Africa, which was held at Cape Town, South Africa. Prime Minister Ambrose Dlamini represented His Majesty King Mswati III in the summit.

The summit was under the theme; "Shaping Inclusive Growth and Shared Futures in the Forth Industrial Revolution"

The theme facilitated an opportunity to interrogate ways to further strengthen the continents and the world's response to technological advances brought about by the forth industrial revolution.

Speaking during a media briefing upon his return on Saturday, the prime minister disclosed that his delegation participated in a number of discussions with other heads of state. Amongst these discussions, heads of governments discussed the possibility of manufacturing medicine

in Africa, and improving the continent in the fractured world. The prime minister was assigned to lead and direct these two sessions.

Strategies

Dlamini said his delegation actively participated mainly on the first topic in which the heads of governments discussed strategies on how the continent may benefit in manufacturing its own medicine. This comes amid reports that government is struggling to keep sufficient stock of medicine in health facilities due to financial challenges.

Meanwhile, the premier said his delegation also honoured a courtesy call to President Cyril Ramaphosa who affirmed that country's commitment to maintain and strengthen bilateral relations with Eswatini.

In the same vein, the prime minister held bilateral talks with South African Minister of Trade and Industry Rob Davies where issues of trade were discussed. During these deliberations, the two governments interrogated the possibility of the long awaited 24-hour operation of border gates linking the two countries.

"In general, the summit was a success as heads of governments managed to discuss a number of priority issues touching on the economy of Africa," said the PM.

Japan pledges support on Science and Technology

JAPAN has pledged to continue supporting Eswatini, especially in Science and Technology and other development programmes.

This was reported by Prime Minister Ambrose Dlamini upon his return from the seventh Tokyo International Conference on Africa Development (TICAD).

The conference was held at Yokohama. Japan. During the conference, heads of states deliberated on several issues under the theme: "Advancing Africa's Development through People, Technology and Innovation".

The Eswatini delegation, which was led by the prime minister, made interventions at two plenary sessions and one thematic session, namely; Accelerating Economic Transformation and Improving the Business Environment through Innovation and Private Sector Engagement.

Dlamini said his delegation also met with the prime minister of that country, Shinzo Abe and engaged on bilateral talks. It was during these discussions that Japan pledged support to Eswatini on Innovation and Technology and other priority issues.

The PM acknowledged that Japan has already supported the country in a number of development programmes. These also included financial and technical co-operation in the areas of health, education, people development, mining and priority infrastructure projects for the country.

Police accommodation a breeding ground for SODV cases

The current accommodation arrangement for the Royal Eswatini Police Services (REPS) personnel has been branded as a major hazard and a breeding ground for SODV cases.

The concern was raised by Senator Tony Sibandze during the debate of the police first quarter performance report at Senate on Thursday.

He mentioned the sharing of houses by the police was a cause for concern, as they were exposed to tempting environments that could lead to cases of abuse and violence.

He wondered, as the nation moved forward in addressing matters of sexual offences and domestic violence, how protected the police service personnel was, as they are constantly exposed to trying environments due to sharing of apartments as a result of a shortage in accommodation.

"It is a major concern that police officers around the country are forced to share houses while other officers



are living with their wives and children," he said.

Sibandze mentioned he was hopeful that the matter of accommodation for the police personnel would be addressed as it was non-conducive and unsafe for the law enforcers and their families.

Sibandze said the reported reduction in some criminal activities within the country as well as the REPS strategic roadmap was very encouraging even though they were faced with challenges.

He stated that another more pressing issue regarded the police working tools, especially police vehicles. The services provided by the police, according to the senator, were crucial and needed for safety and peace with-

In his preamble, Prime Minister Ambrose Mandvulo Dlamini, who was represented by Deputy Prime Minister (DPM) Themba Masuku, noted that in the period under review, certain crimes such as murder, armed robberies and rapes have been on the ascendency, there were numerous efforts made by the police in addressing the matter.

The senator said even though the efforts and plans put in place by the police were encouraging, it was also apparent that they were attained under trying circumstances as the police were not well equipped when it came to vehicles and the ones that were available were also not in good condition.

Ensuring

"If more effort was put in ensuring that the police had adequate working equipment, the reduction of crime would be enhanced," he said.

Sibandze made an example of Manzini as a big city with lots of businesses and residents, which posed a challenge for police to respond to calls due to the lack of vehicles as there were only four vehicles available to the traffic police.

He stated that this was not good for Emaswati and also the police as their response time to incident calls was affected, thus leading to poor service delivery. "Some police officers opt

to use their own private cars to be able to promptly respond to calls which is not good," he added.

He requested that as the REPS and the Prime Minister's Office was formulating the roadmap, the issue of increasing the number of police vehicles should also be considered.

Critical

He added the services provided by the police were as crucial as health services because they offered the country's citizens a sense of safety and

Meanwhile Senator Chief Nzameya Nhlabatsi concurred with Sibandze in that the services provided by the police were critical and the shortage of police vehicles needed urgent attention as it was a serious matter of secu-

He stated the rural police posts were the most hindered in terms of police working tools as well as accommodation. He said some of the rural police posts were responsible for large jurisdictions but had limited cars for attending to incidents resulting in poor service delivery which consequently could lead to citizens losing faith in the police service.

He urged the Prime Minister's Office to take urgent action in addressing the issue of vehicles and accommodation for police personnel in order to improve on service delivery.

You are a class member, and will be included in the settlement, if you meet all the requirements of any of the four classes:

Class 1:

- 1. who as at the date when the settlement agreement comes into force, have undertaken risk work. In terms of the settlement agreement, risk work means "risk work" as defined in the Occupational Diseases in Mines and Works Act, 1973 or any of the following work:
- (i) work in the underground workings of a gold mine;
- aundry where clothing of underground mineworkers is washed; (iii) work on a slimes dam of a gold mine; (iv) work in an assay laboratory of a gold mine where the composition of gold bearing ore is analysed, and where the mass of respirable dust from personal
- sampling is determined; (v) work in a metallurgical plant of a gold mine, including crushing, milling, transporting and smelting of ore; and
- (vi) work at conveyor belt operations which are undertaken to convey broken rock from the underground operations of a gold mine to surface;
- 2. who on or before the date when the settlement agreement comes into force, have contracted silicosis or have been exposed to silica dust; 3. who undertake or have undertaken risk work on one or more of the mines
- listed in Annexure A of this notice after 12 March 1965; and 4. Who did not settle their claims in previously finalised settlements with Anglo American South Africa Limited and AngloGold Ashanti Limited on 14 March
- 2016 and Anglo American South Africa Limited on 19 September 2013,

The dependants of any of the persons in Class 1 above who are deceased as at the date when the settlement agreement comes into force.

All people:

- 1. who as at the date when the settlement agreement comes into force have undertaken risk work:
- 2. who on, before or after the date when the settlement agreement will come into force have contracted Tuberculosis; and
- 3. who undertake or have undertaken risk work, after 12 March 1965, on one or more of the gold mines listed in Annexure A of this notice

The dependants of any of the persons in Class 3 above who are deceased as at the date when the settlement agreement comes into force.

WHAT IS THE EFFECT OF THE SETTLEMENT?

Tshiamiso Trust to receive monetary compensation.

The settlement is not yet in force because some of its conditions have not yet been met. If the conditions are met, the participating gold mining companies will establish a fund, called the TSHIAMISO TRUST.

If the settlement agreement comes into force:

- · The participating gold mining companies will pay agreed contributions to the Tshiamiso Trust and the process of paying compensation can start.
- · All class members can submit a claim to the Tshiamiso Trust for monetary compensation, except for those class members who opt out of the settlement



board which was previously led by now Prime Minister Ambrose Mandvulo Dlamini for the good work they have been doing in improving lives of destitute people in the rural communities.


Establishment


Meanwhile, Sandile Simelane has been named as the new Chairman.



Mamba was informed that half of her sentence was suspended for a period of six months, meaning that she would have to part with E500 to gain her liberation.

'Love for 'li-orintji' got

A man sporting blood and mud stained clothing and a bandage covered head caused laughter in court after he told the tale of how home-brewed alcohol caused him to lose control of his vehicle.

Police reports released yesterday revealed that 97 motorists where nabbed for driving under the influence of alcohol over the long weekend.

20-year-old Mxolisi Hlophe of Maguga told Magistrate Sifiso Vilakati that he was drinking wine with his friends when they sent him to restock their alcohol supply.

"I was deemed the best fit to drive, as every one of my friends was too inebriated to drive. The owner of the vehicle furnished me with his car keys and I was advised to restock the alcohol supply at the army barracks at Nkambeni. I agreed and I went on my way," Hlophe explained.

Hlophe recalled that on his way to the barracks, he received a phone call from his brother inviting him to another party he was hosting that same night.

"My brother informed me that he brewed alcohol made from the orange fruit, and it was the best he had ever made. The news excited me to the point of making the decision to abandon the trip to the barracks to buy my friends' alcohol. I then made a U-turn in an attempt to drive towards my brother's place. I was too drunk to control the vehicle and that was when it veered into a drainage system," Hlophe recalled, much to the amusement of the court.

During his appearance, it was ascertained that Hlophe had been arrested and charged with four counts of contravening the Road Traffic Act.

As a result of the accident, Hlophe appeared before the court covered in blood and mud stained clothing, and a large bandage covering his head was enough evidence of his misfortune.

According to the first count, Hlophe was found to have been driving a Toyota Vios vehicle while under the influence of alcohol on Saturday evening at LaMgabhi. When a breathalyser test was conducted on him by police officers, he was found to have an alcohol content reading of 0.85mg/l.

In the second count, Hlophe was found to have lost control of the vehicle, causing it to plunge into a drainage system. The particulars of his negligent driving stated that Hlophe drove at an unreasonable speed, failed to apply his brakes on time and failed to avoid an accident

NDMA sends stern warnings for spring season

EMASWATI are urged to be safe than sorry during the spring season.

The National Disaster Management Agency (NDMA) made this call. The spring season is normally accompanied by storms, thunderstorms and heavy rains that may cause disasters and damage property.

Fresh from the winter season that left over E20 million damage caused by wild fires, the agency said it was no time for rest for them as the spring season officially began.

NDMA Communications Manager Wandile Mavuso issued a stern warning to Emaswati in order to prevent the extensive damage caused by the extreme weather conditions experienced during the season.

"It is necessary to preach safety this spring," he said.

Mavuso, speaking during an interview, said they can never be completely ready for disaster but prepared if one may occur. The disaster mouthpiece shared a few pointers with Emaswati which can minimise the effects of the natural disasters.

Firstly, he urged the nation at large to keep track of weather updates.

He said by keeping track of weather forecasts, they would be able to prepare for extreme weather conditions hence minimising the damage.

Secondly, Mavuso said it was time to fix leaking roofs and loose screws.

He added that this would minimise the rate at which houses are left without roofing when hailstorms and thunderstorms strike. "Fixing the roofs will

be cheaper than replacing it after it has been damaged by wind," he said.

The manager also urged people to remove all heavy material on roof tops. Mavuso said in the past they encountered incidents whereby people were hurt by rocks, logs and tyres placed on roof tops after the heavy storms blew their roofs

Above all, he could not over emphasise on the crossing of overflowing

He said the agency would be engaging with people on different media platforms to ensure that the distraction is minimised as much as possible.

Apart from common spring season weather patterns, Mavuso said they were also in the lookout of damage caused by fire from lighting and burning of fields in preparation for the ploughing season.

Govt hit paper shortage

GOVERNMENT offices are hit by a serious shortage of stationery.

Operations seem to be disturbed in government offices and organisations. This is because the government has a shortfall of a serious commodity 'paper'. People visiting government offices had to look for other means of accessing services in these offices mainly those whose documents had to be printed.

Some members of the public that visited the Master of the High Court were asked by officers to make copies of certain forms they need to fill because the office could not produce more form for them. According to the members of the public, they were told that the offices did not have stationery 'paper' to be exact.

Another government department hit

by the paper shortage is the ministry of home affairs.

This is reflecting at the border posts as people have to share gate passes. One traveller said he had to wait for three more people at Ngwenya Border Gate so that the officer can furnish him with a gate pass. "Gate passes are given in groups," said the traveller.

Civil servants are starting to have blur memory of a payslip. This is because even this month civil servant payslips were not printed.

This is the third month civil servants had to go without payslips. When asked, it is communicated that there is a shortage of paper hence the government is unable to print payslips.

According to some civil servants who needed their payslips to apply for financial assistance and purchasing some items, they had to visit the government treasury department asking for their payslips.

The civil servant said this was time consuming and a waste of money they do not have travelling to Mbabane and plead for their payslips.

When Government Spokesperson Percy Simelane was contacted, he said the fact that travellers had to wait for a gate pass at borders should be evidence that plan B is in place.

Simelane was responding to the question of what is the government doing to minimise the shortage of paper.

In addition he said she happens from time to time all over the world, including during crucial times such as elections.

"There shall always be replenishment mechanisms," he said.

Coming to the issue of payslips, he stated that all ministries have accounts sections, therefore, anybody who wishes to access their pay slips can approach these offices for assistance.

Simelane emphasised that the shortage is not across government as some ministries are not affected.

WHILST making reference to Hlophe's unfortunate incident, Magistrate Sifiso Vilakati condemned the 11 drink-drivers who appeared before the court yesterday for driving while under the influence of alcohol.

"You are all here for driving while under the influence of alcohol, yet none of you were wise enough to use alternative means to get home. Taxi cabs are a safer alternative to driving while drunk, and are a cheaper option. You probably did not even spend more than E200 while buying your alcohol, yet you will pay fines of more than E1 000 for risking your lives on the road," the magistrate cautioned.

Magistrate Vilakati stated that the fines they were set to pay for driving while under the influence of alcohol were enough to sustain their families' needs.

"E1 500 goes a long way with providing families with just the basic necessities. Electricity and utilities bills, food and other things can be sorted out with that amount of money alone. Yet, you

all decided to waste your monies on drinking alcohol when your families could have used the money for more constructive things. The court will continue to reprimand you for committing this offence as it is risky and irresponsible behaviour which leads to death on the country's roads," the magistrate

I had umcombotsi from traditional wedding-DD accused

WHAT was meant to be a joyful day for a man who had attended a traditional wedding ended up being a moment he would want to forget soon after spending a night behind the police cells.

This was the story of Mbuyiseni Sukati who appeared before the Magistrate's Court where he faced a charge of driving a motor vehicle while under the influence of alcohol. He was charged with contravening the Road Traffic Act of 2007. According to the charge sheet, Sukati was said

to have wrongfully and unlawfully driven a motor vehicle while under the influence of intoxicating liquor. A breathalyser test indicated that the accused person had an alcohol content reading as 0.76 mg/l in his system. This is above the legal limit which stands at 0.37 mg/l.

When the charge sheet was read to

him, Sukati pleaded guilty to the charge.

His plea was accepted by the crown without leading evidence to prove commission of the offence. He then mitigated for a lenient sentence from the court, saying he was a first time offender.

He further told the court that he was on his way from attending a traditional wedding at Mzilikazi when he was nabbed by traffic officers who had mounted a roadblock.

Sukati said he had a few cups of a traditional brew which is known as umcombotsi.

"I just had a few cups of umcombotsi as part of the ceremony where attendees are expected to share a bowl of the brew," he said. Sukati was eventually found guilty of the charge. He was sentenced to three months in a correctional facility with an option to pay E1 000 fine.

Man accused of raping minor (12)

A man (40) has appeared before the Magistrate's Court after he was alleged to have raped a minor girl (12).

Bheki Shabalala appeared before Principal Magistrate Fikile Nhlabatsi after he was charged

with rape. The accused has pleaded not

guilty to the offence. Shabalala told the magistrate that by the time the offence was

committed he was at work. The incident happened in Mbabane on April 18.

"Your Worship, I did not commit the offence. In fact on the said day, I had just started work after a long time of not working. There was no way I could have left office to the place where the offence was committed. I was going to lose my job.

The truth shall come out in this matter," said Shabalala.

The survivor's grandmother Zandi Dlamini * told the court that she noticed symptoms of rape when the minor returned

from school on the day of the incident. She told her that she had eaten guavas.

Dlamini told the magistrate that the survivor kept visiting the toilet now and again.

Dlamini* told the court that when she returned from Easter Holidays, she discovered that the minor had been raped.

Returned

The minor's mother Sindi Dlamini * also told the court that when she returned from Easter Holidays, the minor told her that she had been raped by a man she knew from around area.

"The minor told me that she had had been raped by a man who usually passes by my home and gives them chips. She told me that she was coming from school and suddenly the accused emerged from the bush and held her by her hand," said Dlamini

Dlamini said the minor related that the accused held her hand , made her lie on the ground and

Dlamini also told the court that the survivor's friends fled, leaving her with the accused.

Your Worship, after he was

done, the accused offered the minor a sum of E10 and further threatened to stab her if she spoke about the incident to her family members. "However the minor refused to take the money and instead she fled back home," said Dlamini

During cross-examination, the accused asked what colour was the knife she had threatened to stab the victim with and in her reply Dlamini told the court that she did not know it.

Dlaminisaid the surivivor was taken to the hospital when the doctors confirmed that she had been raped.

The matter is still pending at the Magistrate's Court.

ADOLESCENT FINED E300 FOR STEALING WATCH

COURT President Chief Mabhedla Hlophe has ruled that an adolescent (17) who stole a wrist watch while at Mbabane Truworths Stores be in custody for three months or pay a fine of E300.

Sikhombiso Mhlongo of Dlangeni stole a watch valued at E300.

The wrist watch was in the lawful custody of Sizwe Kunene.

Pleaded

The incident happened on August 3.

The accused pleaded guilty to the offence. Fidelity guard Mandla Kunene told the court that the time was 09.40 am and he was on guard at the Mbabane Truworths fashion outlet.

He also told the court that while he was carrying out his duties, he then heard the clothing alarm at the stores door going off.

"Your Honour, the accused entered the shop and he went to the watch section where he took one watch and put it in his pocket. At the exit point the alarm then went off.

I then hurried to the door to find out why the alarm went off.

At first the accused did not want us to search him and with the help of my fellow workmates we were then able to take him to the storeroom where we searched him and discovered the stolen watch hidden in his pockets," said Kunene.

He then reported the matter to his senior manager who urged him to report the matter to the police.

Repeat

During mitigation, Mhlongo told the court that it was a mistake and he will not repeat this offence again.

He told the court that he was still a scholar. "Your Honour it is true that I went to the Truworths outlet and stole a watch.

This was because I wanted to replace my friend's watch that I lost in Cape Town.

My friend was pressuring me and I also gave him my cellphone.

I needed my cellphone back and so I went to steal the watch at the shop hoping that my friend would give me back my cellphone," said Mhlongo

"The court condemns the act of shoplifting. You were going to succeed if the guard didn't apprehend you.

This offence was intentional and purposeful," said Court President Mabhedla Hlophe.

1. Business Environment and the National Quality Infrastructure (NQI)

A healthy business environment can be essential for growth and poverty reduction and a prerequisite for trade and competitiveness. The Quality Infrastructure (QI) is an important element of the business environment. Hence, business environment initiatives without considering QI reform may be incomplete.

1.1 Business Environment Initiatives and Quality Infrastructure

The business environment can be defined as the complex of policy, legal, institutional and regulatory conditions that govern business activity. It is a subset of the investment climate and includes the administration and enforcement mechanisms established to implement government policies, as well as the institutional arrangements that influence the way key actors operate, such as government agencies, regulatory authorities, and business membership organisations.

The business environment clearly has an influence on the development of the private sector, and thereby on economic growth and the generation of livelihood and jobs. Business environment reform promotes the development of markets that encourage healthy competition and enhances the effectiveness and sustainability of development interventions. Business environment reform is multifaceted, operating on many levels and involving a very wide range of stakeholders.

1.2 The Quality Infrastructure - Overview

The QI is generally understood to be the totality of the policy, legal, regulatory and administrative frameworks and the institutional arrangements (public and/or private) required to establish and implement standardisation, metrology (scientific, industrial and legal), accreditation and conformity assessment services (inspection, testing and product- and system certification) necessary to provide acceptable evidence that products and services meet defined requirements, demanded either by authorities (e.g. in the case of technical regulation) or the marketplace (e.g. contractually or inferred).

It is important to understand that the QI, consisting of a number of institutions or service providers, can only function properly as a whole; the incompetence or absence of any one of the constituents will compromise the effectiveness and ultimately the efficiency of the whole system, thereby negatively impacting the business environment. The foundational parts of a QI are the standards, technical regulations metrology, conformity assessment activities and accreditation organisations/institutions without which none of the other elements will

be able to function properly. Because of their importance, it is imperative that governments play an active and continuous role in the establishment and sustainability of these institutions. They provide services which oftentimes are not targeted at a specific beneficiary that could be made responsible for their financing.




Figure 1 below illustrates how the QI cascades.




Figure 2: Flow of products or services to global markets

borders; the quality of products and services is therefore a key determinant of private sector performance as it allows companies to compete, conform to market requirements and connect to markets - see Figure 2.

Cracks in the leadership of Mathendele

THERE is a serious division he was now considering in the leadership of Mathendele Township which is also threatening its existence.

It is understood that the elders known as 'libandla' which has similar authority to that of an inner council in a chiefdom no longer see eye to eye. Mathendele Township is considered one of the mini-chiefdoms of Mbangweni Umphakatsi. The elders of the township consult and report to Mbangweni Umphakatsi.

For years, the township's known Indvuna was the late Tom 'Good Morning' Hlatshwako who was a soldier. It is now not clearly understood as to who is acting on the position. Hlatshwako was also active in royal activities as he never missed the weeding and harvesting of royal fields.

Now, it is believed some of the so called members of 'libandla' are not pulling in the same direction, a situation which requires elders from Mbangweni Umphakatsi to address before things turn ugly.

Pat Gamedze who has all along been considered Chairman of the libandla confirmed that there were people who were doing things their own way. He stated that as someone tasked with the role of chairman, things were now done behind his back. He said

approaching the umphakatsi elders to dissolve the 'lihandla'. "As I speak, there is a new member in the 'libandla' who has been added without my consent.

Some of these people, they have been ordered by the Mbangweni Umphakatsi to bring their documents to prove that they indeed deserve to be in the leadership. There are those that possess documents bearing names of other chiefs and don't qualify to be part of the libandla. I am sure, the Mbangweni elders are soon to act on this issue," Gamedze said. On the other hand, Anthony Maseko who is regarded as secretary of the 'libandla' said in as far as he was aware; Gamedze was no longer part of them (libandla).

He said Gamedze had no say on issues pertaining the township's leadership.

"In our books, we consider him as no longer existing. He has to do his homework as even the constitution we have, it is there in black and white as to who are the people who should be part of this libandla," Maseko told Shiselweni News.

On what Maseko stated, Gamedze said he would not respond as he was not answerable to them and they did not possess the power push him

AFTER 26 YEARS, SISTERS GRANTED FATHER'S ESTATE

ABOUT 26 years after they were expelled from their parental home as a result of an estate dispute, two women have been granted permission to officially possess their late father's estate.

Phumzile (60) and Thuli Manyatsi (57) of KaNdinda under Chief Lukhwabitsi received the good news that their fight against their uncle and cousin who had been illegally occupying their father's home had been won, courtesy of Mankayane National Court (Ndabazabantu). The verdict was issued on August 19 and the women have since started making renovations in their home.

Convened

According to the eldest of the daughters; Phumzile, they were ordered out of their father's home in 1993 after their father, Ben Babili Manyatsi died.

It is said that on the day of Manyatsi's burial, his younger brother convened some family members, including the deceased's daughters, to inform them that he was in charge of his late brother's estate.

Also, Phumzile said, it was dur-



ing that meeting that the family was informed that the uncle's son; James Mehluko Manyatsi, had been adopted by Manyatsi and his other wife; Fikile Idah Hlatshwako, since she did not have children of her own.

Documents

This, according to Phumzile, came as a surprise because no one in the family knew about it.

She said this was more so because the siSwati tradition of kufaka umuntfu esiswini (fostering) was never performed and there was no documentation of such.

Back then, Phumzile said since Manyatsi's daughters were in disagreement with what their uncle was telling them, they decided to engage the KaNdinda Umphakatsi which, after requesting that the uncle furnish them with documents to sub-

Adopted son runs to court

AFTER the unexpected return of Phumzile and Thuli Manyatsi to their parental homestead, James Mehluko Manyatsi has since run to court seeking an interdiction of the women from the home he claims to be legal-

Last Wednesday, James filed an urgent application at the High Court seeking that it interdicts the two Manyatsi women from renovating the houses situated in the homestead he claims to be his marital homestead that he shares with his father and family.

In the court papers, James claims that Phumzile and Thuli are renovating his home in anticipation

stantiate his claim but to no avail, also ruled that the women return to their parental homestead.

However, the umphakatsi council is said to have been divided in the matter so much that those who were for the return of the women to their home were overthrown from the seats in the council.

This then left those in favour of the uncle and his son. This turn of of occupying it unlawfully.

He said the interdiction should include the builders who have been hired by the women.

Valid

Also, James claimed that the court should interdict the two women because his family had been dispossessed of the physical control of the home without a valid court order, therefore, infringing on his family's constitutional rights.

Further, James alleged that the women's actions should be sanctioned in the interest of peace in the community, as well as the fact that no one may take the law into his own hands by unlawfully possessing one's property.

events is said to have resulted to the delay of finalising the matter.

Also, the demise of Manyatsi's wife LaHlatshwako three years later, fuelled for more dispute and delay of finalising the issue.

Her death, according to Phumzile, was the final nail in the coffin for them since their children were also shown the exit door.

This forced Thuli to resort to rent

out apartments with her children since she was not married at the time while Phumzile was already a Mrs Dlamini. "I have built my own home where I reside with my children since my husband died but I fought for my father's home because I want my children and grandchildren to know where I come from," Phumzile said.

"For 18 years I was renting houses all over the place since I was not welcome in my own home," added Thuli.

Justice

Since the demise of their father and step-mother, the two women are said to have been in and out of the KaNdinda Umphakatsi in search for justice to prevail.

After some time, the umphakatsi eventually ruled in favour of the uncle and his son.

The ruling that was made by the KaNdinda Council in December 1999 stated that Mehluko Manyatsi was indeed an adopted son by the late couple and he was entitled to the late Manyatsi's estate.

However, as per the law, the two women resorted to take the matter up with the Mankayane Ndabazabantu since they were not satisfied with the verdict of the umphakatsi coun-

The women did this recently, with the assistance of Umhluma Women and Children Foundation; an organisation assisting women and children who have been deprived of their inheritance by parties after the death of the heads of the family.

Umhluma Foundation joins poverty fight

COOPERATIVES have proved to be one way of creating decent jobs worldwide and Umhluma Women and Children Foundation is about to join the fight against

This was relayed by Umhluma Women and Children Foundation Director Lungelo Zulu during a press conference held on Friday.

The director said in the pipeline was the foundation's fundraising event that is aimed at generating money to assist widows to start their own savings and credit coopera-

Zulu said the fundraising event; a gospel festival, would be held at Divine Healing Ministries on October 18. In his statement, Zulu said the cooperative would be of great assistance in ensuring that the widows generate income to help sustain them and their children in the absence of their spouses

Terms

This, he added, was also at par with the objective of the foundation in that the women will not only be taken care of in terms of legal assistance to fight for their late husbands' estate, but it will also ensure that they have a lasting source of

The director mentioned that the income. idea to have a savings and credit cooperative for women was most-

ly ignited by the fact that judging from statistics of cases that the foundation has worked on, it had transpired that most of the widows never had a stable source of income as they had never been employed. He said these women had been fully dependent on their spouses, which then becomes a problem in the event that the husband died.

Affordable

With the estate battles that widows usually encounter at the hands of their in-laws, Zulu said having the cooperative that would be specifically for them, would assist in generating jobs and affordable financial assistance to some who are otherwise unable to access credit.

Further, Zulu stated that once the

foundation's cooperative was up and running, about 3 000 widows from 15 constituencies stood to ben-

This, according to the director, would not be the only income generating tactic to be undertaken by the widows as there are already existing projects that have since yielded positive results.

Support

He said these projects include carpentry where the women are making and supplying desks to certain organisations.

The director then invited businesses and individuals to support the event for a noble course. Interested parties can get tickets from Voice of the Church at a fee of E50. Other retail outlets will be unveiled in due course.

Currently, the foundation has been sponsored by Bishop Dr Nash Shongwe of Divine Healing Ministries who donated E20 000 cash towards the festival while United Holdings (Dups) has availed its assistance in the form of a special funeral policy for the widows.

The sponsorship package includes that the widows will get a E10 000 funeral cover with a monthly instalment of E45.

Widow members will be covered only after three months of joining and they will be able to access free storage for two weeks before they can be charged for utilising the mortuary. Transport of corpse on collection will also be free.

E400 fine for bag snatcher at Timele

THE Eswatini National Court President Chief Mabhedla Hlophe has condemned an act of robbery whereby a man (20) stole a handbag belonging to another woman (22).

Siphesihle Kunene of Mahwalala did unlawfully and purposefully take by force a handbag belonging to Simangele Dlamini. Kunene is reported to have further pinched a sum of E230 that was inside the handbag.

The event happened at Timele Bar Msunduza on September 2. Dlamini took offence at the assault and she went to report the matter to the police.

The accused pleaded guilty to the offence. "Your parents gave you a good name but you are failing to follow it. You unlawfully took the complant's handbag and you then discarded her bank cards and other important documents.

Condemns

"The court condemns your action in that you are spreading fear among the nation and the court must discipline you," said Hlophe.

Dlamini told the court that while at Timelele Bar at Msunduza in the Hhohho region. Kunene approached her and took her handbag and fled the scene.

"Your Honour, I went to the bar at about 7pm to buy food at the butchery. Kunene, who was also at the bar, emerged from the side and he then took my handbag and ran away with it.'



said Dlamini.

Dlamini also told the court that she was not related to the accused.

Dlamini added that the accused disappeared to a nearby forest and later Mona Flats. Security guards from Kwekwe Security were able to recover her missing handbag but some items like bank cards and money were miss-

Items

"Your Honour, inside the wallet was a sum of E230, which till today I have not recovered," said Dlamini

Dlamini told the court that when the accused was apprehended by Kwekwe Security, Kunene then apologised.

During mitigation, Kunene told the court that when he committed the offence he was in the company of another man who disappeared in the night with the sum of E230.

"Your Honour, the man I was with when we committed the offence escaped. He also took the money that was inside the handbag," the accused said.

The accused then apologised to the court for the offence. He was then sentenced to six months in custody with the option to pay a fine of E400.

- Applicants should ensure that before submission, attachments are included as guided in the requirements checklist found in the last page of the application form.

- Certified copy of Certificate of Incorporation (for a registered company)
- Certified Copy of Form J
- Certified Copy of Memorandum & Articles of Association
- Premises / Land right (Chief's Letter, Title Deed, Lease Agreement, etc)
- Business Plan (include relevant CV)
- vii. Market Contract/Letter of Intent as proof of market
- viii. Trading Licenses (where applicable)
- ix. The applications received shall not be interpreted as deserving for funding.

Only relevant requirements shall be attached by the applicants, i.e. not all the above requirements will be applicable to all applications.

Loan Appraisal Process

The appraisal process shall be as follows:

- Stage 1 YERF pre-screening to ensure; compliance, eligibility and feasibility
- Stage 2 Pitch up for qualifying applicants to present their business proposals.
- Stage 3 Qualifying applications are referred to the Intermediary for viability analysis including site visits.
- Stage 4 Viable applications are recommended to YERF by the Intermediary, where the Board of Directors shall approve projects deserving funding.
- Stage 5 Feedback is sent to applicants. Those that are not successful shall be given reasons for non-approval and they will be assisted to improve them and re-submit in the next cycle.
- vi. The process between receipts of loan applications to approval stage is expected to take about one (1) month.

- Disbursements shall be made direct to suppliers as much as possible.

- Loan terms to be provided:

Petition to minister still not addressed

THE ministry of education and training Inspectorate Department have to smoke a peacepipe.

This is because the director of Education as well as the Teaching Service Commission executive secretary are here to stay.

Principal Secretary at the Ministry of Education and Training Bertram Stewart said the two candidates hired for these positions are not going anywhere. vices Commission Executive Secretary These posts were filled by Ncamsile Mtshali as well as Dr Lenhle Dlamini. respectively. Since the inspectors wrote the petition to the minister, no feedback has been received from the ministry.

According to one of the inspectors, the only letter or form of communication was the one sent by the former Principal Secretary Dr Sibongile Mtshali on May 2, when she introduced the two candidates. It looks like the inspectors will have to accept the two candidates whether they recognised them or not.

The inspectors argued that the right recruitment channels were not followed when hiring the two candidates. In the petition, the inspectors argued that the TSC executive secretary should be someone who has worked in the field of education not administrative positions.

According to one of the inspectors who spoke to this reporter, they believed that the removal of the former PS would speed up the process as she will not be interfering with any of the operations or the dealings of the matter. This is because the former PS was accused of nepotism as she is related to Ncamsile Mtshali, the TSC Executive Secretary.

REPS urged to do more in eliminating copper theft

WITH copper theft increasingly becoming a serious crime concern, efforts to mitigate and turnaround the tide ought to be intensified.

Prime Minister Ambrose Dlamini launched the national anti-copper theft campaign in June.

This was done in collaboration with corporate entities who are most affected by copper theft which include the Eswatini Electricity Company (EEC), Eswatini Posts and Telecommunications Corporation (EPTC) and Eswatini Water Services Corporation (EWSC), to name a few. Following the launch, senators have urged the Royal Eswatini Police Service to intensify their efforts

This was outlined in the prime minister's office portfolio committee debate of the police first quarter performance report held in the Senate on Thursday.

in addressing the matter.

Senator Sylvia Mthethwa commended the launch of the national anti-copper theft and echoed the prime minister's sentiments that copper theft should be classified as a priority crime and terrorist activity, so that it is uprooted from the social landscape:

The senator said the country needed to draft an enabling legislation targeting theft of copper wire and non-ferrous materials. She added that there should also be a provision in the legislation that prohibits the sale of copper without a permit or a police clearance.

Mthethwa added that since the police had access to improved electronic technology such as Closed Circuit Television (CCTV), she wondered if it was possible for these devices to be placed in strategic areas where the theft of copper was more prevalent. In her view, this could go a long way

in assisting the REPS address the matter as it had become a national crisis.

She noted that the use of such technology could be helpful in apprehending the criminals. Senate Deputy President Senator

Ndumiso Mdliuli also praised the national anti-copper theft campaign launch.

"With the news that there is a new legislation that is coming to address this matter, we are grateful for that. We hope the bill would pass soon and it does not become a song for the next five years as it is apparent that there is a serious problem," he said.

The senator wondered if the office of the prime minister considered classifying the theft of copper wire under items considered as national disaster.

The prime minister's office was requested to submit a written response on the issues raised by the senators.

Need to speed up extradition of criminals

SENATOR Sylvia Mthethwa wants the police to use the good working relationship forged with neighbouring countries to allow for speedy arrest and extradition of criminals.

The senator commended the progress made in strengthening working relationships with other SADC countries and the cooperation between police services from within the region.

"Why is it so difficult to arrest criminals who flee to other countries while the police services within the region are working collaboratively?" enquired Mthethwa.

She further asked if there could be a way to speed up the arrest and extradition of criminals once they fled as it was a concerning and increasing trend of late

ESWATINI INCORPORATED: 2022 & BEYOND

MOVING FROM RHETORIC TO ACTION

EARLY last month the Chief Justice of the Kingdom of Eswatini Bheki Maphalala made some disturbing comments about the Judicial Service Commission (JSC) being undersiege from some powerful political clique.

He went further to allege that the conduct of the powerful political elite is treasonous and further stated that its existence threatens the political and economic stability of the country together with its international relations and peaceful coexistence.

Whilst enjoying that political stage during the swearing in ceremony of the newly appointed Judicial Service Commission (JSC) new members, the CJ went further to underscore his dissatisfaction about the work of the Royal Commission which looked into terms and conditions of politicians and other institutional bodies and commissions.

He lamented the treatment of the JSC which he leads as chairman saying it was the least paid, describing their appeal to have fallen on deaf ears.

He wondered despite making presentations to the Royal Commission why his commission was financially discriminated and disregarded, saying this was very disappointing.

A friendly advice to the CJ is that he must keep out of politics and focus his attention to the job at hand.

His immediate predecessor, now the late Michael Ramodibedi was undermined by his penchant to delve into the political space.

He completely lost the plot and started to make alliances with forces that were going to advance his course and in his own right, also dealing with some political clique or individual who was undermining the independence of the judiciary.

Clear

His foe was not a secret as it was clear that he together with former justice and constitutional affairs minister Senator Sibusiso Shongwe and then president of senate Gelane Zwane made it known that they were not happy with him.

In fact, the then president of senate told His Majesty the King that there was an individual who had appropriated to himself more powers than he should enjoy and had become a threat. The former CJ in his drive to demonstrate

how he wanted to deal with his nemesis started to project himself as the only person who cared for the King more than the collective wisdom of the rest of Emaswati.

When I listened to and read the CJ Bheki Maphalala's remarks or statements I was left frozen and taken aback to the era of the late Ramodibedi and the late Prime Minister Dr. Barnabas Sibusiso Dlamini.

I am still trying to understand where the CJ and the current Prime Minister Ambrose Mandvulo Dlamini have lost each other.

But maybe I need to go far to understand that, reading from the CJ's complaints about the



threats of being under-siege and all that jazz if he or she feels his or her interests are not met. We all have to act within the interest of the


This is not a threat to the CJ - he must just keep away from politics and focus on delivering justice.

(POCA 2018)

87. (1) Subject to this section, the hearings of the court contemplated in this Act, except for ex parte applications, shall be open to the public.

(2) If the court, in any proceedings before it, is satisfied that-

(a) it would be in the interest of justice; or

(b) there is a likelihood that harm may ensue to any person as a result of the proceedings being open, it may direct that those proceedings be held behind closed doors and that the public shall not be present at those proceedings or any part of them.

(3) An application for proceedings to be held behind closed doors may be brought by the Director of Public Prosecutions, the curator bonis or any other person referred to in Subsection (2)(b), and that application shall be heard behind closed doors.

(4) The court may at any time review its decision with regard to the question whether or not the proceedings shall be held behind closed doors.

(5) Where the court under subsection (2) on any grounds referred to in that Subsection directs that the public shall not be present at any proceedings or part of them, the court may—

 (a) direct that information relating to the proceedings or any part of them held behind closed doors, shall not be made public in any manner;

(b) direct that a person shall not, in any manner, make public any information which may reveal the identity of any witness in the proceedings;

(c) give any directions in respect of the record of proceedings which may be necessary to protect the identity of any witness, but the court may authorise the publication of so much information as it considers would be just and equitable.

(6) Any person who discloses any information in contravention of Subsection (5) commits an offence and is liable, on conviction, to a fine not exceeding eight thousand Emalangeni or to imprisonment for a period not exceeding two years or to both. Fugitives precluded from participating in proceedings

88. A person-

(a) who has been summoned or warned to appear in court on a specific date or otherwise made aware to appear in court on a specific date and failed to appear in court on that date; or

(b) in respect of whom a warrant of arrest has been issued and whose attendance in court cannot be secured in spite of all reasonable steps having been taken to execute the warrant, shall not participate in any proceedings under Part IV or VIII for as long as the person continues to fail to appear in court or that warrant of arrest remains in force and unexecuted.

Knowledge of fact

89. (1) For the purposes of this Act a person has knowledge of a fact if—

(a) the person has actual knowledge of that fact; or

(b) the court is satisfied that the person believes that there is a reasonable possibility of the existence of that fact but fails to obtain information to confirm the existence of that fact.

(2) For the purposes of this Act a person ought reasonably to have known or suspected a fact if the conclusions that the person ought to have reached are those which would have been reached by a reasonably diligent and vigilant person having both the general knowledge, skill, training and experience that may reasonably be expected of a person in that position; and the general knowledge, skill, training and experience that the person in fact has.

(3) Nothing in this Act is to be construed to limit prosecution under any other provision of the law.

Regulations

90. (1) The Minister may make regulations—
(a) with regard to the fees referred to in Section

(b) with regard to the form and manner in which any notice, summons or other legal process required to be prepared, executed or served under this Act is to be prepared, executed or served;

(c) to prescribe from time to time the maximum allowable costs for legal services provided in connection with an application for a restraint order, a preservation of property order, confiscation order or a forfeiture order or the defending of a criminal charge which may be met out of property that is subject to a restraint order;

(d) providing for any matter which is required or permitted to be or may be prescribed under any provision of this Act; and

(e) providing for any matter which the Minister may consider necessary or expedient to prescribe or to regulate in order to achieve the objects of this Act.

(2) Any regulation made under this section that may result in financial expenditure for the State shall be made in consultation with the Minister responsible for finance.

Limitation of liability

91. Any person generally or specifically authorised to perform any function in terms of this Act is not liable for anything done or omitted to be done in good faith under this Act.

Repeal of laws

92. At the commencement of this Act, -

(a) the Serious Offences (Confiscation of Proceeds)
Act, of 2001; and

(b) Sections 41 and 50 of the Prevention of Corruption Act, Act 3 of 2006. are repealed.

Transitional arrangements

93. (1) Any person designated for purposes of taking control and safekeeping of any property or assets in terms of the Serious Offences (Confiscation of Proceeds) Act, Act 8 of 2001, or the Money Laundering and Financing of Terrorism (Prevention) Act of 2011, trustee or other functionary appointed in terms of the provisions of those Acts shall, at the commencement of this Act, be deemed to have been duly designated or appointed to the corresponding position under this Act and shall continue to hold office in accordance with the applicable laws.

(2) All proceedings which immediately before the commencement of this Act were instituted in terms of the provisions of the Serious Offences (Confiscation of Proceeds) Act, Act 8 of 2001, or the Money Laundering and Financing of Terrorism (Prevention) Act of 2011 and which may have been repealed by Section 91, and which proceedings were pending before any court of law or reviewing authority shall be dealt with as if this Act had not been passed.

(3) An investigation, or prosecution or other legal proceedings, in respect of conduct which would have constituted an offence under the Serious Offences (Confiscation of Proceeds) Act, Act 8 of 2001, Section 41 of the Prevention of Corruption Act, Act 3 of 2006 and the Money Laundering and Financing of Terrorism (Prevention) Act of 2011, and which occurred after the commencement of that Act but before the commencement of this Act, may be instituted and continued as if this Act had not been passed.

State has no business administering death penalty

...Neither the death penalty, nor a state of emergency can curb the savage violence that society appears to have licensed. Only a restoration of values and an effective state can, writes Ebrahim Fakir.

THE past few days have seen renewed calls for the reintroduction of capital punishment and the imposition of a 'state of emergency' in response to the wanton brutality, criminality and impunity of the recurrently xenophobic, but more properly, generalised criminal violence and theft.

The long scourge of brutal rape of and violence against women, which culminated this past week in the rape and murder of Uyinene Mrwetyana have intensified these calls.

The death penalty and a state of emergency are considered by some of its proponents locally as an antidote to the inability of authorities to effectively police recurrent outbreaks of criminal looting and xenophobic violence and the seemingly constant savage criminality that South Africans have to live with.

Those who want the imposition of capital punishment or the declaration of a state of emergency believe that it will also serve to curb the scourges that society's public morality and civic ethics have failed to contain and miraculously restore them.

Surprisingly, calls for both feign ignorance of South Africa's horrendous apartheid past, which eroded all sense of public ethics but worse, when these were used - not as instruments of effective policing and social control, but - as instruments of political oppression and socio-economic marginalisation and exclusion.

My concern here is two-fold. Apart from being inhumane and ineffective, capital punishment is premised on a society anchored in unmediated vengeance, victimisation and retribution rather than reconciliatory rehabilitation.

Apart from the moral problematic, the administration of capital punishment and its utility as a deterrent is entirely dependent on capable and effective policing and the efficient administration of justice. States of emergencies extend the power of the repressive instruments of the state in extraordinary ways, which, to be a means for the restoration of social order, requires reasonable levels of state capacity, especially in the criminal justice cluster.

Corrupted


This can't be said of South Africa at present, which would render both these measures moot, except to entrench the well-known impunity with which an incapable, inept and corrupted security establishment behaves and further licence the impudent unaccountability of the political class in charge of them.

For good reason, capital punishment was scrapped in 1995. Instrumentally, the re-imposition of capital punishment will require a two-thirds majority in the National Assembly and the support of six of the nine provinces in the National Council of Provinces (NCOP). This implies that six of the nine provinces will need to resolve in favour of capital punishment at provincial level and instruct their delegations to the NCOP to support a resolution in favour of it. This is an unlikely prospect. But the elaborate and practical legislative process impediment ought to be less serious a consideration. The values of society and the use of these instruments as effective modes of deterring criminal barbarism and social control are.

On this score, the evidence is that in South Africa this is unlikely to be prudent, or effective.

Globally, there is no proof that capital punishment is effective as a deterrent to abhorrent violent crime. In South Africa, this is compounded by the manifest and serious weaknesses and failings in the police and justice systems. These need ings in the police and effort to reduce violent crime to be prioritised in an effort to reduce violent crime

and combat gender-based violence. If there is no guarantee that a person committing a crime will be caught and apprehended, or



that real detective capacity exists to gather intelligence, detect and thoroughly investigate, that prosecutions are properly handled, and appropriate and fair sanctions and punishment is handed down that befit, then the basic requirements for the threat of capital punishment to work as a deterrent are absent, then capital punishment will be ineffectual and make no difference.

With its imposition being irreversible, and confidence in the competence of the security and justice cluster low, coupled with a lack of trust, the fear of incorrect conviction, manipulation of justice processes to victimise, is a real one.

There are many examples, particularly in the US, of suspects being put to death only for their innocence to be proven years later on the basis of new information coming to light.

It is astounding, therefore, that there are calls for capital punishment when the basic functions of the criminal justice system upon which its effective administration and its deterrent ability depend, is widely derided as being incapable and untrust-

After all, for the death penalty to be administered, the criminals have to be caught. The SA Police Service is known for many things. Apprehending criminals is not one of them.

Licences

What the SAPS is known for, apart from its sloth ineptitude and ineffectiveness, is inappropriate and heavy-handed police brutality. Declaring a state of emergency licenses this purported impunity and sanctions the police brutality that is widely, justifiably feared. States of emergency provide the police and security services with greater powers and functions, exercised with less transparency, reduced accountability and limited supervision and oversight over them. After all, the police and security agencies become the agents of administering the state of emergency on behalf of the politicians who decide on it.

As such security agencies can be easily used, abused and manipulated by politicians. This mode of behaviour is precisely what South Africans have been bemoaning about the last two decades of institutional and process manipulation by the ANC and its deployed cadres in orienting public institutions, through abuse and manipulation, to serve private ends rather than the public interest.

How much worse would this be, when the raft of the whole security establishment is given over to craven politicians who, as will be the case in a state of emergency, suspend all normal constitutional procedures, conventions and curbs on power. That means the dilution of the separation of powers, loosening the limits on the use of authority,

no curbs on the exercise of executive power.

Can you imagine these powers in the hands of someone like Jacob Zuma, who with South Africa's magnificent constitutional architecture and regulatory and procedural infrastructure, managed with the help of the ANC and its party apparatus, to bend the state to the arc of his and his malevolent friends' corrupt will?

That President Cyril Ramaphosa may appear to be better than Zuma doesn't mean that these extraordinary powers will be wisely used, or that they should be afforded to him - and extended to the politicians that surround him.

Emergency

An ANC which has lost influence and power in four metros, would love nothing more than access to the unfettered power and authority that a state of emergency affords, so that they can continue (ab)using authority and power through means foully acquired and appropriated, rather than fairly and legitimately contested and won.

Dealing with the scourge of brutal violent crime and the social psychosis manifested in racism, xenophobia and other forms of intolerance means rooting out the sloth, ineptitude and corruption in the security and intelligence services and other public institutions. It also requires rehabilitating a society which appears to have lost its basic values and given way to its savage instincts.

In this context it makes no sense extending the powers, and burdening an incapable state or imposing measures which have no hope of success because the basic preconditions for its success are

KHULA NATSI YOUTH FUND RECEIVES OVER 140 APPLICATIONS

'Good marketing plan integrates company marketing activities'

A good marketing plan integrates a company's marketing activities into a coherent whole, protects it from sudden changes, establishes targets and acts as a focal point for management

It cannot, however, predict and prevent mistakes or provide guarantees.

This is according the Eswatini export readiness guide manual launched by Eswatini Investment Promotion Authority (EIPA) on September 2 at the Mavuso Trade Centre.

It states that if a company has a marketing manager, the plan should be prepared together with him/her and in consultation with production and finance managers (if available) to ensure that the plan fits with the company's overall business strat-

"The first essential ingredient of any plan is to determine the time span it will cover. This could be 10 years for a perspective plan, five for a strategic plan, one year for an operational plan or even one month for a control plan.

There are no hard rules for choosing a particular time span, because it depends on the degree of uncertainty, the shorter the time span should be. Even if it is difficult to prepare strategic plans up into annual operational plans and further subdivide them into control charts for a monthly review,"

The manual further advises that from the start, the marketing plan should be written and viewed as a flexible management tool, not as a static doc-

This is according to the manual by EIPA which states that the quality must be right and it must be maintained. "Even when you can turn out products of high quality, production can be inconsistent. As some goods are of high quality and some are not, buyers are never sure of what they will get. Quality may be generally good, but the product may vary from one lot to another in such aspects as colour or size," it reads.

It further states that the result is the importers are not as prepared to pay good prices for these products as they are for more consistent products from suppliers they can rely on. Worse still, they may not buy them at all, and the goods will remain unsold. An individual exporter's products of poor

ument. Objectives in the plan should be compared with actual results to measure the success of different strategies. "Your company should not hesitate to modify the plan and make it more specific as new information and experiences are gained."

In terms of product identification and selection, the manual states that one of the key requirements for engaging in the export business is to have the right products to export.

What are the product benefits or what do consumers perceive as the product meeting their needs? product development is a process which requires generation of ideas, screening, business analysis,

INCONSISTENT quality is often an obstacle or unreliable quality can damage the entire country's reputation as a supplier. Even if the product is of high quality, the company might suffer from this national reputation.

However, one way of enhancing the company's product quality is to get product certification through the quality assurance department of the Eswatini Standards Authority (SWASA). This helps assure consumers that the products meets a certain standard of quality. SWASA will offer compulsory or voluntary or a combination of both quality check certification. Compulsory quality check schemes are important if your product is expected to meet certain legal quality standards. Quality improvement can also be done through programmes that include worker training and the provision of information on inspecting and testing procedures, and on quality standards.

development (eg Production, design and packaging), market testing and launching. Even for direct products like vegetables which may not require additional processing you may have to sort out issues such as varieties, taste, size, blemishes, etc.

Elements

It further states that there are elements associated with a product such as specifications, styles, branding and packaging one's needs to think about. Product utility value can range from nutritional value, tastes, aesthetics and colour use and so on. The product must be of sufficient quality to be acceptable on the international market.

TRUMP CANCELLED PEACE TALKS WITH TALIBAN OVER ATTACK

WASHINGTON - US President Donald Trump on Saturday said he canceled peace talks with Afghanistan's Taliban leaders after the insurgent group claimed responsibility last week for an attack in Kabul that killed an American soldier and 11 other people.

Trump said he had planned a secret meeting with the Taliban's "major leaders" yesterday at a presidential compound in Camp David, Maryland. Trump said he also planned to meet with Afghanistan's president.

But Trump said he immediately called the talks off when the insurgents said they were behind the attack.

'If they cannot agree to a ceasefire during these very important peace talks, and would even kill 12 innocent people, then they probably don't have the power to negotiate a meaningful agreement anyway," Trump said on Twitter.

The surprise announcement left in doubt the future of the draft accord worked out last week by

Zalmay Khalilzad, the special US envoy for peace in Afghanistan, for a drawdown of thousands of US troops over the coming months.

There was no immediate reaction from the Taliban but the decision appeared to catch them by surprise.

Just hours before Trump's tweet, a senior Taliban leader privy to talks in Doha with US officials including Khalilzad and Taliban Chief Negotiator Mullah Abdul Ghani Baradar, said an agreement to sign the deal appeared close.

Assaults

Taliban fighters, who now control more territory than at any time since 2001, launched fresh assaults on the northern cities of Kunduz and Pul-e Khumri over the past week and carried out two major

suicide bombings in the capital Kabul. One of the blasts, a suicide attack in Kabul on Thursday, took the life of US Army Sergeant 1st Class Elis A. Barreto Ortiz, 34, from Puerto Rico, bringing the number of American troops killed in Afghanistan this year to 16.

A spike in attacks by Taliban insurgents in Afghanistan has been "particularly unhelpful" to peace efforts there, a senior US military commander said on Saturday as he visited neighbouring Pakistan, where many Taliban militants are based.

US Marine General Kenneth McKenzie, who oversees American troops in the region, declined to comment on the diplomatic negotiations themselves but criticised a wave of Taliban violence that has cast a long shadow over the deal.

"It is particularly unhelpful at this moment in Afghanistan's history for the Taliban to ramp up violence," McKenzie, head of US Central Command, told reporters traveling with him. *Reuters*

UK Work, Pensions Secretary quits govt

LONDON - Britain's Work and Pensions Secretary Amber Rudd resigned from the government and the ruling Conservative Party on Saturday in a protest over Prime Minister Boris Johnson's handling of the country's departure from the European Union.

Johnson says he wants to take Britain out of the EU on Oct. 31 with or without a deal with the bloc. But he lost his parliamentary majority this week and expelled 21 lawmakers from his Conservative Party's group in Parliament after they supported an opposition plan to try to block a no-deal exit.

Rudd, also a former interior minister who voted to remain in the 2016 Brexit referendum, said the ousting of the rebel lawmakers, who included the grandson of Britain's wartime leader Winston Churchill and two former finance ministers, was an "assault on decency and democracy." "I have resigned from Cabinet and surrendered the Conservative whip," Rudd said on her Twitter account.

"I cannot stand by as good, loyal moderate Conservatives are expelled. I have spoken to the PM and my association chairman to explain," she said. Brexit remains up in the air more than three years after Britons voted to leave the EU.

HURRICANE DORIAN DEATH TOLL CLIMBS TO 43

NASSAU - The death toll from Hurricane Dorian's devastating rampage across the Bahamas rose to 43 and was likely to climb "significantly," officials said, with hundreds missing even as rescuers plucked desperate survivors from the debris.

More than 260 residents of the brutally damaged Abaco Islands arrived in the capital city of Nassau after spending more than seven hours on a government-chartered ferry, a second of which was expected to arrive overnight.

Those who made it to safety awaited news of loved ones such as Diane Forbes, who had not heard from her two sons since Tuesday and was searching for them among some 200 evacuees sheltering at a gymnasium Friday night in Nassau, which was spared the wrath of the hurricane.

Hungry

"They said they were hungry and the scent of the bodies, the dead, was really getting to them... I don't know if my son is alive or not," she said of one of her children, who had been in Marsh Harbour on Abaco with his girlfriend and her mother.

Confirming the new toll of 43, Prime Minister Hubert Minnis said 35 were killed on worst-hit Abaco and eight on Grand Bahama island. *AFP*

Hong Kong protesters call on Trump to 'liberate' city

HONG KONG - Thousands of Hong Kong protesters on Sunday chanted the US national anthem and called on US President Donald Trump to "liberate" the Chinese-ruled city, the latest in a series of demonstrations that have gripped the territory for months.

Police stood by as protesters, under a sea of umbrellas against the sub-tropical sun, waved the Stars and Stripes and placards appealing for democracy after another night of violence in the 14th week of unrest. "Fight for freedom, stand with Hong Kong," they shouted. "Resist Beijing, liberate Hong Kong."

US Defense Secretary Mark Esper on Saturday urged China to exercise restraint in Hong Kong, a former British colony which returned to Chinese rule in 1997.



Esper made his call in Paris as police in Hong Kong prevented protesters from blocking access to the airport but fired tear gas for a second night running in the densely populated district of Mong Kok. "With the US locked in a trade

war with China at this point in time, it's a good opportunity for us to show (the United States) how the pro-China groups are also violating human rights in Hong Kong and allowing police brutality," said Cherry. *Reuters*

Govt eyes cashless cards for welfare recipients

MELBOURNE - Australia's Prime Minister Scott Morrison is eyeing plans for a cashless debit card for welfare recipients and defended a proposal to drug test some job seekers, setting the government on a collision course with opposition lawmakers and welfare groups when Parliament returns.

In an interview with Nine newspapers published Yesterday, Prime Minister Scott Morrison flagged welfare reform would be a priority for his government and discussed the cashless welfare card - aimed at preventing welfare payments being spent on alcohol, drugs and gambling.

He also defended plans to trial drug testing for new job seekers. *Reuters*

Empress undergoes breast cancer surgery

TOKYO - Japan's Empress Emerita Michiko underwent surgery for early-stage breast cancer at a Tokyo hospital yesterday, national broadcaster NHK said. The four-hour procedure to remove cancerous tissue from the 84-year-old's left breast was completed successfully at the University of Tokyo Hospital, NHK said. NHK said the country's Imperial Household Agency would make an official announcement. According to the broadcaster, by around 0530 GMT, Michiko had returned to her private room at the hospital following her surgery, which was performed under general anesthesia. *Reuters*

Russia, Ukraine swap prisoners

MOSCOW - Russia and Ukraine made a longawaited swap of 70 prisoners on Saturday, a deal hailed as a first step towards ending five years of tensions and conflict. Two planes carrying 35 prisoners from each side landed simultaneously in Moscow and Kiev, where the passengers emerged under sunny skies. "We have taken the first step," Ukrainian President Volodymyr Zelensky said on the tarmac after greeting and hugging former detainees. "We have to take all the steps to finish this horrible war." In emotional scenes at Kiev's Boryspil airport, family members embraced and handed flowers to the former prisoners, many weeping with joy. AFP

Pakistan denies use of airspace to Indian Pres.

NEW DELHI - Pakistan on Saturday said it had denied India's President Ram Nath Kovind permission to fly through its airspace — access to which is usually granted — due to New Delhi's recent "behaviour". The decision comes at a time of high tension between the two nuclear-armed South Asian neighbours over the disputed Himalayan region of Kashmir. "The decision has been taken in view of India's behaviour," Pakistani Foreign Minister Shah Mehmood Qureshi said in a statement. "The Indian President had sought permission to use Pakistan's airspace to travel to Iceland, but we decided not to permit him," Qureshi added, without giving further details. AFP

Zulu king promises to tackle recent xenophobic violence

KWAZULU NATAL - Zulu monarch King Goodwill Zwelithini has vowed to bring Johannesburg to a standstill and douse the flames following violent clashes in the city.

Addressing thousands of maidens during the annual Reed Dance hosted at his eNyokeni palace in KwaNongoma, northern KwaZulu-Natal, on Saturday, the king said he had received numerous calls asking him to comment on the violent spats between South Africans and foreign nationals in recent weeks. "Regarding the chaos in Johannesburg, I got a lot of calls and requests for me to comment or put the fires out. What amazed me was that some of those calls were from the very same people who swore at me a couple of years ago and said I was the one who caused violence, which is something they no longer speak about today," he said. Zwelithini was referring to the backlash he received after commenting in March 2015 that foreigners were in SA to steal jobs and were a social ill. Shortly afterwards, xenophobic attacks hit areas south of Durban, leaving seven dead.

Comments

The SA Human Rights Commission in September 2016 found there was no causal link between Zwelithini's comments and the violence, and that they did not amount to hate speech - however, they were hurtful and harmful. At the Reed Dance on Saturday, Zwelithini said: "When I get to Johannesburg it will be at a standstill and be quiet, and no one will ask what's happening. Can the violent people please give us a break because we know violence and what it has done to the nation? "I don't do things because I want to be liked or seen by the media. I have a programme that will bring peace and unity. It starts with the Zulu nation then it spills out into other nations," he said. The monarch added that he was glad to hear that the ministerial imbizo to deal with incidents of violence that would have been hosted by Police Minister Bheki Cele this weekend had been postponed. Zwelithini said he was not consulted on the imbizo, which the ministry said was postponed because it clashed with the Reed Dance, which many of the people who needed to be involved in the imbizo namely izinduna who represent hostel dwellers - would have been attending. RAMAPHOSA EYES GOOD BEHAVIOUR IN NORTH WES

PRETORIA - President Cyril Ramaphosa has given the ANC interim leadership in North West the thumbs-up for the work done so far, but more decisive action could be taken in dealing with the continuing acts of ill-discipline among party leaders and members in the province.

Ramaphosa led the ANC national executive committee members during a meeting held last weekend in North West, which came on the back of provincial-wide briefings between the ANC top brass and ordinary members across the province's four regions, some of which were marred by minor incidents of disruption.

"His take is more that because of where the province comes from,

"We would like to provide opportunities for other young women like Uyinene, who dream of a career that was embedded within the discipline of the humanities. Each time that the scholarship is awarded, it will be a conscious reminder of the tragic circumstances under which Uyinene's life was taken.'

The Mrwetyana family has thanked all South Africans for their outpouring support during this difficult time. EWN

King Zwelithini slams 'Zuluphobia'

DURBAN - King Goodwill Zwelithini is going to court to fight attempts to repeal the Ingonyama Trust Act because he said people with "Zuluphobic" tendencies wanted to take away his land.

He addressed thousands of maidens, traditional leaders and government officials during the annual Reed Dance ceremony at his Enyokeni Palace at Nongoma, Zululand, on Saturday. King Zwelithini accused President Cyril Ramaphosa of being disingenuous in handling the controversial issue of Ingonyama Trust Land. He said the hatred for the Zulu nation was highlighted by former presdent Kgalema Motlanthe's High Level Panel which in 2017 recommended that the Act be repealed. He said he had finalised court papers with the aim of protecting KwaZulu-Natal's rural land

which was under the Ingonyama Trust Board's control. King Zwelithini said the presidential expert advisory panel on land, which Ramaphosa had appointed, also continued to insult him.

Provoked

"From now we are no longer going to be provoked and keep quiet, but we are going to defend ourselves. I can assure you that court papers are ready because we want the court to explain to us if what is being done to us is correct. There is no court we are not going to go to in this country to defend our land. There is no court we are not going to go to outside the borders," he said.

King Zwelithini said after he heard that Ramaphosa had appointed his panel to prepare for the implementation of Motlanthe's recommendations, he wrote to him. Political Bureau

Why aren't leaders keeping their people at home - Mashaba

JOHANNESBURG - In a long column in City Press on Sunday, Johannesburg Mayor Herman Mashaba opined that he would not "remain silent" on confronting "uncomfortable topics", particularly questions about government's failure to safeguard South Africa's borders and prevent illegal migration.

He said he had seen five home affairs ministers come and go in a space of just three years, and not one of them had been able to come up with a satisfactory plan on immigration, let alone to implement one, in his view. He also alleged that high levels of corruption at home affairs were undermining any efforts to contain the influx of undocumented migrants into, particularly, Johannesburg, where people were





ed attacks on citizens from outside our country - sadly called foreign nationals - for no one is foreign, all are all God's people and all are Africans, I am appalled and ashamed by the violence meted out against them, especially against truck drivers, and at the prejudice voiced against these vulnerable people who come from beyond our borders.

"We are dismayed by the inept statements that fuel mindsets of rejection in the public discourse, and which disregard the trauma of displacement that these, God's people, have to endure," he said.



LATE MUGABE TO BE BURIED NEXT SUNDAY

HARARE - Former Zimbabwe president Robert Mugabe is expected to be buried next Sunday, state media reported.

Mugabe, an ex-guerrilla leader who became the southern African country's first leader following independence from white minority rule in 1980 and held on to power until he was forced to resign in 2017, died in Singapore on Friday.

His body will arrive in Zimbabwe on Wednesday, the Sunday Mail quoted presidential spokesman George Charamba

Mugabe enjoyed strong backing from Zimbabwe's people after taking over in 1980 but that support waned following decades of repression, economic mismanagement and allegations of election-rigging.

He is still regarded by many as a national hero, though, with some even beginning to say they missed him after his successor, Emmerson Mnangagwa, a former ally turned foe, failed to revive the economy and used the army to crush

According to Charamba, Mnangagwa

and family members will receive the body at the airport named after the former president in the capital, Harare. The body will be taken to his rural home, about 85 kilometres (53 miles) southwest of Harare before being placed in a giant stadium for public viewing.

Mnangagwa, who described Mugabe as a "a great teacher and mentor", declared him a national hero, the highest posthumous award in the country and said offi-

cial mourning will only end after the burial at the National Heroes Acre, a hilltop shrine reserved exclusively for Zimbabweans who made huge sacrifices during the war against white-minor-

In death, Mugabe received praise from his former political and military allies. who propped up his rule for close to four decades before forcing him out in 2017. AP

Pope pleads with Madagascans to protect rainforest

ANTANANARIVO - Pope Francis on Saturday made an impassioned plea to Madagascans to protect the Indian Ocean's unique environment from "excessive deforestation", on the second leg of his African tour.

Weeks after a spike of fires in the Amazon, the Argentine pontiff told his hosts they should "create jobs and money-making activities which respect the environment and help people escape poverty".

Madagascar - famed for its immense diversity of flora and fauna

- is home to 25 million people, the vast majority of whom live in poverty on an income of less than two dollars a day.

More than half of its young people are out of work, even if many boast good qualifications.

Benefit

The pope said there "were many causes driving excessive deforestation which benefits just a few people... and compromises the future of the country."

The authorities should also ensure social justice, he added. AFP

Bomb explosion at South Africa embassy, fake news - Nigeria govt

ABUJA - The Nigerian government on Saturday dispelled reports that there had been an explosion at the Abuja premises of the South African High Commission.

Information Minister Lai Mohammed through an aide said in a statement that the reports that had been making the rounds were untrue and that no such incident had taken place.

The statement said the "explosion" was fake news orchestrated by the desperate opposition to cause panic and chaos among the populace.

The minister said: "the video of the purported bomb explosion which is being circulated on the social media, is that of the bomb explosion at Emab plaza, near Banex, in Abuja on June 25, 2014."

The police also called the report a "classical" fake news. "Meanwhile, the Nigeria Police Force has provided adequate security in and around all South African Missions and related business interests," their statement read in part.

Attacks

South African businesses were targeted earlier this week in reprisal attacks by some Nigerians after a surge in xenophobic violence saw other Africans attacked in Johannesburg and other areas.

The South African embassy closed its doors in the wake of the security threats that officials were receiving. Some businesses like MTN and Shoprite closed their shops for fear of attacks. Africa News

JUBA - South Sudan government has ordered all flags flown at half-staff for three days as a sign of respect for the recent passing on of former Zimbabwean President Robert Gabriel Mugabe, who died Friday in Singapore at the age of 95. The announcement was made by Information Minister Michael Makuei Lueth following a Cabinet meeting in the capital Juba on Friday. "The President has directed that the flags in South Sudan should fly at half-mast for the next three days in honour of this great African leader," Makuei said. 



He has his own opinions - Foden

MANCHESTER - Phil Foden has promised to let his football do the talking as he responded to Pep Guardiola's criticism that he needs more assertiveness.

Foden has been seen as one of the bright young prospects at Manchester City and with England, but has struggled for game-time with the Premier League champions

Pep Guardiola recently declared Foden "a shy guy" and believes he should start showing more assertiveness like the more senior members of the City side.

However, Foden is not ready to change, and believes his football in training will prove he is ready for increased game time.

"He has his own opinions and I stick by how I am," Foden told

"I just know that I'm ready to play. I feel like I am. I try to show him every day in training.

"There is a bit of team-mates telling me to be patient but obviously I'm hungry and want to play now. I'm going to fight for it every day. I'm ready to play whenever."

Foden is currently with the England Under-21s, and started as his side fought back to defeat Turkey to open up their play in Euro U-21 qualifying.

The Man City youngster received high marks for his performance, and admitted he was hopeful his club manager was able to tune in to see.

"It will be nice if Pep watched the Turkey game but maybe he's taken a little holiday to play golf or something! I wouldn't blame him," Foden said.

"It's massively important to start with a win. It gives your team a boost; when you don't get off to a good start

sometimes it can affect you. "It's going to take a couple of games. We can already see the potential that the group has and we are only going in the right direction."

The England U-21 side are next in action today against Kosovo and Foden will return to Manchester City at the weekend fo face Norwich in Premier League action.

Goal

Salah can match Messi if he becomes less selfish - Wenger

LONDON - Liverpool star Mohamed Salah boasts similarities to Lionel Messi and can become even better if he tones down his obsession with goals, according to Arsene Wenger.

The ex-Arsenal coach, who recently hinted at a possible return to management in the international arena, believes the Reds attacker's game is comparable to Messi's but is still missing a few crucial ingredients.

Aside from a few more goals, Wenger also stressed Salah has to learn when to go for goal himself and when to pass it to a teammate. "He's 20 goals away basically, if you want to be as concrete as possible," Wenger told beIN Sports.

"But he is similar to Messi. He must still find the consistency of Messi. I find him a just as good finisher but Messi is the complete thing - he gives the final ball as well and Salah is a bit obsessed now by finishing himself so that's a dimension he'll get certainly when he gets a little bit older. To find the moment when you have to give the ball and when you have to finish.

"I like him very much, he has huge potential."

In Liverpool's recent 3-0 win over Burnley, Salah was criticised after fail-



ing to pass to Sadio Mane in the second half when his fellow attacker was in a far better position.

While Salah is the star of the Reds frontline, Mane and Roberto Firmino have also been consistent performers for Jurgen Klopp's side with Wenger praising the Brazilian striker in particular for his selfless style of play.

"You forget the guy that sacrifices himself a little bit is Firmino," he said.

"Like Luis Suarez did for Messi and Neymar. A guy that works for the team, that works for everybody and gets them to shine.

"This piece of the jigsaw is very hard to find - a striker that is generous."

Since stepping aside from Arsenal in 2018, Wenger has avoided jumping straight back into management but admits he remains obsessed with the beautiful

"I needed longer than I thought to take a distance from what I did before. To really let it settle," Wenger said.

"I took a distance and realised I was living like somebody in a coma for 35 years and who woke up and saw something different in life other than just my club, my game and my work.

"I watch it still when I wake up in the morning - straight in my mind is football. My main interest is still there."



Liverpool paid £75 million to get their man, after seeing efforts fail during the summer prior when the club had to issue an apology to Van Dijk's former employers Southampton for their conduct. The fee made Van Dijk the world's most expensive defender at the time, eclipsing the then record £45 million purchase of Kyle Walker by Manchester City.

His time on Merseyside has already seen Van Dijk crowned PFA Player of the Year, while he is also tipped to edge living legends Lionel Messi and Cristiano Ronaldo to be crowned 2019 Ballon d'Or winner later in the year.



Andreescu opples Serena **US Open final** NEW YORK - Teenager Bianca double faults.

Andreescu became Canada's first Grand Slam singles champion Saturday with a rollercoaster 6-3, 7-5 win over 23-time major champion Serena Williams in the US Open final.

The 19-year-old Andreescu became the youngest Grand Slam winner since Maria Sharapova at the 2006 US Open, handing Williams a fourth consecutive defeat in the final of a major to again deny her a record-equaling 24th Slam title. Williams, 37, suffered a second finals loss in a row at Flushing Meadows, after a 2018 defeat against Naomi Osaka best remembered for a furious tirade against chair umpire Carlos Ramos.

Appearing in a 33rd Grand Slam final, and fourth since the last of her 23 major titles, Williams made an inauspicious start at Arthur Ashe Stadium by conceding her opening ser-

vice game with successive

Andreescu, who wasn't even born when Williams won her maiden Slam at the 1999 US Open, responded with a comfortable hold, a pattern that repeated itself until the Canadian threatened to run away with the opening set.

Serving at 2-4, Williams erased five break points with a combination of aces and booming groundstrokes but Andreescu was knocking on the door once more as the American served to stay in the set.

A forehand winner earned the youngster a set point, and Williams duly gifted her the opener with another double fault.

Andreescu had failed to even reach the main draw the past two years, twice falling in the first qualifying round, and her confidence continued to flow as she surged 2-0 ahead in the second -- Williams again doubled-faulting on break

The American carved out four opportunities to hit back the following game, benefiting from a huge stroke of luck when a forehand brushed the tape and trickled over to haul herself back on serve.

Poor effort 'inexcusable' - Serena

NEW YORK - Serena Williams is wondering when she will start playing like a 23-time Grand Slam champion again in a major final, calling her poor showing in Saturday's US Open final loss "inexcusable."

Williams fell to 19-year-old Canadian Bianca Andreescu 6-3, 7-5 at Arthur Ashe Stadium on the same court where she won her first Grand Slam title 20 years ago, nine months before Andreescu was born.

"I love Bianca. I think she's a great girl. But I think this was the worst match I've played all tournament. It's hard to know that you could do better," Williams said.

"Bianca obviously played well. I think her returns make me play better and put pressure on my serve.

"At the same time it's inexcusable for me to play at that level."

Williams had 33 winners but just as many unforced errors. She hit nine aces but misfired eight double faults and hit only 44 per cent of her first serves. She dropped 30 of 43 points on her second serve.

"I believe I could have played better. I believe I could have done more. I believe I could have just been more Serena today," Williams said. "I honestly don't think Serena showed up. I have to kind of figure out how to get her to show up in Grand Slam finals." Williams, who remains one Slam title shy of matching Margaret Court's all-time record, has lost the past two Wimbledon and US Open finals since returning after having a baby two years ago. AFP

STERLING TIPPED TO WIN BALLON D'OR

LONDON - Raheem Sterling is one of the top five players in the world, better than Neymar, and should be targeting winning the Ballon d'Or in his career - according to former Chelsea and Marseille forward Tony Cascarino.

The Manchester City winger put in another incisive performance for England on Saturday night, with a goal and an assist in the 4-0 Euro 2020 qualifying victory over Bulgaria.

Neymar made a goalscoring return for Brazil earlier in the week, netting in the 2-2 draw with Colombia after three months out with an ankle injury. But for Cascarino, Sterling has surpassed him in recent seasons.

Who would you rather have: Neymar or Sterling? I'd have Sterling as a player," he told talkSPORT. "Try to ignore the antics that have gone on with Neymar off the field, I actually think Sterling's better on the field.

"His numbers are better and he's playing in a better team. I've seen



Neymar do things that no other footballer can do in the game, like a 'Harlem Globetrotter' footballer.

"But if you want a player to be brilliant for the team and score goals at the rate Neymar can, Sterling's your man." Sterling registered more goals and more assists than Neymar from a similar position on the left wing last season, and lifted more trophies

as City waltzed to a historic domestic treble. He did, however, also play nearly twice as many games as the Brazilian, whose season was curtailed by injury problems.

Three years Neymar's junior at 24, Sterling's improvement in recent seasons has been remarkable, with many crediting City boss Pep Guardiola for his evolution as a player. His manager

has been keen to ensure the praise goes to Sterling, who he says could hit the 30-goal mark for the first time this season.

"I would definitely argue he's in the top five players in the world," added Cascarino.

"What excites me about Sterling is the improvement. The improvement has been dramatic.

Kosovo emerge as unlikely obstacle

LONDON - England are breezing through a Euro 2020 qualifying group featuring the fading soccer forces of Bulgaria and the Czech Republic but Kosovo, one of the newest members of the world soccer family, may be about to make their life tougher.

The small Balkan nation of 1.8 million inhabitants may be ranked 120th in the FIFA rankings but not even the powerhouses of world soccer can match their form over the past two

On Saturday, they came from a goal down to beat the Czechs 2-1 in front of a joyous crowd at the Fadil Vokrri stadium in Kosovo's capital Pristina and will head to Southampton tomorrow just one point behind Gareth Southgate's

Incredibly for a nation only awarded FIFA. status little over three years ago, along with Gibraltar, they are undefeated in 15 matches and have become the surprise challengers to England's Group A domination.

Kosovo's last defeat came against Iceland in October 2017 at the end of a chastening World Cup qualifiction programme in which they managed only one point from 10 matches but since then they have won 10 and drawn five of their matches.

Swiss coach Bernard Challandes's side began their Euro 2020 qualifying campaign with draws against Bulgaria and Montenegro but then scored a last-gasp winner to beat Bulgaria 3-2 away in June and their defeat of the Czechs lifted them to eight points.

Struggle

A nation that only declared independence in 2008 after decades of political struggle and a year-long war with Serbia from 1998-99, has taken huge pride in its soccer team and the dream of a place in its first finals is realistic.

Even if they fail to qualify directly, they have another backup option in the play-offs, thanks to an impressive Nations League performance.

While their first steps into international football were difficult with nine successive defeats, Albert Bunjaki, Challandes's predecessor, worked tirelessly trawling Europe's Kosovan diaspora in search of eligible players.

Many had played for other nations after moving away as children to escape a conflict which eventually led to NATO's bombing of the former Yugoslavia.

Challandes has reaped the benefit. Standard Liege defender Mergim Vojvoda, scorer of Kosovo's winner on Saturday, played for Albania Under-21s, while Swansea City's attacking midfielder Bersant Celina grew up in Norway.

Celina represented the Nordic nation until Under-21 level before switching when the door opened for Kosovo in 2016. Goal

Charles pips Valtteri Bottas to win Italian Grand Prix

MONZA - Charles Leclerc was harried and hustled all the way around Monza by Lewis Hamilton - but the rising star ultimately held on and ended up the triumphant hero of Ferrari and by extension of all Italy.

What a moment of jubilation it was for the ice-veined Monegasque, a 21-year-old in his first Italian Grand Prix wearing the most famous overalls in motor racing.

It was not easy, as we were saying, because he had the greatest driver in the world breathing right down his neck for most of this



sprint around the Temple of Speed. That meant he spent the majority of the 53 laps with no let up, just

an examination of his nerve. He won for the second time in eight days, following his maiden F1 glory in Belgium last Sunday.

It is not entirely right to say Leclerc was faultless. He ran straight on after locking up at the first corner on lap 36 but he wiggled back out in the lead. Hamilton was less than impressed, saying: "There's some dangerous driving going on."

The stewards decided - rightly in my view - that Leclerc gained no advantage and therefore let him race on unhampered by punishment.

As if to show that Leclerc's mistake was an understandable lapse, Hamilton also locked up six laps

later. He lost second place to Valtteri Bottas, his Mercedes team-mate, as he went round the bollards and back on to the track. It finished that way: Lelcerc first, Bottas second, Hamilton third.

Hamilton, however, holds a huge 63-point lead over Bottas in the race for the title with seven rounds remaining.

Leclerc, who started on pole, held off a sustained Hamilton thrust in the middle third of the grand prix. The best of a long duel of machismo-soaked racing saw them side by side in the second chicane towards the middle of the action.




