EMBATTLED Matsapha Mayor Sandlane Zwane hated corruption, hence other councillors were against him.

These sentiments were submitted by Councillors Mavela Shongwe and Bongani Mkhatshwa yesterday before the Commission of Enquiry to probe into the Matsapha Town Council affairs.

Shongwe, during his submission, strongly refuted corruption and abuse of unopposed motions allegations that were thrown towards Zwane by the other councillors for two days of submissions.

He said Zwane hated corruption and he (Shongwe) would not have fallen under his side if he was corrupt as is alluded by the other councillors.

Shongwe also introduced himself to the commission that he was a member of the Matsapha Town Council Finance Committee.

"I am a puppet of truth, not a package of someone as it is alluded. I strongly stand for the truth. If there was evidence that Zwane was somehow involved in corruption, I would not be on his side," Shongwe said.

He said chaos within the council ensued after an audit tender was granted to the PWC over KPMG, who happened to score a 100 per cent when graded and compared to the other audit firms.

He said the policy within the ministry of housing and urban development stated clearly that an audit firm should not audit for a period that is over three years hence PWC won the audit tender.

# 'SANDLANE VICTUMISED FOR HATING CORRUPTION'

Shongwe said with the ratepayers complainming about unaccounted for funds, which they too as councillors could not account for while under KPMG, they came to the decision to grant PWC the audit contract.

He was further questioned by Commissioner Benito Jones if indeed council meetings were turned into those of Bongani Mkhatshwa and Zwane's meetings, as other councilors simply became bench fillers. Shongwe said the councillors were obligated to raise their hands whenever they had questions, not that the chairperson only gave his faction the opportunity to speak during meetings.

Was it proper for Zwane to move a motion and Shongwe and Mkhatshwa seconding that motion, that is the question that was posed by Jones based on August 2 last year minutes. Shongwe said Zwane moved that motion because he saw that Matsapha would bene-

fit from that tender granting not that he was acting corrupt.

He clarified that Zwane never abused power of the unopposed motion, but acted within his authority as the chairperson of Matsapha. He appeared tongue-tied when asked why he acted swiftly and investigated other councillors he felt were corrupt, yet turned a blind eye on Zwane's doings. Chairperson of the Commission Lungile Magagula raised that there were issues of fraud against Zwane that

# Mkhulu sells land twice, strikes it rich



AN elderly man of Mvutjini is at the centre of a land sale controversy, in which he is alleged to have conned two buyers of the same land E70 000.

Enock Motsa, 63, appeared yesterday before Senior Magistrate Nonhlanhla Dlamini.

Theodette Semanana, a tenant at Mona Flats, a teacher by profession, parted with E36 500 and allegedly gave it to Motsa for a piece of land. She told the court that on August 4, 2018, her employee by the name of Maxwell Dlamini, told her of an advert referring to the sale of land issued in the name of one Sindisiwe.

She alleged that the young man told her of the advert because she was interested in building a home of her own instead of losing money every month



to landlords. She contacted Sindisiwe and made arrangements to see the land, which happened instantly. She told the court that she, her employee and Sindisiwe went to see the land. "I loved the land and requested that she makes arrangements for me to see the land owner," she said. The owner intro-

duced himself as Mandla Enock Motsa.

Motsa told her that a lot of people were interested in the land, but if she really wanted to secure it, she should pay immediately and it was agreed that cash would exchange hands inside Sindisiwe's house.

During their meeting, the accused told the victim that she had to pay E30 000 upfront. On the day of the payment Motsa is said to have arrived with a female companion he introduced as his girlfriend. He was handed over the money and Motsa then took out E1 000 and gave it to Sindisiwe as a token of appreciation for advertising the land for him, and the rest was given to his girlfriend, who put it in a handbag. Motsa then asked for a lift from the buyer, who dropped him off in Matsapha.

End of August, Motsa called her and told her she had to pay E5 500 for a cow to be presented to the chief, as per the Khonta land acquisition process on Swazi Nation Land.

Theodette was ordered to take the money to a Dvuba homestead, that was identified to her as the Indvuna's homestead at Mnyamatsini. She presented the money before the alleged Indvuna, who was allegedly in the presence of his wife and she was told that the money would be taken to the chief at Mpolonjeni.

She left the Dvuba premises with the accused and her employee and a short distance from the homestead, the accused is said to have told them that he was returning to the homestead because he wanted to drink *emahewu*, they left.

Again in September he called her, requesting that she pays E1 000 to be introduced to the community and she did so through mobile money.

The money was transferred to Motsa's number. tion time. From then, his phone was off and she kept on calling and if she would be lucky he would tell her he was busy, until his number was unreachable.

She then decided to report to the Dvuba homestead that she was having difficulty getting in touch with Motsa. Amidst that, there was a funeral in which the Indvuna's wife told the complainant that her husband would confront Motsa at the funeral. Another blackout ensued until she paid another visit to the Dvubas, but again she was told told that a daughter who had been a student at UNESWA had committed suicide.

She further told the court that she made attempts to find the chief, to find out if the money had been delivered to him and the attempts were futile. After all the frustrations, she reported the matter to the Lobamba police station. A few months later, she was called to the police station and was imported that the accused had been captured.

# PUBLIC SERVANTS WANT 14.4 PER CENT COLA IN BUDGET

PUBLIC sector associations (PSAs) are calling for a 14.4 per cent CoLA provision in the national budget to be tabled in a fortnight.

The PSAs claim that government owes them 14.4 per cent in respect of the cost of living adjustment (CoLA) which was accumulated in the past two financial years. This was said by Swaziland National Association of Teachers (SNAT) Secretary General Sikelela Dlamini.

Dlamini said this when making known their expectations regarding the budget that is expected to be delivered by Finance Minister Neal Rijkenberg in the next two weeks. Dlamini said the issue of CoLA must be catered for in the budget.

He said the civil servants' salaries had not been adjusted for a very long time now. He insisted that that had eroded the buying power of the workers, amid the inflation rate that was ever increasing. The secretary general said government owed them 14.4 per cent of the salaries earned by the civil servants.

He further said the percentage

owed by government in respect of CoLA was expected to increase in the 2019/2020 financial year because that would mean another year for the government.

"We are looking at the Central Bank of Eswatini (CBE) to inform us on the inflation rate in April when the next financial year starts and we will be informed of the exact percentage owed to us by the govemment in the three years," Dlamini

Dlamini further said the workers wanted nothing less than the 14.4 per cent owed to them by the government.

He stated that the minister of finance should include at least the 14.4 per cent when he delivered the budget in Parliament.

National Public Service and Allied Workers Union (NAPSAWU) President Aubrey Sibiya echoed Dlamini's words. He said it was imperative for the government to allocate a certain amount for the civil servants' salaries to be increased in the form of the owed CoLA. He said the civil servants had been patient for far too long now and they had to be given what was due to them because life was difficult for the workers.

The CoLA impasse between government and the civil servants started last year in July when government offered to give them zero per cent increment. The government stated that it did not have the money to implement the CoLA, hence it offered the zero per cent.

The civil servants did not accept this as a series of strikes and marches followed thereafter. In September last year, the Industrial Court stopped the PSAs who wanted to take to the streets to try and force government to give them the CoLA. Government had gone to obtain a court order to stop the workers from striking because there was no Legislature or Executive at the time.

The Industrial Court stopped the PSAs though recognising that the strike was lawful. The PSAs shifted the strike to January 28. Again, the Industrial Court stopped the strike because the matter was still before it.

## Allocate 26% budget to education - SNAT

**GOVERNMENT** should allocate at least 26 per cent of the national budget to the education sector.

This was a view expressed by the Swaziland National Association of Teachers (SNAT) as it was expressing what it expected the budget to cover. SNAT Secretary General Sikelela Dlamini said this was important because education was a very large sector in the country.

He further said education was the very basic sector through which all the country's development goals could be achieved. "This country has a goal of reaching the much-talkedabout first world status in 2022. For this to happen, education has to be given the percentage we are talking about. We also have to ensure that by 2030, we achieve Sustainable Development Goal (SDG) Number 4, which talks about the accessibility of education for all citizens of the country," Dlamini said.

He further said the education ministry had to ensure it took care of the free primary education (FPE), orphaned and vulnerable children (OVC) programme, and to ensure that tertiary education was accessible for all Emaswati. Dlamini said all that needed a serious budget directed to the ministry of education and training so that it could all be achievable.

# Elderly should be given E2 000 per month - NAPSAWU

THE elderly people should be given E2 000 per month and this year's budget should cater for that.

This was said by NAPSAWU President Aubrey Sibiya yesterday when stating what they would like this year's budget to cover.

Before stating what his union would like the budget to cover, Sibiya stated that it was unfortunate that people had their own expectations and government, on the other hand, did things its own way.

Sibiya said if the government did the will of the people, it would cater for the elderly people and fight to ensure that they earned more than they were getting. He believed it could be possible for the government to pay E2 000 per month to the elderly people. It was a disgrace for the elderly people, Sibiya observed, to earn E400 per month because they had a lot of responsibilities.

He further said the health and education sectors needed to be strengthened in the country. The issue of lack of drugs and nursing staff must be dealt with in the budget.

The budget also needs to respond to the educational needs of the country.

He said the tertiary education had been increased by almost 400 per cent.

That meant that government had to find ways of ensuring that Emaswati had access to education from primary to tertiary level.

# Budget in the next two weeks

THE budget speech is expected to be tabled in about two weeks from

This was said by Minister for Finance Neal Rijkenberg on Friday last week in Parliament.

He was interviewed by Eswatini Broadcasting and Information Services (EBIS). Rijkenberg was interviewed shortly after His Majesty King Mswati III had finished delivering the speech from the Throne.

Considering what the minister for finance said, the budget speech might be delivered on the first day next

However, the minister is yet to issue the exact date when the budget speech is to be delivered.

The King, in his speech from the Throne last Friday, called upon the government to ensure that the budget is prepared according to the money country's revenue was not so certain. available in the coffers of the gov-

This means this year's budget might be less than that of last year.

In the past years, the government used to deliver the budget based on mere numbers.

It was a budget formulated on the hope that certain streams of revenue for the country would be able to finance the budget. Currently, the country has two main streams of revenue.

#### Taxes

They include the receipts the country gets from the Southern African Customs Union (SACU) and the revenue collected internally in the form of taxes.

The country is supposed to get a E500 million increase from the SACU receipts this year.

However, despite this, His Majesty the King noted that the future of this

He even called for the SACU mem-

ber countries to review the revenuesharing formula.

In the 2017/2018 financial year, the budget was at E21.8 billion. However, most of the projects that were budgeted for ended up not being financed, due to the cash flow problems. Regional Development Fund (RDF) and Micro Projects were not adequately financed and that remained a thorn on the flesh of the MPs at the time.

#### Decision

This called for the MPs to reject the budget, something that was a first of its kind. However, they were to later reverse their decision. The budget went ahead as it was

# Foetus at Zakhele Police Camp

MANZINI Municipal Council workers made a grisly find when they stumbled on a foetus stashed in a refuse bag while collecting garbage at Zakhele Police Camp.

Information gathered from reliable sources is that the discovery was made by the council employees who were doing their daily duties of collecting rubbish around the police village at around 8am yesterday.

The source said after the discovery, the employees alerted police officers at the camp to come and look at the refuse bag. The discovery also drew attention of members of the public who were pass-

ing by who commented that the find happened at a rather unusual place.

Chief Police Information and Communications Superintendent Phindile Vilakati confirmed that a foetus was found. She said the foetus was found outside the gate of the camp. "Police are investigating the matter," she said.

It is not the first time a foetus has been discovered in a police camp as in 2017 a similar discovery was made at Lobamba. It was alleged that a police recruit was involved in the dumping of the foetus.

However, the allegations were not proved at Lobamba.

# Another showdown in Phakama

POLICE were called in to intervene in a stand-off among offspring of the late business mogul and bus owner Richard 'Phakama' Dlamini, with a faction getting impatient due to delays in the distribution of his estate.

The yesterday morning scuffle resulted in a fire being started and the fleet of buses stopped from leaving the premises until the estate issues were cleared.

When contacted, one of Phakama's daughters said the commotion was after most of them expressed impatience due to waiting for so long for the distribution of the estate, while they waited on the sidelines when the other siblings were busy enriching themselves from the family estate.

The angry daughter said the issue began sometime last year when she allegedly hijacked one of the buses on its way to Phakama business premises in Malkerns. She is alleged to have grabbed a bag full of money and ran off, leaving the bus driver and conductor perplexed.

The bus driver and conductor called other family members, before driving off to the Malkerns police station, where they reported the hijacking.

She said later that day, the police came and took her and her mother in for questioning. She added that she told the police that she did not steal the money, as she had a right to take the money, simply because it belonged to her father. She was later released and the police advised her not to do it again.

#### Commotion

Three of Phakama's children yesterday morning at around 2:30 are alleged to have been at the scene of the commotion at the business premises entrance in Malkerns. They allegedly insisted that no bus would be allowed to leave until they got what was rightfully theirs.

The daughter said they were tired of watching their siblings benefit, while they got nothing, so they decided to take action. Yesterday, they decided to go to Malkerns at the business site and started a fire in an attempt to expedite the process of liquidation and distribution of the estate.

Dlamini said what annoyed them the most was that they were overlooked by the other siblings. She added that all they wanted was what was rightfully theirs.

"We are tired of waiting, our father died on December 20, 2013 and still we have not received anything. We don't understand why the executor is delaying the estate distribution because he is the one in charge of the whole process, as his name is in the will. By doing this, we are provoking a reaction from him," said one of the children

#### **Dstribution**

Police had to intervene and ordered them to put out the fire and allow the buses to leave. She said in the company of police, one of the managers showed them a letter from the Master of High Court, which states that the deadline for the liquidation and distribution of the estate was February

28, and they were advised to wait for that day. Dlamini said they were not aware of the letter and after they were made aware, they decided to call off the protest.

When contacted, the executor of the estate Muzi Dlamini said he was not aware of any commotion at the business premises. When this publication contacted the manager who revealed the letter to the fed up children, his

mobile phone rang unanswered for the better part of yesterday afternoon.

When contacted, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the matter was reported to the police. She said police attended to the matter and it was resolved amicably. She further added that there was no damaged property and no one was arrested.

A male teacher at Mnotfweni High School in the Lubombo region has ended his life after he was embattled with family and financial problems, it has been established.

Mnotfweni High School is a new school under the Siphofaneni constituency.

The teacher, Sibusiso Hlophe, taught History and Geography at the same school. Ironically, Hlophe's death came less than five months after another teacher of Kamkhweli, in the same region, killed himself in August 2018 also due to financial problems.

This is a sad story of Hlophe (46) who died on February 3, 2019 around midnight after he is believed to have intentionally taken an overdose of his medication due to pressure from the financial problems. Reliable sources revealed that Hlophe's life was not so smooth over the past three years.

Insignificant

His financial situation had become so dire that he would rely on his mother for just about the most insignificant of bills. He also could not adequately fend for his children and that took a toll on him, say sources.

His mother was equally living from hand to mouth, given that she was only a pensioner of Eswatini Post and Telecommunications Corporation.

Sibusiso was laid to rest at Ngwane Park Cemetery last Saturday after a night vigil at his parental home at Eteteni, Matsapha.

When this publication visited the homestead of the deceased on Sunday the family was found still in mourning. The mother, Hildah Hlophe, could not control her emotions as she narrated how her son died.

Hildah, 67, said it pained her to see her son's life deteriorating at that rate for the past three years. She confirmed that the problems encountered by the deceased were family and financialrelated.

She said for the past three years her son was swimming in debts that resulted in him taking home a paltry E200 at the end of each month.

She disclosed that his bank cards were kept with loan sharks, the shylock, as collateral for the outstanding debts he was repaying.

#### Transferred

She said her son told her several times that he wanted to resign from the teaching profession or he would end his life because no matter how hard he worked, he still earned virtually nothing.

She said she remembered that when her son was transferred from Dvokodvweni to the new school in 2018, there was no accommodation at Mnotfweni High School.

She said her son used to commute from Matsapha to Mnotfweni and would sometimes accumulate debts to pay conductors in the public transport.

She said Sibusiso later relocated to Phuzamoya, where he rented a flat so that he could reduce the transport costs. It must be mentioned that Phuzamoya is approximately 15 kilometres from Mnotfweni High School.

"I would try to convince Sibusiso not to resign, encouraging him that things would get better. Little did I know that he would finally take his life," said the distraught mother, repeating the same account she had given to mourners.

She further disclosed that on February 3, at around 10pm she heard her son crying from his house which is not far

from the main house.

Arriving there, she said he confessed to her that he had intentionally over-dosed with tablets he was taking daily for an undisclosed sickness.

As he made the confession, he kept vomiting, said the mother, who then gave him water and he appeared to be recovering. "It never even crossed my mind that I should call an ambulance. He then told me to give him a blanket because he was shivering from the cold and that I should switch off the lights because he wanted to sleep. I didn't know that he was talking about an eternal sleep and it was during that night when I last spoke to him," said Hlophe.

Overdose

"The doctors certified him dead at Raleigh Fitkin Memorial (RFM) Hospital, where the overdose was confirmed by the doctors," she added.

"I am a pensioner earning a lousy E2 200 a month, the money was not enough for me to help my son and I would sometimes give him the little I have."

Both teachers and pupils of Mnotfweni High School spoke highly of the deceased. They said for the past months, he was looking stressed but they did not ask him what was really troubling him.

Hlophe enrolled at William Pitcher Teacher's Training College where he completed in 1996. Some of the schools where he once taught at are Mphini Primary and Dwalile High School. He left behind six children.

Principal of the school Jethro Mngometulu said they were devastated as a school to lose such a hard-working teacher. He said it would be difficult to fill the void left by Hlophe.

Mngometulu also confirmed that in the last week before Hlophe met his death, he was looking stressed.

# SANU students break early amidst strike

AMID the class boycott that has seen students engaging in violence which resulted to one student being admitted to Raleigh Fitkin Memorial (RFM) Hospital, the Southern Africa Nazarene University (SANU) has given students their mid-term break earlier than stipulated.

SANU students are currently engaged in a class boycott over, among other issues, delayed living allowances.

In a memo that was issued by the institution's Registrar, Stanley Ngqwane he notified the students that their mid-term break had been brought forward so that it commences on February 11, which was yesterday, instead of next week Monday as scheduled.

"All ongoing students are notified that Senate has resolved to bring forward the mid-term break so that it starts on February 11, 2019.

#### Issue

"This time should allow the government of Eswatini sponsored students to resolve the issue of allowances. Students shall be informed when classes will resume," reads the memo.

The students were supposed to deliver a petition to the ministry of labour and social security yesterday over their allowances, but the move was cancelled because of multiple reasons, including that most students are at home due to the mid-term break.

The SANU students' body issued a the petition.

memo apologising to the students on the cancellation of the proposed petition delivery, stating that the students representative council was currently organising a journey to the Ministry to hear on the issue of allowances and feedback will be provided.

### Petition

The memo was issued by SRC president Tholumuzi Simelane.

"As the SRC, we pass our sincere apology that going to Mbabane is no longer possible. We are aggrieved as you are comrades, pending the delay of allowances and other issues that were going to be addressed and delivered through the petition,"

Shortage of funds was also listed among the things that hindered the delivering of the petition.

# Mhlongo's CEO contract remains valid-Court orders

MBABANE City Council Chief Executive Officer (CEO) Gideon Mhlongo's contract remains valid, the High Court has said.

High Court Judge Mbutfo Mamba, in his judgment, has ordered that until and unless declared invalid by a competent authority, Mhlongo's contract remains valid.

Judge Mamba stated that suspended Councillor Sikhatsi Dlamini lacks the standing to challenge the renewal of the CEO's contract of employment between the city council and Mhlongo. "Of course, ratepayers indeed residents of a municipality have an interest in its municipal manager being properly appointed but this does not, without

further ado, qualify it as a necessary interest, something more is required for these reasons, I hold that the applicant has failed to demonstrate or establish that this application is urgent consequently the application is refused with costs," Judge Mamba ordered.

**Proceedings** 

However, the court noted that on the issue of legal standing, it is clear that the applicant (Dlamini) has the requisite standing to challenge his suspension and the proceedings that resulted in such suspension.

Dlamini had filed an urgent application at the High Court, seeking an order for review of the decision of the committee that sanctioned his suspension and further disputed the authority of Mhlongo, a deponent, in an affidavit filed before the court. According to Dlamini in his papers, the deponent was the CEO of the city council until July 31, 2018 when his contract expired, further stating that his tenure was not extended by any other contract. The matter had been brought under a certificate of urgency before Judge Mamba, where Dlamini was seeking, inter alia orders that pending finalisation of the matter, he be allowed to attend council meetings in his capacity as the chairman of the finance committee.

Further, he was seeking an order that the mayor, CEO, Sithembile Hlanze, Sabelo Magagula, Bongani Dlamini, the municipality and the ministry of housing and urban development or anyone acting in their behest or authority, be interdicted, restrained from removing or preventing him from going about his duties.

He was also seeking the order declaring the CEO not the municipality's

CEO, arguing that his contract lapsed on July 31, 2018. Dlamini had submitted that on May 25, 2018 at an adjourned special meeting held at council chambers, council resolved by seven votes to four that the contract of the CEO was not to be renewed and that the council resolution not to renew the contract was confirmed in a letter to the ministry of housing and urban development, cited as the seventh respondents.

#### Documentation

He further submitted that a letter was written to the then minister of housing, informing him of the council resolution and the minister in turn requested documentation considered during appraisals process of the CEO's performance. He submitted that on June 8, a motion was moved by councillor Thamsanqa Mkhonta of Ward 8 that

the then CEO be sent on a leave of absence for the remaining period of his contract with full pay and reasons for this motion were explained as the irretrievable breakdown of the working relationship with Mhlongo and coun-

Following the renewal of Mhlongo's contract by the then minister contrary to the council resolution, Dlamini submitted that they then sought legal opinion as regards the then minister's move.

"I humbly submit that the legal opinion has been obtained from the city council's attorneys of record and the opinion is clear that there is no contract for the deponent (Mhlongo) to continue in the position of CEO of the city council, the legal opinion is also clear in that the then minister acted unlawfully by directing the Mbabane City Council to renew the deponent's contract," Dlamini had submitted.

He was also seeking for an order of court, reviewing and setting aside the proceedings held by the disciplinary panel and the decision issued by the mayor for non-compliance with the rules of natural justice and Section 21 of the Constitution of the Kingdom of Eswatini.

# Man's (46) bail application opposed for raping gogo (60)

A 46-year-old man has been arrested for having sexual intercourse with Gogo (60) and is facing the crime of rape.

Charged under the Sexual Offences and Domestic Violence Act of 2018, Thishela Andreas Mamba of Macetjeni is accused of raping the elderly woman in that he wrongfully, unlawfully and with intent had sexual intercourse with the 60-year-old without her consent. The Crown has filed a notice of intention to oppose the bail application, as it has been cited in the charge sheet that the applicant (Mamba) raped a defenceless woman. According to the charge sheet, the accused raped a defenceless female adult aged 60, and further he did not use a condom, exposing the complainant to sexually transmitted diseases, including HIV/AIDS, inflicting a lifetime trauma by raping her. The Crown is opposing his bail as it has filed a notice of intention to oppose.

# Man hacks wife, disappears into thick night

A wife narrated before court how she was hacked by her husband last year.

Lucky Vilakati was arrested and charged with contravening the SODV Act, in that he attacked his wife on December 23, last year.

During trial, the accused sat quietly listening to his wife detailing before court the events that unfolded on the day she was hacked.

She told the court that on the said day, she called her husband and asked him for their children's clothes and he said there was none and would not give them anything.

After the call, she and her eldest child went to town to shop in preparation for Christmas.

When shopping, she met up with her friend, whom she identified as Thabsile Ngozo and she ordered her child to return home. "We went to buy drinks and chilled for a bit whilst catching up and at six in the evening, she decided to leave and I remained behind," she

Hours after her friend had left, she decided to check outside from where she was having drinks, and realised that it was dark and the time was 8pm.

She realised that there was no longer transport to take her home. She then went to hike at Total service station.

#### Dropped

At around nine at night, a car driven by one Sibusiso Ngidi, who she said also resided around her area, stopped and gave her a lift.

During the drive, he told her that he was driving home but she requested that he dropped her at Mantabeni. Ngidi had no problem driving her there because it was late, and upon arrival, she further pleaded that he drop her off at home and she would pay him and he did not decline.

The entire time she was sitting at the backseat of the car driven

Upon arrival at her matrimonial home, as she was about to emerge from the car head first, her husband charged at her with a bushknife with intent to hack her on the head and she used her left arm to shield herself and instead of her head, her arm was hacked.

#### Rushed

She said she raised an alarm, calling her mother-in-law, who rushed to see what was happening while her husband fled.

It was unclear where the gentleman who had given her a lift disappeared to, but she told the court that after being hacked by her husband, she and her mother-in-law called an ambulance and the police. Neither of the two attended to them.

Due to the sustained injuries, they asked a neighbour to rush her to Mbabane government hospital, where she was attended to and dis-

charged, but was told to return the following day and when she did, she was admitted.

She further revealed to the court that prior to the hacking, she and her husband had fought about the woman he is currently residing with and it was unclear what had led to him hacking her.

#### Question

"He told me he doesn't want me anymore," she said.

The accused was also given an opportunity to question his wife as per his right since he was conducting his own defence.

He asked his wife as to what time she arrived at home on the day of the incident, and she responded that it was around 10pm.

The accused blamed the complainant of lying, as he claimed she had returned home at midnight.

He further asked how she had seen that he hacked her with a bush knife, and she replied that the car had lights and when she alighted from it, she saw the bush knife.

The trial continues on February

# 3 men convicted of attempted murder

THREE employees from a Siphofaneni based sugar cane cutting company were yesterday convicted for attempting to kill their employer and further stealing his cellphone worth E500.

High Court Judge Doris Tshabalala found them guilty of attempting to kill Bhekithemba Maziya on the first count and guilty of stealing a cellphone Samsung GT E2220 valued at E500 from him.

The three were charged with attempted murder in the first count in that on December 20, 2013 at or near Mabudlweni area at Siphofaneni in the Lubombo region, each or all of them acting jointly in furtherance of a common purpose did unlawfully and with intent tried to kill Maziya by shooting him with a

According to evidence brought before court, on the night of December 20, 2013, the complainant (Maziya) and his girlfriend Nelsiwe Shongwe were sleeping when they were awakened by noise coming from barking dogs outside at around 2300 hours.

Maziya told the court that he went to

peek through one of the windows and saw people outside and further observed that all four windows to his house were guarded by at least one person and further saw another human figure at the two windows to their bedroom.

In his evidence, he stated that shots were fired from outside through the window into the bedroom shattering the window in the process and he used a broom stick to try and scare the attackers and that is when he was shot by a subsequent shot fired at him and the assailants entered the house through the window, prompting him to escape from the bedroom to another room in their three- room house before calling for

According to Maziya, two of the attackers were known to him as they are employees at his company Fundukuwela Investments. When the incident happened, the company had closed for Christmas holidays since December 10, 2013 and was to resume operations on January 8, 2014.

After an alarm was raised, his bothers arrived in a car and the thieves bolted away after failing to find money which they shouted they were looking for. Maziya was taken to the police station before being rushed to the Raleigh Fitkin Memorial (RFM) Hospital.

Maziya informed the court in his evidence that two of the armed men were employed by his company and his employees were supposed to get their Christmas bonuses on the previous day of the incident but the money was not paid to them as the payment day fell on

He stated that the attack was motivated by the non-payment of the bonuses since they shouted for a money bag when they broke into his house, only to find an empty money bag.

They were later caught and arrested by the police. One of them sold the cellphone to his uncle for a lousy E30 and they later made confession statements before the Siteki Magistrate's Court.

# Judgement reserved on SNAT 'spot check' forms matter


TEACHERS will have to wait until February 21 to know what the judgement is in the matter between them and the ministry of education and training over

The judgement on the matter is slated for February 21 at the Industrial Court.

# JUDGMENT RESERVED IN GOVT APPEAL ON E1M COMPENSATION

THE Supreme Court has reserved its judgment in an appeal filed by government following an award of E1 million compensation to a man who was shot by members of the Eswatini Umbutfo Defence Force (EUDF).

The Supreme Court reserved the judgment to a date to be communicated to both counsels by the registrar.

Representing government in the civil appeal yesterday was the office of the attorney general while Howard Pokwane Nkambule was represented by Rodrigues and Associates law firm.

The High Court last year granted an order that government should pay Nkambule E1 100 000 for damages he suffered after being shot by the soldiers while at a bus station during the night.

Principal Judge Qinisile Mabuza issued the order in favour of Nkambule and the quantum of damages as per Judge Mabuza was the above money as she noted that the plaintiff (Nkambule) had not proved loss of earnings and could not be awarded anything under that head.

However, the High Court noted that the injuries that he suffered were very

Justice Mabuza had further ordered that the action succeeds and the plaintiff is awarded damages in the sum of E1 100000 together with interest and costs, inter-

### Justice Mabuza awarded him the following;

- Pain and suffering E350 000
- Permanent disability E200 000,
- Loss of amenities to life E400 000
- Future medical expenses E150 000 Total - E1 100 000.

The plaintiff on November 7, 2001 issued summons against the attorney general (the defendant in the court a quo) in which he claimed payment of the sum of E1 428 000 in respect of damages; interest thereon at the rate of nine per cent per annum a tempora morae; costs of suit and further and alternative relief.

The attorney general was sued in his capacity as government legal advisor and legal representative.

The claim was directed at members of UEDF who were represented by the attor-

The claim was defended by the attorney general in the court a quo.

The cause of action arose on or about February 3, 1997 at Mvutjini, in the Hhohho region.

It was alleged that the plaintiff was wrongfully assaulted by members of the Defence Force whose full and further

particulars are unknown to the plaintiff and in the cause of the assault the plaintiff was shot in the face.

The defendant (applicant in the present application) denied the allegation by the plaintiff, in particular that the stated members of the Defence Force or any person or persons acting on their behalf assaulted or shot plaintiff.

#### Disabled

It is stated in the particulars of claim that as a result of the assault, the plaintiff sustained severe injuries and has become permanently disabled in the following respects; he has suffered permanent injury to his jaw and mouth, experiences a poignant pain in his jaw, has difficulty eating solid foods, cannot run and participate in sport and is now unable to lift heavy objects.

The attorney general, in response, stated that he has no knowledge of these allegations, denies them and put Nkambule to the proof thereof who had stated that at the time of the assault, the said members of EUDF were at all material times acting within the course and scope of their duties as they drove a government vehicle and some occupants were in EUDF uniform. Meanwhile, also on appeal was the matter involving Floyd Mlotjwa and Webster Lukhele who are appealing against the judgment of the High Court which ruled in favour of Manzini North Member of Parliament Macford Sibandze in his 2018 national elections victory.



# MANFINED E700 FOR STEALING BEER ATRITZ

A 40-year-old man from Mantabeni under Chief Jabhane in the Hhohho region has been arrested for stealing alcohol at Ritz Food and Beverages shop in Mbabane.

Happy Dlamini was nabbed

Saturday by the police after stealing four Castle beer bottles from the shop.

#### Beer

Upon gaining entry at the outlet which is located at Gwamile Street, Dlamini illegally and purposefully tried to steal beer bottles that were under Fikile Motsa's

Dlamini and Clerk Winile Malinga were presiding over the matter.

The court learnt that Dlamini ordered four Castle beer bottles (750ml each) at the counter.

The bottles were brought to him at the counter, but he left them and went to the meat fridge, taking some meat that was for sale and headed back to the counter where he paid only for the meat.

When he returned from the fridge to get the meat, Dlamini is said to have used another line that was shorter than the one he had used before when ordering for his drinks, leaving behind the beer.

#### Paid

"He paid for the meat and went back to the first counter where he had left his beers. Upon reaching that counter, he claimed the alco-

He simply took the beers that were inside a plastic bag and headed towards the exit door together with the meat he had paid for. I decided to purse him. The total amount of the beer he had stolen is E75.76," said Nkosinathi Dlamini, a security guard at Ritz.

Worth noting is the fact that Dlamini was not a first offender in the case. Late last year in December, at the same shop, the management had to forgive him for committing the same offence. He had stolen six wine

Then, a security guard followed the accused who was already crossing the street. Dlamini is said to have been surprised by the fact that the security wanted to arrest him.

"Sewebe ludziwo lolukhulu, what must the court do with you," asked the court presi-

He was sentenced to seven months in a correctional facility or pay a fine of E700.

The two youngsters were alone when the incident happened. Bulunga's daughter had long hair, and

when she returned home, it was noticed that her hair had been trimmed. The accused told the court that they

went looking for the hair the next day and they could not find it.

Bulunga pleaded guilty to the charge of verbal assault, but he maintained that his daughter's hair was really cut by Gama's son.

The court also learnt that the two had met whilst crossing the Mbuluzi River and Bulunga was driving his car.

The accused first ignored Gama and then reversed his motor vehicle to him.

"Bulunga said umntfwanami uyagula ngoba tinwele tajutjwa, umncutse leni," Gama said in court.

The court then wanted to know why Bulunga told the complainant that his daughter was sickly.

"The reason I reported the matter to Gama is because Gama's wife works at the pre-school where my daughter attends classes. My daughter was with Gama's son when her hair was trimmed. Also, Your Honour, Gama is one of the elders in the area and we sometimes tell him what's affecting us as a community," said Bulunga.

He further told the court that it has been six weeks since his daughter fell ill. The accused was fined E800 or face imprisonment of eight months.

#### **Business**

"I was earning E800 per month, and this was too little to cater for my needs. I decided to leave the

job and started selling ice blocks on the streets of Siphofaneni," she said.

Dlamini said a few months into the world of entrepreneurship; she then expanded and started selling perfumes to individuals. She got her stock from neighbouring South Africa. Dlamini said she continued trading as a vendor until a time when she decided to open such small shop for her cosmetic products. By this time, she registered her business as Place of Power Cosmetics. Dlamini said her business flourished over a few months, and she started selling her products to other vendors. "I am now operating more like a wholesaler, because some shops already buy their stock from me," she said.

Meanwhile, Dlamini said she has recently enrolled for an accounting course at one of the institutions in Manzini.

She said she was doing this so that she can manage her cash flow, and be able to see if her business was making profits or not. Her ultimate goal is to grow into a large scale business under the cosmetics industry.

# Stress drives woman to the bar, nabbed for DD

THE stress of finding out that your teenage daughter is pregnant just after you have paid school fees for the whole year can sometimes push you straight into the nearest bar.

This is exactly what happened to Zanele Khoza (50) of Ndwandwe area who was nabbed for drink-driving. According to the charge sheet, on Saturday, at about 2159 hours near Mathayini along Duma public road in the Manzini District, Khoza, being the driver of a Kia vehicle registered PSD 442 BM, wrongfully and unlawfully drove the said motor vehicle on a public road under the influence of intoxicating liquor or drug, thus contravening Section 91(1) as read with Section 122(2) of the Road Traffic Act No.6 of 2007.

She pleaded guilty to the charge. Khoza told the court that if she could be able to turn back the hands of time, she could. This was because she was not proud of her act of driving while she was under the influence of alcohol. She left the court in stunned silence when she revealed the reason behind her excessive drinking. Khoza recorded 0.88mg/l when a breath specimen was conducted on her. She told the court that after finding out that her teenage daughter was pregnant, she did not know what to do. To avoid hurting her, she left her home to try clear her mind.

"Your Worship, I didn't know what to do after realising that my daughter was pregnant. I had just paid her school fees for the whole year since we all know schools have just opened for the year," she said.

Khoza said she was very angry at her daughter for making a fool out of her.

She then took a drive in an attempt to clear her mind. That was when she ended up having a few alcoholic beverages. Following the stress relieving beverages, according to her, she was nabbed by the police on her way back home.

Magistrate Xolile Nxumalo found her guilty of the charge. She was sentenced to 10 months imprisonment with an option to pay E1 500.

# STRESSED KOMBI DRIVER NABBED FOR DD

AN allegedly stressed kombi driver was nabbed for drinking and driving.

Sifiso Tsabedze of Mpembekati area was charged with contravening Section 91(1) of the Road Traffic Act of 2007 in that on Saturday, near KaHlobile along MR31 public road in the Manzini District being a driver of a motor vehicle registered BSD 713 AH, a Toyota kombi mini-bus, he wrongfully and unlawfully drove the said motor vehicle on a public road while he was under the influence of an intoxicating liquor or drugs. His alcohol content was 0.79

mg/l, which is above the legal limit of 0.38mg/l.

Tsabedze appeared before Magistrate Xolile Nxumalo on Sunday. As a public transport operator, he was told that he is putting people's lives in danger. Tsabedze told the court that there were no passengers in his vehicle when he was nabbed for driving under the influence of alcohol.

Astating

He told the court that he wanted to clear his mind following a series of devastating issues that he was faced with. He did not disclose the nature of the issues that he was faced with that landed him in trouble.

"Your Worship I was trying to relieve myself of stress by drinking alcohol. Mind you it was after hours, it is just that I was driving the mini-bus," he said.

He concluded by voicing out that he was a first time offender and had no intention of committing such an offence in the future, no matter how stressed he can be. Tsabedze was found guilty of the charge and was sentenced to 10 months in prison with an option to pay E1 500 fine.

# Sick sibali lands man behind bars

A hurried call by his sister to come and pick up his sick brother-in-law landed Mandla Ndlangamandla of Nsongweni area in jail for over-speeding and driving under the influence of

Ndlangamandla was in court facing two traffic offences. He was arrested at Sidvokodvo near Riders' Ranch along MR9 public road in the Manzini region. He was driving a Honda Fit registered QSD 509 CM and did wrongfully and unlawfully drove the said vehicle under

the influence of an intoxicating liquor with a reading of 1.09mg/l.

He was also charged with contravening Section 54 (4) (a) as read with Section 122(4) of the Road Traffic Act 6 of 2007 in that on Saturday, at about 0900hrs, he drove the said motor vehicle on a public road at a speed of 79km/h, in excess of the general limit which is 60km/h thus contravening the Act. Ndlangamandla told the court that he was rushing to fetch his brother-in-law at Mankayane.

"Your Worship, I am a responsible per-

son. I wouldn't just drink alcohol and then take my car and speed on the road," he said.

Ndlangamandla added that he even told the arresting officer 7295 Constable Sicelo Mkhwanazi the reason for his speeding. He said he received a phone call from his sister pleading for assistance since his brother-in-law was extremely sick. He was found guilty of all charges. On the first count, he was sentenced to 12 months imprisonment with an option to pay E1 700. On the second count, he was sentenced to four months imprisonment with an option to pay E600.

# MARULA TASTING LANDS MAN IN JAIL

A crowd can sometimes lead you astray and this is a lesson that Sithembiso Tfwala learnt on Sunday in court.

Tfwala (34) of Nyakeni area appeared before Magistrate Nxumalo charged with contravening Section 91(1) as read with Section 122 of the Road Traffic Act of 2007 that he committed on Sunday.

Tfwala was driving a Honda sedan registered XSD 036 CM on MR31 public road near KaHlobile under the influence of intoxicating liquor or narcotic drugs with a reading of 0.77mg/l, which is above the legal limit of 0.38mg/l.

"Your Worship, it is not like I drank intentionally. In fact, I only tasted the brew,"

he said.

He told the court that he only had one cup of marula brew.

He further stated that he only

drank the cup after seeing his friends enjoying the seasonal brew.

He added that seeing the state his friends were in, he was tempted to taste the brew.

He told the court that if he knew that the brew had so much alcohol content in it, he wouldn't even have touched it.

#### Assured

Tfwala further told the court that he was not a regular drinker and it was his first time in court.

He further stated that when he was stopped by the police officers, he did not think that he had so much alcohol in his system because he was stable. He assured everyone in court that he does not have any intentions of getting closer to any intoxicating drinks because of the expense and embarrassment that comes with them.

He was found guilty of the charge and was sentenced to 10 months in prison with an option to pay E1 500 fine.

# EU dishes out E80m for ICT improvement

THE European Union (EU) has dished a sum of E82 823 167.13 to the Government of Eswatini to assist in improving the information, communication and technology (ICT) sector.

The money was announced yesterday at the ministry of ICT by EU Ambassador to Eswatini Esmeralda Hernandez Aragones.

Aragones had gone there with EU Head of Cooperation Ariane Labat.

Organisations to benefit from this kind gesture include government ministries and parastatals such as the prime minister's office, ministries of finance, natural resources and energy, agriculture, ICT, National Agricultural Marketing Board (NAMBoard) and Eswatini Revenue Authority (SRA).

An amount of €136 000 (E2 114 800) has been allocated for the implementation of an e-government technical assistance project. This project seeks to assist the government in implementing its own e-government strategy and action plan. The project also seeks to align the e-government programme to the whole transformation project, including innovation and change. This is to improve public administration through the use of ICTs.

A sum of €4 380 000 (E69 109 000) has been allocated towards the Integrated Financial Management and Information System (IFMIS).

This project is aimed at supporting the automation and integration of public financial management processes, including budget formulation, execution (e.g commitment control, cash/debt management, and treasury operations), accounting and reporting.

IFMIS solutions significantly improve the efficiency and equity of government operations, and offer a great potential

for increasing participation, transparency and accountability for sound Public Financial Management (PFM).

The EU also allocated £283 580.61 (E4 409 678.49) for the supply of ICT and GPS equipment for the sustainable land administration and management project in the country. This project aims at improving the security of tenure and access to land for the rural poor people, thereby improving food security. EU has supplied the Land Management Board (LMB) and 23 chiefdoms with GIS equipment and tablets, as a pilot project to do the mapping for house-

holds' use of land under the DCI-FOOD project for land administration and management at national, regional and chiefdom level.

The ministry of agriculture has also benefitted from the donation as €267 518.08 (E4 159 906.14) has been allocated for Agricultural Marketing Information System (AMIS). This is a web-based portal that aims to provide relevant information to all agricultural stakeholders, allowing them to have better access to information related to market demand and supply for increased opportunities to market access.

# SRA gets more than E2m

ESWATINI Revenue Authority (SRA) has been given an amount of about E2 836 320 by the European Union (EU).

This money was given to SRA for the installation of ASYCUDA World Performance Management System (ASYPM).

This project is to facilitate the effective monitoring of trade flows and the effectiveness of trade facilitation measures by tracking the performance of the system, as well as the officers using it. The ASYPM is a system specifically designed to work with the Automated System for Customs Data (ASYCUDA), which is a computerised system to administer Eswatini's customs.

The ASYCUDA system helps in making revenue collection more efficient and it further reduces both the clearing time and the administrative burden on the trading community. It also generates trade data that can be used for statistical economic analysis. Managing the performance of this system is critical to ensure that cross-border trade remains effortless in Eswatini.

The EU also allocated €10 500 (E163 275) for IT experts to develop a web-based information management system for approval and certification of plants and plant products. This system will provide a harmonised solution for issuing phytosanitary certification that contributes to facilitating safe trade.

An amount of €40 000 (E622 000) was allocated for the development of an electronic veterinary drugs and medicinal database. This project seeks to support an official harmonised national database system for the control and regulation of veterinary drugs and medicinal substances in Eswatini.

The system is expected to promote Eswatini's compliance with international standards in the regulation of veterinary drugs and medicinal substances, ensure prudent and responsible use of veterinary drugs and medicinal substances especially in food producing animals, thus ensuring safety of food of animal origin and fostering trade partners' confidence and such promote international trade.

An amount of €26 250 (E408 187.50) was also allocated for research and innovation collaboration within Africa and Europe to monitor ICT-related activities. This project focuses on strengthening ICT-related research and innovation cooperation between African and Europe by fostering greater coordination of ICT-related research and innovation activities to inform policy formulation and research collaboration, and coordinating stakeholders to formulate research priorities and activities addressing socio-economic challenges and strengthening African innovation ecosystems.

# EU assistance came at right time – Princess Sikhanyiso

THE European Union's (EU) assistance has come at the right time for the ministry of information, Ccommunication and technology (ICT).

This was said by Minister for ICT Princess Sikhanyiso as she was commenting on the assistance rendered by the EU to the ICT ministry. The princess mentioned that the ministry of ICT was given a task by Prime Minister Ambrose Dlamini, of ensuring that the ICT sector was improved by the ICT ministry.

She said there was a need to implement the e-government strategy and that was a very huge task that lied ahead for the ministry. She said she hoped that the EU would be there to assist as the ministry wanted to help the country in moving towards Vision 2022 using ICT.

The minister said the EU had been there for the country during hard economic times, and it had never ceased to be of great help to the country. The minister related that one of their main objectives is to

#### NIGERIA is preparing for its general election.

But will it be credible? Nigerian voters are well aware that the elections will not be won solely by votes or popular consensus. There are several other variables that influence election results.

These include the incumbent's control of state security apparatuses, grassroots structures, and control of institutions such as market traders associations, and the National Union for Road Transport Workers.

The road transport workers' union, which acts as a canopy for bus drivers, conductors, and motor park touts in South-western Nigeria, has a history of providing foot soldiers for employment as election thugs with skills in ballot box snatching and voter intimidation tactics.

In addition, the possibility that the election could be rigged cannot be ignored.

Questions around the credibility of elections in post-independence Nigeria can be traced as far back as the 'First Republic' which lasted from 1960 - 1966. After allegations of massive rigging in the 1965 elections the country's western region was engulfed in the infamous 'Operation Wet-

The riots pitted rival political groups against each other leading to Nigeria's first military coup in 1966. From then on the country experienced a series of coups. Between 1966 and 1999, when the country made a decisive break with military politics, Nigeria experienced eight military coups. In that same time period three general elections were conducted.

### **Tumultuous** past

The years outside of military rule were comparatively brief and arguably overshadowed by the spectre of the military. When elections did happen they were plagued by strong allegations of electoral fraud. Since 1999, when the country broke with military rule, five elections have been conducted all of which have been tainted by controver-

It's clear to see that Nigeria has survived a tumultuous political history. Going into this next election, questions still remain about the credibility of the country's electoral system, and the viability of it's governance structures. Looking back things have often gone wrong, but are there instances where things have worked out well for the electorate?

I would argue that there have at least two instances when voters got what they asked for. One is the June 1993 presidential election, which is considered to have been relatively free and fair in its conduct, its eventual annulment notwithstanding. Another is the presidential election of May 2015 when the incumbent Goodluck Jonathan, gracefully accepted defeat by conceding to President Muhammadu Buhari.

Yet I still feel that Nigeria's electoral system needs a complete overhaul if it's to perform its functions with as little external interference as possible.

## Shadow of military rule

The country has been ruled by military administrators more than it has by democratically elected leaders.

For 29 years of Nigeria's independent history military dictators have had a grip on its leadership. This is compared to just 20

years of democracy. The result has been that electoral rigging and malpractice are rife within Nigeria's electoral process.

Since 1999, Olusegun Obasanjo and Muhammadu Buhari, both of whom were previously military dictators spent a combined 12 years in power.

President Buhari is now seeking a second term.

As a result, there are still those who argue that the country's transition from military rule to democracy is not quite complete.

The executive arm, for example, still maintains certain authoritarian characteristics that are reminiscent of the military era. One of these is the use of the armed forces to manipulate election processes. For instance, during the recent gubernatorial elections in Ekiti and Osun states voter intimidation by the security forces was rife. This was done to scare away opposition voters and give the ruling All Progressives Congress an edge.

### The electoral commission

Another factor to consider is the supposed independence and impartiality of the Independent National Electoral Commission which is in charge of running the elections. Critics point to the fact that the commission chairperson and others in the commission are nominated by the president. This calls into question the credibility of the entire electoral commission.

Further, Buhari has just appointed Amina Zakari as the new collation officer. Zakari will oversee the committee responsible for the national collation centre from where results of the presidential election will be announced.

But Zakari has been alleged to have a family relationship with the president. This has raised suspicion within opposition circles that the government intends to rig the polls.

To make matters worse, the behaviour of the electoral commission in previous elections hasn't always been above reproach.

This has lent credence to the criticisms bout the body's impartiality. In the run up to the 2007 general for example, the Supreme Court ruled that the commission had no power to disqualify candidates in the eleventh houras it had purported to do in the case of opposition candidate Atiku Abubakar.

The opaque nature in which recent gubernatorial elections have been held has also added to the fears of a rigged presidential poll.

The September 2018 gubernatorial election in Osun, for example, was panned by election observers as being riddled with voting irregularitieslike voter harassment, and interference by 'inappropriate persons'. These irregularities were reinforced by the high number of security officers deployed to the state during the election period.

The involvement of the security apparatus in tilting this tightly contested election in favour of the ruling All Progressives Congress is considered to be an indicator of how things could pan out in the general election.

#### Role of outsiders

Observers like the European Union and the US also exert a measure of influence on Nigerian elections. By ramping up the rhetoric on the importance of free and fair elections they play into the hands of the opposition who have historically appealed to foreign powers to umpire the electoral process.

Incumbent governments, on the other hand, have typically been on the other side of the argument. Nigerian governments have often cited what they call the 'neo-imperialism' of countries like the UK and the US and decried their interference in Nigeria's sovereignty. This resistance to foreign interference was most recently evidenced in comments made by Kaduna State governor, Nasir El-Rufai, who threatened foreign observers with death if they engaged with local politi-

Former president Goodluck Jonathan also trotted out the 'foreign interference' trope when he claimed in his recently published memoirthat the US played a hand in ensuring that he lost the 2015 election.

And a few weeks ago the ruling All Progressives Congress joined the bandwagon when they issued a statement telling the EU to not undermine Nigeria's sovereignty.

#### Not all grim

Despite all of the above, it's not all grim. There are some positive precedents that can be built on.

For example, despite predictions that there would election violence during the 2015 poll, Jonathan did the honourable thing by conceding defeat to Buhari.

His concession reinforced the notion that elections need not be a 'do or die' affair.

This peaceful transition after just one presidential term in office also set a positive trend for elections across Africa.

But with the slim margin between the incumbent, Buhari, and his main contender Abubakar of the People's Democratic Party - this narrative might need to be reinforced when Nigeria goes to the polls again on February 16. The Conversation



# Ramaphosa's education plans don't quite make the grade

CAPE TOWN - South African President Cyril Ramaphosa's State of the Nation Address, delivered in Cape Town on February 7, has attracted a fair amount of praise.

But while the speech scored an A for its vision and plan for economic renewal, it scored an F for education.

If the amount of time spent on a topic during the speech is any indication of where the president's priorities lie, then those concerned about South Africa's education system – at all levels – have reason to be concerned.

Early on, he listed "improving education" as one of the government's five most urgent tasks, but he didn't elaborate on this point until well into his second hour of speaking. In fact, more time was given to tourism than education.

One can appreciate that the president had many pressing points to make about the country's dysfunctional parastatals, and weeding out corruption.

It's likely that the audience he was most concerned about were potential foreign investors, not ordinary citizens concerned about the safety of their children on university campuses after a week of protests or those who worry about the quality of basic education.

But it would have been good to hear Ramaphosa use his brief time at the podium to give a considered, thoughtful – and sobering – assessment of the state of South Africa's entire education system.

He could have acknowledged that, after 25 years as a democracy, the country's education system hasn't yet turned the corner from deep dysfunctionality to sustained success. And this critical assessment should have been accompanied by a strategy to map the way forward.

#### BASIC EDUCATION

Instead, Ramaphosa spoke of his government's commitment to basic infrastructural backlogs, such as toilets. Ensuring that schools have basic infrastructure in place is critical. But the fact that the president had to raise this as an issue at all is a shame to the minister of basic education. Ramaphosa made similar promises in his 2018 State of the Nation Address about school infrastructure development, which the department of basic education hasn't delivered on.

These infrastructural problems should have been sorted out a decade ago, especially given that the department has been taken to court to make it happen. The focus now should be on substantive educational issues.

It would have been important to hear the president comment on South Africa's ongoing challenges in producing school leavers who are qualified for first year university mathematics.

The president also created a fanfare by announcing the rollout of e-tablets for all school children. If he sincerely believes that access to this form of technology is one of South Africa's most pressing problems, he has been badly advised by his minister.

Technology is merely a tool for teaching and learning. If the teaching and learning experience is poor for a variety of reasons, access to a tablet will make no difference.

Where are the country's skills going to come from to compete in the fourth industrial revolution? Probably not from giving pupils access to e-tablets when the principles of basic numeracy are still not properly taught.

#### HIGHER EDUCATION

With respect to the technical and vocational education and training sector, Ramaphosa echoed the same promises that have been made before, vowing to build up this sector so it can contribute to the development of technically skilled graduates. No one will disagree with this.

But what should have been discussed was the progress or lack thereof that has been made in the past five years to strengthen this important sector.

This was among the former minister of the department of higher education and training's priorities, and is high on the current minister's list, too. So: what progress has there been on their watch?

The week leading up to Ramaphosa's speech saw student protests erupt on a number of university campuses. One protest ended in tragedy: Mlungisi Madonsela, a student at the Durban University of Technology, was shot dead—allegedly by a security guard hired to protect the campus. Ramaphosa acknowledged both the protests and Madonsela's death. But the sector urgently needed some stabilising assurances. Will the promise of 'free education' for the poorest be delivered on now and in the future?

Is the state thinking beyond the current crises to issues of financial sustainability for the future?

What happens to academically eligible students whose National Student Financial Aid Scheme funding runs out after four years?

Finally, Ramaphosa rightly lauded the achievements of the Square Kilometre Array, which will be the world's largest radio telescope when it's completed in the mid-2020s.

But the reality is that sustaining this kind of research will require investment in South African universities' research capacity.

It would have been good if the president had acknowledged the deplorable conditions of research funding in universities and the huge risk this presents to the country unless it is addressed.

Academics and the public need to know that this is on the president's radar—and, specifically, how this trend will be reversed.

Overall, the president failed to convince ordinary South Africans that education—arguably one of the most important contributors to a thriving society—is in good hands. *The Conversation*

As large landowners, mining groups are also afraid of paying the price of a massive and unbridled redistribution of land.

South African mines, which have long been at the forefront of the economy, have been in slow decline for years, suffering from falling commodity prices and rising production costs.

In this difficult context, the government's desire to accelerate the redistribution of land to the black majority in the country, to correct the inequalities inherited from apartheid, has chilled the entire sector.

Three months ago, the CEO of the giant Anglo American made the terms of the debate very clear. If ownership of mining lands is not guaranteed, he said, investors will flee.

"We must find sustainable and inclusive solutions," said Mark Cutifani, "South Africa's willingness to boost foreign investment on its soil can only be met if the government details its plan on land in

The rating agency Moody's, which has placed South Africa under close scrutiny, shares its concern.

"Uncertainty continues to limit short-term investment," she warned in June. "If reform were to prove costly for companies, the decline in investment would be even more pronounced."

Determined to involve foreign companies in the recovery of its economy, Cyril Ramaphosa received the strong and clear message. So he took advantage of his big annual raid this week in Cape Town to try to reassure the mining sector.

#### DON'T BE AFRAID

"Investors should not be afraid, their property will not be taken from them," he promised.

Land reform, he recalled again this week, aims to "repair (...) the original sin committed against black South Africans during colonisation and apartheid".

A quarter of a century after the fall of the white racist regime, threequarters of the country's agricultural land is still in the hands of the white community, which represents only eight per cent of its 55 million inhabitants.

Still under discussion in Parliament, the expropriation without compensation project has already had its first effect.

On the ground, it has exacerbated the struggle of local populations against mining companies to oppose the expansion of their activities, reclaim their land or, failing that, enjoy a (small) share of their profits.

"The mine affects our lives because we no longer have land," says Milicent Shungube, spokesperson for the community of Emalahleni (north), in conflict with the Glencore mining group.

"We tried to get them to leave, but to no avail," he continues. "So we'd like to enjoy it. They make billions of dollars in profits, but we don't see anything of it."

Last year, however, the justice system required Mines Minister Gwede Mantashe to consult with the community of Xolobeni (southeast) before granting a permit to the Australian company Transworld Energy and Mineral Resources (TEM). A rare victory for the peo-

#### LAND REFORM IS A POLITICAL TOOL

However, industry experts do not expect a flood of decisions against the mining industry.

The parliamentary elections of 8 May in sight, the intentions of the head of state did not escape his rivals. The companies, on the other hand, seem ready to play the game. If the balance between justice and development is maintained.

"The industry recognises the need for progress on the land issue," summarises South African Chamber of Mines spokesperson Charmane Russell, "we hope this will be done in a way that does not affect investor confidence." AFP

# Eskom unbundling won't affect Eswatini

...ESERA announces contingency plans to increase Eswatini's electricity production by 80 MegaWatts for the next five years, to avoid heavy reliance on imported power

WHEN South Africa President Cyril Ramaphosa announced the unbundling of power supplier ESKOM into three distinct state-owned units namely: Generation, transmission and distribution, local electricity users could not stop feeling uneasy, because most of the country's power comes from South Africa.

Nonetheless, the country's energy regulator ESERA has assured the nation that ESKOM's unbundling will not affect the kingdom in any way.

ESERA is the Eswatini Energy Regulatory Authority.

ESERA Manager Consumer and Stakeholder Sikhumbuzo Nkambule explained yesterday that ESKOM's unbundling would not have a negative effect on its power supply to Eswatini. He explained: "The unbundling of ESKOM is an effort to improve efficiency and productivity, as well as better manage the operations of the utility.




Nkambule made an assurance that any challenges that may have an impact on the supply of power are always communicated in advance. In the meantime, the ESERA consumer and stakeholder manager also made it clear that the kingdom nonetheless is not banking on hopes of long-term reliance on imports for power supply. He announced that ESERA, working closely with the ministry of natural resources and energy, is working to improve security of supply through the Short Term Generation Expansion Plan (SGEP), which stipulates that the country should have up to 80 MegaWatts of generation capacity in the shortterm.

This project should be implemented within five years starting in 2018 and has already been approved by government. Nkambule explained that the main idea is to gradually increase this capacity in line with the Energy Master Plan, which is targeting generation projects up to year 2034.

South African publication Finance24 said ESKOM's unbundling had attracted mixed

reactions from different unions. The National Union of Metalworkers of South Africa (NUMSA), one of three recognised unions at the power utility, rejected the unbundling exercise. The union is reportedly concerned that the unbundling would lead to the privatisation of Eskom, which would lead to job shedding. In contrast, COSATU called for President Ramaphosa to make a commitment that the restructuring would not lead to job losses. "We appreciate the president's commitment to a just transition. But he did not say what exactly does that mean. Workers only want one thing. Job security," COSATU parliamentary coordinator Matthew Parks said in a statement, COSATU is the Congress of South African Trade Unions



# Eswatini remains on negative B2 Moody's rating

THE prevailing financial and economic pressures have seen the country remain in a negative B2 rating from reputable rating agency Moody's.

A B2 rating is one that is within speculative grade Moody's Longterm Corporate Obligation Rating. Obligations rated B2 are considered speculative and are subject to high credit risk.

According to the latest ranking by Moody's, Eswatini remains in the same rating as the previous rating announced by former minister of finance, Martin Dlamini in his budget speech last year.

Ratings by credit agencies are considered important for all countries of risk associated with investing in a particular country, including polit-

CBE Governor Majozi Sithole said after the opening of the 11th Parliament last Friday that it was imperative for the nation to note the importance of the ratings which place the country in a position that it can repay loans received.

He said it was important that the nation embraces the recommendations given by the rating agency in order to show that the country can move away from negative rating.

"By the time they come back, the country should have improved further," he said.

The finance minister said B2 was generally based on the country's small and slow growing economy which he also described as being relatively well integrated, diversified and resilient.

2. Institutional strength constrained by governance challenges that have been hampering fiscal policy-making and progress with structural

3. Moderate (+)' fiscal strength that balances low public debt-to-GDP ratio which is below regional and similarly-rated peers, against structural fiscal weaknesses that has caused rapid debt accumulation and increased interest costs in recent years.

4. Moderate (+) susceptibility to event risk, which reflects on-going government liquidity challenges.

# Speedily implement King's suggestions, UNESWA economist urges govt

UNIVERSITY of Eswatini (UNESWA) Senior Agricultural and Applied **Economics Lecturer Dr Daniel Dlamini** has said government must regulate the informal sector, address electricity supply, tackle crime and corruption, as well as customs and trade regulations in order to realise a turn-around in the country's economy.

He said the King's speech was spot on and that the business community and government should address the issues highlighted by His Majesty King Mswati III in his speech from the throne last week Friday. Addressing questions posed to him by the Business Desk, Dr Dlamini said the informal sector needs to be regulated to avoid unnecessary competition with established business people who are paying rent and taxes to government. He said in most cases, the established business people are locals and foreign traders involved in illegal business dealings.


"The informal sector is very important and plays a huge role in the economy, but it needs to be regulated. They must have designated areas to trade to avoid a situation where by they even do business in front of other business establishments, who happen to be in the same line of business. This becomes unfair because most of the informal traders do not even have

trading licences and do not pay tax," he

Dlamini described electricity supply as another critical matter, which needs government's immediate attention. He said power connection costs are currently very high in the country as they discourage investors. He said government needs to address these issues because thay frustrate business people who would have been doing a lot in the rural areas but because of such obstacles they eventually give up. "The issue of electricity is a huge challenge because it escalates what we call sunk costs, or rather costs of starting a business," he added.

He said customs is another equally sensitive issue, which adversely affects businesses. "When business people bring their goods into the country, there are always delays at the entry points which affect business because, some of the imports are raw materials. If the materials are delayed for more than a day at the border, it causes problems for the business," he said.

"The King was spot-on in saying there is a need to have one-stop shops which will then reduce the number of days for one to get all the documentation needed to start up a business. Even the money paid for registration is currently expensive. As one of the means of improving the ease of doing business as said by the King, the costs need to be reviewed," he



# 'Eswatini exporting too many jobs'

UNESWA agricultural economist Dr Daniel Dlamini says the country is importing way too many goods from other countries, yet it produces lots of raw materials, which are later imported back as finished products.

He said the country imports even the simplest and smallest of things, which results in the exporting of jobs.

He said the country would have co ated many job opportunities, if for instance, instead of selling corn cornflakes be manufactured locally and selling tomato sauce instead of selling

He said the King spoke at length on agro-processing, which means now government needs to have an import substitute policy which will put control on the imports that come into the

"An export based policy is key and it could be complemented by import substitutes on processed foods. The country imports too much of consumption demand. Hence, we are indirectly exporting jobs to where the food comes from. The issue of value addition and agro-processing is long overdue," he noted.

Designated

Dr Dlamini said food processing industries must be prioritised and supported. He also said a special vehicle in the form of financing and the establishment of special economic zones designated for food industries should also be established.

"The national industrialisation plan must focus on agricultural products. Government should support the establishment of agro-processing incubators to improve quality.

"The expansion of agricultural production will be key to supply stock to the industries. There is also a need to pay special focus on commercial farming, where agricultural graduates could be supported with land and start up financing," he said.



EU - Avocado imports have soared around the world, mostly to the European Union and the United States, but China and Japan are now importing thousands of tonnes of the multifaceted green fruit too.

Even as US imports of avocados slowed slightly, the taste for avocado has globalised.

Avocados may have originated in South America, but it is Africa that is cashing in on the world's love of avocados.

In 2017, Kenya overtook South Africa as Africa's largest avocado exporter. Before the leap, South Africa was fourth after Peru, Chile and California as the world's exporters of the popular Hass avocados. Kenya's coffee farmers caught on, and switched to avocados, making 10 times as much as they did from coffee. Avocados now make up 17 per cent of Kenya's horticultural exports, accord-

ing to the International Trade Centre.

Also deflated by the falling price of coffee beans, Tanzania is beginning to invest in avocado farming. This week, one of the country's largest avocado growers. Africado, announced that it had secured 2.5 million euros (\$2.8 million) to scale up its business. To its credit, Africado spotted the opportunity in avocados early. Africado was founded in 2007, and has partnered with Wastfalia, an avocado producer based in South Africa's avocado Limpopo province. It's located in Tanzania's coffee growing Kilimanjaro region. They work with 2 000 local farmers along with their own orchards to target the European market. With the loan from Finland, they also plan to diversify to other avocado varieties and nuts.

In 2012, Africado was awarded a grant to build a processing, cold-chain and packaging facility that would allow it to

ship avocados straight to the port of Mombasa. Before the Africado facility was set up, Tanzania's avocado growers used to send their produce to Nairobi for packaging and export, but the journey left a lot of the fruit bruised or spoiled, leading to high losses. The early success of Tanzania's avocado crops has also convinced some banana farmers to try avocados. This sort of investment falls under aid-for-trade, used by nascent industries in developing countries. These schemes have not always been sustainable, but Kenya, South Africa and Tanzania are taking advantage of a global culinary trend to develop their agricultural markets, and the infrastructure needed to grow it. If, by some culinary disaster, avocados fall out of favour, African farmers will be ready to take advantage of the next trendy crop.

PLATEAU STATE - An office for Nigeria's election commission has been burned down just six days before the country is due to vote in a general elec-


The general election is due to be held on Saturday.

mmadu Buhari warned of potential electoral fraud.

"The Economic and Financial Crimes Commission has raised concerns over laundered money being funnelled into vote buying," he said in an editorial published in the Pulse newspaper.

He is running for re-election in Saturday's poll where more than 84 million people are registered to vote. Although there are many presidential candidates, analysts say Buhari's main contender is former Vice-President Atiku Abubakar.

LONDON - Prime Minister Theresa May has rejected the idea of targeting a customs union with the European Union, pouring cold water on hopes from some that she could shift her Brexit policy to win over the opposition Labour Party.

Britain is due to leave the EU on March 29 but has yet to find a deal which is acceptable to both Brussels and lawmakers at home, raising the prospect of a disorderly exit that could damage the world's fifth largest economy.

Brexit has divided Britain at every level from voters to Cabinet, and raised fears internationally that it will weaken the West. Brexit supexit deal in Parliament. Foremost was a demand that May seek a "permanent and comprehensive UKwide customs union"

The EU has urged May to grasp Labour's compromise offer rather than press ahead with her preferred option of getting her own divided party onside by renegotiating a clause in the exit agreement relating to the Northern Irish border.

But May's office published her reply to Corbyn late on Sunday, showing little appetite for a U-turn which would risk splitting her fractious party by ruling out the scope for Britain to strike its own trade deals around the world.

"I am not clear why you believe it would be preferable to seek a say in future EU trade deals rather than the ability to strike our own deal?" May wrote in a three-page letter.

May and her government have repeatedly said membership of a customs union would prevent it having an independent trade policy something they have promoted as one of the main economic benefits of leaving the EU.

Although May welcomed the prospect of future talks with Corbyn to try and find a compromise, the letter gave no ground on their central point of disagreement.

That leaves May battling to persuade a reluctant EU to look again at the Irish backstop - a fallback policy designed to prevent the resurrection of a hard border in Ireland if talks to find a long-term trade arrangement fail. Brexit Minister Stephen Barclay met EU negotiator Michel Barnier yesterday ahead of a crunch moment in Parliament on Thursday, when lawmakers will try to force May to change course or give up control of the exit process. May will promise lawmakers a second opportunity to influence the Brexit talks later in the month in a bid to stave off any rebellion from within her own party by those who fear Britain could end up leaving without a deal.

# 'Withdrawal of US forces in Syria to start in weeks'

WASHINGTON - The United States is likely just weeks away from starting the withdrawal of ground troops from Syria ordered by President Donald Trump, the top US. commander overseeing American forces in the Middle East said on Sunday.

US Army General Joseph Votel, head of the US Central Command, cautioned that the exact timing would depend on the situation in Syria, where US-backed fighters have launched a final assault against Islamic State enclaves near the

The US military has already started withdrawing equipment from Syria. Asked whether the withdrawal of America's more than 2 000 troops would begin in days or weeks, Votel said: "Probably weeks. But again, it will all be driven by the situation on the ground."

"In terms of the withdrawal ... I think we're right on track with where we wanted to be," Votel told reporters traveling with him during a trip to the Middle East.

"Moving people is easier than moving equipment and so what we're trying to do right now is again (to) kind of clear out those materials, that equipment, that we do not need." Reuters

# Algeria's Bouteflika confirms run for 5th term

ALGIERS - Ailing President Abdelaziz Bouteflika declared he will seek a fifth term in April elections in a message published by state media on Sunday, after he was endorsed by his party and the ruling coalition.

The 81-year-old head of state uses a wheelchair and has rarely been seen in public since suffering a stroke in 2013.

"Of course, I am no longer the same physical force as before -- something that I have never hidden from the people," said Bouteflika, according to the APS news agency, as he apparently broke his silence on his intentions for the April 18 poll. "But the unwavering desire to serve... has never left me and it allows me to transcend the constraints linked to health troubles which everyone may one day face," the president reportedly added. Known for wearing a three-piece suit even in the stifling heat, Bouteflika gained respect from many for his role in ending Algeria's decade-long civil war, which official figures say killed nearly 200 000 people.AFP

## Ramaphosa to chair AU in 2020

ADDIS ABABA - President Cyril Ramaphosa has been announced as chairperson of the African Union for 2020, taking over from Egyptian President Abdel Fattah el-Sisi.

The announcement was made on Sunday at the 32nd Ordinary Session of the Assembly of the Heads of State and Government in Addis Ababa, Ethiopia.

The session was held over two days under the theme 'The year of refugees, returnees, and international displaced persons - towards durable solutions to forced displacement in Africa'.

"It presents an invaluable opportunity to reflect on and address the root causes of forced displacement in Africa," the presidency said. IOL

# ANC FAILED TO DO BASIC THINGS - MOTSOENENG

RUSTENBURG - The African National Congress has failed to do "basic things" African Content Movement leader Hlaudi Motsoeneng said on Sunday.

"The ANC is an Old Testament. They failed to provide title deeds and now they are talking of lands. How can you be able to provide land when you failed to provide title deeds? Within six months, the ACM will provide title deeds and double old age pension grants," Motsoeneng told supporters in Boitekong near Rustenburg.

He also promised pensioners free water and electricity. He was in Rustenburg to drum up support for his new party ahead of the May 8 general elections. The former SABC COO said he was the only person "tested" on service delivery.

He promised that under an ACM-led government the minibus taxi industry would get subsidies because they transported poor people. "Those using Gautrain and planes have money. Why do we have to subsidise them? The taxi industry transports poor people, they must get subsidy. In our government, taxis will not pay etolls. In fact we are going to scrap the e-

tolls," he said to rousing applause.

He also promised to create jobs, adding that the ANC failed to provide free education. "There is no free education. Students countrywide cannot get accommodation and they cannot get their results because of outstanding debts. Where is free education?" he asked.

Despite the ANC holding an event a few metres away from Motsoeneng's meeting, the event went off peacefully. Some people went to the ACM rally to get free purple party T-shirts, then went to the ANC event and took off the ACM T-shirt, exchanging them for ANC T-shirts.


The party has been vocal about its intentions to abolish the programme once it comes into power.

In 2018, the DA tried to clarify its position on Broad-Based Black Economic Empowerment.

It said its economic policy will focus on empowering black people, but it will rely less on race as criteria.

Earlier in 2018, the party leaders made public their disagreement on the policy, with some claiming that it was ditched.

The party said it unreservedly supports the goal of economically empowering black South Africans who are currently left out of the economy.

The DA said that no policy can negate that race still remains a proxy for disadvantaged South Africans.

Following public disagreements on the party's stance on the empowerment policy, the party said that all party leaders should rally behind the decision.

The DA said that as it builds one South Africa for all, they will rely less on race as the inequality gap closes in the country.

- TopGen Energy partner, Mike Jines, is seen holding gun over two dead elephants
- The hunt took place in October 2018 and photos were shared online in January
- Social media users have called the photos 'horrible', 'sad' and 'sickening'
- Some have threatened Jines and others have called for boycott of his company
- Jines is now claiming that the two elephants were shot dead in self-defence

LONDON - A Georgia businessman, who was pictured holding a gun as he and another man stood over two dead elephants, claims he killed the animals in self-defence when they charged at him.

Mike Jines, a partner with TopGen Energy in Alpharetta, Georgia, made the claim after the photo went viral on social media and critics started targeting his business.

Thousands of social media users have accused Jines and professional hunter, Max 'Buzz' Delezenne, of killing two baby elephants on an African 'trophy' hunt in Zimbabwe.

The hunt occurred in October 2018, but the images weren't shared on social media until last month.

Darrel Eisman shared the photos in a Facebook post, which has more than 56 000 shares.

"Apologies for the disturbing photo," Eisman wrote. "If you're really upset by what you see, than make this go viral along with an email letting Mike Jines know what you think," Eisman added.

He also included Jines' email address in the post.

Thousands commented on the post calling the photos 'horrible', 'sad' and 'sickening'.


"It utterly breaks my heart to see such cruelty going on those scumbags who killed this poor innocent creature should be punished, hunters should be banned as a lot of animals in Africa are now on the verge of extinction how tragic," one Facebook user wrote.


"You have no heart, no soul. This is sickening and pathetic. It's just so sad to see this," another angry Twitter user wrote.

Another tweeted: "There's evil, and then there's you #mikejines one can only hope the universe and all that is just punish you for killing those elephants. Boycott #TopGenEnergy."

Since the photos emerged, Jines says he's focused on "making sure people understand the actual facts as opposed to the mischaracterisation of the information on social media".

Piracy

Information gathered by this publication two weeks ago states that any person guilty of music piracy will be liable to a fine not exceeding E 20 000 or to imprisonment not exceeding three years, or both, depending on the offence. This is the Copyright Act of 1912.

It states that a person cannot tamper with work without the authority of the owner of the copyright. Any person who causes a literally or musical work to be performed in the public, or any person who causes a broadcast to be re-broadcast (knowing that the copyrights subsists in the work and the performance) shall be found guilty

However, the Copy Right, Neighbouring Act 2 which was enacted by His Majesty King Mswati III and the Parliament of The Kingdom of Eswatini in March 2018 - to repeal and replace the Copyright Act of 1912 is still not operational. If this act was operational, the culprits would have to pay a total amount of E25 000.

The new Act works eligible for copyright include musical works, artistic works, audio visual works, sound recordings, broadcasts etc. Matters like ideas, concepts, discoveries, news, and speeches will not be eligible for copyright.

It states that ownership of any copyright shall vest in the author of the work or the person under whose direction the work was created. Where a person commissions a photograph, portrait, sound recording, graphic work and pays for it, the commissioner will own the copyright of work done. It states clearly that copyrights may be transmitted and an owner of the copyright may assign his or her economic rights to any other person or country, whether in full or partly.

# UEFA CHAMPIONS

Di Maria with point to prove

PARIS - An expensive flop who lasted just a single season at Manchester United, Angel Di Maria might be keen to prove a point when he goes back to Old Trafford as a Paris Saint-Germain player tonight.

The Argentine, who turns 31 later this week, has a vital role to play for PSG in their crunch Champions League last 16, first leg against a resurgent United with Neymar and Edinson Cavani out injured.

Those absences will place even more of an onus on Di Maria to show why PSG were prepared to make him their superstar signing in the summer of 2015, two years before Neymar and Kylian Mbappe arrived in the French capital.

The former Benfica and Real Madrid man cost United a British record transfer fee of just under £60 million (almost 75 million euros at the time) in 2014, but he was an unmitigated failure in England.

Di Maria scored only three times in 27 Premier League appearances in 2014-15 for a United side who finished fourth, a long way behind champions Chelsea.

His time in England was also marred by an attempted burglary on his family's home outside Manchester that reportedly left his wife and daughter terrified, and keen to get away.

His manager that year, Louis van Gaal, had hailed Di Maria as "world class" on his arrival, but their relationship quickly turned sour, with the player blaming the Dutchman for playing him out of position.

"I only stayed one year. It wasn't the best period of my career, or they didn't let me have my best time there," Di Maria said in a recent interview with radio station France Bleu.

"There were problems with the coach at the time. But thanks to God, I was able to come to PSG and be myself again."

United made a loss when they sold Di Maria for €63 million, but it was very much PSG's gain.

Spain for his slender frame, Di Maria is in his fourth season in Paris and recently extended his contract to 2021.

He has scored or created more than 70 goals in Ligue 1 for PSG, although he was signed chiefly to win big Champions League games and has been unable to prevent his side being knocked out in the last 16 in each of the last two seasons.

Nevertheless, if Di Maria's days in Paris seemed numbered after Neymar and Mbappe signed in mega-bucks deals at the start of last season, he ended up being one of his team's most consistent performers in the last campaign. *SuperSport* 

POGBA LEADS WAY
While Jose Mourinho butted heads with and routinely dropped Paul Pogba, Solskjaer has built his side around the French World Cup

winner, with stunning results.

Pogba has scored eight goals and provided five assists in his past 10 games. "Before the coach arrived I was in the shadows, on the bench, and I accepted that," said Pogba. "It is a pleasure to play again. Now I am always smiling."

#### RASHFORD REBORN

The fact Marcus Rashford was rested at Fulham to keep him fresh for PSG, while Romelu Lukaku was handed a rare start says a lot for the change in his fortunes under Solskjaer. The 21-year-old was never trusted with a consistent run of games as a central striker under Mourinho. In United's last European home game against Young Boys, the Portuguese

coach did not hide his disgust when he missed an early chance.

No longer fearing the consequences of a missed opportunity, Rashford has scored six goals in eight starts

since the change in management and finally looks set to deliver on his abundant potential.



Solskjaer outlined his first task as putting smiles back on the players' faces but the feel-good factor has galvanised the fans just as much as his squad. Once a European fortress, United's three home games in the group stages produced just one goal and Sevilla also secured a rare away win in the Champions League to dump United out at this stage last season. The decibel level has risen since Solskjaer's arrival, even for humble opposition in Huddersfield, Boumemouth, Reading, Brighton and Burnley.

#### LINDELOF LIKE A NEW SIGNING

Mourinho spent most of his final season complaining that he had not been furnished with the experienced centre-back he demanded in preseason, while chopping and changing his defence. Solskjaer has put his faith in Victor Lindelof, who started the first 10 games under the new boss before being left out of Saturday's 3-0 win at Fulham to rest for tonight's challenge.

# Buffon sends warning to team-mates

PARIS - Gianlugi Buffon has told his PSG team-mates that they need to improve in every area if they are to take anything from tonight's game with Manchester United.

The French giants, who go into the first leg of their last-16 Champions League clash on the back of three unconvincing results, will face a United side in fine form.

Ole Gunnar Solskjaer has won 10 of his 11 games in charge since taking charge and Buffon admits PSG must up their game to avoid defeat at Old Trafford.

Speaking after an Edinson Cavani penalty earned Thomas Tuchel's men a 1-0 win over Bordeaux on Saturday, Buffon said: "I appreciated the victory but I did not like the match.

"We have to improve mentally and in our attitude, to have more of a spirit of sacrifice for the team."

PSG will be without Cavani, who picked up a thigh injury at the weekend, and star man Neymar, who is suffering with a foot problem.

PARIS - Paris Saint-Germain midfielder Marco Verratti could make a return to face Manchester United in the Champions League after returning to training with the French club.

PSG coach Thomas Tuchel revealed on Friday that Verratti had trained with the rest of the squad and is set to start against Bordeaux on Saturday at the Parc des Princes.

The Italian midfielder had been rated a serious doubt to face United in tonight's Champions League clash at Old Trafford after suffering an ankle injury in January.

The news of Verratti's comeback will come as a welcome boost to the French side who are already without star player Neymar, who will miss both legs of the tie against United after fracturing his metatarsal.





# 'Solskjaer to be named full-time United boss'

MANCHESTER - Manchester United's board have reportedly made the decision to name Ole Gunnar Solskjaer as the club's fulltime manager.

According to The Sun, the decision has been made at board level but may not announce it until the end of the

Co-chairman Avram Glazer spoke with Solskjaer after United's 3-0 win over Fulham, and is said to be convinced alongside fellow co-chairman Joel Glazer.

Tottenham Manager Mauricio Pochettino had been United's main

Aguero was substituted to a standing ovation before Sterling added City's sixth, his place in the history books already assured.

As well as being level with Shearer for hat-tricks, Aguero is ahead of Premier League greats Robbie

Fowler (nine), Thierry Henry, Harry Kane, Michael Owen (all eight and Wayne Rooney (seven).

The win took Manchester City back to the top of the Premier League table while putting Aguero joint-top of the scoring charts with Liverpool's Mohamed Salah on 17.

CAPE TOWN - Benni McCarthy admitted it was not his team's night on Saturday as a dominant Cape Town City lost 1-0 to AmaZulu at King Zwelithini Stadium.

After a game the Citizens dominated for almost the entire 90 minutes, McCarthy's side left empty-handed as they failed to find a way past Usuthu.

"If you don't score they punish you, we created chances and dominated the game but we failed to win, the loss feels like a sucker punch." McCarthy said after the match.

"I always hear people saying football can kill you. For the first time I felt like that, we didn't deserve a loss but that's football for you."

The former Orlando Pirates striker gave credit to Cavin Johnson's side for snatching a win with a cracking free-kick by Tapelo Nyongo.

"We must give them credit for the win, they managed to walk away with a win in a tough situation as they were under pressure almost the whole game," he added.

McCarthy also felt his side lacked aggression in terms of punishing their opponents in front of goal.

"We need to be aggressive. I'm not talking about playing rough and kicking our opponents, I'm talking about goals, punish them, we should win such games," he explained.

On whether the loss had an impact on their league target for the season, McCarthy said their only focus is on improving as a team.

# Middendorp rules roost at Chiefs

JOHANNESBURG-Kaizer Chiefs coach Ernst Middendorp has revealed his stance in omitting certain players from the lineup and has said that no one at the club has a contract that guarantees a starting berth.

One notable omission from Chiefs' starting line-up in Saturday's Soweto Derby stalemate with Orlando Pirates was Zimbabwean midfield enforcer Willard Katsande.

The 32-year-old was later brought on as a substitute, which has since drawn criticism of the German tactician, though he has explained why he left the veteran out in the first place. "I don't understand this issue. We left Khama Billiat on the bench against AmaZulu. We left Katsande on the bench [against Pirates]. I don't know, maybe next is Leonardo [Castro]," explained Middendorp.

"I want to make sure this is regular and it's normal. Where is it written? I don't think there's a contract written that says a player has a guarantee to start – I don't think so.

"I think you saw in the first half, there were three tactical moments where it looked like we had done something right without Katsande. We got something right against AmaZulu, without Billiat.

"Let's really understand this, there's no guarantee for anybody [to start]. It's about performance and really going into [each match].

"I've said it before, all players are equal, but some are more equal.

And in the moment, who is more equal is a decision of the technical team during the week in preparation for the match."

# 'Chiefs were unconventional'

JOHANNESBURG - Orlando Pirates head coach Milutin Sredojevic says they tried their best to beat rivals Kaizer Chiefs in a PSL clash on Saturday afternoon.

Despite their failure to secure a win and close the gap on log leaders, Bidvest Wits, the Bucs gaffer believes that they still have so many games to fight for the PSL title.

"We tried our best, just as Chiefs did. We pulled off this draw. There may be regrets, but it's not about what you deserve, but what you get," said Sredojevic to the media.

Pirates are four points behind Wits, but the former have one game in hand as the race for the PSL title intensifies.

"There are a lot of matches to go. It wasn't an ordinary match. It was end to end. We wanted an extraordinary performance against a top class team," he added.


"We put ourselves in a better offensive shape in the second half," concluded the coach. *Goal*

and Libya – in the shock goalless first leg played in Durban last year.


"If there is a player that has a hot vein of form going into it, I think







"I've been invited to come play that side and of course I'm happy and looking forward to come and play in Swaziland (Eswatini)," he said.



"The main objective of game is to encourage youth to take part in sports. We are discouraging them against alcohol abuse and promoting education," he said.


Fakudze further stated they would soon release the list of all the internationals to take part in the tournament.


