ESWATINI, UK SIGN MULTI-BILLION TRADE PREFERENTIAL AGREEMENT

THE United Kingdom's government has agreed to trade continuity with six African countries on Tuesday.

The British High Commissioner John Lindfield said UK initialed an Economic Partnership Agreement (EPA) with the Southern African Customs Union and Mozambique (SACU+M) that will allow businesses to keep trading freely

This marked the end of formal trade discussions and the UK-SACU+M Economic Partnership Agreement will be subject to final checks before it is formally signed.

The agreement will allow businesses to continue to trade on preferential terms with Eswatini, the Republic of South Africa, Botswana, Lesotho, Namibia and Mozambique. It also supports the economic development of these Commonwealth partners, laying the foundations for new trade and investment in the future.

"This will help to strengthen further the trading relationship between the UK and SACU+M nations, which was worth E136 billion (£9.7 billion) last year," he said.

Lindfield said the SACU+M nations were an important market for UK exports of machinery and mechanical appliances worth E 5.7 billion (£409 million), motor vehicles worth E 4.7 billion (£335 million) and beverages including whisky worth E1.9 billion (£136 million) last

To increase economies and create jobs

INTERNATIONAL Trade Secretary Liz Truss said once signed the trade agreement will take effect allowing businesses to keep trading after Brexit without any additional barriers.

It will also benefit British businesses supporting developing countries in reducing poverty through trade.

They will be able to grow their economies, create jobs and increase incomes for their cit-

"This is a major milestone as the UK prepares to become an independent trading nation once again and we are helping businesses get ready to trade with the most exciting markets around the world," she said.

Meanwhile the UK High Commissioner to Botswana Katy Ransome said the agreement in principle demonstrated their commitment

Consumers and businesses in the UK will continue to benefit from more choice and lower prices on goods imported from SACU+M countries. Major imports to the UK from these countries last year included edible fruit and nuts valued at E8 billion (£547 million) and motor vehito increasing trade with developing countries and boosting economies across Southern Africa and the UK.

"This new agreement, once it is signed and takes effect, ensures continuity in our E136 billion trading relationship, allowing our businesses to continue supporting our mutual prosperity and economic development, she said.

Global Director of Government Affairs for Diageo PLC Wilson Del Sorocco added that his country warmly welcomed the news of a UK-Southern African Customs Union and Mozambique agreement in principle because international trade was vital to Diageo as it gave the opportunity to reach more consumers and markets around the world.

"Africa is an important growth region for Diageo, including export markets like South Africa for Scotch whisky," he said

Deal secures UK, SACU+M relations beyond Brexit

COMMERCE Industry and Trade Minister Mangoba Khumalo has said this initialed agreement with UK secures the country's trade preferential market beyond Brexit, which is scheduled to take place at the end of next month.

In a statement issued by all the SACU+M countries, the ministers confirmed the initialing of the multi-billion pounds trade agreement.

This agreement followed the decision of the UK in 2016 to leave the European Union (EU), the Southern African Customs Union (SACU), Mozambique and the United Kingdom (UK) ministers agreed to roll-over the Economic Partnership Agreement between the European Union (EU) and the SADC EPA States (EU-SADC EPA) into a new Agreement.

The roll-over was on the understanding that adjustments may be needed to address specific matters. This agreement was reached on Tuesday in Botswana, where these countries initialed the text of the new agreement.

The initialled agreement will now be presented for approval in each country to facilitate signature and subsequent ratification according to the domestic processes of each country.

"The agreement will enter into force upon the completion of these aforementioned processes. However, pending ratification, the parties agreed to develop a non-binding Memorandum of Understanding which would be used as the basis to provisionally apply the effects of the EU-SADC EPA until the domestic ratification processes in each country have been completed," statement read.

Dlamini said he was happy with his achievements and he would be able to make use of the vehicles to help his people at Mtfongwaneni.

He said he wanted to buy himself a water tanker so that he could make clean water available at Mtfongwaneni con-

He said water was a huge challenge at Mtfongwaneni, so a tanker would work very well for him because it would be easy to bring clean water nearer to the people. He said the water was scarce

such that even animals had a challenge when they wanted to drink. He said with the tanker, he could fetch the water from as far as the Hhohho region.

Other notable politicians who were spotted at the auction included Ludzeludze MP Vusi Swali and former Lugongolweni MP Joseph Souza. He got himself a sec-

They also wanted to get some vehicles for themselves so that they could be able to do their work in their respec-

A total of 215 vehicles were lined up for sale during the auction in Mbabane and Matsapha. The vehicles sold included vans, sedans, quantums and other yellow vehicles for civil works, which were in Matsapha.

People were able to buy cars like Ford Rangers for a price range of about E50 000 to about E78 000. Some people were able to get motor bikes for prices as low as E600. The auction started from 9am in Mbabane.

SIGN OR GET EXPELLED, UNESWA TO STUDENTS

...promises to deal with hooligans who vandalised university property

STUDENTS who will fail to sign the re-admission form will not be regarded as part and parcel of the university.

This was declared by the University of Eswatini (UNESWA) Registrar Dr Salebona Simelane during a press conference held at the UNESWA Kwaluseni premises yesterday.

This strong warning follows a decision by the university Senate to re-open the institution with classes expected to resume today.

By signing the re-admission forms, students commit by undertaking that they will not embark on class boycotts/toy-toying, acts of vandalism, theft of property and intimidation of staff and students in the future.

The form further mentions that no student body meetings should be held at night anymore.

When Dr Simelane was asked what would happen to the students if they do not comply with the Senate restriction, he mentioned that they would automatically be expelled from the institution. He said students were only given till tomorrow to sign the forms.

"To those who won't sign the re-admission forms, it will be a direct indicator that they are planning to continue with the protest and vandalising of the university property," he said.

Dr Simelane said that Senate was looking to put together a disciplinary committee that would look into students that act unlawfully within the university.

When Dr Simelane was asked of what would happen if the students would all

stand a united front and start another protest based on the re-admission forms, he mentioned that the Senate was hoping the students would co-operate with them in order for them to have smooth operations.

He further highlighted that they were in the process of fixing the properties that were vandalised, but added that some of the things that were destroyed were extremely expensive and the university does not have enough resources to fix them all at once.

"Other things that were broken will be fixed as we go along," he added.

Dr Simelane stated that the university was not yet done with students that were involved in the acts of hooliganism which resulted in the property being damaged. He stated that the students are all known by name.

He continued to mention that they

will undergo a disciplinary process and they will all pay for their actions according to the measure of their contribution to the acts of violence.

When asked if the form meant that students would not boycott now or in the future, he mentioned that the form was merely for the current situation, but were looking to using it even in the

He was again asked on the issue of allowances, which seemed to have caused the previous protest, as to what they will do if they reject the new offer, Dr. Simelane stated that the issue of allowances was between the students and the ministry of labour social security.

He said Senate was grateful to the way the government handled the matter, and advised that students should have a proper manner of addressing government in the future.

Widow wins her farm from in-laws

IN what might come as an inspiration to other widows, a widow was relieved after the Supreme Court declared her as the rightful owner of her late husband's

The farm in question is said to be situated somewhere around Siphofaneni and in terms of size, it is said to be about 900 000 hectares.

Effie Sonia Henwood is said to have bought the farm from her husband, Israel Henwood, who died about 30 years ago.

It is said that the problem was that Sonia's in-laws, who are also Henwoods, challenged the sale of the farm by the late Israel to Sonia.

Israel was a husband to Sonia and her argument in court was that Israel had sold the farm to her before he

This did not sit down well with Sonia's in-laws and they approached the High Court in 2001 to challenge the sale of the property by Israel to

It was Pius Henwood who approached the High Court on behalf of the in-laws. He was successful in challenging the sale of the farm. Pius was the applicant in this case, while Sonia and the late Israel were the first and second respondents, respectively.

Sonia was not pleased with the High Court judgment and she instituted an appeal at the Supreme Court. According to the judgment, it was not clear when the case was heard by the Supreme Court.

At the end, the Supreme Court

ruled in favour of Pius, which means the court dismissed Sonia's appeal.

The reason for such a judgment was that the Supreme Court had found that the Deed of Sale did not comply with the provisions of Section 31 of the Transfer Duty Act of 1902.

The judgment of the Supreme Court did not stop Sonia from instituting proceedings to have the matter reviewed by the Supreme Court.

The Supreme Court, on November 30, 2018, ruled in favour of Sonia and Israel and set aside both previous judgments from the High Court and the Supreme Court.

However, Pius was not satisfied with the outcome of the review of the Supreme Court and launched a second review, relying on Section 148 (2) of the Constitution.

At the end, the second review was not heard because Pius could not convince the Supreme Court on why the second review was supposed to be heard.

Sonia and Israel in this case were represented by Sibusiso B. Shongwe and Associates, while Pius was represented by Howe Masuku Nsibande Attorneys.

Mpofu has been the General Manager for MVtel since 2003, a company which was owned by the late businessman and Mbabane Swallows boss Victor 'Maradona' Gamedze.

Takawira has been involved in many projects which include E-Top-up and Top-Lotto during his time with MVtel.

Takawira, who was a qualified engineer, was also involved in the construction of Madlenya House which houses Eswatini Mobile, where he was a site acquisition.

Princess Lungile, who took over from her late husband (Gamedze) said they were saddened by the demise of Takawira and were still shocked since they got the news of his death.

She said she had known the deceased to be her husband's right hand man and was responsible for all of Gamedze's projects including Eswatini Mobile.

She went on to say that Takawira had

contributed immensely to the growth and success of most of Victor Gamedze's companies, including MVtel and Eswatini Mobile among others.

"We feel like he has followed Gamedze very soon as he was the person who spoke on behalf of all the companies during Gamedze's memorial service at the Prince of Wales last year," she said.

In addition, Princess Lungile lamented the fact that Takawira was a person who had vast experience and was one of the few people who knew how to run the business.

She mentioned that this was a great loss, as it would be hard to find someone who can replace him given all the qualities he possessed.

"All the achievements that Gamedze had were attributed to him as he was always available to help and providing his expertise whenever he was needed. He was a man of integrity and honesty and we will always miss his great leadership skills and hardworking spirit," she said.

Gamedze then passed her sincere condolences to Takawira's family, saying that they should seek the Lord's guidance during this difficult time in their

Meanwhile, his memorial service will be held at Mananga Centre, Ezulwini tomorrow at 2:30pm and a celebration of his life later in the evening at the Mbabane Theatre Club.

City Council rocked by another motion on Mhlongo

THE Municipal Council of Mbabane has been rocked by another motion moved by councillors who want underfire CEO Gideon Mhlongo to appoint an Adhoc Committee to investigate the issue of three cows that are said to have been bought by the council and were to be presented to the country's authorities.

This was revealed by one of the councillors, who said means of getting the CEO to take action pertaining this matter has been met with fire as Mhlongo is said to have threatened the councillors with Section 27.

This sections states that, if there are councillors who want to cause maladministration the CEO should report those to the Council and then to the minister of housing and urban development.

The councillors said what is far worse is that the very same person who is threatening them with section 27 is not even part of the council, as they insist that he ...councillors allegedly threatened with Section 27

does not have a contract.

"Mhlongo is the one who is causing the maladministration as he does not have a contract and it surprises us that how on earth can someone threaten his employers because we are the ones who are Mhlongo's employers," said the councillor. The councillors argue that they just want simple information, but Mhlongo is busy threatening them for no reason as this is an issue of concern.

The three cows that are said to be kept at Ngwenya Town Board pound have been kept for a year now, attracting a bill that is close to E200 000 in one year. However, it is said an arrangement was made with Ngwenya Town Board not to pay for keeping them.

These cows were purchased last year in or around August 6.

It also transpired that even the council does not know the cattle, but the only people who have clear knowledge are the CEO and the Internal and Public Relations Officer Lucky Tsabedze. They are said to have gone to Ludzidzini on

numerous occasions to present the cows but returned with them.

Mhlongo is alleged to have threatened to impose or apply section 27 after the councillors asked that since the matter is of paramount importance and urgency it should be addressed as such because it cannot wait for the ordinary council

"We request that a notice be issued in terms of Clause 12.1 (ii) of the council rules of Procedure for a special meeting to be held on 11 September 2019 at 17:30 or on a date to be determined by the Chief Executive Officer," the councillors said in a letter.

In a letter from the CEO to Musa Dlamini, who is Ward 2 councillor, the CEO states that there was a serious omission on the meeting form as the approved form needs councillors requesting a special meeting to advise council if they had been advised by management whether or not the matter justifies the convening of a special meeting.

"For the above reason, the meeting


cannot be called as it would mean the office having to escalate the matter to prepare a section 27 report, which we believe is not necessary as the issue can be quickly corrected," reads part of Mhlongo's let-

Mhlongo's contract case, which has been a thorny issue among ratepayers, zone leaders and street vendors is expected in the Supreme Court today.

Mhlongo did not answer his phone when contacted last night and he did not reply to text messages sent to him. Council IPRO Lucky Tsabedze said he did not know anything about the matter. He asked that the documents in question be sent Gideon Mhlongo.

FAMILY members were stunned when they caught a pensioner red-handed allegedly raping his two-year-old granddaughter.

The incident happened at Sidvokodvo in Luve on Tuesday afternoon. Information gathered was that the elderly man, who is estimated to be around 70 years old, had come to the toddler's mother;

his daughter-in-law, to ask for the baby whom he said he wanted to-play with.

When he did this, the encounter is said to have been witnessed by other family members who were relaxing in the compound.

After he took the child from its mother, the elderly man is said elderly man would get to have gone to his house. A few minutes later, sources said the baby's ear-piercing screams sent was all in vain. the mother running towards her father-in-law's house. Upon arrival

at the entrance, the young mother is said to have been dumbfounded when she allegedly saw the elderly man on top of her daughter who lay on the floor facing up.

When she tried ordering her father-in-law to get off her child, it is said her shouts fell on deaf ears

as the man did not move an inch and the child

The shocked mother kept on shouting with the hope that the elderly man would get off her child, but it was all in vain. The situation was helped by that she ended up calling for her mother-inlaw who was also within the premises but far away from where the incident happened," the

While the rest of the family members, including the grandmother, were on their way towards

the house, it is said it was only then that the pensioner moved away from the toddler.

When the rest of the family eventually arrived at the scene, it is said he was found trying to dress up. The police were called to the scene shortly after the inci-

When sought for comment, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the Mliba police

had received the report on the incident.

However, when the child was taken to hospital on the same night, Vilakati said the medical report stated that there were no signs of penetration. No arrest was made by the time that the police mouthpiece was contacted.

Girl (5) killed by car on first day of third term

THE first day of third term saw a five-yearold pre-school going child killed in a car acci-

The young girl of Bhejisa area in Sihlutse was knocked down by a VW Polo driven by a 41year- old man of Our Lady of Sorrows.

The accident took place at 6:55am hours at Bhejisa along MR 11 public. It is reported that the car lost control and knocked the girl.

She suffered serious injuries all over the body and was certified dead upon arrival at Matsanjeni Health Centre while the driver was not injured.

Chief police information and Communications Officer Superintendent Phindile Vilakati confirmed the accident.

She pleaded with parents to accompany young children to school while also urging drivers to be careful as they use the road, more especially in places where there are schools closer to the road. The accident comes after the publication yesterday reported that five minors were involved in an accident whereby a white Toyota Noah SUV collided with a purple Honda Fit sedan at the corner of Somhlolo-Gwamile street traffic lights in Mbabane on Tuesday.

Information gathered was to the effect that when

the collision happened, the vehicle which was transporting the minors was coming from the direction of Mdzimba Avenue to join Gwamile Street and the Honda Fit was driving on Gwamile Street to join Somhlolo Road. Meanwhile, the Road Safety Council has sent a stern warning to drivers transporting pupils to schools.

The first day of the last term of the year saw an increase visibility of traffic police officers as well as road safety officers on the country's roads.

Road Safety Education and Information Officer Thembani Dlamini pleaded with Emaswati to be vigilant as they use the roads. She said people should not think of themselves as they use the road but be observant for the next person.

Firstly, she pleaded with kombi drivers to avoid overloading. She urged drivers to stick to legal speed limits. Dlamini said most accidents are caused by over-speeding which results to rivers losing control of their vehicles.

She said it is even worse when the vehicle is loaded beyond its capacity. She added that sticking to speed limits will reduce the number of pedestrians who are hit by motor vehicles as drivers will be able apply brakes on time.

She further pleaded with road users at large to keep a sharp eye on children as they are fresh from the holidays. To ensure road safety the officer said they have a series of programmes in place they will present to the nation soon.

Financial institutions to join ESRIC strike Monday

FINANCIAL institutions have promised to join the ongoing strike at ESRIC on Monday as a sign of solidarity.

The Eswatini Royal Insurance Corporation (ESRIC) strike has entered into a third week and the workers are not backing down until their grievances are met.

The new development means all the financial institutions in the country might ground operations in the financial institutions, including banks. This was revealed by the Secretary General of Swaziland Union of Financial Institutions and Allied Workers (SUFIAW) Jabu Shiba yesterday during the ongoing strike by ESRIC employees. Shiba mentioned that operations from most of the financial institutions including banks are going to be heavily affected due to the strike as this would now be a collective course.

The striking workers are represented by SUFI-AW and the workers are still determined to get the attention of the employer.

Shiba said the employer so far had not shown any interest in the matter.

"We will focus on the protesting as it is the only thing we have at our disposal and another thing is that it will depend on the employer's willingness to engage," she said.

She also mentioned that as a Union they do not have processes that will force the employer to engage. She continued to say that they usually try to engage the employer in different occasions but so far that has not yielded any fruits.

'So far, we have seen that the employer is not willing to meet us and negotiate our grievances and as a union we are going to continue picketing until we are heard," Shiba added.

On the issue of the no work no pay, Shiba said that would not be a hindrance to them as they would continue striking with or without that rule. She said as time goes by the whole of SUFIAW would join the strike as the dispute between ESRIC and SUFIAW

The strike action which started on August 27 has seen the corporation complaining that they had suffered in millions of Emalangeni in delayed

The employer had at first complained that the picketing workers were disturbing operations as they picketed at the entrance of the company's premises and that led to a disagreement on the designated area to be used by the picketing employees, which led the company taking the workers

Employees however argued that they did not in any way threaten anyone or intimidate anyone. They said their protest was not a violent one.

In these events they will be unpacking the


theme and the career opportunities that the country has to offer the youth through tourism.

ities in attraction sites and weekend stays. Representatives from the industry were present during the draw including the minister of tourism and environmental affairs.





AN electrical fault at the Municipal Council of Mbabane triggered a major emergency response yesterday morning, with services grinding to a halt.

Police and firefighters from Mbabane responded swiftly after receiving a call at around 10:30am, reporting smoke being emitted from a broken fluorescent tube within one of the council's offices.

An issue with the lighting system had caused smoke, while business was ongoing within the city council buildings.

The fault announced itself by emitting smoke, which billowed upwards and set off the smoke sensors and the fire alarm system.

Staff and customers who had come for various services had to be evacuated, and the offices were shut down

temporarily as fire personnel tried to locate the source of the smoke.

Evacuated

According to Information and Public Relations Officer Lucky Tsabedze, over 50 people responded to the alarm and swiftly evacuated the building, after word was sent around about a possible fire breaking out.

The incident also attracted several onlookers who came to observe the operation.

"There was smoke coming out from

conducted.

"We have also appointed a certain number of employees trained as fire marshals, if there is a fire. The fire marshals assist staff and our customers in ensuring swift and organised evacuations from the building.

"We are also fortunate that our state-of-theart smoke detectors were able to detect the fault, and we were able to attend to the fault in a timely fashion," Tsabedze stated.

He indicated that they had launched a full investigation, in collaboration with the police and the National Fire and Emergency Services. Tsabedze also thanked the various role players who worked tirelessly to ensure everyone in the building was safe.

One of the Mbabane City Council employees admitted that when he heard the alarm ring, his initial reaction was fear.

'In a situation like this, the first reaction is always fear and panic, so when this happened, we had to adhere to all instructions from our designated fire marshals. Fortunately, it was a small fault, and no one was hurt," he expressed.





Four suspects arrested after consulting inyanga for juju

THE consultation at an *inyanga* did not protect four men from being arrested.

The four men who were suspected to have plotted to rob a certain business in Manzini were arrested in Mahlanya last Wednesday.

Information sourced from reliable sources was to the effect that the six men, including a South African, had gone to an unidentified *inyanga* for assistance pertaining to a robbery they wanted to undertake in Manzini.

Sources alleged that on the day of arrest, the six men had gone to the *inyanga* to ask for his help in making sure that they neither get caught nor arrested while they robbed the business which they allegedly mentioned to the *inyanga*. The traditional healer is said to have instructed the dozen men to go and buy some razor blades with which he would cut them (*kugata*).

Indeed, thinking that they would eventually be assisted in pursuing their devious deeds, the men are said to have left for the shop. However, it seemed that the *inyanga* was not the only person who knew about the robbery plan as after the men had returned with the razor blades, and they had been cut and given *muti* that would supposedly protect them from being caught, they came face to face with the police who were waiting for them outside the *inyanga*'s compound.

Cuts

Sources alleged that the men travelled in two vehicles, and all had razor cuts on their heads and a black substance believed to have been the *muti* they were given by the *inyanga*.

When they saw the police, the men are said to have run helter-skelter using their supposed getaway cars.

The police are said to have managed to apprehend only four of them.

These are also said to have been found in possession of an unlicensed firearm with one round of ammunition.

On Sunday; four days later, another group of four men; suspected to be part of the arrested group, is said to have struck in Malkerns where they robbed

a shop belonging to an Asian national and made away with E4 000 cash.

The robbery took place at around 6pm and members of the public were stunned when they heard gunshots between the police and the four suspects.

Car

This time, the four men are said not to have had a getaway car as after the police got hot on their heels, they tried to forcefully board public transport that was full with passengers in a bid to evade arrest. They are said to have succeeded in running away from the law as none of them was arrested.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the two incidents.

In the recent one, Vilakati said a CCTV footage from the shop assisted in identifying the four suspects on the run. However, she could not state whether or not these were connected with the four that were arrested last week.

Vilakati said the police were still investigating the incident together with other robberies that had taken place around Mahlanya

'Help us find dead

THE police have urged members of the public to assist in locating family and relatives of the man who was found dead at Sidvokodvo in Luve on Tuesday morning.

A motorist, Thulani Mabuza of Luve discovered the unidentified man's body while on his way to

When interviewed, Mabuza said he was with another person when the discovery was made.

they noticed the motionless figure lying near a small bush by the roadside, Mabuza said they just suspected that he might be dead. This, according to Mabuza, was more so because the figure lay facing up with his arms strain on his sides

Out of curiosity, Mabuza said he stopped the car and he, along with his companion, went closer to where the body lay and their suspicion was confirmed. More shocking is said to be that the man had a greenish rone tied around his neck.

ish rope tied around his neck.

The witness added that the man's whole body was swollen, which he said might have been a result of

internal bleeding.

Also, Mabuza said there were no visible bruises on his body but there was some blood dripping out of his

"The photographic memory of what I saw in the morning vividly remains in my mind. My day was spoilt," Mabuza said in a sombre mood.

The deceased man is estimated to be between the ages 30 to 32. He is said to be dark in complexion with short black hair.

He wore a pink T-shirt and blue jeans with elastic ankles. His blue Uzzie cap and flip flops are said to have been placed on his side. No identification documents are said to have been found on the body when searched by the police.

Govt working on Biosafety Bill to introduce GMOs


GOVERNMENT is currently working on the Biosafety Bill which seeks to introduce the Genetically Modified Organisms (GMOs) in agriculture.

This transpired during a meeting by the ministry of tourism and environmental affairs and its members of the portfolio committee at Lugogo Sun yesterday.

Modern biotechnology is referred to as the tool that enables the transfer of genes across organisms at cellular level to get a desired product and this process is called Genetically Modified Organisms (GMOs).

The Biosafety Act of 2012 embraces the benefits of modern technology and recognises the fact that if used the right way the technology will help Swazi farmers. The minister said the law requires aspiring GMO users to consult with the Eswatini Environmental Authority to ensure that the particular GMO will pose no negative effects to humans or the environment. This is as per the provision of the Biosafety Act of 2012 section 4 which designates the EEA to be the National Competent Authority on biosafety matters and to be the national focal point.

Eswatini had a Biosafety Act of 2012



and that act had some challenges as in section 32 which touches on the liability clause where it stated that the producers of GMOs were liable hence the producers are at the far end of the value chain.

This was revealed by the Minister of Tourism and Environmental Affairs Moses Vilakati during the workshop.

He said in some instances, it could happen that it's the farmer who did not take care of the GMO seeds but at the end liability fell with the producer.

Vilakati said as government, they were trying by all means to amend that clause such that now it is the farmer's responsibility to be liable rather than everybody in the value chain.

"That is very key because as of now the farmers were not able to access the GMO seeds because of that clause and we hope that the amendment farmers will get back to business and produce cotton which will revive our cotton ginnery in Big Bend," Vilakati said.

The minister continued to say that thus was all meant to ensure that the cotton industry flourishes as the responsibilities are now going to be on the farmers who are the ones who are producing. He pointed out that the farmers will be trained to make sure that they follow the requirements of the GMO proper-

"If anyone decides not to follow the procedures that will be his or her own problem as they will have too shoulder all the expenses including legal claims rather than everybody in the value chain," he said.

Dejected husband wants out of marriage

A man has filed for divorce from his wife of eight years after she deserted their matrimonial home without a feasible explanation.

Simangaliso Dlamini has recently filed an application for divorce from his wife Ncamsile, who deserted their home, leaving him with their only child.

The couple was married on October 1, 2011 at Ezulwini, where they entered into a civil rites union. They were said to have established their matrimonial home at Makholokholo in Mbabane, where they lived until 2013, when the man's wife deserted their home. During his appearance before Magistrate Sifiso Vilakati yesterday, Simangaliso revealed what occurred on the day she deserted him.

"I arrived home from work and found that she had packed all her belongings and left our home. When I attempted to call her on her cellphone, she did not answer all of my calls. The one time she answered, she told me that there was nothing to discuss as she had nothing to say to me," Simangaliso revealed.

According to Simangaliso's evidence led before the court, numerous attempts at intervention by their families proved futile, as Neamsile did not show any interest or concern

"I plead with the court to grant me a final decree of divorce, as my wife has made it clear that she no longer wants to be with me. I also wish to have full custody of our child, as she currently lives with me," he stated.

Dlamini's attorney also informed the court that his client was praying for the restoration of conjugal rights and in the event that Ncansile is unable to meet those needs, the court should grant him a final decree of divorce within seven days after he is served with court orders.

Magistrate Sifiso Vilakati then issued an order for Neamsile to restore conjugal rights to Simangaliso within five days after he is issued with the order.

'Risk management in the GMOs a crucial part'


RISK management has been confirmed as the most crucial part that needs to be considered when dealing with the introduction of GMOs in farming indus-

This was revealed by Chief Environmentalist Hlobisile Sikhosana during the workshop organised by the ministry of tourism and environmental authority, portfolio committee members and environmental stakeholders. Sikhosana said risk management of the GMO process needs to be taken care of from the manufacture to the wholesale to the retailer down to the farmer to avoid unnecessary environmental, human health, and animal health issues.

She said every activity involving GMOs need to undergo a scientifically based risk assessment where possible consequences are investigated. In addition she said that there is need for farmers to make sure that they plant GMOs under confined procedures to deal with risk management hence enabling every player to be liable if there are errors.

"The risk assessment process also ensures that the particular GMO is being used in other countries and that the Swazi user will use it harmony with his or her community," she said.

It was highlighted during the workshop that public involvement in the process is key. This is if the amendment of the bill pass in parliament, any farmer who will want to use GMOs will have to notify the public. This is where the public will then object or have recommendations about that for a period of 28 days.

CANGO Communications Officer Nkosingiphile Myeni said the organisation notes that despite the current economic challenges facing the country, government is prioritising service delivery to cater for many schools going chil-

dren needs, including the schools feeding programme.

Myeni said this reaffirms government's commitment to address poverty and inequalities and is in line with one of the pillars of strategic roadmap, 2019-2022, social safety nets; to ensure inclusive growth and living no LiSwati behind.

He mentioned that recently a report by Oxfam had pinned the country at the top of the list of highly unequal countries in Sub Saharan Africa.

The same report also acknowledges that Eswatini was one of the countries with political will to address the inequality through social protection programmes.

"On another note, CANGO would like to acknowledge the positive response by the government to the tertiary students outcry by increasing allowances paving the way for the re-opening of closed tertiary institution."

Meanwhile, UNESWA issued a statement calling for students to return following a decision by the Senate to reopen the institution today.

UNESWA Registrar Dr Salebona Simelane said classes will resume this morning and issued a stern warning to students against damaging property.

Maid (25) steals wig, clothing items from boss

"DO not bite the hand that feeds you."

These words uttered by Magistrate Sifiso Vilakati rang true as a woman faced theft charges after she stole her employer's belongings valued at E2 000.

The 25-year-old Colile Ginindza of Mangcongco was arrested and charged with theft after she was found to have stolen items belonging to her employer, Cinisile Fakudze.

According to her charge sheet, Ginindza was said to have, from March 2019 to August 2019, at Nkoyoyo area, did wrongfully and unlawfully steal items belonging to Fakudze.

Some of the items stolen by Ginindza included various clothing items, artificial hair and shoes. All these items were said to have been of the value of E2 000.

During her appearance before Magistrate Vilakati yesterday, the magistrate questioned Ginindza on

the reasons that led to her committing the offence.

"How can you steal from someone who has employed you? She has entrusted and brought you in her home and given you a job so that you may sustain yourself.

"You have probably even been fired from this job, as no employer wants to retain an employee who disrespects them. You will now have a criminal record, how are you even going to get a new job?" the magistrate questioned.

Ginindza responded that she was indeed fired from her job, and further apologised immensely for her actions. She explained to the court that she had not intended to steal the clothes.

After hearing her mitigation, Ginindza was sentenced to pay a fine of E2 000 and in default of payment, serve two years in a correctional facility.

Half of Ginindza's sentence was wholly suspended for a period of one year, in the event that she did not commit a similar offence during that period.

The sugar company was responsible for providing cleaning material and transporting the collected garbage to its own landfill site.


RSSC Group Public Affairs Manager Sifiso Nyembe said the clean-up campaign resonates with the RSSC habit of vigilantly keeping clean villages.

2019 PAY AS YOU EARN (PAYE) RECONCILIATION BY EMPLOYERS

In an effort to simplify annual reconciliation statements submissions and a quicker processing cycle, the Eswatini Revenue Authority (SRA) urges employers to utilize the PAYE Electronic Submission (i.e., the recommended spreadsheet/notepad).

Who may use Notepad?

Employers with a payroll software should extract the very same report from which tax certificates for their employees are printed and submit in notepad format. Who may use the recommended spreadsheet?

Employers who do not have a payroll software or if the payroll software cannot be converted into notepad format may use the Electronic Spreadsheet which can be downloaded from our website (www.sra.org.sz).

Notwithstanding the mode of submission used, employers are hereby reminded to adhere to the following:

1. All submissions and calculations should be in accordance with the requirements of Legal Notice no 3 of 2005 with regards to the Final Deduction System (FDS) procedure - this Legal Notice is contained in the PAYE Tables also available for download on the SRA website:

III. The Final Deduction System must be correctly applied for the submission to be accepted as complete, failing which it shall be rejected during submission:

III. Information such as Personal Identity Numbers

(PINs) and Graded Tax numbers should be verified prior to the submission of the reconciliation by employer. Taxpayers' submissions with incorrect or incomplete information will be considered as a NON-SUBMISSION;

For notepad format submissions, the graded tax numbers should exclude the first six digits (i.e., chief and Indvuna codes);

For excel format submissions, the graded tax numbers should be complete in that it should contain up to 15 digits;

IV. All submissions should have employee numbers for ease of reference;

 V. NO hard copy reconciliation shall be submitted for Large Taxpayers;

VI. Tax Certificates should ONLY be printed once a written endorsement is made by the Commissioner General that indeed the PAYE Reconciliation is correct and all PAYE payments (remissions) have been made:

While there, Siyabonga said he knocked on an open window of his brother's house and he and an unidentified friend came to the widow. This is then that Phumlani allegedly hacked his brother on the hand with the slasher through the open window.

Hacked

"When he hacked me he did not say anything and I don't know why he did it because I had not provoked him in any way," said Siyabonga.

As soon as he was attacked, Siyabonga said he ran to his other brother's house, where he asked that the sibling call the police so that he could go to hospital.

He was attended at to in a local health institution and was transferred to Mbabane Government Hospital, where he was given further medical attention.

Evidently, Siyabonga had a plaster of Paris on his right arm and he had a sling on to support his arm when he came to court yesterday. It was further revealed that Phumlani and Siyabonga had a misunderstanding three days before this incident. Siyabonga told the court that he had confronted his brother on allegations that he had raped his (Siyabonga) girlfriend.

The said girlfriend is said to have resided at the Manyatsi homestead and she allegedly informed Siyabonga that Phumlani had

This did not sit well with Siyabonga and as a result, he reported the matter to his

The two were supposedly called to a family meeting that was aimed at addressing the matter. "When he was asked about it, Phumlani said he thought I tell him to marry both my girlfriend and his," Siyabonga told the court.

As a result of the purported rape allegation, Siyabonga said he decided to send his girlfriend away since he was not sure of what action he should take.

Phumlani was remanded in custody and was admitted on E6 000 bail.

Gogo (71) changes plea to guilty due to conscience

WHILE most senior citizens spend their golden years enjoying the fruits of their labour, an elderly woman changed her tune to pleading guilty, after she was intent on pleading not guilty as the consignment allegedly belonged to her daughter.

Priar to her appearance before Magistrate Temantimandze Shongwe on Tuesday, Alice Nkambule was advised by her arresting officer to plead not guilty to the charges, as the consignment was said to belong to her daughter.

However, when elderly lady entered the accused dock and was asked by the court clerk what her plea would be, she stated that she pleaded not guilty as the consignment belonged to her daughter.

However, gogo Alice's conscience took over, as she quickly changed her plea to guilty at the last second.

Alice, who was arrested alongside Ncobile Nkambule (29) were arrested after they were found to have contravened the Pharmacy Act of 1929.

The two women were found to have, on September 9, 2019 at Nkalangeni, acted jointly in furtherance of a common purpose and not being holders of a valid licence or permit to possess dagga, did wrongfully and unlawfully possessed 7.4 kilograms of dagga.

After their arrest, it was discov-

ered that the women were also in possession of 1 kilogram of dagga seeds on September 9, 2019 at Nkalangeni, thus contravening the Opium and Habit Forming Act of

Simile Nkambule and Mkhonzeni Nkambule appeared before the Mbabane Magistrate's Court after they was arrested and charged with contravening the Pharmacy Act of 1929.

The Nkambules were said to have, on September 9, 2019 at Nkalangeni, not being holders of a valid licence or permit possessed dagga weighing 6.4 kilograms which is a potentially poisonous substance, thus contravening the Act.

They were also said to have an additional charge placed against them, after they were said to have contravened the Opium and Habit Forming Act after they was disseeds, further contravening the Act.

During their appearance before the court on Tuesday, Simile pleaded not guilty to both charges, after which she was acquitted and discharged.

On the other hand, Mkhonzeni was found guilty as per his own plea, where he was later sentenced to pay a fine of E1 800 and in default of payment, 20 months in prison.

Mkhonzeni was further sentenced to serve a year in prison, with the option to pay a fine of E1 000 for being found in possession of dagga


MASHUMI, WIFE WED THE TRADITIONAL WAY

Boy (18) rapes niece, gets E2 000 bail

AN 18-year-old boy appeared before the Magistrate's Court, where he faced a charge of contravening the Sexual Offences and Domestic Violence Act of 2018.

*Sipho was said to have committed an unlawful act of sexual nature upon a minor aged 13 years old. He was charged with Section Three of the said Act.

The charge was accompanied by aggravating factors, which included that the accused person inflicted the minor child with a lifetime trauma by forcing her to the act. He was also said to have stood in loco parentis by virtue of being an uncle to her.

The accused person's act was said to have exposed the complainant to the risk of contracting sexually transmitted ill-

During his appearance before court, the accused person elected to conduct his own defence after being informed of his rights to legal representation.

He was, however not asked to plead to the charge as the Crown indicated that it intends to lead evidence to prove commission of the offence. He successfully filed an application to be admitted to bail. He was ordered to pay a sum of E2 000 as bail and return to court on December 11 for commencement of trial.

Meanwhile, in the same court, Mbongiseni Mngometulu (49) faced a similar of contravening the SODV Act. He was said to have committed an unlawful act of a sexual nature upon a woman without her consent.

The charge was also accompanied by aggravating factors, which included that the accused person threatened to stab the complainant if she resisted to his demand. The accused person elected to conduct his own defence in the matter.

The matter was postponed to a later date pending setting of a date of trial.

Medical student loses phone while 'gambling'


A traumatised university student narrated his ordeal before court which saw him and his friend lose their cellphones due to tricks played by three men.

Relating his tale before the court on Tuesday, medical student Sibonginkhosi Dlamini recalled that on the day in question, he decided to have his lunch at the Mbabane Park with his friend Falakahe Motsa.

"When we arrived, we found a group of men playing what we thought, was a game of cards. We did not suspect that they were gambling, as they did not seem to be placing bets on anything.

"Taking an interest in the game, we decided to ask to join in. They agreed, and we went on to win our first game without any hitch," Dlamini explained.

Dlamini recalled that, one of the three suspects suggested that they upped that stakes by placing their cellphones as a prize for the winner. The suspect also added that there



along with our phones. "That was when another suspect proposed that we pay him an amount of E2 000 in order to get our cellphones back. We obliged, however we discovered that Motsa and I did not have our bank cards with us. We then called one Wandile Hlatshwayo to assist us, with the promise to pay him back at a later stage. That was when one of the suspects disappeared with our cellphones, and we were

left with two of the other suspects," he revealed.

Arrested

Futhi Dlamini of Mdzimba, Sicelo Tfwala of Mangwaneni and Dumisani Khumalo of Hlobane were arrested and charged with contravening two counts of the Crimes Act of 1889, where they were found to have conspired to illegally obtain cellphones belonging to Falakhe Motsa and Sibonginkhosi Dlamini.

According to their charge sheet, the trio was said to have committed the offences at Mbabane Park behind Engen Filling Station on Tuesday. On the first count, the trio was said

to have acted jointly and in furtherance of a common purpose, did wrongfully and unlawfully conspire with each other to trick Falakhe Motsa. They are said to have done this by playing cards, and by doing so to win Motsa's cellphone by the illegal game and obtained a Samsung Galaxy J1 cellphone valued at E2 100.

On the second count, the trio was said to have committed the same offence, this time conspiring to trick Sibonginkhosi Dlamini, in order to 'win' his Samsung Galaxy J7 cellphone valued at E6 000. The matter was postponed for a later date for the continuation of trial.

House-breaking suspects admitted to E17 000 bail

WHEN three women walked into their houses after a long day of work, they were shocked to find that the only furniture they had were their curtains hanging by their windows, after thugs robbed them of their life's possessions.

Menzi Bonginkhosi and Gcina Nkambule stand accused of emptying Bawinile Matse, Gugu Matsebula and Nondumiso Ngwenya's houses, after they are

said to have stolen items amounting to E37 476.

The suspects are said to have entered the women's residences at Mpolonjeni, Siphocosini and Sigangeni areas, in their absence and made away with items such as clothing, blankets and grocery items. House

According to their charge sheet,

Menzi and Nkambule were said to have broken into Matse's house at Mpolonjeni on August 21, 2019 and stole items valued at E13 480.

They were then said to have proceeded to Matsebula's home on September 7, 2019 at Siphocosini, and stole items valued at E16 956. Ngwenya was their third victim, where they were said to have stolen items valued at E7 040 at her home at Sigangeni on August 16, 2019. Assaults

The duo was additionally charged with two separate assaults with grievous bodily harm charges, where they were said to have assaulted one Majaha Dlamini and Michael Billa with a bush-knife.

During their first appearance before Magistrate Temantimandze Shongwe on Monday, the prosecution applied

for the court to set a trial date in order to lead evidence of the commission of the offence, thus informing the court that bail for the duo was not opposed.

The prosecution also applied for the duo to be remanded into custody until today. Magistrate Shongwe granted the prosecution its application, informing the suspects that their bail was set at E17 000, which, as the law dictates, is set at half of the value of the items stolen.

The suspects were further warned to appear before the court today for commencement of their trial, and if they were unable to pay the bail. they were to be remanded into custody until then for the setting of their trial date.

ELIMINATING STIGMA, DISCRIMINATION CATALYST TO ENDING AIDS **MULTISECTORAL**



THE HIV and AIDS epidemic has been a concerning issue for the Kingdom of Eswatini. since the first case of HIV was reported in

The early years were particularly difficult as there was not much information known about the disease and there were no treatment options, leading health practitioners and academics to predict that the epidemic would wipe out the whole population, it was projected that the country would experience a negative population growth rate by 2004.

Today however, new HIV infections have reduced by 44 per cent since 2014 and by the year 2017, the initiation of people living with HIV (PLHIV) on antiretroviral therapy (ART) had been accelerated to reach 85 per cent of PLHIV, with 92 per cent of those virally sup-

The HIV prevalence has stabilised to 27.4 per cent, and to date, over 70 000 AIDS-related deaths have been averted since the introduction of ART in 2003. These key indicators suggest that the country is on the right trajectory to ending AIDS as a public health threat.

However, despite these achievements, there remains many concerning issues in the Eswatini HIV response and the global community. In the over three decades of responding to HIV, stigma and discrimination PLHIV and those populations at increased risk of HIV transmission still exists to varying degrees.

In June 2016, the United Nations General Assembly (UNGASS) having agreed that ending AIDS by 2030 requires a fast-track response set a target to reach three milestones by 2020. Importantly, the third milestone is to, "elimi-

nate HIV-related stigma and discrimination by

The National Multisectoral HIV and AIDS National Strategic Framework (NSF) 2018-2023 recognises and incorporates the global strategy, as seen in its vision to super fast-track the HIV response to achieve: 85 per cent reduction of new HIV infections; avert 50 per cent of deaths among PLHIV; and Elimination of HIV stigma and discrimination. This means that eliminating stigma and discrimination is a priority in Eswatini's HIV response.

STIGMA AND DISCRIMINATION

Stigma is the process of devaluation of people either living with HIV or associated with the ill-



Stigmatisation can take various forms, including being discredited, seen as a disgrace, and or perceived to have less value. When stigma is acted upon (also referred to as "enacted stigma"), the result is discrimination - the unjust treatment of individuals based on their real or perceived HIV status.

Discrimination consists of actions or omissions that are derived from stigma and directed towards those individuals who are stigmatised.

HIV-related stigma often builds upon and reinforces other existing prejudices, such as those related to gender, sexuality and race.

Typically, the stigma associated with HIV is often based upon the association of HIV and AIDS with already marginalised and stigmatised behaviors such as sex work and same-sex and transgender sexual practices.

HIV-related stigma affects those living with HIV and through association, those that they are associated with, such as their partner or spouse, children, and other members of their household.

Stigma, discrimination and human rights prohibitions are barriers that hinder access to HIV

Among PLHIV, self-stigma and fear partly accounts for late initiation on ART, especially among men, and hinders status disclosure and adherence to treatment.

As a result, most people testing HIV positive prefer to seek treatment services in distant health facilities where they are not known.

On the other hand, discrimination deters people from getting tested; it discourages open dialogue and safe practices (around issues of HIV and AIDS in general, condom use, and support for PLHIV), and lowers self-esteem, thus increas-

Discrimination consists of actions or omissions that are derived from stigma and directed towards those individuals who are stigmatised.

es the spread of HIV and AIDS.

The Multiple Indicator Cluster Survey (MICS) 2014, showed a drop in the percentage of people who report accepting attitudes towards people living with HIV, from 47.1 per cent in 2010 to 37.4 per cent among women aged 15-49 years and 45.7 per cent in 2010 to 36.2 per cent among men aged 15-49 years.

Based on this, the NSF 2018-2023 therefore identifies stigma and discrimination as a major hurdle for the attainment of the national vision of ending AIDS by 2022.

THE 2011 STIGMA INDEX REPORT

As the country seeks to end AIDS by 2022, there is a realisation that the target can only be attained when the pivotal role of PLHIV is recognised and encouraged.

With the NSF 2018-2023 recognising the need to eliminate HIV stigma and discrimination as a key pillar to Ending AIDS by 2022, the NSF 2018-2023 includes a programme for HIV related stigma and discrimination and human rights, with a target to reduce stigma to less than 10 per

The first Stigma Index Report was pioneered in 2011by the Swaziland National Network of People Living with HIV and AIDS (SWAN-

It assessed the prevalence and type of stigma and discrimination in the country by collecting experiences of PLHIV in communities in relation to stigma, discrimination at home, at work, in relationships and even measured the extent of self or personal stigma.

Specifically, the stigma index determined and documented the experiences of stigma among PLHIV in relation to health care, employment, sexual and reproductive health rights and measured the (negative) impact of stigma on interventions implemented in the country.

Some of the key findings of the Stigma Index Report include the following:

- In relationships, eight per cent of the respondents indicated that they had been subjected to psychological pressure or manipulation by their spouses or partners, wherein their HIV status was used against them. 20 per cent of the respondents indicated experiencing situations where their spouse or partner, members of their household was discriminated because of the respondent's positive HIV status;
- About 5.5 per cent of the respondents stated that they had experienced discrimination by

other PLHIV;

- There were 2.8 per cent respondents who alluded to having the experience of being refused employment or a work opportunity as a result of their HIV positive status.
- At least 2.3 per cent of the respondents reported having their job description or nature of their work changed or refused promotion as a result of their HIV status;
- There were 4.6 per cent who were denied dental care because of their HIV status; 1.1 per cent were denied family planning services; and 3.7 per cent were denied sexual reproductive health services.

RECENT STIGMA INDEX REPORT PRELIMINARY REPORT

The NSF 2018-2023 identifies the need to eliminate HIV stigma and discrimination as a key pillar to Ending AIDS by 2022 and includes a programme for HIV related stigma and discrimination and human rights, with a target to reduce stigma to less than 10 per cent by 2023.

Consequently, the HIV responserecently engaged in a critical assessment of HIV related stigma, discrimination and human rights among PLHIV, using The People Living with HIV Stigma Index Guideline.

The purpose of the assessment was to measure where and when stigma and discrimination against people living with HIV and AIDS occurs; to measure stigma and discrimination and its impact on the response to HIV especially disclosure and treatment; to identify promising approaches to stigma and discrimination that can be taken to scale to achieve sufficient impact across the country, to generate evidence and identify gaps in HIV programs that may fuel stigma and discrimination; to assess and document the experiences of PLHIV in general and key populations living with HIV, regarding stigma and discrimination and profile PLHIV on matters related to human rights.

The preliminary findings show that:

- Of the respondents asked about any experiences related to stigma and discrimination from health care workers in the past 12 months. Only less than 10 per cent of respondents reported experiencing stigma and discrimination from health care workers.
- Of those asked if they believed their medical records were kept confidential when they go to seek health care services, most respondents, about 79 per cent reported that they have trust that their medical records were kept confi-
- Among those who self-identified themselves as sex workers, 55 per cent indicated that they had not experienced stigma and discrimination because of sex work.
- About 38 per cent indicated that they had been verbally harassed.
- 52 per cent of sex workers indicated that family and friends did not know that they were sex
- About 88 per cent of sex workers were on HIV treatment.

Though there is a notable reduction in stigma and discrimination, the preliminary results point out that disclosure is still a problem.

This undermines preventative strategies, affects health seeking behaviour, and drives the epidemic underground, which perpetuates the vicious and silent nature of the epidemic.

Witness Protection Act 2018

PROTECTION OF MINOR OR MENTALLY IMPAIRED **PERSON**

13. (1) No minor or a mentally impaired person shall be placed under protection without the consent of the parent or guardian of that minor or mentally impaired person.

(2) Any minor or mentally impaired person-

(a) Who, as a witness, applies for protection in respect of proceedings against the parents or guardian of the minor or mentally impaired person or in which the parent or guardian is a suspect;

(b) Who has no parent or guardian;

(c) whose parent or guardian cannot be identified or found, notwithstanding reasonable efforts to do so;

(d) Whose parent or guardian is unreasonably withholding or is unable to give consent, may be placed under protection without the consent of the parent or guardian if the Director is of the opinion that it is necessary to do so for the safety of the minor or mentally impaired person.

(3) Where the Director places a minor or mentally impaired person under protection without the consent of the parent or guardian, the Director shall, within seven days of such placement or within such further period as a judge of the High Court may determine in an application made by the Director, submit to the judge a report setting out the reasons for such placement and the draft protection agreement for consideration by the judge in chambers.

(4) The Director shall also furnish the minor or mentally impaired person concerned and, where applicable, to the parent or guardian, a copy of the report and the draft protection agreement referred to in subsection

(5) The judge may, after considering the report and the draft protection agreement, by order-

(a) Set aside the placement under protection;

(b) Confirm the placement under protection and ratify the draft protection agreement;


(c) Confirm the placement under protection and amend the draft protection agreement in a manner that the judge considers to be in the best interests and necessary to ensure the safety of the minor or mentally impaired

(6) The Director shall forthwith discharge a minor or mentally impaired person from protection where the placement under protection of the minor or the mentally impaired person is set aside.

(7) The Director shall be the curator ad litem of a minor or mentally impaired person who has been placed under protection without the consent of the parents or guardian.

DISCHARGE FROM PROTECTION

14. (1) The Director may, subject to subsections (5) and (8), on his accord or upon receipt of a report



referred to in subsection (3) and after consideration of any representations referred to in subsection (5), by written notice discharge a protected person from protection if the Director is of the opinion that-

(a) The circumstances that gave rise to the need for protection and assistance for the witness have ceased to exist;

(b) Satisfactory alternative arrangements have been made for the protection of the person;

(c) The witness deliberately breached a requirement or undertaking relating to the programme;

(d) The witness, in making the application for placement under protection, wilfully furnished false or misleading information or particulars or made a statement which is false or misleading in any material respect or willfully failed to disclose any information or particulars material to the application;

(e) The witness refused or failed to enter into a protection agreement when required to do so;

(f) The behaviour of the witness is likely to threaten the security or compromise the integrity of the programme; or

(g) The witness wilfully caused serious damage to the place of safety where the witness is protected or to any property in that place of safe-

(2) The Director may, subject to subsections (4) and (5) and after consideration of any representations referred to in subsection (5), upon receipt of a written notice given by the interested functionary concerned that the evidence of a witness is no longer required in the proceedings concerned or that such proceedings have been concluded, by written notice, discharge the witness and all related persons from protection.

(3) A witness protection officer shall forthwith report to the Director where the witness protection officer has reasonable grounds to believe or to suspect that-

(a) Any of the circumstances for discharge referred to in subsection (1)(a) or (b) exist; or

(b) A protected person is performing or has performed any act referred to in subsection (1)(c) to (g).

(4) The Director may, upon appli-

cation by a protected person, the parent or guardian of a minor or impaired person or a minor or impaired person referred to in section 13(2), extend the period of protection for as long as it may be necessary, if the Director is of the opinion that the safety of the witness is still being threatened after the conclusion of the proceedings concerned.

(5) The protection of a minor or mentally impaired person referred to in section 13(2) may not be extended without the prior approval of a judge in chambers.

(6) The Director shall, before removing a protected person from protection, take reasonable steps to notify, in the prescribed manner, the protected person and, if it is a minor or a mentally impaired person, the parent or guardian and the interested functionary concerned of the contemplated discharge in terms of subsection (1) or (2).

(7) The Director shall allow the protected person, and where applicable, the parent or guardian and the interested functionary concerned to make written representations within the prescribed period and in the prescribed manner in relation to any matter regarding the discharge.

(8) A protected person shall remain under protection until discharged from protection in terms of subsection (1) or (2) or in accordance with an agreement or until the person, the parent or guardian of a minor or mentally impaired person or a minor or mentally impaired person referred to in section 13(2), submits a waiver of protection to the Director in the prescribed manner.

(9) The Director shall, subject to subsection (10), upon receipt of a waiver of protection referred to in subsection (8), without delay discharge the protected person from pro-

(10) The Director may not discharge-

(a) A protected person from protection in terms of this section without the prior approval of the Minister;

(b) A minor or a mentally impaired person referred to in section 13(2) from protection in terms of this section without the prior approval of a judge in chambers.

SUSPENSION OF PROTECTION

15. (1) The Director may suspend protection provided to a witness under the programme if the Director is satisfied that the witness has done or intends to do something that limits the ability of the Director to provide adequate protection to the witness.

(2) Before suspending the protection, the Director shall take steps that are reasonably necessary-

(a) To inform the witness the reason why it is proposed to suspend the protection; and

(b) To give the witness a reasonable opportunity to state why the protection should not be suspended.

REVIEW OF INVOLUNTARY DISCHARGE OR SUSPENSION BY MINISTER

16(1) If the Director makes a decision under section 14 or 16 that a witness be discharged from the programme or that protection be suspended, the Director shall-

(a) Take reasonable steps to notify the witness of the decision; and

(b) Notify the Minister, in writing, of the decision.

(2) Any person who feels aggrieved by any decision of or steps taken by the Director or any person acting on behalf of the Director under a provision of this Act, may within the prescribed period and in the prescribed manner, apply to the Minister to review the decision of the Director.

CIVIL PROCEEDINGS IN WHICH PROTECTED PERSON IS A PARTY OR WITNESS

17. (1) Any civil proceedings in which a protected person is a party or a witness may, subject to subsection (2), be proceeded with in terms of the laws regulating such proceedings.

(2) If it appears to a judge of the High Court in an ex parte application made in chambers by the Director, that the safety of any protected person might be endangered by the institution or prosecution of any civil proceedings in which a protected person is a party or witness, whether in that High Court or in any lower court within its area of jurisdiction, the judge may make an appropriate order with regard to the institution or prosecution or postponement of those proceedings in a manner aimed at-

(a) Preventing the disclosure of the identity or whereabouts of the said person; or

(b) Achieving the objects of this

(3) Notice of any order made in terms of subsection (2) shall be given to the parties to the proceedings concerned and to their legal representatives in accordance with the rules of the court.

(4) The address of the Office for witness protection shall for all purposes of service of process on a protected person, serve as the domicilium citandi et executandi of that person and notice of such address shall be given in writing by the Director and delivered by hand or sent by registered mail to all the other parties or their legal representatives.

The plight of women before historic marital power judgment

BEFORE the marital power High Court full-bench judgment, married women were regarded as not capable of taking decisions by themselves - the power was vested upon men to dictate on impacting families.

Section 24 and 25 of the Marriage Act deprived women their right to purchase properties without the authorisation of their husbands and as such, they were always at the mercy of men.

This was open to manipulation particularly in the event of marital disputes that forced some married couples to be on separation.

With due respect, Prince Masitsela might not be aware of how women, particularly those on separation and undergoing divorce proceedings suffered every time they want to take some steps in life.

In the midst of those marital disputes, those married are forced to negotiate with their husband for their signatures every time they want to buy a property

This would give abusive men an advantage to frustrate them more for instituting divorce proceedings and some would find themselves withdrawing the court cases, as their lives were frustrated.

It should be noted that despite that these provisions of the Marriage Act were against the principles of gender equality, they were unconstitutional as rightly declared by the

In a marriage, both parties who entered into it should enjoy equal powers, that would encourage dialogue and couples would engage one another to find solutions instead of one party dictating terms to the

As Women and Law for Southern Africa (WLSA) Eswatini, we appreciate the recent judgment on marital power, it comes as a relief to the struggling women who were frustrated by their husbands and those who were deprived of their right to take decisions regarding issues affecting their welfare.

As an organisation that advocates for the rights of women, we appeal for support and understanding from highly-respected figures like Prince Masitsela that such judgments are meant to restore harmony within the families.

Court judgments in favour of gender equality should not be misinterpreted as a way of toppling men as head of families; here we are addressing the aspect of marital power that was open to abuse by men who want to frustrate women.

One would make an example of a hardworking woman, who made savings to buy property in town.

This woman is in a five-year separation from her husband and as such they are no longer living togeth-

However, the woman, despite her efforts would be required to go back to her husband and seek his consent before buying the property and in the event he says NO, that would be the end.

This was not only affecting women but the whole country, as women through their hard work drive the economy and they should not be deprived of their right to progress economically by their husbands




THE EswatiniBank has sponsored a sum of E110 000 to Enactus Eswatini.

OVER E120 000 MADE AT BREEDING BULLS' AUCTION BY BAHLE GAMA

A total sum of E121 800 was made at a Breeding bull auction held for the first time at the Mavuso Trade

Center. Livestock marketing officer in the ministry of agriculture Mzamo Bhembe disclosed this information during an interview.

He stated that the auction is usually conducted once a year at Mpisi farm and Manyonyaneni hence they decided to hold it for the first time at the trade fair whereby 14 bulls were in the auction and farmers came in numbers to purchases them. Registered buyers were 15 and paid a commitment fee of E3000.

"A total of 13 breeding bulls were sold during the auction with only one remaining and the two bulls were bought for the highest price of E22 000 each," he said.

He further disclosed that one bull which weighed 370kg was auctioned for E8 400 and one which weighed 400kg was sold for E9 000.

He added that the purpose of the auction was to help farmers improve their cattle and to reduce inbreeding, further stating that the auctioned gave farmers the chance to own their own breeding bulls instead of renting from government. "Government has a bull loan scheme where farmers rent bulls for 3 years at an average price of 1500 and we discovered that some farmers cannot afford to rent these bulls hence the auction," he added.

Bhembe further disclosed that as the auction was the first of its kind at the trade fair it was not its last as they intend to ensure that it is held yearly at the trade fair. In terms of poultry

MTN FINED R5M FOR TRIPLING WHATSAPP DATA BUNDLE PRICES

THE Independent **Communications Authority** of SA (ICASA) has fined MTN R5m for its decision to triple the price of its WhatsApp data bundles.

In 2018 the country's second largest mobile network operator by subscriber numbers introduced a monthly WhatsApp bundle of 1GB for R10 in April

This move resulted in WhatsApp usage on the network increasing by 300 per cent in eight weeks, Jacqui O'Sullivan, executive for corporate affairs at MTN SA, said.

ICASA's complaints and compliance committee (CCC) said MTN had knowingly contravened regulations and brought problems for itself.

"The finding of the CCC is that MTN was in grave error by introducing the R10 deal," the regulator said. The R10 monthly bundle resulted in increased traffic from customers, forcing MTN to invest R200m to expand capacity on its network. MTN later advised ICASA that it intended to raise the price to reduce demand and



pressure on its 3G network. "An unintended consequence of the low-priced WhatsApp data has been an extraordinary increase in demand on MTN's 3G network," said O'Sullivan.

On June 18, 2018, MTN advised Icasa that it intended to raise the price from R10 to R20 but chose to delay the change, hoping it could improve its network to cope with the increased traffic.

This did not work out as planned and on July 12 the operator notified Icasa that an even higher price increase was needed to reduce demand and pressure on the 3G network.

Requesting

MTN SA CEO Godfrey Motsa followed this up with a letter to Icasa requesting leniency and arguing that the operator could not wait the normal seven days from notification to implement the price

MTN ultimately changed the price on July 16 after it did not receive a response to the letter, O'Sullivan said. The operator has said it will appeal the regulator's decision in the High Court.

Transaction data points to flat third quarter growth for SA

JOHANNESBURG - An economic index that tracks interbank payments suggests that South Africa can expect flat economic growth for the third quarter of the year.

The BankervAfrica Economic Transactions Index for August was published on Wednesday. Quarterly and the monthly numbers both showed declines of 0.9 per cent in August.

"The [index] suggests the economy is stagnating again. It is clear that the strong positive GDP growth of Q2 2019 will be substantially softer in the third quarter as the data thus far shows," BankervAfrica said in a statement.

It said that while changes in metrics for September could still alter third quarter growth, current data for the quarter "gives little hope of another quarter with a 3 per cent GDP increase".

SA's quarterly economic growth rate plunged at the start of the year, declining by a restated 3.1per cent - its biggest fall in a decade. But unlike the start of 2018, the county didn't fall into at recession after growth in the second quarter rebounded by 3.1per cent.

The country's predicted GDP growth rate has been repeated downgraded this year, while unemployment has risen to record highs.

On Tuesday ratings agency Moody's lowered SA's 2019 growth rate to 0.7 per cent, in line with predictions previously made by the SA Reserve Bank. The agency said, however, there was a low likelihood that it would downgrade SA's sovereign credit rating to junk in the near future. Fin24

Zim holds diamond auction for 316 000 carats

HARARE - Zimbabwe's stateowned Minerals Marketing Corporation opened a 316 000 carat diamond auction, which will close at the end of the week, an official said.

"This is the third auction we have conducted this year as there were some administrative issues which were taking place within the organisation," MMCZ's General Manager Tongai Muzenda said by phone yesterday. The last auction was held in July, he said.

The auction, which began Monday and will close tomorrow, has attracted buying interest from Belgium, Dubai, India, Israel and South Africa, but

Muzenda declined to name the companies bidding, citing confidentiality.

Zimbabwe expects to produce 4.1 million carats of diamonds this year, up from 2.8 carats in 2018. At the peak of production in 2012, the southern African country's output was 12 million carats. Bloomberg

'Overwhelming' majority of Naspers shareholders to opt for Prosus shares

AMSTERDAM - It looks like most Naspers [JSE:NPN] shareholders will take the immediate capital gains tax hit and opt for Prosus shares instead of getting more Naspers shares.

Prosus shares made a strong debut in Amsterdam and Johannesburg yesterday. By late morning, shares in the Naspers spinoff were trading at 74.50 euro - 27 per cent higher than the "reference price" of 58.70 Euros (around R950) was fixed for the share.

Basil Sgourdos, chief financial officer of Naspers, told journalists on Wednesday that, so far, the company is seeing an 'overwhelming move' towards Prosus shares.

NASPERS shareholders were issued with new Naspers M

shares yesterday morning, which are equal to one Prosus share for every Naspers share.

They have until tomorrow to choose whether these should be converted into Naspers shares instead.

For South African investors, accepting the Prosus shares will mean an immediate capital gains tax charge.

RMI EARNINGS **DECLINE BY** 4% TO R4.08bn

DURBAN-Rand Merchant Investment Holdings' (RMI) normalised earnings declined 4 per cent in the year to end June to R4.08 billion as its investments in OUTsurance and Discovery took a hit on a spike in short-term insurance claims and spend on new strategic initiatives.

RMI, a strategic active manager of a R52bn financial services portfolio, has interests in listed companies, which include Discovery (25 per cent), Momentum Metropolitan (27.3 per cent), OUTsurance (89.1?percent) and Hastings (29.9 per cent), a disruptive UK short-term digital insurer.

RMI said normalised earnings from OUTsurance, including its shareholding in Hastings, decreased by 13 per cent to R2.6bn, mainly due to higher claims and cost ratios across the group, coupled with a lower earnings contribution from its investment in Hastings, while Discovery's normalised headline earnings decreased by 7 per cent to R5bn, as a consequence of a significant planned increased investment in new strategic initiatives and an unexpected spike in large Discovery Life claims in the first half of the year.

However, Momentum Metropolitan managed to offset the disappointing performance by reporting a 53 per cent increase in diluted normalised headline earnings to R3.07bn.

The group's headline earnings declined by 7 per cent to R3.80bn while headline earnings per share were down by 8 per cent to 249 cents a share.

The group declared a final dividend of 65c a share, the same compared to last year. But the total dividend for the year increased to 110c, up from 104c compared to last year. It said the past 12 months had been a very challenging time for the South African investment market and asset management industry broadly

"Despite the JSE All Share Index ending the period up 4.42 per cent, its performance lagged cash (7.27 per cent), bonds (11.5 per cent) and inflation (4.5?percent)," the group said. It added that global equities and emerging market equities also disappointed by delivering 4.97 per cent and 3.27 per cent respectively in the past year.

Looking ahead the group said RMI had a high degree of confidence in its portfolio companies and expected their unique attributes to continue to deliver long-term growth.

"Economic conditions in the South African market are expected to remain challenging in the medium term as a result of the recessionary climate and the constrained fiscal position. A focus on maintaining pricing discipline and incrementally improving operations remain the best defence during market cyclicality," the group said.

MUGABE'S BODY HEADS BACK TO A DIVIDED ZIM FOR BURIAL

SINGAPORE - The body of Zimbabwe's ex-president Robert Mugabe was flown out of Singapore vesterday following his death last week, his nephew said, heading home for burial in a country bitterly divided by the hero-turned-despot's lega-

Mugabe, a guerrilla leader who swept to power after Zimbabwe's independence from Britain and went on to rule for 37 years until he was ousted in 2017, died on Friday, aged 95.

His health deteriorated after he was toppled by the military and former loyalists in November 2017, ending an increasingly iron-fisted rule that sent the economy into ruin.

He died after receiving treatment at a Singapore hospital for several months, and a delegation including Vice President Kembo Mohadi travelled to the affluent city-state on a chartered flight to bring him home.

Early yesterday a hearse transporting Mugabe's body left a Singapore funeral parlour bound for an airport and accompanied by a police escort, driving past a group of waiting journalists.

A plane carrying the former leader and the visiting delegation departed shortly afterwards, his nephew Adam Molai told AFP.



"It just left now," he said by phone from the plane as it took off, with the noise of the aircraft audible in the back-

The Zimbabwean delegation arrived on Tuesday and attended a private Catholic mass for Mugabe at the funeral parlour, officiated by a Zimbabwean priest. Zimbabweans have been divided over how to mourn a former leader once hailed as a liberation hero but who later brutally repressed his opponents.

He was initially praised for ridding the former British colony Rhodesia of white minority rule, but later used repression and fear to govern until he was finally ousted.

His increasingly tyrannical leadership and economic mismanagement prompted millions to leave the country.

Following his death, President Emmerson Mnangagwa announced he had been declared a 'national hero', flags flew at half mast across Harare and news of his passing was splashed across newspaper front pages.

Yet Harare residents appeared largely unconcerned, with shops remaining open and people going about their daily

Afghans fear Trump's Taliban move means more civilians die

KABUL - The sound of the blast ripped through Kabul, in an instant wrenching the Afghan capital's attention from a nationally televised interview in which a United States envoy revealed the first details of a deal to end America's longest

Last week's Taliban car bomb targeted a foreign compound but instead shredded Afghan homes, with stunned and bloodied families picking up children and fleeing in darkness as their once-solid world collapsed. One family saw 30 relatives wounded - many of them women - including a son still healing from an attack the year before. "Our only hope was peace," Hayat Khan, the family's 54-yearold patriarch, said Tuesday, "and that doesn't happen now."

President Donald Trump says the US Taliban talks on ending the fighting in Afghanistan are "dead," deeply unfortunate wording for the Afghan civilians who have been killed by the tens of thousands over almost 18 years. Many fear his cancellation of negotiations will bring more carnage as the US and Taliban, as well as Afghan forces, step up their offensives and everyday people die in the crossfire.

As America on Wednesday mourns thousands of civilians killed in the 9/11 attacks, weary Afghans watch their own toll from the aftermath continue to rise.

"Here innocent people are killed and there is bloodshed everywhere. Families lose their sons, mothers, even their livestock, but no one cares about it," Khan said, a bandage still around his head from the blast. "Who remembers them? Are they not humans?" AP



Pope tells UK to obey UN, give back Chagos Islands to Mauritius

CHANGOS - Pope Francis said on Tuesday that Britain should obey a UN resolution and return to Mauritius a disputed Indian Ocean archipelago that hosts the U.S. military base at Diego Garcia.

Francis cited Catholic doctrine in responding to a question about the Chagos Islands during an in-flight press conference as he flew home from a visit to three African countries, including Mauritius.

Francis said when countries give international organisations such as the United Nations or international tribunals the right to adjudicate disputes, those decisions must be respect-

"It's true that not always things that seem 'just' for all of humanity are 'just' for our pockets," he said. "But you must obey international institutions." Earlier this year, the U.N. General Assembly voted overwhelmingly to demand that Britain, which held onto the Chagos Islands after granting Mauritius independence in 1968, end its 'colonial administration' and return the Chagos Islands to Mauritius. AP

Rwanda agrees deal to take in hundreds of African migrants

KIGALI - Rwanda has agreed to take in hundreds of African migrants who are currently being held in Libyan detention centres.

A joint agreement between the government, the UN refugee agency (UNHRC) and the African Union (AU) was announced on Tuesday.

An initial group of 500 people will be evacuated by aeroplane to Rwanda in the coming weeks, a statement

That group, which includes children and vulnerable young people, is mainly made up of refugees from the Horn of Africa.

Netanyahu announces post-election plan

JERUSALEM - Israeli Prime Minister Benjamin Netanyahu announced his intention on Tuesday to annex the Jordan Valley, a large swathe of the occupied West Bank, if he wins a closely contested election just a week away. Palestinian President Mahmoud Abbas said in a statement that 'all signed agreements with Israel and the obligations resulting from them would end' if Netanyahu went through with the move. Israel captured the West Bank in a 1967 war and Palestinians, who signed interim peace deals with Israel in the 1990s that include security cooperation, seek to make the area part of a future state. Israeli political commentators saw Netanyahu's declaration, in a speech broadcast live on Israel's main TV channels, as a bid to siphon support away from far-right rivals who have long advocated annexation of Jewish settlements in the West Bank. Reuters

Mexico sees decrease in US-bound immigration

WASHINGTON - Mexican Foreign Minister JOHANNESBURG - Mozambique President Marcelo Ebrard said after a White House meeting on Tuesday that there has been a 'significant decrease' in US bound immigration through Mexico, especially from Central America, and he expects the trend to continue. Ebrard met U.S. Vice President Mike Pence, and had a brief exchange with President Donald Trump, to review progress in efforts to curb a surge in Central American migrants. Pence acknowledged Mexico's efforts. He said US officials would work with Mexico to expand implementation of the Migrant Protection Protocols to speed up processing of asylum claims, the White House said in a statement. Mexico's strategy of putting more than 25,000 National Guard militarized police along its borders and stepping up raids on people traffickers has been a success, Ebrard told a news conference. Reuters

Moz to repatriate citizens

Filipe Nyusi says his country the repatriation of hundreds of Mozambican citizens from South Africa after continuing xenophobic violence resulted in 500 Mozambicans losing their homes in South Africa, the privatelyowned STV Noticias reported. Nigeria also reported that more than 600 of its citizens were ready to be airlifted home as South African ministers held a special security meeting on Tuesday and promised to clamp down on illegal migration into the country. "With regards to hiring of undocumented foreign nationals, we will clamp down on private business owners who do not abide by the labour and immigration laws. Home Affairs, Police Service and department of labour will intensify inspections," the Justice, Crime Prevention and Security Cluster said. African News Agency

Zim to evacuate 171 people over violence

HARARE - Zimbabwe's Foreign Minister Sibusiso ivioyo tolu reporters in the capital riarare that the government planned to evacuate 171 people from South Africa, including the bodies of two people. Moyo added that Harare would 'escalate' the evacuation if the situation deteriorated and he was seeking support from international organisations to help those affected.

EFF rejects EWN's apology over Malema comment

JOHANNESBURG - The **Economic Freedom Fighters (EFF)** has rejected what it calls "the delayed lukewarm Eyewitness News apology," after senior reporter Barry Bateman was filmed, apparently swearing at party leader Julius Malema.

Bateman was among a group of journalists interviewing Malema outside the Hawks' office on Tuesday.

The EFF leader was summoned there to give a written statement about allegations that he discharged an automatic weapon during the party's 5th birthday celebrations in the Eastern Cape in 2018.

Responding to a question about an incident in which Malema allegedly got into an altercation with a security official at Winnie Madikizela-Mandela's funeral, the EFF leader responded, "A white, big white Afrikaner male, stopping me from burying Winnie Mandela? I had to be next to the coffin and no white man was going to stop me from burying Winnie. When Bateman asked if Malema had insulted the police officer, Malema responded "I wish I assaulted him. I wish I did a real thing, proper. I regret not doing it. I

should have done it so that I deal with real stuff. I'm not scared, boet. Uniform or no uniform. Afrikaner or no Afrikaner. White or pink, I will deal with you decisively".

Malema then walked away and video footage showed Bateman turning and mouthing what appeared to be "f***ing p**s".

Reaction on social media was swift, with Bateman and the phrase 'p**s'

Eyewitness News responded by "unreservedly apologising to the Economic Freedom Fighers leader Julius Malema for the foul language used by its reporter."

The news organisation said that Bateman was taken off air immediately after they were made aware of the video. An internal probe would be held to investigate the matter.

Responding via a statement, the EFF said, "The EWN must take concomitant action. Had it been a black journalist who would have insulted a white party leader, he would be under suspension with immediate effect. Bateman must be dealt with the same way and not be accorded the white privilege of kids' gloves."

XENOPHOBIC VIOLENCE

JOHANNESBURG-The wave of violence sweeping through Gauteng could have been deliberately designed to sink President Cyril Ramaphosa's administration and to reduce pressure on leaders tainted in the Commission of Inquiry into State Capture, political analyst Andre Duvenhage has claimed.

"We have been dealing with the issues of (anti-foreign-sentiments) blamed for unemployment, crime and drugs for the past 10 years. Why now when Ramaphosa had just returned from an important forum like the G7 (summit) where he took his investor drive?" he asked.

Duvenhage said it was also worrying that the violence erupted at the time when Ramaphosa was hosting more than 1,000 regional and global leaders at the 28th World Economic Forum on Africa in Cape Town.

The uprising was not spontaneous; there was an element of elite involvement in the violence and people did not just wake up and decide to burn their town - these attacks were well planned, Duvenhage said. The collapse of the crime intelligence made the attacks easy to plan and execute because the intelligence had no operatives in the hostels from where these attacks were carried out.

According to Duvenhage, who is also research director at the University of the North West, said "there must be an elite involvement" because there must be some form of trigger.

"This is part of the fight-back strategy... there is a lot of pressure on those fingered at the Zondo commission and we are going to see a lot of these (uprisings). Big things do not just happen without politicians involved. On the other end, it boils down to mass uprising by people dissatisfied with the government."

Duvenhage said the current diplomatic spat between Lagos and Pretoria, heat on SA's companies on the continent and international condemnation was exactly what the instigators wanted, as it embarrassed Ramaphosa and could scupper his investor-seeking efforts.

Mxolisi Makhubu, African Transformation Movement (ATM) spokesperson, said they strongly believed the unrest was a manufactured conflict, aimed at driving a wedge between South Africa and its neighbours.

Two of the 12 people killed in the violence, which left a trail of destruction in Pretoria, Johannesburg and

ANCYL presidential hopeful vows to tackle eThekwini service issues

JOHANNESBURG - African National Congress Youth League (ANCYL) presidential hopeful Thanduxolo Sabelo has vowed to tackle poor service delivery in eThekwini and get rid of underperforming contractors.

Sabelo was elected chairperson of the Human Settlements and Infrastructure Development committee in the municipality on Tuesday.

ANC top six to engage with protesters

JOHANNESBURG - The ANC has been forced into action to address the socio-economic grievances that precipitated the xenophobic violence in certain parts of the country.

After almost a fortnight of watching from the sidelines as government officials tried but failed to quell the attacks targetting foreign nationals of African descent, the ANC top brass met on Monday and decided to deploy its top six to deal with the concerns of the protesters this week.

They were hoping that addressing the causes of the strife would help to end the violence which has engulfed parts of Gauteng, KwaZulu-Natal and Mpumalanga since last week.

ANC Secretary-General Ace Magashule announced yesterday that the ANC top six would visit communities later this week. The top six comprised President Cyril Ramaphosa, his deputy David Mabuza, national chairperson

Gwede Mantashe, deputy secretarygeneral Jessie Duarte, treasurer-general Paul Mashatile and Magashule.

"The ANC calls on its members to play an active role in mobilising communities against violence, xenophobia and other forms of intolerance.

"It will work with communities and grassroots organisations to restore har- acts of violence," he said. mony and good relations to affected communities," Magashule said.

The countrywide visits to communities were aimed at giving impetus to the call for mobilisation against vio-

Political analyst Ralph Mathekga said the deployment of the ANC's top brass to talk to people on the ground was a good initiative.

"People need an honest response from the government. Of course, such efforts should have started earlier," Mathekga said. Magashule said the ANC had also heeded the calls to listen to the genuine grievances that South Africans have, which may be giving rise to frustration and anger.

"The ANC calls upon government and its social partners to accelerate efforts and work with greater impact to address the social and economic conditions of the people that fuel such

KZN stops hiring 'foreign doctors' to accommodate Cuban-trained locals

DURBAN - The health department in KwaZulu-Natal has put a stop to the hiring of foreign health professionals, particularly doctors, to accommodate Cuban-trained South African

An internal circular dated September 4, 2019 signed by the department's acting head of health, Dr Musa Gumede, states: "The Department has taken a decision to suspend the recruitment and employment of foreign health professionals in particular foreign doctors." The African News Agency (ANA) has seen the circular and verified its authenticity. It is addressed

to district managers, hospital managers, community health centre managers, institution heads and head office managers.

In the circular, Gumede says the decision to suspend the foreign professionals was taken because the department 'has recruited a huge number of South African citizens to be trained as doctors in

Some of the medical students were returning to medical schools around the country to complete their training, continued Gumede, and the department 'will not have sufficient posts and funds to absorb these doctors should the recruitment and employment of foreign doctors not (be) reviewed and suspended'.

The department also had a 'huge' responsibility to ensure the Cubantrained doctors were absorbed into the healthcare system in the near future, said Gumede.

"Planning ahead is therefore crucial for this project to be successful, bearing in mind the financial constraints in the filling of critical posts." The suspension would continue until further notice, concluded Gumede. In a statement issued last year as part of celebrations to welcome 260 Cuban-trained student doctors to KZN, the department said there were 2 885 medical students in Cuba who were at various levels of study.

"No fewer than 590 doctors have already qualified from the training programme, while 98 students are doing their final year at South African medical schools," said the

KwaZulu-Natal's then health MEC, Dr Sibongiseni Dhlomo, called the agreement to train South African students in Cuba "revolutionary" and a catalyst for the continued 'upskilling' of medical students. "For the first time, the student doctors would be placed in various hospitals throughout the province, as opposed to the erstwhile approach where their training was mainly concentrated in the metropolitan areas of eThekwini and UMsunduzi municipalities," said Dhlomo. African News Agency



'I'M NOT HERE TO DEFEND MYSELF'

JOHANNESBURG - Former SABC COO Hlaudi Motsoeneng told the Chairperson of the commission of inquiry into state capture, Deputy Chief Justice Raymond Zondo, that he had come to the commission to tell the truth and not to defend himself.

"I'm not here to defend myself, I'm here to tell you the truth, whether wrong or right," Motsoeneng told Zondo.

Motsoeneng said media reports on his testimony at the commission gave the impression that he appeared before the inquiry to defend himself.

He added that Zondo's findings would determine whether he had been wrong or right.

JOHANNESBURG - Accountability Now, warns VBS liquidators who could be in a long battle with former president Jacob Zuma.





TRIPLE-Idol-play cripples Steffi's game







DORTMUND - Borussia Dortmund have confirmed Manchester United did hold a meeting about signing Jadon Sancho in March.

Blues target £35 million swoop for Nice defender

LONDON - Chelsea could launch a £35 million bid for Nice defender Youcef Atal if their two-window transfer ban is lifted in January, according to reports.

The Blues have made a mixed start to the season, with a win, two draws and a defeat from their opening four league games leaving them 11th in the Premier League table.

Chelsea boss Frank Lampard has been concerned by their frailties at the back, which as seen his side ship nine goals already and is planning to strengthen his rearguard.

Lampard is keen to make a move for Nice defender Youcef Atal, but may not be able to secure his services until next summer.

Chelsea are currently banned from buying players as a result of a twowindow transfer ban for breaking rules regarding the signing of young players.

However, the club have contested the punishment and remain hopeful that the ban will be overturned, leaving them free to sign players in January.

Atal has emerged as a key player for Nice, who are managed by Arsenal legend Patrick Vieira, having joined the club from Algerian side Paradou AC in 2018.

He made 29 appearances for the club in 2018-19, while he's also

represented Algeria 13 times at international level.

If Chelsea are successful in their pursuit of the centre-back, he would provide competition for the trio of Kurt Zouma, Andreas Christensen and Fikavo Tomori.

LONDON - Chelsea are confident the hamstring injury Emerson Palmieri's suffered on international duty isn't serious - but he is doubt for Saturday's clash against Wolves.

The Italy left-back limped off in the eighth minute of their clash against Finland at the weekend causing concern that he could miss crucial games for the Blues.

Frank Lampard will make a late call on Palmieri's availability for the weekend visit to Molineux, but Blues medics are hopeful the defender is not facing a lengthy spell on the sidelines.

It is understood his substitution whilst playing for Italy was precautionary.

Palmieri felt his hamstring contract, but didn't feel a serious tear - nevertheless the Italians took the decision not to risk the full-back.

Chelsea staff may feel it is too much of a risk to play Palmieri against Wolves on Saturday, but there is hope he won't miss further games.

Meanwhile, young right-back Reece James is poised to hand Lampard a key injury boost by returning to full training.

James has missed the start of the season after undergoing ankle surgery in the summer - but he is due to recommence full training in the

The 19-year-old will be given the opportunity to make the right-back slot his own by Lampard, who is a keen admirer of James' abilities.

Cesar Azpilicueta is currently Chelsea's first choice right-back - but Lampard is understood to be keen to provide James with an opportunity to impress once he returns to full fitness.

The teenager was a target for a number of Premier League clubs in the summer - but Lampard insisted James had to stay at Stamford Bridge, a clear indication that he features in the Chelsea manager's plans.


ALIDAEI, MOVE OVER!

...Ronaldo destined to become international football's greatest scorer ever

VILNIUS - When Cristiano Ronaldo is at his free-flowing best, there is simply no stopping him in front of goal, something Lithuania found out the hard way on Tuesday night when the star attacker bagged four goals in a 5-1 win for Portugal.

The haul on Tuesday saw him add another record to his list.

With 25 goals scored, he has now become the all-time leading goalscorer in European Championship qualifiers.



coach Fernando Santos claimed post-match.

Bringing up his eighth international hat-trick in the process, Ronaldo also increased his tally of goals for his nation to 93 to leave him within touching distance of a record many thought would never be broken.

Iranian striker Ali Daei, who won a Bundesliga title with Bayern Munich in 1999, scored a remarkable 109 goals across 149 games for his country and that feat has long left him with the most international strikes by a single play-

Ronaldo, however, is now hot on Daei's heels and it's hard to see the Juventus star not claiming a record that would literally make him the greatest scorer of all time, on the international stage at least.

Against Lithuania on Tuesday, the 34-year-old proved his age is a hurdle he'll be capable of leaping over for a few years to come as he effortlessly found the back of the net four times.

From a seventh-minute penalty and a shocking goalkeeping error to a delightful curling effort and a tap-in, Ronaldo once again made scoring look far too easy on a cold night at the LFF Stadium.

Indeed, he could have scored

a few

more with the Portuguese star clearly not losing his unquenchable appetite for finding the back of the net.

If anything, age has only made Ronaldo hungrier and more efficient in front of goal. Over the past four years alone, he's scored a remarkable 33 goals for Portugal.

Now well and truly standing tall, you'd be brave to bet against the Juventus striker scoring another 17 in order to surpass a record Daei likely thought would be his for decades to come.

Speaking after his freakish performance against Lithuania, Ronaldo made it clear that performing for Portugal remains one of

PARIS - Michael Schumacher is "aware", according to an anonymous source at the Paris hospital where the F1 legend is currently being treated.

Le Parisien newspaper this week revealed that the former Ferrari and Mercedes driver was admitted on Monday to the Hopital Europeen Georges-Pompidou.

Reportedly, the 50-year-old, who was brain damaged in a 2013 skiing fall, will receive experimental stem cell treatment. The report said the treatment is risky. Almost nothing is known about Schumacher's condition - like whether he is even aware of his surroundings.

"Corinna and the family have kept a very tight control on information about his condition and his treatment which, I think, is a pity," said former Mercedes boss Nick Fry in his new book.

It means Schumacher's fans have to resort to unofficial reports and rumours for information. Italian newspaper La Repubblica quoted Milanbased biology professor Angelo Vescovi as saying he was "contacted by a person who knew Schumacher's family" some years ago.

"They asked if something could be done (for Schumacher)," he said. "At that time, we had made an attempt to inject the same cells we use for multiple sclerosis into the brain of a boy in a coma with quite good results. "At the moment, we can only make assumptions about what they are doing in Paris."

'Lukaku can easily beat Ronaldo'

MILAN - Romelu Lukaku will score more Serie A goals than Cristiano Ronaldo this season, according to former Inter attacker Andy van der Meyde.

After joining Antonio Conte's side from Manchester United for a clubrecord fee, Lukaku has hit the ground running in Italy, scoring two goals across his first two league games.

While managing just 12 goals in the Premier League last season for the Red Devils, van der Meyde believes Lukaku will shine in Serie A and can easily outscore Ronaldo.

"Lukaku is a fan of Italian football and I think he's made for this competition," van der Meyde told Juvenews.eu.

"He is strong and can score many goals. He has a very powerful physical structure and this will put all Italian defences in crisis.

"Lukaku can easily beat Ronaldo. He has always shown that he knows how to score wherever he has played, he is a pure centre-forward, while Cristiano plays most of the time out wide."

Ronaldo has shown no signs of slowing down in front of goal however, and after scoring four goals against Lithuania on Tuesday, is closing in on the record for most international goals scored by a single player.

In his first Serie A season with Juventus, the 34-year-old scored 21 times and already has one goal from two appearances this campaign.

With both Lukaku and Ronaldo set to supply plenty of goals, the league race looks like it could be tighter this season with Inter currently top of the table on goal dif-

ference.

After a strong summer of signings and with Antonio Conte at the helm, van der Meyde thinks Inter are on the right track but that Juventus will once again prove too strong.

"I think Conte is a good coach for Inter, which will bring stability and this is what Inter needs right now," he said.

"They chose the ideal coach to start over and get back to the top.

"I think the title will go to Juve. They are always the best there is in Italy, the one that has more quality and more players than everyone. I believe that in the end they will win again."

Neymar rape accuser indicted for extortion

SAO PAULO - Sao Paulo? police have moved to indict Najila Trindade? and her partner Estivens Alves over allegations of rape levelled at Brazilian football star Neymar back in May.

. Neymar has vehemently denied claims he raped the alleged victim in a Paris hotel room on May 15.

The woman claimed in a television interview with SBT Brasil that she exchanged messages with the 27-year-old on social media before meeting him at the Sofitel Paris Arc Du Triomphe.

She said she returned to Brazil two days later but was too emotionally shaken to report the incident until May 31.

Neymar subsequently posted an Instagram update in which he claimed the allegations were part of an extortion attempt.

Police in Brazil closed the investigation into the rape allegations in late July, with Sao Paulo police investigator Juliana Lopes Bussacos saying in a press conference: "I did not see enough elements to indict." That was followed by prosecutors in Brazil also finding a lack of evidence and announcing their decision earlier this month to



close the case against Neymar.

"We decided in favour of closing the case because there is insufficient evidence," prosecutor Flavia Merlini said at a news conference.

"The police investigator asked her to plug her phone into a computer so she could see the video [supposedly showing an attack], but she [the alleged victim] didn't want to do that. She also refused to hand over her phone, and later she said it had been stolen," co-prosecutor Estefania Paulin added. "The case will be closed as long as no new evidence is presented. If evidence comes up and we come to understand it is relevant and important, the case could be reopened." In Tuesday's announcement, police said they indicted the accuser (N.) for procedural fraud, slanderous denunciation and extortion, while adding that Alves has been indicted for "disclosing material with erotic content from N. to a reporter."

Beckham 'reaches out to Messi over move to Inter Miami'

MIAMI - David Beckham has reportedly 'reached out' to Barcelona forward Lionel Messi in a bid to see him become the star of his new Inter Miami side.

Beckham's club will launch in the MLS from March 2020 and the former Manchester United and Real Madrid winger is looking to make a statement of intent in his first season.

And according to Barcelona Radio host Xavi Campos, contact has been made with Messi about a switch to the US, after it emerged he can walk away from Barcelona for free at the end of

the 2019-20 season if he chooses.

Beckham has not been shy in setting out his dream transfer targets in the past after revealing earlier this year both Messi and Cristiano Ronaldo would be his preferred names to bring over to the MLS.

'Everyone has their wish list,' he said.
'But if you look at the way Leo and Cristiano are still playing, even at what you might think is the later stage of their careers, I don't see it ending for them.

'They're playing at such a high level that it's hard to see them leaving the clubs they are at. But we will see. You

never know what can happen in football.' Messi has not featured so far this season as he continues to recover from an injury picked up before La Liga got underway.

But all the talk around the five-time Ballon d'Or winner has surrounded news of Barcelona's decision to allow him to depart for free if he wishes to leave the club - such is their belief he will remain at the Nou Camp. 'Messi signed until 2021. It was agreed that at the end of the penultimate season he is at liberty to leave for free,' president Josep Bartomeu told Barca TV recently. *Daily Mail*







Allen's documents authethic - EFA

SOCCER - IN a rather twist of events, the Eswatini Football Association (EFA) has admitted that Allen Mabuza's documents are authentic.

The two documents that were questionable are an affidavit allegedly deposed by the first applicant (Allen Mabuza) and a sick note.

In founding affidavit papers, signed by EFA Chief Executive Frederick Mngomezulu it is stated that on August 30, 2019, he sent a letter to the Royal Eswatini Police Service Commission to initiate the authenticity of the documents.

He stated that the preliminary report was sent to the offices of his attorneys, the National Commissioner of Police, Mr. C.M Dlamini through a letter dated September5, 2019, reporting the affidavit in question had been deposed by unknown person and the stamp was illegally used.

Further, the commissioner reported that the force number reflected on the affidavit belonged to an officer who was stationed in Pigg's Peak.

"On or about the September 10 2019, between, I am advised and verily believed, by Mr. Sandile Mthethwa, article clerk at the offices of my attorneys, that he received a call from Pigg's Peak Station Commander one Sabelo Methula at around 3:30pm - 4pm inform-

ing him that surprisingly, the affidavit was authentic and was commissioned by an officer, who belongs to the Pigg's Peak Police Station, which is in contrast to the report the dated September 2019, signed by the National Commissioner. Sabelo Methula further undertook to file a report on the same on or before the end of business, September

"I further state that Sandile Mthethwa further informed me that the Principal Secretary at the Ministry of Health, through a letter dated the September 11, 2019, confirmed the sick sheet which its authenticity was initially questionable, is indeed authentic, much in contrast with the initial preliminary report," reads the affidavit that was signed by EFA Chief Executive Officer Mngomezulu.

The matter will be heard today at 9:30am before High Court Judge Nkululeko Hlophe after it was postponed yesterday. This was due to the fact that the parties were not ready to make their arguments since the matter is now consolidated.
