# 'SNAT SG DRIVING A POLITICAL AGENDA'

GOVERNMENT has accused Swaziland National Association (SNAT) Secretary General Sikelela Dlamini of pursuing a political agenda and warned him to stop misleading unsuspecting teachers.

Government's Spokesperson Percy Simelane in a strongly worded statement yesterday stated that as a matter of principle, government does not respond to illogical and populist utterances from people seeking relevance but will not shy away from stating facts on issues of national interest.

"We wish therefore to briefly put matters into perspective with regards to insults directed at the prime minister and government by the secretary general of the Swaziland National Association of Teachers (SNAT).

"The statement released by the PM is a government position and we stand by it. No amount of insinuations and insults will help government afford a Cost of Living Adjustment for civil servants in the current financial year.

### Constraints

"It is for this reason that government has availed herself to all social partners to bring forward their ideas on how to remedy the current fiscal constraints," the statement read.

Government states that it shall always be open to constructive criticism because it is a part of healthy engagement but shall continually advise against character assassination because it has the potency of drowning the initial message and

# What open door-SNAT

SNAT ridiculed the Government day, seven days a week. Even if spokesperson statement of government's open constructive criticism and being always open to engagement.

SNAT General Secretary Sikelela Dlamini said they appreciate the indication that government is always open to engagements.

"However, our government actions tell a different story because when they engage with us at the Joint Negotiating Forum (JNF) they seem as if they are not regarding us as social partners," he said.

Dlamini added that government negotiations are never in good faith. This is because if government offers 0.0 per cent consistently it means workers are not taken seriously in the country.

Dlamini denied any political agenda in workers demanding what they deserve, which is the 7.85 per cent Cost of Living Adjustment.

# **Ambitions**

"No political ambitions whatsoever are hidden in this honest workers' demand. It is also true that for the year 2018/2019 the CoLA was supposed to be 6.5 per cent and again civil servants were not given. In the current year the CoLA is 5.5 per cent although it has not been discussed and concluded at JNF. Government did not want the matter included in the agenda because they are saying they do not have money. It means salaries of workers are worse off by 19.9 per cent," he said.

Government states that it remains committed to implementing programmes and initiatives that will give the economy the necessary impetus to grow and afford the Cost of Living Adjustment for civil servants.

"As the Prime Minister reiterated, government's doors are open to PSA's to be part of the process of monitoring the performance of the economy on a quarterly basis, with a view of awarding a Cost of Living Adjustment for the financial year 2020/2021 if the economy improves," government stated.

The PM Ambrose Mandvulo

Dlamini further stated that the allegations against him are absurd as SNAT is a trade union that is registered in terms of the laws of the land and is a worker organisation whose members are educators who ply their trade within the borders of Eswatini. SNAT is not and shall never be a political party.

### Bargaining


"The government spokesperson is supposed to know basics with regards to collective bargaining of trade unions," he said.

He further stated that SNAT has clearly laid down objectives that form part of the navigational system of the 91-years-old educators' organisation.

"It is never about some individuals in SNAT or about the secretary general as Simelane puts it. Perhaps his inaccurate analysis has been caused by lack of clear understanding of the jargon used in the statement that was issued by the SNAT SG," he said.

Dlamini recently briefed Parliament that signs were that they may record an economic turnaround by the fall of the current calendar year.

However, on Friday he warned that if Public Sector Associations were hell-bent to proceed with their intended strike action it may delay that target. He stated categorically and repeated in this statement that government currently is in no position to offer any CoLA but instead committed itself from getting contributions from all stakeholders including PSAs on how to quickly turn the situation

# Emfuleni's Daladi reports threats on his life

EMFULENI lifestyle's owner's life is in danger as it is suspected that there are people after him.

It is reported that the renowned businessman, Sifiso 'Daladi' Dlamini, is targeted by a certain group of people who are up to no good.

After the shocking cold-blooded murder of football administrator and businessman Victor Gamedze in January 14, 2018 at Galp Filling Station, no businessman or person of note can afford to keep quiet when he gets reports of threats over his life.

Similarly, Dlamini seemed to have had enough of the stalking to the extent that he went on to vent on social media about the stalking and harassment he had been experiencing for quite some

In an interview Dlamini said it seems as if these people are after his every move. What irked the businessman the most was the fact that these stalkers do not even respect his place of business. Dlamini said there had been random people who would come to his business and ask his staff about him and his movement.

The businessman added that it was clear that these people were hired by certain individuals as they would even ask for his pictures from his staff.

He further alleged that he thinks his skin colour plays a huge part in the constant harassment because if he were not of colour his place of business as well as and success would be respected.

# Harrassment

Moreover, Dlamini said he does not only fear for himself but his staff members and customers.

The latest of this harassment Dlamini said was yesterday morning whereby two gentlemen arrived at eMfuleni Lifestyle which is a popular joint owned by Dlamini.

He said the guys were driving a South African registered VW red Polo. He said they asked his staff about his whereabouts as well as his photograph. This infuriated Dlamini as he quickly expressed his anger on his facebook page, which upsetted a number of his followers after which he suspended his account.

He said ever since he got the reports from his staff, he reported the incidents at the Lobamba Police Station. He said these two men follow another gang of four men who also came for the same mission in the recent past. Dlamini said in as much as the harassment has not stopped, he has the full cooperation of the police.

"Police are constantly conducting spot checks to ensure safety," he said.

He further expressed his gratitude to the police as he said they had shown willingness in apprehending whoever is behind this harassment and

Meanwhile, Chief Police Information and Communication Supt. Phindile Vilakati confirmed that the matter was reported to the police but no arrest had been made.

The emotional family member said that they were still finding it hard to accept the news of their father's death and it was really a hard time for the family.


"As you can see my brother everything is not okay. We are still trying to come to terms with all of this," he said.

He was reporting to the council on whatever issues related to the Jewish faith that happen in Eswatini and coordinated meetings for the Jewish community since he also doubled as a local president having assumed the position over 15 years ago.



# SNAKE DISCOVERED IN SHOPRITE STOREROOM

EMPLOYEES at U Save Shoprite in Pigg's Peak were shocked to discover a one-metre long snake slithering inside the shop's locked storeroom.

The reptile was spotted by two Shoprite employees who when interviewed asked to remain anonymous after having spoken to management. After seeing the snake slithering under multiple boxes of comflakes, the shocked employees ran to the nearby shop owned by Asian businessman and snake catcher, Sharafat Ali Shafi.

They asked Shafi to help retrieve the snake. The employees said they had no idea where the snake came from as the storeroom was always locked.

### Located

"The storeroom is located in a basement behind the actual shop. It has one large door that is always locked, hence we have no idea where the snake came from. We suspect that it slithered inside while we were receiving stock on another day. However, while packing the cornflakes boxes, we saw the tail of the brown snake slithering under a box." Shafi took a broomstick before heading towards the locked storeroom.

He entered the store-room and soon located the snake in a corner under many boxes. He used the broomstick to pin the snake down and retrieved it using his bare hands.

Shafi confirmed the incident and said the snake, which he could not identify, will be released at a secluded area near Bulembu.

"The snake was about one metre long and brown in colour. I retrieved it safely

without hurting it or myself. I will release it back into the wild in a safe area near Bulembu on Monday," he said.

When asked for comment, U Save Shoprite Pigg's Peak management said they were not permitted to speak to the media as their head offices are located in the Republic of South Africa (RSA).

Chief Police Information and Communications Officer (CPICO) Superintendent Phindile Vilakati said the police heard about the incident but no official report was made by the shop.



# Natural resources spends E17m on review of Oil Reserve designs

MINISTRY of natural resources and energy spent E17 million to review the Strategic Oil Reserve project designs.

Senate Deputy President Ndumiso Mdluli enquired about the total cost for the review of the strategic oil reserve facility designs, as well as why the ministry reviewed the designs as they were previously reviewed by a previously contracted company.

This was derived from the report of the ministry of natural resources and energy portfolio committee debate of the ministry's first quarter performance report. Mdluli also enquired about the status of the previously contracted company and why the ministry was sourcing a loan for the construction of the facility because Parliament had mandated the previous contractor to source funding and gave the company a loan guarantee.

Minister Peter Bhembe said the ministry had partnered with the Republic of China (Taiwan) through the government to government cooperation on energy in the review of the designs and the cost of the review was E17 million.

He stated that the previously contracted company did not review the designs. He said government conducted a feasibility study in

2005 and came up with preliminary designs for the facility. "It became necessary, therefore to detail and update the designs before construction of the facility could commence," he said.

He added that the previously contracted company could not perform or construct the Strategic Oil Reserve facility since the signing of the first contract in 2014, hence the lapse of the contracts in 2017.

### Model

He mentioned that the model of contracting private companies to build, own, operate and transfer the facility could not work and has seriously delayed commencement of the project as the companies failed to raise the funding. He stated that government was exploring the option of getting assistance through cooperation with the Republic of China (Taiwan) which was promising to deliver the results on time.

Bhembe added the Republic of China (Taiwan) would assist the ministry with securing the loan through the government to government co-operation at a discounted rate. He added that a national petroleum company was being operationalised which would operate the facility.

He said the benefit of the model, which was also implemented in other SADC countries, was that the government got to control the strategic stocks from the onset.

# PM's office develops system to monitor economic recovery strategy

THE office of the prime minister has developed a Performance Monitoring Framework to ensure the implementation of the economic recovery

With the country moving in the direction of economic recovery, the prime minister's office has found the need to establish a performance monitoring framework to ensure all ministries were pulling in the same direction towards resuscitating the country's frail econo-

This was contained in the Senate report of the prime minister's office portfolio committee on the debate of the min-

istry's first quarter performance report. This submission was raised by a question posed by Senator Sylvia Mthethwa. The senator stated the initiative of the performance monitoring framework was a good one. She enquired when it would be introduced in government

In response, Prime Minister Ambrose Mandvulo Dlamini said the monitoring framework was developed initially by the Policy and Performance Coordination Unit (PPCU) under his

office prior to the arrival of a team of experts under a technical assistance support programme provided by the European Union to assist in the implementation of the Eswatini Strategic Road Map (2019-2023).

He said the terms of reference for the technical assistance team included a review and development of existing performance management, planning, monitoring and reporting systems and tools to ensure efficiency and effectiveness in the implementation of the economic recovery strategy.

Also assistance with the integration of results based monitoring and evaluation into all government annual and quarterly plans and reports.

# Experts

"The team of experts have since commenced their work and one of the deliverables of the experts' assignments is a revamped performance monitoring network. This will then be fully implemented within the entire government system," said the PM.

He added the EU team had so far developed a template for the preparation of ministerial strategic plans and implementation plans which aligned with the Eswatini strategic roadmap. He added presently government ministries were refining their strategic plans in line with the new template.

He also mentioned the PPCU developed performance monitoring framework would be incorporated under the revamped performance monitoring framework and fully implemented as soon as it was ready.

# Man hangs himself near Maguga bus stop



# SHOT PUPIL BACK IN CLASS

BY BONGIWE DLAMINI Manzini

THE 20-year-old pupil who was allegedly shot by the police during the Epic Gig returned to class for the first since she came back home from a South African hospital.

The bullet is still lodged in her body.

Xolile Mthembu, a Form Four pupil of St Mary's High, was shot by a stray bullet during a mayhem that occurred at an event held at Mavuso Trade Centre in May.

As a result of the incident, Mthembu spent five days at the Raleigh Fitkin Memorial Hospital, where doctors failed to extract the bullet from her body, claiming that it is too close to the heart, before she was transferred to the South African hospital, courtesy of Phalala Fund.

Information was to the effect that the bullet was allegedly fired by a police officer after some hooligans started engaging in barbaric behaviour by hurling bottles to the stage and vandalised property. When this happened, it is said the lights were off on stage due to the pushing and shoving that occurred when famous South African artist Mlindo the Vocalist performed.

This forced police to call for the riot squad, which came fully armed with riot gear, including teargas canisters and rubber bullets. The police tried to disperse the crowd using teargas and rubber bullets which ended up injuring some people.

For Mthembu it was a different story altogether as she was hit by a live bullet that is suspected to have been from a police officer's service gun.

At first, it was argued that she was only injured by a rubber bullet only for a medical report to confirm that it was a real bullet.

Before leaving for South Africa, Mthembu had informed this publication that she was standing next to one of the halls at Mavuso when she heard a loud bang as police dispersed the rowdy crowd.

Shortly thereafter, she said she felt her body becoming numb and she fell to the ground. At that moment, the scholar said her friends who were next to her thought she was merely being frightened by the gunshot and tried to get her back on her feet. To their shock, her friends saw that she was bleeding from the back.

It was then that it was discovered that she had been shot as there was a bullet wound on her shoulder. Xolile said she couldn't feel her feet and her clothes were soaked in blood.

In an interview with her mother; Futhi Motsa, yesterday, it transpired that she only returned home from South Africa in July and could not walk on her own. Although she had improved with the assistance of medication she obtained from the health centre, but her life has not been the same

in that she no longer can walk for long distances. When she walks for longer distances, she becomes weak so much that she has to relax before being able to walk again. The distraught mother said doctors informed her that this was caused by the

fact that the bullet also affected her lungs.

"She was weak after she returned home so much that she could not even go to school until this week," Motsa said.


On the same note, the mother said her daughter missed out on several lessons last term as well as the mock examination. In a bid to assist her, the mother said she was scheduled to start physio therapy soon. Even so, Motsa said she still wanted answers as how her daughter could be assisted or even be compensated by the police service as it was alleged that an officer of the law was responsible for her daughter's injury.

She said she had engaged the Manzini Regional Commander about the matter and a response she got was that the police service had nothing to go on since the service banked on the bullet that is in Mthembu's body to provide proof that it indeed belonged to the police service.

She further stated that she was confused as to where she could go for assistance regarding the matter because she wanted justice to be served.

When sought for comment, Deputy Police Information and Communications Officer Inspector Nosipho Mnguni confirmed having received reports of her return. She said after the incident, the police had an attempted murder case opened and still investigating.

When asked whether or not the police were responsible, Mnguni said the police had nothing to go on because there was no new piece of evidence that could be used to link the police to the allegation.

# I have learnt my lesson – intoxicated driver

# Defiant Quantum driver slapped with E4 000 fine for overloading

**SENIOR Magistrate Sindisiwe** Zwane issued a stern warning to public transport drivers for overloading passengers, saying it puts passengers' lives at risk.

Ntokozo Shongwe of Eteni, Matsapha was slapped with a fine of E4 000 for overloading and failure to adhere to police instruction when he refused to offload passengers when ordered to do so.

Shongwe was charged with the offense of contravening Section 27 (1) as read with Section 32 (1) (c) of the road traffic Act 2007 in that upon September 14, at about 1700 hours at or near Care Bears MR 27 public road in Manzini district, being the driver of a public service motor vehicle a Toyota Quantum registration Number ISD 369 BH did wrongfully and unlawfully exceed the motor vehicle capacity, which is 14 passengers, and permitted 19 passengers to board the said motor vehicle overloading with five passengers, thus contravening the Act.

In the second count, Shongwe failed to comply with police instruction by refusing to offload the overloaded passengers when told to do so by the police.

In his mitigation, he pleaded with the magistrate to be lenient in passing sentence. Magistrate Zwane said she would not be lenient as he showed disregard and disrespect to the police by refusing to adhere to their instructions when he refused to offload the overloaded passengers.

The accused was arrested on Saturday near Eteni driving an Isuzu LDV where he wrongfully and unlawfully drove the

vehicle while under the influence of intoxicating liquor. His alcohol reading was 1.00mg/l which is above the legal limit of 0.38mg/l.

In the second count, the accused is said to have negligently reversed and knocked another motor vehicle which was a Honda

The particulars of the negligent driving were that the accused drove without due care and attention and failed to apply breaks timeously.

The accused is also said to have failed to avoid an accident which a reasonable driver could have avoided.

The accused said his friend had taken

one too many and asked him to drive his car which led to the unfortunate accident. "I was just trying to do the humane thing, my friend asked me to drive his car as he was more intoxicated than I was," he said.

Magistrate Zwane said everyone was aware that driving while under the influence of alcohol was against the law and should be avoided. She also said had the accused been sober, he would have been able to avoid the accident and due to the accident.

The accused was sentenced to two years imprisonment with a fine option for E 2 000 for drink-driving and eight months imprisonment with a fine option of E 800 for negligent driving.

The proposed settlement will settle the claims against the participating gold mining companies arising from the class action that was initiated before the High Court for:

- · the harm and loss suffered by mineworkers who contracted silicosis and/or TB during their work on certain gold mines in South Africa, and
- the harm and loss suffered by the dependants of mineworkers who died of these

The settlement was approved by the High Court in Johannesburg on 26 July 2019.

# WHO IS INCLUDED IN THE SETTLEMENT?

You are a class member, and will be included in the settlement, if you meet all the requirements of any of the four classes:

- who as at the date when the settlement agreement comes into force, have undertaken risk work. In terms of the settlement agreement, risk work means "risk work" as defined in the Occupational Diseases in Mines and Works Act, 1973 or any of the following work:
- and workings of (i) work in the undergr
- (ii) work in a laundry where clothing of underground mineworkers is washed: (iii) work on a slimes dam of a gold mine; (iv) work in an assay laboratory of a gold mine where the composition of gold
- bearing ore is analysed, and where the mass of respirable dust from personal sampling is determined; (v) work in a metallurgical plant of a gold mine, including crushing, milling,
- transporting and smelting of ore; and (vi) work at conveyor belt operations which are undertaken to convey broken rock
- from the underground operations of a gold mine to surface: who on or before the date when the settlement agreement comes into force. have contracted silicosis or have been exposed to silica dust.
- who undertake or have undertaken risk work on one or more of the mines listed in Annexure A of this notice after 12 March 1965; and
- 4. who did not settle their claims in previously finalised settlements with Anglo American South Africa Limited and AngloGold Ashanti Limited on 14 March 2016 and Angio American South Africa Limited on 19 September 2013. respectively.

The settlement is not yet in force because some of its conditions have not yet been met. If the conditions are met, the participating gold mining companies will establish a fund, called the TSHIAMISO TRUST.

- The participating gold mining companies will pay agreed contributions to the Tshiamiso Trust and the process of paying compensation can start.
- · All class members can submit a claim to the Tshiamiso Trust for monetary compensation, except for those class members who opt out of the settlement.
- · Details of how to submit a claim to the Tshiamiso Trust will be published in the media and on the website www.silicosissettlement.co.za.
- The Tshiamiso Trust will pay compensation to eligible claimants. An eligible claimant is a person who is a member of any of the classes and who meets the requirements of the Tshiamiso Trust to receive monetary compensation.
- · Class members must submit a completed claim form to the Tshiamiso Trust and may have to undergo a medical examination to determine if they are eligible claimants. Once the settlement agreement is in force, eligible claimants will be entitled to receive

a once-off payment of between R10 000 and R250 000, depending on the nature and seriousness of the disease. In certain exceptional circumstances, this amount may be increased to up to R500 000.



# Govt to ensure rights of elderly, disabled are promoted - DPM

GOVERNMENT is working towards the process of ensuring that the protocol on the rights of elderly persons are signed and ratified in support of the advancement of issues of elderly persons and persons with disability in the country.

This was revealed by Deputy Prime Minister Themba Masuku during the advocacy meeting on the Kingdom of Eswatini's ratification of the protocol on the rights of older persons and the protocol on the rights of persons with disability held at Lugogo Sun last Thursday.

DPM was represented by the Minister of Justice and Constitutional Affairs Pholile Shankantu.

Lesotho was cited as the only country in the SADC region to have signed and ratified this protocol, while Eswatini is determined to be

Masuku said the Constitution of the kingdom of Eswatini recognises the rights of elderly persons, and further obligates the government to make a reasonable provision for their welfare and maintenance of older persons as articulated in Article 60 (5) of the Constitution.

The Constitution also provides for disability mainstreaming issues in Section 30 subsection (1) where it articulates that persons with disabilities have a right to respect and human dignity and that the government and society shall take appropriate measures to ensure that those persons realise their full mental and physical potential. It also articulates that Parliament shall take measures to ensure that those persons realise their full mental and physical potential.

"From the majority of people, older people, old age in itself brings income insecurity, food insecurity, increased vulnerability to abuse, and psychosocial challenges. This in turn means that a significant number of elderly people are not able to meet their basic needs," Masuku said.

He said many older persons are now caring for grandchildren whose parents have died as a result of the burden of diseases, such as HIV and AIDS, non-communicable illnesses among others. He said there was therefore a need for continued support for older persons to enable them to meet their basic needs, as appropriate.

The DPM continued to say with regards to issues of persons with disabilities, the country has been able to put in place an enabling environment through a number of policies and programs such as the ratification of the United Nations Convention on the Rights of Persons with Disabilities, Adoption of the National Disability Policy of 2013 and the Eswatini National

Disability Plan of Action of 2018 – 2022 with clear monitoring and evaluation framework and clearly spelt out indicators of achievements across its thematic areas, as well as its costing to advise on the levels of investments required to implement the plan appropriately.

"It is worth mentioning, that the undertaking of this important meeting on the ratification of the aforementioned protocols has come at an opportune time when the country is preparing for the signing and ratification of these protocols to ensure that Eswatini continues supporting issues of older persons and persons with disabilities, as appropriate," he said.

In addition, Masuku said it was based on this conviction that, with all these instruments in place older persons and person with disability will be accorded their rightful place in society and they shall be empowered to contribute toward the development of the country.

# Call for Eswatini to implement legislative frameworks

Gama said these frameworks can play a vital role in disability issues in the country as the democracy of these instruments have made it extremely difficult for the disability institutions to operate such that it is hard to realise the presence of such organisations. He stated that according to the provisions of the Disability Act, they have noticed with regret that

Gama concluded by urging other private sector organisations, religious and faith-based organisations and other stakeholders to continue partnering with government to take decisive steps towards improving the livelihoods of people with disabilities.

# Cotton Board welcomes GMOs

THE Cotton Board is eagerly waiting for the successful amendment of Section 32 of the Biosafety Act of 2012 which will see the introduction of Genetically Modified Organisms (GMOs).

This section of the Biosafety Act of 2012 was only implying that the producer of the GMOs seed was to be the only one liable in case anything went wrong in farming of that seed and if it is amended this will mean everyone in the value chain will be responsible for liability. According to the Chief Executive Officer of the Cotton Board Daniel Khumalo, the issue of the GMOs has been long overdue and the Biosafety Act came about as a result of cotton farmers showing interest in using the GMOs like in South Africa.

Khumalo said the GMOs cotton seeds were introduced by South Africa in 1996 and Eswatini cotton farmers were interested in it as it proved that it has lower cost than the one they were used to. He said in terms of maintenance it is very good as it is genetically made which means there is less to spend in buying chemicals to control pests. He said cotton farmers will gladly appreciate the introduction of these GMOs in the cotton industry as it will increase yields and will see them producing high quality cotton that will meet international standards.

Khumalo mentioned that this kind of seeds will mean that farmers will have to spend less in growing it as there will be less need to weed or control pests because it will be treated from the manufacturer.

"This will mean that farmers will now not spend a lot of money in hiring people who will weed their cotton fields as the seeds that they will be growing will be weed free," he said.

This is going to help cotton farmers to maximise their profits and the issue of applying pesticides will be a thing of the past because the current seeds that they use they usually spray the cotton around eight times in one season depending on the duration of that planting season. He said the profit margin for farmers will be very high and they will be able to contribute to the country's economy of the country. "Cotton farmers have always been interested in this since 1996 but the problem was the Act, which is why it need to be amended," he said.

Khumalo stated that when the local farmers shown their interest in using GMOs the producers of the technology urged them to go and come up with a legislative framework that will govern its use and that's when Eswatini came with the Biosafety Act of 2012.

"Farmers have been capacitated with handling of the GMOs since 1996 and I can assure you that if you can ask any cotton farmer about this you will find that they are all well aware of this Act and the GMOs," said Khumalo.

When reached for comment well-known cotton farmer Boy Matse said they can be very happy if the amendment of the Act can come through as this will help cotton farmers in a very positive way. Matse said the introduction of GMOs can be a solution to the cotton industry given the fact that they have talked a about it for a long time. He said with the use of GMOs costs will be minimised as there will be less worry in hiring people to weed the fields.

"The GMOs will help us as farmers to produce high quality cotton in a short space of time and this will mean that we will spend less on buying pesticides," Matse said.

He made an example with the rainy days where he said cotton is usually affected by worms if it is subjected to too much rain and weed grow so fast which on the other hand deter good pro-

# ESWATINI IS OPEN FOR BUSINESS

# 1. Business Environment and the National Quality Infrastructure (NQI)

A healthy business environment can be essential for growth and poverty reduction and a prerequisite for trade and competitiveness. The Quality Infrastructure (QI) is an important element of the business environment. Hence, business environment initiatives without considering QI reform may be incomplete.

### 1.1 Business Environment Initiatives and Quality Infrastructure

The business environment can be defined as the complex of policy, legal, institutional and regulatory conditions that govern business activity. It is a subset of the investment climate and includes the administration and enforcement mechanisms established to implement government policies, as well as the institutional arrangements that influence the way key actors operate, such as government agencies, regulatory authorities, and business membership organisations.

The business environment clearly has an influence on the development of the private sector, and thereby on economic growth and the generation of livelihood and jobs. Business environment reform promotes the development of markets that encourage healthy competition and enhances the effectiveness and sustainability of development interventions. Business environment reform is multifaceted, operating on many levels and involving a very wide range of stakeholders.

# 1.2 The Quality Infrastructure - Overview

The QI is generally understood to be the totality of the policy, legal, regulatory and administrative frameworks and the institutional arrangements (public and/or private) required to establish and implement standardisation, metrology (scientific, industrial and legal), accreditation and conformity assessment services (inspection, testing and product- and system certification) necessary to provide acceptable evidence that products and services meet defined requirements, demanded either by authorities (e.g. in the case of technical regulation) or the marketplace (e.g. contractually or inferred).

It is important to understand that the consisting of a number of institutions or service providers, can only function properly as a whole; the incompetence or absence of any one of the constituents will compromise the effectiveness and ultimately the efficiency of the whole system, thereby negatively impacting the business environment. The foundational parts of a QI are the standards, technical regulations metrology, conformity assessment activities and accreditation organisations/institutions without which none of the other elements will

be able to function properly. Because of their importance, it is imperative that governments play an active and continuous role in the establishment and sustainability of these institutions. They provide services which oftentimes are not targeted at a specific beneficiary that could be made responsible for their financing.




Figure 1 below illustrates how the QI cascades.




Figure 2: Flow of products or services to global markets

borders; the quality of products and services is therefore a key determinant of private sector performance as it allows companies to compete, conform to market requirements and connect to markets -see Figure 2.

During his appearance before Magistrate Lenhle Zulu last Thursday, the prosecution applied for Nkambule to be remanded into custody until September 20, 2019, pending his trial date.

The prosecution further informed the court that bail was not opposed, prompting the court to grant Nkambule bail amounting to E3 500.

# 'Crime does not pay'

A man who attempted to use his poverty situation as an excuse to dabble in illegal dagga related activities was warned against it by Magistrate Lenhle Zulu last Thursday.

Sifiso Mnisi has been fined E4 000 or alternatively serve two years in a correctional facility for being in possession of eight kilogrammes of dagga.

Mnisi was arrested and charged with contravening the Pharmacy Act after he was found to have been in possession of dagga at Malanti last Wednesday.

According to investigating officer, Detective Constable Mxolisi Thole, he received a tip off that there was illegal dagga activity at Malanti, to which he proceeded to investigate.

"When we arrived at a homestead at Malanti, we found a man sitting inside his house. When we knocked on the door, he opened for us with no qualms.

However, once we proceeded to search the house, we discovered that there was dagga drying on the roof rafters.

After it was ascertained that Mnisi did not have a permit or licence to be in possession of the illegal substance, that was when we arrested Mnisi," Thole explained.

At the time of his arrest, law enforcement officers packed the dagga found, in two sacks and proceeded to the police station, where it was weighed and Mnisi formally charged.

During his appearance before Magistrate Zulu, Mnisi pleaded guilty to the charge of dagga possession. He said his motive for possessing the dagga was poverty.

"I am unemployed so I needed some money. In my desperation, I decided to sell dagga to feed my family.

My friends are the ones who convinced me that it was a lucrative trade and I did not waste time in involving myself in it," Mnisi claimed.

Magistrate Zulu warned Mnisi against using illegal practices to make money.

### Sentenced

"Mnisi, crime does not pay. We are well aware that the unemployment rate is high in the Kingdom, however it does not justify committing a crime to earn a living," the magistrate emphasised.

After hearing his mitigation, presiding Magistrate Zulu sentenced Mnisi to pay a fine of E4 000 and in default of payment, serve two years in a correctional facility.

Mnisi was further informed that the eight kilogramme consignment found in his possession would be confiscated by the state for the purposes of destruction.

# Hawkers back in business

EMASWATI hawkers have bounced back in business as the xenophobic chaos in South Africa has died down.

This was confirmed by Phandzela Umntfwana Association Chairperson Mabhawodi Dlamini in an interview. He said some of the association's members had gone to Durban last Monday and had since returned with their stock. It is said the association has members who purchase their stock from Durban and Johannesburg.

On Monday the chairperson informed this publication that the trip association members usually took to buy their stock in Johannesburg had to be cancelled due to the intensity of the chaos that happened there two weeks ago.

According to Dlamini, he had received some information from a local transport driver who had driven some hawkers to Johannesburg to replenish their stock and had returned home empty handed.

He said this was because the shops from which they bought their stock were closed as a result of the attacks.

Taking advantage of this situation, some people with ulterior motives are said to have targeted the women who had gone there for business by stealing their properties while they queued in traffic jams.

However, on Tuesday, the chair-

person said there were reports that the coast was clear in Johannesburg meaning that hawkers could conduct business as usual. He added that some of the association members were set to leave the country for Johannesburg last night.

Other independent hawkers who were contacted on the matter confirmed the latest developments regarding the green light they have received from their colleagues in South Africa.

One of the hawkers who preferred anonymity said she was supposed to go to Johannesburg last Tuesday but had since cancelled her trip after the news that the situation had culminated to physical attacks on almost all foreigners.

"I am leaving today (Thursday) and if all goes well I will return the following day. I have decided to leave on this day because I've been advised that the situation has normalised again," she said

Even so, the businesswoman said she was greatly affected by the South African chaos in that she could not deliver to her customers on time as some had placed orders with the hope that they would have received their items by now.

# Widow gets 3 years for dagga possession

ON the other hand, a woman also faced the wrath of the law after she was found to have been in illegal possession of dagga and dagga seeds.

Nomcebo Dlamini was arrested and charged with contravening the Pharmacy Act on two counts, after she was found to have been in possession of 5.8 kilogrammes of dagga.

She was also found to have been in possession of two kilogrames of dagga seeds.

Dlamini was found to have been in possession of the illegal substances on April 11, at Ekufikeni. During her appearance before Magistrate Sifiso Vilakati, Dlamini practiced her legal right to representation and was represented by an attorney.

In mitigation, Dlamini's attorney informed the court that she was a widow who was solely responsible for the well being of her two minor children.

## Default

After hearing her mitigation, Magistrate Vilakati sentenced Dlamini to pay a fine of E2 000 and in default of payment, serve two years in prison for being in possession of dagga.

She was further sentenced to one year in prison, with the option to pay a fine of E1 000.

# Moza man troubled by thieves steals padlock at Shoprite

A Mozambican man (33) who stole a padlock at Mbabane Shoprite has been sentenced to five months in custody by the Eswatini National Court.

Rodgers Msibini did unlawfully and purposefully steal a padlock valued at E109 while at Mbabane Shoprite. The item was in the rightful custody of Zwelithini Dlamini, who then went to report the matter to the police.

The incident happened at Mbabane Shoprite on September 10.

The defendant pleaded guilty to the offence.

Leading evidence, Dlamini told the court that while he was on guard at the Mbabane Shoprite, the accused entered the shop and viwed the different store sections. He also told the court that it was not the first time the accused had tried to steal at the shop.

He then told court that the accused once tried to steal four other padlocks from the same shop but failed when he showed up. "Your honour, while doing my duties at the Mbabane Shoprite, the accused entered the shop and he scanned the different sections in the shop. He then went to the security and protection section, where he took a padlock and hid it in his underwear. When he put the padlock in his underwear, I then took cover so he could

Leading evidence, Dlamini told the court that while he was on guard at the Mhabane Shoprite, the accused that he be searched," said Dlamini.

Dlamini then told the court that the accused at first refused to be searched. "Your honour, when we discovered the padlock in Msibini's underwear, I then asked him to pay for it.

However, he told me that he had no money.

I then took him to my manager, who then told me to go and report the matter," said Dlamini.

During cross examination, Msibini told the court that he had no questions for Dlamini.

Dlamini then told the court that Msibini said he wanted to use the security device to stop thieves gaining entry



at his apartment.

During mitigation Msibini told the court that his door was broken and thieves kept on stealing from him.

He told the court that he was going to use the security device to lock his door.

"Your Honour, my padlock is broken and thieves are stealing parcels at my house. I usually go to Mbabane Shoprite to buy materials.

I plead with the court to please give a lighter sentence since I have two children who look up to me," said

Msibini was then sentenced to five months in custody with the option fine of E500.

# EMASWATINOT APPRECIATEDAS TOURISTS LOCALLY

EMASWATI do not feel appreciated as tourists when they visit local tourist attraction sites.

According to a Domestic Travel Survey that was conducted by Eswatini Tourism Authority (ETA), Emaswati feel more appreciated when they go out of the country.

Over 2 000 locals participated in the study. ETA Research and Statistics Officer Sebendzile Ginindza said the Domestic Tourism Survey sought to gain insight on the travel choices and preferences of Emaswati in their engagement with the local products.

Ginindza stated that the survey took only six weeks, whereby a total of 2 006 locals were asked to share their views.

"They were asked to provide information relating to factors that influence their choices of traveling through telephone interviews," she said.

The demographic groups of the research were Emaswati between the age of 21 years and earning an income of at least E32 000 per annum, and being able and willing to travel.

The research shows that 65 per cent of Emaswati travel. Most of them travel for weekends instead of one night travels. She stated that the choices of the places of travel are influenced by the activities available in that place of visit. "Events have been ruled out as one of the motivations to travel in an unusual environment," she said.

The unusual environment is 10 kilometres from where you are residing.

Ginindza said 35 per cent indicated that they dot travel yet they consider themselves as tourist largely because of their experiences.

She added that one major comment they made was that when they visit South Africa or Mozambique they are made to feel like tourists because of the treatment they experience. They said when they visit locally they are not valued in local tourist destinations.

"They consider a holiday for them to be out of the country," she said.

Therefore, she said there is a need a need to engage with product development and marketing that will

feature on how they can provide best survive and Excellency to Emaswati.

In terms of spending, Ginindza said part of the 35 per cent do not expect to spend more than E2 000, and they mostly travel when there are specials or discounts with the local industry. She highlighted that they even picked it on the figures they collected in these places of interest.

The research officer said in the survey they discovered that Emaswati travel as families or friends, thus meaning they travel in larger groups instead of individuals or couples. She mentioned that the findings of the survey are fundamental in informing development

# STATEMENT ON THE CURRENT IMPASSE BETWEEN SUFIAW AND ESRIC

Since the 27th August 2019 members of the Swaziland Union of Financial and Allied Workers Union, SUFIAW (the Union) at ESRIC have been embarking on a strike action. The said strike relates to the implementation of the 2017 job evaluation and salary review exercise. Management does not believe the strike action is necessary or warranted. Nonetheless, Management has activated a comprehensive contingency plan and measures to ensure minimal disruption to operations and services provided to clients. Management would like to make the following clarifications and context to all stakeholders:

# Background

The Remuneration Policy of the Corporation stipulates that a market remuneration survey and review will be done every three years and the remuneration structure may be adjusted in accordance with the market remuneration survey data.

A Salaries Review was due in 2015 and following the Board's approval of the exercise, Management engaged with the Union on the matter. At the time the Insurance and Allied Undertakings Workers' Union (IAUWU) was the representative Union.

Whilst the matter was being discussed Management was later to be informed that IAUWU was being dissolved. Despite this development Management felt obliged to proceed with the exercise considering that not all employees were in the bargaining unit and not all employees were members of the Union.

Camphor Consultants (Pty) Ltd proceeded with the exercise and the report was presented to the Remunerations Committee of the Board for approval. After the Swaziland Union of Financial Institutions and Allied Workers (SUFIAW) was recognised by ESRIC and a collective agreement signed, the Union put on table the discussion of a salaries review. Management presented the Camphor report which had been approved by the Board, however, the Union categorically rejected the report prepared by Camphor Consultants, refusing to even reading the report. The Union presented a request to Management that a fresh job evaluation and salary review exercise be undertaken where the terms of reference and the consultant would be agreed upon between the Union and the Corporation. Without setting a precedent and for purposes of maintaining good industrial relations, Management made a recommendation to REMCO that the request by the Union be acceded to and a salary review exercise be undertaken in 2017 in respect of only employees in the bargaining unit of the Union. This was to ensure transparency in the selection of the consultant and the terms of reference. Through consensus Deloitte Consulting was therefore appointed to undertake the exercise based on previously agreed terms of reference.

# Results of the Exercise

Based on the market data, the Consultants developed a new pay scale. Some employees were found to be falling below the minimum of the recommended pay scale. The recommendation therefore was to move those identified employees to at least the minimum of the recommended pay scale. A monetary amount per annum was determined how much it would cost to make the necessary adjustments. This adjustment was to be backdated to January 2017.

# Presentation of the Report

The Deloitte Consultants presented their report to both parties including the

recommendations made. Subsequent to the initial presentation by the Consultants, the Union sought further clarifications which were duly given by the Consultants on several occasions.

# Dispute

Surprisingly, the Union declared a dispute against ESRIC in June 2019. The main contention was that Management was "refusing to negotiate" the implementation of the job evaluation and salary review report. After a number of CMAC representations CMAC issued a certificate of an unresolved dispute in June 2019 after not being able to reach common ground.

It must be noted that a certificate of an unresolved dispute does not imply that one party is correct and the other party wrong. It means that the parties could not find a middle ground and gives permission to the Union to withdraw their labour.

# Series of Engagements

Prior to the commencement of the strike, ESRIC conceded to yet another request by the Union to have Deloitte Consultants come and give further clarity to questions the Union had on the report. Notwithstanding this, the Union proceeded with the strike action.

In spite of the on-going strike, parties have had a series of meetings with a view to finding a solution to the impasse. In the last meeting the Union presented a proposal that another consultant be engaged to analyse and interpret the report by Deloitte Consultants. This proposal was not acceptable to the Corporation.

## **ESRIC Position on the Matter**

Management values the Union's relationship with ESRIC and we have always kept the lines of communication between us. However, on this matter we see things differently. Management feels it has fulfilled its mandate as per the Collective Agreement and the Remuneration Policy. The process followed by the Consultants was clear, transparent and participatory. The main point of departure is the expectation that the outcomes of the exercise should be "negotiated". It is the view of management that any sort of negotiation erodes the independence and objectivity of the exercise. It casts doubts on the outcome of what should be an objective assignment. In addition, the recommendations of the Consultants are competitive and take into account realities in the financial services industry. Management is committed to the implementation of the recommendations of the report including the proposed new salary pay scales.

In the light of the above Management does not feel the strike action is necessary or warranted. The strike threatens to reverse the significant gains made over the years to improve the welfare of all employees of the Corporation.

Management remains committed to resolving the dispute and making decisions that will promote the long term well-being of all staff members and the sustainability of the business. The Corporation remains financially sound. However, it still requires discipline and determined leadership to ensure that over the long term the organization becomes financially sustainable.

# HANDED LAW

# (POCA 2018)

20. (1) The Director may, with the approval of the Minister, receive any donation, bequest or contribution, in money or otherwise, from any source for the purpose of giving effect to the provisions of this Act.

(2) The Director shall utilise any donations, bequests or contributions contemplated in subsection (1) as prescribed and in accordance with the conditions, if any, imposed by the donor, testator or contributor concerned, in so far as such conditions are not inconsistent with the provisions of this Act.

## Agreements with international bodies, institutions, organizations or foreign countries

21. (1) The Minister may enter into an agreement, either in general or on specific terms and conditions, with any international body, institution, organisation or foreign country in order to-

(a) place a person who is being protected under a witness protection programme administered by that body, institution, organisation or country, under protection in terms of this Act; or

(b) admit a protected person to a witness protection programme in terms of any law applicable to that body, institution or organisation or in that country.

### Immunity from legal proceedings during exercise of functions under this Act

22. The Director or a witness protection officer shall not be liable to any action, suit or proceedings for an act done or omitted to be done by the Director or witness protection officer in good faith and without negligence in the exercise or purported exercise of a function conferred by this Act.

### **PART IV GENERAL**

# Offences and penalties

23. (1) Any person who-

(a) wilfully or negligently allows any unauthorised person to gain access to any protected person;

(b) wilfully or negligently discloses, in contravention of any provision of this Act-

(i) the identity of a protected person;

(ii) information that a particular protected person is under protection; the place of safety or location where any person is under protection or has been relocated to in terms of this Act;

(iii) any information which could lead to the identification of a protected person or any place of

(iv) any information which undermines or compromises or could undermine or compromise the integrity of a witness protection programme in terms of this Act; or

(vi) any information relating to the relocation or change of identity of a protected person; or

(c) wilfully or negligently contravenes any provision of Section 17, shall be guilty of an offence and on conviction be liable to a fine not exceeding E15 000 or to imprisonment for a period not exceeding 10 years or to both.


(2) (a) Any person who-

(i) wilfully interferes with, or hinders or obstructs the Director or any other member of the Office in the exercise, performance or carrying out of any of the powers, functions and duties contemplated in this Act; or

(ii) with intent to gain for himself or for any other person protection in terms of this Act, makes a false statement or furnishes information that is untrue or misleading, shall be guilty of an offence and on conviction be liable to a fine not exceeding E7 500 or to imprisonment for a period not exceeding five years or to both.

(b) Upon the conviction of any person for an offence referred to in paragraph (a)(ii), the public prosecutor shall, if the State has suffered any loss as a result of such offence, apply for an order for the payment of compensation.

# Donations, bequests and contributions for witness protection



(1) Subject to this Section, the Minister may, by regulations provide for all matters which by this Act are required or permitted to be prescribed or which, in the opinion of the Minister, are necessary or convenient to be prescribed for carrying out or giving effect to this Act.

(2) Regulations made in terms of Subsection (1) may provide for-

(a) the placing of witnesses or related persons under protection;

(b) the protection of the identity of protected

(c) the regulation of access to places of safety where persons are being kept or relocated in terms of this Act;

(d) the utilisation of security officers or private security personnel for protection services in terms of this Act;

(e) the assistance to be rendered or functions to be performed by any Department of State, person, body, institution or organisation for the purpose of giving effect to the provisions of this Act;

(f) the information to be furnished by, or any steps to be taken in respect of, a witness or related person whose application for placement under protection is being considered;

(g) the terms and conditions that should be included in protection agreements or in other agreements or arrangements entered into under this Act;

(h) the procedure for the relocation or change of identity of a protected person;

(i) the manner in which and the conditions under which any decision of or steps taken by the Director or any person acting on behalf of the Director under a provision of this Act may be subjected to review by the Minister;

(j) the powers, functions and duties of witness protection officers;

(k) the mechanisms to be put in place in order to monitor the circumstances under which a person is kept under protection;

(I) specific offences in respect of which, in addition to the offences listed in the second schedule to this Act, a witness or related person may be placed under protection; and

(m) any other matter that is required or permitted to be prescribed in terms of this Act

(2) Any regulation made under Subsection (1)

which may result in financial expenditure to the State shall be made in consultation with the Minister of Finance.

# GOVT MUST SORT EPTC, MTN JVA TO UNLOCK ECONOMY

TODAY I deliberately choose to look the other direction when it comes to the threat by public sector associations to engage on a strike action in order to force government to commit into paying the Cost of Living Adjustment.

I will deal with it next Monday, provided there will still be no solution to avert the strike, instead let me deal with something which I hope will quickly enhance the growth of our ailing economy.

Let me address Her Royal Highness Princess Sikhanyiso and the Prime Minister Ambrose Mandvulo Dlamini on the urgency need to fix the Eswatini Post and Telecommunications Corporation (EPTC) and MTN Eswatini Joint Venture Agreement (JVA).

Both the Prime Minister and Her Royal Highness have a relationship with MTN Eswatini, as former CEO and former board member.

The five-year delay in sorting the JVA is not good for the country and we expect both of them to quickly resolve the issue because it not only affecting EPTC but the entire telecommunications space and the economy.

When Princess Sikhanyiso spoke at Sibaya last year before her appointment as Minister of Information Communications and Technology, she was not only eloquent but demonstrated to all in sundry that she was not only clear but well vest on ICT issues, hence her appointment into this portfolio did not come as a surprise.

## **Improve**

Whilst in office she has said a lot on how we need to improve the portfolio and has interacted with a number of partners. However, it is her handling of the EPTC question which seems to be unclear up to now.

She has not yet presented a plan on how and when we should expect the unbundling of EPTC to have been completed.

EPTC being a 100 per cent government company is looking to government for guidance on how they should go about the process. This is not a matter for the regulator, the Eswatini Communications Commissions (ESCCOM) as it appears to be at this stage.

ESCCOM jumped the gun in 2016 when it granted EPTC the technology neutral licence, which now allowed it to get into the mobile space, without first ensuring that it divests its ownership in MTN Eswatini.

This has been a thorny issue even before the promulgation of the Eswatini Communications Act of 2013. EPTC has always argued that the JVA was only meant to exist for 10 years; thereafter the parties were free to go separate ways. However, government as shareholder has always been the one forcing these companies to remain in the JVA and today despite a decision by ESCCOM to demand that these parties get out of the JVA because its existence is inconsistent with the prevailing regulatory environment it seems it continues to fail, because the decision is addressed to wrong people.

EPTC and its board are ready to divest its ownership in MTN Eswatini but government continues to fail to provide leadership.

The indecision to move in this area is inconsistent with the country's vision to attain first

- Lack of implementation on key national priorities

- Lack of commitment and decision making hampering implementation

Her Royal Highness needs to move beyond from just stating her fears on what ending the JVA would mean for EPTC to stating the corporation stands to gain if it gets out. Clearly, at the moment the only beneficiary of this arrangement is MTN Eswatini to the detriment of all other players.

Government's blue print when it comes to ICT, it noted these two critical points, which are not going to be attained with this current EPTC and MTN Eswatini JVA still intact;

- ICT lagging behind other nations and our aspirational needs
- High ICT costs impacting operations in both public and private sectors as well as the population at large

As we speak, Eswatini Mobile is struggling, not because of its main doing, but because the playing field is still not level.

Despite the regulator stating that MTN Eswatini is the dominant player, hence Eswatini Mobile must have access to all


EPTC on the other hand is ready to use the money from the sale of its 41 per cent shares to set up the three entities.

### Issue

In closing therefore, we need Her Royal Highness and the Prime Minister and his Cabinet team to move fast on this issue. If we desire to create jobs and deliver a first world network which will be cheaper to the populace, let's be quicker in deciding this matter, it is long overdue.

The previous government made its position clear that it would not allow EPTC to divest from MTN Eswatini, but today we have moved in terms of legislation to the extent that government's actions are now illegal and frustrate the economy.

The regulator needs to be strong to ensure that the law is followed to the letter otherwise its position frustrates honest investors and the populace. We appreciate its efforts to continue to monitor the costs in the sector, but more can still be done if everyone was playing by the book.

# MEDSCHEME GRANTS 25% SHARES TO ENPF

THE Eswatini National Pension Fund (ENPF) has been granted 25 per cent shares of Medscheme Eswatini.

This was disclosed by Financial Services Regulatory Authority (FSRA) CEO Sandile Dlamini during the launch of the company at the Happy Valley Hotel and Casino on Thursday evening.

Making his remarks during the event, Dlamini said there was another 20 percent available for a local entity. He, however, stated that the shares were only available to an organisation and not for individuals.

"I am sure we are all aware that the ENPF currently boasts of membership of about 80 000 Emaswati and we are happy that Medscheme took the decision to partner with them.

"As we witness today (Thursday) the coming into full operation of the company,we have been con-

vinced by their strategic plan for the next three to five years, as it shows they will be doing more to benefit the local population," he said.

He also mentioned the actual landscape of health care provision in the country, stating that there were less than 50 000 Emaswati covered by any form of medical scheme.

"The majority of gainful employees, about 270 000 have no provision whatsoever in terms of medical schemes, let alone the other half a million that is supported by people that are gainfully employed but not covered as well.

"That being the case, we want to challenge Medscheme to try to broaden their product offering to address this situation," he added. He noted that Medscheme met the minimum requirements, especially being fully aware of that they satisfy the FSRA on a number of issues seeing that they provide essential services to members of the public

matters of life and death to human beings and as the regulatory authority that is entrusted with this responsibility, we normally up our standards when considering applications of the likes of Medscheme, hence it took us quite a while to check the background of the company in terms of where they have been operating and what they intend to do in the kingdom," he said.

He also urged the entity to conclude any ongoing matters in court so that everything would go back to normal and be business as usual.

"The major concern in such issues is the consumers of your products

and services. We worry that it should not deteriorate up to a point where lives could be lost, as you are in a very delicate industry that borders on matters of life and death," he added.

Dlamini also encouraged Medscheme to list on the stock exchange in order for more Emaswati to take ownership, adding that the reason for FSRA to emphasise the indigenisation of the companies that are operating in the kingdom is because they believe that as a small economy like Eswatini is in a position to mobilise a lot of financial resources.

# Ministry piloting medical scheme bill

THE ministry of finance is in the process of finalising a medical scheme Bill.

This will govern the provision of medical schemes and healthcare provision in the kingdom.

Financial Services Regulatory Authority (FSRA) CEO Sandile Dlamini said he hoped that Medscheme, as a stakeholder would contribute towards the piloting of the bill, so that by the time it gets to Parliament, it was truly representative of the aspirations of the populations of the kingdom.

"Some of the things that concern us the most are that we have a lot of Emaswati students that are studying outside the country and are having a challenge in getting medical provision whilst there," he said.

He said this was an opportunity that Medscheme could consider exploring, as it was a tedious process for students to travel all the way from their tertiary institutions outside the country to get medical treatment in Eswatini when the medical services could be provided at

their disposal with the proper medical cover.

"You need to cover people anywhere in the world to prevent any inconveniences for clients because some situations are not predictable and come at any time," he said.

# Ezulwini Reinsurance gross premiums increase by E12 million

# Govt revives plan to take free stake in energy projects

JOHANNESBURG - The government is drafting a new law that aims at securing it a free stake in all new oil and gas ventures, revising the terms of a proposal shelved four years ago.

Under the legislation, which the Department of Mineral Resources and Energy outlined to lawmakers in Cape Town thi sweek the state would secure 10 per cent ownership of energy projects at the exploration phase and the rights to 10 per cent of their production at no cost. The law, which is still being refined, will be submitted to parliament in the final quarter of this year, said Ntokozo Ngcwabe, a deputy director-general in the department. Oil and gas companies that have secured exploration rights have held back on costly drilling while they await clarity from the government on the commercial terms. Plans to give the state a 20 per cent free stake in all new ventures and the right to a buy an unspecified additional share were put on hold in 2015, leaving the energy industry in limbo. In 2017, Royal Dutch Shell relinquished a license to search for oil in the Orange Basin off the northwest coast.

The finalising of energy legislation has become more urgent since Total SA announced the first significant deep-water oil find off the coast of South Africa in February. Since the discovery, Shell has bought a stake in exploration blocks in the same area from Anadarko Petroleum

# Other key aspects of the proposed law:

- The contract terms offered to companies will be informed by the location of their exploration block and whether they plan to tap a conventional or unconventional resource.

- The national interest and the bearing projects will have on the security of the nation's energy supply will also be taken into account.

Contracts should include a provision for black investors to be granted a 10 per cent stake in new

- The energy minister should have the right to reserve some exploration blocks for companies that are wholly owned by black investors.

There was no mention of the state being allowed to buy additional stakes in energy ventures.

# CONSUMERS KEEN TO BUY SUBSTANDARD GOODS AT CHEAPER PRICES - MCIT

THE ministry of commerce, industry and trade says that consumers are always keen to purchase substandard goods because they are cheaper and readily available.

Chief Quality Systems Administrator in the Regulator and Quality Infrastructure department Priscilla Dlamini said this during a workshop on the inclusion of quality issues in the secondary school curriculum held at Royal Villas.

Stakeholders from government, the public and private sectors were in attendance and the purpose of the workshop was to try to include the curriculum who stakeholders had gathered to lobby and sell out the idea.

She said they had analysed the situation on the ground and noted the reasons they were seeing a lot of substandard goods in the country and the way of practicing them.

"People do not mind to buy substandard goods as long as they are cheap. A situation analysis has been conducted and they understood that

the problem cannot be solved at high level but need to inculcate a culture within young people of Eswatini to be quality conscience when shopping and when starting their own businesses," she said.

She added that most people lack information and are ignorant when it comes to purchasing these substandard good because most of them did not grow in a culture that discourages the purchasing of substandard goods at cheaper prices.

She also mentioned that they want Emaswati to also be able to say that their products are of high quality even at that

# Lack of consequence against financial mismanagement 'very costly'

CAPE TOWN - Auditor-General Kimi Makwetu said the lack of action and consequences against financial mismanagement in government was costing his office a lot of money.

On Friday, Makwetu briefed the standing committee on the Auditor-General during a workshop on the work of the institution and the Public Audit Act which came into effect in April.

He said this year, irregular expenditure decreased from R29.7 billion to R25 billion after record highs in previous years.

Makwetu said irregular expenditure was still a big problem, but auditing departments and entities had become a costly and useless exercise as nothing was being done about the audit outcomes

"So, there was clear evidence that these audits were starting to become a useless exercise that says the same thing all the time without changing and the reason being that there really was no consequence." Makwetu said the AG's office raised and invested a lot of money into auditing government.

He said they raised about R3 billion in revenue to be able to fund their audits but achieved very little because there were no consequences.

"With expenditure that is close to that figure, now that's a huge investment. If you have that investment and you are not able to make a difference in protecting and in ensuring that there are no stages of a significant nature, then you've got a huge investment achievement."

He said the Public Audit Act, which gave him more powers, would help address the issue.

# 'Board's decision to sack Moyo was unanimous'

JOHANNESBURG – Old Mutual Board Chair Trevor Manuel said chances of Peter Moyo winning against 14 other Board members are near nil.

Manuel addressed the media on Friday for the first time since Moyo was suspended and subsequently dismissed.

He said the board is unanimous that Moyo must go and the Johannesburg High Court ruling that reinstated him will be challenged.

Fired

The former CEO was fired for chairing a meeting that decided to pay R109 million in dividends to ordinary shareholders of his company NMT capital, while old mutual that holds preference shares in the same company, was not paid.

Board Chair Trevor Manuel said, "The employment contract says

we recognise that there will dual loyalties but when you put money in your pocket and leave the needs of Old Mutual aside, there is an unmanageable conflict of interest, and that is what this issue is about."

Moyo alleged in court that he was victimised for objecting to Manuel's triple conflict of interest.

But Manuel said Moyo never objected to this, and the other 14 Board members are unanimous he must go.

"It almost seems easier to deal with one person than to deal with 14 – but I'm not suggesting anything. You can't transcend the impact of corporate governance as set out in the Companies Act that shareholders elect directors to represent their interests."

# SA must act fast, coherently on economy - Minerals Council SA

> Baxter said a key focus should shift to 'government implementing a number of serious structural reforms to get the economy back on track'.

Mboweni's plan – the Economic Transformation, Inclusive Growth and Competitiveness: Towards an Economic Strategy for South Africa document – reflected 'a serious effort to construct a practical long-term economic strategy based on the national development plan'. Baxter said the document reflected 'a holistic strategy with sequencing of interventions, timelines, sectoral implications and underpinned by economic modelling'.

He continued: "Importantly, this strategy reflects a coherent exposition of the far-reaching policy trade-offs ... to get the South African economy back on a growth trajectory.

"It recognises that growth and competitiveness are interdependent, requiring substantial modernisation of network industries: electricity, telecommunications, transport and water. Preferably, private sector competition." Policy certainty was critical, 'in particular ... in the mining sector'. *The Citizen*

# HONG KONG PROTESTERS MARCH AFTER PLEA TO COLONIAL POWE

HONG KONG - Thousands of Hong Kong pro-democracy protesters marched under a sea of umbrellas yesterday after hundreds had sung "God Save the Queen" outside the British Consulate demanding that the former colonial power ensures China honours the city's freedoms.

Top-brand department stores in the Causeway Bay shopping district and the Central business area to the west closed their shutters in case of a return to the mob violence of last weekend.

The Chinese-ruled territory has been rocked by more than three months of sometimes violent protests, with demonstrators angry about what they see as creeping interference by Beijing in their city's affairs despite a promise of autonomy.

The Sino-British Joint Declaration, signed in 1984, lays out Hong Kong's future after its return to China in 1997, a "one country, two systems" formula that ensures freedoms not enjoyed on the mainland.

"Sino-British Joint Declaration is VOID," one placard read in the protest outside the British Consulate.

"SOS Hong Kong," read another.

"One country, two systems is dead," protesters shouted in English under umbrellas shielding them from the sub-tropical sun, some carrying the colonial flag also bearing the Union Jack. "Free Hong Kong."

Some broke into a refrain of "Rule Britannia".

The protesters handed in a petition and drifted away as thousands were heading in their direction along the artery of Hennessy Road where the "ding ding" trams have run for more

than 100 years. Gas masks were being handed out under the cover of umbrellas in case of tear gas, but many protesters showed their faces and most only wore surgical masks.

Major shops in Central and Causeway Bay closed their shutters in case of the violence that has broken out on previous weekends when protesters trashed metro stations and set street fires, with the police responding with tear gas, rubber bullets and water canon.

# ZIM SEES THAW IN CHILLY TIES WITH WEST

HARARE - Zimbabwe's frosty relations with Western powers are thawing, despite tensions caused by a brutal repression of protests, the country's foreign minister says.

Since the military-backed ouster of late ruler Robert Mugabe in November 2017, President Emmerson Mnangagwa's government has campaigned to reengage internationally.

The European Union and the US had imposed sanctions - including travel bans on Mugabe and his inner circle - for violence, electoral fraud and undermining democra-

Foreign Minister Sibusiso Moyo said the new government was making progress in mending ties damaged under Mugabe, who died a

"Zimbabwe has been isolated for the past 20 years... and we cannot survive that way," Moyo told AFP at his offices in Harare on Friday.

"This government took over an economy which was sliding for the past 20 years, and there had not been any investment activity within the state enterprises and even in the private sector.'

During his nearly four-decade rule, Mugabe had become one of the world's most bitter critics of Western "imperialism" and an international pariah.

Mugabe's mismanagement helped push Zimbabwe's economy into crisis, and the country desperately needs investment and struggles with soaring inflation and shortages. AFP



# World Bank, approves \$450 million loan for Tanzania

WASHINGTON - The World Bank has approved a \$450 million loan to Tanzania, the bank said on Friday, signalling the release of the first tranche of funds to the East African nation that were frozen last year because of concern over government policies.

Those concerns included passing a law that made it illegal to question official statistics and expelling pregnant girls from public schools.

The government amended the statistics law in June to remove the threat of jail. But has yet to announce changes to the rules on teenage pregnancy.

The World Bank has been engaging with the government of Tanzania on a range of policy issues that led to a hold-up of financing since 2018.

The financing comes from the

bank's International Development Assistance (IDA), which gives grants or low-interest loans to the world's poorest countries. It covers a poverty- reduction programme that will help around five million Tanzanians, the bank said in a statement.

"The World Bank has been engaging with the government of Tanzania on a range of policy issues that led to a hold-up of financing since 2018", the World Bank said in a statement.

"Approval of this project acknowledges efforts by the government of Tanzania to address the policy issues by amending the statistics law (2018) in line with international practice, as well as the government's commitment to facilitate all girls to complete their education."

# Egypt's el-Sissi dismisses corruption allegations

CAIRO - Egypt's president on Saturday angrily dismissed corruption allegations made by a businessman-in-exile against the country's military as "sheer lies and defamation."

In viral social media videos posted over the past week, the entrepreneur alleged large-scale misuse of public funds in the building of luxurious hotels, presidential palaces and a tomb for President Abdel-Fattah el-Sissi's mother, who died in

"I've built presidential palaces and I will continue to do so," el-Sissi, a general-turned-president, said in televised comments. "I am building a new country ... All of this is not mine. It's Egypt's."

El-Sissi was responding to claims by contractor Mohammed Ali, who

said he had worked for the military for 15 years.

The president said his government has been building some of the biggest art and culture projects in the world in the country's \$45 billion new administrative capital — el-Sissi's brainchild located in the

desert east of the capital of Cairo. He denied corruption allegations as "sheer lies and defamation," without

elaborating.

He portrayed Ali's videos as an attempt to weaken Egypt and undermine the public's trust and confidence in the military and its leader.

> "The military is a patriotic, honest and firm military. Its firmness stems from its honour," he said angrily.

Appearing to fight back tears, el-Sissi said he risked his life when, as defense minister, he led the military's overthrow of an elected but divisive Islamist

president in 2013 amid mass protests against his brief rule. AP

# African leaders agree on billion-dollar plan Ex-PM Cameron slams Johnson over Brexit

OUAGADOUGOU - West African leaders on Saturday announced a billion-dollar plan to fight the rising problem of jihadist violence in the region, at a summit in Burkina Faso. The plan, to be funded from 2020 to 2024, was announced at end of the Economic Community Summit of West African States in Ouagadougou, where the ECOWAS nations were joined by Mauritania and Chad.

ECOWAS had decided to mobilise "the financial resources of up to a billion dollars for the fight against terrorism", said Niger's President Mahamadou Issoufou. The money, paid into a common fund, would help reinforce the military operations of the nations involved - and those of the joint military operations in the region. AFP

LONDON - Former British prime minister David Cameron launched a blistering attack on the UK's current leader Boris Johnson in extracts of his memoirs published yesterday, accusing him of only backing Brexit to further his own career. He said Johnson, who took office in July, believed that campaigning for Britain to leave the European Union during the 2016 referendum would make him the "darling" of their Conservative party. Damningly, he also said that Johnson privately believed there should be a second referendum to confirm the terms of Brexit — something the premier has strongly resisted since. AFP

# Special Presidential Envoys to deliver messages of solidarity across Africa

According to a statement issued by the presidency, the team comprises Jeff Radebe, Ambassador Kingsley Mmabolo and Dr. Khulu Mbatha and they will visit countries such as Nigeria, Niger, Ghana, Senegal, Tanzania, the Democratic Republic of Congo and

"The Special Envoys will deliver a message from President Ramaphosa regarding the incidents of violence that recently erupted in some parts South Africa, which have manifested in attacks on foreign nationals and destruction of property," said the presidency. "The Special Envoys are tasked with reassuring fellow African countries that South Africa is committed to the ideals of pan-African unity and solidarity. The Special Envoys will also reaffirm South Africa's commitment to the rule of law."

# Bob Hewitt will be released on parole later this month

JOHANNESBURG - Despite reports that convicted rapist and former tennis player and coach Bob Hewitt will not yet be released on parole, the Citizen can confirm that he will indeed be released on parole on September 23.

This is according to lawyer Tania Koen who represents one of his victims, Olivia Jasriel.

"Written confirmation was sent to one of the victims on Friday (letter dated 12 (September) that Hewitt is being released on 23 September," said Koen.

While there was a parole hearing, Koen said her client was not informed. Her interpretation of the Correctional Services Act is that the hearing should not have taken place without the knowledge of the victims.

She also believes that Hewitt's release, especially given the country's current mood regarding sexual assault and gender-based violence, will 'send the wrong message to society.'

According to National Department of Correctional Services (DCS) Spokesperson Singabakho Nxumalo, the proper processes were not adhered with regards to the parole hearing and as such the outcome of the parole process was not yet meant to be public knowledge.

In a follow-up official response, Nxumalo included confirmation that Hewitt was indeed eligible for

parole but Nxumalo apparently denied that a final decision had been made.

"DCS will be guided by the recommendations of correctional supervision and parole Board on either to grant or deny Mr Hewitt parole at this stage.

"The offender has indeed served the minimum required time to be considered for parole by the Board.

"Once the decision has been made, it will (be) communicated to the parties involved, which includes the offender, victims of crime and their families."

# **MYSTERY AROUND** MAIMANE, 'HIS' R3.85M **CLAREMONT HOUSE**

CAPE TOWN - DA leader Mmusi Maimane listed a house worth almost R4m as one of his assets on the parliamentary registerybut it turns out he does not own the home in Claremont, Cape Town, according to Rapport newspaper.

After the Afrikaans Sunday newspaper confronted him about this, Maimane made an aboutturn, saying he was actually renting the home from an old friend.

The newspaper said it came across several inconsistencies when it started investigating Maimane's home ownership.

In September 2018, Maimane declared to Parliament that a home in Claremont and a home in Roodepoort both belong to him. But, according to records at the deeds office, only the Roodepoort home is registered in his and his wife's names.

The real owner of the Claremont home is a shelf company, of which Durban businessman Wessel Jacobs is the only director and shareholder. Jacobs confirmed this to Rapport. He

bought the house in September 2017 for R3.85m. Maimane told Rapport he was paying "market-related rent" but would not say how much. Asked the same question, Jacobs said although he believed in transparent, fact-based and fair

journalism, he could not divulge confidential information.

Jacobs is the owner of Jacobs Capital, a private investment company in Durban.

DA spokesperson Solly Malatsi told TimesLive that Maimane declared the house in the 2017/2018 financial year and again in the 2018/2019 financial year because, "at the time, he was under the impression that he had to declare the rented property. Timeslive

"Malema called for this banning on Thursday during the EFF's memorial service for former Zimbabwean president, Robert Mugabe. Speaking to party supporters, Malema said the publications, should be treated as the enemy, much like the EFF did when it banned Guptaowned, The New Age newspaper and broadcaster, ANN7," SANEF said in a statement.

The move by the EFF comes after Scorpio published an exposé on Malema, Party Deputy President Floyd Shivambu, Shivambu's brother Brian, as well as a cousin of Malema's, making allegations that they were involved in the illicit flow of funds from the plundered

# Pep 'congratulates' Liverpool on winning Premier League

LONDON - Pep Guardiola has 'congratulated' rivals Liverpool on winning the Premier League after Manchester City's loss at Norwich.

The City boss joked that Jurgen Klopp's side have won the league after Norwich overcame Man City 3-2, with Liverpool defeating Newcastle 3-1 to go five points clear at the top.

Speaking to reporters after the shock defeat to the newly-promoted Canaries, Guardiola joked that the Reds have already clinched the league

"We're September... we're going to do that? Okay: congratulations, Liverpool, you are the cham-

"We're in September! We'll recover, go to Ukraine, then we come back.

"Of course, we've dropped five points. Tottenham was a pity because we played very well.

"Against Norwich, it was in the important parts, in set pieces for example, that the players have to know exactly what to do."

Liverpool moved five points clear of City at the top of the table after securing their fifth victory in as many

games, where they became the first team in top-flight history to win 14 consecutive matches

The Citizens, meanwhile, sit second after suffering their first loss of the campaign, having also dropped points earlier in the season as they drew 2-2 with Spurs back in August.

Guardiola did, however, play down any concerns this early in the season, expressing his delight at working with the current group of play-

"It's a joy as a trainer to be with these guys," said the City manager. "I don't know what's going to hap-

pen this season until the last part of my period here.

"But not even one second am I going to doubt what the players have done for me, for the club, for everybody. I am a guy who says the truth all the time," he

added. "In the changing room, I speak with them and at the same time I know the commitment in every single training session and in all they do."

# Manchester City's defence comes under the spotlight

MANCHESTER - It was fitting that Manchester City chose this week to honour one of their greatest defenders.

Fitting, too, that Pep Guardiola's current crop chose on Saturday night to illustrate the hole Vincent Kompany has left at the heart of their back four. If only this trip to Norwich was a testimonial, too. After five games, it would be foolish to suggest this brilliant side are out of the title race. But as Liverpool march on, City are giving themselves plenty of ground to make up.

Five points is now the gap after Norwich stunned Guardiola's side at Carrow Road. No

one in City colours did much to enhance their reputation in the 3-2 defeat -Sergio Aguero and Raheem Sterling both missed good chances to score - but it's the defence that will come under the spotlight once more. After 18 minutes, Kenny

McLean was allowed a free run to the near post to open the scoring for Norwich, meaning eight of the last nine goals that City have conceded in the league have come from set pieces. Four of those have come from corners. On Saturday their issues extended to open play, too. Kyle Walker played Todd Cantwell onside in the build up to the second and, after the break, Nicolas Otamendi's unforgivable decision to dawdle on the ball inside his own area allowed Emi Buendia to nick the ball and set up Norwich's third.

The Argentine has now made five errors leading to goals in the Premier League since Pep Guardiola took over. John Stones - who gave his centre back partner the fateful pass - has made three. The rest of City's outfield stars have made two between them. Daily Mail



# Rashford has 13 goals in his last 38 Premier League

MANCHESTER - Marcus minutes of those games, managing Rashford finally got what he always wanted this summer: the keys to the Manchester United attack.

Since he burst onto the scene under Louis van Gaal in 2016, Rashford had not been a regular starter. He was playing second fiddle to Romelu Lukaku, Zlatan Ibrahimovic and anyone else considered superior to the clearly talented, but still very

raw, England young-

Rashford's status at the club changed this summer when Lukaku left for Inter Milan and he finally got the chance to be United's main man. But after just five games of the new season, doubts have already arisen over whether he can lead them back to the summit of English football.

United have had an underwhelming start to the season, winning just two of their opening five matches. Rashford has played all but five three goals and one assist and it is that inconsistency that leaves doubts over his ability.

Since the start of the 2018/19 Premier League campaign, Rashford has scored 13 goals in 38

> appearances, which gives him a minutes per goal ratio of 214. When comparing that to the rest of the top flight's leading strikers, it is worryingly high.

To make things worse, just across Manchester, the ruthless Sergio Aguero is the standard-bearer. The

Argentine has made the same number of appearances in the top flight as Rashford since August 2018 but has managed a goal every 101 minutes.

Liverpool ace Mohamed Salah has one every 142, despite playing five more times. Arsenal's Pierre Emerick-Aubameyang (124), Harry Kane (143) and Chelsea starlet Tammy Abraham (114) have all proven to be more reliable in front of goal than Rashford. Daily Mail

"With Salah? It's forgotten," Mane said to Canal+.

He didn't say anything more... I also don't understand what happened [sigh-


"It did hurt me obviously, even now my heart is still broken. But maybe it's part of football, I'm not the first one to experience this. It's something I have to live with and continue with

"Therefore, we invite all the Parisian supporters who have felt hurt at one point or another to show him that he no longer has the right to make mistakes and the path of redemption will be long... very long. "It's out of the question that we will penalise the team due to a single player."

# Black coaches undermined - Ace

JOHANNESBURG - Kaizer Chiefs legend Donald Ace Khuse has expressed his unhappiness with the way he believes South African football treats black coaches.

Khuse has been one of those coaches in the country who has not been given many opportunities in either club first teams or national junior sides, despite his experience as a footballer and coach.

'Ace' expressed his disappointment at how he believes black coaches are treated in the country.

"I feel not only me but black coaches are being undermined in South African football, they are not taken seriously. They probably think we cannot do what they want us to do,"

Khuse lamented. "If they can give us fair chances, like two or threeyears contract and see what can you do, if you fail then take you out. The second half started in similar fashion to the first, but Celtic were eventually level on the hour mark as Ramasimong Maloisane caught Marc van Heerden


to nod home at the far post.



He said they would continue working hard.


