



PSPF SHOULD NOT HAVE BEEN UPGRADED - OWEN

FORMER Public Service Minister Owen Nxumalo told the Government Assurance Committee (GAC) that Cabinet erred by upgrading the Public Service Pensions Fund (PSPF) into a Category A parastatal.

In fact, he told the committee that the PSPF should still be under Category Barran Nxumalo revealed this when he appeared

before the GAC on Wednesday.

The GAC is a committee of Members of Parliament responsible for following up on decisions made by the House and ensuring that they are implemented.

To have PSPF as a Category B enterprise was widely accepted mostly by stakeholders, particularly the pensioners.

The former minister was called by the committee to answer why he did not implement a Parliament resolution concerning PSPF, which was taken by the 10th Parliament in 2015.

Nxumalo said his conscience told him that PSPF was not supposed to be where it was, which was Category A, but should be in Category B.

Nxumalo said this after he was asked by GAC Chairperson Motshane MP Robert Magongo, about the PSPF issue.

The former minister said he could not implement the resolution of Parliament because it was difficult for him to do so at Cabinet, mainly because of the collective responsibility.

Resolution

"When I became part of Cabinet in 2016, I found that Cabinet had already taken a resolution on the matter.

The Cabinet resolution was taken even before we worked on it as a Parliament Select Committee.

I could not change that resolution on my own," Nxumalo said.

He further said he found that the ministry was under the tutelage of Minister Jabulani Mabuza, who was acting at the time, now Minister of Agriculture.

"I asked 'Buy Cash' about this matter

and he clearly told me that a Cabinet resolution had been taken on this matter.

He stated that if I wanted to be part of the Cabinet, I had to abide by the resolution because failure to do so would mean that outside elements had informed me to effect Parliament resolution, much against the Cabinet resolution.

Bengingeke ngikhone kukwenta lokoBahlonishwa kule Cabinet leya. (I could not do so, Honourable members in that Cabinet)," Nxumalo said, much to the amusement of the GAC members.

Being under Category A means that the parastatal is entirely owned by government and this did not go down well with the stakeholders.

This was how Parliament weighed in on the matter in 2015. A select committee was appointed chaired by former Hhukwini MP Saladin Magagula.

Nxumalo was also part of that committee.

The committee resolved that the re-categorisation should be reversed. That did not happen.

Magongo disappointed with Owen

GAC Chairperson Robert Magongo expressed his disappointment with former Minister of Public Service Owen Nxumalo.

Magongo said what disturbed him was that Nxumalo was part of the Parliament Select Committee that probed the re-categorisation of the Public Service Pensions Fund (PSPF).

Magongo said he understood that there was the collective responsibility at Cabinet, but that was not superior to the law.

Magongo wondered why it was difficult for him to effect the resolution, now that he was the public service minister. However, when Nxumalo explained why it was difficult for him to reverse the re-categorisation, Magongo seemed to understand

Nxumalo explained that being an MP was different from a minister. He would want the PSPF to be under Category B as an MP, but it was difficult for him to implement the decision as a public service minister.

Abide

Nxumalo said he had to abide by the decision taken by Cabinet, which was taken before the august House made its own resolution on the same matter.

"Your Cabinet chairman [the late former Prime Minister Dr Sibusiso Dlamini] was very clever. He appointed you to the very ministry that you challenged while still an MP," Magongo said.

The other members of the GAC laughed.

Nxumalo interrogated by 'Small Joe' on matter

IN a rather surprising move, former Minister of Public Service Owen Nxumalo found himself having to answer about the PSPF to his Cabinet colleague Mduduzi 'Small Joe' Dlamini.

Dlamini was Minister of Tinkhundla Administration and Development when Cabinet took a decision to recategorise Public Service Pensions Fund (PSPF) to Category A in 2014. This means Dlamini was part of the ministers that decided that PSPF should be re-categorised.

The former tinkhundla minister wanted to know from Nxumalo if he found himself having to answer somewhere besides Cabinet about the PSPF. Dlamini also wanted to know if Nxumalo knew how the profits from PSPF were used.

Nxumalo, in response, expressed surprise because they were together with Dlamini at Cabinet. In fact, Dlamini was at Cabinet when the decision was taken. Nxumalo could not understand why he was asked by someone who was with him in Cabinet.

"Uyangihlekisa uMhlonishwa ngoba besinaye le Cabinet nakwenteka letintfo (The Honourable MP surprises me because I was with him in Cabinet when all this happened),"
Nxumalo said.

However, Dlamini said he understood that they were together at Cabinet, but he asked because he wanted things to be set straight before the committee. He pleaded with Nxumalo not to take his enquiries in a wrong way. Manzini North MP Macford Sibandze, who is also part of the committee, intervened in the discussion.

Sibandze said he knew and understood what was said by Nxumalo. He said there were times at Cabinet where ministers would abide by decisions taken by Cabinet. There would be no way in which another different opinion would be allowed because a decision would have been taken.

GAC to meet Wednesday

THE Government Assurance Committee is expected to meet again on Wednesday.

This was confirmed by Motshane MP Robert Magongo yesterday when called to state the next date on which his committee would meet. However, Magongo did not want to state whom they would be calling to have a date with on Wednesday.

He said it will not be good for the concerned individuals to be known at this stage. He said his committee would need to first inform House of Assembly Speaker Petros Mavimbela, who would then formally invite the particular person or people to the GAC.

Meanwhile, Ntfonjeni MP Sifiso Sompisi Magagula said with Nxumalo having appeared to state his side on the PSPF matter, it was now clear will find answers on the matter. Magagula said this without stating where they were supposed to go.

Kumethula MP Derrick Masuku also shared the same sentiments. He said former Minister of Finance Martin Dlamini

NURSES THREATEN TO RELEASE PSYCH PATIENTS

AS the country's health system wiggles, nurses at the National Psychiatric Centre have issued a second intent to release psychotic patients due to lack of medication.

This is the second occurrence in a year, where the nurses have threatened to release the institution's patients due to lack of medication.

In the first instance, they threatened to do so when petitioning the ministry of public service for a Cost-of-Living-Adjustment (CoLA) and lack of medication.

The National Psychiatric Centre is located at Two-Sticks Township which is about four kilometres away from the Manzini Central Business District (CBD).

Some of the nurses who preferred anonymity conveyed that the situation at the institution was appalling in that the patients no longer received the amount of medication that they described as 'calming'.

The health practitioners said the shortage of medication was an ongoing issue but was worse this time around. They said in the past, when one drug was out of stock an alternative prescription would be availed.

The nurses said the medication

predicament resulted to violence within the institution which was dangerous to them as health practitioners as well as to other patients.

"The wards have become battle rings because the patients are fighting more than usual since there are those who need to be kept in check through medication. It's hard for us because our patients can't reason due to their ailment," said one nurse.

Evident to this, another nurse said the pharmacy department of the hospital was of late prescribing medication for those who had sustained injuries during the fights.

Prolonged absence of the necessary medication, according to the nurses, would result to worse results of the prevailing fights among the patients.

Shortage

Conversely, the Raleigh Fitkin Memorial (RFM) Hospital is not sparred from the drug shortage that has hit most of the country's health facilities.

According to the institution's medical practitioners, the hospital was part of the national public health network and just like other

national health centres; it received its medical stock from the Central Medical Stores.

The hospital is said to have only paracetamol as a pain killer. Patients who needed stronger pain relievers are said to be forced by the situation to purchase them at pharmacies around town.

Also, those that had fractured limbs were only bandaged and informed to return at later date or alternatively take their medication as the cast-formulating chemical was out of stock.

When sought for comment, RFM's Senior Medical Officer Mbuso Sihlongonyane confirmed that there were challenges in many public health centres including their institution.

Although he did not have the list of medication that was out of stock, he said most was not available but alternatives were.

The Director of health Dr Vusi Magagula, when called for comment, requested that he be given some time to enquire from the psychiatric hospital about the medication out of stock.

When he was called again yesterday, he said, through a text message, that he was in a meeting.

The Principal Secretary for the Ministry of Health Dr Simon Zwane could not be reached for comment as his phone rang unanswered.

Health ministry addressing problems in hospitals

THE ministry of health is acknowledging the problems faced by health workers, especially nurses, and is addressing the problems.

This was said by Minister of Health Lizzy Nkosi, when called on the matter yesterday.

Nkosi said this after nurses engaged in a goslow in various health institutions in the country. The nurses are complaining about lack of drugs in the health facilities and staff shortages.

Nkosi said she was aware that the health workers were undergoing those challenges and they contemplated delivering a petition to Prime Minister Ambrose Mandvulo Dlamini this Friday.

Nkosi stated that they were working tirelessly on the matters to improve the working conditions of the health workers.

She said drugs were in short supply because of some problems in procurement matters. However, the minister assured Emaswati that ARV drugs were available in health facilities.

Only 18th Complained

The minister further stated that the health workers complained about the shortage of staff in health institutions.

She said the shortage of staff had been a problem for a very long time, mainly because of the cash flow challenges faced by the government. Nkosi said the ministry of public service would give them a few posts at a time to fill the vacancies. She said the vacancies would filled slowly because of the economic problem faced by the country. The minister said she could not give the exact numbers of health workers that were given by the ministry of public service. The minister said some of the vacancies were created way before the current government and it was hard to fill them up because of the cash flow problems. The minister told the health workers that the ministry was aware of the challenges they faced and they were working on solving the challenges. However, she acknowledged the slow pace saying that was due to the lack

'ESWATINIBANK TAXATION TO CRIPPLE ITS DEVELOPMENT

ESWATINIBANK Managing Director Zakhele Lukhele has revealed that taxation of the bank would cause it to fail to provide for future projects.

Last Wednesday the Senate Portfolio Committee tabled the Eswatini Development and Savings Bank Amendment Bill No. 08, whose objective was to amend the Eswatini Development and Savings Bank Order, 1973 in relation to the Income Tax Order, 1975 to render the bank liable to tax and provide incidental matters.

Following extensive deliberation on the Bill the Senate Finance Portfolio Committee found it appropriate to recommend approval of the Bill.

When responding to this development, Lukhele said taxation of the bank would not provide an opportunity for it to provide for future projects.

"The bank's profitability is still at low levels and the introduction of tax will significantly reduce its profits to be invested back into the business," said Lukhele.

He mentioned that the bank appreciated the fact that this was a stakeholder issue and was not in a position to support or not support the removal of Section 27 of the Eswatini Development and Savings Bank Bill (SDSB) order.

He said the bank operated inline with its developmental mandate to provide extensive support to farmers and small micro and medium enterprises.

In the absence of government funding or direct development support, it had become crucial for the bank to focus on improving its commercial wing, which in turn subsidised the loss making developmental business.

Affordable

He added the subsidisation enabled the bank to price the developmental products competitively and in a manner affordable to all citizens. Lukhele said the bank relied on borrowings and public deposits for funding.

"Customers expect competitive products in particular the digital innovations. The bank therefore uses the profits generated to invest in these innovations to ensure maximum customer retention, without which the bank would easily run into liquidity challenges," said the MD.

entity basing their argument on that the bank would be taxed only what was due. The committee eventually voted the amendment should be accepted.

After extensively deliberating on the clauses of the Bill, noting the stakeholders concerns, the committee concurred with the house of assembly to pass the Bill without any amendment.

Minister of Finance Rijkenberg met with the bank's Managing Director regarding the imposition of income tax on EswatiniBank.

"It was clarified that the intensions of tax was not in any way meant to remove or reduce the development mandate of the bank but only take part of the bank's profits and invest them in a bigger development agenda with government, whilst the rest was ploughed back in the bank's business," said the minister. The minister said they discussed other measures with the MD, which could be considered to improve the profitability of the bank as the ministry would be working more closely with the bank on the initiative.

The minister also had discussions with the governor of the central bank of Eswatini to clarify concerns of the bank's developmental mandate.

In this meeting it was appreciated that the policy stance seeks to level the playing field for all banks under the Central Bank's supervision.

Hunter Shongwe back in court on gun charges

SHOULD owners of toy guns expect a visit by law enforcement officers too?

This is the question that one should ask after it was ascertained that private investigator Hunter Shongwe was arrested and charged for a toy gun.

Shongwe is back in court for the commencement of his trial, after he was arrested last year for failing to take reasonable precaution in the safe keeping of his firearms.

Shongwe was charged with contravening Section15 (4) (5) as read with Section (6) of the Arms and Ammunition Act 24 of 1964, after he was said to have, on February 19, 2018 at or near Mvutshini in the Hhohho region, possessed a firearm and wrongfully and unlawfully failing to take reasonable precautions to ensure that ammunition of the firearm

was kept in safe custody while at Mvutshini.

During his appearance before Mbabane Principal Magistrate Fikile Nhlabatsi on Thursday, Shongwe's attorney put it to the crown counsel's first witness Thobile Dlamini, that the firearm she was called to identify on the day in question, was in actual fact, a toy gun.

Approached

This was after Dlamini had informed the court that, as Shongwe's landlord, she was approached by three police officers to unlock the bedsitter occupied by Shongwe.

"After I opened the door, the police officers and I entered the living room area, where, laid out on the dining room table were seven yellow gun cartridges, 14 rounds of ammunition, a small, black firearm and a rifle palm which hung on a nail on the wall," Dlamini stated.

According to Dlamini's recollection of the events that took place that day, Shongwe was present when the



police officers approached her in the

his house.

However, when the crown counsel represented by Nomkhosi Dlamini cross examined the crown's second witness, neighbour Mzwandile Vilakati;

he relayed a different version of the events that occurred that day.

"I live just 300 metres away from the compound where Shongwe lives, however I was sitting right by his compound that day, when I saw a sedan drive up and park right by Shongwe's front door. Inside was Shongwe, who was accompanied by uniformed police officers," Vilakati recalled.

Confiscated

Vilakati relayed that the police officers called him towards the car, where they had 14 live rounds of ammunition, seven cartridges and two guns – one small gun with a torch on the underside, and one large rifle.

"The police officers brought the items to me, where they asked me to count all of the items, to which I did. They then confiscated the items and are now in police custody," he stated

During his cross examination of both witnesses, Shongwe's attorney questioned them, whether there was easy access into Shongwe's abode, considering the security precautionary measures his client had put in place.

"I put it to you that is it not true that my client has burglar proof windows and doors around his house? My client has a state of the art camera system installed both in the interior and exterior of his house, which serves as a means of taking reasonable precautions to ensure that firearms and live ammunition are kept in safe custody," the attorney stated, to which both witnesses responded to the affirmative

As the crown was set to call one of the investigation officers as its third witness, it was later ascertained that the police officer had sustained an injury. This compelled the crown to postpone the matter until August 22 for continuation of trial.





Woman (32) arrested for squandering late mom's pension

A young woman is facing the retributive arm of the law after she unlawfully squandered her late mother's pension monies.

Gcebile Mkhweli of Emvembili area under Chief Solani is said to have stolen money amounting to over E45 000 in respect of her late mother Theresa Mkhweli's pension. She was arrested and charged with theft.

According to her charge sheet, Mkhweli is said to have, between the periods of November 2017 to September 2018, unlawfully and intentionally stolen money amounting to E45 090.19, which were monies paid into a Swaziland Building Society (SBS) account. The mentioned sum of money was in respect of pensions for the late Theresa Mkhweli.

Gcebile allegedly further made withdrawals from the SBS account, with the sole intention to use the money for her personal gain. The monies are said to have been in the lawful possession of the Public Service Pensions Fund (PSPF), in their capacity as issuer of pension monies.

Geebile reportedly made these unlawful withdrawals knowing fully well that she was unauthorised to make the withdrawals as she was not legally entitled to the pension payments.

As, in her first appearance before the Mbabane Magistrate's Court, she had pleaded not guilty. She appeared before the court on Tuesday for the continuation of her trial. TERM TIBIL

This was where the court was set to call its first witness to lead evidence in the case.

However, it was later ascertained that the crown's witness could not make an appearance as he could not be located. This last minute turn of events compelled the court to postpone the matter for a continuation of trial on July 16.

Man nabbed for DD claims to have taken energy drink

TWO cans of Dragon energy drink resulted to a Mozambican man missing his father's funeral.

Patrick Matola (32) was slapped with two counts of driving while under the influence of alcohol and also driving without a licence.

He appeared before Magistrate Sebenzile Ndlela yesterday.

The Mozambican was arrested on Saturday near Eswatini Beverages traffic lights while driving a Nissan sedan. His specimen reading was 0.49mg/l, exceeding the legal limit of 0.38mg/l. The man was driving a vehicle with registration number USD 842 AL.

On the second count, Matola is said to have failed to produce a valid driver's licence when requested to do so by police officers.

When explaining his story, Matola said he arrived in the country on Friday with the intention to fetch his dead father's body from Dups as he had died

while in Eswatini. He said while at the morgue, he was asked by another to accompany him to get some food.

After meals, Matola said he gulped down two cans of Dragon energy drink. When all this was done, the Mozambican said he was then asked to take the wheel of the vehicle they were travelling in to Matsapha to fetch two other people who were going to Mozambique for his father's funeral only for them to be stopped by traffic police along the way.

Shocked

"I was shocked to learn from the police that there was some alcohol content in my blood system because all I drank was the energy drink," he said.

He went on to inform the court that the police told him that the energy drink had guarana extracts. According to www.drugs.com, a dose of guarana paste has a caffeine content of between 3.6 and 5.8 per cent.

"I don't even know what guarana is," said Matola.

In the case of driving without a licence, Matola said he had one but it was left in his car at Dups when he went for food in another vehicle that was not initially driven by him. He said although he was not aware that the energy drink had alcohol, he did not intend to drive any vehicle hence he left the licence.

When mitigating, the Mozambican pleaded with the court to be lenient because he did not have any money after the costs he had to pay to ensure that his father's body was returned back to Maputo. To substantiate this, Matola said he had to pay E2 000 for transport that would ferry his father's body to Maputo since his own car was too small to carry the coffin.

He was sentenced to 10 months imprisonment with an option of E1 000 fine for the first count and five months imprisonment with an option of E500 for the second one. His sentences were to run concurrently, meaning he was supposed to pay E1000 or spend 10 months behind bars.

Even after this leniency that was demonstrated by the court, Matola was heard murmuring that the E1 000 was too much for him because he did not have any money on him.

After their arrest, it was discovered that the accused persons were also in possession of 0.520 kilogrammes of dagga seeds, thus contra-

into custody for their trial date set for July 15.

Woman granted E2 000 bail for 14 kg dagga

A 55-year-old woman has been admitted to bail fixed at E2 000 after she was nabbed with 14 kilogrammes of dagga without a permit.

Sibongile Mncina of Nkomanzi appeared before the Mbabane Magistrate's Court on Tuesday after she was arrested and charged with contravening the Pharmacy Act of 1929.

Mncina is said to have, on June 9, at Nkomanzi, not a holder of a valid licence or permit to possess dagga, did wrongfully and unlawfully been in the possession of 14 kilogrammes of dagga, a potentially poisonous substance, thus contravening the Act.

Mncina is also said to have an additional charge placed against her, she is said to have contravened the Opium and Habit Forming Act after she was discovered with 1.8 kilogrammes of

The incident is alleged to have happened last Saturday at a farm in Waaihoek, Sheepmor near Piet Retief It has been nine days since the police have engaged on a manhunt for the killers but to no avail. The locals who are still at large are now suspected to had a hand in the

murder of the farmer. What makes things harder for SAPS is that the identities of the Emaswati is unknown by the police as they do not have their pictures.

After killing the farm owner, the two are suspected to have dumped his body in a plantation within the farm and vanished with his firearm.

According to Colonel Mtsholi Bhembe from SAPS, information at their disposal revealed that the farmer was last a relative as missing, on Tuesday.

Bhembe said a search was conducted and his body was found in the plantation, not far from his residence. A preliminary probe suggested that the deceased was struck repeatedly with a sharp object.

He said his firearm was also missing from his house as well as his two employees believed to be from the Kingdom of Eswatini. Bhembe said the two employees' identities are yet to be established.

Urged Bhembe said the two were still at large

and no arrest had been made as yet. He said, however a woman was taken in for questioning.

Bhembe said anyone with information that might assist police in their investigation should to contact Lieutenant Colonel Mbongeni Myeni at 082 556 5605 or the SAPS Crime Stop number, 08600 10111.

Chief Police Information and Communications Officer Superintended Phindile Vilakati said local police were not aware of the matter.

This is not the first time farm workers working in a South African farm near Piet Retief have been implicated in the murder of their employee. A few years back it was reported that Charlotte van Zyl, 55, the wife of a Mpumalanga farmer Johannes van Zyl, 84, died two days after she was attacked with a set

The alleged attacker was a 35-yearold Swazi national who was an employee on their farm in Dirkiesdorp near Piet

The suspect was taken into custody and is currently incarcerated in one of the South African prisons on murder

According to News 24, the police arrived on the scene to find Johannes van Zyl on the bathroom floor. She had sustained serious injuries and later died at the scene.

Most Emaswati flock Piet Retief in search of work in the farms. These workers are usually employed in forest plantations by the farmers.

They usually go to Piet Retief due to its close proximity with Eswatini. Most of these Emaswati are undocumented citizens who use informal crossings to get to the other side.

esertification is a major economic, social and environmental problem of concern to many countries in all regions of the world. It is a type of land degradation where arid land regions become increasingly dry, typically losing bodies of water as well as vegetation and wildlife. The main cause of development of desert-like conditions in regions is usually experiences in conditions of human disturbance such as deforestation, overgrazing or poorly managed agriculture. Annually on 17 June countries come together to observe this day as means to promote public awareness of international efforts to combat desertification. This is a unique moment to remind everyone that Land Degradation Neutrality (LDN) is achievable through problem solving, strong community involvement and cooperation at all levels. The United Nations Convention to Combat Desertification UNCCD strongly advocates for bold new solutions to protect and restore land resources for current and future generations. Eswatini joins the rest of the world in the commemoration of this day with the aim to promote public awareness on land degradation and also to draw attention to the implementation of interventions that can try to curb issues of serious drought and/or desertification. This year the theme requests for countries to look into what has been achieved in the past 25 years, focusing on the path the Convention has taken and also what countries hope to achieve in the future in the next 25 years

What the country continues to strive

The kingdom of Eswatini became part of United Nations Convention to Combat Desertification (UNCCD) in 1994. The country continues to focus on activities that promote Desertification, Land Degradation and Drought (DLDD). The country is an active stakeholder to the UNthat carries out the mandate to combat desertification and is also expected to converge and seek a joint implementation of the UNCCD at the

The country is focused on four Strategic objectives and they are:

- To improve the living conditions of affected populations
- To improve the condition of affected ecosystems
- To generate global benefits through effective implementation of the UNCCD
- To mobilize resources to support implementation of the Convention through building effective partnerships between national and international actors

As we commemorate this day, as a country we take the opportunity to reflect on our deteriorating land resources that undermine the nations efforts in alleviating poverty and food security. The Potential of our land is seriously undermined by its vulnerability to climate change, climate variability and land degradation, among other factors. We also take the opportunity to remind ourselves of the causes and impacts of land degradation with a view to address them so that we can improve the livelihoods of people staying in this country, especially in the drought-stricken areas.

Unsustainable land use, eventually causes degradation and loss of critical ecosystem services. As a result, consumption of the earth's natural reserves have doubled in the last 30 years, with a third of the planet's land already severely degraded.

By turning land degradation into land restoration/recovery, we can realize the land's full potential. Healthy and productive land can bring not only environmental, but also significant economic gains. The country is rich in natural resources and has an abundance of water resources, pristine rivers and diverse species of flora and fauna. Desertification poses a serious threat to the sustainable management of these resources which includes sustenance of livelihoods as well as attainment of sustainable development of the country. Three important causes of desertification are:

over-grazing over cultivation and Ш. deforestation.

Major threats include land degradation, depletion and extinction of species (loss of biodiversity), increasing frequencies of droughts, water stress, dwindling production and productivity and overdependence on natural resources. Direct and indirect causes of Land Degradation in Eswatini include: improper land use, climate effects, uncontrolled fires, invasive alien plant species, population increase, road infrastructure development, effects and impacts of poverty, crop farming practices, livestock farming practices, and others.

Operational objectives:

Achieving these long-term goals as a country involves developing and implementing long-term integrated strategies that focus simultaneously, in affected areas, on improved productivity of land, and the rehabilitation, conservation and sustainable management of land and water resources, leading to improved living conditions, in particular at the community level. These are not limited

- Advocacy, awareness raising and education: To actively influence relevant international, national and local processes and actors in a dequately addressing desertification/land degradation and drought-related issues.
- Policy framework: To support the creation of enabling environments for promoting solutions to combat desertification/land degradation and mitigate the effects of drought.
- Science, technology and knowledge: To become a global authority on scientific and technical knowledge pertaining to desertification/land degradation and mitigation of the effects of drought.

 Capacity-building: To identify and address capacity-building needs to prevent and reverse desertification/land degradation and mitigate the effects of drought.

Financing and technology transfer: To mobilize and improve the targeting and coordination of national, bilateral and multilateral financial and technological resources in order to increase their impact and effectiveness.

What has been achieved by the country in the past 25 years

Since its adoption in 1994, UNCCD has contributed to the advancement of sustainable land management. Today, its 197 Parties which include Eswatini implement the Convention under coordinated and results-oriented actions with clear targets to recover and restore degraded land. The end goal is to protect our land, from over-use and drought, so it can continue to provide us all with food, water and energy.

There are clear evidences of recovery and restoration of degraded landscapes through sustainable land management (SLM) that have been practiced by the country over these years. For example, in Sithobela, Nceka, sihlangwini and Gucuka degraded land has been restored through rehabilitation (using gabion baskets and planting of trees). Reintroduction of Agroforestry, increased trees on the farm.

There is still a lot that needs to be done by the country and this has to happen sooner rather than later. The current pressures on land still remain enormous and still continue to grow. Continued land degradation and drought poses a threat on desertification. Moreover, the recurrent and growing threats of forest fires, heatwaves, mass migrations, flash floods, and food and water insecurity are still more evident.

What the country hopes to achieve in the next 25 years

The importance and urgency of addressing these challenges is more widely recognized than it was two decades ago as shown in the adoption of achieving land degradation neutrality as one of the Sustainable Development

2030 is viewed as a significant milestone

for achieving land degradation neutrality as one of the Sustainable Development Goals. This is a stepping stone towards a true land-based sustainable future. By achieving land degradation neutrality, the country will have more land available for further sustainable development. The country is urged to generate and sustain fundamental and sustainable positive change by keeping the land productive. As an international agreement on good land stewardship, the country must ensure that the convention moves forward to achieving land degradation neutrality by 2030 and dive into the world beyond 2030 where land degradation neutrality will ensure an enabling environment for people, communities and countries to create wealth, grow economies and secure enough food, clean water and energy. Towards this ambition, the Parties to the Convention are taking concrete steps that include tackling of the root causes of instability in Africa (3S Initiative); developing comprehensive national plans for drought management; and restoring Africa's degraded landscapes at massive scale (Great Green Wall

Key messages

Initiative).

- As the world has become more and more fragile against the effect of a changing climate, the Convention must grow, and be recognized as the authority and leader o n a chieving Land Degradation Neutrality (LDN) and leveraging LDN as a stepping stone towards true landbased sustainable development beyond 2030.
- The 197 Parties to the Convention renews their commitment to good land stewardship that helps people, communities and countries create wealth, grow economies and secure enough food, clean water and energy by ensuring land users an enabling environment for sustainable land management.
- Sustainable land management is everyone's business. Together, we can restore the productivity of over 2 billion hectares of degraded land and improve the livelihoods of more than 1.3 billion people around the



She thanked the nursing schools for the continued support in mobilising student nurses to support

"Healthy children perform better in class leading to improved educational outcomes. I therefore call upon all national stakeholders to support this mass medicine administration campaign. Break-in suspect's hand chopped off

A suspected thief had his hand cut off, whilst attempting to break into a grocery business whose owner was inside.

Apart from the crowbar he used to break inside, also found in Agrippa's possession was a bush-knife. ESWATINI INCORPORATED: 2022 & BEYOND

'MOVING FROM RHETORIC TO ACTION'

ON Thursday the Public Accounts Committee (PAC) chaired by MP Phila Buthelezi, who is also Deputy Speaker, decided on a matter that has seen many government agencies failing to resolve, that of controversial officer Knowledge Ngwenya in the ministry of education.

Ngwenya, the self-important blueeyed boy of retired Principal Secretary Pat Muir and some senior ministry officials, has caused untold damage within the teaching profession in the name of being a top and celebrated investigator of teachers' malpractices and wielded more power than his superiors.

No one within the ministry of education was prepared to give an ear or listen to anyone pointing inappropriate conduct towards their wonderful and super sleuth.

In fact, I understood him very well when he explained why he failed to assume his position in the Shiselweni region, talking about insecurity.

The insecurity he was referring too, is not that of physical protection but the knowledge that he has his bosses to cover his back. When instructed to perform a task, he knew that he would use their powers effectively to achieve whatever he wanted and would tell his suspects to jump. Many teachers have approached the newspaper with gory stories in the past, including allegations of corruption levelled against Ngwenya.

Qualifying

Personally, I have an experience of a teacher in one of the schools in the Hhohho region who suffered a stroke as a result of alleged extortion and rape but nothing ever happened to the suspect despite reporting her case to the police and the ministry of education.

The Swazi Observer's Fanyana Mabuza wrote in August 5, 2015 about the very same things that would today see Ngwenya coughing out E524 000.

Retired Principal Secretary Pat Muir recommended him for a post of assistant career guidance officer, for which Ngwenya openly came short of qualifying.

Justifying his recommendation, Muir wrote in an official minute directed to the executive secretary of the Civil Service Commission that Ngwenya, in his current position, that of clerical officer, was instrumental in the investigation of cases of the abuse of pupils by teachers and as such, the TSC and the Career Guidance department relied heavily on his expertise in bringing such cases to a fitting close.

The PS continued in his recommendation letter, dated May 21, 2014, that Ngwenya's determination and dedication to his sleuth duties had occasionally been met with resistance, especially in disciplinary hearings and Magistrate's Courts by the persons he was investigating, who would question his position, duties and responsibilities.

"Therefore, this recommendation

is based on the fact that in order for him to conduct his duties without being questioned, he needed to occupy a mid-level management position."

Drafted

This was despite the fact that according to an advertisement for the position of assistant career guidance officer drafted by the ministry's legal advisor in August 26, 2014, the required person should have held a Bachelor's Degree in Social Sciences and or Humanities.

But Ngwenya, by his own admission, did not possess such paperwork. The candidate should also have thorough knowledge in information communication technology, possess a proven track record of the highest level of professionalism and performance while also having a minimum of two years teaching or working experience.

It was an open secret that Ngwenya did not possess almost all of these qualifications as according to papers leaked to this newspaper and was confirmed to the PAC on Thursday, he only had a Diploma in HIV and AIDS Management obtained from Boston College in 2005.

The then PS Muir made this recommendation knowing very well that the ministry did not have a position for an investigator and that he fell too short for the same promotion he was recommending this officer for.

Recommendation

The question that we must ask ourselves today; should we be satisfied with the PAC decision?

NO. I disagree! I feel more heads still need to roll before we accept the recommendation by the PAC. I know that the PAC often times works hand-in-hand with the Anti-Corruption Commission and the police as some cases would be referred to them to continue with investigations and arrest those found to be wanting.

In Ngwenya's case, if they had asked the ACC or the police, they would have been told that they have Ngwenya's file somewhere; it's just that the powers that be at the time did not want their golden boy to be touched.

PS Dr Sibongile Mtshali is clear that they do not need an investigator within the ministry, where such services would be required they would engage the police. But the question is why wait for the PAC to tell us that?

The PS should have drawn the line the moment she assumed the position by removing the officer from government's pay system. By so doing she would have upheld Section 63 (a) and (g) of the Constitution of the Kingdom of Eswatini which states on the duties of the citizen.

"The exercise and enjoyment of rights and freedoms is inseparable from the performance of duties and obligations, and accordingly, it shall be the duty of every citizen to —

(a) uphold and defend this Constitution and the law; (g) protect and preserve public property, and to combat misuse and waste of public funds and property."

The Prevention of Corruption Act Section 49 further enjoins her and other officers in the ministry to report corrupt transactions.

The section states: "(1) A person who holds a position of authority and who knows or ought reasonably to have known or suspected that another person has committed - (a) an offence under Part III; or (b) the offence of theft, fraud, extortion, forgery or uttering a forged

document involving an amount of E10 000 or more, and fails to report that knowledge or suspicion or cause that knowledge or suspicion to be reported to any police officer or investigating officer of the Anti-Corruption Commission, commits an offence and shall, on conviction, be liable to a fine not exceeding five thousand Emalangeni or imprisonment not exceeding two years or to both.

(2) For purposes of subsection (1) the following persons hold a position of authority, namely (a) a principal secretary in charge of any government ministry, the head of a department or other establishment of government, or equivalent officer, or a regional administrator, or regional secretary..."

So based on the above pieces of legislation, the PAC's ruling on the matter is not sufficient and more people need to take responsibility for this negligence.

People must learn that we should not leave everything to the auditor general to do our bidding. If we are serious about fighting corruption we need to stop making the auditor general the scapegoat. People must take responsibility and stop the abuse of public resources as an when it happens. In fact, even that decision to leave everything to the AG and the PAC is not honest in that the latter is seen as a better devil than the courts of law, whose cases carry more stigma of being arrested and a criminal record.

People must be charged and face the wrath of the law if they fail to do an honest job. Maybe it is time we capacitate or appoint someone within the Human Rights and Integrity Commission to head the office of the Public Protector.

In this case, the Public Protector will not wait for the AG's report to be tabled before the PAC for a decision to be taken, but will deal with it as an when it occurs.

This will change the current culture of *kubindvwa kobonwa*. It will be another way of adding to the efforts of the 'made' toothless Anti-Corruption Commission.

Some teachers who forged their qualifications have been arrested, charged and lost their jobs. I don't believe that this matter should be treated any different, including those who participated in this thieving.



(d) has a visual, hearing or speech impairment.

PART X: NATIONAL **REGISTER FOR SEXUAL OFFENDERS**

Establishment of National Register for Sex Offenders and designation of Registrar of Register.

56. (1) A National Register for Sex Offenders containing particulars of persons convicted of any sexual offence or who have been dealt with in terms of Section 165 or Section 319 of the Criminal Procedure and Evidence Act whether committed before or after the commencement of this Act and regulations, shall be established and maintained by the minister or an officer so designated by the minister or other appropriate authority.

(2) The minister or such other appropriate authority shall designate a fit and proper person, with due regard to the experience, conscientiousness and integrity of that person, as the Registrar for the National Register for Sex Offenders.

(3) The Registrar shall exercise and perform such powers, duties and functions subject to the provisions of this Act and the regulations.

Objects of the Register.

57. The objects of the Register are to protect victims of sexual offences particularly children and persons who are physically or mentally disabled against sexual offenders by-

(a) establishing and maintaining a record of persons who have been convicted of a sexual offence, whether committed before or after the commencement of this Act and whether committed in or outside Eswatini; or

(b) establishing and maintaining a record of persons who are alleged to have committed a sexual offence, in respect of whom a court, whether before or after the commencement of this Act-

(i) in the Kingdom of Eswatini has made a finding and given a direction in terms of Section 165 or Section 319 of the Criminal Procedure and Evidence Act; or

(ii) outside the Kingdom of Eswatini has made a finding and given a direction mentioned in sub-paragraph (i) in terms of the law of the country in question:

(c) informing an employer applying for a certificate under Section 64 whether or not the particulars of the person seeking employment from an employer are contained in the Register; and

(d) informing the relevant authorities dealing with fostering, care-giving, adoption, applying for a certifi-

cate as specified in this Part whether or not the particulars of any applicant, as specified in Section 58, have been included in the Register.

(a) be established and maintained in the prescribed manner and format;

(b) contain the following particulars of persons referred to in section

Contents of Register.

58. The Register shall:

(a) be established and maintained in the prescribed manner and format; and

(b) contain the following particulars of persons referred to in section 59- (i) the title, actual or estimated age, full names and surname of the person, including any known alias or nickname and, where applicable, the profession or trade of that person;

(ii) the last known physical address of the person, and any other contact details, including a postal address, where applicable;

(iii) the identity number, passport number and driver's licence number of the person, where applicable;

(iv) the sexual offence in respect of which the person has been convicted, the sentence imposed, the date and place of conviction and sentence, as well as the relevant prisoner identification number, where applicable;

(v) the court in which the trial took place and the case number;

(vi) the name of the medical institution or medical practitioner of a person and details of the sexual offence allegedly committed by a person who has been dealt with in terms of section 165 of the Criminal Procedure and Evidence Act, and

(vii) any other particulars as may be prescribed in the regulations; and (c) if the conviction and sentence took place in a foreign jurisdiction, contain as far as possible the equivalent information as is mentioned in paragraph (b), as obtained from the relevant country or any other legal source.

Persons whose names shall be included in Register and related matters.

59. (1) The particulars of the following persons shall be included in the Register:

(a) A person who in terms of this Act or any other law;

(i) has been convicted of a sexual offence:

(ii) is alleged to have committed a sexual offence in respect of whom a court, made or has made a finding and given a direction in terms of Section 165 or 319 of the Criminal Procedure and Evidence Act;

(iii) is serving a sentence of imprisonment or who has served a sentence of imprisonment as the result of a conviction for a sexual offence; or

(iv) has a previous conviction for a sexual offence or who has not served a sentence of imprisonment for such offence; and

(b) any person-

(i) who, in any foreign jurisdiction, has been convicted of any offence equivalent to the commission of a sexual offence;

(ii) who, in any foreign jurisdiction, has been dealt with in a manner equivalent to that contemplated in paragraph (a)(ii) or (iii) whose particulars appear on an official register in any foreign jurisdiction, pursuant to a conviction for a sexual offence or as a result of an order equivalent to that contemplated in paragraph (a)(ii), whether committed before or after the commencement of this Act.

(2) A court that has in terms of this Act or any other law:

(a) convicted a person of a sexual offence and, after sentence has been imposed by that court for such offence, in the presence of the convicted per-

(b) made a finding and given a direction in terms of Section 165 of the Criminal Procedure and Evidence Act, that the person is by reason of mental illness or mental defect not capable of understanding the proceedings so as to make a proper defence or was, by reason of mental illness or mental defect, not criminally responsible for the act which constituted a sexual offence, in the presence of that person, - shall make an order that the particulars of the person be included in the Register.

(3) When making an order under subsection (2), the court shall explain the contents and implications of such an order, including section 68, to the convicted person.

(4) Where a court has made an order under subsection (2)(a), the Registrar of the High Court or the clerk of the relevant Magistrate's Court shall, where possible notify the employer in the prescribed manner, of such order and shall forthwith forward the order to the Registrar, together with all the particulars referred to in Section 58 of the convicted person, and the Registrar shall immediately and provisionally, in the prescribed manner,

enter the particulars of the person concerned in the Register, pending the outcome of any appeal or review and shall, after;

(a) the period for noting an appeal or taking the matter on review has expired; or

(b) the appeal or review proceedings have been concluded in the case of an appeal or review,

either enter or remove such particulars from the Register, depending on the outcome of the appeal or review or the abandonment or expiry of the noting of appeal or review.

(5) Where a court, for whatever reason, fails to make an order under subsection (2) the prosecuting authority or any person shall immediately or at any other time bring this omission to the attention of the court and the court shall make such order.

(6) The commissioner general of correctional services shall;

(a) in the prescribed manner and within three months after the commencement of this Act, forward to the Registrar the particulars referred to in Section 58 of every prisoner or former prisoner which he has on record, who, at the commencement of this Act, is serving a sentence of imprisonment or who has served a sentence of imprisonment as the result of a conviction for a sexual offence, and the Registrar shall forthwith enter those particulars in the Register; and

(b) in the prescribed manner and period, inform each serving prisoner whose particulars have been forwarded to the Registrar of the implications of the particulars so sent to the Registrar.

(7) The national commissioner of the Royal Eswatini Police Service shall, in the prescribed manner and within three months after the commencement of this Act, forward to the Registrar all the available particulars in his or her possession referred to in Section 58 of every person, who, at the commencement of this Act, has a previous conviction for a sexual offence and the Registrar shall forthwith enter those particulars in the Register.

(8) The director of health services shall:

(a) in the prescribed manner and within three months after the commencement of this Act, forward to the Registrar the particulars referred to in Section 58 of every person, who, at the commencement of this Act, is subject to a direction in terms of Section 165 of the Criminal Procedure and Evidence Act, as the result of an act which constituted a sexual offence and the Registrar shall forthwith enter those particulars in the Register; and

(b) in the prescribed manner and period, inform each person referred to in paragraph (a) whose particulars have been forwarded to the Registrar of the implications thereof.

Are stokvels a possible solution to financial inclusion?

STOKVELS have become an integral part of Africans' lives and culture.

These informal self-help savings groups stem from the communal values of Africans, which have not been fully incorporated into western discourse that informs much of the development agenda in the global South.

Stokvels are informal self-help financial groups comprising between 10 and 18 individuals, though some might have more or fewer members, depending on their nature and purpose. Like many informal activities, stokvels operate in the shadow economy and, therefore, they are not formally registered with any institution within the government system.

Nevertheless, despite being largely informal, the role of stokvels is increasingly generating a lot of interest in the financial sector, particularly when it comes to issues of accelerating financial inclusion for all in Eswatini.

In South Africa, for instance, a recent assessment by Rudzani Malaudzi found that stokvels form part of the biggest buyers in that country's economy, with an estimated R44 billion circulating among 820 000 groups consisting of over 11 million members. The recognition of stokvels as a social and economic tool or survival instrument for a majority of people who depend on them (especially low-income earners and the rural poor) is receiving more attention from financial institutions and policymakers.

In a pilot survey that assesses the features and financial inclusion capability of informal savings groups, Dr Phindile Dlamini from the University of Eswatini finds that in just 64 savings groups with 1 746 members, total savings contributed amount to well over E3 million.

Considering the fact that the number of stokvel groups in Eswatini could easily be in the thousands, there is a lot of financial and economic potential brewing in informal savings groups. However, the total monetary value of stokvels in Eswatini - and how policymakers can leverage these

savings groups to deepen financial inclusion - still needs assessment.

Literature states that the contribution of stokvels on financial and economic empowerment of low-income groups is far-reaching. Stokvels are an important grassroots initiative to smoothout household consumption and to meet livelihood contingencies.

Many people use stokvels to pool their financial resources to cater for their livelihood needs such as school fees, food, building homes, to start small businesses, amongst other gainful activities.

Unplanned

In times of financial shocks, some people use stokvels as the first line of defence to mitigate and adjust to unexpected/unplanned life events.

To foster sustainable financial mobility for low-income earners, there is an ongoing debate around the formalisation or institutionalisation of stokyels as an option to provide financial services to the financially excluded.

Despite the interest to introduce stokvel-like services into formal financial markets, the 2019 Oslo Financial Inclusion Summit emphasised that informal credit markets (which includes stokvels) are inefficient and tend to exacerbate fraud and enable individuals to evade taxes.

Although this may be true, one aspect that should not be overlooked is the capacity and extent to which stokvels serve a greater purpose to support livelihoods, especially in rural communities where formal financial services are usually non-existent.

So, what can be done to enhance stokvels so that they are efficient enough to complement conventional financial institutions? Instead of vilifying everything informal, the role of policy is to create a conducive environment to enhance these traditional initiatives without taking away their indigenous or fundamental function to meet people's livelihood needs.

Good financial inclusion policy should not ignore the grassroots initiatives and innovations that people engage in to overcome poverty and improve their lives. Rather, it should enhance what already works to improve access to financial services as well as ensure diversity of the financial products to serve all levels of livelihoods and lifestyles.

In essence, stokvels offer an alternative mechanism to relieve the financially excluded from their economic burdens and carve an alternative path toeconomic independence.

The National Financial Inclusion Strategy 2017-2022 states that 27 per cent of adults in Eswatini are still financially excluded.

This means 324 000 of the adult population have to turn to alternative informal options for their financial needs. By definition, financial inclusion encompasses four main products: savings, transaction, credit, and insurance which can be accessed either through formal or informal channels. Note that poor people are not hopeless nor ignorant of their financial struggles. They too engage in economic activities when they gain access to money.

Stokvels are a testament that low-income earners know their problems, acknowledge their financial needs, and are experienced in the dynamics of their financial struggles.

Hence, stokvels - among other savings and borrowing instruments - help them to mobilise savings and mitigate their financial issues. It is a misconception that only poor people partake in informal savings groups, people with bank accounts and reliable sources of income also participate in stokvels. By giving it the attention it deserves, the country would be en-route to improving many people's lives.

The wide provision of financial services by banks or other formal financial institutions has simply become the gold standard for financial inclusion. For sub-Saharan Africa, this view on financial inclusion is narrow as the economic realities are nothing compared to those of developed countries. What good is it to push everyone to have a bank account that will have a zero or negative balance most of the time?

Incomes

In the context of our social and economic realities, financial inclusion needs to be a greater pursuit than just making people subscribe to formal financial systems without supporting their ability to engage in productive activities to generate the necessary incomes to achieve financial freedom. Financial services need to be connected to the social systems in which people operate, it needs to be accessible and made available at an affordable cost to all individuals and their business pursuits

In order to bring stokvel savings groups into the realm of financial inclusion discourse, it is worth developing a deeper understanding on how these groups help Emaswati save, borrow, make payments, and manage risks. Also, it should be noted that not all rural folks make use of stokvels, some use banks, some livestock, and discouraging as it may be, some do not save at all.

Eswatini needs to broaden the scope of financial inclusion, especially now that we know that the country has a large informal economy (equivalent to 37.4 per cent of the formal economy), which government must tap into to develop people's lives.

Fortunately, the Eswatini National Financial Inclusion Strategy (NFIS) lays out a plausible vision for the enhancement of financial inclusion in the country.

To contribute to the formulation of a coordinated rural national financial inclusion policy and a strategy for financial inclusion, the Eswatini Economic Policy Analysis and Research Centre (ESEPARC) is conducting a study on stokvels to determine the key features that can be enhanced to improve access as well as the depth of financial products to the financially excluded populace.

AFRICAN SWINE FEVER OUTBREAK: ESWATINI CLEARED

FOLLOWING the outbreak of African Swine fever, the government of Eswatini has taken measures to make sure that the country is not affected by it.

In an interview with this publication, Dr. Roland Xolani Dlamini the Director of Veterinary and Livestock Services said African swine fever (ASF) was a serious viral disease of pigs that can cause fever, internal bleeding and high death rates.

It is highly contagious and can spread rapidly through both direct and indirect contact with infected pigs or pig products.

He said the country had taken prevention measures and therefore the country was free from the disease. He said one of the steps taken was

that of separating of domestic pigs and wild pigs. "Wild pigs are mainly found in

"Wild pigs are mainly found in nature reserves, away from farms with domestic pigs.

As a biosecurity measure, domestic pigs are kept in enclosures and are not allowed to roam free in the community. Any pigs roaming free are denied access to the formal markets.

Pigs

Movement of pigs between farms is controlled, requires a stock removal permit. Currently the Veterinary Services is working on designing and implementing an identification and traceability system" he said.

The director also said ASF could be spread directly between sick and healthy pigs. This happens through contact with the blood, tissues, secre-

tions and excretions from infected pigs. Animals that recover may become persistent carriers of the virus.

Clear

He made it clear that Eswatini does not import live pigs from ASF positive countries or zones. Also, imported pigs are from disease free compartments that test regularly for African swine fever and Classical Swine Fever amongst other diseases.

"All imported pigs undergo compulsory 30 days quarantine at the Government Quarantine station. The issuing and or use of veterinary import permits are strictly controlled" he said.

"Eswatini does not import pork and related products from countries/ zones that are positive for ASF. Importations are only allowed from slaughter houses and establishments that are located in ASF free zones and also source their slaughter stock from registered and supervised disease free compartments," he added.

Dlamini also mentioned that feeding of swill was discouraged. The fact that pigs are permanently housed prevents them from accessing food scraps accidentally. He attested that feed companies are required to implement a GMP, HACCP or any other recognized safety and quality standard.

Asked about a Contingency Plan, the director said should an outbreak occur the Veterinary Services would implement a stamping out policy in accordance to the Animal Disease Act 7/65. He added that there was no treatment or vaccine for ASF.

Eswatini records E745.5 million trade deficit in May

THE country, in the month of May, recorded a trade deficit of E747.5 million, a turnaround from a surplus of E189.1 million in the previous month.

According to the central Bank Recent Development Statistics, the deficit was informed by a significant increase in imports while exports grew at a steady rate in the month.

Exports were E2.309 billion in May, up by 4.1 per cent from the

preceding month.

The import bill in the month of May 2019 amounted to E3.057 billion reflecting a month-on-month increase of 50.6 per cent.

Invoices

The increase was influenced by a tripling in invoices for energy products in the month. Cumulative export earnings for 2019 as at May amounted to E10.793 billion, 25.7 per cent higher than the E8.583 billion of May the previous year.

The report stated that the country's major export of miscellaneous edibles posted a 13.0 per cent increase

o amount to E1.214 billion.

Proceeds from sugar and sugar confectionery products declined by 19.6 per cent in the review period, totalling E438.8 million.

Earnings

There was also a decline in export earnings from textile and textile apparel, which amounted to E252.2 million down from the E273.7 million of the previous month.

Wood and wood article exports increased by 27.8 per cent to total E139.9 million in May.

Imports of energy products which accounted for 37.8 per cent of total

imports, increased substantially in the month, growing from E323.1 million to E1.156 billion.

There was also an increase of 14.7 per cent recorded in the import of nuclear boilers, machinery and equipment which were E240.6 million in the month of May.

Bill

The import bill for vehicles amounted to E172.4 million increasing by a month-on-month 5.6 per cent. Imports of cereals were E96.9 million in May 2019, reflecting an increase of 3.2 per cent when compared to the month of April.

Compared to the US Dollar, the Lilangeni depreciated by 2.1 per cent to average E14.43 to the US Dollar from an average of E14.13 in April.

The weakening throughout the month is mainly due to a large Rand sell-off prompted by low investor confidence towards emerging market economies following the news of renewed US-China trade war to which there was optimism that it would disappear.

This is contained in the Recent Development Statistics released by the Central Bank of Eswatini for May 2019.

The US in the period under review has already imposed tariffs on Chinese products, which puts emerging market currencies including the rand, under pressure.

While the market may have reacted positively to the May 2019 election outcome in South Africa, the dovish tone of the South African Reserve Bank and uncertainty around the delayed appointment of new Cabinet ministers in South Africa saw the rand depreciating against the US Dollar.

Against the Pound Sterling the local unit depreciated by 0.5 per cent to average E18.54 from an average of E18.45 in April.

The Rand when compared to the Euro was also weaker at E16.14, down from an average of E15.89 in April. The Lilangeni closed the month of May 2019 at E14.77 to the US Dollar, E18.63 to the Pound Sterling and E16.45 to the Euro after closing the month of April at E14.37 to the US Dollar, E18.60 to the Pound Sterling and E16.08 to the Euro. Even though the local unit is weaker, it is set to rebound in the short-tomedium term as domestic risks which impede investor sentiments are expected to fade driven by policy reforms which are likely to reignite growth in South Africa.

The trade war tension embarked upon by the US on various economies, however, remains a major threat to the Rand/Lilangeni outlook against the major trading currencies.

stood at E10.6 billion as at the end of May, an equivalent of 16.1 per cent of GDP.

This almost remained constant when compared to the previous month. The Central Bank of Eswatini Recent Development Statistics highlighted that this suggests that there has been no net effect in the issuances during the month. The reports further noted that a total of E41.50 million was issued through private placements

THE Outstanding domestic debt in the Suppliers' bond programme. On 27 May, the bank, on behalf of government, auctioned four different tenors in plain vanilla bonds totalling E220 million.

ESERA TO CREATE DATABASE FOR

THE Eswatini Energy Regulatory Authority (ESERA) seeks to create a database of parties who may be interested in participating in the development of 40 MW of solar by 2020 and 40 MW of biomass by 2021.

The projects, which will be part of the Ministry of Natural Resources and Energy recently released Short-Term Generation Expansion Plan, will be designed to reduce the country's dependence on power imports from South African utility Eskom.

The authority has begun the procurement process for 40MW of PV capacity. The projects, which will be assigned by 2020, will also include 40MW of biomass. ESERA has also begun the process of procuring new generating capacity from independent power producers, with the support of the ministry of natural resources and energy.

"Due to the constraints faced by Eskom and the expected significant tariff increases from Eskom, the reliance by Eswatini on electricity imports from South Africa is no longer secured," the ESERA said in the document.

Eswatini issued its first utilityscale solar tender in June. It aims to increase the share of renewables in the country's electricity mix to 50 per cent by 2030.

The current installed capacity of Eswatini Electricity Company (EEC). is only around 60 MW, which is enough to cover just 10 per cent of the kingdom's electricity demand. The vast majority of the electricity the small country consumes cos from Mozambique and South via the Southern African Pool (SAPP).

US POLICY TOWARD IRAN IS ALL STICK AND NO CARROT

•A war between Iran and the US would pit the mighty American military machine against a much smaller but highly mobile array of Iranian forces and allies spread around the Middle East.

ABU DHABI - The motorcycle zipped past our taxi as we headed to Tyre in southern Lebanon, veering off the road onto a dirt track leading up into the hills.

The passenger on the back of the motorcycle had what appeared to be long tubes, concealed by cloth, strapped to his back.

I couldn't stop and ask who they were or what those tubes were, but they were probably Hezbollah fighters moving rockets or other weapons to the south.

For weeks in July 2006 Israeli jets bombed Beirut's southern suburbs, and other towns and villages in Lebanon's south, trying to knock the Iranian-backed group out of action. They failed.

From our camera position south of Tyre, we watched daily as vol-

ley after volley of Katyusha rockets roared out of the banana groves toward Israel. Frequent Israeli air strikes didn't appear to have any impact on the men launching the rockets.

Iran provided -- and continues to provide -- training, weaponry and equipment to Hezbollah.

As the US and Iran rush perilously close to a violent confrontation, the example of Hezbollah's 34-day war with Israel comes to mind. A war between Iran and the US would pit the mighty American military machine against a much smaller but highly mobile array of Iranian forces and allies spread around the Middle East.

Regardless of the details behind Thursday's attacks on two tankers

in the Gulf of Oman, a confrontation between Iran and the United States became ever more likely after the Trump administration unilaterally pulled out of the Iran nuclear deal last year, brought on by ultra-Iran hawks Mike Pompeo as Secretary of State and John Bolton as National Security Advisor, and then began to tighten the screws on Iran with ever more punishing economic sanctions.

US policy toward Iran now is maximum sticks, no carrots.

Iran is very different to Saddam's Iraq

Unlike Saddam Hussein's Iraq in 2003, however, Iran has plenty of sticks at its disposal.

In 2003 Iraq was a shadow of its former self. I recall driving to

Baghdad two years before the war and being stopped at an Iraqi Army checkpoint in the desert. The gaunt, weary troops didn't ask for our papers. They asked for food and water. By 2003 Iraq was weak and isolated. In his hour of need, no one came to Saddam's aid.

Iran is different. It has armed and trained Hezbollah, perhaps one of the most effective fighting forces in the Middle East. It has backed the Houthis in Yemen, who have managed to fight the US-backed and armed Saudi and Emirati armies to a standstill. An array of militias in Iraq receive support from Iran.

Plus, Tehran has had close ties with Syria going back to the 1979 revolution. Iranian troops and advisers helped, along with Russia and Hezbollah, to keep Bashar al-Assad

Iran has plenty of IOUs it can call in. Its friends have already made it clear they won't stand idly by if Iran is attacked. On May 31, Hezbollah Secretary General Hassan Nasrallah told a rally "a war on Iran will not remain within the boundaries of Iran. A war on Iran will inflame the entire region, and American forces and American interests will be destroyed."

Notre Dame celebrates 1st Mass since devastating April fire

PARIS - The archbishop wore a hard-hat helmet, burnt wood debris was still visible and only about 30 people were let inside, but Notre Dame Cathedral on Saturday held its first Mass since the devastating April 15th fire that ravaged its roof and toppled its masterpiece spire.

dral remains in a "fragile" state, especially its vaulted ceiling, which is still at risk of collapsing.

For security reasons, only about

ers wore construction worker's helmets. Some of the workers rebuilding the church were also invited.

Other worshippers could watch the Mass live on a Catholic TV station. The video showed some burnt wood still in the church but a famous statue of the Virgin and Child appeared intact behind wooden construction planks.

The annual Dedication Mass commemorated the cathedral's consecration as a place of worship.

"This cathedral is a place of worship, it is its very own and unique purpose," Aupetit said.

One French priest called the service "a true happiness, full of hope." AP

'Sea of black' Hong Kong protesters demand leader step down

HONG KONG - Hundreds of thousands of people clogged the streets in central Hong Kong on Sunday dressed in black to demand the city's leader step down, a day after she suspended an extradition bill in a dramatic retreat following the most violent protests in decades.

The massive rally saw some protesters carry white carnation flowers, while others held banners saying, "Do not shoot, we are HongKonger," as they sought to avoid a repeat of the violence that rocked the financial centre on Wednesday when police fired rubber bullets and tear gas.

Six contenders remain, with Johnson by far the favourite. Lawmakers are set to narrow the field this week in a series of elimination votes, with the final two names put to a vote of Conservative members nationwide. AP

'Times Russia report is 'virtual treason'

NEW YORK - US President Donald Trump on Saturday accused The New York Times of "a virtual act of treason," after it reported the US is stepping up digital incursions into Russia's electric power grid.

Current and former government officials have described the classified deployment of American computer code inside Russia's power grid and other targets, the Times reported.

The action is intended partly as a warning but also to leave the US poised to conduct cyberstrikes in the event of a major conflict between the US and Russia, the newspaper said.

Erdogan sees S-400s delivery starting in July

ISTANBUL - Turkish President Tayyip Erdogan said he expected Russian S-400 missile defense systems to start arriving in Turkey in the first half of July, broadcaster NTV reported on Sunday, a development set to fuel tensions with NATO ally Washington.

The S-400s are not compatible with NATO's systems and have been a growing source of discord between Turkey and the United States in recent months. "We discussed the S-400 subject with Russia. Indeed the S-400 issue is settled," Erdogan was cited as telling reporters on his plane returning from a visit to Tajikistan, where he attended a summit and met Russian President Vladimir Putin. Reuters

Opposition wants 'urgent action' from Ramaphosa at SONA

CAPE TOWN - President Cyril Ramaphosa is under pressure to provide detailed plans in his State of the Nation Address on Thursday to fix the country, an ailing economy and struggling state-owned entities.

Opposition parties said on Saturday the honeymoon for Ramaphosa was over and he needs to ignite growth in the economy and create jobs.

The Cabinet held its lekgotla in the week where it discussed the state of the economy, infrastructure upgrade, jobs and investments.

The lekgotla comes after the economy contracted by 3.2 per cent in the first quarter of the year, and ratings agencies warned the government to get things right.

Ramaphosa has set aside R400 billion for infrastructure upgrades.

SOEs have come under fire with two chief executives resigning in a few weeks of one another.

Eskom's Phakamani Hadebe quit a few weeks ago and was followed Vuyani Jarana at SAA.

Economists and investors have warned that Eskom is the biggest risk to the economy with a debt of more than R420 billion. SAA needs R21.7bn to continue operating until



2021, and its board said it would break even in two years time.

The SABC needs a bailout of R6.8bn for it to operate. Statistics South Africa also released figures recently that unemployment had increased from 27.1 per cent in the first quarter to 27.6 per cent.

Ramaphosa has promised to raise \$100bn (R1.4 trillion) investments in the next five years.

The ACDP, IFP and UDM said on Saturday this was an opportunity for Ramaphosa to get things right because the country was in a crisis.

Steve Swart of the ACDP said most of the issues that need to come from the SONA are the state of the economy and the high debt levels.

"On SONA, most of the issues relate to the economy and our GDP (gross domestic product) contrac-

tion by 3.2 per cent and that is of most concern to us and the fiscal sustainability of our debt," said Swart.

The debt was approaching 60 per cent of the GDP. Swart said Ramaphosa must deal with the parlous state of SOEs. He said the president must deal with those who are implicated in state capture.

"We want urgent action on those implicated in state capture and the money stolen must be returned," he said.

The IFP's Mkhuleko Hlengwa said they want Ramaphosa to ramp up growth in the economy, create jobs and stabilise SOEs.

"As we indicated when the president was elected, that when he does right, we will support him. SONA requires tangible action on job creation and economic growth

due to sluggish growth," said Hlengwa.

UDM leader Bantu Holomisa said he did not expect anything new from the SONA.

He said Ramaphosa has been saying the same things since he took over last year.

He said the issue of the SOEs was not new and this was caused by the ANC's cadre deployment policy and political interference.

"The issue of SOEs is not new because we deployed cadres, some of whom have no clue. As long as you allow the political head to usurp the powers of CEOs and heads of departments, we will continue to swim in this chaos," said Holomisa.

He said "every document you read" points to political interference by former leaders of the ANC in the entities. *Sunday Independent*

ANC Johannesburg Regional Chairperson GeoffMakhubu praised the ANCWL's young women's desk, which he described for stepping into the void left by the chaos in the ANC Youth League.

"The absence of the ANCYL has really been mitigated by the presence of the young women's desk," he said. *Sunday Independent*

ANC welcomes five new MPs to be sworn in

CAPE TOWN-The African National Congress in Parliament will welcome five new MPs when they are sworn in as members to fill vacancies in the National Assembly next week, ANC Chief whip Pemmy Majodina said on Saturday.

The vacancies arose after the recent resignations of former energy minister Jeff Radebe, former home affairs minister Siyabonga Cwele, former minister for women in the presidency Bathabile Dlamini, former tourism minister Derek Hanekom, and former labour minister Mildred Oliphant, she said in a statement.

The five new MPs were Alexandra Beukes, Kebby Maphatsoe, Zanele Nkomo, Wilma Newhoudt-Druchen, and Matthew Wolmarans.

"The ANC in Parliament welcomes these new members and we have full confidence that they will serve the people of South Africa with

The swearing-in ceremony will take place on tomorrow, at [3pm] in Parliament.

Jackson Mthembu to lead government propaganda department

PRETORIA - Newly-appointed Minister in the Presidency Jackson Mthembu will be responsible for government propaganda, a function previously the responsibility of the ministry of communications.

According to Ramaphosa, the ministry of communications, headed by Stella Ndabeni-Abrahams, will relinquish the Government Communication and Information System (GSIC), which will now be housed at Mthembu's office.

Mthembu will also be responsible for Brand SA and the Media Development and Diversity Agency.

As part of the reconfigured departments, Minister of Public Works and Infrastructure Patricia de Lille will also assume added responsibilities that were not a function of the ministry under her predecessors.

De Lille, over and above the previous mandate of the department, will be responsible for "coordinating responsibility for all public infrastructure development".

The statement by the president said that the reconfigured departments were meant to "strengthen accountability".

Ramaphosa also clarified which deputy minister will be responsible for which function in departments with two deputy ministers. At the department of agriculture, land reform and rural development, deputy minister Mcebisis Skwatsha will be responsible for land reform while Sdumo Dlamini will be in charge of rural development.

Deputy minister Pam Tshwete will look after human settlements, while David Mahlobo has been tasked with water and sanitation at the department of human settlements, water and sanitation.

The IRR is reacting to a statement by Trade and Industry Minister Ebrahim Patel that retirement funds play a role in the country's development.


The institute says government simply doesn't have enough money.

MADAGASCAR PRESIDENT **ASSURED OF WINNING** MAJORITY SEATS IN PA

ANTANANARIVO - Malagasy President Andry Rajoelina is assured of winning the majority of seats in the next National Assembly, according to the full results published Saturday by the National Independent **Electoral Commission (CENI).**

Projections made by political parties on the basis of these results attribute 84 of the 151 seats of deputies to the Rajoelina-led coalition, compared to only 16 to his unfortunate presidential opponent's party, Marc Ravalomanana.

The other 51 seats were won by candidates for the independent

Malagasy voters largely avoided the ballot box during the legislative elections on 28 May, with a turnout rate of less than a third of registered voters (31 per cent). "The results proclaimed assure

"The most important thing is that the president of the republic will be able to work in complete peace during his term of office," Pierre Houlder Ramaholimasy was pleased to say.

Sudan's Bashir to appear in court on graft charge - Prosecutor

KHARTOUM - Ousted Sudanese leader Omar al-Bashir is to appear in court next week to face charges of corruption and illegal possession of foreign currency, the country's acting prosecutor general announced Saturday.

The announcement came more than two months after the military overthrew Bashir following mass nationwide protests against his iron-fisted rule.

Bashir "will appear in court next week following charges of corruption and possessing foreign currency", Al-Waleed Sayyed Ahmed told reporters, without specifying the day.

On Thursday, an unnamed official quoted by the official SUNA news agency said Bashir was facing charges including "possessing foreign funds, acquiring suspected and illegal wealth, and ordering the (state of) emergency". AFP

Zim's local 'Dollar' should be allowed to depreciate further -Mnangagwa

HARARE - In his first live radio interview, President Emmerson Mnangagwa said Zimbabwe's local 'dollar' should be allowed to depreciate further from its current rate of around 1:6 with the US dollar, to make the country's exports competitive.

Mnangagwa said the RTGS dollar is still the strongest currency in the region, a claim that will anger struggling Zimbabwean workers, who have seen their purchasing power massively reduced in recent months.

Yesterday unions in the energy sector gave notice their members plan to go on strike soon; they say workers are no longer earning a living wage.

In a wide-ranging discussion with Capitalk, Mnangagwa spoke of his desire to leave a legacy as a reformer.

He also spoke of his dismay at rising prices but said his government won't be imposing price controls. EWN

20 jihadists 'neutralised' in French-Malian counter-terrorism operation

AKABAR - A joint operation by the Malian army and the French anti-jihadist force Barkhane, underway in northeastern Mali, has resulted in the "neutralisation" of some 20 jihadists, the Malian Armed Forces (FAMa) announced Saturday evening.

"About 20 terrorists neutralised in #Ménaka. The #FAMa and #Barkhane are conducting a joint operation in the locality of Akabar, in the Ménaka sector. This operation made it possible to neutralize about twenty terrorists," the Malian army reported on Twitter, without further details.

A jihadist group that calls itself the "Islamic State in the Great Sahara" (EIGS) is mainly active in this region of Ménaka and across the border with Niger.

In particular, he claimed responsibility for the October 2017 attack on Tongo Tongo in Niger. This ambush cost the lives of four American and four Nigerian sol-

Northern Mali had fallen in March-April 2012 under the control of jihadist groups, largely dispersed by a military intervention launched in January 2013 at the



initiative of France. This intervention continues with Operation Barkhane, which mobilises some 4 500 soldiers in the Sahel.

But entire areas of Mali are beyond the control of Malian, French and UN forces, despite the signing in 2015 of a peace agreement intended to definitively isolate jihadists.

Since 2015, violence has spread from the North to the centre, and sometimes even to the South.

Islamic State confirms killings

MAIDUGURI – Islamic State's West African branch claimed responsibility for an attack on a Nigerian army base in northeastern Borno state and said its fighters had killed 20 soldiers. The assault, which raised questions about government claims to have almost defeated the insurgents, took place in the town of Kareto on Wednesday. The barracks were burnt and a tank destroyed, Islamic State in West Africa (ISWA) said in a statement published on the SITE Intelligence website.

Security sources had said earlier that the base, home to the from the Nigerian Army's 158th Battalion and 130 km from the state capital Maiduguri, had been overrun and the commander killed. EWN

9 civilians killed in revenge attack

MOGADISHU - Nine civilians were executed by a local militia in war-torn Somalia after the killing of a policeman by the Islamist militant group Al-Shabaab, police said Saturday. The revenge attack on Friday just outside Galkayo - one of the most developed cities in the centre of the country - targeted the Rahanweyn clan, several of whose members are suspected of being Shabaab fighters.

"This was a horrible incident, a gruesome killing against nine unarmed innocent civilians in southern Galkayo. All of the civilians belong to one clan and the gunmen shot them dead in one location a few minutes after suspected Shabaab gunmen killed" a policeman, Mohamed Abdirahman, a local police official said. AFP

Bomb kills several police officers

NAIROBI - At least eight Kenyan police officers have died after their car hit a roadside bomb near the Somali border.

Eleven people were in the car when it hit the device in east Wajir county. The fate of the others is unclear.

No-one has admitted planting the explosives. Unnamed officials told AFP news agency that the police had been pursuing suspected al-Shabab Islamist militants fighting Somalia's government and its backers, including Kenya. The al-Qaeda-linked group has been trying to overthrow the Somali government for years. BBC

Tanzania 'in danger' following Ebola cases

DODOMA - Tanzania's health minister issued an Ebola 'alert' yesterday after the disease, which has killed over 1 400 people in the Democratic Republic of Congo, appeared in their shared neighbour, Uganda.

"I want to alert the public that there is the threat of an Ebola epidemic in our country," Ummy Mwalimu tweeted days after officials confirmed that members of a family who had travelled to the DRC had died in western Uganda. The minister said the alert was necessary given the frequent interactions between Tanzanian and Ugandan people "via the official borders or by other, unofficial channels." The Citizen





Paul Pogba puts Juventus, Madrid

on red alert

TOKYO - Manchester United midfielder Paul Pogba suggested on Sunday that he could be open to a move away from the Premier League side, telling reporters in Tokyo that now 'could be a good time to have anew challenge somewhere else'.

The Frenchman has been linked with a move to Real Madrid to work with coach Zinedine Zidane, or with a return to his former club Juventus. Pogba's time at Man-chester United has coincided with some insipid performances on the pitch and organisational turmoil at the club.

"Like you said, there is a lot of talking and a lot of thinking as well," Pogba, 26 told reporters in Tokyo.

"Forme I have been for three years in Manchester and have been doing great; some good moments and some bad moments, like everybody. Like everywhere else. Daily Mail

Frank Lampard agrees to take over at Chelsea

LONDON - Frank Lampard 'will take over at Chelsea in the coming days after being assured of at least two years in the hot-seat at Stamford Bridge'.

Maurizio Sarri is on the verge of leaving Chelsea for Juventus, and Lampard is set to replace him at the club where he plied his trade as a player for 13 years. And the Derby boss has been given a major assurance, with The Times reporting that Roman Abramovich called him personally last week to tell him he would have at least two transfer windows to demonstrate his worth.

Given that Chelsea are currently serving a twowindow transfer ban, that would mean Lampard will definitely stay for the 2019-20 and 2020-21 seasons. The Blues will need to pay a substantial compensation package to Derby to get Lampard, and will use the money they receive from their own compensation package from Juventus.

It has been claimed this week that Derby - in a desperate bid to keep their manager after falling short of a place in the Premier League - have offered Lampard a new deal, but he is unlikely to rebuff the advances of his old club.

Chelsea are keen to bring in Lampard, knowing that he is a hugely popular choice with a fanbase who were frustrated last season by Sarri's management despite winning the Europa League and finishing in the top four of the Premier League.

Torreira is AC Milan's top transfer target

LONDON - AC Milan have reportedly made Arsenal's Lucas Torreira their top transfertarget this summer and are considering offering Franck Kessie in part-exchange.

Toreira moved to the Emirates Stadium only 12 months ago in a£26million move from Sampdona and has admitted that adapting to life in England has been a struggle.

The Uruguayan's former boss at Sampdoria, Marco Giampaolo, is set to become the new Milan manager and has reportedly made Torreira his top target.

According to Italian newspaper Gazzetta dello Sport, Milan have contacted Torreira's agent to discuss the possibility of a quick return to Italy.

Milan would have to pay around £40m for the midfielder but,

according to Tuttosport, could offer 22-year-old Ivorian Kessie as part of the deal.

Alternatively, Kessie could be sold to another club to raise funds to land Torreira.

The decision will be made in part by two club legends appointed into roles at the San Siro just this week. Zvonimir Boban was appointed the club's chief football officer while Paolo Maldini has become technical director.

Milan are boosted in their pursuit of Torreira by the fact his girlfriend, Vittoria Repetto, who hails from Genoa, isn't happy in London and would like to return to her homeland.

And this desire to move was reflected by Torreira in comments when asked last week what he enjoys most about England. He said: "I don't know if there are many things that I enjoy. I think it was better in Italy. England is a totally different world, a very large country.

"The language barrier has cost me, to be able to relate with my peers and with the people. It's very difficult when you can't have dialogue. And so is the climate. You go out in the morning and it is cloudy, you arrive late to your home and it is cloudy.

"It is strange a little bit, the sun, the more of us that we are here and we are accustomed to having always or almost always the sun. But as the years pass, I'm going to be adapting."

However, Milan could offer Torreira an escape route this summer and with Kessie keen to test himself in the Premier League, a deal could be struck.

Goals from Roger Martinez and Duvan Zapata in the final 20 minutes gave Colombia their first tournament victory over Argentina in 20 years as Messi's hopes of finally landing a major international tournament after losing in four finals suffered a serious blow

"We leave here feeling bitter," said Messi following the Group B clash in Salvador. "In the second half we had our chances."

One of the best of those fell to the 31year-old Barcelona icon but he headed wide after Colombia's goalkeeper David Ospina got down quickly to push out a header from center-back Nicolas Otamendi

But although Argentina dominated possession and created more chances in the second period, they rarely caused Ospina any serious concerns.

"We didn't want to start this way,

obviously, but now we have to lift our heads and keep going," said the fivetime Ballon d'Or winner, who lined up in an enviable forward trio with Manchester City's Sergio Aguero and Angel Di Maria of Paris Saint-Germain.

"In the first half we retreated a little and were holding on, but in the second we really opened up," said Messi, the Argentina captain.

"Whenever you lose it's hard for us, we usually take it badly. Now we have to think about Paraguay.'

Argentina can still make the knockout stages with games against Paraguay and guests Qatar, the Asian champions, to come.

Midfielder Leandro Paredes, who forced a diving save out of Ospina with one long range strike and sent a second whistling past the post, was pleased with the second half performance.

"We created a lot but unfortunately they scored in our best period," he said.

Colombia were the better side in a goalless first half but scored twice against the run of play in the second period, with both goals coming from substitutes. AFP



Buffon considers taking year off after rejecting PSG offer


TURIN - Gianluigi Buffon could spend a year out of football after turning down Paris Saint-Germain's lucrative offer of a second season because he did not want to watch from the



As of the end of 2018, non-current assets stood at E40 983 173 of the EFA's purse, while current assets, which include trade and other receivables plus cash and cash equivalents, stood at E5 564 652.

Expected

The EFA's value is expected to increase as of the current financial year as a number of projects are expected to mushroom under the EFA's FIFA Forward Programme, including the technical centre at Ka-Langa, and others at Mkhuzweni

and Manzini, which are also expected to be commissioned soon.

EFA's Chief Executive Officer (CEO), Frederick Mngomezulu revealed to affiliates at the AGM that the Ka-Langa Technical Centre, including the artificial pitch that goes with it, were very close to completion.

Remains

"The structure is already complete at Ka-Langa. We already have running water and electricity, and what remains is the planting of grass and a few final complementary things that need to be done before operations can begin," he said.

The CEO further stated that Mkhuzweni Technical Centre, also under the FIFA Forward Programme, would be commissioned before the end of this year.

Commissioned

"The documentation is already with FIFA, and we expect the project to be commissioned within the last quarter of 2019," he said.

He added that Manzini shall follow after Mkhuzweni, adding that the planning phase had already begun as they had identified the site. "We have a very impressive structure at Ka-Langa and shall use it as a benchmark for the rest of the projects under the Federation of International Football Associations (FIFA) Forward Programme," he said.

E500 000 BOOST FOR CAF BOUND

SOCCER - THE two local CAF envoys Green Mamba and Young Buffaloes will receive E500 000 from the Eswatini Football Association for their continental missions.

The two teams will be representing the country in the 2019 CAF interclub competition where Green Mamba will be competing in the CAF Champions League while Buffaloes will be campaigning in the CAF Confederation Cup.

The news was confirmed by the FFA Chief Executive Officer (CEO) Frederick Mngomezulu during the organisation's Annual General Assembly held at the Sibane Hotel yesterday.

Activeness

"We will assist clubs local clubs who will be representing the country in the CAF clubs competition. Each team will get a once-off financial injection of E500 000 for their respective assignment. There will be no extra money given to these

teams beyond that despite their activeness in their respective competitions," he said.

Correctional Services side Green

Mamba sealed their continental ticket by winning the 2018/19 MTN Premier League crown while Buffaloes ensured their return to the CAF

Confederation Cup by winning the 2019 EswatiniBank Cup for the third time in a row.

E1.2 million for regional associations

SOCCER - THE four regional associations will receive E1.2 million to share among themselves from the Eswatini Football Association.

The associations have already received a portion of the money which they used for their administrative costs.

This was revealed by the EFA President Adam 'Bomber' Mthethwa in his speech during the organisation's Special General Assembly.

"The EFA has exclusively decided to create a budgetary line from the FIFA Forward Programme as a grant to its member associations.

This establishment will assure

that members, even as and when they implement their activities, there is a minimum grant upon which their business can be projected on an annual basis.

Depending

"The first figure has been placed at E1.2 million which will be distributed in varying amounts, depending on the nature of business, to the various members of the Football Association.

"This will be received in two equal parts in February and in August every year," he said

Mthethwa further announced that the four regional associations would now have their general secretaries, otherwise known as chief executive officers employed on fulltime basis.

Ka-Langa Stadium to be opened in November

SOCCER - THE country's stadium shortage will soon be alleviated after the opening of the Ka-Langa Stadium in Siteki.

The new stadium, which is part of the FIFA Goal Project, is expected to be ready for usage in November.

This was revealed by EFA Chief Executive Officer Frederick Mngomezulu yesterday.

"The Ka-Langa Stadium will be operating later this year around November as the project is nearing completion. We are still expecting a team of FIFA European experts to arrive in the country to install the artificial turf at the stadium.

"The stadium has several important features such as dressing rooms and offices to be utilised by the Lubombo Regional Football Association (LRFA)," he said.

"The executive committee will this forthcoming year operationalise the professional employment of fulltime general secretary on contract for the Regional Football Associations," he said.

The longest serving EFA President also announced that they would now provide an insurance life cover for executive members.

Tight schedule for Sihlangu

SOCCER - THE senior national team Sihlangu Semnikati will have a busy 2019.

The nation's pride is expected to compete in the 2021 AFCON Qualifiers and 2026 FIFA World Cup Qualifiers in September.

The upcoming schedule for the Kostadin Papic men was announced by the EFA Secretary Frederick Mngomezulu. "The senior national team is expected to compete in qualifiers later this year for the AFCON 2021 and 2026 FIFA World Cup. The draw for the two competitions will be done in July. We might need more money for the team if they manage to reach the third round of the CHAN Qualifiers around November," he said.

Mngomezulu further announced that they were also working on securing a technical sponsor for Sihlangu before the upcoming CHAN second round qualifier against Angola next month.

"We are working around the clock to have a technical sponsor that will also provide replica kits for the team before our next match against Angola.

Package

"We are still in talks with several companies, who have shown interest in sponsoring the national team. We will look for a package that will come with an affordable prize for the replica jerseys to benefit the nation," he said.

Swiss company Macron recently provided a kit for Sihlangu during the recent 2019 COSAFA Cup held in Durban, South Africa.

Mngomezulu further mentioned that the registration for domestic competitions will open on July 8 until September 20.



EFAINE8.4M DEFIC

SOCCER – THE fall in government's allocation drove the Eswatini Football Association (EFA) into a deficit of about E8.5 million.

Financial statements released by the EFA for the 2018 financial year show that the association's finances from a surplus of about E2.5 million at the end of 2017, to a short-fall of about E8.5 million, was recorded at the end of 2018. EFA's Chief Executive Officer, Frederick Mngomezulu stated this during the EFA's AGM at Sibane Hotel yesterday. He said they had projected to receive at least E10 million from government but ended up getting less than E5 million. He pointed out that as a result of their anticipation of a bigger share, they committed all the national teams

in international assignments only to find out that they would actually be getting far less.

"We ended up using the monies we carried over from the previous financial year to finance some of our activities.

This explains the huge deficit reflected in our finances, but our position is not as bad as the figures reflect," he said. The CEO added that they expect stability for between now and next year as they

are well aware of monies that would come into the association's coffers.

He said they also expect stable changes from other grants, like those from FIFA and CAF. "We expect our financial reporting to be comparable for the next financial reporting because of that reason," he said. The EFA has budgeted to receive at least E5 million from government for 2019 and 2020.

EFA TO DISPOSE OF E0.8 MILLION SAFA BUS

SOCCER - THE Eswatini Football Association (EFA)'s executive committee has taken a decision to dispose of the E0.8 million worth bus donated to it by the South African Football Association (SAFA) after the 2010 World Cup.

The bus had literally become the association's feet over the last nine years, but EFA's Chief Executive Officer, Frederick Mngomezulu indicated that costs for its mainte-

nance had been unbearable.

The EFA used the bus to transport the various squads for training sessions and attending international matches. Mngomezulu explained that the over E900 000 incurred by the association over the past financial year on motor vehicle maintenance and repairs incorporated huge costs for servicing the bus in neighbouring South Africa.

"The association has agreed to

dispose of two vehicles in total to moderate the costs of maintenance," he said. A member of the Eswatini Football Coaches Association (EFCA), asked what plans the EFA had to ensure that they secured other vehicles to replace those being disposed because it was near impossible to run football, let alone any organisation, without vehicles.

Mngomezulu acknowledged that replacing the said vehicles was a top priority for the EFA, but in the

meantime, they would continue to lease vehicles to meet their day-to-day requirements for running their offices. A member of the Premier League of Eswatini (PLE) enquired what the reasons were for the effect of the disposal of the said assets not to appear in the budget for 2019 and 2020. The CEO said the reason for that was because the decision to dispose of the assets was taken after the budget had been drafted.
