Hot Christmas Day



...she fears for her unborn child's life, suspects arrested

A 24-year-old woman feared for the life of her unborn baby after she was repeatedly raped when she was eight months pregnant.

*Bulelwa of New Village was raped by two men who had given her and another woman a lift from Nhlambeni to New Village.

The two suspects; Thokozani 'TK' Madolo (25) of Khuphuka and Bongani Mahlalela (20) of Mpaka were arrested and charged with three counts; two of rape and the other for robbery.

The incident happened near New Village on November 27.

Narrating her ordeal in court, Bulelwa said she was from visiting her sister at Nhlambeni area to New Village when she got a lift from the two accused persons' car.

Car

She said it was around 8pm when this happened. After the car stopped, Bulelwa said Thokozani alighted from the front passenger seat and sat at the back, allowing her to sit next to Bongani who was driving the grey Corolla vehicle.

Upon getting into the car, Bulelwa informed the two that she was headed for New Village, and they promised to take her there since they claimed to have been driving to Malkerns.

Along the way, at KaShali area to be precise, Bulelwa said they stopped for another woman who was hitch-hiking. This woman, *Dudu (25), informed the car occupants that she was going to Mfabantfu

The four then reportedly drove for some time and when they reached a place known as Emabhodini in Ngwane Park, Thokozani complained that the car did not have sufficient water, hence the mechanical problems. Amid all this, Bongani drove the car for a while before stopping far off the main road.

Fault

The two men reportedly alighted presumably to discuss what was to be done regarding the faulty car.

A short while later, the suspects

returned into the vehicle before locking all its doors.

Thokozani then asked for his bag which was at the feet of Bulelwa. Upon taking it from the pregnant woman, the suspect drew a knife and placed it on her stomach, demanding that she surrendered her cellphone. Thokozani also demanded that Bulelwa removed any security password, failing which he would stab her on the stomach.

Death

Meanwhile, Bongani also demanded same from Dudu, and she complied. Thereafter, the two men waited until there were no oncoming cars on the road, before they ordered the women to go into a nearby bush. The suspects told the two women that they would have sex with them in the bush, and if they refused, they would kill them.

Dudu pleaded that the suspects used condoms when raping them. Bulelwa told the court that she objected to sex as she was worried about the baby she was carrying.

In response, the men told her that any objection would be countered by death. After hearing this, Bulelwa said she then pleaded for condom use instead but her request fell on deaf ears. Each of the women was told that they would sleep with the one they were seated with in the car. They were then directed to different directions within the bush. Bulelwa said she was ordered to undress and Bongani inserted a condom before grabbing her neck and pushing her to bend over.

Police

After raping the woman, Bongani told Bulelwa that he would make her his wife, but she informed him that she feared him after what he did to her.

While the two were talking, Dudu and Thokozani emerged from the other side of the bush and they were talking about money on e-Wallet.

Dudu suggested that she transferred some cash to Thokozani's phone because she did not have cash on her.

After this was concluded, Thokozani ordered the pregnant woman to undress again before forcing his hands into her private parts while saying that he also wanted to sleep with her.

However, after some time, Bulelwa said Thokozani's focus was turned back to the money sent to him by Dudu, so he ordered the two women to hug each other.

Meanwhile, Bulelwa said while they were hugging, they heard the car speed off leaving them in the bush.

Luckily, a Good Samaritan gave them a lift and they relayed their ordeal to him.

The Good Samaritan assisted them by driving to Mhlaleni and Logoba hoping to find the accused persons withdrawing the E300 from an FNB ATM.

When they couldn't spot the car at these two places, the man suggested that they reported the matter to the police.

While they were driving to the Manzini Police Station, Bulelwa said they saw the car parked near the post office. The Good Samaritan quickly drove the two women to the police station where Gugu in the company of police officers, returned to the post office where the two suspects were eventually arrested.

The two women were then taken to hospital where in Bulelwa's case, the doctor reportedly could not detect the heartbeat of the unborn baby.

In a bid to resuscitate the baby, the doctor injected and prescribed some medication to Bulelwa.

She said she had been in and out of hospital where the doctors had been trying to ensure that the baby was alive and healthy.

However, whether or not these efforts were effective is still to be made known to the court after Bulelwa has delivered the baby.

The matter is pending before Manzini Principal Magistrate David Khumalo. More witnesses will be paraded on Friday.

REVEALED: FARMERS BANK TO FINALLY START OPERATION

A year after the Central Bank of Eswatini issued a banking licence to a new bank called the Farmers Bank (Pty) Ltd, the bank is expected to finally operate early next year.

The licence allows Farmers Bank to conduct banking business in the Kingdom of Eswatini as a commercial bank as of October last year.

Even though the management of the Farmers Bank did not want to respond to questions on

the matter saying they would be pre-empting their current position, investigations by this publication indicate that the bank may be operating by January, which is two weeks away. Similarly, the Central Bank of Eswatini has not responded to questionnaire on the status of the bank sent two weeks ago. The Chairperson of the Farmers Bank Hlonipho Dlamini said they were currently not in a position to say anything at the moment for fear of pre-empting their position until they are ready to operate.

"We will grant you an interview at the appropriate time," he said. However, the Eswatini

Observer while investigating the matter came across billboards which indicate that the bank is ready to operate and will be at the Arcade Building (Manzini) located near the Satellite Bus Rank. Sources stated that this venue will be the first offices of the bank with prospects of establishing branches over time.

Efforts to get comment from the Central Bank, which is a regulator of banks, proved futile as a questionnaire sent to the Head of Communications Zithulele Gina on 10 December was not responded to. His phone rang unanswered when called several times in the interim and the last call was

made yesterday at 5:16 pm. Gina was called on December 12 at 12:07pm, he was also called on December 17 at 10:16am and again on December 18 at 13:13pm. Similarly, efforts to get comment from the CBE Governor Majozi Sithole proved futile as his phone rang unanswered on December 12 at 12:10pm and yesterday at 17:17pm. When confirming granting the license last year the governor was quoted by the media having said the Central Bank was doing so after having done a thorough interrogation and determination of the incoming bank and its directors.

BUCOPHO COMMITS SUICIDE AT LOVER'S

MEMBERS of a Sihlongonyane family in Mpolonjeni near Siteki yesterday morning woke up to a shocking discovery after a man was found hanging in a tree which is in the middle of the homestead.

It transpired that the individual was Bucopho of the area, Hawane Dlamini (39) and was married. The incident has left both the Dlamini and Sihlongonyane families dumbfounded as they try to comprehend what could have led to Dlamini ending his life.

Chief Police Information and Communications Officer Supt. Phindile Vilakati confirmed the incident, adding that the police were carrying out active investigations.

Tablets

She stated that at the moment nothing tangible has reached them on why Dlamini decided to end his life.

It is gathered that before he was found hanging at the Sihlongonyane homestead, Dlamini was discovered with weevil tablets and was discouraged from

Dlamini is said to have had a lover at the Sihlongonyane homestead.

However, his lover is reported to have not been at home when the incident happened.

The mother of Dlamini's girlfriend was the one who made the shocking discovery as she was out to pass water early in the morning.

She raised an alarm, prompting neighbours to make a prompt response. It was then that the hanging body was close

ly inspected and identified as that of Dlamini.

Police were also called to the scene, upon which they recorded statements before taking the body to Good Shepherd

By yesterday afternoon, members of the Dlamini family were found gathered at the homestead where they discussed preparations for burial.

Tree

Qonda Mazibuko, the deceased's halfbrother, confirmed the sudden death of Dlamini. Mazibuko said the family was still traumatised and trying to gather pieces of information which could explain his brother's decision to end his life.

Mazibuko said they received a call from the Sihlongonyane family in the early hours of yesterday, informing them about the incident.

He said the Sihlongonyane family also could not give any explanation as they claimed to have only discovered the body hanging from the tree in the morn-

"My brother did not leave even a note, something which makes it even harder for us to know what could have influenced his decision," said Mazibuko.

He then referred further questions to the police, saying they could be the ones with clear answers.

Meanwhile, relatives who claimed to be privy of some details stated that Dlamini visited his in-laws' homestead in the middle of the night for unknown reasons. He parked his vehicle outside the premises of the homestead before walking in to commit the alleged sui-

Dlamini's relationship with one of women at the Sihlongonyane homestead was reportedly well-known in the community. He was said to have recently rented a flat for his lover at Mhlume, where he would make occasional visits. "We do not understand why he went to his in-laws' homestead while knowing that his girlfriend was not there," said a relative who preferred anonymi-

Man burns own house, commits suicide

IN a rather shocking incident, a 30-year old man of Mankayane, Mgazini, shocked family members when he burnt down his house before committing sui-

This was allegedly after going through his wife's cellphone and seeing another man's picture.

Bongi Mabuza is said to have gone through his wife Nontsikelelo Ndzimandze's cellphone and little did he know that he would see another man posing in a sexy man-

It has been reliably gathered from well-placed sources that upon seeing the picture of the man, an altercation ensued between him and his wife which led to him walking out of their matrimonial home.

After walking out, he went to get petrol which he then doused the house which is located at the heart of his parental home.

And he later ended his life.

Family members, including his sisters, children and brothers rushed to the scene and removed him from the rafters.

They rushed him to hospital where he was certified dead upon

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the incident.

Meanwhile, Nontsikelelo, the surviving spouse of the deceased, refuted claims that her husband killed himself because of a picture and altercation they had earlier. "He was fine, he just woke up burnt his house and decided to kill himself," said Ndzimandze.

Speaking on behalf of the family was the deceased's sister Jabulile Mabuza who said they were still reeling in shock following the incident as a family.

She stated that the deceased was doing well and they had not anticipated that such would happen to him. "We know for a fact he had a fight with his wife on the fateful day but we had not expected such," said Mabuza.



Cops bust three wanted robbers ahead of Christmas

RESIDENTS of Pigg's Peak and Mbabane can now breathe a sigh of relief as three men have been arrested in connection with a string of armed robberies.

This brings the almost month long search for the trio to a close, after the Royal Eswatini Police Service issued notices of the wanted persons published through the media.

Bongani 'Mdi' Buthelezi (27), Sanele Ngwenya (31) and Sipho Sibandze (35) have since been advised to move their bail application at the High Court after their appearance before Magistrate Sifiso

According to court records, the trio was said to have been charged with six counts, after they were said to have committed the offences at Mangwaneni, Mahwalala, Mgababa Bar in Mbabane and in Pigg's

They were said to have forcefully taken items valued at E49 472 from various unsuspecting victims. The highest value of items taken by the trio was from one Yasen Patel, where Buthelezi and Ngwenya were said to have taken items valued at E25 130.

Some of the items taken from Patel included three cellphones, money in cash amounting to E6 500, cigarettes and a work permit valued at E2 000.

They were further said to have threatened to assault one Monel Hassan with a gun, if he refused to let them take his valuables valued at E7 720

Some of the items taken from Hassan included a Samsung J6 cellphone valued at E2 900, six boxes of cigarettes and money in cash amounting to E2 500.

During their appearance before the court, the trio was informed that they were to be remanded into custody until February 7, 2020 for the setting of their trial date.

GOVTINE30 MILLION NIC SUBSIDY WESS

... farmers turned back without farm inputs as agro-suppliers not paid

OVER 2 600 farmers who registered for the input subsidy programme may find themselves being serviced later than anticipated as government is said to have failed to pay the National Maize Corporation (NMC) E30 million.

This amount according to sources, includes that of last year as government reportedly paid part of the funds resulting to the parastatal failing to efficiently roll out the programme.

For instance, NMC had a balance carry over of 1 055 hours from last

A well-placed source stated that this year the government did not pay even a single cent of the E30 million subvention to NMC. Therefore. NMC reached the last straw as it cannot maintain the programme they were entrusted with.

Tools

"Since last year the government has not paid the subvention in full, this year not even a single cent of the subvention has been paid to NMC. Therefore, NMC is unable to maintain services which range from fixing tractors that have developed mechanical faults to buying ploughing tools," said the source.

Following the frustrations that were encountered by NMC to keep the tractor hiring service afloat a decision was made to ground the operations to put pressure on gov-

In addition to the issue of tractors, the well-placed source revealed that farmers were turned back by agro-

dealers listed to supply farming inputs under the programme as they have not been paid.

This comes as a disadvantage to the farmers because they have paid their potion of the money but now they are being turned back.

Through the input subsidy programme farmers pay half of the price for the inputs of one hectare and government subsidises them with the other half which means farmers save 50 per cent under this programme.

Dealers

The source narrated that the E30 million was budgeted to cater for all the necessities of the programme. Farmers started accessing their farm inputs from the agro - dealers spread across the country from the first week of October 2019 but the dates were extended as some have not received their inputs.

NMC Marketing Communications Manager Nokwanda Dlamini in September said the parastatal was ready for the 2019 farming season as they had already ploughed 4 098 hours out of the nearly 14 000 hours paid by the

She said they were awaiting rains to commence ploughing the remaining hours, we are ready to service farmers anytime as soon as we receive rains."

A total of 178 tractors, both govemment and privately-owned tractors are waiting to plough as soon as the rains come. This number is expected to increase as we continue to service more tractors," she said at the time.

She revealed that 46 more tractors were to be added to the pool as soon as they were repaired.

Dlamini assured the farmers that

they would be serviced regardless of the number of tractors that may have brokedown in their RDAs as the tractors from the pool would be distributedd to the different areas across the country.

"We sometimes get comments from the concerned public about a number of non-operational tractors they see in RDAs. We would like to advise that we have fixed several the tractors and RDA's are not necessarily allocated those tractors parked at the RDAs.

Fears

We distribute tractors around the country according to the demand and we can assure farmers and the general public that they will get scrviced on time, because we aim to finish all registered hours during the current ploughing season," she

Last year, not all the farmers who had paid had their fields ploughed and thus some of the hours were carried over to this year's farming season.

In a press statement, NMC announced the disruption of services under the government tractor hire programme. The corporation assured members of the public that it was working around the clock together with the ministry of agriculture to fix the problem.

"The corporation is aware of the negative ripple effects that this disruption may cause, however, the challenge is beyond NMC's con-

Farmers frustrated over service delivery

PRESIDENT of the National Agricultural Union Boya Matse has expressed disappointment about the poor service delivery.

Firstly most farmers from the Lowveld narrated that this was unfair on them as the rainy season is limited in the Lowveld.

SANU SRC members not guilty

THE seven-member Southern Africa Nazarene University (SANU) Student Representative Council (SRC) has been acquitted of the three charges that were levelled against them.

The verdict was reached last Tuesday and it was issued by the Chairman of the disciplinary committee Sicelo Dlamini last Friday. The SRC members were suspended on November 11, after leading students in a protest action that led to the total shutdown of the institution.

The three counts that the seven students of the institution faced included that of alleged misconduct in that on October 31, the SRC members called an illegal meeting, without a written consent form from the dean of student affairs.

On the second count, the seven students were charged for misconduct in that on the 1st and 4th of November, they conducted an unlawful activity on the institution's premises without following the procedure as prescribed in Regulation C6 (6.3) of the university's calendar. The other charge was for damaging the university's property during the protest action.

Papers presented to the affected students by their lawyer stated that evidence brought before the disciplinary committee to prove that they were responsible for the removal of the rest of the student body from classes was unsatisfactory.

"We accordingly find that all the accused students are not guilty on all the charges based on evidence that was presented during the disciplinary hearing," read the

On another note, one other student, Sibusiso Nkwanyana, who was suspended along with the SRC members, is still not in the clear as his disciplinary hearing has been scheduled for January 9. Nkwanyana also has a pending matter at the Manzini Magistrate's Court, along with two others, where he faces a charge for contravening Section 83 of the Road Traffic Act of 2007 which states that one shall not place or cause to be placed a barrier, gate, rope, wire or any other obstruction across a public road.

Gathered

Likewise, the fate of the SRC President Simelane Tholumuzi Gubevu and secretary general Maseko Colani Khulekani remains unknown as they have not yet appeared before the disciplinary tribunal. Information gathered was to the effect that their lawyer has written a letter to SANU requesting that the two be allowed to register for the second semester next year. The letter also stated that the institution should respond in writing before December 31.

Failure to do so, the letter states, will result to the matter being referred to the

High Court where the student leadership's lawyer would request that the charges levelled against the two be withdrawn altogether.

When SANU's Marketing Manager
Petros Mavuso was sought for comment
on the way forward following the seven
students' verdict, he said in as much as
he was aware of the verdict the management was still waiting for an instruction
from Senate directing them on what to
do, especially because these students have
missed their end of semester examinations

"Currently, the institution has closed for the holidays and most of the relevant figures are away. Until we get a directive on what to do, I cannot say anything," he said. Meanwhile, Swaziland National Union Students (SNUS) SANU branch has called on the institution's administration to ensure that the SRC members write the tests that they have missed which contribute to their continuous assessment (CA), and the missed first semester examination. "Until and unless our 12 demands are met, the issue of Phephile Sifundza is resolved, and the SRC president and secretary general are back in class our discontentment will remain permanent. Students should be aware that our challenges as students of SANU will be better addressed in a democratic government and by a sound and competent administration," read a statement by SNUS.

"There were 138 drink-driving cases reported over the past weekend," she said.

This has been the highest number of drink-driving cases that has been recorded by the service in a while. Last week, the police recorded 99 cases.

The reason behind the drastic increase is attributed to the festive season as people indulge a lot in alcoholic beverages during this time. The weekend before last police nabbed 117 motorists

for driving under the influence of alcohol.

On December 1, 91 motorists were arrested for driving while under the influence of alcohol.

This therefore effectively means within a space of three weeks police have arrested 445 motorists for con-

travening Section 91 (1) as read with Section 122 of the Road Traffic Act of 2007.

According to the Act, the legal limit stands at 0.38mg/l and every motorist found with more than the stipulated legal content will be charged for contravening the Act.

Man gets suspended sentence after 'unfair' arrest

A 33-year-old man was shocked by his arrest as he claimed that police officers ordered him to look after his friend's car.

He was later arrested for occupying the driver's seat while under the influence of alcohol.

Relaying his side of events before the court, Nhlanhla Vilakati of Thembelihle claimed that the car they were travelling in broke down near

For failing to produce a driver's licence, he was sentenced to serve five months in prison, with the option to pay a fine of E500. Both sentences were suspended for a period of one year each, on condition that he was not to commit similar offences.

He was arrested on Saturday night near Eswatini Wire in Industries Matsapha while driving a Toyota sedan, and his alcohol specimen reading was 0.75mg/l, exceeding the legal limit of 0.38mg/l.

Motsa told the court that he was from dropping off his son who was hired as a deejay at an event in Matsapha when he decided to watch soccer on television. The man said he remembered that there were two cans of Castle Milk Stout in his fridge that were left by his friend.

Motsa said he drank the two beers after a meal. After some time, he had to go fetch his son from Matsapha and along the way stumbled on the police who arrested him.

Motsa added that he was shocked

after taking only the two cans of beers.

"I usually drink Heineken beer and after taking the same volume as the Stout, I would still feel fit to drive, and I'd know this by not feeling tipsy," he said. Surprised, Magistrate Lukhele asked what apparatus was used by Motsa to determine that his alcohol content in the blood system was below the legal limit.

He said he had never been arrested for such an offence before because he would have drunk the Heineken beer which was not problematic.



Woman attempts suicide after assault by hubby

AN assault by her husband nearly ended the life of a woman who doused herself with petrol.

"I took several pills to end the misery I suffered throughout my marriage." These words were uttered by a battered and abused woman who shook the entire courtroom to its core as she relayed her harrowing tale of abuse endured in her marriage.

Nompumelelo Shongwe told the court that after marrying 50-year-old Charles Nkambule, she suffered untold emotional and physical abuse at his (Nkambule's) and family members'

"On the day the incident occurred, Nkambule and I had an argument about several issues we had encountered during the course of our marriage. Every time we spent time together, he would receive countless phone calls from different women and would always brush me aside when I confronted him about them. I then questioned him on why he chose to spend weekends away from me, instead of resolving our issues amicably," Shongwe said.

She stated that after several back and forth jabs at each other, Nkambule assaulted her with open hands and fists, then dragged and banged her head against the edge of a door.

She told the court that she was fortunate enough to escape from him as she headed outside to the edge of the fence on a rainy night.

She went to his car, took a container filled with petrol and proceeded into the house, locked the door and doused herself with petrol.

The matter was postponed to Friday for continuation of trial.

Widow's stokvel grocery stolen

WHAT was supposed to be a Merry Christmas for a widow, turned into a fairytale as her stokvel grocery was stolen.

Ntombiyembuso Maseko from Ka-LaDzimba at Buhleni is still reeling in shock after all her yearly savings in a stokvel went to waste. The widow, who lives with her three children, said she was from the last stokvel meeting where they shared their annual grocery when the incident happened.

Maseko said as usual they hired a car to ferry them to their various homesteads after sharing their groceries. When she got home at around 7pm she packed her groceries in another room and locked it.

She mentioned that when they went to sleep they even cross-checked if the room was properly locked. To her dismay, in the morning they found that the room with the groceries had its door slightly opened.

"I heard one of my children saying the room wasn't locked as the door was opened. I didn't believe her and went straight to see for myself and indeed unlocked," she narrated.

She stated that when they came closer they found out that the door was damaged, she hurriedly went inside with the intention to look for her groceries and indeed found that they were stolen. Maseko said the break-in could have happened at the middle of the night as she didn't hear anything. The groceries included three 10kg rice, two trays of eggs, 10kg brown sugar, two 5 litres of cooking oil and two 10kg baking flour.

"I am still confused about the breakin and have already involved the community police to try and help me in this issue although I doubt it will be of any help," she said.

When quizzed if she contacted the Royal Eswatini Police Service, she said she was confused such that she even forgot to do so but only reported to the community police with the assistance of her neighbours.

'SHONGWE HAD EXHAUSTED ALL LEGAL AVENUES'

WHILE in the country Shongwe is currently exploring all legal avenues to gain his liberation, back in South Africa it is a different story altogether.

It has been revealed that Shongwe had exhausted all legal avenues in respect of appealing his conviction and sentences as his case had been turned down even in the Constitutional Court. Principal Magistrate David Khumalo in his ruling indicated that all these considerations and circumstances at interplay could cumulatively be used to reasonably infer that Shongwe knew about his release and had given mandate to the one who drew and uttered the documents that facilitated his release. Khumalo said on the question of whether or not there is still an out-

standing sentence for Shongwe to serve in Barberton Correctional Services, it should be noted that it is not only a question of fact but also of law.

Khumalo stated that Section 139 (3) (a) of the Correctional Services Act 111 of 1998 as amended states that a prisoner serving a life imprisonment sentence can only be considered for parole after serving 20 years. Khumalo said it has not been disputed that in this case Shongwe had not been considered for parole at the time of his release.

Khumalo said this was because he had not served the necessary period for him to be considered for parole. This is because, according to Khumalo, the suspect started serving his sentence for the two life imprisonment in 2001 and when he was eventually released in 2008, he still fell far too short of reaching the 20 years for him to be considered for parole.

Witness' credibility cannot be used to determine matter

PRINCIPAL Magistrate David Khumalo has indicated that he is in agreement with the assertion that some of the Directorate of Public Prosecutions witnesses contradicted themselves, hence they cannot be regarded as credible.

Khumalo said he agrees with the crown that credibility cannot be used at this stage to determine the matter unless it can be shown that the

witnesses were so incredible so as to render the applicant (DPP's) case irretrievably shattered, which is not the position *in casu*.

Khumalo said he is satisfied that the crown has succeeded to make a prima facie case to warrant the respondent to come to his defence. The principal magistrate said this, therefore, means the application for absolution from the instance is dismissed.

his office have mentioned several times that his office pays out disability grants every after three months but that this is far from true as they have never received any disability grant.

"We have never received any disability grant, people should know that there is no disability grant but a social grant which has different beneficiaries like the elderly and some disabled persons," said Mhlanga. Mhlanga added that persons with disability who received grants were lucky because this is picky and does not cater for all the needs of the

disabled people in the country. He further added that the DPM only pushing the SODV Act agenda instead. Mhlanga said the DPM and his office need to be taught more about people with disabilities and how their needs can be catered

Assistance

Concurring with Mhlanga was Lomhlangano Mkhabela of Manzini North Inkhundla who said she has not received any form of assistance following her disability some years ago. DPM Themba Masuku, responding,

said his offices were always open to anyone who has questions on how they work and remains ready to explain or offer assistance where they can.

Touch

"I am not sure what motivates Mhlanga's comments, but I can invite him or his organisation (FODSWA) whom we work closely with to get in touch so that I can understand the nature of his con-

The disability grant and the

Disability Act are real issues. Last month, the prime minister announced that the grant would be increased as of January just like the elderly grants," he said.

The DPM said it was true that he had prioritised amongst many of his activities the SODV Act because this was one law that affects all people, including the disabled, as they suffer in silence.

Masuku said he was open to engage and listen to anyone with whom his office deals with.

Unemployed man beats lover for coming late from work

AN unemployed man was arrested and charged with assaulting his girlfriend for coming home late from work.

Mandla Phumlani Mbhamali (29) of Esibayeni in Matsapha appeared before Magistrate Lucia Lukhele at the Matsapha Circuit Court on a charge of contravening the Sexual Offences and Domestic Violence (SODV) Act.

Mbhamali's charge sheet stated that last Wednesday, he assaulted his girlfriend Nomvula Dlamini with fists on her face, and further used a stick to beat her on the forehead. When asked why

he committed the offence, Mbhamali told the court that he was irked by the fact that his lover had lied to him in that when he called her through her mobile phone, she said she was already in her

Mbhamali said Nomvula is employed by one of the textile factories in Matsapha and her knock-off time is 5pm. After Nomvula told him that she was already in her house, Mbhamali said he went there only for him to find that his lover was not there.

By then, Mbhamali said it was around

Magistrate Lukhele asked if the accused person was aware of the SODV Act, and he responded to the affirmative. When she asked what exactly he knew about it, the 29-year-old said, "ngati kutsi kuyaboshwana blind."

The magistrate then asked if Mbhamali assaulted his lover for the first time and he first denied it before eventually admittting. Magistrate Lukhele told Mbhamali that the SODV Act was meant to prevent domestic violence.

She said if Mbhamali was upset about being lied to, he should have talked to his girlfriend about it. If the two failed to reach common ground, the magistrate said the provoked party should then excuse him or herself from the relationship rather than resorting to vio-

Mbhamali was sentenced to two years imprisonment with an option of E2 000





2006 - Arnold Schwarzenegger in a skiing accident

2006: Amold Schwarzenegger has broken his leg while skiing with his family in Sun Valley, Idaho. The California Governor was taken to a local hospital for X-rays, which revealed he had fractured his femur. An Austrian, Mr Schwarzenegger is an experienced skier and frequent visitor to Sun Valley, where a piste has been named Arnold's Run after him. Three days later, in Santa Monica, he underwent surgery to repair the break.

2007 - Turkish planes bomb Iraq again Turkish warplanes have again bombed Kurdish rebels along the border of northern Iraq. Jabbar Yawer, a spokesman for the Iraqi Kurdish security forces has said that the raid lasted more than three hours, but that 'there was no damage or loss of life.' Turkey has now carried out three air strikes on northern Iraq in the past week, as well as a small ground incursion. The PKK, which is designated a terrorist organisation by Turkey, the US, and the EU is thought to have about three thousand rebels based in Iraq. The Turkish government says that many of the rebels are holed up in the Qandil mountains.

2009 - Hoax Balloon Boy's parents given jail sentences

The man who triggered a major alert by falsely claiming that his son was adrift in a helium balloon has been sentenced to 90 days in jail, and his wife to 20. Richard Heene, and his wife Mayumi, said in October that their son had been carried off by the balloon. The boy was eventually found hiding at home.

Heene apologised to rescue workers and the community in the Colorado courtroom. The judge ordered four years of supervised probation for the couple and banned them from receiving any form of financial benefit from the case.

2011 - Chinese writer jailed for "subversive" writing

2011: Chen Wei, a Chinese writer, was sentenced to nine years in jail after being convicted of "inciting subversion of state power". Chen Wei wrote many online essays in which he called for freedom of speech and a reform to the one-party system in China.

2012 - Pirate hostages freed

Somalian troops were able to free 22 hostages that had been taken by pirates almost three years prior. Sources stated that troops were fighting with the pirates for two weeks before being able to rescue the hostages.

2013 - Russia sends trucks to Syria 2013: Russia has sent 75 trucks to Syria with the intention of helping clear chemical weapons in the war-torn country. They were flown into Syria and will be used to transport the chemical weapons.

(Act No. 16 of 2019) AN ACT ENTITLED

AN ACT to provide for the sustainable regulation and utilisation of fish resources and the development of aquaculture by giving effect to the Southern Africa Development Community (SADC), 2006; to repeal and replace the Protection of Fresh Water Fish Act No. 75 of 1937; and to provide for incidental matters.

Enacted by the King and the Parliament of the Kingdom of Eswatini

Short title and commencement.

1. (1) This Act may be cited as the Fisheries and Aquaculture Act, 2019.

(2) This Act shall come into force on a date to be determined by the Minister by Notice published in the Gazette.

INTERPRETATION

2. In this Act, unless the context otherwise requires -

"aquaculture" means the cultivation of aquatic organisms in controlled or selected fresh water environments where the end product is raised in fresh water and where the earlier stages of the life cycle of these species may be spent in brackish waters or marine waters and where the cultivated stock may be privately owned and disposed of for commercial gain or for subsistence purposes;

"aquatic resources" means all living organisms located on shores of or in a body of water, including but not limited to –

(a) all organic or inorganic substances; (b) living organisms and their habitats including fish; and

(c) habitats and their interacting natural ecosystems;

"Board" means the Fisheries and Aquaculture Board established under Section 8;

"citizen or permanent resident of Eswatini" means either –

(a) a citizen of Eswatini;

(b) a permanent resident of Eswatini; (c) a legal entity where the majority of the issued share capital or interest, as the case may

be, is beneficially controlled by a citizen of Eswatini; or

(d) a trust where the majority of trustees and beneficiaries are Eswatini citizens;

"commercial aquaculture" means the production of fish for commercial sale whether domestically or for export:

"fish" means any aquatic plant or animal and includes the eggs, larvae and all juvenile stages;

"fish processing" means the process associated with fish and fish products between the time fish is caught or harvested up to the time the final product is delivered to the consumer; "fish processing establishment" means any commercial vehicle, vessel, premises or place where any substance or article is produced from fish by any method, including the work of cutting up, dismembering, separating parts of, cleaning, sorting, lining and preserving of fish, or where fish are canned, packed, dried, gutted, salted, iced, chilled, frozen or otherwise processed for sale in or outside the territory of Eswatini;

"fishing" means -

(a) searching for, catching, taking or harvesting fish or an attempt to undertake any such activity;

(b) engaging in any other activity which can reasonably be

expected to result in the locating, catching, taking or

harvesting of fish; (c) placing, searching for or recovering any fish aggregating device

or associated gear;

(d) any operation in support or in preparation of any activity described in this definition;

"fisheries observer" means an independent specialist who serves on board commercial fishing vessels, or in fish processing plants and other platforms and is employed by the fisheries observer program either by a government department or by a third party contractor;

"fishing activities" means -

(a) storing, buying, selling, processing or transporting fish or any fish product taken from Eswatini waters;

(b) on-shore storing, buying, selling or processing of fish or any fish product;

(c) refueling or supplying fishing vessels, selling or supplying fishing equipment or

performing any other act in support of fishing; or

(d) exporting and importing fish or any fish product;

"fishing vessel" means any craft ship which is used for, equipped to be used for or of a type that is normally used for fishing or related activities, and includes all gear, equipment, stores, cargo and fuel on board the vessel;

"Minister" means the Minister responsible for fisheries and aquaculture;

"national water bodies" means any body of water, river or stream located either entirely or partly on privately owned land and includes those water bodies managed as dams by any Government department;

"Principal Secretary" means the Principal Secretary of the

Ministry responsible for fisheries and aquaculture;

"recreation or sport fishing" means fishing for pleasure or competition;

"small-scale commercial aquaculture" means the farming

of fish in ponds that produce more than 400 kilograms but not exceeding 10 000 kilograms of fish annually and is sold, bartered or exchanged for commercial gain or for goods and services; "small-scale commercial fishing" means fishing where the majority of the catch is sold for commercial gain or in exchange for goods and services and a minority of the catch is used for subsistence purposes; "subsistence aquaculture" means the farming of fish in domestic ponds for purposes of ownconsumption:

"total allowable catch" means the total allowable catch determined by the Board in accordance with this Act; and

"total applied effort" means the total applied effort determined by the Minister in accordance with this Act.

Objectives and principles of the Act.

3. The Minister, a Government

department or official shall, in exercising any power under this Act, have regard to the following objectives and principles – (a) the environmental principles

set out in the Environment Management Act (Act No. 5 of 2002), in so far as they are applicable; (b) the need to achieve optimum utilisation and ecologically sustainable development of fish stocks and aquaculture;

(c) the need to conserve fish stocks for both present and future generations; (d) the need to apply precautionary approaches and the utilisation of the best available scientific research in respect of the management and development of fisheries and aquaculture;

(e) the need to utilise fisheries and aquaculture to achieve economic growth, human resource development, employment creation and a sound ecological balance consistent with the development objectives of the Kingdom;

(f) the need to preserve environmental and fisheries biodiversity;

(g) the need to minimize, mitigate and prevent pollution (according to polluter pays principle) of water bodies; and

(h) any relevant obligation of the country in terms of any international agreement or applicable international law.

APPLICATION OF THE ACT

4. Unless the context indicates otherwise, this Act shall apply –
(a) to a person, a fishing activity, a fishing vessel, and an aircraft, including a foreign aircraft, on or in the airspace above the territory of Eswatini:

(b) to a fishing activity or aquaculture carried out in water bodies within the territory of Eswatini or in foreign or international waters by a vessel bearing an Eswatini flag or a person in possession of Eswatini license or permit; and

(c) to a fishing activity, vessel or aircraft bearing Eswatini national flag or such colors, emblem or depiction of national importance.

Achieving targets on energy

IN 2015, world leaders adopted the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs).

The 17 SDGs call for action by all countries, poor, rich and middle income to promote prosperity while protecting the planet. With only 10 years remaining to achieve these goals, countries are accelerating steps towards ending all forms of poverty, fighting inequalities, tackling climate change and ensuring that no one is left behind. Every month, the United Nations places one of the 17 SDGs under the spotlight, highlighting its purpose, target, indicators and outlining its criticality in advancing Agenda 2030 for sustainable development. The focus is placed this month on ensuring access to affordable, reliable, sustainable and modern energy for all - SDG 7.

Energy is central to nearly every major challenge and opportunity the world faces today. From job creation to economic development, from security concerns to the full empowerment of women, from poverty eradication to food security, health, education, sustainable cities, transport, and adaptation to climate change, energy lies at the heart of the Sustainable Development Goals (SDGs) agreed to by the world's leaders in September 2015 as part of the 2030 Agenda.

In the words of former UN Secretary-General Ban Ki-moon: "Energy is the golden thread that connects economic growth, increased social equity, and an environment that allows the world to thrive.'

Renewable

Focusing on universal access to energy, increased energy efficiency and the increased use of renewable energy is crucial to creating more sustainable and inclusive communities and resilience to environmental issues such as climate change. Globally, 840 million people – one out of seven - do not have access to electricity to light their homes, refrigerate their food, or keep cool in rising temperatures. Around three billion people have to rely on dirty biomass fuels such as charcoal, coal and animal waste for cooking and are exposed to dangerous levels of air pollution. In Sub-Saharan Africa and Asia, 20 countries have the largest gaps in electricity and clean cooking access. These regions are also represented in the 80 per cent of countries worldwide that do not have access to elec-

Without access to clean, modern energy, it is impossible to achieve SDGs to reduce poverty, broaden education and improve public health. Without a stable electricity supply, countries will not be able to power their economies. A well-established energy system supports all sectors ...will help meet other Sustainable Development Goals (SDGs)



from businesses, medicine and education to agriculture, infrastructure, communications and high-technol-

Without electricity, women and girls have to spend hours fetching water; clinics cannot store vaccines for children; many schoolchildren cannot do homework at night; and people cannot run competitive businesses. The health and the well-being of some three billion people are adversely impacted by the lack of clean cooking fuels such as wood, charcoal, dung and coal, which cause indoor air pollution. As an example, replacing outdated stoves and open fires would save the lives of 800 000 children who die each year from exposure to indoor air pollution. That is why SDG7 calls for action to close these energy gaps by 2030.

More specifically, SDG 7 calls for the "affordable, reliable, sustainable and modern energy for all by 2030. Its three core targets are the foundation for our work, which is, ensuring universal access to affordable, reliable and modern energy services; increase substantially the share of renewable energy in global energy mix and double the global rate of improvement in energy efficiency.

Fortunately, progress has been made in the past decade on the use of renewable electricity from water, solar and wind power, and the ratio of energy used per unit of GDP is also declining. However, the challenge is far from being solved. More access to clean fuel and technology is required, and more progress shall be made towards integrating renewable energy into end-use applications in buildings, transport and industry.

While a greater focus shall be placed on regulatory frameworks and innovative business models to transform the world's energy systems, public and private investments in energy shall be increased. Sustainable Energy for All (SEforALL) research shows that investment for better electricity access falls far short of the spending needed to deliver universal access by 2030. For example, an estimated \$45 billion of annual investment is needed to achieve universal electricity access. Finance to fund clean cooking solutions in the 20 countries that need them most requires an investment of \$4.4 billion annually - it currently averages just US\$32 million a year. The outlook for renewables is also below par - despite revolutionary advances in renewable energy technologies, finance for off-grid

energy solutions amounts to only 1.3 per cent of all funds flowing to electrification. SDG 7 sets out to change these numbers and advocate for more investment in sustainable, renewable

Countries can accelerate the transition to an affordable, reliable and sustainable energy system by investing in renewable energy resources, prioritising energy efficient practices, and adopting clean energy technologies and infrastructure.

Businesses can maintain and protect ecosystems in order to be able to use and develop hydropower sources of electricity and bioenergy, and commit to sourcing 100 per cent of operational electricity needs from renewable sources.

Plugging

As individuals, we can save electricity by plugging appliances into a power strip and turning them off completely when not in use, including our computers. You can also bike, walk or take public transport to reduce carbon emissions.

In its Energy Masterplan 2034, the Kingdom of Eswatini has identified renewable energy as the driving force of the country's energy transformation and sustainable energy as a priority area for support to the development results for the Kingdom. The key challenge facing the country's energy system is a lack of security of supply. Eswatini imports around 70 per cent of its power despite being well endowed with conventional and renewable energy resources, including coal, solar, hydro, wind and biomass residues from the sugar and forestry industries. These resources could meet the entire national electricity demand if fully exploited, and the excess energy provide export opportunities to Eswatini's neigh-

The overall goal for the Eswatini energy system is therefore to reduce dependency on electricity imports. The country intends to increase renewable power generation technologies to 40 per cent of all electricity generation by 2020.

Following the United Nations Conference on Sustainable Development - or Rio+20 - which took place in Rio de Janeiro, Brazil on 20-22 June 2012, Eswatini initiated the Sustainable Energy for All (SE4ALL). Eswatini's SE4ALL Rapid Assessment and Gap Analysis, together with an Action Plan for 2014 to 2030, were successfully completed in 2014 with support from

Eswatini has set the ambitious targets to increase electricity access for households from 80 per cent currently to 85 per cent in 2022 through the rural electrification programme. The programme seeks to develop a distinctive approach and accelerate the deployment of rural electrification utilising renewable mini-grids.

FARMERS DEMAND OVER 190 HOURS FROM GOVT

...hours amounting to about 80 hours date back to RDA period

WHILE others have cried foul over the disruption of the Tractor Hire Services, other farmers have revealed they are owed over 190 hours.

Information gathered is that farmers from Mahamba are allegedly owed about 194 hours which is equivalent to 80 hectares from the previous ploughing season.

This was revealed by Eswatini National Agriculture Union (ENAU) President Boy Matse during an interview.

He stated that the farmers paid for the government tractor hire programmee service at the Mahamba/Zombodze Rural Development Area (RDA). He said the farmers were worried about the disruption of the service.

"This is not something new but we hope that



these farmers will be compensated in due course,"

He added that this could negatively affect yields because they do not know when the problem would be fixed.

Matse said it was unfortunate that the service

was disrupted at a time when farmers were in

In a press statement released earlier this week the NMC announced the disruption of the services under the government tractor hire programme, however assured farmers that they were working tirelessly to address the challenge in conjunction with the ministry of agriculture. When asked about the pending hours, Principal Secretary at the Ministry of Agriculture Bongani Masuku said farmers with pending hours should take slips to the RDA offices despite the year of payment.

"Farmers with such concerns should produce slips, the service is still open and we will address the issue.

"We are working with NMC to ensure the programme is addressed. The situation will normalise since some farmers have already paid for this season," added Masuku.

MTN Eswatini has activated high definition (HD) voice on its 3G network which emulates real life communication because of its clarity.

This was revealed by MTN Eswatini Corporate Affairs Manager Mandla Luphondvo.

The upgrade was rolled out last Friday.

Luphondvo said the HD improves voice clarity as it uses a wider band of frequency as an upgrade from narrow band. The range of the human voice typically extends from 80 Hz to 14 kHz but traditional, voice band or narrowband telephone calls limit audio frequencies to the range of 300 to 3.4 kHz.

"HD voice transmits the voice over a wider range of frequencies, which makes it feel like real life communication like you are speaking faceto-face with the person on the other

end of the call," he said.

Luphondvo advised MTN customers not to panic when they pick this difference in the quality and clarity of voice calls.

"This is said against the background that some of our customers have already noticed the distinct clarity. While some appreciate the upgrade, some have misinterpreted it as being bugged," he said.





'RELEASE PIC COMMISSION REPORT AS CHRISTMAS PRESENT

JOHANNESBURG - The Public Servants Association wants President Cyril Ramaphosa to immediately release the findings of a judicial commission of inquiry's report into state asset manager the Public Investment Corporation "as a Christmas present".

In a statement on Thursday, the union said the immediate release of the report would help avoid leaks. Presidency spokesperson Khusela Diko told Fin24 on Friday that Ramaphosa would announce a way forward once he is done studying the report. "The president is still studying the report and will make his intentions known on how he will further process it when he is done," she texted via WhatsApp.

Ramaphosa appointed the commission last year to investigate allegations of irregularities at the the asset manager with regard to investments which did not yield results or broke laws. The inquiry was also tasked with assessing the quality of PIC's corporate governance and whether employees were victimised by superiors.

The PIC manages over R2.2trn in state workers' funds, and invests on behalf of the Government Employees Pension Fund and the Unemployment Insurance Fund, among others. The commission, which was chaired by Justice Lex Mpati, met its December 15 deadline to submit its final report to the president, after the deadline was extended three times. The PSA has criticised the delays, and has now asked for the prompt release of the final report. "The PSA is of the view that the release of the report would give majority of public servants, pensioners and beneficiaries a sense of relief and understanding on the state of the PIC where their hard-earned livelihoods are invested," the statement read. It said an immediate release would "curb ongoing speculations of the outcomes as well as leaks that are quite unfortunate and undermine the commission's process and integrity". Fin24

JOHANNESBURG - It's easy to consider packing for Perth when our national airline is in business rescue and persistent load shedding is said to have cost the South African economy R8.5bn, while political in-fighting lays the blame on anyone and everyone for the mess in which we find ourselves.

I've had so many people - both personal and professional connections compare us to Zimbabwe or Venezuela. And while we may not be Singapore or the US or any of the Scandinavian countries, South Africa is not a bas-

It's worth remembering that South Africa is a developing economy with many first-world characteristics. In fact, we climbed seven spots in the World Bank's Global Competitive Report for 2019, making us the second-most competitive economy in the IMF has sub-Saharan Africa pegged sub-Saharan Africa, after Mauritius. at three per cent annual real GDP

We are a real gateway to the rest of Africa. We have advanced banking and telecommunications sectors and unsurpassed manufacturing capabilities compared with other major economies on the continent, including Nigeria and Egypt.

But that does not mean such assets cannot be run down and eroded over

Former President Jacob Zuma's administration shows just how easy it is to slide down the slippery slope to becoming Zimbabwe or Venezuela. So possibly the solution for our economic doldrums is to look closer to

Enhanced intercontinental trade is not only going to benefit our banks, retailers and manufacturers, but smaller business and entrepreneurs too if they do their research to understand where the gaps in different markets are, and either fill those gaps or get into the supply chain that does.

In the medium-term, it is likely that South Africa's GDP growth will continue to be laboured.

Government needs to implement major structural reforms to stimulate greater foreign direct investment, economic competitiveness and productivity than a weak rand alone can provide. And, of course, most crucial for more than just economic growth, here and in Africa as our neighbours use our power too, is a clear, workable and immediate solution to the Eskom crisis.

I've worked successfully on the continent for many years. It's true, Africa is not for sissies but it's a place of possibility and easier trade agreements will ease the risks for those businesses - large and small - looking for new growth opportunities. If even a fraction of South African businesses succeed in their Africa strategy, we will see local economic growth, improved employment and hopefully less of us packing for Perth.

MOZA OPPOSITION CALLS ON LEADER TO QUIT

MAPUTO - Mozambique's largest opposition party this past week called on President Filipe Nyusi to resign after allegations in a US court that he benefited from proceeds of a \$2-billion debt scandal.

The loans were acquired at a time when Nyusi was defence minister and preparing to run in presidential elections in 2014, but were not disclosed until 2016.

"We demand Filipe Jacinto Nyusi resign immediately as president of the Republic of Mozambique," Jose Manteigas, spokesperson for the RENAMO opposition, told a news conference in Maputo.

He also urged the attorney generals office to "investigate the truth and consequent civil and criminal liability of all involved in financial fraud".

Between 2013 and 2014, state-owned security companies borrowed about \$2 billion (1.75 billion euros) from

Credit Suisse and Russia's VTB Bank to buy military and fishing vessels from an Abu Dhabi based ship-building company, Prinivest.

But government only disclosed the debt in 2016 – a development that plunged the poor, donor-dependent country into its worst-ever financial crisis

The United States also alleges that at least \$200 million of the loans was spent on bribes and kickbacks to politicians and top officials.

Zim faces bleak festive season

HARARE - Zimbabweans are supposed to join the world in celebrating Christmas in a few days, but the mood remains sombre in the country with nothing to show that it is time to be merry.

With only two days to Christmas, workers, who spoke to NewsDay Weekender yesterday, said there was nothing to celebrate this festive season as the future remained bleak.

Several companies are failing to pay workers and to those who can, local banks are not able to avail cash, hence meandering queues being the order of the day around the country.

A survey by NewsDay Weekender last week showed desperation among Zimbabweans who queued for cash, fuel and struggled to plan for the holidays, amid speculation that schools were planning to raise fees.

The Zimbabwe Congress of Trade Unions (ZCTU) said 2019 had been a tough year for the workers and there was no joy this festive season. "It has been a difficult year for Zimbabweans. It has been one of the difficult years for workers.

We are not sure if the majority will be able to enjoy their festive season. We are not sure if the majority of workers will be able to visit their loved ones. We are not sure the majority of workers will be able to pay school fees for their children come January," ZCTU Secretary-General Japhet Moyo said.

"The majority of people have not been able to access their money from banks and are resorting to buying money through EcoCash. It is really tough," he said.

Crisis in Zimbabwe Coalition spokesperson Marvellous Khumalo said there was nothing in the country and this was a desperate situation for Zimbabweans.

"There is nothing in the country, but unfortunately we are lacking leadership. The leadership is fronsing on wrong things despite a myriad of challenges we have. In the current crisis, instead of leaders focusing on how to give a good festive season by addressing economic challenges, we are witnessing sideshows," he said.

"As we go into this festive season, prices of basic commodities have sky-rocketed. Early next year, we will be talking of school fees when children will be expected to go back to school." News Day

West African nations to reform, rename joint French-backed currency

PARIS - The French-backed West African CFA franc currency will be reformed and renamed to the 'eco,' in what Ivory Coast President Alassane Ouattara called a "historic" move over the weekend.

France, the ex-colonial power in the region, will withdraw from being involved in the committees of the West African joint currency.

The far-reaching reform affects the countries in the West African Economic and Monetary Union (known by its French acronym UEMOA), Ouattara said at a press conference in Abidjan, with French President Emmanuel

US PLACES NIGERIA ON 'SPECIAL WATCH LIST' NEW YORK - The US government

has added Nigeria to a 'Special Watch List (SWL)' of countries that have engaged in or tolerated "severe violations of religious freedom."

This is coming at a time many Nigerians and the international community have criticised the Nigerian government for its serial violations of court orders and the shrinking civic and media space in the country.

The inclusion of Nigeria in the religion violations list was announced by the US Secretary of State, Mike Pompeo.

"On December 18, 2019, the Department of State re-designated Burma, China, Eritrea, Iran, North Korea, Pakistan, Saudi Arabia, Tajikistan, and Turkmenistan as Countries of Particular Concern under the International Religious Freedom Act of 1998 for having engaged in or tolerated "systematic, ongoing, [and] egregious violations of religious freedom." "The Department renewed the placement of Comoros, Russia, and Uzbekistan on a Special Watch List (SWL) for governments that have engaged in or tolerated 'severe violations of religious freedom,' and added Cuba, Nicaragua, Nigeria, and Sudan to this list," Pompeo said.

According to Pompeo, the US also designated al-Nusra Front, al-Qa'ida in the Arabian Peninsula, al-Qa'ida, al-Shabab, Boko Haram, the Houthis, ISIS, ISIS-Khorasan, and the Taliban as Entities of Particular Concern.

The 2018 report of the United States Commission for International Religious Freedom (USCIRF), which recommended Nigeria's designation as a Country of Particular Concern (CPC), noted that religious freedom trended negatively in

"Religious freedom conditions in Nigeria trended negatively in 2018. The Nigerian government at the national and state levels continued to tolerate violence and discrimination on the basis of religion or belief, and suppressed the freedom to manifest religion or belief."

The report added that "religious sectarian violence increased during the year, with Muslims and Christians attacked based on their religious and ethnic identity."

Another case cited is the violation of rights of Shi'a members of the Islamic Movement in Nigeria (IMN).

"The Nigerian military and government continued to violate the religious freedom and human rights of the Shi'a members of the Islamic Movement in Nigeria (IMN). IMN leader Sheikh Ibrahim Al Zak Zaky remained in detention".

"However, in 12 Muslim-majority northem Nigerian states, federalism has allowed the adoption of Islamic Shari'ah law in the criminal codes.

The Nigerian constitution also establishes the roles of customary law and Shari'ah courts for Islamic personal law, family." DPA

WASHINGTON - The International Monetary Fund's Executive Board approved a three-year \$2.9 billion financing package to support Ethiopia's economic reform programme, the IMF said. The agreement, supported by the Fund's Extended Credit Facility (ECF) and Extended Fund Facility (EFF), "aims to support the authorities" implementation of their ambitious reform agenda and catalyse concessional donor financing," the IMF said in a statement.

France kills 33 militants in Mali raid

ABIDJAN/BAMAKO - French forces killed 33 Islamist militants in Mali over the weekend using attack helicopters, ground troops and a drone, near the border with Mauritania where a group linked to al Qaeda operates, French authorities said.

The raid about 150 km (90 miles) northwest of Mopti in Mali targeted the same forest area where France wrongly claimed last year it had killed Amadou Koufa, one of the most senior Islamist militants being hunted by French forces in the Sahel. AFP

Colonialism was a grave mistake - Macron

PARIS - French President Emmanuel Macron over the weekend said "colonialism was a grave mistake," and called for "turning the page" on the past during a visit to Ivory Coast, a former French colony in West Africa.

Macron, speaking in Ivory Coast's main city Abidjan, said France was often viewed as having a "hegemonistic view and the trappings of colonialism that was a grave mistake and a fault of the Republic."

Belgian court jails Rwandan for 25 years

KIGALI - A Belgian court on Friday sentenced a former Rwandan official convicted of genocide for his part in his country's 1994 massacres to 25 years in prison. Fabien Neretse, an agricultural engineer, was arrested in France in 2011 and was found guilty of genocide and war crimes after a trial in the Brussels high court. RPresiding judge Sophie Leclercq said the 71-year-old had committed "an irreparable attack against the whole of humanity and shown himself at the trial to be without pity or remorse for his crimes.'

LONDON - The Queen's Christmas holiday got off to a muted start on Saturday but hopes rose that the Duke of Edinburgh will be well enough to join her for this week's celebrations.

During a subdued day at the Sandringham Estate in Norfolk, the Queen is thought to have postponed her normal routine of visiting the Royal stud on the first day of her festive break.

The Queen normally tours the stud on the 20 000-acre estate soon after arriving from London to see her horses and the staff who care for them. While staff appeared to be preparing for a Royal arrival on Saturday morning, the Queen seemingly did not visit.

In another apparent break from routine, there was no Saturday pheasant shoot, despite it being the height of the shooting season.

In recent years, Philip has watched shoots at Sandringham from the warmth of a Land Rover.

The start of this year's celebrations have been overshadowed by concern over the Duke's health.

Philip, 98, was flown by helicopter to hospital in London on Friday morn-

ing for 'observation and treatment' of an unspecified pre-existing condition. The dash followed a month of ill-health for the Duke, including a reported fall.

Philip 'doesn't want any fuss' in the wake of his hospital treatment for a 'pre-exisiting condition' and has told his family to 'carry on as usual' with their festive celebrations, an insider told the The Sun on Sunday.

"The Duke doesn't want any fuss", a source said. "He doesn't want the family coming to see him when he is in hospital".

White House argues that Trump not officially impeached

NEW YORK - The White House may try to argue that President Trump has not, in fact, been officially impeached because Speaker Nancy Pelosi hasn't sent the articles of impeachment to the Senate yet.

Two sources involved with Trump's impeachment defence told CBS News that the White House is considering making that argument following a Thursday opinion piece written by Harvard Law professor Noah

Harvard Law professor Noah Feldman, a legal expert who testified for the House Judiciary Committee in early December and has advocated for Trump's impeachment and removal from office. In the Bloomberg opinion piece, Feldman wrote that "Impeachment as contemplated by the Constitution does not consist merely of the vote by the House, but of the process of sending the articles to the Senate for trial."

The professor went on to note that "Both parts are necessary to make an impeachment under the Constitution: The House must actually send the

articles and send managers to the Senate to prosecute the impeachment. And the Senate must actually hold a trial."

The sentiment that Trump's legal team appears to have latched on to was Feldman's statement that: "If the House does not communicate its impeachment to the Senate, it hasn't actually impeached the president. If the articles are not transmitted, Trump could legitimately say that he wasn't truly impeached at all."

In response Feldman's piece, Fox News Chief White House correspondent John Roberts' tweeted that "If Pelosi holds onto them indefinitely, @realDonald Trump would not be 'impeached, leading Trump to reply: "Plus, never did anything wrong. Read the Transcripts. A Democrat Hoax!" Feldman's fellow Harvard

Trump bashes impeachment vote in front of screaming teenage fans

NEW YORK - Donald Trump on Saturday complained of the 'unfair' impeachment vote against him as he railed against 'crazy' Speaker Nancy Pelosi, claiming she hasn't sent the articles against him to the Senate because she has 'no case.'

The president, speaking to high school pupils and college students at a conservative gathering, started his remarks focused on Wednesday's vote in the House of Representatives.

And Republican Rep. Dan Crenshaw came up on stage and presented Trump with his voting card from that day - red to signal he was a no on impeachment. Green voting cards were a yes.

"It's a no vote on impeachment day," Trump said, waving the card in the air before putting it in his suit pocket.

The room of over 1 000 teenagers went crazy at the president's one-liners and riffs, giving him multiple standing ovations, cheering 'four more years,' and wearing 'Make America Great Again' gear. During Wednesday night's vote on the two articles of impeachment against the president, many Republican law-makers filled out paper ballots, which they then got back to keep as souvenirs.

"It's so unfair," the president said of the action. In his 73-minute speech, Trump praised the members of Congress who supported him by voting no.

POPE FRANCIS WARNS CHRISTIANITY

ROME - Pope Francis has used his Christmas message to warn followers that rigidly following the Christian faith is creating a 'minefield' of hate and misunderstanding.

The head of the Roman Catholic church spoke candidly to cardinals, bishops, priests and members of staff in the Sala Clementina in the Apostolic Palace, Vatican City, yesterday as he also sought to remind them that the church no longer enjoys the authority it once did. The papacy has been rocked by historical sex abuse claims and financial scandals this year.

And the Pope's leadership has been challenged after he called for married men to be ordained as priests, and was seen with a 'pagan' statue of a pregnant woman while in the Amazon.



During his Christmas message, which was also delivered at the Paul VI Hall, Vatican City, the pope also asked Vatican bureaucrats to consider embracing change. "Today we are no longer the only ones that produce culture, no

longer the first nor the most listened to," he said. "The faith in Europe and in much of the West is no longer an obvious presumption but is often denied, derided, marginalised and ridiculed." *Daily Mail*

The event, which was held some 270 km from Ahmedabad, has run for eight years in a row and is funded by diamond tycoon Mahesh Savani, who believes that giving away brides is a blessing from God. Earlier this year, she picked out two dresses for baself and paid a R70 deposit. As part of the layby agreement, she still owed R373.

"It was really painful for me to let the dresses §0. The lay-by was the first time I was spoiling myself this year - because I always put my children first."

Peterse did not want to believe it when a shop assistant told her that somebody had already paid. "Ma'am, are you playing around? Do you take me for a fool? Is there a camera somewhere?" she said to the shop assistant. Suzette Wessels, PEP Stores' Regional Manager for the Outeniqua district, confirmed that the benefactor paid outstanding balances of between R10 and R1 300 for 363 clients.

"I recall when I first came into contact with the Lord, I did things I would have never done. I urge you tonight to forget about what people think and lose yourself in the Lord," said Kaledi.


The show was a great success such that members of the audience could not stop talking about it after it was over.

If there's one thing I will never do is take the tall for something I know nothing about. I will fight till my last breath because that's who I am," Kelly said. Just last month during an interview on Real Goboza, Kelly said being called a "killer" was the most hurtful thing.

"I think that hurts, because I'm not a killer. I may be a hell lot of things, but I am not a killer."

Later in the month, Kelly said she was tired of defending herself because the court of public opinion she had already made a ruling against her.

Lukaku had the final say in the 71st minute when he collected the ball outside the area, moved forward, skipped past a defender and rifled a left-foot shot in off the crossbar for his 12th league goal of the season.

PARIS - Kylian Mbappe scored two sublime goals and found time to sign an autograph for a young fan as Paris St Germain crushed Amiens 4-1 on Saturday to go into the Ligue 1 Christmas break seven points clear of Olympique de Marseille with a game in hand.

Champions PSG took the lead when an Amiens attack broke down and a precise pass from Neymar found Mbappe, the 21-year-old French international sprinting forward and coolly chipping the ball past keeper Regis Gurtner in the 10th minute.

Gurtner pulled off a string of fine saves to keep his side in the game but the Amiens defence was breached immediately after the break as Mauro Icardi forced the ball in towards Neymar who rattled it home.

Mbappe's second came from another perfect pass, this time from Angel Di Maria, and he fired a superb firsttime shot to make it 3-0 to the home side in the 65th minute.

With central defenders Abdou Diallo and Thiago Silva both substituted due to injuries, Stiven Mendoza found enough space to pull a goal back before Icardi struck six minutes from

time.

Mbappe had time to hug a young fan wearing a Santa Claus hat who made it onto the pitch and produced a book from under his jacket for the World Cup-winning forward to sign as he was escorted off by security.

It took an own goal from Sofiane Alakouch to break the deadlock for Marseille against second-bottom Nimes, with Dario Benedetto and Dimitri Payet adding a goal each in a 3-1 win that kept them in touch with PSG at the top of the standings.

Wissam Ben Yedder struck twice in the second half as Monaco came back from a goal down to thrash Lille 5-1, a defeat which sent the visitors down to fourth in the table after Rennes beat visiting Girondins Bordeaux 1-0. There was more misery for bottom side Toulouse, who were hammered 3-0 by mid-table Nice, while Habib Maiga's late goal gave fellow strugglers Metz a 2-2 draw at Dijon that lifted them out of the bottom three to be replaced by Amiens.

With the third Test - and with it the series - seemingly lost, Stokes smashed an incredible 135 not out to seal a near-impossible win at Headingley.

A source told The Sun: "The World Cup win was the sporting highlight of the year — not just the summer.

"Eoin captained the team to win a World Cup Final and only a handful of people have ever been able to say that."

Qatar winning the right to host 2022 World Cup

DOHA - FIFA's ruling Executive Committee of December 2010 was a human smorgasbord of greed, corruption, self-interest and dishonesty and it is nine years now since those 22 men voted to send the 2018 World Cup to Russia and the 2022 event to Qatar.

In the weeks before they did so, I spent long days in conversation about their upcoming decision, first with a former Qatari bid insider turned whistleblower, Phaedra Almajid, and then with this newspaper's lawyers, to decide how much of what she told me we could print.

"I don't think Qatar will win," a brave but nervous Almajid told me. IknowQatar will win."

And then, in great detail, she went on to explain how Qatar had bought access to and influence over an array of senior sports officials, including not just multiple FIFA ExCo voters but others who might shape the vote, including political figures.

She told me how Qatar had bought the support of multiple famous footballers, paying millions of dollars for the endorsements of, among others, Zinedine Zidane, Gabriel Batistuta and Pep Guardiola, then manager of Barcelona.

There is no implication of any corruption on the part of Zidane, Batistuta, Guardiola or any other footballers who endorsed the bid.

Crucially

She told me that Spain bidding for 2018 would be key to Qatar's success as part of a secret Qatar-Spain pact (against FIFA bid rules) that would help to deliver Qatar some European ExCo votes but crucially three South American votes from corrupt ExCo voters Ricardo Teixeira (of Brazil), Nicolas Leoz and Julio Grondona (Argentina), all on that infamous 22-man panel.

She also explained how Qatar had paid \$1.6m (£1.2m) to sponsor an African football conference, giving Qatar exclusive access to lobby Africa's ExCo voters and promise them 'assistance' in exchange for their votes.



His career had been blighted by off-thefield issues with his fitness and discipline.



HAMILTON DESERVES AKNICHTHOOD

LONDON - David Richards, the head of Motorsport UK, has called for F1 champion Lewis Hamilton to receive a knighthood in the New Year Honours.

Lewis Hamilton should be rewarded for winning his sixth Formula One world championship by receiving a knighthood in the New Year Honours, says the head of Motorsport UK.

Hamilton cruised to a third successive title and is now just one shy of Michael Schumacher's all-time record of seven championships.

The 34-year-old was awarded an OBE in 2008, following his maiden championship triumph, but David Richards, the head of British motor racing's governing body, believes it would be an oversight if Hamilton does not receive a higher honour this time.

Labour peer Lord Peter Hain has written to UK Prime Minister Boris Johnson to declare his support for Hamilton to receive a knighthood, and Richards insists the Mercedes driver is worthy of the title.

"Naturally as the governing body of motorsport in the UK we wholeheartedly support Peter Hain," Richards told the Guardian.

"I can't think of anyone more worthy of that recognition than Lewis. It would be a major oversight if that is not recognised in the New Year Honours.

"Lewis is far more remarkable in that he did not come from a privileged background. He and his father worked incredibly hard to get into karting and up the steps of the ladder.

"It was sheer hard graft, not gifted to him on a plate. They made huge sacrifices and that makes his achievements even more extraordinary.

"He is a role model for underprivileged children in the UK to show them that anything is possible. I hope he uses that to help and leave a legacy for other children to show their ambitions are achiev-

England 1966 World Cup hero Martin Peters dies aged 76

LONDON - England World Cup hero Sir Geoff Hurst on Saturday led tributes to his former team mate Martin Peters, who died following a battle with Alzheimer's disease.

Peters, 76, was one of three West Ham players who lifted the Jules Rimet trophy in Wembley Stadium in 1966.

He scored the second goal of the match which put England 2-1 up against West Germany.

Sir Geoff, who scored a hat-trick that day wrote on Twitter: "Today is a very sad day for football and for me personally.

'Martin Peters was one of the alltime greats and a close friend and colleague of mine for in excess of 50 years.

"A fellow World cup final goalscorer and my West Ham partner for years along with Bobby Moore.

Renowned as being the complete midfielder, Peters was good in the air, able to cross with either foot and possessed great movement, being able to drift into goal-scoring positions unnoticed by his markers which would later see him nicknamed 'The Ghost'.

Peters came through the West Ham academy, having signed as an apprentice in 1959 and went on to help the east London club win the European Cup Winners' Cup in 1965.

His former club West Ham confirmed the sad news earlier this afternoon in a statement.

"Everyone at West Ham United is deeply saddened by the tragic news that legendary Hammer Martin Peters MBE has died at the age of

"The directors, management, players and staff wish to pass on our sincere condolences at this extremely sad time to Martin's wife Kath, his children Leeann and Grant, granddaughters Hannah and Meg, and all of Martin's family and friends."

"A beloved husband, dad and granddad, and a kind, gentle and private man, we are devastated by his loss but so very proud of all that he achieved and comforted by the many happy memories we shared.

"We will be making no further comment and kindly ask that the privacy of our family is respected at this extremely difficult time."

Another former West Ham striker, Tony Cottee, said on Sky Sports News: "First and foremost he was a fantastic player.

"Obviously he was one of the three West Ham players who played in the '66 World Cup winning team. We've lost Bobby Moore and now we've lost Martin Peters.

"I'm really sad, I knew him well, he worked for the club and I got to know him as a friend. As a West Ham man it's really, really sad news."

Peters famously scored for England during the World Cup final - as the Three Lions beat West Germany 4-2 at Wembley.

A West Ham legend, Peters made 302 appearances and scored 81 goals during an 11-year-spell at the club from 1959 to 1970.

He was famed for becoming Britain's first £200,000 player when he left the Hammers to join Tottenham Hotspurs.

During his career he also played for Norwich City and Sheffield United.

Part of the West Ham trio which helped England win the 1966 World Cup, Martin Peters was never one to seek the limelight.

He following a battle with Alzheimer's, was the scorer of England's second goal at Wembley before fellow Hammer Geoff Hurst took centre stage with a hat-trick.

Indeed, it was very nearly Peters, on only his eighth appearance for his country, who had the honour of netting the winner after rifling home a deflected Hurst shot to put the hosts 2-1 up in the 78th minute. West Germany equalised in the last minute and Hurst went on score twice more in extra-time.

As the players walked up the 39 steps and England and West Ham captain Bobby Moore was presented with the Jules Rimet Trophy, Peters took a moment to wipe his hands on his shorts before meeting the Queen, not wanting to risk getting any mud on her Majesty's pristine white gloves.

A silver-service banquet for Alf Ramsey's triumphant squad followed at the Royal Garden Hotel in Kensington.






