Sipho Shongwe murder trial resumes before Judge Maseko today

More witnesses expected to take to the witness stand

BY SANDILE NKAMBULE High Court

BUSINESSMAN Sipho Shongwe's murder trial resumes at the High Court today and more witnesses are expected to take the stand.

The trial resumes before Judge Nkosinathi Maseko and shall be heard in four days between today, Thursday, Friday and Monday before the second session of the High Court ends.

The matter is expected back in Court in September 10 and the trial shall run through September 13.

Shongwe stands accused of the murder of businessman and football administrator Victor Gamedze who was allegedly gunned down by two men believed to be South African nationals while at the Galp Filling station near Corner Plaza at Ezulwini in January 14, 2018.

Already, about 10 witnesses have been paraded by the Crown and these include amongst others; Steve Horton, Mike Mamba, Sihle Gugu Mamba, Sipho Tsetla Bhembe, Ananias Khumalo, Zeeman and police officer Thwala.

Also expected to give evidence are the two South African nationals the crown has applied that they give evidence through an Audio Visual Link (AVL) while in the neighbouring country.

Judge Maseko took over from Justice Mbutfo Mamba who recused himself from the matter which had already been heard in part.

WOMEN WANT MARITAL

The High Court will soon make a landmark ruling where it will decide whether sections of the Marriage Act 47 of 1964 should be abolished or not.

Yesterday, legal representatives from the Women and Law of Swaziland (WLSA) were in court where they presented their arguments on why they feel certain sections of the Act are unconstitutional as they give more power to men than women.

The matter is before the High Court full-bench which now constitutes itself into a Constitutional Court and was heard by Principal Judge Qinisile Mabuza, Judge Nkululeko Hlophe and Judge Titus Mangeni.

The argument was that the purpose of marital power is that someone must be in control and men tend to abuse that power. The complaint that was raised is that people get married through civil rites but the consequences are faced in common law. WILSA's argument is that the issue of marital power denies women their rights.

... High Court full-bench reserves judgment



Submissions made at the High Court yesterday by WILSA legal team was that the High Court declare Section(s) 24 and 25 of the Marriage Act 47 of 1964 unconstitutional in that it violates Sections 18, 20 and 28 of the Constitution of Swaziland Act 001 of 2005

The first half of Section 24 of the Act, it was argued, provides that the

consequences of marriage under the Act are to be governed by common law. The second part of it, according to papers submitted to court says if the parties are Africans, the marriage consequences shall be in accordance with Swazi Law and Customs unless they exercise an option in terms of Section 25 of the Act. This section, according to WILSA, is discriminatory.

The court was informed that the principle of marital power gives a husband married under civil rite and in community of property three broad powers: The husband's power as head of the family, by which power he has the decisive say in all matters, concerning the common life of the family. The second power

Dvokolwako high re-opening in limbo

THE re-opening of Dvokolwako High School is in limbo as the ministry of education and training and Dvokolwako Umphakatsi failed to reach an amicable agreement.

This was confirmed by the ministry's Principal Secretary Dr Sibongile Mtshali during an interview yester-

This was apparent after the ministry's officials, Hhohho Regional Education Office and Dvokolwako Chiefdom representatives met on Monday in an effort to come up with a solution that would see the school up and running again.

Dvokolwako High School was shut down by parents and pupils last week Monday as they claimed that the Principal Sabelo Sibandze was responsible for some unfortunate incidences which have affected the school negatively. These are allegations whose veracity has not been tested. They claimed that for as long as Sibandze was heading the school, there would

This was a response by Dvokolwako Chiefdom representative Joseph Mgabhi when asked what the umphakatsi would do to resolve the issue. Mgabhi said in as much as some par-

ents were under the Dvokolwako Chiefdom where the school is located, it was not their responsibility to see to it that the parents were made to under stand the situation that would result to the school being re-opened. Mgabhi said there are six chiefdoms under Madlangemphisi Constituency so the Dvokolwako Chiefdom could only manage to call its people to try and make them understand that accepting Principal Sabelo Sibandze was the only way to have their children back to class

never be peace. The parents and the Dvokolwako Chiefdom then implored the ministry to avail a temporary principal while the matter of Sibandze was being investigated.

Dr Mtshali said although the ministry was not formally informed why parents shut down the school, they are hoping to find a solution to the

the other chiefdoms, meaning they cannot be summoned by the Dvokolwako Chiefdom. "The ministry of education officials know how to handle such matters and our hope is that they provide a tem-porary principal while they conduct their own investigations on the root of the chaos that erupted in the school," said

It was for this reason that the secretary said the ministry was the one responsible for convening all the parents to notify and paint the picture of what could happen should they fail to accept Sibandze back. On another note, Mgabhi said it was worrisome to bring the principal back because the parents made it clear that should he return, there would never be peace at the school and that they vowed to do everything to get rid of

problem.

However, the PS said Dvokolwako authorities said the only thing they wanted was for the school to re-open while on the other hand they did not want Principal Sibandze to return to the school.

"This is mind blogging because in order for the situation to normalize

Sibandze needs to return to the school," she said.

The chiefdom representatives are said to have also implored the ministry to conduct its own investigation to get the root cause of the chaos while an interim principal oversees the operations of the school.

When asked whether the ministry would avail a temporary principal, Dr Mtshali said there was no way that the ministry could do such because technically, the principal was not officially suspended by the relevant office from the ministry.

"The parents and the umphakatsi say they don't want Sibandze to return on suspicions of witchcraft but the ministry does not have an instrument to investigate witchcraft," Mtshali said. She further stated that the ministry was not going to re-open the school because it did not instruct anyone to shut it down in the first place.

This, according to the PS, meant that if parents wanted the school to re-open parents should accept Sibandze back to school before they could formally report their grievances to the ministry.

is the husband's power over his wife, including legal representation and lastly it is the husband's power over the property of the wife, by which he administer the joint estate as if the regime is in community of property.

Section 25 it was argued provides relevantly an application for an option where the parties to the said marriage are Africans.

"The parties are to decide before the solemnisation of the marriage will be in accordance with common law, thereby excluding the application of customary law.

According to the applicants, Section 24 and 25 of the Marriage Act of 1964 dictates that material power and property rights should be governed by Swazi Law and Custom.

The problem, however, is that Swazi Custom vests these powers in the man, not the woman. This is viewed by WILSA as something which violates the Bill of Rights which is enshrined in the Constitution.

However, in the heads of argument presented by Crown Counsel Malibongwe Mashinini, representing the Office of the Attorney General, was that there are many other couples who would happily want their marriage to be in terms of Section (s) 24 and 25 un-amended or with minor amendments if any.

The AG argued that in any case prayers 1 and 2 are bad in law, in that with Section (s) 24 and 25 invalidated as prayed, there will be a vacuum for there will be nothing to inform as to what are the consequences of the marriage under the Act will be.

It was argued that with the removal of marital power, government's lawyers stated that one has to be considerate of the multitudes of women, married in community of property who are at peace with the current setting of marital power.

According to WILSA, government has signed many treaties advocating for gender equality and women's rights but is failing to implement such.

The argument was that countries such as Botswana, Lesotho and South Africa have made amendments to Marriage Acts infringing on women's rights.

Government's legal team is objecting to the application made by WILSA, saying the application for invalidating Section (s) 24 and 25 as a whole is not necessary because there are other options that applicants could have opted, in order to attain the remedy being sought, such as seeking an order of court in varying the control of the communal assets.

However, the judges pointed out that it is not everyone who has easy access to court.

The Attorney General's Office argued that marital power is a variable consequence of a marriage and is not automatic.

"The parties can choose to exclude marital power by opting to enter into an antenuptual contract of marriage," part of the argument from the Attorney General's office read.

After making the submissions, the respondent which is the government team, indicated that they will now await the court's decision in the matter.

The judges indicated that they will make judgment on the matter very soon and they pointed out that the parties will be informed once judgment is ready.

Representing WLSA in the matter is lawyer Mzwandile Dlamini from MS Dlamini Legal.

Women suffering a lot from marital powers given to men

An affidavit of Makhosazane Sacolo and WLSA Director Colani Hlatjwako was used to support the application that women really suffer a lot because of the marital powers given to men.

Sacolo stated how she was married to her husband on August 19, 2000. She said the marriage was in terms of Civil Rite, in community of property and was registered on the same date.

In the marriage Sacolo had four children. She indicated that she had tried to force her husband via a court order to maintain his four children and was eventually granted a court order forcing her husband to pay E900 per month in 2012. She said prior to that they obtained land at Swazi Nation Land and built a homestead there. Sacolo said in 2004 she bought four cattle and brought them to their matrimonial home. Sacolo said her husband refused to contribute anything towards the purchase price. She said the cattle were registered under husband's name due to the marital power vested to him under common law. Sacolo indicated that between 2009 and 2011 her husband changed his behaviour and became irresponsible and violent and refused to contribute towards their daily upkeep or paying school fees towards

their children.

Sacolo said one day she was informed by her husband that there was a truck which was coming to load all the cattle as her husband had sold them without her knowledge. She said she also learned that her husband has wedded another woman.

Sacolo said in 2012 she lost her job as a pre-school teacher and when she attempted to sell some cattle to pay for school fees and to provide food for her family, she was told that she is not allowed to do so. She said she was advised that she does not have the marital power and that the cattle were registered in husband's name. She said in 2013, she approached the veterinary officer and requested that the cattle be registered in her name so that she could sell them when the need arose. She said the veterinarian refused and told her that even if they were registered in her name, she would still need sion from her husband to transfer the cattle. She said family members of her husband tried to evict her from her matrimonial home.

"I am very frustrated that I am bound by the Common Law which vests the marital power in my husband," Sacolo's affidavit read.

Government to create 70 000 jobs

The ministry of commerce industry and trade intends to create 70 000 jobs through the construction 40 factory shells in four years.

The Minister of Commerce Industry and Trade Manqoba Khumalo said investigations by the ministry conducted with Eswatini Investment Promotion Authority (EIPA) unveiled the need to construct 40 factory shells around the kingdom.

This he revealed yesterday during the ministry of commerce industry and trade portfolio committee deliberations on the ministry's first quarter performance report.

During the deliberation, portfolio committee member and Mkhiweni Member of Parliament Michael Masuku asked the minister if there was a need to construct more factory shells as a number

of them were lying idle and not being utilised for their intended business purposes.

"When constructing the factory shells, is it taken into account the businesses which would be occupying the shells, as during a tour of the country's industrial hub, Matsapha it was discovered that

there were a number of shells that were not being used and were lying idle while there were a number of businesses that did not have any space to work in," asked the Masuku.

In response, Khumalo said following their research, it was discovered that there was a demand for factory shells which could result in the creation of job opportunities for 70 000 people. He said the current shells were mainly owned by the private sector and not for government.

He mentioned that private companies normally charged higher rates per square metre as they are profit-driven which resulted in possible investors being deterned as their businesses would not be viable due to the high rates.

The minister said government owned factory shells rates were more affordable, thus attracting more possible investors.

Khumalo said government was looking to construct 10 factory shells per year

Unfavourable economic conditions

The country's economic growth is expected to remain subdued according to the economic growth projection.

In the ministry's first quarter financial report, the Minister of Commerce Industry and Trade Manqoba Khumalo said the period under review ended with unfavourable economic conditions that generally affected the performance of the business environment.

He said economic growth was projected to remain subdued at 1.1 per cent. He mentioned another factor that was posing danger to the country's economy was the dwindling South Africa Customs Union (SACU) receipts.

He added the ministry was, however, committed to observe that Emaswati had access to decent work, increase export and also empowered domestic producers for gainful and significant economic development. Khumalo said in the period under review, the ministry has facilitated the creation of 141 jobs, bringing the number of jobs created to 1 520, inclusive of jobs created in the last financial year: 2018/19.

Furthermore, three companies were registered and five trading licences were facilitated in the first quarter.

He also added that 36 visas and 10 working permits were facilitated for 12 and five companies respectively.

The ministry has also announced investment decisions that will result in more than 5000 jobs being created in the next 12 to 18 months once these companies finished setting up. He added that the ministry continued to implement its after care strategy and as such visited 9 companies who mostly reported challenges relating to electricity and markets.

for the next four years, resulting in a total of 40 shells in a period of four years. He mentioned out of every 10 shells, four shells would be constructed at Tinkhundla level with the other six shells constructed in the economic areas such as urban areas.

He said this would offer possible investors in the Tinkhundla centres an opportunity to access working space and in the process creating employment at a local level.

Businessman slapped with three counts after wife's murder

The businessman who brutally murdered his wife in cold blood on Sunday has appeared in court on murder and gun-related charges.

Owner of SD Transport Maswati Simelane (45) of Bhunya appeared before Mbabane Magistrate Sifiso Vilakati yesterday, just two days after he was said to have murdered his wife Zanele Manana.

According to his charge sheet, Simelane was arrested and charged with the first count of murder, where he was said to have, on July 21, 2019 at Mahwalala Zone 6, shot Zanele Manana with a pistol once in the neck, inflicting a fatal wound of which Manana died from.

On the second count, Simelane was charged with contravening the Arms and Ammunition Act of 1964, where he was found to have, on July 22, 2019 near Mbabane, not being a holder of a valid licence or permit to possess a firearm, did wrongfully and unlawfully possess a 9mm Parabellum Luger MSO pistol without a valid licence or permit.

The third count stated that, while contravening the Arms and Ammunition Act of 1964, Simelane, not being a holder of a valid licence or permit to possess a live round of ammunition, did wrongfully and

unlawfully possess one 9mm Luger live round of ammunition without a valid licence or permit.

Before his appearance before open court, Simelane is said to have been making his confession before Senior Magistrate Nonhlanhla Dlamini in her chambers. The confession, which seemed to have taken over an hour, delayed his appearance as he only appeared before open court after a short adjournment of the court after fresh matters were heard.

During his appearance before Magistrate Vilakati, Simelane practiced his legal right to representation, as he was represented by an attorney known as Dlamini.

The prosecution represented by

Chris Sibandze informed the court that it had two applications with regards to Simelane's case.

The first application made by the prosecution was to the effect that Simelane be remanded back into custody until August 2, 2019, pending his committal to the High Court.

The second application saw the prosecution apply for the court to allow for blood samples to be taken for the purposes of the on-going investigation of the case. This saw Simelane's attorney apply for the deferment of the taking of blood samples to August 2, 2019, citing that he was to consult further on the matter.

Further opposing the defence's

application for deferment, the prosecution claimed that such a deferment was unnecessary, as the blood samples would be taken anyway for the purpose of the investigation.

"The prosecution opposes this deferment because at the end of the day, the postponement of taking blood samples is going to delay the investigation, when the blood samples will have to be taken anyway," Sibandze stated.

Magistrate Vilakati granted the prosecution both applications made before him, informing Simelane's attorney that Simelane will not suffer any prejudice by providing his blood samples.

"The court's view is that Simelane has no prejudice to suffer if he has his blood samples taken. Therefore, this court orders that Simelane has his blood samples taken for the continuation of the investigation of this case," Magistrate Vilakati ordered.

Dressed in a navy blue sweater and light blue denim jeans, Simelane appeared expressionless, yet pensive during his court appearance.





After exhausting all possible avenues to get her Brexit plan through Parliament, Theresa May stepped down as party leader on June 7, triggering a six-week leadership contest. Johnson. who has vowed to take Britain out of the European

Union on the October 31 deadline, with or without a deal, is set to march head-on into a collision with Brussels, the British Parliament and Tehran.

The former London mayor, who chams and alarms colleagues in equal numbers, beat Foreign Secretary Jeremy Hunt and will take over from Theresa May as prime minister today.



Smokers were not left out as they were told to always ensure their cigarette stubs and matches are properly extinguished before dumping, "Honey harvesters are advised never to use fire in or outside forests," reads the statement.

Commercial forests have created thousands jobs in this country which are continuously being threatened by these fires.

The unfortunate loss of jobs has a negative effect on the economy.





King worried about non-prosecution of cases

HIS Majesty King Mswati III is worried about people being arrested and having to wait for many years for their cases to be concluded.

This was said by MP Themba Ginindza during the debate of the first quarter performance report of the ministry of justice and constitutional affairs, which took place in the House of Assembly yesterday.

The debate was between MPs who are members of the portfolio committee of the justice ministry.

Ginindza said the tendency of arresting people just to stigmatise them was not good. "Even His Majesty the King raised concerns about this, stating that he was not happy to see it happening. He said it last year when we went to introduce the speaker (Petros Mavimbela) to him. I am taking this opportunity to state how serious this matter is, considering that even the King raised it," Ginindza said. Ginindza said this after several MPs raised concerns about the Anti-Corruption Commission (ACC) being used by powerful people as a tool to show how powerful they were.

MPs stated that they had seen such happening in the past and they wanted to know from Minister Pholile Shakantu if something like this would be ended.

In response, Shakantu said the ACC would work independently, without any interference of some sort. She further said no person would use the ACC to arrest people willy-nilly just to prove a point or show how powerful he or she was.

She further stated that the ACC, by law, was supposed to treat its matters in a confidential manner, so as to give respect to the people it investigated.

Warders should salute us – Magongo

IT is important for officers from His Majesty's Correctional Services (HMCS) to salute leg-

These words were uttered by Motshane MP Robert Magongo during the debate of the first quarter performance report of the ministry of justice and constitutional affairs yesterday.

Magongo wondered why officers of HMCS did not salute them as legislators. He said to his knowledge that was not supposed to be the case. He said the HMCS officers were the only ones among the security forces that did not recognise them as legislators. The Motshane MP said he was gazetted to become an MP, just as much as other legislators were gazetted to become lawmakers in their different capacities. That on its own warrants them the privilege of being saluted as legislators. Minister of Justice and Constitutional Affairs Pholile Shakantu responded by saying she hoped the HMCS officials who were also present heard Magongo's concerns. She said she hoped they would attend to his concerns. However, Magongo was not convinced with the minister's response. He asked Shakantu


to give a better response to his concern because the officials she talked about did not have a privilege to talk during such debates.

The only person who was privileged to talk was the minister herself. The minister ended up assuring Magongo that she would talk to the HMCS officials, but she was informed that commissioned officers were the only ones that were saluted. Meanwhile, Magongo wanted to know if the HMCS bakery was audited.

The same question was asked by Nhlambeni MP Manzi Zwane, who also wanted to know who audited the financial statements of the canteens and bakeries at

The minister responded by saying the bakeries and canteens were managed by different companies and not by the HMCS. Magongo further stated that he had two judgments from the Industrial Court. In one judgment, a worker was suspended for nine years and was to be paid money and re-instated to work. In the other judgment, another worker was suspended for five years and was to get nothing and no re-instatement.

In response, Minister Shakantu



ESACRO director boards public transport to Parly

ESACRO Director Desmond Maphanga had to be given money by a Member of Parliament (MP) in order to make it to Parliament.

Maphanga is a director of Eswatini Association for Crime Prevention and Rehabilitation of Offenders (ESACRO), which is a department under the ministry of justice and constitutional affairs. This means Maphanga had to be there as his ministry's performance report was supposed to be debated by the

The problem is that the ESACRO workers had not been paid for four months now. This also affected the director, who had to use public transport to go to Parliament.

The money for his transport fare was donated to him by Kwaluseni MP Sibusiso Mabhanisi Dlamini through the MTN's Mobile Money platform. MPs expressed concerns over government's tendency to neglect this department, which they described as very important. Motshane MP Robert Magongo said workers at this department were having it tough at work as they had worked for four months without earning their salaries.

He urged the minister to hastily work on the problems, with an aim of bringing solutions to the problems engulfing the ESACRO workers.

Kwaluseni MP Mabhanisi Dlamini, who was chairing the debate, stated that ESACRO was a very important department and did not have to be neglected in this way.

Dlamini said he had to fork out his own money to give to the director so that he could travel to Parliament for the debate. "Can you imagine a whole director having to board public transport to Parliament without money for transport?" Dlamini wondered.

He further said he was from a place that was one of the crime-infested areas in the country

Skills

For him, it was nice to see a person from his Inkhundla waking up every morning to go to ESACRO to learn the life skills offered by that depart-

"Seeing a person doing such a thing encourages you to help wherever you can because that tells you that the person has decided to change their lives for the better," Dlamini said. Nkhomiyahlaba MP Welcome Shongwe also voiced his concerns about ESACRO. He said the buildings of the department were becoming an eyesore and they needed the attention of government.

He asked the minister to fast-track the improvement of the buildings of this department. Phondo MP Xolani Vilakati also called for an improvement of the money allocated to ESACRO because it was clear that a lot of work needed to be done to improve the state of the department.

FARMERS CAN'T WAIT FOR COLD CHAIN SUMMIT

LOCAL farmers can't wait for the first Cold Chain Summit to kick-off!

A significant number of growers took advantage of early bird registration to secure their space and be part of agribusiness history in the first Cold Chain Summit to be held in the Kingdom of Eswatini.

The event organisers have also been pushing registration of individual farmers and schemes ahead of the summit to be held August 7-8 at Mavuso Trade and Exhibition Centre in Manzini.

One of the farmers who registered for the summit is George Fakudze from Malkerns, who has been a farmer for the past 18 years.

He grows, broccoli, cauliflower, butternuts, spinach, lettuce, and cabbages. He currently sells to shops including

Pick n Pay, OK Supermarket, Spar, and also sell directly to the public.

"I am currently looking for new market opportunities and I believe that the summit can give me a breakthrough in this regard," he said.

Fakudze also hopes the summit will help him understand required standards for selling in different markets.

He lost an opportunity to supply one of the local hotels because he didn't have cold storage facilities and temperaturecontrolled transportation for his produce.

"I hope to see affordable off-grid cold chain technologies that can be cost effective for smallholder farmers at the summit," he said.

Fakudze also expects to engage with financiers and insurance companies.

"My objective is to increase production this year and these two stakeholders are essential to ensure the sustainability of my growth plan," he said.

Asked why farming is important to him, Fakudze says it means his life.

"It is the only skill I have and I do not know any job so well like farming," he said.

Wendy Zwane from Sigombeni is also amongst the farmers who had already secured access to the summit.

She produces broccoli, cauliflower, green beans, cabbages, chillies, green pepper, and butternuts. Farming had been her sole livelihood since 2012.

Long term

She sells to NAMBoard and would love to export directly in the long term.

However, one of her struggles is keeping her produce fresh.

"I look forward to learn from the experts who have been lined for the Cold Chain Summit, especially on existing mechanisms that we can use to keep our produce fresh for export markets," she said.

A young farmer, Njabulo Dlamini (30) from Gebeni was also visibly excited following his successful registration to take part in the highly anticipated summit.

As a young person, Dlamini has set his heart on the Young Professionals Breakfast session to be held on the second day of the summit (August 8).

"This is the first opportunity for me to attend such a gathering and I can't wait to interact, learn, and get motivation from other people's experiences," he said.

He currently sells to NAMBoard but is also looking for opportunities to expand production and tap into new markets for diversification.

However, like most farmers, his expansion dream is stifled by the lack of cost-effective resources to keep his produce fresh. This cost him an opportunity to directly supply supermarkets.

Dlamini grows cabbages, green beans, beetroot, cauliflower, broccoli, spinach, tomatoes, and butternuts.

"If I had an affordable temperature regulated vehicle, I would have been still supplying supermarkets as well," he said. Farming had also been his only source of income since 2011.

"It is the only job I know and have mastered. It can be difficult for me to adapt to a different kind of job," he said.

Steven De Sousa said to keep his produce fresh for the market, he is forced to harvest and deliver the same day.

He grows cucumber by means of tunnel farming and they have 15 (10×30m) tunnels at Eagles Nest in Malkerns.

"I am going to the summit with an open mind to learn from experts," he said.

The summit is championed by the National Agricultural Marketing Board (NAMBoard) on behalf of the Government of the Kingdom of Eswatini.

Youth looking to take advantage of summit

AS the country continues to grapple with high youth unemployment, the Cold Chain Summit may perhaps create a window of opportunity for youth that once seized, could greatly contribute towards sustainable job creation.

This is the sentiment of Professor Paul Kamau Wahome. He is a lecturer at the University of Eswatini (UNESWA) Luyengo Campus, under the Faculty of Agriculture, Department of Horticulture.

He is also a consultant for postharvest losses in cabbages and tomatoes for the Food and Agriculture Organisation (FAO) Eswatini, and one of the speakers for the upcoming summit.

Wahome commented after a presentation of existing opportunities for youth in the upcoming Cold Chain Summit which is championed by the National Agricultural Marketing Board (NAMBoard).

During his presentation to final year horticulture students at the university, NAMBoard Agribusiness Manager Tammy Dlamini said part of the benefits of attending the summit for young people is exposure to over 500 local, regional, and international leading experts in various fields.

The summit also has dedicated sessions for young people and women. Dlamini said the event will provide a good platform for young people to learn about existing opportunities within the cold chain sector.

"It will also provide a good platform for the youth to learn, share experiences, network with captains of industry, and to forge vital business relationships with suppliers, producers, retailers, and processors," he said.

That being so, Professor Wahome, who came into the country almost two decades ago said he has no doubt that the summit will stimulate production and interest for young people to join agribusiness, which had been the missing link in efforts to bridge the age gap in farming.

"Most young people have established different enterprises because they have been encouraged to do so, and we have not adequately done this in horticulture. Therefore, this summit could not have come at a better time," he said.

He further encouraged young people who are looking for opportunities in agribusiness to attend the summit, adding that horticultural business is the easiest way to go.

"If you look at the current unemployment rate, it is really quite sad. But all what young people need for a business in horticulture, is just a small piece of land to produce a few lettuce plants, tomatoes, cabbages, and then they can be able to sustain themselves," he said.

Seven students from the UNESWA Luyengo Campus already have guaranteed access to the summit after winning free tickets to the event.

NAMBoard will continue to engage youth groups in a bid to encourage them to participate in the first Cold Chain Summit to be held in the Kingdom of Eswatini.

The summit will be staged from August 7-8 at Mavuso Exhibition and Trade Centre in Manzini. Early bird registration for the summit costs E200 and pre-sale costs E250.

Eswatini to strengthen cancer prevention control capacities

THE development of the National Cancer Control Plan (NCCP) was necessitated by the growing burden of cancer including an increasing number of new patients every year.

It was also necessitated by the high impact of cancer mortality as it is among the leading cause of death in Eswatini. Increased costs of cancer, uneven uptake

of knowledge and innovation, limited availability of tools and resources and lack of collaboration among cancer stakeholders also necessitated this.

This is contained in the National Cancer control Plan 2019 to 2022 by the ministry of health. The World Health Organization (WHO) and other non-governmental organisations (NGOs) contributed to this valuable document.

The National Cancer Control Plan aims to build on the existing health system in Eswatini in order to strengthen cancer prevention control capacities, both in public and private sectors through the control of risk factors associated with cancer, investment in cancer control workforce, use diagnostics, surveillance and cancer research.

"This is the first cancer control document to be developed in Eswatini. It consolidates aspects of cancer prevention, screening, diagnosis, treatment and care for cancer patients as well as the investment required to deliver these services," reads the plan.

The plan particularly reinforced the need for action to prevent cancer, espe-

According to the plan, enhanced health promotion, education and advocacy would enable government and other partners to improve the public understanding of cancer.

In particular, the plan aims to empower the public to adopt healthier lifestyles and help healthcare professionals to recognise the symptoms of cancer and identify people at risk or living with can-

"The plan also seeks to improve early detection of cancer by expanding the available screening programmes and introducing mechanisms and services that are proven to save lives.

It ultimately seeks to shorten the time taken to diagnose and treat cancer by streamlining the diagnosis, referral systems and process of care by investing in improved access to diagnostics, cancer treatment as well as capacitating more

cancer specialists and other health care staff."

It seeks to harmonise and coordinate cancer care, the national cancer registration, sharing resources and information among health facilities. It would help patients and their families have better support and access to quality treatment including palliative care.

The plan would enable the country to improve services through education and research in the field of cancer prevention and control ensuring a culture of evidence based practice. The plan on the WHO's global cancer control strategy.

The National Cancer Control Unit would provide oversight and facilitation of the implementation of the National Cancer Control Plan.

It would require technical assistance from World Health Organization, hospitals, community clinics, Non-Governmental Organizations and the private sector.

Over 700 000 tourists received in 3 months

THE country received 798 814 tourists into the country between April and June this year.

This is contained in the 2019/20 first quarter performance report of the ministry of home affairs. The number of departures recorded in the first quarter of this financial year stood at 788 648.

Tourists recorded entered using vehicles, while some were passengers, pedestrians and cyclists and these tourists entered using the various border gates around the country.

The ones who used King Mswati III International Airport and Matsapha International Airport used planes whereas those who used Mpaka Railway Station used trains to enter the country.

There were 262 462 arrivals and 255 984 departures recorded at Ngwenya Border Gate during this period.

Ngwenya turns out to be the highest entry/exit point in terms of tourists who entered and exited the country during the period under

Mahamba Border Gate recorded 143 023 tourists who got into the country during this period,

while those who exited using the same border gate were 141 848. Matsamo recorded 90 094 tourists into the country and those who exited were 90 801.

Among the two border gates that this country shares with Mozambique, Lomahasha proved to be the busiest during this period under review. There were 36 834 entries recorded and 34 657 departures recorded at this entry/exit point.

Mhlumeni Border Gate recorded 24 269 entries, while its departures were 23 638.

Lundzi Border Gate was the lowest entry/exit point in terms of tourists' movement. This border gate, during the period under review. recorded 1 662 entries and recorded 1 928 departures. It is followed by Bulembu Border Gate, which recorded 2 582 entries and 2 166 departures. Among the two airports the country has, KM III International Airport proved to be the busiest, with 6 851 tourists entering the country, while 6551 leaving the country through this airport. Matsapha International Airport recorded only 205 visitors, while recording only 161 departures. Mpaka Railway Station received 435 tourists and the same number left through the station during this period.



Submission of Income Tax Returns (Individuals and Companies)

In terms of Section 33 of the Income Tax Order 1975 as amended (hereinafter referred to as the Order) the Commissioner General of the Eswatini Revenue Authority (SRA) hereby notifies all concerned and/or cited persons in this notice to submit Income Tax Returns for the year of assessment ended 30 June 2019.

1. Person(s) Liable to submit Income Tax Returns in terms of the Order

The following persons are required to submit Income Tax Returns for the abovementioned year of assessment:

a) Every person, (other than a company or a trust) who received any gross income sourced in Eswatini and was not ordinarily resident in Eswatini during the year of

b)A pensioner who was ordinarily resident in Eswatini, who has multiple sources of income;

c) The Public Officer of any company, in respect of such company;

d) A recognized representative of a trust fund in respect of such trust income;

e) An employee who earns remuneration from more than one employer;

f) An employee or a director who derived business or property income, in addition to his/her employment income;

g) A director of a company;

h) A member of a clergy (e.g. pastor, priest, priestess, minister, apostle etc.) and a church

i) A Member of Parliament, board member of a statutory or similar body, a partner in a partnership, and locally recruited personnel working in embassies, consulates, missions and or international organizations;

j) A person who derives income from providing professional independent services and their agents;

k) A person who receives interest or dividends from funds invested in Commercial Banks, Building Societies, and Investment houses;

I) Any person whose income is 1.2 million Emalangeni and above; and

m) Any other person who may be required by the Commissioner General in writing to render a return of income in respect of the current year of assessment.

2. Persons not required to submit Income Tax Returns in terms of section 33bis of the Order.

a) A person, in continuous employment with a single employer, whose gross income during the year of assessment consisted ONLY of remuneration; save for persons whose income was 1.2 million Emalangeni and above, or:

b) An employee who's income tax deducted was payable in terms of the prescribed tax deduction tables and subject to the Final Deduction System (FDS); save for persons whose income was E1.2 M and above, and;

c) Such person did not derive any other income, or if the additional income derived, consisted of a dividend, which has been subjected to a final withholding tax.

Deadline for the furnishing of returns in terms of Section 33 of the Order

a) The Commissioner General in exercising his powers has introduced the staggering of the submission of income tax returns between different taxpayer segments by establishing a logical set of due dates to allow taxpayers enough time to prepare and file correct tax returns.

b) Taxpayers are expected to submit their returns within the following periods:

New Filing Deadline	
31 December 2019	
30 November 2019 31 October 2019	

4. P.A.Y.E Tax Returns

All employers including those who do not have employees that fall within the PAYE tax bracket MUST submit an annual return of salaries (PAYE 05, PAYE 15 and PAYE 16) for reconciliation purposes on or before 30 September 2019.

All taxpayers who are required to self-assess, i.e. Large Taxpayers, companies and individuals registered for VAT, High Net Worth Individuals and special groups (MPs, Emabandla, Heads of Government Departments, are hereby reminded that their Income Tax Returns are required to be submitted together with payments. The deadline of the payments is 31 December 2019.

All taxpayers registered for e-Tax are encouraged to submit their income tax returns using

the online platform. However, Large Taxpayers are compelled to submit using this method (e-Tax). The e-Tax platform can be accessed through https://etax.sra.org.sz/.

7. Payment Methods

Taxpayers are encouraged to make payments via Electronic Fund Transfer (EFT) (i.e. Internet Banking), Mobile Money, or direct deposits. Point of sale machines (Speed points) are available at SRA service centres and cash payments are discouraged.

8. Extension of Time to file income tax returns

Taxpayers whose filing period has been extended to 30 November and 31 December 2019, respectively SHALL NOT be granted further extension. However, all other taxpayers who foresee challenges in filing their income returns for one reason or the other may apply for an extension of time to submit their income tax returns any time before 30 September 2019 for the Commissioner General's consideration. Extension of time applications made after this date shall NOT be considered. Note that a mere submission of an extension of time application does not guarantee approval.

9. Offences in terms of section 66 of the Order

(a) Anyone who fails to submit a return within the stipulated period commits an offence and may be liable on conviction to a fine of E10 000 and or imprisonment for a period of up to one year or both.

(b) A Taxpayer who makes false statements or entries in a return with an intention to evade or assists someone with evading assessment or taxation, is liable to a fine of up to E50 000 or imprisonment of up to five years or both.

It must be noted that Additional taxes are imposed in terms of

Section 40 of the Order for any default or omission as below:

(a) A taxpayer who defaults in submitting a return in respect of any year of assessment is liable to pay additional tax, an amount equal to twice the tax chargeable in respect of his taxable income for such year of assessment.

(b) A taxpayer who omits from a return, any amount which ought to have been included therein, will be liable to pay an amount equal to twice the difference between the tax as calculated in respect of the taxable income returned by him and the tax properly chargeable in respect of his taxable income as finally determined after including the omitted amount.

(c) A taxpayer who makes any incorrect statement in any return rendered by him, which results or would if accepted, result in the assessment of the normal tax at an amount which would be less than the tax properly chargeable may be liable to pay, in addition to the tax due, an amount equal to twice the difference between the tax assessed in accordance with the return made by him and the tax properly chargeable if the incorrect statement had not been made. Taxpayers are cautioned to exercise diligence when completing the return forms in order to avoid any omissions or making incorrect statements. Taxpayers are encouraged to seek guidance from the SRA if in doubt.

THE handover of four classrooms at Mphofu Primary School by MTN Eswatini on Thursday was made extra special by the delivery of donations from World Vision Eswatini.

The organisation handed over a child safe classroom filled with clothing, sanitary packs, clothes, blankets, toys and books to the school. The donation, worth E200 540 was presented to the Minister of Education and Training Lady Howard-Mabuza who was in the company of the Minister of Sports Harries 'Madze' Bulunga and his counterpart in the agriculture portfolio Jabulani Mabuza.

Problems

Presenting the donation to the minister was Advocacy and Justice for Children Associate Director Sakhile Dlamini who said this was the country's first classroom where children can be at ease to privately talk to teachers about their problems, such as those to do with abuse.

She said the classrooms came about as a collaborative effort with MTN Eswatini and partners in their annual 21 Days of Y'ello Care.

"MTN partnered with organisations such as Swaziland Empowerment Limited, AfriSam and Macmillan in the recently ended drive," she explained.

Dlamini said the concept of having such classrooms was necessitated by the fact that children spent most of their time between schools and their home. As such, providing such a facility enabled children space where they can sit and talk without being made uncomfortable by others, such as is most likely to happen in a staffroom situation.

Dlamini further invited other corporates to partner with them in ensuring that children have a refuge where they can talk and offload their life circumstances to caring and trained teachers. "World Vision is pleased to have been part of this wonderful initiative as part of our ongoing campaign to end sexual violence against children," she said.

Efforts

She stated that part of the campaign's objectives include increasing awareness of violence against children and enhancing reporting of sexual violence incidents and one way of doing this in schools is ensuring that there are child-friendly classrooms.

Adding, she stated that World Vision recognised the efforts of government through the ministry of education to ensure that these rooms are there in all schools.

Appreciating the support from MTN, Dlamini said they were grateful for the positive response when they approached them to be part of the 21 Days of Y'ello Care.

She assured that the organisation would be training teachers to enable them to adequately be receptive and counsel children who approach them.

STOPEARLY CHIL MARRIAGES - REP

POLICE have pleaded with families not to subject their female children to early marriages.

This plea comes a month after a 16-year-old child was murdered by her unemployed husband, aged 25, who then committed sticide at Emalibenia at Emalibeni.

In this case, police started to investigate the family of the female minor who allowed the illegal marriage to take place in 2018 when the now deceased was only 15 years old.

Police who wanted to remain anonymous said in worse rural areas of the kingdom, especially in Northern Hhohho, early childhood marriages are still very common despite the extensive media coverage against such.

"With the introduction of the

Sexual Offences and Domestic Violence (SODV) Act of 2018, we can now arrest individuals who subject their female children to early marriages.

In the past, a 16-year-old minor

could be married to an adult male as long as there was consent from the minor's legal guardian.

It is important to mention that a guardian can be any adult related

Due to the HIV/AIDS epidemic, many adults have passed away, leaving their children in the care of relatives who then resort to selling the female children into early marriages," they said.

The police added that poverty was a major contributor to early child marriages.

"Homesteads in the remote rural areas are poverty stricken, so if there is a female child, she is forced to an early marriage so that the homestead gets cows and money. Child marriages are rife in Northern Hhohho," they added.

Chief Police Information and Communications Officer (CPICO) Superintendent Phindile Vilakati said early child marriages are still common in the kingdom even though such is illegal.

Shafi rescues spitting cobra

ASIAN businessman and part-time snake catcher, Sharafat Ali Shafi has rescued a spitting cobra near Mhlatane High School teachers quarters.

A month after his five-month holiday in Pakistan, Shafi has managed to rescue four snakes around the town of Pigg's Peak.

During the latest snake rescue, eyewitness Xolile Nxumalo said she called Shafi after the snake was spotted slithering on the grass outside her rented residence.

"I was seated outside my rented home near Mhlatane High School quarters when I spotted the snake slithering along the grass, a few metres away from me. The snake had very shiny skin.

Out of fear, I ran back into the house and used my landline to call the police who intum forwarded me to Shafi. It took him less than five minutes to drive to my home using his own vehicle," she said.

Nxumalo added that the snake spat at Shafi numerous times as he tried to retrieve it from a collection of concrete slabs.

"He first located it as it was trying to hide under some concrete slabs. After removing the slabs, Shafi approached the snake but it spat at his face numerous times. Luckily Shafi was wearing protective eyeglasses 50 the snake venom failed to blind him. After the spitting, Shafi used a long broom to immobilise the snake before retrieving it safely with his bare hands. I was shocked to see how long the snake was," she added.

Shafi said the snake measured about 1.5 metres long.

He said he would release it back into the wild at a safe area away from members of the public.

Businessman still complains about storm water damage 23 years later

DESPITE the construction of a new storm water drainage by the Pigg's Peak Plaza, businessman King Mziyako is still complaining about storm water being dumped into his plot.

Mziyako, who owns a residential and commercial plot in Pigg's Peak behind the Pigg's Peak Plaza, claimed that in 1996 when the plaza was being constructed, labourers 'forgot' to construct a proper storm water drainage system.

This oversight resulted in water that was being collected on the plaza roofing being dumped on Mziyako's plot, that is located bellow the plaza building.

Mziyako said the water still flows into his building despite the new storm water drainage.

"I have had this complaint for more than 23 years now and I have nowhere to go. My story is not new and media houses have reported on the matter in the past. In 1996, I approached the Pigg's Peak Plaza about the water problem but they chose to ignore me. I then approached the Pigg's Peak Town Council to mediate in 1997 but they also ignored me. I then approached the media but still I got no assistance," he said.

Mziyako said the water damage has devalued his building over the past 23 years.

"The front of my building is a commercial area, housing two

shops. Behind my building is a residential area with three rooms that are up for rent. These residential rooms are the most affected by the storm water because it flow into the rooms under the doors, creating mould and forcing my tenants to remove it. This has resulted in my tenants leaving the rooms in summer whenever it rains as my building is now ruined and devalued by the storm water from the plaza," he added.

Plaza Manager Costa Ginindza said new water drainages were constructed in 2017 and since that time no water has tricked down to Mziyako's building.

"We constructed new drainages in 2017, which lead to those of the Pigg's Peak Town Council at the bottom of the adjoining street. No water is being channelled to the plot and Mziyako is just causing confusion," he said.

Pigg's Peak Town Clerk Mzwandile Ndzinisa said the new storm water drainages were effectively removing water away from the affected plot.

Motorist nabbed for DD after payday

CELEBRATIONS at times can land one in trouble.

This is what one Sibusiso Mtsetfwa (34) learnt after finding himself behind bars just a few hours after having some good times with friends.

Mtsetfwa was nabbed driving a motor vehicle while under the influence of alcohol, a serious offence according to the Eswatini traffic laws. He appeared before the magistrate's court, where he faced a charge of contravening the Road Traffic Act of 2007.

Accused

The accused person was said to have driven his motor vehicle along the Simunye-Manzini road while under the influence of intoxicating

A breathalyser test conducted on him read 0.87 mg/l, which is above the legal limit which stands at 0.37 mg/l.

When the charge sheet was read to him, the accused person pleaded guilty to the charge.

His plea was also accepted by the

Crown without leading evidence to prove commission of the offence.

During mitigation, the accused person told the court that he was arrested while on his way home from a drinking hall with friends. He said they met at Simunye after getting their salaries and decided to go and have a small celebration at the drinking hall.

The accused person was accordingly found guilty by the court. He was sentenced to 60 days in a correctional facility with an option to pay E1 000 fine.

TAIWAN INTENSIFIES MEDICAL TRAINING FOR EMASWATI

A total of 79 local students are expected to undergo clinical education post-graduate training in the Republic of China (Taiwan) so as to improve healthcare in the Kingdom of Eswatini.

Speaking during a lunch meeting the Republic of China (Taiwan) Taiwan Ambassador Jeremy Liang said such a project was under the regulation of Eswatini Medical and Dental Council and ministry of health.

He said the training was expected to take about two years, adding that already 10 graduates have joined an internship programme at the Mbabane Government Hospital.

"When they completed the twoyear programme, they will be well trained and qualified for further training," he said during a luncheon at Luxy Gardens last week. At the lunch meeting, the ambassador was joined by the Minister

Oliver Harn, Project Director who is also a specialist in Internal Medicine Liao Say-Trung, Nurse Administrator Chen Wen-Ting, Family Physician Tsai Hui Shan, Peditrician Chu Feu-hung and Obstetrician Gynaecologist Ou Kae Yng. All the specialists are based at the Mbabane Government Hospital.

He added that the Mbabane Government Hospital would be a qualified teaching hospital in post-graduate, residency, and specialist programme in the future.

The interns, who will be taking part in the programme, would include those from other countries as well as Emaswati who are studying in Taiwan from I-Shou

Liang said the project was based on a memorandum between the Kingdom of Eswatini and Taiwan, and that of Eswatini and Taipei Medical University and hospital.

The ambassador said as part of their action plan, they had formed a team of 10 to 17 specialists and medical officers who have clinical experience of more than 10 years.

The programme would run for 104 weeks. The first four weeks will be orientation, whilst the remaining weeks are for clinical rotation course. The medical interns would rotate six major blocks of internal medicine, surgery, obstetrics and gynaecology, paediatric, orthopaedic-anaesthesia-ICU and family medicine.

He said the interns would be assessed regularly using multiple tools for assessments such as objective structured examination, miniclinical evaluation exercise, case based discussion, direct observation of procedural skills and many more.

Man arrested for dagga worth over E40 000

IN yet another drug arrest, members of the Royal Eswatini Police Service (REPS) have arrested a 28-year-old man for the possession of dagga worth more than E40 000 while at Nyakatfo.

It is said the accused, Sihle Myeni was a repeat offender, who had been arrested numerous times for dagga possession. "Police who were act-

ing on a tip off raided a certain homestead at Nyakatfo, where they found 59 kilogrammes of dried dagga worth about E47 200. The illegal herb had been concealed inside a large black plastic container, under a few empty sacks. On top of the container was a large tight lid that concealed the potent dagga smell. The container itself was located inside a shed near

the accused person's bedroom." Myeni was expected to appear before the Pigg's Peak Magistrate's Court.

Church puts food on the table for families

THE Life Church in Mbabane has found new ways to spread goodness and mercy to its members.

The church for the longest of time has been donating food parcels to its members and non-church members too. The food parcels come in different sizes and are usually delivered by Pastor Mandla Madlazi, who delivers the food weekly to chosen homesteads. Some food parcels and any form of help is usually done on Sundays at their premises of worship at the City Court.

The church currently feeds 15 families.

The pastor said this for him is simply living by the word of God, which requires people to love and do well by their neighbour.

Their slogan is 'manifesting God's

glory'. "The Lord wants us to take care of each other, not only one's relatives but everyone who is around us, hence I started gathering the little that I have together with my congregants and put food on the table for others," added Madlazi.

The church has also been paying school fees and university tuition fees for a number of pupils, who are also part of the church.

The church has become the sole financial aid for the said pupils and the pastor has vowed to pay for them until they complete their programmes.

They have put five pupils through high school and three students to tertiary institutions.

LUNDZI RESIDENTS WANT SHOP NEARBY

LUNDZI residents have decried the unavailability of shops to buy the most basic amenities.

They claim that they have to travel distances just to get a shop to buy salt.

"There is a serious lack of shops in our area, and we find ourselves asking for basic needs from our neighbors.

When we go to town, it is usually once in a while and by the time we decide to go there, we would have run out of a number of household items," shared one resident who identified himself as Mabuza.

Supposed

He said the shops where they are supposed to get the simplest of things like sugar, a box matches and maize meal, were over 20 kilometres away.

Upon a mini tour of the area, it was discovered that shops are indeed remote. The community also expressed that they are happy with the upcoming clinic that is nearing completion.

"Not all is gloomy in our small area as you can see we have a pending clinic and the water project that was opened by the minister. All we need now are shops that

are operate nearby for the supply of items that we need urgently," said another resident who was identified as Dlamini.

The interviews were conducted when Minister of Natural Resources and Energy Peter Bhembe officially opened a water project that would benefit many households

Present was Mhlambanyatsi Member of Parliament Petros Mavimbela who applauded the community members for their patience whilst the project was being implemented.

"All remaining projects will be implemented in due course and I urge you to continue exercising patience," said Mavimbela. Lundzi is said to have 78 per cent electricity coveraged which means that a few homesteads do not have electricity.

It is now a game for vultures; a battle for the soul of the ANC, as it turns out, will roast itself in the biggest braai of hate.



PART II

Racketeering

3. (1) Any person who, within Eswatini or elsewhere-

(a) receives or retains any property derived, directly or indirectly, from a pattern of racketeering activity;

(b) knows or ought reasonably to have known that that property is so derived; and

(c) uses or invests, directly or indirectly, any part of that property in the acquisition of any interest in, or the establishment or operation or activities of any enterprise, commits an offence.

(2) Any person who, within Eswatini or elsewhere-

(a) receives or retains any property, directly or indirectly, on behalf of any enterprise; and

(b) knows or ought reasonably to have known that that property derived or is derived from or through a pattern of racketeering activity, commits an offence.

(3) Any person who, within Eswatini or elsewhere-

(a) uses or invests any property, directly or indirectly, on behalf of any enterprise or in the acquisition of any interest in, or the establishment or operation or activities of any enterprise; and

(b) knows or ought reasonably to have known that that property derived or is derived from or through a pattern of racketeering activity, commits an offence.

(4) Any person who, within Eswatini or elsewhere, acquires or maintains, directly or indirectly, any interest in or control of any enterprise through a pattern of racketeering activity commits an offence.

(5) Any person who, whilst managing or employed by or associated with any enterprise within Eswatini or elsewhere, conducts or participates in the conduct, directly or indirectly, of the affairs of that enterprise through a pattern of racketeering activity commits an offence.

(6) Any person who, within Eswatini or elsewhere, manages the operation or activities of an enterprise and who knows or ought reasonably to have known that any person, whilst employed by or associated with that enterprise, conducts or participates in the conduct, directly or indirectly, of the affairs of that enterprise through a pattern of racketeering activity commits an offence.

(7) A court may hear evidence, including evidence with regard to hearsay, similar facts or previous convictions, relating to offences contemplated in subsections (1) to (6) notwithstanding that that evidence might otherwise be inadmissible, provided that the evidence would not render a trial unfair.


(8) For the purposes of proving a previous conviction during a trial in respect of an offence contemplated in subsections (1) to (6) it is sufficient to prove the original record of judicial proceedings if a copy of that record, certified or purporting to be certified as a true copy-

(a) by the registrar, deputy registrar or clerk of the court or other staff member having the custody of the record of those judicial proceedings; or

(b) in the case where judicial proceedings are taken down in shorthand or by mechanical means, by the person who transcribed those proceedings,

is produced in evidence at the trial, and that copy shall be prima facie proof that any matter purporting to be recorded in that copy was

correctly recorded.

(9) A person shall not be charged with committing an offence contemplated in subsections (1) to (6) unless a prosecution has been authorised in writing by the Director of Public Prosecutions.

Penalties

4. (1) Any person convicted of an offence referred to in section 3(1) to (6) is liable to a fine not exceeding twenty million Emalangeni or to imprisonment for a period not exceeding fifty years or to both.

(2) A sentence imposed in terms of this section is not subject to postponement or suspension in terms of the Criminal Procedure and Evidence Act, 1938, or its successor.

PART III OFFENCES RELATING TO CRIMI-**NAL GANG ACTIVITIES**

Gang related offences

5. (1) A person who participates in or is a member of a criminal gang and who

(a) aids and abets any criminal activity committed for the benefit of, at the direction of, or in association with any criminal gang;

(b) threatens to commit, bring about or perform any act of violence or any criminal activity by a criminal gang or with the assistance of a criminal gang; or

(c) threatens any specific person or persons in general with retaliation in any manner or by any means whatsoever, in response to any act or alleged act of violence, commits an offence.

(2) Any person who- (a) performs any act which is aimed at causing, bringing about, promoting or contributing towards a patter criminal gang activity;

(b) incites, instigates, commands, aids, advises, encourages or procures any other person to commit, bring about, perform or participate in a pattern of criminal gang activity; or

(c) causes, encourages, recruits, incites, instigates, commands, aids or advises another person to join a criminal gang, commits an offence.

Penalties

6. (1) Aperson convicted of an offence under-(a) section 5(1) or 5 (2) (a) is liable on conviction, to a fine not exceeding two hundred

and fifty thousand Emalangeni or to imprisonment for a period not exceeding six years or to both, but, if the offence was committed under the circumstances referred to in subsection (2), is liable to a fine not exceeding four hundred thousand Emalangeni or to imprisonment for a period not exceeding eight years or to both; and

(b)section 5(2)(b) or (c), is liable on conviction, to a fine not exceeding one hundred and twenty five thousand Emalangeni or to imprisonment for a period not exceeding two years or to both, but, if the offence was committed under the circumstances referred to in subsection (2), is liable on conviction, to a fine not exceeding two hundred thousand Emalangeni or to imprisonment for a period not exceeding three years or to both.

(2) If any of the offences contemplated in section 5 is committed on the premises or grounds of, or within five hundred metres of a school or any other educational institution, during hours in which the facility is open for classes or school related programmes or when minors are using the facility, that fact shall be regarded as an aggravating factor for sentencing purposes.

(3) A court shall, after convicting an accused of any offence, including an offence contemplated in this Act, regard as an aggravating factor for purposes of sentencing, the fact that an accused was a member of a criminal gang.

Identification of a member of a criminal gang

7. In considering whether a person is a member of a criminal gang for the purposes of this Act, the court may have regard to all relevant factors, including the following factors, namely that, that person-

(a) admits to being a member of a criminal gang;

(b) is identified as a member of a criminal gang by the parent, guardian or relative;

(c) resides in or frequents a particular area for gangs area and adopts their style of dress, their use of hand signs, language or their tattoos, and associates with known members of a criminal

(d) has been arrested more than once in the company of identified members of a criminal gang for offences which are consistent with usual criminal gang activities; or

(e) is identified as a member of a criminal gang by physical evidence such as photographs or other documentation.

TBILLION RISING REVOLUTION

WOMEN and Law in Southern Africa (Eswatini) has been granted the privilege of being guests on the breakfast show hosted by Sandton Maiber, otherwise known as JT every fortnight.

During these shows a specific topic is discussed, with the host posing probing questions to drive the conversation. Normally, some listeners will interact with the host on the topic of the day.

On last week's show (July 17), WLSA was on the show, speaking on their upcoming second annual Women's Convention under the theme 'Promoting Inclusive Decision-Making through Economic Empowerment of Women'.

As per the norm, some listeners interacted with the host during and after the show. What is worth noting is that most comments are made by men, complaining of the fact that women and their issues are receiving too much attention, while men are being neglected.

They complain that while the focus is on women's rights and gender equality, men are therefore being discriminated against. Mostly, they say what the guests say during the show is not true because women have always been included in issues in society and that the position put forward by WLSA is an exaggeration.

While we will not speak to their complaints as this has been addressed in different fora and in several articles, ours will be to focus on the

theme of the convention.

Many people (mainly men) question a woman's ability to be in positions of leadership and/or decision-making positions, and to this end, the quote by Margaret Thatcher (former British Prime Minister) comes to mind when she said 'Any woman who understands the problems of running a home will be near to understanding the problems of running a country.'

Our interventions do not come from the top of our heads, but are informed by several studies which have been carried out and some of the findings are as follows:

Women generally devote more of the household budget to education, health and nutrition than men. As such, a woman would also prioritise those issues on the national budget, making the necessary budgetary allocations.

Societies with greater gender equality not only offer better socio-economic opportunities for women, but also tend to grow faster and more equitably.

An example of this would be Rwanda which has a significantly increase in women representation since 1994 and their parliament currently has the largest number of women representatives in the world. One may even posture that this may be a large contributing factor to Rwanda's rapidly growing economy and development.

There are more gains in areas including poverty reduction, environmental sustainability and decision-making is broader on a wider set of issues. Since women's main focus is to ensure that their families' basic needs are met, this should necessarily flow into national programmes that will prioritise these issues as



well.

For example, the World Bank found in Latin America and the Caribbean, that women played a critical role in the decline of poverty, with the female market contributing to a 30 per cent reduction in extreme poverty over a ten-year period.

● Lowering barriers faced by women entrepreneurs bolsters growth and inclusion which will create more, better paying jobs for women. The inclusion of more women in processes will ensure that women play an active role in policies that will improve their conditions in the home, in the workforce and at the national level.

Economic development and gender equality go hand in hand and therefore placing women at the heart of policy-making will go a long way towards realising the UN 2030 Agenda goal of achieving gender equality and empowering all women and girls. Therefore, the Government of Eswatini has an obligation to ensure that women are placed at the centre of all programmes and interventions towards policy-making processes and ensure that women fully participate in those processes. It is not enough to just have policies designed for gender equality and women empowerment, but these have to

have women participating during the conceptualising, designing and implementation processes.

As the world speaks to a 50 per cent representation of women across the board, the Eswatini constitution only speaks to a 30 per cent quota for women representation in parliament, but it is does not make any provision for other positions of decision-making. This poses the problem of focusing only on participation in parliament and neglecting representation in the private and public sectors.

Despite the fact that the country falls way below the 50 per cent global threshold, we still fail to meet our obligations in terms of representation in parliament.

Doing a scan of women in leadership, while it is acknowledged that there are women in leadership, that in the question being what percentagership they represent nationally? The numbers available currently do not talk to equality in representation, with women being under-represented.

We are not looking for token women being appointed into positions, but talking to women competing equally with their male counterparts and being appointed or elected on merit. And in order for this to happen, women do need to be empowered to obtain the necessary competence and capacity to effectively compete equally for the opportunities available, and to contribute effectively to the shaping of policies that will drive the country to discharge its national, regional, continental and international obligations on gender equality and women and girl's empowerment, with the broader result being attainment of all developmental goals.





ETA concerned about declining number of Moz tourists

THE Eswatini Tourism Authority (ETA) is concerned about the decline in the number of tourists from Mozambique coming into the country, as statistics indicate an over 10 000 decline.

This was revealed by ETA CEO Linda Nxumalo during the ETA calendar of events activation in Maputo, Mozambique on Friday. She said the recent statistics were disturbing as the country was currently making efforts to increase the number of tourists visiting the kingdom, especially from the region and conti-

The activation held at Radisson Blu Hotel was attended by tour operators, media and travel agencies, including the leadership of National Tourism Institute (INATUR). Also in attendance were Eswatini High Commissioner to Mozambique Reverend Abednego Ntshangase and Consular Sigayoyo Magongo.

"We have been mandated by the new government through the ministry of tourism and environmental to increase the number of tourists coming into the country, hence the decline is not pleasing as we want this drive to be suc-

"We have seen, with dissatisfaction, a slight decrease in terms of total arrivals from Mozambique. In 2018 alone we saw 195 644 arrivals, 13 276 less than what we got in 2017. We notice though that more than half of the total arrivals are aged between 25 and 45 years of

Segment

This market segment is very important to us and tourism globally. These are the people at the centre of popular culture creation right now. They love travelling and attending events," she

She added that the world youth tourism industry was estimated to be around 190 million international travellers per year, according to UNWTO forecasts. The CEO said it was expected that in 2020 there would be about 300 million young people who will travel in a year, accounting for US\$320 billion in market value. "The development of this market presents a unique opportunity for us. The social value and impact of events continues to form part of the overall government agenda where tourism is concerned," she added while addressing the attendees of the activation."

She said tourism thrived on private public partnerships, hence were grateful to privately-owned entities who host international events like the MTN Bushfire Festival, a proudly Eswatini event and one of the major tourist attractions to the Kingdom of Eswatini.

She said the festival attracts thousands of visitors who flock to the kingdom on the weekend of the festival. The MTN Bushfire 2019 Festival alone generated E81.2 million in revenue, which contributed to the economy of the country.

"By indirectly and directly inviting our neighbours to experience the Eswatini way of life, our events play an important part in Eswatini's regional marketing strategy. According to the Visitor Survey, in the last 12 months, 22.8 per cent of all visitors from Mozambique attended an organised sporting event, festival, fair or cultural celebration.

Our festivals and Royal ceremonies are considered to contribute significantly towards the cultural and economic development of Emaswati," she said.

... INATUR pledges to support ETA

MOZAMBIQUE National Tourism Institute (INATUR) official Nuno Fortes says they remain committed to working with Eswatini in a bid to promote the country.

He said they would continue working with the Eswatini Tourism Authority and further encourage Mozambican nationals to visit the kingdom.

"There are a number of activities in Eswatini and personally will be attending the annual Bikers Rally with a number of tourists. Eswatini is a beautiful country and we love it, hence we will continue to support it and promote it and what it has to offer," he said.

He explained that one of the reasons behind the decline was the newly-completed Chinese-built Maputo-Katembe Bridge and Link Roads. He said most of the visitors were those in transit and were now using the new bridge to cross to South Africa. "The new bridge allows people to cross directly to South African, hence the less numbers coming into Eswatini. I think you are only losing out of the E50 road levy which they were paying when entering the country.

"Otherwise the stats must not worry you, as most of these people were not spending much because they were just passing through. However, these are some of the positives and negatives that come with development," he said.

Reverend Abednego Ntshangase also pledged support to ETA, stating that his office would go a long way in marketing the country, as this was one of the responsibilities of his office. He said they were also flexible to work with tour operators, especially on the issue of providing VISAs in good time for tourists who want to visit the kingdom. He urged tour operators to contact his office in the event they have tourists coming from countries which need VISAs accreditation to come to Eswatini. "We are able to issue VISAs on arrival at our embassy, especially if they use the same process used when applying for the VISA to come to Mozambique. It makes things easy and we are able to issue it on the spot," he added.

ESWATINI COMMEMORATES INTERNATIONAL DAY FCO-OPERATI

> THE Kingdom of Eswatini will tomorrow commemorate the International Day of Co-operatives under the theme 'Co-operatives for Decent Work'.

The International Day of Co-operatives is celebrated worldwide annually; usually on the first Saturday of July. This is in line with a resolution of the United Nations General Assembly, which declared the first Saturday of July 1995 to be International Day Cooperatives,

marking the centenary of the establishment of the International Cooperative Alliance. This was on December 16, 1992. Since 1995, the United Nations' International Day of Co-operatives has been observed jointly alongside International Co-operative Day. This year, it fell on July 6, 2019.

Each country within the United Nations celebrates this day in its own fashion; and each year a theme is decided at UN Assembly level. The kingdom, therefore, will only be celebrating this event on Thursday July 25, 2019 at Metropolitan

Evangelical Church in Manzini. The event will be graced by Minister of Commerce, Industry and Trade Mangoba Khumalo, as well as Minister of Labour and Social Security Makhosi Vilakati. The event will include an award ceremony in recognition of co-operatives that are doing well in the country. As a build-up to tomorrow's event, the Department of Co-operatives within the Ministry of Commerce, Industry and Trade yesterday hosted an exhibition day at the Millennium Park, also in Manzini. Festivities began at 7am with a series of wellness activities.

The first activity was the testing of sugar diabetes. Thereafter, there was a march around Manzini city; that began and ended at the Millennium Park. This was followed by aerobics. Other wellness activities were voluntary HIV testing, High Blood Pressure testing, cancer, tuberculosis and malaria awareness. Fitness activities included tug-of-war and sack race. There was also lots of entertainment activities; including music, sibhaca, drama and dance. In attendance during the exhibition day was the Commissioner of Labour, Sipho Tsabedze.

Cooperatives for Decent Work

THE 2019 theme Cooperatives Decent Work' was selected in support of Sustainable Development Goal (SDG) 8; which speaks to inclusive development and decent work.

As already alluded in last week's column, employment creation forms part of the key mandate for co-operatives.

Besides employing Emaswati in key and ordinary positions within co-operative associations; co-operators are also able to create employment from businesses that they start using either their dividends or loans taken against their savings. In most developed countries, cooperative membership forms a high proportion of the adult population.

This, indirectly, translates to job creation. In Brazil, for example, an estimated 296 000 jobs were created through the Organisation of Brazil Cooperatives, while a further 148 000 were employed by health co-operative UNIMED in 1994 alone.

That's only just a tip of an iceberg compared to India; who created an

estimated 13.8 million jobs within the same year. Moreover, in a number of African countries, co-operatives have become the second largest employer; surpassed only by the government. Salaried jobs have been created through activities in the agricultural, production as well as credit and savings sectors. Kenya, for example, created an estimated 250 000 jobs within co-operatives in 1996 alone; followed by South Africa with an estimated 100 000 jobs and Morocco with 48 000; according to 'Co-operatives in East Africa'. For Eswatini, an assessment determining the number of people employed directly and indirectly through cooperatives is

yet to be done. However, it goes without saying that within the country's 628 adult co-operatives and 51 in-school cooperatives, a large number of Emaswati are currently occupying key positions. The theme for this year's event, therefore, is relevant given today's widening inequality, increased job insecurity and high unemployment levels, particularly among the youth. Without a doubt, decent work for all should remain a priority not only within the co-operative movement but for the nation as a whole.

GIC appeals to Concourt to set aside R5.2bn takeover

JOHANNESBURG - The greater Lonmin Community (GLC) has approached the Constitutional Court for leave to appeal the setting aside of the acquisition of platinum mining company Lonmin by Sibanye-Stillwater.

In papers filed by Khanyile MB Attorneys Inc last week, the GLC argued that the Competition Tribunal erred in approving the merger with conditions, without proper investigation of Lonmin's social labour plan (SLP), which was in the process of being amended at the time. The group said the Competition Commission approved the merger without a proper investigation and all documents needed for approval submitted as per section 11 of the Mineral Petroleum Resources Development Act.

The GLC is a not-for-profit organisation representing affected communities of Rustenburg, such as Marikana, Mooinooi, Majakeng, Tomado, Nkaneng



and Bapo ba Mogale. Sibanye's offer of Mineworkers and Construction Union to acquire the entity and to-be-issued ordinary share capital of Lonmin, subject to certain specific conditions, for about R5.2billion, became effective in June after 18 months of talks and litigation. In May, the Competition Appeals Court (CAC) upheld the Competition Tribunal's November decision to approve Sibanye's offer to acquire Lonmin and thus dismissed the appeal by Association

The GLC wants the court to declare section 17 of the Competition Act unconstitutional and to declare the merger of Sibanye and Lonmin irregular.

It contends that the merger was approved without the Department of Mineral Resources having approved a social labour plan (SLP) on a large merger.

Kumba interim profit jumps to R13bn on higher iron ore price

JOHANNESBURG - Kumba Iron Ore yesterday pointed to a higher iron ore price and a weaker Rand as it reported a whooping increase in net profit to R13.2 billion in the six months ended June 30 compared with R3.9 billion last year.

Kumba, a unit of Anglo American and a supplier of high-quality iron ore to the global steel industry, said headline earnings were up 239 percent to R10.1 billion or R31.51 per share versus R9.31 during the same period a year ago.

Total revenue increased by 77 per cent to R34.5 billion, largely driven by a 57 per cent increase in the average realised iron ore price to US\$108 tonne and the Rand weakening by 16 per cent on average against the



Mkhwanazi said the miner experienced a challenging first half which saw production volumes decreasing by 11 percent largely due to unscheduled plant maintenance in the first quarter, but made good progress in the second quarter.

KENYA'S FINANCE MINISTER, TOP OFFICIALS ARRESTED FOR GRAFT

NAIROBI -Kenya's Finance Minister Henry Rotich and other treasury officials were arrested Monday on corruption and fraud charges over a multi-million dollar project to build two mega dams, police said.

Director of Public Prosecutions Noordin Haji had ordered the arrest and prosecution of Rotich and 27 other top officials on charges of fraud, abuse of office and financial misconduct in the latest scandal to rock graft-wracked Kenya.

Rotich, his principal secretary and the chief executive of Kenya's environmental authority then presented themselves to the police.

"They are in custody now awaiting to be taken to court," police chief George Kinoti told AFP.

"We are looking for (the) others and they will all go to court.'

Haji said the conception, procurement and payment processes for the dam project - part of a bid to improve water supply in the drought-prone country - was "riddled with irregularities".

"Investigations established that government officials flouted all procurement rules and abused their oath of office to ensure the scheme went through," said Haji.

He pointed to the awarding of the contract to Italian firm CMC di Ravenna in a manner that flouted proper procurement procedures, and despite financial woes that forced the company into liquidation and had led to it failing complete three other megadam projects.

According to the contract, the project was to cost a total of \$450 million (401 million euros), but the treasury had increased this amount by \$164 million "without regard to performance or works," said Haji.

Some \$180 million has already been paid out, with little construction to

Another \$6 million was paid out for the resettlement of people living in areas that would be affected by the

project, but there is no evidence of land being acquired for this, the chief prosecutor said.

"I am satisfied that economic crimes were committed and I have therefore approved their arrests and prosecutions," said Haji.

'Well-choreographed scheme'

"The persons we are charging today were mandated with safeguarding our public interest and deliberately breached this trust. "Under the guise of carrying out legitimate commercial transactions, colossal amounts were unjustifiably and illegally paid out through a well-choreographed scheme by government officers in collusion with private individuals and institutions.

Rotich has previously denied any wrongdoing in the scandal.

The dams scandal is one of several in the poverty-plagued country that has seen hundreds of millions of dollars of public money disappear due to fraud. In 2017 Kenya fell to 143rd out of 180 countries in Transparency International's annual corruption index.

In March 2018, a damning report from the auditor general showed the government could not account for \$400 million in public funds. A string of top officials have been charged since last year as President Uhuru Kenyatta vows to combat corruption -a refrain weary Kenyans have heard from multiple presidents.

Army officer admits his part in murder of Gambian editor

BANJUL - An army officer said he was among a group of men who murdered Gambian editor Devda Hydara in 2004 on the direct orders of then-president Yahya Jammeh, Agence France-Press has report-

In testimony before Gambia's Truth, Reconciliation and Reparations Commission, which was broadcast on the local Kerr Fatou Network, Lieutenant Malick Jatta said he carried out the shooting with at least two others, and that during the operation his commander was on the phone with Jammeh.

He said that the commander later handed him an envelope containing

Reacting to the confession, Committee to Protect Journalists (CPJ) Africa Program Coordinator Angela Quintal said: "For 15 years, CPJ has called on Gambian authorities to do everything in their power to ensure those

who carried out Deyda Hydara's killing are brought to justice.

"Today, Yahya Jammeh himself was accused of giving the order to kill a respected journalist.

"Jammeh should be extradited to Gambia without delay to stand trial for the murder of Hydara and other abuses carried out during his rule."

Hydara was the managing editor and co-owner of the independent newspaper The Point, and a correspondent for AFP and Reporters Without Borders.

Gambia's UN-backed Truth, Reconciliation, and Reparations Commission was set up in October to investigate alleged abuses under Jammeh's 22-year year rule. Its mission is to document abuses and grant reparations to victims, the BBC report-

The former leader is living in exile in Equatorial Guinea after losing an election. African News Agency

Zim vice president in China to receive treatment for unknown illness

HARARE - Zimbabwean vice president Constantino Chiwenga was flown to China for medical treatment, a presidential spokesman said on Monday, but gave no details of the health problems that have kept Chiwenga away from work for more than two months.

The 62-year-old former general led a coup against Robert Mugabe in 2017 and was subsequently appointed one of the two deputies to President Emmerson Mnangagwa. He retained that position after last year's election.

Zimbabweans closely follow the health of Chiwenga because he is widely seen as the power behind Mnangagwa and the front-runner to succeed him. His absence from public duties has stoked speculation about the gravity of his illness, which authorities have sought to play down.

Chiwenga, who has previously received treatment in India, was in a hospital in South Africa before being taken to China, presidential spokesman George Charamba said in a statement.

"The office of the president and cabinet wishes to inform the nation that the vice president this week left for the People's Republic of China where he is set to undergo further medical tests," Charamba said.

After high-level discussions between Zimbabwe and China, it was agreed "to allow Chinese medical experts to join their expert counterparts from Zimbabwe, SA and India in attending to the vice president", Charamba said.

Siemens, Nigeria sign power deal

ABUJA - Nigeria and German company Siemens have agreed a roadmap to nearly triple the country's "reliable" power supply by 2023, President Muhammadu Buhari said on Monday. Nigeria's ailing power infrastructure, which forces businesses and households to run costly fuel generators, is often blamed for hobbling growth in Africa's largest economy. The dilapidated governmentowned grid, operated by the Transmission Company of Nigeria, would collapse if all the country's power generators operated at full tilt. Buhari, who held talks with Siemens CEO and president Joe Kaeser in Nigeria's capital, Abuja. Reuters

CAMEROON - In the ongoing bloody struggle with separatists from Cameroon's English-speaking minority regions, who are fighting for an independent state of Ambazonia, the country's security forces have been accused of committing major rights abuses. In a press release, Human Rights Watch (HRW) asserts these abuses include the killing of civilians and the raping of women. In mid-June, during a security operation, at least four civilians were killed and one woman raped in the country's north-west region. Those killed included an elderly man with a physical disability and a young man with a mental disability, said the rights group.

KHARTOUM - Democratic Republic of the Congo's health minister resigned in protest after being stripped off the responsibilty of managing the country's Ebola outbreak by the presidency. In a resignation letter posted on his Twitter account on Monday, Oly Ilunga Kalenga decried "interference in the management of the response" to the outbreak, which is the second deadliest in history, and the creation of parallel chains of authority. Ilunga's move came after DRC President Felix Tshisekedi's office announced on Saturday it was assigning responsibility for the response to a multi-disciplinary team that would report directly to Tshisekedi."

Five dead in Somalia car bomb attack

SOMALIA - At least five people were killed and several wounded when a car bomb was detonated outside a hotel in the Somali capital Mogadishu, a security officer and witnesses said. The explosion near a checkpoint outside the Afrik Hotel reverberated throughout the city, and sent a massive plume of black smoke into the air. Abdullahi Ahmed, a security officer who witnessed the blast, said at least five people were killed in the attack, which appeared to be targeting the hotel." I can confirm the death of five people: three civilians and two government security officers at the checkpoint,"

'Money is changing hands' as land grabs intensify in Lenasia'

JOHANNESBURG - Evidence is emerging of a "politically-orchestrated campaign" to occupy land in Lenasia that must be investigated by the police, Johannesburg mayor Herman Mashaba said yesterday.

Authorities reported a steep escalation in land grabs in the area during the past week, saying the situation was "getting out of control" with land occupiers firing shots.

Mashaba called for urgent police intervention on Monday, saying that the Johannesburg Metropolitan Police Department (JMPD), with its comparatively limited public order policing resources, "cannot handle the situation alone"

Yesterday he said that the JMPD had requested provincial police commissioner Major General Elias Mawela to set up a task team to probe who was behind the occupation.

"On Monday, I met with a group of residents from Lenasia who have demonstrated to me how these land occupations are politicallyorchestrated by a local councillor ... What is taking place is, effectively, organised crime and must be dealt with decisively," he said in a statement.

"These residents are in possession of evidence which demonstrates how money is exchanging hands, and that ready made-up shacks are being issued to those willing to pay for a piece of land where the occupations are taking place.

"Those behind these occupations are being witnessed driving around the area in highend luxury vehicles, as a testament to the lucrative nature of their criminal activity.

"I have supported these residents to take their evidence to the SAPS and the South African Human Rights Commission, so that investigations are conducted as a matter of

urgency," said Mashaba. He said any "political agenda" of those involved in the land grabs had to be exposed. Timeslive

MBOWENI CONFIRMS R59 BILLION ESKOM BAILOUT

CAPE TOWN - Finance Minister Tito Mboweni yesterday presented his plans to parliament to provide financial support to struggling energy utility Eskom.

Mboweni introduced the Special Appropriation Bill in the National Assembly, which will offer the parastatal a lifeline in the current and next financial year.


This will lead to a R59 billion bailout from government in two instalments: R26bn in the 2019/20 financial year followed by R33bn in the 2020/21 financial year.

"I stated in my budget vote 7 for the National Treasury that Eskom presents the biggest risk to the fiscal framework because of its financial problems and negative impact on the economy," Mboweni said.

"Given the high risks of a systemic failure if Eskom were to collapse, government is urgently working on stabilising the utility, while developing a broad strategy for its future.

"Eskom faces serious financial and operational challenges, which to a large extent were caused by the governance challenges that the entity previously experienced which resulted in a decline in investor con-

The minister also said the debt and restructuring of Eskom would need to be addressed.

Mboweni said a team of officials had considered a number of options as a solution to the company's debt challenges in order to ensure its sustainability. He will be appointing a chief restructuring officer, who "will be mandated to test these options with the ratings agencies to establish what impact each will have on the fiscus and recommend the appropriate one for implementation".

Rupert 'trying to distort history on Biko'- PAC

JOHANNEBSURG - Billionaire businessman Johann Rupert has ruffled more feathers by claiming that he had developed a "relationship" with Steve Biko, founder of the Black Consciousness Movement in South Africa, who died while being held in detention by the apartheid police in 1977.

The Pan Africanist Congress (PAC) on Monday said Biko never even met Rupert and they have records of the Struggle icon, which will back this up.

The apparent meeting is contained in a book, The Stellenbosch Mafia: Inside the Billionaires' Club by Pieter du Toit. In a review by Du Toit himself, Rupert allegedly met Biko in 1970, while he was in Stellenbosch during a South African Students' Organisation (Saso) conference. He claimed that he struck up a "relationship" with the black consciousness leader, who died on September 12, 1977, after being assaulted by police in a holding cell,



in Port Elizabeth. "Biko was in Stellenbosch to attend a conference of the Saso. We met one day and we continued talking until very late. I told him that if I were a black man, I would also be a Pan Africanist, I would also be a member of the PAC, not the ANC. We agreed that there could be no peace in the country unless there was a deal between white nationalists and black nationalists," reads an excerpt from the book quoting Rupert. Rupert's claim

has angered the PAC, which has accused him of trying "to distort and rewrite history".

Speaking to Independent Media on Monday, the party's president Narius Moloto angrily said they have no records of such a meeting, especially as this would have been a high-profile meeting and would have been recorded in Biko's diary or in the internal history annals of the PAC.

Pupils offered counselling after pastor says gay people are 'going to hell'

WESTERN CAPE - Counselling has been offered to pupils after a pastor invited to speak at a high school in Cape Town allegedly likened members of the LGBTI+ community to paedophiles who were going to hell.

The pastor allegedly told pupils affiliated to the school's Christian student body that there was "no place in heaven" for gay people, and that youngsters who had sex before marriage were prostitutes.

Details about what was allegedly relayed by the pastor were revealed in an email read out on Cape Talk radio yesterday. He also allegedly offended pupils by describing sangomas as "devils and witches".

Western Cape education department director of communication Bronagh Hammond said the pastor's comments about the LGBTI+ community and sex had been reported "to the principal as well as our district office".

"We have offered support and coun-

selling for those learners," she added. She said the department was not aware of a second visit by the pastor during which he allegedly described sangomas as witches.

"There is a lot of hurt and anxiety around this but we just hope that the school uses this as an opportunity to just showcase what intolerance can do, and what hatred can come out of intolerance," said Hammond.

Explaining the department's policy on religion in schools, she said people were allowed to have freedom of expression, but at the same time principals were warned to be cautious when dealing with controversial topics that could hurt people's feelings.

She said pupils had the right not to partake in religious activities, should they not wish to.

The school principal was in a staff meeting when Cape Talk tried to contact him early yesterday.

MOYANE WILLING TO TESTIFY IN COURT ON SARS'ROGUE UNIT'

JOHANNESBURG - The former commissioner of the South African Revenue Service (SARS), Tom Moyane, through his legal representative, said he is willing to testify in court if required to do so in order to prove the existence of the controversial Sars rogue unit.

Moyane's lawyer, Eric Mabuza, said should a court subpoena his long-term and high-profile client to enlighten it on the contentious matter, he can do so with ease as no one defies a court instruction.

"Of course he can testify if he is subpoenaed by the courts to do so. That is obvious as when subpoenaed you have to come to court and give evidence," Mabuza said on behalf of his client when asked by Independent Media whether he can make the claims under oath.

But the lawyer could not answer questions of what Moyane thinks of the decision by public enterprises minister, Pravin Gordhan, to challenge the findings which includes the unit by Public Protector Busisiwe Mkhwebane when considering the fact he (Moyane) insists that the unit existed.

The findings of Mkhwebane on the rogue unit matter were challenged yesterday morning by Gordhan in the Gauteng High Court in Pretoria. Last week, the top Sars



official, who was fired by President Cyril Ramaphosa in November last year, claimed that he is in fact the one who opened the criminal case against the unit obtaining a legal opinion. He said he got to know the matter through two former employees of Sars, who told his during a recorded meeting of the many illegal activities of the unit which included bugging the offices of the National Prosecuting Authority and the SAPS. He said among the spying equipment the unit brought were surveillance

cameras, audio recorders and cellphone jammers, which are used to disrupt communication between the phone and the cellphone network station effectively disabling mobile phones within the range of the jammer, preventing them from receiving signals and from transmitting them. "I opened a case with the Brooklyn police station in May 2015 and the two employees also handed themselves over to the police and confessed.

SHIVAMBU DENIES 'COSY RELATIONSHIP' WITH RUPERT

JOHANNESBURG - EFF deputy president Floyd Shivambu denied having a relationship with one of South Africa's richest men, Johann Rupert.

This denial comes after claims made in a book by journalist Pieter du Toit that the relationship between the two was "cosy".

The book, Stellenbosch Mafia: Inside the Billionaire's Club, details how the wealthiest people in the country make their money, and how they use their power and influence to get what they want.

The book alleges that the EFF is "financially supported" by Rupert and his friends, and details an apparent meeting between Shivambu and Rupert at Tokara wine estate in the Western Cape to allegedly secure funding for a hospital in Limpopo.

Du Toit also suggests that Shivambu provided Rupert with private political information, including the likelihood of a Cyril Ramaphosa victory during the 2017 ANC leadership battle.

Taking to social media, Shivambu denied the claims, stating that he had never asked for organisational or personal assistance from the businessman

He added that "white monopoly capital" remained a "primary enemy in the war for freedom".

Shivambu also released WhatsApp text messages, allegedly between him and Du Toit, in which he declined to comment on the "illusionary relationship" with Rupert.

The EFF also issued a statement, saying that in 2017 it had noted reports suggesting Shivambu had a "cosy relationship" with Rupert and had been asked by an association to assist it with obtaining funding to build a hospital.

The party said Shivambu then wrote to Mediclinic, in which Rupert has business interests, to organise a meeting with their representatives, including board members of Mediclinic

and Remgro.

In February 2018, after a state of the nation (Sona) debate in which he told President Cyril Ramaphosa that "white monopoly capitalists" excitement at his election was cause for concern, Shivambu received a text message via SIGNAL messenger from Rupert.

According to EFF national spokesperson Mbuyiseni Ndlozi, the message contained a video clip that showed Shivhambu saying "white monopoly capital is too comfortable with the president and he should be worried that the likes of Stephen Koseff, Brian Joffe and the Ruperts are happy with him". "The text message underneath the video clip sent on February 20 2018, by Johann Rupert read as follows: 'I have not looted anything and am very disappointed in you for this BS. Thought you were more honourable and intelligent than this. Goodbye and good luck."

According to Ndlozi, Shivambu replied, saying: "You need to surround yourself with people who understand political dynamics and articulations." *Timeslive*

'Give expensive cars to the police - not to politicians'

CAPE TOWN - If DA leader Mmusi Maimane had his way, luxury cars would be taken away from ministers and be given to the police.

Maimane told the Bonteheuwel community in Cape Town on Monday that metro police needed the "German cars", not politicians.

He unpacked his party's crime-fighting strategy alongside DA provincial leader Bonginkosi Madikizela and Albert Fritz, the MEC for community safety. Maimane told a group of metro police officers who paraded outside civic centre: "You are the ones who need the fancy cars, not the executives. So my fight will continue that the German vehicles that chase criminals will be given to this force and not be given to politicians."

Maimane lamented violent crime across the country and that gangsters had taken siege of communities on the Cape Flats. He also called for a provincial police force and for an urgent solution to police understaffing, among other issues.

"Across the country, too many people have been killed," said Maimane.

"We cannot continue to live in a world where gangs are attacking our communities, drugs are ravaging our young people and, ultimately, we are ending up in situations where the future of our nation is being compromised by those who commit such heinous crimes."



NEW YORK - Two Louisiana policemen were fired on Monday over an incendiary Facebook post

The officer's Facebook post fol-

lowed criticism that the president's incendiary rhetoric, which continued on Monday with a new tweet about the four 'very racist' and 'not very smart' Democratic congresswomen. was bordering on incitement to violence. "This vile idiot needs a round.....and I don't mean the kind she used to serve," Charlie Rispoli, of the Gretna police department, wrote of former bartender Ocasio-Cortez.

He was writing in response to a news article published by a self-styled 'satirical' website which falsely claimed the lawmaker had said American soldiers were paid too much. Following an investigation. Gretna police chief Arthur Lawson fired Rispoli - as well as fellow officer Angelo Varisco, who 'liked' Rispoli's post. "Both of these officers we consider have violated our policies regarding social media," Lawson said at a press conference posted online. "This incident, we feel, has been an embarrassment to our department. These officers have certainly acted in a manner which was unprofessional," he said.

"Alluding to a violent act to be conducted against a sitting congressman. a member of our government - we're not going to tolerate that."

Over the past week Trump has tweeted multiple attacks on Ocasio-Cortez and fellow first-term, ethnic minority lawmakers Rashida Tlaib, Ilhan Omar and Ayanna Pressley. AFP

What would it take for US Congress to impeach Trump? WASHINGTON - A dark cloud of impeachment has threatened President Donald Trump for many months, with Democrats in the US House of Representatives, where any such effort to remove him from office would begin, divided about whether to proceed. In American politics, few procedures are as arduous or as divisive as the Constitution's carefully balanced law

No president has ever been removed as a direct result of it. One, President Richard Nixon, resigned before he could be removed. Two, presidents Andrew Johnson and Bill Clinton, were impeached by the House, but not convicted by the Senate. Since he took office in January 2017, Trump has been under investigation. A turning point came in mid-April with the release of a redacted version of a long-awaited report from former US Special Counsel Robert Mueller. Today, Mueller will testify before two House committees about his report, with Democrats planning to focus the proceedings on Trump's conduct. The strategy, described by Democratic congressional aides, is intended to build support among Americans for Democrats' investigative agenda, possibly leading to impeachment proceedings. Reuters

Abuses in Philippine youth homes worse than prison

PHILIPPINE -Eleven-year-old Jerry's crime was breaking curfew laws after fleeing violence at

His punishment? Being sent to a youth detention centre, where he says he endured sexual abuse.

Officially called 'Houses of Hope', proponents in the Philippines say such facilities are places for reformation and education, but critics slam many of them as 'hellholes' where children are treated like caged animals.

Rights' groups say Jerry should never have been detained under current laws, but warn a proposed bill to lower the age of criminal responsibility from 15 to 12, will mean thousands more children will be sent to overcrowded and underfunded centres - leaving them vulnerable to mistreatment.

"I felt so dirty. That was the first time it happened to me," Jerry told AFP as he recalled the night he was pulled from his bed, forced to the bathroom and attacked by older boys also held at a decaying centre in Manila. "I cannot forget the sexual abuse," he explained, adding that he left home to escape beatings from his father and ended up sleeping on the streets. His mother works in Kuwait.

Under existing law, Houses of Hope are primarily to hold young offenders aged 15 to 18. AFP

SYDNEY - Several inmates were stabbed during a riot at an Australian juvenile detention centre that ended after 21 hours with 20 arrests, police said on Monday. The song is basically a soulful catchy beat, with an encouraging message laced with the unmistakable Neo Soul character of Symphony's music.





MADRID - Progress on Gareth Bale's deal to China is slow and problematic.

Zinedine Zidane's hint on Saturday night in Houston that the player could be gone in 24-hours looks to have been wishful thinking on his part.

This should have been the perfect match: Bale and Zidane are two players with a very similar knack of scoring goals - often sensational ones in big finals.

Instead they are at war at Madrid and if Bale's move to China comes to nothing the Santiago Bernabeu is unlikely to be a big enough town for the both of them going into the new season.

Zidane came out all guns blazing on Saturday night telling media that the sooner Bale left the better. Jonathan Barnett responded by calling the coach a disgrace.

Just 48-hours later Zidane bizarrely remembered something he had forgotten in his previous media appearance - that, in his words: 'The other day Gareth did not get changed because he didn't want to, because he said he the club was working on his departure so he didn't get changed

'Disrespected' Bale is determined to see out his contract in Madrid but Zidane wants him out - and Pogba in - at all costs... so just who is in the right in the spectacular fallout that's ripping Real apart?

because of that.'

So did Bale choose to sit in the stands or did Zidane not want him to play? 'Both' seems a likely answer with the former decision following latter. Sportsmail unpacks why both men believe they are right.

The case for Bale

Respect means a lot in football. There are unwritten rules and one concerns coaches calling out players in-front of the world's media. Zidane broke those rules on Saturday when he admitted he wanted shot of Bale as soon as possible.

Bale's camp was furious and the club president Florentino Perez was not too happy either because every battle in this conflict seems to send Bale's price down even more. As it is, Madrid are now faced with the prospect of losing Bale on what Chinese clubs hands tied by tax laws.

This is not the first time Bale - a player who played a large part in at least three of Real Madrid's four Champions League successes in the last six seasons - has not been shown the respect he deserves.

He was hooked at half time by Zidane last season against Juventus in the Champions League. He was also dropped for a game against Paris Saint-Germain, and all this just months after winning the competition almost single-handedly with those two long range strikes in Kiev.

Zidane told Bale he had no future at the club in a head-to-head meeting in June but his contract says otherwise. The French coach can't overwrite a deal in which it is agreed Bale will receive €17m (£15.2m) net a season until 2022, just because he wants to make changes.

Billiat has reportedly received a massive offer from the cash-rich side following some stand-out individual displays for his country at the Africa Cup of Nations in Egypt.


North African giants Al Ahly and Wydad Casablanca are also said to have the 28-year-old forward on their radar.

about his players suffering burnout because of the fixture schedule.



Zuma criticises Bafana players

JOHANNESBURG - Former Bafana Bafana striker Sibusiso Zuma has not shied away from pointing towards the current crop of players for the team's AFCON shortcom-

While many have laid into various parties for the manner in which Bafana's Africa Cup of Nations campaign unravelled, some criticism has now gone towards the players.

Bafana were eliminated from the tournament after a late lapse of concentration saw them lose 2-1 to Nigeria in their quarterfinal showdown earlier this month.

Their brightest moment was undoubtedly upsetting hosts Egypt and Liverpool star Mohamed Salah with a stunning 1-0 victory in the Round of 16.

But majority of their performances were heavily criticised, including the decisions of head coach Stuart Baxter, whose head has been called for by many South Africans.

Zuma, however, felt the players should have given more for the national jersey as he pointed to the inconsistency of the team as a whole.

"Performance-wise, I thought it was bad. But then again, you know with Bafana it's always confusing because they're going to give you one half of good football," 'Rhee' tells KickOff.com. "So, you can't say everything was all bad, but when looking at the games, I still believe they should have beaten Ivory Coast. "The game against Nigeria, I still believe they should have won that game, so really it was not a good tournament [overall]. "Our team always shows improvement because we have those individuals [who step up], but as a team we didn't do well."

The 44-year-old, who amassed over 60 Bafana caps, also refused to cast the blame on Baxter, insisting that the coach is not in control of the players doing the work on the pitch. By that time, it had been some decades since the then dominant Mbabane Highlanders had put the beautiful kingdom on the map in reaching the quarter final of the African Cup Winners Cup (now Confederations Cup), where they were ousted by the feared Egyptian giants Zamalek FC, albeit under a different format. This and many other achievements gives us the glimmer of hope that this tiny Kingdom of Eswatini has the potential of reach-

ing greater heights in international football, only if we do the right things at the right time in as far as development is concerned. GOOD day my beloved sports people. Today I will be discussing sudden cardiac arrest.

Sudden Cardiac Arrest (SCA) is the leading cause of sudden death in footballers in the field-of-play. It is typically the result of an undiagnosed structural or electrical cardiovascular disease.

Causes

There are a range of conditions which can cause SCA arrest in athletes. In general terms, the most common cause of SCA in football players is hypertrophic cardiomyopathy. In athletes over the age of 35 years, however, the most common cause is due to coronary artery dis-

Hypertrophic cardiomyopathy (HCM)- is a genetically determined heart muscle disease caused by mutations in one of several sarcomere genes which encode components of the contractile apparatus.

Coronary artery anomalies- second leading cause of SCA - usually due to an abnormal origin of the left coronary artery arising from the right sinus of Valsalva.

Arrhythmogenic right ventricular cardiomyopathy- is characterised by a progressive fibro-fatty replacement of the ventricular myocardium causing wall thinning and dilatation.

SUDDEN CARDIAC ARREST



Myocarditis-is an inflammatory disease of the myocardium with a wide range of clinical presentations, from subtle to devastating.

Ion channel disorders- such as long OT syndrome, short QT syndrome, Brugada syndrome, Wolff-Parkinson-White syndrome, and catecholaminergic polymorphic ventricular tachycardia are primary electrical diseases of the heart predisposing to lethal ventricular arrhythmias.

Screening and prevention

History and Physical Examination-Most players with unknown cardiac disease are asymptomatic. In fact, 60-80 per cent of players who develop SCA have no previous symptoms. warning symptoms including syncope or chest pain with exertion, unexplained seizure, and excessive shortness of breath or fatigue with exercise. A family history of a genetic heart condition or premature death in relatives < age 50 years of age. A physical examination focused on

the detection of murmurs and the physical stigmata of Marfan's syndrome.

ECG screening- An ECG should be undertaken on all players at the beginning of their playing career and then once every year.

Echocardiography And Other Investigations- It should be considered at least once in a player's early career to better detect structural disorders not routinely identified by ECG. An exercise ECG test should be considered in athletes older than 35 years of age to screen for ischemic coronary artery disease.

Recognition

Non-contact collapse- Any player, who collapses on the field of play without having had any contact with another player or the moving ball, is to be regarded as SCA with immediate response onto the field of play and activation of the emergency medical plan. The healthcare professionals should enter the field of play immediately and not wait to be invited by the referee.

Unresponsive- The non-contact collapsed player will be totally unresponsive to any verbal or painful stimuli.

Breathing- The athlete may still be breathing. Normal breathing generally will deteriorate into gasping and/or slow agonal respirations. This should not be interpreted as normal breathing. Start CPR and AED use immediately.

Response

Evaluation and CPR

Chest compressions should be started immediately and continued until the AED is correctly applied and ready to analyze the cardiac rhythm. Interruptions in chest compressions should be minimized both before and after defibrilla-

Automatic External Defibrillator (AED)

Application and use of the AED when necessary as prompted by the AED because players will usually be in ventricular fibrillation.

Activation

Activation of the EMS or summoning the ambulance onto the field of play. Ambulance staff should be alerted immediately.

Transport

Plans to transfer the player from the field of play to the nearest hospital. Lastly have a productive and fruitful week, God bless you all.


Each of them walked away with a trophy and gold medals for their efforts.





Shongwe said a number of clubs had not been practising fair play even after being asked not to do so by former HRFA Chairman Brilliant Motsa during the 2017 AGM.


"Our former chairman made a plea with clubs to let the spirit of fair play flow within each member of the HRFA. It seems his plea fell on deaf ears as the 2018/19 season saw a lot of clubs hauled before the Eswatini Football Association (EFA) Disciplinary Committee (DC)," he said. Offences included violence during matches and forgery of registration cards, which was a major problem. Shongwe said after realising the depth of the problem following a series of complaints forwarded to the office, the executive saw it fit to form the code of ethics.

"After a lot of soul-searching the executive members discovered that the general level of ethics has gone to almost zero. In that regard, we proposed the introduction of the Code of Ethics which will act as a guide and deterrent to future offenders," he said.

In closing, the chairman reminded the affiliates that it was their shared responsibility to ensure the HRFA acts ethically and honestly.

"Under these codes anyone and everyone is expected to report any violation of the law or regulations,
