

RAMAPHOSA HEREMARCH3

SOUTH Africa's fifth democratically elected President Cyril Ramaphosa is expected to jet into the country on March 3 for a brief visit.

Ramaphosa is the president of the Africa National Congress (ANC), the ruling party in the neighbouring country. Although it is not confirmed yet, Ramaphosa, who will be coming into the country for the first time since he became president of South Africa after the resignation of then president Jacob Zuma in February 2018, will have a brief visit to the country to meet His Majesty King Mswati III, among other things.

Ministry of Foreign Affairs and International Cooperation Principal Secretary Joel Nhleko said Ramaphosa's visit was not yet confirmed, but did not dispute the news when sought for comment yesterday.

"As soon as it is confirmed, you will be notified,"

he said briefly. Highly-placed sources in South African media confirmed March 3, as per presidential schedules, this being easily accessible information in the neighbouring country.

The South African president recently met with Prime Minister Ambrose Mandvulo Dlamini at the 32nd African Union Summit, which kicked off on February 10, 2019 at Addis Ababa in Ethiopia.

'USE OF MUTI IN CHURCHES ON THE RISE'

THE use of muti and other forms of hipnosis is reportedly gaining momentum in many churches.

As a result, a certain level of enmity amongst some church leaders fighting for membership is said to be prevalent. This was revealed during the Lubombo regional prayer service, which was held at Matsetsa School for the Deaf last Friday. The prayer service was attended by leaders of communities and Christians from various denominations.

Simunye-based FEA Pastor Themba Malangwane led the main sermon of the day. As per norm, Malangwane

based his sermon on the scriptures, reading from the Book of 2 Samuel chapter 14. It was during this sermon that Malangwane expressed his concern about the rampant use of muti and evil spirits by some church leaders who would perform magic under the guise

Malangwane said it was evident that Christians were steadily being led astray by individuals who have refashioned the Gospel and centred it on money. "We cannot run away from the fact that some church leaders get their powers from witch-doctors. This is something which is steadily shaming the Church, and Christians have a duty to pray that such things come to an end," said Pastor Malangwane. The long-serving pastor said it was now an open secret that some individuals established churches solely for the purpose of generating money through offerings.

Malangwane further expressed his concern on church leaders who constantly make headlines in the media for all the wrong reasons. He said for instance, the Christian fraternity felt ashamed each time a pastor would be reported to have been arrested for breaking the law.Malangwane implored Christians to utilise gatherings such as regional prayers to pray fervently against all the ills which were out to tarnish the image of the Christian faith. Meanwhile, the gathering prayed for a number of things which were listed as factors affecting the region. 'English as a passing subject worrisome'

THE argument whether or not English language should be a passing subject in the country's schools will be a thing of the past, as this status quo shall soon be removed, according to Minister of Education Lady Howard Mabuza.

She was interviewed by this publication following complaints from private and government schools that the English language has been a stumbling block to academic progress. One of the complaints came from Ka-Shali PRO Learning High School management and directors, urging the minister of education to reconsider removing English as a passing subject. "We note with sadness the continued use of English Language as a stumbling block to the academic progress of many pupils. It is indeed an embracement that after 50 years of independence, we still have the former colonial language as an entry requirement in institutions of higher learning. This extends to even in courses which have nothing to do with the mastery of the English Language

The PRO Learning management went on to urge the ministry and other relevant stakeholders to put the interest of the country first and remove the unnecessary barrier with immediate effect. Minister Mabuza said the ministry was working towards the removal of English as a passing subject in response to many complaints. "It's true that English has destroyed the careers of many pupils. Some of them have decided to kill themselves, after failing, due to the mentioned subject," she said. The minister said, currently, the ministry was discussing with all the stakeholders involved regarding this iss-

"But I can assure you that the outcome will be positive, more especially because in the past the ministry also deliberated on it." She said the subject might soon apply to other courses using English as a medium and pleaded for patience to all concerned, while the ministry is working on finer details with all the relevant stakeholders.

4000 unqualified teachers

AFRICAN Committee of Experts on the Rights and Welfare of the Child (ACERWC), has been informed that there are over 4 000 unqualified teachers in the education sys-

In addition, the number of teachers is not adequate for the implementation of free primary education programme.

The committee also wants to know the teacher-to-pupil ratio in primary and secondary schools, and whether or not the teachers are capable to deliver quality education.

The committee was informed that even though free primary educationis guaranteed in the constitution, topup fees are required by a majority of public schools, thus excluding children who are economically disadvantaged, orphaned and those who are in vulnerable situations.

The committee was also informed

that measures taken by the government to remedy the challenge are not adequate, such as grants to schools to support orphaned and vulnerable children. The committee would like to know measures taken to ensure effective implementation of free primary education and the current enrolment rate of children in primary schools. Also, the committee wants to know whether or not the Free Primary Education Act makes primary education compulsory.

In a report submitted in 2017 about the Implementation of the African Charter on the Rights and Welfare of the Child, the government of Eswatini notified the African Union of the measures taken by the country in promoting child welfare.

In response, the Commission of the African Union forwarded a document containing observations made from the report and sought clarifications on a number of issues identified in the report on the Implementation of the African Charter on the Rights and welfare of the Child.

Last week Thursday and Friday, the deputy prime minister's office together with different ministerial representatives, attended a consultative meeting at The George Hotel in Manzini on comments regarding state party issues raised by the African ACER-WC. The committee expects to receive the answers to the list of issues raised by Thursday.

The committee also invited the Kingdom of Eswatini to designate and send high level representatives to discuss the report with the committee on March 20 at the AUC headquarters in Ethiopia, Addis Ababa.

Sexual exploitation cases in wrong cop shop

THE committee also stated that they were informed that child victims of sexual violence are taken to facilities that house police officers.

Also that cultural law is used to address sexual violence cases against children and not the Dutch-Roman law. Furthermore, children with disabilities are kept in chicken sheds when they report cases of sexual violence. The committee wished to know if this information is accurate.

On the issue of taking child victims to facilities that house police officers, the response was that this information is not true. There are no sexual violence survivors (children) that are housed at police hous-

On the issue of cultural law, the response was that this information is also not true.

Firstly, in Eswatini, there is no cultural law, but rather Swazi Law and Custom. Before the introduction of the Sexual Offences and Domestic Violence Act (SODV), all cases that are of a sexual nature are handled using the Roman-Dutch Law, but now the country uses the SODV as well as well as the CPWA. No cases of sexual nature were ever dealt with using the Swazi Law and Custom.

Furthermore, sexual offences are governed by statutes and these are not dealt with culturally. If a case is of a sexual nature, the police are immediately informed.

On the issue of children with disabilities kept in chicken sheds, the response was that this information is not true.

Another issue raised was that the committee would like to get information on measures taken to hold perpetrators of sexual exploitation of children accountable.

The response was that offenders are arrested, prosecuted, convicted and sentenced without the option

Also under sexual exploitation, the committee stated that they were informed that one in three females experience some form of sexual violence by the time they are 18, and one in five females experience coerced sex before 18. The committee would like to know if this information is correct; if so the measures that are being taken by the state party to prevent gender based violence and exploitation, to hold perpetrators accountable, to ensure accessibility and availability of legal services and to provide psychosocial support to children affected by sexual exploita-

The response was that statistically, it is true according to the 2007 national study on violence against women and girls.

Measures being taken by the state are that the country has legal instruments such as SODV and the People Trafficking and People Smuggling Prohibiting Act. Also, there is an ongoing process of community sensitisation and public awareness, especially girls on date rape, thus preventing gender based violence and exploitation.

bestowed upon me by the country's authorities with diligence as God is on my side," said Dlamini.


The PM said those who trusted in God never fail. He was without doubt that even the challenges the country is facing, in particular the ailing economy, would be overcome through belief in God.



ANINCREASEOF 27.5% OF VIOLENCE & ABUSE CASES

A review of statistics relationg to abuse recorded between 2017 and 2018, illustrates that there seems to be on upward trend.

This was revealed by REP Senior Deputy Commissioner Lydia Dlamini at the One Billion Rising campaign held at Mafutseni Inkhundla last Saturday.

Dlamini said as REPS they were immensely pleased to join the various stakeholder categories present at the event. She added that it gratified the police agency to see such a large number of diverse stakeholders from the Mafutseni community and the nation at large in attendance to support what she themed a very important campaign.

Abusing

"The matter of abusing women and children has escalated from simply being a matter of crime, now it is a social crisis that pinpoints to a serious fracture of our society's moral fabric," added Dlamini.

Dlamini stated that the willy-nilly sexual and physical abuse of women and children witnessed in the country indicates that there is a decay of the standards of morality in society. There is a need to identify the root cause of the problem, so as to restore the virtues of "buntfu" that should ordinarily be a characteristic feature of Eswatini as a nation.

A review of statistics of cases of abuse indicates that abuse of women and children is on the rise. Illustrating this is that

THE Royal Eswatini Police Service (REP) has prioritised the investigation of cases of abuse.

The police service has also strengthened the capacity of officers to tackle such matters with speed and pro-

Speaking at the One Billion Rising Campaign held at Mafutseni last Saturday, REPS Senior Deputy National Commissioner Lydia Dlamini said the police service had set up a dedicated communication and advocacy task force which is already conducting an intensive communication and public Women and Law In Southern Africa Research and Educational Trust **VIOLENCE MUST** STOP: Senior Deputy National Commissionel Lydia Diamini makes a presentation on the prevalence of violence against women and children in the country.

in 2018, there was a total of 3 964 cases of violence and abuse recorded compared to 2017, where 3 108 cases were recorded. This translates to an increase of 27.5

Dlamini said rape, in particular, appears to be gaining momentum as 517 cases were recorded in 2018 compared to 442 cases recorded in 2017. She added that of note, in 2018, 284 reported cases of rape involved girls below the age of 17, including children below the age of five years. In 2017, there were 237 reported cases involving young girls.

With regard to intimate partner killings, a total of 33 women were murdered in 2018 versus 30 women murdered in 2017. She added that this was very sobering as any loss of life as a consequence of crime is one loss too many.

One Billion movement in its 6th year

THIS year, the One Billion movement is on its sixth year.

One Billion Rising is a global movement founded by American playwright, performer, feminist and activist Eve Ensler to end rape and sexual violence against women. It was started in 2012 as part of the V-Day movement.

The billion refers to the United Nations statistics that one in three women will be raped or beaten in her lifetime. The campaign expands each year and this year's theme is 'Rising from a campaign to a wayof

Last Saturday, scores of women convened at Mafutseni Inkhundla to attend the One Billion rising campaign. Women and Law Southern Africa (WLSA) National Director Colani Hlatjwako said in Eswatini, the movement started in 2013 and is now in its sixth year.

She stated that every February, there are gatherings all over the world to raise awareness on issues of gender-based violence.

Hlatiwako added that these issues should be talked about on a daily basis, as violence against women and children remained a concern, not only in the country but the world at large.

She stated that everyone should be involved.

The director appreciated the attendance at this year's event, as it showed that Emaswati were willing to stop women abuse. She also thanked the Mafutseni community for putting trust in a woman, as they elected a woman to represent them as a member of parliament (MP).

Former MP and businesswomen Nonhlanhla Dlamini said there were a number of challenges faced by women on a daily basis and these issues should involve everyone, including men.

Dlamini said women in the country wanted to thank the Eswatini Government for enacting the Sexual

Offences and Domestic Violence Act of 2018, and stated that the act will go a long way in addressing issues of abuse against women in the country.

Women have a number of issues that they needed the relevant parties to address. One of the issues she said women needed to be addressed was that of the top up fees in schools. She said as women, they were pleading with government to standardise the top up fees in the schools, as some schools charge higher fees compared to others.


On another note, Dlamini said even though the country's Constitution is open in terms of women wearing widow gowns (tinzilo) in mourning their dead husbands, in some communities women are still forced to wear the gowns, while men are not forced.

Skills

She said government should improve life skills (emakhono) and they should be incorporated into the schools' curriculum as not all pupils are able to enrol in tertiary institutions. She added that the skills would come in handy for those who do not do well in school as they will be able to utilise the skills and earn a living.

On the issue of women's dress code in Parliament, she stated that women were pleading not to be forced to cover their heads in Parliament, as they viewed this as moving backwards instead of forward and depriving women of their freedom of expression.

Dlamini also aluded that there is still a need for more women in Parliament and said they as women appreciated the inclusion of the four regional women MPs as it shows that the country is moving in the right direction. On the issue of business registration, she said aspiring businesswomen were deterred from registering their businesses, as the registration fees are too high. Also the SRA tax was too high.

education drive to sensitise and conscientise the nation through the mass media on issues relating to the abuse of women and children.

She added that whilst they acknowledge the challenge those cases of this nature occurred in intimately private places, they have nonetheless further increased target visibility policing in areas where crimes such as rape are becoming a frequent occurrence.

Dlamini also stated that as REP they continue staging crime prevention campaigns and hold dialogues with relevant stakeholders to up the ante of awareness and also seek shared pragmatic solutions to end the scourge of violence and abuse against women and children. She also took the opportunity to extend her gratitude as a police service to the relevant structures for the promulgation into law the Sexual

Offences and Domestic Violence Act be made to face the wrath of the law of 2018. She said the act is enabling the police service and is a comprehensive legal framework for the protection of vulnerable categories from domestic violence and sexual assault.

Dlamini appealed to members of the public to ensure that all cases of sexual abuse occurring in communities should be reported without fail so that the perpetrators can be exposed and

for their misdeeds.

The practice of hiding incidents under the carpet which continues to persist is not the way to go as it adds fuel for further continuation of violence and abuse. There is a need to join hands and put an end to the abuse of women and children as it is evil and ill-portrays the nation to the international community, concluded Dlamini.

THE issue of space and sponsorship challenge saw 4 301 soon-to-be tertiary learners being turned down at Ngwane Teacher's Training College (NTTC) in the 2018/19 financial year


The college admission processes began in January and closed in March 2018. The college offers two programmes, namely Primary Teacher's Diploma (PTD) and Early Childhood Care Education (ECE).

There were 4 109 applicants for PTD and only 250 were admitted, leaving out 3 859 while 550 applied for ECE, with only 108 admitted and 442 left out due to the aforementioned challenges. This is contained in the ministry of education and training annual performance report for the 2018/19 financial year. According to the report, lack of accommodation for both students and staff continues to be a challenge for the college and there is still no construction of additional offices for the academic staff despite the fact that a budget allocation was made both in the 2016/17 and 2017/18 financial years. The lack of office space is a serious challenge, resulting to some staff members having no place to work from. Another challenge that the school

FOLLOWING the transfer, promotion and retirement of officers in the secretariat dating as far back as 2016 at the Teaching Service Commission (TSC), no officer has been appointed to fill these vacant positions.

The five vacancies are two principal human resources officers, one human resource officer, one assistant accountant and the executive secretary. The vacant posts were listed under challenges at the commission as the report states that they are all very critical positions.

The report revealed that it takes a long time for the appointing authorities to fill vacated or ...due to space and sponsorship challenges

There is also a high turn-over in remote schools due to harsh living conditions and lack of accommodation.

The Embassy of Taiwan has been working with the ministry of foreign affairs to find ways to ensure that the International Capacity Development Fund (ICDF) is more helpful to the general population in Eswatini. Priority education and training fields for the country are a necessity to Taiwan government so that they can channel their scholarship programmes to what the country needs and what could almost guarantee that the 370 students hosted by Taiwan can go back to Eswatini and find employment opportunities in their fields of study. For the period under review, through the programmes sponsored by the government of the Republic of China (Taiwan), the embassy has received about 26 officials from Eswatini who attend short term training in areas such as workshop in agriculture and workshop in urban waste management, to mention but only a few.

The report showed an increase in the number of scholarships offered to local public servants which have also been realised from close ties with India and Thailand. The ministry of foreign affairs, through its bilateral ties with France, was able to enroll 15 officers for French lessons at the Alliance Francoise in Mbabane. The report indicated that collaborations with academic institutions in Netherlands have resulted in interesting and potentially viable collaborative programmes in education services. The country has also managed to foster relationship ties with Netherlands University and Research Centre.

BACK TO THE CROSS STARTS TONIGHT





First, was Duduzile Mkhwanazi (61) of Macobolwane who was arrested on Saturday for driving while under the influence of alco-

Breadwinner

She pleaded for leniency and stated that she is a breadwinner who takes care of her grandchildren and some of her children.

"Ngicela inkantolo idle itishiyele, angeke ngiphindze," she concluded. She was sentenced to two years in prison with an option of a fine



E2 000 bail for 'not guilty' driver

A 30-year-old man told the court that he was not guilty of the crime of drinkdriving during his court appearance vesterday morning.

Bongani Ngwenya (30) of Mankayane was arrested yesterday in the early hours on the day at Mankayane after allegedly driving while under the influence of

When subjected to a breathalyser test, his alcohol content was 0.79mg/l.

Fiddling

He told the court that police officers found him at a parking lot with friends and he was on the driver's seat fiddling with the sound system when he was arrested.

When the prosecution applied that he be remanded into police custody, the accused also applied for bail which was granted at E2 000.

He is set to return to court on Friday.

E2 500 fine for highly intoxicated driver

A 37-year-old man from Lobamba, Nkhanini area, was the only one with a high alcohol content reading, so was his fine.

Phillip Mdluli was arrested yesterday morning at Lobamba along D38 public road.

When a breathalyser test was conducted on him, it read 1.25mg/l.

He was charged with contravening Section 91 of the Traffic Act.

During mitigation, he did not say much as he seemed to be still intoxicated.

"I don't have any other offences, I plead for leniency," he said.

He was sentenced to two years in prison with an option of a fine of E2 500.

Another highly intoxicated driver was Sandile Willis Dlamini, a 38-year-old man of Lobamba. He was arrested on Saturday for driving under the influence of alcohol and his alcohol content was 0.94mg/l.

Leniency

He pleaded for leniency and told the court that it was a mistake.

"Lidlojwe libhekile Nkhosi yenkantolo, ngiyacolisa kakhulu, bengicala ngigcina, "he said. He told the court that he is a father of five and has an extra five individuals who depend on him as well.

He was sentenced to two years in prison with an option of a fine of E2 000.

Lastly, was Ncamiso Tsabedze, a 30-yearold man from Mankayane who was arrested on Saturday at Makholokholo area for driving under the influence of alcohol and when subjected to a breathalyser test, his content was 0.59mg/l.

He pleaded for leniency and told the court that he is the breadwinner and has five dependants. He was sentenced to 15 months in prison with an option of a fine of E1 500.

Cop nabbed, blames wife's death

THE death of a wife supposedly forced a police officer to resort to alcohol.

Zwelithini Mavuso (44) of Ezulwini area appeared before Magistrate Nelisiwe Hlophe yesterday for contravening Section 91(1) as read with Section 122 Act 6 of the Road Traffic Act of 2007.

He was arrested at Ngwane Park (Mathayini) in Manzini driving a motor vehicle registered CSD 502 DM.

A breathalyser test conducted on him read 1.01 mg/l. Upon realising that the accused person was a police officer, the magistrate questioned his irresponsible act.

"I am surprised that you are a person of the law, a police officer, who enforces the law daily. The level of alcohol that was found in you was too high," she said.

Mavuso told the court that he was not a usual alcohol drinker, but circumstances forced him to consider it so as relive him from the stress and confusion after what befell him on Saturday. "I do not drink alcohol Your

Worship, it was my first and last time," he said. The police officer told the court that his wife died on Saturday and left him with eight

children. He added that the chil-

dren were crying non-stop, say-

ing they want their mother. He said most of them were very young to understand the meaning of death.

Mavuso said he was confused because he had been with his wife for 25 years. He claimed that he left his house to clear his mind and regain strength to face his young children.

Mavuso further told the court that he was not supposed to be appearing before the court yesterday because of an agreement that was reached between him and traffic officers.

He said when he was nabbed during the wee hours of yesterday morning, the police told him to park his car and go straight

"They told me to leave my car

with them and fetch it in the morning when sober because I had told them my story. I also believe they saw the state I was in yesterday besides that I was drunk," he said.

Upon arriving at the Manzini Police Station, the police officers told him to get into the police van as he had to appear before court. After he completed mitigating, the magistrate advised the police officer to seek counselling.

"I hear your problem. I understand the stress and confusion that you are in. Losing a loved one is not easy more especially your wife of 25 years, it must be very hard for you. Looking at the amount of alcohol you have consumed yesterday not forgetting that it was your first time, you are likely to head downhill. With that being said you have children that you have to look after, I suggest and urge you go for counselling soonest," she said.

He was found guilty of the charge and sentenced to two years imprisonment with a fine option of E2 000.

Soldier not spared for his love of booze

A member of Umbutfo Eswatini Defence Force (UEDF) was in court yesterday charged with contravening Section 91(1) as read with Section 122 Act 6 of the Road Traffic Act of 2007.

Bonginkosi Kunene (30) was nabbed along MR3 public road in the Manzini region.

He called Magistrate Hlophe 'madam' after he did not hear a question that was posed by the magistrate.

Kunene drove a VW registered OSD 061 AM with a reading of 0.79mg/l which was above the legal limit of 0.38 mg/l.

He pleaded for the court's leniency, saying he fathered three children whose mothers are

not employed.

Hlophe condemned Kunene's act as she suggested that he should start living by example.

Disgrace

"You are a disgrace in the community; you are supposed to lead by example Kunene. What will your children learn from you? You need to start showing that you are a responsible human being like you said before. Right now, I am only seeing an irresponsible person who is putting his life and others in danger by driving drunk," she said.

He was found guilty of the charge and was sentenced to 10 months in a correctional facility with a fine option of E1 500.

Drink a weevil tablet, die alone - offender told

A drink driving offender stunned the court motorists as he sat on the driver's seat drunk. when he said his offence has been blown out of proportion as he was not driving on a public road.

Sibusiso Dlamini was nabbed driving a motor vehicle registered DSD 834 DM while under the influence of alcohol with a recording of 0.84mg/l, which is above the legal limit of 0.38

Exposing

Dlamini told the court he was from fetching his father who is an elderly person from work because it was too late in the evening.

Magistrate Nelisiwe Hlophe asked him if he thought of the danger he was exposing other

Dlamini told the court that he did not expose so many people to danger because he was not driving on a busy road, but on a gravel one.

Remorseful

"I was driving emgwacweni wesintfu not a tarred road so I wasn't exposing so many people to danger," he said.

The court felt Dlamini was not remorseful of his act. The magistrate told him to drink a weevil tablet if he wanted to die. She added that accidents also happened on gravel roads in residential areas.

He was sentenced to 10 months imprisonment with a fine option of E1 500.

Mayor, CEO wanted out of council premises

MBABANE Mayor Zephaniah Nkambule and CEO Gideon Mhlongo are wanted out of Mbabane City Council premises with immediate effect, by Mbabane residents and ratepayers.

This is contained in a petition to be delivered to the council today.

It is addressed to the mayor, councillors and Parliament.

The eight demands listed in the petition are said to be based on allegations that the mayor abused his position by charging their councillors for carrying out their mandate.

Of note, the petition states that the councillors were suspended, and this resulted in the residents having no representation within council.

This they said after reports surfaced that four councillors were recently charged for allegedly refusing to partake in the appraisal of Mhlongo, as they are alleged to have instead asked for his contract, as well as the council minutes which put him in the position of CEO.

"Mhlongo must be removed from council premises because he doesn't have a valid contract. Seven councillors voted for non-renewal of the contract against four, who voted for the renewal of the contract on May 25, 2018. Council must appoint a proper and fit person for the

position of CEO," reads the petition in part.

The residents also alleged that Mhlongo was forcing the local community committee policy to be implemented against a parliamentary resolution.

It is claimed that Mhlongo does not want to uplift the building ban, which has been in place since 1992.

"Mhlongo is selling our houses much against a court order which says they must attach movable items first," reads item five of the petition.

The residents also touched on the CEO's contract, claiming that Mhlongo and Nkambule committed fraud by drawing the town clerk's salary, allegedly without a contract and they quantified this to close to a E1 million after summing up E150 000 said to have been paid to him within the seven months since his con-

tract was renewed.

The residents are further aggrieved by the alleged suspension of councillors, which they say has been unlawfully done as they were elected into office by them as residents.

They called upon Parliament to set up a probe team to look into the council affairs, as they alleged interference by the minister of housing and urban development in the operations of council, especially on the issue of the non-renewal of the contract of employment of the former (incumbent) CEO.

Also, they implored Parliament to investigate the issues surrounding the former employees who were sent home through restructuring and allegedly promised tenders by Mhlongo, but were never awarded. Worth noting is that all these allegations are yet to be tested.

MINISTRY RESPONDS

WHEN reached for comments, Principal Secretary in the Ministry of Housing and Urban Development Clifford Mamba said; "The ministry is charged with overseeing council, so it is amiss to say we are interfering in their business when in fact we are playing a role that is clearly pointed out by the Urban Government Act, which governs council.

"The Act clearly states that the hiring and firing of CEOs is a process that will go through the ministry, therefore you can't say we are interfering when we are exercising a role given to us by the clause in the Act."

Regular suspension of councillors:

"Council in the exercise of its mandate and following its own standing orders will take necessary decisions they deem appropriate when dealing with matters arising in the course of council business.

"The ministry is not aware of council acting outside of its competence as provided for by the aforementioned standing orders.

"The ministry is unaware of the regular suspension of councillors.

LCC approval:

"LCC was approved by us, where there are issues arising consultations with that particular community are not prohibited, they are encouraged.

Commission of Inquiry:

"We have not received any resolution by the ratepayers.

"In any event, the institution of an action by way of inquiry or other action into the activities of a council will be on the basis of the ministry, following its own assessment and being satisfied of the need for that purported or required action."

Mhlongo has a contract - Mayor

MBABANE Mayor Zephaniah Nkambule has said in as far as he is concerned the CEO was in office legitimately, saying such was substantiated by the High Court ruling, which is appealed.

"These matters are in court and it has ruled that Mhlongo has the right to occupy office. You can't put people in the forest, Mhlongo has a contract, look what Judge Mamba said in his judgement, who are we to oppose the courts? "The suspended councillors also ran to court, so I will not comment about their case as well," he said.

Herdsman sells master's cow to butchery owners

A herdsman aged 23, has been arrested with his friend for stealing and killing a cow belonging to his master.

It is said Celucolo Mkhonta, the herdsman and his friend Mangaliso Mbatha (18) stole the cow belonging to Sipho Sikonela at Mahwalala.

The court heard that the two stole the cow in a bid to sell it. Together with the buyers, who supposedly own a butchery in Manzini, dressed the cow, leaving behind its skin which was presented in court as evidence.

Three witnesses appeared before Senior Magistrate Nonhlanhla Dlamini to give an account of what happened.

One was Bonginkhosi Fakudze, who told the court that he was a herdboy for Muzi Fakudze and he knew Mkhonta (the accused) from the mountains, where he herded cattle belonging to Sikonela.

Fakudze said, around December, he took his father's cattle to the mountains as usual and when he returned he found Sikonela's cattle still inside the kraal, with a few gentlemen inside including the accused.

"I asked him what was going on and he said he had been sent by Sikonela and I rushed home to tell my father of what was happening. Together with my father, we went to Sikonela's kraal," he said.

Fakudze added that when they arrived at the kraal, they found the accused

and the others gone, however, they was a cow's skin left behind.

Sikonela was called by Fakudze and they all went to Tophill to search for the people responsible and only managed to capture two men and he identified one of them as Gift, who told them that the accused had told them he was instructed by Sikonela to 'sell'

"Sikonela was present and he said he had no knowledge of what Gift was saying," he continued.

Police

The police were then called to the scene and took the two men to the police station.

The second witness was one Mlungisi Dlamini who was present when the crime was committed and he was allegedly turned state witness, narrated before the court how the accused stole and sold the cow.

He told the court that he was asked by the accused to help him find a person who could buy his family's cows and his father had permitted him to sell the cow.

"He said he would give me E500 if I found a buyer for one cow," he said.

Butchery

He told the court that he was in Manzini when called, and he decided to visit a butchery however, its manager was not around. He went to another one, where he was successful and they were interested in buying the cow.

At first there were disagreements on the amount they wanted to pay for the cow, and he told them that he was heading back to Mbabane, hence he would talk with the owner so they exchanged numbers.

Later on the same day, the buyers called and they agreed that the cow would be sold for E6 000.

The following day, they came to Mahwalala to fetch the cow.

He stated that they met at Engen Filling Station with Cele and another gentleman, and along with the buyers, they headed for Hilltop at Mahwalala.

The accused led them to the kraal where the gentlemen were told to choose a cow and they chose a pregnant one. It was slaughtered instantly

It is said the accused threw away the unborn calf.

He told the buyers that his father was not around to provide his ID for the proper documents to be made, so he allegedly told the buyers that they should leave its kidney behind, which he would take to madibhane.

They all boarded the vehicle driven by the buyers, and along the way the accused asked that they drop him off so he could go home to change. Dlamini proceeded with the buyers to town, where they gave him E2 000 as they had had an agreement that they would pay the said amount on the day and the rest a few days later.

"I then called Cele, and told him the buyer had given me the money and he arrived, then gave me the E500 as per his promise and we parted ways," he continued.

The buyers paid the balance through Mobile Money.

You were an accomplice -Suspect tells witness

DURING cross examination, the suspect incriminated Mlungisi Dlamini.

"Aren't you the one who told me that we should sell one of my family cows because you wanted to fix your car?" he asked.

He further told the court that he only knew that the cow had been sold for E5 000, which made him wonder where the E1 000 had gone to

The accused stated that when the buyer arrived to buy the cow, Dlamini told them that he was the elder brother and was standing in, on behalf of their father, who was not around at the time and the buyers knew that their business transaction was an unlawful one.

Dlamini refuted the accused's claims, saying had he known that the cow was being sold illegally, he would not have involved himself at all.

"Bengingati kutsi kuyagangeka futsi nje bengingeke ngichubeke, watsi wena babe wakho bekakuvumele kutsi utsengiselenkhomo;" he said.

He stated that the accused had sold cows before, which is how they met because he had been asked by one of his friends to transport a cow for him, which he had bought from the accused.

He also disclosed to the court that the accused had told him that his father had permitted him to sell the cattle, because they were trying to raise money to pay an attorney, who would represent his brother, who was behind bars at the time. Trial is set to continue tomorrow.





THE chemical soil stabiliser (probase) project should start in rural areas so as to benefit people living there.

This was an expression made by Members of Parliament (MPs) who are members of the portfolio committee of the ministry of public works and transport. The MPs said this on Wednesday in the Senate during a meeting with the ministry of public works and transport officials.

The MPs, especially those from rural areas, felt the ministry of public works and transport made a poor judgment in allowing this project to benefit people who were in urban areas.

The MPs said it was unfair for the people they represented as they were

given a raw deal in as far as the probase project was concerned.

Maphalaleni MP Mabulala Maseko said it was unfortunate for his constituency not to be included in the first phase of the project.

Constituencies like Lobamba, Maseko said, were prioritised in the project yet there were many tarred roads passing though Lobamba though his constituency had no single stretch of tarred road

Prioritised

Ntfonjeni MP Sompisi Magagula echoed the sentiments of the Maphalaleni MP. He said the people in the rural areas were supposed to be prioritised in this project, especially because it was difficult for them and their goods to be moved.

The least that government could do for them was to make their lives easier by helping them so that their businesses could be boosted. Probase would facilitate the easy movement of goods and rural entrepreneurs.

Mhlume MP Victor Malambe urged the ministry of works to speed up the project and prioritise rural areas. He further told the works ministry that the King was also banking on that project for the country to develop.

Motshane MP Robert Magongo, who is the Chairperson of the ministry of works portfolio committee in the House of Assembly, said he wished that this programme could be stopped. His comment, which amused those those present in the chamber, was sparked by the fact that the probase project was not finished in Mpolonjeni (Mbabane), which is under his constituency. He said this annoyed him and he did not see the need to continue with the project if such a shoddy job would be done.

'Elections should be managed'

THE ministry of finance says spending on elections should be properly managed.


It said no exorbitant amount should be spent on the elections.

Church of England spiritual leader to plead for unity

LONDON - The spiritual leader of the Church of England may lead five days of prayer with other churches after Britain's March 29 exit from the European Union in an attempt to ease Brexit divisions, The Sunday Times reported.

The 2016 Brexit referendum showed a United Kingdom divided about much more than the European Union, and has fueled soul-searching about everything

from secession and immigration to capitalism, empire and modern Britishness.

Under plans discussed by the Church of England, Archbishop of Canterbury Justin Welby wants to pray in public with the leaders of the Catholic, Methodist, Baptist and United Reformed churches on the day after Britain leaves.

"I would hope that it will resonate with the wider nation, that this is the time for turning to something deeper in the human spirit than legal arguments and philosophical discussions, and to seek wisdom from God," a senior Church of England source was quoted as telling the newspaper. With the clock ticking down to March 29, the date set in law for Britain to leave the EU, the United Kingdom is in the deepest political crisis in half a century as it grapples with how, or even whether, to exit the European project it joined in 1973. *Reuters*

Man beats up girlfriend, insults her

A 38-year-old man of Dlangeni has been arrested and charged with contravening the Sexual Offences and Domestic Violence (SODV) Act of 2018.

He appeared before Senior Magistrate Nonhlanhla Dlamini.

Madoda Gama was charged with two counts under the Act after he was arrested on January 31, for beating up his girlfriend Nomvula Matse with open hands on the face and all over her body.

He further insulted her and that injured and impaired her dignity, hence he was charged with contravening Section 77(1) (f) of the Sexual Offences and Domestic Violence Act 15/2018.

Gama pleaded guilty to both counts and told the court that he was drunk when he committed the crimes. He asked for forgiveness and pleaded for leniency from the court, stating that it was a mistake.

He further stated that he was still paying school fees for his children, hence he was hoping the court would be considerate.

He was sentenced to two years in a correctional facility with a fine option of E2 000 for beating Matse and a year in prison with an option of a fine of E1 000 for insulting her.

Sikhatsi wins brawl over land with neighbour

BY BAHLE GAMA High Court

SIKHATSI Dlamini has won a land dispute that was between him and his neighbour at Nkoyoyo. Dlamini had been taken to court by his neighbour Nomsa Rosemary Hlatshwayo for destroying her drive way protection wall at Nkoyoyo.

Hlatshwayo filed an urgent application at the High Court where she stated that on February 20, 2018 after she noticed five men destroying the protection wall using five-pound hammers whilst carrying spades to remove the debris.

She was represented by an attorney from S.S Hlophe Atttorneys while Sikhatsi conducted his own defence in the matter.

The matter appeared before High Court Judge Ticheme Dlamini last Wednesday. The founding affidavit by Hlatshwayo states that she then went to Vusani Dvuba, who is a brother to the chief and reported the matter to him. He advised her not to confront the men. He then called another senior member in the community identified as Gabriel Shiba and asked that he speaks to the five men who disclosed that they were acting on orders of Dlamini.

Hlatshwayo and Dlamini are neighbours at Nkoyoyo under the jurisdiction of Chief Zembe Dvuba and each were allocated a piece of land on Swati Nation Land and were allocated next to each other.

She then filed an application under a certificate of urgency and she inter alia sought that Dlamini be ordered and directed to forthwith re-erect and restore her driveway protection wall that was unlawfully demolished.

She further applied that he paid the costs of the application.

In her founding affidavit, she further stated that when she asked the men to produce a court order that authorised them to demolish the wall, they failed and told her that they were acting on the instructions and orders of Dlamini. Hence they finished demolishing and discarded the debris into a nearby sewer.

In his answering affidavit, Dlamini said Hlatshwayo's protection wall was built on his land. He had been away for two months and when he returned he found that the wall had been constructed right inside his land and it blocked access to his house. He also stated that he did not immediately react but reported to one of the area's authorities by the name of Mangwana Zulu, who at the time did not know who had constructed the wall and when it was inquired no one knew, but, it was suspected that Hlatshwayo had. She was summoned twice but never responded to the summons, which was then that he decided to demolish the wall because he did not know who had constructed it.

He also disclosed that she had lost the land war at their *umphakatsi* in 2010. He further stated that Hlatshwayo's application did not meet the urgency requirements stipulated by Rule 6 (25).

"On the basis of the Rikhotso and Tswelopele (supra) decisions, this court cannot order restoration under the spoliation remedy because the protection wall was destroyed and the debris thereof were thrown into a sewer. The application is accordingly dismissed with costs," reads the last part of the judgment signed by Dlamini," Dlamini said.

FOLLOWING three successful rounds of the deworming campaign, the Kingdom of Eswatini has embarked on a week-long exercise to prepare for a mid-term evaluation of the impact of the intervention on the burden of bilharzia and worms in the kingdom.

Deworming of children in the kingdom was re-introduced in 2016 following the suspension of the exercise in 2009.

The country has been ranked number one out of 49 countries in the African region in scaling up efforts to eliminate bilharzia and worms.

This is based on the campaign reaching nine in 10 of the school aged children in Eswatini. The country has achieved above the minimum recommended level of 75 per cent.

Actions

This has been made possible through collaborative actions between the deputy prime minister's office; ministries of health; education and training; tinkhundla administration and development; World Health Organisation (WHO), UNICEF and other development partners, as well as school communities; parents; learners and members of the media.

WHO, through the Expanded Special Project for Elimination of Neglected Tropical Diseases (ESPEN), is sup-

porting countries, including Eswatini, to scale up interventions to eliminate bilharzia, worms and other Neglected Tropical Diseases (NTDs) including snake bites and rabies as public health problems.

Countries are required to periodically monitor and evaluate the impact of the interventions towards reducing the burden of these diseases through setting up sentinel surveillance sites in schools and conducting impact surveys. Eswatini is due for the mid-term review of the deworming campaigns as well as setting up of the sentinel surveillance

Two experts, Professor Nicholas

Midzi and Dr Maurice Odiere are in the kingdom for a week to assist with the selection of the sentinel schools and developing a protocol for the mid-term review and the impact survey.

Lukhele, the senior medical officer in charge of public health institution in the ministry of health. Dr Lukhele stated that the power to succeed in the elimination of bilharzia and worms in Eswatini lies in the hands of everyone and hopes that everyone continues to rise to the challenge and do their part and together, making a difference and have the two diseases eliminated in our lifetime.

Dr Lukhele further thanked the WHO consultants for providing technical assistance towards this activity, adding that this was indeed the beginning of an important step in the elimination of the diseases. He also recognised the partnership between the ministry of health,

and the ministry of education and training towards improving the health of school children and educational outcomes for sustainable development.

The mid-term review will be conducted in May this year and involves visiting the selected school to test urine and stools from learners for bilharzia and worms. Also of note is that this will be followed by the fourth round of the deworming campaign in June year. The ministry of health looks forward to the cooperation by learners, teachers and parents, as demonstrated in 2015 when the baseline mapping exercise was conducted. These are crucial events towards Eswatini free of bilharzia and worms.



BREAKING SOME BONES: THE PLANS FOR SA'S REFORMATION

LAST Wednesday, before tabling his first budget vote in the National Assembly, Finance Minister Tito Mboweni cut a totally different figure than his immediate predecessors.

In 2017 Pravin Gordhan was under siege and warding off repeated attacks from then president Jacob Zuma while attempting to pacify sceptical financial markets. The strain showed and he used the Budget platform to rally national support.

In 2018 Malusi Gigaba was visibly crestfallen, having just lost his political patron Zuma, who had been removed after a series of strategic manouevres by President Cyril Ramaphosa. He was out of his depth and knew he was on his way out.

Both those budget votes however, in 2017 and 2018, issued the same warnings contained in Mboweni's 2019 version. The widening budget deficit, increased debt-to-GDP ratio, tepid growth, a bloated public service wage bill, the dangers of a ratings downgrade...it was all there. South Africa is in deep, deep trouble.

Mboweni isn't under attack from within, like Gordhan was, and he has job security, unlike Gigaba. He has the clear support of his principal and it seems as if he will be able to pick the time of his leaving. He also has the political experience and gravitas to navigate the gauntlet that is ANC ideology and internal alliance politics.

Because after signalling the Ramaphosa government's intent - including a clamp-down on errant state-owned companies and reducing the public setor wage bill -he is going to have to gird himself for political war.

The reformation process of the South African state, initiated after Ramaphosa's election as ANC leader at Nasrec with the installation of a new board at Eskom in January 2018, is facing resistance on all the fronts it has opened.

There are numerous public processes underway (or have been concluded) that have started to exact accountability (if not prosecutions) after years of corruption and neglect, including the inquiry into the South African Revenue Service (SARS), state capture, the Public Investment Corporation (PIC) and senior officials at the National Prosecuting Authority (NPA), while a new chief prosecutor has been appointed and a new tax commissioner will be announced soon.

These aren't insignificant, given the national state of affairs 12 months ago. But much of the heavy lifting is happening out of sight and out of earshot, with Ramaphosa's reformists active on three fronts: rolling back corruption and rentseeking in the state, stabilising and rejuvenating the economy and refitting the ANC.

The struggle to change the ANC's culture is a monumental one, and Ramaphosa seems determined to do this concurrently with his two other major projects: the state and the economy. According to operators with insight into strategy and unfolding events, the damage caused to the ANC by the party's presidential election campaign is severe.

Passive

Whole structures, from provincial level down to branch level, have been bought or co-opted by factions who remain antagonistic to Ramaphosa. And they are not passive, they are actively organising against the ANC leader, who aims to change the culture of money for support and votes. It is a herculean task, given that the practice to lobby and buy support has now been entrenched for more than a decade.

Beyond the party's internal strife, recovering the state and retooling the economy are Ramaphosa's most pressing tasks - and Mboweni and Gordhan his most important

During the years of state cap-

ture, National Treasury, with its a direct line into daily operations. constitutional mandate, adherence to rules and regulations and commitment to strict control was the rent-seeking cabal's principal enemy. It kept a tight leash on public money, ferretted out corruption and put a brake on the nuclear deal. Zuma, as evidenced by his removal of a succession of finance ministers, considered them adverse to his project of total capture, and mounted repeated assaults on the institution.

In the post-Zuma era Treasury now seems be positioned to indeed become the "super-ministry" Zumaites like Bathabile Dlamini and Nomvula Monokyane were

Mboweni and Gordhan will soon appoint a 'chief reconfguration officer' at Eskom, who will be responsible for ensuring that the utilty adheres to Treasury's strict prescripts. This CRO will be 'Treasury's man" at Eskom and will look after taxpayers' money. The minister of finance said on Wednesday that the days of free money are over and that Treasury will from now on make sure "every rand and cent" is looked after.

Bankrupt

Eskom surely won't be the only state-owned company to get a CRO. SAA is bankrupt, Transnet's procurement and tendering processes are being investigated, Denel has instituted a turnaround plan and the South African Post Office is using debt to fund on State companies, individually and as a collective are in dire straits. According to Treasury they are all loss-making, with debt steeply rising over the last couple of years.

In order for them to remain functional, government has issued guarantees to the tune of R483bn last year, a staggeringly high amount. Just to keep the lights on and aircrafts flying.

But Treasury will now have a direct say in how these companies are managed through the deployment of CROs, which would give the department's officials in Pretoria

And which, in theory, should prevent overspend on expenses like diesel at Eskom.

It is going to give Treasury enormous insight to and control of entities gutted by corruption and fraud and used as cash cows for the corrupt and unscrupulous.

Gordhan is Mboweni's perfect foil. Where the finance minister will remain in charge of disbursements, Gordhan (who as a former minister of finance and SARS commissioner knows everything about fruitless and wasteful expenditure) will be responsible to whip the companies into line.

According to Treasury's Budget Review Eskom remains the single biggest threat to the economy due to its deteriorating debt position, that now makes up more than 15% of national debt.

Both Mboweni and Gordhan will be in charge of rescuing the parastatal and the economy through the restructuring and unbundling process.


It will be this process - an obvious precursor to wider state reforms - that will test both ministers' resolve.

In the Budget Review, Treasury lays the groundwork for far-reaching policy adjustments, including privatisation, which Ramaphosa has already rejected. But Mboweni, ahead of his speech, wasn't flustered when asked about Treasury's position.

He spoke of antiquated 'Sovietstyle' thinking and said if he had his way he'd rather spend money investing in railroads and taxis than on SAA.

According to Treasury the first priority in the reorgansiation of Eskom will be to establish an independent transmission company and adds: "In line with the president's statement, the new company will invite the participation of strategic equity partners that will provide capital for the business and strengthen oversight."

PROPOSED IAAF RULES AGAINST CASTER ARE ARROGANT AND INSULTING

AS the world gathered in Monaco last week to celebrate the crème de la crème of global sport at the Laureus World Sports Awards, another global star started the next phase of the gruelling battle for her identity, dignity and possibly her life.

Lawyers for the International Association of Athletics Federation (IAAF) have argued that the 28-year-old world and Olympic champion, Caster Semenya, is a 'biological male' as well as a classified female. Spectators have also joined in, posting the vilest insults and verbal abuse.

Their tone is no longer that of people who genuinely want to understand the genetic and social issues on the table. The names they call her leave you in no doubt that their prism is populated with racism, homophobia and misog-

Semenya has been fighting a decade long battle that is no longer just about naturally occurring hormones. It is about her freedom to live and excel in the body in which she was born. It is about her identity as a woman being questioned. It is about who gets to tell women, that they are not women?

Imagine being an athlete competing on the international platform, setting the tarmac on fire every time you compete. Crowds roar and cheer you on from inside the stadium and others from the comfort of their homes. The applause is deafening. But for

The IAAF wants to introduce new rules, that will apply to women who take part in track events from 400 metres. They are to keep their testosterone levels below a prescribed amount prior to competing. Prescribed by whom? Furthermore, the international athletics body has arrogantly conferred unto itself the authority to determine what constitutes 'normal female'. It is outrageous. It is insulting. It is crass. Even their vocabulary is violent and discriminatory.

And we all know how that goes down!

All Caster wants is to run naturally, the way she was born. In a recent interview, shortly after she had decided to challenge the proposed rules, she told me, "The IAAF has pissed me off and I want to make this right."

Well, my sense is that Caster is not the only one who is pissed off. For many years South Africans have rallied behind her, with a few exceptions. NIDCS SPENDS E9.3 BILLION ON STRATEGIC INVESTMENT

THE ministry of commerce, industry and trade has reported that the National Industrial Development Corporation of Swaziland spent a total of E9.3 billion on strategic investment projects.

The strategic investment projects are said to have been in various economic sectors, such as agriculture, agro-processing, infrastructure and transport to name a few. "As means to proactively peruse stronger sources of revenue for the corporation, while developing the country's industries, 11 project profiles were developed." According to the report from the ministry, the agricultural sector managed to get E6.7 million worth of development projects approved in 2018. Agriculture and agro-processing have received the larger share of the funds directed to industrial development at 28 per cent. The larger share directed towards agriculture is justified in the report by saying that the NIDC supports the agricultural sector strongly for food security, import substitution, export promotion and employment creation.

The second largest shares were obtained by education and infrastructure respectively at 18 per cent, while art and transport obtained nine per cent.

The report also points out an increase in loan and equity financing in some economic sectors in 2018. "The number of approved loan funding requests received during the quarter when compared to the previous quarter," reads the report.

In the agricultural sector 95 per cent of loans of loans distributed are reported to have been utilized in crop farming while five per cent was allocated towards animal farming in the Manzini and Lubombo regions.

The smallholder market-led project will be held at the Bethel Court at Ezulwini on Thursday.


Stakeholders will gather at Bethel Court on Thursday to brainstorm best practices aimed at improving the legumes industry through employing modern technologies and innovations.

Amazon tapping into e-commerce customers in Kenya

KENYA - THE e-commerce giant has rolled out a service that will allow customers to purchase goods and then pay for them at a local Western Union retail agent.

During checkout, a special QR code will be generated that will be used to verify the customer's identity and matched to the order confirmation for payment. Dubbed Amazon PayCode, the crossborder payment option has been launched in Kenya in Africa, along with nine other countries in Asia and Latin America.

The service's launch underscores Amazon's pivot towards e-savvy consumers in Kenya, who are keen on buying things online but might not have access to international credit cards or prefer to buy goods in cash and in their own currency. This is especially crucial as research shows that cross-border shopping sales will represent 20 per cent of e-commerce by 2022, with sales

reaching \$630 billion, boosted by increasingly sophisticated customers in markets, including Africa and the Middle East. Kenya has specifically undergone a mobile commerce revolution, buoyed in part by ubiquitous mobile penetration, increased smartphone adoption, and a mobile-first strategy that enables shoppers to pay for goods and services online through mobile money platforms

Amazon's partnership with Western Union also signals the company's grad-

ual turn towards expanding its footprint in developing markets as it faces off with rivals like Alibaba. This is compounded by the fact that the company is yet to replicate its success in the US in markets, including China and India. Amazon currently delivers to only 10 African nations as part of its global shipments operations, with its e-commerce subsidiary Souq operating in Egypt too.

The Seattle-headquartered company could also be following in the footsteps of global tech giants who have all looked to Africa to deepen their presence and increase their revenue.

Besides pioneering a project to deliver internet to remote areas, Google last year integrated Kenya's M-Pesa mobile money service as a form of payment in its store. Chinese e-commerce giant Alibaba has also been keen on Africa and recently launched deals with the Rwandan government to boost e-com-



US to deny visas to DRC officials over election misconduct

JUBA - Tens of thousands face starvation in South Sudan, aid agencies warned last Friday, as fighting continues despite a peace deal signed six months ago meant to end civil war.

Nearly seven million people or twothirds of the country face extreme hunger, the government and UN agencies said.

"The food security situation continues to deteriorate," said Isaiah Chol Aruai, Chairman of the National Bureau of Statistics, as he released the latest round of mind-boggling food assess-

Nearly a fifth more people now need food aid to survive than when a manmade famine was declared in 2017,

Aruai, speaking to reporters in Juba alongside the heads of the UN's World Food Programme (WFP) and the Food and Agriculture Organization (FAO), pleaded for more aid to avert further catastrophe.

"The projections are alarming," said FAO boss Pierre Vauthier. "Food security continues to worsen."

When famine was declared in 2017, 4.9 million people or 40 per cent of the country needed food aid. Now over 6.1 million people, or just over half the population, are assessed to be in 'acute food insecurity'.

Without action, those figures will

EFF takes issue with Jabu Mabuza's 'conflict of interest' at Eskom

JOHANNESBURG-The Economic Freedom Fighters said it wants new Eskom Board Chairperson Jabu Mabuza to step down following disclosures he made at the judicial commission of inquiry into state capture last Friday.

The EFF last Saturday said Mabuza

disclosed a 'serious conflict of interest' during his testimony that should have disqualified him from his position at the power utility.

Mabuza, who is currently chairing the new Eskom Board tasked with ridding the state-owned entity of impropriety, told the commission on Friday that he had bought six per cent of shares in Sphere Investment worth R26m. He said that upon accepting the position of board chairperson in January 2018 he declared all his interests and resigned from future investment decisions at Sphere. The shares had also been put in a blind trust.

"Mabuza told the commission that he is an executive chair of a company that maintains a third of Eskom's boilers," EFF spokesperson Mbuyiseni Ndlozi said in a statement on Saturday.

Ndlozi was referring to Sphere's shares in Babcock and Honeywell, who have contracts with Eskom. The use of a blind trust was not good enough, Ndlozi continued.

"The use of blind trusts by high profile executives in state-owned companies, including political office, is nothing but a web of dishonesty and deception used to hide the conflict of interest and dealings taking place to enrich the few, at the expense of South Africans," Ndlozi claimed.

Zizi Kodwa denies rape allegations

JOHANNESBURG - ANC acting spokesperson Zizi Kodwa has denied the rape allegations levelled against him.

Kodwa released a statement denying allegations saying 'It's a dirty tricks campaign against me'.

Yesterday, the party confirmed receiving a letter from a woman-making the claims.

The ANC says it advised the woman to approach the police as the alleged incident happened at a private party last year.

In a statement released this morning, Kodwa describes the rape allegations as a grotesque attack on him and his reputation.

He says the letter his accuser sent to the ANC is replete with false accusations.

The acting spokesperson confirms that he is accused of rape, sexual assault and drugging two women.

But he says he denies the allegations with the contempt they deserve adding: "I refuse to succumb to extortion and blackmail."

Kodwa alleges that there are cowards operating from factional dark corners using women to neutralize him.

He says he will not be silenced through a dirty tricks campaign and is considering filing a case of extortion or defamation. *Eyewitness*

VOTERS LIKE CYRIL RAMAPHOSA MORE THAN THEY LIKE THE ANC: SURVEY

JOHANNESBURG - President Cyril Ramaphosa is more popular than the ANC, a survey by the party has found.

A poll conducted by the governing party's research unit says Ramaphosa has an approval rating of 73 per cent by South African voters, whereas only 60 per cent of those polled are pleased with the ANC.

The ANC has set itself a target of at least 60 per cent of the national vote in the May 8 polls, which would be an improvement from the 54 per cent national support it received in the 2016 local government elections.

The party received 62 per cent in the 2014 general elections.

But Ramaphosa's support may not automatically translate into ANC votes — as was the

case with former president Nelson Mandela, who was also more popular than the party but could not get it beyond 63 per cent of the vote.

"The people have got to see the president in the image of the ANC," said ANC head of elections Fikile Mbalula. "The two are not disconnected.

"When he acts in government and does good things, people see Ramaphosa, not the ANC, but that is so because of where we come from with an ANC that was associated with badness because of the head of state."

Maimane reiterates no to land expropriation without compensation

JOHANNESBURG - DA leader Mmusi Maimane is threatening court action if Parliament decides to amend Section 25 of the Constitution to pave the way for land expropriation without compensation.

Launching the party's manifesto for the May elections in Johannesburg yesterday, Maimane said the party was not opposing the amendment of the Constitution just for the sake of it.

The party says allowing land expropriation without compensation would mean citizens will have to rent their homes and land from government and they will never enjoy security of tenure.

Last week, a Parliamentary ad hoc

committee started working on its programme for the amendment, after the National Assembly adopted a resolution from the Constitutional review committee last year that the Constitution should be changed.

The DA is standing by its position that it does not support the ANC and EFF's plan for land expropriation without compensation.

Its manifesto says that land reform should be a tool for economic development and that land reform shouldn't mean that government must take from one to give to another.

The DA leader says his party wants people to own land and there should be no limits to the amount of holding

Eskom chair warns of threat to the economy should debt not be repaid

JOHANNESBURG - Eskom Board Chair Jabu Mabuza has described the consequences for the country and its economy if the power utility defaults on its debt repayments,

Mabuza took the stand at the Zondo Commission on Friday and is expected to conclude his testimony today.

Finance Minister Tito Mboweni announced this week that Eskom will receive a guarantee of R69 billion over the next three years to service its debt.

The power utility is sitting with a debt of over R400 billion.

There are funders that have extended loans to Eskom and those loans have a material default clause which, if breached, could have serious implications for the country.

The Eskom board chair explains:

"A breach of any of the covenants within Eskom, the fatal effect of it whether they are Denel or SAA..."

THE MAN WITH A TOOTH GROWING IN HIS NOSTRIL:

'Rare' condition left the 59-year-old with a blocked nose for 2 years

AARHUS - A 59-year-old man had a tooth growing in his nostril because of a rare condition which left him with a blocked nose for two years.

The strange growth, called an intranasal retained tooth, can be caused by physical damage or development problems but doctors couldn't explain this case.

After doing scans and investigations to try and work out what the growth was, doctors removed it during surgery and discovered it was an entire tooth.

Growing a tooth in the nostril is rare and thought to affect somewhere between 0.1 per cent and one per cent of the population but can go unnoticed.

The report was published in the journal BMJ Case Reports and included pictures which clearly show a pearly white tooth inside the unnamed man's nose.

Experts said they could only find 23 incidences of the odd condition recorded in medical journals between between 1959 and

The man, who saw doctors at the Ear, Nose and Throat unit at University Hospital Aarhus, had been suffering from a blocked nose and loss of sense of smell over the past couple of years.

He had also had a regular milky discharge, particularly coming from the left nostril.

After topical nasal steroids - sprays to reduce swelling - had failed to solve his problems after a month, he saw a doctor.

"It can easily be missed", the doctors, led by Dr Milos Fuglsang, wrote. "Diagnosis is important since it potentially can cause dis-

A scan revealed the man's nose was crooked to one side and there was a mass growing in his nasal cavity.

Doctors suspected it was a cyst or even a tumour, and decided to operate and pull the growth out.

Previous case reports have described this condition happening when normal teeth are displaced after facial trauma, infections or developmental problems such as cleft palates.

They found the man had broken his jaw and nose when he was younger, which had needed surgery to reconstruct, but they couldn't find any link between the two incidents.

The doctors added: "Our patient most likely had the intranasal retained tooth most of his life, but had late onset of symptoms."


The patient was fine within a month after he used nasal saline irrigation and ten days of antibiotics.

"Intranasal teeth are a rare finding but important to recognise since nasal congestion, chronic discharge and hyposmia car decrease quality of life," the report concluded. Daily Mail

These include amongst others, the annual public notices, phone calls and letters.

Estimated assessments are raised in accordance with Section 39 of the Income Tax Order 1975, as amended, which states that an estimated assessment may be raised by the Commissioner General in every case in which a taxpayer defaults in furnishing a return; or, if the return submitted by the taxpayer is unsatisfactory to the Commissioner General.

After the estimated assessment has been raised. the taxpayer has a right to object to that assessment within twenty- one days as provided for by Section 52(1) of the Order; mote that failure to object within the time limit set above, renders the

assessment final and any tax due is collectable and must be paid by the taxpayer.

Caution: Upon publishing of this notice, the Commissioner General shall not reverse any estimated assessments issued against taxpavers who have failed to submit their returns, and have furthermore ignored reminders from Commissioner General. Additionally, any failure to adhere to the notice / the provisions of the law will result to a liability as per the Income Tax Order 1975, as amended.

Taxpayers are further urged to advise the authority of their preferred mode of communication. This is required in order to facilitate receipt of communication from the SRA. Where the contact details or physical address have changed. taxpayers are cautioned on the legal obligation to notify the Commissioner General of the change.

NORTH KOREA REPORTS KIM'S SUMMIT WITH TRUMP

HANOI - North Korea on Sunday confirmed for the first time that its leader, Kim Jong Un, will hold a second summit with US President Donald Trump, days ahead of the highstakes nuclear meeting in Vietnam's capital of Hanoi.

Kim left Pyongyang by train on Saturday afternoon for the February27-28 summit accompanied by senior North Korean officials as well as his influential sister, North Korea's official KCNA news agency and its Rodong Sinmun newspaper report-

Trump and Kim will meet in Hanoi eight months after their historic summit in Singapore, the first between a sitting US president and a North Korean leader, where they pledged to work toward the complete denaturalisation of the Korean peninsula.

With little progress since then, the two leaders are expected to focus on what elements of North Korea's nuclear program it might begin to give up, in exchange for US concessions.

Coverage

In rare, revealing coverage of Kim's travel, while it is still going on, Rodong featured photographs of Kim getting a red-carpet honorguard send-off in Pyongyang and waving from a train carriage door while holding a cigarette.

He was accompanied by top officials also involved in the Singapore summit, including Kim Yong Chol, a former spy chief and Kim's top envoy in negotiations with the United States, as well as senior party aide Ri Su Yong, Foreign Minister Ri Yong Ho and defense chief No Kwang

The North Korean leader's sister, Kim Yo Jong, who acted as a close aide to him in Singapore, is again part of the delegation, KCNA said.

The extensive coverage in the secretive North's official media was a contrast to the limited reporting that has traditionally prevailed during his foreign trips.

Other senior North Korean officials, such as his de facto chief of staff Kim Chang Son and Kim Hyok Chol, negotiations counterpart to US envoy Stephen Biegun, were already in Hanoi to prepare for the summit.

Brexit must not be frustrated, Theresa May vows

LONDON - In a speech to Tory activists the PM said, as her negotiations with the EU reach their final stages, the 'worst thing we could do is lose our focus'.

It came as three pro-EU cabinet members warned they could vote to delay Brexit to prevent a 'disastrous' no-deal.

But Theresa May said there must be no party 'purges' over MPs with differing views.

Ahead of crucial votes in the Commons next week, Greg Clark, Amber Rudd and David Gauke told the Daily Mail they would be prepared to defy the prime minister and vote for a delay.

The intervention led to calls for their resignations by Tory Brexiteers.

The UK remains on course to leave the European Union on March 29.

However, the government has repeatedly refused to rule out the possibility of the UK leaving without a formal deal, in the event that Mrs May cannot get MPs to approve the deal she negotiated with Brussels in time.Largest democratic exercise May's speech to the National Conservative Convention in Oxford on Saturday evening came as MPs prepare for a series of votes on Wednesday, which could see Parliament take control of the Brexit process.

Delegates at the convention overwhelmingly backed a symbolic motion saying Brexit should not be delayed, and leaving without an agreement should remain an option.

Clark, the business secretary, along with Rudd, the work and pensions secretary, and the justice secretary, Gauke, had earlier said they would be prepared to defy May and vote for a delay to Brexit.

They argued there 'simply will not be time to agree a deal and complete all the necessary legislation' unless a deal is approved in the coming days.

An amendment tabled by former Tory Minister Sir Oliver Letwin and Labour's Yvette Cooper would give Parliament the opportunity to delay Brexit and prevent a no-deal situation if there is no agreement with the EU by the middle of March.

But May told activists: "Our focus to deliver Brexit must be absolute. "We must not, and I will not, frustrate what was the largest democratic exercise in this country's history. In the very final stages of this process, the worst thing we could do is lose our focus." AP

France calls on Germany to ease arms export rules

BERLIN - French Economy Minister Bruno Le Maire said yesterday that Germany should ease its strict arms export rules for countries outside the European Union to strengthen the defence industry.

France has complained that joint arms manufacturing projects are being stalled by Berlin's refusal to authorise future arms export licenses to Saudi Arabia, a major buyer.

Germany said in November it would reject future arms export licenses to Riyadh over the killing of Saudi journalist Jamal Khashoggi. It has not formally banned previously approved deals but has urged industry to refrain from such shipments

"It is useless to produce weapons through improved cooperation between France and Germany if we are unable to export them," Le Maire told Welt am Sonntag newspaper.

"If you want to be competitive and efficient, we need to be able to export to countries outside Europe," Le Maire said.

The minister said France also had relatively strict rules for arms exports. "Our hope is that we will come to an agreement with Germany in this crucial point," Le

Germany and France are working on a joint proposal for arms export guidelines to non-European countries.

Already lashed by criticism over his collapsing nuclear deal and renewed tensions with the US, the relatively moderate Rouhani faces anger from clerics, hard-line forces and an ever-growing disaffected public that now threatens his position.

Princess announced as US ambassador

RIYADH - Saudi Arabia has announced that Princess Rima bint Bandar al-Saud will become its next ambassador to the US - the first woman ever to take on an envoy role for the kingdom.

Her appointment was made public in a royal decree this past Saturday. Princess Rima spent part of her childhood living in Washington DC. She assumes the role at a difficult time, as Saudi Arabia tries to quell an international outcry over journalist Jamal Khashoggi's death. After giving conflicting explanations of what happened, the Kingdom eventually admitted Khashoggi, who was once a Royal insider, was murdered after entering the country's consulate in Istanbul last year. BBC

'Manafort's 'criminal actions were bold'

WASHINGTON - Prosecutors from special counsel Robert Mueller's office wrote in a sentencing memo filed Friday for Paul Manafort that the former Trump campaign chairman's years of criminality were "bold" and continued even when and after he served as Donald Trump's campaign chair in the 2016 election.

The memo was made public last Saturday with some redactions, and prosecutors asked Judge Amy Berman Jackson to make sure the nowjailed 69-year-old may never walk free again. Manafort pleaded guilty in September to conspiracy against the US and conspiracy witness tampering. CNN

Expectations surge ahead of new talks

DOHA - The US and the Taliban are to meet in Qatar for fresh talks Monday seeking an end to 17 years of grinding conflict in Afghanistan, with the stakes ratcheting higher as the spring fighting season approaches.

Marathon talks held in Doha last month have stoked hopes of a breakthrough after the two sides walked away with a 'draft framework' that included a Taliban commitment to prevent Afghanistan from once again becoming a safe haven for international terror groups.

It was the most substantial engagement by Washington with the militants since US forces ousted them from power in 2001. AP

"I have not been to the country for almost 20 years and it is amazing how the people still uphold their culture,"




"The show was emotional for me, seeing my family in the audience and everyone who had promised to come truly filled my heart, I may not have reached the target but I have accomplished my dream," he added.









"It is always hard to win here and we knew that we would have to rediscover our form. We did that and performed very well and got the result."


In comparison, Cristiano Ronaldo has 51 hat-tricks in 948 games for club and country.







Vilakati said his former employer's supporters should just let him be.


He said this soon after watching his team beat Manzini Sundowns 2-0 at the Somhlolo National Stadium yesterday.
