# PASTOR STABBED RESCUING LOVELORN DAUG

A pastor from Mpolonjeni was allegedly stabbed by his daughter's boyfriend's brother after he stormed their homestead looking for her.

The pastor is said to have stormed the homestead sometime last week

and in the event he broke doors, demanding his daughter after claiming that she was having sexual relations with the accused's younger brother.

The accused, one Sibusiso Mkhatjwa (25) of Mpolonjeni was arrested this past weekend for allegedly stabbing Clement Ntjalintjali after a questioning session between the two went wrong. He stabbed him with a knife in his right thigh and further assaulted him with fists all over the body.

On the day of the stabbing, the accused approached the pastor with intent to question him about the broken doors, but the pastor became aggressive and an altercation occurred.

He is said to have been seen falling and screaming 'Inyandzaleyo' after the accused allegedly stabbed him and he was seen fleeing the scene, leaving the pastor bleeding from his lower limbs.

The pastor was treated and discharged at the Mbabane Government Hospital and reported the matter to the Mbabane police.

It was disclosed that the suspect was then arrested and charged with assault

GBH and he voluntarily led the police to the scene of crime, where he retrieved the weapon he allegedly used to stab the pastor which was an Okapi knife, which he handed it to the police in the presence of witnesses, including his family members. During his court appearance, the accused applied for bail, which was set at E1 500. Trial is set to begin on March 1.

# UPROAR AS GOVT ABSENT AT BUDGET WORKS: OF

THE budget workshop for members of parliament held yesterday was almost chaotic as cabinet ministers elected to absent themselves.

This happened yesterday during the training of MPs on budget literacy. The workshop was conducted by Financial Services Volunteer Corps (FSVC). They included Baly Mourad (Programme Manager), Marjan Nikolov and Vesna

Marjan Nikolov was the workshop facilitator, who gave information throughout the workshop

Purpose

The purpose of the workshop was to sharpen the MPs with skills that would enable them to effectively play an oversight role on how government handled public finances. It was also meant to sharpen the Executive with skills that would enable them to handle funds in a way that would bring better life for all Emaswati.

The MPs went to the workshop yesterday, having been informed that Cabinet ministers would also be part of the workshop. It looked as if the legislators were looking forward to having the Cabinet ministers in their midst, probably to ensure that they also heard loud and clear how they were supposed to handle public

However, the Cabinet ministers were not to be part of the workshop yesterday. This caused uproar among the legislators, such that it became difficult to move forward with the workshop. Nikolov found himself having to answer questions he did not know, as he was asked who he was talking to because the Executive was not part of the workshop.

Nikolov was only implementing his duty of differentiating between the roles between the Legislature and the Executive

when the hullabaloo took place. He said the role of the Executive was to set goals on what they wanted to achieve in the next financial year and making sure they managed that. The role of the Legislature, according to Nikolov, was to ensure that the Executive did just that.

**Key Matters** 

The MPs did not understand why Nikolov was talking about a role of people who were not present at the workshop. Ndzingeni MP Lutfo Dlamini is the one who rescued the situation and explained what caused the hullabaloo.

He said the problem was that MPs expected that Cabinet ministers would be present yesterday, so that they should also listen to what Nikolov's teachings included. The sudden absence of the ministers disturbed the MPs such that they saw no reason of continuing with the workshop when the very people who were key in budgetary matters were not present.

Dlamini said it would be good for someone to apologise on behalf of the ministers and explain why they were not available. House of Assembly Speaker Petros Mavimbela explained that Cabinet had communicated and stated that they had been busy with some Cabinet responsibilities yesterday.

Mavimbela pleaded with the MPs to continue with the workshop because Cabinet would be joining them today.

What 4 000 unqualified teachers? - TSC

INSINUATIONS that there are 4 000 unqualified teachers in the educational sector in the country may as well be not accurate.

African Committee of Experts on the Rights and Welfare of the Child (ACERWC) said they were informed that there were over 4 000 unqualified teachers in the education system and that the number of teachers was not adequate for the implementation of free primary education. The committee also wants to know the teacher to pupil ratio in primary and secondary schools, and whether or not the teachers are capable to deliver quality education.

When contacted for comment, SWANCEFA National Coordinator Nelisiwe Nhlabatsi said, concerning the accuracy of the information, she was not in a position to say whether it was accurate or not.

Education

However, the ministry of education and training is in the best position to comment because it conduct annual education censors, which also includes teachers in all schools in the

Nhlabatsi said on the implications on quality education if it was true SWANCEFA that, the teacher the most important factor in the quality education of education. A teacher in order to deliver quality should be sufficiently trained, sufficiently suited to teach a specific grade or a group.

If a teacher is trained he or she is able to use teaching methods that enable learners to grasp concepts eas-

If the report is accurate, then government needs to increase the budget for education to attract the best candidates to teaching even in rural schools, adds Nhlabatsi. She says government should also train more teachers to meet the needs of all learners, post teachers where they are needed most, as well as use a competitive pay structure to retain the best teach-

On the other hand, Chairperson of

the Teaching Service Commission Simanga Mamba says all the teachers engaged in the educational sector are adequately qualified. Mamba adds that as TSC, they thanked government for ensuring that all persons in the teaching profession are properly trained and qualified. For the first time since the country's independence, government has ensured that all teachers are trained and qualified as education is essential foundation for children.

Challenges

Mamba stated that all teachers currently teaching in primary schools are all adequately qualified.

The figure querried by ACERWC is not accurate and not a true reflection of the educational system in the country.

He, however, notes that in secondary and high schools, they face a challenge, as there is a shortage of teachers who are adequately qualified for teaching science subjects, such as Mathematics and Physics. He attributes this to that teachers who are qualified for these subjects attract interest from other fields and usualy opt to leave the teaching practice because the other jobs have better remuneration packages compared to the teaching profession.

In mitigating the challenge, Mamba says they engage qualified professionals who do not necessarily possess PGCE (post graduate certificate in education) required to be a teacher. However, even though they may not be qualified teachers, they do hold degrees in fields such as Physics and Chemical Engineering.

He clarifies that as these teachers may not possess the methodology required to apply their skills as teachers, they are engaged in workshops to train them.

He also claims that out of the 16 000 professional teachers in the educational sector, these teachers are less than 800, which is far from the 4000 mentioned by ACERWC. He also states that in 2011, there was a shortage of qualified teachers in the country but government has ensured that this gap is filled, which he regards as an achievement.

# Supplementary budget signs of ill-discipline

SUPPLEMETARY budgets are a sign of fiscal ill-discipline and should be avoided at all costs.

This was said by FSVC Volunteer Marjan Nikolov, who is also President for the Centre for Economic Analyses. Nikolov said MPs and ministers should always know that budgets were a legal obligation for government to perform

ing financial year. He said fiscal discipline was crucial in handling public funds, because this would enable government to achieve the goals it had set for itself. The use of supplementary budgets meant somewhere during the implementation of the budget, something wrong happened and that, in most instances, meant the money could have in a certain way with funds for the combeen used for things not intended for.



# GANGSTER WARS ROCK HAWANE HIGH

POLICE were called in to calm down a situation that nearly turned nasty on Friday after two groups of pupils were reportedly fighting each other for two days at Hawane High School, outside Mbabane.

The incident that left the school teachers and pupils living in fear happened February 21 and 22. It

has been revealed that within the school there are two factions of boys involved in the fighting. These are Nkoyoyo and Hawane groups.

So serious is the issue that the two groups carry dangerous weapons to school. Sources said they did not know the bone of contention between the two groups. However, it has been suspected that the fight emanated from a superior source. Strong language associate with gangsterism dominated the verbal exchanges.

It had been revealed that the fights took place outside and inside the classrooms while teachers were at the staffroom. The staffroom is about five metres away from the classes, which made it difficult for the teachers to hear any noises from the classrooms. Information gathered from reliable sources revealed that when the fight initially took place on Thursday, the teachers tried to calm down the situation by calling the gang members involved in the fight to a meeting. Little did the teachers know that the situation will turn nasty on Friday. An impeccable source said that on Friday morning the pupils engaged in a fierce fight that prompted the teachers to call the police.

"The police from Mbabane arrived at the school and took eight of the boys for questioning on Friday and by the close of business they had not returned," said the source.

The pupils are said to have outsmarted the teachers and police by hiding their weapons before a search was conducted on Friday.

A team from this publication vis-

ited the school at noon on Monday and found the situation calm. Teachers were in class conducting lessons while the principal were reportedly out of office conducting other duties. The deputy principal declined to give comment to this reporter when asked about the fight. "I'm not allowed to give comment to media, please call the principal," he said.

Principal Philiph Mathunywa confirmed the incident. "I was out of school on Friday attending a workshop but I was informed that there was a fight within the school that resulted in some of the pupils being apprehended by the police," he said.

Mathunywa said at the moment the school was monitoring the situation and waiting for feedback from the police, thereafter they would take action. He however, said what happened at the school was not acceptable and they would soon meet the parents. Mathunywa described the fight as a gangster war.

Chief Police Information and Commucations Officer Phindile Vilakati confirmed the matter and said the pupils were arrested and charged with common assault. She added that they would appear before the magistrate court on Wednesday.

# Pupil threatens female teacher with bushknife

DUE to the existence of the gangsters at the school, teachers are now living in fear after one of the pupils threatened to hack a female teacher with a bush knife.

The startling revelation is said to have been unfolded in one of the school meetings recently. Sources mentioned that one of the teachers received the threats while walking along the school corridors. "He told the teacher that he was not happy about her and threatened to sort her out with a bush knife," said the source.

Various teachers when interviewed confirmed that they were living in fear and urged the management of the school to hire security guards to check all pupils' bags when coming into the school premis-

# Local with E2.6m dagga gets 12 years in SA

A dagga dealer enroute to Johannesburg coming from the watini was arrested before reaching his destination Kingdom of Es after he was found in possession of dagga worth E2.6 million.

Patrick Bongumenzi Thwala (48) was arrested by South African police in an area known as Buccleuch. According to a media statement from the Directorate of Priority Crimes Investigation (HAWKS) South African Police Service, Thwala was convicted by the Alexandra Magistrate's Court last week Tuesday for charges of dealing in dagga valued at approximately R2.6 million.Captain Ndivhuwo Mulamu from the SAPS said Thwala was arrested last Friday at the premises of Buccleuch near Johannesburg, along with a 39-year-old accomplice.

He said the arrest follows an intel-

ligence driven operation by the Hawks' Narcotics Enforcement Bureau, Crime Intelligence Counter Narcotics and Border Policing after it came to light that they were transporting a large quantity of dagga from Eswatini to South Africa.

"The consignment of (532,5 kg) of dagga that originated from neighbouring Swaziland was recovered from a motor vehicle and also from the house where they were arrested.

Thwala pleaded guilty for possession and dealing in dagga whilst his accomplice was acquitted following the admission," part of the statement

The court has sentenced Thwala to a four and eight years concurrent prison terms for both charges, suspended for five years, with an option of a R20 000 fine provided he is not found guilty of a similar offence during the period of suspension. Meanwhile in another separate incident the South African Police Service have confirmed that in an area known as Mangweni in Inanda there was a major dagga bust whereby a dagga dealer was arrested for possession of dagga worth E350 000. It is said the officers approached a house after receiving intelligence and found dagga weighing 28.5kg, with a street value of R350, 000-00.

"A 55-year-old man was arrested for dealing in drugs. It is believed that the dagga was coming from Swaziland and transported to Inanda and surroundings. All the arrested suspects appeared in the Verulam Magistrate's Court on Monday February 18.Such busts come at a time when in the country police have been engaged in an operation of destroying vast dagga

This time of the year is known as dagga harvesting season and dagga dealers in the country are transporting their harvested products to neighbouring countries where they are making a killing.

# EEC says Thursday strike illegal

**ESWATINI Electricity Company** (EEC) has declared the proposed strike by the Swaziland Electricity Supply Maintenance and Allied Workers Union (SESMAWU) illegal.

SESMAWU has resolved to embark on a strike action until EEC employees are paid as per the full Salary Alignment report which was delivered by consultants KPMG last week. The strike action is set to commence on Thursday and was confirmed by Trade Union Congress of Swaziland (TUCOSWA) Deputy Secretary General Muzi Mhlanga.

In a press statement released yesterday, EEC management stated that it has since come to their knowledge that at a General Council of the Swaziland Electricity Supply Maintenance and Allied Workers Union held on February 22 2019 a resolution was reached that its members are to embark on a strike action/work stoppage with effect from Thursday

February 28, 2019. "Management wishes to advise the public and the nation at large that such action will be illegal and against the provisions of the Industrial Relations Act, which prohibits industrial action in essential services. Management would like to advise the public that a plan has been put in place to mitigate any possible interruptions in the electricity supply to the nation," reads the statement. The EEC management, led by Managing Director Meshack Kunene, stated that issues raised by the Union are still being deliberated by all concerned in the appropriate internal forums and the parties have neither declared nor reached a deadlock that would translate the issue into a reportable dispute.

"The Union has not lodged any dispute with CMAC in terms of the Industrial Relations Act so that management and the union may be invited for a conciliatory process. Management calls upon the union to utilise the internal and external dispute resolution mechanisms without resorting to unlawful industrial action,"

says the statement.



PRETORIA - Investors who put their faith in an investment scheme with links to Prophet Shepherd Bushiri's church are out of pocket after their money was 'lost'.

About 250 members of the Mpumalanga branch of Bushiri's Enlightened Christian Gathering church have reported the losses to church leaders and to the Hawks. The members had invested the money with a senior pastor at the church, Nicholus Mgiba, who is CEO of Merger Chen Solutions (MCS).

Hawks spokesman Hangwani Mulaudzi said they were investigating the reports.

Though no figures are known, other investors from Limpopo, the Eastern Cape and Gauteng are also affected. In Mpumalanga, members said they had invested R10m. According to a document that investors claim was given to them by MCS, and which the Sunday Times has seen, the congregants were promised huge returns.

Those who invested R200 000 were promised R11.5m after six months. Those who invested R1m were promised R57.6m in six months. Most investors are said to be retired people.


In a meeting this week at Bushiri's Pretoria church, senior pastors allegedly told investor representatives that Shepherd Bushiri Investments (SBI) had also 'been defrauded'.

Shepherd Bushiri Trading, a subsidiary of SBI, invested congregants' money in a fraudulent scheme, investors were told.

According to investors, church leaders who addressed them said Bushiri had tried his best to take responsibility, including refunding many people who had invested with his company.

# Bushiri's flock out of pocket after cash 'lost' in investment scheme

A church-linked investment scheme promised big returns

The investors showed the Sunday Times a WhatsApp message they claimed had come from church leaders. It said: "SBI as his personal business has now appointed a law firm to assist in the investigation and is trying to recover whatever it can from these fraudsters."

The WhatsApp message also said: "It is unknown at this moment as to how long the process will take and how

much will be recovered, or if there will be anything to be recovered."

People from four provinces have confirmed receiving the messages.

Mpumalanga congregant Florence Mangwane, who invested in the MCS scheme, said she had been caught by surprise when she received the mes-

church. I took my money, R150 000, and my husband put R200 000 into this. We lost it all," she said.

"The truth must be told. Why is he not opening a case with the police if he lost money in this scam? Why lawyers? What are they going to do?"

Fight

Her husband, Ernest Mangwane, said they were ready to fight for their money.

The Sunday Times has seen the list of about 250 Mpumalanga congregants, who say they have invested in schemes linked to the church.

It details amounts that were allegedly deposited in the bank accounts belonging to several senior church leaders, as well as the church's own account, and another account for a church investment scheme called Seer Salvation.

MCS has no official links to the church. The only link is that Mgiba is a senior pastor at Bushiri's church and runs the church's Phalaborwa branch. He did not respond to calls, e-mails and WhatsApp mes-

Congregants said they started investing in MCS in January 2018.

Julia Mafukeni, who invested R10 000 in MCS, said she had hoped to get good returns. "People

should stop blaming Bushiri; he's young and not properly advised. All I need, though, is my money," she said.

A staunch Bushiri supporter, Thulani Maake, said she believed in God and that her money would return.

"If only the people who are leading us can believe in God, we will get our

They need not panic," she said.

One leader in Limpopo said senior officials of the church had introduced them to Mgiba. The leader showed the Sunday Times a notice of his R100 000

deposit. "That was January last year and I am yet to get anything back." Timeslive



# Chicken farmer arrested for attempting to kill worker

A chicken farmer has been arrested for attempting to kill his employee following the theft of his cellphones, *buganu* and money amounting to E3 000.

Simanga Teddy Mavuso of Ngwenya Village is facing a charge of attempted murder. He has since filed an urgent application for bail at the High Court. Appearing before Judge Titus Mlangeni yesterday morning, Mavuso was granted bail fixed at E15 000 as the crown did not oppose same.

However, Judge Mlangeni ordered that he pays E3 000 in cash and E12 000 will be in a form of surety. According to Mavuso, he was arrested by the Mbabane police on February 16 and subsequently charged with the offence of murder and is currently kept at the Sidvwashini remand centre.

He submitted that he is innocent of the charge preferred against him and will plead not guilty during trial since he did not attempt to kill the complainant.

Mavuso stated that the complainant was injured after he assaulted him following the theft of his three cellphones, money amounting to E3 000 and a five litre of *buganu* brew inside his house.

He stated that the complainant is actually his employee who assisted him in feeding his chickens as he (Mavuso) runs a poultry business and has been working with the complainant for the past two years, hence he had no reason to attempt to ...Over stolen buganu, cellphones, money

kill him since he is of value to the business and he understands it. He submitted that on February 15 leading to the present charges against him, he had actually gone to buy chicken feed and left the complainant behind at his (Mavuso) home feeding the chickens with the little feed that was left.

Complainant

He averred that he had actually left the money for the business in excess of E5 000, the cellphones and the buganu and at some point he found the complainant inside his house without his consent and failed to understand how he got access since he had locked the doors. When he enquired from him as to how he gained access, he failed to give a satisfactory answer, save to say he was sorry.

Having retuned from buying the chicken feed, Mavuso stated that he went into his house as he wanted to retrieve one of the cellphone, but was shocked when he discovered that all the three phones were missing.

Upon such discovery, he submitted that he called the complainant and asked him about the whereabouts of the cellphones, but he denied knowledge of them and he (Mavuso) further discovered that the money bag had been tempered with and that the E3 000 was missing together with the 5L of buganu. The complainant, according to Mavuso admitted to have taken the marula drink and consumed it with his friends and further said he had thrown the cellphones into a pit latrine, as he

was angry at Mavuso.

Mavuso submitted that he personally tried to retrieve the phones from the pit latrine but to no avail and that is when he started assaulting the complainant in anger.

"I asked him to show me the area of the toilet where he had dumped the phones, as I was urgently in need of them and did not bother about the money as I was going to deduct it from his salary. I went to the extent of wearing plastics in a bid to retrieve the phones but could not find them, out of anger and loosing temper, I assaulted the complainant with a pipe and my bare hands and not bricks and stones as alleged," Mavuso submitted.

He informed the court that there is no likelihood that he is going to evade trial upon being release on bail and that he may endanger the safety of the public or any particular person.

# Elephants leave for Mozambique

THE three elephants that terrorised areas such as Tikhuba, Maphungwane and Sitsatsaweni last week have finally left the country for Mozambique.

The elephants first invaded Tikhuba last Tuesday after crossing into the country through an opening along the border line separating Eswatini and neighbouring Mozambique and South Africa. Their exact origin was not known to the ministry of agriculture.

The animals moved to Sitsatsaweni on Thursday, leaving a trail of destruction in maize fields at Tikhuba and Maphungwane. Even though residents of the said communities were uneasey about the presence of the animals, they flocked to the fields where the giant animals had been spotted, just to have a glimpse at them. Elephants are ordinarily calm animals, at least until they feel threatened, upon which they are likely to react violently.

Damage

The damage which the animals caused in the fields as they moved along the eastern part of the Lubombo region is said to have

amounted to thousands of Emalangeni. Officers under the ministry of agriculture who have been monitoring the



movements of the elephants reported that the animals eventually left the country on Friday. They are said to have crossed the border line near Sitsatsaweni and into Mozambique. Initially, Director of Veterinary Dr Xolani Dlamini stated that even though the origin of the elephants was not known, it was most likely that they came from Mozambique. Residents have expressed their relief upon learning that the animals have left. The residents were also worried about their safety as the animals would get closer to homesteads during the night.

# MAN (26) ACCUSED OF ASSAULTING EX-LOVER

A 26-year-old man from Ngwane Park area has been charged for contravening the Sexual Offences and Domestic Violence (SODV) Act after he assaulted his former girlfriend.

Sibusiso Gumedze was arrested by Manzini police after he violently assaulted her former girlfriend resulting to her having a sprained wrist. According to the charge sheet presented to court

before Manzini Senior Magistrate Phathaphatha Mdluli, it is alleged that Gumedze assaulted his former lover while at Sidzakeni area by banging her several times on the ground injuring her temple and spraining her wrist.

Relationship

It is not clear what the bone of contention was between the two. It is only stated that the victim was involved in a relationship with Gumedze before she decided to call it quits. Gumedze made her first court appearance yesterday at the Manzini Magistrate's Court.

The prosecutor applied that he be remanded back into police custody pending recovery of the complainant.

The magistrate ordered that the accused be remanded back into police custody, however Gumedze applied to be released on bail. He was granted bail fixed at E3 000.

The bail conditions were that the accused must not be found to have committed a similar offence while out on bail. He was further warned not to interfere with crown witnesses. Gumedze is expected to be back in court next week Tuesday.

# Over 20 homesteads ravaged by Saturday storm



# Education budget not for teacher salaries but improving the sector

WITH less than 24 hours left before Minister of Finance Neal Rijkenberg delivers the much anticipated national budget speech, unions and organisations have advocated for the education sector to be allocated a fair percentage of the budget.

Rijkenberg will be delivering his first budget speech tomorrow in parliament since he was appointed minister of finance by His Majesty King Mswati III in November last year.

The Swaziland Network Campaign for Education for All (SWANCEFA) said they have noted that in the past, a huge chunk of the education budget goes to paying teacher salaries and administration, but in 2019 their wish is to see salaries of teachers being moved to civil service and the budget to education be dedicated to expanding access to education and improving the quality of the education system.

This must include building of classrooms and integrating technology in schools.

This was revealed by SWANCEFA National Coordinator Nelisiwe Nhlabatsi when asked about the entity's expectations on the budget tomor-

She said they expected government to spend not less than the internationally recommended amount of 20 per cent of the total budget or 6 per cent GDP on education.

"How funds are allocated is also critical, we are advocating for sufficient allocation to marginalised groups such as children with special education needs. Also it is important to sufficiently invest in early childhood education and expanding access to pre-school or grade zero education for children in Eswatini.

"We also noted that in the past a huge chunk of

# TUCOSWA wants govt to do organisational audit

IT will not help government to mitigate on issues of salary increment while there are 'ghost employees' in its payroll hence the need to have an organisational audit that will wipe out the problem.

An article from a local publication recently revealed that there are over 3 000 ghost employees in government's payroll. The Trade Union Congress of Swaziland (TUCOSWA) Secretary Mduduzi Gina said the issue of civil servant's salary increment remains a priority to them as a union but government needs to tackle the issue of ghost employees who are milking on the ailing economy.

"The country will not move forward in terms of service delivery if those that are expected to carry out the mandate of government to provide services are disgruntled. It is of interest to us to have the minister address the issue on his speech. However, at the moment we can't have a figure that can see government overcoming the salary increment issue because a lot of people are in its payroll yet they are not working. We need an organisational audit that will deter-

Gina said another issue of priority is consistency in the payment of the elderly social grants which also needs to be reviewed and adjusted because seemingly the elderly are not given primacy, which was very wrong. He said a nation that disregards its elderly gets clouded by misfortune. "There has to be a regulation that gives the elderly the power to exercise their rights in getting the social grants because right now, it seems as though it's a favour for them to get the grant and they can't question anyone even if they get less than they are supposed to get". Gina said the Health and Education sector should also be prioritised in the budget as they are two critical sectors.

"The Free Primary Education is a constitutional right and as a country we can't dodge it but we are also looking to get quality as well so government should set aside adequate resources that will see the pupils go all the way to tertiary."

"Education is the most critical sector. We have over 800 schools and about 16 000 teachers in the country and the number of students seeking scholarship is increasing each year. The expectation is that government should allocate 26 per cent of the budget to education".


Sin tax was also increased in South Africa's budget speech delivered by Finance minister Tito Mboweni a week ago.

A sin tax is an excise or sales tax specifically levied on certain goods deemed harmful to society and individuals, for example alcohol and tobacco, candies, drugs, soft drinks, fast foods, coffee, sugar, gambling and pornography. Du Pont feeling is that increasing sin tax will give room to manufactured product's tax to be reduced.

"Domestic investment is the backbone of the

country's economy and it is of importance to have the finance minister cutting tax on locally manufactured products. Foreign investment should find us on or two feet in terms of Small, Micro and Medium Enterprises (SMMEs).

Meanwhile, Swaziland Consumer Association Chairman Bongani Mdluli said increasing sin tax will not help that much because spending on these items depends on the attitude of the people. "Those are just habits and no matter the circumstances, people will always spend on them yet it doesn't bring any benefit to them. Instead, they become government's burden when they fall sick". Mdluli said he expects the minister to prioritise issues of education, agriculture among others.

# Lordship Justice Fikile Nhlabatsi puts murder, other cases to rest

ABOUT 10 different cases have been put to rest after her Lordship Justice Fikile Nhlabatsi handed down sentences on pending cases backdating to 2014.

Sentencing was done in just a day.

These cases include murder, attempted murder and culpable homicide, where suspects saw themselves receiving sentences as high as 15 years without an option of a fine.

One pending case to be put to rest was that of Elliot Ngwenya, who was sentenced to 15 years in prison without an option of a fine.

His sentence was then backdated to November 1, 2015.

Ngwenya was arrested and charged with attempted murder on November 1, 2018 at Khombaso area, where he stabbed his girlfriend at the time by the name of Lomdladla Matsenjwa with a knife in the abdomen.

He had been from a drinking spree when he found Matsenjwa preparing supper and he asked that she handed him a knife which she did without question, and before she knew its the knife was thrust in her abdomen without any provocation.

#### Witness

She ran to her neighbours whilst bleeding and with the knife still stuck in her abdomen. At the time the accused was following her and the neighbours called community polices, who immediately called police officers and she was rushed to Pigg's Peak Government Hospital, where she was admitted for six days.

Another to be sentenced was Sikhumbuzo Sipho Masilela, who was arrested on April 3, 2014 at Nkwalini area after he stabbed his girlfriend Nonkhululeko Matsebula to death, who was also his

A witness who was a neighbour to the couple told the court that she heard the deceased screaming for help and when she ran to the house, she found that she had already been stabbed and was bleeding profusely.

The accused then went to another neighbour's house and asked that they rush the deceased to hospital as he had injured her.

Police were called and he handed the knife he used to stab Matsebula and was

arrested.

Masilela was sentenced to 10 years in prison without an option of a fine.

Mfanimpela Sifundza was arrested and charged with culpable homicide after he stabbed his wife, one Phetsile Mbhamali with a spear with intent to

The incident happened on December 22, 2015 at Lomahasha when the accused went to his wife's parental home in search for his wife, who had left home and in the processt he was carrying a spear, which he had hidden under his

Upon arrival his wife spotted him and fled.

He ran after her and when he caught up with her, he stabbed her once in her right shoulder and twice on top of her left breast. She lost consciousness and neighbours who heard her screaming for help rushed to the scene and police were called. She was rushed to Lomahasha clinic, where she was deemed critical and she was transferred to Good Shepherd Hospital, where she was admitted.

The accused was sentenced to 15 years in prison without an option of a fine and his sentence was backdated to December 22, 2015.

# Catering college vanishes with students' E50 000 tuition

A supposed catering college owner has been accused of vanishing with almost E50 000 which has been paid by desperate Emaswati in pursuit of furthering their education.

Unitex Catering College owner Sifiso Gamedze allegedly went missing after taking money from people who wanted to study catering in his school.

One of the victims claimed that she paid E4 000 as tuition fees at the catering college.

Worth noting is that the tuition fees at the supposed college in Matsapha varied for unknown rea-

"Some said they paid E 4 900 tuition fees," the aggrieved local said, adding that the catering course she would enrol for would last up to three months, starting from January

It is said classes started, but only lasted for three weeks.

"We only went to school for only three weeks in January. I was a full time student at the college. My classes were from Monday to Thursday," she said.

Currently, the owner of the catering school supposedly vanished without a trace.

When the publication tried to reach him to clarify the situation, his phone rang unanswered. Allegations are that Gamedze is originally from Siphofaneni.

When the students were asked how they located the college, they claimed that there were adverts on Facebook by a certain Nomphumelelo Gamedze, who is allegedly working with Sifiso Heizo Gamedze. There is also a WhatsApp group that was formed for communication purposes.

Apparently, the WhatsApp group is no longer functional.

Another source claimed Gamedze had been operating the supposed fly-by-night catering college for almost three years. The source said the collage was once located at Luve in 2017 and left without students having completed their three-month courses.

"The college has been hoping from town to town. It is just that last year they then started advertising on social media," said the source.

Another victim said they reported the matter to the Matsapha Police Station, but they are still awaiting a response. When the reporter tried to reach Gamedze's cellphone it rang unanswered.

The reporter was able to locate his mother, who identified herself as Make Hlandze. She told the publication that Sifiso had been away from home for over two weeks.

"We are also looking for him, he has been gone from home for more than two to three weeks now. We do not know where he is," she said.

His mother confirmed that her son had a catering college in Matsapha that has been shut down. She added that people had been storming her home looking for her son.

Meanwhile, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the matter had been reported to the police.

# Singeni sugar cane farmers want executive board removed from office

YET another sugar cane farmers' company is embroiled in a leadership dispute, as members of Singeni Investments (Pty) Ltd have taken their leadership to court as they want the current board removed

Sabelo Dlamini and Sipho Shabangu have filed an urgent application at the High Court, seeking an order that the board comprising Japhter Dlamini, Musa Shongwe, Siboniso Magagula, Erick Dlamini, Nomsa Shongwe and Sikhumbuzo Maphanga be removed appointed, because the six are failing to conduct elections as their term of office had lapsed.

The two are also seeking an order that members and shareholders of the company are ordered to conduct elections of the executive board within two weeks from grant of the court order, which results shall be final and binding to all parties.

According to Sabelo the first applicant in his affidavit, as duly authorised to depose of same by the aggrieved members, they are a company that was formed by the members at Tshaneni to deal with sugar cane farming and the respondents are the first execu-

from office and an interim board tive committee (board).

He submitted that in terms of their constitution, the respondents were to be in office for a period of three years and then the election of a new executive be conducted and the elections to replace the respondents were to be held in July 2018.

However, for reasons best known to them, the respondents extended the elections to November 2018 and remained in office much against the dictates of the company's constitu-

"It was a grave concern amongst the members of the company that the respondents did not want to move out of office, and they were frustrating every move to have the elections

conducted to the extent that the applicants were appointed by the general membership to work with them, but the respondents also frustrated this Sabelo submitted.

Priority

He stated that their financier, FIN-CORP, even raised a concern with the delay in conducting the elections, as it was long overdue and was causing malfunctioning of the company since it was made a priority that when the financier extended finance to the company, elections should be a priority with a new executive for the proper administration of the compa-

On January 30, 2019 when the election were supposed to be conducted, the first respondent Japhter, who is the chairman, indicated that the elections could not proceed as there was a matter that is pending in court.

He further submitted that as a result of such frustration, the company has not been doing well such that dividends have not been shared, and it appears that such will prevail if the issue of the elections is not sorted out.

He highlighted the fact that the court will take judicial notice of the fights that are on the rise in the sugar cane growing industry, where board members do not want to move out of office ,with the courts being flooded with similar applications such as the present one. The matter is still pending in court.

# Govt committed to work towards protection of women, girls

ESWATINI has prioritised the eradication of gender-based violence (GBV) and promotion of gender equality for the attainment of sustainable development in the country.

Deputy Prime Minister Themba Masuku said government has spearheaded a number of initiatives and developed interventions to ensure it prioritised these.

He was speaking through Minister of Labour and Social Security Makhosi Vilakati during the One Billion Rising Campaign held at Mafutseni Inkhundla on Saturday.

Masuku said during the development of the National Gender Policy, it was his hope that such would facilitate the amendment of legislation and influence positive changes for implementation of activities aimed at achieving gender equality.

#### Guide

He added that the policy would serve as a guide to address the strategic needs of both women and men.

The DPM said its implementation has taken place to some extent, through the enactment of the Sexual Offences and Domestic Violence Act 2018 (SODV), which addresses the legislative changes that the policy envisaged.

With the firm and clear definition of offences, and the heavier sentences and fines imposed by the SODV, it is anticipated that there shall be a decline of GBV cases, and a full eradication eventually.

"Measures have been taken to ensure training of prosecutors and continue to train the Royal Eswatini Police Service (REPS) on the law, for full maximisation of the protection it affords to victims, and in also holding the perpetrator to account for his actions," said Masuku.

Masuku added that the national strategy and action plan to end violence in Eswatini 2017-2022 speaks to the collaborative and multi-sectoral integrated measures to prevent and eliminate violence in the country.

"The strategy details an action plan which includes collaboration with key stakeholders such as Women and Law in Southern Africa (WLSA), who are a very strategic partner with government and who have brought us here today for the One Billion Rising Campaign," the DPM added.

He said through the Department of Gender and Family Issues, the DPM's office have over the years collaborated and partnered with various stakeholders on different programmes or campaigns to eradicate gender-based violence. "Also cognisance of the various campaigns that some stakeholders are currently running, such as: the Musumbulala Uzomdinga Campaign by the REPS, the End Violence against Children Campaign by World Vision as well as the "One Billion Rising Campaign" by WLSA," added Masuku.

Masuku called on other stakeholders to join in the fight against GBV and further urge them to come up with campaigns that will strengthen the work currently being done.

He noted that these initiatives were extremely important as they are the means through which members of the community could be educated on various issues affecting them.

# Resources

However, DPM said currently, government does not have the necessary resources to reach every single person in the Kingdom. Therefore it relied on collaborations and partnerships.

Masuku said government is currently focusing on the economic turnaround strategy to ensure that the country develops sustainable economy that will facilitate the necessary resource allocation for the eradication of GBV.

"It is our intention not to 'leave anyone behind' as per the sustainable development goals. In this case, government intends not to leave any victim of GBV unprotected. The protection and promotion of a victim's rights should be at the forefront of any implementation of the SODV and any other law or policy."

He added that by strengthening existing partnerships and collaboration in a multi-sectoral integrated manner, it will be ensured that the fight against GBV becomes a way of life and erad-

icate it by 2022 as per the government's strategy. The DPM said he wished to ensure the nation that government remains committed to its objectives in the national policy and will continue

to work towards the protection of women and girls.

"We will work tirelessly to eradicate GBV and make Eswatini a violence-free country," he said.

# ...SODV Act a victory

THE Sexual Offenses and Domestic Violence Act is a victory, not just for survivors of gender based violence, but also for the society.

This was outlined by United States Ambassador Lisa Peterson when presenting her speech at the One Billion Rising campaign hosted at Mafutseni Inkhundla on Saturday.

Peterson said she was honoured to be part of the campaign and urged every citizen to stand against gender based violence. She stated that one of the greatest milestones of 2018 in the country was the enactment of the SODV Act.

The ambassador said more important than just the enactment of the law is the fact that perpetrators are already being convicted under the law.

#### Law

She added that the work does not just stop because a law is now in place. In some ways the work becomes more difficult, because some of the things that still need to change are behaviours and beliefs.

A critical part of behaviour change in Eswatini will be changing the culture of silence around gender based violence. It is time to reject the notion that we, as bystanders have no role to play in the violence perpetrated against our loved ones, friends and neighbours she added.

Gender based violence is at the top of the spectrum of behaviours that are rooted in attitudes and beliefs about women and men. The stereotypes that dictate women's submission to men, or the implicit biases that say some people just do not deserve as much as others.

She said when culture or law restrict women's ability to own land, manage matrimonial property or inherit more than just a child's share, society is saying that women simply are not worth as much as men.

Peterson also urged Eswatini to seek new avenues of engagement on issues that disadvantage, discriminate against or victimise women.

She added that as all parties continue to work toward women's equality, the U.S Embassy stands ready to listen, discuss and explore new approaches to combat gender based violence and its foundation across all levels of society.

# MAN (33) DIES IN A CAR ACCIDENT



# 'Christian fraternity ashamed of some church leaders'

THE Christian fraternity is reportedly feeling ashamed of some church leaders who constantly find themselves listed amongst law breakers and engaging in adulterous affairs.

This was stated by Pastor Themba Malangwane during the Lubombo regional prayer service which was held at Matsetsa School for the Deaf last Friday.

Amongst the prayer items, the gathering prayed for sound leadership in churches.

When delivering his sermon, Malangwane noted that some churches were led by individuals who have 'anointed' and decorated themselves with titles such as pastor, reverend, evangelist, among other titles, while their social behaviour appeared to be the opposite of how Christians should present themselves in the

"This is why you would find more women than men in most churches; men are not happy with the way some church leaders conduct themselves in the communities," he said. Malangwane further warned Christians against being judgemental to people who still want to repent from their sins.

He noted that Christians would have a bad attitude when a known non-believer visit their church for a Sunday service.

"Christians must learn to accommodate all people, regardless of their religious beliefs," said the pastor. Malangwane the senior Pastor of Evangelical Assemblies at Simunye said people learn more from what a Christian does than what he speaks.

# Angry customers drop spoilt meat at EEC premises after blackout

A thunderstorm which was experienced in some parts of the Lubombo region has left hundreds of homesteads in Siteki without electricity supply for over two days.

The thunderstorm, which was accompanied by strong winds, was experienced on Saturday evening. Areas such as Mhlumeni, Lugongolweni, Mlindazwe, Moyeni, Siteki CBD, Mzilikazi and others reported electricity outages immediately after the storm subsided.

Yesterday, a number of customers cranmed the Siteki Depot of Eswatini Electricity Company (EEC) to make a follow up on their reported faults. The visibly frustrated customers claimed to have reported faults on Saturday evening, but until yesterday, they had not been attended to. Some also alleged to have reported similar faults last Friday.

To illustrate their frustration, some of the customers brought spoilt meat portions and dropped them at the entrance point of the EEC offices. They stated that the electricity outage had resulted to foodstuffs which had been kept in refrigerators getting spoiled. "Right now I have no food in the house after my foodstuff which could be valued at over E1 000 have just gone to waste," said a visibly angry lady. who was found at the EEC offices. Business in the town centre was said to have also been affected when an electricity outage was experienced in the early hours of yesterday. Affected businesses included those which are housed within the main Siteki market. The customers said they were mostly infuriated by the staff at the EEC offices, as they seemed not to be taking them seriously. Meanwhile, some workers who were found at the depot disclosed that there have been over 600 faults reported around Siteki alone. By noon yesterday, the technicians were said to have only attended to less than half of the reported

# POLICE HAVE SHORTAGE OF WORKING TOOLS

SHISELWENI Regional Secretary Zwakele Dlamini says Eswatini's laws were lax when it comes to protecting police officers.

He said unless something is done, members of the public will continue abusing police officers.

He said it was time the courts hand down heavy sentences on anyone who would be found to have abused police officers on duty.

The RS was speaking during the visit of Prime Minister Ambrose Mandvulo Dlamini, who met with Shiselweni police as part of his familiarisation tour. The police service falls under the PM's office.

The RS said it was worrying to see police officers assaulted yet they are trying to maintain law and order.

He said that the way things were happening in the country, it was not different that there were no laws to protect police officers when going about their duties. "It is high time the country enacts laws which will specifically deal with the imbeciles who disturb police when executing their duties. Police need to be protected and for someone

to have the guts of beating up a police officer, it shows that our laws need to be tightened. In other countries such as in America, there is a heavy penalty for anyone found to have beaten or assaulted a police officer. It's time we do the same even in this country," said Dlamini.

The RS told the PM that police officers in the region were dedicated to their work. He said even the working relationship with all the government departments was good. "I must say as the regional administration office, we are happy with the way police are doing their work," said Dlamini.

#### Believed

The RS turned to the PM saying he was appointed to the position at a time when things were tough for the country. He said he believed in the PM adding that he was hopeful that he (PM) would save the country.

Dlamini stated that the PM was capable of making things happen including reviving the economy which has taken a nose dive. He said with the police service being a critical body whose work needs to be taken serious, the PM and his cabinet should do something with regard to the budget for the service. He said it was an open secret that there were not enough resources in the police service, hence at times, police encounter problems in executing their work.

"It is sad to see police officers sacrifice their own resources when doing government's work. There is a need to fast-track implementing the police budget, it should be a priority and should not be delayed as the present situation has turned us as a country, into a laughing stock.

"There is no way the officers have been motivated when considering that they don't have working tools. Others are found hitchhiking to attend to accidents or to crime scenes. Something needs to be done honourable PM," said

About promotions, the RS said it was worrying that it was like officers from the region were not considered. He said when promotions were announced, the list of promoted officers were usually dominated by the other regions.

"Officers from the region are left out each time promotions are announced and if there are those that are fortunate to be considered, the number is usually low compared to those promoted in the other regions. You then start wondering what criteria is used in this exercise," said Dlamini.

JOHANNESBURG - It's a Sunday morning and a healing and deliverance miracle service is on at the Alleluia Ministries International Church, north of Joburg, led by Pastor Alph Lukau.

Wheelchair-bound congregants are rising up and walking, those who struggle to walk and use crutches toss them aside and start running. But something much bigger is about to hit.

While these miracles were still going on inside the church, a hearse pulls up outside, with weeping family members in tow.

Lukau is called outside to tend to the mourners, who've brought a deceased man in a coffin. He'd allegedly been dead since Friday.

Some minutes later, the coffin is opened, with thousands of eyes now watching, Lukau lays his hands on the dead man in a white suit named Elliot, prays and boom! - the man is brought back to life.

Miracle

The congregants and Elliot's family lose it. A miracle has happened right before their eyes and in broad daylight.

A clip of the 'miracle' is posted on social media, sending users into a frenzy over the authenticity of this alleged act of God wrought through the hands of a 'man of God'.

Ouestions from the public have varied: Is this real? Why did the man not look like someone who'd been dead two days? Where is his death certificate? Why was he not immediately tended to by a health care professional?

The funeral parlour which brought the coffin to the church, Kings and Queens Funerals, were duped into being part of the spectacle.

The questions outnumber the answers by far. Of course, social media could not pass the opportunity to turn this into a challenge. Introducing the Dead Man Challenge.

This gala dinner did not come cheap though. The cheapest ticket was R450, while R5 000 got attendees a seat at the


The following Sunday at his church, a mass wedding was held with women who'd attended the dinner getting married to their partners.

# How pollution and greenhouse gases affect the climate in Sahel

OVER the last decade many countries in the Sahel region - the semi-arid southern edge of the Sahara that stretches from Senegal to Ethiopia – have been embroiled in conflict.

Populations in these countries are growing. This means that resources are increasingly scarce, and a highly variable climate is making agriculture based livelihoods more uncertain.

These events in the region have been linked to climate change.

Over the last 100 years there have been major swings in the region's climate. Abundant rains in the 1950s and 1960s were followed by persistent drought in the 1970s and 1980s. The period since the mid-1990s is characterised by the alternation of good and bad years.

My latest research attributes this evolution to emissions from fossil fuel burning. We show that the most recent generation of global climate models account for the Sahel's persistent drought when information about emissions of pollutants and greenhouse gases is included.

And that these models can do that. This is because they simulate changes in ocean temperatures and in regional rain consistently with what's observed in the real world.

This is the first time that the 20th century evolution of rainfall over a region is shown to have been directly affected by human emissions specifically pollutants and greenhouse gases. It's also the first time that a single argument is proposed that consistently explains natural fluctuations and anthropogenic change. This argument rests on the influence of the oceans on regional climate.

#### **DRYING SAHEL**

The Sahel gets its rain from moisture that is carried by monsoon windsfrom the North Atlantic

As air rises, it cools and condenses the moisture that falls back as rain. The warmer the North Atlantic Ocean, the greater the moisture that evaporates from its surface and is carried onto land, the wetter the Sahel.

But whether air can rise locally depends on where else air is rising globally. For example, during an El Niño event, air rises over a much warmer tropical Pacific, and, sinking elsewhere, produces widespread drought.

During the second half of the 20th century greenhouse gases warmed the tropical oceans, making conditions for air to rise elsewhere similarly unfavourable.

At the same time the amounts of fine solid particles - known as sulfate aerosols - that were emitted by coal-fired plants increased, as countries rebuilt their economies after World War

These cooled the North Atlantic directly, by reflecting incoming solar radiation, as well as indirectly, by favouring the formation of clouds which in turn reflect incoming radiation.

Our analysis of an ensemble of 29 global climate models shows that the unique combination of the warming of tropical oceans - caused by greenhouse gases - and cooling of the North Atlantic Ocean - caused by sulfate aerosols that characterised the second half of the 20th century led to the drying of the Sahel.

Our analysis also shows that despite the role of greenhouse gases in past drought, drought is

not necessarily the future of climate change in the Sahel.

Now that sulfate aerosol emissions have been drastically reducedaround the North Atlantic, thanks to environmental legislation aimed at reducing acid rain and the public health consequences of pollution, warming has picked up in the North Atlantic Ocean.

Therefore, projections for wetter conditions under warming are in line with the explanation given above: air can now rise over the Sahel, fuelled by the increased moisture imported from a warming North Atlantic Ocean, in a challenge to the sinking motion imposed by warming tropical oceans elsewhere.

Projections are also in line with emerging trends in observations toward a more vigorous water cycle: the more intense, though perhaps less frequent, rainfall events that have led to recurrent episodes of flooding over the past decade.

### **FUTURE POLICIES**

Attribution of Sahel drought to emissions demonstrates that climate change is real, and is already here. Technologies to adapt to drought and more generally to climate variability do

They include seasonal climate prediction and land management practices like agro-forestry. conservation agriculture, and soil and water conservation, which already play a role in resilience

However, given the societal pressures mentioned at the outset, to develop the Sahel needs to diversify economies away from agriculture. This needs a lot more energy than is produced in the Sahel at present.

Within the global context of climate change policy it is mitigation that opens up the opportunity to develop sustainably, with support for an energy transition toward renewable energy particularly appealing in a region endowed by an abundance of sun and wind.

# S. Sudan peace deal offers promising end to conflict

JUBA - Many attempts at ceasefires and peace deals have failed in South Sudan.

But a 2018 peace agreement, signed five years after the 2013 conflict began, has inspired hope for a lasting peace treaty.

As part of the deal, former rebel leader Riek Machar has rejoined the government and resumed his vice president duties. However, it's still unclear when Machar will to return to the capital Juba.

The young nation hasn't fared well since the optimism that was felt around the world when the Republic gained its independence on July 9, 2011.

Trouble began in December 2013, a mere 17 months after independence, when a power struggle within the ruling Sudan People's Liberation Movement divided the political

The movement is the political wing of the guerrilla army that led the struggle for independence.

President SalvaKiir retained leadership of the movement and his deputy, resigned from government to form the SPLM In Opposition.

The split triggered a new civil war between the two men's supporters. It started in Juba but by the start of 2014 it had spread across the country

Sudan had once again descended into chaos assisted in no small way by the interference of its neighbours. Both Uganda and Sudan are reported to have backed factions during the

The expectation for sustained peace and prosperity had begun to fizzle until late 2018 when a revitalised peace deal was reached.

The hope is that peace will prevail. But after so many failed attempts to end hostilitiesthere is some scepticism. Can this latest truce hold?

# PROMISING ENDING

This deal certainly offers a promising end to

the young nation's conflict. Since the regionally brokered agreement was reached, President Kiir has also signed a declaration giving amnesty to the troops, army generals, and leaders of the SPLM in Opposition.

The amnesty included Vice President Machar and was an important gesture showing Kiir's commitment to moving on from the senseless war.

Moves such as these inspire optimism because they suggest that the government of South Sudan is finally committed to creating a functioning republic. So far Kiir and Machar have shown a willingness to act responsibly towards the successful implementation of the peace

But a lot still remains to be done. Stake holders like the Intergovernmental Authority on Development, the African Union, United Nations, and other state and non-state actors must actively support the peace process. Their first challenge would be to manage the region's refugee problem.

### REFUGEE MANAGEMENT

Regional stability should be considered a priority. East Africa is a volatile region with many shared problems.

A political challenge in any given state has the potential to immediately impact neighbouring states. And conflicts in any of the countries in the region have over the years created a variety of problems, one of which is an enduring refugee crisis.

Ethiopia now tops the global list of countries with the highest number of internally displaced citizens. Meanwhile, more than 800 000 Somalis have sought asylum in neighbouring countries.

In South Sudan, 2.4 million people have fled to neighbouring countries because of the war. Just over 2 million are internally displaced. Together, this is more than one third of the country's population.

This is a humanitarian crisis as well as a security risk because refugees are often targeted for recruitment by rebels, and even terrorists.

Refugee management and successful repatriation of nationals must therefore be a key pillar of South Sudan's peace strategy.

### SOLID COMMITMENT

The second dragon that South Sudan must slay is disunity. The two SPLMs must present a united front. Their conflict resolution arrangements must be upheld at all costs.

If Kiir and Machar succeed in holding it together this time around the people of South Sudan may have a genuine shot at a peaceful existence. Which is not to say they won't face some obstacles along the way.

There have already been a few violations to the cease fire agreement. This is a worrying development that must be nipped in the bud if South Sudan, its neighbours, and the world are truly committed to a viable peace process.

# Eswatini targeting 50% electricity from renewable energy sources by 203

ESWATINI has set a target to have 50 percent of all electricity consumed in the country generated from renewable energy sources by 2030.

This is also contained in the Energy Master Plan by the ministry of natural resources and energy, which will provide a long term planning roadmap for the development of new generation capacity for the country from 2018 to 2034.

This was revealed by Acting Minister of Natural Resources and Energy Prince Simelane during the opening of the Electrifying Eswatini's Sustainable Future seminar hosted by Siemens last Thursday.

In his remarks, the minister said the Plan has stemmed the shortterm generation expansion plan which provides information on the first technologies, initial capacities and timing of the generation capacity to be procured and delivered within the next five years.

"This short-term generation expansion plan identified solar photo voltaic and biomass power projects to be procured in the first procurement ...government implementing a new policy under which the procurement of new power generation IPPs will be undertaken through public competitive tendering processes

The minister also mentioned that government was tirelessly working towards increasing the country's energy security by reducing reliance on electricity imports, which currently sit at around 80 per cent, as the country is only able to generate about 20 per cent of its electricity needs.

"This aligns with the country's vision of attaining first world status by 2022 as sustainable energy supplies remains the key driver for

socio-economic growth. His majesty the king, in his recent Parliament Opening speech, underscored the importance of turning around the energy situation by looking into strategies to create enough energy for the entire country and export any surplus produced.

"In order to achieve this goal, government has been and will continue encouraging the development of renewable energy projets to meet our clean energy objectives and to underpin sustainable economic

growth," he said. The minister however noted that government cannot achieve this task alone but needs to work with the private sector.

"To foster our partnership with the private sector and to ensure the orderly development of new generation capacity that will achieve government's strategic objectives, government is now implementing a new policy under which the procurement of new power generation by independent power producers (IPPs) will be undertaken through public competitive tendering processes based on the country's laws, regional and international best-prac-

"As opposed to the unsolicited generation capacity procurement method, the competitive tendering process will ultimately benefit electricity users in the country as bidders will offer most competitive tariffs in relation to the technology being employed. I can mention that in the next few weeks, a request for Qualification will be launched to mark the beginning of the procurement process," he said.

# Council begins property valuation exercise

EZULWINI- The Ezulwini Municipal Council has begun a property valuation exercise and will issue out notices on a draft valuation roll of 2018/19 on May

Town Treasurer Ruth Maziya made this announcement during a meeting with residents last Tuesday and Thursday stating that the deadline for submission of objection to this roll was June 6.

She also informed residents that Council had appointed Christian Amoako & Co Pty Ltd to prepare the 2018/2019 General Valuation Roll.

"The Valuer will have an identification card and a letter introducing him or her to enter into and upon any land or buildings within the Ezulwini urban area at all reasonable hours during the day time. This started on February 11 and is expected to be end on March 16, 2019," she said.

She said this was in line with Section 10 of the Rating Act which states, "The Local Authority shall from time to time, but not less than once every 5 years, or such longer or shorter periods as the Minister may approve, cause a valuation to be made of all immovable property within its area and cause a valuation roll to be prepared."

She humbly requested residents to participate and cooperate with the exercise. During the IDP consultation meeting, the residents had a chance to pose questions on the roll out of the valuation roll as well to the appointed Valuer.

# Stocks climb as China soars on optimism over trade

SHANGHAI - US equity futures advanced alongside stocks in Europe and Asia after President Donald Trump postponed the date for boosting tariffs on Chinese imports, taken as a sign of progress in the trade talks. Bonds fell and the dollar retreated.

The headlines boosted carmakers and miners, fueling an advance in the Stoxx Europe 600 Index, with contracts on the

Asia, the Shanghai Stock Exchange Composite Index rallied the most since 2015 and the yuan strengthened after Trump said he will delay the March 1 trade deadline, and as comments from China President Xi Jinping suggested top officials will focus on growth rather than cracking down on leverage. Emergingmarket currencies and shares advanced despite China's state-run Xinhua news Nasdaq and S&P all climbing. In agency later publishing a commentary

saying talks will be harder at the final stage. Treasuries and core European bonds slipped, while Italy's securities advanced and the euro strengthened.

"This is a sigh of relief," Ben Emons, managing director for global macro strategy at Medley Global Advisors, told Bloomberg TV. "Markets will still keep a level of caution, but this news is encouraging."

# In one Market South Africa bonds look like junk

JOHANNESBURG - The consensus among economists is that South Africa will hold onto its investment grade status for the time being. Derivatives traders are not so sure.

The cost of insuring South Africa's government debt against default is higher than Brazil's, which has a non-investment grade rating from Moody's Investors Service, S&P Global and Fitch Ratings. South Africa's five-year credit default swaps were trading at 184 basis points yesterday, compared with 162 for Brazil.

Moody's, which ranks South Africa's debt at the lowest investment level, is reviewing its assessment on March 29. The CDS spread was 164 basis points when the company last reviewed, and affirmed, the rating in November. S&P Global Ratings and Fitch Ratings both cut the country's debt to junk in April

"The current CDS signals the market pricing in moderate risk of a down-

grade," Shireen Darmalingam, a Johannesburg-based economist at Standard Bank Group Ltd., said in a client note. "Nevertheless, despite South Africa's fiscal outlook now even worse and the economic outlook even bleaker, we believe that Moody's will likely keep the sovereign rating unchanged."

Finance Minister Tito Mboweni's budget last week went some way toward allaying concern about a cut to junk.

# EU SEES FIRST ARAB SUMMIT AS RESPONSE TO RUSSIA, CHINA

SHARM EL-SHEIKH -European and Arab leaders last Sunday opened their first summit in a bid to bolster cooperation as EU President Donald Tusk said neighbours 'should not leave it to powers far from our region', alluding to China and Russia.

Host Egyptian President Abdel Fattah al-Sisi painted a 'bleak' picture for a region hit by wars and terrorism as he appealed for deeper cooperation, in his opening summit speech at the Red Sea resort of Sharm el-Sheikh.

European Union countries view the summit as a way to protect their traditional diplomatic, economic and security interests while China and Russia move to fill a vacuum left by the United States. Tusk, the president of the

European Council who organises summits for EU countries, acknowledged 'there are differences between us' but said neighbours had more at stake than distant powers.

"We need to cooperate and not leave it to global powers far from our region," the former Polish Bashar al-Assad in his civil war.

European Council who organis- premier told leaders from about 40 es summits for EU countries, countries.

He did not name those powers but an EU source confirmed he meant China and Russia. China is increasing trade with the region and has established a military base in Djibouti. Russia militarily backs Syria's President Bashar al-Assad in his civil war. EU sources said the first EU-Arab summit is all the more important as the United States "disengages" from the region while Russia and China make inroads.

"We don't want to see this vacuum soaked up by Russia and China," one of the sources told AFP.

# New Sudan PM sworn in as protesters rally against emergency

KHARTOUM - Bashir imposed a year-long emergency last Friday after a deadly crackdown failed to suppress weeks of protests against his three-decade rule.

The veteran leader, who swept to power in an Islamist-backed coup in 1989, dissolved the cabinet and provincial governments, and pledged to bring in technocrats to help end the economic crisis — the key factor behind the protests.

Last Sunday, former governor of the agricultural state of Jazeera, Mohamed Tahir Ela, was sworn in as the new prime minister at a ceremony, an AFP photographer said.

Defence Minister General Awad Ibnouf was also sworn in as the first vice president after his predecessor Bakri Hassan Saleh was sacked by Bashir.

Bashir also swore in 16 army officers and two officers from the National Intelligence and Security Service as new governors for the country's 18 provinces.

protests that have rocked his rule.

Even as the new officials took oath, hundreds of protesters rallied in Omdurman, the twin city of Khartoum, against the state of emergency. "We want to give the president a message that the state of emergency will not deter us," said protester Sawsan Bashir.

"Our aim is to overthrow this regime and we will do it."

Protest organisers have vowed to continue with daily rallies, accusing Bashir and his officials of mismanaging the economy that has led to soaring food prices and shortage of foreign currency.

Deadly clashes between protesters and security forces have left 31 people dead since protests first erupted on December 19, officials say.

Human Rights Watch says at least 51 people have been killed including medics and children.

Protests initially erupted in the labour town of Atbara after a government decision to triple the price of bread. But the rallies swiftly escalated into protests against Bashir's iron-fisted rule, with protesters calling for his resignation. *AFP* 

# Anger as UK's May asks for yet more time to amend Brexit deal

LONDON - British Prime Minister Theresa May last Sunday called for still more time to renegotiate her Brexit deal, and drew outrage by suggesting parliament may not be able to vote on the text until just 17 days before Britain leaves the EU.

Business leaders and MPs reacted with anger and dismay at the news, which also prompted fresh calls to delay Brexit to avoid a damaging 'no deal' exit on March 29.

Three of May's ministers had earlier warned that the House of Commons would seek a delay if there was no breakthrough this week.

May had raised the possibility of a vote on her deal in the coming days, but said last Sunday she was still negotiating with the European Union. "As we're continuing with those talks, we won't bring a meaningful vote to parliament this week," she said at a summit of European and Arab leaders in Egypt. "But that will happen by March 12. And we still have it within our grasp to leave the European Union with a deal on March 29." Lawmakers last month rejected her withdrawal deal, and since then, May has sought to address their concerns about its so-called 'backstop' plan for the border between Northern Ireland and EU member Ireland.

# 'Scores killed in Nigeria poll violence'

ABUJA - As many as 35 people were killed in election violence in Nigeria civil society groups said last Sunday after voters went to the polls in a tight presidential race between President Muhammadu Buhari and businessman Atiku Abubakar.

The groups said the death toll during Africa's biggest election were higher than that of the 2015 poll which was widely considered to have been orderly, aside from a Boko Haram attack that killed more than a dozen people.

Past polls have been marred by violence and vote-rigging. Clement Nwankwo, convener of the Situation Room, which represents more than 70 civil society groups, said 16 people were killed in election violence across eight states, while Lagos-based consultancy SBM Intelligence cited 35 deaths. Police did not immediately respond to phone calls and text messages seeking comment. Buhari, 76, a former military ruler who is seeking a second elected term at the helm of Africa's top oil producer on an anti-corruption platform, faces Atiku, 72, a former vice president who has promised to expand the role of the private sector. *Reuters*

### Maduro faces 'diplomatic siege'

CARACAS - Venezuelan President Nicolas Maduro faced growing regional pressure last Sunday after his troops repelled foreign aid convoys, with the United States threatening new sanctions and Brazil urging allies to join a 'liberation effort'. Violent clashes with security forces over the opposition's US-backed attempt on Saturday to bring aid into the economically devastated country left almost 300 wounded and at least three protesters dead near the Brazilian border. Juan Guaido, recognised by most Western nations as Venezuela's legitimate leader, urged foreign powers to consider 'all options' in ousting Maduro, ahead of a meeting of the regional Lima Group of nations in Bogota yesterday attended by US Vice President Mike Pence.

Nigerian security personnel ambushed

IPOKIA - Two Nigerian security personnel, escorting election results from Ipokia in Ogun State, have been rushed to hospital after they were ambushed and shot. Sunday's ambush near the border of Benin came as Nigerians went to the polls last Saturday to elect legislative members to represent them in the National Assembly, the Premium Times reported Monday morning. The election officials were on their way to Oronna Town Hall, where they were expected to deliver the local government's house of representative and senatorial election results. Presidential and legislative electoral results are being collated across Nigerian states. During the attack, a security officer and a driver were shot and were subsequently evacuated to hospital.

President vows US\$30 billion transfer to villages

JAKARTA - Indonesian President Joko Widodo has pledged to raise the funds the government transfers to villages across the world's fourth most populous country to nearly US\$30 billion over the next five years if he wins a second term in April. The World Bank has questioned the effectiveness of the program, called Village Funds, while there are also concerns about how the transfers can fuel corruption. Widodo, who will be facing former military general Prabowo Subianto in a re-run of the 2014 contest, made the pledge in a televised speech on Sunday night. By the end of 2019, his administration would have transferred 257 trillion rupiah (US\$18.36 billion) to villages and this would rise to 400 trillion rupiah (US\$28.54 billion) if he got another five years, he said.

Ghana opposition picks ex-president to run in 2020

ACCRA - Mahama was the overwhelming favourite among seven candidates, winning 95 percent of 213 487 votes cast last Saturday, making him the flagbearer of the National Democratic Congress.

Mahama was president from 2012 to 2016, when he lost a re-election bid to President Nana Akufo-Addo of the New Patriotic Party (NPP) over a faltering economy and corruption allegations. "Tonight, I want to serve notice to Ghana that from the outcome of this election, the NDC is strong," Mahama said after his victory was announced.

"The NDC is united. The NDC is poised for victory in 2020."



CAPE TOWN - President Cyril Ramaphosa has appointed a special tribunal in a bid to fast-track proceedings from graft investigations by the Special Investigating Unit (SIU), the presidency said in a statement on Sunday.

"Fast-tracking these matters through the Special Tribunal will enable the SIU to recover monies and or assets lost by state institutions through irregular and corrupt means; thus ensuring that those who are responsible for the loss of monies and or assets by state institutions are held accountable. The litigation process includes both public and private sectors persons and entities," the presidency said.

Ramaphosa has appointed Judge Gidfonia Mlindelwa Makhanya, as the President of the Tribunal for a period of three years.

He also appointed Judge Icantharuby Pillay, Judge Johannes Eksteen, Judge Selewe Peter Mothle, Judge Lebogang Modiba, Judge Thina Siwendu, Judge David van Zyl and Judge Sirajudien Desai as additional members.

The tribunal seeks to tackle any civil proceedings brought before it by the SIU, which will investigate wrongdoing and malpractice in state institutions, state assets and public money, the presidency said in a statement.

# Juju makes quick appearance in Newcastle court



NEWCASTLE - The case against EFF leader Julius Malema has once again stalled because of his legal challenge of the law.

Malema made a brief appearance at the Newcastle Magistrate's Court on Monday where state prosecutor Jabulani Mlotshwa told the court that the matter could not continue until the finalisation of Malema's challenge of the Riotous Assembly act.

Malema filed an application to the Pretoria High Court in December challenging the constitutionality of the laws used to charge him.

Judgment was reserved on the matter. Mlotshwa said that there was no indication of when the Pretoria matter would be finalised but hoped it would be some time before March.

Malema faces separate charges under the 1956 Riotous Assemblies Act and the Trespass Act for inciting people to occupy any vacant land that they find. The charges stem from two incidents in 2014 and 2017.

In 2014 he told the EFF's elective conference in Bloemfontein: "We're going to occupy the unoccupied land because we need land. For us to eat, we must have the land.

For us to work, we must have the land. I come from Seshego – if there is unoccupied land, we will go and occupy the land with my branch. You must go and do the same in the branch where you come from."

In June 2017, Malema told supporters in the northern KwaZulu-Natal town of Newcastle that white people could not claim ownership of land because it belonged to the country's black African majority. The matter will be back in court

After his appearance, Malema strode out of court confidently to address about a thousand supporters who had each received EFF t-

# WOMAN WHOSE MEMORY WAS WIPED BY A RARE BRAIN INFECTION

SWANLEY - A computer analyst's short-term memory was completely wiped by a rare brain infection.

Clair Bennett, 29, of Swanley, Kent, suddenly developed 'violent headaches' and fevers in January 2015. Things took a turn for the worse when Ms Bennett became so disorientated she was convinced she was in the US.

After being rushed to Queen Elizabeth Hospital in Woolwich, south east London, Ms Bennett was diagnosed with the rare brain condition encephalitis, which doctors suspect was caused by a virus.

Following a two-week stay, Ms Bennett was discharged, only to be admitted three days later to Dartford's Darent Valley Hospital in Kent when her symptoms reappeared. After a two-month stint in hospital, Ms Bennett is home but unable to remember anything beyond the past few minutes.

And with doctors warning her short-term memory will never return, she even has to remind herself to shower and eat.

Ms Bennett - who cannot remember the six months before she became unwell - had been looking forward to a solo holiday to Australia.

But amid the excitement of her upcoming travels, she began to feel unwell. Told by her doctor it was likely just flu and she should rest, things took a dramatic turn for the worse on January 12.

Ms Bennett's father Mark, 60 - who is now her full-time carer - said: "Clair's work had phoned her flatmate to say she hadn't come in, asking if she was okay.

"When she went to check on her, Clair was really disorientated, asking if she was in America.

"She phoned me to let me know what was going on, but I wasn't sure why any of this was happening, or what to think of it, which I feel guilty about now."

By the time Mark and his wife Penny arrived, doctors had already diagnosed their daughter.

"They told my wife Penny and I to go home and get some rest, as she'd be in intensive care overnight,' he said. 'The next morning, we came back and she was awake, but very disorientated.

"She kept asking if we had missed Christmas and then, when I asked if she knew who we were, she said no. "As a dad, that still makes me emotional – for your own daughter not to recognise you."

After a two-week stint in hospital, Ms Bennett was discharged but her memory has never been the same. While she is able to recall things that happened before she became unwell, her short-term memory was initially virtually non-existent. 'Thankfully, she'd got back who we were and could remember things like where she grew up and who her old friends were,' Mark said. 'But she couldn't hold on to short-term memories.

"Friends would come round and

visit and she'd soon forget she'd even seen them.' Hoping they could put the ordeal behind them and move forward, Ms Bennett's family were dealt another blow when she was struck by encephalitis again just three days after leaving hospital. 'She came downstairs one morning and seemed really wobbly, as if she could fall over at any second,' Mark said.

'The only thing I could think to do was what I'd seen on TV, where police test drunk drivers, getting them to count back from 20.

"She tried, but couldn't do it."
Mark phoned 111 - the NHS nonemergency number - who sent out
a paramedic.

Ms Bennett was rushed to hospital, where her diagnosis was con-

#### WHAT IS ENCEPHALITIS?

Encephalitis is an uncommon but serious condition in which the brain becomes inflamed (swollen).

It can be life-threatening and requires urgent treatment in hospital.

Anyone can be affected, but the very young and very old are most at risk.

Encephalitis sometimes starts off with flulike symptoms, such as a high temperature and headache, but these don't always occur.


More serious symptoms develop over hours, days or weeks, including: confusion or disorientation, seizures (fits), changes in personality and behaviour or loss of consciousness.

Dial 999 for an ambulance immediately if you or someone else has these more serious symptoms.

It's not always clear what causes encephalitis, but it can be caused by viral infections. Several common viruses can spread to the brain and cause encephalitis in rare cases, including the herpes simplex virus (which causes cold sores and genital herpes) and the chickenpox virus.

firmed. This time the computer analyst stayed in hospital for two months and one week, by which time her short-term memory was even worse. Mark recalls an instance in August 2015 when, on the way to the ferry port for a family holiday, Ms Bennett asked 48 times in a 90-minute journey if he had her passport.

Following several ECG scans, doctors have confirmed Ms Bennett is unlikely to ever see any significant improvement to her memory.

On the advice of an occupational therapist, she keeps a daily diary, where she records everything she has done that day, as well as reminders to do basic things like wash and eat. 'She needs to be able to physically tick things off to remind her she's done them, or she'll have no idea,' Mark said.

"For example, she still loves cooking, but she has to follow recipes with a tick list, otherwise she'll forget she has already finished a step and start peeling a load of potatoes or prepping veg again. "Daily Mail













# 'Racist' S Williams cartoon given Australian all-clear

MELBOURNE - A controversial Australian newspaper cartoon of Serena Williams which was blasted as racist and sexist did not breach media standards, the country's press watchdog ruled Monday.

Melbourne Herald-Sun illustrator Mark Knight's caricature in September showed a butch and fat-lipped Williams throwing a temper tantrum at last year's US Open after losing to Naomi Osaka.

It sparked widespread condemnation across the world, including from Harry Potter author JK Rowling and the Washington Post, which likened it to the era of racial segregation in the United States

The Herald-Sun defiantly republished the cartoon on its front page in the wake of the criticism under the headline "WEL-COME TO PC WORLD".

The Australian Press Council received complaints that Williams' depiction "may cause it to be an offensive and sexist representation of a woman and a prejudicial racial stereotype of African-American people generally".

It said there was concern about her being shown with "large lips, a broad flat nose, a wild afro-styled ponytail hairstyle different to that worn by Ms Williams during the match and positioned in an ape-like pose".

But it accepted that the newspaper's intent was simply to depict her behav-

iour as "childish by showing her spitting a pacifier out while she jumps up and down".

"The Council considers that the cartoon uses exaggeration and absurdity to make its point," it said.

"It accepts the publisher's claim that it does not depict Ms Williams as an ape, rather showing her as 'spitting the dummy', a non-racist caricature familiar to most Australian readers."

The Council did acknowledge that some readers found it offensive, but added that there was "sufficient public interest in commenting on behaviour and sportsmanship during a significant dispute between a tennis player with a globally high profile and an umpire at the US Open final".

"As such, the Council does not consider that the publication failed to take reasonable steps to avoid causing substantial offence, distress or prejudice, without sufficient justification in the public interest."

The furore followed 23-time Grand Slam champion Williams smashing her racquet and calling the umpire a "thief" and a "liar" during her Flushing Meadows meltdown. *AFP*



Surely many of our finals are turning to a football cliche as long as we try to craft certain pairings in our tournaments.

Yes we understand the need to

give the sponsors maximum possible mileage by ensuring high attendance volumes but surely not long ago in 2017, we had the original Matsapha United dusting it out against Young Buffaloes and need I remind you of how much our Somhlolo National Stadium filled up to the rafters.

## Teams

Needless to talk about the noise or excitement such a tournament creates among the so called small

With the seeding in this year's draw, there could be no potential Mbabane Derby. Infact, fans have been denied an opportunity of exciting encounters.

The so called small teams do not need an easier path to qualify, but just a fair one.

As it is now the deck is continu-

ally stacked against them.

The point some people are missing is that some teams will get an easier run because of their perception as a big team when in reality they'd be worse.

I agree that if a team wants to win the major they should be ready to beat any team in the tournament. The seeding only allow for big teams not to play against each other in earlier stages

### **Tournament**

The tournament needs suspense and it is not good for fans or sponsors if the outcome gets decided too early. So, there is a desire to see it happen.

The MC is just trying to be too clever, which is not good. With that said, I think we have exciting encounters and again any team can surprise you on any day.

All the teams have to prepare well for these games. The early rounds of the SwaziBank Cup have traditionally produced plenty of fireworks, whether they are in the form of giant killings or heavy scores and we expect more fireworks this weekend. 'Solo Inje' mbamba yini?


