

As per the norm in the past few years, more girls were born than boys. Out of the 78, 45 were girls and 33 were boys.

Last year, a total of 55 babies were born. Mbabane Government Hospital recorded the highest number of births.

BROTHIBRS BRUTATAY MURDERE BYMOB

A mob of about 20 individuals brutally murdered two Mamba brothers, Muzi (31) and Mxolisi (29) of Letindze, KaNkonjwa, by hacking, stabbing and further stoning them to death on Christmas Eve.

Letindze is a community between Sithobelweni and Ngudzeni Constituencies, which is partly in the Lubombo and Shiselweni regions.

It is alleged that spears, axes, bush-knives, knives and stones used in the incident were collected from the scene as exhibits by Sithobelweni police.

The two brothers were dragged out of their home on Tuesday afternoon by the enraged mob which took turns assaulting them in what was a never been before witnessed incident in the community. It is alleged that it all started when one of the deceased persons, Mxolisi attacked another resident at a funeral three weeks ago whom he stabbed around the arm.

This incident was amicably resolved by the warring parties though such that it was not

even reported to the police.

However, Mxolisi reportedly threatened to assault the same resident when they were in a watering hole (shebeen); something that is suspected to have enraged the community.

Upon invading the Mamba homestead, the angry mob found only the deceased brothers.

"Kube bawutfola wonkhe umndeni waka-Mamba, ngabe kuvalwe ngelihlahla," one of

Others said one of the deceased, though unconscious, was dragged to a sports field where they continued to assault him with all sorts of objects.

"We are not sure what motivated the killings or if it has anything to do with the threats uttered by the deceased (Mxolisi) in his drunken stupor,"said an impeccable source.

Chief Police Information and Communications Officer, Superintendent Phindile Vilakati confirmed the incident, adding that nine suspects had already been arrested and would appear in court soon.

"We are still baffled as we

don't know what led to the mob behaving in this manner

We are sad because the world at large is in a festive mood et we have nothing to celebrate as a family," said Mamba.

They would wait for the postmortem results as the bodies of the two would be taken to pathologists today.

Family appeals for financial help

ON the other hand, Mamba said even though they were still to meet as a family to decide the date of the funeral, they were requesting for help from anyone to cover the funer-

"We are yet to decide on the funeral date but once we are done with the postmortem; we

will meet for all these logistics.

We appeal to anyone who can help, asina-

Coffins and food; we can appreciate whatever donation from those willing to assist us," said Mamba.

'Don't touch political activists'

HIGH Court Judge Nkosinathi Maseko has ordered that no action should be taken against political activists.

This is while the court is still dealing with the issue of the legality of the search warrants which were used to seize the documents and electronic gadgets belonging to the activists.

Judge Maseko made this order on Christmas Eve after the political activists approached the High Court where they challenged the legality of the search warrants used against them.

Sibongile Mazibuko, Wandile Dludlu, Jan Sithole and Musa Nkambule have since, through their attorney Thulani Maseko, approached the High Court to seek for redress in the issue.

Justice Maseko said he was now dealing with the matter where the applicants are challenging the warrants and the very same search warrants which will result to their arrest.

The judge stated that he does not want to see a situation whereby political activists are arrested while the matter is pending.

"What guarantee are we giving to the nation that once people are in court trying to enforce their rights in the meantime they are arrested?

Why can't the court processes be finished first," Judge Maseko stated

He said he will not allow a situation whereby individuals come to court and then the next day they are arrested on the very same allegations which they made before court and have not been answered by government.

In their submissions the applicants indicated that given the haste with which the searches were conducted there is a likelihood that the police intend arresting them for crime save for expressing themselves on the governance of the country.

The applicants indicated that the police seek to use the information obtained from the gadgets to develop the basis of their arrest and detention.

They said the police were likely to formulate criminal charges and haul them before a court of law on the basis of information unlawfully obtained.

The applicants stated that once they are charged, their right to a presumption of innocence as guaranteed in Section 21(2) (a) of the Constitution will be infringed as they will be charged with criminal offences that have no basis in law given the unlawfulness of the search warrants.

The matter will be argued before court on 8 January before the same Judge.

Political activists rush to court, demand seized gadgets back

FOLLOWING the issuing of search warrants which saw items belonging to political activists being confiscated by the police, have since approached the High Court to seek for redress.

The four made an urgent application at the High Court on Christmas Eve. They were represented by senior lawyer Thulani Maseko.

The matter appeared before Judge Nkosinathi Maseko. Representing the crown was Deputy Attorney General Mbuso Simelane.

The political activists want the search warrants issued against them set aside as they argue that this is because they do not comply with the requirements of Section 46 of the Criminal Procedure and Evidence Act, 1938 (the Act) as read with Section 22 of the Constitution, Act No. 001 of 2005.

The political activists also sought for an order directing police to hand back the documents and electronic gadgets including cellphones and laptops, taken from them during the raids conducted at their homesteads by the police.

The applicants submitted that they have been deprived of their mobile cellular phones, laptops and tablets and other electronic gadgets rendering their lives disorganised, yet electronic gadgets are vital instruments in modern societies as these are used not only for communicating purposes but for banking, money transfers and payments.

Maseko further submitted that this is a busy time of the year and depriving the political activists the use of their gadgets means they may not be able to execute certain transInvestigations started months back now at 95% complete - Crown

THE investigations that led to the seizure of items belonging to political activists started some months back.

This was revealed by the Crown, which is represented by Assistant Deputy Attorney General Mbuso Simelane in the matter that is now at the High Court. Simelane indicated that if anything will be found by the police on the seized items, it will just be five per cent of what the police already have.

He said it would just be a drop in the ocean. Simelane argued that whatever crime is alleged to be committed by the applicants, it would continue abated if they are

actions as they see fit and expedient. The applicants stated that in this modern world of technology they have been greatly inconvenienced by the seizure of their cellphones and other electronic gadgets.

The attorney stated that the search warrants are an aberration of the rule of law in that they amount to a continuation and perpetuation of an unlawful act as they fall outside the ambit of Section 46 and therefore constitute a violation of Section 22 of the Constitution which guarantees the rights to

Maseko argued that the police intend to use whatever information they may find in the let free. The Crown informed the court that they do not know what next move the applicants are planning.

Simelane stated that the applicants come to court claiming that they are PUDE-MO presidents and secretaries, which are proscribed entities in the country.

He said the very same individuals were claiming that they will do whatever pleases them and the courts must not do anything to them.

Justice Maseko indicated that he has a problem because on one hand the matter is before court and the information at his disposal is that the search warrants might result into arrest without warrant.

political activists gadgets to institute criminal proceedings, yet the information would have been unlawfully and unconstitutionally obtained. Maseko submitted that the political activists are susceptible to unlawful and malicious prosecution based on evidence unlawfully obtained.

He added that if the matter is not heard urgently and the overly broad search warrants remain in effect, the applicants are at risk of being prosecuted and detained on the basis of an unlawful process.

Coming

Maseko said the High Court was justified in coming to the assistance of the applicants to prevent the perpetuation of an unlawful act, abuse of power by the police in breach of rule of law and constitutional behaviour and conduct.



The elderly man, Bacondzile Khumalo, who is 76 years old, stays alone and is a sickly person. His neighbours in support have also appealed on his behalf to help in rebulding the house for Khumalo.

One of the residents of Mpholi, who commented on condition of anonymity, said the old man's situation worsens day-by-day.

He said there were times where Khumalo would go to bed on an empty stomach.

What worries the residents most is that Khumalo still has relatives and some of them work.

"This is very sad and as neighbours we think it's high time we mobilise resources to help Khumalo because we cannot sit back and watch," he said.

On another note, it transpired that Khumalo was once offered help by one of his relatives who was discouraged by some family members after insitating that he was bragging about his money

VICTORY FOR LOBAMBA FREFIGHTERS

AFTER weeks of unrest particularly at Lobamba Fire Station, there has been a major reshuffle of senior officers at the National Fire and Emergency Services.

Shortly before Christmas Day, the National Fire and Emergency Service announced a major reshuffle of senior officers effective next

In a letter signed by Denis Khumalo on behalf of the national fire chief officer the reshuffle was aimed at improving services.

"Their posting is with effect from 13 January 2020," he said.

The reshuffle came as a ray of sunshine for Lobamba fire-fighters. It comes a month after they delivered a petition to the Chief Fire-Fighter Jabulani Ndzimandze, where they listed a number of grievances including calling for the removal of Thamsanqa Mndzebele as Lobamba Station Manager. They also cited horrible working conditions at the station.

Following several communications with Ndzimandze the officers had opted to lock down Lobamba Fire Station if serious actions that included the removal of Ndzimandze

were not implemented.

Therefore before the week ended, the chief firefighter announced the reshuffle which included Lobamba Station Manager Thamsanqa Mndzebele.

He has been moved to Matsapha Fire Prevention. From January 13, 2020 Lobamba

Fire Station will be managed by Douglas Mkhaliphi from Matsapha Fire Prevention.

Charles Mhlanga from the Royal Wing has also been added to Lobamba Fire Station.

In total, nine fire senior officers across stations were affected by the reshuffle.

The reshuffle brought hope to Lobamba fire-fighters as well as all the other fire stations because

COURT STOPS PIGG'S PEAK HOTEL STRIKE

THE Industrial Court of Eswatini has stopped a proposed strike action by Pigg's Peak Hotel staff over a 13th cheque and freebies.

The employees had intended to down tools, starting on Christmas Eve and subsequent days. The hotel through its attorney Sikhumbuzo Simelane stated that the workers' contemplated strike action was unlawful because the workers had not reported the dispute to CMAC nor had there been compliance with the Industrial Relations Act 2000.

The hotel management stated that the Industrial Relations Act states that there has to be proper procedure followed before employees engage in a strike action. The hotel alleged that what the employees wanted to do was unlawful and would have constituted a wild-cat strike action.

The hotel through its attorneys argued that festive holidays, especially from 24 to 31 were the busiest days of the year.

The hotel submitted that the employees who had threatened to strike were very key in the day-to-day services of guests and if they engaged in a strike, then there would have been serious disruption in the operations of the hotel business.

The court issued an interim inter-



right to engage all its employees to report for duty and to work on Christmas Eve and Christmas day and any other subsequent date thereafter. The court indicated that the employees have legally binding employment contracts with the hotel which must not be violated.

Simelane submitted that the contracts have legal rights and obligations. "The respondents have issued a notice in which they say they will infringe the applicants' aforesaid right and therefore applicant is enti-

tled to an interdict," part of the papers submitted in court read.

The court was informed that there was a reasonable apprehension of irreparable harm and prejudice that the hotel would suffer if the employees would not be interdicted and restrained from engaging in the strike action because guests would not be serviced.

The court further added that there would be no prejudice to be suffered by the workers if interdicted from proceeding with their strike action.

It was stated that in any event the issues the workers were complaining about could be resolved through dialogue in the workplace and also through dispute resolution mechanisms provided by labour laws of the country.

The hotel through its lawyers claimed that it had no other satisfactory remedy other than to apply for an interim interdict in court because CMAC is now closed and also because CMAC would not have the power to issue and interdict even if it was still opened.

Taiwan Medical Mission serves 260 at Mhlambanyatsi constituency

THE Taiwan Medical Mission treated 260 community members from Mhlambanyatsi Constituency during an outreach service at Mlindazwe High last Saturday.

A total of 11 doctors from Taiwan Medical Mission held the outreach service, which saw 130 females, 81 males and 49 pupils treated.

The outreach team included specialists in pediatrician, orthopedic, general medicine, urologist and neurosurgeon from Taiwan Medical Mission and volunteers from Southern Africa Nazarene University (SANU). The outreach provided physical check-up, disease consultation and free medication.

During the service, Dr. Tsai Yuan Chun mentioned that a pupil came with an ear discharge problem and hearing impairment. After examining the minor's ear with an otoscope they discovered a turbid eardrum, which is likely to be an acute otitis media. This is an infection that occurs behind the eardrum.

"Most of the otitis media may be treated without antibiotic treatment but the prevention for further otitis media should not be overlooked.

To prevent recurrent of the otitis media, parents should maintain environmental hygiene for children, washing hands and toys frequently, and prevent flu infection, choose breast-feeding during infancy and also prevent smoking," said

Dr. Hsieh, Shang-Jung noted that

many senior citizens complained of blurred vision and they may possibly be suffering from cataract, which is a degenerative lens disease that is common with the elderly. Usually patients with cataract may suffer from photophobia, progressive nearsightedness or loss of distance vision and eventually loss of vision as lens opacity develops.

He said risk factors of cataract includes age, smoking, diabetes mellitus, sunlight exposure and long-term use of corticosteroid. Thus, it is important to have good lifestyle habits and control of blood sugar.

He warned the patients not to forget to wear sunglasses to protect eyes from sunlight exposure.

He went on to say that it was a pleasure for the Taiwan Medical Mission to conduct the medical outreach under Mhlambanyatsi Inkhundla. The location was recommended by the Member of Parliament Petros Mavimbela.

Mavimbela expressed appreciation to Taiwan Mission for the services rendered and said in the near future, the mission may have another outreach service at Lundzi.

Mavimbela said there were still many communities that need the medical assistance. "It is important for us to hold outreach services in the rural areas as the mission understands that it may be difficult for community members, especially the elderly to seek medical attention," he said.

In 2020, the Taiwan Medical Mission is planning to hold six outreach services in different constituencies.

...as shop owners fiddle with expiry dates

MEMBERS of the public, especially those buying food in bulk for stokvels, have been urged to be careful when purchasing in large quantities from shops.

This follows a discovery that some shop owners fiddle with expiry dates for spoiled food items that should be taken out of the shelves.

Information gathered is that some shop owners go as far as replacing the original expiry date in food items with an extended one. Some of those who have fallen prey to these antics are those who were buying food in bulks for stokvels.

Manzini is where this illegal practice has been found to be rife. This has led to Manzini Municipal Council Public Relations Officer Mathokoza Thwala to sending out a stern warning to members of the public.

Thwala said consumers should thoroughly check food labels for dates of expiry before buying items this festive.

He said council had since intensified health inspections in shops around town. He said during these inspections bakkie loads of expired and other not-fit-for-consumption food items were removed from the shelves.

Thwala said the health inspection operation is still on-going. Pointing out to some of the shocking discoveries made by council during the operation, Thwala said some shop owners fiddled with the expiry date while others covered it with an extended one

"That's an illegal practice," Thwala stated.

In one food item, two expiry dates were found which indicates that the item had long expired while another expiry date which was on top of the original one indicated that the item will expire on December 31, 2020.

The Municipal Council of Manzini has since pleaded with consumers not to buy expired food stuff no matter the price discount. "Always check the expiry date. Don't buy if the date has been scratched or replaced," Thwala stated.

Meanwhile, consumers have been warned to look out for blown, leaking, dented and rusted tins. These, according to Thwala, must be avoided at all costs.

Those who will be shopping in town were urged to be always on the lookout for the food establishment's grade. Thwala said shops with Grade A and B labels were quite safe to buy from 2409



Assault case leads police to stumble on 10.8kg dagga

POLICE who were initially investigating a man for an assault case ended up busting him for possession of 10.8kg of dagga at his homestead near Nsangwini on Sunday.

Initially, the police who made the discovery were responding to a distress call received from Gcinile Mhlanga, who claimed that she had been assaulted by Melusi Dlamini.

Those who come across food items that are unfit for human consumption have been urged to contact town council.

The number for those who want to report the spoiled food items found in shops is 2508 5034, 2508 5037 or Council's 24/7 Call Centre (800 2004/2505 7000).

The Municipal Council of Mbabane has also sent out a warning to consumers. A message from the communications office warned consumers against purchasing of unsound or unsafe food commodities.

The message stated that this is a time where shoppers buy impulsively in bulk without paying much attention to the condition of the food items.

"Members of the public are therefore cautioned to be on the lookout for any defects on food items," part of the message from Mbabane Municipality reads.

Usual procedure dictates that non-complying food premises are served with notices to rectify the short comings. In cases where expired or unsound food is found in shops, the food is seized and sanitary disposed at the landfill.

The ministry of commerce industry and trade when drawn for comment on this issue indicated that the municipalities have their own regulations on how they deal with such offenders. Ministry of Commerce Communications Officer Thabile Mdluli said in urban areas town councils have their own health inspectors while in the rural areas government provides health inspectors.

AFTER enjoying Christmas Day festivities, several road traffic offenders confessed to have taken one too many drinks.

This was an excuse put forward by some of the road traffic offenders who appeared before Magistrate Xolile Nxumalo at the Manzini Magistrate's Court yesterday. One of these offenders, Kukhanya Dlamini, who was arrested yesterday while at Kwaluseni, told the court that he found himself indulging in more alcohol than necessary as he got too thirsty.

Dlamini was arrested for driving while under the influence of alcohol. His alcohol content was 1.15mg/l.

In mitigation, Dlamini told the court that, "Bengitsi ngehlisa koma kani sengitotsatsa kakhulu kwatise kutsi bekunguKhismusi ngayitolo."

Another offender, Thembinkosi Ndlela, who was arrested on Christmas Day along the Police Academy in Matsapha, pleaded for the court's leniency when meting out sentence.

He said breaking the law was not his intention as he was only trying to quench his thirst after a good Christmas meal. Ndlela's alcohol specimen reading was 0.42mg/l.

"Bengitsi ngehlisa emafutsa enyama kani sengephula umtsetfo," he said.

Dlamini and Ndlela were sentenced to 12 months imprisonment with an option of E1 700 fine and six months imprisonment with an option of E800 fine, respectively.

AFTER finding himself before the court of law, a drunk driver swore never to risk it by asking for a lift from equally intoxicated people.

Mandisa Dlamini was before Magistrate Nxumalo on a charge of driving while intoxicated.

He was arrested on Christmas Day near Checkers in Manzini while driving a Toyota vehicle with registration number SSD 320 CM. His alcohol specimen reading was 1.22mg/l, exceeding the legal limit of 0.38mg/l.

Offender pleads guilty after denying charges

A road traffic offender startled the court when he vehemently denied the charges levelled against him but pleaded guilty at the same time.

Bongani Shongwe faced three counts of contravening the Road Traffic Act of 2007, with the first one being that of driving while under the influence of alcohol.

According to his charge sheet, Shongwe was arrested on Christmas Day at Ngwane Park while driving a VW sedan with registration number HSD 119 CH.

He was suspected to have driven this vehicle while intoxicated.

His second charge was for refusing to lave his breath specimen reading taken by a traffic police officer. Additionally, he was also charged for failing to comply with instructions by the same officer. When asked of his plea to the aforementioned charges, Shongwe denied that he was intoxicated when driving

In what may be deemed as the quietest day in law enforcement history, only three motorists were arrested for having been found driving while under the influence of alcohol on Christmas

The three were said to have appeared before Principal Magistrate Fikile Nhlabatsi yesterday, where it was ascertained that the three motorists were nabbed in Ezulwini, with none making an appearance from Mbabane.

39-year-old Sive Dlamini of Bhunya was arrested on Christmas Day at Lobamba along the MR103 Public Road, where he was charged with drink driving after he was found driving a BMW sedan while under the influence of an intoxicating substance.

When a breathalyser test was conducted on him, Dlamini was found to have an alcohol reading of 0.87mgl. In his mitigation, Dlamini pleaded with the court to be lenient in his sentencing as he promised never to commit the offence again.

After hearing his mitigation, Dlamini was sentenced to serve 18 months in prison, with the option to pay a fine of E1 800.

Later on that evening at around 2340 hours, Lobamba traffic police officers also arrested 39-year-old Madoda Masuku of Mbabane who had been driving while under the influence of alcohol.

Masuku was nabbed at Ezulwini while driving a Mazda station wagon sedan. When a breathalyser was administered on him, he was found to have a blood alcohol content reading of 0.67 mg/l.

Masuku told the court that he regretted having committed the offence, especially because he had to spend time behind bars rather than spend time with his family on Christmas Day.

Principal Magistrate Fikile Nhlabatsi sentenced him to serve 16 months in prison, with the option to pay a fine of E1 600.

A South African national and the only female to be nabbed for drink-driving on Christmas Day, Erica Cassamo (30) claimed that she was currently unemployed and pleaded for a lighter sentence.

"Your Worship, I am a first offender and I honestly did not think that my stay in the country would turn out in this manner. I am currently unemployed with children and I am pleading with you to be lenient with my sentence," Cassamo pleaded.

After hearing her mitigation, the court sentenced Cassamo to pay a fine of E1 500 and in default of payment, serve 15 months in prison.

No Mbabane offenders, well done - Principal Magistrate

ON a lighter note, Principal Magistrate Fikile Nhlabatsi commended Emaswati, specifically the Mbabane residents for being well behaved this Christmas.

After only three drink-drivers appeared before the court on Thursday, the judicial officer expressed her content at the low numbers of offenders. "It is not every day that we come to court and there are so few drink-drivers before the court, especially during the festive season. It is visible that Mbabane residents were well behaved today, or rather they adhered to the traffic laws. Journalists, take note that good behaviour should be jotted down as well," the jubilant judicial officer said.




"My gratitude goes to the ministry's portfolio committee which has assisted us in a number of issues.

Minister advises councils to be considerate of ratepayers

TOWNS and cities need to be considerate when effecting rates increase for properties as not everyone can afford the hiked fees, Minister of Housing and Urban Development Prince Simelane said.

The minister said payment of rates was obligatory as per one of the clauses in the Urban Government Act. He said for the towns and cities to function without hindrances, rates must be paid timeously.

He, however, said effecting the increase in rates should take into

account that within the urban areas with ratable properties, there were those that did not afford paying rates due to a number of reasons.

He said some of the properties in towns and cities were owned by the destitute such as widows, orphans or child-headed families who have no income and earn a living through the generosity of others.

He said it was time this issue was addressed. "I am not saying they should be exempted but government should look into how these people can be assisted. In schools, there is a programme known as orphaned and vulnerable children (OVC) catering for the pupils who lost their parents or whose parents are incapacitated and their school fees is paid by government. We need to devise a way of assisting those urban predicaments.

The ministry, in my own opinion, needs to determine how those who can't afford to pay rates are assisted at least half way. Some of these people know no other homes than their properties within the

urban area," said the prince.

Retired magistrate happy to reach finishing line

"IT has been a long journey but I am happy that I managed to make it to the finishing line still full of vigour and energy.

I am now celebrating with you for this achievement and simultaneously passing the baton to others."

These were the words of retired Nhlangano Magistrate Peter Simelane.

The likeable Simelane officially retired last month after reaching 60.

He worked in a number of Magistrate's Courts around the country.

During his farewell function held at the Golden Gate Guest House in Nhlangano recently, Simelane recalled a number of challenges he encountered, including how he almost lost his life while on duty when inmates brought for remand hearing assaulted him.

He also recalled how another magistrate made a mockery of him whilst presiding on a matter where he (Simelane) was an interpreter.

"During our time as interpreters, magistrates never hesitated to ridicule you anyhow.

They had no time of 'babysitting' you as they were harsh on us.

I remember how one of them (presiding officer) said something irritating me and I ended up gossipping that: 'Udzakiwe'. I was so irritated with what he was saying while interpreting. I wanted him to educate me on how to pronounce a certain word.

Touched

We used to have magistrates who were seemingly only interested in undermining those junior to them.

But we never threw in the towel but continued with our work," said Simelane.

When Simelane started telling the gathering how he was almost killed in a courtroom, many of those in attendance were touched. "There have been a number of episodes some which were a threat to my life. I remember how I survived the wrath of a group of inmates who were brought to be remanded and out of the blue, they started assaulting me with fists and kicks.

The commotion in the courtroom was too much but God saved my life.

My life was in danger but the Correctional Services officers were able to contain the situation," said Simelane.

Simelane thanked all those he worked with from the first day he started working for government

He spent all his working life in the Judiciary where he started as an interpreter and climbed the ladder until he became Senior Magistrate.



1979 - Afghanistan -- Soviet Union Seizes Control The Soviet Union seizes control of Afghanistan. President Hafizullah Amin, who was overthrown and executed, has been replaced by Babrak Karmal.

1983 - USA -- Recession More Jobs Lost

1983: With the recession continuing to effect manufacturing in the United States. US Steel announces that it would reduce its steel making capacity by roughly 20 percent laying off a further 4 600 bringing the total lay-offs for the year to 15 400.

1985 - Rwanda -- Dian Fossey

The American Zoologist Dian Fossey, who had studied mountain gorillas in Rwanda, was found hacked to death at a research station in Rwanda.

1985 - Italy / Austria -- Terrorist Attack

A twin terrorist attack at Rome and Vienna airports by gunmen on waiting passengers has left more than 100 people injured and reports of 15 fatalities.

1987 - Canada -- Chrysler Motors

The protests were also over concern that some ultra-Orthodox groups in the city were trying to segregate men and women. Protesters also had the support of Israel's president who said that the protests were necessary to defend the majority of Israelis against a minority trying to change the country.

MILATITE LAW SAYS

THE FISHERIES AND AQUACULTURE ACT, 2019

Fish export and import permits

12. (1) A person may not export or import any fish, or aquatic material or product thereof whether live, frozen or processed in any form without an export or import permit.

(2) An application for an export or import permit shall be made to the principal secretary in the format prescribed.

(3) An application to import live fish shall be denied if the principal secretary is of the opinion that to permit that import would threaten or harm any indigenous or endemic fish or aquatic resource or in any way harm fish or aquatic biodiversity.

(4) The principal secretary shall issue export and import permits for a period not exceeding twelve (12) months.

Aquaculture licences

13. (1) A person shall not undertake small-scale commercial or large – scale commercial aquaculture without an aquaculture licence issued by the Board.

(2) An application for an aquaculture licence shall be made to the Board in the prescribed form

(3) The Board may issue an aquaculture licence authorising one of the following categories of aquaculture -

(a) small-scale commercial aquaculture; or

(b) large-scale commercial aquaculture.

(4) The Board shall not grant an aquaculture licence for a period in excess of five (5) years renewable for small-scale and large – scale commercial aquaculture.

(5) Small-scale commercial aquaculture licences may not be granted to persons other than citizens or permanent residents of Eswatini.

(6) Large-scale commercial aquaculture licenses may be granted to any person resident in the Country.

(7) The minister shall annually prescribe the fees applicable for the granting and renewal of aquaculture licences by notice published in the Gazette.

(8) The Board shall annually prescribe the levies applicable to the gross annual production of fish by notice published in the Gazette and that notice may set different levies for different species of fish farmed.

(9) Aquaculture licences are not transferable except in accordance with sub-section (10).

(10) The Board may authorise the transfer of an aquaculture licence upon written application by the holder of an aquaculture licence showing good cause why the Board should transfer the licence.


Fish processing establishment.

14. (1) A person or establishment shall not undertake fish processing without a fish processing establishment permit issued by the principal secretary.

(2) An application for a fish processing establishment permit shall be made to the principal secretary and in the format prescribed.

(3) The principal secretary may not grant a fish processing establishment permit for a period in excess of (5) five years.

(4) A fish processing establishment permit may only be granted to any person resident in Eswatini.
(5) The principal secretary shall annually prescribe the fees applicable to the granting of fish processing establishment permits by notice published in the Gazette.

(7) The principal secretary may authorize the transfer of a fish processing establishment permit upon written application by the permit holder showing good reasons why the principal secretary should authorize the transfer of the permit.

(8) Where the principal secretary considers it appropriate, a permit issued under this provision may be suspended, withdrawn or terminated.

Fishing vessels

15. (1) A person responsible for a fishing vessel flying the Eswatini flag shall cause the vessel to be registered.

(2) The registration of fishing vessels shall be the responsibility of the ministry responsible for fisheries and aquaculture.

(3) A person shall not operate a fishing vessel in any national, foreign or international water body without a vessel permit.

(4) An application for a fishing vessel permit shall be made to the principal secretary in a format to be prescribed.

(5) The principal secretary shall not grant a fishing vessel permit for a period exceeding a period of one (1) year.

(6) The principal secretary shall annually prescribe the fees applicable to the granting of fishing vessel permits by notice published in the Gazette.

(7) The principal secretary shall open and maintain a public register of fishing vessels.

(8) A vessel flying the Eswatini flag shall comply with any relevant legislation whether of local, coastal state or the international law of the sea.

Register of licences and permits

16. (1) The principal secretary shall open and keep a register of all licences and permits granted or issued in terms of this Act.

(2) The register contemplated in sub-section (1)

shall be publicly available and accessible.

(3) The register shall be maintained and updated at least annually.

Administrative penalties

17. (1) If a holder of a licence or permit-

 (a) furnishes information in the application for that licence or permit, or submits any other information which is false or incomplete;

(b) contravenes or fails to comply with a condition imposed in the licence or permit;(c) contravenes or fails to comply with a provi-

sion of this Act; (d) is convicted of an offence in terms of this

Act; or

(e) fails to effect; the tilica that licence or per-

(e) fails to effectively utilise that licence or permit, without any reasonable cause,

the principal secretary may, by written notice delivered to that holder, request for the holder to show cause in writing within a period of twenty-one (21) days from the date of the notice, why the licence or permit should not be revoked, suspended, withdrawn or altered as the case may be.

(2) The principal secretary shall, after the expiry of the period referred to in sub-section (1), refer the matter together with any reason furnished by the holder in question, to the Minister for a decision.

(3) When a matter is referred to the minister in terms of sub-section (2), the minister may - (a) revoke, suspend or alter the licence or per-

mit; or


(b) decide not to make suspend or after the

(b) decide not to revoke, suspend or alter the licence or permit.

(4) Without conflicting the provisions of subsections (1), (2) and (3), the minister may, whenever the minister is of the opinion that it

is in the interests of promoting, protecting or utilising on a sustainable basis of a particular aquatic resource, at any time by written notice to the holder of a licence or permit, revoke, suspend or reduce that licence or permit.

ENIGMATIC ETHIOPIA: AFRICA'S (STILL) HIDDEN JEWEL IN THE CROWN?



ADDIS ABABA, a seething and rapidly developing African metropolis, is a regular transit stop for north-south travellers and a destination for officials connected to the African Union and its many commissions.

While transit travellers benefit from the cheaper rates of Ethiopian Airlines - Africa's largest and most globally connected national carrier - the development of Ethiopia's tourism industry is still at an early

It will not stay that way for long. Africa's diplomatic capital - which means "New Flower" in the native Amharic language – is inundated with construction sites, leading hotel chains and sprawling markets amid chaotic traffic in overcrowded streets.

Mountain lodges and hilltop hotels are appearing in the main historic towns in the north of the country where ruined palaces, obelisks and monasteries of the Ethiopian Orthodox Church add to the Ethiopian enig-

A recent 10-day visit to Africa's fastest-growing economy - it grew at an average of 10 per cent a year between 2008 and 2018 - revealed a country of 105-million people with a fascinating history and a kaleidoscope of ethnic, religious and cultural diversity.

It is Africa's second-most populous country and was the fastest growing economy in the world last year, albeit from a low base.

The ancient kingdoms of Yeha, Axum, Lalibela and Gondar weave a narrative rooted in a deep-seated faith spanning the three major monotheistic religions.

The 12 iconic rock churches of Lalibela - where Christianity was first declared a state religion in AD 300 - vie with the Seven Wonders of the World for sheer vision, scale and resilience.

The breathtaking rock churches, which have been in regular use continuously for the past 700 years, defy both imagination and description. We were in Axum, the 10th Century capital of the Kingdom of Ethiopia, on what is called Saint Mary's day: one of the most important festivals on the Ethiopian Christian calendar. From morning to night there were rivers of pilgrims clad in white muslin cloth streaming towards the Church of Saint Mary of Zion.

Axum is the city of the Queen of Sheba's ancient palace and the Ark of the Covenant which is never seen by anyone other than the lone custodian charged with its safekeeping, according to the legend.

Today, the mosaic of Ethiopia is an intriguing intertwining of religious, ethnic and regional loyalties which appear to contribute to a somewhat precarious equilibrium which erupts from time to time.

Some 63 per cent of the population is Christian, 34 per cent are Muslim and there are some 80 ethnic groups living in 10 states or provinces.

The largest ethnic groups are the Oromo (34 per cent), Amhara (27 per cent) and the Tigrayans, who span the border with Eritrea and box well above their six per cent of the total.

The government is made up of four liberation movements which resisted and defeated the Sovietbacked military junta, the Derg (1974-91), headed by Mengistu Haile Mariam, a brutal dictator who fled to Zimbabwe where he still lives in exile.

The Derg was followed by the Ethiopian People's Revolutionary Democratic Front (EPRDF) which ruled for 27 years under Prime Minister Meles Zenawi's policy of ethnic federalism and his successor, Hailemariam Desalegn.

The four movements are now being subsumed along with five other groups in a single party known as the Prosperity Party which is the brainchild of reformist Prime Minister Abiy Ahmed Ali who was awarded the 2019 Nobel Peace Prize for negotiating a peace deal with Eritrea.

Since Abiy was elected in 2018, he has pursued a vigorous process of reform, releasing political prisoners, promoting freedom of speech and attempting to unite a country driven by ethnic and regional conflicts which have claimed hundreds of lives and seen 3.5-million people displaced since 2015.

Lifting decades of repression has unleashed resistance including an attempted coup in which two senior officials were killed in June and a spontaneous uprising in his Oromia heartland in October which claimed more than 80 lives, with 200 injured.

The recent referendum granting the Sidama ethnic group in the south a tenth state has opened the floodgates to demands from at least five other ethnic groups wanting their own states.

The dynamics of conflict are complex and often occur within ethnic groups over differences regarding regional vs federal power; sometimes, religion also plays a part but is not the primary cause of conflict.

Ethiopia has survived catastrophic famines (1888, 1973 and 1984/85), Muslim-Christian wars (1490-1529), invasions by the Egyptians and Somalia, five years of occupation by the Italians (1935-1941), decades of war with Eritrea and a seventeen-year liberation struggle against the Soviet-backed Derg (1974-91).

But the country has never been colonised and it shows in the pride, dignity and independent spirit of the people ruled by successive emperors and kings over two thousand years, culminating with the interrupted four-decade rule and



ignominious death of Emperor Haile Selassie (1931-1974) ousted by the

Ethiopia has not yet managed to fully realise its natural position as a regional power in the Horn of Africa due to landlocked territory and conflict with troublesome neighbours such as Eritrea, the Sudan and Somalia.

But there is opportunity looming now for a forward leap under the energetic leadership of Abiy.

Investment flows from China, the United States, Saudi Arabia, Turkey, and India. Chinese friendship signs abound and it is a major investor in the massive Grand Ethiopian Renaissance Dam and other key road, rail and telecommunication infrastructure projects.

The IMF and World Bank have also weighed in with major sup-

Ethiopia is Africa's major producer and exporter of coffee but it is diversifying a traditionally agricultural economy with a focus on the industrial and service sectors.

Abiy has encouraged liberalisation of the economy but despite the phenomenal growth - it has halved poverty in a decade – Ethiopia is still one of the world's poorest countries and faces massive youth unemployment. Yet some experts see Ethiopia as the future "China of Africa" and Bloomberg has listed Ethiopia and the Ivory Coast as the only two African countries in the world's top 10 growth destinations.

The mountain landscapes in the north are breathtaking as are the cultivated plateaus, river canyons and patchwork of smallholdings clearly visible on the flight from Lalibela to Axum.

And the four-hour drive from the ancient city of Gondar to Bahir Dar reveals fertile plains and valleys planted with the staple grain, teff, and cow-drawn ploughs and threshing circles that are as ancient as the Bible.

The Ethiopian belief that it es the Ark of the Covenant, containing the tablets bearing the 10 Commandments, is at the centre of the faith of the Ethiopian Orthodox Church. Ethiopian Christians also believe that the first King of Ethiopia, Menelik I, was conceived in a union between the Queen of Sheba known as Queen Makeda in Ethiopia and King Solomon in Jerusalem during a visit to the Holy City.

Lake Tana, adjoining Bahir Dar, is the source of the Blue Nile as it begins its journey to the Mediterranean. The Blue Nile Falls,

several hours away on foot, are an impressive sight.

But the volume of water cascading 150 feet has been diminished by the diversion of water to the massive Renaissance Dam which is already a source of tension with the Sudan and Egypt as the main source of water for those two coun-

As our visit with New York Times Journeys had as its focus ancient lands and religious Festivals we did not get to see the renowned bearded monkeys in the Simeon Mountains or the extraordinary Danakil Depression which claims to be the lowest and hottest destination on earth.

But we did get to visit the Ethnographic Museum in Addis which houses a replica of Lucy, which vies with South Africa's Little Foot, as the oldest hominid of the genus Australopithecus found in Africa, which is estimated to be 3.2-million years old.

Little Foot is estimated to be 3.7million years old. The species Afarensis has been found only in the Afar depression - dubbed the Cradle of Civilisation - in Ethiopia while Africanus has been found only in the vicinity of the Sterkfontien in South Africa known as the Cradle of Mankind.

Hominids are the oldest known relatives of Homo Sapiens, modern humans, who are about 200 000 years old. Successive finds in South Africa since 1925 of the species Australopithecus Africanus have included the skull of Mrs Ples, the Taung Child and most recently the almost complete skeleton of Little Foot.

Even older species of hominids, which are found only in Africa, have been found in Ethiopia, Kenya and Chad and go back between five and six million years.

We learned from our guide at the museum was that Lucy, Ethiopia's oldest and most famous female, owes her name to famous Beatles hit Lucy in the Sky with Diamonds (LSD), from the album Sergeant Pepper's Lonely Heartsclub Band, which is said to have been inspired by the psychedelic drug LSD.

It could be that enigmatic Ethiopia is still Africa's best-kept secret.

...One of the challenges cited in cross-subsidisation of electricity

BUSINESSES reportedly regard non-cost reflective tariffs as unsustainable, and are exploring alternative self-generation options.

This is one of the challenges resulting from cross-subsidisation, which according to Wikipedia, is the the practice of charging higher prices to one type of consumers to artificially lower prices for another group.

According to an economic regulation presentation by the Eswatini Energy Regulatory Authority (ESERA) Regulation Manager Simphiwe Khumalo, the top four customers contributed to about 16 per cent to the total revenue. It highlighted that the business customers, especially industrial, were growing at a very slow pace.

The presentation also pointed that some business customers charged up to 40 per cent more to pay for lower domestic customer tariffs.

He said the migration of business customers' off-grid would decrease economies of scale and significantly increase tariffs for remaining customers while excessively high tariffs would make it unaffordable for most Eswatini.

Khumalo also explained the benefits of costreflective tariffs, noting that the electricity industry was less reliant on single customer group for sustainability.

"The reduced cost of doing business in Eswatini is attractive to investment. Businesses are likely to reinvest savings into

expansion of economic activity, athus more jobs are created. "Also, the utility is able to maintain and

invest in infrastructure for improved quality and reliability of electricity," he said. He further mentioned that the captive

electricity consumers were protected from potential excessively high electricity

Prices

In his presentation, Khumalo cited that The Electricity Act states that prices shall be regulated according to one or more of the following tariff methodologies, which shall allow a licensee that operates efficiently to recover the full costs of its business activities, including a reasonable return on the capital invested in business, provide incentives for continued improvement in respect of technical and economic efficiency with which services

are provided, incen-

tives for continued improvement of quality services, give to consumers proper signals regarding the costs that their consumption imposes on the business of the licensee and to avoid undue discrimination between consumers and consumer categories.

He highlighted that the tariff methodology sought to balance the different and sometimes conflicting needs of the various stakeholders

"There is also the cost of service study (CoSS), which is a tool used to ensure that rates are tied to the costs of providing electricity to customers.

It involves analysing historical expenses and projecting future cash flow needs to arrive at a revenue requirement.

"The components of revenue requirement are functionalised, classified, and allocated to a utility's various customer classes to arrive at proposed rates. The CoSS is the basis upon which costreflective tariffs are set," he said.

Toyota's 2020 forecast edges it closer to Volkswagen

NEW YORK -Toyota Motor Corp. is forecasting sales of 10.77 million vehicles worldwide during 2020, nudging it closer to No. 1 automaker Volkswagen AG.

Toyota's outlook, which includes vehicles sold by subsidiaries Daihatsu Motor Co. and truck maker Hino Motors Ltd., shows slight growth from an estimated 10.72 million vehicles this year. Volkswagen sold 10.8 million units in 2018 and said in October it expects deliveries to be little changed this year. Automakers are fighting to sell cars in a difficult environment, with tepid economic growth worldwide and trade tensions forcing them

to cut profitability outlooks and slash more than 80,000 jobs.

At the same time, they are seeking new growth by investing in a once-in-a-generation industry shift toward electric vehicles, self-driving technologies and rideon-demand business models.

SARS collected R421.1bn off the personal PAYE of SA workforce in 2018

CAPE TOWN - The SA Revenue Service (SARS) received more than 18.2 million employees' tax certificates or IRP5s showing PAYE collection of R421.1billion last year.

According to the latest statistics released jointly by SARS and the National Treasury, personal income tax (PIT) is South Africa's largest source of tax revenue, and contributed 38.3 per cent of the total tax revenue collected in 2018/19, reflecting a marginal increase in the contribution share of 38.1 per cent in 2017/18. SARS identified nearly 13.1 million unique individuals and an analysis of the IRP5 certificates linked to them shows that 6.1 million were female taxpayers and 7 million were male.

A statement from SARS and the Treasury read: "These unique individuals should not be regarded as an indication of the number of people working in the formal labour market.

"Some individuals who are not formally employed are also issued with IRP5 certificates. These include individuals who receive benefits from retirement funds or annuities. Sars could not link all the IRP5 certificates to specific individuals as some certificates were incorrectly completed by employers or contained inaccurate information."

Meanwhile, 1342 511 (27.3 per cent) of assessed taxpayers were aged 35 to 44 years; and 1 976 674 (40.2 per cent) of assessed taxpayers were registered in Gauteng, of whom 636 460 lived in the Johannesburg metro and were taxed on an average taxable income of R446 838. The Western Cape came second with 15.39 per cent or 753652 taxpayers.

The 2019 edition provides an overview of tax-revenue collections and tax-return information for the 2015 to 2018 tax years, as well as the 2014/15 to 2018/19 fiscal years.

From South Africa to Egypt, 10 African markets to watch in 2020

JOHANNESBURG -Global bond traders who ventured into Africa this year have reaped rich rewards.

The continent's sovereign Dollar debt has generated total returns of 20 per cent since the start of 2019, more than any other region in emerging markets.

Local bonds have also performed strongly. Egyptian Pound and Nigerian Naira bonds each returned more than 30 per cent in Dollar terms.

If the world's major central banks remain dovish in 2020, that should sustain a dash for higher yields in emerging markets and mean that African bonds remain in hot demand.

The extra yield investors get when buying sovereign Dollar bonds in Africa rather than US Treasuries has narrowed almost 100 basis points this year, according to J.P. Morgan Chase & Co's indices. Still, at 461 basis points, that spread remains the highest of any emergingmarket region and double that of Eastern Europe.

Africa is a "land of opportunity" and could be one of the main beneficiaries if the US and China make more progress on trade talks, said Bank of America strategists including London-based David Hauner.

But investors face plenty of potential risks in 2020. South Africa could lose its last investment-grade rating, Ghana's government might ramp up spending ahead of elections, Zambia's debt crisis could spiral out of control and Nigeria may be forced to devalue its currency. Here's what to watch for in 10 key

SOUTH AFRICA

markets.

Portfolio investors have exited South Africa en masse this year, pulling a net \$10bn from its stock and local-bond

markets, according to data from the Johannesburg Stock Exchange. They've been concerned by the deepening crisis at state-owned power company Eskom, which can't service its R450bn of debts without government support, and the increasing chance that Moody's Investors Service will cut South Africa's final investment-grade rating to junk.

But if President Cyril Ramaphosa makes headway in reforming Eskom, investors will probably be quick to come back. Bank of America and Goldman Sachs both say its inflationadjusted bond yields are attractive and the central bank has room to cut interest rates.

ANGOLA

Africa's second-biggest oil producer is still reeling from a crash in crude prices five years ago. The economy will contract for a fourth straight year in 2019, the International Monetary Fund said this week. Still, investors have been impressed by the central bank's reforms, including the devaluation of the kwanza.

Its fall of 32 per cent this year against the Dollar - only Argentina's Peso has weakened more - has increased inflationary pressure. But it's also eased a shortage of foreign exchange that was crippling businesses.

● EGYPT

Egypt remains a favourite among portfolio investors. Carry traders, attracted by yields of around 14 per cent on pound bonds, have flocked to the Arab nation. The currency has rallied 12 per cent this year, its best performance in at least 25 years - and Societe Generale SA forecasts it will gain another 4.5 per cent to 15.35 per Dollar in 2020.

But the reforms of President Abdel-Fattah El-Sisi are yet to translate into the foreign direct investment and jobs that Egypt badly needs. Aware of that, investors will watch to see if there's any repeat of the anti-government protests in September that briefly rocked local markets.

ETHIOPIA

The Horn-of-Africa nation remains one of the fastest-growing economies in the world. But that masks deep problems: inflation has accelerated to more than 20 per cent and shortages of foreign exchange are acute. Prime Minister Abiy Ahmed, this year's Nobel Peace Prize winner, recently turned to the IMF for a \$2.9bn, three-year loan.

Investors welcomed the move, which should speed up plans to open up and modernise the state-controlled economy. The central bank has already started to weaken the overvalued birr, which had been largely pegged to the dollar. "This IMF deal is one of the biggest ideological shifts I've seen in Africa this decade," said Charlie Robertson, Renaissance Capital's London-based chief economist.

CHANA

West Africa's second-biggest economy holds general elections in late 2020, with President Nana Akufo-Addo probably seeking a second term. The country has a history of fiscal profligacy in the run-up to polls and investors will watch whether the government is more cautious this time. The cedi has been under pressure and fell to a record low this month. But Renaissance Capital, which recommends that clients buy Ghana's Eurobonds, says it is now one of Africa's most undervalued curren-

cies

IVORY COAST

The Francophone country is set to hold a general election in October. Many analysts hoped it would mark a transition to a younger generation of leaders. But there's a chance it will be a contest between President Alassane Ouattara, who came to power in 2011, and his long-time rivals Henri Konan Bedie and Laurent Gbagbo.

If so, "the country risks slipping back into the political turmoil it seemed to have escaped barely 10 years ago," said Teneo Intelligence analysts Anne Fruhauf and Malte Liewerscheidt.

KENY

Kenya's economy is forecast to grow 5.8 per cent next year, making it one of Africa's most buoyant nations. Bank of America says the removal of a cap on interest rates in November is a further reason for optimism and should help the government obtain a standby loan from the IMF. Key to the East African country's longer-term prospects will be whether it can rein in the budget deficit. Forecast to be 6.6 per cent of gross domestic product this year, it's one of the widest in sub-Saharan Africa.

● MOZAMBIQUE

Mozambique completed a debt restructuring in October that had dragged on since it defaulted on \$727m of Eurobonds in early 2017. That should pave the way for the government to raise the funding it needs for its portion of multibillion-dollar gas projects. Once they're finished, the impoverished southern African country is set to become a major exporter of liquefied natural gas.

NIGERIA

Nigeria's status as one of the world's best carry trades will probably last as long as central bank Governor Godwin Emefiele keeps the Naira stable. That's becoming harder, with Nigerian foreign reserves having dropped 14 per cent to \$39bn since July. Emefiele's signaled he'll let them fall a lot further before loosening his grip on the currency, which barely budges. Fiscal authorities, meanwhile, will try to boost an economy that's been growing more slowly than the population for the past five years.

ZAMBIA

Zambia's economy has worsened this year, the latest problems being severe drought and electricity outages. The copper producer's Dollar-bond yields trade at almost 20 per cent, suggesting investors see a high risk of default. The government still has some time on its hands - its next Eurobonds don't mature until September 2022. But many analysts believe it will struggle to avoid a restructuring unless it quickly gets debt relief on loans from China and a bailout from the IMF. President Edgar Lungu has so far seemed reluctant to accept the conditions that would come with a loan from the Washington-based lender. Fin24

Robber throws cash in air, shouting 'Merry Christmas'

COLORADO - A man with a white beard was being held on \$10 000 bond for allegedly robbing a Colorado bank and throwing the stolen cash into the air while shouting, "Merry Christmas" to passersby, police and local media reported on Tuesday.

David Wayne Oliver, 65, was arrested at a nearby Starbucks coffee shop after he held up the Academy Bank in Colorado Springs on Monday afternoon, according to a police report. Police said the suspect had "threatened the use of a weapon" and left the bank with an undisclosed amount of cash.

A police spokesperson could not immediately be reached for comment, but Colorado Springs television station KKTV reported that eyewitness Dion Pascale recounted Oliver stepped outside the bank and tossed the money "all over the place". "He started throwing money out of the bag" before yelling, "Merry Christmas," the TV station quoted Pascale as saying.

Pascale said bystanders retrieved some of the money and returned it to the bank as Oliver walked to the Starbucks, sat down and appeared to be waiting for police to arrest him, KKTV reported.

The Denver Post quoted police as saying "thousands of dollars remained unaccounted for," adding there was no indication Oliver used a weapon in the heist.

And, for the benefit of those who had still not got the message - or only just switched on the telly - she ended on the same thought: Christmas was "a timely reminder of what positive things can be achieved when people set aside past differences and come together."

The best way to achieve this, she explained

repeatedly, was through "small steps" - a phrase she had borrowed from the first man on the Moon. Recalling that this year is the 50th anniversary of Nasa's Apollo 11 mission, she spoke of being 'transfixed' watching Neil Armstrong 'taking a small step for man and a giant leap for mankind'. LONDON - Prince Andrew skipped pital being treated for a mystery ailthe Christmas Day church service to 'avoid being heckled' while the other royals beamed with joy as they met an adoring public at Sandringham.

The Queen was buoyed after her great-grandchildren stole the show in their first public appearance on her Norfolk estate.

But the absence of her poorly husband, Prince Philip, and shamed son, the Duke of York - as well as Harry and Meghan - cast a shadow over the occasion. After four days in hosment, frail Philip, 98, was being cared for at the main house on the Norfolk estate as Her Majesty and other senior royals attended church.

During the service, which was broadcast over speakers to the public outside, Canon Jonathan Riviere appeared to refer to the Duke of Edinburgh when he told the congregation: "We pray for those struggling with illness." Prince Andrew was forced to step down from public duties over his friendship with paedophile Jeffrey Epstein. Daily Mail

NEW YORK - Billionaire US presidential candidate Michael Bloomberg on Tuesday said his campaign had unknowingly used prison workers to make telephone calls on his behalf. Bloomberg, who last month entered the Democratic Party race to face Republican President Donald Trump in the November 2020 election, said the campaign had ended its relationship with a company that used prison labour for making phone calls."We do not support this practice and we are making sure our vendors more properly vet their subcontractors moving forward," Bloomberg said in a statement.

MANILA - Christmas turned to chaos for many holiday observers in the central Philippines as a typhoon with strong winds and heavy rains destroyed homes, cut off power and stranded travellers, disaster officials said on Wednesday. Typhoon Phanfone, rated category 2 by Tropical Storm Risk, was packing maximum sustained winds of 120km per hour with gusts up to 150 kph when it made landfall in the eastern province of Samar on Tuesday, weather and disaster officials said. More than 4 000 people have been evacuated in the Eastern Visayas region of the central Philippines, disaster officials said, although no deaths have been reported. Reuters

GAZA - Israeli Prime Minister Benjamin Netanyahu was forced to take cover in a bomb shelter after a rocket was launched from the Gaza Strip to city where he was hosting a campaign visit. The Israeli military confirmed the launch against Ashkelon, which is 7.5 miles (12 km) from the coastal Palestinian enclave, saying the rocket was shot down by an Iron Dome air defence interceptor. There was no immediate claim of responsibility in Gaza, which is under the control of Hamas Islamists and where a smaller armed faction, Islamic Jihad, exchanged fire with Israel during a twoday surge of violence last month. Daily Mail

LONDON - The biggest reason that voters ditched the Labour Party at this year's general election was Jeremy Corbyn's leadership, a YouGov poll claims.

Following the left-winger's disastrous performance as Boris Johnson secured a landslide victory, the polling group asked 500 people who backed him in 2017 why they did not this time around. Labour's vote share fell by almost eight per cent this time and 35 per cent of respondents said they didn't back them this year due to Corbyn's leadership.

President Erdogan closer to deploying troops in Libya

TRIPOLI - Turkish President Tayyip Erdogan has hinted he is edging closer to deploying troops in Libya.

Erdogan paid a surprise visit to Tunisia on Wednesday to discuss cooperation for a possible ceasefire in neighbouring Libya, where Ankara supports the internationally recognised government,

The Turkish president, speaking at a joint news conference with Tunisia's President Kais Saied, also reaffirmed Ankara's willingness to send troops to Libya if it received such a request.

Erdogan's visit to Tunis came a month after Turkey and Libya signed two separate accords, one on maritime boundaries in the eastern Mediterranean and another on security and military cooperation.

Turkey backs Fayez al-Serraj's Government of National Accord (GNA), which has been fending off a monthslong offensive by Khalifa Haftar's forces in eastern Libya.

Erdogan, the first head of state to visit Tunis since Saied's landslide election win in October, said the developments in Libya were having a negative impact on neighbouring states, including Tunisia.

Discussed

"We discussed the possible steps we can take and cooperation opportunities with the aim of establishing ceasefire in Libya as soon as possible and returning to a political process," Erdogan

In Tunisia's hybrid political system, the prime minister controls most policy areas, while the president is in charge of foreign affairs, defence and security. Tunisia's main foreign policy interests have traditionally been in maintaining strong ties with its two much larger neighbours Algeria and

Last week, Erdogan said Turkey would not remain silent in the face of

"mercenaries" such as the Russianbacked Wagner, a group of private military contractors, supporting Haftar's forces in Libya. Moscow has said it is very concerned about the prospect of Turkish troops being deployed there.

Deploying

On Wednesday, Erdogan reiterated that Turkey would evaluate the option of deploying troops if the GNA asked for support after signing the military agreement, and added that the Wagner group had "no connections, nothing" in Libya.

US PULLS AMBASSADOR FROM ZAMBI

...after he criticised jailing of gay couple and was told he 'crossed the line'

ZAMBIA -The US State Department has recalled its ambassador to Zambia after he criticised the harsh laws around sodomy and the jailing of a gay couple.

A spokesperson for the US State Department said Washington is 'dismayed' by the Zambian government's statement that

Ambassador Daniel Foote's position 'is no longer tenable.'

"Despite this action, the United States remains committed to our partnership with the Zambian people," the spokesperson said.

Relationship

"We seek an open and frank relationship of mutual respect, commensurate with the generous aid provided to the Zambian people by the United States."

Zambia's High Court last month jailed the male gay couple for 15 years for engaging in sexual relations "against the order of nature", a decision the US ambassador said was horrifying.

When Foote publicly stated he was 'personally horrified' by the jailing, he was told he had "crossed a line."

Foote added: "Meanwhile, government officials can steal millions of public dollars without prosecution, political cadres can beat innocent citizens ... with no consequences, poachers can kill numerous elephants... and face a maximum of only five years."

Beneficiary

President Edgar Lungu said on December 15 that Zambia, a major beneficiary of US aid, had sent a protest letter to Washington over the remarks by Foote and was awaiting a response.

A US embassy source who is not allowed to issue statements told Reuters that Washington had decided to recall its ambassador because it was difficult for him to work in Zambia. "Since Lungu says he does not want to work with Foote, there was no point of him remaining. Also don't forget that there are security issues so Washington want their man back," the source said.

"The US cannot be paying a

salary to someone who cannot work because the hosts don't want him," a second US embassy source said.

Zambia's foreign affairs ministry did not respond to a request for comment.

Zambia receives hundreds of millions of dollars every year in financial support from the United States, some of which goes toward fighting HIV/AIDS.

African countries have some of the world's most prohibitive laws governing homosexuality. Same-sex relationships are considered taboo and gay sex is a crime across most of the continent, with punishments ranging from imprisonment to death.

"The United States firmly opposes abuses against LGBTI persons. Governments have an obligation to ensure that all people can freely enjoy the universal human rights and fundamental freedoms to which they are entitled," the State Department spokesperson said. Daily Mail

BOKO HARAM JIHADISTS KILL 7, ABDUCT TEENAGE GIRL

ABUJA -Boko Haram jihadists killed seven people in a raid on a Christian village in Nigeria on Christmas Eve.

Dozens of fighters driving trucks and motorcycles stormed into Kwarangulum late on Tuesday, shooting fleeing residents and burning homes after looting food supplies.

"They killed seven people and abducted a teenage girl in the attack," local vigilante David Bitrus said.

"They took away food stuff and burnt many houses before leaving,' he said, adding that a church was also burnt. The jihadists were believed to have attacked from Boko Haram's nearby Sambisa forest enclave, said Chibok community leader Ayuba Alamson who confirmed the toll. Boko Haram and its IS-affiliated

Islamic State West Africa Province (ISWAP) faction have recently stepped up attacks on military and civilian targets. Kwarangulum, which is 10 miles from Chibok, came under attack in April by Boko Haram terrorists who stole food and burned much of the village. Residents had managed to flee before the arrival of the jihadists following tip-off from people who saw the gunmen heading toward the village.

Chibok is the scene of the mass kidnap of 276 schoolgirls in 2014 by Boko Haram which sparked global outrage and drew attention to the group's notoriety. Daily Mail

Road carnages claim 589 lives in SA

CAPE TOWN - A total of 589 people have been killed on South African roads since the start of this year's festive season, Transport Minister Fikile Mbalula said this week.

The fatalities were the result of 489 crashes, the minister said in his latest update on road fatalities during the festive season which began in mid-November.

The toll remained high despite a 25 per cent drop from the same period last year, when 839 people were killed in 656 fatal accidents, the minister

"The majority of those who died were pedestrians, at 39 per cent, followed by passengers, at 34 per cent, drivers, at 26 per cent, and cyclists, at one per cent," Mbalula said.

The minister attributed most of the fatal accidents to drunk driving, speeding, and reckless and negligent driving. Law enforcement agencies have made 2915 arrests, a slight drop from the 3 052 arrests recorded during the same period last year, according to

Improvement

The drop represented a slight improvement in driver behaviour, Mbalula said. "However, we remain concerned about the high number of people who continue to drive under the influence of alcohol," he said.

Among those arrested this year, 1 397 were arrested for driving under the influence of alcohol and 272 for speeding, Mbalula said.

35 civilians killed in attack

OUAGADOUGOU - A militant attack in northern Burkina Faso killed 35 civilians, almost all of them women, the president said, one of the deadliest assaults in nearly five years of jihadist violence in the West African country. Seven soldiers and 80 jihadists were also killed in the double attack on a military base and Arbinda town in Soum province, the army said.

Burkina Faso, bordering Mali and Niger, has seen regular jihadist attacks which have left hundreds dead since the start of 2015 when militant violence began to spread across the Sahel region.

Man dies of suspected suicide in custody

LONDON - A Nigerian man died in federal immigration custody over the weekend, just days after he was convicted of a sex offence and assault in Maryland. Anthony Oluseye Akinyemi, 56, died early on Saturday morning after being found unresponsive in his cell at the Worcester County Jail in Snow Hill, Maryland, according to a Monday news release from US Immigration and Customs Enforcement.

The official cause of death was not immediately determined, but authorities believe Akinyemi took his own life by strangling himself.

Court rejects opposition election fraud claims

GABORONE - A High Court in Botswana's capital on Tuesday dismissed the opposition Umbrella for Democratic Change's (UDC) call to have the results of the October general election thrown out over "irregularities".

Botswana voted on October 23 and the ruling Botswana Democratic Party (BDP) won with a majority of 38 seats against the UDC's 15 seats in the 57-member Parliament. The UDC had petitioned the court and contested the outcome of the election citing "irregularities in some of the constituencies".

Rights activist charged with money laundering

DAR ES SALAAM - A Tanzanian court charged rights activist Tito Magoti with money laundering and other offences after holding him in custody for four days, the organisation for which he works said. Prosecutors in Kisuto court said Magoti and co-worker Theodory Giyan had been charged with leading organised crime, money laundering and possessing computer programmes designed for the purpose of committing crimes. Both were being held in custody to await a January 7 hearing. Magoti, of the Legal and Human Rights Centre (LHRC), was arrested by plain-clothed officers who bundled him into an unmarked car, initially raising fears that he had been abducted. AFP



KING DALINDYEBO JAILED FOR JOINING DA'

CAPE TOWN - It is claimed that AbaThembu King Buyelekhaya Dalindyebo was punished and sentenced to jail for his decision to dump the ANC and join the DA.

This is according to the President of the Congress of Traditional Leaders of SA (Contralesa), Kgoshi Mathupa Mokoena, in his reaction following King Dalindyebo's release on Sunday night from the East London Correctional Centre where he was serving a 12-year jail sentence.

"The incarceration of King Dalindyebo was politically motivated. At some point, the King joined the DA and that did not go down well with the authorities in government," Kgoshi Mokoena said. He maintained that King Dalindyebo was also punished for calling a senior government official a boy - "meaning he was not circumcised".

"As you can remember, one former minister of Co-operative Governance and Traditional Affairs (Richard Baloyi) was sacked for refusing to take disciplinary action against King Dalindyebo," Kgoshi Mokoena said.

King Dalindyebo's Spokesperson, Prince Mthunzi Ngonyama, said the royal family was planning to conduct a ritual for the king that would include a "cleansing ceremony" before he could take up his duties. After his release on Sunday night, King Dalindyebo travelled from East London Correctional Service Centre for two hours and 30 minutes on a road trip to the Great Bumbane Palace in Umtata.

Prince Mthunzi Ngonyama accompanied the king's wife, Queen Nokwanda Dalindyebo, to East

London for a formal hand-over to his family upon his release on Sunday.

The King was, however, driven to his family home by prison officials. "The King is resting at his private residence. "He will, in the coming days, address his people and make pronouncements to them about things he intends to do for them," Ngonyama said. The Star

CAPE TOWN -Sangoma Sibusiso Mathe is furious with Zahara.

The 38-year-old from Khayelitsha, Cape Town, told Daily Sun the artist owed him money. He had booked her to perform at the End of the Year Music Festival in Khayelitsha, which took place last Saturday, but she didn't

"I'm very unhappy with what she did. I loved her so much but she disappointed me. I never received a proper apology. I just got a phone call to say she was sorry for what happened," Mathe said. The sangoma had booked a flight from Joburg to Cape Town for Zahara and her manager, but the artist apparently only rocked up after the show. Mathe claimed he had already paid Zahara an appearance fee deposit of R10 000 of a total R20 000 she was supposed to be paid for the performance. He said: "I want my money back. I paid her R10 000. My expenses to bring her to Cape Town with her manager is another R10 000. Daily Sun

Zuma spotted at chess tourney

DURBAN - Former president Jacob Zuma has made his first public appearance since reports that he was in Cuba seeking treatment for an illness.

Zuma was spotted at the 11th annual JG Zuma Chess Tournament at Sibusisiwe Hall in Mandeni, where he went to "encourage schoolchildren competing in a tournament", according to TimesLive.

According to the publication, the chess tournament reaches out to scores of schoolchildren across the province during the December holidays. Weekly newspaper Sunday World previously reported that Zuma was in Cuba seeking treatment for an illness linked to an alleged poison plot in 2014. He also, apparently, was struggling with memory loss.

Investigate

The National Prosecuting Authority, however, in September declined to investigate claims of him being poisoned, saying there was no evidence that such an act had taken place.

On December 9, Zuma's lawyers told the Zondo commission of inquiry into state capture that he would not meet his deadline to respond to an application by journalist and broadcaster Redi Tlhabi for leave to crossexamine him, because he had been hospitalised, TimesLive reported.

During his testimony in July, Zuma claimed that Tlhabi was working on a film about his rape trial. He was acquitted on a charge of rape in 2007, News24 reported.

The former president claimed there were attempts by certain individuals to "assassinate his character" and that the media was part of this attempt.

He said Tlhabi was working on a movie to push a narrative that he is a rapist.





TOKYO - Sprinting legend Usain Bolt believes that his world records could fall at next year's Olympic Games in Tokyo.

The 33 year old was in Japan for the officially opening of the new National Stadium, the main Olympic venue which will host the opening and closing ceremonies, along with all athletics events at the games.

The 68000 capacity stadium, which started to build in 2016, was completed in November and the three-time Olympic 100m champion participated in a commemorative relay race dubbed 'One race', which featured Olympic and Paralympic athletes. Bolt said in an interview with Olympic.com that there is a chance that some can step up to claim his 100m world record. "Anything is possible, you know what I mean. I'm

looking to see what happens next season," he said. "Let's see whose running fast, let's see who is doing good."

One of the athletes that could seriously challenge Bolt's 100m record is American Christian Coleman, the holder of the

60m world record. The 23-year-old captured his first outdoor world title at the World Athletic Championships in Doha, winning the 100m in a lifetime best and world-leading time of 9.76 seconds.

NEW YORK - Good friends Serena Williams and Caroline Wozniacki will team up on the doubles court for the first time next month at the ASB Classic in New Zealand, which runs Jan. 6-18.

Williams was one of the bridesmaids in Wozniacki's wedding to former NBA standout David Lee last June. Now with Wozniacki set to retire following the Australian Open to focus on marriage and starting a family, the duo will team up after years of battling in singles.

"We've been wanting to play doubles together for a long time, but it just hasn't worked out so I'm really excited that it's finally going to happen, especially at one of my favourite tournaments on tour.

It's going to be so much fun!" Wozniacki said. Williams, considered by many the Greatest of All Time (GOAT) of women's tennis, leads Wozniacki 10-1 all-time in singles, including a victory in the 2014 US Open final.

Schumacher's wife gives cryptic update

GENEVA - Michael Schumacher's wife has given a rare update about the Formula 1 legend's condition ahead of the six-year anniversary of the skiing accident which left him in a coma.

The seven-time champion suffered a serious brain injury while skiing in the Alps on December 29, 2013, and has not been seen in public since.

He hit his head on a rock and was placed in a medically-induced coma

for six months and has been treated at his family's home in Lake Geneva ever since. But as fans are preparing to launch a new 'KeepFightingMichael' social media page on the anniversary of the accident, Schumacher's wife Corinna has opened up, saying "big things start with small steps", The Mirror reported.

She reportedly told fans: "Many small particles can form a huge mosaic. Together you are stronger, and that is exactly how combined forces of the KeepFighting movement make it easier to encourage others."

The fan club based in Kerpen, Germany, Schumacher's birthplace, has announced it will use the hashtag 'KeepFighting' for its campaign.

It is also the name of the family foundation which supports accident victims and invests in brain and spinal cord research.

Chairman of the club Reiner Ferling said he hopes to see Schumacher in public again.

KIM CLIJSTERS RETURNS TO ACTION IN MARCH 2020

LONDON - Kim Clijsters plans to make her delayed comeback to tennis at the Monterrey Open in March, more than seven years after her second retirement.

Clijsters said she accepted wild cards into the Mexican hard-court event which begins on March 2, followed by Indian Wells from March 11, then the Charleston clay tournament from April 6.


The former No. 1 and four-time major champion, who already is a member of the International Tennis Hall of Fame, announced her comeback attempt in September. Her plans were delayed in November when she tore a ligament in her right knee.

"I am really pleased with my progress and it's been great to get back on the court and play tennis again," Clijsters said in a statement. It's been a setback but has really shown me how determined I am to return to the game I love."

WTA rules allow her, as a past Grand Slam champion, to receive unlimited wild-card invitations to tournaments and, as someone who is older than 30, to opt out of mandatory appearances at certain events.

The 36-year-old Clijsters left the tour in 2007 and got married and had the first of her three children. She returned about two years later and won her second and third US Opens and an Australian Open. She retired again in 2012 and was working in television.

Slade facing race to play in Six Nations

LONDON-Henry Slade could face a fight to be fit for the Six Nations after injuring both ankles playing for Exeter against Leicester last weekend.

The centre, 26, hobbled off at Welford Road during the first half of Chiefs' 31-22 win.

While Exeter were unable to confirm the extent of the injury after initial scans, Slade will almost certainly miss the festive fixtures and the European Champions Cup games in January.

'It's not something he will be able to get over in a week or two, it will be a bit more significant than that," said Exeter Director of rugby Rob Baxter.

'He picked up injuries to both ankles. "He hobbled along with one and then picked up a second one.

"The second one is an injury to the old injury he had which he had plated.

"It's not so much that he has done the two as they both could end up being similar times, but it's not an insignificant injury.

"We will know later in the week when he has more scans and we get into the early treatment phase over the next couple of days.

He's going to be out for a little while. We are hoping it is weeks not months at this stage."

England's opening Six Nations game is on February 2 against France in Paris, so if Slade's injuries are significant they could well rule him out of at least the early stages of the championship.

Slade was involved in every matchday squad at the World Cup and started the quarter-final against Australia before moving to the bench as Eddie Jones picked George Ford, Manu Tuilagi and Owen Farrell together. *Daily Mail*

'Ronaldo had agreement with AC Milan before signing for Juventus'

JUVENTUS - Cristiano Ronaldo almost joined AC Milan before the deal hit the rocks, according to former sporting director Massimiliano Mirabelli.

The Portuguese superstar made the most high profile move of 2018 when he swapped Real Madrid for Italian champions Juventus in a £100million deal. But the 34-year-old's future

could have panned out differently if previous Milan owner Li Yonghong hadn't pulled the plug on the move.

Mirabelli admitted that the move wasn't financially feasible but he would be playing in a Milan shirt now had the current owners been at the helm.

Speaking to TV channel Sportitalia, he said: "It was something we talked

about with Jorge Mendes.

"We knew there could be problems with Real and Ronaldo.

We did everything, but then the Chinese owners blocked the deal because it was not sustainable.

"With the current owners CR7 would have been a Milan player."

AC Milan were taken over by American hedge fund Elliot Management in July 2018 to end Li's one-year spell at the club.

Mirabelli also revealed how they attempted to appoint former Chelsea boss Antonio Conte as manager.

He added:

, "I was proud to have made this choice [when appointing Gattuso] because of his professionalism, his seriousness and the love he and his staff put into their work.

"The Chinese owners did not agree because they thought from the outside it would look like a backward step, but I explained that for me Rino was the coach of the future.

He has worked in Greece, Serie C and B and for me this is a positive.

"We listened to [Conte], we talked directly. It was a chat that didn't result in anything."







KickOff.com looks at eight players not pulling their weight at the Soweto giants:

JORIS DELLE (29)

The former French youth international joined the Mighty Bucs in July this year but has played only three games for the club this season. With his credentials, a lot more is expected of the former Feyenoord shotstopper, who has yet to prove his worth to the Bucs faithful.

SIYABONGA MPONTSHANE (33)

Mpontshane is into his fifth season with the club but has never really established himself as first-choice keeper, and this season has seen him fail to make a single contribution to the team as he continues to watch from the stands.

JUSTICE CHABALALA (28)

Once regarded as one of the best defenders in the country, he has played only two games this season as Pirates technical team appear to see something lacking in his game. Starved of opportunities, there is a belief that Chabalala is not in the plans of the club as a possible move away in the January transfer window looms.

TEBOGO TLOLANE (24)

The former Chippa United defender has made just a solitary appearance this season, with the left-back position covered by Innocent Maela and Paseka Mako. Tlolane was once a key figure at The Chilli Boys but now finds himself in the stands at the Soweto giants.

BONGANI SAM (22)

Sam played no less than 25 matches for Bloemfontein Celtic last season as he received widespread plaudits for his influence at leftback. However, he has yet to make his competitive debut for Pirates, after coming off the bench in the Carling Black Label Cup Soweto Derby back in July.

AUGUSTINE MAHLONOKO (18)

In 2018 Mahlonoko was named by UK publication The Guardian as one of the Top 60 young players in the world. This season, the youngster finds himself playing with the club's ABC Motsepe League feeder team Pele-Pele

AUSTIN MUWOWO (23)

The Zambian footballer of the year has managed only one appearance for the club this season and is taking up a valuable foreign space in the club's stable. Whether he could impress new coach Josef Zinnbauer remains to be seen.

ZAKHELE LEPASA (22)

Lepasa was once dubbed the 'Kaizer Chiefs slayer' after he condemned Pirates' Soweto rivals to an embarrassing Nedbank Cup final defeat to First Division side TS Galaxy in May. He has since been recalled from that loan spell but has so far featured just once for The Buccaneers this season as he finds himself in the periphery at the club.

I WATCHED THE GAMES ON DVDs - ZINNBAUER

JOHANNESBURG

Orlando Pirates' new coach Josef Zinnbauer, naturally, having had so little time to work with his team, saw plenty of room for improvement as Bucs got off to a decent 3-1 Absa Premiership winning start under his tenure against Polokwane City at Orlando Stadium on Saturday.

Zinnbauer's background, though, and the manner in which he came to Pirates, remains shrouded in mystery as questions related to such in the post-match press conference were quickly shut down by Bucs' Media Officer Thandi Merafe.

Tembo unsure of catching up with leaders Chiefs

But Harry Kane equalised after the interval and Alli finished off a flowing Tottenham move in the closing stages to erase the bitter taste of last weekend's acrimonious London derby loss to

"The little details are more important than what people look at. His attitude and fighting spirit was so good."

That Chelsea setback was completely overshadowed by the alleged racist abuse of Blues defender Antonio Rudiger by Tottenham fans after his role in Son Heung-min's red card.

Amid widespread calls for stronger action to stamp out racism in football, Tottenham fans appeared to behave better this time.


