# Ratepayers petition PM

#### ...over Mbabane Municipal Council CEO

MBABANE ratepayers' leadership yesterday delivered a petition to the Prime Minister Ambrose Mandvulo Dlamini asking him to remove Gideon Mhlongo as CEO of Mbabane Municipal Council.

This follows the feud between the ratepayers, street vendors and the Mbabane Municipal Council in recent months. Led by Solomon Nxumalo who is the Chairperson of the Ratepayers Association, Dan Mavuso who is the Secretary of the Zone Leaders and Sibongile Mazibuko, they started at the ministry of housing and urban development where they also delivered a petition. In their petition, the leaders of the aggrieved parties outlined that they were asking for the premier's intervention because they were aware that Mhlongo was brought back as an employee of the Council by the prime minister's office. The ratepayers said this is despite the fact that there are two reports of a commission of inquiry into the affairs of the Municipal Council of Mbabane, appointed by the minister of housing and urban development that were critical of Mhlongo's leadership at the munic-

They disclosed that one of these


commission reports was the November 2008 'Matsebula Report', from which Mhlongo was allegedly dismissed by the council.

The petitioners said that the Matsebula Commission of Inquiry found Mhlongo guilty on a number of issues regarding the status of his employment.

"We shall endeavour to enumerate the issues that compromise human security and infringe seriously on the rights of the residents especially the elderly, OVC and the unemployed," reads part of the petition. Among the many grievances the ratepayers accuse Mhlongo of is drafting a policy and forcing its implementation despite the fact that Parliament stopped it pending consultation with stakeholders and they find this as a major cause for the conflict in the municipality.

The ratepayers made a number serious allegations against Mhlongo, raising the issue of the awarding of the car wash tender as a prime example why they wanted the embattled CEO removed from his position.

The car wash business in question is situated by the Prince of Wales, which was operated by 20 young men who were later removed from that spot. The tender was then awarded to Vusi Sibisi. They also lament the escalating property rates which they claimed the elderly cannot afford and they allege Mhlongo is refusing to reconsider.



#### ... 'Mhlongo's salary too high'

RATEPAYERS and street vendors now want Gideon Mhlongo's salary reviewed.

In fact, ratepayers have alleged that the Mbabane Municipality chief executive officer earns way above the Prime Minister Ambrose Mandvulo Dlamini.

There are claims that Mhlongo's package is worth over E140 000, including allowances.

It is an open secret that Mhlongo has asked for a salary increase of five per cent.

This has irked the ratepayers who feel he does not deserve this huge pay as he does not have a contract that outlines his employment terms and conditions together with his salary.

Secretary of the Zone Leaders

Dan Mavuso wondered how and why the ratepayers' money was used in such a manner. He said as ratepayers they are the ones who contribute to the CEO's salary and the fact that he was now looking for a salary increment did not sit well with them.

Sibongile Mazibuko said the ratepayers cannot afford the CEO's salary because it was too high. She wondered how he got the increment while the premier has made it clear that there should be no salary increments as means of salvaging the current economic situation.

Mazibuko said there is need to readvertise the CEO's post so a qualifying and deserving person is recruited in a fair and transparent hiring

# UNESWA, ECMU get E191million

THE University of Eswatini (UNESWA) and Eswatini Christian Medical University (ECMU) have been given E191 044 105.

The two institutions received the money as a grant from the ministry of education and training for the first three months of the ongoing financial year.

This is contained in the report of the education ministry for the first quarter of 2019/20 financial year.

The report stated that the money released for post-secondary education for the first three months (April to June) was E191 845 437.

Of this budget, E191 044 105 was transferred to subvented institutions which included UNESWA and ECMU.

The ministry of education and training further released E14 911 137 for teacher training institutions like William Pitcher in Manzini and Ngwane College in Nhlangano.

Of this amount, E13 073 307 was committed by the ministry on these institutions. In-Service Education and Training (INSET) was also included in this budget.

The money, according to the report, was spent on salaries, travel and communication, utilities, service contracts, consumables and office equipment under teacher education (William Pitcher, Ngwane College and INSET).

Adult and non-formal education's

released budget for the quarter was E3 260 083. Of this, E2 816 682 was spent during the three months of the last quarter. Expenditure was mainly on salaries, subvention to Sebenta National Institute (SNI) and consumables.

An amount of E10 755 269 was spent for the 2019/20 first quarter on vocational education by the education ministry.

E12 520 538 was released by the ministry and the E10 755 269 was spent on CTA charges, personnel costs, communications, professional services, and consumables.

Vocational education institutions in the country include Gwamile VOC-TIM, Eswatini College of Technology (ECOT) and the various skills centres.

The ministry spent E3 501 122 and the released budget for this quarter was

E4 087 468. The money was spent on CTA charges, personnel costs, communications, professional services, and consumables. On career guidance and counselling, the ministry spent E1 124 422 on personnel costs.

The released budget on this department was E1 661 394.

The ministry, during the 2019/20 first quarter, spent E905 097 and the budget released was E593 310. On special education, E4 963 340 yet the released budget was E5 446 090. Expenditure was mostly on food commodities for special schools.

The budget in this activity, according to the report, is not adequate to meet the needs of the special schools, including Ekwetsembeni, Ekululameni, and Schools for the Deaf (both primary and high schools).

### E334m spent on primary education

AN amount of E334 506 708 has been spent by the ministry of education and training on primary education.

This is contained in the report of the education ministry for the first quarter of 2019/20 financial year. It must be noted that the money talked about here includes free primary education.

The primary education's released budget for the quarter was E385 187 875 and of this, E334 506 708 was spent. The budget was mostly spent on salaries, workshop for primary school inspectorate and free primary education grants

(FPE).

At least E297 128 594 was spent on personnel costs and E101 272 was spent on professional services. E7 901 622 was allocated on consumables, while E29 375 220 was spent on internal grants provided by the ministry towards primary education.

The ministry further spent E331 122 723 on secondary education. The money released towards this course for the first quarter of the 2019/20 financial year was E267 673 039. The budget was mostly spent on CTA charges, con-

sumables, and salaries. The overall budget has an over-expenditure of 24 per cent due to personnel costs, which have been overspent by 24 per cent.

On curriculum development, the ministry spent E3 501 122 yet the budget released was E4 087 468. The money was spent on CTA charges, which cost E7 192. Personnel costs accounted for E3 446 605 and travel and communications coast accounted for E8 011. Professional services and consumables accounted for E28 814 and E10 500, respectively.

#### Micro-Projects' E125m projects for education ministry

MICRO-PROJECTS has implemented different projects that total E125 million for the ministry of education.

The department, which is under the ministry of economic planning and development, carried out the different projects in a space of three months, from April to June. This is contained in the

report of the education ministry for the first quarter of 2019/20 financial year.

The work done by Micro-Projects includes constructing inclusive secondary schools, building secondary school classrooms, extension of Eswatini Skills Centre in Pigg's Peak, rehabilitation of Sebenta National Institute (SNI), and water supply to schools.



Other projects that were implemented by this unit include building toilets, construction of primary and secondary school teachers' houses, and rehabilitation of government schools. The projects by Micro-Projects were part of the capital projects to be done by the ministry of education and training for the first quarter of the 2019/20 financial year.

E133 million was allocated for the ministry of education and training to implement its capital projects and Micro-Projects was given E125 million to implement about 10 projects under the education ministry. The ministry of education and training has done three, out of the 13 ought to have been implemented by the ministry, according to the report.

This means the education ministry only spent E8 million to implement its own capital projects for the first quarter of the 2019/20 financial year.

# LOZITHA CRASH:

TWO more victims of the horrific accident at Lozitha on Tuesday who were fighting for their lives, have succumbed to death.

This now brings to four the death toll for the accident, which occurred along the MR3 Highway on Tuesday after-

The two, who had been admitted to hospital, are believed to have succumbed to death in the early hours of yesterday, according to our sources.

The trio was rushed to hospital after the driver lost control of the car following a tyre burst, overturned and landed in a donga along the MR3 Highway;

The driver had apparently tried to apply brakes when the front tyre burst, which caused it to spin and overturn.

Two of the five occupants of the Chevrolet sedan died on the spot.

One of the deceased persons was the driver of the car and was aged 33 from Gebeni, while the other was aged 33 years also from Gebeni and the other two were aged 25 from Bhunya and Gebeni, respectively.

The fifth victim of the accident who was also admitted in hospital was report-

edly discharged from hospital and is aged 31. He is said to hail from Ndinda

#### Notified

The identities of the victims have not been released at this point as their next of keen have not yet been notified.

According to witnesses, the accident is suspected to have been caused by the high speed at which the lime Chevrolet sedan was moving in while headed towards the Mbabane direction. It could not be ascertained why the vehicle was over-speeding but eye-witnesses speculated that that they must have been involved in some sort of deals.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed the death of the two victims, further confirming that the families of the four men were still to be notified of their deaths.

#### PSAs to mobilise students, conductors for CoLA strike

MEMBERS of the public sector associations (PSAs) have called upon their leadership to engage, mobilise tertiary students and the public transport associations for the planned strike action.

The public sector associations are demanding a Cost of Living Adjustment (CoLA) from government which they say has been due for the past five years. Yesterday, the workers' unions continued with their preparatory meetings which started on Tuesday in various branches across the country. Attendees at the meeting which was held in Siteki highlighted a need for the associations to rope in other organisations to ensure that the proposed strike action is effective.

This was confirmed by Secretary General of the Swaziland National Association of Teachers (SNAT) Sikelela Dlamini who stated that the associations intend to make an impact which would compel govemment to give in to their demands.

Dlamini said the issue of cost of living adjustment affected every Liswati in one way or the other, hence the need for all workers to join hands with the public sector associations. The secretary general was echoed by Deputy President of the Trade Union Congress of Swaziland (TUCOSWA) Simangele Mtetwa who urged the leadership to engage the public transport associations and the Student Representative Councils in formal talks. Mtetwa said they acknowledged that during previous activities, other organisations such as the transport industry distanced themselves as they felt neglected or side-lined by the

"This time we have to do things right and engage these organisations in a formal setup and ask them to join the struggle," said Mtetwa.

Meanwhile, the secretary general of SNAT urged shop stewards to ensure that members of their unions come in their numbers for the strike. Dlamini recalled that the last strike action which recorded the highest number of attendees was in 2011 where there were about 8 000 workers on the streets at the same time.

"We expect a total shutdown of business during the dates of the strike which will first be held regionally," he said. The strike action will be preceded by the delivery of petitions at government departments on September 17. Dlamini said they were also hoping to make this as effective as the actual day of the strike action.

#### Student riots will affect tertiary institutions - Govt BY SIFISO NHLABATSI

**GOVERNMENT** has condemned the acts of violence by students from tertiary institutions during the recent protests over allowances and other grievances.

The government has expressed its concern that these incidents of violence and impromptu closures of learning institutions will greatly affect the students in the near future as they may affect the ranking of their tertiary institutions and render their qualifications inferior in the job market, locally and internationally.

Acting Prime Minister Themba Masuku said His Majesty's Government regrets the unfortunate closure of the University of Eswatini and three other tertiary institutions following incidents of violence that led to devastating damage to prop-

He explained that these acts of violence caused extensive damage of the university property, particularly the bookshop, hostels, and student's personal artifacts.

Masuku said government notes that the vandalised infrastructure is a crucial tool for learning.

"Government strongly condemns this violence and absolutely finds no justification for this act of blatant vandalism," Masuku said.

Explaining the situation which has escalated out of control, Masuku said it was necessary and appropriate to point out that the bone of contention that led to this violent destruction of property is the disbursement of student allowances

that government loans out to tertiary students to further their education and build their future and that of their chil-

#### Review

According to Masuku, the ministry of labour and social security had committed to looking at the monthly disbursement option and review the allowances upward and had asked the students through their representatives to be patient until Friday.

He added that the ministry had been in talks with the Student Representative Councils from the different tertiary institutions as nothing had been finalised yet, only to be met with news of this

The acting prime minister pointed out

that such incidents could greatly affect the students in the near future.

#### Guidance

Government implored parents and guardians to be involved in giving constructive guidance to the students to ensure they do not jeopardise their future by involving themselves in vandalism and destruction of property, which is a criminal offence punishable by law.

Masuku pointed out that parents are also guarantors of the educational loans. The acting prime minister assured students that His Majesty's government would continue giving educational loans to deserving Emaswati and asked students to act responsibly and embrace the spirit of tolerance and dialogue which is the hallmark of Eswatini.


She was echoed by Siteki Branch

Furthermore, Masina said there were other issues which also needed to be addressed during the delivery of petitions to government depart-






#### IMBALI HAPPY WITH GIFTS

# SANU wants owing students to pay

THE Southern African Nazarene University (SANU) has denied allegations made by students that they are selling photocopied books at prices higher than those offered by bookshops.

The institution further shed some light on the issue of students who were served with statements indicating that they owed the institution money.

Last week, SANU students were shocked when they were served with statements indicating that they owed tuition fees, yet they were of the idea that government had settled every debt for them.

The students expressed their worry that, they might end up not getting their certificates after they gradu-

#### Students

SANU Marketing Manager Petros Mavuso said when students are admitted at the university the institution reflects as to how much tuition must be paid.

He said if a student decides to accept that offer, he or she is given a form to sign.

Mavuso said by signing this form, they believe that a student commits that he will pay the amount required.

He said it was true that there was a directive from the court but as an institution they had taken that directive as a guide on proper steps to follow when applying fee hikes as an institution working with government.

Mavuso said the university followed that directive.

For example, since government said they must not hike fees this year, SANU adhered to that order.

He said in previous years, the institution hiked fees because the law allowed them to do that.

Mavuso said students who were self-sponsored tried by all means to raise the money in order to pay for tuition fees. He said those giving them challenges, were government sponsored students.

#### **Students**

He said students must know that when government promises to pay for their tuition fees, it does not mean that government will pay the exact amount required by the university.

Mavuso said they have always requested students to try and top up the remaining amount which is not covered by government.

He added that the issue of sponsorship lied solely with the students and that did not mean that if student failed to secure sponsorship they must come back to the institution and negotiate for a lesser amount.

Mavuso said every student was expected to pay the required amount. He distanced the institution from

He distanced the institution from allegations that it was selling old used books at exorbitant prices.

# Strike costs us millions in delayed transactions - ESRIC

TRANSACTIONS to Eswatini Royal Insurance Company (ESRIC) clients amounting to millions of Emalangeni have been delayed because of the ongoing strike by employees of ESRIC.

The employees protest entered day two yesterday.

The workers are demanding that their employer comply with recommendations contained in a salary review report.

The workers who were picketing at the entrance of the company premises were later taken by their employer to court in an attempt to get an order to have them picket away from company premises.

#### Workers

ESRIC took SUFIAW which is representing the workers to court after a disagreement on the designated area for picketing. ESRIC was represented by Hasso Magagula while SUFIAW was represented by Happy Mkhabela. The matter appeared before Acting Industrial Court Judge Bongi Magagula.

ESRIC was seeking an order which would force workers to picket away from the company's entrance where it alleged that customers were being

blocked. ESRIC also argued that the due to the close proximity to the entrance, picketing workers were threatening and intimidating workers who were not involved in the strike action.

However, workers argued that they did not threaten employers or clients and that they had a right to protest near the company premises, since the place was situated next to the road and it was dangerous for them to protest just next to the road.

The workers through their attorney argued there was also no designated area for picketing that was agreed on. ESRIC is the applicant in the matter while SUFIAW is the respondent, representing employees of ESRIC.

pied by non-civil servants including bus conductors and those working in the private sector.

In a memorandum released by the Ministry of Public Service Principal Secretary Sipho Tsabedze, there was a directive that all affected should verify if indeed they are civil servants.

The order was that if non-civil servants are found in any of the houses they should be evicted.

This move comes after a Parliament motion which recommended an audit of all government houses.

The ministry was also directed to create a database of all government institutional and pool houses on regional basis and make a list of the occupants.

The PS was assigned to embark on this exercise and submit the information to the ministry of public service for compilation of the data base and the report to be

submitted to Parliament on September 23.

The root cause of non-civil servants occupying government houses according to the ministry was that officers occupy houses above their salary grade which they fail to maintain thereby end up renting out quarters to substantiate their income.

The ministry in its report also submitted that some of these occupants inherit government quarters from their relatives who are legally allocated officers.

Government housing unit admitted that there was a difficulty identifying the correct total number of houses available per location.

Coupled with the lack of periodic house inspections of government quarters by the

housing unit this has led to an influx on non-civil servants occupying government houses.

Another cause for this problem according to the report is that h u m a n resource officers do not effect the vacation pro-

cedure, neither do they advise officers to hand over house keys to the housing unit upon vaca-

According to General Order A. 700 (1); all government officers shall be entitled to be considered for the provision of government housing as and when it becomes available, mean-

while General Order A702 states that an officer shall not let or sub-let, either in whole or in part government quarters which have been allocated to him.

#### Officers

According to the law all retiring officers must vacate government owned quarters by the last day of their service. Some of the investigations done in 2016/17 found that non-civil servants occupy government houses.

The ministry has since indicated that unpaid rentals would be recovered and calculations will be done and the ministry of public service will request for advice from the attorney general's office on how these funds could be recovered.

# Court interdicts members from acts of intimidation

ACTING Industrial Court Judge Bongi Magagula ruled that the employers and employees of ESRIC must meet so as to discuss and agree on the rules and logistics of the strike action, inclusive of the designated areas, where the picketing should take place,

Having heard the submissions made by counsel the court made a ruling that the Rule of Court in relation to the requirements of service of process and time-

Magagula informed the court that ESRIC suffered a major blow because of the strike action as millions of transactions which were meant to be made to clients were delayed. Magagula said on Tuesday Cash in transit personnel were blocked by picketing personnel.

However, the union's representative argued that her clients never at any time blocked Cash in Transit employees.

The union denied that there was a meeting which was called by ESRIC management before the strike action commenced on Tuesday. They claimed that the only form of communication they received was a message which

# Woman bites lover in self-defence, charged with SODV

THE Sexual Offences and Domestic Violence (SODV) Act does not condone all forms of domestic violence and a woman felt the full extent of its wrath.

Pretty Matsebula (29) of Mvutjini was arrested and charged for biting her lover Eugene Dlamini on his left arm. Matsebula was further charged with damaging various items valued at E4 600, which belong to Dlamini.

According to her charge sheet, Matsebula was said to have bitten Dlamini on his left upper arm, with the intent to cause grievous bodily harm. She was also said to have proceeded to damage Dlamini's Samsung television set valued at E3 000, Defy microwave valued at E1 400 and a bathroom mirror valued at E200.

Matsebula was said to have committed these offences on Monday evening at Mvutjini.

During her appearance before Magistrate Temantimandze Shongwe on Wednesday, Matsebula tried to explain that when she bit Dlamini, she was acting in self-defence.

"Firstly, Dlamini was saying hurtful things towards me and made me feel as though I was an idiot. He is the father of my child and has supported me from the beginning.

However, our disagreement this time got out of hand. When I bit him, he had me in a choke-hold, at the same time, attempting to take my phone away from me.

Our bone of contention is that he does not want to let go of my past, and he does everything in his power to make sure I never forget it," Matsebula stat-

Matsebula revealed that she also sustained injuries and had a wide abrasion of the side of her face.

#### Appeared

She appeared as though she had spent the night crying, as she had a tissue and would sniffle at times.

After hearing her mitigation, the court found Matsebula guilty as per her own plea.

Magistrate Shongwe then sentenced Matsebula to, in the first count, pay a fine of E1 500 and in default of payment, serve 14 months in prison. In the second count, Matsebula was sentenced to serve a further 14 months imprisonment, with the option to pay a fine of E1 500.

#### CORPSE FOUND FLOATING IN WATER CANAL

A corpse has been found floating in one of Ubombo Sugar water canals at Big Bend.

Shocked residents said they discovered the floating body and immediately raised an alarm.

It is said it did not take the police and emergency services long to attend to the scene, where they removed the body from the canal.

It is said it was discovered that the person was long dead. The residents were

shocked to realise that it was a known mentally disturbed man who lived in the area named Chawe 'Bazu' Mhlambi (49).

Mhlambi lived in Big Bend for quite some time and worked for Ubombo Sugar before he was mentally challenged.

#### Residents

The residents have been left with more questions than answers regarding the death of Mhlambi. Firstly he had not been reported as a missing person.

However, according to some of the forensics, Mhlambi has been dead for some days, hence his body was floating in the canal. Meanwhile, the internet states that the length of time that has to elapse before the body floats depends not only upon the

amount of fat contained in the tissues but on the temperature of the water. If the water is warm, the formation of gas within the body occurs rapidly and the body may rise to the surface in a day or two. However, if the water is cold, bacterial action takes place very slowly and it may take several weeks before the body appears on the surface.

When a body is fully distended it is almost impossible to sink even with counter weights. Chief Police Information and Communications Superintendent Phindile Vilakati confirmed that a mentally challenged person was found dead in a water canal in Big-Bend. She added that police were still investigating the cause of death.

#### Inquiry hears how 'blesser' Magashule used public funds

JOHANNESBURG - Former Free State premier Ace Magashule committed fraud and money laundering by distributing kickbacks from the asbestos eradication project using a service provider to do so, the state capture commission of inquiry heard yesterday.

Giving testimony on the second day, former Free State MEC for economic

development Mxolisi Dukwana told the inquiry that Magashule directed the late Ignatius 'Igo" Mpambani to make various payments to various individuals.

Dukwana alleged that Magashule instructed his then-personal assistant Moroadi Cholota and an official in his office, Ipeleng Morake to request payments from Mpambani through emails.

Mpambani was in a business venture with a businessman named Edwin Sodi and scored the R255 million contract to audit and assess pre-1994 housing units with asbestos roofs in the Free State. The project was never put on tender, said Dukwana, and the busi-

ness partners wrote a proposal to the Free State government to undertake the auditing of asbestos roofs to the tune of R255 million.

Two companies, Blackhead Consulting and Mpambani's company, Diamond Hill Trading netted R255 million paid in batches by the Free State government between 2014 and 2016, Dukwana said. Dukwana read emails retrieved from the Free State government detailing payment requests and proof of such payments sent.

The requests to Mpambani included one for over US\$24 000 for suspended South African Revenue Service (SARS) head of legal services Refiloe Mokoena's daughter who was studying overseas.

# One of 4 arrested local truck drivers released on bail

ONLY one of the four local drivers who were arrested has been freed on bail in South Africa.

Eswatini Transport Association Technical Director Vama Jele confirmed the latest developments.

Jele said the freed one had to pay bail fixed at E1 000.

He said the freed driver was the only member of Eswatini Transport Association. Jele said their wish was to get them all out, but were constrained by resources.

This is because the association had to acquire services of a lawyer for their member.

He said the association only relied on member subscriptions which were also quite low.

"They have been in custody for two weeks now," he said.

Adding, he pleaded with cross-border drivers and others interested in working in the neighbouring country to register with the association.

Jele said by being a member of the association, it helped mitigate unfore-



seeable problems in future.

"The union will also help to solve problems they have with their employers," he said.

He said employers could take advantage of those that were not the association's members, for instance, through underpaying them and when they voice out their concerns, the employers quickly call the police who arrest them for working in South Africa illegally.

Jele further stated that if South Africa continues to ignore the 1986 treaty, Emaswati working there would be subjected to violation and labour exploitation.

Jele said the 1986 treaty was not for

miners only but cuts across all labour sectors, hence there is need for it to be redefined and interpreted.

Furthermore, the director urged drivers to register with the association so that they could be known where they work.

He added that a lot of Emaswati working in South Africa did not declare with the relavant ministries and bodies their mission in the Republic.

Meanwhile, the ministry of labour tried to sort out the cross-border employment challenges but they encountered obstacles in terms of data as Emaswati did not come forward with the necessary information.

#### SWAGAA, education meet principals on girls programme

SWAZILAND Action Group Against Abuse (SWAGGA) has held a follow up meeting on their Girls Empowerment Programme (GEP) with school heads.

In partnership with the Ministry of Education, SWAGAA convened with principals at the George Hotel, to discuss the school based empowerment girls club programme.

# Principals fall ill ahead of PAC meeting

TWO school principals have reportedly fallen sick ahead of their appearance before the Public Accounts Committee (PAC).

The two school principals are said to be part of the four schools that are expected to appear before the PAC for audit queries that were raised by the auditor general in his 2018 report.

The four schools include Hillside High School in Manzini, Lobamba National High School, SAGM Primary School in Mbabane, and St John's Primary School.

The principals who fell sick,

according to a well-placed source, included a former Hillside principal and an incumbent Lobamba National High School principal.

"The audit implicates the former head teacher and we were informed that he suffered a stroke when he was supposed to appear before the PAC.

#### Suffered

However, that is not to say that he suffered the stroke due to being called by the PAC," said the source.

Concerning Lobamba National High School, it was stated that the principal had undergone an operation on the day he was supposed to appear before the PAC.

Regarding SAGM Primary School, the principal was reported to be out of the country and was taking care of her husband.

The husband was reported to have been admitted at an undisclosed hospital in South Africa.

The principal of St John's Primary School was reported to have been informed very late about the appearance before the PAC.

"The principal was said to have been given a short notice to appear before the PAC, yet he had already engaged himself to other commitments," the source said.

Last Friday, the PAC had summoned various government ministries to make a follow-up on some rulings it made during its sessions.

Among the ministries that appeared were the ministries of

foreign affairs and international cooperation; commerce, industry and trade; Tinkhundla administration and development; information, communication and technology (ICT), and public works and transport.

**Appeared** 

The reason why the PAC summoned the ministries was to be able to compile a report on progress made since the ministries appeared before it.

The issues tackled on that day included updates on a car taken by former ACC Boss Advocate Thanda Mngwengwe, updates on Heptagon Construction's payment to government, the issue of Eswatini envoys to South Africa, among other issues.

#### WE DON'T OWE GOVT – HEPTAGON

HEPTAGON Company does not owe government even a cent.

This transpired last Friday when the ministry of commerce, industry and trade appeared before the Public Accounts Committee (PAC). Ministry of Commerce, Industry and Trade Principal Secretary (PS) Siboniso Nkambule told the PAC that Heptagon was not willing to pay back the money.

Nkambule said Heptagon wrote to the commerce ministry, through its lawyer, informing the ministry that the company believed that it did not owe government anything. As a result, Nkambule said they saw it imperative that they report the matter to the office of the attorney general.

The PS also informed the PAC that his ministry also wrote to the ministry of public works and transport, informing them about two engineers that were stationed at the commerce ministry. Nkambule

said they informed the works ministry that they no longer needed the engineers because they were doing nothing at the commerce ministry.

The engineers were employed to work at the ministry of public works and transport but were eventually stationed in the commerce ministry. One of the engineers, Caleb Motsa, who appeared before the PAC in April this year, said they last worked on a project in 2016.

Since then, they have been paid without engaging on any serious project. Motsa was told by PAC Chairman Phila Buthelezi that such was not a good thing because it meant they were getting paid for nothing. The engineers were further blamed for letting money out of the ministry right in their presence, yet they had a gate-keeping role to play.

Heptagon Company is also said

to have taken properties worth E986 000, which belonged to the ministry of commerce, industry and trade.

The properties are said to have been used by Heptagon while executing some of the projects of the commerce ministry. The E986 000 is part of the over E79 742 609.28 that was lost by the commerce ministry to Heptagon Company. The properties were eventually taken by the company and are said to be in its possession now.

The properties included furnished temporary offices, telephone systems, name boards, kitchen unit, motor vehicles, and other properties. The properties, according to the contract between the ministry and Heptagon, were to be returned to the ministry when the work was finished.

PAC members recommended that the properties should be recov-

# SOME EMASWATISTILL LACK SAFE WATER

**DESPITE** progress, hundreds of thousands still lack safe water. sanitation and handwashing facilities in Eswatini.

Data suggests that achieving universal access to basic sanitation service by 2030 as suggested by the Sustainable Development Goal 6, would require doubling the current annual rate of progress.

More efficient use and management of water are critical to addressing the growing demand for water, threats to water security and the increasing frequency and severity of droughts and floods resulting from climate change.

Desert Research Institute (DRI) is having a three weeks training workshop at Esibayeni Lodge on Water, Sanitation and Hygiene (WASH) programme. Dr. Braimaah Apambire said this was a result of a partnership between DRI and World Vision.

They have 29 students, two of whom are from Eswatini and only three are from outside the continent in

DRI is a non-profit research campus of the Nevada System of Higher Education, the organisation that oversees all publicly supported higher education in the US state of Nevada.

"This post-graduate programme in international WASH has been running for four years divided into

cohorts. This is the fourth cohort and each cohort runs from January to December on four different courses. It is divided into face-to-face teaching, field and laboratory work which the participants completed.

The second phase of two courses will see World Vision Eswatini lead the fieldwork and the University of Eswatini (UNESWA) Department of Environmental Health and the Faculty of Agriculture," he said. Dr. Apambire said the DRI had also developed a partnership with UNESWA to study the effluence of Mbabane water treatment plant to the water system.

There will be another partnership with government through the National Disaster Management Agency (NDMA) being proactive to work jointly discussing a framework to use when disasters arise.

The objective of the programme to build capacity of water, sanitation and hygiene (WASH) professionals in developing countries to be able to implement programmes efficiently and effectively. It also aimed at conducting active research in these countries that will improve the quality of WASH programmes, information dissemination as well.

"The building capacity will also be in universities, hence the partnership with UNESWA.

The plan is to have four more cohorts then evaluation can take place. World Vision must evaluate staff progression, how they use skills and knowledge.

We are developing a server tool that will monitor how they used their knowledge in two to three years," Dr. Apambire said.

He said this would help evaluate if their work has improved in quality or if they have faced a situation where they had to implement their skills immediately.

There was also cross-coordination of information as other technological technical information from countries ahead of Eswatini can be applicable in the country.

Safe and affordable drinking water for all by 2030 require investments in adequate infrastructure, provide sanitation facilities, and encourage hygiene.

Protecting and restoring waterrelated ecosystems is essential.

According to a United Nations study, more countries were experiencing water stress, and increasing drought and desertification is already worsening these trends. By 2050, it is projected that at least one in four people will suffer recurring water shortages.







# Crime rate declines in Lubombo region

IF the number of cases appearing before the Siteki Magistrate's Court is anything to go by, crime is seemingly declining in the Lubombo region.

For approximately a week, there has been no fresh cases brought before the court, save for drink-driving ones.

The court covers a large part of the region.

Cases which normally appear before this court include those of the Sexual Offences and Domestic Violence (SODV) Act, robbery, house breaking and theft, pharmacy and assault, amongst others.

SODV and robbery cases are normally brought before Principal Magistrate Dumisani Magagula as they carry heavy sentences.

Other cases are brought before Acting Magistrates Lungile Shongwe and Cebsile Ngwenya, respectively.

Current records indicate that the court had no fresh cases for the past few days. This reflects a significant decline in criminal activity in the

region. The notable decline in crime apparently comes after the Royal Eswatini Police Service (REPS) made breakthroughs in a number of cases.

A number of suspects who were on the police most wanted list were rounded up over the past couple of months. Most of them are remanded at the Big-Bend correctional facility. Meanwhile, there are a number of on-going trials before the court. One of these which was before Principal Magistrate Magagula yesterday was that of Musa Maziya who faces a charge of house breaking with intent to steal and theft.

Maziya allegedly broke into a house at Mpolonjeni and stole items valued at E11 750.

The accused person elected to conduct his own defence when he was informed of his right to legal representation.

He further stated that he intends to plead not guilty to the charge. The crown filed for a postponement of the matter as it intends to call witnesses to prove commission of the offence.

The matter was ordered to return to court next week Tuesday for commencement of trial.



# Man fined E600 for insulting his grandmother

MTHOKOZISI Sifundza (37) of Lomahasha has been fined E600 after he was found guilty of insulting his grandmother by calling her a witch.

The accused person appeared before the Eswatini National Court where he faced a charge of crimen injuria

He wrongfully and unlawfully insulted the elderly woman by accusing her of witchcraft. This was during an argument which ensued between the two while they were at their homestead.

When the charge sheet was read to him, Sifunjdza pleaded not guilty. The complainant was then called in to present her evidence. She told the court that her grandson accused her of being responsible for his misfortunes.

The complainant said her grandson further accused her of causing him bad luck, something which saw him being unable to get employment. The elderly woman said Sifundza made all these accusations after she had attempted to caution him for misbehaviour.

"My grandson has become a drunkard, he comes home drunk almost every day," said the elderly woman. She said the man insulted her after she warned him against indulging in alcohol.

The accused person was reportedly drunk when he made the derogatory statements against his grandmother.

When given a chance to crossexamine the complainant, Sifundza admitted to have engaged in an argument with his grandmother.

He claimed to have forgotten what he said during the argument, saying he was too drunk. He then passed his apologies to the elderly woman and pledged to behave accordingly. The accused person further asked the court to be lenient when passing sentence, saying he was a first time offender. He was eventually found guilty by the court and sentenced to six months in a correctional facility with an option to pay F600 fine.

# Social workers at elderly grants pay-points

SOCIAL workers will now be visible in all elderly grants pay points going forward.

Deputy Prime Minister's Office Under Secretary Hlobsile Dlamini said this was a response to complaints from the nation that social welfare officers were not available to help them.

She said the officers in each area would listen to the complaints and help where possible then escalate if need be.

Dlamini said there were many different reasons why some elderly grant beneficiaries and proxies were turned back last week when the disbursement of the grants started.

"It is either they come not on the stipulated date or the person fetching the money isn't the proxy who was registered. However, those who have missed the said dates are given a grace period after the last day of the payments.

"This will run from today to September 5 and this is called special payment," she said.

Last Tuesday, there was confusion at Mbabane Post Office when elderly people some of them with disabilities were turned back for not appearing on the system.

Proxies were also turned back although they had registered when the registration window was opened. They were told that they didn't appear in the system, which caused commotion.

"It is sad to queue for some time and then told that you don't appear in the system, especially in this cold weather. I came with my grandmother and she signed that I will fetch her money from now onwards as she is sickly. Today I was told that I cannot be helped. Look around, out of 38 proxies, only five appear in the system and this shows that their verification process is inefficient," said Tengetiwe Simelane.

Minister of Sports, Culture and Youth Affairs who is also Mbabane

East MP Harries 'Madze' Bulunga was at the scene and he had intendend to help his constituents to make sure the process was smooth.

"I went there to make sure that everything is smooth sailing. Some of my constituents were turned back as they were omitted in the system and told that they didn't register. Even with the proxy issues some didn't appear in the system apparently," Bulunga said.

Meanwhile, Director of Social Welfare Moses Dlamini said his office was fixing the problems and apologised for any inconvenience

He said the problems that arose helped because the elderly showed up afterwards to verify that they were still alive.

Dlamini said it was very worrying that suddenly almost everyone was a proxy.

He said they were preparing for a period where the elderly would use finger access control at the pay points so they could be verified as right now it was easy to defraud government.

"There are so many proxies and something is wrong with this.

"The proxy option was made for elderly people who are bedridden. It is unbelievable that all of a sudden every old person in the country is bedridden. To me it appears that people don't take this process seriously. We also want to avoid situations where the money doesn't reach the designated person," Dlamini goid

# EBC to oversee Botswana elections

# MULTISECTORAL RESPONSE (MR) BY SAMKELO MAHLALELA Information Centre Manager The National HIV and AIDS Information and Training Centre

TWO weeks ago, the Parliament Prime Minister's Office Portfolio Committee toured the National Emergency Response Council on HIV/AIDS (NERCHA) headquarters to familiarise themselves with the organisation's business.

In her brief to the Portfolio Committee, the NERCHA Council Vice Chairperson, Ms Gcebile Ndlovu (standing in for Council Chairman, Nick Jackson) stated that the country had made significant strides in halting the spread of HIV and thus was in a strong position to meet His Majesty King Mswati III's HIV and AIDS related Vision 2022 target.

We know of course that the fight against HIV and AIDS is not over yet, and this cannot be over emphasised. In fact, the journey to end AIDS as a public health threat in the country has just begun in earnest. In 2017, Eswatini saw 3 500 people succumb to AIDS-related deaths and 7 000 people were newly infected with HIV.

The journey is not yet over for the 210 000 people living with HIV (PLHIV) nor the over 883 000 that are HIV negative. Great strides have been made in strengthening antiretroviral therapy (ART) services, and currently, the fight is to eliminate stigma and discrimination against PLHIV as well as convince the people that do not have HIV to adopt "appropriate" behavior to reduce their HIV risks.

In the midst of all these, NERCHA continues to strive to provide visionary leadership in the country's HIV response by rolling out programmes that advance the numerous global strategies and translates their ideals into local targets through the National Multisectoral HIV and AIDS Strategic Framework (NSF) 2018-2023, with all efforts taking guidance from His Majesty's Vision 2022.


In short, the vision of the NSF 2018-2023 is to End AIDS as a public health threat by 2022. Its goal is to super-fast track the HIV response to reduce new infections by 85 per cent and AIDS related mortality by 50 per cent from 2017 levels by 2022.

In working towards attaining the vision, NER-CHA is mindful of the obtaining challenges, including the steadily declining financial resources, especially from external sources – which necessitate that the country look inward for financial resources to sustain the many gains that have been made, this far, in the country's HIV response.

To deliver on the daunting task of ensuring that this key national goal is achieved and that the journey to end AIDS is meaningful, there is need for NERCHA to come up with a deliberate strategy to sustain political support and to disseminate strategic information. Advocacy

and communication at national, regional and community level as well as at international level is undertaken.

#### NERCHA at the 2019 Eswatini International Trade Fair

At regional level, advocacy aims to strengthen community systems and promote community involvement, while at national level, advocacy is meant to sustain government's commitment to the HIV response. International partners are targeted for financial and technical support and to showcase Eswatini's successes in the HIV response.

As part of a deliberate effort to reach-out to the masses with target-specific information that promotes the programmes of the NSF that are designed to address their specific concerns and needs.

Beginning tomorrow, 9th September, the National HIV and AIDS Information and Training Centre (Info Centre) a NERCHA department, will take part in the 51st Eswatini International Trade Fair (EITF). The Info Centre will be exhibiting and disseminating HIV and AIDS information.

The 2019 EITF theme is "Eswatini is open for business".

The EITF is a trade and business event in which the over 200 exhibitors from within and outside Eswatini, showcase their products and services to over 30 000 visitors.

#### 2019 ETTF theme "Eswatini open for business" sweet melody

Back in 2015, at a time when HIV and AIDS seemed to be slowly but systematically relegated to the bottom of the heap of the country's priorities, His Majesty King Mswati III's Vision 2022 brought it back to the pinnacle of public discourse.

His Majesty, in the 2015 Speech from the Throne, through a wide-ranging address, unprecedentedly and categorically said the first world Eswatini that every liSwati needs to work towards attaining by 2022, should be AIDS-free.

Without question, His Majesty's call was and remains on point. We cannot speak first world status while AIDS remains a public health threat.

With the current government fiscal challenges, it has become even more apparent that the country doubles its effort to End AIDS.

NERCHA is particularly thankful of the manner, in which over the years, the national multisectoral HIV response, including non-governmental organisations, the public sector, faithbased organisations, civil society, traditional organisations and development partners have galvanised effort to work towards the single goal of curbing the spread of HIV.

As the Eswatini Investment Promotion Authority (EIPA) puts final touches on logistics necessary for the smooth running of the 2019 EITF, the theme, "Eswatini Open For Business" challenges one to recall an era in the country's socioeconomic history, when the HIV epidemic was ravishing the country to the extent that academics and researchers alike, predicted.

Indeed, the many achievements in the HIV response have got us to a period when we can all testify that "Our health is Our Wealth". We have lived through and know that it is only when we are healthy and in a good space that we can be productive and generate wealth.

As a country, we acknowledge that health is a critical component of the country's balance sheet. Evidence shows that the country is on the trajectory to End AIDS as a public health threat. Indeed, Eswatini is "Open for Business!

Ending the AIDS epidemic requires a shared responsibility that demands increases in both domestic and international investment in the HIV response.

Investment needs for preventing

new infections from occurring through condom promotion, prevention of mother-to-child transmission (PMTCT), pre-exposure prophylaxis (PrEP), voluntary medical male circumcision (VMMC), a contribution towards outreach services for key populations and using treatment as prevention require an increase in the HIV response budget.

This and many more, needs to be brought to the fore, for all to appreciate and identify a role to play – individually and collectively; regionally and nationally.

#### HIV response at 2019 EITF

NERCHA is not a newcomer to the EITF, as it has been participating since 2007, when the Info Centre was established. The aim is to disseminate information on innovative programmes and strategies to assist the country accelerate towards Vision 2022, from which our regional partners could perhaps learn.

The current incidence rate of 1.5 per cent among those aged 15-49 is not sufficient to achieve epidemic control. Younger people bear higher new infections, some (15 per cent) of PLHIV are not tested nor enrolled in care, while more children and men are living with HIV are not virally suppressed. These are the issues that the Info Centre will bring to the EITF agenda.

The Info Centre stall will allow for engagement with the visiting public, including children. With His Majesty also directing that "Akubete lotfola i-HIV", various ways will be used to get ideas and advice on what can be done if we really are to end AIDS by 2022. The NERCHA facebook page will be used to promote EITF activities as well as to gather the thoughts and suggestions of those not able to make it to the EITF. Numerous short films will also be shown, including the popular MTV Shuga series.

#### Need for HIV to remain on the development agenda

NERCHA Executive Director Khanyakwezwe Mabuza (speaking at a recent briefing of the Senate HIV/AIDS Portfolio Committee) expressed the need to ensure that the HIV and AIDS agenda remains on the country's socio-economic agenda.

He emphasised that despite the many achievements in the recent past, the HIV epidemic could still rebound, then it would be déjà vu - doom and gloom all over again. Mabuza notes that without more domestic investment and international assistance, the country remains in a precarious position where the gains can be reversed

overnight.

# AGE IS NOTHING BUT ANUMBER: OR IS IT?

IT has often been said that it is not the numbers that age a person but do we really believe that as Emaswati?

The norm has always been for a man to marry a woman considerably younger than him. On close inspection, one finds that the main reason for this is the belief that women age faster than men do. A question arises therein, does love see age or are our marriages as a people void of love?

Countless women have been targeted, mocked and punished for "consorting" with men much younger than them. Reports have been published in years past of women being chased out of their homes by their own family members and sometimes even beaten for loving men younger than them.

When you raise the topic with others the general consensus is that it is deemed bad luck for a man to marry a woman much older than him. This phenomenon has caused women of an elderly age bracket who have either lost a spouse or never married in their younger years to remain unmarried and live out their lives as the family matriarch. Men, on the other hand, are free to remarry and actually expected to do so in the event of the passing of their spouse.

#### FINANCIAL GAIN

When people are confronted with a couple where the woman is older

than the man, the concept that love could be the binding factor is immediately thrown out the window and a number of speculations are born. Most believe that a union of this nature is for the benefit of the man as he stands to gain financially from the union and that the woman is desperate enough to provide to his every whim.

Some family members believe this to be true and will often dictate that the union be ended. The heart ache caused by this is never taken into consideration, just as long as they part ways for good. It is for this reason that most couples with such a unique age gap keep it to themselves, never fully expressing their love for one another in the manner they so desire.

#### MATURITY

Some will justify their actions by claiming that the man is not mature enough to be in a relationship with the older woman. Who are we to determine this? Is maturity always determined by age? Aside from the maturity debate, how do we give ourselves the right to pass judgment on the relationship of others?

#### LOBOLA

Even when the couple's family come around to accept this union, there are certain practices that hold a certain tone of prejudice against

the woman. When it comes to lobola negotiations, the young man's family will not fail to point out the unique age difference and negotiate for a lower dowry some. This directly translates as the woman being of lesser or insignificant value when compared to younger women who would be in the same position as she. The wedding thereof will often be kept low key, if there would be one at all. Instead of celebrating a beautiful union, this would be treated as a family secret with only a few privy of it.

#### CHILDREN

Many family members will argue still that a union of this nature will rob them of children, especially if the woman has lived passed her child bearing years. They will place high expectations on the man by saying that he will extend the family name through his kids, thus preventing a lasting union with the older woman as he would need to find a woman who would give him children.

#### ACCEPTANCE

If our acceptance of this union comes with conditions such as if and when the couple should marry, have we really accepted it? True acceptance is treating the couple as normal as we would a one with a more traditional age gap. Lobola should not be determined by the


woman's age and the responsibility for continuing the family name should not be put on the man's head, the choice to procreate should be theirs entirely.

#### LONGEVITY

If the argument is that it will not last, then that means that all other relationships with a reversed age gap last. Does the age determine the longevity of a relationship? If so, why is it ok for a man to marry a woman considerably younger than him? Are we really going to keep turning a blind eye to this double standard even in this day and age?

#### IN THE END

When it is all said and done, the age gap between a man a woman where the woman is older has no bearing on our lives. Ours is to accept our loved ones in their choices and support them at every turn. In the end, it is their lives and they will be the ones to live with that choice which puts them in a position to know what is good for them.

# Application of Part to deceased estates

62. (1) Any notice authorised or required to be given to a person under this Part is, in the case of a deceased person, sufficiently given, if given to the executor of the estate of that person.

(2) A reference in this Part to property of a person is, in the case of a person who is deceased, a reference to property that the person held immediately before death.

(3) An order may be applied for and made under this Part-

(a) in respect of property which forms part of a deceased estate; and

(b) on evidence adduced concerning the activities of a person who is deceased.

#### Effect of death of joint owner of preserved prop-

63. (1) The death of a person who has an interest in property as joint owner after a preservation of property order in respect of the interest is made shall not, while the order is in force, operate to vest the interest in the surviving joint owner or owners and the preservation of property order and continues to apply to the interest as if the person had not died.

(2) A forfeiture or preservation of property order made in respect of an interest referred to in subsection (1) applies as if the order took effect in relation to the interest immediately before the person died.

(3) Subsection (1) does not apply to an interest in property if a preservation of property order ceases to apply to that interest without a forfeiture order being made in respect of that interest.

#### Expediting applications

64. (1) In any application instituted under this Part by the State, the director of public prosecutions may file with the registrar of the High Court a certificate stating that the case is of general public importance.

(2) The registrar of the High Court shall immediately furnish a copy of the certificate to the chief jus-

(3) On receipt of the copy referred to in subsection (2), the chief justice shall immediately designate a judge of the High Court to hear and determine the application.

#### PART XI CRIMINAL ASSETS RECOVERY FUND

Establishment of Criminal Assets Recovery Fund 65. (1) There is hereby established a special fund to be known as the Criminal Assets Recovery Fund.

(2) The minister, after consultation with the minister responsible for finance, shall, by notice in the Gazette, designate a staff member or appoint a person to be the accounting officer of the Fund.

# DRMIKE OUTLINES IMPORTANCE OF SUGAR INDUSTRY


THE sugar industry in Eswatini plays a multi-functional role in supporting the Eswatini Strategic Roadmap (ESR).

Economist/Lobbyist Dr Mike Matsebula said this during the Federation of SADC Sugar Producers (FSSP) conference hosted by Eswatini Sugar Association (ESA) held at the Royal Swazi Spa Convention Centre yesterday.

He said the industry in the country had a high profile relative to the overall economy as revealed by its substantial contributions to agricultural employment and output manufacturing employment.

"It contributes significantly to social services in the form of education, health care, housing, water, sanitation and recreational facilities. It is directly linked to various sectors in the overall economy through both the input and output sides. Adding indirect linkages pushes up the multiplier and accelerator effects; thus raising the potential of the SI to be impactful," he said.

Examples of links through the input side are transportation, fertiliser, chemicals, labour and financial services and examples of links through

the output side are prepacking, beverages, sweets, various sugar-containing products and export sector.

Matsebula said it also conducted its activities in an environmentally friendly manner and has set aside a significant portion of land for the preservation of natural flora and fauna

The sugar industry had also con-

tributed positively to deeper economic integration within SACU.

In particular, it sells more than onehalf of its total tonnage into SACU and sources virtually all of its nonlabour inputs from South Africa.

"The ESR identifies five key growth sectors on the basis of their ability to deliver high impact on GDP growth, job creation and public revenue mobilisation.

The sugar industry fits in two of these sectors namely, agriculture (because of sugarcane growing) and agro-processing/manufacturing (because of the processing of sugarcane to produce sugar). It is directly through these two dimensions that the SI can play a positive role in the ESR implementation.



These two sectors are the direct conduits for defining the role of the industry.

Indirect conduits exist through the other key growth sectors because of linkages involving the sugar industry," he said.

He added that when fulfilling its role in the ESR, the industry would also be contributing to Eswatini's obligations to be achieved under Africa's Agenda 2063 and UN's Agenda 2030.

Agenda 2063 was adopted in January 2015.

"Through it, Africa is striving for accelerated and inclusive growth with equity; growth which will result in job creation, poverty eradication and sustainable socio-economic development.

It specifies targets.

Agenda 2030 is a post-2015 universal development agenda adopted in September 2015. It recognises that eradicating poverty in all its forms and dimensions is the greatest global challenge and an indispensable requirement for sustainable development. The plan of action specifies 17 SDGs," he added.

Given that the sugar industry lies mostly in the Lubombo region, there are synergies which can be generated.

Dr Mike Matsebula made this revelation during the sugar conference.

He said it is important to note that indeed, through its operations and nature reserves, the sugar industry is already a major player in the region from a sustainability perspective.

The starting point is to recognise the existence of important stakeholders; both within and outside the industry.

A programme towards harnessing the potential already alluded to must be compiled and discussed with all the key stakeholders. The guiding principle in this process must be the attainment of sustainable growth for the benefit of current and future generations. "In this connection, the compilation of a programme for the sugar industry to contribute positively to the ESR

implementation should be done under an appropriate theme. It could be along the lines 'sugar industry efforts towards a sustainable contribution to the ESR'. We turn to some of the main elements for consideration in this harnessing endeavour," he said. He added that examples would include ethanol for fuel blending; alcoholic beverages; electricity cogeneration to supply the national grid; bio-degradable plastics; and animal feeds.

"The need for product diversification is definitely not a new issue for the local sugar industry. Examples elsewhere in SADC abound. The question is why has it not taken off in a visible manner for the benefit of all industry members in Eswatini?

Are the financial and social returns foregone by not embarking on this journey insignificant? Should there be special incentives considered and, if so, what kind?

In theory, the incentives can range from moral suasion through policy prescription to legislation," Dr Matsebula closed.

#### DIVERSIFICATION OF SUGAR MARKETS

WITH the launch of the African Continental Free Trade Area, a new dimension has been added to the pursuit of remunerative markets by SADC sugar industries.

The collective SADC approach is worth retaining in discussions with

other regions in Africa.

It is of utmost importance that each SADC sugar industry keeps its government in the picture as negotiations ensue and to seek specific support where such is necessary to gain access into various African sugar markets. This

assertion is based on the multi-functional role of the SI which makes it strategic from a socio-economic perspective.

It requires a strong political will and different types of interventions for nurturing it.

#### Economic empowerment of Emaswati

THE economist said the support given by government (through bulk water projects) and by the EU (through partfinancing of development costs) has empowered a number of smallholder sugarcane growers.

This was a good move from a social return perspective.

The non-sugar small and medium enterprise (SME) sector in the Lubombo region needs to be systematically empowered. One option is to empower SMEs through a mentorship arrangement negotiated among the Eswatini Sugar Association, relevant members of the SI, potential SMEs and financiers.

The objective of the mentorship programme would be to reduce the risk of SME failure and there-

by enhance chances of creating sustainable financial as well as social returns in the sugar belt.

A second option is providing infrastructure to promote SI tourism through which the beauty of cane fields can be appreciated by local and foreign visitors.

The infrastructure would comprise facilities which are strategically located around the sugar belt to service tourists through refreshments, indigenous foods, handicrafts and restrooms. SMEs should pay affordable rentals to operate in these facilities.

The Sugar Museum at Tambankulu would be part of this SI tourism concept and the improvement in facilities used by informal sector operators (commonly referred to as community markets) is a third option.

#### FINANCING SI EFFORTS

Dr Mike Matsebula said to evaluate, plan and put in motion the SI support towards ESR implementation, requires money and skills.

A consultancy has to do all the groundwork pertaining to the required resources. The consultancy should ideally report to a team convened by the Eswatini Sugar Association to compile a programme towards the sourcing of the necessary funding.

Possible funding sources would include the local banking sector and impact investors. The latter are funds whose intention is to generate a measurable beneficial social impact alongside a financial return.

Impact investors provide capital on affordable terms to address social issues such as poverty, social inequalities and environmental degradation. Tapping these funds may take a long time.

# 'NEW FARM DWELLERS CONTROL BILL HINDERS GROWTH OF AGRI-BUSINESS'

AN economist says the new Farm Dwellers Control Amendment Bill of 2019 is unfavourable to farm owners and will negatively affect agricultural growth and the country's economy.

The fundamental issue is with regards to the constitutionality of The Farm Dwellers Control (Amendment) Bill as it seemed to infringe on the rights of a farm owner of being able to buy and sell property at will.

The bill was publicised on Friday, and the economist's take was that the bill limited the involvement of the private sector which has been earmarked as key to the country's economic recovery.

The main concern was with regards to a clause in the bill which stated that a farmer who intended to sell a farm shall give priority to farm dwellers, failing which the neighbouring chiefdoms or government must make an offer to purchase the farm.

"This essentially means that any



business to business transaction would then come fourth in line.

This from an economic perspective is worrying because this would lead to an undesirable situation where government was crowding out private sector investments, particularly in the very productive agricultural lands," said the economist.

It was also highlighted that the bill did not seem to articulate what would happen with the existing government farms.

This means now government farms

would not be bought by the private sector or individuals because they might be intending to lease them.

"There are also a number of issues from purely a business perspective as the bill limits the productivity of arable land being farms which was a concern on its own. There was also a bigger concern in terms of devaluing the price of the existing farms, particularly if it were bonded to a bank through a mortgage loan."

The gazette brought a lot of restrictions around who a land or farm owner was supposed to sell to.

"Banks would either be typically adverse in terms of funding or using any agricultural lands that may have farm dwellers as collateral simply because they might not be able to recoup their investments should the business be unsuccessful, he said.

It was also noted that there were a number of aspects raised by the bill that required serious consultation or redrafting of the bill as well taking into account some of these issues highlighted.

There was an absurdity around farm owners and government expecting them to contribute to a fund that would ultimately buy the farm.

"This is self-defeating and clearly the whole process just outlined that government did not actually have a clear plan in terms of how to finance the whole objective of securing security of tenure for general citizens.

"This impacts on the business side of things commercially when looking at potential productivity. The bill would decrease the amount of productivity since if there was any sale, most of the land would either be used for housing or would be under government ownership," the economist noted

#### Treasury to sell Eskom coal plants to raise R450 billion

JOHANNESBURG – The national Treasury has issued its first real indication of its plans to unbundle Eskom, saying that it would consider disposing of the debt-ridden power utility's coal-fired power stations in an effort that could potentially raise about R450 billion.

In an economic policy paper released for public comment yesterday, the Treasury said Eskom needed to restructure and modernise its business in light of international developments as well as its own poor technical and commercial performance.

It said alternative models such as the separation of generation assets - leaving the state-owned transmission company to buy electricity transparently from IPPs (Independent Power Producers) and state-owned power generators - were also being explored.

"The government could take a decision that Eskom should sell coal-fired power stations, possibly through a series



of auctions," the Treasury said.

"Through these auctions, Eskom would sell the power station itself, all its power station-specific obligations (staff contracts, coal-supply contracts, supplier contracts, environmental obligations, etc), together with a power purchase agreement (PPA) at a predefined, power station-specific tariff."

National Treasury said the PPA would see new power station owners to supply a specific amount of electricity annually "over the remaining lifetime of the power station to the Single Buyer Office at Eskom at a predefined tariff".

It said on average, half of Eskom's coal-powered fleet was over 37 years old. South Africa's economy depends on electricity produced by Eskom with its primarily coal-based generation plants, nuclear power station and some hydropower and a small percentage of renewables.

However, growth in Eskom's generation capacity has not kept pace, with ageing coal power plants still making up much of supply and the commissioning of new plants Medupi and Kusile still in progress. *IOL* 

#### 'MEDUPI STATION'S LAST UNIT SYNCHRONISED TO THE GRID'

JOHANNESBURG - State-owned electricity utility Eskom says its Medupi coal-fired power station in Limpopo has produced first power out of its last unit.

In a statement late on Tuesday, Eskom said Unit 1 attained 190MW earlier in the day, making it the last of Medupi's six units to be synchronised to the national grid. First synchronisation or first power is when the generator in the unit is electrically connected to the national power grid so that it is aligned with all other generators.

Unit 1 will start generating and delivering electricity intermittently into the grid over several months during a testing and optimisation phase to ensure the country has stable supply.

Eskom was forced to implement rotational powercuts earlier this year to avoid a total collapse of the grid as supply struggled to keep up with demand.

"The first synchronisation of Unit 1 also marks a key milestone towards the full commercial operation of the unit ahead of its scheduled commercial operation in November 2020," the compa-

ny said on Tuesday.

"The swiftness in delivering the unit has been due to the fact that lessons learned on previous units were implemented." The testing and optimisation of the unit will result in it being able to generate full power of 800MW, taking it a step closer to being commercially operational, which generally occurs within six to nine months after first synchronisation." Eskom takes pride in Team Medupi and its contractors having achieved this milestone. The team is commended for the dedication and commitment for working tirelessly to ensure the synchronisation of Unit 1," Eskom utility said.

#### BRITISH ENVOY TO ZAMBIA BLASTS GOVT OVER GRAFT IN LEAVING SPEECH

LUSAKA -Britain's outgoing ambassador to Zambia on Tuesday denounced 'rampant corruption' in the southern African nation and said donors were right to slash aid.

In an usually outspoken diplomatic address, Fergus Cochrane-Dyet said reports of fraud within the government had caused international donors and foreign companies to 'withhold aid and investment'.

"Corruption kills as surely as any gun, depriving Zambians of life-saving government resources, water-preserving forest, intentionally renowned wildlife and jobs that foreign companies would otherwise provide," Cochrane-Dyet said during a leaving speech at his residence in the capital

Zambians have grown increasingly disaffected with President Edgar Lungu's government, which has faced several graft scandals since he came to power in 2015. Evidence of embezzlement has included the alleged state purchase of 42 firetrucks said to cost \$1 million (900 000 euros) each.

Anti-graft activists also accuse ministers of using public money to fund lavish lifestyles, with some ministers owning up to 40 homes while most Zambians live in poverty.

The allegations caused Foreign Minister Harry Kalaba to resign in protest last year, citing "swelling" corruption in government ranks 'perpetrated by those who are expected to be the solution'. Cochrane-Dyet said he received threats of expulsion after publicly speaking out against corruption in 2018. Britain suspended aid to Zambia last year after a mounting row with the government

over the alleged misuse of social payments. The dispute led to the arrest of former social services minister Emerine Kabanshi, whose trial is set to begin next month. Cochrane-Dyet told reporters it was his responsibility to speak candidly, and he urged the government to declare Zambia's hunger situation an emergency in order to 'unlock international humanitarian assistance'. ### 16 CHILDREN DEVELOP WEREWOLF SYNDROME

... after taking contaminated medication on Spain's Costa del Sol

BARCELONA - Sixteen children have developed 'werewolf syndrome' after taking contaminated medicine in Spain.

The infants have hypertrichosis - hair growth throughout their bodies - after taking a formula tainted with minoxidil, an alopecia remedy.

The Spanish Agency for Medicines and Health Products ordered that several batches from Farma-Química Sur SL, a Malaga-based pharmaceuticals company, be taken out of circulation on July 11.

The babies were given tainted omeprazole, used to treat acid reflux and indigestion, as part of a formula.

Health sources told El Pais it was noted that when the children stopped taking the medicine their hair growth subsided.

Parents have been advised to seek medical help if their child has been given the formula and check with their pharmacy if they have purchased an affect-

The Spanish agency pulled a first batch off the market last month when 13 cases were reported.

Another three reports were made at the start of this month and another batch of Farma-Química Sur's medicine was pulled from pharmacy shelves.

Officials believe the contamination could have affected up to 30 Andalusian pharmacies and more than 50 batches of the drug. Farma-Química Sur has

had its licence suspended and cannot manufacture, import or distribute drugs.

The pharmaceuticals company has a supplier in India and it is reported by Granada Hoy, the contamination was made at source. Spanish authorities say that the issue is isolated to the formulas for children and that adults taking omeprazole capsules should not worry about developing 'werewolf syndrome.'

According to Global News, once children stop taking the contaminated medicine, they should see a reversal of any hypertrichosis symptoms.

Hypertrichosis is the term used for the growth of hair on any part of the body in excess of the amount usually present in persons of the same age, race, and sex.

It is a very rare condition which patients are either born with or develop later in

It excludes excessive hair caused by abnormally high levels of male hormones.

Throughout history those afflicted have been a source of great interest and they have performed in travelling circuses and freak shows.

Excessive hair may cause cosmetic embarrassment, resulting in a significant emotional burden.

Treatment options are limited, and the results of therapy not always satisfac-

No single method of hair removal is appropriate for all body locations or patients, and the one adopted will depend on the character, area, and amount of hair growth, as well as on the age of the patient, and their personal preference.

Treatment methods include cosmetic procedures, bleaching, trimming, shaving, plucking, waxing, chemical depilatories, electrosurgical epilation, and hair removal using light sources and lasers.

Laser-assisted hair removal is the most efficient method of long-term hair removal currently available.

#### Brazil will accept \$20m aid package

RIO - Brazil has said it will accept foreign aid to help fight fires in the Amazon, but only if it can determine how the money will be spent.

The move comes amid an increasingly bitter war of words involving French President Emmanuel Macron and Brazilian leader Jair Bolsonaro over the crisis.

Presidential spokesman Rego Barros said: "The Brazilian government, through its president, is open to receiving financial support from organizations and countries.

"This money, when it enters the country, will have the total governance of the Brazilian people.'

G7 leaders pledged the \$20 million after discussing the fires ravaging an area often dubbed 'the lungs of the world".

The offer, which was made at a summit in France, has stirred up emotions within Bolsonaro's nationalist government.

Some officials are grateful for the much-needed help, and others view it as a colonial gesture that undermines Brazil's control of its lands.

Bolsonaro has previously said he would only consider accepting a \$20million offer of aid from the G7 if French President Emmanuel Macron withdrew the 'insults' against

Bolsonaro and Macron have been embroiled in a war of words, with Bolsonaro mocking Macron's wife and accusing the French leader of disrespecting Brazil's sovereignty.

Macron has called Bolsonaro a liar and said Brazilian women are

'probably ashamed' of him.

Brazil's president is finding himself increasingly isolated on the global stage over his response to the blazes, which threaten what many view as a key bulwark against global climate change.

The far-right government's response could threaten Brazil's trade deals and powerful agribusiness sector, which is a crucial driver of its recession-plagued economy.

Flávio Dino, the governor of Maranhao state, told reporters: "We think that it's not the moment to turn down money.

'The anti-environment rhetoric could expose Brazil to international sanctions."

The governor's comments came after Bolsonaro pledged to agree on a package of legislative measures with the states by September 5 to help prevent the surge in forest fires happening again.

The number of blazes in Brazil has skyrocketed by 80 per cent this year so far, compared to the same period in 2018, according to data from space research agency INPE.

Widespread rain that could snuff the fires out are likely weeks away, according to weather data.

A local farmer, who declined to give his name, said he expected the fires to worsen next week when the forest is usually at its driest.

U.S. President Donald Trump tweeted his support for Bolsonaro, an ideological ally on the environment, China and trade.

rules committee acted swiftly on formulating laws around the procedure that needed to be followed.

Mohamed said the Constitution allowed for Mkhwebane's axing on the grounds of misconduct, incompetence or incapacity.

"However, despite this provision, the Constitution does not explicitly state the mechanism that should be employed to remove an individual from the office of the public protector," he said.

"Therefore, it is with this in mind that Parliament's rules committee has been tasked with drafting a set of rules that will dictate what procedure should be followed when removing the public protector, or the head of any other Chapter 9 institution from office," Mohamed

DA MP Glynnis Breytenbach, meanwhile, said that the letter to the speaker detailed the need to fasttrack the process.

The justice committee said that the rules would have to accommodate all Chapter 9 institutions to avoid pitfalls in the future.

The committee's chairperson, Bulelani Magwanishe, also expressed the urgency of the matter.

The committee has yet to indicate how many days it would set down to discuss and conclude the process in question.

#### 'Gauteng govt won't accept foreigners 'who enter illegally'

JOHANNESBURG -It's not xenophobic to block illegal immigrants, confiscate counterfeit goods or stop human trafficking and illegal weapons, Gauteng Premier David Makhura says.

David Makhura says the Gauteng government will accept foreigners who add value to the economy through their skills, but not those who enter illegally or commit crimes inside the country.

Makhura said it was not xenophobic to block illegal immigrants, confiscate counterfeit goods or stop human trafficking and illegal weapons entering the country.

Deporting undocumented and illegal immigrants was an international practice that had nothing to do with xenophobia.

According to Makhura, as a signatory to several conventions, including the 1951 UN Convention on the Status of Refugees and the 1969 OAU Convention Governing the aspects of Refugees, South Africa was a human rights-based democracy that took a progressive posture when it came to foreigners seeking asylum.

"Therefore, our policy as a province regarding the documentation and identification of foreign traders is guided by both the international conventions and the national policies of trading," he said. Citizen

#### Labour minister to crack whip after employers fail to meet equity targets

JOHANNESBURG - Labour minister Thulas Nxesi has vowed that his department will be "hard" on employers who do not meet their employment equi-

Nxesi sounded the warning after receiving the Commission for Employment Equity's 19th annual report, which showed that whites continued to be the dominant group in top management positions, despite being among the lowest economically active population group.

The report was presented by commission chair Tabea Kabinde on Tuesday

The commission submits an annual report to the labour minister on the state of employment equity in SA. Employers are obliged to annually submit their employment equity reports to the labour department on demographic profiles, gender representation and employment equity plans on how to address discrimination and inequity in the workplace.

The report stated that black people constituted 78.8 per cent of the economically active population, followed by coloured people (9.6 per cent), white people (9 per cent) and Indian people (2.6 per cent).

The economically active propulation includes people from 5 to 64 years of age who are ther employed or unemployed and seeking employment.

It is used as a benchmark to help employers in the analysis of their workforce to determine the degree of under-representation of the designated groups in the workforce.

The 19th report said white people held 66.5 per cent of top management positions by population group. It found that black people constituted 15.1per cent of the top management population in 2018, up from the 14.3 per cent the previous year. Coloured people constituted 5.3 per cent of top management while Indian people represented 9.7 per cent of managers. Foreign top management remained unchanged at 3.4 per cent.

Kabinde said men comprised 76.5 per cent of top management positions and women 23.5 per cent. The report revealed that the black population group comprised 63per cent of the skilled working population, followed by whites (18.5 per cent), coloureds (11.2 per cent) and Indians (5.4 per cent). Accepting the report, Nxesi said the objective of employment equity was to eliminate discrimination at work.

"We also expect that when some employers are slow to reform, that activism by the workers and their unions will help nudge the process of employment equity in the right direction," Nxesi said. News24

#### 'Eyewitness' claims Gavin Watson committed suicide

JOHANNESBURG - A man who says he witnessed Gavin Watson's car crash believes he committed sui-

Speaking to Power FM on Tuesday, a man identifying himself as Mphahlele described the scene that played out before him on Monday.

"It is very sketchy, this thing happened in front of me. I was taking one client to the airport around 05:00 and there was this Corolla in front of me but I thought it was one of the Ubers or the shuttle companies. He was driving at a high speed. I thought maybe that person was running late to catch a flight.

"That Corolla was taking the far right [lane used for rental and underground parking at OR Tambo International Airport]. Then suddenly, in a split second, it goes straight to the pillar, then it turns around. Some bumpers were flying up, and to me it was someone who wanted to commit suicide. I don't believe in some other [conspiracy] theories," he said.

Mphahlele claimed that apart from his vehicle, there were no vehicles in front or behind Watson's car.

He told the radio station he had not reported the matter to the police as he was in shock.

Watson died after the Toyota Corolla sedan he was driving collided with a concrete pillar on the road leading to the drop-off and parking sections of OR Tambo International Airport shortly after 05:00 on Monday.

Graphic photographs of the scene, showing Watson lying next to the car have placed the identity of the driver beyond doubt. Sources, who have firsthand knowledge of discussions in the family, have told News24 they believed he was murdered.

Papa Leshabane, a spokesperson for the family and Bosasa (now known as African Global Operations), would only confirm the family was not ruling out foul play. News24 has also confirmed with two major airlines that Watson was not booked on any flights out of Johannesburg. The process of checking with other airlines is ongoing.

Earlier on Tuesday, News24 reported that R70 was found in Watson's wallet. His ID and driver's licence were also found by law enforcement officials.

#### False accusation on Facebook leads to cop shop petrol bombed

MPUMALANGA -A 22-year-old man is in police custody for allegedly inciting public violence by spreading 'lies' that a policeman had killed a teenager in Emzinoni, Bethal, Mpumalanga.

Protesters later set the policeman's house alight. Police spokesperson Brigadier Leonard Hlathi said Ayanda Khubeka had appeared in the Bethal

Magistrate's Court on Monday facing charges of intimidation, crimen injuria and incitement to commit a crime. He was remanded pending his next appearance. Khubeka was arrested on August 22 after he allegedly circulated malicious allegations on Facebook indicating a police officer stationed at Emzinoni police station had shot and killed a 14year-old during a violent protest which

broke out in Emzinoni last week.

"Those false accusations went viral on social media, putting the officer's life in danger. The police are taking these allegations seriously and are calling on the public to refrain from intentionally tainting other people through social media by making false accusations as it is deemed an aggressive act.

# ZONDO WANTE WATSON TO FURNISH

JOHANNESBURG - The chairperson of the commission of inquiry into state capture, Deputy Chief Justice Raymond Zondo yesterday clarified that he had signed a directive that once served would have required the late African Global Operations CEO Gavin Watson to furnish an affidavit to the commis-

Zondo made the clarification ahead of the second day of testimony by former Free State economic development MEC Mxolisi Dukwana.

Zondo said following Watson's passing, the commission had received a number of media enquiries on whether or not it intended to call him to testify at the inquiry or had made efforts towards that end. "Yes indeed he was one of the people the commission intended to give the opportunity to give evidence and put his side of the story and be questioned," Zondo said.

However, he clarified that Watson had not been called and that a date for his appearance at the commission had not been arranged.

Zondo explained that at the time of Watson's passing, he had signed regulation 10 (6) which empowered him to issue a directive to a person that may have information relevant to the terms of reference of the commission.

In terms of the powers given to the chair under the regulation, the chair can direct a person to appear before the commission or to furnish an affidavit or statement in regard to certain matters, Zondo explained.

However, he said the regulation directive he had signed did not require him to appear before the commission as yet but rather to furnish an affidavit dealing with the various matters former African Global Operations COO Angelo Agrizzi had testified on.

Zondo added that the personnel of the commission had already been in touch with Watson's attorneys and attempts were being made for the directive to be served on Watson.

He said Watson's attorneys had indicated that the directive should be served to them but at the time of Watson's passing, it hadn't been, Zondo said.

#### VBS, Eskom cases among 1 800 currently before the NPA - Bheki Cele

JOHANNESBURG - Police minister Bheki Cele has revealed that 1,800 cases were investigated by the Hawks and sent to the national director of public prosecutions for decision.

Cele said these included "sophisticated" cases that involved municipalities, the corruption and fraud at the now defunct VBS Mutual Bank, and Eskom.

"We expect, in the not distant future, to have real serious results," he told the National Council of Provinces on Tuesday.

"Remember, they don't investigate who stole bread, they investigate cyber, commercial and highly sophisticated crimes," he added.

Cele attributed this to the security cluster aligning its work, saying police boss Khehla Sitole, Hawks head Godfrey Lebeya and national director of public prosecutions Shamila Batohi have been meeting regularly. This, according to Cele, was now producing results.

Cele was one of the peace and security cluster ministers who were answering MPs' oral questions in the NCOP. The questions ranged from allocation of police resources to maintaining law and order, to specialised crime units.

He clashed with DA MP George

Michalakis, who wanted to know if he would commit to delegating some of his powers to provincial governments who could assist in crime fighting.

Michalakis cited the example of a Cape Town township Bonteheuwel, where the City of Cape Town had deployed 100 metro police officers - a move which saw gang-related crimes in the area drop dramati-

Michalakis said this was evidence that when different spheres

worked together, it led to a reduction in crime.

'Why are you so hell-bent on denying the provinces an opportunity to fight crime when they are keen to do so?" he asked, adding the delegation of pow-

ers would not require any change of the constitution or law.

Cele wouldn't budge, insisting that policing was in essence a national competence and the needs and priorities of a province could be addressed on a continuous basis through an MEC.

"This one is a legal framework, it's not a decision or option of the minister. There is no minister that stands alone and changes the law. The laws are changed through parliament," he said.

#### Magashule 'protected' despite signs of mismanagement

JOHANNES-**BURG** - Former Free State economic development MEC Mxolisi Dukwana has described a system of patronage which 'compromised' structures in the province under the premiership of Ace Magashule.

Testifying for a second round at the state capture inquiry Tuesday, Dukwana said although there were signs of mismanagement, Magashule was protected.

"There were signs there for us. I think we did a disservice to the Free State people because being close to the man [Magashule] you could see the signs but instead we protected," he said. "When I was MEC




We know by now that Buzwe definitely has something to hide.

fer deadline looming, it appears they will get their wish.


They haven't brought in a midfielder this summer as a replacement, and selling Pogba now would mean they wouldn't be able to sign anyone until January to take his place.

It has been 17 months since the veteran Swede left Old Trafford for the city of stars and the confident, larger-than-life striker has proven a big hit in Major League Soccer. That injury in April 2017 brought an abrupt halt to a superb first season at Old Trafford, where his 28goal haul included efforts in United's EFL Cup and Community Shield triumphs.

Ibrahimovic would only make a further seven appearances before heading Stateside and the well-travelled striker continues to keep a close eye on a club, he knows he would shine for.

"I could play easy in the Premier League, so if United needs me, I'm here," he said with a grin in Los Angeles. "But Galaxy has me, so I'm sorry.

"Nah, I did my job in Europe. I enjoyed it, I have 33 trophies that I brought with me here and hopefully, I can get something here.

"And then we will see where that adventure finishes."

United could certainly have done with Ibrahimovic's cutting edge at the weekend as Ole Gunnar Solskjaer's side fell to a galling 2-1 home defeat to Crystal Palace.

"I look, I look, I look," the striker told PA. "I saw the last game and I think they were unlucky.

"If they score the penalty, it's a different game but a game in England is not finished until its finished.

"Anything can happen, especially in the last minutes where everything is in the heat of the moment."



#### EFA wants Allen matter returned to Players Status Committee

SOCCER - THE Eswatini Football Association (EFA) wants the matter involving Pigg's Peak Black Swallows, Mbabane Highlanders and suspended player Allen Mabuza to return to the Players Status Committee.

This comes after Black Swallows, through their lawyer Zakhele Dlamini, filed an urgent application at the High Court asking for reviewing of the decision to suspend the player.

Mabuza has been cited as the first applicant in the matter while Black Swallows are the second applicant. Chairperson of the Players Status Committee is the second respondent while Mbabane Highlanders are the first respondent.

#### Abuse

EFA, through their lawyer Sidumo Mdladla, yesterday submitted that the application placed before the court was an abuse of the court system. He said the cardinal rules of the fifth respondent which binds the applicants is that football matters were not to be taken to ordinary courts

He further submitted that the fifth respondent draws a line between 'ordinary court' and arbitration tribunal. He said this, therefore, means that the applicants are compelled to follow procedures of the fifth respondent which is affiliated to FIFA.

"FIFA also make it clear and unequivocal that matters which pertain to soccer are to be resolved through the processes which are established by FIFA. This, therefore, means that the applicants are members of the fifth respondent and cannot use the forums to settle its disputes.

#### Frowned

"The habit of teams in this jurisdiction of using courts to settle matters goes against FIFA statutes. The practise has become common and it is done at a drop of a hat. Our jurisdiction is now frowned upon by FIFA to the extent that the membership of the fiveth respondent is strained due to the recent trend of having 'ordinary courts' deal with football matters," read part of the submissions.

The lawyer averred that the cardinal rule in voluntary associations is that courts would not interfere in the grievance procedures of voluntary associations except in circumstances whereby voluntary association has breached its own constitution.

#### Approach

He said this approach was also adopted in the Eswatini jurisdiction by Justice Ben Dunn.

The matter is to be argued before High Court Judge Titus Mlangeni.

Meanwhile, it had been established that Mbabane Highlanders Football Club have confirmed their protest against Pigg's Peak Black Swallows for fielding Mabuza in the MTN league game last Wednesday night.

Meanwhile the Players' Status Committee cleared the player to Mbabane Highlanders last night, as the case was heared at Sigwaca House.
