WEATHER forecast issued by Accu Weather Services indicates that the week will be cloudy becoming warm and hot in the lowveld.



LUBOMBOREORETREMENT DIAMINADISPENS

THE Lubombo Regional Education Officer (REO) Musa Mthupha believed to be 60 but has not retired, his elder sister Sibongile is still in office as a teacher.

This comes a week after this publication broke a story on the REO, who according to his national identity documents seen by this publication, was born on 11 October 1959 which suggests that he is 60 years old and should have retired but he has not as, government records of employment indicates that he is five years younger and is expected to retire in

The REO on the other hand, admitted that the dates were incorrectly registered claiming the matter was being discussed in other forums.

Report According to the Public Service Act the retirement age of public officers is 60 which means the REO should have retired by October, or should have had his contract renewed before he can continue to serve in his office. The ministry of public service reported to be investigating the natter to ascertain his exact age and establish his retirement date.

Similarly, the ministry of education principal secretary Bertram Stewart said he was still investigating the mat-

Sibongile, on the other hand, admitted to be the REO's senior sister and that she would be retiring next year. She, however denied that she was above 60 as she believes she is 59, which raises a question as to now the REO, whom she is adamant is younger than her, should have retired in October.

Sources close to the matter also raised the questions on the sister Sibongile's age as she has not retired yet she is believed to be older than the REO.

Order

"Since you revealed the age of the REO and it indicates that he should have retired, what do you make of his elder sister who is older than him but she has not retired?

"If Musa should have retired in October, then Sibongile should have retired at least four years ago because she is about four years older than him according to the birth order," said the

According to government records of employment the, REO's elder sister, Sibongile Mthupha -Malinga who is a teacher at Manzini Central Primary School, will retire next year.

Ministry of Public Service Communications Officer Hlobsile Vilakati confirmed that Sibongile's employment documents indicated

She said she was not aware that the REO had reached retirement age except that she was older than him.

She said she was born on April 24, 1960 and was retiring in April next year. This she said that was the information recorded in her national identity documents, which indicated that she was 59. When told that her brother Musa had, in his national documents, provided information that he was born in 1959 which meant that she was younger than him, she insisted that she was senior as per the birth order. "I was born in 1960; I will be retiring next year. It is true that by birth order, I am older than him (Musa). The first born is Sipho followed by myself then Musa.

'Ulama mine lo. I do not know his exact age but he should be still working because he is younger than

that she had not reached her retire-

'According to information in our system, she has not reached retireme," she said.

She said it was new to her that her brother should have retired as she was convinced that she was older than him. Asked on what could have happened with regards to their dates of birth which suggested that the REO was older than her, Sibongile said they could have been misreported as they relied on relatives when registering their national documents because their parents were deceased by then. "This may be a result of the fact that we grew up separately as our parents died while we were young and we grabbed anyone who knew our parents when registering the national documents," she said. Ministry of Education and Training Principal Secretary Bertram Stewart said he was not aware of Sibongile's matter, addig that he was going to investigate it as well.

"Thank you for the information I will investigate the matter. I had instructed the human resources officer to check the REO's matter, we will be done by next week," he said.

SA man arrested, faces three attempted murder charges

A South African man's visit to Eswatini for the festive holidays was spoilt by him landing behind bars on three counts of attempted murder.

Wonder Sipho Nxumalo (38) of Nelspruit was arrested on Saturday morning and was slapped with a total of five counts; three for attempted murder, one for being found in possession of 47 live rounds of ammunition and the other for being found in possession of a pistol without a licence.

Arrest

Nxumalo is said to have been in the country visiting his relatives at Msinda area, near Mliba.

Leading to his arrest, sources alleged that Nxumalo was at Croydon

Bar in Dvokolwako in the company of a bevy of beauties and another Liswati man.

While at the bar at around 12:30am, Nxumalo is said to have engaged in an argument with one Saneliso 'Sgagu' Magagula (21) of Dvokolwako. It could not be ascertained what the bone of contention

As the two were engaged in the verbal altercation, Nxumalo is said to have been on the driver's seat of a white Lexus sedan while Magagula was standing on the other side of the vehicle.

Argument

In the middle of the argument, Magagula is said to have walked away, leaving Nxumalo and his friends. This seemed to have irked the South African man as eyewitnesses alleged that he got infuriated and aimed his pistol at Magagula through the car window and fired once. Just like in an action-packed movie, Magagula is said to have turned back to face towards the direction of Nxumalo at the same time that the shot was fired and he was hit in the stomach. The bullet, according to impeccable sources, is said to have hit Magagula and proceeded to hit another person who was standing behind him. The second victim of the South African's refined shooting technique is 31year-old Mndeni Dlamini of Dvokolwako, who was hit in his right hip.

As if that was not enough, the same bullet is said not to have found a home in Dlamini's body as it further proceeded to hit one Mancoba Sifundza (25) of Nsuka in his thigh, where it (bullet) remained.

The first victim, Magagula, is said to have sustained severe injuries in his stomach and he, along Sifundza and Dlamini, were rushed to Dvokolwako Health Centre.

Dlamini is said to have been treated and discharged while Magagula and Sifundza remained admitted at the health centre. After the incident, Nxumalo is said to have sped off, leaving the trio lying in cold blood. After the matter was reported to the Mliba police, the men in blue are said to have acted promptly and the South African was arrested at 6am on the same day. When apprehended, he is said to have been found in possession of the pistol with the 47 live rounds of ammunition without a valid licence, hence he was also charged for these offences. Communications Officer,

Superintendent Phindile Vilakati confirmed the incident. She said the two victims, Sifundza

and Magagula, were still fighting for their lives in hospital.

Nxumalo is expected to make his first court appearance today.

MAN (53) CRITICAL AFTER DRINKING SEX-ENHANCING IMBITA

A 53-year-old man is critically ill after drinking imbita in a bid to boost his sexual libido.

*Makhosi Masuku (not his real name to protect his wife and children) of Mantambe is said to have sought the assistance of a Jericho priest after experiencing a relatively low sex drive as he feared that he might lose his

wife due to his low sex drive. It has been reliably gathered that Masuku started showing some changes happening to her husband. in his behaviour after ingesting the concoction. This was noticed by his wife the same day he administered the concoction.

Masuku, who stays with his wife and two of his five children, had been seeing the priest often for spiritual

Sources close to the matter said at first, Masuku thought he was hungry as he started complaining about stom-

However, as time went by, the situation worsened, and this shocked his wife who was not sure what was

'His wife gave him some tablets to ease the pains, but that did not help. Instead, Masuku started vomiting and his bladder became swollen such that he could no longer urinate," added the source.

Family members were called to attend to the situation and that is when Masuku confessed to have taken the concoction from the Jericho priest.

One family member pointed out that Masuku had made it his habit to seek help from the priest when it came to spiritual beliefs.

The family member wondered how

Masuku fell ill after ingesting the priest's medication as it was not the first time he did that.

"This has shocked us as family, more especially because he did not want to tell us what happened at first." said the family member.

He was then rushed to Hlatikulu Government Hospital where he was admitted.

The priest, Thokozani Gama, when sought for comment, was reluctant to answer to this reporter's questions, but could only say he never gave Masuku anything which could have caused complications.

The Jericho priest saidnot even a single client of his had ever complained of complication after administering his herbs.

"I have been helping people for 17 years now and there is no one who ever came to complain about my healing powers," he said.

He mentioned that there was no way he could use something harmful in

his tiwasho. He wondered why he could use the word of God when helping people if he would end up using something that would pose a health hazard to

40 000 DUBAIS VS 11 000 LOCAL IMPORTS IN TWO YEARS

...SRA concerned as this affects SACU receipts

ESWATINI Revenue Authority (SRA) has raised concerns on the increase of importation of high value items from outside of SACU due to its negative impact on the SACU pool.

As though each civil servant has imported a car in the past two years, the country has imported enough (Dubais) close to 40 000, a number which is almost equal to the number of civil servants.

Data from SRA indicates that in the past two years a total of 38 977 Dubais were imported into the country.

On the contrary, only 10 525 vehicles assembled in Africa or the SADC were imported in the same period.

Out of the nearly 40 000 government collected E8.5 million as Import Levy for grey cars.

Goods

SRA warns that the continued increase of imports from non-SACU countries will continue to negatively affect the customs union revenue share.

SACU member states agreed that in determining their respective shares of the total customs, and additional duties collected in the Common Customs Area in any financial year, the share accruing to each member state should be calculated from three distinct components; customs component excise and development component.

The SACU revenue that flows to Eswatini is derived mostly from the customs component and it is a function of the country's percentage share of total intra-SACU imports. On average total intra-SACU imports grew by three per cent in the financial year 2017/2018 compared to 2016/2017.

Impact

While the country's intra-SACU imports grew by 3.5 per cent in this financial year which is above average, some member states recorded a growth of 20 per cent for the same period.

SRA Director Communications Vusi Dlamini when asked on the influx of import vehicles popularly called Dubais or grey cars notes that importation of any goods from outside SACU has a negative impact on the SACU pool.

"This is not only vehicles but any high value item. We have seen in recent years, where we import fuel from non-SACU countries that it also has a serious negative impact on our SACU pool. It is a policy matter, but the reality of the matter is that if we continue to import most goods from non-SACU countries, then our SACU share will unfortunately not improve as we have seen recently," he said.

Limit

Ministry of finance on the other hand, in the 2020/2021 Call Budget Circular notes that the SACU receipts may continue on a downward trajectory and government's fiscal challenges are expected to continue to weigh down on public sector performance.

"Downside risks remain elevated stemming from the further tightening in the budget financing due to the accumulation of domestic arrears, deteriorating bank asset quality and low Southern Africa Customs Union (SACU) revenue. As such, the fiscal space for the coming fiscal year and the medium term is quite limited, influenced mainly by the volatile SACU receipts, limited revenue sources and the various expenditure commitments taken during the previous budget years. As such collection of non-SACU revenues cannot grow as much to meet the gap," reads the Circular.

Why SRA charges more than 15 per cent VAT on some imports

by Emaswati who import the second hand vehicles on the Value Added Tax (VAT) charged by SRA, SRA has clarified why they tax more than the 15 per cent of the purchase price.

SRA Director Commuications Vusi Dlamini said this was done within the ambit of legislation which is the Customs and Excise Act and the VAT Act.

"The legislation gives us a clear direction on the valuation methods for goods imported into the country. We talk about customs value, which is not necessarily the price and people should not confuse the two. Someone may sell you an item worth E100 000 for E50 000, but the actual value of the item is E100 000.

We have seen a lot of under declaration especially for good imported into the country. And for imports VAT is calculated on the dustoms value plus duties and all this is provided for in Legislation and we don't depart from that," he said.

Former Mr. Eswatini arrested

FORMER Mr. Eswatini Mphumuti Nkambule (36) was arrested and charged for house-breaking with intent to steal and theft.

Nkambule was arrested along with two females Winile Setsabile Matsenjwa (31) of kaNkonjwa and Zandile Ncala (31) of Timbutini area.

The trio appeared before Magistrate Lucia Lukhele at the Matsapha Circuit Court last Friday.

Information contained by court records was to the effect that Nkambule and his co-accused broke into an MTN Service Centre situated at the Big Tree

in Matsapha, and stole the E36 3 3 8 c a s h that was in the

lawful pos-

session of one Sebenele Nkambule.

The incident happened at around 8pm on December 10.

Although details on the matter are scanty, it is alleged that one of the women Winile Matsenjwa who is employed at the service centre as a cleaner was the mastermind behind the theft as she was well aware of all the operations, and how they would get inside the centre.

Bail

On the other hand, Zandile Ncala is said to be an ex-employee of the same service centre. Sources claimed that Matsenjwa duplicated keys to open the centre.

During their court appearance last Friday, the three were each admitted to E6 000 bail.

Nkambule is not new to controversy as back in 2008 during his reign as Mr. Eswatini, he was stripped off his title for alleged misconduct after he got arrested for stealing some music equipment. He was duly replaced by his First Prince Okwakhe Dlamini.

Again on October 19, 2010, Nkambule was arrested and charged with two offences together with a Ghanaian friend. They are said to have stolen an unregistered navy blue Mercedes Benz at Alqaim Motor in Manzini.

They are also said to have entered and broken into the same premises and stole keys for different vehicles namely the Mercedes Benz worth E3 000, Red Opel Vita key worth E2 000 Silver grey Opel Vita key worth E2 000 and also various CDs worth E350 before stealing the Mercedes Benz.

Then, he was admitted to E50 000 bail by the Manzini Magistrate's Court, wherein he was ordered to

pay E5 000 cash and provide surety worth E45 000. However,

the former beauty king failed to pay the E5 0 0 0 0 a n d sub-

sequently filed a review application at the High Court where he sought an order allowing him to pay E1 000 cash and provide surety worth E49 000, but his application was dismissed.

His criminal record also reflects that this is not the first time the former king has been arrested for theft as he was previously arrested for theft of items belonging to one Winile Dlamini worth E30 900 which he later sold to DJ Karly B (real name Khulekani Mamba).

Also in 2010, Nkambule was arrested and charged with nine counts emanating from robberies that were staged at SEDCO building. Then, he was arrested along a 17-year-old from Zakhele.

It is said that in one of the many incidents, the two also assaulted one of their victims and further stole cellphones. In all the robberies that they staged, Nkambule and the teenager are said to have used a toy gun to induce submission on their victims.

DPM rescues Mkhulu Mathobela

DEPUTY Prime Minister Themba Masuku has pledged to build a house for Maphishi Mathobela of New Heaven who lives in abject poverty and only has a hovel which he subdivided to sleep and cook.

The DPM was accompanied by his wife Dimpo, son Sabelo Masuku, who is also the Chairman of the Human Rights Commission, amongst other members of his family.

Masuku said he was touched by the plight of the old man who lives in a structure that is not fit for human occupation.

He said upon reading the article published by our sister publication, Sunday Observer, Masuku abandoned all his plans for the day and decided to visit the old man so that he could get first-hand information.

In an interview after witnessing the depressing situation under which the old man lives, Masuku committed that his family would build a two-room for the old man so that he could have a descent roof over his head

like all normal human beings.

"On arrival here, I realised that this is not a good place for human occupation.

"I am touched and I must say that we will soon be coming back to start the construction of the house.

"We will put together resources as the Masuku family and get a builder who will assist us with the skills so that we come up with a proper structure "We noticed that he also has a piece of land which is uncultivated, so we will also get a tractor to plough the field and also give him maize seeds and fertiliser so that he can also plough like everyone else," he said.

Masuku also urged the public to also come forward with any form of assistance for the old man.

He said the food stuffs they brought him would not last for long hence there was a need of constant food supply before harvesting of the yield they had pledged to plant for him.

Ascertain

On another note, Masuku said he was expecting that social workers from his office would visit the old man to ascertain more of his needs, just like they did when they get similar reports.

"But I must say that the pledge we are making is not from government but us as a Masuku family and of course, with the help from anyone else who will contribute.

"I must also remind the nation that people must also take initiatives to assist those in need around them. "We must look out for one another and not wait for government's intervention at all times," he said.

Khanyisile Gwebu, who is a neighbour and health motivator of the area, said they were grateful to Masuku for the pledge, stating that as people living closer to Mathobela they were also at pains seeing him living under this situation.

"If we had enough we would have long assisted him but due to lack of funds on our part, we could only assist with food stuffs whenever we had some.

"We thank God that Mathobela is still alive under the circumstances. During heavy storms and rainy days he has always survived.

"Even when proper structures are brought down by the storm, his will always be spared," she added.

The deputy prime minister's office is the one responsible for social welfare of elderly people and those living with disabilities.

The DPM also assured that he ensure Mathobela receive the social grant and he confirmed he was one of the beneficiaries of the now reviewed grants.

According to well-placed sources, Malinga has been involved in the illegal trade of dagga for quite some time and was once warned by some church elders to quit his habit but he denied being involved in the dagga trade.

It is said that the church has even faced division amongst its members with some of the view the pastor is not fit to lead the church.

One of the elders who also commented on conditions of anonymity said they have even tried talking to their leader on three different occa-

When contacted by this reporter Malinga rubbished all these allegations claiming there were forces within the church that wanted to see him out of as a leader by subsequently stepping down from his position.

He stated that he was not arrested for such a crime because all evidence never pointed at him as it transpired that the dagga belonged to two men he had given a lift while on his way to a night vigil.

The under fire pastor said the allegations were fabricated to taint his name so that it could appear as if he was no longer fit to lead the church. He said he would stand his ground as he believes that these tribulations awould pass.


Information from well-placed sources was to the effect that these were introduced as acting magistrates on December 24, but assumed their positions on December

She said when she came with the said items, she told Mhlanga that she should come fetch the items and

When Mhlanga came to fetch her items, she did not have the cash and that worried Masina as that was against their arrangement.

Payment

"I asked about the payment and she told me that she did not have hard cash at that time but promised to e-Wallet me the following day of which I obliged," she said.

She stated that on the following day no payment was made and she remained patient as she did not think Mhlanga would rob her because of the healthy relationship they had enjoyed.

"She continued to make empty promises for the whole month and I became worried as I needed the money to re-stock," Masina explained.

She then called her on December 15 to find out what was wrong and she was told that there were some problems in transferring the money. Then later on December 17 she received an incontact notification.

When she went to the nearest ATM

found that there was no money that was transferred to her mobile num-

What worried her the most was that there was even a pin number.

Upon arrival, Principal Magistrate Fikile Nhlabatsi greeted Hlophe and asked him how he was feeling as he had suffered injuries after due to the shootout.

Response

In response, Hlophe stated that although he was well, he was in extreme pain.

"I am feeling extreme pain in my lower waist area after I was shot by police officers yesterday. One of the bullets fired by police officers entered through my back and exited out my hip," Hlophe responded.

Hlophe was remanded back into custody until January 30, 2019 pending his recovery.

Bleak festive for Siteki, surrounding areas as taps run dry

IT has been a bleak festive season for Siteki and surrounding communities after the Eswatini Water Services Corporation (EWSC) taps ran dry since Boxing Day.

Communities affected by the water crisis include Siteki, Mzilikazi, Mhlumeni, Malindza, Sikhuphe, Mpaka, Mpolonjeni and KaLanga. They have been without water for the past four days. Through a statement, the supplying company notified consumers about the interruption of water supply. The EWSC public affairs and customer service department stated that the interruption had been planned to allow maintenance processes to take place.

"Eswatini Water Services Corporation would like to notify its valued customers in Siteki and surrounding areas that there is an interruption in water supply due to technical problems at the Mbuluzi River intake works at Simunye Water Treatment Plant," reads part of the statement that was also published on the company's official social media page. Following the interruption, the company provided temporal water tanks in strategic areas to service its customers. The water tanks were placed at Siteki Old bus rank, Mzilikazi Stores, Mpolonjeni Inkhundla and Lonhlupheko.

The interruption in water supply was said to have caused serious inconveniences to customers, especially because it came at the time of the festive season.

Some of the customers vented their frustration to this publication, blaming the supplying company for choosing this time of the year to undertake its maintenance works.

Frustrating

"Can you imagine a festive season without water, it is very frustrating," said one of the customers who only identified himself as Maziya from KaLanga. The water interruption is also said to have affected businesses which uses water as an essential ingredient in their productions.

Eateries operating within the town centre were reportedly fetching water from Mabhodweni Dam, which is situated near JS Clothing textile factory.

This dam commonly used by public transport operators for washing their vehicles. However, through the statement, EWSC promised to have the problem



Man found floating at Lubovane Dam was murdered - reports

IN a turn of events, the man, who was thought to have drowned at Lubovane Dam after his body was found floating recently, was actually murdered.

On December 20, Madlenya community discovered a body of man floating at Lubovane Dam in Madlenya. Police were called to the scene to retrieve the body. A Ndwandwe family from Mganyaneni discovered that it was one of their own. In fact, the man was mentally challenged.

According to investigations conducted following the discovery of the body, the man was murdered before he was dumped into the dam.

A family member said their relative was murdered days before he was discovered.

The family member added that the mentally challenged relative had been reported missing for days before he was found dead.

The deceased was laid to rest last Tuesday because of the state his body was in.

The discovery of the body and the realisation that he was murdered has sent shocking waves among community members who are now living in fear.

One of the residents who attended the funeral narrated that this was not the first time an incident slightly similar to this one around the area occurred. It is suspected that there are people who were killig community members and then dump them into the dam so that it may look as if they drowned.

Recently, it has been reported that Siphofaneni police have already rounded up some people for questioning who are suspected to be connected to the death of the man.

Meanwhile, Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that a body of a man was found floating at Lubovane Dam. She further stated that police were still investigating the incident.

IT was indeed a busy weekend as the number of motorists nabbed for driving while under the influence of alcohol drastically escalated after Christmas.

This past weekend, the Royal Eswatini Police Service (REPS) recorded a whopping 145 cases of drink-driving. This was disclosed by Chief Police Information and Communications Officer Superintendent Phindile Vilakati vesterday.

The numbers of drunken motorists have drastically increased from last week's 138.

This is the highest number to be recorded by the service in a long time.

Throughout the year December had the highest number of motorists who Contravened Section 91 (1) as reads with section 122 of the Road Traffic Act of 2007.

According to the Act, the legal limit is 0.38mg/l for driver and every motorist found with more than the stipulated legal content will be charged for contravening the Act.


On December 1, 2019, 91 motorists were arrested for driving while under the influence of alcohol.

The following weekend saw 117 motorists arrested while 99 were arrested the third this past weekend.

During the last month of the year REPS arrested 452 motorists for driving their vehicles while under the influence.

Vilakati said all the motorists had appeared before the magistrates' courts in the country and accordingly found guilty and sentenced.

Apologies galore from drunk drivers

DURING their appearance before Principal Magistrate Fikile Nhlabatsi yesterday, five drink-drivers apologised profusely for driving while under the influence of alcohol.

With the highest recorded alcohol content of 1. 27 mg/l, 27year-old Raymond Dlamini of St Mark's told the court that he was a breadwinner at his home.

This occurred on Saturday evening near Kia Traffic Lights, where he was driving his Chevrolet SUV.

When a breathalyser test was conducted on him, Veco had a blood alcohol content reading of 0.41 mg/l. Upon hearing his 'sincere' apologies, the court sentenced him to pay a fine of E1 000, and in default of payment serve 10 months in prison.

For driving through a red light, Veco was sentenced to serve six months in prison with the option to pay a fine of E800.

E2 000 fine for failing to follow cops' orders

AS the numbers of drink-drivers continue to dwindle in Mbabane, the law continues to play its part by arresting those outliers found breaking the traffic rules.

Twenthy-five-year-old Siphamandla Mabuza of Mvutshini faced the wrath of the law after he failed to stop his vehicle when ordered to do so by police officers. This occurred on Saturday evening near Lobamba and along Kalafaro public road Mabuza was said to have been driving while under the influence of alcohol. When Mabuza approached the roadblock set up along Kalafaro public road, Constable Manqoba Ginindza was said to have used a hand signal to stop Mabuza's vehicle. However, because he knew he was driving while under the influence of alcohol, Mabuza sped off. That was when police officers were said to have pursued him until St Mary's junction, where he was eventually arrested. When a breathalyser test was administered on him, Mabuza exceeded the legal alcohol limit of 0.38 mg/l, and recorded 0.76 mg/l. In his mitigation before the court, Mabuza pleaded guilty on both counts and apologised profusely for having broken the law. He was sentenced to serve 17 months in prison, with the option to pay a fine of E1 700 for driving while under the influence of alcohol. For failing to follow police instructions, Mabuza was fined E2 000 and in default of payment, serve one year in prison.

Murder suspect who fled from Joburg High Court re-arrested

JOHANNESBURG - A suspect, who escaped from the Gauteng High Court in Johannesburg, was among more than 800 people arrested in a police crackdown over the weekend in Gauteng.

Police confirmed yesterday that Africa Nkuna, who escaped on December 9, was rearrested. During the chaotic scenes at the court on the day, three other suspected were rearrested, while another was shot dead.

Nkuna, who was in court for a murder charge, managed to exit the court and was on the run before being rearrested by Kagiso police on Saturday. Police spokesperson Captain Mavela Masondo said police and detectives from the Kagiso Crime Prevention Unit intercepted a Nissan Mpendulo minibus that Nkuna and his friend were making use of.

He said Nkuna now also faces charges of escaping from lawful custody and attempted murder. Masondo noted that Gauteng's Safer Festive Season Operations saw more than 850 suspects being arrested for various crimes.

He said 199 suspects were arrested in Johannesburg as police were conducting roadblocks as well as stop and

"Drunk driving topped the list as 39 offenders who have been found driving motor vehicles while under the influence of alcohol were detained." Meanwhile, police in Ekurhuleni also worked jointly with other law enforcement officers and arrested more than 360 suspects. These were for crime ranging from house robbery, rape, assault, malicious damage to property, possession of drugs, car hijacking, reckless and negligent driving and attempted murder.

In Tshwane, unlicensed liquor stores were raided, resulting in 10 of the outlets being shut down for non-compliance. Large volumes of liquor were also confiscated during the operation.

This is a saying to best describe one woman's crime after her desperate efforts to steal from a Greek tourist were thwarted when she was arrested for theft.

According to the charge sheet, she was said to have, on December 25, 2019 at Royal Swazi Spa in Ezulwini, intentionally stolen items valued at E10 500, in the lawful possession of Dionysius Nagnostatos of Greece.

Items

Some of the items said to have been stolen by Dlamini included an iPhone valued at E10 000, ear phones valued at E500 and £15 (E275.209).

During her appearance before Principal Magistrate Fikile Nhlabatsi yesterday, the court did not waste time as she was put to trial after entering a plea of guilt.

Without even mitigating for a lighter sentence, the court sentenced Dlamini to serve two years in a correctional facility with an option to pay a fine of E2 000.



No dentists at King Sobhuza II Clinic

The King Sobhuza II Clinic has not been able to provide dental assistance to its patients forcing most of them to seek medical attention at other health institutions, it has been gathered.

When the Minister of Health Lizzy Nkosi was contacted she was also appalled and asked to report back after having done her own investigations on the matter.

He said he had hopes that their mindset had changed from what they had heard from Thindwa.





2020 HERE WE COME

AS we close the year tomorrow, it is important that we reflect not only on 2019, but the entire decade, so that we can appreciate the challenge that awaits us in 2020 going forward.

Our frustrations in the out going year were not made in 2019, but were as a result of poor decisions, failure to implement the grand plan we crafted in 1997 and endorsed as the National Development Strategy (NDS Vision 2022), which we should be seeing its coming to fruition in 2022.

Whilst we have made some progress in some areas like the sustainable development goals (SDGs), we have clearly made regressed in many areas that would have otherwise made life enjoyable for our people.

In fact, we have failed to deliver decent jobs and despite having compulsory free primary education since 2010, we have not made the progress we wanted. Tertiary education has been compromised by lack of resources in both the funding for our institutions and still struggling to fund all students who qualify to enrol at our institutions.

Education and health are key to any nation's development agenda and our struggle in those two sectors continues to compromise our quality of life.

The past decade we witnessed the collapse of key institutions which would have otherwise given us a fighting chance to attain the Vision 2022. The executive arm of government failed to align with the NDS by not controlling its expenditure which reached unsustainable levels.

Even the projects that were established to kickstart economic activity continued to struggle despite investing billions of emalangeni into it.

Our checks and balances systems, be it the legislature or the judiciary, were malfunctioning in the decade we are about to close tomorrow.

Emaswati, during Sibaya, expressed their displeasure at the performance of our government and demanded changes. Voters elected to do the talking through the ballot box but the judiciary which has been accused of failing the country in terms of dealing with corruption remained complacent.

Impeached

This is despite that a chief justice and a judge were impeached and removed from their positions for impropriety.

The above incidents contribute in worsening our capability to attract foreign direct investors and those that are already on the ground become coy in expanding.


The mandate of the current government is to create confidence, not only to foreign investors but also to Emaswati that the 2022 Vision could still be salvaged.

Salvaging Vision 2022 will not just be an event, but it is a process and commitment overtime to ideals of good governance that will weed the country of corruption and prudence in expenditure.

We need to develop plans to ensure that projects like ICCFISH, King Mswati III International Airport, Mavuso Trade and Exhibition Centre start to fulfill their mandate. Some of these projects have been described as white elephants and it is time we invited Emaswati to come up with ideas on how they could make these projects work for the country.

A commission of enquiry, alongside a forensic audit need to be conducted on the Gege-Sicunusa-Nhlangano road project. It cannot be

that the country can waste over half a billion emalangeni on a project which is not near completion and do nothing about it. We need to learn from these mistakes, and those found liable must be taken to task.

We do need to develop a culture of consequence management. People must learn to account for their actions. In terms of our politics, I do recall that Emaswati still deem the Tinkhundla system as the best to serve their interests, but clearly there are some adjustments that need to take place.

Wealmesses

After the 2018 elections, at Sibaya there were a number of weaknesses that were pointed out that need to be addressed. Vote buying is one such challenge, but there is more, including the MPs' understanding on how the system is supposed to serve the electorate.

Before we rush to introduce a Tinkhundla system syllabus in our schools, there is need to engage on how we expect the system to function. It is not sufficient that we can talk of direct representation, but we need to go further on how we engage with all our structures on the ground.

We need to move beyond the notion that looks at the system as only delivering services, we need to engage on governance and how we can enhance it

Currently, there is a discord when it comes to clearly identifying the role of chiefs within the system. It needs to go beyond just having their signatures in approving projects. We need to engage intellectually on how we can bring about development in our own communities. In fact,

we need to start interrogating Section 218 to 226 of the constitution how we implement it, because that these sections give meaning to what tinkhundla is all about.

Political we seem to engage in low key the role of His Majesty the King and we seem to have a superfluous understanding of what he does.

We now need to move beyond that vague appreciation and bring him to the centre. He will be brought to the centre once the chiefs start to be clear of their roles in nation-building and its politics.

The new decade 2020-2030 is crucial to us as a nation and we need to be clear on what we want and how we will deliver.

Our challenge has been that we have been too apologetic about who we are and decided to be selective on how we engage. We need to promote the notion of market of ideas from grass roots level so that by the time we get to elect some of our own to parliament, they have developed the idea of engaging issues. Currently, we can blame the crop of MPs we have as being weak, but where do we expect them to have the skills if our grass roots only know to discuss communal disputes.

In the new decade we need to stand up and represent who we are before being swallowed by the voices that keep telling us how bad we look. Our ministers must learn to debate issues and defend their positions. They should not rely on their positions to get their messages across.

We need them to articulate government policy from the point of understanding, than just repeating what they have been sent to communicate.

The year 2020 should be the beginning of the process of change. Change is not an event. You don't wake up to it, you work towards it.

Let's commit to a better future.

THEFTSHIPSAND AQUACULTURE ACT, 2019

PART IV FISHERIES CONSERVATIO

Fisheries protected areas.

18. (1) The Minister may, by notice published in the Gazette, declare any national water body or part of a water body to be a fisheries protected area

(a) for the protection of aquatic resources and ecosystems or particular fish species;

(b) to facilitate fishery management by protecting spawning stock, allowing stock

recovery, enhancing stock abundance in adjacent areas, and providing pristine

aquatic ecosystems for research; or

to diminish any conflict that may arise from competing uses in that area.

(2) A person shall not in any fisheries protected area, without permission granted in terms of sub-section (3)

(a) fish or attempt to fish;


(b) take or destroy any aquatic resource;

(c) dredge, extract sand or gravel, discharge or deposit waste or any other polluting

matter, or in any way disturb, alter or destroy the natural environment;

(d) construct or erect any building or other structure on or over any land or water within a fisheries protected area; or(e) carry on any activity which may adversely impact on the ecosystems of that area.

(3) The Minister may, upon application and provision of good reasons, give permission, in writing, by way of a permit issued under this



Act that any activity prohibited in terms of this section may be undertaken on condition that, that activity will not harm or threaten the objectives of declaring an area or part of an area a fisheries protection zone.

Prohibited Fishing practices.

19. The Minister shall declare, by notice published in the Gazette, any fishing practices that are considered to be harmful, destructive or damaging to aquatic resources, to be prohibited fishing practices.

Establishment of a Fisheries and Aquaculture

20. (1) The Fisheries and Aquaculture Fund is established.

(2) The Fund shall consist of-

(a) all money paid in respect of fines, penalties and interest for any offence committed in terms of this Act, including any proceeds from the sale of any vessel, vehicle, aircraft, gear or fish forfeited or seized in terms of this Act;

(b) all interest and fees collected in terms of

(c) money appropriated from the Consolidated Fund for the realisation of the objects of the

(d) interest on investments;

(e) donations received with the approval of the Minister in consultation with the Minister responsible for finance;

(f) money which, with the approval of the Minister in consultation with the Minister responsible for finance, may accrue to the Fund from any other source; and

(g) any levy on fish, fish products, aquatic plants or other fish resources, imposed and collected in terms of this Act.

(3) The Fund shall be administered by the Principal Secretary in consultation with the Minister, in accordance with an estimate, a supplementary or revised estimate of revenue and expenditure approved by the Minister in consultation with the Minister responsible for finance in respect of each financial year, which shall end on the 31st March, and no expenditure payable from the Fund may be incurred except in accordance with that estimate of expenditure.

(4) The Principal Secretary shall be the accounting officer charged with the responsibility of accounting for money received and expenditure incurred by the Fund.

(5) The Principal Secretary shall invest money in the Fund not required for immediate use on the advice of the Minister responsible for finance.

(6) Any unexpended balance in the Fund at the end of a financial year shall be carried forward as a credit in the Fund to the next finan-

(7) The Auditor-General shall audit the books and accounts of the Fund annually.

Functions of the Fund

21. The functions of the Fund shall be to -(a) facilitate the fisheries and aquaculture devel-

opment and management;

(b) support commercial aquaculture;

(c) facilitate the execution of fisheries conservation and bio-diversity programs; and

(d) enhance adaptation to climate change in the fisheries and aquaculture sector and making preventive investment to reduce the impact of natural disasters on the sector.

PARTY LAW ENFORCEMENT

Fishery enforcement officers and voluntary fishery enforcement officers.

22. (1) The Minister may, in consultation with the Ministry responsible for public service, designate posts or ranks in the Ministry of which the incumbents shall be Fishery Enforcement

(2) The Minister may, by written notice in the Gazette, appoint any person that the Minister considers fit to be a Fishery Enforcement Officer or a Volunteer Fishery Enforcement Officer, and in doing so may specify the powers to be exercised by that person in terms of this Act.

(3) A Fishery Enforcement Officer and a Volunteer Fishery Enforcement Officer shall be furnished by the Principal Secretary with an identity card recording the name of the officer and designation.

(4) The Minister may withdraw the appointment or authority of an Enforcement Officer at any time.

Powers of fishery enforcement officers.

23. (1) For the purposes of enforcing this Act, any Fishery Enforcement Officer may, with a warrant issued by a Magistrates Court, enter and search any fishing vessel, vehicle, aircraft or premises or seize any property.

(2) For the purposes of enforcing this Act any Fishery Enforcement Officer may without a warrant -

(a) order any fishing vessel in the territory of Eswatini to stop;

(b) require the skipper of a vessel to stop fishing and take the gear of the vessel back on

(c) require the skipper of a vessel to facilitate the boarding of a vessel by all appropriate

(d) go on board a vessel and take with any other persons that the fishery enforcement officer may require for assistance in the execution of their powers;

(e) require any vessel documents, catch logbooks, licences or permits to be produced and

(g) require the skipper to give an explanation concerning the vessel, the crew, any person on board the vessel and any document referred to

(h) make any examination or enquiry which the Fishery Enforcement Officer may consider necessary to ascertain whether any provision of this Act has been contravened;

(i) make an entry dated and signed by the Fishery Enforcement Officer in any vessel's log book;

(j) where a Fishery Enforcement Officer has reasonable grounds to believe that an offence in terms of this Act has been or is being committed, take or require the skipper to take the vessel to any place within the country for the purpose of carrying out any search, examination or enquiry;

(k) give directions to the skipper and any crew member of any vessel stopped, boarded or searched as may be necessary or reasonably expedient for any purpose specified in this Act or for the compliance by the vessel, skipper or any crew member with any condition of a licence or permit;

(I) at all reasonable times enter and inspect any fish processing establishment or any other place where fish or fish products are kept or

(m) take samples of any fish found in any vessel, vehicle, aircraft or on any premises searched in terms of this section.

(3) A Fishery Enforcement Officer may, without a warrant -

(a) enter and search any vessel, vehicle, aircraft or premises if the Fishery Enforcement Officer has reasonable grounds to believe that an offence has been or is being committed or that fish illegally fished or that any prohibited fishing gear is being stowed or stored;

(b) stop, enter and search any vessel, vehicle or aircraft flying the Eswatini flag which the Fishery Enforcement Officer reasonably suspects is being used or is involved in the commission of an offence in terms of this Act;

(i) any property on board any vessel, vehicle or aircraft or on any premises if - the person in control of the vessel, vehicle, aircraft or premises consents to that seizure; or the Fishery Enforcement Officer has reasonable grounds to believe that a warrant will be issued, if the Fishery Enforcement Officer were to apply for that warrant, and the delay caused by the obtaining of that warrant would defeat the object of the seizure;

(ii) any vessel, including its gear, equipment, stores and cargo, and any vehicle or aircraft of which the Fishery Enforcement Officer has reasonable grounds to believe that it has been or is being used in the commission of an offence

in terms of this Act or in respect of which the Fishery Enforcement Officer suspects an offence to have been committed or which the Fishery Enforcement Officer knows or has reasonable grounds to suspect that it has been seized or forfeited in terms of any provision of this Act;

(iii) any fish or fish product which the Fishery Enforcement Officer has reasonable grounds to suspect to have been taken or produced in the commission of that offence or which are possessed in contravention of this Act;

(iv) any substance or device which the Fishery Enforcement Officer has reasonable grounds to suspect to have been used or to be possessed or controlled in contravention of any provision of this Act;

(v) any log book, chart or other document required to be maintained in terms of this Act or in terms of any license, in respect of which the Fishery Enforcement Officer has reasonable grounds to believe that it shows or tends to show, with or without other evidence, the commission of an offence in terms of this Act;

(vi) anything which the Fishery Enforcement Officer has reasonable grounds to believe might be used as evidence in any proceedings in terms of this Act; or

(d) arrest any person whom the Fishery Enforcement Officer has reasonable grounds to suspect to have committed an offence in terms of this Act.

DELIVERY, POST-NATAL CARE TIPS FOR FIRST TIME MOMS

MATERNAL AND INFANT HEALTH CARE PROMOTION PROGRAMME

THE maternal and infant health care promotion programme funded by Taiwan International Cooperation Development Fund (TaiwanICDF), in collaboration with Sexual Reproductive Health Unit under Ministry of Health in the month of last month discussed a number of topics in their programme aired by the Voice of the Nation every Monday morning.

Some of the topics discussed during the programme include the "abnormal delivery, bleeding, breastfeeding and cleanliness".

Below is a summary of health

SESSION 1: "Abnormal Delivery"

- 1) The two types of c-sections:
- a) Emergency c-section:

When there is suspected danger to the mother's or baby's condition. The mother can give consent by signing for herself to allow the procedure.

b) Elective c-section:

Planned and done on a specific date, chosen by the doctor after assessing the maturity of the baby. Consent can be given by a relative.

2) Indications for C-section:

- · Fetal distress
- · Labor doesn't progress
- · Baby very big
- · Breech position (baby comes by feet)
- Previous classical cesarean
- · Genital herpes in the mother
- Uterine deformity
- · The unborn baby is tight by the umbilical cord around the neck
- · Pelvic bones too tight to give way

3) After delivery

The mother is kept in the hospital ward for 48 hours to five days depending on how the mother recov-

ers. Then after discharge, the mother needs to come to the

hospital after three days for a medical checkup.

SESSION 2: "POST-NATAL CARE"

Stage 1: Bleeding

Fresh or bright red blood is not expected after delivery as it may signal that the uterus is not well contracted or there are some products of conception that remained inside that continue the bright red or bleeding. The blood should be a bit darker to brown as the days goes by.

 The blood flow should be lesser and lesser each day that passes. The pads are not expected to be heavily soaked every day.

1) Natural delivery wound

- Do seat bath for at least 5-10
- Can also drink pain medica-

if prescribed to relieve afterbirth pains.

2) C-Section wound

- Try to keep it dry at all times. Drink prescribed pain medication, and do not overdose.
- Do not bandage the wound at home because it might get infec-

Stage 2: Breastfeeding

First time mothers tend to have poor attachment problems, which lead to pain when breastfeeding, so, proper breast attachment of the baby is encouraged.

 Never drink alcohol when breastfeeding.

 Eat a balanced meal with all the food groups and take plenty of fluids.

Stage 3: Disposal and Cleanliness

- Dispose nappies in a pit toilet or burn them.
- When coming from a toilet or any place, wash your hands with soap and fresh water then you wipe your hands to dry, before touching the baby.
- The baby's prepared food should not be left open, and the feeding equipment should be thoroughly washed clean to avoid development of microorganism on them that may then cause infection to the baby.

2019: A grim year for state-owned entities

JOHANNESBURG - As the country battled low growth and record unemployment this year, a number of key state-owned enterprises - which are supposed to drive economic activity - faced financial ruin, putting further strain on the already ailing economy.

Many of South Africa's major public entities have been impli-

cated in state capture and corruption, including allegations of the looting of billions of rands through the irregular awarding of contracts, as heard in evidence presented at the Zondo Commission into state capture.

The government has continued to guarantee the debt of cashstrapped public entities, which has included billions in bailouts to help them ward off insolvency, and, at times, even help them pay salaries.

Ratings agencies and international lending institutions, meanwhile, have repeatedly flagged the draining effect of SOEs on state coffers, calling for urgent reforms to reduce their dependency on government.

which sank deeper into the financial abyss in 2019:

TOTAL Revenue for 2020/21has been projected to be E18 184 737 263.

This is according to the govern-

ment of the Kingdom of Eswatini estimates for the years from April 1, 2018 to March 31, 2021.

Income

This is made of income taxes, taxes on property, taxes on goods and services, non-tax revenue.

According to the estimates, income taxes are estimated to be E6 378 827 003, taxes on property E41 620 318, taxes on goods and services 11 045 365 21 and non-tax revenue E718 924 681.

In the year 2019/20 total revenue

was projected to be E17 64 562 979 with income taxes estimated to be E5 889 685 902, taxes on property E40 019 184, taxes on goods and services E10 949 185 444 and non-tax revenue E785 672 448.

According to the ministry of finance second quarter report the total annual budget for government financed capital projects was E2.029 billion. About 54 per cent of the annual budget was released in the second quarter of the 2019/20 financial year.

The main releases were E331.7 million for the ministry of economic planning and development, E128.6 million for the ministry of agriculture, E118.1 million for ministry of public works and transport and E100.3 million for the ministry of natural resources and energy.

According to the Eswatini Energy Regulatory Authority (ESERA) Regulatory Framework on the promotion of access to electricity, the ministry of natural resources and energy is mandated to prepare a rural electrification plan.

"There should also be a provision for co-ordination of rural access fund as well as a rural electrification data base," reads part of the presentation.

The framework also highlights the Regulation of the Electricity Supply Industry citing the different types of licences awarded which include Generation, Transmission, Distribution licence, Supply licence and Import and export license.

"On the Exemption from obligation to hold a Licence Section 22 of the Electricity Act 2007 provides that any person who generates, transmits and distributes electricity for own use, approved and authorised by the authority, is exempted from the obligation to apply for and hold a licence.

Quality

"In case there is a commercial activity of up to 1GWh of electricity, the tariff and quality should not be less favourable than the electricity that would have been sold by the licensee who sells the electricity," it read.

It also stated that Section 9 of the Electricity Licensing By Laws provided that the following persons were exempted from holding a licence; An operator of off grid and mini grid supply schemes and a generator who generates of more than one hundred kilowatts exclusively for own use shall apply and hold a license.

Eskom breakdowns remain sky high

JOHANNESBURG - Eskom announced yesterday morning that load shedding was not expected for the day thanks to a drop in demand during the holiday period and a return of some generating units to service.

But as of yesterday morning, a massive 14,574MW remains missing from SA's electricity system due to unplanned breakdowns at power stations. Any unplanned outages above 9,500 MW

mean that system is severely constrained and that load shedding may be on the cards. Eskom said the system remains vulnerable and unpredictable, and the load shedding remains a possibility.

Emergency

It will continue to use emergency power generation if necessary. This involves using open cycle gas turbines and pumped-storage hydroelectric plants.

These are very expensive ways of

generating power, particularly the gas turbines, which require large quantities of diesel. They can only be used for short periods before diesel and water reserves start running out.

South Africa has been hit by severe load shedding in February, October and December this year. After the economy shrank in the third quarter, economists fear that the load shedding in the fourth quarter could land SA in a recession.

Zimbabwe drought, food crisis likely to run into 2020

HARARE - A swathe of Zimbabwe, running from the southwest to the northeast, faces a "Phase 3" food crisis after a sporadic start to the November to March rainy season, the Famine Early Warning Systems Network said.

Phase 3 is just two steps down from full-blown famine, the USAID-funded Fewsnet said in an emailed statement on Friday. The forecast for the region is for "below average rainfall," it said.

Parts of the Democratic Republic of Congo, Madagascar, Mozambique and Malawi will also be affected, it added.

It's the second drought in as many years. "Many areas of the region are likely to face a second consecutive poor rainfall season and harvest," the organisation warned.

That's particularly bad for Zimbabwe where the "poor macroeconomy is negatively affecting planting and germination rates," it said. Millions of rural



Zimbabweans are too poor to plant and farm corn, the country's staple food. Zimbabwe faces an economic crisis where shortages of cash, fuel and electricity cripple people's access to basic food.

"High staple prices in the region are contributing to below-average purchasing power for a significant number of poor households," Fewsnet said, mainly because prices are trending five per cent to 10 per cent above the five-year average in South Africa, the region's biggest producer and the source of much of the region's milled corn.

adds to the management turmoil at Boeing as the nine-month grounding of the manufacturer's best-selling jet drags on. David Calhoun, a board member who took over as chair in October, will replace Muilenburg on January 13. Chief Financial Officer Greg Smith is

serving as interim CEO.

Boeing is under increased pressure in Washington after disclosing a new batch of internal communications about the Max's development to the US Federal Aviation Administration on December



VOLKSWAGEN DEVELOPING MOBILE **AUTONOMOUS ROBOTS**

MUNICH - Volkswagen has claimed that electric car owners won't need to drive to charging stations in the future - because the charger will be delivered to them via robots.

The German auto giant says it is developing 'mobile charging robots', which will autonomously drive themselves to a car's locations, open the socket flap and plug it into a compact charging device without any need for human inter-


The robots are aimed at providing charging solutions in multistorey and underground car parks where space is at a minimum.

Self-driving robots will then transport a mobile energy storage device - known as a battery wagon - on a trailer to its whereabouts, open the charging socket flap, connect the plug to commence charging and decouple it once the batteries have been replenished.

The chargers and robots are all stored on site in a dedicated area, ready for them to leap into action. When fully charged, the battery wagons are equipped with an around 25 kWh each.

The mobile energy storage device stays with the vehicle during the whole charging process takes place while the robot, in the meantime, transports more systems to other vehicles in that car park that are in desperate need of electricity.

Once the charging service is complete, the robot collects the energy storage device and brings it back the on-site charging stations, where it can be plugged into the mains to boost it back to full capacity ready

to service other charge-strapped cars in the vicinity.

Images released by VW show the robot chargers - oddly with cartoon-like eyes - delivering one of the devices to a VW ID.3, the firm's first dedicated, from-the-groundup, mainstream electric model due next year.

What is VW's new V2X system?

The original version of VW's V2X system is called Car2X and will debut in the new Golf hatchback next year.

This allows the car to talk to other models with the system installed.

Data can be pinged from one to the other in a matter of milliseconds.

It won't be gossiping about you to other Golfs, though.

Instead it can send and receive alerts about accidents, broken-down vehicles, traffic jams, roadworks and any emergency vehicles in the immediate vicinity.

Further development will mean the system fitted to electric models could be able to communicate with the autonomous driving robots to notify them that their in need of charge.

Mark Möller, Head of Development at Volkswagen Group Components, which is designing the charging bots, said: "The mobile charging robot will spark a revolution when it comes to charging in different parking facilities, such as multi-storey car parks, parking spaces and underground car parks because we bring the charging infrastructure to the car and not the other way around.

"With this, we are making almost every car park electric, without any complex individual infrastructural measures.

"It's a visionary prototype, which can be made into reality quite quickly, if the general conditions are right.'

The charging robots can move several battery wagons at the same time and each one allows for DC quick charging with up to 50kW on the vehicle.

The robots themselves are fitted with the latest self-driving systems powered by cameras, laser scanners and ultrasonic sensors.

The combination of these not only allows the robot to carry out the charging process completely autonomously but also to move around freely in the parking area, to recognise possible obstacles and to react to these.

Volkswagen says the robot and charging devices are only in a prototype phase and won't give a possible date for when they might be put into action

Depending on the size of the parking area or the underground car park, several charging robots can be employed simultaneously so that several vehicles can be attended to, VW said.

"This approach has an enormous economic potential', Möller added.

"The constructional work as well as the costs for the assembly of the charging infrastructure can be reduced considerably through the use of the robots

'Even the well-known problem of a charging station being blocked by another vehicle will no longer exist with our concept. You simply choose any parking space as usual. You can leave the rest to our electronic helper."

The mobile charging robots are currently only at the prototype phase of development. Volkswagen has refused to suggest a possible date for a market launch.

ZIMBABWE JOURNOS SUFFERASREGIVE TICHTENSGR

HARARE - Fanuel Mapfumo has been unable to lift heavy objects since a Zimbabwe police officer fractured his left arm as he was covering a story last August.

The 28-year-old journalist was filming a banned protest in the capital Harare when it happened.

Opposition supporters were voicing their discontent with the country's ailing economy when police descended on the crowd with batons.

Zim Morning Post, said they ordered him to stop filming.

"I identified myself as a journalist," he told AFP.

"But the next thing I remember is being dragged into a group of police officers who beat me all over my body."

Rights groups have accused Zimbabwe's President Emmerson Mnangagwa of persistently violating human rights since he took office in 2018.

In August last year six people Mapfumo, who works for the died after the army used force against civilians protesting a delay in the announcement of election results. In January, the army attacked protesters marching against a hefty fuel price hike, leaving 17 dead.

And as Mnangagwa has tightened his stance on dissent, journalists have also suffered repercussions.

"We documented 18 cases of abuse of members of the media this year," said Tabani Moyo, who heads the Media Institute of Southern Africa (MISA) up from

only one case in 2018.

Most of the incidents involved police officers, he added.

The rise of attacks on journalists has brought back memories of the regime under former president Robert Mugabe, whose increasingly despotic rule cracked down on the independent media.

Mugabe was toppled by a military putsch in 2017 after 37 years in power, which led some of the country's embattled media professionals to hope for better days.

PARIS - Former Ivory Coast rebel leader Guillaume Soro dismissed an arrest warrant issued against him as baseless and said he would pursue his campaign as a presidential candidate from overseas, according to comments published in a French newspaper yesterday.

Ivory Coast's public prosecutor issued the warrant for Soro on December 23 as part of an investigation into an alleged coup plot, forcing him to call off a planned homecoming for the first time since May and ahead of the October 2020 election.

The broadcaster reported that in stark contrast to previous years when several political and business heavyweights were spotted at the event, only former North West premier Supra Mahumapelo showed up this year.

Weekly newspaper Sunday World previously reported that Zuma was in Cuba seeking treatment for an illness linked to an alleged poison plot in 2014. He also, apparently, was struggling with memory loss. On December 9, Zuma's lawyers told the Zondo commission of inquiry into state capture that he would not meet his deadline to respond to an application by journalist and broadcaster Redi Tlhabi for leave to cross-examine him, because he had been hospitalised, TimesLive reported.

During his testimony in July, Zuma claimed that Tlhabi was working on a film about his rape trial. News24

Matric pupils to write exams in isiXhosa, Sotho

CAPE TOWN - In a decision that will have major implications for isiXhosa and Sotho speaking pupils in the province, the Eastern Cape education department has given the go-ahead for matric pupils to answer exam questions in their home language from 2020.

The announcement was made by Provincial Education MEC Fundile Gade at a media briefing earlier this month, reports the Daily Dispatch.

To date, matrics have only been able to answer exam questions in English and Afrikaans. Multilingual exams will ensure that pupils receive question papers in their home languages as well as English and Afrikaans and can choose which language to use.

Eastern Cape schools will be the first in the country to apply this exam model in Grade 12. It will mean that pupils who struggle to understand English or Afrikaans will now be able to understand subject content more easily, according to some education experts.


Addressing the media in Zwelitsha, Gade said more and more schools in the Eastern Cape had started mother tongue-based teaching, learning and assessment at the foundation phase to improve results.

Seven years ago, the Eastern Cape became the first province to move towards implementing the home language programme.

In September, Gade said of the 5 400 schools in the province, more than 2 000 had adopted the programme in Grades 1, 2 and 3.

He said in 2012, 74 schools in Cofimvaba adopted the model and started teaching subjects, including mathematics, in isiXhosa. In 2017, the model was rolled out to a further 310 schools and extended to other lower grades. In 2020 the programme would be implemented at Grade 12 level, Gade said.

"We have passed through the 2019 examinations. Our eyes are now on the 2020 examinations because we are going to have Grade 12 exam questions in isiXhosa, Sotho, Afrikaans and English."



Stats SA Census 2021 Mini Test reveals a need for privacy

CAPE TOWN - Concerns about the privacy of information shared affected response rates to the justconcluded Census 2021 Mini Test conducted by Stats SA.

This despite assurances from officials of the national statistics agency that confidentiality of information collected is protected under the Statistics Act.

The act provides for a fine of up to R10 000 and/or imprisonment of up to six months for fieldworkers or other employees of Stats SA who are found guilty of contra-

In a statement, Stats SA said: "We are experiencing a general decline in response rates due to concerns about information security.'

Other challenges of collecting data faced during the Mini Test includ-



ed: "Accessing households in highwalled security complexes due to safety and security concerns and respondent apathy due to the current political and social environment."

According to the agency: "Every Stats SA official is swom to uphold the confidentiality of collected data.

Employees of Stats SA will be legally bound, by signing the oath of confidentiality, never to disclose individual information gathered in the course of their duties.

"The oath continues to apply even after employment has ceased."

In the frequently asked questions section of its website, Stats SA offers

the guarantee that "Section 8 of the Statistics Act states that no unauthorised person or organisation (including government departments) can have access to individual information that is gathered in terms of the act."

The Act states: "No other government organisation can look at any individual information collected during the census except when the data have been aggregated for report purposes and the respondent's personal details have been excluded."

Other challenges were a level of respondent fatigue due to the long census questionnaire, which hampered maximum co-operation from respondents as well as managing to recruit fieldworkers from within their enumeration areas.

He said that the fatal mix of alcohol and irresponsible driving remained the most serious problem. Also of key concern was the use of unroadworthy vehicles found particularly to be crossing to and fro from the Beitbridge bor-

In addition, he said it was worrying that a large number of road fatalities were that of drunk pedes-

He said that compared to this period last year, the number of fatalities appeared significantly reduced - although the final statistics would only be released on January 23.

"We are blessed that up until now, we have not witnessed a major fatality [involving many people] on the roads," he told the broadcaster. News24

DA will lose Tshwane in 2020, says ANC

JOHANNESBURG - The African National Congress (ANC) in Tshwane is adamant that the Democratic Alliance (DA) will be removed come the next council meeting in the new

The past week, the High Court in Pretoria ruled that the DA should remain in control, pending the finalisation of a review application and suspended all resolutions taken at a council meeting that removed Mayor Stevens Mokgalapa and Speaker Katlego Mathebe.

It also ruled that the case will be treated as a matter of urgency

The DA approached the High Court after chaotic scenes in the council ahead of a vote to remove Mokgalapa and Mathebe.

The ANC's Kgosi Maepa said: "While the (court) review happens, the council will continue. Council will continue and we can remove the people again on 3 January." The Star

Eskom appeals for collective effort to keep electricity usage low

JOHANNESBURG - Electricity utility Eskom confirmed yesterday that no load-shedding was expected for the day, in a continuation of the drop in demand from the start of the holiday period in mid-December.

"Eskom will continue to use emergency reserves to supplement capacity if necessary over this period. We, however, remind customers that as the system continues to be vulnerable and unpredictable, the possibility of load-shedding remains," it said in a statement.

"Breakdowns (UCLF) are at 14 574MW as at 6.30 this morning. Our technical teams will continue to work over the holiday period to monitor the situation, carry out planned maintenance and to work at reducing unplanned breakdowns to below 9 500MW to enable us to minimise the possibility of load-shedding.

"We continue to ask customers to reduce demand as a concerted collective effort can help to avoid or lessen the level of load-shedding."

Eskom has offered tips to consumers on how to reduce their electricity usage, ranging from switching off appliances when not in use at plug points - including those on standby mode - and minimising use of air conditioning systems.

"We are relatively pleased with the way [traffic flow] is going," said RTMC Spokesperson Simon Zwane.

He said that yesterday, traffic was flowing normally, with about 800 cars per hour recorded on the roads from Johannesburg into Durban and Limpopo

"Traffic will calm down now on

major national routes."

Zwane said people travelling on the N1 should be careful of trailers, and some cars, that had broken down along the road.

He said a key problem remained people driving with overloaded trailers.

As Christmas approaches, officials will focus on key areas of holiday-making destinations and enforce road safety there, said Zwane.

Pedestrian safety and curbing drink-driving is also another key

focus area for officials.

Roadblocks and checkpoints will be set up, and alcohol tests conducted

"The fact there are a number of single-vehicle accidents occurring suggests that driver fatigue or drunken driving remain problems."

Jonck said he was pleased to see highly visible road traffic enforcement this year.

Sol's family fumes as 'cage' erected around his grave

KIMBERLY - The family of Sol Plaatje has accused the Northern Cape government of 'desecration' by putting a 'cage' around the political icon's grave in what appears to be a rushed spruce-up project ahead of a planned wreathlaying by President Cyril Ramaphosa next month.

A family member said while they welcomed Ramaphosa's gesture of paying homage to Plaatje, they were unhappy and felt 'disrespected' that the grave had been touched without their consent or input.

"They can't put a cage, lock the gate and we don't even know who's got the keys ... we're locked out. The cage has created a barrier for everyone," said the literary icon's greatgrandson Sebeka Plaatje.

He was referring to the galvanised welded mesh fencing around the grave. "Had we agreed to it, we would not have allowed them to put a cage around the grave. We cannot allow this to happen just for some people to score political mileage," he said.

Sebeka added that they were denied an opportunity to perform a ritual on the grave before it was fenced off. The family have since instructed their lawyers to write to several government officials, including Ramaphosa and Northern Cape Premier Zamani Saul, demanding that work should be stopped pending a proper consultative process. City Press

Close to 30 die in initiation ceremonies

JOHANNESBURG - The number of initiation deaths across the country is now close to 30, with the Eastern Cape topping the death toll.

In Gauteng, two initiates have died at two different illegal initiation schools, with one person arrested.

One of them was 16-year-old Lenasia resident Mpho Mothupi who went missing on 23 November.

His family say men visited their home, telling them that he had taken himself to an initiation school but his family believes he was abducted

Mothupi's body was found on December 18, a short distance from a now illegal initiation school.

UN approves Russiabacked 'cybercrime' treaty

GENEVA - The United Nations has approved a Russian-backed cybercrime treaty that has alarmed America and Western powers who fear it will censor the internet.

The General Assembly approved the resolution, sponsored by Russia and backed by China, on Friday. The movement will now set up a committee of international experts in 2020. The panel will work to set up 'a comprehensive international convention on countering the use of information and communications technologies for criminal purposes,' according to the resolution.

America, Western powers and other rights groups have already warned against the move as they fear that the language is code for legitimising crackdowns on expression.

China already heavily restricts internet searches to avoid topics that are sensitive to its communist leadership as well as news sites with critical coverage.

A number of countries have increasingly tried to follow suit and crack down on internet usage. India is set to cut off online access in Kashmir in August after it stripped autonomy to the Muslim-majority region.

The editor-in-chief of Christian Today blasted Trump after the impeachment hearings.

"Unfortunately, the words that we applied to Mr. Clinton 20 years



ago apply almost perfectly to our current president,' Mark Galli wrote on Thursday.

"Whether Trump should be removed from office by the Senate or by popular vote next election that is a matter of prudential judgment. That he should be removed, we believe, is not a matter of partisan loyalties but loyalty to the Creator of the Ten



Commandments.'

Trump replied to the old meme he resurfaced years later: "Thank

The plenary session, which opened on Saturday, follows widespread speculation that Pyongyang is preparing to test an intercontinental ballistic missile - as a threatened 'Christmas gift' for Washington.

Kim presided over the meeting which discussed a new 'transparent, anti-imperialist independent stand', the official Korean Central News Agency (KCNA) reported.

The ruling Workers' Party of Korea will also 'discuss important matters arising... in the building of the state and national defence', KCNA added.

Talks on denuclearising the Korean peninsula have been largely deadlocked since the second summit between Kim and US President Donald Trump collapsed in Hanoi at the start of this year. The opening of the plenary comes a week after Kim held a meeting of top defence officials and discussed boosting military capabilities. Pyongyang has carried out a

Violence breaks out over transport strike

PARIS - Violence broke out on the streets of Paris when French 'yellow vest' protesters gathered on the 24th day of the nationwide multi-sector strike.

Protesters marching against the French government's planned pension reform clashed with the police in Paris on Saturday as police fired tear gas to disperse some groups of demonstrators.

French trade unions have spearheaded nationwide strikes since early December in an outcry over President Emmanuel Macron's pensions overhaul, disrupting schools, railways and roads, while lending support to regular protests.

Attacker stabs five at rabbi's home

NEW YORK - An attacker stabbed five people late on Saturday at a rabbi's home in New York state before fleeing, a Jewish organization said, in a rampage that came after days of increased tensions over anti-Semitic assaults. The Orthodox Jewish Public Affairs Council said on Twitter an attacker wearing a scarf stabbed the victims at a house in Monsey, Rockland County, about 30 miles north of New York City. All five victims were taken to local hospitals, the council said, adding that two of the victims were critical, with one of them stabbed at least six times. New York Attorney General Letitia James said she was "deeply disturbed" by the situation in Monsey.

"Not all artists send us DJ packs," said hip hop DJ Master P. He said

"I am overwhelmed by the support people give me, the fact that they voted for me shows how much people love my music and how much I have connected with my fans," Zulu D said.







Dutch coach Koeman might be the most likely successor - after the former Everton boss revealed there is a clause in his Holland contract that allows him to leave if he is offered the Nou Camp hot-seat.

It would be a triumphant return, after winning the Champions League and four Spanish titles on the pitch for Barca.

The former free-kick master moved into the dugout as assistant for two seasons after he retired - before jobs with Ajax, Benfica and Southampton as number one. *Daily Mail*

Beckham 'set to appoint first Inter Miami manager'

MIAMI - David Beckham is set to appoint former Monterrey boss Diego Alonso as his first manager at Inter Miami after speculation a big name would take over.

A host of high-profile managers were linked with the post as the former Manchester United star looks to get his new team off to a good start when they start their MLS season in February.

Carlo Ancelotti's name had been rumoured after working with Beckham at AC Milan, but the Italian has since joined Everton, while David Moyes and Nice boss Patrick Vieira were also mentioned. But Beckham is set to unveil the relatively unknown Alonso as his first manager on Monday, according to the Miami Herald.

Alonso was only in charge at Monterrey for one season, but he led the Mexican side to CON-CACAF Champions League glory in May paving the way for them to appear at the Club World Cup this month. However, the Uruguayan was sacked by the club in September after suffering a poor run of results and replaced by Antonio Mohamed, who led the team into the Club World Cup semi finals against Liverpool, losing 2-1 in stoppage time. This season was not the only time Alonso has lifted the North American Champions League, having won it with another Mexican side Pachuca in the 2016-17 campaign, having won the nation's top flight division the season before. His other posts have been in his native Uruguay, including at Olimpia, Penarol and Bella Vista.







The two were evictd from the grounds around 2.50pm [Australian time] for behavioural issues, a Victoria police spokesperson said according to the report.

"The 22-year-old and 23-yearold, both New Zealand nationals, have been evicted and have incurred a 24-hour ban from the MCG," the spokesperson said.

A witness, also a New Zealander, who claims he saw what happened, said: "He sat down and had a big gulp of half-a-beer and got kicked out... I was sitting 10 metres from him. He remained calm and had a big gulp."

This is not the first time the All Blacks' utility back has found himself in trouble for an alcohol-related incident. Last year, police were called after an ellegedly intoxicated Barrett was found eating a McDonald's burger in the wrong flat at 5am in the morning after a Hurricanes game.

"I was not intoxicated". He apologised for the incident at the time.

"I can't say I'm embarrassed by what's happened, I'm just disappointed with the events that have unfolded. I don't believe I've caused any harm to anyone.

"It was a human error, I walked into the wrong flat and then we left.

Serena Williams named AP's top female athlete of decade

NEW YORK - Serena Williams dominated the decade, on the court and in conversation.

There were, to begin with, the dozen Grand Slam single titles no other woman had more than three over the past 10 seasons and the three and a half years in a row at No. 1 in the WTA rank-

nis, making everything she did and said newsworthy, whether it was

the triumphs and trophies and fashion statements or the disputes with tour-

nament officials, the magazine covers or the Super Bowl ad with a message about women's power, the birth of her daughter or the health scare that followed.

Still winning matches and reaching Grand Slam finals into her

late 30s, still mattering as much as ever, Williams was selected by The Associated Press as the Female Athlete of the Decade on Saturday after a vote by AP member sports editors and AP beat writers.

"When the history books are written, it could be that the great Serena Williams is the greatest athlete of all time. . . . I like to call it the 'Serena Superpowers' — that champion's mindset. Irrespective of the adversity and the odds that are facing her, she always believes in herself," said Stacey Allaster, CEO of the WTA from 2009-15 and now chief executive for professional tennis at the U.S. Tennis Association, which runs the US Open.

"Whether it was health issues: coming back; having a child; almost dying from that - she has endured it all and she is still in championship form," Allaster said. "Her records speak for them-

Gymnast Simone Biles, the 2019 AP Female Athlete of the Year, finished second to Williams in voting for the decade honour, followed by swimmer Katie Ledecky. Two ski racers were next, with Lindsey Vonn finishing fourth and Mikaela Shiffirin

Former Uruguayan internationals showed their support too as Sebastian Abreu and ex-captain Diego Lugano were seen in the line-up that played against him, with Forlan picking a team of his closest friends and

team-mates. Forlan was given the perfect send-off as he scored along the way to a 6-6 thriller, before his farewell was wrapped up with a feel-good ceremony with pyrotechnics and music.

The 40-year-old is now set for the next chapter of his career as he prepares to take on his first managerial job in charge of Uruguayan side Penarol.

He started his youth career with the Montevideo-based team before joining them later on in his career for one season in 2015-16, and said the opportunity to coach them was a dream come

To have my first experience in a club of traditions and of a high level like Penarol is more than I dreamt of," he said. "When you play you notice if you like soccer itself. It isn't only about playing. I enjoy it, I like it, I analyse it, I see it." Forlan had an excellent career, winning an array of trophies throughout his 21 years on the pitch, first winning the Premier League and FA Cup with Man United before lifting the Europa League and Super Cup with Atletico.

He also won the Copa America with Uruguay in 2011 after finishing as the top goal-scorer at the 2010 World Cup in South Africa, where he led his team to the semi-finals.







CHESS NATIONAL TEAM OFF TO RUSSIA NEXT YEAR

CHESS -The Eswatini Chess Federation (ECF) will send a national squad to the 44th World Chess Olympiad to be held in Russia, August next year.

This was revealed by Tournament Director William Seyame during an interview yesterday.

He said the federation was in the process of selecting the squad to represent the country, stating that it would be Eswatini's fourth participation in the biggest chess festival in the world where over187 countries and over 1 600 players are expected to take part.

"We will select more players who will present Eswatini on other international assignments which include the Manzini Open Section to be staged in January," he said.

Seyame highlighted that their first participation in the World Chess Olympiad was in Stoklsom, Norway in 2014 meanwhile their second participation was in 2016 at Baku, Azerbaijan.

"The last time we participated was in 2018 at Batumi, Georgia and we are preparing ourselves for the 44th World Chess Olympiad tournament next year," he added.

The director said they would take advantage of other tournaments before the 44th World Chess Olympiad as they would practise for the bigger assignment.

Seyame further said they were pleased with the standard of the

sport in the country

"We are on the right track, and in few years' time we will produce not only candidate masters, but fide and international masters," he added.

The World Chess Olympiad is held every two years.

This will be the 44th men's Chess Olympiad (the first one took place back in 1927 in London) and the 29th women's Chess Olympiad. Moscow has hosted the Chess Olympiad twice, in 1956 and 1994 and Khanty-Mansiysk once, in 2010.





ter revealed that the players had already informed the squad management through their captain Banele 'Makonese' Dlamini.

"The players are still waiting for their monies after asking the captain to speak, on their behalf, to the management and they haven't received any response from the management.

Each player is owed E3 000 by the mother body.

"The players are entitled to E1 000 for training allowance, E2 000 for a win and E500 for a loss," said the source.

"We are now in dilemma since we were not paid the money, yet the some of the officials are insisting that we were paid," said one of the players. Eswatini Football Association Marketing Officer Muzi Radebe said these matters were administrative when sought for comment yesterday.

"These are administrative issues between the employer and employee; therefore, I cannot go into details," he said. Meanwhile, the nation's pride will return to action in March under the guidance of a new coach during the 2021 AFCON qualifiers. This follows the recent departure of Serbian coach, Kostadin Papic who parted ways with the national mother body amicably.
