

EX-RAMBLAS EMPLOYEE FINGERED IN ROBBERY

A former Ramblas Restaurant employee has been identified as one of the three suspects who robbed the eatery money and valuable items.

This was confirmed by Ramblers restaurant owner Jordi Soler. He said the former employee's name is Thami Mandela Ndlovu from Msunduza.

Companion

When relating what happened, Solar said Ndlovu, together with his companion, came to the restaurant and found his wife with other employees counting money.

The two went to the table where the money was being counted ad stashed it into a plastic dustbin and ran away.

They are said to have been wearing balaclavas which made it hard for the staff to recognise them at that moment.

After they took the E20 000 cash, a laptop and a cell phone they ran away and Ramblas staff started chasing them. They ran towards the traffic circle where a Honda fit was waiting for them.

Investigations

Before Ndlovu got into the car, Soler said he took off his balaclava and the employees were able to identify him.

The driver of the car has been arrested and he confessed that he was hired by the two to drive them to Ramblas and after the robbery, he drove them back to Eveni.

Police got a tip off from the members of the public who gave them the car's registration numbers which the police used to trace and arrest the driver on Tuesday.

The two are still at large.

Police Information and Communications Officer Superintendent Phindile Vilakati said investigations were ongoing.

WOMAN SEDUCES MANINTO SEX, LATER OPENS RAPE CASE

A man who was seduced into sex by a 24-year-old woman learnt the hard way to have self-control as he ended being arrested for rape.

Sanele Boyboy Simelane of Mdzimba was arrested by Lobamba police and charged with Contravening Section 3(1) of the Sexual Offences and Domestic Violence Act 15/2018.

According to the charge sheet, it is alleged that the accused person unlawfully and intentionally had sexual intercourse with the complainant, without her consent.

On December 27, Simelane made his

first court appearance before Mbabane Principal Magistrate Fikile Nhlabatsi. The accused was remanded back into police custody and he spent the festive holidays behind bars.

He was advised to move his bail application at the High Court. Simelane, in his affidavit, denied raping the complainant. He stated that the sexual intercourse was consensual. In fact the complainant was the one who initiated the sex. Simelane, submitted that his continued incarceration will have serious and negative repercussions to him since he is a farmer who earns a living through crops and vegetables farming. He said when he was arrested he had already cultivated his maize fields and same was prone to fail as no one was taking

care of the crops.

Furthermore, Simelane stated that he is a father of two children, with the eldest being four years and about to go to preschool.

The accused argued that there is no one who would pay for his daughter's school fees while he is incarcerated as his girlfriend is unemployed.

He stated that he possesses a passport and wishes to surrender same to the relevant authorities and will not use illegal exit points but remain in Eswatini.

Simelane appeared before Judge Mzwandile Fakudze yesterday and he was granted bail fixed at E15 000. He was ordered to pay E2 000 cash and provide surety to the amount of E13 000

SUICIDE PUPIL DELETES ALL MESSAGES ON WHATSAPP

THE Form Four pupil who committed suicide after discovering that she was pregnant deleted all whatsApp messages from her mobile phone hours before her death.

The deceased, Nolwazi Constance Mnisi, a former pupil of Mgobodzi High School, committed suicide by ingesting weevil tablets at her homestead at Ngowane on Tuesday. Nolwazi, who was the youngest of five siblings, was discovered unconscious inside her bedroom by her mother Nomsa Mnisi.

The shocked Mnisi phoned the Emergency Medical Services (EMS) who rushed the deceased to the Pigg's Peak Government Hospital where she was certified dead.

Speaking yesterday, the mother of the

deceased said Nolwazi had deleted all her WhatsApp messages on her phone hours before her suicide.

"Due to my age, I am unable to use the modern phones, so I asked one of the elder daughters' to access Nolwazi's phone and read any messages to me. When my daughter unlocked the phone, she told me that Nolwazi had deleted all her messages on WhatsApp.

"That was strange because Nolwazi was always on WhatsApp," she said. The mother added that Nolwazi had a

few male friends.

"We suspect that Nolwazi was in a relationship with an older man but that is still speculation because she had a few male friends. As a family we are still confused," she added.

Chief Police Information and Communications Officer Superintendent Phindile Vilakati confirmed that the matter was finally reported to the police.

"We will wait for a post-mortem to determine the cause of death," Vilakati said.

DPM DECLARES ASSETS

DEPUTY Prime Minister Themba Masuku yesterday declared his assets and liabilities to the Human Rights and Integrity Commission.

The exercise was conducted by Human Right and Integrity Commission Deputy Commissioner Duduzile Dlamini at the DPM's Office.

Other commissioners present to witness the declaration were the Commission's Chairman, Sabelo Masuku, who happens to be the DPM's son, Chief Masuku Dlamini and the commission's staff members.

The declaration of assets, liabilities and gifts received during the cause of their work as politicians is in compliance with Section 241 of the Kingdom of Eswatini's Constitution.

The DPM said this exercise was just meant to show transparency because people are always suspicious of what they have and if it was acquired through rightful means.

"It is this kind of exercise that is going to put people at ease. People are always suspicious of where you got your assets and how," said

He said it was important that as leaders in

government they conduct their business honesty and transparently.

"We are holding public positions and acquire assets. People will always have questions wether whatever we acquired is through rightful means and not through corrupt practices. We are thankful to the Human Rights Commission for this. These records will help us even when we acquire new assets as it can be corroborated with the information we submitted," continued Masuku.

In closing, the DPM said they are also in positions where they sometimes receive gifts from people and they have to declare those gifts because some of these presents maybe wrapped with hidden agendas in the form of favours. He said declaring the gifts would help them keep track of people who might want to bribe them.

Human Rights Commission Chairman Sabelo Masuku concurred with the DPM and said this exercise was to monitor them, adding that for it to be successful they depended on the honesty of the people declaring the assets.

"For this whole process to be done we solely depend on the honesty of the people. We will not be going around investigating people what assets they have, it is up to them to be trans-

parent," explained Sabelo.

Sabelo said if people feel there maybe assets hidden from the commission, they are free to approach the court for an order to check if indeed all the assets were declared. The declaring of assets is an exercise that is done at the beginning of the term of public officers and

two years after that and when they leave office.

"On the issue of making the assets public, we are still waiting for the Parliament to advice on that. But until then, a person who wants to know what the assets are, can file for a court order," said the commission's chairman.

BOY (14) TRACICALLY HANGS TO DEATH

A 14-year-old boy accidentally hanged himself while playing with his friend in his bedroom last Thursday.

The incident took place at Mpolonjeni, Siteki. Wandile Silindza was a pupil at St'Augustine Primary School doing Grade 4. The teen was with his 14-year-old friend acting like they do in movie scenes when they tied the rope to the roof top.

They loved acting scenes they had seen in soapies and their favourite at the moment is the South African series, Uzalo.

Information gathered suggests that before Silindza hanged himself, the friend did it first and complained that it was sore. Silindza then told his friend "let me do it," and asked him what he would do if he were to die for real.

"We were told the friend said he would call out for help," a close family member revealed.


The deceased is said to have climbed on top of a bucket they had placed and tied the rope aroud his neck. Whilst he was doing that, the friend left him as he had to attend to a call from outside.

It is said his friend left him alone as he had to attend to residents who had come for water. When the friend returned, he said Silindza

was quiet but still hanging.

The friend said he tried to shake Silindza but

he did not respond.

The friend also poured water on Silindza and that too failed as he did not respond.

The friend then went to get panga and cut off the rope.

Silindza fell to the floor and his friend tried several times to wake him up and after all his efforts were unsuccessful, he cried and called out to the neighbours.

Upon seeing that the 14-year-old was dead, the neighbours called his elder brother, Lucky. The brother said when he got home and found

his brother laying on the ground, he was too emotional but gathered himself and called his parents to tell them the news.

"Our parents were in Big Bend running some errands when I contacted them. They hurried back home and we called the police who came and collected his body," said Lucky.

Lucky said the incident shocked to everyone and a lot of people have been coming the Silindza family to offer condolences.


He said they were currently busy arranging for his burial as he will be laid to rest this week-

end

"It has been very hard arranging for the funeral but we have managed to get some tents which will be used during the night vigil and we have already paid for the casket.

"We are, although, still struggling with buying food, so we will welcome any form of assistance," said Lucky.

Chief Police Information and Communications Officer, Assistant Superintendent Phindile Vilakati confirmed that the case had been indeed reported.

FIVE TEENAGE GIRLS LIVE ALONE, WORRY RESIDENTS

ABOUT five young girls living at Mncitsini, Msunduza location in Mbabane have been forced to fend for themselves after being neglected by their parents.

After the passing of their grandfather early last year, the five girls found refuge at their grandfather's house where they are living alone.

According to sources, the girls are wild and their behaviour is wayward. They are usually spotted roaming the streets of Msunduza at night.

One source revealed that she knows the girls through her 14-year-old daughter who used to socialise with them.

The source said she told her daughter to stop socialising with the girls because she believed they were of bad influence to her and others after she had heard that they hanged out with boys in the area.

"On the 24th of December last year, I saw one of them carrying booze roaming the streets with boys. I felt like they took this behaviour after their mother who neglected them," said the source.

ource.
The source further said the girls would some-

times bring boys to the house as there was no elder living with them.

She added that one of the girls is suspected to be pregnant.

The source took the newspaper to the homestead and upon arrival, all the girls were home. They live in a back room that is surrounded by several flats.

What was gathered from speaking to them is that three of the girls are aged 15 and had started their Form One but dropped out due to lack of funds and two who are the 14 years, dropped out at Grade Seven. Four of the girls share a mother. Two of the girl's father works and resides in South Africa and the other left home to live with their sisters after their father brought a girlfriend home. The other girl is just a friend. She initially lived with her father because her mother had passed on.

Her father is married now and lives in Ngculwini. She claims she left home because her stepmother forced her father to stop paying for her school fees

When questioned how they make ends meet, the girls said they get E400 rent money plus E200 for electricity and water from the three tenants that occupy the flats.

However, they mentioned that sometimes the

tenents default paying rent and they have to ask from neighbouring residents for rice or pap.

"We then go out and pick *imbuya* (greens) or *ligusha* and we cook that," said one of the girls.

Despite their circumstances, all the girls asked for one thing, to be taken back to school. Some asked to be given the chance to re-do their birth certificates. Deputy Prime Minister (DPM) Themba Masuku warned parents against neglecting their children, stating that every person who brought a child into this world had a responsibility to take care of them.

"Parenting is a responsibility and if there are people who are found to be neglecting their responsibilities, we will take action against them. They will, therefore, answer before the court of law," said Masuku.

The DPM said parents should know that before they decide to bring a child into this world, they should know they will be accountable for everything that happens to that child.

He said the Children's Act does not allow parents to abandon their children and those who do that must face drastic consequences for it.

Masuku said the social welfare office will investigate the matter, adding that the parents would be traced down and action taken against them.

Teenage suicide real – Ndo

CLINICAL psychologist Ndo Mdlalose said the number of teenage suicide cases in the country is seemingly increasing.


She said in this particular incident, she suspects the children did not understand that these scenes from the movies were fiction and when you do that in real life you die.

Mdlalose added that the teens were not mature enough to understand how these scenes are played and that they are not real.

"Let us not take suicide lightly. This is a serious, issue and parents need to make their children understand that when they are found playing with things like these, they will be seriously punished," said Mdlalose.

She further stated that parents should talk to their children about such issues.

"Shows like WWE are now accompanied with warnings that kids should not try these at home and they should take that seriously. Let's learn and be able to address such things in our homes," she said.





List of private schools approved by govt

THE list of private schools expected to operate in Eswatini this year has been released.

These include pre-schools, primary and high schools. Out of 216 schools only three have no authority to operate, 24 were full closed and the rest either have full or provisional author-

ity

Director of Education in the Ministry of Education and Training Dr. Lenhle Dlamini warned parents to be wary of non-registered private schools.

She said parents had a right to request a letter from the ministry approving or authorising a school to operate whenever they look for space in schools.

Dlamini added that should parents fail to get space for their children, they could engage the regional education offices (REOs) for assistance.

"We don't have the list of non-complying schools as yet because the school calendar starts next Tuesday, we can only rely on what we had last year.

Surprised

"Only then will we be able to check if all the schools have met the minimal standards. The REOs will have the information. I was surprised when I came back from Lesotho to find that there was a list published supposedly endorsed by me," she said.

Adding, she said it was a crime for any school to operate without being authorised by the ministry.

"Should any school be found to have flouted the rules, necessary measures stipulated by the ministry will be taken against that school, she said.

Dr. Dlamini further mentioned that the minimum requirements include toilets that have been approved for usage, water, fencing ound the school, classrooms, qualif determined curriculum feeding schemes arrangement in primary schools and laboratories in high schools.

"At times we give what is called provisional licence which is valid for a year while we finalise processes with that particular school.

"We plead with the nation to alert us should they suspect a school to be operating illegally," she said.

Ministry changes logistics management system

APART from the delayed payment of suppliers, the ministry of health believes the drug shortages in hospitals are caused by the discrepancies in the supply chain management system.

In a bid to address the shortages of drugs in hospitals and health centres, the ministry is in the process of replacing the current logistic management system (Commodity Tracking System) with a new system called the electronic Logistics Management System (eLMS).

Nurses, on the other hand, believe that the new system will not resolve the shortages unless government pays suppliers.

Minister of Health Lizzie Nkosi said until the system had been overhauled and a new one put in place, the shortages would persist.

For this reason, the ministry is currently engaging a consultant to assess how best to install an electronic system that will allow the Central Medical Stores (CMS) and entire supply chain management stakeholders to see the stock in real time.

and find a wayforward.

"Systems are improved all the time. The one we are using also needs to be improved. The researchers are looking into the changes that could be made.

"Until we have a system where we can all see how much stock each facility has in real time, the shortages will continue," she said.

The minister said the assessment is expected to be completed by January 22 (next Wednesday). Information gathered suggests that the system has already been piloted and may be linked to the client management system.

Opposed

The current shortages are believed to be partly caused by the fact that the current inventory management system at the Central Medical Stores is not synced to those of the facilities. As a result, it takes a month for the CMS to get data on the amount of stock in each facility as opposed to the real time or on a daily basis.

Sources close to the matter said the CMS was currently relying on the reports and orders made by the facilities on a monthly basis, whereas the new system is expected to be linked to the facilities and thus report immediately when the drugs are dispensed to clients.

"The system that will be installed will immediately allow the CMS to monitor the drugs online and in real time.

"Where there is poor internet connection, the information would be updated on the next day," a source revealed.

The source stated that the rolling out of the new system might take a while as there were several processes involved, including the training of the officers and the consideration of the recommendations of the team that is carrying out the assessment.

The Swaziland Nurses Association

(SNA), on the other hand, emphasised that government should settle its arrears as they believe that the shortage of drugs has nothing to do with dispensing challenges, but it has to do with the health care financing model as government was owing suppliers.

SNA President Bheki Mamba said the notion that the drug shortages resulted from the logistics management system was a fallacy as the real cause was the late payment of suppliers, which the ministry also admitted in its reports.

"There are no drugs in hospitals because government owes suppliers hence they no longer supply drugs.

The allegations that the medicines are stolen are unfounded. Why are the people stealing them not arrested? Are they in all the facilities?

"The introduction of a new system will not help as there are no drugs to be monitored. We are at a point where we do not have money to procure medicines. Government has admitted to owing suppliers to the region of E400 million," he said.

The ministry has always listed the shortage of drugs as one of its major challenges, which was attributed to the late payment of suppliers, according to the ministry of health quarterly report.

"Among the major challenges faced by the ministry is the shortage of drugs, delayed payment of service providers, frequent shortages of fuel and breakdown of facility transport and shortages in human resources," reads the report.

The shortage of drugs had been reported to be a national challenge for the ministry as all the health facilities have reported frequent drug stock-outs.

"While most patients were negatively affected, highly impacted patients were those on psychiatric medication, which stocked out for longer periods and those taking anti-hypertensive treatment.

The main cause for the stock-outs is failure to pay suppliers on time due to the fiscal challenges faced by government," further reads the 2019 first quarter.

Delayed

On the other hand, the delay in the payment of service providers also saw most of the health facilities running out of supplies as well as companies withdrawing their services.

Most facilities have been negatively affected by the delayed payment and subsequent withdrawal of services by service providers.

"This includes catering, security, servicing of medical equipment, immunisation, external referrals, CMIS rollout, cleaning materials, protective supplies, etc. This has negatively affected the provision of health services thus reducing the quality of patient stay at facilities.

"Some of the most affected facilities are Mbabane Government Hospital and Nhlangano Health Centre, particularly with regards to catering and security," further reads the report.

SITEKI SUSPECT SERIAL RAPIST TO PLEAD GUILTY TO EIGHT COUNTS

NKOSINATHI Alucious Nkonyane (39), who stands accused of committing a string of rape cases around Siteki, has told the court that he will be pleading guilty to all the charges.

Nkonyane faces eight charges ranging from rape, robbery and house-breaking.

He was apprehended by members of the public, who responded to an alarm raised by one of the survivors on November 27, 2019.

Contravening

The accused person made his second appearance before Principal Magistrate Dumisani Magagula yesterday. Amongst the charges he faces is that of contravening Section 3 of the Sexual Offences and Domestic Violence Act of 2018.

He is alleged to have committed an unlawful sexual act upon a 30-year-old woman. The charge is accompanied with aggravating factors in that the accused person threatened to stab the complainant with a knife if she resisted



to his demand.

On another count, the suspect allegedly committed an unlawful sexual act on a 12-year-old girl. The accused person is alleged to to have strangled the girl as he committed the offence.

On two other counts, the accused person is alleged to have attempted to rape two women on separate incidents. He is said to have strangled the women and ordered them to undress.

Luckily, the women managed to escape after raising an alarm.

On another count, the accused person is charged with robbery.

He is alleged to have wrong-

fully and unlawfully robbed a woman of Moyeni of her items valued at E950.

The accused person is said to have strangled the complainant and further threatened to stab her if she resisted to the robbery.

During his court appearance yesterday, the accused person was asked how he intended to plead to the charges and he stated that he would plead guilty.

The accused person, however, asked the court to give him time so that he could get the services of an attorney. The matter was, therefore, postponed to next Monday, pending setting of a date of trial.


THE ministry of education and training has released a list of schools where parents can use MTN Mobile Money to pay for their children's school fees on top of other payment options.

he Eswatini Electricity Company (EEC) has a more reason to celebrate in 2020 having completed 20 years as a partner in the Mozambique Transmission Company (MOTRACO) and also settling a E212.7 equity loan with the European Investment Bank (EIB).

MOTRACO is a joint venture between Eswatini Electricity Company (EEC), Electricidade de Mozambique (EDM), and Eskom of South Africa. The principal objective of the joint venture was to establish a 400kV power transmission system in order to facilitate the wheeling of electricity from South Africa to the Mozal Aluminium Smelter in Maputo, Mozambique.

It has been more than 20 years already since MOTRACO was established. This transmission project was conceived at a time when EEC was still battling with several challenges including, but not limited to,

at transmission level, transmission constraints and general voltage drops that were being experienced in the power supply system. Several options were considered by the company at that

EC Managing Direc-tor Meshack Kunene stated that this achievement is one of the company's greatest milestones over the past two decades, particularly considering the potential risk of default bearing on this loan facility.

"We are very proud to have finally settled this long-standing obliga-tion despite facing some difficult challenges over the past 20 years," Kunene said.

He mentioned that the drought experienced over the years compounded with persistent harsh economic conditions had a huge impact on EEC's profitability and this could have easily affected the company's ability to maintain its obligation in relation to the sinking fund.

Kunene further stated that the conditions of the loan were that EEC would have to make a single payment at the end of the maturity of the loan.

Kunene further explained that the variable portion of the loan obligation was determinable based on the loan obligation was deven by the loan obligation was determinable based on the loan obl equity valuation of MOTRACO. The purpose of the valuation was to establish the post-acquisition value of the company's equity in June 2019 of which EIB was contractually entitled to share 50% of the portion attributable to EEC.

"After a series of engagements and negotiations, EIB finally accepted a valuation report of MOTRACO and on the basis thereof further accepted a sum of Eur4,5 Million in full and final settlement of the variable portion of the loan obligation. Effectively, this then brought the total amount paid to EIB to Eur12,7 Million," Kunene said. He added that the EEC Board was satisfied with arrangements made to mitigate a green light to work on finalising the loan obligation.

Kunene expressed his appreciation to Government as EEC's shareholder for the vision and foresight displayed by endorsing this initiative, which has already proven to be a good investment for both EEC and the



While EEC was to pay nothing until the maturity of the loan facility in 20 years, there was always a lingering risk of default owing to the bullet nature of the repayment. The company adopted a sinking fund strategy for purposes of accumulating the required foreign currency amount to redeem the loan when it fell due.

This arrangement was necessary in order to proactively manage the default risk on maturity of the loan facility which the financier would not tolerate. Twenty years later (June 2019), the EIB loan facility matured, the sinking had accumulated adequate resources to extinguish the loan. EEC paid to EIB a total of E212.7 million (EUR12,7 million) in full redemption of both the principal amount and the variable obligation as determinable from the MOTRACO equity valuation report. This is one single payment that

joint-venture agreement, the shareholding was split equally between the three investing parties. Each company then had to contribute one-third of the USD39.5 million required equity to acquire its stake on the project. EEC was also to benefit immensely

MOTRACO therefore imports energy for direct sales to Mozal on behalf of EDM, EEC and Eskom through a 400kV line that cuts across the shareholder countries

ability of the MOTRACO 400kV line has benefited EEC immensely in that it provides an inter connector with the Southern African Power Pool (SAPP).

he would be stabbed.


Mkoko then placed a knife to Magagula's throat and robbed him of a navy blue hat valued at E100 and E300 in cash.

SPEED UP ESTABLISHMENT OF **DISABILITY COUNCIL - FODSWA**

THE Federation of Disabled People in Eswatini (FODSWA) has urged government to speed up the process of setting up a National Disability Council.

FODSWA President Sipho Dlamini said the council should have been appointed by now as the National Disability Act was passed in August

He said there were programmes that need to be unpacked in the Act and without the council it is very hard to do that.

Dlamini said the council would look into all issues of disabled people such as their rights, grants and other socio-economic aspects.

He said currently, there was no specific structure dealing with those issues and it is government's role to set up the council.

"It has been long over-due and we urge the government to act swiftly in appointing the National Disability Council which is outlined in the National Disability Plan of Action," Dlamini

He added that without the council, a lot of programmes had fallen behind and this is making it difficult for the stakeholders to carry out their

He said it was also hard for his organisation to diligently carry out its various initiatives of empowering people with disability.

He added that the council will have the power

to solicit funds on behalf of the disabled people, mobilise resources and work hand-in-hand with the relevant stakeholders such as FODSWA and other bodies.


"Not only that, the council will work closely with the ministry of finance when crafting the budget for disabled people," he said.

On another note, Dlamini said currently, there was confusion on the grants received by disabled people.

He said disabled people are not getting disability grants but social grants. This is because issues for disability are handled by the social welfare department within the deputy prime minister's office.

The DPM's office Under Secretary Hlobsile Dlamini said the council could have long been established but the problem was the financial challenges facing the country.

"Once the ministry of finance gives us enough money, the council can be set up," she said.

However, Dlamini mentioned that the office of the deputy prime minister presently works with associations and other structures that deal with issues of disability.

SANU SRC RUNS TO COURT

WITH the prolonged delay to conclude a disciplinary hearing for Southern African Nazarene University (SANU) Student Representative Council (SRC) executive, the president and secretary general have sought the court's intervention.

The SRC's Tholumuzi 'Gubevu' Simelane and Colani the President and Secretary General, respectively, have filed an urgent application in court seeking an order for SANU to set aside the suspension imposed on them and another student who is not a member of the SRC, Sibusiso

The application was filed yesterday at the High Court. Simelane, Maseko and Nkwanyana were the first, second and third applicants while the university and the Vice-Chancellor Professor Winnie Nhlengethwa were cited as first and second respondents, respectively.

The trio was suspended from the university on November 11, 2019 along other members of the

The rest of the SRC members had been called

for a hearing before the tribunal and the verdict was issued on December 17, 2019 where they were all found not guilty of the charges levelled against them.

However, to date Simelane, Maseko and Nkwanyana have not yet been informed of their disciplinary hearing date.

Nkwanyana's hearing was set for January 9, but it was later postponed. Since their suspension was indefinite, the three students missed the final examination of their first semester written in December.

Also, the students said with their academic calendar having resumed yesterday, they pleaded with the court to allow them to return to class.

Further, the students prayed that the vice-chancellor allows them to write all class tests and first semester examinations they missed during the period of their suspension.

In December, the trio, through their lawyer Thembinkosi Xaba of Xaba Attorneys requested SANU in writing, to allow them to register for the second semester which begins today.

The letter also stated that the institution should respond in writing before December 31, 2019. SANU was expected to respond to the present application by close of business yesterday.

Drastic changes in autistic children

Parents experiences

The case of Sandile Mabilisa, who has an autistic child aged five, said it started when his son had just turned two and had a seizure.

"It was the first time it had happened but it later stopped. It only came back when he was three years old as he suffered more seizures forcing him out of school," he said. Mabilisa added they took their son to several hospitals and the seizures stopped for a while and at this point, his son looked physically and mentally confused.

He stated that they heard of the Autism Programme that Desiree Alexander had and took him there and since then they have seen quite a drastic improvement in their son as the seizure attacks are now less.

As a Christian, Mabilisa said they have taken their son to pastors for prayer and that too has helped them, but he strongly believes that the therapy Desiree provides is impressive.

Another parent who preferred to remain anonymous, said their seven-year old boy was able to speak but had challenges in writing and being generally sociable. The parent noted that ever since they signed him up at the school their son has also improved such that he will be going back again this year.

"Desiree is very good with the children, she treats them with extra care and I would encourage every parent who has an autistic child to take them there as they will not regret it. All parents who feel like they have lost all hope should just take the chance and just try her out," advised the parent.

Another parent concurred, saying her five - year old boy has also improved drastically. "My son was still on a nappy when he turned five but after I took him to Montessory he stopped using it and responded very well to the sessions," said the proud parent.

One of the teachers assisting Alexander, Phumlile Mkoko said what they basically do was to rewire the children's brains so that they are able to go back to school.

Mkoko said in the thee years she has been at Montessory, she has seen so many children improve, especially in their speech.

Autism centre almost ready

BRINGING up a child with autism can be challenging for parents, especially when other people do not understand the issues.

The Manzini Municipality has therefore built a centre that aims at assisting both autistic children and their parents.

Situated in Manzini, Fairview just past KaMthunyelewa Complex, the centre will deliver on support services that parents were

unable to get easily.

Public Relations Officer for the Manzini
Municipality, Mathokoza Thwala said the
centre will provide Autism Spectrum Disorder
therapy services for children suffering from
the disorder, as well as counselling services
for their parents as it can be stressful raising
a child with the disorder.

"The Autism Centre is not yet operational.

We're still tying up a few loose ends but are hoping that it will be operational soon," said Thwala.

DESIREE Alexander, who works at Panorama Montessory in Mbabane offers a programme for Autistic children.

Alexander, who has a Diploma in Speech and Language and a Diploma in Good Practice and understanding Autism and Interventions, said autism spectrum disorder conditions affect social interaction, communication, and behaviour. The impact can range from mild to severe.

It mostly appears in early childhood, and normally continues into adulthood. Some people with autism spectrum disorder are highly gifted in a specific field.

Alexander said the programme offered at Montessory, combines the therapeutic value of listening and sound therapy with specific visuals and balance activities, the combination trains the brain to process and manage multi-sensory input, and unlocks hidden physical and mental abilities.

"The programme improves the concentration, cognitive skills such as reading, writing, auditory processing movements and coordination, process speed, energy, confidence, mood, behavior, reduces stress and anxiety, organisation and speech," she said.

According to Alexander the programme used basically raises fine hairs in the ear, it is research based and scientifically proven. Some children recover up to 70 per cent depending on how soon they were diagnosed and brought in for therapy and interventions.

"So depending when a child starts with the intensive intervention, we cannot say how long they will progress or recover. We have, however seen some children show significant improve-

ment within a month.

"Sleep patterns improve dramatically, outburst and meltdowns start to disappear, calmness replaces anxiety. Only then can any form of learning (academics) start to take place," said Alexander. She advised that learning should never be rushed particularly at pre-school going age and added that best results are seen when the child learns through playing. Alexander claims children learn through a lot of indoor and outdoor playing, not teacher directed.

The good news is that the situation for children with autism and their parents is slowly changing, thanks to increasing awareness about the disorder, complemented by the efforts of affected families to band together to share information and experiences. A few parents who have seen quite an improvement in their children have spoken up and would like to encourage other parents as well to not lose hope.

As schools opening is nigh, parents have been warned against inscribing names of their children on the outside of their backpacks as this may expose them to kidnapping and more likely human trafficking.

The warning that has been circulating on social media states that when the names of the children are clearly inscribed on the backpacks, kidnappers, rapists and murderers may easily lure the children into believing that perpetrators know them as they may call them by their names after noticing it from their backpacks. Parents, according to the warning have been advised to write the names of their children in the inside of their backpacks.

"Please do not write the names of your children at the back of their school bags as these innocent souls may respond positively when called by perpetrators with the hope that the criminals know them please relay the message to other parents and save our children," reads the warming.

When sought for comment as regards the matter, Chief Police Information and Communications Officer (PICO) Superintendent, Phindile Vilakati said this was true and sternly advised parents against writing their children's names on their back packs.

"With schools opening, most children will be wearing backpacks. Never put your child's name on their backpack where a stranger can see it, children may be attracted in going with someone if they know their names," said Vilakati.

She further advised parents to be cautious when sending children to school by telling their children not to speak to any strangers for them not to fall prey to perpetrators of such crime.

We were lured into soldier's house - Suspect

Three women have been arrested for breaking into a house and stealing items valued at over E14

The trio is said to have broken into UEDF member Futhi Dlamini's house at Elangeni and went away with the items while she was at work.

Dlamini got the shock of her life when she received a phone call from her boyfriend, stating that her house at Elangeni had been burgled.

What she did not expect, was that her sister Zandile was the master mind behind the break-in.

'After receiving the call from Menzi Masango, I left the army barracks and rushed home and dis-

covered that the lock on the door had been tampered with, when I walked into the house, I noticed that most of my electronic appliances had been stolen. That was when I approached the Lobamba Police Station to report the matter," Futhi stated.

Exempt

However, in a dramatic turn of events, when Zandile, along with Siphesihle Madzinane and Nomfundo Sihlongonyane were nabbed for the housebreaking, Sihlongonyane decided to turn against her accomplices and turned accomplice witness and testified against Madzinane and Zandile. An accomplice witness is an accused person who is a participant in a alleged crime before, during, or after its commission, and is exempt from prosecution for the offense committed. Sihlongonyane

told the court that Madzinane approached them the previous night, with Futhi's house keys in her hand.

"She invited us to go into Make Futhi's house and take her valuables. She promised each of us that we would get a share of the takings and we obliged.

Anxious

"After several attempts to insert the key, we managed to enter the house. We took items ranging from a KIC fridge, television set, microwave, kettle, toaster and even bedding. If we could have taken Make Futhi's bed, we would have.

"We then loaded the items into Madzinane's boyfriend's van, which seemed to have appeared out of nowhere," Sihlongonyane claimed.

Sihlongonyane recalled that after they had loaded the items, Madzinane told them that she would be taking

the fridge and television set and nine cases of beer, and Ncane Zandile and I could pick what was left. However, I decided not to take the items, as I was anxious about being found in possession of the goods by police officers," she stated. After their arrest, it was discovered that the trio had stolen various items including a KIC fridge worth E3 500, television (E4 500), 15 frozen chickens (E600), nine cases of beer valued at E1 300 and other items. The total value of the items stolen by the trio amounted to E14 195.

Bizarrely, an amount of E2 000 in cash was said to have been one of the items stolen from Futhi's house, which all the suspects stated they were not aware of. The matter continues as the prosecution is to make its closing submissions at a later date.


want them to eat, rather than asking them to avoid the foods that may irritate them.

Suggestions for lunch boxes

There are lots of food choices available for lunch boxes. However, it can sometimes be difficult to decide which foods are healthy choices. We have come up with suggestions on what do always have in your child's lunch-box.

- Fruit Best choices of fruit are just fresh fruit, be it from the market or from the store, the trick is that it must be fresh fruit. Dried fruit is sticky and high in sugar and it also has very high content in sugar, are low in fibre and stick to children's teeth causing tooth decay.
- Vegetables Because children aren't usually big fans of vegetables, try vegetable sticks with a dip or a small container with mixed vegetables such as tomatoes, carrot sticks, and cucumber. Packets of crisps are best left for parties and special occasions.
- · Milk, yoghurt and custard -Include a small drink of milk (freeze overnight) wrapped in a cloth in the lunch box. Fruit yoghurts should be kept cool in an insulated lunch box. Best left out of the lunch box are 'dairy desserts' and flavoured milks, which are high in sugar.
- · Dips, cheese and biscuits Pre-

packaged or your own homemade versions of cheese and crackers are

Children enjoy mini packaged cheeses. Avoid sweet dips such as chocolate spreads. 'Oven-baked' savoury biscuits are just as high in salt and fat as chips and are best avoided.

 Different breads add interest – Include a variety of bread, especially if children begin to lose interest in sandwiches. Try bread rolls, buns, scones, or muffins.

 Muffins and cakes – Try making your own muffins and cakes as a great way to not only save money, but to also include more fruit and vegetables.

Examples include carrot, banana

r pumpkin. Doughnuts and creamy cakes are best offered at special occasions instead of in lunch boxes.

· Muesli and 'breakfast' bars -Almost all 'bars' are too high in sugar to include regularly, but cereal bars may be better for teeth than chewy sticky muesli bars. Try to avoid muesli bars and chocolate bars in lunch boxes. These are expensive and usually stuck together with fats and sugars.




ESWATINI's current account balance is projected to stand at E3 422 872 500 (0.237 USD billion) in December 2024.

This is contained in the CEIC data/forecast collection report by International Monetary Fund (IMF)-World Economic Outlook.


Eswatini's current account balance was forecasted to be E1 689 772 00 (0.117 USD billion) in Dec 2019 and it recorded an increase from the last reported number of E1 357 595 000 (0.094 USD billion) in Dec 2018.

"Looking ahead, Eswatini's current account balance is projected to stand at 0.237 USD billion in Dec 2024," reads the report.

The data is updated yearly and is categorised in CEIC under World Trend Plus's Country Forecast – Table IMF.WEO: BPM6: Current Account: USD.

December 2019 headline inflation rate at 2.0 per cent

THE headline inflation rate in December 2019 for the country is 2.0 per cent, which is 0.2 index points higher than the corresponding annual rate of 1.8 per cent observed in November 2019.

This is the annual percentage change in the Consumer Price Index (CPI) in December 2019 compared with that of December 2018).

According to a report released by the Central Statistical Office, the month on month inflation rate, which is the percentage change in the CPI in December 2019 compared with that of November

2019) was 0.3 per cent.

The higher headline inflation was due to increasing annual rates of change reflected in December in the price indices for:

The report highlighted that miscellaneous goods and services which increased from 1.0 per cent in November 2019 to -0.6 per cent in December 2019 while personal effects (namely jewellery, clocks and watches); and personal care (such as electric appliance)

ances for personal care) contributed to the higher index in this category.

Also contributing was housing, water, electricity, gas, and other fuels, which increased from 0.2 per cent in November 2019

"Alcoholic beverages, tobacco and narcotics which increased from 4.9 per cent in November 2019 to 5.2 per cent in December 2019 as well as tobacco; and alcoholic beverages,

such as spirits and wine, mainly contributed to the increased index in this category.

ANC blasts Mboweni for tweet opposing Reserve Bank's nationalisation

JOHANNESBURG - The ANC has censured finance minister and senior member Tito Mboweni for saying the party's resolution to nationalise the Reserve Bank was a mis-

Mboweni made his position known on social media on Tuesday when he tweeted that he was not behind the ANC's decision to nationalise the central bank. The ANC come out guns blazing on Wednesday against Mboweni, suggesting that his statement fed into the narrative of a lack of policy certainty.

In a strongly worded statement, ANC spokesperson Pule Mabe expressed concern over Mboweni's public posture on the bank, especially as he held a position in the economic cluster.

"It is our view that comrade Tito should act with care and be cautious at all times on matters of policy given his position as the minister of finance, including subjecting himself to the overall communications protocols of the African

National Congress.

"Those who serve in leadership structures of our movement, especially within the national executive committee (NEC), the highest decision-making body in-between conferences, are expected at all times to uphold and defend resolutions of the ANC on public platforms," said Mabe. Mboweni had earlier tweeted: "As a longstanding member of the ANC and its leadership structures, I know and understand our resolutions.

"I don't need lectures on that. But on the SARB, I am convinced that we adopted a wrong resolution. What do we want to achieve? Our strategic focus: structural economic reforms."

Mabe took the opportunity to remind Mboweni that ANC branches determined policy positions and that elected ANC leaders were not free-lancers but remained bound by the overall prescripts of the organisation.

"Only the national conference has the right

and power to review, ratify, alter or rescind any decision taken by any of the constituent structures, committees or officials of the organisation," he said.

The ANC added that all party members in good standing were entitled to take full part in the discussion, formulation and implementation of the policies of the party through appropriate internal platforms.

Mabe encouraged leaders and members of the ANC to raise debates within the confines of the structures and discipline of the party.

"Any public statement by a leader of the ANC questioning the wisdom of a national conference outside formal structures has the potential to create confusion within and outside the organisation. The constitution of the ANC enjoins only the president as the political head to make pronouncements for and on behalf of the NEC, outlining and explaining the policy or attitude of the ANC on any question." *TimesLive*

Grabbing the bull by its horns to grow Eswatini economy

"THE Kingdom of Eswatini has made encouraging strides in housing and health provision in recent years, as well as in improving the education system.



Organisation's governing body. "As with many other developing countries, we have our challenges. Along with the global economy, ours has been hard-hit, forcing us to make tough but necessary decisions. "The Eswatini Strategic Roadmap 2019-2022 flows from the directive given by King Mswati III to the incoming government administration, in collaboration with all Emaswati, to work tirelessly to revive the economy in the shortest possible time.

"The challenges facing Eswatini include unemployment, poverty, sustainable economic development, provision of quality health services, education and social welfare for all Emaswati. "The strategic roadmap is a culmination of extensive research and consultations on feasible quick wins, combined with long-term goals. It aims to introduce a new range of measures that have the most potential to kick-start the journey to economic revival and inclusive growth, taking along Emaswati at home and abroad.

Rejuvenate

"Coming into office in November 2018, it was clear that something urgent needed to be done to rejuvenate the economy. Government revenues are lower than expected and expenditures are continuously increasing. This is driven by declining receipts from the Southern African Customs Union (SACU) and ever-increasing govern-

ment expenditure.

"Despite this downturn, we are projecting an increase in SACU receipts in the coming year. This, however, is not enough to stem the tide, and more needs to be done for the country to return to sound economic health.

"Much as we are encouraged by the projected increase in domestic collections by the Eswatini Revenue Authority for the financial year 2019-2020, these will not be sufficient to offset the arrears accumulated over the years. The collections will not be sufficient to meet the government's finance requirements for the fiscal year. We share and acknowledge the IMF's concerns with regard to government spending on certain items. These, together with historic challenges to the economy, demand that certain tough decisions be placed on the table for consideration.

"The expansionary fiscal position has surpassed sustainable levels, resulting in the accumulation of arrears, increased depletion of reserves and constrained growth. Potentially unpopular decisions and sacrifices will have to be made to ensure we table a fully financed budget.

Unsustainable

"The country must take the necessary measures to curtail expenditure while looking for creative ways of enhancing government revenue. In simple terms, the country cannot afford to spend what it does not have, or hopes to have in future. It is patently unsustainable that the public wage bill makes up about 37 per cent of the budget. It is plain to see why urgent work needs to be done, and is being done. The public service needs to be streamlined to ensure a culture of excellence across sectors.

"The government has identified five areas as critical to our country's economic recovery. These are agriculture, manufacturing and agroprocessing, energy and mining, tourism and the ICT and education sector. "With regard to tourism, Ezulwini will soon have a new five-star hotel and an international convention centre to add to the attractive tourist destination our nation is renowned for internationally. To prepare for future energy needs, the government has commissioned a study into the use of thermal and solar power as alternative energy sources. "These, along with improved

broadband penetration and the expected reduction of the cost of data, give promise that efforts to take the country down the digitisation path and clean technologies are well on track.

"Rejuvenation of an ailing economy needs a strong criminal justice system to identify and punish those who seek to enrich themselves through criminal means. As an addition to existing law enforcement agencies, the kingdom has established an asset recovery unit to trace and reclaim the proceeds of crime, including corruption.

"An economy can only grow with the nurturing of the nation's next generation of entrepreneurs. That is why the kingdom has relaunched the Youth Enterprise Revolving Fund to encourage young entrepreneurs to start businesses and create employment. This is in addition to the normal university scholarships across various disciplines that the government offers to deserving students.

"Eswatini is not only open for business but is also committed to play its role in ensuring lasting stability in the region and on the continent. The Kingdom of Eswatini is acutely aware that the success of its plans is partly dependent on partnerships with governments and foreign direct investment."

South Sudan, holdout rebels commit to truce this week

JUBA - South Sudan's government and opposition groups, who had snubbed an earlier peace deal, said they had agreed to a ceasefire from yesterday after peace talks in Rome.

Members of the South Sudan Opposition Alliance (SSOMA) and an envoy of the government in Juba said they had signed a document on Sunday committing to a December 2017 peace deal to "avoid any further armed confrontation across the country".

South Sudan, the world's youngest country, descended into civil war in 2013 when President Salva Kiir accused his former deputy and fellow former rebel leader, Riek Machar, of plotting a coup.

About 380,000 people have died in the conflict and about four million have fled their homes.

Fears have grown in recent weeks that a fragile peace deal will not hold after ongoing disagreements and delays in implementing a unity government.

While peace has largely held across the country, fighting has continued in the Central Equatoria region between government troops and the National Salvation Front, whose leader, Thomas Cirillo Swaka, signed the agreement in Rome.

"We are ashamed this peace has eluded us," Pa'Gan Amum Okiech, a member of SSOMA's leadership council and interim chairperson of another rebel group, the Real-APLM group, said on Monday.

"We agree to begin this process of dialogue to reach comprehensive solutions to the crisis," Amum Okiech told journalists, stressing those solutions would be "inclusive."

Progress on a more recent agreement in September 2018 calling for Kiir to form a transitional unity government with Machar has been delayed over a host of unresolved issues.

Rebel groups within the SSOMA refused to sign it because it did not address "root causes" of the war, Amum Okiech said.

Sticking points include the return of refugees, the integration of rebel forces into the army, and land issues, such as compensation for the destruction of property during the conflict.

Machar is due in Juba on Tuesday for another round of talks with Kiir. *AFP*

Libya's Haftar leaves Moscow without signing peace deal

MOSCOW - Libyan strongman Khalifa Haftar left Moscow on Tuesday without signing a ceasefire agreement aimed at ending nine months of fighting, leaving the future of a fragile truce uncertain.

The commander's abrupt departure in the early hours of Tuesday was a setback for an international diplomatic push in recent days, though Moscow insisted it would continue mediation efforts.

Turkish President Recep Tayyip Erdogan -- who first brokered the Libya truce deal with President Vladimir Putin of Russia last week warned he would "teach a lesson" to Haftar if his forces resumed fighting. Haftar and his allies were in Moscow on Monday for talks with the UN-recognised government headed by Fayez al-Sarraj

that is based in Tripoli.

Sarraj's government has been under attack since last April from forces loyal to Haftar, who is based in the east of the oil-rich North African country with his own loyalist politicians. The two sides had agreed to the ceasefire that took effect at the weekend and were in Moscow to sign a long-term agreement.

The talks raised hopes of an end to the latest fighting to wrack Libya since a 2011 NATO-backed uprising killed longtime dictator Moamer Kadhafi.

But after seven hours of negotiations, only Sarraj had signed on to the agreement and Russian officials confirmed to AFP that Haftar's delegation had left without inking the deal.

Nagy's visit will also highlight the 10th anniversary of the Young African Leaders Initiative which engages the next generation of leaders by facilitating connections with their peers across the continent and in the United States.

'Boyfriend smoked tik before gruesome murder'

CAPE TOWN - The mother of a 16-monthold baby who was allegedly stabbed to death by her 33-year-old boyfriend said the accused had smoked tik with a friend the night before the incident.

Nadia Saayman, the mother of baby Alime Mbasha, on Tuesday spoke about the incident that led to the death of her daughter last Thursday at Buffelsjag farm in Swellendam.

Her boyfriend, Siyabonga Mbasha, better known as Moffit, was arrested shortly after the incident and has been charged with the murder of his child.

Saayman said: "The trouble started on Wednesday when my boyfriend and a friend smoked tik for most of the night.

Siyabonga worked at another farm in Witsand some kilometres away from Buffelsjag, where I stay, and I didn't want to move with him to

"On Thursday afternoon, he started to get angry. He got hold of a knife and I fought with him, trying to get the knife out of his hand. I cut my hand in the process and started running out of the house.

"He ran after me and tried to stab me. I remember Alime was in the room. My granny saw him coming out with the baby.

He stood in the door holding a knife at Alime's neck.

He walked towards the gate holding the baby by the leg, twice dropping her to the floor before he slit her throat and stabbed the baby in the chest in front of my granny."

Gielie de Kock, the owner of Witsand where the accused worked, said:

"Moffit worked for 14 years in the milk parlour on the farm.

"He had the potential to be one of the best workers. But he had a drug problem." Cape Argus

AZENATHITAKES ONHISFATHER

JOHANNESBURG - A group belonging to the abaThembu nation based in Msinga, KwaZulu-Natal (KZN), has thrown its weight behind acting King Azenathi Dalindyebo to continue as head of the kingdom.

This despite King Buyelekhaya Dalindyebo, who is Azenathi's father, preferring one of his wives, Queen Nokwanda, to take over the reins as regent.

Tensions between Dalindyebo and his son were laid bare a day after the king was released from prison last year, when he refused to see Azenathi, who had visited him at his Nkululekweni private residence in Mthatha, Eastern Cape.

On Thursday, Azenathi called a meeting of the entire abaThembu nation, which included the amaDlomo (the core royal family), iinkosi (traditional leaders) and abaThembu in general, to discuss the way forward.

Dalindyebo and those seen as being close to him did not attend.

A number of abaThembu leaders who attended the meeting at Bumbane Great Place, which is being occupied by Azenathi and his royal council, said they supported Azenathi's leadership because it had brought stability to the nation.

Vusi Mvelase, Chairperson of the abaThembu in Msinga, criticised the amaDlomo for bringing the nation into disrepute and called for Azenathi to continue as acting king or be appointed permanently as king, a statement that is sure to further divide the nation as Dalindyebo still enjoys support within abaThembu.

"As abaThembu in KZN, we wish that you [Azenathi] continue as king because we have seen the great work you have done in bringing stability to the nation.

"People hate us in KZN because of our allegiance to you as abaThembu. When we invited King Buyelekhaya to visit us in Msinga some years back, Zulu King Goodwill Zwelithini had harsh words for us, saying that we were bringing a king from another nation to his kingdom. But it was because we wanted to show that, even though we are in KZN territory, our king is that of abaThembu," said Mvelase.

He said they were aware of attempts to replace Azenathi and appoint Queen Nokwanda in an acting capacity.

"We came all the way from KZN because we are part of this nation. This is not a kingdom of amaDlomo, but of the entire Thembu nation." Myelase called for amaDlomo to support Azenathi.

"For the first time, the kingdom of abaThembu is in good hands. Keep it up," said Mvelase, directly addressing Azenathi. His words were met with applause.

Azenathi started his speech by hailing his father by his praise name, saying: "Ah! Zwelibanzi!"

He confirmed that he and a group of senior traditional leaders had been turned away at the gate when they tried to visit the king in Nkululekweni on December 24.

'Mama Gumede is an honest person'

JOHANNESBURG - Supporters of embattled former eThekwini mayor, Zandile Gumede, hope that the case against her will be kicked out, maintaining their belief that the tender corruption case is politically motivated.

Speaking to News24 on Tuesday ahead of Gumede's return to court yesterday, Mzomuhle Dube said Gumede's support was growing.

"We are saying that we have reached a level. People must begin to understand, if they had a case, they would have charged her properly. What we are saying all along is happening. The National Prosecuting Authority has been unable to present any concise charges," said Dube, a loyal Gumede ally, who is also the coordinator of her supporters.

"We have had smaller build-up events [before] the court appearance tomorrow. People are starting to see that all is not like it seems. Mama Gumede is an honest person and a good leader. We are expecting a large crowd tomorrow."

They also hosted a vigil outside court late on Tuesday night.

"She is a recognised leader and people want to come out to show their support. When we spoke this week, she said she was ready for anything." Dube said they denounced the handling of the corruption case against Gumede. He felt her involvement in the case was not yet fully

explained.

"In her last court appearance, the State failed to present specific charges regarding her involvement in the case. Up to today, we have not heard the State putting charges to her."

"We will continue supporting her. Her support is growing. We are preparing for a regional conference. We feel she is poised to reclaim her leadership." In December 2019, the Hawks arrested seven more people, including four councillors, in connection with the allegations, which relate to a R200m Durban solid waste tender. News24

I received no NECSA board resignations - Mantashe

JOHANNESBURG-Energy expert and EE business Intelligence MD Chris Yelland dropped a bombshell on Twitter yesterday morning, saying the entire board of the Nuclear Energy Corporation of South Africa (NECSA) has tendered its resignation to Mineral Resources and Energy Minister Gwede Mantashe.

Yelland revealed that the five board members, including the chairperson, resigned, due to the "dysfunctional" relationship between NECSA and Mantashe. This was due to "his apparent unwillingness to address the deep financial problems facing NECSA," Yelland said.

Mantashe, however, said that he had not yet received any resignations from the board. according to Fin24.

The minister was attending a briefing session at the Bonginsimbi Comprehensive School in Witbank, where he told eNCA that there was already no board as there were only three members left, and that they had been accommodated, but "if they want to leave, I won't stop them."

Mantashe said the energy department was currently replenishing the board, and that names were identified on Tuesday to begin putting together a new NECSA board

"What we are doing in this department is to resuscitate governance and entities in the department, which [have] collapsed...

So we are rebuilding it, and we are not rushing... we are not angry with anyone... we are quite steady and move step by step to rebuild governance in the department.

"If you don't have good governance, you are running a high financial and operational risk... There can be no financial performance if there's no

good governance," he explained. In July last year, Moneyweb reported that NECSA has burnt through six CEOs and two chairpeople in seven months.

The once-profitable stateowned enterprise under the previous board is now a financial wreck, asking Parliament for a R500-million bailout.

"They were unlawfully appointed, they are unlawfully occupying their seats, and all decisions they make must be subject to review.

This is quite apart from the fact that the board is inquorate [lacks enough members to make up a quorum]." Fin24

SAPS guards mess up salute at Richard Maponya's funeral

CAPE TOWN - Twitter had a field day after footage emerged showing police guards not knowing their left from their right.

The salute that went horribly wrong took place at the funeral and memonal service of business leader Richard Maponya at Westpark Cemetry. The faux pas was shown during a live broadcast of the funeral on

President Cyril Ramaphosa honoured Maponya with a Special Official Funeral Category 2. Special Official Funeral Category 2 has elements of police ceremonial honours and Maponya's remains will not lie-in-state.

Maponya died in Johannesburg on January 6 a few days after celebrating his 99th birthday. During his career, which spanned over 50 years, he created many job opporfunities for black citizens during the apartheid regime.

Ramaphosa also delivered Maponya's eulogy. The president described him as a man of "extraordinary resilience" who "persevered until he reached the pinnacle of success".

"And yet he remained humble, magnanimous and generous.

South Africa indeed has lost one of her finest sons."

Ramaphosa added that Maponya was driven by the conviction that South Africa would never be truly free until the fruits of prosperity were shared by all its people, saying the entrpreneur had stood for self-upliftment and inspired a new generation of business people.

Former presidents Thabo Mbeki and Kgalema Motlanthe were also in attendance, along with other dignitaries and politicians.

South African tweeps saw the humour in it, while others feared that South Africa would become the "laughing stock of the world".

TRUCK PETROL-BOMBED INKZNPROTEST

DURBAN - A truck was allegedly petrol-bombed during a service delivery protest on the N2 near Magabeni, south of Durban, yesterday.

eThekwini Fire Department South Divisional Commander Justin Bateman said protesters gathered on the N2 northbound after the Magabeni and Ilfracombe offramp as early as 5am.

The protesters allegedly set alight tyres and blocked the road preventing motor vehicles from passing through towards Amanzimtoti and Durban.

Bateman said the protest could have been linked to lack of water supply to the Magabeni community.

"The driver of a super link truck carrying car parts had noticed the fire in the distance when he neared the offramp. However, while the driver was turning towards the offramp it was allegedly hit by a petrol bomb. The driver and his assistant fled the scene. They were not injured. Once the area was stabilised by the Public Order Police we moved in and extinguished the fire," Bateman

The truck, trailer and goods were extensively damaged.

Traffic on the N2 and the alternative R102 was initially interrupted by the protest but later re-opened.

eThekwini Ward 99 Councillor Bob Daniel Naidoo said the alternate route on the R102 had also been blocked with tree logs but was cleared by police.

"For some time now the community of Magabeni have been asking for an improvement to the water supply in the area. Some of the areas do not have a water supply," Naidoo said.

A community leader in the Danganya area near Ilfracombe, who did not want to be named, said it was the fourth time

that people had been protesting. He said another issue was the resurfacing of certain roads near the Danyaga Primary

"The municipality contractors filled the road with gravel instead of providing a properly tarred surface. People are angry," he said.

Police spokesperson Colonel Thembeka Mbele said that at 02:30 a group of people from Danganya in Umkomaas blockaded N2 with burning tyres, stones and set a truck alight.

"The truck driver sustained injuries. He was rushed to the hospital for medical attention. Members are still at the scene to monitor the situation," she said.

Charges of public violence, malicious damage to property and attempted murder will be opened at Umkomaas Police Station for investigation.

Activist Kanya Cekeshe thanks SA for support

JOHANNESBURG-#FeesMustFall activist Kanya Cekeshe, who was jailed for violence that flared up during the varsity fees protests, has thanked South Africans for their support and lobbying for his release.

On Twitter, Cekeshe said he would not have been freed had it not been for the public's calls for his release.

"I'd like to take a moment to thank all those who tirelessly championed the cause for my release and used social media platforms, such as this one, to raise awareness around my case. I know I would not have been released without its added pressure," Cekeshe said, adding that he was humbled by the support.

Cekeshe was released on parole from the Leeuwkop Prison in Bryanston, Johannesburg, on December 24.

He had been there since December 2017, after being sentenced to eight years in prison, three of which were suspended, for public violence and malicious damage to property. He pleaded guilty to setting a police vehicle alight during a #FeesMustFall protest in 2016.

There were mixed reactions to Cekeshe's post, which was shared hundreds of times.

Many hailed him a hero, saying his name would be etched in the history books, but others condemned him for having taken the law into his own hands.

Police rape kit contract worth nearly R500m

JOHANNESBURG - The government contract to provide evidence collection kits for rape cases to police stations across the country was awarded to Acino Forensic at a cost of nearly R500m.

Police Minister Bheki Cele revealed in a written reply to a parliamentary question on Tuesday that the contract - worth R497.7m for a three-year period - was awarded in August 2019.

The collection kits, commonly known as rape kits, are used to collect DNA evidence from victims of sexual crimes.

Cele explained that the police did not have contracts in place in 2017 and 2018 because despite calling for bidders, the bids received in those years had not met the requirements.

He said prior to the awarding of the contract to Acino Forensics, evidence collection kits were procured on a quotation basis from three service providers: Batho Pele Health, Letsepe Investments and Yhira Investments.

He said the contract was awarded to Acino Forensics because it was the only bidder that met all the requirements of the bid.

Cele revealed the information while responding to a question from DA MP Andrew Whitfield, who wanted to know which companies were awarded contracts to provide rape kits in 2017, 2018 and 2019, and the value of each contract.

Whitfield revealed in August last year that 76 per cent of SA police stations did not have adult rape kits and 69 per cent of stations did not have child rape kits in stock.

He described the shortage of rape kits as a gross injustice to rape sur-

"Without these kits, evidence in reported rape cases cannot be collected. Without evidence, the ability to successfully prosecute rapists diminishes drastically," he said at the time. In his parliamentary response published on Tuesday, Cele also explained

that the SAPS made use of 16 different types of evidence collection kits to collect samples at crime scenes. "These include the two types of evi-

dence collection kits - the adult sexual assault collection kit and the paediatric sexual assault collection kit which are used to collect evidence from victims of sexual assault and rape," he said.

"The deoxyribonucleic acid (DNA) reference buccal sample kits are used to take buccal samples from persons who are arrested and charged, for schedule-eight offences [this includes serial murderers and serial rapists] as required by the DNA Act."

THUNBERG, TRUMP, MERKEL TO ATTEND 50TH EDITION OF WEF

GENEVA - Some of the world's most powerful leaders, including US President Donald Trump and German Chancellor Angela Merkel, are set to trek to the Swiss mountains next week to mark the 50th anniversary of the summit in the village of

As global power is no longer measured in troops and economic prowess but also in social media influence, it is 17-year-old Greta Thunberg who sets the tone for the meeting that highlights the challenges of the year and the decade ahead.

In an open letter published ahead of the World Economic Forum in Davos, Thunberg and a group of young climate campaigners demanded an immediate global stop to subsidies and investments related to fossil fuels.

"In an emergency you step out of your comfort zone and make decisions that may not be very comfortable or pleasant," they wrote in Britain's Guardian news-

The World Economic Forum's 81-year-old founder Klaus Schwab, who organises the event for thousands of politicians and businessmen in Davos each year, has not only invited her for the second year in a row but has also adopted some of her language.

He reminded reporters on Tuesday the world is facing a "state of emergency." "We do not want to reach the tipping point on climate change," he told a press conference.

"We do not want that the next generations inherit a world which becomes ever more hostile and ever less habitable - just think of the wildfires in Australia."

The summit that runs from Tuesday to Friday next week would also focus on various other pressing problems, according to the organisers, including slowing global economic growth, trade wars, geopolitical tensions in East Asia and Middle Eastern hot spots.

While the list of attendees includes country and government leaders from Jordan, the Palestinian Authority, Iraq, Afghanistan and Pakistan, there is one glaring absence: Iran's Foreign Minister Mohamad Javad Zarif.

Zarif's cancellation means that the Islamic regional power that is involved in an escalating nuclear spat with world powers and in various Middle Eastern crises will not be represented in Davos.



VANCOUVER - Meghan Markle broke cover for the first time on Tuesday leaving the palatial \$14million Canadian home where she has been holed up since last week to visit a women's shelter in Canada's poorest neighbourhood.

The Duchess of Sussex left the Vancouver Island ocean-side mansion shortly before 10am local time and arrived at Victoria Harbour Airport around 20 minutes later, where she appeared happy and relaxed as she laughed with her security team before boarding a seaplane for the mainland.

She then made a surprise visit to the Downtown Eastside Women's Centre in Vancouver to 'offer support' and to

'boost the staff's spirits'.

The shelter posted a photograph on its Facebook page of Meghan at the centre of a group of eight women, with the caption 'Look who we had tea with today!

'The Duchess of Sussex, Meghan Markle, visited us today to discuss issues affecting women in the community.'

A staff member said they only became aware of the visit when Meghan arrived and that she spent time meeting with managers.

The shelter provides counselling, hot meals, and basic needs for women and children in need.

"She asked what the women would need in terms of support. It was a nice meeting," the staff member said.

Back in Britain, where the royal family is in turmoil over the Sussexes decision to quit as senior royals and emigrate to Canada, it has also emerged:

Thomas Markle is prepared to give evidence against his own daughter in an extraordinary legal case over a letter she sent to Harry.

TRUMP TRIAL LIKELY TO **BEGIN NEXT TUESDAY**

WASHINGTON -The Senate impeachment trial of US President Donald Trump is likely to begin in seven days with key players sworn in later this week, Majority Leader Mitch McConnell said on Tuesday.

McConnell said he had expected the House of Representatives to deliver the articles of impeachment against Trump to the upper chamber yesterday.

"We believe that if that happens - in all likelihood - we'll go through

preliminary steps here this week which could well include the chief justice coming over and swearingin members of the Senate and some other kinds of housekeeping measures," McConnell told reporters. "We hope to achieve that by consent which would set us up to begin the actual trial next Tuesday."

Trump faces charges of abuse of power and obstruction of Congress, and the 100 senators will be his judge.

Iran arrests several people over missile strike

IRAN - Iran yesterday said it has arrested several people over the erroneous missile strike which brought down a passenger jet last week.

Judiciary spokesman Gholamhossein Esmaili said "some individuals' had been detained after 'extensive investigations", without saying how many.

Esmaili also described British Ambassador Rob Macaire - who was briefly arrested at the weekend for attending an anti-regime protest - an "undesirable element" and said he expects him to be expelled from the country.

"Our people and the international community expect him to be expelled from the country," Esmaili told Iran's INSA

Meanwhile, President Hassan Rouhani has vowed to punish those responsible as he called the shoot-down of the Boeing 737 an "unforgivable error".

The regime has been forced on to the back foot by the crash after its initial denials and subsequent admission prompted a fresh wave of protests.

Rouhani yesterday called for a special court to be set up to probe the 'painful and unforgivable' mistake which killed 176 people, including dozens of Iranians.

The president said "one person cannot be solely responsible for the plane crash" as he vowed a thorough investigation into the disaster.

"For our people it is very important in this incident that anyone who was at fault or negligent at any level" face justice," he said in a televised speech.

"Iranian armed forces admitting their mistake is a good first step ... We should assure people that it will not happen again. "Anyone who should be punished must be punished. "The Judiciary must form a special court with highranking judge and dozens of experts... The whole world will be watching."

Rouhani said his government was "accountable to Iranians and other nations who lost lives,"including Canada and Ukraine.

LOS ANGELES - Los Angeles County firefighters and paramedics treated at least 20 children and dozens of adults after they came in contact with jet fuel dumped by a plane flying overhead.

The Los Angeles County Fire Department said in a tweet that 44 people were treated at the scene with minor injuries related to the accident and were released.

The fire department said that 20 children and 11 adults were treated at Park Avenue Elementary School in Cudahy, California, while 13 other patients from schools in nearby South Gate and Florence Graham were also evaluated.

MILWAUKEE - US President Donald Trump threw his support, welcome or not, behind Democratic presidential contender Bernie Sanders in his back-and-forth with rival Elizabeth Warren, saying he did not believe Sanders would suggest a woman could not win the 2020 election. Tensions between Warren and Sanders, two progressive US senators who are running for the Democratic nomination, have risen after a report that Sanders told Warren in 2018 that he did not believe a woman could beat Trump. Warren confirmed the report late on Monday in a statement, saying: "I thought a woman could win; he disagreed".

82 000 people flee erupting Taal Volcano

MANILA - Two people have died from heart attack while fleeing from an erupting volcano near the Philippine capital of Manila, which has displaced more than 82 000 people, officials said yesterday. Taal Volcano in Batangas province, which is 66 kilometres south of Manila and located in the middle of a lake of the same name, started sporadically expelling ash on Sunday. The victims were a 65-year-old woman and a 27-year-old man from the towns of Talisay and Taal in Batangas, the provincial disaster risk reduction office said. The woman suffered cardiac arrest on Monday, while the man died on Tuesday, the office added.

Man's penis stuck in metal pipe for 5 days

THAILAND - A Thai man's penis began to decay after he got it jammed in a metal pipe for five days and only sought medical attention after the pain became unbearable.

The 21-year-old placed his penis in a sock and then put it into a metal cylinder and had sex with it last week.

After climax, the tip had swollen so much the blood couldn't flow back - and he was stuck inside the make-shift sex toy.

He wandered around his house for five days in extreme pain while trying a variety of lubricants to free himself from the jam. Daily Mail

How do we often respond

when things are not going well? The temptation is to 'go down to Egypt when the going gets tough'. When business or relationships are not going well, we are tempted to go back to the dark business arts and relationship practices of Egypt.


This is often our reaction in other arenas of life. God knew Isaac was tempted to respond to this famine by going down to Egypt and he quickly warned him not to.

The man who will experience Rehoboth must be a man who does not respond to famine by seeking a return to Egypt.

Third, sow 'and Isaac sowed in that land' you are going to do some sowing. The chapter that starts with a famine and ends with Rehoboth must require some sowing in between. That's what Isaac did

He sowed despite the odds of a famine. That is what I felt the Spirit was saying, keep sowing. Give, Work, Fight, Dare and Pray. Don't hold back. Don't not let the gloomy conditions stop you from sowing.

A lot of us confuse our passion for music and art in that we then assume we are artists even when we are not made to create but manage, sell, promote, organise, etc. "There are many


opportunities that exist in the music and arts industries outside being an artist. Having great passion for art doesn't mean you have to be an artist," said Dlamini.



Khabonina Qubeka wants R40million for placenta

PRETORIA - Actor Khabonina Qubeka is demanding millions of rands from a Johannesburg private hospital after her placenta was disposed of despite her request that it be kept for her.

When she gave birth to her daughter Lwandle in October 2018, the 'Isidingo' star signed a legal agreement with the Life Bedford Gardens Hospital requesting to take her placenta home. Sowetan has seen the document in which she "refused the disposal by incineration [burning] or by other lawful means of human tissue".

Qubeka and her world-champion kickboxing husband Vuyisile 'Master Vusi' Colossa wanted to keep the placenta for cultural and business reasons. But when she went back to collect the placenta a month after giving birth, it was missing despite the hospital's promise to temporarily store it for her.

Qubeka said when she went to obtain a hospital letter to present to the police so they can issue her with an affidavit to release the

placenta into her possession, the hospital couldn't provide her with

nal processes and policies of Life Healthcare, the allegations surrounding the placenta of Ms Qubeka, after giving birth during October 2018, was investigated at various levels, including hospital, operational and management level," Bottin said in an email statement.

"Having considered all the facts, we find no negligence on the part of the hospital.

Ms Qubeka was required to complete and sign an affidavit for the safe disposal of human tissue by a patient, in order to collect the placenta after her discharge. Ms Qubeka did not complete the affidavit nor queried upon discharge the whereabouts of the placenta.

"As a result, the hospital is obligated to dispose of the placenta in an ethical manner as required in terms of legislation."

Colossa said the placenta was significant for him and his family to be used in Tsonga rituals. "You can cleanse the child traditionally if something happens to them," Colossa said. "Some other cultures they plant it and then plant a tree to represent the life of the child."







Ben Stokes named World Player of the Year

JOHANNESBURG - Ben Stokes was named ICC Player of the Year yesterday after a red-hot 12 months during which the allrounder helped England to a maiden 50-overs Cricket World Cup crown.

Stokes smashed an unbeaten 84 in a heart-stopping World Cup final against New Zealand at Lord's, which ended in a tie before hosts England claimed the title on boundary count back.

The 28-year-old also hit 135 not out to secure an astonishing victory for England in the third Ashes test against Australia at Headingley.

"The last 12 months have been the best in my career, and I believe what we attained will be the catalyst to achieve further success over the next few years," Stokes said in a statement issued by the International Cricket Council (ICC). Australia quick Pat Cummins pipped, among others, compatriots Steve Smith and Marnus

Bayern Munich extend Audi sponsorship deal

BERLIN - Bayern Munich have extended their sponsorship deal with automotive manufacturer Audi until 2029, the German champions announced on Tuesday.

According to German tabloid Bild, Audi, who have sponsored the Bavarian giants since 2002 and have been shareholders since 2011, will pay Bayern €60 million a season instead of the current €40 million.

The duo's previous contract ran until 2025.

"For Bayern, this agreement is an important step for the coming years," said club President Karl-Heinz Rummenigge. Last season Bayern generated €660 million of revenue according to consulting firm Deloitte, which ranks the five-time European champions fourth in its Money League behind Barcelona, Real Madrid and Manchester United.

In June, Bayern sued BMW for between 10-20 million euros following the failure of a sponsorship deal between the club and automobile giant, which reportedly demanded that their contract with rival Audi be broken before any deal between the parties be done. AFP

"We are delighted to announce that we have reached an agreement for the 18-month loan of Gedson Fernandes from Benfica with an option to make the transfer permanent," said a club statement. Fernandes, capped twice at senior level, told Spurs

TV he was looking forward to working with compatriot Mourinho. "All young players want to work with Jose Mourinho because he's one of the best. All of us as players want to stay near the best, so it's fantastic to work with him. "I have

to say about the stadium because it is fantastic," he added. "I have never been or seen anything like this, It is unbelievable."

Fernandes was offered to Spurs by Mourinho's friend and super agent Jorges Mendes and they beat off competition from West Ham, who were keen to bring him to London.

Mourinho will be hoping that more arrivals may follow, particularly a striker following Harry Kane's potentially season-ending hamstring injury, with the club eighth in the Premier League, nine points behind fourth-placed Chelsea.

The club are understood to be interested in AC Milan's Krzysztof Piatek while Christian Benteke, Edison Cavani and even former striker Fernando Llorente have been linked.

There could also be departures at Spurs this month, with Kyle Walker-Peters hoping to join Crystal Palace on loan while the club are trying offload Christian

There have been very few marquee transfers done, setting up a potentially explosive few weeks as clubs look to strengthen their squads for the final few months of the season. Here, Sportsmail analyses 10 potential deals that could be done between now and when the window slarns shut on January 31.

Christian Eriksen's possible departure for Spurs is one of the deals to be sorted out this month

Christian Benteke (Crystal Palace to Tottenham/Aston Villa)

It seems odd that Benteke has any suitors, given his form of late for Crystal Palace, but such is the desperation for Spurs and Aston Villa to sign a striker that he may prove to be auseless stop-gap.

The Eagles are looking to send their record signing out on loan in an attempt to restart the former Liverpool striker's stuttering career. Earlier this month, the Eagles signed Everton's Cenk Tosun on loan for the rest of the season and Benteke could be the man to fill in for Spurs and Villa, amid their injury crises until the end of the season. Crystal Palace's Christian Benteke is an option for Spurs to replace the injured Harry Kane.

Hwang Hee-chan (Red Bull Salzburg to Leicester/Wolves/Brighton)

If Hwang were to leave Red Bull Salzburg then the Austrian side's forward line would have been completely decimated this month. First Takumi Minamino left for Liverpool before Erling Haaland jumped ship to go to Borussia Dortmund.

Surely they can't be tempted to let their third talisman leave before the end of the season? A

Christian Eriksen (Tottenham to Inter Milan/PSG)

Eriksen will leave Tottenham but it is now a case of will they get some money for him this month or will he leave for free this summer? In either case, Inter Milan looks to be his next destination.

It would still be a good move for the Danish international but there is no denying that he looked set for the bright lights of the Bernabeu before his form dipped around 12 months ago.

Real Madrid don't seem to be keen anymore, neither do Manchester United, so a move to Italy is on the cards. Spurs rejected a £10m offer from Inter on Tuesday night and are holding out for a fee of

PSG are also in the hunt for his signature with the Ligue 1 champions monitoring talks between Eriksen and Inter. They are said to be encouraged by the low numbers surrounding the deal at present.

Bruno Fernandes (Sporting Lisbon to Manchester United)

It seems this transfer is becoming more and more likely to go through as United finally appear to have added some quality to their midfield ranks. Fernandes was linked with a move away from his native Portugal all summer but nothing materialised and he stayed put. United, desperate for an injection of class in the middle of the pitch, have made their move now and look to be close to a £64m deal. It was reported on Tuesday that Andreas Pereira could be part of the deal as negotiations con-

tinue between the two clubs.

Olivier Giroud (Chelsea to Inter Milan)

Along with Eriksen, Olivier Giroud is hopeful of making the move from London to Milan this month. The Frenchman has seen his game time limited at Stamford Bridge due to the emergence of Tammy Abraham and Frank Lampard's preference to select younger players. Giroud is still a capable marksman though and would be a welcome addition to Inter as they chase the Serie A title with Juventus. Olivier Giroud has struggled for minutes at Chelsea this season due to Tammy Abraham's form.

Bruno Guimaraes (Atletico Paranaense to Arsenal)

Mikel Arteta has only been at Arsenal a matter of weeks but already knows there are areas that need improving.

One of those is midfield and the President of Brazilian side Athletico Paranaense, Mario Celso Petraglia, confirmed this week that the Gunners are interested in Bruno Guimaraes but will have to compete with Benfica for his signature.

Arsenal, unlike Benfica, are yet to lodge a bid for Guimaraes but the north London club could make an offer for the midfielder to ensure they don't lose out on one of South America's brightest prospects.

Krzysztof Piatek (AC Milan to Tottenham/Aston Villa/Newcastle)

Piatek is another striker who could profit from injuries by landing a move to the Premier League this month.

The Pole was the hottest striker on the planet around 12 months ago, scoring goals for fun with Genoa before continuing his fine form once he had secured a January move to AC Milan. His momentum slowed this season though. Piatek has scored just four goals in 18 appearances and the arrival of Zlatan Ibrahimovic has nudged him further down the pecking order. Spurs are in the race for his signature, while Villa also have firm interest.

Emre Can (Juventus to Tottenham/Chelsea/Arsenal)

Not much has gone right for the German midfielder since he left Liverpool for Juventus in summer 2018 and now it looks like his time in Italy could be nearing an end. Can has found opportunities hard to come by as the Serie A champions added Aaron Ramsey and Adrien Rabiot to their squad over the summer and a return to England has been talked about.

He has been offered to Spurs, Chelsea and Arsenal this month while Manchester United are said to have turned down the chance to recruit him.

Moussa Dembele (Lyon to Chelsea)

Giroud's exit from Stamford Bridge would mean Lampard needs a replacement and somebody to offer competition and support to Abraham. Dembele could be that man.

A number of English clubs have had a longterm interest in the Frenchman and he is known in British football due to his sucess at youth level with Fulham and then at Celtic. He also shown his quality in the past few seasons with Lyon. Manchester United are also keen on him, while Manchester City watched him in the recent game against Bordeaux, when he scored the winner. It would be difficult to get him out of the club in January, though, with President Jean-Michel Aulas refusing to let him go.



Phumlani 'Jones' Shongwe is said to have physically assaulted referee Tshepho Nkambule while coach Bheki 'Size' Nxumalo was found guilty of insulting the BASE executive in front of the sponsors who were waiting to do a presentation of medals and trophy inside court after Superstars had won the MTN Basketball League.

Shongwe and Nxumalo were called before the disciplinary committee chaired by Charlie Jele which was instructed by the association.
