## WHO Interim Guidelines for the Treatment of gambiense Human African Trypanosomiasis

## Summary of declared interests

Conflicts of interest were managed as follows:

- Experts participating in the process were required to complete the WHO Declaration of Interest (DOI) form before they commenced their work for WHO, and to promptly notify WHO if any change in the disclosed information occurred during the course of the guidelines development. The completed DOI forms were reviewed by the WHO Secretariat with a view to managing disclosed interests in the field of HAT.
- At the meeting of the Guidelines Development Group in December 2018, all meeting participants verbally disclosed any interests declared to the rest of the group. Hence, the GDG was aware of any existing interests among its members.
- All declarations of interest were reviewed by the WHO Secretariat. It was decided that all experts could participate in the process as no member had financial or commercial interests related to HAT therapeutics, and that there were no significant intellectual conflicts of interests that would exclude any member from fully participating in the guideline development process. As a result, options for conditional participation, partial exclusion or total exclusion of any member were not discussed.
