<sup>2</sup> Respondents who did not report their school enrollment status, who reported not being enrolled in school in the past 12 months, or who reported being home-schooled were not asked about receipt of mental health treatment/counseling from this source; however respondents who reported not being enrolled in school in the past 12 months were classified as not having received treatment/counseling from this source.

<sup>3</sup> Because of revisions to the Source of Youth Mental Health Education Services questions in 2009, these estimates are not comparable with the education services estimates presented before the 2009 NSDUH.

<sup>4</sup> Includes receipt of any specialty mental health services and receipt of services from either Education or Medical sources.

<sup>5</sup> These services were often provided by psychiatrists, psychologists, social workers or counselors who work for the court system.
