Three categories of mental illness severity are defined based on the level of functional impairment: mild mental illness, moderate mental illness, and serious mental illness. Any mental illness includes individuals in any of the three categories. These mental illness estimates are based on a predictive model and are not direct measures of diagnostic status.
